19 Jan 90 Call from Stephen and Lynda Hassan. A diamond shaped formation of lights was observed over Penacook.

7 Feb 90 "V" formation of lights observed over Penacook at 7:00 PM. (Wednesday)

14 Feb 90 "V" formation of lights observed over Penacook at 6:30 PM. (Wednesday)

21 Feb 90 Due to a pattern of Wednesday sightings in Penacook a team of NH MUFON members were stationed at a public parking area in Boscawen. A "V" formation of lights was observed. Also observed was a bright white light hovering near the observation site. A blue beam was seen emanating from the object toward the ground. Photographs were taken. Analysis of the photos is being conducted.

28 Feb 90 MUFON team on location in Boscawen observed "V" formation at 6:15 PM and again at 6:40 PM. Several pictures were taken with poor results.

18 Mar 90 A woman driving North on Rt 114 toward Weare observed a bright white light hovering over a garage. Just prior to observing the light her car radio malfunctioned. She stopped her car to look at the object. Suddenly it shot off to the North.

21 Mar 90 MUFON team on location in Boscawen observed "V" formation again. While on site a team of "ORGANIZED DISRUPTERS" entered the public parking area and proceeded to harass our team.

28 Mar 90 MUFON team at an alternate site (to avoid the "DISRUPTERS") observed the "V". Photos were successfully taken and are being analyzed.

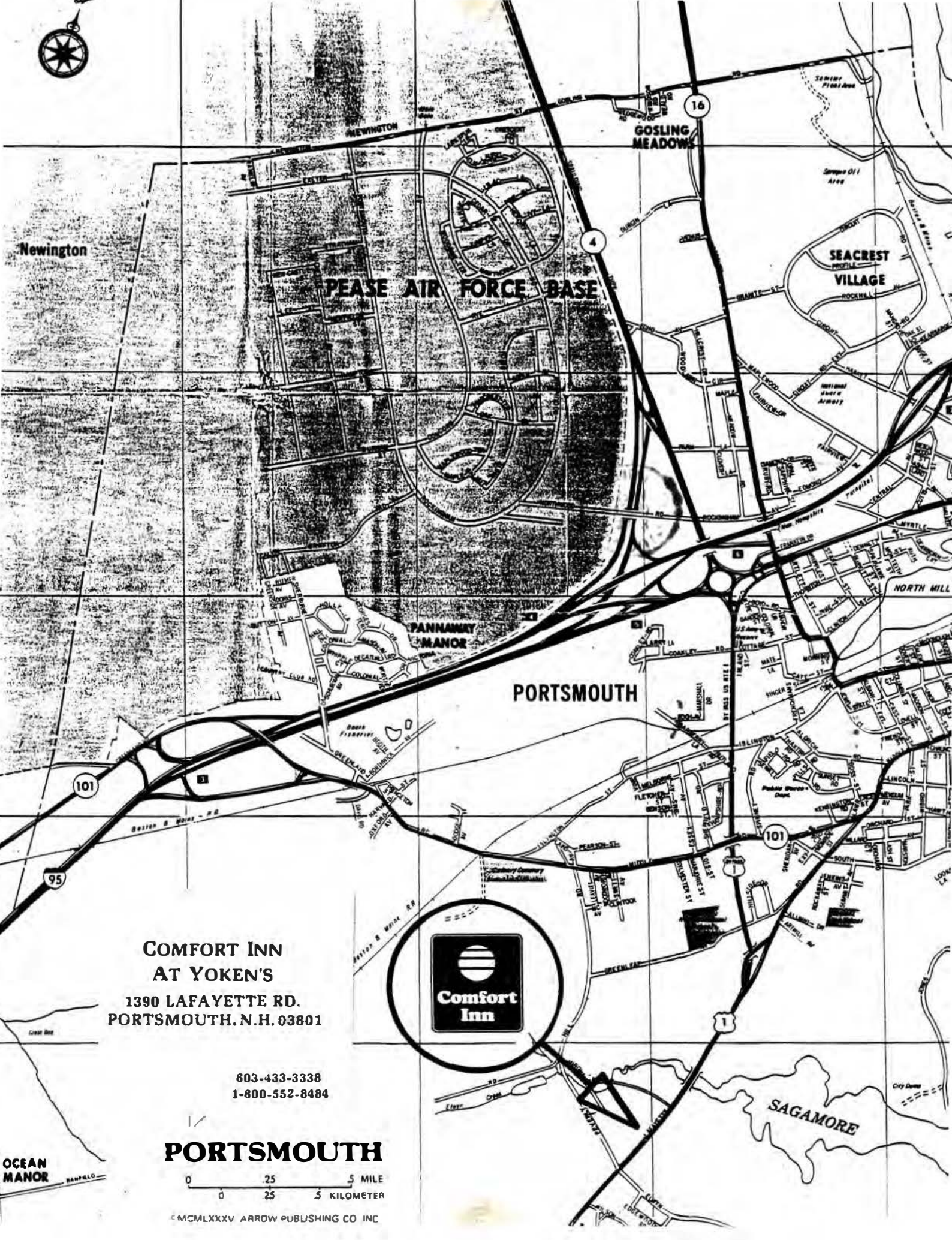
