## NH MUFON CASE LOG

**Date:** March 6, 1992

**Place:** Newton, NH.

A mother was putting her young children to bed. It was early evening, about 9:00 PM, all was calm in the well kept home overlooking a huge swamp in Newton. Mom was in the bedroom tucking the children in when she noticed a strange looking light hovering over the swamp near their house. Not wanting to alarm the children she comely said good night and left the room. She immediately went to the living room window where she saw a white glowing light hovering over the swamp not far from the house. Her view was such that she was looking straight out the window through a narrow tree line over the swamp. the light was moving from side to side. As she moved closer to the window the light moved closer to the house. This frightened her and she immediately moved back. The light also moved away and hovered. She could not believe what was happening. Could the light be reacting to *her* ?. She again moved to the window and again the light moved toward the house to a point where it was within a hundred yards. Afraid to go near the window she observed the light from the edge of the window for about twenty minutes before it drifted out of sight to the west. During this time she observed several maneuvers. The light hovered. went up and down, zig zaged rapidly, moved slowly almost like drifting, and moved near the house several times. She described it's size when closest to the house as that of a basketball at arms length. No missing time was noticed and the remainder of the night was uneventful.

During the investigation of this case it was learned the woman had a previous UFO sighting which turned out to be a multiple witness CE I.

About ten years ago this witness was riding in a car at about 8:30 PM with three other people in Amesbury MA. She was in the back seat with her husband. In the front was her uncle who was driving and his girl friend. They were heading west on Friend Rd. just before the W. Whitehall Rd. junction when our witness spotted a bright light to the rear of their car. She alerted everyone and all observed the light which was now a huge lighted object pass in front of the car and stop in front of them just off to the side of the road. The huge object hesitated for a few seconds then headed for the car. Her uncle stopped the car and they observed this thing pass directly in front of the car at a altitude of about one hundred feet and was the size of three horse barns. Our witness was frightened, her husband was amazed, her uncle couldn't believe it and kept saying "that can't be an airplane", and his girl friend wanted it to come back so she could go for a ride. No missing time was noticed however they did see a spark like object eject from the bottom of the craft heading toward the ground at an angle. It went out before reaching the ground. No sound was heard from the craft or the ejected object. The night was clear and they continued to their destination without further incident. Upon reaching her home in Newton (not the present residence) she called her mother who lives in Plaistow NH. Her mother saw the same type of craft in Plastow that night. At this time we are trying to locate the other witnesses who were in the car. The uncle and girlfriend are somewhere in California. The craft was described as having a disc shaped bottom section with rectangular sections covering the bottom. There was a white light around the perimeter of the craft much like a huge round fluorescent tube. Above the disc section was another section which was much larger blocking out the night sky. The shape of this section was that of a giant hot air balloon with some type of connecting structure. On the side of the disc was a large rectangular window with white lights inside. No figures were seen although she was sure she could see inside. There is much work to be done on this case. To make things even more strange the children are talking about little men in their bedroom. Could this be an ongoing situation. Our witness also has what could be a scoop mark on her ankle. Stay tuned for more !!

**Date:** March 3, 1992

**Place:** Concord Area

The night of March 3, 1992 had the media and NH Mufon running to find out what was flying over the New Hampshire skies. People were calling radio and TV stations with strange stories of **Flying Triangles** with white lights making no sound. Some sightings at low altitudes. The March 7 issue of The Union Leader had a color picture front page story of one of the witnesses. He saw a huge triangular object with many blue-white lights covering the bottom. The car he was driving began to shake and he heard a sound described as rain hitting a canvas tent. He stopped his car, got out to see an object the size of a small base ball field moving slowly over nearby houses and out of sight. He stated the drawing on the front page of The Union Leader was not exactly what he saw. The artist showed the lights as shining beams of light. This was not the case. The lights were *not* making a beam. Many other sightings were reported in towns such as Claremont, Newport, Bradford, Salisbury and Penacook.
