GABE VALDEZ ON DULCE, MUTILATIONS, UFOs AND MORE

Gabe Valdez, a New Mexico state police officer stationed in Dulce for 19 years, spoke to NM MUFON on March 23, 1995. Many members agreed that this was one of the best programs we've ever had.

Gabe's involvement with cattle mutilations, UFOs, helicopters and other strange phenomena began on June 13, 1976, in the midst of his regular law-enforcement activities. On that day, a local rancher, Manuel Gomez, found a dead four-year-old black cross hereford with all reproductive organs removed.

"I was a rookie," said Gabe. "But I knew it wasn't a predator. I thought--devil worshipers. It's the first thing you think of." When he checked out the crime scene, he found triangular pod marks 300 feet away from the carcass. There were traces of another vehicle also. "I was raised on a ranch and had never seen anything like it."

During 1976 Gabe investigated 18 mutilation cases while also breaking up bar fights, stopping drunk drivers and filling out normal paper work. The state police lab wasn't equipped to handle the cattle biopsies, so he sent samples to labs in Denver and Dallas. From 1976 to 1988, Gabe followed up on about 35 mutes. According to him, only three of the

cases could be attributed to natural causes and/or predators.

What Were the Results?

There were many unexpected things discovered during the course of these investigations. Some of the mutilation sites had altered magnetic fields. At some other sites, they found twice the normal background radiation.

Howard Burgess, from Sandia National Labs, helped with some of the investigations. Burgess and others conducted a test on cattle using a black light. A fluorescent white powder was found on the necks of five out of 150 cattle tested, but Gabe did not say if these animals were later found mutilated.

Several tranquilizers were found in fresh mutes. These turned out to be atropine and chloroform. There was a kind of white paint found on the hides of mutes. This was determined to be vitamin B12. Gabe said, "I thought then that somebody was messing with the immune systems of the animals."

They found pieces of radar chaff (used to confuse radar) at one site. In another case, a piece of chaff was found inside the mouth of a mute. In one case, an Army-style gas mask was found at a mutilation site.

Some of the organs taken from the cows were out of the ordinary for mutilations. "They were trying to throw us off," Gabe stated.

One carcass was sent to Los Alamos National Labs for a necropsy. High levels of potassium and copper were reported. This remains unexplained.

Some of the Problems

Problems developed with getting good vet and lab reports. "Many vets in New Mexico and nationwide won't give good reports on what happens after an animal dies. They won't put their name on the line," he said. Some of them finally refused to accept any more carcasses from him. He told of a case where a cow had died and some of the officers decided to make mutilation cuts on it and send it to the lab for results. The samples were sent to Colorado State University, a good veterinary school. Their diagnosis was: predators!

Many people simply didn't believe that anything unusual was happening to the cattle. "There was a lot of backstabbing going on," he told us. "There were editorials written in a newspaper that said that I should be committed to the mental institution in Las Vegas [NM]!" The *Albuquerque Journal* supported him, but without it, "I would have been history," he said.

"I just want to say that 75 to 80 percent of what Bennewitz said was true."

Gabe said that even though things became difficult for him at the time, he *knew* something strange was happening. "My

credibility stood up in court and I knew I wasn't crazy," he said. He pointed out that as a trusted law officer, testimony sworn to by himself and by other community members who had witnessed unusual activities would have been welcome in a court of law in a normal court case or even a murder trial. His intelligence and even handed manner was certainly obvious to us. He is an open, sincere and persuasive speaker.

Who or What Was Doing This?

Well, there were a lot of unidentified lights. "I witnessed a bunch when I was running surveillance," during his regular work, he said. The unidentified lights were "orange, pulsing, slow-moving and disappeared like when you blow out a candle."

Gabe and some other investigators used night scopes and high-speed film. With these they were often able to see things that were not visible to the naked eye. Sometimes, too, when unidentified lights were seen, the light on Gabe's radio would inexplicably come on at the same time.

Helicopters were seen at the same time as mutes were discovered and sometimes just before such a discovery. "This is a fact," Gabe said. "UFO activity and helicopters are associated." He once saw a UFO that "made noise like a John Deere tractor." It was twice as big as a nearby pine tree and looked like a hot air balloon, but it wasn't one. "It was pear-shaped, and smaller ones came out of it," he said.

Is it the government, aliens, or both? Or is it a very sophisticated aircraft? It would have to be very sophisticated," said Gabe.

What is So Special About Dulce?

In 1968, the Dulce earthquake project, "Project Gasbuggy", was begun. "They drilled down for two miles to create a big hole to get natural gas," Gabe explained. Then they used another bomb to cap it. Since then, the land has been contaminated. He said that the Atomic Energy Commission began monitoring the water in Dulce.

Also near Dulce, in San Ysidro, is a Search and Rescue Training center. White helicopters were seen there in 1975-1978. Some of the dark helicopters seen recently are used for antidrug operations according to Gabe.

Paul Bennewitz

Gabe spoke about his association with Paul Bennewitz, an Albuquerque engineer and UFO investigator. He said he first met Bennewitz in 1980 at Cimarron, NM, at a conference hosted by Harrison Schmidt. At that time Gabe asked Bennewitz for help with the occurrences at Dulce. This was when Bennewitz was working with Leo Sprinkle on an abduction case involving a woman and her son. Tests were done on them and they allegedly had implants in their necks. The x-rays were never released however. "I sure would like to see *that* report," Gabe said.

"I just want to say," said Gabe, "that 75 to 80% of what Bennewitz said was true." He confided that Bennewitz called him often about crashed UFOs on Mount Archuleta. Bennewitz also maintained that a nuclear-powered craft had crashed near Dulce.

"I went up there, took a group of people," said Gabe. "It's a remote area. You have to walking for five hours. We found the place Bennewitz was talking about. There was a burned area and two trees were knocked out. We found a government ballpoint pen on the ground. While we were searching the area that night, some aircraft came in real fast and

then just disappeared into another dimension. There was no noise."

Gabe said that Bennewitz was fed false information by an Air Force investigator stationed at Kirtland. "I won't say his name," Gabe said. (We know it was... Richard Doty--Ed.) "And the same thing happened to Linda Howe," he added.

"The Air Force people broke into Bennewitz's house and changed his furniture around!" he said. "And I know someone tapped my phone, too."

"Bennewitz is doing okay now," he said. "His boys run the company" (Thunder Scientific Corp.)

When asked where to look for interesting things in Dulce, Gabe said he never found Bennewitz's underground base, but a rumor says that there's something about a mile southeast of Dulce Lake in Soldier's Canyon.

Gabe told us that he and his wife saw Bennewitz communicating with aliens through Bennewitz's computer. Was it a trick? Did the man preprogram it? Gabe said that his wife decided to test it and asked the computer "Who is the creator of the universe?" The computer was silent for ten minutes, then the answer came. "We have been discussing the problem with higher personnel. The conclusion is there is only one god."

Gabe recalled that an image then appeared on the computer screen. "It looked like a reptile creature wearing an old Roman helmet," he said.

I asked Gabe if the Air Force could have been accessing Bennewitz's computer. He said, "It's possible."

Other Phenomena and AIDS

Gabe told us that there is a cemetery on the Gomez property about 1.5 miles from the house. Among the rock headstones is a glowing form shaped like a 21" black and white TV screen! This glow can be seen from a distance but it disappears when viewed up close. "It's still there," he said.

Is there a connection between AIDS and mutilations? "It's one of my top theories," Gabe said, that it "was developed in a lab and we can't control it. It's scary. I think the federal government hasn't told us everything."

The Bottom Line

What is Gabe's theory about mutilations? He said it could be a secret military or government research project on something lost in the atmosphere--maybe something biological. Or, it could be UFO activity and they are monitoring it. "Whatever it is, it's important, top potato!" Gabe said. "And it could be affecting our health."

Everyone in the gathering enjoyed Gabe's talk, and we all hope he feels free to make attending our meetings a regular habit.

FROM OUT OF THE BLUE!

Dear Carolyn,

Thank you for the nice story about my research on underground bases and tunnels. There are just a few factual discrepancies in the article that I would like to clarify.

There are more than rumors of FEMA installations at the cities identified in your article. In fact, FEMA *does* have centers in Santa Rose, CA; Thomasville, GA; Maynard, MA; Battlecreek, MI; Denton, TX; and Bothell, WA.

The total number of FEMA underground facilities is unknown. But one report in 1976 (in *The Progressive*) put the number in Maryland, Virginia, Pennsylvania, West Virginia and North Carolina alone at 96. During the 1980s there were scores of secret bunkers built as part of the "Project" carried out by the CIA, Army generals and others. In 1989 *U.S. News & World Report* reported that there are approximately 50 secret presidential bunkers around the country.

The article reports that United Tech makes tunnel boring machines. I know of no company by this name which makes tunnel boring machines. Perhaps the most prominent tunnel boring machine manufacturer is the Robbins Company, of Kent, WA.

I do not know if Parsons, Brinkerhoff, Quade and Douglas and the TRW Corporation have their own underground facilities. What I did say is that they both have worked on underground projects. TRW has contracted for electronic and communications systems and Parsons, Brinkerhoff, Quade and Douglas has managed actual construction, notably for the Cheyenne Mountain NORAD facility.

The base in the Manzano foothills, near Albuquerque was built by the Air Force and is on Kirtland Air Force Base. It is still administered by the Air Force, though there is now occupancy of some of the bunkers in the area by the DOE.

I have no knowledge of new underground construction at Los Alamos in the 1980s. I have received some information that there was some minor work inside the "ice house" underground facility, involving duct work and the like. But this was comparatively minor.

As for White Sands--I have no documentation concerning underground facilities there. A couple of people have told me that there is an underground laser facility there. But I do not believe this information is widely known publicly.

Readers who would like the documented facts may profitably consult my book. There is a lot going

on underground and UFOlogists would be well served by a dose of documented facts to go along with the reams of wild speculation that abound in this field.

I would like to thank New Mexico MUFON for the opportunity to explore the topic of underground bases and tunnels at their February 1995 meeting.

Dear Ms. Duce-Ashe:

I'm not sure why it is so important for Karl Pflock to believe that I once endorsed his Project Mogul theory. The fact is, I tried to send a note to a colleague congratulating him on the completion of his work and nothing more. I meant nothing other than his work supported his theory. I felt that it was not the forum to criticize the work. That would come later as we all reviewed the report.

However, to put this in perspective, let me say that on June 27, 1994 (before the July 6 note), I wrote to Dick Hall, saying, "We are fully aware of Mogul, and I will say that it will answer nothing. Mogul was not responsible..." On July 28, 1994 (after the July 6 note), I again wrote to Hall saying, "I am suggesting that Mogul was not responsible for the debris and when the documentation for Mogul Balloon Project launch No. 9 is located, it will prove that no Mogul balloons were found that could explain what was discovered by Brazel... Pflock's report is flawed..."

In January we learned that Flight No. 9 contained no array train. The flight was not launched "in the wee hours of July 4" as Pflock speculated, but at 7:30 p.m. on July 3. Photographs of it, and Professor Charles Moore's statements about Flight No. 9, eliminate it completely.

This is an argument that should not be taking place. I know what I meant and I know what I said. Pflock's interpretation is flawed. He can only guess, but I know the truth.

I do not know why Kevin Randle thinks there is an argument about his views on the Mogul explanation for the junk found by Rancher Mac Brazel. As I have written, I am quite willing to take

him at his word (see my letter in "From Out of the Blue" News, #24). 'Nuff said, as far as I am concerned.

Further, I agree with Randle that Brazel did not find remains of Mogul Flight 9, as I had speculated in *Roswell in Perspective*. When I completed *RIP* in March 1994, the information I had concerning specific Mogul flights was in many respects sketchy and in some part erroneous. At the time, Flight 9, launched, as Randle notes, on the evening of July 3, 1947, seemed the most likely source of the debris found on the Foster Ranch. Now, with considerably more information in hand and based on hard evidence, it is clear it could not have been the culprit. On the other hand, substantial evidence, including important weather data obtained by Randle, strongly suggests Brazel's find was debris from Mogul Flight 4, launched on June 4, 1947.

Professor C. B. Moore, who served as the Mogul project engineer, has recently completed a white paper, "The New York University [Army Air Force Project Mogul contractor] Balloon Flights During Early June, 1947," setting forth his analysis of the data and his own firsthand recollections. Therein he explains why Flight 4 almost certainly was a "full-scale cluster [a flight train more than 450 feet high], complete with the targets for tracking by the Watson Lab radar," and recalls "J. R. Smith watching the June 4th cluster through a theodolite" and "Capt. Dyvad report[ing] that the... radar had lost the targets while Smith had them in view." He also recalls the flight was tracked from the air by the crew of a B-17G assigned to the project, who "terminated their chase, while the balloons were still airborne..., in the vicinity of Capitan Peak," about 23 miles south-southeast of the Foster Ranch. Moore concludes, "When the wind information is coupled with the similarities in the debris described by eyewitnesses... to the materials used in our balloon flight trains, it appears to me that it would be difficult to exclude NYU Flight #4 as a likely source of the debris that W. W. Brazel found."

I hope Professor Moore's paper will be available generally in the near future, and I congratulate Randle for his initiative in collecting the important weather information which has contributed so significantly to Moore's analysis and our growing understanding of what really happened near Roswell so long ago.

Book Review: Ceto's New Friends

I heard Leah Haley's first public address at the Ozark UFO Conference in 1993. She expressed her anxiety and concern about her own abduction experiences. At that time she was still working on her book *Lost Was the Key*. (See review in *NM MUFON News* issue #8.)

I was impressed with her intelligence and courage in relating her story which goes back to her childhood; she said she wished there had been a book available then that might have helped her understand what had happened to her when she was young.

Now, Leah is a well known speaker, touring and lecturing with her husband, Marc Davenport, author of *Visitor's From Time*. (Reviewed in issue #12.)

Leah's new book for pre-schoolers, *Ceto's New Friends*, has been praised by teachers, children and children's librarians because of "the colorful pictures, fun story and typeface identical to that used to teach children to print."

The press release is right to point out that the book is "much more than just good, instructive entertainment." *Ceto's New Friends* "is an excellent tool for helping the growing number of youngsters who report extraterrestrial encounters to assimilate their experiences. When they see the children in the book interacting with the entity in a matter-of-fact way, their fears may be calmed. Also, the book is invaluable as an aid to parents who are trying to understand their children's experiences, since the children can talk about the characters in the book instead of about themselves, thus distancing themselves from disturbing situations... I can't find enough superlatives for Ms. Haley's work."--Richard J. Boylen, PH.D., a clinical psychologist and founding director of the Academy of Close Encounter Therapists.

Leah Haley holds master's degrees in both education and business administration. She is a teacher, writer and abductee. Her story of a friendly grey alien and two human children who become his friends is a carefully constructed narrative incorporating many aspects of the well known abduction scenario. This includes the ETH, talking "through the eyes," stepping into the light, floating up in the light, going into a spaceship, operating the spaceship, returning to earth, and saying goodbye to the alien. These elements are all woven into an amusing and nonthreatening story. The illustrations

by Lisa Dusenberry are well done and help to portray the delight and innocence of children meeting a friendly ET.

This would be an excellent book for children who have spoken of having UFO dreams or encounters. It could indeed help parents and therapists to talk to children and help children to open up and deal with experiences they may be having.

However, it might not be a good idea to expose preschoolers to the elements of the so far unproven abduction phenomenon. When parents discover their children talking about it, they should listen carefully, perhaps the best initial step. Contamination can occur to children's open-minded exploration of ideas and dreams before they can consider their own recollections of "what happened."

Since books by Budd Hopkins and John Mack and others have come out, many parents are now taking their children's accounts of contact seriously. I would recommend this book for young children who say they've encountered these things. The book documents a friendly, safe encounter. As we all know, the abduction phenomenon hasn't been friendly or safe for all abductees, including children. But the book could prove to be an effective therapy tool.

Alien object uncovered on Main Street

A Twin Mountain backhoe operator working on the Main Street project Thursday unearthed a cavern containing an object which is tentatively being described as "alien in nature."

Presently, little is known about the object. Dr. Mia Van Aswegen, an archeologist from Eastern New Mexico University, examined the object and said, "we definitely have a prime specimen of, say, an alien nature." She went on to describe a piece of the object as having markings similar to Egyptian hieroglyphics, but not exactly the same.

Reactions to Aswegen's pronouncement ranged from disbelief to fear.

"I don't believe that the object is an alien artifact," said a construction worker who wanted to remain anonymous. "Maybe the last guys who laid road put it here as a practical joke. Hoo boy! I bet they're laughing now."

"Liar! That's what that woman is, a liar," one man yelled from his car as he sped out of town. The car was emblazoned with red painted letters spelling, "Aliens go home."

Fumes were also reported in the area, but seem to have had no ill effects on the workers.

One worker, Chester Harlequin, said, "I feel great. In fact, all I want to do is get back to work and dig that thing up. It's like it's calling to me. And if those guys from Wright-Patterson think they can stop me, they better think again," he said, brandishing his shovel.

Other workers expressed the same sentiments, mainly resentment about the indefinite shutdown on construction and hostility towards officials from Ohio's Wright-Patterson Air Force Base and New Mexico's Los Alamos Laboratories. The officials have been called in to investigate the glowing device partially buried under Main Street.

Legends about alien flying craft landing in or near Roswell have been circulating since the time of Billy the Kid. In fact one letter from "The Kid" to Pat Garrett stated that he had seen an unusual light in the sky just before a bright light stole his favorite horse out from under him.

Several historians dispute the letter's authenticity, noting that the first letter of the first word in each paragraph spelled out the phrase APRIL FOOLS.

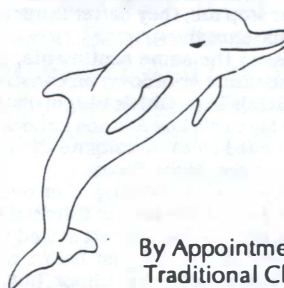
