New Director of Investigations

Greetings from Englewood, Colorado; as of this writing I am told there are officially 116 MUFON International members who reside within our state. Of that number I was recently informed that roughly 55 individuals and families hold memberships in both MUFON International and Colorado MUFON, Inc. With these numbers in mind, having rejoined both organizations myself in August, 2001, time would seem appropriate to reintroduce myself through a little personal history and to begin to address our current strengths and weaknesses on the investigative side.

When I originally joined MUFON in 1986, at that time there were not many members in Colorado, perhaps 20 to 25 if my memory is correct. Most were inactive and communicating was via long distance phone calls or snail mail; there was no e-mail or Internet yet. Our State Director was Myron Carlson, an aircraft accident investigator who lived near Greeley. By and by I telephoned Myron to see what I could learn about what was happening with the Colorado organization. He informed me that very little was happening and so it was decided to mail out invitation letters to all Colorado members who might wish to attend a meeting at Myron's home. All totaled, Myron, myself and about three or four other members traveled to what might possibly pass for Colorado MUFON's first ever state meeting. In fact, the very first issue of this newsletter, the Colorado MUFON News, originated shortly thereafter.

By 1988 we were gaining more members, most of who resided in the Denver area. We began holding state meetings at a local library but the commute, work, family and other factors curtailed Myron's ability to travel into town and so he decided to resign his post as State Director, regrettably, eventually leaving MUFON. He recommended me to then International Director, Walt Andrus, who subsequently asked me to take on the position. Thereafter, I served as State Director for Colorado from 1988 to 1992. Over that period membership fluctuated averaging somewhere around 50 to 60 members, near 70, I think at its peak.

I departed MUFON in 1992 and later began to pursue

From the book: Warning

In the early morning hours of Sunday Aug. 5, 2001, my wife Jane was apparently abducted. When she woke that morning, her thumb ring had been moved to her ring finger. This started to freak her out, because it meant someone had moved it in her sleep right next to a \$25,000. ring on her ring finger. They could have just as easily have been stolen. Then she started to remember a "dream" she had that night. Her dream started with her standing in a drab gray hallway with between 50 to 100 other women. They were milling around in groups, talking to each other. Janie said that she felt a strong undercurrent of fear, which to her was strange, because if she had full control of her senses, she would be going ballistic demanding why she was there, and getting rowdy. She was slightly suppressed and could not engage her anger reaction. Some of the women were telling her and others that they had been through this before and it was OK, everything would be all right, just follow directions and do as you're told. She had the impression that they were being told to walk down the hallway. All the women walked down the hall which curved around gradually to the right as they covered about 100 yards. Everything along the way was colored the same drab gray color. There were no doors, windows, or signs or markings on anything. She could not remember seeing a ceiling or source of lighting. There was no carpet or floor covering on the floor. It was a metal deck, as were the walls. Janie had the impression that all the women were clad in something like smocks or hospital gowns. They were all barefoot. None were wearing eyeglasses. This indicated to me that they were all abducted while sleeping. No one wears shoes or glasses to bed. She said the women were all about 30 years old, nice looking, no obvious ethnic characteristics, and no black women. This may indicate the aliens abducted all the women from the same white neighborhood. The lady standing next to Janie had black hair, but Janie was unable to determine her ethnic background. She said there was nothing obvious in their speech to indicate where they came from, no southern accents, etc. I personally believe the women were all locals. Most of the people living here, even the native Floridians, have no distinctive regional accent. The hall ended at the



 investigations on my own. It was one such investigation that led me back to MUFON in July, 2001. For on the hope that I might find some answers to a perplexing physical condition, *apparent subcutaneous fluorescence*, that had appeared on the legs of one of my clients who also claimed a lengthy history of close encounter experiences, I decided to attend the 32nd Annual MUFON UFO Symposium in Irvine, California. It was there that I first met John Schuessler. Intriguingly, a mere four months later I was introduced again to this peculiar and astonishing phenomenon (See October, 2002, MUFON UFO Journal, page 3) when Deputy International Director, George Zeiler, and I detected and photographed apparent subcutaneous fluorescence on another alleged abductee, the now well-known Stan Romanek case.

Other than for the Romanek case that appeared to dominate 2001 and 2002, headed by Mr. Zeiler, reports of UFO sightings in Colorado appeared to be in short supply as did the number of investigators prepared to investigate them. In 2003 we started to hear about unusual nocturnal lights via the hotline from people who wanted to know if others had reported what they had observed. Most declined to meet being more curious about what they'd seen than wanting to file a formal report. Into late spring and over the summer a few more reports trickled in with a noticeable increase in the amount of detail being offered by witnesses. This trend continued well into the fall, including some reports that were supported by still photos and video tapes. Throughout this period, however, our ability to respond to reports was quite limited. *Why*, we may ask?

From my perspective, when I returned to Colorado MUFON in August, 2001, I had no idea what to expect since I'd been away for about 9 years. I began to attend the state meetings to learn who was who, how things were organized and renew some old acquaintances. I had no idea how many members we had, who was the State Director, how many investigators there were, or whether there were any other active cases being investigated. Then, like a number of us I found myself suddenly unemployed and having to undertake a career change. I continued to attend most of the state meetings and over time things came into focus. We had (*and continue to have*) a tremendous group of regulars, dedicated and hardworking individuals and families keeping things moving and I was very impressed by this. Having been away for 9 years I can say with complete objectivity that I have never seen our state organization as strong and poised as it is today.

Simultaneously, however, though I think we've made a good start and done some good work in 2003, since

returning it has been my observation that, overall, our investigative resources and capabilities have not been our forte. Colorado is a big place and we have but a small handful of dedicated investigators who are willing and reasonably prepared to respond and follow through in a timely manner. Subsequently, it may only take a few good cases to overwhelm our ability to respond. All across our state our need to improve is evident, at what we are attempting to do, from initially contacting witnesses, conducting interviews, completing those dreaded report forms, making collateral contacts, *writing up the investigator's written reports* and finally putting it all together for submission before it is scanned into the Pandora Project database. We have a big job ahead of us if we are to get where we need to be and naturally it will take time. As your new Colorado Director of Investigations I intend to address these critical issues in a variety of ways, including via this newsletter, to help expand and ensure our continued success. Moreover, whether you are currently a journal subscriber, trainee, investigator, section director, consultant or other investigative assistant I would appreciate hearing your thoughts, questions, answers, or other concerns regarding our ongoing development on the investigative side of Colorado MUFON. I look forward to hearing from you.

entrance to a large room. Just off to the right outside the entrance to that room was an alcove set a few feet back into the wall. In the alcove was a drab gray metal podium that was about chest high. A normal looking human male was standing to the side of the podium. He was wearing khaki colored slacks and a golf type T-shirt open at the neck. Janie got the impression that the women were supposed to form a single line and file into the next room, which they did. In the next room were a series of 18 inch wide shallow channels cut into the metal floor. They were only about 4 inches deep. The channels were parallel to each other and about 3 feet apart from each other. The women filed into these channels and then faced left toward a stage that was running the length of the front of the room. The women were lined up in the first ten rows facing the stage, there were about ten women in each row. Drab gray metal steps about 3 feet wide and 3 feet from front to back led up to the stage. The steps were near the right end of the stage. All of the women were telepathically asked in turn to walk up the stairs and remove their clothes. The stage was at chest height but Janie could get no impression of what was up on the stage. It was like a blank area that she could not see into. Janie was in the middle of the front row. When it was her turn, she refused to move to the stairs. She was taken to the end of the first line and the others in her line were taken ahead of her. Then it was her turn again; she was told firmly that she had to go too. She was escorted somehow to the stairs and asked to take off her clothes. She resisted again and that is all she can remember. Her consciousness must have been faded out, or her memory erased. Janie told me this dream did not have the texture or feel of any dream she had ever had before. The only non-abductee she saw during the entire experience was the man outside the stage room. She saw no alien looking beings. Usually before someone is abducted, they will have a close sighting experience. Janie did meet that criteria. Janie had an encounter a few months back when my son Nate had asked her to come over to his house and hang out in his backyard with him to see if they could see any more shadow people. He had surprised 20 of them in his backyard the night before. After laying out on reclining lawn chairs for 4 hours, she finally saw one herself. The aliens must have picked up her mental frequency when they saw each other that night and had been looking for her ever since. When the aliens started scanning our neighborhood for likely abduction candidates, their computer must have recognized her mental frequency and they abducted her. This is hitting too close to home. In the home even. In April 2002 my seven-year-old granddaughter told me that she had been in the kitchen when my son had seen all the aliens in the back yard. Due to the excitement of my son and his wife seeing the aliens, none of us thought to ask her if she had seen anything. She told me she saw one of them follow her dad back inside the house through the back door without him realizing it, float through the kitchen right in front of her, and follow her dad down the

hall. Then she lost sight of it. I am still shaken that she was so close to all this.

The Psychological Aspects of Alien Abduction

I remember watching the television show The X-Files and seeing the wall of "Mulder's" office sporting a UFO poster with the statement "I want to believe" in bold letters. I think that it delineated a position that both abductees and non abductees are caught in. It is no secret that UFO and Abduction investigators are at times strongly divided-to the point of shouting or writing discrediting emails. There is always someone at the meeting who appears somewhat lost and may be an Abductee in need of support. People might be close friends at MUFON meetings and find that neither can agree on the abduction question. The Abductee might be torn apart emotionally from traumatic abduction experiences. Recently some abduction experiences have come to light where physical injuries are the result of the abduction encounter. A man in New York was so seriously harmed that he had to be hospitalized. Also there are those that believe in the "Space Brothers" and channeled Alien guides. The persons I am concerned with in this short commentary are those that feel or are victimized by encounters. If a man or woman is raped or assaulted in some manner there are immediate procedures that come into play.

Evidence is collected, legal representation is secured, and most importantly trauma counseling is initiated. The Abductee has none of these remedies unless they are fortunate enough to encounter a major researcher or active support group. If an Abductee were to call the Aurora, Thornton, or other community police agency about an abduction incident, they would promptly be escorted to mental health care. No evidence would be sought and great effort would be made to reorient the Abductee to reality. Obvious injuries would be suspected of being self inflicted and if found not to be, would probably be set aside or explained away. As you might surmise, I am painting the picture of a lonely and often tortured person. Their story is so "out of this world" that it cannot be casually told even to family members. Abductions are real and perhaps some are pleasant and transformative events, however the Ab-

THE SHAPE OF THINGS TO COME

MUFON International Director, John Schuessler, wrote an article in December's MUFON Journal about programmable matter. Speculatively, this is matter which could theoretically be "configured electronically to replicate the properties of any known atom and then can be changed, as fast as an electrical signal can travel, to have the properties of a different atom."

ductee who feels victimized as if he/she were being repeatedly abused needs our support. In fact we all need to support one another, as there are plenty of news reporters that are willing to report UFO sightings in connection with moonshine consumption. Abductees may at times be difficult to understand and there are a few persons in UFO groups that have that understanding and have the skill to offer needed support and referrals. These people are valuable and should be encouraged in their efforts to help abductees. Often abductees relate strongly to Holocaust stories because their treatment so closely parallels the abductees' life. The main aspect of connection is the loss of control over being victimized-the Jewish could not change their nationality nor can abductees stop being human research and resource subjects. Connection with caring people is a valuable commodity to the Abductee. It is my feeling that we should familiarize ourselves with abduction literature and make an effort to hear the abductees story. It may take a few moments of our time but can offer the feeling of community to the Abductee and the support so desperately needed. Perhaps in the future new methods of gathering evidence and proof of encounters will become more evident until then, I will whenever able listen and offer emotional support. The most important thing is not to retraumatize the person by asking insensitive questions or exposing them to more than two people at first investigation and most importantly protecting their privacy. Of course-I might just Want To Believe.
