BBC Enlists COMUFON Help on Bob White Documentary

This all began when I got an e-mail from Will Dixon (Researcher) from the Flame Television Production Ltd. in London, United Kingdom. He mentioned that he had contacted John Schuessler, and that John had suggested that he contact me, in regards to filming an episode for the TV series called:

"Jane Goldman Investigates". They would be coming to the Grand Junction area March 27th to reenact a UFO incident from the mid 1980s. The web site for this TV Series is: www.flametv.co.uk Re: The Program: It is a six-part second-season Living TV production. The writer and presenter Jane Goldman explores the mysterious world of the unexplained. Each episode presents an overview of the subject as well as focusing on Jane's investigation of specific current and archive cases. The show casts its net worldwide in the search for the most compelling occurrences of unexplained activity. Every week there will also be independent expert input to give a balanced view of the proceedings e.g. from academics involved in research into the phenomena. The series is non-judgmental and includes alternative points of view. Jane is open and curious to discover the truths behind the mysteries, whatever they may be. The programs have a natural style using hand held cameras, and they include reconstruction to illustrate some of the background stories and historical information.

Will Dixon from Flame TV wanted me to share any other UFO sightings that I might have learned about either past or present that had occurred in the Grand Junction area. I contacted 3 individuals to see if they would mind being interviewed.

In the mean time John Schuessler sent me a packet of information about Bob White in the mail. I was so very glad to get it as I had not heard anything about it. BOB WHITE: "Today is May 7, 1998. My name is Robert White. I live in Reeds Spring, MO. Over Ten years ago, a lady friend and I were driving to Las Vegas from Denver, Colorado. It was about 2 or 3:00 A.M. We were just west of Grand Junction when something very unusual happened. Jan was driving and I was napping. She woke me, asking me what is that bright orange light ahead of us? Since there was a railroad track on the north side of the highway, I told her it was just a railroad light, and resumed my nap. A while later, Jan woke me again and said, "that is no railroad light."

She was right. It was about the size of a full harvest moon. I decided to stay awake and watch this thing. As we got closer, it grew larger.

We were a few hundred yards from it, when I reached over and shut off the lights on the car. It was a very clear night and there were no other cars on the highway, so it was not dangerous to do so. When we were a few hundred feet from it, I turned off the ignition and we coasted up close to it. It turned out to be on the left side of the highway instead of the right side. It was huge, the size of a very big barn. I made Jan stop the car, which she did not want to do. She was terrified and shaking badly. "Let's keep going," she pleaded. I tried to assure her there was nothing to fear, after all this is just a bright light. I got out of the car on the passenger side and stepped in front of the car for a better look at this thing. For some unknown reason, Jan turned on the headlights, and this light went up in the sky as fast as my eyes could follow it. When it reached a great height, it either changed shape or connected to another light, which looked like two long, blue, tubular, neon lights, one on top of the other with a space in between them. Then I saw another small light, bright orange with a tinge of yellow, white and blue falling from it. For a minute I thought it was the same light coming back down. It came back down almost to where it started from. I did not see it hit the ground, because from where I was standing there was a small incline. I climbed the incline and went over to where I thought it might have hit. I found a groove in the ground about 18 inches deep and 9 inches wide. I followed the groove and there it lay.

I watched it for a while and it was still glowing. I walked back to the car, took the keys from the ignition, and opened the trunk to look for some gloves. There was one brown, cotton glove. I went back to the object and it was no longer glowing. I ran my hand over it and since I didn't feel any heat, I picked it up with the glove, carried it back to the car, and put it in the trunk. I have been told by Dr. Reiswick from Los Alamos National Laboratory, materials, science and technology division, who did the analization on it, this object is definitely extraterrestrial. I swear under oath this is a

true story.

On March 27 fellow MUFON member Gladie Bartels and I drove to Grand Junction to meet the TV crew at the Holiday Inn and Bill Merkel, MUFON member from Grand Junction. Shortly after arriving we also got to meet Bob White and his companions from the "Museum of the Unexplained" in Reeds Spring, Missouri. I don't know all the backgrounds of his companions except that one was a former NASA Scientist and Physicist and one other was a Physicist as well. So in a convoy of vehicles, with Bob and his group leading the way, followed by the TV crew, another vehicle with the sound man from Denver, then our van, followed by MUFON member John Blake, we proceeded out to the old highway going out NE of Grand Junction to Utah. Bob remembered that on the other side of road would have been a hill sloping up and he found the only two places that it could logically have been (it had been 15 years since he had been back to Grand Junction).

The second place was chosen as the location, and you could see in the distance, (probably a quarter of a mile or so), the Utah/Colorado state line. There was a stone monument there. Bob remembered being close to the state line when he and his companion experienced this UFO sighting. We watched the reenactment and interviews were filmed with Gladie, John and myself. We returned to Grand Junction, while the rest of them traveled further out into Utah to Cisco, which is where Bob stopped at a restaurant (now shut down) and called the Air Force from a telephone booth. They filmed the reenactment of this event as well.

The Air Force told Bob that they did not have an operation out there that night in the area that he described to them.

We were able to talk with Bob White and his companions and see and hold the object. When we asked if we could hold the object, Bob told us of course you can;.. it is yours, it is the worlds. Bob was very open and easy to talk with, and answered all our questions. The object looked heavier than it really was. It's shape and size consisted of a cone or tear drop shape, gray in color, about 9 inches long, 3 inches wide at one end and 1 inch at the other. It has a scaly,

feathery like appearance, see photo.

Several Analysis' have been conducted on it, one at Los Alamos Lab in New Mexico, that "Unsolved Mysteries" helped pay for.

Scientists have found that it is comprised 65% Aluminum, plus more than 30 other elements. The object has the consistency of

IN CASE YOU MISSED IT...

David Sereda spoke on April 10th at the monthly COMUFON general meeting. When David was 10 years old he witnessed a classic disc shaped UFO in Berkeley, California. David became an environmentalist who was bothered by the fact that the U.S. pays \$125 billion a year for foreign oil. Why couldn't that money stay here for research into alternative forms of energy?

He got involved researching Helium 3 fusion which converts charged particles directly into electricity. He was also interested in Bob Lazar's research into element 115. Davis theorized that wormholes would be physically and mathematically impossible to travel at great distances in space.

David got interested in how mass would be affected if moving at the speed of light. He discovered that mass vibrates in different frequencies and the higher the frequency the lighter

mass becomes. This could explain why UFOs are witnessed as light orbs or just "wink out."

He also found out from physicists that water comets (30 feet wide and traveling at 35,000 mph!) were impacting our atmosphere creating small amounts of ozone.

David has extensively researched NASA space shuttle video footage of a 12-mile tether that broke away from a shuttle mission in space and was then surrounded by disc and orb shaped UFOs for hours. He continues to do research on this UFO encounter.

aluminum, but the strength of steel. It has iron and more exotic elements like strontium europium and zirconium. So the mystery continues and so does the continued efforts in its analysis and study. An aluminum foundry was challenged to create one like it. They told Bob that he was crazy and that it can't be done. Bob White has taken 2-3 polygraph tests now and passed all of them. Including a new one he took in Grand Junction for FlameTV. We recently heard that Bob White may be coming back to Colorado soon to do another documentary with a TV company from California.

Following the reenactment the film crew interview the 3 of us (all MUFON members) about general sightings and personal UFO experiences. I told him about the sighting that had occurred over the Grand Valley near the Grand Junction airport the same morning as Tim Edward's sighting over Salida, Colorado. This UFO sighting was seen by two people running in the Redlands/Monument area. They observed a cylinder from which a couple of smaller half moon shaped objects ejected and flew rapidly into the Bookcliffs northeast of Grand Junction. As each of these hit there was a bright flash of light, but no sound was heard during the whole episode.

Gladie Bartels told about her sighting of a triangle shaped object that flew over their place south of Montrose, Colorado. John Blake, MUFON member from Glade Park shared his experience out near Moab where he hiked to a remote area to take photos of an Arch. 3 of his photos show something unusual that he didn't notice when he took them. One has a cylinder shaped object and 2 others show a beam of light. This took place in the afternoon on a sunny day. The photos are currently being analyzed.

Purple Haze UFO Videoed In Colorado

I was hoping to write a longer story on this mystery, room allowing, however room does not allow. There is too much great stuff going on to write about. This will have to serve as a teaser of more to come on this growing on-going investigation.

Ethan Rich, COMUFON Director of Investigations, gets me involved with video that is forwarded to us. As a videographer /movie maker hobbyist, I have some hardware and equipment which allows us to look at the video closer. In my first case the video was amazing! With analysis we were able to make out these craft had tail feathers. Then I found wings. These turned out to be ducks, but I didn't have to wait long to get more mysterious video to look at.

In October of 2003 we were contacted by a very cooperative and enthusiastic witness that had video taped something that looked like a bright star. However, it fluttered strangely and somehow had a bluish haze around it at times. The witness had made friends and family aware of the object, and many of them saw it as well.

Soon after that, Phil Tori, COMUFON member and experimenter, brought in video he had taken on two separate occasions of something he though looked very similar. Phil's video definitely showed a bright fluttery object. He said it changed colors, it had a bluish/reddish, purplish haze, and it continually changed colors. His first video was taken in Michigan in 1994, the second was here in CO last October in 2003.

Finally, Ethan brought in the most interesting video of all, shot near Deertrail, CO. It is a seeming close up of the object(s) we had seen in the prior videos. Unfortunately, we will not be able to continue interviewing this witness, he passed away this past Easter Sunday. We are very grateful he shared this information with us, and we wish his family our warmest condolences.



A brand new update is that the local FOX station, KDVR, is interested in the Deertrail video also. In fact Ethan was interviewed by reporter Kim Posey today, and I am scheduled to be interviewed tomorrow. On top of that, Ethan and Davina say they have received even more videos!

We will report more on this case in future newsletters, and videos and stills will be displayed at the MUFON Symposium in July.
