IN CASE YOU MISSED IT.....Joe Fex

Comufon's featured November speaker was paranormal and Bigfoot researcher Joe Fex.. Joe is a pioneering researcher who maintains an archival library brimming with many rare artifacts, photos and publications. He feels the general public needs to change its approach and perspective of the unusual.. ie. UFOs, Bigfoot.....

Joe began speaking about how in biblical times alleged UFOs were described as "columns of fire." In 1887, a family of nine in South America heard a loud buzzing sound and witnessed a bright white light. Several days later the family starting experiencing vomiting, hair loss and blackening of the skin; symptoms of a large dose of radiation. What technology was available in 1887 to cause this life-threatening situation?

An 1814 British publication tells the story of a man in England walking home from the town of Poland when he saw two brightly lit objects in the sky that surrounded his chest with bands of light. He then heard a booming voice that said, "Are you prepared to die?" He was dead nine days later.

Joe also displayed rare and early photos of UFOs. One photo from New Hampshire in 1870 showed an unusual phenomenon known as a "mountain of frost" with a rectangular black object hovering in front of the mountain

November Meeting UFO Investigation Updates

At the November COMUFON meeting, Ethan Rich, COMUFON Director of Investigations, arranged updates on some current investigations. A few investigators took a weekend to go to Longmont to interview witnesses out there. Newly certified investigator, Randy VanLandingham, briefed the attendees.

The first witness had seen orbs on October 9th at around 5:30 PM. The witness was in his late 60's, and reported his son

had also seen the objects. His son is in his early 30's. They say they saw spherical objects in the sky. They were moving, but there was no order in their movement. They asked an elderly man that lives across the street if he had seen them. He said he did. They also saw some kids down the street. They asked the kids if they saw them, but the kids joked around about it. However

when they did look, they did see the objects. There were 20 or so spheres that the witness and his son watched for 45 minutes until they lost interest and went back inside.

The second witness had their sighting in early September in a subdivision. Above him he could see a rectangular object. It had two rows of four lights running down the middle. They didn't seem to be emitting light, but glowing. It was about dusk, so he couldn't completely make it out, but the side seemed to have wings of some sort. The witness said if he put his thumb over it, it would have only covered half. It moved slowly from the west to the east.

The *MUFON Field Investigators Manual* is available from MUFON HQ for \$25. It is essential for taking the exam, and is an invaluable reference tool in conducting field investigations. hundreds of feet in the air. Another photo from the 1920s in France showed a beautiful sprawling chateau with a clearly shaped disc object hovering above and behind it. There was also a photo from Admiral Byrd's Antarctica expedition party in "Little America" showing two hovering disc shaped objects with lit portals. A rare 1920s German photo showed a fireworks display with a large rectangular brightly lit object floating about 500 feet up. Maybe aliens like cool fireworks too.

Joe's other area of expertise is Bigfoot research. He is arranging an expedition to eastern Tennessee in the spring of 2005 to observe what appears to be a Bigfoot tribe. When Joe was last there he witnessed several Bigfoot sightings. The local family in the area had named two of the beings; Fox and a 12' to 14' Bigfoot named Canunea. Joe believes these beings have been around as long as man and have their own language and may be telepathic. He also believes they are being abducted by aliens just like humans, experiencing the same pain, frustration and humiliation. Every U.S. state has had a Bigfoot sighting except Rhode Island and Hawaii.

Is Bigfoot slowly making themselves known to man?

IN CASE YOU MISSED IT.....Jim Frazier

COMUFON held its September monthly meeting on the western slope in the city of Montrose. Guest speaker, Jim Frazier, a former newspaper reporter and editor and now investigative journalist and video documentary producer, spoke about his new book, "Transformation of a Common Man: The Brian Scott Story." Brian's unusual journey began with seeing an unusual orange ball of light in the sky then lost two unexplained hours of time. The story continues with Brian going down to South America to complete his transformation in an Incan Temple. This was known as "Quantum Evolution to mind level 8." An alien race, the Nordics, explained to Brian that transformation of a man has happened nine times before throughout history. Another alien race, the Grays, along with the Nordics had worked together with the Incas to help them achieve enlightenment. But now the Grays want to meddle and intervene with the progression of human-

kind. However, the Nordics negotiated with the U.S. government to put the Grays on "hold" with their intervention. Allegedly the Grays conceded to stop meddling as long as humankind transformed to enlightenment by December 24th 2011.

To prove that humankind can develop technologically, Brian built a machine called the Neural-Optical-Responder. This involved the developmental use of neurological and optical collusion. As a result, in 1980, Brian was commended for this technology by then President Jimmy Carter in the White House. According to Jim Frazier's book, there appears to be a race against time for humankind to psychologically and technologically develop to "mind level 8" before the Gray's intervene for purposes of their own.

This strange and unusual story continues to unfold. Frazier has completed a screenplay concerning these events and is looking to produce a documentary.

The third witness saw a light in the sky in late September. She couldn't tell how large it was, but felt it was very large. She also felt she had a telepathic connection, and had the impression that she might have communicated with beings. She was hesitant to talk about it, so she was referred to a hypnotherapist. She saw the object for 30 minutes it moved slowly from the east to the west, at around 6 or 7 PM.

Ethan then presented some video. The first was from a man in Minturn. It was a round bright object that changed colors quickly. The next video was taken by another new investigator, Stace Von Tussell. She had previously reported seeing shiny orbs flying around high in the sky above her home in Denver. She recently was also able to get some video tape. In one tape there is a stationary bright point of light high in the clear daytime sky. A jet flies through the screen, and the con trail passes over the object. It did appear at first glance that the object was behind the con trail and much higher. In a second video there are a few faint objects, and then a brighter one moves across the screen. Ethan also reports seeing similar objects in his home in Denver. Ethan is still in the process of getting these and other videos looked at more closely, and all of these reports are still being put together and researched.
