



CLOSE ENCOUNTERS OF A GOVERNMENT KIND

Ever since they went "public" in 1969 with their claims of contact with extraterrestrial beings, Betty and Bob Luca of Higganum believe

they have been victims of a concerted government campaign of harassment because of their interest in UFO phenomena.

Robert and Betty Luca hardly seem the sort of people to be of interest to eerie alien spacecraft, not to mention earth-launched, but equally ominous, black helicopters. The couple live in a trailer park on a rural hillside in Higganum. Bob, 49, works as an auto technician in Middletown. Betty, 51, is a free-lance artist.

Indeed, the Lucases appear to be just plain folks, nice, average, down-to-earth middle Americans, who just happen to have had, they claim, numerous close encounters with UFOs and extraterrestrial beings.

It was back in January 1967 when Betty, then living in South Ashburnham, Mass., with her first husband and their seven young children, was taken on board a spacecraft by pint-sized aliens who subjected her to a physical examination, then brought her back to her home. For years, she "consciously" remembered only a fraction of the strange encounter; then in 1977, after reading a local newspaper story about UFO researcher Dr. J. Arlen Hynek, Betty got in touch with the doctor and subsequently underwent lengthy hypnotic regression sessions with a team of UFO investigators during which she relived her adventure in detail. The next year, Raymond Fowler's *The Andreasson Affair* (Andreasson was Betty's former married name) was published, chronicling the story of her encounter with UFO occupants.

Betty married Bob that August and the couple moved to Meriden; soon after, strange things began happening to them—lights blinked on and off in their home, rappings began to sound from the cellar, a man's featureless head popped around the side of the kitchen door.

Then there were the black helicopters. Betty had spotted the first one hovering over her South Ashburnham home shortly after the 1967 close encounter. Twelve years later, as she and Bob were making plans for a publicity tour for their new book, they were becoming a regular occurrence. Bob, who was working toward obtaining a pilot's license at the time, recognized that the copters were flying below the 500-foot limit. "Otherwise I wouldn't have bothered with them," he

says. "Then I saw that they had no markings, which is illegal."

Besides breaking the law, the hovering craft, which looked like military Huey UH-1Hs, were downright spooky-looking. "These things are totally black and the windows are tinted so dark that you can't see through them," says Bob. The whirlybirds followed the couple when they moved to Cheshire and later to Higganum, although they "have not been as bad" at their present residence, according to Betty. The copters have even shadowed them while they've been driving or camping, including once at Hammonasset Beach.

In a four-year period Bob took over 200 photographs of the mysterious craft. He contacted the Federal Aviation Administration, the Aircraft Owners and Pilots Association, the Connecticut National Guard, the Air Force, the F.B.I. and the C.I.A.—anyone he could think of who might be able to identify them. No one, however, could tell him who was flying them. "Now come on, that's a little ridiculous," says Bob.

There was one Federal Aviation official who took a fleeting interest in the Lucases' reports. A Sam Martino, whom Bob spoke with on the phone and wrote to in late 1979, showed up at the Lucases' Cheshire home one Saturday morning and, finding no one home, left a note. When Bob tried to call Martino again at his FAA office in Westfield, Mass., he was told that he no longer worked there.

When located in Suffield, where he now lives, Martino said he "vaguely" recalled the case. "It would be unusual for a helicopter not to have markings," he says. "But I'm sure it had markings. They were probably indistinguishable from where [Luca] was, or maybe the light was bad or whatever." Martino says that he retired from the FAA in August 1980, eight months after Bob first filed his complaint.

The black choppers are just the most obvious examples of what the Lucases believe is a concerted government campaign of harassment because of their interest in UFO phenomena. The couple also say that their mail has been opened

and resealed, that their telephone has been tapped, and that they have been watched by individuals in cars and on foot.


"Up until last year I have no doubt that our phone was tapped," says Bob. "I bought a device that is supposed to detect a tap, and it lit up for our phone but for none of the others I tested it on." Betty adds, "Once I picked it up to make an outgoing call and a voice on the other end said 'director's office.' I asked 'director of what?' and the person got all excited and said, 'Oh, I'm sorry,' and hung up."

Then there is the incident of the faithful watchdog that failed to bark. The Lucases asked the phone company to send someone out to check their telephone for a tap. "The repair guy who showed up couldn't even get the mouthpiece off," Bob recalls. "He told us, 'This phone is tight, nobody's been in here,' and left. It was a joke, because a tap can be anywhere on the line, not just in the receiver." What wasn't so funny to the Lucases was the fact that their dog, who barked at everybody, behaved as if he had already made the acquaintance of the perfunctory repairman.

On another occasion, while he was planting grass, Bob noticed planks high up in a pine tree in front of the house. The makeshift observation deck, which Luca took down, seemed ideal for someone to keep watch over the Lucases.

"Sometimes you get a little paranoid," admits Bob as he relates such incidents. "There are so many things that could be coincidences, but none of this stuff happened before the book was published. There have been too many coincidences to be just coincidences."

One of these was not a trifling matter. Shortly after the Lucases hit the talk-show circuit ("Good Morning America," "The Mike Douglas Show," et cetera) with *The Andreasson Affair*, they were informed that the Internal Revenue Service had scheduled an audit. A few years later, the IRS would audit the Lucases' taxes again. Both times the Lucases were assessed extra taxes.



Again, it could be coincidence, it could be paranoia. Lots of people, after all, undergo tax audits (even twice), have problems with their phone and mail, or are bothered occasionally by peeping Toms. But one thing is clear, as Bob's photographs will attest: The black helicopters are real. These earthly craft have taken a most peculiar interest in the Lucas wherever they happen to be. And the various government agencies that have been contacted about the illegal visitations seem to have no interest in helping solve the mystery.

When the Lucas first moved into their home on Draper Avenue in Meriden, Judith and Jim Niland made a point of welcoming their new next-door neighbors. Both families had teen-agers who quickly became good friends. "They seemed like such regular people," recalls Judith Niland, a member of the Meriden City Council. The Lucas, however, would prove to be anything but ordinary neighbors.

Just before the publication of *The Andreasson Affair*, the Lucas decided they'd better have the Nilands over for a chat. They told them about the upcoming book and their UFO experiences and said it might cause a stir, perhaps even attract some "thrill seekers" to sedate Draper Avenue. This was news to the Nilands: They were dumbfounded. "We knew nothing whatsoever about this. I had never heard anything like this before from anybody," says Judith. "And I have to tell you, my husband and I sat there for two hours with our mouths wide open. It was almost like a joke. Up to that point, they were such sincere, such *regular* people."

The Nilands walked home in silence. It all seemed so preposterous—all, that is, except the part about the black helicopters. "When they talked about the helicopters, I said, 'You know, I *have* noticed an awful lot of helicopter activity lately,'" Judith recalls. "Our houses were old, so I noticed it because the windows would really rattle because they were hovering very low—very, very low."

The Lucas asked Judith if she would keep a log of the times when helicopters flew over, what their direction was and the like. She agreed. "The activity was continuous, all the time they lived there," she says of her records (which she has since thrown away). "Every single day there was some kind of helicopter activity overhead."

The Nilands never reported the helicopters to anyone, but they did sign a statement attesting to their observations that Bob included with his various letters of inquiry. "It didn't bother me, I didn't feel threatened by it," says Judith. "To tell you the truth, I thought it was kind of interesting."

Interesting indeed was the conspicuousness of the copters. Discretion was certainly not high on their agenda. One day in March '79, Judith was sitting at her kitchen table having a cup of coffee, when she heard a terrible commotion. "It was probably around 8:00 in the morning. It was a bright sunny day and all of a sudden I heard it. The noise was not like a regular helicopter passing overhead, because it was so low. I got up and walked out onto the sun porch and thought to myself, 'I don't believe this.'

"It was right there—it couldn't have been flying any lower or it would have hit the trees," she continues. "This all-black helicopter was flying right down the street, heading north. It didn't have one marking on it. And it was going so slow past our houses. I looked next door and Betty was standing outside watching it,

too."

In September of that year, the Lucas moved from Meriden to Cheshire. Judith says she was sad to see the family leave Draper Avenue, but not the helicopters. "When Betty and Bob moved, the helicopters stopped coming over—they just stopped."

One explanation for their disappearance from Meriden is that black helicopters were soon appearing over the Lucas' Spring Street home in Cheshire, as well as over Johnson Publishing, where Betty worked as an enumerator. "We had black helicopters come over here every day that Betty worked here," recalls her former supervisor, Donna Braman. "They were just plain black, with no markings, and after she left, they stopped flying over."

Braman also backs up Betty's claim that her phone at work was continually acting up. "She did have problems that none of the other girls in the office had," says Braman. When Bob used his tap-detecting device on Betty's office phone it showed the phone was being monitored. It was the only phone in the office that registered a tap on the line.

One of the more puzzling incidents that occurred while Betty was at Johnson involved a company salesman who called in an order from Massachusetts and somehow reached the main switchboard at the Pentagon. They asked what they could do for him and he hung up quickly. This curious occurrence may well be no more sinister than a misdialed number. (The area code for the nation's capital is 202 and Connecticut's is 203; if 202 plus the Cheshire firm's phone number are dialed, the Army Corps of Engineers at the Pentagon will answer.) The main number for the Pentagon, however, bears no resemblance to that of Johnson Publishing (all seven digits are different), and the salesman had called the office number hundreds of times.

Then there was the night in early 1984 when the Lucas left for a vacation in Florida in their mobile home—in the dead of night, telling few people they were going. A week after their departure, several men showed up at Bob's workplace, Middletown Toyota, making inquiries about their whereabouts.

Chip Hinrichs, a mechanic at the dealership, remembers the men well. "Two guys showed up one day about a week after Bob had left and asked where he was," he recalls. "They said they were with the government and needed to know where he'd gone to. I told them he'd left—that's all. I didn't think it was any of their business where he was. They were two very well-dressed gentlemen."

Jim Tomaino, a former Middletown Toyota employee who now lives in Vermont, was also approached by the two men. "It seems to me someone—and I can't give you any details—someone did inquire about where Luca was, but that's the extent of what I know about it," he says. "I was new there at the time and I had to refer them to someone else. As far as who they were and where they came from, I have no idea."

The Lucas feel they do know who is keeping tabs on them and why. The government, they believe, is deeply concerned about the national security implications of UFOs: They can violate American airspace at will and monitor sensitive military installations with impunity. Despite official protestations to the contrary, the Lucas say Uncle Sam a confirmed believer in extraterrestrial visitors and wants to find out all he can about them from people who have had "close encounters."

According to this theory, held by many "UFOlogists," our nation's leaders in Washington want the public to believe that "flying saucers" are fanciful, yet at the same time, various government agencies are secretly seeking to learn all they can about alien spacecraft, including clues to their advanced technology that may be of use to our military.

To bolster his claim, Bob points to numerous documents he has collected through the Freedom of Information Act from the Air Force, the C.I.A. and other agencies attesting to repeated sightings by military personnel of UFOs over highly restricted facilities like Loring Air Force Base in Maine (where nuclear weapons are stored) and Los Alamos, N.M. One of the documents describes an unearthly craft that in the fall of 1975 was "demonstrating clear intent in the weapons storage area" at Loring AFB.

"The government may be trying to intimidate us, or they may be trying to gather information on who we talk to about UFO phenomena," Bob theorizes. "They investigate UFO sightings and related phenomena with our tax money and then play God and decide they can't tell us what they know." Betty adds, "I'd say we have more to fear from our own government than from any alien force from space, but I don't feel afraid. I feel God is watching over us. The information has to come out on UFOs for the benefit of mankind, regardless of who is against you—the C.I.A., the F.B.I. or whoever."

The Big Brother intimidation theory rests on the assumption that the government wants to scare people like the Lucas into leaving the investigation of UFOs up to Washington. If that's the case, it doesn't seem to be working. The Lucas continue to appear on radio and television shows speaking out on their pet subject, and Bob subscribes to a UFO clip service which gathers newspaper accounts of sightings from all over the country. He then tries to obtain government documents on the specific instances. "I'll take every opportunity I can get to challenge the government on their involvement," he says. The couple are also "working on a case which may produce physical evidence connecting the black helicopters with the UFO phenomena," and plan to publish a third book.

Larry Fawcett of Coventry, who saw black helicopters over the Lucas' Cheshire home "many, many times," believes their purpose is some sort of surveillance. A lieutenant with the Coventry Police Department, a veteran UFO investigator and author on the side, Fawcett helped the Lucas try to identify the mysterious aircraft. "When we sent the photographs Bob took to the Federal Aviation Administration, they admitted that the helicopters were unmarked and flying too low—both violations of law," he says. "But the FAA made no attempt to assist us in identifying them—I think they knew what they were."

Raymond Fowler, author of *The Andreasson Affair* and its sequel, *The Andreasson Affair, Phase Two*, admits, "There is a very fine line between paranoia and what really may be going on." (Oddly enough, the phone interview for this article was punctuated with clicking sounds, and at one point the connection was broken off completely.) But Fowler, who spent decades working on nuclear weapons systems at Stamford-based GTE Corp. until his retirement two years ago, is convinced that the Lucas are on the level. "One of the reasons people like Betty and Bob are being harassed this way is so they will go public with their stories about it and look foolish as a result," he says. "By not admitting publicly that UFOs do, in fact, exist or that the government is surveilling people like the Lucas, it has promoted the notion that people who see flying saucers are wackos."

Bob Luca agrees with Fowler on that point. "Because of the policy of our government, people like my wife and I are made to look like liars or fools," he says. "I don't like looking that way because we have told nothing but the truth. When the government states publicly that UFOs don't exist, how could we have seen them? But the government's own private documents report and analyze UFO sightings, and UFO activity is considered a threat to national security by Washington."

"A lot of people have suffered because of our government," agrees Betty. "It's an awful ego trip by man to think we're the only life forms in the universe. There are 100 billion suns in the Milky Way alone. Numerical odds dictate that there is life out there."

Bob and Betty Luca plan to continue their efforts to publicize UFO phenomena despite what they believe is serious governmental disapproval of such activity. "When the government started this cover-up in the 1940s, they may have felt that they were preventing a panic from breaking out as it did when Orson Welles broadcast his 'War of the Worlds' radio show," says Bob. "But today I don't think people are going to panic. I think it's unfair for Washington to treat the public like little children."

Still, Bob believes the government is not playing a child's game. "I had a talk once with someone who was retired from Air Force Intelligence...he wouldn't want his name disclosed—that's a bad thing about a lot of this. Anyway, he said that this UFO thing is a big puzzle, and that if you get enough of it together to become a threat, the government will get rid of you."

It sounds a little extreme, to be sure, and there is absolutely no proof of such intent on the government's part. A watchdog that fails to bark at a telephone repairman is the sort of evidence that is

meaningful only to fictional sleuths like Sherlock Holmes. But it should be understood that the Lucas are not the only people pondering what's in the stars.

And what if UFOs are extraterrestrial craft? What are the implications of this possibility? A National Security Agency report, "UFO Hypotheses and Survival Questions," written in 1968 and released under the Freedom of Information Act a decade later, provides an unsettling answer: "If 'they' discover you, it is an old but hardly invalid rule of thumb, 'they' are your technological superiors. Human history has shown us time and again the tragic results of a confrontation between a technologically superior civilization and a technologically inferior people." □

Copter Search Without a Warrant Is Upheld

WASHINGTON, Jan. 23 — The Supreme Court ruled today that the police do not need a search warrant to conduct low-altitude helicopter searches of private property.

The 5-to-4 decision allowed Florida prosecutors to use evidence garnered by a police helicopter that flew 400 feet over a greenhouse in which marijuana plants were visible through a partly dismantled roof. The ruling overturned a decision by the Florida Supreme Court, which had held that the flight was an unconstitutional search.

The decision today was an extension of a ruling three years ago, in which the Justices permitted a warrantless search by an airplane flying at 1,000 feet. The rationale then was that since aircraft commonly fly over private property at such altitudes, no one could reasonably expect property visible to the unaided eye from such a flight to remain shielded from view.

Since low-level helicopter flights are a less common occurrence, the question for the Court today was whether a landowner could reasonably expect privacy from that type of aerial intrusion.

No Majority on Rationale.

While five Justices agreed that the flight was constitutionally permissible, there was no majority agreement on a rationale.

Justice Byron R. White, in a plurality opinion joined by Chief Justice William H. Rehnquist and Justices Antonin Scalia and Anthony M. Kennedy, relied primarily on the fact that the flight was within the airspace legally available to helicopters under Federal regulations.

While fixed-wing aircraft may generally fly no lower than 500 feet, there are no lower limits for helicopters. "There is no indication that such flights are unheard of in Pasco County, Fla.," Justice White said. He also noted that the flight had revealed "no intimate details" of life on the property.

In a separate opinion, Justice Sandra Day O'Connor agreed that the search was constitutional but said Justice White's opinion placed too much emphasis on the fact that the helicopter was in legal airspace. Flights at lower altitudes than the 400 feet in this case, she said, "may be sufficiently rare that police surveillance from such altitudes would violate reasonable expectations of privacy despite compliance with F.A.A. air safety regulations."

In a dissenting opinion, Justice William J. Brennan said that under the plurality's approach, "the expectation of privacy is defeated if a single member of the public could conceivably position herself to see into the area in question without doing anything illegal." He said there was a "lack of any meaningful limit" to the type of search the opinion would authorize.

Space clutter worries NASA planners

NASA is trying to find out how littered space actually is, according to the Washington Times. The space agency is worried about what small pieces of orbiting space junk might do to its proposed 176-ton space station. In order to detect space debris, NASA is proposing a land-based radar that could detect debris as small as one centimeter orbiting between 180 and 360 miles above Earth. There could be as many as 20,000 to 60,000 small fragments orbiting in that band, according to NASA. Small debris in space has already caused some damage. Launched in 1984, a satellite had 3,000 craters from collisions with micron-sized paint chips. A paint chip struck the cockpit of the shuttle Challenger on an earlier mission and the windshield had to be replaced.

Soviet space probe now orbiting Mars

The Soviet Union has put its Phobos 2 spacecraft into Mars orbit, and its two landers will descend to Phobos in April, according to Aviation Week & Space Technology. U.S. team members are to participate in the Phobos 2 science operations. The only approved U.S. Mars flight is the Mars Observer spacecraft scheduled for launch in 1992. The NASA Deep Space Tracking Network provided the Soviet Union with data to assist in the final targeting for Phobos 2.

BIG MAMA

Towards, Mars, there exists a huge space station 20,000,000 miles out! It exists off of space. It feeds off the natural free energy forces.

In space, a space scoop would exist in travel for billions of miles. The amount of raw energy for power and anti-matter power would be endless and limitless.

This huge base station has been nicknamed by the Soviets as "Big Mama!" and operates on particles and rays in space.

20 -30 -45,000,000 miles towards Mars, "Big Mama" at that distance the solar flux is at 1360 W/m², and conventional logic of producing "Big Mama's" fuel would be to produce 10¹⁹ antiprotons a second, and a gram of antimatter every 24 hours and at 100 TW (terawatts) production.

I feel "Big Mama" operates a little differently with "antimatter propulsion systems" than its secondary sized crafts from Mars and "Big Mama" and Earth.

Big Mama would be in a more suitable position for natural production of energy.

Large crafts would operate just as well with high energy lasers and the production of anti-protons, by high intensity lasers by strong electric fields generated by focused CO₂ LASER BEAMS with intensities of 10¹⁷ w/cm² produce proton -anti-proton pairs. Both large crafts, and scout ships would operate as particle beam ships with power lasers, and inertial fusion mechanics.

Another Soviet concept is even out further, is yet another "Big Mama". It is larger because it is the central space-station for

our solar system. It has a larger role function.

Mars (Big Mama) is concerned about Earth, Mars and our Moon, and is located in our blindspot. Space, deep space, would provide a more natural basis for a space scoop!

(Scout ship S-1-4 type) drives on anti-matter, (as propulsion) which is a highly concentrated form of energy storage and with a specific energy density of $9 \times 10^{16} \text{ J/Kg}$!

S-1-4 type scout ship drives on antimatter as a propulsion system and the antimatter is in the form of antiprotons, antihydrogen particles that interact with the kinetic energy to be transferred to the S-1-4 type craft and also to the working plasma fluid to obtain thrust for movement! For optimum operation (antiprotons and antihydrogen particles) would be utilized to heat a much larger amount of reaction mass (S-1-4 type) in transit at earth's speed. Inside the CRAFTS center, the operation of magnetics with re-entry plasmas in its disk center circumference gives off various colors!



Thus anti-gravity systems allow operations of acceleration and deceleration

Space alien invasion only 3 years away, says top UFO expert

A Kansas housewife who claims to meet with space aliens almost every day says the creatures will soon reveal themselves in public for everyone to see!

And a top UFO researcher, who is also a medical doctor, says the meetings between the aliens and homemaker Donna Butts, 36, of Russell, Kans., are for real.

She says a space creature named Cephis first appeared

in her basement four years ago in 1984.

tioner and UFO researcher from Ottawa, Kans., has interviewed the woman extensively.


And he is convinced that she is telling the truth about her UFO experiences.

BELIEVER — Dr. Scott Corder supports the bizarre claim of Kansas housewife Donna Butts.


"Right now the aliens are giving us information which we send to prominent doctors, scientists and government officials around the world," she continued. "I can't reveal the nature of the information at this time.

I still have not found a person qualified to "regress" me to get to the origin of my scar. I know when the time is right — I'll be enlightened.





To prove its validity will take research. Some people can never have enough proof and therefore remain dissenters while the rest of us are off onto new investigations leaving the dissenters in the proverbial dust.

The following article is taken from the last "The UFO Enigma", Volume 9, Number 3, November 1988 published by the UFO Study Group of Greater St. Louis, Inc. The specific article is entitled:

UFO STUDY GROUP HEAR LATEST FROM CENTRAL STATES MUFON DIRECTOR
By Ken Hanke

(An annotated version)

Following the video tape, George and Shirley Coyne treated members to some of their fascinating experiences and insights in the UFO area. George told us that the Gulf Breeze subject has taken a total of 61 photographs from November 11 through May 1, 1988. Many of the sightings and "photo sessions" have been correlated with sightings by other Gulf Breeze residents. Bruce Macabee, an optical physicist for the Navy has found no photo evidence of any fraud. Other photo analysts have also subjected these photos to computer enhancement and every trick in the trade without finding any evidence of double exposure or other tampering.

There seems to be evidence of a number of abductions in the Gulf Breeze community. George indicated that "Mr. Ed" has been abducted at least 4 times in 8 year increments at age 17, 25, 33 and 41.

George Coyne told the Study Group of a sighting over Lake Erie off of Cleveland, Ohio. On March 4, 1988, a 1500 foot craft appeared over the ice on Lake Erie. Several hundred people saw the craft and 35 formal reports are under investigation. The craft hovered just over the ice about a quarter mile off shore. Several smaller, triangular shaped craft came out of the craft and started darting around including on shore. The U.S. Coast Guard was called and dispatched three personnel to the beach opposite the craft. The triangular shaped craft started darting at the Coast Guard people who retreated behind some sand dunes.

The large craft eventually set down on, and went through, the ice. When the Coast Guard called nearby Wright-Patterson Air Force base, they were told in effect to "lay off - don't investigate any further." As a result, MUFON has the original copy of the Coast Guard report. Interestingly, all newspaper reports in the Cleveland area were quashed completely. They could not report anything on this event. It was noted that 75 percent of all reports in recent times are over, on or under the water.

George indicated that MUFON and UFO investigations in general are moving into a new era. He believes that we are soon coming to a time when the government is going to come out and tell the public some of what is going on.

The Coynes, themselves, have had some interesting experiences. In August, 1973 at the Coynes home near Flushing, Michigan, they had 6 sightings within 100 feet of them. One night at 1:30 a.m. while driving home, two huge beams of light came slowly at the Coynes and followed them part of the way home. A week later, George's doctor called to tell him that his cardiac pace maker was stopped and needed to be restarted (all over the phone).

Again in 1986, the Coyne's had a sighting one night, three small yellowish orange balls passed them. Again, George's pace maker was affected and had to be reset.

George Coyne cited evidence that the United States government is vitally interested in UFOs and those people actively pursuing them. On January 9, 1988, the Coyne's called a hypnotist and a suspected abduction subject inviting them to the Coyne house for a hypnosis session. The session was scheduled for 10:00 a.m., the next day. During that session, a black, military, HU-1 helicopter appeared and hovered around their house, some 30 feet above the ground. The helicopter kept facing the Coyne house. At that time, the tape recorder the Coyne's were using to record the session suddenly malfunctioned. The Coyne's have found out from various sources that the government has both a telephone tap and a tracer which indicates the phone numbers in contact with the Coyne's.

This helicopter is all black with dark tinted glass and no markings other than a small insignia which Mr. Coyne declined to describe. On March 25, 1988, the same helicopter followed the Coyne's in their car for 90 minutes while on a trip to Indiana. Again on May 15 of this year on their way to Lansing, Michigan to a MUFON meeting the same black helicopter followed them. After the meeting began, the helicopter was reported to be circling the meeting place. Everyone at the meeting saw the craft. Because this MUFON organization video tapes all of its meetings, footage of this helicopter maneuvering around the meeting place was taken. The big black helicopter is not above harassing people in the middle of the night. On August 1 at 2:20 a.m. the helicopter awoke the Coyne's by buzzing their house.

George believes that the government is trying to send a message to certain active UFO investigators that the government is monitoring them and is aware of what is going on with UFOs. The government cover-up continues.

Shirley Coyne's UFO experiences go all the way back to 1949 as a child on an Arkansas cotton farm. This experience involved her entire family. She was awakened by her mother shooting at three small alien beings. She then discovered two beings in her bedroom. The next thing Shirley knew, she was being escorted out of her house - through walls and doors - and into an alien craft. As Shirley was going through the house, all of her family members and guard dogs were frozen in place. The experience inside of the craft is now familiar to many who have been abducted. This included an examination which included a tissue biopsy being taken which left a scar which remains today.

Under hypnosis, it seems that Shirley has had a series of such encounters at age 5, 9, 16, 17, 20 and beyond. The Michigan MUFON organization is currently working on 42 different abductee cases. Their 5 hypnotherapists, a psychiatrist and a registered nurse are working hard to catch up with the back log.

Shirley was told by the aliens that they were doing genetic experiments because the aliens had lost some of their natural abilities and were trying to recover them with some genetic infusion from humans.

Dear Aileen:

The reason I have decided to go public now, after all this silence is because I have been told it is time.

During the past year I have written 4-500 pages of daily journal material on my contacts, machine construction, dreams, alien encounters. I also have several very unusual photos of what I believe are UFOs I am willing to release.

There is a time for everything - an activation point for every individual. I am now being told to relay what I know to the public. I first considered publishing a book, but it's better if I get this out slowly, piece by piece so it can be absorbed in a proper way. Then perhaps by the time "Communion" and "Intruders" are released in the theaters, I will pursue this avenue. This is up to my friends.

On June 5, 1988 at 11:30 p.m. I had a sighting of a UFO from my apartment. It was traveling over Sunset Beach between two buildings. The craft was circular in shape with 10 central flashing, rotating, red, white and green lights. From the bottom, the UFO emitted bright bolts of colored electrical lightning flashes, one of which temporarily blinded me for 1 or 2 seconds. Throughout that same night I had dreams of symbols and machines and the next day I began constructing a signaling device. Since that time until now, I have been experimenting with electrical communication devices, using Xenon tubes, infrared light and various symbols received telepathically, or in my dreams. I have discovered a means to communicate with them using electronics, telepathy, and a special combination of vitamins and amino acids.

In future issues, I will give this information to the public, so everyone will be able to contact these beings. Only one catch. The machines work only once. Then you either have to construct a completely different one or improve on it.

By the way, there are 20 amino acids per peptide. Each peptide carries a message in the brain. This is why the UFO was flashing 20 lights at me. They were replacing peptides with light flashes and communicating directly with the neural pathways of my brain, giving me symbols, messages and sentences at high speed. But more on this in a future issue.

Another recent sighting in October was in Fresno, California, specifically in the San Joaquin Valley. There are 3 municipal airfields in that area and if you remove the "F" from Fresno, and rearrange the letters, you have the name Orsen!?! There is also, a Wildlife Reserve nearby. The Wildlife reserve is the only similarity I could find to the Aboriginal Reserve near Eucla and Ceduna. Also, there is a San Joaquin in Bolivia and Paraguay. Perhaps an important event is yet to occur in one of these countries! NOTE: The word Fresno, means ash in Spanish.

It turns out that Halloween 1988 is the 50th anniversary of Orsen Wells, War of the Worlds (done at Grover Mills). Grover Mills is located (see map) beside the James Forrestal Research Center at Princeton University which has (see paper attached) a

proton beam nuclear accelerator and space research using plasma physics.

In July of 1987, air raid sirens were triggered by bolts of lightning and traffic lights were shut down across the lower mainland of Vancouver, British Columbia, Canada. During the same month a hydro transformer blew on the weekend and the airport was practically shut down, cancelling flights. Only July 14, a brilliant daylight fireball was seen in the Vancouver skies by several witnesses. Astronomer David Dodge of the Gordon Southam Observatory appealed in the newspapers for more information from the public.

In August and September, there were more major power outages in the Vancouver and outlying suburban areas, one of which blacked out thousands of people at a major National Exhibition after a loud bang.

In August and September there were many sightings by groups of people in the town of Hatzic, a riverside hamlet, east of Mission, British Columbia, not too far from Vancouver. It became so intense that the newspapers did several articles, interviewing witnesses, one of which was a police officer who was "dazzled by a UFO."

Shortly after, in early October of 1987, there was a major, near disastrous earthquake in the Los Angeles area, with the epicenter of the quake in Pasadena, California.

It occurred to me that there might have been a connection between the power blackouts, UFO sightings and the earthquake.

So I looked up the longitude and latitude of Hatzic and Pasadena. When I subtracted Pasadena from Hatzic, this is what came up with:

Hatzic, BC (Canada UFOs) -	49.09 degrees N	122 15 degrees W.
Pasadena, CA (earthquake)-	<u>34.09 degrees N</u>	<u>118.09 degrees W.</u>
	15.00 degrees N	4.06 degrees W

Then I went to the library, and searched through maps until I located the result, and what a surprise I got when I discovered that 15.00 degrees N, 4.06 degrees W. was the rainforest area of the Bandiagara district in MALI, S.W. Africa, which is populated by the Dogon Tribe.

The Dogons believe that amphibious space people once visited them thousands of years ago, and some day they will return once again. They have knowledge of the Sirius Star System in their traditional rites and culture.

It is pure speculation, but there is a possibility that the UFOs were warning us about an earthquake. If that is the case, then it would be possible, using this method, to predict an earthquake by reversing the order of the calculations.

Another interesting thing I discovered the other day relating to the above concerns the two recent mass sightings in Gulf Breeze, Florida and San Joaquin Valley in Fresno. If you join these points with a line, and extend it outward toward Africa, it cuts through Mali, very close to the Bandiagara area, once again.

Could it be that the extraterrestrials of the Dogon legends, have returned, and have set up a base with the tribe? Only time will tell.
