

THE ENIGMA OF PAT MCGUIRE

'Or what does Pat have to feel thankful about on Thanksgiving?'

Pat McGuire has been my friend for the last eight years. He is like a brother to me and a person I respect very much. Through the years I have observed him going through many disheartening events until today he is a broken man, without hope. If ever there was a person that needed help and compassion from his fellow man, it is Pat.

Perhaps there are some of you who have never heard of Pat McGuire. For some unknown reason I had the urge to feature him in this month's Missing Link. From past experience I realize there is someone else directing me in these urges; therefore, I will tell you his story.

I met Pat in 1981 at the Rocky Mountain UFO Conference. At the time I did not know that within the next year I would be moving to Wyoming myself. There is another story on how that all happened which you can read in my book, "On the Road Again".

When we moved to Wyoming Pat became a close friend, often spending the night with us at Arlington, Wyoming. We used to laugh and tease and have a great time. When I think of Pat I am reminded of those happy days. The last time I saw him the laughter was gone and I found it hard to coax a smile out of him. Pat is an Irishman and you all know how they love to laugh. When he laughs the sparks jump right out of his bright blue eyes.

In the following pages are articles that have been in national tabloids and the OMNI magazine concerning his case. He also was featured on "That's Incredible". If I remember correctly all he got out of that was a T-Shirt with the show's name on it and not much more! After that interview Dr. Leo Sprinkle who hypnotized Pat on the show found disfavor with the University of Wyoming where he was a professor. They did not want this type of publicity brought to the attention of the scholastic community. It seemed that each time someone interviewed Pat, Leo was brought into it also which heaped more notoriety on the University.

We will give you a short overview of his case and then present some of the visions he has had, plus the messages from "Michael", that Pat was to relay to Israel, and to President Reagan on the abortion issue.

Pat was living on his ranch with his family and eight children. He noticed that some of his cattle were missing. Determined to catch the "cattle rustlers" he sat outside at night with his rifle and watched through the scope. Finally he saw a light in the sky which sent a beam down on his cattle. At that point he was ready to shoot the culprit, (he thought it was a helicopter!) and he started to pull the trigger. He was instantly paralyzed from his neck down. A voice in his head said: "You don't want to do that!" Standing next to him was "Michael".

After that night Pat was contacted repeatedly by Michael who allegedly is the "Arch Angel" Michael who "works" for the "Supreme Being". Michael is described as being approximately 6

feet tall, a small nose, large black eyes, a very small mouth and a large white head. He wears the Star of David on his belt.

Not only Pat has seen Michael, there have been others too. One was a public relations person during Pat's campaign for governor. She was living on the University of Colorado campus. Pat was instructed by Michael to send a newspaper announcement to Reagan and to the Israelis (through their Embassy) to stop abortion. It seems the P.R. person had been very busy and had not done so fast enough to the liking of Michael. One evening she was walking across the campus and all of a sudden in front of her appeared "Michael". He said "I am Pat McGuire's Michael". She was too terrified to move. He said "You were supposed to send out the announcement - why haven't you done so?" She replied she would do so right away. She went straight to her room and started typing when Michael appeared again at her side making sure she did what he wanted. That was the end for her. She dropped anything to do with the campaign. She told Pat it was too frightening for her.

When Ariel Sharon was the Minister of Defense in Israel and even before, Pat was picked up and his spirit placed in Ariel Sharon's body. He was in the 6 Day war in Israel where Sharon hurt his leg. Pat's leg also was hurt in the same place. (Please don't ask me how this happened, I do not know the mechanics of such a complicated procedure.) Ariel Sharon's spirit was kept on the ship until Pat was brought back.

It was during the times he was in Ariel Sharon's body that he learned how to fix "tank" motors as Sharon was in the Tank Corp. This was to come in handy later. Perhaps it was the whole reason this phenomenon happened.

He was instructed by Michael to drill a well. This part of Wyoming is high desert where water is scarce. Most of the moisture is from the heavy snow that falls in the winter. When he went to the bank to borrow funds to drill the well they just laughed at him. The aliens had instructed him to place three rocks where he would dig and at the appropriate time they would bring the water. During the seven years it took to drill the well he was to fly the Israeli flag over the site. The motor to run the well was taken from a surplus tank that Pat purchased. One of his neighbors asked him how he was going to fix the motor if anything went wrong. Pat replied (this was before he was hypnotized) that he didn't know how he knew but he knew all about tank motors. In Wyoming he had never seen a tank!

Pat was shown a vision of two domed cities on his ranch. The cities were of the future and were covered with a protective bubble. Pat was told that everything under a certain elevation would be covered with water and everything above that elevation would be consumed with fire. The water from the well was for the future.

The following is quoted from a letter received in 1985 from Pat. "The two cities look like the city of Jerusalem. Adobe, domed buildings, etc. The well supplies both cities. There's enough water to support a population of 125,000 per city. The cities will be built after everything has settled down and it is safe to come away from the area of the caves. Michael says that

no one but God knows when this will take place and that anytime you see a certain date set for Armageddon, or any other main event like that, it is the black side trying to manipulate things in their favor."

Unfortunately, after seven years of hardship digging the well, the water came in. When the water came there was a huge boom on the trailer home. At the time only Pat and the geologist that was working with him were there. When the boom hit the trailer the geologist was scared to death. Pat hit the floor running. He said the water is here! It was alright - 8,450 gallons per minute. The aliens had brought an underground river from Canada in 10 minutes. Why do I say "Unfortunately?" After the water came in Pat borrowed the money to buy sprinklers. These sprinklers were huge moving water wheels that watered his huge acreage. More often than not he would go out in the morning and his sprinkling system had been damaged by someone tampering with it in the night. That first year, through many problems, such as the latter, he took his first crop off the land. It was beyond his wildest expectations.

When he took the crop to the granary they were all full so until they could find a place for it they piled it on the ground. When the inspectors came to purchase it they found all sorts of things had been mixed in with it, like corn, peas, etc. It was no longer worth much. Pat had figured on that money to pay for the sprinklers and put in his next crop.

The money Pat had borrowed at the bank was in a bank account. When he wrote out some large checks to pay for his equipment they bounced. It was then he found out someone had tampered with the bank account. Just another problem to compound everything else that had happened. He didn't have the money to make the payment on the land so it was confiscated and sold at auction to the Federal Land Bank. It has sat there ever since and has not been sold to anyone as far as I know. If anyone has an update on this let me know and I will be happy to correct myself.

The caves mentioned above are known to Pat at this moment. He was to take supplies there and have them ready. I believe he has done this. He also was to take seven pure men with him and walk to the caves. They are forty miles from his ranch. That was several years ago. There was a stipulation as to who he picked. Each one would have to be pure and have had nothing to do with anyone that had had an abortion. They could not have paid for one - helped anyone to get one - or caused one or had anyone in the family that had one. As far as I know he never found seven pure men to go on this trek.

When Michael instructed Pat to run for governor he didn't have the foggiest notion on how to proceed. He often joked that he didn't have any money in his pockets for a campaign but there he was campaigning! Then all of a sudden Michael instructed him to stop; so he did after hardly getting started. When election time came Pat garnered 15% of the vote in Wyoming without even campaigning! He ran for governor twice - each time with the same results.

In the second campaign he had visited the Indians in northern Wyoming and they were all prepared to vote for him. On the day

of the election it snowed so hard they couldn't get out to the polls. So again Pat lost. He felt if the Indians had been able to vote he would have won.

Perhaps many of you do not know that the population of Wyoming is only around 450,000 people. There are more antelope in Wyoming than people.

About the time that the ranch was lost his wife Wanda was pregnant with their ninth child. She was very unhappy about this. Michael told Pat that she was to have the child and he was very upset when she miscarried - to the point that he told Pat to divorce her. The baby is buried on the hill above the well with a statue of Jesus and the Virgin Mary watching over it.

Pat had been instructed by Michael to have 12 children. One for every tribe of Israel. So Pat married again and had more children to please Michael.

By this time life became almost unbearable. Jobs were so scarce that he and his little family almost starved. Some friends were helpful but more often than not people turned their backs on Pat. He became the laughing stock of Laramie, Wyoming. His older children started having bad grades and when asked why it was because they didn't want to go to school because all the kids laughed at them because of their father. Pat's heart was hurting and no one could heal it no matter how much you wanted to. His oldest son finally moved to Wheatland to live with his grandparents and started getting all "As". No one cared in Wheatland about who his father was.

Finally his second wife left him too. He says she found someone that life was easier for her to be with. I will have to admit that life was only the hardest you can think of when they lived in a trailer house out on the land next to his former ranch that belonged to his brother. They lived in this old trailer house without electricity or water with three babies. This was in the winter. I know how "cold" a Wyoming winter can be. I lived through one!

There is much more to Pat's story which should be written up because it is unique in the annals of UFOlogy. I have asked Wendelle Stevens to write a book on Pat's case; I think it is important.

The last time I saw him he was living in a friend's trailer and working at any job he could find just to keep body and soul together.

If anyone has the feeling they would like to help Pat you can send a letter, a check, money order, anything to the UFOCCI Northwest Headquarters in Federal Way and we will see that he gets it.

An interview with Pat and Neil Zajac follows this article. The interview was made over the phone on October 22, 1989.

INTERVIEW WITH PAT McGUIRE BY TELEPHONE - OCTOBER 1989

Neil: How do you feel about your contact now?
Pat: Without a contact you don't have a problem. Problem lies in how to handle it.
Neil: In the past few years has your contact continued? Has it improved your life and have you learned anything new?
Pat: Hardly in any way. Like I said, I just got contacted the other night. It was three nights ago. The thing is that when you are contacted, it is a steady on-going dilemma with the Feds. If they help you (the aliens) they (the Feds) come on to you that much tougher so it is counteractive. Until this situation improves, and of course if it wasn't for them (the Feds) a fellow would still have the ranch. This is an on-going problem with harassment. I don't see any future from the standpoint of the contactee because the minute they diagnose you as one of them your problems will just keep growing and as you get more active and they get more progressive.
Neil: You are one that has been persecuted more - losing your land - losing everything. Others have not lost everything. What I am asking is do you feel that your particular contacts have helped you any or are they leaving it up to you to bumble through life regardless of where they take you or what they give you. In other words we feel that a great deal of the E.T.s, however, good or bad their intentions, are definitely here to do their thing regardless of what Earth people suffer or do not suffer for it. You have lost a great deal.
Pat: Uh huh.
Neil: Over the years you have lost everything. Have they attempted to help you or do they care or it's simply not their purpose to help you or is it their purpose to teach you or something? Just exactly what are you getting out of this contact?
Pat: Like I said, if I see a place where it is increased then you see the negative which, you know, is the Feds, you just see them come back and counter the good that they (the E.T.s) have tried to help you out with. The thing is, it is just like he (Michael) told me - they have to have it that way because if the Feds have the people seized that are doing good for you - they want to get contacted - their losing control.
Neil: Yes, I definitely agree with you there, we agree on all those points. So in other words, you feel your experience is so worth while, other than the fact you are bothered by the federal people, you feel that what you have experienced is worth it over all these years.
Pat: Well, like what I said, it is counteractive. It goes right back to - the thing is - my aliens weren't willing to take the Feds off.

Nell: Yes, that is what we were thinking. They were not willing to protect you in other words.

Pat: No!

Nell: That's it. Can you break this contact at any time or not? Do they have such a hold over you that they can pick you up, do anything they want with you?

Pat: That is my opinion. I think if you did quit the Feds would kill you.

Nell: Oh! You think so?

Pat: Oh, sure. I don't think there is a doubt in my mind.

Nell: So in other words, your contact, your E.T.s are not of the highest quality people and their not doing you any good, the Feds are not doing you any good and you're the man caught in the middle.

Pat: I didn't say that. I said the Feds are not doing me any good!

Nell: No - true...

Pat: This is what I say.

Nell: Well what about your allens - your E.T.s.?

Pat: Nobody is telling me what they are doing in the background in order to keep me here.

Nell: Well have they suggested taking you somewhere else, and improving your life in any way?

Pat: Where would you go - where the CIA isn't?

Nell: Well, to another planet.

Pat: With all my kids left here? I don't want that!

Nell: Well, that's true, I didn't know if you were still in contact with your family.

Pat: Oh, sure.

Nell: So you are just the man caught in the middle. Basically, you are doing what you were doing two years ago when we saw you, is that it?

Pat: Oh, yeah.

Nell: Just hanging around, doing odd jobs and that's it?

Pat: Most of the time I am not working.

Nell: That is what I was afraid of. It's really made you go down hill. You said you had a contact just three days ago?

Pat: Oh, yeah.

Nell: Did you go anywhere, or can you say it over the phone?

Pat: I had hurt my back 25 - 30 years ago in a car - I hurt my back and they fixed my back.

Nell: Oh, good - that is a positive thing. That was recent?

Pat: Like I said, they tried to get rid of me three times. (Speaking of the Feds) I doubt they would have tried to get rid of me if I didn't have the contact.

Nell: Oh... It is still bad news for you all the way around.

Pat: Like I said - I can name any person I have been in contact with that had anything to start with has lost it.


Nell: Are your particular E.T.s telling you of any imminent catastrophes or danger to the Earth, or are you able to tell me?

Pat: What they wanted done is being done by them. As far as I am concerned, the government has been doing what they want and so I see a big back up between the two of everything. I see a big improvement about that part. I don't care about that - I am sitting here spinning my wheels really. The biggest thing I am trying to do is there has got to be a.. definitely a switch and change or the people that's contacted need to be kept under cover because the policy of the Feds is depression and as long as they never (the contactees) had nothing to start with there were no threats. They want to watch and see if they don't come up (monetarily). They are following along the way the government wants them to. So I feel, in other words, the only way you are going to get through with it is if you can convince somebody like Leo Sprinkle or some hypnotist that you are a contactee; that you follow along with an E.T. line or some line that has something to do... or ain't contacted at all... with this Earth - you don't come into any friction with the Feds. It's like I said, there aren't too many that were told to run for governor and actually did it. When we do stuff like that you are directly involved with the Feds and you will definitely be at odds.

Experts say aliens are preparing major landing on American ranch

The aliens are coming. That's the conclusion of experts who have closely studied an amazing series of dazzling UFO appearances in the skies over a remote farm in Wyoming.

"I believe the craft appearing over Pat McGuire's farm could be the goodwill ambassadors of an alien civilization," said Dr. Leo Sprinkle, a UFO expert and parapsychologist with the University of Wyoming.

"The area around the farm may become the showcase of an overall 'get acquainted' program which will lead to full-scale landings over the next 10 years or so."

Farmer Pat McGuire says his spread has been visited by humanoids in their multi-colored spacecraft every night for the past seven years.

His sightings are confirmed by his wife and eight children, as well as a couple who also live on the farm.

Many other people, including reporters, have seen strange, dancing lights in the sky they can't explain.

"The UFOs are about 300 feet wide and about 60 feet high," McGuire said. "There seems to be no limit to how fast they can go."

The farmer said his family were frightened by the UFOs at first, especially when they dis-

covered mutilated cattle scattered over his 5,100 acres.

"I got frightened one time when my brother-in-law and I saw a craft hovering over a young calf one evening in 1976," McGuire said.

"We heard that calf bawling for quite a while, then when the UFO flew away it took the calf with it. We never did find out where they took it."

There have been no mutilations since that incident, and the McGuire family now feels safe again.

"I believe people like Pat McGuire are being chosen by the aliens to spread the word that they're among us," Dr. Sprinkle said.


"I believe we will see full-scale contact between us and them over the next decade or so. When that happens, we could be the race in the spaceships in future generations."

McGuire said the aliens told him to dig a well in the high plains country near his former home in Laramie.

The land is more than 7,000 feet above sea level, and he was told by geologists and drilling companies that he could sink a well forever and never find water.

But something drove him on. He bought the land and jury-rigged a well.

His neighbors too thought McGuire was crazy. They were stunned when he struck a



massive underground river at 350 feet.

The well was a gusher, pumping 8,000 gallons of pure, soft water a minute. McGuire has now turned his dry patch of sagebrush desert into a 5,100-acre oasis of fertile grassland.

Under hypnosis, McGuire revealed information about the aliens to Dr. Sprinkle that had been lost in his subconscious.

According to a psychiatrist who had worked with the UFO expert, McGuire told Sprinkle he had been taken on board an alien spacecraft, and that the aliens had told him to drill his well.

The farmer said the aliens were about 6 feet tall, around 200 pounds with large eyes, thin lips and bald heads.

UFO expert Jim Lorenzen of the Aerial Phenomena Research Organization said:

"Dr. Sprinkle is very close to the investigations there, and his opinion that the place is an alien showcase could well be valid."

MYSTERY OF THE FLYING OBJECT

A GROUP researching unidentified flying objects claims to have spotted one in the skies above Ilford and Dagenham.

The claim was made by the East Anglian UFO and Paranormal Research Association.

Researcher Sheridan

Lane said the first sighting was made on Nov 17 at Becontree Heath, Dagenham.

At 10.25pm Tony and Chris Pratt said they saw an object from their bedroom window. It was egg-shaped with blue and white lights round the edges.

It made no sound and

was heading very fast towards East London. They watched it for four to five minutes.

On June 19 a similar object was seen travelling towards Ilford at midnight, claims the association. It was shaped like a rugby ball but slightly larger and had

an orange glow.

Its movement was erratic but slow. It made no sound and the observer watched it for 15 minutes.

Miss Lane said the association carried out its usual checks, contacting local groups, airports and other organisations to see if the sighting could be explained

by ordinary objects known to be in the area at the time, but there were none.

She said that since it was formed last July, the association had recorded 1,100 reported sightings.

Farmer: Aliens Use My Ranch as Their Landing Place

A Wyoming farmer, placed under hypnosis by an expert, claims that aliens from another dimension are using his ranch as their UFO landing place.

Amazingly, reveals Pat McGuire, 38, the aliens have helped him find water for his 5,100-acre ranch on the high, arid plain.

Huge, saucer-shaped UFOs visit his ranch quite often, McGuire insists, and his family and others claim to have seen them, too.

Under hypnosis, McGuire also recalls visits on board a UFO.

And according to Dr. R. Leo

Sprinkle, Ph.D., a psychologist and professor at the University of Wyoming in Laramie, his hours of hypnosis sessions with McGuire have convinced him "Pat is reporting sincerely what he experienced."

"Under hypnosis I sometimes find myself in an oval room, sitting in a comfortable chair," McGuire told The ENQUIRER. "The aliens are six feet tall, slender but muscular, with large eyes, a short nose, thin lips and no hair. They are dressed in all black. Their heads are bigger than ours. They didn't lift their feet as they walked — they shuffled along. Their skin was real white and they all looked exactly alike."

The most tangible evidence supporting McGuire's claim is his farm, a lush, green 5,100-acre oasis in the midst of a dry plain.

McGuire bought the desert land in 1970 saying he would drill a well big enough to grow cash crops — something unheard of in the arid region. But McGuire wasn't worried.

"The aliens told me to drill the well and they would bring the water to me," he explains simply.

That was in 1971. Neighbors were really surprised when McGuire hit water soon afterward, but they were shocked when, seven years later, he tapped an underground river. Now he irrigates 1,400 acres of malt barley.

Many other ranchers in the area have since tried to tap

the same water source with no success.

"Before, neighbors thought Pat was a little strange because he was going to dig that well and because he could see all these flying saucers," Dr. Sprinkle revealed. "Now he's strange only because he sees the flying saucers — anybody can go out there and see the well."

And McGuire's wife, Wanda, and their eight children all say they have seen UFOs, too. Local newspaper and television reporters have also seen strange lights darting over the McGuire ranch.

"Under hypnosis the aliens tell me they are from another dimension," McGuire said. "They're not from another star system. But they say there are UFOs that are from this dimension — from other stars."

"I've seen as many as seven spaceships at one time, with two of them sitting on the ground less than half a mile from my house and the other five hovering above them."

"I believe Pat is credible," Dr. Sprinkle told The ENQUIRER.

"There is no specific factor that would indicate that he is lying."

Last fall rancher Pat McGuire from Laramie, Wyoming, was defeated by Governor Ed Herschler in one of the most bizarre gubernatorial primaries in American history. At his first political rally, McGuire climbed to a podium in a local shopping mall and screamed, "A vote for McGuire is a vote for the extraterrestrials."

McGuire's campaign trail really began in 1976 on the couch of psychologist Leo Sprinkle. Staring at the ceiling, McGuire nervously recalled getting lost in a snowstorm while hunting elk in the Tetons. Though he was found alert and walking six hours later, he couldn't remember where he'd been. *

Sprinkle then hypnotized McGuire. After 24 sessions, the cattle rancher recalled his abduction by aliens who flew him to Israel during the Yom Kippur War. That, says McGuire, is when he learned that aliens had given the Jewish people "protective powers" to keep the Arabs in check. "So you see," McGuire explains, "if a Syrian pushes a button to fire a missile at an Israeli jet, there's always an invisible alien perched on his shoulder ready to send the missile off target."

Since this discovery, McGuire has hoisted an Israeli flag over his ranch and hitched a silver Star of David to his belt buckle. But, he points out, the UFO contact that inspired his political career didn't occur until a month after he left Sprinkle's care. Someone had mutilated one of his cows, and the sheriff, it seems, chalked it up to vandals. McGuire, however, claims the cow had been "shredded with cookie-cutter precision," as if it had been run through a machine. "As I stared at it," he adds, "I could feel this wonderful energy." In fact, McGuire says, this "energy" turned out to be "Michael," the alien who insisted McGuire run for governor because he, "like the Jewish people, had been given special powers" that would benefit the human race.

How did Wyoming Governor Herschler feel about campaigning against an opponent with political strategies emanating from aliens? "I felt unfortunate," says Herschler. "McGuire got eight thousand votes, which proves a lot of people in this state have seen UFOs. I guess I'd like to see one, too." The governor adds, however, that McGuire's role in the Israeli army didn't help his campaign.

McGuire agrees. "Let's face it," he says, "this is redneck country. And I ain't got any Jewish blood in me. I'm all Irish. So I guess some people think I'm nuts."

Even McGuire's ex-wife, Wanda, admits. "This Israeli thing went too far." Though she, too, got messages from aliens, she says, she never heard anything about the Mid-east.





UFO SIGHTING UPDATE

5-2-89--Louisville, Kentucky--5:15 a.m.: A 31-year old male was working on his morning paper route when he spotted a "big, bright light" stationary in the sky under the cloud layer. He continued to watch the light as he delivered his papers but, when he finished his route, he noticed that the light was now moving in a circular pattern. As he got back into his truck he noticed that the light was now moving toward him at a "pretty fast speed" and was about 125 feet from his truck. When he started the engine and turned on the headlights for a quick exit from the area, the light "stopped in an instant" about 100 feet from the witness. In about five seconds the light then moved from right to left in front of the truck and moved out of sight.

5-2-89--Walworth, New York--9:45 p.m.: A 16-year-old female was looking out her bedroom window when she noticed a large, dark object approaching her house below treetop level. The craft was whale-shaped and black in color. The girl could hear a loud sound similar to that of a helicopter, causing the house to shake. As the strange vehicle moved between her and the neighbors house it had a near collision with a tree, maneuvering around it at the last second. The craft was also observed by the girl's father who said it was definitely "all steel, total solid." Later that night the teenager learned that a friend of hers in another part of the city had also seen the vehicle. All witnesses agreed that the craft was about 50 feet long.

5-6-89--Ferndale, Washington--10 p.m. Five Female adults sighted a large light form low in the sky which appeared to be stationary. As they watched a second light form joined the first, then one moved away at a high rate of speed. The second light form descended toward the ground and moved toward the witnesses. It passed directly overhead at rooftop level. The light form was described as being long and wide, "really huge" and moving without sound. As the women watched the light form appeared to land in an open field and then vanished. The observation lasted for about 15 minutes.

5-10-89--Near Farmington Hills, Michigan--Midnight: A large greenish-silver disc-shaped object, turned up on end, paced a car occupied by a 38-year-old male and a 16-year-old female. They reported that the pursuit continued for nearly two hours, and that the craft frequently moved in front of their car and to the rear of the auto. During that period the car radio stopped working. Later that morning the entire electrical system in the car was found to be unworkable.

6-3-89--Longbeach, Washington--10:46 p.m.: Four glowing football-shaped objects were sighted by an adult couple moving south to north about 700 feet above ground at an estimated speed

of 500 mph. They estimated the craft to be 20 to 30 feet long. No sound was heard during the one minute observation.

6-9-89--Near Fayetteville, Arkansas--10:23 a.m.: The pilots of five airliners flying at 35,000 feet in an 80 square mile area, reported seeing a large glowing object streak across the sky.


6-13-89--Frankfort, Kentucky--11:30 p.m.: While driving on the Express Connector roadway, a 36-year-old female observed two large, bright white lights moving in her direction. She stopped her car for a better look and as the lights got closer she could tell that they were attached to a rectangular-shaped object, "massive in size." The woman got out of her car just in time to see the craft stop directly overhead and remain in that spot for about two minutes. During that period she could see what appeared to be numerous pipes laying flat against the underside of the vehicle which was illuminated by several lights. No sound was heard coming from the craft and there was no other traffic on the major roadway while the craft was in the area.

MUTILATIONS

The question has been asked, "Why are so many cattle being mutilated?" We most often hear of cattle and do not hear about other animals. Investigators, ranchers, outdoor people, hikers, Forest Service personnel, cowboys, hunters and a host of other people have found every type and description of animal mutilations - wild and domestic - in many different countries of the world. The only reason we hear most often about mutilations in North America is because we live here. Mutilations do happen in other places. One reason so many mutilations take place in North America is because the United States government (allegedly) has made a treaty with certain alien beings allowing them to construct underground quarters in North America. So we have these alien beings living in our country - naturally they are going to harvest the animals nearest to where they live.

The reason these alien beings mainly use cattle is for the same reasons we do - accessibility. We use cattle because they produce huge amounts of protein. Aliens use cattle because they produce huge amounts of what they need - blood. The alien beings do not need to bother about raising cattle themselves; they simply take what they need.

I live in the Southwest which is mostly desert. I have been to places where range cattle have been mutilated. I have also seen some wild animals that have been mutilated in the "classic fashion," rectum, sex organs, lips, eye, and tongue, removed which I will cover later. For some reason predatory animals leave these mutilated carcasses alone. One reason could be because the animals I have seen were within a very intense magnetic field called a "vortex".

The carcass will simply lay where it was deposited, sometimes for years if undisturbed. The flesh will dry up like it was dehydrated, mummified or whatever. The flesh appears to turn to leather. One carcass I visited several years after the first time I had seen it; maybe fifteen years later; it had been scattered around the area. The cartilage and gristle between the bones was dry and very brittle. Anything walking through the area such as other cattle or people could have kicked the remains around. I saw one carcass that had been in a dry wash, when the rains came it flooded the wash and the remains of the carcass washed up into a tree about ten feet off the ground. In most of the cattle I found where the carcass was old, the skulls were gone. I attributed this to people who may have found them and taken the skull home to decorate their yard. The few skulls I found that had been there for sometime, if I could separate the skin, the skull had a round, clean-cut hole in the middle of the forehead as if the animal had been shot with a very high power small bore rifle except the hole was smaller than a bullet hole. If the animal had been shot I could not find any place where the bullet had come out. The hole could have been made by some

device that would stun or paralyze the animal such as a laser beam.

One time I found a Javalina that had been dead about three or four weeks. The strange thing was there was no detectable odor. Usually a dead Javalina will stink to high heaven. The absence of odor may have been because the body fluids had been removed. This could also be one reason the buzzards had not found it; no odor.

Another interesting thing is that most of the mutilations I have seen were in the winter. In this part of the country there are no buzzards during the winter months, they all migrate to Mexico.

One time I found a wild burro that had been mutilated in the "classic fashion". The difference about this animal as compared to the other animals I've seen was one front left leg had been severed and was gone. I examined the exposed bone with a magnifying glass and could see no circular marks as a meat cutting blade might make. Neither could I see any marks a band saw might leave; the surface of the bone was perfectly smooth and very precisely cut. It was as if some being had cut the foot off to take home for a souvenir. I have read that on a human mutilation the left ear was gone. Modern day animal bounty hunters collect the ears of the animals they kill and turn them in for the bounty. The left ear of a human being could be a trophy much like in the olden days when people collected scalps.

One thing I haven't come across in my travels are mutilated wild cats such as lynx, bobcat, mountain lion, jaguar, etc. However some investigators in other parts of the country have reported house cats mutilated.

One method the alien beings use to remove all the body fluids from a body very easily is to simply remove the rectum which is the end part of the large intestine. By separating the intestine from the rest of the body, they can then remove all the body fluids without contaminating the fluids.

Another reason for removing the rectum is because the glands in the rectum secrete chemicals that are toxic to the aliens; they do not have rectums. The risk of being contaminated by toxic chemicals is reduced by removing the rectum before drawing out the body fluids. Often the animals are mutilated and the fluids are removed while the animal is still living.

Also, the alien beings collecting these products from animals save the rectum because they can process chemicals from the rectum to manufacture pheromones, which they use to control human beings to some degree. The effect pheromones have on human beings is to put them in a sleep like state. After the affect of the pheromones wears off, usually in about two to four hours, the person has no memory of the event. Aliens can fly over an area with their flying craft and broadcast this substance much the same way a crop duster would apply a pesticide. Usually this is done during the night when people are sleeping. When the people who were affected wake up there is no memory of anything that may have happened while they "slept."

During the time the human beings are incapacitated the aliens can come into the area and do anything they please; mutilate live

stock, abduct children or carry out any projects they are involved in at the time. These insidious aliens can mix this pheromone in various strengths. One method the aliens use to abduct people in isolated cases is to spread pheromones across a road or highway in the form of a mist or fog. If any vehicle enters this "fog", all the occupants in the vehicle are affected. The people can remember driving into the fog, they can remember coming out, but they cannot remember what took place in between. The aliens have the technology to take charge of the vehicle during this period of time. Stop the engine, remove occupants, etc. Only after the abduction occupants of the vehicle may discover they are "missing" a period of time.

The particular type of aliens that do these things have no digestive tract. Therefore they do not have the hollow internal organs that produce digestive enzymes: liver, pancreas, spleen, etc. Consequently they have no emotions (the spleen is said to be the seat of the emotions), and they have no sex organs.

When they mutilate a body they remove the sex organs thereby emptying the bladder so the urine will not contaminate other body fluids when they are extracted. The aliens get their highs from human emotions. In some cases these emotions can be artificially reproduced from the chemicals in the body fluids the aliens extract from the sex organs.

(Allegedly) With the permission of the United States government, these aliens have set up laboratories where they can process these organic parts and perform genetic experiments. One phase of these genetic experiments is cloning which requires vast amounts of blood.

These aliens have to "eat" or at least replace their body energy by some method. Cattle have four distinct digestive processes. They have the ability to turn cellulose from plants into protein. Each different stomach of the animal secretes its own particular enzymes (solvents). These body chemicals cause changes in matter. Enzymes are collected during the procedure involved in draining the body fluids from the animal. Because these aliens do not have a digestive tract no mouth is visible or possibly only a vestige of one; so they take the lips, tongue and eye from their prey and process these tissues into a form they can use to rebuild their energy supply. They make a solution of these tissues using the enzymes they have collected. They can then place their hands into this solution and absorb the nutrients through their skin by osmosis. During good times when they have an abundance they may even submerge their whole bodies into this solution in much the same way we would take a bath.

These aliens are small beings so they don't require large volumes of "food". However, they have a very large brain which does require complex protein.

The aliens also process this nutrient rich solution by a form of dehydration. They remove all the moisture and concentrate the ingredients for future use and easy storing.

This whole mess is a very insidious thing. It really upsets me to know the United States Government will allow these parasites to flourish. These beings produce nothing. The U.S. Government (allegedly) is receiving technology from these beastly little creatures which has cost human lives, then they give this ill-gotten technology away freely to other countries.

For what?

Creatures, flying lights reported

WELCH, Okla. — Whatever they were, the two 9-foot, green, glowing, thin beings that may or may not have had heads certainly weren't Oklahomans.

The England family — out driving when they say the things popped from a round object that decidedly was not a car — got mighty worried about that.

"We were driving down this gravel road out south and this round thing with two red lights was blocking our way," said Shirley England, the mother. "Then these green, glowing things popped out. Me, Debbie, John, Sarah, the baby and a neighbor girl, we all saw it. I don't know what it was, but we're all pretty jumpy around here now."

The Englands are not alone. Between Oct. 8 and Oct. 16, more than 100 people in northeastern Oklahoma and southeastern Kansas reported seeing white, red, yellow, and green or blue lights zipping through the dark sky or hovering over trees or houses.

Only the Englands, who Craig County Sheriff Jess Walker said are not the type to tell tall tales, claim to have seen creatures.

But thousands of others — from police chiefs and sheriffs to county commissioners, morticians, television cameramen and newspaper reporters, schoolchildren and retired citizens — claim to have seen the lights.

"Folks were lining their cars along country roads and sitting out to watch the lights dance in the sky," said Police Chief Bob Baine of Commerce, Okla. "I'd say that around here, more people saw them than didn't."

The lights often flew high but frequently dipped to tree level or just below. For a week, they appeared every night between 8 p.m. and midnight. The lights appeared to rotate as they moved.

Those who say they observed this draw pictures of a ball-shaped or a partly deflated football-shaped ship. And though many people said they thought they were within a mile of the object, no one heard any engine noise.

The lights sometimes were stationary or moving slowly but often traveled about the speed of a small plane.

Occasionally, however, the lights "in the snap of your finger, or the blink of an eye, are across the horizon, and I guarantee you we don't have anything in our Army that could catch those buggers," said Jack Young, an Ottawa County commissioner.

The overwhelming feeling in the region is bemusement. Was this some cosmic trick? Were secret weapons being tested? And, if not, just what the heck were folks seeing?

"I've read stories before about people who've seen this stuff, and I've always thought they were idiots," said Larry Murdock of Columbus, Kan. "But I looked at the lights through the binoculars, and I never was so shocked in all my life."

"There it was, the traditional flying saucer, spherical and turning. Honest to God, I believe it's something from another planet. I just hope no Barney Fife type decides to go shooting up whatever it is."

Jim Green, a police officer and Miami civil defense director, said craft from outer space might be going a bit far.

"If we had 12 witnesses to a robbery give stories this similar, we'd have a pretty good case," he said. "Something is out there, probably some experimental aircraft."

"But here's what gets me. It rose as if going straight up, hovered over a house, then took off with no noise."

Many say the lights might have been caused by a fast helicopter, a glider, a remote-controlled kite, or a military-controlled mini-balloon. But then they say the lights moved unlike any of those things.

And police said that during the sightings, radar controllers in Tulsa, Okla., said no planes were flying in the area.

Mark Paonessa, professor of physics at the University of Kansas, said the sightings could be accounted for by any number of natural phenomena. He said airplanes, rockets, bright planets, atmospheric conditions, a recent solar flare, methane gas or even secret military projects could account for the lights.
