Associate Director, Barbara Becker of our center in St. Louis, recently sent us the following information off the CAJI COMPUTER BULLETIN BOARD OF BILL COOPER. Because of the content we would like to reprint it and clear up any discrepancies pertaining to the murder of Stacey Borland.

Stacey Borland Murdered

Recently, Stacey Borland, the leader of a Las Vegas contactee group (Ed. Note: The UFOCCI) sponsored a talk by Budd Hopkins at a library in Las Vegas. It is rumored that a man who worked in the top secret area known as "DREAMLAND" approached Stacey and gave her some documents. The next day it was reported that Stacey and her brother were found dead in her Las Vegas apartment. They both had been stabbed many times and blood was all over the walls and floors. As if that were not enough, Stacey was set afire and burned horribly. The apartment did not catch fire. Odd, don't you think? The list of members of the contactee group and the sign-in sheet from the Hopkins event are reported missing.

_____, aka Val Valerian, aka Mr. Wilson (in shadow with voice disguised in a video entitled "Top Secret Coverup") moved right in and took over leadership of the contactee group. _____ is the co-author, along with John Lear of "The Matrix" and authored "The Secret Treaty". _____ is also the director of the "Nevada Aerial Research Society". A "Capt. _____" is mentioned in the "Aquarius Telex" that was leaked by the confessed agent William Moore.

_____ is an active duty agent of the Counter Intelligence Division of the Air Force Office of Special Investigation. He has been seen wearing an Air Force officers uniform bearing the rank of Captain, an Army officer's uniform, and an Air Force enlisted man's uniform with the rank of Staff Sergeant. He attends most all UFO conferences and always wears a name badge with an alias printed on it such as "Klark Kent", the badge he wore at the 89 MUFON symposium.

It is reported that as the new leader of the contactee group he is categorizing the members into groups as to their degree of alien encounter. He is compiling lists labeled "CONFIDENTIAL" and the forms have been reported to look like official military or government forms.

I have just received a copy of the excerpts from Bill Cooper's newsletter and I must say I am not surprised in the least by the content. It is filled with the distortions, exaggerations, and half truths for which Cooper has become so famous. (There was much discussion concerning Bob Lazar and then the following write up on Stacey.)

The same newsletter that distorted the Lazar story also befouls the reputation of a kind woman, the late Stacey Borland. According to Cooper, Borland and her Las Vegas contactee group arranged for Budd Hopkins to lecture at a local library. Borland was supposedly given some documents at that lecture and the next day was found murdered. Stacey Borland was murdered, that much is true, but the crime occurred three weeks before Budd Hopkins came to town. The lecture wasn't arranged by a contactee group. It was set up by the Library District. The disinformation from Cooper seems designed to discredit _____ (Valdemar Valerian), who was appointed to take over the contactee group following the murder.

_____ is an odd character, but it seems very unlikely that his is a murderer in the employ of the government. The reason Cooper wants _____ discredited is that _____ is a close associate of John Lears and thus knows much about Cooper's lies and distortions. In fact, Cooper got his start in the UFO field with the help of Lear and _____ and has spent a great deal of time with both men. I have been at Lear's house and have heard the threats from Cooper regarding the possible publication of Cooper's fiction. Bill Cooper does not want Lear, _____, Lazar, Moore, or Friedman to be believed by anyone, because they all know that he is a phony. Soon, others will know as well.

Director's Comment: Stacey Borland and her brother were murdered on March 3 or 4 (the date never was determined, as far as I know). Stacey's meeting was February 26 as Gerald and Mark Andrews attended. Stacey was never given any papers by anyone purporting to be from "Area 51 or Site 4". Mark and Gerald were with her at all times. Stacey is the one who picked Valdemar Valerian because she had spoke most highly of him. He taught her a lot about UFOlogy and she respected him. I had many calls from Las Vegas after her death recommending Val to the position. I already knew that he holds a position in the Air Force. He explained it to my satisfaction. It is not with any intelligence service but instead he was involved in writing contracts for supplies. A most harmless job. Even if he is, which I do not believe, he has done more to bring out what is happening in this field than any other person I know - so why would he jeopardize his career by releasing such information.

At first he was hesitant to take the position. He felt he was too busy with his own UFO activities but finally acquiesced. If he was a government dis-information - or information person he would have jumped at the chance. Now he feels more comfortable about it, except for the comments of such persons as Cooper, has made.

In July the second "Matrix" will be released through Arcturus Book Service. Be sure to write and reserve your copy. I have been told by Val it is 500 and some odd pages in length. I asked him what is in it and he said "You name it!" I guess that means everything.

I also know that "Klark Kent" is a person that has his own UFO organization. He advertises in many periodicals, such as California UFO. I saw him too at the MUFON conference. Of course he should wear his name tag - we all did. It depicted "who" we were.

I'm sorry Bill but this time you have really messed up on your information. If it hadn't of been Stacey that you were writing about I would not have commented but since we loved her and want to remember her as the sweet person she was we think she deserves more than what you wrote about her. You could have just said she was murdered without adding the gory details. Some persons are very sensitive to this.

By the way Mark Andrews, our Associate Director from Costa Mesa has enlisted "Unsolved Mysteries" to pursue this case as it seems nothing is being done - or else we haven't heard anything from the Las Vegas Police Department. We hope they will get down to the nitty gritty of this case and find the person responsible. We do not believe it was connected with UFOs.

In response to last month's statement that our organization does not channel entities nor pursue religious beliefs or doctrines, this is a letter from an exchange subscriber.

Dear Missing Link:

Upon receiving your latest newsletter we have realized your style has changed. We also noticed our ad was not in this issue. We are, therefore, cancelling the exchange.

We found it interesting in your "Notes" about your clarification about being hard core UFO contactee experiences yet you still had articles about crystals and telepathic contact. Telepathy is Relayed Channeling and crystals are non UFO related. We are Star System Sirian, not Pleiadian, as you should know from our "Solar Trek."

We strongly disagree with "E.T. Truth". The Pleiadians are not masters of the universe. Star System Sirians are older and far more advanced than the Pleiadians. The Pleiadeans are in fact answerable to the Star System Sirians since being from the Greater Universe. The Pleiadians do not have the right to tell other ET aliens what to do, where to go and what to believe. There are many religions in the Greater Universe. All are positive and have a right to be.

In the Greater Universe there is a law called the non-interference law. All positive ET alien races are aware of this law. It states: "No other ET alien race or government shall impinge upon the rights of any other alien race, worlds, vessels (starships). Nor shall any race interfere with the territory of any other ET alien race, or prevent one race from coming to other worlds." The Star System Sirians have a right to be here because they were present here during Project: Genesis when this world was created.

Terra 14 (Earth) is a free planet and the Pleiadians are not the masters of Terra 14. Other ET alien races including the Star System Sirians do not take orders from the Pleiadians!

You never notified us about the clarified focus and you were aware we were mystical UFO from our ad. We are therefore as earlier stated cancelling the exchange.

People have the right to disagree with others. Different assertions are not always fantasies, hallucinations and etc. This includes religion and Spiritual Teachings. ET aliens have often come to Terra 14 to teach. There are many different types of people in the UFO field. It is the policy of our networking section to print all types of experiences and beliefs!.... Stellar Blessings, Sirian Rainbow Lodge.

We want to thank the Sirian Rainbow Lodge for giving us this opportunity to express more clearly our last statement. It is not our intent to dictate to anyone what they should or should not believe. As persons who work closely with abductees we have seen them lose their primary focus to other's channeling and also their personal power when they could have retained it by listening to their inner guidance. We believe the abductees have been awakened through their contact experiences so that psychically they have an inner knowing as to what is best for them.

As for crystals and telepathy: many persons having had physical abductions/contact develop in various psychic abilities. Using crystals is one such way. Knowledge that was previously not known or cared about comes to the forefront after an abduction. This is also true for telepathic abilities. A center within the mind is opened in order to receive telepathic transmission. We keep track of such abilities through many, many cases and it is so.

As an abductee oriented organization we began with the express purpose of providing a place where those persons having unusual experiences could come together and discuss the anomalies happening in their lives. We intend to adhere to those guidelines to the best of our ability. We have never changed our policy.

I just finished re-reading the June Missing Link and want you to know that I believe the **Smith article** and the **Alaskan Abduction** tape, are the most informative accounts that I have come across in a long time. Very stimulating. I hope you continue to relate more info on the Greys.

I do have a question though, have you ever come across any other references as to the blue liquid that is injected into contactees.

I find it curious that although the abductors seem to be the same species - large head - black large eyes, etc. that neither the Alaskan abductee, or the Smith account mentions vats of body parts, a common observation of some abductees who describe their abducters as similar to the above.

As one who has come across many abduction stories would you please comment on this.

Editors reply: Yes, there have been many cases where the abductee was given blue liquid to drink. Also in the Avis Abduction case in England you may remember they were given wafers, like mints to eat before they left. Dr. Edith Fiore's new book, "Encounters" relates an account about the blue liquid.

It is my opinion that whatever is in the blue liquid makes them forget (for the time being). It may also serve to condition their body to whatever is transpiring aboard the space craft. However, that would only be speculation.

We would be interested in hearing about any cases that investigators may have on file where the witness was forced to drink a liquid (any color) or eat something.

I would not readily assume that these beings are the "greys" per se'. Where did that all come from anyway and how many people really have been abducted by the underground species. When I think of our cases there are very few. We are too ready to assume that they fall into one category and I do not believe that is valid reasoning. Just think of all the books Wendelle Stevens wrote and how many diverse types of beings there are in those books.

I always have wondered why when persons tell about their encounters in writeups in the sleezoid magazines, or in "off center" groups, the aliens invariably come from "Pleiades, Sirius, Zeta Reticuli I and II, or some "heard" of place?? Why not places we have never heard of instead. I would believe that more readily. To me it just means, they do not know but want to be in the forefront and appear they have all the answers when the truth is none of us do. When we have "all" the answers that will be the end of UFO research organizations. The mystery will be solved.

Dear Aileen:

Thank you for your letter. First of all, let me clarify what the "Greys" are. The Greys are more or less cloned beings, not necessarily from Zeta Reticuli, but that is one of the regions where they are in use.

Long ago the Association of Planets scientists realized that more suitable physical and mental characteristics were needed for space travel as well as for inter-dimensional travel. 

This UFO can be identified

PENSACOLA, Fla. — A model flying saucer made of foam plates reportedly has been found in the former residence of a man whose UFO photographs two years ago focused worldwide attention on sightings in northwest Florida.

Ed Walters, 43, who wrote a book about his supposed encounters with aliens and their paralyzer rays, said he knows nothing about the model "unidentified flying object" or how it got in the attic of his former residence.


"There's no logic in me leaving the object up there," Walters told the Pensacola News Journal.

The newspaper printed several pictures yesterday taken by staff photographers who used the model to show what appear to be UFOs flying above treetops and a house. Walters said the photos are similar to the ones he took in 1987.

Walters' pictures were published in his book, "The Gulf Breeze Sightings: The Most Astounding Multiple Sightings of UFOs in U.S. History."

The model is 9 inches across and 5 inches top to bottom. It is made of four foam plates and construction paper, a plastic tube and some electrical tape.

On the back of the paper are dimensions for a house in what appears to be Walters' handwriting. Walters said someone could have taken the drafting paper from his garbage.



The following letter was sent to Ed and Francis Walters by Nell Zajac, Secretary to the UFOCCI Board of Directors:

Dear Ed and Frances Walters:

In response to the enclosed article (see left) which was in today's newspaper, we as an organization wish to reinforce our faith in your case and to support you in this obvious attempt to ridicule your integrity.

Our group was formed to help contactees in particular and we have had similar cases such as yours - only some of the contactees have not been able to handle it as well as yourselves.

We would like to rebuttal from you that we may print in next month's Missing Link. That is our newsletter which goes out to all our associated centers, not only in the United States, several to Canada and other parts of the world.

- o *Recently a young man claimed that he witnessed Ed Walters take double exposures of a UFO model in 1987. In a rush to print the uncorroborated story the News Journal did not check out the story.*
- o *A simple test with the 4 lens Nimslo stereo camera shows that the stereo photos are not an airplane landing as claimed.*
- o *A lighted object (UFO) cannot be exposed behind a dark object (trees). A simple test shows that the lighted object always bleeds through.*

- o *Claim after claim should have been checked out but when the claim was made that Ed Walters "turned a trampoline upside down" on the high school soccer field "and jumped up and down on it" to kill a circle of grass (this also can be tested), it is clear that the accusations cannot be taken seriously.*
- o *Two days after the "model double exposure" accusations hit the Sunday front page, Ed Walters took a voice lie detection test administered by Ronald Lauand, a certified instructor, court recognized expert, licensed analyst in the field of Psychological Stress Evaluation. The questions were specific: Is it true that you did not make the UFO model that was found at 612 Silverthorn Drive? Is it true that you did not have a model of a UFO at 612 Silverthorn Drive?, etc... This lie detection test was his fourth, administered by three different analysts.*
- o *In every test Ed Walters was determined to be telling the truth.*



In my previous article I explained how you could easily construct a machine to signal alien lifeforms. Now I will discuss one method that is used by an advanced race of beings I call the "WATCHERS" to communicate words and ideas.

During the period of time I was experimenting with electronic beacons, I was having repetitive dreams about bananas. The dreams became so intense and identical that I was compelled to go to the library. I found myself scanning medical research books on the brain. The information was quite technical, and since I was very poor in math, physics and biology, failing miserably in school, I was astonished to find myself quite easily comprehending the material. It wasn't long before I discovered that bananas, figs and dates all contain the amino acid tryptophan. Used by physicians as a sleeping aid to patients, its supply in the body can be augmented, as well, by consumption of warm milk. Vitamin B7 and C are required for conversion of tryptophan to serotonin, which is a neurochemical transmitter of information. Its chemical structure is similar to LSD, however, it does not cause hallucinations. Its function is to program different parts of the nervous system and the brain.

The pineal gland, or third eye, is a small triangular object attached to the top of the brain stem. There is scientific speculation that it is a valve, regulating the flow of thought. It has the ability to receive, and process incoming information about light and dark. This is also the spot which is said by sages to be the seat of psychic power and intuition. Melanin, a chemical which is elaborated from serotonin by the action of enzymes, determines skin pigment and is only found in the pineal. The serotonin acts as a timing mechanism and relay station, switching states of consciousness on and off, as well as regulating sleep. Light is absorbed into the pineal from the sun, by way of the optic nerve. This is important to know so I can explain how the "Watchers" transmit information.

Peptides, on the other hand, relay micro-cellular words, broadcasting sentences, after the area targeted has been switched on by the neurochemical, to receive. The string of 20 amino acids which make up a peptide is a kind of alphabet used to construct genetic material.

There is a great biological signalling system out there known as the Genetic Signalling System. If you are not properly tuned to the frequency, it is merely static, and useless to the receiver. There are both WORLD POPULATION BROADCASTS (WPBs) and Individually targeted systems (I&S). Their main function is to trigger evolutionary growth patterns. Each nervous system will process the information in a different way, and respond according to their own past life development, and current sociological imprinting. The goal of the "Watchers" is to help create one Bio-Planetary nervous system. Scanning, probing and modulating thoughts, emotions and soul blueprints on this globe, these sentient beings correct and adjust accordingly, using biochemically driven energy beams, in order to give a gentle push or shove where they can without having to land outright on the Whitehouse lawn.

The Watchers, specifically a female called Estera (Star-Sun), told me, using direct coded impulse stimulation of the auditory nerve, that they are able to transmit information directly into my brain for storage, assembly and assimilation by the following method:

A beam of energy, different than light, but containing many of its properties, biological in nature, is transmitted to the pineal gland. This concentrated focus of computerized impulses is able to hold and transmit information at tremendous speeds. It enters the gland by way of the optic nerve. From there, serotonin and melatonin are released, translating the messages into physical response. Various parts of the learning centers are switched on. The increase in the neurochemicals, aided by the purposeful intake of tryptophan, causes the mind to enter a deeply relaxed and receptive theta state. The pineal acts as a relay station between the incoming psychotronic impulses from the UFO, and the message transmitted inside the brain, after processing.

The amino acids which make up the genetic alphabet are influenced and affected by the frequency, intensity and color of the craft's flashing lights. One blinding flash of light, may indeed consist of hundreds of high speed transmissions. Thus, cellular information is transmitted on the energy beam carrier wave, together with the neurochemical on/off binary codes. So they not only put me in a receptive state to receive knowledge, but fed it to me, as well, like a bio-computer fax-machine!

THE STONEWALLING OF HIGH STRANGENESS

A large crack appeared in the stonewalling of high strangeness on October 14, 1988. On that date, there was a semi-official admission of the reality of extra-terrestrial intervention in human affairs, in the guise of a two-hour TV special, hosted by Mike Farrell, entitled UFO COVER-UP...LIVE! Participation by U.S. and Soviet officials was so extensive that it could not have occurred without the consent of both governments.

Furthermore, the program was presented to the public simultaneously in the United States and Russia, the first time in history that any TV program has received such preferential treatment. A first-ever arrangement of this nature would have been impossible to make without the collaboration of both governments. However, in spite of this clearly implied U.S. - U.S.S.R. seal of approval (or perhaps because of it?), what the program contained was a clever mix of information and disinformation.

The valid information was that we are not alone, and that the United States Government has made a hitherto secret agreement with short gray humanoids who say they are from Zeta Reticuli.

Although it was not specifically stated that the short gray humanoids, supposedly from Zeta Reticuli, were the only E.T. group our government has made contact with, this was certainly implied. To the extent that it was implied, it was a falsehood.

The statement that the Grays nourish themselves on vegetables was an outright lie, to which the cattle mutilations (which were not even mentioned on the program) bear unequivocal testimony, contained in the "Mysterious Mutilations" chapter of *Extra-Terrestrials Among Us*. Linda Moulton Howe's brilliant master-work, *An Alien Harvest* (published by LMH Productions, P. O. Box 3130, Littleton, CO 80161, in 1989) presents irrefutably conclusive photographic and documentary evidence that these mutilations have in fact occurred on an enormous scale, and are still occurring.

The complex question of what the nourishment of the Grays consists of is investigated in detail in what you are about to read, as well as the relationship between this subject and the epidemic of abductions we are at present faced with. The program admitted the existence of the abductions, but implied that the motivations of the Grays are benign -- another falsehood.

The TV audience was told that the Grays are the guests of our government, and have been given a base in Nevada. Nothing was said about the other bases our government has given the Grays, or about the activities being carried on in those underground bases. The conditions of the agreement made between our government and the Grays were not mentioned. What those conditions consisted of, and what kind of relationship our government really has with the Grays, are discussed at length in the following pages.

The general implication of the TV program was that Uncle Sam had made a smart deal. However, the truth of the matter is that this was the most disastrous mistake, not only in the history of our nation, but in the history of our entire civilization. There

were other E.T. groups that we could have made incomparably better arrangements with. Although it is a scandal similar in nature to the Iran-Contra deal, it is a tragedy on such a scale of unprecedented magnitude that in comparison Iran-Contra seems like very small change indeed.

The Eduard "Billy" Meier case in Switzerland, which Mike Farrell stigmatized as "an obvious hoax", is not without its ambiguities, absurdities and contradictions. Nevertheless, the physical evidence is so strong that this is one of the best-substantiated cases on record. Dr. James Deardorff has speculated that the E.T.s may be making deliberate use of absurdity as a form of strategic camouflage, in order to ensure gradual rather than sudden realization of their presence. By cloaking their activities in an aura of absurdity, they repel serious investigation, and make people hesitate to endorse the reality of the phenomena, keeping it all border-line and marginal, which distracts human attention from their presence. If this is the game that is going on, the E.T.s may be feeding Meier a mixture of truth and falsehood, which he relays to the public in the sincere belief that it is all true. One of the most curious aspects of the Meier case is the veritable obsession displayed by the government's plain clothes media agents (such as William Moore, who has publicly admitted his links with government agencies) in over-zealous attempts to discredit the evidence. There has been an all-out media vendetta waged against the Meier case that seems totally out of proportion with the investigation of any one single UFO case. Is this because Meier's contact was not with the Zeta Grays our government made a deal with, but with a rival E.T. group, in appearance so human as to be almost indistinguishable from us, which shares a common ancestry with us, known among researchers as the Blonds or Swedes? This is the same group that was known in antiquity to the Scandinavians as the Aesir, to the Irish as the Tuatha Te Danaan, and by other names in other cultures. One of the modern Russian cases mentioned on the Mike Farrell program, in which the UFO opened up like a flower, was an encounter with the blonds, who are the group I think we should be in alliance with.

Dr. Jean Mundy is a Professor Emeritus in Psychology at Long Island University, and has been in private practice in psychotherapy and hypnotherapy for over twenty years. She is a member of a long list of professional and honorary societies, and has published articles on a wide variety of subjects in both the academic and the popular press. During recent years she has focused her expertise on the subject of UFO phenomena, and has written the following analysis of the public reaction to the TV program under discussion:

"The most astonishing UFO TV documentary aired to date, on October 14, 1988, with Mike Farrell as the host, had all the ingredients of a blockbuster. Note just some of the cast of characters: 1) A Russian scientist, revealing that aliens have landed in Russia and contacted their military personnel. 2) Two CIA agents, identities disguised, revealing that extra-terrestrial aliens are now the "guests" of the U.S. government". 3) About a hundred residents of Gulf Breeze, Florida, who have witnessed and photographed the extensive UFO activity in their home town. 4) Abductees telling their own stories under hypnosis. 5) Expert witnesses from the military saying that sightings they reported while in service "disappeared" from the records. 6) A psychiatrist reporting that abductees she has treated were sane and suffering from trauma as a result of their contact with aliens. 7) Evidence by investigators of crashed UFO sites. 8) Testimony from Budd Hopkins, who has investigated hundreds of abductee cases for over 12 years, that genetic experiments are being performed by aliens on humans on a large scale. 9) Other witnesses, each expert in his/her own field, testifying to the validity of photographic or other tangible documentation of UFOs. 10) Paintings of aliens drawn by artists from the testimony of witnesses.

Surely, even by Hollywood standards, here are all the ingredients of a box-office hit. Was it a hit? Well, during the two-hour show, 75,000 viewers did pay one dollar each

to have their phone-in vote about their belief in human-alien contact recorded. What other signs of success made the front page? Not a one! The show was a flop in terms of arousing public interest. How can this be? How could such a carefully concocted combination of ingredients, culminating in the most news-worthy disclosure in human history, not elicit a bang, nor even a whimper?

I played a video-tape of the show to my adult education class on alien-human contact. I watched the reactions of my class members. Thanks to the review/playback capability, I was able to conduct some experiments.

The adult students who signed up for this course were believers in the possibility of human-alien contact. Some even had personal experience of contact, yet after the screening they were more doubtful than before! Wow! I then recognized that UFO COVER-UP!...LIVE! made a brilliant use of the best of propaganda techniques. IF you have a tape of the show, watch it again, and listen carefully to the soundtrack. Look at the painted backdrops and, most important look at Mike Farrell's reactions.

You will see and hear some interesting contradictions. The astute viewer cannot dismiss these contradictions as sloppy production. The production HAD a huge budget, and was planned many months in advance. In fact, Budd Hopkins reported to me that each witness was interviewed at length before the show, then certain words of that interview were selected to be used. The words were put on cue cards, and the night of the show, the witnesses were allowed to say only what was on the cards. UFO COVER-UP?...LIVE! was carefully rehearsed. Reading from cue cards, unless one is experienced in doing so, gives the words a stilted sound which many listeners take as phony. Score one for not believing the witnesses.

Score two: When we listen to words spoken over background music, the music makes an unconscious impression which flavors the emotional impact of the words. For example, the relentless "approach", louder and louder in intensity, of the orchestration of the JAWS sound-track as the shark nears its victim builds up a feeling of dread even before any action takes place. The background music for UFO COVER-UP?...LIVE! is light, pleasant dance music. While the Russian is speaking of terrifying abductions, the music is a rousing polka!

Score three: when the Russian says, "The aliens communicated with the terrified soldiers by mental telepathy.", Mike Farrell responds, "Oh, they used music just like in the movie Close Encounters." We depend very much on the reaction of others to set our own reaction. Obviously, if someone tells you a story and they are laughing, you think the story is funny. If they are in a panic state while telling it to you, you think of it as tragic. Throughout the entire show, Mike Farrell reacted to all the UFO information with puzzlement, but in an amused and light-hearted manner. So, for the most part, the audience did too.

Score four: through the skillful but unobtrusive use of another media technique, the painted backdrop against which the alien Greys are portrayed is, believe it or not, a bright sunny room overlooking a garden! Nothing to take seriously there, certainly nothing to worry about.

(Note by G.A.: I would like to add that the depictions of the Greys were idealized, and did not conform to witness descriptions, giving the impression of benign Disneyesque animated characters.)

Score five: another powerful media technique is to trivialize something important by focusing on a tiny detail. For example, of all the things we could learn about alien life forms, the least important is what flavor of ice cream they prefer: Telling the audience that the aliens "prefer strawberry ice cream" reduces these mysterious life forms to a childish format.

Score six: we are so accustomed to Hollywood movies that we are entertained by a "historical" film, but never for a moment truly believe that the "action" taking PLACE ON the screen is real. We know it is rehearsed and played by actors. When Mike Farrell puts the UFO reports in the same category as the movie Close Encounters, the

audience automatically thinks of the TV documentary UFO COVER-UP?...LIVE! as just another Hollywood movie. No one writes a letter to the editor of their local newspaper or phones their Congressman to demand action about a crime committed in a Hollywood movie. There is more. I HAPPEN to know one of the women presented in the documentary, who has been abducted by aliens. Her entire life has been affected by her terrifying alien contact. The one and only comment highlighted on the cue card for her to use on the supposedly "LIVE!" Mike Farrell show was, "Oh, he's so ugly." When my students heard this, they giggled! They took it to be comical.

Neither my students nor the majority of the viewing audience took the UFO COVER-UP?...LIVE! program seriously. That is why there was no audience response. One of my students said he thought: "The man portraying the Russian couldn't have been a real Russian, because he spoke English too well." No doubt he was trying to account for why the show did not have the ring of truth to it.

The question remains: were the producers of the show, whoever they really are, PLEASED that their show was a "flop", in that few Viewers of it took the reality of alien-human contact (or invasion) seriously? Or were they disappointed by the lack of audience response? What, indeed, was the real purpose of this carefully staged show?

The format in which UFO COVER-UP?...LIVE! was presented tranquilized the general public, as did the movies E.T. and Close Encounters of the Third Kind, in the comfortable belief that there is absolutely nothing to worry about, as far as any reports of alleged "aliens" are concerned."

As Dr. Mundy has pointed out, this comfortable belief system so assiduously maintained by the authorities through their constant insistence on relegating anything pertaining to the subject of alien intervention in human affairs to the realm of media trivia, relies for its support on some very thin ice indeed.

This ice is so thin that it can be shattered by featherweight random events, such as the arrival in my mailbox of a letter from Rev. John E. Schroeder of the UFO Study Group of Greater St. Louis, saying: "You mentioned William Moore's TV program hosted by Mike Farrell. Is it any surprise that the November 1989 issue of prestigious Millimeter magazine for film and TV producers listed the CIA as paying producer for that show? I wonder what happened to the response requests? Who effectively collected whose paying phone numbers? Why? How are they to be used? Was any data ever given congressional members! The plot thickens!!"

SPECIAL REPORT 2

UFO/MILITARY CONFRONTATIONS

General Discussion

Secretary of the Air Force Robert C. Seamans, Jr., announced today (December 17, 1969) the termination of Project Blue Book, The Air Force program for the investigation of unidentified flying objects (UFOs).

In a memorandum to Air Force Chief of Staff General John D. Ryan, Secretary Seamans stated that "the continuation of Project Blue Book cannot be justified either on the ground of national security or in the interest of science," and concluded that the project does not merit future expenditures of resources.

The above two paragraphs are the beginning of the Department of Defense News release, terminating Project Blue Book. From these two paragraphs, we can see that the Air Force was publicly stating that UFOs did not have any scientific value nor did they represent any threat to our national security.

If UFOs do not have any scientific value, why is it that to this very day every scientific branch of the American Intelligence Community has a "scientific interest" in the phenomena? Especially what is termed by the American Intelligence Community as "UFO Technology." But this is the subject of another Special Report.

This report deals with military confrontations with UFOs and the American Intelligence Community's reaction to them. This report will attempt to show that the American Intelligence Community, for reasons that remain unclear, do in fact consider UFOs to be a matter of national security.

I believe that before we discuss file cases, we should define a couple of terms in order to better understand what the intelligence community considers to be a UFO and what is meant by the term "national security." For the purpose of this report, I will use the Department of Defense definitions for both these terms.

UNIDENTIFIED FLYING OBJECT (UFO) - The definition of an Unidentified Flying Object is any airborne object that by performance, aerodynamic characteristics or unusual features does not conform to any presently known type of aircraft or missile, or which cannot be identified as a known object or phenomenon (Source: Project Blue Book Briefing given the Air Defense Command, 1952).

NATIONAL SECURITY - A collective term encompassing both national defense and foreign relations of the United States. Specifically, the condition provided by: a. a military or defense advantage over any foreign nation or group of nations, or b. a favorable foreign relations position, or c. a defense posture capable of successfully resisting hostile or destructive action from within or without, overt or covert (Source: Joint Chiefs of Staff Publication 1, Sept. 3, 1974).

SECURITY - A condition which results from the establishment of measures which protects designated information, personnel, systems, components and equipment against hostile persons, acts, or influences (Source: Joint Chiefs of Staff Publication 1, Sept. 3, 1974).

I would ask the reader of this report to keep these definitions in mind as we go over the file cases; keeping in mind that the American Intelligence Community still has information on these cases classified at least SECRET and in many cases the information is classified TOP SECRET with Sensitive Compartmented Information (SCI) access restrictions.

Case Files

File Case 1 (Cuba, March 1967)

In March 1967, the 6947th Security Squadron based with the Boca Chica Naval Air Station near Key West, Florida recorded this incident. The mission of the 6947th was to monitor all Cuban military communications.

Cuban radar installations reported a bogey approaching the Cuban land mass from the northeast. Two MIG-21 fighter-interceptors were scrambled when the bogey crossed into Cuban air space at an altitude of approximately 32,000 feet and an air speed of about 649 miles. The scrambled flight was directed to within 3 miles of the object by Cuban Ground Control Intercept (CGCI). Both pilots made a visual of the object and the flight leader radios to CGCI that the object appeared to be a bright metallic sphere with no visible markings or appendages. At this point, the flight leader made a futile attempt to contact the object for identification. Failing to get a response from the object, Cuban Air Defense Headquarters ordered the object destroyed. The flight leader armed his on board weapons systems, achieved a radar lock on of the object and directed his wing man to follow him in on the combat run to engage the object. Seconds later the wing man broke off his approach to the object and started screaming to the ground controller that the flight leader's aircraft had exploded. After regaining his composure, he further reported that there was no smoke or flame, the flight leader's aircraft had disintegrated. CGCI reported that the object then quickly accelerated and climbed beyond 32,000 feet and at last report was heading south-southeast towards South America.

A spot report was immediately sent priority to the National Security Agency (NSA) as is standard procedure in cases involving the loss of military aircraft by a nation that is potentially hostile to the United States. The NSA is required to acknowledge receipt of such a report. However, in this case they did not. Therefore a follow-up report was re-transmitted. Several hours later the 6947th was directed to ship all records pertinent to this case to NSA Headquarters and to list the loss of the aircraft as an equipment malfunction.

The NSA still maintains all records and pertinent intelligence on this case classified at the TS/SCI level.

File Case 2 (Iran, 19 - 20 Sept. 1976)

At about 0300 hours on 19 September 1976 the operations office at the Imperial Iranian Air Force's command post in the Tehran area received four telephone calls from citizens living in the Shemiran area of Tehran saying that they had seen strange objects in the sky. Some reported a kind of bird-like object while others reported a helicopter with a light on. There were no helicopters airborne at that time. A senior officer at the command post, after telling the citizens it was only stars had talked to Mehrabad Tower, decided to look for himself. He noticed an object in the sky similar to a star but bigger and brighter. He decided to scramble an F-4 from Shahpokhi AFB to investigate.

At 0130 hours the F-4 took off and proceeded to a point about 40 nautical miles north of Tehran. Due to its brilliance, the object was easily visible from 70 miles away. As the F-4 approached a range of 25 nautical miles the pilot lost all instrumentation and communications aboard his aircraft. He broke off the intercept and headed back to Shahpokhi. When the F-4 turned away from the object and apparently was no longer a threat to it the aircraft regained all instrumentation and communications. At 0140 hours a second F-4 was scrambled. The backseater (instrument officer) acquired a radar lock on at 27 nautical miles in the 13 o'clock high position with the VC (rate of closure) at 150 nautical miles per hours. As the range decreased to 25 nautical miles the object moved away at a speed that was visible on the radar scope and stayed at 25 nautical miles.

The size of the radar return was comparable to that of a KC-135 tanker. The visual size of the object was difficult to discern because of its intense brilliance. The light that it gave off was that of flashing strobe lights arranged in a rectangular pattern and alternating blue, green, red and orange in color. The sequence of the lights was so fast that all the colors could be seen at once. The object and pursuing F-4 continued on a course to the south of Tehran when another brightly lighted object, estimated to be one half to one third the apparent size of the moon, came out of the original object. This second object headed straight toward the F-4 at a very fast rate of speed. The pilot attempted to fire an AIM-9 missile at the object but at that instant his weapons control panel went off and he lost all communications. At this point the pilot initiated a turn and negative G drive to get away. As he turned the object fell in trail at what appeared to be about 3 to 4 nautical miles. As he continued in his turn away from the primary object, the second object went to the inside of his turn then returned to the primary object for a perfect rejoin.

Shortly after the second object joined up with the primary object another object appeared to come out of the other side of the primary object going straight down at a great rate of speed. The F-4 crew having regained communications and weapons systems, watched the object approach the ground anticipating a large explosion. This object appeared to come to rest gently on the earth and cast a very bright light over an area of about 1.2 to 1.8 miles.

The crew descended from their altitude of 25 miles to 15 miles and continued to observe and marked the object's position. They had some difficulty in adjusting their night visibility for landing, so after orbiting Mehrabad a few times they went out for a straight in landing. There was a lot of interference on the UHF (radio) and each time they passed through a magnetic bearing of 150 degrees from Mehrabad they lost their communications and the INS fluctuated from 30 to 50 degrees.

The one civil airliner that was approaching Mehrabad during this same time experienced communications failure in the same vicinity but did not report seeing anything.

While the F-4 was on a long final approach the crew noticed another cylinder shaped object (about the size of a T-Bird at 10 miles) with bright steady lights on each end and a flasher in the middle. When queried the tower stated there was no other known traffic in the area. During the time that the object passed over the F-4 the tower did not have a visual on it but picked it up after the pilot told them to look between the mountains and the refinery.

During daylight the F-4 crew was taken out to the area in a helicopter where the object apparently had landed. Nothing was noticed at the spot where they thought the object landed (a dry lake bed) but as they circled off to the west of the area, they picked up a very noticeable beeper signal. At the point where the return was the loudest was a small house with a garden. They landed and asked the people within if they had noticed anything strange last night. The people talked about a loud noise and a very bright light like lightning. The aircraft and area where the object was believed to have landed were checked for possible radiation. The results of that check remains classified by the American Intelligence Community.

File Case 3 (Peru, 9 & 10 May 1980)

On May 9, 1980 a group of Peruvian Air Force officers in formation at Mariano Malgar spotted a UFO that was found in shape, hovering near the airfield. The air commander scrambled an SU-22 aircraft to make an intercept. The pilot intercepted the object and fired upon it at very close range without causing any apparent damage. The pilot tried to make a second pass on the object, but the object out-ran the SU-22.

During the night of May 10, 1980 a second object with lights was sighted. Again an SU-22 was scrambled, but the object out-ran the aircraft.

The State Department telex concerning this incident made this very interesting comment about the incident, "Apparently some vehicle was spotted, but its origin remains unknown."

File Case 4 (Brazil, May 19, 1986)

At least 20 unidentified flying objects were observed by several aircrews and on radar the night of May 19, 1986. The objects were first seen by the pilot of a Xingu aircraft, transporting Ozires Silvea, former President of Embraer, between Sao Paulo and Rio De Janeiro. Fighters were scramble from Santa Cruz Air Base at approximately 2100 hours. Although three made radar contact, only one of the three pilots managed to see what he described as red, white and green lights. Shortly afterward, radar contact was made with similar objects near Brasilia and three mirages (jet fighters) were scrambled from Annapolis Air Base. All three made radar and visual contact at 20,000 feet. They reported that they were escorted by thirteen of these disks with red, green and white lights at a distance of one to three miles. The objects then rapidly disappeared from both ground and airborne radars.

The Air Minister is quoted by the press as saying there were three groups of targets on the ground radar and that the scopes of the airborne radars were saturated. The State Department Telex concerning this incident made this comment, "There is too much here to be ignored. Three visual sightings and positive radar contact from three different types of radar systems leads one to believe that something arrived over Brazil the night of 19 May."

CONCLUSIONS

The cases cited above are but a small representation of the volumes of information the American Intelligence Community has on cases similar to those cited in this report. However, those cases remain classified in the interest of national security. To be sure, the American Intelligence Community even has information on the cases cited that is classified at the TS/SCI level, once again in the interest of national security.

Regardless of what the United States Air Force states publicly, the official record clearly indicates that the Air Force, as well as the rest of the intelligence community, considers incidents such as those cited, by the fact that so much information concerning UFO/military confrontations remain classified in the interest of national security. The reason(s) for the classification of this information remain unknown to the general public and UFO researchers alike. 18

It is the conclusion of this researcher that based on the best available information from the United States Government some type of aerial objects, displaying technology that no nation on the face of the earth currently has, is operating in the air space of the United States as well as every other nation on earth. Also, these objects seem directed and with purpose; under intelligent control not of this world. Furthermore, and this is the most frightening aspect of all, these objects can come and go as they please and the nations of the world are powerless to do anything about them other than watch and observe.

It may be the fact that we are powerless to do anything that has led the governments of the world, to include the United States, to deny the existence of these objects and classify the subject matter to such a high degree. After all, no nation wishes to express a sense of helplessness in any situation as this could lead to a sense of insecurity on the part of the people, as well as the governing body, of that nation.

The American Intelligence Community, especially the United States Air Force, has been made the fall guy in the so called UFO cover-up. I believe that it should be made clear at this point that every existing government on the face of the earth has classified information concerning UFOs; not just the U.S. Government. Also, I feel that much of this information is classified to protect such things as methodology, technology, locations and identities of intelligence operatives vital to intelligence operations; all correct and legitimate concerns of any intelligence agency. Furthermore, I feel it is necessary to state, having some knowledge of the intelligence community, that there exist no greater dedicated people in the world than those within the intelligence community.

However, I feel that in order to be more open in government and to ensure an informed public, the American Intelligence Community needs to reconsider its thought and position on those documents that have thus far been denied the public.

UFOs are deserving a closer look by the scientific community and the only way this will happen is with the U.S. Government making available to the scientific community all the information the government has on UFOs. This includes the information presently classified in the interest of national security.
