


is what you see really me?


When you open your hand



Dear Aileen,

At the March UFOCCI meeting, I obtained a copy of the January 1992 "The Missing Link." That issue printed three letters from Tro, dated 9-20-1991 Over Russia, 10-19-1991 In General Transit, and 11-18-1991 Ticonderoga, N.Y. identified as Letter 4. Subsequently, you graciously gave me a copy of Letter 1 dated 6-5-91 Kissimmee, Fl, and Letter 5 dated Leap Year Day [2-29?] 1992, Manchester, England from which you read a part at the meeting.

I assume that the UFOCCI printed a statement of its purpose or policy, such as: organized as a forum to promote the awareness of sentient beings from beyond Earth, and for empathetic assistance to those who contacted such beings.

If so, I'm disappointed by letters from UFOCCI associates who responded to Tro's letters. Each of these writers probably believe their own experience with UFOs is "real." Yet, isn't it amazing that some instantly ruled that the contact that readers of TML have with Tro (via his letters) is a hoax! Come on, let's lighten up.

This to me, is hilarious. Are everyone's dreams dashed apart so often in life they haven't got any trust left? Can't we laugh at ourselves when we are gullible and let ourselves be suckered in on a prank? Don't we all love a good magic show, or a mystery story? Don't most of us enjoy a joke with a surprise ending? Well I do.

I think the crop-symbols are not any joke or hoax. They're pretty heavy-duty stuff. It takes a lot of technology to produce them. I'd like to learn what they rebzen for Earth-humans.

Are Tro's letters a proffered contact for finding out the answers to these, and other presently baffling, puzzles? In what tenor should we logically accept them? I want to publicly thank Tro for the offer to meet with our friends in our larger family. Please, Tro, may I have a ride with you to "France"?

For the past year or so, I've worked up a mathematical formula to determine how to predict the swift-changing "location" of any thusfar undetected planets in our Sol's system by the relationship of the masses of the bodies to their periods (orbital revolutions).

Astronomers at the University of Washington, state there is no such determination possible. Well, so much for them and data from the International Astronomical Union (France).

According to my comps, we should have a planet near the orbits of the Earth/Eros, and two more bodies beyond the Neptune/Pluto loops. I believe we can determine fairly accurately the mass and orbital radii of these bodies. The problem we have is knowing where to look along the 50 billion mile circumference for these planets. This assumes they are within seven degrees plus/minus the ecliptic.

Tro, would you kindly let us know where to find these planets? Would that be a sufficiently innocuous "prediction" for Earth's sci community to verify when the source for the data is through TML?

Re our written "English" language: During the past 800 years no one knew or classified the rules for spelling the speech sounds of English words and published these rules for others to see. Also, during those centuries no one made a major change to the Roman-English alphabet. It badly needs fixing. We've only 26 letters for those speech sounds-- several of which are unneeded such as K, Q, X.

I've researched the spelling rules for combining the letters of so-called English for more than 35,000 hours. That's equivalent to eight hours a day for fifteen years. Americans use forty-two basic speech sounds. We have 1719+ categories of ways to spell those 42 speech sounds. This averages 41 ways to spell each sound!

We need 21 new letters to rebzen the remainder of our speech sounds. I've studied the evolution of the forms of the alphabet letters, print, calligraphy, etc.. So language symbols, such as appear in perishable form in grain fields, fascinate me.

A circular area, such as cut out from a piece of paper, is the most basic concept for a child to grasp. Folded over on itself this produces a straight line. Again folded, produces the concept of right angles, cross, quadrant, and three dimensions-- which, moved through space becomes a "fourth" dimension involving time.

Every Earth human is born into the fourth dimension, like it or not. To me it's really the First Dimension. Collapsing it into three or two dimensions is illogical, unless for mental exercise. The human soul is placeless and timeless. Therefore infinite. Therefore we "really" only exist in the Zero, Nul, dimension.

Mathematical formulas that have "everything" on one side of an equation equal to "everything" on the other side of the equation (which is 0 or Nothing) to me shows a constricted outlook. The Zero (0) is just a Standard One. (Mathematical $0 = 1$.) This One, plus the many other Standard Ones, all added = The One universe = All.

This is why I know that you, Tro, come from the same universe as the rest of us here. There is nothing outside of the Universe. If it's connected someway, then it's the same universe. Otherwise, "You can't get there from here."

We are all one, with our origin from the One Creator. Should anyone be afraid of that fact? We're more than just friends, we are family. Did some of the letter-writers mentioned above forget that?

Do the agriglyphs in the "grain" fields relate to the quantum particles (seeds) in the Earth's magnetic and other "fields"? Does the flux of the forces of particle physics (energy) and of the Earth itself, overlap and intertwine as demonstrated by the grain stalks?

Thank you very much on behalf of us appreciative ones, re meteor-deflect, politi-stabilizing, enviro-rescue, ozonitting...

6 PONCEANS AFFIRM TWO "CREATURES" INSPECTED PAN DURING PASSING

ADJUNTAS--Six residents of Ponce who encamped last October 27 on land nearby the new deviation of 10 street, had a tremendous scare when about 4:00 a.m. they were visited by two extraterrestrials who even examined the contents of a pan where there was a rabbit in fricassee. John John Leon explained that one of the beings had an oval face, small nose, three feet height and big leaping eyes.

This species of extraterrestrials is which investigators of UFO phenomenon describe as "Rigelians," because they come from the planetary system Rigel. The strange visitors made noises in the small camping house while they took the pan lid off where the fricassee was kept. Leon, a factory supervisor in Ponce, does not know if the beings ate the food, although, he said that they left the pan lid turned upside down.

"We were camping in the land near the spring when those things appeared," the young Leon commented. He rebuffed that the visitors were common rogues, because he could see one of them almost from the front. He said besides that he saw a small hand taking the pan lid off, then seconds later, it fell to the ground making noise.

As for Mr. Leon, he made clear that he did not see any UFO, but he reassured that the aliens were about to take the pan with the tasty rabbit fricassee.

AGAINST UFOS

LAJAS--In an apparent attempt to impede people from talking about supposed experiences with UFOs and "visitors" from other planets, the local police department is not paying attention to calls from citizens that ask them to investigate the subject. This editor knew that a sergeant, whose last name is Toro, made fun of a resident's call that reported a strange flying object near the Aerostat.

Also Anibal Roman Morales, Regional Director of the Civil Defense, convened a meeting of the press tonight at 10:30 pm where they want to prove that the colored lights seen by some citizens are the reflection of the lighting system of Candelaria District. The official will promote a blackout to establish his theory.

It has become known that Roman Morales has united himself with a group of representatives from state and federal governments who cast ridicule on those who believe in the UFO phenomenon.

However, hundreds of people continue calling radio dials of the west area and the local editorial staff or El Vocero, to tell about their experiences. The most recent case is about a sighting made by Mrs. Joselyn Irizarry, resident of this population.

She alleges that she and her husband were returning to their house when they saw a big UFO above a mountain in Lajas. The lady told Jorge Martin that the object was much bigger than the Aerostat located in Olivares district, and that it stayed there for 5 minutes. "It seemed like a plate above the mountain," the lady explained to Martin. She also said that the UFO had different colored lights.

In this case, the lady communicated with the police department, but they made fun of her. The informant pointed out that Sergeant Toro told her not to tell anybody about what she saw, and he tried to make her believe that what she saw was the Aerostat of Lajas.

THINKS UFOS CURED HIS LEG

PONCE -- To coincide with the manifestations of the merchant Amador Piazza Velez, who alleged to have seen an enormous flying object perched on a mountain of Las Cucharas sector, fisherman Jose Maria Fernandez Martinez said, both he and his wife Gloria Santiago had the same experience Friday of last week. Also Fernandez Martinez showed to this editor the video tape where something similar to a UFO appears that emits different colored lights.

The fisherman, resident of the mentioned sector, explained that the strange object was suspended above the mountain for more than 10 minutes which gave him the opportunity to record the movie. He clarified, however, that the camera had defects at the moment of recording the UFO. The result of this case is that Fernandez Martinez affirms that since the night when he saw the UFO, his left leg was unexplainably cured from a serious lesion.

The fisherman pointed out in front of several witnesses that he had been bitten by a shark and the wound he suffered would take a long time to heal. Fernandez Martinez, who is the father of 7 children, showed his left leg completely cured and a scar big enough on the heel of the mentioned leg.

"I cannot tell that the beings who came in the ship cured me, but something strange happened to me because my wound closed since that night," the fisherman argued. On the other hand, Fernandez Martinez told that his wife, Gloria Santiago, saw strange lights leaving the sea in the area of El Tuque. "The sea was in completed clam and there was no breeze while those lights left the water," Fernandez Martinez claimed.

The sighting of Unidentified Flying Objects does not have limits just in Cartagena de Lajas Lagoon and the population of Adjuntas. Residents of Las Cucharas de Ponce sector, alleged seeing strange lights, but held that they prefer to keep quiet to avoid people saying they are looking for notoriety.

MAYOR WHO WAS A WITNESS TO A SIGHTING IS WAITING BUSH'S RESPONSE TO HIS LETTER

ADJUNTAS -- While the State Civil Defense has issued orders to investigate all related with the supposed sightings of Unidentified Flying Objects (UFOs) in different sectors of the Island, the mayor of this town, Rigoberto (Pucho) Ramos, continues waiting for the federal authorities to answer a letter he sent to President Bush. The incumbent wrote to Bush, after being witness along with other people, of the presence of strange lights that moved in the Adjuntas sky.

Relatives of the New Progressist Mayor indicated that Ramos has the genuine concern to know if, in effect, there are UFOs furrowing the local air space or if the federal authorities are making an experiment.

"This is a subject that we are treating with the seriousness it deserves," reiterated the radical reporter Edwin Plaza, who expressed he knew nothing about President Bush's answer to Mayor Ramos or if he has referred the subject to any government agency. The civil leader did not discard that the investigation initiated by the State Civil Defense, would be a result of the steps made on this level.

APPEARANCES CONTINUE

Meanwhile, residents of this mountain town continue reporting sightings of strange flying objects that move at great speed.

Some allege that UFOs, some with oval and luminous shapes, have converted Las Minas Sector into a "UFOport." This area is rich in copper, iron, silver and other valuable minerals.

At another region, from the neighborhood of Palo Hincado in Barranquitas people reported about a sighting of a strange ship with a triangular shape that kept suspended near a mountain in that place. An informant explained that the object, bigger than a truck, was in the Palo Hincado sky for some minutes and then it displaced to an unknown course. This informant asserted that it was not a plane or helicopter, because the supposed ship did not emit strong noises, except a sound similar to a radio out of frequency.

THEY OBJECT PROOF TO LESSEN STRENGTH OF UFOS

LAJAS--About 200 people met last Monday night in the suburbs of Cartagena Lagoon to observe the blackout induced by several government agencies with the purpose of establishing that there is no presence of UFOs in this body of water.

Personnel of the Electrical Energy Authority suspended the electric service for some minutes affecting Candelaria and Palmarejo precincts. After that, they focused a reflector on the center of Cartagena Lagoon intending to prove that the strange lights observed in that place are produced by reflections. However, during this experiment, the yellow, red, green and blue lights observed by this editor and other western residents did not appear.

Both federals of the Civil Defense and Police Department are trying to discourage people who continue frequenting the mysterious lagoon located in the municipal limits of this town.

The experiment made last Monday night was initiated by Anibal Roman Morales, Regional Director of Civil Defense in Mayaguez. In spite of Roman Morales insisting that the strange lights in the lagoon are reflections of the lighting system in Candelaria precinct, believers in the UFO phenomenon rejected that version.

Wilson Sosa, resident investigator in Cabo Rojo, alleged that Roman Morales is lending himself to the people who intend to subtract credibility from this subject. According to Sosa, the mysterious colored lights seen in Cartagena Lagoon come forth from the water to the outside and not upwards to downwards.

"They are not going to hide a truth even by using hundreds of these experiments," he emphasized. Visitors from New York and Dominican Republic went to observe the spectacle set up by Roman Morales and the Lieutenant Rafael Rodriguez, Police Commissioner of Lajas District. West area residents summoned the Regional Director of Civil Defense last Monday for him to show the same interest in clearing up the gases problem by making experiments to those effects that since many years ago affects the complex of the Free Zone of Mayaguez.

Space aliens communicate with cafeteria employee

Paula Watson works in the kitchen of the high school cafeteria and has been visited by aliens for the past nine years.

Watson resides in Mt. Vernon with her husband, Ron, and their two children. They used to live in Greenfield where they first encountered the alien life forms.

"The first thing I saw were two little grey beings," said Watson. "They were standing by a cow in our field and they had their hands placed above the cow. All of a sudden, the cow and the little grey beings started floating toward the hillside where they finally disappeared."

The next day her husband saw strange lights in the sky and a cone-shaped object which he believed to be a UFO, but the cow was never to be seen again.

As might be imagined, Watson was terrified by the creatures.

"I was scared to death because I knew they weren't human," she said. "I always thought there was

other life in the universe, but I never thought I would see it."

Watson describes the creatures as being a kind of grey or silver color, with very skinny bodies, about three and one-half feet tall. She said they had big heads, long fingers, and were wearing tiny back packs.

Coincidentally, this description matches the description given by others who have witnessed alien beings.

"Our sighting is almost common," she said. "We have contacts from Pennsylvania and Texas and other places, as well, where other people have seen the same things we have."

Besides just seeing the creatures, Watson said she was abducted by them, however she does not remember the actual occasions. She has recurring dreams and has been professionally hypnotized three times, during which she has described in the detail, the events of her abductions.

Watson has encountered aliens around twenty different times

and seen other species besides the grey beings. She has seen lizard-like, or reptilian creatures, and she says there are at least 12 different types. Some of them are good and some are bad.

"The evil ones will not harm you as long as you believe in God," she said.

Watson said she has also spoken with the aliens.

"Their voices are like nothing I've ever heard before," she said. "Sometimes they have communicated with me telepathically, but the first time they spoke to me they said, 'We are your neighbors.'"

The Watsons have spoken at international conferences in Arizona and Las Vegas, where people from all over the world gather to talk of their alien life experiences.

"I like going to the conferences," Watson said. "It makes me feel better to know that I am not alone, and talking to others helps me deal with the situation."

Their case has been docu-

mented in the film *Earth Mysteries*, *Alien Life Forms*, and the couple is now working on their own book, due out in about six months.

Although Watson is willing to share her experiences, she does not advocate searching for your own alien encounters.

"Don't go looking for the aliens unless you know what you are doing," she said. "Be cautious. There are a lot of things out there."

Certain aspects of the whole ordeal tend to puzzle her.

"I just wonder why they picked me out of everyone else," she said. "I guess I was just there at the time."

Watson said she realizes some people may disbelieve her, but she doesn't seem to let it bother her.

"Sometimes I wish it wouldn't have happened because people can be so judgemental," she said. "It makes me believe me then that is fine. They have the right to their own opinions, but all I know is what I have seen with my own two eyes."





UFOs, ETs AND YOU

IN THIS BUSINESS I MEET a lot of people from all over the world who have had UFO experiences. People sometimes go to considerable lengths to look me up — and I'm glad they do. Even though some of what I hear I have heard many times before in different variations, occasionally someone comes along with information that really gets my full attention and response.

I recently met three people from Florida, two women and a man, who, by the most unusual succession of "coincidences" went for an eight-mile round-trip walk with myself and a friend into Secret Canyon. The hike itself was very nice, but I found myself frequently wondering what the whole purpose of this meeting was, because it was becoming clearer as the day wore on that some higher power had somehow arranged the whole thing. It's too long and detailed a story to go into here, but I have seen and experienced these orchestrated coming-togethers many times before.

At times it is very eerie, almost uncomfortably so. The two women, from their visions, knew exactly what my friend Alan and I looked like before they met us. Not only that, they even knew our names, though they'd never heard of my books. One woman even had precise premonitions of what Secret Canyon looked like. Neither of the women had ever been in Secret Canyon before that day. (Incidentally, I believe that in the future, Secret Canyon will become one

of the world's premier power spots (even after Sedona is overdeveloped, as it is rapidly becoming.)

Secret Canyon, due to its remoteness in National Forest land, will retain its mysterious nature. I have scant explanation of what might exist there, but whatever "it" is, it is quite extraordinary. It is a long day's walk into Secret Canyon (minimum six miles round trip), but well worth it. Once you get to the mouth of the canyon you have to go at least one or two miles more to experience the effect — and it is not always positive. One usually can't get into Secret Canyon in late December through March due to deep snow in its shadowy depths.

That day of the hike I was wondering what the real intent, purpose, or benefit of the get-together was. I found out, at least from my personal perspective, in the evening when we all went into Sedona for dinner. One of the women, a Polynesian originally from Tahiti, began to describe some of her lifelong UFO experiences. What she talked about was rather intense, and the information forced my mind to shift into high speed as I put together bits and pieces from hundreds of similar incidents I had studied.

She said that from early childhood she had had close encounters with UFOs and ETs, to the point where she often had painful difficulties with relatives and friends. They thought she was making stories up — or was crazy. (I think she is consciously or unconsciously serving some meaningful plan by her involvement in all this.) She has had direct contact with a variety of human and humanoid extraterrestrials since the age of three or four. As a young child she was often taken to a room that seemed to be nearby by "government" agents who asked what the aliens had told her and what she had seen during these alien encounters. These interrogations occurred so many times that it almost destroyed

her relationship with her mother, who would at times lock her out of the house because of her complete frustration over the whole matter.

Individuals like the Florida woman who have had these kinds of experiences now have lots of other people to share with and relate to. I have met many geographically isolated people who were completely despondent because they had absolutely no one to talk to about their ET/UFO experiences. I knew this Florida woman was not fabricating her story because I have heard it so many times before in slightly different variations. There are certain questions I ask abductees/contactees to determine whether they are suffering from some sort of delusion or are merely repeating something they read in a book. In five years of interviewing people who have had paranormal encounters, I have run across only two I was certain were lying.

That evening in our conversation I got to the question I almost hated to ask her, one I had been putting off. I asked, "Have you had any pregnancies or fetuses disappear in the third or fourth month?" She looked at me with a wide-eyed, astonished expression, and I knew her answer. She exclaimed that yes, she had had three pregnancies disappear at between twelve and sixteen weeks over a long span of time. These were medically confirmed pregnancies, even though in one instance she hadn't had sex for several years. (Except for a short marriage, she has been single all of her life.)

I have heard all of this before many times. The Florida woman also has memories from an altered state of holding alien/human-looking babies. They were hers. (In the last pages of my book, *The Alien Tide*, there is a painting by a Pennsylvania resident, David Huggins, of these human/alien hybrids.) The upshot of all this — and it is the only conclusion that can be made in the light of overwhelming evidence — is that our human race is being crossbred with a humanoid but nonhuman race of beings. Why?

Is this half-human, half-alien new race going to replace us here on Earth after some cataclysmic event befalls the Earth? I happen to think so, and I think we will find out soon. There is a remote possibility that their race is dying out and that this new race will replace them — but I doubt that hypothesis. If you have any innovative thoughts on this, I would like to see them. This is an enigma that is not going to go away — and it involves all of us.

DIMENSIONS

Although some New Age individuals speak of "dimensions" as if they understood something essential about them, we must realize that intuitive understandings may not translate into well defined conceptual assessments immediately. Revolutionary information may need time to penetrate a cultural setting before careful and objective studies follow. The first step should be to define the main questions and to study all relevant possibilities.

Many ET sources have revealed that we are about to experience a "dimensional shift" into a dramatically new mode of existence. With this in mind, we sorely need to be aware of the questions this issue raises. There are those that see the expected change mostly as a change in awareness or a change in behavior towards life. Some may be ecological activists and may assume that the underlying physical parameters of the world will remain unaltered. Others believe changes will include predicted geophysical upheavals, which may also be accompanied by a "dimensional shift".

Generally speaking, many of those in the New Age who explore information transmitted by extraterrestrial/ultraterrestrial intelligences accept the concept of a "dimensional shift". However, the time scale of this event and its exact nature is not agreed upon. And, other well established sources of information do not seem to correlate very well either. For example, the most influential theosophical description of dimensions is based upon seven "planes". They are the Physical (dense and etheric), the Astral, the Mental, and the Causal. Then we have the Atomic, Monodic, and Divine (which constitute more universal or cosmic planes). On the other hand, Yogi Ramacharaka in Life After Death, makes a clear distinction between "planes" and "subplanes", but categorizes human existence after death as occurring mostly in the "Astral World". Apparently, his version of what the Astral World is includes several of the planes mentioned by the theosophist, but comparisons can be confusing due to the lack of a common ground of well defined concepts.

A contactee, whose identity I wish to keep anonymous, received the information that there are three universes: The Physical (consisting of seven dimensions), the Mental (consisting of three dimensions), and the spiritual (consisting of two dimensions). Extraterrestrials experiencing reincarnation would occupy one of the seven physical dimensions according to their evolution. It seems that we are occupying the Third Physical Dimension of the Physical Universe and progressing towards the fourth. Corresponding "dimensions of consciousness" would be related to each physical dimension.

But, what is a "dimension"?

The American Heritage Dictionary of Science (1986) defines a "dimension" as: a) the size of a figure, especially length, width, or thickness b) any of the three directions or ordinary space, at right angles to each other c) a factor of a term represented by a letter d) a fundamental physical quantity expressed as a factor in an algebraic term. But, what does this tell us?


I would tentatively suggest that a "dimension" can either be thought of as an essential parameter absolutely necessary for imposing certain natural limits in the modes of expression of a specific system of reality or, in turn, be thought of as the entire system of reality itself. Normally, we conceive space as consisting of three dimensions, but theoretically, it is possible to conceive space in four or more dimensions. "Hyperspace" is a good example. The hyperspace of Superstring Theory contains ten or eleven spatial dimensions.


Channelled and ET information have also expressed that "dimension" can be understood as a state of (atomic?) "vibration" and as a state of consciousness. Can we combine all the information available on the subject to begin asking meaningful theoretical questions? Do UFOs operate in the physical etheric level? Can they operate sophisticated physical technologies in the Astral World? Dr. Fred Bell, in his book Death of Ignorance, asserts that the Astral World does not exist in the physical realm of spacetime. He also shows a diagram borrowed from Leadbeater's Man Visible and Invisible, that considers the previously mentioned theosophical "planes" as states of "matter". Does this mean that matter can surpass our definition of what physical is?

Dimensions are said to interpenetrate and interact with each other to maintain a continuity of life throughout Creation. Perhaps Kirlian photography presents indirect evidence--through the connective role of electric fields--of the state of matter called the "etheric". Should we consider the ether as existing in the "Fourth Dimension" or in a Third dimensional negative space (as suggested by Dr. William Tiller and others)?

Questions about an anti-matter universe (complete with all its set of dimensions), questions about natural or artificially created distortions in space-time (what Dr. Valery Uvarov from Russia refers to as "Kronapits") and the most fundamental questions about how consciousness and information relate to manifestation of forms and dimensions need to be considered more seriously. Different UFOs seem to utilize various ways to manipulate dimensions to travel. According to some reports, some utilize either vortexes to nullify inertia. Other reports suggest that some amplify gravity waves to "pull" distant third dimensional space-time location towards them. In the contact notes of Billy Meier, a short explanation is made about a ship being impelled beyond the speed of light and entering "null space and time" where the ship and its occupants are said to become like the energy of thought.

There is much information available both from conventional and unconventional scientific sources, as well as, from contactees. I believe that we shouldn't expect extraterrestrials to spoon feed us information. Our responsibility as co-creators in the New Age is to expand our subjective, as well as, our objective knowledge of Reality. Spiritual insight and **active intelligent inquiry** will be necessary to assess enough information to extend our field of action beyond the Third Dimension involving our current cultural settings.

Next moon explorers will find camp ready

Camping out on the moon doesn't sound like your typical two weeks in the summer at Camp Hiawatha. Instead, returning to the moon — this time to stay — will help America keep its leadership role in manned spaceflight and prepare this country for one of its greatest endeavors: a journey to Mars.

On July 20, 1989, President Bush challenged the nation from the steps of the Smithsonian's National Air and Space Museum in Washington, D.C., to complete Space Station Freedom, set up a permanent outpost on the moon and land human beings on Mars.

Employees of the Boeing Defense & Space Group advanced civil space systems organization in Huntsville, Ala., who are chartered to prepare the company for its role in space exploration beyond the space station, have some pretty good ideas about an early outpost

on the moon.

"The President's goal to set up a permanent outpost on the moon will be accomplished in several steps," said Carl Case, Boeing lunar outpost manager.

"First there will be precursor missions for resource mapping and gravity-field measurements," Case said. "These lunar orbiter missions will be followed by robotic landers that will prepare the way for later manned missions."

One of the most interesting mis-

sions will be to establish a lunar outpost, starting with a campsite, which Case and his group have been working on for a couple of years.

As early as 2000, the campsite could be launched from Earth — unmanned, but fully assembled. It would land on the lunar surface at a location selected by earlier robotic missions.

Once in place, the campsite, consisting of a habitat module, airlock, lander stage, thermal radiators, solar arrays, life-support system and communications gear, would await the arrival of a human crew of four. The human crew would then call the campsite home for up to 45 days.

“The campsite could be used by several crews in succession as a construction facility for the development of a permanent lunar base or as a remote science facility,” Case said.

Campsite technologies will be derived from the operational experience of Space Station Freedom, helping reduce cost and technological risk. In fact, the two space projects share many common technologies, including those for the structure, life support system, thermal control and crew accommodations.

Campsite astronauts will use rovers for exploration.

Boeing’s Apollo rover experience and three years of recent study have produced concepts tailored to lunar exploration.

One concept, called “Rover First,” would put an enclosed-cab pressurized rover on the moon for some time before the campsite arrives.

Controlled from Earth, the rover would travel around the lunar surface collecting data, surveying and performing experiments.

When human crews arrive at the campsite, the rover would be waiting for them, along with all the research it had conducted and specimens it had collected. The


human crew would be able to use the rover to explore in a shirt-sleeves environment, without wearing space suits.

“We’re intrigued by this concept because of its return on investment,” said Brand Griffin, Boeing preliminary design manager. “It starts early, operates with or without a crew, and has a long productive life supporting science and permanent-base development.”

Other lunar surface systems and supporting technologies are being studied by Boeing in Huntsville. They include permanent base concepts, lunar mining and fuel extraction, and an entire family of rover concepts.

About 50 people work for the Boeing advanced civil space systems group in Huntsville, studying lunar and Mars missions, designing the National Launch System and studying on-orbit operations. Another 2,000 are designing and building the core of Space Station Freedom — its pressurized modules, connecting node structures and selected on-board systems. □

How do dreams differ from visions? The second vision I received the night of March 26 to 27, 92. A red-hot missile, appearing on the far eastern horizon like a huge, pulsating fiery ball, moved at lightning speed toward us. Three others with me in a car hurried off the highway toward the right and cautiously parked on a grassy meadow in the dark as we watched this fiery object hurtling by us on the highway we left seconds ago, missing us.

Gazing fearfully toward the horizon, I detected another orange glowing sun. Another missile?

Terrified, I woke up.

Not fully understanding whether these visions pertained to my recovery from the flu or indicated a national threat, a third vision followed on its heels the night of April 3 to 4, 92.

War had broken out suddenly. Crashing explosions moved in closer. Several girls, including myself, ran out of a huge building where we attended a class. From an elevated position, I viewed fire raining from heaven, destroying everything in its wake as far as the East Coast, racing toward us at terrifying speed while crashing with an indescribable roar. Frightened to go back to sleep, I got up and turned on the radio. Instead of the usual rock music or boring news, one lone angelic voice, now joined by a choir, sang heavenly music. I burst out in violent sobs. Is God still with us?

From the radio announcer I learned the choral piece sung was Allegri's, MISERE, recorded by the Tallis Scholars. A coincidence? I let you answer.

Later that afternoon, while weeding, I heard a telepathic message, explaining this last vision was sponsored by The Office of The Elohim Metatron.

A vision addressing Mankind, including **you and me**.

The reason for sharing these visions with you is to appeal to your heart, to pray without ceasing as I do.

The following interview was conducted by Jim McCampbell. It is with Paul Bennewitz's permission obtained through the UFOCCI Center in Roswell, N.M. that we bring it to you.

Some have read this report before but many more have not. To be fully knowledgeable on what has taken place in UFOlogy we share it with you - only for informational purposes.

SUMMARY OF NOTES TAKEN BY JIM McCAMPBELL
CONCERNING TWO TELEPHONE INTERVIEWS WITH DR.
PAUL F. BENNEWITZ, (SIGNED BY WALT ANDRUS,
DIRECTOR - MUFON. DATED SEPTEMBER 19, 1984)

This is Jim McCampbell making a recording of a remarkable episode on July 13, 1984. It has to do with a UFO base, cattle mutilations, advanced weaponry, contact with aliens, etc.

The episode began about a week ago when I received a little semi-annual periodical titled Stigmata. It is Number 21, the First Half of 1984. This little bulletin is prepared by Thomas Adams at P. O. Box 1094, Paris, TX 75460. He has a hotline for reporting possible or confirmed mutilations at 214-784-5922.

He has a rather lengthy article. One finds point of interest on page 9 and I suppose the only way to pursue this is to read what he has here as it is fundamental to the entire story.

Quoting "In May of 1980 a most interesting event occurred in northern New Mexico. An event similar in many respects to the Doraty Case. A mother and her young son were driving on a rural highway near Cimarron, New Mexico. They observed two or more craft and as Judy Doraty did, they observed a calf being abducted. Both observers were themselves abducted and taken on separate craft to what was apparently an underground installation, as well as the dead animal she had observed being mutilated in the field. It has been alleged that she also observed a vat containing unidentified cattle body parts floating in a liquid, and another vat containing the body of a male human.

The woman was subjected to an examination and it has been further alleged that small metallic objects were implanted into her body as well as into her son's body. More than one source has informed us that CAT scans have confirmed the presence of these implants.

Paul Bennewitz, President of his own scientific company in Albuquerque and an investigator with the Aerial Phenomenon Research Organization, has been the principal investigator of the case. Interviewed in his office in April 1983, Bennewitz reports that through regressive hypnosis of the mother and child and his own follow-up investigation, (including communications received via his computer terminal which ostensibly is from a UFO related source), he was able to determine the location of the underground facility; a kilometer underground beneath the Jicarilla Apache Indian Reservation near Dulce, New Mexico. (Since 1976, one of the areas of the U.S. hardest hit by mutilations or whatever.) Bennewitz's information is that this installation is operated jointly as part of an ongoing program of cooperation between the U.S. government and extraterrestrial UFO-nauts. The story continues that after initial contacts years ago, the aliens agreed to give "us" certain technological advances while we provided them with the location for the New Mexico base and at least three others. Plus, the aliens were to be allowed to carry out certain operations, abductions and mutilations without our intervention. The mother and son, by the way, were returned back to their car that night. Since the incident, they have suffered repeated trauma and difficulties as they attempt to recover from the episode. We pass this along because the account is, of course, most crucial if true; but we are not in a position to confirm the alleged findings. Hopefully, more information regarding this incident will be aired in the near future. We can only consider such reports while continuing to seek the evidence to refute or confirm." That's the end of this remarkable quotation from Stigmata.

As I have been studying the idea of bases for aliens for some time, this has caught my attention and I also suspected cooperation between the U.S. Government and the aliens. It also gives the name and locations of a man who has his own scientific operation, Dr. Paul Bennewitz. I tried to get in touch with him. Through the telephone information service I was able to do so. I got in touch with Dr. Bennewitz by telephone and indicated that I had seen this reference to him and his work and I wanted to find out whether he was being misrepresented or whatever. I told him that I would xerox a copy of it and

forward it to him for comments, which I did. This morning, July 13, 1984, he telephoned me and said that he, having looked over the article, found that it was substantially correct. I forgot to mention that in my letter to him I said that none of the details that were in this particular article gave me any strain. Then Dr. Bennewitz, who I will refer to as Paul... He took time to close the door to his office and elaborated upon the whole story and the conversation lasted somewhere near an hour. It is rather mind boggling and here is the substance of that telephone conversation.

The article is basically accurate and he does have the coordinates of the base. He is a physicist and he started four years ago to determine in his own mind whether UFOs exist or do not and he has gotten much more deeply involved than he ever intended. It has caused him a great deal of trouble from the government intelligence groups. He has pictures from the location. He went with a Highway Patrol Officer and they saw a UFO take off from a mesa at the location. He obtained photographs and what he calls launch ships were 330 ft. long and 130 ft. across. The cattle rancher named Gomez and he went back to this location which is a mesa and saw a surveillance vehicle which was about 5 ft by 10 ft, like a satellite, he said. He had been using a Polaroid camera and then got a Hasselblad to produce much better pictures. He set up a monitoring station and observed that UFOs are all over the area. He was also able to pick up signals and obtain video pictures that are transmissions from the aliens screens. He has been dealing heavily with a Major Edwards, Security Commander of Manzano Security. He and his wife saw four objects outside of a warhead storage area at a range of about 2500 feet and obtained movies of them. He now has about 6000 feet of movie footage, of which 5000 ft is in Super Eight. The objects have the ability to "cloak." That is his word, spells CLOAK like cloak and dagger, like cover up and he says that they can cause themselves to go invisible by a field that causes the light waves to bend around the object and that one sees the sky behind them.

He confirmed the fact that the woman was picked up when she accidentally observed the calf being abducted. He has paid for a pathology work and a medical doctor work. The pathologist is a former head of the microbiology department of New Mexico University. They have done CAT scans to show that the woman did in fact have an implant in her body.

She has a vaginal disease like streptococci-bacillus and tried many antibiotics to destroy the bacteria.. That it has survived off the antibodies themselves. The aliens keep hassling her.

Paul kept the woman and her mother at his house and the UFOs were flying overhead constantly. There is no ESP involved, but it is just plain physics.

They send a beam down. They have a beam through which they can sense her thoughts. They can communicate through this beam. She picked up their transmissions. He devised a means of communication based upon hex Ascii code; one is equal to "no" and two being "yes." Through this code he has been able to talk to the aliens. He then computerized the system that would reject extraneous inputs. He said that they can be very threatening and malevolent. One of them he talked to said that he would drop off communication if he became too familiar. He was told about the base.

He then told the O.S.I. of the Air Force and gave several presentations to high level Air Force people in briefings on the subject, Wing Level Command, and many others, including this fellow Edwards.

After he gave his presentation he was taken twice by helicopter to the site; once with an OSI Agent and the next time with a Col. Carpenter . He made photographs.

He says that you can see saucers on the ground. He says there is a kind of a cone - a large cone and the larger vehicles come and land on top of the cone with the top of the cone fitting into a hole in the bottom. There is an elevator inside of the cone and that goes down into the mountain or ground about one kilometer. You can see the aliens running around the base getting into the vehicles. They use small vehicles to get around that have no wheels. They are rectangular in shape and they levitate. They do not show up in color because they are highly reflective, but in black and white they are visible. He says that there are beam weapons that are floating in strategic locations and there is a road into the base. He obtained infra-red photos of the area from an altitude of 14,000 ft. There is a level highway going into the area that is 36 ft. wide. It is a government road. One can see telemetry trailers and buildings that are five sided buildings with a dome. It is standard military procedure. There are many guard points and "stakes" and there are launch domes that one can see. Next to the launch dome he saw a black limousine and another at some distance off. The careful measurements showed that the limousine was the same length as his Lincoln Town car. It is a C.I.A. vehicle. Also there was a blue van. He has been cautioned about these limousines as they will run you off the road if you try to get into the

area and in fact somebody has been killed in that manner. To the north is a launch site. There are two wrecked ships there: they are 36 feet with wings, and one can see oxygen and hydrogen tanks. There are four cylindrical objects Socorro type -- two carrying something while flying. The whole operation is based upon a government agreement and a technology trade. We get out of it atomic ships that are operated by plutonium. The Cash-Landrum case was one of them. The doors jammed open and neutron radiation came out.

One is based at Holloman Air Force Base and possibly Ft. Hood, Texas. Refueling of the plutonium is accomplished at Los Alamos.

He had traced pictures of this base back to 1948 and it has been there starting in 1948. Pictures in 1952, you can see many saucers and the base and trucks in winter time. The road was "passed off" to the local inhabitants as a lumber contract. He has photographs (I believe) of the firing of a beam weapon that ejects in two directions. (That would be necessary on a flying saucer. The reaction forces would impede the vehicle.) He has computed the speeds of flying saucers at 15,000 mph and indicates that the pilots of ours are from N.S.A., the National Security Agency. The aliens have had the atomic propulsion system for 48 years and the saucers themselves operate on an electric charge basis having to do with a crystal semiconductor and maybe a super lattice. I think he said "as you increase the voltage, the current goes down." At present there are six to eight vehicles, maybe up to ten over the area and sometimes up to 100. They can be seen in the clouds. They go into the cumulus clouds and produce nitrogen nitride. I speculate it is this you will see when you see black spots in the cloud. They eat holes in the cloud. If you can see black spots in a cloud, then you can tell that a vehicle is in there.

He says they come from six different cultures and in his communications that some come from a binary system, possibly Zeta Reticuli and from distances up to and larger than 32 light years away. They appear to have one to three ships in earth orbit at 50,000 KM altitude. Based upon data he had to form the words to try to communicate and he produced a vocabulary of 627 words in a matrix form and uses a computer. The Flying Saucers we see are limited to operation in the atmosphere.

Now with regard to the cattle problem, the aliens are using the DNA from the cattle and are making humanoids. He got pictures of their video screen. Some of these creatures are animal like, some are near human and some are human and short with large heads. They grow the embryos. After the embryos become active by a year of training, presumably that is required for them to become operational. When they die, they go back into a tank. Their parts are recovered.

In 1979 something happened and the base was closed. There was an argument over weapons and our people were chased out, more than 100 people involved. (Some place later he indicates further details on this point.)

The base is 4000 ft. long and our helicopters are going in there all the time. When it became known that he was familiar with all this, the mutilations stopped. They are taking humanoid embryos out of this base to Albuquerque.

He said there are still quite a few of the helicopters in operation. All are unmarked. They fly at night. He went up there himself in a helicopter and the O.S.I. briefed the copter pilot and he thought perhaps the copter pilot himself was an undercover man. They saw helicopter pads up there - Viet Nam type, with bearing markers and the trees pushed off away from the location. It is such a wild area he said. He agreed to send me the coordinates of this base.

Regarding abductions of people, they pick out medium to low IQ personnel. They are able to scope out each one. They pick up these people and then put implants into them and take tissue samples; including ovum from the women, sperm from the men and DNA.

They can program these people as slaves to do whatever they wish and they will have no memory of it. The hard core type refuse to be x-rayed or hypnotically regressed. You can recognize them because of their eyes. He says "peculiar look in the eyes and expression -- with a funny smile." Hynek knows about all of this and has been in contact with Coral Lorenzen. (Editor's Note: Remember this was before Hynek died, also Coral died this year.) He regards Hynek as a government cover. At his house, he showed Hynek films and out in the back yard a flying saucer. He asked Hynek about his view with regard to abductions as to how many people might have been abducted. Hynek, unhesitatingly said about one out of forty.

He said that many people come to his door to see him, just "out of the blue" and he sees scars on the back of their necks. That previous old scars are easy to detect and that new ones are hard to detect. He feels that this is a sickening situation.

The aliens have gone wild and use hypodermics. He has been paralyzed four times and has been hit 250 times by hypodermics. He says they knock you cold and they do whatever they want to do and the above points have been verified medically.

A man came to see him with a top secret document that was dated in the 50's, indicating if anybody found out about all of this they would kill them. He was asked "doesn't that bother you?" He said "no it didn't."

He said he had sent in some film to Kodak and there were seven rolls. They were Ectokrome G which could not be processed locally, so they had to go to Kodak. He does all of the film work commercially so that nobody could claim that he had "monkeyed" with the film. His films came back, but one of them which was plain Ectokrome was missing for 2 months - when received nine feet was missing and this was close-ups of UFOs that he had taken. Missing pictures known to him showed up in a top secret document that he studied and the code name is Aquarius and it is a project of NASA. They are the ones that kept the film and copied it with deletions on Ectokrome and sent it back he suspects.

There have been indirect threats by the Air Force Intelligence against him.

The location of the base is 2 1/2 miles northwest of Dulce and almost overlooks the town. It is up on a mesa. We discussed the similarity between everything we have been talking about here and the movie Close Encounters of the Third Kind. He said he speculated the movie seemed to be a plan of disclosure. The coordinates of the location are not far off and the mountain where the actual base is looks much like the mountain in the movie.

Here is what we got in the trade off. We got the atomic technology, the atomic flying ships. Several of them. The first one was wrecked on the ground and it can be seen and photographed from the air. A second one was wrecked. A third one was wrecked. Apparently this last one was repaired and was the one that was in Houston -- near Houston in the Cash-Landrum case. The second item that we get out of it, are the beam weapons, the beam technology and third (he speculates) is the thought beam. That is the means by which communication is accomplished. It is electrostatic in character with a magnetic artifact component and it is the only way of communicating with people. They have to have the implants in order to use it. In the crash that occurred at the base when there was a disturbance of some sort, the aliens killed 66 of our people and 44 got away. This was information from alien computer input - true? He does not know. Supposedly it was over an argument and they turned on us.

I discussed with him whether he wished me to relay any of this information to other people. He said he had no objection. He would like to review any writing that I might do, to make sure that it is right in advance, and also to make sure that the source of the information was given. I mentioned in particular, John Schuessler, who would be extremely interested in part of this data.

I gave him a summary of my analysis of the electromagnetic environment around UFOs related to propulsion. He was going to study that, but he did not comment off-hand. He was familiar with what the aliens called MPS which means manipulations per sequence. In an electromagnetic field that can be manipulated into many configurations and the craft can stall. In order to prevent that, this field is adjusted once every forty milliseconds. He has studied the trails from UFOs and they seem to break down into a pulse rate of 62 per second. Based upon the color movie pictures, there seems to be a blast of light and a spectral components and composition in there, with a Bow-Wave in front of the UFO with nitrogen showing green and oxygen showing blue, but with the saucer being invisible. They can run into a car or airplane and this Bow-Wave will destroy them. Rockets can hit this Bow-Wave and be destroyed. They can't penetrate it. At White Sands he was shown pictures of an F-15 shooting rockets with a missile at a target and the saucers came in behind the missile, 30 ft. behind, and then flew thru the explosion. He didn't know what the purpose of the demonstration was, but suspected it might be just to show how invulnerable they are. But sometimes the saucers get into trouble and they are all consumed in some kind of way.

When he went up to Dulce in a helicopter, they landed and left some equipment there, but then when they came back the pilot was extremely nervous. Paul wanted to land on the base, but the pilot wouldn't do that. They came back to Dulce and landed at a small strip there, where they found two large Huey helicopters. The highway patrolman in charge there named Valdez went aboard one of the

choppers and they found them to be full of commandos. They estimated a total of 75 commandos, fully armed with M16 rifles and rocket launchers. They did not have any indication of rank. They only had shoulder patches on. The helicopters were part of a project called Blue Light and they were from Ft. Carson, Colorado according to an OSI input. When they left they were escorted by these two large Huey helicopters. As they were flying along -- in the background, they saw rise up - one of the advanced space technology vehicles that looked like a manta ray with a negative dihedral and projections coming down. It flew vertically past the two accompanying helicopters. Paul feels that it is imperative that this information be released because he feels that it is unconstitutional for the government to be involved in such an arrangement that invades the privacy of the individuals by the implantations. He said that "once they have been tampered with by the aliens, they are never the same." (I suppose one can easily believe that.--Jim McCampbell comment)

So it appears that for the privilege of collecting the biological materials in the mutilation of and the abductions and the operations on board the craft, the government has allowed this to go on and even to assist for the privilege of getting the nuclear flight technology, the beam weaponry and the thought beam technology, plus also the embryos which are flown out of the base. (A rather fantastic story.--Jim McCampbell comment)

Paul strikes me as being an extremely conservative, extremely knowledgeable and reliable scientist, who was intimately familiar with sophisticated laboratory equipment. He is thoroughly scientific and reliable. (Jim McCampbell evaluation)


The base was started in 1948 showing major construction of the base from the photographs that were studied.




