Last summer your editor went to Memphis for Tribute Week at Graceland to honor Elvis Presley. On the evening of the Candlelight Vigil, August 15, 1993, several of my friends and I were just walking around talking to different people. 
**Dear Aileen:**

# UFOs, ETs AND YOU

In my column in the May issue of this magazine I wrote about cattle and horse mutilations, mentioning that the mutilations had ended several years ago. However, I recently discovered that they have not ended, but have recently resumed after a lay-off of about three years. Included here is information from several interesting articles that recently appeared in the *Rocky Mountain News*, a large Denver newspaper. I was given these newspaper pieces just after my May article appeared in print. Because of these new developments, I need to point out again that cattle mutilations (or specimen gathering or research or whatever it really is) is not necessarily a negative thing. Someone, or something, is doing this for a reason, probably a good one. The government is not the perpetrator, although I am sure they have knowledge of who the perpetrators are, and probably the government is, in an indirect way, involved in the act itself. However, I am quite certain that the majority of the "mutes" are being done by extraterrestrial aliens. Ten thousand or so mutes in twenty years

and no one has ever been caught in the act or charged with a crime involving the mutilations; you can be sure the perpetrators are not human or someone would have been shot by a rancher long ago or would have been languishing in jail for ages.

Most of the cattle, it seems, were picked up, mutilated, then dropped off near where they were taken from. In a number of eyewitness situations, a cow or steer was seen to rise straight up off the ground as if being lifted by some sort of "tractor beam." They were bawling loudly and literally vanished after rising a hundred yards or so into the air. During the height of the mutilations back in the late '70s a Montana sheriff was told by some government agents what was actually behind the cattle mutilations. When he was later interviewed by a UFO researcher, the normally stoic sheriff, in a state of extreme anxiety, said to the researcher, "You don't want to know any more!" — whatever that meant. It was a least a good indication that nonhuman aliens were the culprits. It was, I believe, in Wyoming that a woman was walking in the woods one day and came upon a weird scene. She said she came into a clearing and there was a dead steer on the ground. Standing around it were men in what she thought were Air Force uniforms. What really shocked her was the sight of a number of humanoid/reptilian beings mixed in with the apparent Air Force personnel. She began to run, but after a short distance she fell and injured herself quite badly. She was patched by these human and reptilian beings and was warned never to talk about what she had seen. These reptilian types have been seen enough times now that we have a very good idea what they look like. People


who have encountered them say that they are about the same size as we are but have skin a lot like a snake with scales that are generally a diamond or triangle shape. Their eyes are large, round and reptilian, with a vertical pupil much like a cat's eyes. Sounds weird, huh? I'd like to meet one — but on equal terms. "Weird" and "alien" are our perceptions, not theirs.

If the cattle mutilations were being carried out strictly by an Earthly agency they could simply go to any slaughter house and get all the cattle parts they wanted. But this is not the case. Whoever the deed-doers are, they are clandestinely taking parts from open-range cattle. They very obviously don't want to be seen. I really don't think this is being done for reasons of nourishment; that just doesn't make sense. If that were the case, why wouldn't they just take the whole cow and throw back a few bones and a tail? No, I think the mutilations are related to something not so good that is transpiring in our Earth's environment, something we are not yet aware of — at least not us commoners. No doubt someone or something is monitoring this activity by what is deposited or what is accumulating in certain cattle parts. Remember that cattle blood is so close to human blood in makeup that (as I understand it) it could be used in place of human blood for transfusions in an emergency or a national crisis.

In all honesty, every time I look into or do research on something that involves a terror factor, I find that the terror or simple fear of the object or being is at least 95% of the time generated by the human factor. It's usually our own fear that is the controlling enemy, not what is "out there." If we didn't have such a primitive, knee-jerk response to the unknown, we just might find that they want to be our friends — that is, if we hadn't taken a couple of shots at them first. Now we have to back-track a bit and approach the whole situation from a calmer point of view. If "they" wanted to get rid of us and take over the planet they could have done it a thousand years ago.



dently is on tape; the fellow was recording it. It is a good clue that doings we are not aware of have been underfoot for a long time. I have an iron-clad motto: Question Everything. I think if we all question everything at this point, it just might keep us from being maneuvered into something that we'll want to be able to get out of in the future.

I'm probably the last person on to have read these two books, but in case you haven't read them I would consider them required reading, especially for anyone who has a healthy curiosity. They are *Journeys Out of Body* and *Far Journeys* by Robert Monroe. Robert Monroe more or less pioneered out-of-body experimentation and study. His experiences include some of what we might expect to face beyond the physical, although I think some of his experiences may have been in a small way influenced by his own beliefs. I think it be-

Lastly, I am going to mention the Dan-

## Cattle mutilations strike in Alabama

Two counties report 32 cases similar to those in Colorado; helicopter seen at several sites

Colorado is not alone in witnessing the resumption of cattle mutilations. Officials in Alabama say 32 mutilations have occurred since October in two northeastern counties.

"The cow's udder had been cut off cleaner than you could cut with a razor. I've been ranching

mals that predators got hold of. I'd be willing to bet my life it was no predator," said Jimmy Pope, a Geraldine, Ala., rancher whose cow was found in a pasture 500 feet from his house.

"The cow had an oval-shaped cut on her shoulder where skin and hair had been removed, there was no blood nowhere, and the head had been cut in an oval shape and the teeth had been removed surgically," he said.

While removal of specific organs in DeKalb and Marshall counties cases is similar to two incidents last November in Costilla and Las Animas counties in southern Colorado, the Alabama

twists. Tissue samples from one Alabama cow, examined under microscope by Denver pathologist Dr. John Altshuler, showed that the blood around the cut tissue had been "cooked," indicating temperatures of at least 300 degrees had been used to make or cauterize the cuts.

Also, traces of a chemical substance were found at the scene of a mutilation, according to Fyffe, Ala., police officer Ted Oliphant.

"We found a white substance on a cow's right rib cage and on the ground next to it. I put it into a plastic wrapper, and back at the

with the metal tip of my pen, it turned to liquid within one second. I put the rest on a piece of paper. We sent it to a molecular biologist for analysis and found it was composed of aluminum, titanium, oxygen and silicon. This is not a substance that occurs in nature," said Oliphant.

"The Alabama mutilations fit the classic pattern, officials said.

"It varies from animal to animal, but generally the same things are taken. Sex organs are removed with an oval incision. Rectums are cored out, tongues are cut out, jaws stripped to the bone, milk sacks are removed, and internal organs are taken,

said Oliphant.

Pope said he was awakened by his barking Labrador retrievers about 3 a.m. but looked outside and saw nothing. His neighbor, 3 miles away, told Pope he had seen a low-flying helicopter late that night.

"We've got helicopters in about 90% of these cases, either reported by the farmers themselves or their neighbors," said Oliphant. "They're these light blue with gray bottoms, Bell Jet Rangers with no markings on them. We don't know whose running these things, but they're pushing their luck. The farmers are driving around with high-powered rifles in their trucks."

## Cattle resumes in Colorado

Disfiguring of 2 animals baffles lawmen in southern part of state

**SAN LUIS** — Cattle mutilations, mysterious killings that seemed to stop in the Colorado valley and resumed in this southern Colorado valley and a neighboring valley west of Trinidad, authorities confirm.

Again, as during their peak in the 1970s, circumstances surrounding the killings are strange and unexplained: lack of footprints, animal tracks or any sign of a struggle; selective, surgical-like removal of certain parts of the animals; and a lack of certain things that could have killed them, "said Costilla County Sheriff Billy Maestas. "We didn't find bullet holes or cartridges or wounds."

Maestas investigated one of two mutilations in recent months, a pregnant cow belonging to San Luis-area rancher Manuel Sanchez, found by Sanchez in a field in November.

A similar mutilation occurred about the

same time near Weston west of Trinidad. While the two locations are some distance apart by road, they are separated geographically only by a low mountain.

"It's literally right over the hill from Costilla County," said Las Animas County Sheriff Lou Girodo.

In both cases, the cows' eyes and udders were removed by surgical-witnesses describe as surgical-like cuts, not the tearing wounds associated with predators.

Girodo, who has investigated mutilations for about 20 years, said he is equally puzzled.

"We just don't have anything to follow up on," he said of the West- "There's no blood, no signs of a struggle, no evidence at the scene indicating anyone was there," he said.

"I can tell you what it isn't. I don't think it's pranksters or the occult or anything like that," Sanchez, who ranches 130 acres east of San Luis, found his cow in a field near his house after it did not appear with the herd for its morning feeding.

"I thought probably coyotes or dogs had gotten to her, but when I walked over and saw how she was cut, I knew right away it was no

"The eyes and the bag and the rear end were cut out with some-

thing like a real sharp blade. They were real clean cuts and there was no blood around the cuts."

Sanchez and Maestas walked over the field and found no animal or human tracks. He had heard nothing the night before.

The mutilations seemed to stop in the late 1980s almost as abruptly as they began in the late 1960s. Throughout the 1970s, cattle mutilations became a regular phenomenon, and while some were attributed to predators, vandals and even cult activity, others were never explained.

In many cases, the animals' eyes, ears, tongue or sex organs were removed with surgical-like excisions, and the carcasses were found in fields without any tracks around them or signs of struggle.

Dr. John Altshuler, a Denver pathologist who has investigated mutilations, said descriptions of the two recent cases appear similar to earlier cases, he said, "the cuts appeared sharp and fairly well-delineated."

"It seems unusual to find a dead animal that has surgical incisions, or some kind of incisions even by a predator, without blood around," he said.

But Altshuler joined perplexed law-enforcement officials when asked for an explanation.

"I'm not offering an answer or a solution," he said.

## Strange lights in San Luis area

**SAN LUIS** — The return of cattle mutilation reports in the San Luis Valley has brought with it a surge in reports of mysterious lights in the night sky.

The inexplicable incidents began recurring last November after a hiatus of a decade or more. During the mid-1970s, there was a rash of the incidents in southern Colorado, accompanied by reports of lights in the sky.

"I got up about 3 o'clock in the morning, and I saw a bunch of lights overhead," said John Browning, 54, of Denver, recalling what he saw during a hunting trip near Sa-guache last November.

"There must have been 15 or 16 of them," he said. "They were in a kind of semi-circle, and there were four lights moving around in the center of the circle."

In early December, Andrea and Mike Nisbet of Crestone awakened in the predawn hours to find a bright yellow-orange light shining through their bedroom windows.

"The light was coming from directly above our house. I saw this big, round yellow-orange light in the reflection of our van outside," Andrea Nisbet said. "We were amazed at how bright it was outside. And there was no sound."

Retired Costilla County Sheriff Ernest Sandoval, who held office for 16 years, recalled there were reports of unusual lights when the mutilations were being reported in the mid-1970s. He said he saw some bright lights near San Pablo one night, then later learned there were two mutilation reports there that night.

Astronomer Paul Van Slyke, who operates the Black Forest Observatory north of Colorado Springs, says many things will cause what witnesses describe as "strange lights in the sky."



## A RUDE AWAKENING

The following event that I am about to depict, is a factual account of an experience that took place in Connecticut. I can still remember the vivid details of that hot summer night. It all happened in the early hours of an August morning, in 1987.

Before I continue, perhaps I should first explain some things about myself. I am not a newcomer to the UFO phenomenon. I have been involved in UFO studies for nearly five decades. You can call me a UFOlogist if you wish. The title does not really matter to me. My experiences and knowledge in UFOlogy are vast, and cannot be measured in a mere presumptuous name.

Back in the early 1950s, I had my first UFO sighting. I was always especially interested in space, and often watched science fiction movies and space documentaries on television. In those days UFOs were widely known as flying saucers.

It was also during the early 1950s that I began to acknowledge something strange about myself. I felt like I did not belong here on Earth. I felt like I was a visitor. The body that I inhabited was somehow incorrect, yet I was trapped inside it.

Through the years my interest in UFOs has grown stronger. I have seen the UFO phenomenon grow to an unprecedented number of enthusiasts. And with this great influx of people, the UFO phenomenon has, in fact, become infiltrated with some so-called enthusiasts, who have destroyed the creditability of the entire phenomenon.

I have seen the changes in the way bookstores now display their titles on the subject of UFOs. Books about UFOs and related material, are now found in the occult or New Age section, instead of the general nonfiction section.

The number of UFO organizations and symposiums have also increased through the years. Some symposiums tend to charge too much money for admittance and lectures. I strongly feel that the UFO phenomenon should not be used for monetary gains.

As for me, I tend to stay away from such things as symposiums and organizations, and remain a solitude individual. But, of course, there have been times when I have attended a symposium or some other kind of UFO function, and I always seem to leave with an empty feeling inside.

I seldom ever read material about the UFO phenomenon or listen to lecturers. I want to stay away from what I feel is a lot of misleading information. What I do know and learn about the UFO phenomenon, comes from my own higher level of personal awareness. I often find that whatever information I come into contact with, by way of reading material or lecturers, only coincides with what I already knew.

Through the years I have been abducted by non-human entities, many call the Greys, numerous times. I have remembered some experiences in vivid detail without the use of hypnosis. I have experienced both pain and joy through these encounters, which I see as a positive influence on my life. My personal gain from these experiences, has, in fact, made me a much stronger individual on an intellectual level.

In addition to my being an abductee, I am also a contactee. I have been in communication with the Greys for many years now, and frankly I find the experience very rewarding. In many ways they have helped me through crises, when no one else was there for me. I call them my true friends. After all, the meaning of a true friend is one who remains to help, when others have suddenly gone.

Do I worry about the public ridicule that society imposes on people like me? My answer is very simple: not any more! I have reached a much higher level of personal understanding. I know that people who ridicule on things that they do not understand, are merely feeble and insecure individuals who are just ignorant. I always do my best to ignore them and their kind.

And now that I have laid the groundwork down in my behalf, let me commence with the story. It was early morning when I was abruptly stirred out of a deep sleep. I opened my eyes to a partially moonlit room, and then I saw them.

There were four Greys standing some eight feet away from my bed. Behind the Greys, I could see the lighted dial of the clock, which I kept on a window sill. The time was 2:45 a.m.

Suddenly, I started to toss relentlessly in bed, sweating more and more with each passing moment. I felt no pain but something was definitely trying to invade my body. From time to time, I looked over to the place where the Greys were positioned, and not even once did any of them move any closer to the bed.

Sweat covered my face as I continued to toss restlessly in bed. And through it all, something was still attempting to invade me. I could not see anything by the bed, but I could feel a definite presence of something near me.

Seconds seemed like minutes, and minutes seemed like hours. The Greys continued to occupy the same location, and still never moved any closer. I could still see the clock. It was now 4:40 a.m. The room was beginning to become lighter now, as sunrise approached.

Several more minutes passed. Suddenly, I stopped tossing in bed and gave in to whatever it was that was trying to invade me. I felt no pain, in fact, I felt a sense of relief. I then sat up in bed and started to feel my hands and face. For some reason I had a queer feeling that they had transformed me into a non-human form.

As I felt my hands and face, they seemed normal on the outside, but within me, I still had that queer feeling that something was different about me. After a few moments, I turned my attention back to the Greys. I immediately noticed that they were slowly beginning to disappear from sight. In other words, the Greys were dematerializing before my very eyes.

Within a short time, the Greys were gone. I then promptly got out of bed and went to the bathroom. I had to get a look at myself in the mirror. As I looked at myself in the mirror I could see no external changes on my face or hands, but within me, that same queer feeling still persisted.

There was no missing time involved with this experience. I was meant to remember every minute detail. And believe me, I am well-versed in missing time. I have experienced it many times before.

Some months after my 1987 experience, I was summoned to a specific place where I received a token of respect from the ones who had arranged and had participated in the event. There is no need to go into the details about the place or the meeting, for all that is incidental to the token itself.

The token, or more precisely, the artifact, is a clay like specimen, some six inches in length and two inches in width. It weighs approximately one pound. It was fired at an extremely high temperature, and when one gently strikes it with a fingernail, it makes a high-pitched ping sound, much like the sound of crystal.

The artifact has been studied by several geologists and anthropologists at Yale University's Peabody Museum of Natural History in New Haven, Connecticut. Their findings have concluded that the artifact does not appear to be of Native American origin. The exact age of the artifact has never been ascertained. Further examination of the artifact, is possible, if I so desire it.

Another interesting thing about the artifact is the hieroglyphics. It is obvious that they represent a message. I often think of the artifact as a symbolic messenger, much like the crop circles. And recently, I have begun to manifest the meaning of the message on the artifact. I will not go into the details of the message at this time. I will save that information for another time.

There are skeptics to whom I have encountered through the years, who believe that the artifact is merely a hoax. Their conclusions, I can assure you, are incorrect and deserves no further consideration. The fact remains, the artifact exists. And more importantly, I know its true origin.

That August 1987 experience, and the artifact, have changed my life forever. Ever since that experience, I have been going through a continual metamorphosis. My thoughts have become more logical in selective reasoning. Everyday my level of consciousness increases. Each day I find it harder and harder to deal with humankind. That is another reason why I tend to be a solitary individual. I find the metamorphosis, or the Fifth Encounter as I commonly call it, a very stimulating and rewarding experience.

I do not care that I had no witnesses to my experience. I do not need them. Nor do I wish to subject myself to a lie detector test, to prove my authenticity. There is no need to yield to such deplorable methods. The fact remains, it happened. And nothing can ever change that.

The clay specimen you sent in has been examined by geologists and anthropologists. The final opinion from Professor Michael Coe of the Anthropology Department is that he would not classify it as Native American. It does not appear to have been made using traditional Native American methods.

The pottery was fired at a very high temperature. If you strike the brick lightly with a finger (nail) you will hear a high pitched ping, much like the ring of crystal.

Professor Coe suggests sending the brick to the Smithsonian Museum in Washington for further identification.

## SCOTTISH UFOLOGY, AND NEW HORIZONS

It was 7:20 pm on the evening of October 27, 1992 as the Forsyth family car was traveling on a short journey to Stirling from Denny. Patrick Forsyth had made this journey many times before and his two young sons Barry (11) and David (6) sit quietly in the back discussing the school activities of a few hours earlier. It's dark, and the road is fairly quiet. Suddenly, a vision unfolds to Patrick, as he notices that up ahead, a strange aerial device is hovering motionless above the surface of the road.

"This is strange!" he thinks to himself, "what on earth's going on here?" Not wanting to alarm his two young sons, he says nothing at this point hoping that whatever it is, it will have went away by the time he reaches it in his car. However, his fear remains, for as he drives ever closer to this object, he observes that whatever it is, it's certainly not going to move. He also observes, that this object does not conform to any aircraft or helicopter that he has ever seen before.

Seconds later, and Patrick finds himself only a few yards from the object, he calls out to his sons in the back now accepting that whatever the object is, it isn't going to go away. "Boys, can you see this?" "Yes", they replied in unison. "What is it?" Before Patrick could give an answer, this black two tiered object with small green lights moving around its underside, was obscured by a sudden and instant "fog bank", or what at least "appeared" to be a "fog bank" which stretched from one side of the road to the other.

Patrick quickly applied the brakes and slew the car through this rectangular "fog bank" which was not puffy or misty like fog, but rather as if one had placed a large sheet of white cardboard across the surface of the road. As he ground to a half he noticed another car up front which had been further up the road during his approach to this object, almost crash into the side of the road as it too went through this "instant fog bank". Thankfully Patrick and his two sons were safe. He quickly looked up into the dark night sky and observed that this strange wingless object was gone. His son Barry, said that he looked out of the rear window and saw the object shooting across the sky at an incredible rate in the direction of Grangemouth, a town a few miles to the west.

This was but one, in an incredible series of UFO sightings in and around the town of Bonnybridge in Stirlingshire Central Scotland, that SPI, (Strange Phenomena Investigations), investigated, beginning during the month of November 1992 to September 1993 (indeed, the sightings are still ongoing albeit to a smaller degree). Ever since the famous Livingston incident of November 9, 1979, Scotland has seen a steady increase in UFO sightings. Prior to the Livingston incident, which I'll relate shortly, I investigated a huge wave of UFO sightings in and around the town of Moffat in the region of Dumfries and Galloway back in 1980-81.

Many strange aerial devices were reported in this region by many different people. A multiple witness case with photographs emerged which to this day, has never been satisfactorily explained, although a colleague of mine, a Mr. Stuart Campbell, seems to think that the object caught by the camera (a grey shaped object moving slowly in the sky), was in fact a mirage of a distant mountain top, a view I certainly don't concur with.

A repeater witness (one who claims to see UFOs regularly), a Mrs. Joyce Byres, discussed with me of her many night time observations of small silver ball shaped objects seen in the sky, which would make incredible manoeuvres as they swooped down from the sky towards the ground. Some of Joyce's more alarming UFO sightings were of one particular object which she fondly called, "Big Bertha". A large oval

shaped object which featured a structured appendage attached to its rear, which when seen, made a noise similar in sound to a waterfall.

Some nights she sat for hours watching from her bedroom window as this strange aerial show unfolded before her eyes. Joyce wasn't alone in her UFO observations, as many other people attested to her sightings. Although as is usual, some UFO sightings turned out to have natural explanations. However, this particular region, Dumfries and Galloway, did at that point in time, see quite a lot of UFO activity, which for the moment at least, has appeared to have died down.

In 1982, I was again on the trail of UFOs, this time in another what we UFOlogists call, "window areas", that is an area which receives a high concentration of UFO reports. This time the locality was Central Scotland, Denny to be precise. Little did I know it then, but ten years later I would be back in this region conducting similar research. I spoke to another repeater witness, a Mrs. Elsie Beveridge who claimed to have been observing UFOs on and off for roughly 18 months. Mrs. Beveridge, a pleasant charming woman in her late forties, was not prone I believed, to making up tall stories, rather she related in her own way, her sightings of unusual shapes seen in the sky. Shapes that have also been seen by her husband and daughter.

I learned that the first time Elsie had observed anything unusual in the sky, was back in 1971 in Glasgow. Mrs. Beveridge and her daughter observed a silver domed shaped object which had been stationary for a matter of a few minutes; shoot suddenly up into the sky at an alarming rate. It wasn't until Elsie moved to Denny, a good while after staying in Glasgow, that she began to see UFOs more regularly. So regularly, that in fact, she kept a diary to document them all. Elsie told me, "I've seen dozens of strange craft in the skies, they range from domed shape to cigar shape. They have varied in size, and some have had colored lights on them. They can move very fast, or else just hover completely stationary as if they were watching or listening?"

Why do some people see UFOs more than other people? This has been a major talking point in UFO circles for a number of years now and many theories have been put forward. One such theory, and perhaps one in which I myself would tend to favor, is that certain UFO witnesses are, after researching their claims and discussing their experiences, are generally found to be psychic, and that it is suggested that they may therefore see images that are lost to our own viewing spectrum. They may in certain conditions, get a glimpse into a different reality to view objects operating on a different wavelength. Speculation sure, but something we should at least consider. The Denny UFO window area was interesting and little did I know it then, that I would be back ten years later researching the same area all over again, this time with different witnesses.

Of course the biggest event ever to have occurred in UFOlogical terms in Scotland, was, what's been termed as the "Livingston Incident" of which so much has been written about, and as such I will only give the briefest of details here.

On the morning of November 9, 1979, forestry worker Robert Taylor entered Dechmont Woods near Livingston, (Central Scotland) accompanied by his Irish Red Setter dog. Robert worked for the Livingston Forestry Department and was checking that no sheep or cattle had strayed into the woods. It was whilst doing this, that he encountered what he described as a "spaceship" resting just above the grass. As he stood transfixed at this amazing scene, two small, and what resembled Second World War sea mines, rushed out from below this larger object and raced towards him. One of these small spheres extended its rod like extension onto his trousers, pulling him forcibly in the direction of this large round object with a flange going around its perimeter.

At this point the shock was too much for Robert, and he passed out (but before he did so, he told me in an interview a few days later), that he remembered a "swishing sound" like if one thrust a cane through the air. He also remembers a terrible acrid smell, of which he likened to burning car brake linings. Robert eventually regained consciousness, in which he then observed that the large object and two smaller objects were gone, leaving many impressions in the grass. He then found that he had a terrific thirst and pounding headache.

Robert eventually managed to stagger home and told his wife of his strange encounter in the woods. A short while later the British UFO Research Association, along with Strange Phenomena Investigations, became involved, and the rest as they say, is history.

We at SPI still have in our possession, the actual trousers that Robert wore on that eventful day (which were on display at a UFO museum in London in July 1993). SPI felt that this major case, the biggest in the annals of Scottish UFOlogy, deserved to be publicly recognized, and to this end we commemorated it, with the assistance of the Livingston Development Corporation who erected a cairn with worded plaque at the site of this important event in May 1992. A commemoration of a UFO sighting has never been done anywhere else in the world, and SPI are the first research group to commemorate such an event.

We decided to commemorate it purely to draw attention to how serious the UFO enigma is, (wherever the true conclusion lies!) and in doing so, we hope that we have drawn attention to the complex subject of UFO sightings and their effects on the watching witness.

Since 1979, I have researched a number of UFO reports within Scotland, too many to go into in this short article. Some cases that stick in my mind are the following. We hypnotically regressed a Glasgow man due to his consistent fears of "alien intrusion" into his life. He lost his wife and job through the pressure of his experiences of UFOs and aliens. Under regression, he recounted being on board a UFO where he found himself lying rigidly fixed to a raised bed like table in a circular room devoid of any furnishings/equipment of any kind. In front of him was a huge T.V.-like-screen, that was showing pictures of planet Earth from space, with huge mushroom type explosions rising up from its surface. He then recalls of being terrified of huge slanted staring "yellow eyes". He remembers very little else about this episode, and in our last meeting, still told of being troubled by these recollections.

Another area which seems to attract strange lights in the sky, is near the village of Muchalls which lies in between the towns of Stonchaven and Aberdeen on the northeasterly side of Scotland. Tom Allen, the principle witness regarding these sightings, tells of viewing strange lights in the sky stretching back to when he was a boy growing up in the area. Now this area does see a fair bit of air traffic, particularly helicopters due to their excursions over the North Sea to ferry personnel to and from the oil rigs. But the UFOs that Tom has witnessed (he assures us) are not helicopters or aircraft. Tom has actually filmed on video, these strange lights, some of which, it must be said, are similar to those lights/UFOs, seen in the video "Messengers of Destiny" which details UFO sightings over Mexico City. SPI are still currently working on the Muchalls UFO sightings, and we hope to continue filming these objects, which will hopefully provide an answer, or at least go towards providing some form of conclusion as to what exactly these balls of light are. Paul Devereux's "Earth Lights" maybe? Something akin to those mysterious lights seen in Hessdalen in Norway, who knows.

This brings me to the wave of UFO sightings around the town of Bonnybridge near Falkirk Central Scotland which more or less started in November 1992 when many locals observed strange balls of light and "structured objects" in the sky above their town. A local councilor, Billy Buchanan, collected these early reports whereby soon after I became involved. Both Billy and I soon realized that here in Bonnybridge something truly unusual was going on. After being featured in the local press, I was swamped by people telephoning me to relate their own personal UFO experience. Beginning our research, we soon uncovered the fact that "some" of these UFO sightings had natural down to earth explanations, i.e. aircraft, etc, but this still left a high residue of unexplainable reports which demanded an answer. There clearly was a "case to be answered".

Close proximity UFO sightings were made, one witness claims to have seen a strange craft hovering above a field (similar it must be said, to a UFO that repeater witness Joyce Byres of Moffat had seen some ten years previously!) The witness described the object as having the sound similar to that of a washing machine on its final spin. (A fast humming sound). The object departed seconds later and was soon lost to view. Another witness had a large unidentified object pass above his car near Bonnybridge, which featured a "crucifix pattern of lights" on its underside. The sightings continued, and one family were terrorized on a lonely country road by a bright object which flew above their heads then landed in a nearby field.

The family, a mother, daughter and son, took to their heels, and upon doing so, turned round to notice that the large ball of light which had landed in a nearby field, had now moved and positioned itself in the center of the road. Further along the road, the family claim to have been "blinded" by a burst of brilliant light which shone forth from a group of trees. This particular sighting, has gained the most publicity when the media descended on Bonnybridge.

The sightings continued and were brought to the attention of one Junichi Yaoi, a UFO researcher from Japan, who produces UFO documentaries. Junichi and his film crew visited Bonnybridge in May 1993 on a whistle stop tour of the worlds UFO "hotspots". He told SPI, "i have heard so much about these Bonnybridge UFOs from English researcher, Tony Dodd, that we just had to come over and see for ourselves." Sadly they never saw anything themselves, but what they did do was to interview several witnesses to the UFO phenomena around Bonnybridge. Junichi and his assistant Mitchi Nakamura, were clearly satisfied that "something" very peculiar was going on above the town of Bonnybridge.

Not since the Livingston Incident of 1979, has Scotland experienced such a public awareness of UFO sightings. The Scottish media was alive with UFO reports. Patrick Forsyth, whose account opened this article, will certainly never forget what he saw, the vision is still imprinted firmly upon his mind.

The UFO challenge is still with us, it's like the proverbial carrot dangling in front of the donkey, we see something tangible, but are still trying to grasp what appears to be forever out of our reach. This UFO subject is as elusive as its ever been, and although it appears that there is different components which could make up the full UFO picture, these components are themselves not providing us with any clear cut clues. The E.T. hypothesis may be favoured in the U.S. but across the pond in the U.K. we see it differently.

Why have we not any cases of small grey "beings" being reported here? A few yes, but nothing like the wealth of sightings reported from the U.S.

This UFO business is complex and is fraught with absurdities and we researchers are forever being kept on our toes as to what might happen next. Scotland, like anywhere else, has its UFO problem. We are no nearer a solution now than we were 40 odd years ago.

The UFO phenomenon won't go away, neither will its investigators, and until such times as we listen to one another, and share in one another's views, ideas, speculations, then perhaps we might begin to see some light at the end of the tunnel. But as it is right now, I personally believe that whatever the UFO phenomenon is, it's certainly not prepared to give up its secrets right now. The continuation of abduction reports, cattle mutilations, etc, seems pointless, and begs the answer, "Why?". Why continue, ain't you got enough genetic information?

I've been researching this subject for only a short while now (around 15 years), and in that time the subject has become deeper and more complex. The UFological zoo of different opinionated people which has at times dragged us through the quagmire, the new age UFOlogy, is becoming more and more like a religion to some who see it as a hollow to be filled in their lives. The UFOs are our saviours, the "New Gods" if you like (as Glasgow rock group sing about). All this has been said before, but I hope that when science finally wakes up to the UFO problem then, and only then, will we begin to see new horizons which may effectively lead us into a new understanding, of not only ourselves, but the universe around us, here's hoping anyway.

THEY OBJECT PROOF TO LESSEN STRENGTH OF UFOS

LAJAS--About 200 people met last Monday night in the suburbs of Cartagena Lagoon to observe the blackout induced by several government agencies with the purpose of establishing that there is no presence of UFOs in this body of water.

Personnel of the Electrical Energy Authority suspended the electric service for some minutes affecting Candelaria and Palmarejo precincts. After that, they focused a reflector on the center of Cartagena Lagoon intending to prove that the strange lights observed in that place are produced by reflections. However, during this experiment, the yellow, red, green and blue lights observed by this editor and other western residents did not appear.

Both federals of the Civil Defense and Police Department are trying to discourage people who continue frequenting the mysterious lagoon located in the municipal limits of this town.

The experiment made last Monday night was initiated by Anibal Roman Morales, Regional Director of Civil Defense in Mayaguez. In spite of Roman Morales insisting that the strange lights in the lagoon are reflections of the lighting system in Candelaria precinct, believers in the UFO phenomenon rejected that version.

Wilson Sosa, resident investigator in Cabo Rojo, alleged that Roman Morales is lending himself to the people who intend to subtract credibility form this subject. "They are not going to hide a truth even by using hundreds of these experiments," he emphasized. Visitors from New York and Dominican Republic went to observe the spectacle set up by Roman Morales and the Lieutenant Rafael Rodriguez, Police Commissioner of Lajas District. West area residents summoned the Regional Director of Civil Defense last Monday for him to show the same interest in clearing up the gases problem by making experiments to those effects that since many years ago affects the complex of the Free Zone of Mayaguez.

- C **COSMOS:** The universe considered as a harmonious and orderly system, with no place for gibberish about space Aliens and problems dragged in from other worlds, and other such attempts to make fools out of the general public and our education system, why just the other day I picked up one of those tabloids in a grocery store check out, talked about procuring accounts of close encounters for the purpose of prostituting Aliens from outer space!
- D **DEBRIEF:** As in; I just saw one of those flying saucer gadgets fly over my roof, and now the power has gone on the fritz, and I can't get nothing but static on this damn transistor!, Well, the doctor said it was just a flock of pigeons flying through a cloud of swamp gas, or something like that, any way I take one of these every four hours.
- E **E.T.:** (Latin-Extra Terrenus) Strange Visitor From Another planet who came to Earth with powers far beyond those of mortal men. Clark Kent was one of them walk in type E.T.s, putting on the "I am one of you." Did you ever know anyone like that?
- F **FLYING SAUCER:** A cigar lit at both ends often smoked while floating on clouds of swamp gas in Texas, oh! You don't buy that one? Well how about a star that zig-zags, or maybe a piece of space junk that changed its mind after falling most of the way to earth, any way most reported they looked like upside down saucers flying, so that's the way it went in the paper about 50 years ago, and the name stuck. ## DEATH AND I

I have my NDE on April 30, 1992. A marriage in which I was not heard, or respected, but was beaten to a degree where my college classmates asked about the marks on my body, led me to take an overdose of pain killers.

At the hospital I vaguely remember a nurse yelling, "The lungs have collapsed, Dr. Cramer!" And then I went blank. My next awareness was being on my back, several feet below my body, shocked. Above me I could see my physical hands struggling to take the tube out of my mouth while the nurses tried to restrain my wrists. Where I was, I seemed to be transparent, as though I was the outline of myself. I tried to move, and couldn't! Somehow, I had lost that right. I don't know why I use that word "right," but it feels appropriate. I went blank again. Awareness returned and my physical body was further above me, though it was darker around where I was. Then blank again. When awareness returned I could not longer see my body, just a dim light above. Then I entered a place of total darkness, where I had no sensations for what seemed like a very long time.

The next thing I noticed was that I was vertical, climbing a stone wall, my heart beating rapidly, but I was slipping. Where I was, the light was quite dim, and the rocks were a kind of dark slimy green/yellow, different from any colors I've ever seen. The stones I was climbing felt as though they were arranged like a brick wall, but without the clean edges of brick, and they were difficult to hold onto. oddly, one of the first things I did was glance for my watch, which wasn't there. But I noticed that I could see my arm and fingernails! I also noticed that I didn't have any shoes. A strong gravity-like pull drew me down the wall. To keep from falling, I grasped the stones, which slid under my fingers. I don't recall feeling any pain in my hands, however. As I was drawn deeper, I felt pressure, similar to what one experiences when scuba diving. The downward pull didn't come steadily. Rather it came in stages. I would climb a bit, then be drawn down quite a way, though I have no idea how far. There would be a pause. I'd climb. Then I'd be drawn down again, boom. Then stop. As I got deeper, there were fewer pauses between the drops. And as I approached the bottom, it was just boom, boom, boom, one drop after another, the pressure increasing all the time. I hit the bottom and it was dark.

Then in this low light, I was aware of a greenish, grayish being, in front of me and below me. I would not say that he was wearing clothes, as we know them. Yet, he and all the other beings I encountered here I would call "dressed," as though out of one piece of clothing. The being in front of me move his arms roughly, as a man might, gesturing toward the left. Looking in that direction I saw another being, whose outline appeared to be my father's. My father had died seven years earlier. We had been very close. Next to him stood another being, who appeared taller, and whom I didn't recognize. Both beings were different from the others in this "dimension," since their skin was whitish in color, and it looked as though they might have stood in a kind of spot light.

I was tremendously puzzled about being there, and I had no idea what to do next! I think that it was because of my puzzlement that the greenish being gestured towards my father. From him I could feel a disappointment for what I had done. But he immediately communicated to me "Are you a quitter?" This

was done non-verbally, and very rapidly. It seemed several times faster than the speed of sound.

Perhaps guided by my father's words I looked up, and it was almost as if he was saying, "Because if you're a quitter, this is what will happen." Then I saw them lowering my coffin into a grave, which they filled with dirt! And that terrified me! I didn't want that at all! That's when I realized I had a choice. I could stay, or I could return. Then my father communicated, "You're not a quitter!" Those words gave me the courage and strength to go back. Then several things appeared to happen simultaneously. My father communicating to me that I was running out of time. My thinking, "How do I go back?" My father answering instantaneously that I should follow what was familiar to me from my own world. I thought, "How?" "Listen, hear, look!" he answered. Somehow, immediately as he said that, I was hearing, looking and listening.

Now, what I was standing on was almost like a small table top. I know it was small because there was barely enough room for my feet. Then some hands grabbed one of my ankles. I looked out, and saw more clearly an amphitheater-like-realm, as large as an indoor stadium, filled with greenish/grayish beings. They were all talking at once, trying to convince me to stay. "You wanted this!" "Come down!" "This is a new dimension, a new world. Join us!" They were pulling me down, and I started kicking. I got the one foot free. Then someone grabbed the other ankle, and I tried to pull free of that. Then I felt the palm of a hand pushing me up! Somehow, I don't know how, I could feel through the palm that it was my father. The push from the hand was quite powerful, because after that I was on the wall climbing.

Going back was very difficult. I was fighting against pressure and time. Earlier I had likened that pressure to being far underwater. At the start of this upward climb though I felt I was battling a 250,000/hr wind. Still, I was listening, and it didn't take me long to locate my source, my door to the way out. Far off, I heard human voices, even though they were weak. That's what I followed, a piece of my world that I could relate to. As I climbed, the pressure decreased and my surroundings grew lighter. While I was climbing it seemed that my mind could operate 1000 times more quickly than it does here.

Part way up, I can't say how far, a crystal-clear light, that was not very large, appeared to my right. In appearance, it resembled a water fountain with little points of light inside it, like a sparkler. This light wasn't white, or gold, just clear. And while I would say it was bright, it was easy to look at. It moved around me in awesome patterns, even occasionally traveling though the wall. It radiated a great feeling of companionship and trust. Later, I asked it if it had come to light my path, and it seemed to respond joyfully.

Another transition took place, and I found myself, again, horizontal below my body. I noticed that the colors I was now seeing were the ones I associate with our life here. Somehow, my change in position had cut me off from the colors of wherever I had been. Then I re-entered my body. There was the light of the emergency room, and the faces of friends around me. But what totally absorbed my attention, even as people attempted to talk to me, was that I still saw the light! Somehow it followed me into this world, and I couldn't believe it! It was right around where my waist is, and so bright that I couldn't see my legs! Then it gradually moved away from me, growing in size until it filled the room. "You're safe," it communicated. Then it disappeared!

Even when I was in that other realm, I didn't believe that place was my ultimate destination. Today I know that when I die, if I see that light again, I will surely follow it. Has my life changed as a result of my near death experience? I would have to say very much. I had a real fear of death before. I didn't know if there was a God. I didn't know if we just turned into dust at physical death. Now I know we do survive. I also believe that there's a Supreme Being of some kind, though what that is I think is far beyond our understanding. I have become far more sensitive to the inner life of people, and considerate. People who would have upset me before my NDE, I now can care for, even though their behavior might be construed by some to be offensive. And I reach out to help. This world needs more of that.

### Crop Circle Conference

Power Places Tours organized a crop circle conference in Salisbury, England at the end of July and it gathered many experts. Zecharia Sitchin, author of Genesis Revisited and other interesting books, linked the creation of Stonehenge to a global phenomenon that started about 3,100 BC when a being he identifies as Toth left the Egypto-Sumerian region due to a power struggle between extraterrestrial factions. He also suggested that Stonehenge's second phase of construction (about 2,100 BC) was related to a zodiacal change (Taurus to Aries) and that the present crop circle formations could also be related to another zodiacal change (Pisces to Aquarius). He also indicated his opinion that our present zodiacal position completed a full cycle and a return to the same astrological situation in which the extraterrestrial lord Enki (from a little known planet of our solar system called Nibiru) first landed upon Earth. (Mr. Sitchin can read and interpret Sumerian inscriptions).

Mr. Colin Andrews, who is recognized as a pioneer crop circle researcher, first said that he had just returned from a "power" meeting in London, in which important political figures (including the British minister of defense) participated to talk about the crop circle formations. He said that after a period of disappointing press coverage regarding the phenomenon, we were at a cross roads of opportunity for reaching more people with more accurate information. He also mentioned that in the coming months he would travel as an invited guest to deliver a speech inside a UN forum.

There were many enlightening declarations from Mr. Andrews. For example: "Even though most cereal crops can be bruised or marked easily, these plants are actually bending unmarked and, as of today, no biologist can replicate this." "The Mandelbrot formation was misaligned by 2 or 3 cm in order to make it correspond to the diatonic scale." "Starch crystals taken from crop circle plants appear abnormal to control crystals of the same plants outside of the circles. This has been seen in many samples." "The cell walls appear altered because of a short exposure to a heat source and this is not found in hoax circles." "An American biologist (name mentioned but unrecorded) found genetic changes in crop circle plants." "Small balls of light are now being reported almost daily in the Avebury, Silbury, Alton Barnes area." "On July 24 of last year, 58 persons including me gathered on a hill. A golden ball of light was registered on a video camera which was mounted on a tripod for four minutes. Then, an aircraft was seen moving towards it and the light zipped away to the north and disappeared." "A few years ago, in two parallel operations, the British government set sophisticated infrared, radar, ultrasonic, radiation and light sensitive equipment in a region where the formations were appearing and one day at 6AM a figure was sighted. Its formation had not been detected." "There are crop circles in Georgia that show the crop circles as they were until 1986." "I support Steven Greer's CSETI approach. We must try to interact." "The pattern of a triangle with circles was mentally projected on purpose by a visiting CSETI team and it in fact appeared on the fields the following day." "The Hopi Indians saw the patterns nine months ago and interpreted them as the signs that the spirits from the sky are about to get here." "Also, the Cogui Indian people from Colombia came out from their centuries old isolation not long ago in order to meet people from the BBC." "We are ignoring the Indian peoples at our own peril." In Europe there are no more pine trees and from what I have personally observed while touring the U.S., the same process of death is being repeated in West Virginia and adjacent regions. "The official position of the British government still is that these formations are somehow caused by whirlwinds."

Dr. Chet B. Snow, psychologist, hypnoterapist and author of Dreams of the Future: a preview of the futures that lie before us, has been working with hypnotic progressions ever since linking with Helen Wambach. He acknowledged that the era in which we live is crucial for the outcome of two basic kinds of possible futures: an apocalyptic one or one of initiation and rebirth. Dr. Snow reported on the coincident Hopi indian and crop circle symbols. It turns out to be that the Hopi elder he spoke with immediately recognized the crop circle pictures he showed him as those found in their sand paintings and in ancient sacred petroglyphs. Dr. Snow said that in Hopi terminology "Kachina" can mean "people from the sky" and they are thought to have lived for some time with their ancestors. When Dr. Snow showed a particular 1991 formation to his Hopi elder friend, he got an emotional response together with an interpretation of the symbol that meant "Mother is Crying". Dr. Snow told about another crop circle of the 1991 season, a fairly simple formation that showed a perfect circle with a crescent moon inside. It was immediately recognized as one of their most ancient symbols related to a prophecy pertaining the imminent return of the ancestors from the sky. After Mr. Snow was allowed to enter a Hopi sacred valley containing ancient petroglyphs with cosmic and historic meaning (he took slide pictures), he was told that the white man would eventually be given back some lost tablets containing information about the origin of man since Creation and that this would help to usher humankind into its next world called "the 5th World."

Colette Dowell, a mathematician involved with "the Mars Mission", explained that certain important mathematical relationships were being discovered regarding the crop circles. She explained that from the relationships of the diameters of the circles in these formations, the same algorithm that represents the diatonic scale of the white notes on the piano could be found. (She also mentioned that some crop circles had also served to find the chromatic scale in them). Ms. Dowell explained that specific vibratory rates coinciding with specific notes could be derived from the crop circles. By studying these vibratory rates Ms. Dowell is finding correspondences with many important numbers or geometrical relationships. For example, the frequency that can be derived from the circle with a crescent moon inside is 7,920 and it coincides with the note G and with Earth's diameter in miles. By creatively looking at frequencies in the range of ten hypothetical keyboard scales below and beyond middle C, she began to find numbers that coincide with solstice periods, ratios of the Great Pyramid at Gizah, ancient Egyptian measuring systems, certain constants and other things.

Ms. Dowell said that she received certain words while working with Earth and Moon mathematics. They were: "magnitude", "alternate", "melodic", "harmonic" and "intervals". She also said that the study of the complex "Barbury Castle" formation of 1991 had yielded both the diatonic and the chromatic scales. From the spiral progression found in relation with the chromatic scale, the Fibonacci series could be derived. Interlocking tetrahedra could also be derived and from them hypertetrahedra which according to Richard Hoagland are related to the relationship between a higher spatial dimension and our known physical dimension.

Barbara Lang, psychologist and researcher, reported that crop circles have appeared in rice paddie fields in Japan as well as in different Canadian provinces. She said that in Saskatchewan circles were seen in the making (a spinning object that flew away). About the U.S., she said that these formations have been found in Kansas, Missouri, Iowa, Wisconsin, Florida, Wyoming, Washington State and Montana. (We must remember that recently teenagers saw UFOS associated with the appearance of darkened circular markings inside a Texas ranch and that this was reported on national TV). Ms. Lang also informed that crop circles had been sighted in Russia, France, Italy, Belgium, Germany, Switzerland, Hungary, Czechoslovakia, Australia, New Zealand, Norway and Brazil, although 80% have appeared in England, specially within the Wessex-Wiltshire-Westchester area.

Barbara Hand Clow, author of Signet of Atlantis and other books that attempt to explain many new age mysteries as they relate to shamanic traditions and extraterrestrial information said that since the crop circle phenomenon began (to be noticed) she has been interfacing with information related to "what was powerful in ancient days and was beginning to happen nowadays." She said that as part of the explanation, the crop circles coincided with the return of the Anunaki ETs from planet Nibiru and with the passage of Earth through a consciousness accelerating photon belt. Ms. Hand Clow said that information was coming to us codified and that, in a way, consciousness-energy was making it self visible. She also said that it was imprinting our DNA.

Many other researchers of importance spoke during the conference. Among them were David Spangler and Sir George Trevelyan. In summation of their presentations (because of space considerations), I can say that Mr. Spangler brilliantly expounded that we should try to avoid the warring, exclusivistic attitude of previous "new age" movements if we are to truly change. (He didn't spoke much about the crop circles). Sir George, on the other hand, spoke (with a wonderful prose and poetry and with two shining eyes that represented a remarkably youthful and inspired spirit) that we were indeed one with the source of it all and that because of this reason everything was possible. He stressed that we actually live in a wonderful and enchanted universe of love.

"I was getting pretty upset at all the running around," Schiff said. "Generally, I'm a skeptic on UFOs and alien beings, but there are indications from the runaround that I got that whatever it was, it wasn't a balloon. Apparently, it's another government coverup," he said.

## The search for a UFO coverup: Encounters of a GAO kind

WASHINGTON — Where television's "Unsolved Mysteries" has tried and failed, the General Accounting Office is unafraid to venture.

At the request of Rep. Steven Schiff, R-N.M., Congress' investigative branch has begun a study to determine whether the government covered up a story alleging that the bodies of alien space voyagers were removed from a crashed flying saucer found near Roswell, N.M., in 1947.

After the purported crash of the spacecraft, the bodies of the extraterrestrial visitors were said by a local undertaker and other conspiracy theorists to have been autopsied and then secretly flown to an Air Force base in Ohio.

The "Roswell Incident" has been repeatedly dismissed by the Defense Department as nothing more than UFO fantasizing triggered by the discovery of a downed weather balloon.

In 1989, NBC's "Unsolved Mysteries" investigated the controversy, which the program's host, Robert Stack, concluded remained unsolved.

But now the GAO has begun searching for documents to prove allegations that the Air Force suppressed information sought by Schiff, a member of the House Government Operations Committee, which oversees the GAO.

GAO spokeswoman Laura A. Koppelson said, "As far as I know only one investigator had been assigned" to the case so far, and that not enough work had been done to report any results back to Schiff.

She said there was no way to estimate how much the investigation would cost, and that the GAO does not release such information anyway.

The GAO conducted 1,380 inquiries into government operations in 1992. Its budget has risen from \$46.9 million in 1965 to \$490 million last year. The agency has been criticized, especially by Republicans, as the "lap dog of the requesters," producing reports that tend to support whatever conclusion the requesting member of Congress suggests.

Schiff said that at a routine meeting he had with GAO Controller General Charles A. Bowsher in October, he had merely complained about the Defense Department's lack of responsiveness but that a GAO official said, "We're willing to take a stab at it."

Schiff said that last March, after receiving inquiries from "UFO believers" and some Roswell residents who were in the military in 1947, he wrote to Defense Secretary Les Aspin asking for more information.

Schiff said that after he called Aspin to request a Defense Department briefing on the Roswell incident, he received a call from an Air Force officer who brusquely told him the documents had been turned over to the National Archives.

Schiff said Archives officials told him they did not have the records on Roswell.

# HBO Plans New Film on Roswell Crash

*New Witnesses to Alien Bodies Emerge*

**H**BO is presently in the casting stage for a new movie that will appear on the cable station sometime by the end of this year. The movie will be a dramatization of *UFO Crash at Roswell*, a 1991 book written by Kevin Randle and Donald Schmitt. The film's release will occur simultaneously with that of a new book by the two authors, which promises to rewrite what happened on an extraordinary day in July 1947 near Roswell, New Mexico.

After learning of HBO's plans, I called Don Schmitt for the inside info and the latest on their continuing investigation into the most important event of our century--the crash of a craft from another world and the recovery of alien bodies. Before I cover my discussion and interview with Schmitt, I would like to briefly discuss the history of UFO crashes.

### UFO Crash Reports


The first stories about flying saucer crashes unfortunately were hoaxes. The *Nebraska Nugget*, in 1884, wrote about a blazing object that plunged to the Earth spreading "fragments of cogwheels and other pieces of machinery . . . and glowing with heat so intense as to scorch the grass for a long distance around each fragment and make it impossible for one to approach it."

The crash was reportedly witnessed by a few Dundy County cowboys, and the object was

supposedly so bright that it blinded one of the witnesses. Well, it was later learned that the incident was a fanciful hoax, which made interesting reading for the *Nugget's* readers, and perhaps sold a few extra papers as well.

### More Hoaxes

Frank Scully, author of the 1950 book *Behind the Flying Saucers*, wrote about crashes of Venusian spacecraft in New Mexico and Arizona. Two years later, it was learned that Scully's informants were nothing more than professional con artists. These and other spoofs left a bad taste in the mouth of principal UFO organizations of that time, such as the National Investigations Committee on Aerial Phenomenon (NICAP), the Aerial



Phenomena Research Organization (APRO), and the Civilian Saucer Intelligence. These organizations dismissed most of the crashed saucer stories, desiring not to be embarrassed victims of hoaxers.

The early UFO organizations felt the U.S. Government was covering up information about UFOs, but they never felt the government had actually recovered any of them. Perhaps if their attitudes were different, ufologists would have suspected sooner that our government possibly had at least one UFO in its possession.

### Fictitious Claims?

Rumors began surfacing in early ufology that Wright-Patterson A.F.B., Ohio, was where flying saucer remains and *gray-skinned humanoid beings* were being studied by scientists. The whole matter was rumored to be highly classified because of fears of public panic, and to keep the Soviets from realizing that the U.S. had access to alien technology.

Again, these were only rumors, almost impossible to verify, and serious ufologists continued to dismiss them.

### The Roswell Case

It was veteran ufologist Leonard Stringfield, one of the world's present day experts on UFO crash/retrievals, who, in 1978, began to push for the investigation of UFO crash stories. It was also in 1978 that Stanton Friedman, author of *Crash at Corona*, and William Moore, author of *The Roswell Incident*, got together to discuss an event that took place in early July 1947.

On July 8, 1947, the *Roswell Daily Record*, a small paper in Roswell, New Mexico, printed a story headlined, "RAAF Captures

Flying Saucer On Ranch in Roswell Region." The story broke like wild fire. Calls flooded into the area from around the world. However, the next day, the same paper ran a story announcing that officials from Roswell Army Air Field were mistaken; the debris recovered from a desert ranch was nothing more than a crashed weather balloon. After being shown debris from a weather balloon rather than from the actual wreckage, the reporters were convinced, and so ended the story . . . at least for a while!

Friedman and Moore decided to begin investigating the incident, and discovered enough evidence to strongly suggest that it was not a weather balloon but an actual extraterrestrial craft which crashed on that day. The two also learned that the military organized a retrieval operation, reprimanded local officials for their press release, and created a cover-up story involving a weather balloon to kill interest. The plans for a cover-up originated from high ranking officials at the Pentagon.

An illustration of the extent of cover-up can be seen in one story Friedman looked into. Linda Sleepy, a teletype operator at the KOAT radio station in Albuquerque, received a telephone call on July 7, 1947 from Johnny McBoyle, a reporter at sister station KSWs in Roswell. KSWs had no teletype of their own, so they used KOAT's whenever they wanted something to get out.

McBoyle excitedly told Sleepy

that a genuine flying saucer crashed near Roswell, and that the Army was presently picking it up. He claimed that he had seen the object himself, and described it as looking like a "big crumbled dishpan." McBoyle also said that the Army personnel were talking about "little men" that were found with the craft. McBoyle asked Sleepy to begin putting the story immediately on the teletype.

As McBoyle began dictating the story, Sleepy typed. A few sentences later, the teletype stopped. Thinking there was a mechanical problem, Sleepy explained to McBoyle what happened. However, McBoyle was distracted and Sleepy could hear him talking to someone else. In a strained voice McBoyle said, "Wait a minute. I'll get back to you." Immediately the teletype began again, this time it said: "ATTENTION ALBUQUERQUE: DO NOT TRANSMIT. REPEAT DO NOT TRANSMIT THIS MESSAGE. STOP COMMUNICATION IMMEDIATELY."

Now amazed, Sleepy told McBoyle what she was reading.

McBoyle answered by saying she could forget everything he told her; she wasn't supposed to know what he had said. Later, when Friedman asked McBoyle about the incident, McBoyle was quoted as saying, "Forget about it . . . It never happened."

Eventually, Friedman and Moore gathered about 100 informants involved with the case, and they pieced together a fascinating tale. Each man later co-wrote his own book about the investigations.

In 1988, the J. Allen Hynek Center for UFO Studies (CUFOS) decided to conduct its own separate investigation into the Roswell incident, spearheaded by Kevin Randle and Don Schmitt. Randle is a former Air Force intelligence officer, and Schmitt is the Director of Special Investigations for CU-FOS. They were able to turn up

of Roswell, New Mexico.

On the following day, Brazel discovered a large amount of debris in a remote pasture. The debris was scattered over a 3/4 mile area, and there was a gouge in the ground 200 to 300 feet wide and some 500 feet long. There appeared to be some sort of metal scattered about the crash site. It was very lightweight like balsa wood, but was much stronger. The metal was as thin as foil, but couldn't be cut or dented. There were also some I-beam shaped pieces with purplish geometric symbols on them. The language was unidentifiable to the witnesses. Brazel found one large circular piece of debris and stored it in his shed.

On July 6, Brazel drove to Roswell and reported his discovery to Sheriff Wilcox, who in turn

four alien bodies, for later that evening, a Sgt. Melvin Brown looked under a tarp on the back of a truck at the impact site and saw several alien-looking bodies. Also that evening, local mortician Glenn Dennis received several calls from the base about preserving tissue, and was asked about the smallest caskets that he had.

Dennis was told that there were three mortalities--two of which had badly mangled bodies, but the other was in good condition. Records show that there were no deaths at the Roswell Army Air Field during that time, and there were none at the base hospital either.

After the inquiries from military officials, Dennis drove to the base hospital out of curiosity, but was warned by a nurse friend of endangering himself by being present.

"My God, you are going to get yourself killed," the nurse told him.

He was then abruptly forced to leave by two military police, who grabbed him, lifted him off his feet, and carried him outside. Later, the nurse told Dennis privately why he was so rudely treated. The military, she told him, had recovered from the desert the remains of bodies that were not human!

Through their investigations, Randle and Schmitt have learned what these creatures looked like. The bodies were non-human, and were smaller than adults in size. They weighed about 40 lbs. and were about 3 1/2 to 4 feet tall. The hands had four fingers with no apparent thumb. Heads were very large in proportion to the bodies--

more informants than had previous investigations, and disagreed with some of the information from the Friedman/Moore research. Their results were later published in a book, the basis for the upcoming HBO movie.


#### **Information From The Case**

Despite some differences, all investigating parties agree that a craft not of this world crashed, there was a military retrieval of debris (followed by a cover-up story), and alien bodies were discovered. With all this in mind, we can briefly summarize the Roswell case as follows:

On the evening of July 2, 1947, Mac Brazel and others heard a loud explosion near his home northwest

notified the Roswell Army Air Field. Officials from the Roswell base examined the crash debris at the site, along with the piece in Brazel's shed.

On July 8, Roswell Base Commander Col. William H. Blanchard, dictated a press release to Public Information Officer Walter Haut that a flying disk had been recovered. Meanwhile, military officials began flying out the debris, and guards were posted on the access roads to the debris field to turn away visitors. That same day the *Roswell Daily Record* printed the "RAAF Captures Flying Saucer" story. The military at that point was flying over and searching the area. At some time during these early events, the military discovered

larger than human's--and were bald. Their eyes were large with a concave shape. In fact, the nose, ears and eyes were all slightly concave. They had a slit for a mouth, an indistinct nose, and small openings on the side of their heads for ears. The bodies were pinkish gray in color, and overall, the skull and bones were very fragile.

An interesting feature of the bodies were the arms. The bones from the shoulder to the elbows were shorter than the bones from the elbow to the wrist. Allegedly, the bodies were frozen and flown to Wright Field, which is today Wright-Patterson AFB.

This case, along with the tremendous amount of witness testimony surrounding it, surely represents one of the most important events in man's history. If all is disclosed (the craft and the bodies) by our government, it would represent solid evidence for the existence of other life in our universe.

It would curb the narrow-minded thinking among the NASA SETI folks that life is everywhere in the universe but just never comes here. It would also humble humanity. No

longer would we view ourselves as the highest forms of life in the universe. And, it would create a domino effect, revealing that the government has orchestrated large-scale cover-up programs on this subject, and perhaps countless others.

We may be able to learn more about our past, our future, and possibly our links and relationships to extraterrestrial lifeforms, when we fully know the truth. Many questions researchers have asked may be answered by those who we elected to rule over us, but who have lied and denied us the truth.

So this case represents a lot. And although for over 45 years the cover-up has been successful, it may not last, for the efforts of researchers such as the one we will introduce next are making a difference, and may turn things around for us all.

## Interview with Don Schmitt

After learning that HBO was going to do a movie based on the book *UFO Crash At Roswell*, I was elated about the idea. I immediately contacted Don Schmitt to find out more, and he had quite a lot to say.

Schmitt told me that HBO first approached him and Randle with the idea for a movie before their book was ever released. The co-producer for the project wanted to write his own script based solely on their information. The movie will be a dramatization of the Roswell event, based 100% on their book. Schmitt and Randle will be working as technical consultants for the film. Location for the shoot will be somewhere in the Southwest with the exact location still undetermined. HBO is striving to release the movie by the end of this year. At the moment, no filming has been done--they are "still in the process of casting." Schmitt was asked not to release any info on characters.

I asked Schmitt if the movie will portray any actual ufologists. He told me that so far all scripts submitted have included Kevin and Randle, played by actors. However, they asked to be taken out so as not to appear "too self-serving." HBO also offered Schmitt and Randle small appearances but they declined.

I switched the conversation to the recent movie "Fire In The Sky," and the harsh criticism it received from ufologist for fictionalizing the abduction events (See *U.E.* Vol. 1 #6). I asked Schmitt if he was worried that the HBO movie might suffer the same fate--criticism because the movie makers change the story to create mass appeal. Schmitt explained that they were very fortunate to have met numerous times with the co-producer, the director, and the writer for the movie to ensure that the story remained accurate. In going through

the different drafts, Schmitt explained that there was a great deal of effort to stick to the original story.

The challenge was how to depict the events. Should they be described by retired military officers reminiscing about them, or should they be presented in a story set at the time of the incident? There were many different avenues to choose from, "but they always depicted the event itself almost entirely as we described it in our book," Schmitt explained. What HBO had to create was the dialogue, and even for this they consulted experts.

"What do you think about this line?" Schmitt said the producer would ask. "Would this person say this?" and so forth. "They kept very close contact with us," Schmitt explained.

As technical advisors, people are generally involved in the production, but are seldom allowed to have much input into the script, as have Randle and Schmitt. And to make sure everything is correct, HBO's legal department has been heavily involved in verifying the testimony of Randle and Schmitt's key witnesses.

I was curious to know what those involved with the production actually thought about the Roswell story.

"What's great about the entire production," Schmitt explained, "is that everyone from the producer, to the director, to the screenwriter, is 100% behind the Roswell case. . . . They really didn't know much about it until they read our book. Now they stand behind us."

To give me an example of the

commitment HBO has to the story, Schmitt read me a statement from Mr. Kopit, the screenwriter: "Randle and Schmitt's work is based on hard, extensive and rigorous journalism. *UFO Crash At Roswell*, a scrupulous examination of a purported government cover-up, is such a work. It makes a very serious charge. If proved true, *and I really think it is true*, what is being covered up is of major historical significance."

---

**Latest Investigations And The New Book**

Schmitt told me during our discussion that their investigation has uncovered a staggering 600 first-, second-, and third-hand witnesses to the events at Roswell. What is even more amazing is that they now have over a half-dozen living, first-hand witnesses to the alien bodies! And with their new book, "we will be including first-hand drawings--and certainly all first-hand testimony," Schmitt said. "Based on first-hand testimony, we will be rewriting much of what people's overall conception of what the Roswell case is. It isn't what most people have thought all these years. It won't be just an update. It is in fact a complete rewrite. I would say about 75% new information."

In Randle & Schmitt's first book, they were relying solely on second-hand witnesses to the alien bodies, such as "the Glenn Dennis story," Schmitt said, "even trying

to tie in the Barney Barnett story, which we have thoroughly dismissed." That's not all they have dismissed from previous investigations. "As far as everything that we have been unable to uncover, the entire Plains of San Agustin story is nothing but a rumor," he said.

Schmitt hopes that the simultaneous releases of the movie and their book will motivate some of the remaining witnesses to come forward. Their previous book, which was released in paperback, brought

in hundreds of letters with leads and information. Their future work will be published in a hardback edition, a more climactic ending to their years of investigation.

I asked Schmitt if he hoped to help initiate a congressional hearing on the Roswell events using the witnesses he and Randle have. He responded by saying that has been in the works for a couple of years, but because of the sensitive nature of the material, they were not ready to release all of their witnesses--not without more reassurance that the individuals won't be harassed into silence.

"Has there been any evidence at all," I inquired, "of any effort by any agency, government or civilian, to stumble you in your investigations, or keep you from getting your information out to the public?"

Schmitt answered, "Sadly, and as you mentioned earlier, Torme' [screenwriter for *Fire In The Sky*] ran into the same situation. Most of the roadblocks, most of the distractions, most of the harassment, if not

all, has come from the field [ufology] . . . everything from efforts to censor our book, letters to our publisher and threatened law suits."

Schmitt commented that his only regret is that he didn't begin investigating Roswell years before when many of the first-hand witnesses were still alive. He said that looking back on previous investigations, there was "a very half-hearted effort, very incompetent in many respects."

"The Roswell investigation until Kevin and I started five years ago," Schmitt remarked, "was in limbo . . . nobody was doing anything . . . it was all MJ12. And all of a sudden we start and it's like, 'Oh my God, we have to stop these people . . . we have to stop these guys.' Again it raises some very serious questions. What are the priorities in this field? Is it the truth? Or, is it totally monetary--totally self serving? I mean, how do you claim priority on a historic event? There are over 200 books on the Kennedy assassination, and they threaten to sue because we are doing our own independent investigation of Roswell. . . . I'm not going to name names here--people know who they are."

Schmitt talked about another obstacle that, for the last 45 years, ufology has had to negotiate--the media. "I think once the media would start looking into this and asking the hard questions and pushing for the true nature of the phenomenon, we could really open some doors overnight."

I asked Schmitt what other

difficulties he and Randle have experienced. "We've had some mild threats and have questioned whether or not our phone has been tapped," Schmitt said. "Vehicles with government plates, for example, have pulled in front of my house and even in front of my driveway on a number of occasions. . . . They occasionally put out little test flags, to see how we respond. 'What will it take to shake these guys?' . . . But we are encouraged by it; again, it must mean we are on to something."

I asked Schmitt where he would like to see the case go from here.

"There are still witnesses that we have been in hot pursuit (of) for the last five years--firsthand witnesses that we know were directly involved, not only with the debris and the craft itself," Schmitt said, "but certainly with the bodies. We've heard that there were hundreds of photographs taken. Certainly there had to have been a ton of documentation."

I asked Schmitt what it would take for him to back away from the case. He said he has been asked this before, even by two generals.

"Not by threat, not by harassment, not by intimidation and not by word," Schmitt responded. "They would have to show us--they would have to demonstrate to us that it would indeed be a threat to national security. Documentation won't do it; photographs won't do it. In other words, we would


have to see the genuine article, and then they would have to demonstrate why this is such a terrible secret. After all these years, why are we still unable to handle such an acknowledgment?"

"The point is if we can all concede that some event, some very extraordinary event took place down in Roswell and is still being covered up today, then the next question is, 'what?'"

"We have always been objective enough to go wherever the evidence leads us. And today, with over 600 witnesses unanimously telling us this was extraterrestrial, we are pretty well left with that explanation."

What Roswell has proven, Schmitt explained, is that no matter how old a case is, if there are witnesses still alive, there is great potential for significant discoveries. "There are files just sitting, begging to be reopened, because if a case is classified as unidentified, it is still an active case."

Surely there is another case as significant as Roswell that has never been investigated. We just have to keep searching. But who knows what tomorrow may bring? Another UFO crash could happen anywhere. This time we just have to beat the government to it.
