UFO WITNESSES 'SILENCED'--Mysterious men dressed in Air Force uniforms or bearing impressive credentials from government agencies have been 'silencing' UFO witnesses, according to Col. George P. Freeman, Pentagon spokesman for Project Blue Book. "We have checked a number of these cases," Freeman said, "and these men are not connected with the Air Force in any way." He cited one recent case in which the police officers and other witnesses at the UFO sightings in Wanaque, New Jersey were allegedly collected together by a man wearing an Air Force uniform. They were told that they "hadn't seen anything" and that they shouldn't discuss the incident. "We checked with the local AFB," Freeman declared, and discovered that no one connected with the Air Force had visited Wanaque on the date in question. Whoever it was, he wasn't from the Air Force." Another mystery man, this one bearing credentials from the North American Air Defense (NORAD), turned up at the home of Rex Heflin, a man who had taken a series of UFO pictures in California in 1965, and demanded the originals. Later, NORAD denied having anything to do with the incident. Maj. General M.M. Magee, NORAD's chief of staff, later told Rep. James B. Utt, R-California that "for your information NORAD does not have the responsibility for the evaluation of UFO's and therefore would not knowingly be in the business of collecting UFO pictures for evaluation. In addition, the office of primary interest for UFO matters is the Department of the Air Force." Heflin's photos have never been returned and the Air Force has never been able to determine the identity of the mystery man who took them. Similar mystery men, according to other sources, have turned up and confronted UFO witnesses in the states of Washington, Texas, Connecticut, and on Long Island, New York.

In February, 1960, Joe Perry, a restaurant owner in Grand Blanc, Mich., took a series of UFO pictures and was soon visited by two men posing as FBI agents. They seized a photo of a dome-shaped object with a green tail. More recently, a man claiming to represent "a government agency so secret that he couldn't give the name" appeared in a school in Norwalk, Connecticut and grilled two 12-year-old boys for two hours about the disc-shaped object they said had pursued them at ground level in April 1966. "We haven't been able to find out anything about these men," Freeman admitted. "By posing as Air Force officers and government agents they are committing a federal offense. We would like to catch one." When asked if any efforts have been made to track down the elusive impostors, Freeman replied: "Unfortunately, the trail is always too cold by the time we hear about these cases. But we're still trying." Freeman also commented on the numerous reports of sightings of low-flying unmarked planes over areas where UFO's had recently been seen. "That's a federal offense, too," he said. "All Air Force planes are clearly marked. We don't know anything about these unmarked planes. We'd like to catch one of them too." Many witnesses swore that they saw several Air Force helicopters over Wanaque reservoir following a UFO sighting last October. Freeman said that a careful check had been made in that area at that time. "Besides," he continued, "most Air Force bases have

only one or two helicopters for rescue work. I just don't know where a whole formation of them could have come from.

MANY FLYING OBJECTS REPORTED OVER NORTHEAST PENNSYLVANIA--Something has been zipping around Northeastern Pennsylvania skies for several months, causing consternation in several areas. There's been some highly unusual events occurring there involving aerial phenomena over the past several months. Some of the witnesses talk freely about them. The sightings go back as far as last July. One of those who will talk about it and who admits she was terrified by her experience is Mrs. Robert Non, Pleasant Mount. "I was on my way home from work last November 30...it was about 12:10 a.m., I think," she said. On the two-lane road she travels through the rolling hills to her home, she spotted an object "about 35 feet long with alternating green and red lights hovering over a tree and about 100 feet off the ground. I thought at first it was a plane, but I realized it was not moving. I saw it for about a mile ahead of me and as I got closer it moved from one side of the road to the other. It didn't make a sound...there was no noise at all. When I was less than an eighth of a mile away, it veered down the road toward my car; it looked like it was actually following the road. I swung the car toward the ditch to avoid a collision and this 'thing' zoomed over the car and disappeared at a terrific speed. I was scared to death!". Mrs. Non told of a nearby farmer who spotted one of the objects while at work on his tractor toward dusk. He got into his truck and began heading toward the farmhouse and was followed by the UFO traveling at a low level. Then, there was the woman--not identified--from nearby Starlight who spotted a UFO setting down not far from her trailer on "tripod landing legs." She was terrified and before she could bring herself to look out again, it was gone. Some of the residents report farm animals and dogs "kicking up a fuss" at times when the objects are sighted. Descriptions of the "things"--despite the variance in times of the sightings--generally conform. They are described as having colored and alternately blinking lights, they are shaped somewhat like a "man's Panama hat," some claim there is a dome protruding from the bottom and others have seen a brilliant light torching down from the middle of the underside.

GLOWING OBJECT LANDS IN OKLAHOMA--A flying object with the appearance of a large blue and green light was spotted January 5 by Mrs. Ralph Beard, as they were driving from Greenfield towards Geary, Oklahoma about 11:15 p.m. She said it appeared to be traveling south at a high rate of speed and was very close to the ground. After disappearing behind a hill, the UFO was seen for a second time by Mrs. Beard's sister, Mrs. Lillian White Thunder and Donnie Beard, about a half mile from the highway and looked to be about the size of the moon. When seen the second time it was said to be on the ground but when they got near Geary they said it was in the air again and was still headed south.

UNIVERSITY STUDENTS REPORT UFO's--Scores of students at the University of Mississippi have reported sighting flying objects. A sociology professor at the university claims there are non-earthlings aboard the objects. Dr. Joseph Bruening, assistant professor of sociology and long-time believer in UFO's described one of the sightings as "diamond-shaped with a red light on the bottom and green light on the top. It hovered in this area awhile, then flew off toward Batesville. Evidence points conclusively," he said, "toward this being a manifestation of alien intelligence." Ann Murphy, a sophomore, reported seeing the objects on January 11 and 12. Katherine Milner went to Sardis Lake to

see a UFO, after she heard that Dr. Bruening had told some of his classes that UFO's went to Sardis at night to get water. "Six of us went out there," she said. "We stopped at Kyle Memorial Park, then all of a sudden we saw this white flashing light through the trees. It went straight up, hesitated and then went straight across the sky. It looked like three lights going across and back, kinda like a Thunderbird's turn signal. And it had a strange sound, real faint, that would get louder and then quiet. I was screaming, but they told me to be quiet so they could hear."

ANOTHER OBJECT SEEN NEAR ALLENTOWN, PENNSYLVANIA--A Sandt's Eddy, Penn. man reported he sighted a mysterious aerial object on January 9 just before 11 p.m. Leonard Sabatine, Jr., owner of a radio and electric service company, said he saw two large dome-shaped lights hovering over tree tops near his home. He told of hearing a sound, which seemed associated with the lights, varying in pitch from a high squeal to a low hum. The phenomena disappeared within five or six minutes after the first sighting, he said.

CHILDREN FRIGHTENED BY 'OBJECT'--An Eaton Rapids woman called Sheriff's deputies January 11 to report that her three children, ages seven, eight, and nine, were frightened by an object in the sky as they waited for a school bus. The children are reported to have seen something "dome-shaped with red and blue flashing lights" and with "a type of tail." They told their mother they spotted the UFO heading east over woods, and said it made a circle over their heads and then went south over a rooftop. A similar object was photographed at Mt. Clemens, Michigan the day before the Eaton Rapids, Michigan sighting.

ASTRONOMER SAYS UFO'S FOR THE BIRDS--A widely known priest-astronomer here summed up a raging controversy in a few words--"UFO's are for the birds." Father Francis J. Heyden, S.J., Georgetown University's astronomer, was talking about the nationwide hub-hub stirred up once again by reports of UFO's. In a lecture at the university, the Jesuit scientist disclosed he has been peering through powerful telescopes for nearly 60 years and has yet to see a flying object. The university's pre-space age authority on outer space, speaking on "The Mysteries of UFO's," emphasized there has yet to be presented any concrete evidence that such phenomena as unidentified flying objects exist. He said they are explainable by current scientific knowledge.

MAN STRUCK ON ARM BY UFO OBJECT?--Samuel S. Westfall of Galesburg, Illinois said he saw UFO's on January 11 and 12. Westfall said that the first sighting was southwest of the Gates Rubber Company. The object was shaped like a ball and was red, he said. Westfall said the object landed and he and several other persons watched it for five minutes before it flew away. The next night Westfall said he saw the thing again. "It just flew overhead and didn't land," he said. When he went looking for it on January 14, Westfall said he was struck in the arm by a small round object he thinks was fired by somebody from outer space. "It was imbedded in the arm and my wife and I worked to pull it out." Westfall said he saw nobody when the object struck his arm.

FLYING OBJECTS OVER CANADA--A bright eight-year-old Grade 2 pupil is convinced he saw a UFO January 18 about 6:30 p.m. "I was getting ready to go to bingo," said Mrs. Chute. "David was behind the drapes looking out the window...Then he called come and look, come and look at the

flying object. And there it was, all bright lights across the road and moving away into the distance. I ran to the kitchen window and then saw it was further away. David said: "It was suddenly there over the two houses across the street. There were bright lights flickering all around it and it hurt my eyes. It came closer and two things like legs came out from underneath it. Then they went back and it started to go away." "David was scared and it hurt his eyes," Mrs. Chute said. "He went to lie down for twenty minutes or so but his eyes still hurt afterwards. I know we saw something and it wasn't a plane." David drew a sketch of the UFO he saw and added, "I was scared but I saw it. The lights made me rub my eyes. There wasn't much noise, it just kept going vee-m, vee-m, like a buzzing sound. It was big enough to cover the two houses across the street." The above incident occurred at Fort Erie in the Province of Ontario. On the following night, UFO's were sighted over the Province of New Brunswick. A Cormier Cove teenager, Dianne Arsenault, 16, and Simone Landry, 14, reported seeing a ball-shaped object, traveling "very fast." The object was in sight for about three minutes, and was revolving and moved west and north at great speed. CKCW Radio Station manager Earle Ross, Moncton, sighted a strange lighted object over the Petitcodiac River while driving from Riverview Heights to the city. Mr. Ross said he was approaching the river bridge on the Gunningsville side and had stopped his car at the stop sign when he noticed a bright object approaching from the east and at a height of between 500 and 700 feet above the river. The object seemed to be similar in color to a shooting star, Mr. Ross said, only it was larger. As it neared the bridge it changed direction and rose vertically, disappearing in a few seconds.

HUGE UFO LANDS IN ILLINOIS--A Knoxville, Illinois area farmer said that a huge UFO followed him as he drove his car along the Victoria blacktop on January 20. The man, who said he did not want to give his name, told Galesburg police that the peculiar round object landed in a strip mine area. He said he was driving south on the blacktop about four miles from Victoria when the object appeared above the road. At first glance the farmer said he thought it was a semi-truck. He described it as big as a barn. The driver of another car apparently saw the same thing, the farmer said. The farmer said the object emitted a bright "greenish-blue glow" and he could feel vibrations in his truck. This was about 7:30 pm.

MORE FLYING OBJECTS OVER WEST VIRGINIA--The pilots of the UFO's have a liking for West Virginia. Two young boys said they watched a brilliant ball of light play in the mountains above Riverdale Acres near Nitro about 7:30 p.m. January 21. The boys, Robin Trowbridge, 14, and Jimmy Carnes, 15, said they were watching the moon through a surveyor's transit when the ball of light swooped down the hill. A St. Albans man said that he watched a brilliant light settle in the mountains above Coal River in a place almost inaccessible to even a person on foot. He said the trees on the top of the mountain were bathed by the light several seconds before it vanished. On the 21st of January, a Charleston woman and her husband were driving along U.S. 60 between St. Albans and Spring Hill when an object flared up in the sky before them. She reported the object as being trimmed in pale pink and green with a red tail.

'BOOMERANG' OVER HOUSTON, TEXAS--Houston, Texas police said they received eight reports of UFO's within an hour on January 21. Pasadena, Texas police said they received one report, and Ellington Air Force Base reported two calls. Dr. Albert Kuntz, a psychologist with the University

of Houston counseling and testing department, said he kept an unidentified object in sight from 7 to 8:30 p.m., when fog closed in. "It was a lighted object moving at tremendous speed," Kuntz said. "It stopped, it appeared, instantly, then retraced. It was erratic in terms of the movement it made. It looked like a boomerang. Occasionally you could see what appeared to be a red light or lights." Kuntz said during the entire hour and a half that the object was visible it darted about the same part of the sky. He said he could not estimate either its size or its distance. Bill H. Osborne, of Pasadena, Texas, a former geologist who now is personnel director for an engineering firm, said four neighborhood youngsters, 8 to 11-years-old, told him they had seen a "fuzzy white light" which settled over a Pasadena water tower. "The thing got nearer to the tower," Osborne said the boys told him, "and settled down right over a red aircraft clearance light. As it settled, the red light went out. Then the white light began to rise, and as it rose it got brighter."

TWO UFO'S SPOTTED OVER HAWAIIAN ISLANDS--At least seven policemen, several commercial pilots and a ship at sea reported flying objects over Oahu on January 22. One policeman said he saw jet planes approach one of the objects, but this was denied by military authorities. Police logged the first UFO at 5:50 a.m. It moved generally from Koko Head toward Ewa during a six-minute period. The first officers to report the object described it as "a bright, yellow-orange light," similar to a star except for its color, centered in a circular blue mist "about 100 times larger than the light." The light remained centered in the blue mist as the UFO moved, the officers said. One of the officers said the object appeared to be moving slowly against the sky, but rapidly when seen against the stars. The object did not leave a vapor trail, the officers said. They said they watched the UFO for six minutes as it moved seaward and toward Ewa. Then, in a period of about 30 seconds, the mist faded away and a few seconds later the light vanished, they said. The second object--appearing as two bright lights, was reported at 6:03 a.m.--four minutes after the first. That was when residents began calling police. Several policemen also reported seeing the lights over a period of about 25 minutes. The lights appeared to be hovering over Koko Head, but moving from west to east--opposite of the first object, according to viewers. A policeman in Waikiki spotted the lights at 6:20 a.m. At 6:24 he radioed police headquarters that a jet plane was approaching the lights. At 6:28 he said one jet was near the lights and that other planes were approaching. But the Air Force denied that any jets had been sent to inspect the lights.

CIGAR-SHAPED OBJECT HOVERS OVER ELECTRIC TRANSMISSION LINES--On January 24, Nicholas J. Rinaldi sighted a cigar-shaped UFO hovering over electric transmission lines at Cromwell, Connecticut. The object was hovering about 50 feet above the ground. In addition to Rinaldi, at least 20 people are said to have spotted a cigar-shaped object in the sky about the same time. Karen Ercolani, a waitress at Ford News Agency in Middletown, said she was driving in the Plum Road area a little after 7 p.m. when she and two companions saw a cigar-shaped object, appearing to be the length of a football field. There was no noise, she said, and the UFO darted behind a hill. About five minutes after the trio saw it, they reported seeing several planes circling the area. Rinaldi was in his car when he saw the object. "It must have been 300-feet long, or maybe longer," he said, "and it made a low whirring noise like a top." Rinaldi said the object had three red lights, one at each end and one

off center. He watched the UFO hovering for about three minutes and said he then saw it turn to a 45-degree angle. At this point, he added, "the whirring noise got louder and the lights got brighter. It moved from right to left in a rocking motion for a while. According to Renaldi, the object then moved toward the Hartford area, stopping briefly over some electric transmission lines. Ronaldi said the object looked to be solid with a smooth surface. It had no color, he added. (Editors Note; The cigar-shaped object was explained away as being three helicopters.)

NEAR LANDING IN WEST VIRGINIA--A Dunbar, West Virginia man says he stopped his truck within 10 feet of a UFO and watched it rise silently out of sight in less than two minutes on January 17. Tad Jones described the object as being a "dull aluminum sphere which hovered about four feet above I-64. The 38-year-old father of two said he saw the strange, ball-like object from about 500 feet away. He said the UFO was from 20 to 25 feet in diameter and blocked the west bound lanes. Jones said that about three seconds after he stopped his truck beside the aluminum ball it ascended into the sky. The sphere had two antenna protruding from the top and four legs with wheels like those of an airplane. He said a propeller-like object was located at the bottom between the legs and was slowly revolving when he stopped his truck. Jones said he did not leave his vehicle. He said, as he watched, the propeller-like object started spinning and the UFO rose swiftly, without noise, odor, exhaust or any sense of heat. He said the propeller-like object resembled an inverted washing machine agitator. The Dunbar man said the antenna did not taper at the top like a car antenna. He said they were as thick as broom handles and about six feet high. He said small balls were on the end of the rods which looked to be of the same material as the sphere. He said when the object went into the air "it was like it had been shot out of a gun."

THEY'RE BACK!--UFO's PROWL MICHIGAN SKIES--Two policemen said they watched a bright orange object glide through the night sky, intermittently ejecting "a stream of fire." Their report tallied with a rash of UFO sightings by other residents of southeastern Michigan on February 16 and 17. The sightings were in the same area where flying objects were seen by the dozens in March and April, 1966. Officers Alfred Rogers and John Markwell of the Eastern Michigan University campus police department in Ypsilanti entered a record of sightings in the police record book. "At 9:40 p.m. a UFO sighted in southeasterly direction. It was orange in color. Light seemed to be very bright. At 1 a.m. another object was sighted in the same area. We then called Ypsilanti police department and they also sighted same object. At 1:15 a.m. two more were sighted. Several persons said they saw an object early in the evening on February 16 near downtown Ann Arbor, Michigan. It had two flashing white lights and a red light in the center. The reports all placed the sighting at about the same time. Tom Gieryn, 16, said he saw the UFO while driving just east of the downtown area. "I thought at first that it was a plane," he said. "But it was moving too slow to be a plane--way too slow. It was too dark outside to make out any kind of shape and I couldn't hear any noise." Gieryn's description tallied with a similar report by Bernice Walda, 24, and Nancy Knowles, 23. They were driving home in separate cars when they spotted the object. "I thought it was a reflection at first," Miss Walda said. "But my girl friend who was in another car, spotted it too." Several students at Eastern Michigan University said they saw an object with a steady, white light that eventually faded out. They said the UFO was moving very slowly.

WHERE DO THE UFO'S COME FROM?--Popular theory has it that the flying objects are: 1. Interplanetary--from planets in our solar system or from planets in nearby solar systems. 2. Interdimensional--from a world of matter beyond that of our 3rd dimension; commonly referred to as the 4th dimension or 'etheric' world. 3. Time Travelers--from a world thousands of years in the future, traveling back into our time period.

NICAP/Seattle maintains an open mind on all of the above mentioned theories inasmuch as there is evidence to support all three of them. With this thought in mind, the following letter is published for the information of all members. The letter was written by a Mr. Gerald Light, Los Angeles, California to a Mr. Meade Layne, San Diego, California, dated April 16, 1954. Mr. Layne, now deceased, was the former director of the Borderline Sciences Research Associates. "My Dear Friend: I have just returned from Muroc. The report is true--devastatingly true! I made the journey in company with Franklin Allen of the Hearst papers and Edwin Nourse of Brookings Institute (Truman's erstwhile financial adviser) and Bishop MacIntyre of L.A. (confidential names, for the present, please.) When we were allowed to enter the restricted section, (after about six hours in which we were checked on every possible item, event, incident and aspect of our personal and public lives) I had the distinct feeling that the world had come to an end with fantastic realism. For I have never seen so many human beings in a state of complete collapse and confusion as they realized that their own world had indeed ended with such finality as to beggar description. The reality of "otherplane" aeroforms is now and forever removed from the realms of speculation and made a rather painful part of the consciousness of every responsible scientific and political group. During my two days visit I saw five separate and distinct types of aircraft being studied and handled by our Air Force officials--with the assistance and permission of The Etherians! I have no words to express my reactions. It has finally happened. It is now a matter of history.

President Eisenhower, as you may already know, was spirited over to Muroc one night during his visit to Palm Springs recently. And it is my conviction that he will ignore the terrific conflict between the various "authorities" and go directly to the people via radio and television--if the impasse continues much longer. From what I could gather, an official statement to the country is being prepared for delivery about the middle of May. I will leave it to your own excellent powers of deduction to construct a fitting picture of the mental and emotional pandemonium that is now shattering the consciousness of hundreds of our scientific "authorities" and all the pundits of the various specialized knowledges that make up our current physics. In some instances I could not stifle a wave of pity that arose in my own being as I watched the pathetic bewilderment of rather brilliant brains struggling to make some sort of rational explanation which would enable them to retain their familiar theories and concepts...I shall never forget those forty-eight hours at Muroc!" (Editors Note: Muroc Dry Lake is located at Edwards Air Force Base, California.)

UFO'S WIN RESPECTABILITY--Flying objects are about to become respectable. After years of orthodox scientific scorn, NASA, the U.S. space agency, may soon cooperate in a major investigation into the phenomena of UFO's. The movement inside NASA to place the rich resources of the agency behind such a study is partly heretical, wholly anonymous and aware that most established physicists would still rather endorse the practice of table-

tapping than admit a serious interest in the existence of strange machines in the sky. But an impressive nucleus of respected scientific talent is now prodding NASA into action. This group is led by Dr. J. Allen Hynek, an astrophysicist from Northwestern University, and the official consultant to the U.S. Air Force on UFO's. For almost two decades, Dr. Hynek was a leading member of the special scientific establishment, inclined to dismiss the UFO phenomenon as a product of a gaudy and undisciplined public imagination. Today he is so impressed with the enormous collection of testimony from reliable witnesses that he has begun to organize responsible scientists to assemble and analyze evidence on flying objects from all over the world. "I've called this group the Invisible College," Dr. Hynek said. "It's very much like the early days of the Royal Society in England, when it was not too savory to admit an interest in science. Membership in the Invisible College is limited to those educated at least up to the degree of doctor of philosophy, and a number of prominent British astronomers and physicists, all too shy to reveal their names for publication, have been admitted.

Backed by this multilingual cluster of talent and openly supported by Dr. James McDonald of the Institute of Atmospheric Physics, Hynek wants action on a national scale now--rather than wait 15 months for the results of an investigation into UFO's now being conducted at the University of Colorado. And the action that he most urgently wants is for NASA to use its superlative spacetrack network to monitor and document the entry of mysterious objects into the earth's atmosphere. Up to now, everything that flashes on the spacetrack screens has been classified top secret unavailable even to serious scientists. But on occasions this secrecy has been breached. Hynek is convinced that NASA is sitting on a number of good UFO sightings, and that if its screens could be made available to independent scientists, the findings might be sensational. Now NASA seems to be moving Hynek's way. "Two years ago, most of us regarded UFO's as a branch of witchcraft, one of the foibles of modern man," a NASA scientist said. "But so many reputable people have expressed interest in confidence to NASA that I would not be in the least suprised to see the space agency begin work on a UFO study contract within the next 12 months."

New Book-----"CHALLENGE TO SCIENCE, THE UFO ENIGMA," by Jacques and Janine Vallee. Forward by J. Allen Hynek, Chairman, Department of Astronomy, and Director, Dearborn Observatory, Northwestern University... In early 1964, a renewal of interest in the UFO mystery began to sweep the country. Since that period, thousands of reports of flying objects have been filed with the Air Force. Many of them have been the result of hoaxes, illusions, and simple misidentifications. But a significant number of sightings were made by reputable individuals of known integrity, including airline pilots and astronomers. It is upon the latter group of cases that the authors focus, using the wealth of material collected in official and private files, to both of which they have had access.
