



As for the International Directors themselves, Pete Mazzola holds a Bachelor of Science degree in Psychology, is a New York City Police Officer for 12 years, has completed a manuscript on the UFO phenomena for future publication entitled, "The Beginning of the End" and is a certified expert in the fields of Polygraph and Psychological Stress Evaluation testing. Jim Fallow has completed 2 years of college majoring for an Associate Degree in Computer Science, self-employed as a General Contractor for 6 years, investigated and documented nearly 500 UFO cases over a 15 year period, compiled hundreds of UFO documents, slides and photographs and established an overwhelming rapport with the local police departments of New Jersey and New York in referring all cases of UFO nature to their Headquarters.

Both Pete and Jim have appeared on numerous radio and T.V. programs, lectured and published their own "Step-By-Step" UFO Investigating Manual and their organization's "The S.B.I. Report" (monthly periodical) to inform and alert the public on the UFO phenomena. Currently, each is heavily engaged in the United Nations/UFO discussions dealing with "the seriousness of UFO's on a world-wide basis" which is currently being presented by WNBC producer---- Lee Spiegel.

Besides the aforementioned functions and goals, the S.B.I. contends "the UFO phenomena is solvable within our own lifetime--we have the technology, intelligence, man-power and capabilities to do so--and will not stop until we have accomplished our mission." Pete and Jim state, "We are the first UFO organization to have two International Directors, since we feel two heads are better than one. We are the only UFO organization to operate under semi-military procedures, since a corporation or large body of people cannot function and progress without rules and regulations to govern them."

The S.B.I. is the only UFO organization to offer the following: promotions to those in the organization who merit such positions; the issuance of professional-type badges for identification purposes; the sum of \$50.00 to each investigator who documents a CE 3 case (Abduction Case); offer incentive awards on a yearly basis in the sum of \$150.00 to dedicated members; and have a formal petition to the White House demanding the truth on UFO's under the F.O.I.A. be told to the American public. The Director's believe they are the only UFO organization to have a "completely open-mind" on the entire phenomena, whereas, they do not give any theories or hypotheses on UFO's except, "UFO's EXIST AND OUR WORLD GOVERNMENTS KNOW IT."

Through its extensive documentations the S.B.I. has catagorized four individual types of alien beings that have confronted people all over the world since the early 1960's. The catagory types are as follows;

TYPE #1-3½-4 feet tall, wide deep-set black oval eyes, milky white or grayish skin, pencil-like mouths, large elongalated head, long arms extended to its knees, short legs, wears tight fitting spacesuit or coveralls.

TYPE #2-5-6 feet tall, male or female, resembles a human on Earth in every respect, wears a one-piece coverall with attaching gloves and boots.

TYPE #3-6-10 feet tall, long dark fur, glowing eyes(usually orange, yellow or blue), long arms extending past its knees, hugh massive frame, short legs, sharp claws on hands and feet, very powerful, resembles "Big Foot" legendary creature.

TYPE #4-anything out of the ordinary not classified in TYPES 1,2, or 3 and include: eerie monster or creature types, ghost-like apparitions, and android or robot-like types. These types are often seen wearing a host of various clothing, helmets or carrying strange equipment. Their size range from 3-12 feet tall and have been noted with many different types of skin tone variations.

It is Pete and Jim's opinion not all of these alien life forms are friendly. On the contrary, many UFO encounters definitely indicate signs of hostility. For example, many witnesses of abduction cases, later under regressive hypnosis, reveal these beings abducted them without permission or authority and sometimes even without their knowledge. Others are subjected to extensive and embarassing physical examinations aboard UFO's or undergo a mental blockage ("time loss") from the time they were abducted until the time they are returned. As Jim suggests, "This is an outright case of Kidnapping as we understand it in our own present day society."

Hostility can also be recorded when other witnesses explain they are struck by powerful laser-type beams which emanate from the UFO itself. These beams usually render the witness unconscious, temporarily paralyzed, or burned and sometimes produces rashes or even illness. Do these sound like friendly beings to you? How can anyone in UFOlogy claim, "these beings means us no harm" ? Evidence clearly proves, without a doubt, some

of these aliens, either intentionally or unintentionally, are abducting humans against their will and causing forest fires, eradication of crops, great distress to animals, and minor or serious injury to humans. Finally, let us not forget the fact UFO's are attributed to the cause of power blackouts of major cities, the cause of the disappearances of planes, ships and people from the Bermuda Triangle Zone, and the cause for the stopping of vehicles such as autos, trucks, etc.

Perhaps now you will be able to understand why the United Nations/UFO Discussions were initiated. With the aid of Grenada's Prime Minister Sir Eric Gairy and NBC producer Lee Speigel, a presentation of evidence was shown to the General Assembly in order to show cause that "UFO's present a threat to the national security of the world" and to have the U.N. investigate this threat on a world-wide scale. The discussions still continue, however, the future investigation into this phenomena by the U.N. does not look favorable. It seems the two major powers of the world, the U.S. and Russia, are against any such study due to so called "a financial burden on the U.N.'s primary function--Peace!"

The S.B.I. believes so much in the rationalization of alien being and that some sort of threat is evident, they have acquired the services of a sculptress. In turn they have developed an authentic bust of the most commonly seen alien type, TYPE #1. The alien's head was formed after long and tedious hours of researching and applying to scale the exact measurements of the being as in reality.

The organizations functions does not stop here! At this very moment the S.B.I. is investigating and documenting several aspects of the phenomena which shall put a new perspective on the UFO mystery. With the cooperation and generosity of the publisher & staff writers of "The S,B.I. Report" future articles shall contain in depth details of some of these startling, interesting and well documented cases. . Since these cases are still in progress, for the moment, a brief synopsis will be given in order to give you some idea of what is on the drawing board.

To begin, the S.B.I. is currently negotiating an exchange of information of UFO data from the Republic of China during the last 30 years. As you may already know, Red China has in the past had absolutely no diplomatic relationship with our

own country. For the last 30 years or more, has said little, if nothing at all to the Western world. Now that the U.S. has instituted new policies and attitudes towards the Communistic country, the possibility is extremely high they may have plenty to offer us in the way of UFO documentation in their country. It would be difficult to believe Red China has not had any reports of UFO's within the last 30 years, thereby making it the only country on Earth not to sight these objects. Of course this is totally inconceivable and the reason the S.B.I. is persuing this matter. Perhaps Red China knows more about the UFO phenomena than the rest of the world? Perhaps they have captured an alien being or a UFO itself? Perhaps their country has endured more abductions of their people than in any other part of the globe? Who knows? Only time will tell and the S.B.I. promises to be on top of the situation.

Secondly, the S.B.I. has been investigating and documenting a CE 3 case (an abduction), which in their opinions shall not only support and give credence to the famous Betty and Barney Hill abduction of 1961 but, pre-date it by 2 years. This most significant encounter involves a politician, who currently holds office, from New Jersey. Not only does the story come from a reliable source but, the details were presented to Pete and Jim only two months prior to the witness' election. For this reason they feel the story is reliable and authentic since the politician came forward and related the incident knowing it could have caused the election if it became publicly known.

The case is so similar to the Hill abduction it's uncanny. So many facts are expressed about the alien beings, the alien planet, the interior of the craft, the conversations between the witness and the aliens, the "time loss" which followed the encounter and the recurring dreams which sparked the interest to document this case, it would be necessary to have a feature article solely on this case alone. The S.B.I. feels this is one of the most comprehensive, illustrated and informative abduction cases of all times. The interesting feature of the documentation is that the

witness is presumed to have been abducted not only once, but twice.

Another such case being handled by the S.B.I. occurred in November 1978 in Upstate New York. The investigation stemmed from a simple CE 2 case (UFO seen either landing or hovering in the immediate area where physical trace evidence is found) and later developed into an incredible documentation. What makes this case more important from other similar CE 2 cases?

The fact that two New York City witnesses saw 2 cigar-shaped objects ("mother ships") at close proximity is highly important, but not really unusual in CE 2 cases. However, the fact that these 2 UFO's were the size of football fields (100 yards), the fact that the witnesses had their encounter corroborated by 5 other just as credible and reliable persons, the fact that these 2 UFO's pursued the 2 witnesses as they fled in their auto, the fact that all 7 witnesses observed 3 other UFO's almost one hour later (disc-shaped objects), the fact that U.S. Air Force phantom jets "buzzed" the area at tree-top level the day prior to the encounter, the fact that a horrifying experience occurred to the 2 witnesses the night prior to the encounter and the fact that both witnesses developed signs of possible radiation poisoning several days after their return home makes this an incredible CE 2 case.

Just about every type of factor related to the UFO phenomena transpires at one point or another during this encounter. Possible U.S.A.F. involvement, a strange occurrence prior to the encounter, the presence of "mother ships" and "scout ships", a multiple witness factor, animal reaction after the incident, after effects of illness, the ability of one of the witnesses to display ESP powers, and possibly, a "time loss" period during the time the 2 witnesses fled in their auto all play a tremendous role during this encounter. Needless to say, the encounter is still being investigated.

Some of the best U.F.O. cases are reported on an almost daily basis by various Police Departments and Agencies around the world. The S.B.I. has documented dozens of such reports within the United States alone.

Here is just one recent case from N.J. The date is October 25, 1978, the time at 1:30 A.M. While driving in his patrol car Police Officer Robert Stevens spotted four brightly lite objects in the South West section of the sky. After making sure that the objects were not planes or helicopters, Officer Stevens radioed for a back-up car to meet him at his location to confirm what he was seeing. Upon hearing Officer Stevens call on the radio, Officer James Scott responded to the location. When Scott arrived he found Officer Stevens pointing skyward. "I want you to see something and be a witness for me", Stevens explained. What Officers Scott and Stevens saw were four ball shaped U.F.C.'s. The U.F.C.'s were to remain in a hovering position for another four to six minutes then changed color and latitude before taking off at unbelievable speed.

* Note: Officers Robert Stevens and James Scott are pseudonyms. Actual names, location and details of sighting are on file with the S.B.I.

DOOMSDAY

One of the most realistic outlooks on the UFO phenomena is described ingeniously relating to Man's stupidity on Earth today. Man's non-love and concern for others; Man's non-belief that something far more compelling than the human ego carries us through life: Man's power-mad obsessions for building better and bigger bombs of death-dealing devilment and destruction; Man's ugly and worn-torn age where the threat of physical extinction by misapplied and misused nuclear devices--all suggest--"these aerial phenomena could well prove warning forerunners of significant events whose world-wide impact will fully be felt in the course of the next few years." It also suggests, "UFO's and crews are not making meaningless joyrides in our atmosphere."

As we can readily deduce from many such prophecies, Man-kind has reached a plateau of worrying, fretful, fearfilled phase of evolution and beyond in this year we call 1979. We have altered the balance of Nature, in total calamitous depth by our own ignorance we have affected Earth's central gravity core, we have polluted our atmosphere possibly beyond repair, we have raped our natural resources to an almost certain devastating proportion and we literally continue to act as "animals" towards one another, as we can see from war after war. Evil and corruption go foot-over-foot and death and destruction go hand-over-hand in our battle of idiocy on this planet we proudly call Earth.

We, the populace of planet Earth, are like a "walking time-tomb", ignited many decades ago using a tremendous piece of fuse. The time grows shorter and shorter as the fuse reaches its exploding point. Man, as we know it, will cease to exist unless we awaken to a new renaissance of tranquility, harmony and spiritual evolution in the coming years.

The S.B.I. believes we are being monitored by UFO's for these specific reasons. The hypotheses being the hostility and destruction of our planet not only has upheaved our evolution but, hence started a chain reaction within the Universe itself.

This chain reaction is causing great concern from alien beings (wherever they originate from) and is the primary reason why UFO's and their crew are becoming more visible to the people of Earth and why more and more abductions of humans have taken place in the last decade. They (the aliens) are interested in our progression of evolution, since our own self-destruction of ourselves and our planet shall as equally well affect their existence in the Universe.

OPEN CONTACT

The first objective of the S.B.I. and of the utmost significance to our future survival is TO MAKE OPEN CONTACT WITH THE CREW OF A UFO. In order to achieve this goal the S.B.I. urges everyones support and assistance. We need every UFO report possible, every modern piece of scientific equipment at our avail and every person to do his/her own share to assist us in correlating data and patterns needed to establish open contact. Who knows perhaps we can solve the UFO phenomena and save ourselves from total destruction as well?


