

STRAIGHT TALK

This REPORT is dedicated to seeking the truth and telling it like it is! Therefore, I intend to set the record straight in reference to NBC radio-producer Lee Spiegel's proclamation of producing the next United Nations/ UFO discussions.

Mr. Spiegel, as you may or may not know, is employed by NBC-A.M. radio and broadcasts a 10 minute program, twice a night, Monday through Friday. The name

of this program is, "The UFO Report", whereas, Mr. Spiegel has been dubbed, "The Alien."

The program, which has been aired over a year, is alledged to be the most scientific, conclusive and comprehensive of its kind dealing with the UFO phenomena. Each night interviews with witnesses, abductees and/or UFO researchers take place. Some nights we're lucky enough to hear Mr. Spiegel's own views and opinions on the subject. For all of this hard work, Mr. Spiegel receives a generous salary from NBC, has become a self-acclaimed producer, appears regularly on numerous TV talk shows and has been noted as an authoritarian on the UFO enigma. Sounds very impressive doesn't it? We at the S.B.I. have this to say about it-----BALONEY!!!

We will attempt to show you the inside "tricks of the trade" and an actual look into his super-stardom. About two years ago Lee Spiegel was unheard of in the UFO circle. Low and behold, along comes the illustrious Dr. J. Allen Hynek (director of the Center of UFO Studies/CUFOS), who states, "he is a believer of UFO's and has established his Center for the sole purpose of the solvement of the UFO mystery." We believe Dr. Hynek (the Benedict Arnold of the U.S. Air Force) is the only one to believe this statement and even that is debatable. Hynek converted his opinions (supposedly) after a 22 year consultantship to the Air Force's Project Blue Book and membership/employment with the C.I.A. Subsequently he organized his band of disciples into CUFOS and uses Field Investigators from various UFO organizations to gather his information. By the way, we feel this information on UFO's is re-routed back to the place whence Hynek originated--the C.I.A.

Getting back to Spiegel, an abduction case involving a 13 year old boy from New Jersey naturally arrived to the attention of Hynek. In turn, Hynek requested another organization to send an Investigator to document the case. The Investigator (name known but being omitted) compiled the data and forwarded the same to Hynek. Shortly afterwards, Hynek set-up a number of TV appearances to promote the boy's story and at the same time infiltrate the public to submit further cases to his Center. Simultaneously, Spiegel heard of the case and went to investigate for his radio viewers. As you can deduce, "birds of a feather flock together."

All four appeared on several TV talk shows, Hynek, Spiegel, the Investigator and the boy. Somehow through all the appearances on TV and behind-the-scene talks, Hynek and Spiegel became attracted to one another. Each trying to utilize the other for their own goals. The next thing we hear is that Hynek claims, "Spiegel is a Field Investigator within his organization! The only thing wrong with this statement is Hynek has no Investigators within his organization!

Through their mutual admiration, Hynek's next plan of strategy was to become the domineering factor in the 1978 UN/UFO discussions. Needless to say, he completed his mission swiftly, cunningly and viciously.

As the "supreme king" of the UN/UFO debates, who do you think he chose as a producer to present a showing to 133 delegate members? You guessed it---Lee Spiegel. Hynek and Spiegel, in a combined effort, built up each others status within the realm of UFO's. Spiegel's radio program was boosted tremendously due to the publicity as UN/UFO producer and Hynek got what he wanted as well, total disruption of the debates and mockery towards the phenomena itself.

First, let's analyze Spiegel's status as a producer. As far as the U.N. is concerned, Spiegel did not spend a dime of his own money for the film/slide presentation. Hynek supplied several movie film footages of various UFO sightings taken in the U.S. While others were supplied to Hynek from England and Japan. Along with these film clippings Hynek supplied black and white slides of UFO's supposed to be convincing enough that UFO's exist. Impressive? Not at all! The movies were either too old to determine where the UFO's were on the screen or really not significant enough to show the objects in question were UFO's. The slide presentation consisted primarily of Hynek's archive collection from his Project Blue Book consultantship days when he used to tell these witnesses they were hallucinating or seeing "swamp gas." Now, nine years after the end of Blue Book, he contradicts himself totally and claims these photos are genuine.

To tell you the truth, our S.B.I. lecture/slide presentation is more informative and conclusive than what was presented to the distinguished representatives of the world. Thanks to Hynek's "supplying" and Spiegel's "producing" the 1978 UN/UFO discussions were a joke. If this wasn't enough to handle, Spiegel and Hynek were sponsored by the tiny nation called Grenada, under the leadership of Prime Minister Sir Eric Gairy (recently overthrown by new government). Gairy's 1½ hour speech to the General Assembly, which spoke of butterflies, flowers and peace instead of the hard-core data needed on UFO's presenting a treath to the world, was soon to become one of the U.N.'s most laughable orations on a serious matter. With a team like Hynek, Spiegel and Gairy it isn't hard to understand why the 1978 UN/UFO discussions were soon to be filed under "G"---for GARBAGE.

Keeping within the scope of a producer, let's analyze Spiegel's radio program. The program is sponsored by OMNI magazine, the same magazine company which publishes Penthouse. The S.B.I. thinks Penthouse should stick with their original idea--NUDES-- instead of speaking about a subject which is fully clothed--UFO's. However, OMNI pays "X" amount of dollars to NBC for their aired commercials. In turn, NBC pays Spiegel's salary. We won't tell you just how much that is since it is confidentially given to us, but we will state, "he is overpaid for what he does." Spiegel is given free use of a studio to broadcast his program, so there's no money involved here as we previously saw in the UN/UFO producer-ship. But isn't a producer supposed to lay out money for a production we think to ourselves? This is a correct assumption and Spiegel does it fact spend money as a producer. Spiegel purchases either 30 or 60 minute tape cassettes to record his interviews on the telephone. As a big-time spender Spiegel pre-records most, if not all, of his interviews, thereby, avoiding to actually be present during air

time and having this time allotted to appearing on TV.

On recent programs and in the private circle of the UFO world Speigel is proclaiming, "to be producing the 1979 UN/UFO discussions in July." Enclosed on the last page of this article are two pages of the latest UN General Assembly agenda from June 18th to July of 1979. (Generously supplied by Maj. (Ret.) Coleman Von Keviczky, director of I.C.U.F.O.N.) As we can all denote, we see no such discussions on the agenda. It seems Speigel forgot to tell the General Assembly about his so-called, "new production." Of course, if Speigel wishes to change this alledged debates to the latter part of the year, we can accommodate our readers here also. We have the entire U.N. schedule of the year 1979 and we see no UN/UFO production by Lee Speigel.

At this time we can safely state, "Coleman VonKeviczky not Lee Speigel is secretly meeting with several important delegates of powerful nations to attempt to introduce a proposal into the agenda for UN/UFO talks late in October." If anyone can accomplish this feat, it is Coleman not Speigel. And by the same token, the S.B.I. not Lee Speigel will help produce the next presentation to General Assembly. With our confidential resource backing, our vast multitude of recent UFO photos/slides, our reliable and credible UFO witnesses and abductees, and our recently authenticated 7½ minutes of color movie film showing a variation of UFO activity in the form of several shapes and sizes---it is the S.B.I. not Speigel who will convince the delegates of the world UFO's present a treath to the world as a whole.

In conclusion, what we see is not always what we get? As a producer, Speigel spends nearly \$10.00 a week for his radio show. As an interviewer, Speigel shows us nothing which has not been aired, written, or spoken of previously. As an investigator, Speigel must be the best in his class since he is Chief-of-Field Investigations for UFO Review. UFO Review is a 20 page newspaper, inwhich its publisher Timothy Green Beckley calls a UFO magazines of the highest caliber. Beckley earned the title of "Mr. UFO" back in the sixties after no one who was anyone in the UFO world would listen to him. His self-appointed name immediately brings to mind a marvelous case which brought him a new nick-name from the S.B.I.--Mr. Flake. The case I refer to is one of an alien glove, alledgedly found by a jogger on his way from California to New York in a desert, & brought directly to Beckley's plush New York Office situated in the heart of the Garment District directly over a parking garage. The glove which has never actually made newspaper headlines was never shown to us in reality, except in a photo and when we asked if we could analyze the glove free-of-charge for authenticity, Beckley replied, "the glove doesn't need analyzation since he has seen it and has it in his possession." His newspaper is a classic and recommended for purchase. Twenty exciting pages which include 10 pages of advertising for Beckley's other ventures: books, tapes, records, posters, jewelry and of course the subscription to his paper; leaving 10 pages for unheard of, uninvestigated by a UFO organization, unanalyzed, totally unreliable cases which may earn him the "Flake of the Year Award." We however do recommend you purchase this 20 page newspaper inwhich Speigel is the head-of-investigations. It comes in very handy if you have a dog or cat. (A copy of this newspaper's index clearly showing Speigel's name is provided.) If Speigel knows nothing of this association, we suggest he contact a lawyer and sue Beckley. As a

researcher, Spiegel leaves alot to be desired. What are his goals, theories and just what has he researched? As the "alien", Spiegel has us there! He certainly is alien: alien to friends, alien to other peoples credits and rights, alien to other opinions, alien to Hynek's strategies and alien to the subject of UFO's.



Aid Tells UN: Prepare for Visitors From Outer Space

The United Nations is the only agency that can establish contact and represent mankind in face-to-face meetings with visitors from outer space, UN Secretary General U Thant was told yesterday by one of his staff members.

Colman VonKeviczky, a technician in the UN public information office, said in a press release that he was also a researcher in unidentified flying objects, or flying saucers. VonKeviczky, 36, is a Hungarian-born U.S. citizen who has worked for the UN for nine years.

The release—not authorized by the UN—contained a letter to Thant asking him to establish an observer

network among member nations of the UN to keep extraterrestrial UFOs under permanent control.

"Manned by Intelligent Beings"

VonKeviczky apologized to Thant for making his "odd proposal." He had written him only after discovering that the UN had no UFO information in its files. But he surmised that perhaps the UN had a confidential file on saucer activities.

As for himself, he said that his data was based on 11 years of scientific research activities in "ufology."

He explained to Thant that UFOs "are manned and piloted by intelligent beings from the solar system, terrifying by their dangerous radiations and frequent

landings our peoples, air and ground security organs, military installations, air-rocket-guided missile and atom bases.

Says Test Landings Go On

VonKeviczky said that UFOs were currently experimenting with test landings on the earth's surface and their next logical step might hold dangers to the world.

Who but the UN was best qualified to investigate "this strange and unknown activity around us?" he said.

The letter was received by Thant's office, a UN spokesman confirmed. But Thant was too busy with earthly affairs to read it. It probably will be referred to the UN's outer space affairs section.

ICUFON CONFIDENTIAL

On June 16, 1978, Prime Minister of Grenada, Sir Eric M. GAIRY assigned ICUFON to prepare exhibited analytic evidences (shown at Acapulco, Mex., First International UFO Congress) to reinforce through a visual presentation his UFO statement before the coming U.N. General Assembly, Thirty-Third Session.

On July 13th Prime Minister Gairy surprisingly stated:

"Regarding your exhibition project - my government is aware that your ICUFON Network posses the strongest evidences about the UFOs existence and operation - B U T, my cabinet, myself and our sponsored scientists () would never agree to present and prove before the General Assembly any facts and indications that the UFO forces are endangering the international security."*

Major (Ret.) Colman S. VonKeviczky, the Director of ICUFON Inc. replied:

"The United Nations was constituted by the Nations to maintain the global peace and security, and not sustain scientific study of UFOs. This would be rather due to the UNESCO's scientists, than for the diplomats of the General Assembly."

DOVER ABDUCTION PRE-DATES THE
BETTY AND BARNEY HILL EXPERIENCE

On September 15, 1978, I recieved a phone call from a man in Upstate N.J. The caller identified himself as John Herbert (John Herbert is a pseudo name, actual name on file with the S.B.I.). It seems as Mr. Herbert explained on telephone that he had contact with Alien Life Forms or as he called them a none Earth type, some twenty years previous and he felt that he would like to talk to the S.B.I. and get this off his chest. After setting a date and place that was convenient for all concerned, I next telephone Pete Mazzola and informed him of the conversation. Pete and I set about our strategy as well as checking the background of this individual before we were to meet him. With the help of a Police Sargent in Upstate N.J., I was able to ascertain that Mr. Herbert was not a known criminal, was not a known drug abuser, and in general had a very clean background.

On September the 19th at 1:00 P.M. Mr. Herbert, Pete Mazzola, and myself met at the Ramada Inn Conference room and after six hours of questions and answers the most incredible tale was revealed. Here for the first time are portions of the sixty-eight page transcript that resulted from our first meeting with Mr. Herbert.

"My name is James Herbert, I am thirty-eight years old and am employed by (confidential). In the late 1950's - 1958 or 1959 while still a teenager, I remember I woke up on board some kind of craft, some kind of vehicle. I can't actually say woke up, it was more like coming to from an unconscious state. In other words I became vaguely aware of the things around me. And I noticed there were also two other human beings with me. We were all on the floor of some type of metallic room. The first person I noticed was a women, a matronly type and I would say she was in her thirties or early forties, and there was a man and it looks when I recall back on the event that he was still crumpled on the floor and when he came to he was either very agitated or very upset, I couldn't say for sure. When we came to or shortly thereafter, someone came into the room and ushered us into a larger room through a small narrow hallway, where we met two other people actually two other Aliens, because they weren't like human earth people at all. After some introductions, I can't recall exactly what was said, they told us that we were there to be shown certain relationships of the Universe (uncertainty here, he can't recall). There was a larger Alien whom seemed to be the leader, he was male, they were all males, definately males, and though I can't remember distinctive features on their faces or on their hands or anything. Anyway, I tried to tell the leader that he had the wrong man, and that I didn't know anything about the Stars or the Planets, or anything about the Universe, and it was funny because he kind of smiled and said 'we know'. I went on and tried

to explain to them that there were people on earth like scientists, astronomers, radio astronomers, you know like that, but it didn't seem that they were interested in these people, they were interested in us. He had a screen, it was a screen in which they showed various relationships to a central planet. Now this central planet, according to the leader dealt with our solar system, I believe it was our solar system because he said our planet was involved in it. I also distinctly remember seeing both solid lines and broken red lines emanating from different points on this chart they were showing us. We were just about to understand or be explained what the relationships were on the chart when the man, the human man who was with me mention something about religion, I distinctly remember him mentioning the name Jesus Christ, in which the leader became very upset. And Gentlemen this is all I can tell you about the episode, I can't remember a conscious thing after that. That's it, that's all I can remember about the episode, except for a dream, a dream that has been bothering me for years." Pete Mazzola asked Mr. Herbert to explain about this "dream" that was bothering him, and Mr. Herbert went on to explain; "Well I really can't be sure what it all means and whether it was sparked by the initial episode or not, but this dream as well as this first experience has already cost me a marriage." I then asked Mr. Herbert to define what he had meant by costing him a marriage, and he explained for years after this first episode he had nightmares, his wife had become upset because Mr. Herbert would not confide in her what these dreams or nightmares were all about. Mr. Herbert went on to explain; "Well about this nightmare or dream or whatever the hell it is, I was in a large grassy field and there was another man with me, definitely human plus an alien guide. We were on another planet and he said, the alien said, and I don't remember his lips moving when he said it, but anyway I know this sounds crazy, but anyway he said he was going to take us to a town or a village. So we starting walking. I'd say we were walking about an hour. We started climbing up an incline than as we got closer to this town it became very, very steep and very hard to negotiate up this hill. There was a path that went into this town, a dirt path. When we got into this town, it was more like a small village, and the houses were just like human houses. But I noticed it was very, very quiet. The whole episode was quiet, no birds, no dogs, nothing, just quietness. Well anyway when we got to this town the people started coming out of their homes and they gather around myself and this other man, they wore clothes very much like ours, in fact I couldn't tell anything different about them other than someone pointed out they had six digits on each hand and foot. I looked at someones foot and sure enough I saw six toes." I asked Mr. Herbert, if he saw six fingers or six digits on anyone's hand, he could not recall. "It was bright, it was a bright sunny day but everything seemed red, the ground, the sky, even these houses all seemed red. I never understood this dream or whatever the hell it is. Anyway there was some commotion around the people who had gathered around to view us or look at us, and the next thing that I could remember is running down that hill

away from that hill, away from town running for my life. I thought they were going to catch me and I could see a disc on the bottom portion on a big field and I ran for it, I ran for my life, I knew if I got to that vehicle I was going to be ok, and thats where I wake up, thats where I woke up in this dream."

It is interesting to note here that Mr. Herbert recalls the ships walls and some fixtures inside the disc from the first experience. He remembers the screen being approximately ten feet by twelve feet, and that it was more affixed to the wall than a regular home type movie screen. On March 3, 1979, Mr. Herbert was interviewed by a noted New Jersey psychiatrist, for the purpose of regressive hypnosis. The session lasted approximately two hours in which time the doctor put Mr. Herbert into a deep trance and regressed him to the point of time where the alleged abduction initially started. The doctor was able to ascertain from statements made by the witness that the abduction took place in Dover, N.J. approximately in the summer of 1959. Although Mr. Herbert could not consciously recall and did not make any statements to the effect of a physical examination on board, it is interesting to note, that while under regressive hypnosis he started to recall incidents of an examination that had taken place. It was during this time that Mr. Herbert became violently ill, and in the words of the Doctor; "I thought he was going to have a heart attack due to extreme fright and a definite negative reaction to the whole experience", contrary to Mr. Herbert's statements about the entire experience. At a point in time where the Doctor had regressed Mr. Herbert to the examination part of the abduction, Mr. Herbert started to vomit on himself as well as the Doctor's Office, at this point the Doctor thought that he had struck a raw nerve and it was best for all concern to stop the session in order to help Mr. Herbert clean himself up and regain some dignity.

It is interesting to note here, although the case is still under investigation that the abduction sequence took place approximately two years before the Betty and Barney Hill abduction in 1961. Although this is interesting onto itself, it is also interesting to note the similarities in both the Hill abduction and the Herbert abduction, in that both abduction cases, the abductees were shown a series of charts in relationship to our own universe as well as possible trade routes indicated by broken red lines and solid red lines. Another interesting fact to note is the nightmares that preceded Mr. Herberts coming to the S.B.I.; if the reader will recall he will note that the Hills had suffered from nightmares and unusual dreams immediately after their episode and it was that single fact that prompted them to seek out the help of a noted Boston Psychiatrist. Even though certain portions of the investigation had revealed striking similarities to the Betty Hill and Barney Hill abduction, it is also surprising to see the parallel in the Andreason abduction in which Betty Andreason was abducted from her home in 1967 and allegedly taken to a different planet very similar in description to what Mr. Herbert described.

Mr. Herbert has fully recovered from the episode in the psychiatrist's office and is further willing to explore more portions of the abduction sequence. Perhaps the most interesting fact of this whole alleged abduction would be the point of reference "Jesus Christ", and the extreme negative reaction from the Aliens that was brought about by this name. The S.B.I. right now is scheduling Mr. Herbert for more in depth regression sessions in which we will explore the reasons or possible reasons for this negative reaction to the name Jesus Christ as well as trying to retrieve the names of the two human individuals that accompanied Mr. Herbert in the abduction in Dover, N.J.
