



THE CONSPIRACY

As we undoubtedly know, the government has been scandalized many times over in the past and it is presumed it will occur once again, unless we, the American people, put a stop to it. We have witnessed the Watergate cover-up; the Kennedy assassination cover-up; the F.B.I. illegal wire-tapping, opening of other peoples mail, and harassment of subversive organization leaders cover-up; the Bert Lance cover-up; the politicians sex scandal cover-up; and recently, the Tungson Park Korean payoff cover-up.

The American public has sat idling through countless sex, corruption and criminal cover-ups taking place within our democratic government. It has been prophetsized, "Those who do not learn from their past experiences are condemned to relive them!". Is this what we want? Are we destined to relive our past governmental cover-ups because we have not yet learned from those experiences?

It is assumed 99 % of the American people realize cover-ups have taken place within our government. Why then is it so difficult to believe a UFO cover-up has and is presently taking place? Is it the fact we speak of UFO's as the subject for the cover-up that produces skepticism in the American peoples minds? Believe me, UFO's exist -- just as a cover-up exists! We have to many eyewitnesses, photographs, radar confirmations, and analyzed documentations from both average everyday citizens and people in high offices to discount the fact that something is occurring in our skies and we are being kept in the dark about it.

Now you skeptically say to yourself, "Why does such a cover-up exist?", "How could such a cover-up stay covered-up for over three decades?" and finally you say to yourself, If such a cover-up does exist, "How long does the government intend to kept it covered-up from the public?"

All of these questions will be answered, thereby, giving you a little better understanding on how government operates. I will attempt to show how our operations of secretive intelligence gathering agencies function. Then, just perhaps, you the reader will raise questions within your own heads and shed a doubt on the government's role on UFO's. If it were possible to be both judge and jury in a court of law, we the American people, would be able to convict the government on that alone - reasonable doubt to believe.

If you have either worked for or are presently employed by the government in either a military or civilian capacity, you have a general idea of the government's chain of command and red tape procedures. For those of you that have little or no idea of how a bureaucratic government agency operates, an explanation is necessary.

All of us already know the United States has several branches of government and within those branches lie numerous departments. Originating from one of these branches our military forces arises. The military is comprised ^{of} five separate services, the Air Force, the Army, the Navy, the Marines, and the Coast Guard. Within these services one can find numerous departments for each of the branches. One of these departments in each of the services are for intelligence gathering. Each of these intelligence departments are separately and independently operated from one another. Not only does each intelligence department maintain strict secrecy from each other, but from other departments within their own branch of service. Each of these intelligence departments reports separately and independently directly to the Pentagon. At the Pentagon, high ranking brass

from each of the five branches of service form the Joint Chiefs of Staff. The Joint Chiefs of Staff strategically run the entire military of this country. The Chiefs compile all the intelligence data from all the services and forward a comprehensive report to the Central Intelligence Agency (C.I.A.).

Confused yet? Unfortunately the chain of governmental command does not stop there. The C.I.A. holds all the data it received until it hears from other sister and brother intelligence gathering agencies within their own branch of government. Departments such as the Office of Scientific Intelligence (O.S.I.), the Defense Intelligence Agency (D.I.A.), the Domestic Operations Division (D.O.D.), the Foreign Broadcasting Information Service (F.B.I.S.), the Office of Current Intelligence (O.C.I.) and the National Photographic Interpretation Center (N.P.I.C.) all gather intelligence information locally or foreign. Each of these multitudes of secret organizations operates separately and independently of one another. Each reports their data directly to the National Security Agency, who then comprises the data and forwards the material to the C.I.A.

Confused yet and does it all stop here? Once again the answer is no! Of course we all know, our government has a federally funded space program. This agency known as the National Aeronautics and Space Administration (N.A.S.A.) also collects and investigates intelligence data on a terrestrial and extraterrestrial level. It too forwards all its data to the C.I.A. Last, but not least, we have the Federal Bureau of Investigation (F.B.I.). The F.B.I., among some of its many duties, investigates people or organizations which may or do present a threat to our country's national security. Believe or not, some of these people or organizations

considered for investigation are UFO organizations, which include their directors, investigators and sometimes members. After investigation of the organizations, UFO witnesses, and other data related to UFO's, the F.B.I. forwards their findings to, you guessed it - the C.I.A.

So, here we have it! Everyone, and I repeat, everyone answers one way or another to the C.I.A. The C.I.A. is the nucleus of the entire chain of command in the complex system. Who does the C.I.A. report to? There is no one else, except the President of the United States. Supposedly, the President inturn reports to the Congress and to the American people. However, after 30 years of compiled UFO reports and evidence no one has seen Congress or the American public made aware of UFO existence from any President in office. I have stated the C.I.A. reports directly to the President. Actually, there are a few more steps in between the C.I.A. and the President. The C.I.A. reports to the Secretary of Defense. The Secretary of Defense reports to the Secretary of State. The Secretary of State reports to a few other presidential big-wigs, who inturn finally inform the President.

The way the system is set up, the military intelligence departments only report to the Pentagon not to each other, the domestic and foreign intelligence departments only report to the National Security Agency and not to each other, N.A.S.A., the F.B.I. and the National Security Agency only know what they individually do and report to, and the C.I.A. only knows it reports a total of all intelligence data to its source. No one agency or department knows what the other has learned, which tends to confuse the issue even more. Now if this is not confusing enough for you, within the C.I.A. itself lies a department which documents, computerizes,

investigates and analyzes all UFO data. It is even very possible other departments within the C.I.A. do not realize this department exists, but the possibility is very slim.

As I have stated repeatedly in this book, "If you don't believe me, try yourself to obtain information on UFO's on a government level and see what happens for yourself." You'll find yourself being referred to other departments, other agencies, other branches of the government and eventually wind up where you started - nowhere. Either those you speak with really don't know anything about UFO's or aren't telling who does. You can bet your last dollar, you'll never speak to anyone from the actual department who knows the truth about UFO's.

Now let's return to the questions on hand. Why does a cover-up exist? For many reasons: national security and the well-being of the public; for power, enabling the U.S. to learn more about the aliens before the Russians, Chinese, etc. do; perhaps our government knows no more then they did in 1947 about UFO's; perhaps that truth is to shocking to reveal and may cause the downfall of religions and possibly our government. Through the magic of greed, power and stupidity a cover-up can formulate and breed as long as the public does not catch wind of it. When the public finally wisens up, it's every man for himself, everyone blaming someone else and passing the buck.

How can such a cover-up exist for over three decades? As you can see, they chain of command and red tape secrecy of the intelligence gathering network is quite ^{confusing,} yet fail proof. No one knows what the other is doing, reporting, or informing. And if that's not enough to complicate things, the government has strict enforcement of intelligent data being leaked out to the public.

All those concerned in the system realize whether he is a military personnel, a military high-ranking brass, an intelligence agent, a scientist, or even a high ranking politician the penalty is the same for all - to be silenced. For those leaking information to the public, the penalty may be a forced retirement from the military or agency under strange conditions, a very heavy fine and/or imprisonment, and who knows maybe, just maybe silenced by some freak accident that takes the publicizer's life.

Finally, how long does the government intend to keep the cover-up secret? It is my belief many people within their own governmental administration are bannng together and forming a coalition to inform the public of the truth. These persons who range from pilots, astronauts, top military brass and even some politicians are without knowing it, forcing the government to release UFO data to the American public slowly. Other governments of the world are either beginning projects to investigate UFO's or openly informing their people of certain truths. The United States does not want to get caught with its pants down. Our government most likely feels the public is understanding and forgiving. If they slowly inform us of all they know about UFO's and the reasons why the 30 year cover-up existed we will understand. The government intends to come out smelling like a rose and they just might be right in assuming that.

By now another question has come to your mind. What kind of information has been kept secret and how much data does the government have? Take my word for it, if I didn't have an inside contact within a certain agency who either heard or saw classified data pertaining to UFO's, I would most likely never know the answers to either of these questions. But, fortunately for me I

do have a very good friend who informs me of government data on UFO's. My informed source, naturally can not be mentioned by name for fear of severe punishment, is a reliable friend who has a confidential key position whereby he is able to see compiled data on UFO's. To answer the question how much data does the U.S. have on UFO's? The U.S. along with its allies has compiled almost 30 years of UFO photos, documents, investigations and evidence which can clearly prove the existence of UFO's and its alien occupants. As to what kind of data does the U.S. have? The following list is only a partial glance at what the C.I.A. has in its possession:

- * ALL civilian reports of UFO's since 1948 within the U.S.
- * ALL military reports of UFO's since 1948 within the U.S.
- * ALL foreign country reports of UFO's since 1952.
- * ALL worldwide physical and photographic evidence since 1952.
- * ALL analyzation results from all collected evidence.
- * Physical evidence from landed UFO in Virginia on July 29, 1952.
- * Physical evidence from landed UFO in Maryland on Sept. 28, 1957.
- * Physical and photographic evidence from missing Project Blue Book files from 1953 to 1969.
- * 35 mm film taken by military at White Sands, New Mexico on April 27, 1950.
- * 35 mm film taken by military at White Sands, New Mexico on May 29, 1950.
- * 35 mm film taken by military at White Sands, New Mexico on July 14, 1951.
- * 16 mm film taken by civilian at Santa Ana, California on July 29, 1952.
- * 16 mm film taken by civilian at Fairfax, South Carolina on Aug. 12, 1953.
- * 8 mm film taken by civilian in New Guinea on Aug. 31, 1953.
- * Infra-red film taken by Air Force pilot over Canton, Ohio on May 24, 1954.
- * Numerous film footage taken by Air Force from 1950 to present.
- * Project Blue Book, Report # 13, missing from files.
- * Numerous film footage taken by the Navy from 1954 to present.
- * ALL data on UFO's received from the F.B.I.
- * 150 feet of film taken by government personnel showing an actual UFO landing in the U.S.
- * Numerous film footage of UFO's being tracked on radar.
- * Numerous film footage of Air Force jets attempting to intercept UFO's over the U.S.
- * Numerous film footage of UFO's as seen from high powered telescopes.
- * 30 infra-red photographs taken by civilian showing UFO's travelling over California in 28 out of 30 consecutive nights.
- * All photos and film taken by U.S. astronauts of UFO's while on space missions.

I could go on and on, the list is endless. The most remarkable information I've received thus far dates back to May of 1954 at White Sands, New Mexico. It was told to me a 50 foot in diameter, disc-shaped UFO crashed in the enormous desert area. The C.I.A., with the aid of the military, was capable of obtaining several pieces of fragmentation from the demolished craft. Along with the fragments, the C.I.A. was also able to obtain the remains of two dead alien occupants of the UFO. The two dead aliens which measured at 40 inches tall (a little over 3½ feet) were given extensive autopsy examinations. The findings of this autopsy have been closely guarded since then. Even my informer cannot learn what was discovered as a result of the testing.

I have no reason to doubt my informant's accusations and statements. He has no one else to intrust his secrets to and is gaining absolutely no monetary rewards for speaking the truth. Furthermore, the penalty for divulging classified material of a national security nature is a \$10,000. fine on each count and a minimum of 10 years imprisonment for each count convicted of. Personally I feel as my informant does, he'd never make it to court. He would most likely be committed to an asylum for the rest of his life where no one at all would believe him. He could also be assassinated in order not to speak out. It is for this reason, the anonymity of the informant must be kept secret at all cost. As you can readily deduce, for what purpose would this informant lie. I can't imagine him risking imprisonment, institutionalized for life, or even dying - all for lies.

Don't misunderstand me! I am not anti-C.I.A. or anti any other agency. All their work, suppression and tactics are done for our well-being. They are dedicated, intelligent, loyal

The most far-fetched and unbelievable data is yet to come. Evidence that can not only prove UFO's exist, as well as aliens from space, but can conclusively prove our government may be experimenting with our lives. My informer tells me there is data that would even shock me. Evidence like:

- * Documented proof of C.I.A. agent making contact with aliens of another world while under hypnosis on July 9, 1959.
- * Numerous documents of reports made by high ranking officers of the C.I.A. and the military who have encountered UFO's and/or their alien occupants from 1959 to the present.
- * Numerous film footage of UFO's travelling over large U.S. cities from 1969 to the present.
- * 100 feet of film showing aliens debarking UFO and taking soil samples.
- * 100 feet of film taken by civilian showing UFO's descending, hovering and ascending over a top security military base.
- * Movie film and photographs of a dog being frozen in mid-air by UFO after animal attempted to leap at craft.
- * 50 feet of film taken by military of UFO travelling over Ohio on March 22, 1967.
- * 50 feet of film taken by civilian of UFO travelling over New Jersey on April 5, 1967.
- * 50 feet of film taken by civilian of UFO formation travelling over North Carolina on May 10, 1967.
- * Several pieces of fragmentation of crashed UFO
- * Documents of autopsy reports related to deceased aliens aboard the crashed UFO.
- * Documentation and taped conversations of aliens and government officials in open contact.
- * Numerous documents related to documenting UFO's and suppressing evidence from the public from 1977 to the present.

Americans who have our national security at heart. Their past is their past and I believe they are reforming to more modern day techniques. They are conforming to modernistic society's demands for the release of public information through the Freedom of Information Act adopted in February of 1975. They are slowly informing the public on the truth about UFO's due to constant pressure from public opinion, to many civilian encounters to cope with, more and more military and government personnel coming forward and telling what they know, constant pressure from UFO organizations to unsuppress the truth, and possibly from orders of a higher authority - the President.

THE ALERTING PROCESS

The government is presently participating in an all out project to slowly alert the public on the realism of UFO's. They are slowly making us aware of their past and present existence in our skies. It is slowly being made aware to us our government has investigated and documented countless UFO reports from the year 1969 (the year our government claims they stopped documenting UFO data) to the present. This alerting process is being conducted in such a manner as not to create mass panic. It is a joint effort being made by the Presidential cabinet, the C.I.A., the Air Force and N.A.S.A. to convey to the people what they have known for years.

It is my belief the agencies involved in the alerting process are using every means available to them to inform the public. One of these means is the motion picture industry. The industry is releasing movie after movie on UFO's and alien beings. One such motion picture is, "Close Encounters of the Third Kind." The \$22,000,000. production was written and directed by Steven

Spielberg and has attracted more people at box offices than any other film during the entire motion picture career. The movie, which had thousands of people across the country waiting in lines for hours to get in to see the film, has won many Academy Awards. Is this film, which increased a new interest into the UFO phenomena from the American public, just a coincidence? Why was this film made first, before a sequel to the talented director's world acclaimed, "JAWS"? Why was so much finances put into the realism of the film?

It is my belief, "Close Encounters of the Third Kind", was not a coincidence, but instead a governmented assisted and funded movie to relate basic truths about the phenomena to the public and then record public reactions.

A nationally known Washington magazine, rumored in their April 1977 issue, that the White House is slowly releasing facts on UFO's to the public and is contemplating an official statement in the near future. Other informed sources have learned President Carter had a very advanced preview of the movie, "Close Encounters of the Third Kind." It is speculated the government viewed its contents to study the authenticity and realism of special effects being projected to the public. It would be understandable the government wanted to be reassured the movie would stir the interests of the people and prepare them for the truth of UFO reality and/or future contact with alien beings.

The entire shooting production of the movie was kept strictly secretive to ^{the} point it was phenomenal. Most of the spectacular special effects of the film was made in an old abandoned airplane hanger in Alabama. The area surrounding the production was heavily guarded for miles by dark suited men, carrying guns and walkie-talkies. No one was permitted within two miles of the filming crew.

The script, actors, crew and basic plot of the film was strictly and tightly kept secret. This was a first in the motion picture business - why?

Dr. J. Allen Hynek, the former top astronomer who debunked UFO reports for the Air Force during its Project Blue Book investigation, was the technical advisor and consultant in the movie. Dr. Hynek, who worked for the government for 20 years and then became a pro-UFO believer himself, was hired by the director to produce the factual encounters and authenticity the film needed. The question arises however, as to why the genius of a director suddenly needed a technical advisor for one of his movies? Why was the movie previewed at the White House long before the public was made aware of its existence? Why was the movie production guarded so tightly and secretively? Who were all those men guarding the perimeter of the movie set for miles?

Don't misinterpret the knowledge you have just learned. This was not the only movie the government has had a role in releasing facts to the public on UFO's. No matter how trivial, or how incredible it may sound, the government had its hands in such other space-oriented films as: "Space-Odyssey 2001"; "Star Wars"; "Starship Invasion"; and all others made within the last year. Naturally, I can't prove that I'm right about all this, but we can all see for ourselves that motion pictures are being produced in numbers that have UFO material. Either the motion picture industry believes they are going to make millions from all these space oriented movies or the government is financing the productions.

Another means of alerting the public to the realism of UFO's is the television. Within the last two years, T.V.-made movies

also show an increase in the amounts of UFO or space related films being aired to the public. Movies such as: "The UFO Incident", which describes the factual abduction of Betty and Barney Hill in New Hampshire; "The Disappearance of Flight 412", which describes the true witnessing by two commercial pilots of several Air Force jets disappearing in a cloud-like substance produced from a UFO; and many others just as related to UFO's. Even regular T.V. programs are introducing UFO's into their weekly series. Series like: The Bionic Woman; The Six-Million Dollar Man; Wonder Woman; The Hardy Boys; Barney Miller; Fish; Happy Days; Walt Disney Presents; and loads of others.

Motion pictures and T.V. programs are not the only ones indoctrinating the public on the subject of UFO's. It seems the news media suddenly regained a long-lost interest into the enigma. In depth news specials have sprung-up on all the major networks. CBS covered the phenomena on its Six- O'clock News under the title, "The UFO Inquiry." ABC, not directly speaking about UFO's, did a series on their Eyewitness News called, "The Year 2000." PBS had a series on their network entitled, "Is There Anybody Out There?" NEW conducted one of their own week long series on the Ten O'clock News called, "Who's Out There?" Besides all the informative coverage into the phenomena, news programs all over the U.S. are covering UFO sightings on their programs that are witnessed by every day persons like you and I. Newspapers all across the country are actually printing UFO reports and some even have photographs of the objects when available. Just recently in New York, The New York Post covered their front pages with a story and photograph of a UFO seen in the daylight over midtown Manhattan by a doctor.

As a Field Investigator for the Aerial Phenomena Research Organization (APRO) at the time, I investigated/documentated this case that made national headlines and media coverage on television. For the first time since the 1950's, news programs on T.V. and radio, as well as newspapers all over the country are once again covering UFO stories. No matter who is directly behind the alerting process, the news media or the government, it's certainly nice to once again hear about UFO's publicly and nationally.

By now you're thinking these programs on T.V. and in show houses around our country is only another fad, soon to be done away with. As a matter of fact, major T.V. networks are adding even more UFO programs to their schedules. NBC for example, has just debuted a series entitled, "Project Blue Book", which centers around the Air Force's 16 year investigation into the phenomena. Jack Webb produces the series and it is truly worth watching. ABC has plans for a space oriented program for its fall line-up, which includes Lorne Greene as the star. As for CBS, you can rest assure they too will provide some form of space alerting program.

Is it all a mere coincidence the American public, the news media, the motion picture industry and television have all suddenly acquired new interests into the UFO phenomena? It's not by chance, but rather part of the overall concept the government is projecting to us in order to alert everyone on the reality of UFO's and alien beings. But why is the government slowly alerting the public after 30 years of secrecy on the subject?

The government is slowly alerting us because they can no longer prevent the inevitable - open contact with alien beings.

More and more UFO reports are taking place daily. The public's curiosity can no longer be controlled. The government is having a difficult time keeping the 30 year long secret covered-up. More and more people are witnessing UFO's and more and more people are unsuppressing or telling secrets that have long been guarded. The public's growing interest and concern can no longer be debunked or quelled. In order to prevent mass hysteria and panic, as produced in the 1940's after Orson Welles' radio broadcast of the famous, "War of the Worlds", the government is alerting us. What does the government expect to accomplish from this alerting process? The government hopes to prove to the public it has had our best interests at heart. By keeping the data suppressed for 30 years, by investigating the phenomena by itself with taxpayers money, by harassing and ridiculing young, old, ignorant and intelligent people from all walks of life, by investigating individuals for their belief in UFO's, by ruining occupations, families and lives in order to keep their cover-up secret, and by lying, seizing civilian evidence, and using gusstapo tactics to keep military and government personnel silenced - the government has kept our best interests at heart. Does this sound logical to you?

The main reason for alerting us is so the government can condition us for the future experiences related to UFO's and their occupants. The following sub-chapter deals exclusively with this conditioning process.

There are more believers of UFO's than one would imagine. One merely has to look at some of the many T.V. commercials seen now a days. The advertising companies messages to the public are also geared to space or UFO's. For example, a major auto

company shows one of its models landing from space and onto an airport runway. Another car manufacturer shows its auto taking off from a runway and into the heavens. A vacuum cleaning company shows its product descending from outer space and down to the planet Earth. A major radio broadcasting station advertises its station using several flying saucers zipping across the T.V. screen. The million dollar advertising companies know how to sell a product, by knowing exactly what the public expects and is currently interested in.

As the old slogan goes, "Look and you shall find!" All you have to do is look in front of your own nose and you will notice the change in T.V. programs, news media reporting, and motion pictures yourself. Try it! Look around your usual everyday life and see just how many commercials, T.V. programs, news specials, newspaper and magazine articles, books, and movies you can spot within a week. You'll soon find yourself amazed at how many UFO related or space oriented materials you do notice. After that, ask yourself, why or how come? Perhaps then you will remember my reasoning, information and opinions and begin to see the truth for yourself.

THE CONDITIONING

As asked before, why is the government slowly alerting us? The gradual alerting procedure will eventually condition us to expect anything and everything related to UFO's and alien beings. The conditioning of our minds to accept the reality of UFO's and extraterrestrial life will pave the way for an official statement on the entire phenomena. The President will address the American public and disclose 30 years of data compiled on the enigma.

The government undoubtedly realizes even after the alerting process and conditioning there will still be millions of skeptics scattered throughout the U.S. Some of the skeptics will be border line cases, not knowing what or who to believe. These persons will eventually be swayed towards the majority of the populace who accepts the reality. However, in order to win the confidence of the majority of acceptors or believers and to convince the skeptics of the truth, the government will have to publicly be addressed and the facts stated to be true.

The speech most likely ^{will} tell of the various branches of the government being secretly involved in documenting and investigating UFO's. The speech would have to reassure the public the government has not sat idling as other nations investigated the phenomena. The President would have to state that for reasons of national security the matter has been kept strictly classified; that the motives were in the interest of America. The disclosure of all data the government contains on UFO's would have to surface. And once again, the speech would have to prepare Americans for future contact with UFO's and their occupants.

After a speech of this magnitude, the conditioning of public attitude will enable any American to accept an alien being presence without fear, panic, or ridicule. In the end, the conditioning will awaken the public both mentally and spiritually to the fact we are not alone in the universe. The public will then accept the fact these beings are more superior to us and intend us no harm. Millions of Americans will then believe these aliens are going to help us advance to our fullest potential and someday we will live in peace as they do.

According to the theme of the alerting process and the plot of the conditioning, when the entire process is complete the American public will be ready, willing, and worthy of an open contact with aliens not of this world.

Unless the government proclaims the realism of UFO's straight forward and discloses every fact it has compiled in 30 years of investigating, I don't want to hear it. Unless the politicians of this country stop acting as children instead of men and unless all the lies discontinue - I don't want to hear it. Whether or not the politicians think so or not, we as Americans built this country, formed the government we now have, fought for our democratic freedom, elect our politicians to office, and control them as well as run the government. We have earned the respect and right to know exactly how our government is being operated and what is going on. No matter if it's good or bad news, we still have every right to know. If it's good news, inwhich I doubt, terrific. If it's bad news, well tell us anyway. If we are going to die from an alien invasion, let us know about it so we know why we are going to die and by who.

There are many startling claims in my book and I suppose I will hear one way or another from the government on my alligations. Be it as it may! If they want to silence me they're ^{have to} going to kill me. Even then if that happens, what will that accomplish? There are many, many more UFO researchers who will take my place exactly where I left off.

THE PLEIADES DECEPTION

When the S.B.I. was formed in January of 1979, one of our principle goals was to alert the public on the true nature of the U.F.O. phenomena. For the past eleven months, my colleague and close friend Pete Mazzola and myself have strived to do just that. I state this for the record so you will better understand how difficult it is for me to write this article.

In 1952, one of the oldest and most respected U.F.O. organizations, A.P.R.O. (Aerial Phenomena Research Organization) was founded. It's International Director, Jim Lorenzen and his wife Cora] have for years been at the forefront of Ufology. It was the Lorenzens who first handled abduction cases. This was at a time when abductions were considered nothing more than glorified contactee cases. Yet A.P.R.O. had courage enough to collect data from witnesses who have been in situations of abductions. Now it appears that A.P.R.O. is no longer a useful tool in Ufology. I state this not because I have any personal animosity towards A.P.R.O., or the Lorenzens but because I have now been confronted with facts that lead me to the irrevocable conclusion that Jim Lorenzen has become a prostitute for the world of big business.

Not only has Lorenzen put a black mark against his own name, but he has done a great injustice to the field of Ufology in general. He has given ammunition to the likes of Phillip Klass and James Olberg. This ammunition has come by way of an endorsement that Lorenzen has given to a book entitled, U.F.O. Contact from the Pleiades Volumn I. This book published by Genesis III Productions Limited, is authored by Lt. Col. Wendelle C. Stevens, U.S.A.F. (Ret.) and is the photojournal of a man by the name of Eduard "Billy" Meier. According to Stevens, the photojournal details the "extraterrestrial" contact that Meier has made from 1975 to the present. With the aid of a handy 35mm camera and 8mm motion

picture camera, Meier has taken hundreds of photographs of U.F.O.s at close proximity to himself. Not only are we suppose to believe this, but also that Meier had conversations since 1975 to present with the occupants of U.F.O.s. Meier was also given samples of the ship to be analyzed by the friendly "Aliens"! From the photos that are in this book, we are lead to believe that Meier is a simple farmer toiling the soil on the Swiss Alps, but this is not the case. In several photographs taken at the Meier "farm", it appears to be more of a communal type atmosphere than any type of a farming endeavor. It also appears that Meiers has surrounded himself with believers and has also set himself up to be the modern day "Messiah" but that is not all.

A few years ago, Jim Lorenzen asked Major Coleman Vonkevizky to examine the negatives and photographs as well as the motion picture film taken by Mr. Meier. Coleman spent endless hours examining these photographs and concluded beyond the shadow of a doubt that they were fraudulent. They were in Coleman's words, "A complete farce". Lorenzen was made aware of this in no uncertain terms and was advised by Vonkevizky to steer clear from Meier.

As for the photographs that appear in this book, they are all beautiful, all in full living color, and all ludicrous! As Pete Mazzola has stated for the record, "These U.F.O. photos are so beautiful, the only thing that is lacking is a New York license plate on them".

Throughout the book we are "embellished" with actual quotes from the Aliens themselves. Example: "A single second in the time-less, amounts to many millions of years in outer space". Further on in the book we are again graced with the quotes from the Aliens, this time stating, "Within a short time I will get a new beam ship which you will be allowed to photograph closely to get better pictures". Does this sound consistant to you? On one hand the "Aliens" are talking about the boundless spanses of time and space. On the other hand "they" are instructing Meier that within a short time he will be allowed to photograph a new beam ship. What do they mean by short time? Apparently Meiers overlooked this when the whole affair was fabricated because there is great inconsistency here. As a matter of fact the whole book is full of inconsistencies. In one photograph a U.F.O. is shown and beyond it a

jet fighter. The authors would have us to believe that this fighter has made some 22 passes at the U.F.O. and gave up. I ask you as a rational human being, if a jet fighter had the time to make "22" passes at any U.F.O., wouldn't he have fired on it by the second or third pass? Surely the pilot would have called in reinforcements. No, this fighter simply took off knowing that he could not match the capabilities of the U.F.O. This is preposterous! And yet another photograph leads us to believe that a U.F.O. has just passed behind a rather tall tree. On the caption Mejer gave the tree diameter to be 21 feet, but there is only one problem. A rather large problem for Mr. Lorenzen. It is that the U.F.O. is in focus while the tree is out of focus. This leading of course to the correct assumption that the U.F.O. is probably a lot closer to the photographer than the tree was. Apparently, someone didn't do their homework before this book went to press.

To make matters even worse, A.P.R.O.; Jim Lorenzen in particular, has recently renounced Major Vonkevizky and rescinded his consultantship from his organization. It seems that through Coleman's analyzation of these photographs, and his subsequent statements to the fraudulent nature of these prints, Lorenzen has become nervous now that the book is on the market.

Without a doubt the most saddest state of affairs will affect the membership of A.P.R.O., which for years have remained loyal to Jim Lorenzen and his cause. It seems a terrible waste to me that all these people should have mud cast upon them by the erroneous blunder of Jim Lorenzen.

A SPECIAL REPORT

Last week (November 4, 1979) I had the pleasure, along with Tom Dawiczowski (New York State Director) and both International SBI Directors (Pete & Jim), of attending a seminar on UFO's in Auriesville New York. The seminar was organized and orated by Dan Lowenski (Chief Investigator-UpState New York) and took 9 months of preparation. Beginning at 9:30 a.m. and ending at about 7 p.m. with a visit to Dan's self built observatory, it was concluded on our return trip back to New York City the entire affair was professionally executed and successful in captivating the image of the SBI. For this reason I truely believe Dan is a credit and an asset to the future progression of the SBI.

One of the many questions discussed at the seminar that raised a a serious point of view was, "How did all of us come about being involved with UFOlogy and why is our study of the phenomena so truely involved in seeking unknown answers?" In my own particular case, it began in 1954 at which time I was residing in Garden City, Long Island New York. My home was near by Mitchell Field Air Force Base and on numerous occassions I walked past the base to my home.

On one such day, I was startled to observe 6 or 7 extremely high silver discs hovering above a water tower on the base. After a lapse of approximately one minute the objects took off in a V-type formation at a phenomenal rate of speed. Even though it was daylight, the glow and luminescence of the discs seemed to light-up the entire area. Another thing I noticed, there was absolutely no sounds being emitted from the objects, other than a slight whirring or buzzing sound just prior to speeding away from a hovered position.

When I arrived home I was still excited over the experience that I had witnessed. I wondered to myself if I had really seen these objects, or was it a figment of my imagination whereby I hallucinated? My confusion was quelled the next day as I read a local newspaper concerning sightings over the AFB the day prior to my sighting. I was assured I was not imagining things by the confirmation of fact other persons observed exactly what I had seen. Soon afterwards I began to visit local libraries searching for books relative to the UFO enigma. At the time the only book available was "Report on U.F.O.'s" by Edward Ruppelt. For years this book was like a bible to me on the subject of UFO's. Subsequently, over the years I collected and read most of the books and magazines that were published and my knowledge of the subjected expanded while my mind yearned for more answers. One book which impressed me the most was "The Interrupted Journey" by John Fuller. (For the benefit of the novice just beginning the study of UFO's, this book relates to the famous 1961 abduction of Betty and Barney Hill.)

Intrigued so much by this abduction, I actually visited the area of the White Mountains in New Hampshire with my wife Sophie. We retraced the abductees actualy route to convince ourselves something like this was possible of happening. My point is, how many people do you know that take a vacation to the exact place of a recent abduction

and involve their own wife in the subject, merely because they are curious and desire answers? Not too many I'm sure!

I feel many persons have had sightings similar to the one I had, but the question remains, "why do some people get heavily involved in trying to solve the UFO mystery while yet others, dismiss it from their minds?" I have formulated a theory that can break down the general public into four categories regarding their opinions on UFO's. They are as follows:

- (1) EXTREMIST (with sighting)---Persons having a sighting and become super dedicated in the involvement of solving the UFO phenomena to such an extent that their main goal life is subconsciously programmed in this fashion.
- (2) EXTREMIST (no sighting)---Persons who never had a sighting but dedicated to the extent that one of their main goals in life is to solve the UFO mystery.
- (3) MIDDLE OF THE ROAD (with sighting)---Persons having a sighting but for some unknown reason do not involve themselves in solving the UFO phenomena, yet however, they form an opinion on the subject.
- (4) MIDDLE OF THE ROAD (no sighting)---Persons who never had a sighting but are open-minded in forming an opinion on the UFO subject. THE AVERAGE PUBLIC FALLS WITHIN THIS CATEGORY.
- (5) NON-BELIEVER (with sighting)---Persons having a sighting, but refuse to believe UFO's exist by rationalizing a logical or natural explanation for the incident.
- (6) NON-BELIEVER (no sighting)---Persons who never had a sighting so therefore, refuse to believe UFO's exist.
- (7) NON-BELIEVER EXTREMIST---Persons who flatly refuses to admit UFO's exist and voices their opinions negatively on the UFO subject and to those who have had sightings or believe. THIS IS A SMALL MINORITY OF THE AVERAGE PUBLIC.

From my own experience, I believe I fall under category #1. Which again raises the question, "what is it that makes an Extremist-type researcher, such as myself, act like a fanatic in pursuing the goal of solving the UFO phenomena?"

After some very heavy thinking, I conjectured a theory that all of us who are deeply involved in solving the mystery have, at one time or another in our lives, been programmed, abducted or subconsciously aroused to follow these destinies. This is why it is we crave more and more answers for our questions.

You may think this reasoning is illogical, absurd or even very ludicrous. Be it as it may! However, statistics from a recent Gallop Poll indicated 57% of the American public believe UFO's exist. These 20 million Americans have been broken down to whereby 15,000,000 have stated to have seen what they believe to be a UFO. Keeping with the realm of statistics, Dr. James Harder, professor of engineering at the University of California (Director of Research for APRO), has concluded some interesting studies of persons involved in UFO research as to those who have been abducted, programmed or subconsciously

motivated into UFOlogy. Statistics indicate that 8 out of ten persons involved in UFO research endured some form of subconscious tampering. A study shows that persons involved in UFO research have not only been subjected to some form of mental programming during their adulthood, but during their childhood as well. Usually a person is first encountered at an age of 3-5 years old and then again as an adult. The remembrance of these facts are brought to light some times by recurring dreams, an actual abduction or from a need to know basis.

What does this all prove? It shows Americans as a whole are very interested in UFOlogy; it shows millions of people have observed what appears to be a UFO; it shows some form of relationship between those who seriously study UFOlogy as to those who have had close encounters, recurring dreams or nightmares, or those who enroll in organizations as UFO investigators.

Why were these EXTREMIST UFO believers subconsciously programmed, physically examined or abducted? Who knows & who can say? The reason behind these coincidences have yet to be explained or learned. This is why I feel a similar survey should be conducted within our own organization. Let's find out through regressive hypnosis techniques who within the SBI has at one time or another been programmed, even abducted.

For whatever reason, I personally need to know more and more answers to satisfy my taste for UFOlogy. I am dedicated to the goals and causes of the SBI and as Regional Director of the East Coast my duties and responsibilities are to the organization and to those who too crave more insights into the phenomena. I will not rest until my craving answers have satisfied my taste buds...





SCIENCE/SCOPE

A new ring and moon around Saturn were among the discoveries made by NASA's Pioneer 11 spacecraft during the historic first flyby of the giant planet in September. The spacecraft's electronic camera, an imaging photopolarimeter, also supplied close-up pictures of Saturn's banded cloud structure. Another instrument, an infrared radiometer, found atmospheric temperatures from -279° to -288° on Saturn and its largest moon, Titan. The readings for Titan reduced the possibility of biologic activity in the organic gases of the moon's reddish smoglike atmosphere. The polarimeter and radiometer were built for NASA's Ames Research Center by the Santa Barbara Research Center, a Hughes subsidiary.



EXCLUSIVE: Reports from several reliable sources now confirm that in June of 1978 in Chile a daylight disc (DD) was observed by many at the scene and thousands viewing T.V. The incident occurred during a World Championship Ski Tournament as a live telecast of the event was being broadcasted. A cameraman, panning his camera to capture the beautiful scenery for viewers, instead captured a silver, metallic-looking craft hovering near a mountain top. The object hovered for several seconds and then performed aerobatic maneuvers for all to see. Of course, the Chilean government quickly confiscated the video tape of the event before it could be re-copied by television personnel. The SBI is working with a Consultant from Chile (has governmental influences in Chile) in order to try to obtain either a copy of the film or any documentation concerning the encounter.

Valencia, SPAIN (NOV. 12, 1979): A commercial airline pilot, with a host of passengers aboard and a crew of seven, observed a Red-glowing UFO while nearing the airport for a landing. The night-time encounter was also corroborated by many ground personnel and radar technicians from the airport. At one point, the pilot had to use evasive action as not to cause a head-on collision whereby, the plane dove down 14,000 feet to escape the UFO. The actual events which transpired are at present being wired to SBI Headquarters from representatives from Spain.

Spot UFOs near L. Michigan

Witnesses reported seeing as many as 20 brightly lighted, unidentified objects Monday in southwestern Michigan and northern Indiana, it was reported today.

The lighted objects, described by one witness as "like putting diamonds and rubies up to a very bright light," were observed near Lake Michigan.

Benton Harbor, Mich. police said they have received several other reports of the strange lighted objects in recent weeks.

J. Allen Hynek, director of the Center for UFO Studies, is investigating the sightings.

Reveille's phantom spaceship



The popular British tabloid *Reveille* last week astounded its readers with a front page story headlined "Sensation in Space". According to the story, reprinted from the American weekly *National Enquirer*, Soviet space experts have been tracking wreckage from an alien spaceship which broke up in orbit around the Earth nearly two years before the Russians launched the first Sputnik.

The report quotes science fiction writer, Alexander Kazantsev, described as a professor, as saying "We believe it (the spacecraft) was at least 200 feet long and 100 feet

wide, and had small domes housing telescopes, saucer antennae for communication, and portholes."

Alexei Zolotov, a geologist, adds, "We estimate the alien's maximum height at nine feet. They could be as small as three feet". Kazantsev and Zolotov are well known as proponents of the idea that the enormous explosion over Siberia in 1908 was caused by a crash landing of a nuclear-powered alien spacecraft. (In fact that explosion was almost certainly caused by the impact of a fragment from Encke's comet).

The report quotes Sergei Boshich, described as a "top Soviet astrophysicist", and Vladimir Azhazha, said to be a "top Moscow physicist", as agreeing that the wrecked spacecraft exploded into 10 pieces up to 100 feet long, on 18 December 1955. They say the pieces are orbiting the Earth at a height of 1240 miles.

But Western experts have no knowledge of such unidentified fragments. "If there were objects of the size and distance suggested by the Russians they would be tracked both by radar and visually," says Desmond

King-Hele, of the Royal Aircraft Establishment, Farnborough. "We have seen no such objects".

US Airforce radars in operation since the start of the space age can track orbiting objects as small as one yard across. What is more, a 100 foot object orbiting at a height of 1000 miles would appear as bright as the Echo balloon satellites of the 1960s, which was seen by many people as they drifted across the sky like brilliant stars. "There are no alien spacecraft knocking around in orbit" says Desmond King-Hele.

So what's behind the Russian report? The whole theory seems to be based on a 10 year old misunderstanding. In 1959 an American scientist, John Bagby, published a paper (*Icarus*, vol 10, p 1) which claimed that the Earth possesses at least 10 moonlets, formed when a parent body broke up on 18 December 1955 —the same date now given by the Russians for the "spacecraft explosion". Crucial to Bagby's case were sudden changes in the published orbits of certain Earth satellites,

which he put down to near encounters between artificial satellites and his moonlets.

But Bagby's evidence was erroneous, as pointed out by Belgian astronomer Jean Meeus (*Icarus*, vol 10, p.547). In a withering criticism of what he termed "Bagby's phantom moonlets," Meeus noted that the satellite data used by Bagby were at best approximate and at worst grossly in error so that the apparent orbital changes were illusory. "Bagby's story on the Earth moonlets thus appears groundless," Meeus wrote. "The objects cited by Bagby do not exist".

The Russians, it seems, have now turned phantom moonlets into a phantom spacecraft. □
