As International Director, I firmly believe this is so. Our recent publicity and future endeavors shall keep us in the public's eye for some time to come.

Lecturing on a state-wide basis once a month has contributed to public awareness and membership. To add to our success, many of our affiliate UFO organizations are sending us photographs and soil samples for our lab to analyze. All in all, this makes us feel good--that we are recognized and being trusted.

As we (SBI) were quoted to say in our very first issue of this REPORT, "...the key is unity!" This statement is the essence of our success and motivation. Now, that we have achieved our rightful status in the UFOlogical kingdom, we can not undo what we have accomplished. That being, now we must remain more united than ever. After climbing the ladder of recognition for our organization and ourselves (every member), we cannot and will not become lax as to decline rung by rung our present position on this ladder.

In order to proceed up this hypothetical ladder, the members of the SBI MUST continue to do all they possibly can to support and promote our organization. In an effort to maintain this goal, last month's issue of this REPORT instituted a few new requests. One, a request to our membership to aid us in searching for potential prospects to donate funds and/or equipment or materials to the SBI.

We urgently need grants or donations for future research, investigations and advertising our organization. **THE MONEY IS OUT THERE, ALL WE HAVE TO DO IS FIND THE SOURCE(S).** We, the officers of the SBI, are asking you, the member, to **HELP US** in this required matter. I am positive, if we truly seek these sources we shall, as before, overcome any barriers which may impede us from obtaining these funds.

Two, we asked everyone reading our SBI REPORT to help us alleviate a serious and tedious burden every month. We speak of manuscripts, art work, and newsclippings related to UFO. All these necessities will ease the tension of producing and publishing our monthly literature.

Already, since last month's issue, hundreds of newsclippings, manuscripts and art works have been mailed to our Headquarters. This only goes to prove our membership does care and takes pride in their interest towards the subject. For this we thank all that have contributed to our request.

By the same application to our Headquarters, thousands of letters arrive inquiring about the U.S. Air Force position on the matter now-a-days? People also wish to learn why, if alien life forms exist, why do they not make open contact with our populace of Earth?

In order to answer these questions I shall refer to the U.S. Air Force Training Manual entitled, Introduction to Space Science, Volume 2 (Dept. of Physics, U.S.A.F. Academy, Colorado). Specifically, we refer to Chapter 33 of the Manual which is sub-titled, "Unidentified Flying Objects." (p.455)

The current Air Force position on UFO is that "UFO do not exist." However, this attitude is solely for public imagery. Behind closed doors, the Air Force does not practice what it preaches! The Manual, which is provided to cadets training to become pilots, on the other hand, explains to their trainees how to report a UFO, avoid the public and media on such experiences, includes description classifications, operational domains, some theories as to the nature of phenomena, human reactions, attempts to attack the problem scientifically, and some tentative conclusions. They also make note to their cadets, the phenomena is so vast, the stories so many and varied, that only an outline (tip of the iceberg) on the subject can be presented to them. So, references are given of books to provide an excellent starting point to increase their knowledge of the subject.

In reference to a landing in Socorro, New Mexico in 1964, the Air Force states, "It is rather difficult to label this episode a hoax and it is also doubtful that both Zamora and Chavez (two police sergeants observing the landed UFO ascend and disappear) shared portions of the same hallucination." As to alien visitors appearing to some persons, the Air Force states, "The most stimulating theory for us is that UFO's are material objects which are "manned" or remote controlled by beings who are alien to this planet. There is some evidence supporting this viewpoint." (p.460)

As to why no contact? The Air Force states, "1. We may be the object of intensive sociological and psychological study. In such studies you avoid disturbing the test subjects' environment; 2. You do not "contact" a colony of ants, and humans seem that way to any aliens (example: a zoo is fun to visit, but you don't "contact" the lizards); 3. Such contact may have already taken place secretly; and 4. Such contact may have already taken place on a different plane of awareness and we are not yet sensitive to communicate on such a plane." (p.462)

Besides also stating the following:

1. ...the evidence is that any possible aliens have been ripped apart by mobs, shot and shot at, physically assaulted, and in general treated with fear and aggression. (p.462)
2. "WE TOO HAVE FIRED ON UFO's" (p.462)
3. It was definitely saucer shaped. (p.463)
4. There are a large number of different saucer shapes but this may mean little. For example, look at the number of different types of aircraft which are in use in the U.S.A.F. alone.

The Air Force contends, "it is obvious that intensive scientific study is needed in this area. One thing that must be guarded against in any such study is the trap of implicitly assuming that our knowledge of Physics is complete."

In conclusion, the Air Force states:

1. ...the UFO phenomena appears to have been global in nature for almost 50,000 years.(p.466)
2. The entire phenomena could be psychological in nature but that is quite DOUBTFUL. (p.466)
3. THIS LEAVES US WITH THE UNPLEASANT POSSIBILITY OF ALIEN VISITORS TO OUR PLANET, or at least of ALIEN CONTROLLED UFO's. However, the data are not well correlated, and what data there are DOES SUGGEST THE EXISTENCE OF AT LEAST 3 and maybe 4 DIFFERENT GROUPS OF ALIENS (possibly at different stages of development).

Their final appeal to their cadets concludes the following:
"The best thing to do is keep an open and skeptical mind, and not take an extreme position on any side of the question."

Isn't possible the day in which a UFO lands on Earth and does have open contact, our populace will get a terrible shock. Millions of people from scientists to children, will have to change their thinking about the universe.

If there are other worlds watching us, they will have to treat Earth-folk carefully. They must decide whether or not we are ready for close contact with other worlds.

They must decide whether other worlds are ready for close contact with us.

Meanwhile, we Earth-folk have sent a UFO of our own into the unknown universe. It is a small space probe, Pioneer 10. On it is a simple message that could be understood by any thinking being. The message is a picture that shows a man and a woman. The man's hand is raised in friendship. He seems to be saying: "Here we are. Is there anybody out there?"

PERHAPS SOME DAY WE WILL KNOW THE TRUE ANSWER, AND PERHAPS THE SBI CAN HELP TO OBTAIN THAT ANSWER.

A SPECIAL REPORT



by: MARCELLO GALLUPPI (SBI FIELD INVESTIGATOR--MICHIGAN)

The S.B.I. was incorporated on Jan. 16, 1979 in Wilmington, Delaware and so this day at 9 A.M. must be considered to be the official birth of the organization. For those who are not familiar with the subject of Astrology, let me point out that Astrology is not a subject of Sun Signs alone although the Sun Sign is very important. Some people think that a chart should be set up for an organization based on the moment of conception, that is when the idea was first formed. That would be an interesting chart to be sure but this chart is acceptable to the Courts and is acceptable legally and so that is why this chart is being considered. As we will see it is a most interesting chart considering what the S.B.I. stands for.

Permit me to tell you a bit about what Astrology is and how it works in a few lines. Since the days of the Babylonians Astrology was looked upon as a science and art and astrologers were present in the Courts of Kings as advisors. The Ancients were aware that the Planets (known to them as Gods and Goddesses) had an effect on each person born onto the Earth and that certain combinations of planets within their birth charts and/or planets rising in the birth chart would have a great effect on that person's destiny. That is how certain phrases came to be known in respect to planets; for instance, one was a lunatic (Moon), mercurial (Mercury), warrior/martial arts (Mars), jovial (Jupiter) venerable/charm (Venus), and that phrase that we all use today by saying that someone is a star or that their star is rising (Sun). The Signs of the Zodiac came to be used because animals were depicted to describe those sections of the Zodiac by the astronomers of those times. And today those same animals are still used, especially in connection with one's Sun Sign. And it is a pity that ignorance, fear and deceit on the part of Church officials in the Middle Ages lead to people being burned at the stake or imprisoned because of their belief in the planets, Astrology, herbs, energies of different sorts which was therefore translated as Witchcraft. Energy seems to be inter-related to all things and people and since all of it and us are products of Creation, I never could understand how and why the Church made mockery of Astrologers in those days. After all we never created the planets. And today it seems that people will look upon Astrology as an odd subject and there seems to be a feeling from some quarters of society that Astrologers are strange or weird. But then so are U.F.O.'s and from what I have been able to sort out is that they may indeed be an energy that we don't understand. However I am getting a bit away from some hard information about Astrology. Basically, planets, signs and houses and the relationship of planets to each other and to the angles (the four dark lines in the chart circle) are what make the interpretation of any chart. Now the Planets are the actor and actresses while the Zodial Signs give the personality (the Sun sign is not the only sign of a chart. Why not the personality of Mercury or Venus or Mars etc.) and the Houses are where the different departments of life are. More on that later. Finally the aspects (relationships of the planets to each) give us a very complete picture of how well or poorly the planets interact. So you have a Sun Sign, but I am more interested in how the Sun in your chart is relating to the other planets. An unaspected Sun (type person) will just wander through life because the Sun is not interacting with the other planets and so it feels isolated and does not gain the experience of what the other planets can share with the Sun (goals and will).

Now let us take a look at the chart of the SBI. For orientation to the chart it must be noted that everything above the Ascendant - Descendant axis refers to external and public for that section is the day cycle. Anything below refers to the internal and night cycle. As therefore can be seen the SBI is an external and public group. The Ascendant is the most powerful point in the chart (many times referred to as the Rising sign, and so Asc. will be used from now on for this point) and therefore Aquarius is the Sign listed on the Asc. It means the SBI has a scientific, creative, independent, unique and unusual outlook. Every experience is seen by and comes through the Asc. since it is the beginning of the day cycle being 6 AM in the morning. The sign of Aquarius deals with scientific investigation of unusual subjects among other things and it is an Air Element whereby all communication is transmitted through. So already the SBI is going to do it their way, as the song goes. They are a new breed.

The Sun (in Capricorn) is the most powerful planet (I will refer to all the heavenly bodies here as planets) but in actuality the Sun is a star and through gravitation keeps all the planets within orbit of itself. Without it nothing would exist since it gives nourishment light and heat. Now the Sun refers to Will Power and in the SBI chart it is in the sign of Capricorn (the Goat) which gives, as a personality; ambition, organizational ability, conservatism, practicality, the ability to hang in there and a long life. Now being located in the 11th House there is an interest in group activities, scientific endeavors, a willingness to work for common goals, using new methods (tied up with the Capricorn sense of old methods and tradition) and being a most unusual organization itself. Remember I was saying that it is not just enough to say that one is a Capricorn but that it is essential to observe what other planets are aspecting the Sun to know what added qualities the Sun will have so that it may act in a more expanded way.

Mars (in Capricorn) is in an excellent sign for here Mars will channel it's energies into professional ambition. I said before that Mars refers to the warrior and is connected to such types as firemen, police officers, fighters and daring people of adventure. Mars in this sign also gives the desire to be recognized and to be successful but only through hard work. It's action is well organized and carefully calculated to achieve concrete results. It is extremely practical and efficient. Mars is also in the 11th House and so it will express itself in an efficient and aggressive way with other organizations tied into scientific methods.

Mercury (in Capricorn) indicates a love of truth and attention to detail. It gives good organizational methodology and concentration. It makes the SBI shrewd, patient and reliable disseminators of information. Posted in the 11th House, once again, it has the purpose of exchanging scientific and practical information. All kinds of information and communication come under the heading of Mercury who was the messenger of the gods. You will note that with all this Capricorn quality that there is a strong sense of being reliable and consistent. I notice that the SBI report comes out regularly every month and on time. I don't believe that any other UFO group even comes close to this ability and reliability.

Now we come to the 10th House of career and public image. And Neptune (in Sagittarius) is located here. A very interesting combination to be sure, because Neptune represents that which is not clear or another way of putting it is that Neptune rules fog, dreams, magic and the invisible. It would indicate that having Neptune in Sagittarius up so high in the chart means a great deal of idealism, intuition, the ability to ferret out secrets in their investigations, knowing where to be at the right time and place, having secret enemies and having the ability to remain invisible in the public image if they so desire.

Venus (in Sagittarius) in the 9th House shows good relations when traveling far distances or overseas. It is known that the SBI has good connections in foreign countries, Universities & Colleges, and at far distances across the U.S.A. The 9th House is equated with higher knowledge and foreign travel. Venus is the planet of beauty and relationships and positioned within Sagittarius it is a generous and favorable quality to the relationships formed in the above areas.

Uranus (in Scorpio) located in the 9th House says that the SBI will use electronic and audio-visual techniques to discover the truth. They will use unusual methods (Uranus in Scorpio) like hypnosis and very technical equipment to analyse and detect the information they seek. Since the 9th House speaks of high knowledge and technology, the SBI will use some unusual methods that are old and new to achieve their goals. With Uranus (the planet of change and revolution) located in the powerful sign of Scorpio (the ultimate sign of detective work, and also the sign ruling the underworld and the C.I.A.), the SBI is bound to make some radical changes in the information that is being given out to the public via the Report (monthly) and the Television and Radio interviews. With Uranus the ruler of the Asc. sign it is clear that the SBI is going to make some dramatic changes in the world and topic of UFO's.

Pluto (in Libra) in the 8th House is extremely powerful. Each planet rules a particular house but normally that planet will not be in it's own house. When it is found there it has power all of it's own just because it feels the most comfortable in it's own house of expression. Pluto rules the earthquakes, volcanoes, C.I.A., and is ruler of the Underworld. Plutonium was named after the planet Pluto and we all know the intensity (to a slight extent) of Nuclear Power. Pluto devastates and annihilates. It is the greatest investigator of all the planets. It is the magician of the world of sleuths. If there is any mystery to be probed then Pluto in it's own house of life, death, clairvoyant abilities and extreme do-or-die attitude, can do the job to the ultimate degree. It can also be said that Pluto rules the dark forces and that it is possible that the SBI, which is a force to be reckoned with itself, may meet up with those forces of the dark world from time to time. Pluto certainly would be the closest planet to describe UFO's because they are so weird, frightening and have power that is incomprehensible (almost) to us. Pluto is the ultimate power and it can be said that UFO's exhibit the strangest powers we have seen outside of science fiction. The SBI has the power of Pluto in Libra which is the rebalancing of the Law and especially in this case where there has been so much cover-up by the government over these past thirty years, and it is clear that the SBI is to take on the heavies of the dark forces (James "Darth Vader" Oberg come and get it!) whoever and wherever they be that try to hide the truth. The SBI has got the POWER.

One other point to note is that Pluto is stationary retrograde. In Astronomy that means that Pluto was ready to go (seemingly) backwards in the sky with respect to the Earth. When a planet is stationary (whether retrograde or direct) it has more power than normal. So the fact that Pluto is in its own house that it rules and is also stationary would add even more punch to the above statements about this planet, but in addition it is clear that the SBI uses this assistance to be able to delve into the deepest places for information about the Plutonian subject of UFO's. They will constantly be destroying old traditional patterns with respect to what the public has been used to thinking and hearing about this extraordinary situation of UFO's.

Saturn (in Virgo) in the 7th house of partnerships and relationships. Saturn represents hard work and is the ruler of Capricorn and so therefore it seems that any partnerships made within the SBI will last a long, long time. And since Saturn is the planet that brings people (who knew each other in past lives) together, it seems that maybe we in the SBI used to do some similar research in the olden days. Saturn in this house demands strong responsibility in cooperation and because it is in Virgo uses great precision, accuracy and practicality in its (SBI) methods. They will demand as such from their members to be sure, here is a group that is sincere and dedicated to its principles and members and extremely hard working to achieve results. It is also a point to be aware of for the SBI, that they will definitely have enemies who are themselves hard at work to undo all the good work of this wonderful organization. But the Saturn gives the SBI reliability, and the ability to take on the heavies. For Saturn rules rocks and lead, and that certainly has an advantage for the SBI. They will be around for a long time!

The Moon (in Virgo) in the 7th House speaks of dealings with the public. The Moon refers to feelings and emotions but it also refers to stomach therefore needs that have to be filled and finally the Moon refers to the people. Now being placed in the sign of Virgo there is an attitude of criticality, attention to detail, neatness, precision and hard work. The Moon is in an earth element and so it gives stability to the emotional outlook of the SBI. There is still much enthusiasm since the Moon will express itself to other people concerning the ideals (Aquarius Asc.) that the SBI stands for. Moon in the 7th is excellent for public relations and also for the sensitivity towards other people (and that is shown by the respect that the SBI shows for other people's testimony or the evidence that they may bring forth).

Now we note the North Node also located in the 7th House. The Nodes are connected to the Moon and are points in space. The North Node has a lucky connotation and therefore indicates good fortune through partnerships and public relations. Therefore the public will find the SBI to be very acceptable and with Saturn in the 7th and being conjunct to the North Node, the SBI will be found to be reliable and conservative.

Finally, Jupiter (in Leo) is in the 6th House of work. Since Jupiter is the luckiest planet of the solar system, it is always favorable in whichever house it is posted. Jupiter here gives a practical and optimistic view and outlook in wanting to contribute to the social order. And it can be said that the SBI is more outgoing and optimistic as any UFO organization has ever been. They tend to be trusted because of their honesty and because of their helpfulness to the common people. Jupiter tends to give such outlooks. The work of the SBI is bound to be favorable!

Now it is time to look at the relationships of the planets to each other and to the Angles which are called Aspects. The hard aspects are the Conjunction, Opposition, Square and Quincunx. By hard I mean these aspects make us work on bettering our selves for the Trine and Sextile are very favorable and there is no work involved with these two relationships. The conjunction is the most powerful and then comes the opposition which is followed by the square and finally the weakest hard relationship is the quincunx. The trine is stronger than the sextile

I will not go into all the aspects but those which stand out. With regards to the Sun in Capricorn there is a conjunction to Mars and both square Pluto. This is a most powerful combination of warriors who are fearless. They are not afraid to fight for what their beliefs are nor afraid to go anywhere to look for information. And so it must be said that they will therefore encounter the dark forces of society whether they be on the darker levels of the government or of the underworld. The action of the Sun is careful, practical, methodical and reliable but it acts with much added power from Pluto, Uranus and Mars. These planets denote the unexpected, the unusual and the undaunted actions of the SBI. Here is a force to be reckoned with to be sure. These vibrations fit perfectly with the police force. And because there are so many of the force within the SBI, it is clearly an organization that will not be subdued!

The Moon in Virgo aspects only Venus and Saturn, which contribute to the charisma and extreme hard work and reliability of the SBI. It may also be mentioned that the women who join the SBI are extremely reliable and responsible to the ideals of the organization. They will be of extreme help.

Mercury in Capricorn trines Saturn in Virgo and also squares Pluto. Here is again a powerful combination of communication. Aspected by Pluto makes Mercury speak out bluntly and with determination. Pluto gives Mercury the best ability (of all the planets) to achieve a high degree of detection and investigation, and above all a fearlessness to challenge any authority. In addition to Pluto let us notice the action of Saturn to Mercury, which are in Mutual Reception. That means that each planet is in the other ones sign of rulership. Saturn rules Capricorn and Mercury rules Virgo. And the fact that they aspect each other gives them a tremendous ability to harmonize. They therefore achieve a fine precision, attention to detail, conservative and yet critical eye, learning ability to a high degree, easy relationship to authorities and especially the police and law enforcement agencies and above all have a fine acceptance of evaluated information by people in high places. Like the ad says.....WHEN THE SBI TALKS.....PEOPLE LISTEN!!!!

Venus in Sagittarius trines Jupiter (the ruler of Sagittarius) and therefore makes for wonderful friends and relations especially public. Here there is exhibited a generous, frank and sincere attitude toward people. And then Saturn squares Venus and so here there is, on the other hand, a caution and defensiveness probably because there are those people and forces who want to penetrate the organization and therefore undermine it as has happened with other UFO organizations. Saturn demands proof of reliability and responsibility. The SBI does not trust it's members until they have been vouched for and that goes for the contacts they acquire. And since Venus is so high up, the SBI will be recognized. They have a charisma that makes them be noticed.

Mars in Capricorn aspects Uranus and Pluto. Here again we have a combination of fearlessness and tremendous power to achieve and to overcome any obstacles. It makes for an overly forceful nature and persistence. It is in this combination that the SBI may look for the dark forces (those who work through deceit and cover-ups and for the government or on their own) to try and drive a wedge into and through the organization. For it is clear that the SBI is a group with power, resources and determination of such quality that among the UFO groups there has not been such a one with this type of power. The SBI will be noticed by many that are for and against them. This is definitely a group of warriors.

Jupiter in Leo aspects the Mid Heaven and Nadir and so we have a lot more of assistance and good luck directed to the public and career. It adds its power to the wonderful Venus so high up in the chart. And it is also the ruler of the Mid Heaven (Sagittarius ruled by Jupiter). And so there is even more luck connected to the career and image of the SBI.

Saturn squares the Mid Heaven, Nadir and Neptune. It is here where the SBI must be careful again for those combinations make for some deceitful people slipping into the organization, or trying to do so. It is an excellent policy for the leaders and those in positions of authority within the SBI, to have tough guidelines for allowing members in. It would be a wise point for others to be aware of anyone who may try to come in and then cause confusion and dissension. The CIA has been known to do that in other UFO organizations. They are masters of deceit to be sure and very Plutonian. Since they have been behind the UFO coverup all these years, it should not surprise you if they do in fact infiltrate the SBI, or try to do so. The SBI will be coming up with some excellent material that the CIA and others would love to have. This combination of planets and angles will also bring out the critics such as Oberg and Klass who shouldn't be wasting their time and whoever's money pays them to knock UFO's and groups like the SBI. But nonetheless these kind of people will creep out of the woodwork as they have in the past to do their best to discredit the SBI. Actually it only adds the spotlight more to the SBI. We will love it!

Uranus in Scorpio makes a semi-sextile to both Pluto and Neptune. Now the semi-sextile is a minor aspect but still favorable. It must be noted that the three outer planets Uranus, Neptune and Pluto have a mystical and magical quality and that since they move so slowly in the sky, that they effect generations more so than just individually. These three outer planets have been spaced about 30 degrees from each other from January 1978 to December 1979. It basically means that anything or anyone being born during this period has a rather magical quality to their personality and has the easy usage of these energies to their advantage. Uranus means change and revolution and it is the ruler of the Aquarius Asc. so it clear that this group is different and again will stand out above other groups. This planetary combination adds a great deal to their (SBI) scientific methods and probably they have the most sophisticated equipment and resources at their disposals over and above any other UFO organizations.

Neptune in Sagittarius is, along with Venus, the most elevated planet in the chart and that gives the SBI a mystique and an ability to discover things that other people could not. They will, without a doubt, be very attractive to many people and yet they may not always be understood. The SBI will and probably already has it's enemies who will slander them and try to undermine their objectives. For the one aspect that must be carefully watched is the square of Saturn in the 7th to Neptune in the 10th. These are two house of relations and so there will be those who will infiltrate the SBI in very devious means. It should not be a surprise to read this because the SBI stands out as a powerful group and that means that the dark forces who have been suppressing the information about UFO's will definitely be doing their best to stop the SBI. But unfortunately for those deceitful and insecure dregs of humanity they will have a most difficult time if not impossible of trying to even put a dent into such a wonderful group that speaks the truth and is not afraid.

And finally in the description of the elements, the SBI has five planets in the element of Earth which make for practicality, determination, stubbornness and groundedness. Next three planets in the element of Fire which makes for enthusiasm, great faith in themselves and a strong will power. Two planets are in Air and that means communication to a certain extent. Finally one planet in Water which is lack of emotions and that seems to be quite correct for such an organization as the SBI for they are hard hitting and just want the facts.

Finally, in summation, it may be said that the SBI is a most unique organization with the will, ability and energy to achieve their goals extremely well. They have many valuable qualities that make for a winner. It is refreshing to see such dedicated and able people go for the truth. The SBI will definitely make many valuable contributions to the mysteries of U.F.O.'s, and many Earth people (especially in the U.S. of A.) will be thankful that such a group exists. And if there is a Galactic Federation out there, I'm sure that they will be glad to see such a group as the SBI trying to make for understanding between us and them. It may also be a possibility that the SBI may be involved in making contact with aliens from space which could turn out to be absolutely fantastic. That would be a far cry compared to the edict from the Air Force to bring down a space craft any way possible including shooting them down. It is time that this planet unlearned the ways of war and violence. The SBI is leading the way to truth and peace.

Here I want to give special recognition to Jim Fillow and Pete Mazzola, and those connected to them who all had the concept of the SBI and went ahead and did something about it. It is amazing to me that these people all have regular jobs and still have the energy and time to create such a group as the SBI. That is definitely dedication to the cause of truth. Since the first time I have met these two distinguished men, I have been excited to be a member and investigator with the SBI. It is exciting to know them for they are my kind of people. I did not mention their names in the chart interpretation, for the SBI is all of you and I but I did want to make a special acknowledgement of Jim and Pete.

In future articles I will have more to say about planets and the subject of Astrology. This is my favorite subject and I wish to make Astrology more clear to our readers instead of giving the same old trash that is written in magazines and newspapers. Astrology is a science and one cannot speak of it in general terms, i.e. what's your Sun Sign. There is more to it than that and I'll speak of that the next time.



THE S.B.I. INTERVIEWS JEROME EDEN

Editor's Note: S.B.I. Consultant in Orgonomy, Jerome Eden, clarifies his position regarding UFOs, the scientific discoveries of the late Dr. Wilhelm Reich, and why he feels that knowledge of Orgonomy is so important to the future of planet Earth.

S.B.I.-- When did you first become seriously involved in the study of UFOs? And have you ever personally seen any UFOs?

Eden:--More than a quarter-century ago my wife brought home a copy of Harold Wilkins' Flying Saucers on the Attack. It scared me so much I threw the book into the incinerator! I don't know what was worse--facing my fear of UFOs, or facing my wife's wrath. I think I have grown up considerably in the past 25 years. However, there are still many people who would prefer to incinerate the entire subject of UFOs. It is a frightening subject, especially if one believes as I do that our outer-space visitors may be hostile. As to observing UFOs, I have seen many of them, from New York to Alaska. One hovered directly over my wife and me in Monticello, N.Y., the same week that Betty and Barney Hill were picked up. I have also seen many in North Idaho where I live. In 1971, a UFO zapped me with a lightbeam that put me to bed for a week.

S.B.I.--Would you give us some details of that particular incident?

Eden:--I was conducting DOR-removal operations with my Reich Cloudbuster. That is an apparatus invented by Dr. Wilhelm Reich to clean the atmosphere of the toxic, exhausted energy given off by the propulsion of UFOs which I have described in my book, Planet in Trouble. Shortly after concluding this operation, I stepped outside to observe the skies again. It was winter, darkness was falling. Because of the strong infestation of DOR, I suspected that UFOs were in the area. Well, I hadn't taken more than a dozen steps from my back door when a tremendous light exploded in my face--like a gigantic flashbulb going off. I could distinctly see a pulsating UFO between me and the mountain range about 7 miles away. I called to my wife to bring the binoculars and we watched it as it moved slowly away, still pulsating, until it moved behind the mountains. The mountains glowed briefly, lit from behind. Then there was nothing.

Ten minutes later my eyes were severely bloodshot. I developed a terrible headache, and later, a high fever, chills, dehydration, nausea and diarrhea. I was sick for a week.

S.B.I.:--Do you think the UFOs were observing you because of your work with the Cloudbuster?

Eden:-- Yes, definitely. The Cloudbuster draws vast amounts of cosmic-orgone energy, atmospheric energy discovered by Reich. And since the UFOs apparently use this energy in their propulsion system, they are alerted to changes in the atmospheric energy. I, and others with me, have observed as many as ten or more at a time flying over the area during Cloudbuster operations.

S.B.I.: Perhaps we ought to give our members a brief background of what it was that Wilhelm Reich discovered and why you consider his work so important for UFOlogy.

Eden:--This is a very broad and deep subject. I'll try to be brief. Wilhelm Reich discovered what he called "orgone" energy, or the Life Energy of Man and his planet--the substratum from which all other energies are derived. Orgone energy is mass-free, primordial, pre-atomic energy, the energy responsible for creation of matter and for life. How he discovered this energy, and the scientific proofs for

its existence were published by Reich and other scientists over a period of some 30 years. Experimental proof can be found in his basic work, The Cancer Biopathy.

S.B.I.:--The FDA banned and burned most of Reich's published works-- isn't that correct? And Reich himself was imprisoned in a federal penitentiary where he died in 1957. That seems incredible.

Eden:--Incredible, but true. However, many of his works have been re-published. I would suggest that the interested student begin with his Selected Writings as well as his The Cancer Biopathy.

S.B.I.:--Where can you get his books?

Eden:--Any good bookstore carries a copy of Books in Print. Just look up Wilhelm Reich in Books in Print, which will list his books, the prices, and publisher. The bookstore can then order what you want. Other sources are my own books: Orgone Energy and Planet in Trouble, as well as the scientific journal, The Journal of Orgonomy, published twice a year by Orgonomic Publications, Inc., Box 565, Ansonia Station, New York, N.Y. 10023, at \$15 per year.

Reich was the first scientist to conduct actual field experiments regarding UFOs--that was back in 1953-54. These experiments proved that UFOs were pouring a kind of cosmic "slag" into our environment. Reich termed this exhausted energy "DOR", or Deadly ORgone, energy that is toxic to life, that lacks oxygen and water, and is also associated with high levels of radioactivity. DOR can be seen in the skies as blackish, shreddy "clouds," similar to anti-aircraft flak. They rob the atmosphere, soil, plants, rocks, and all life of moisture, and are the principal cause of planetary desert development. Reich invented the Cloudbuster to rid the skies of DOR over his laboratory acreage near Rangeley, Maine. He concluded that the presence of DOR was a certain indication of the presence or past-presence of UFOs. And, after years of my own research with the Cloudbuster, I must agree with him, as disturbing as these findings are.

S.B.I.:--Do you think the UFOs are deliberately pouring this DOR into our atmosphere to harm us? Or is the DOR merely an "accident"?

Eden:--I can't believe that DOR and desert-development are merely "accidental." Given the high technical intelligence of these spacemen, who apparently know all about orgone energy, one can only conclude that they know what DOR is and what it does to our planetary life. When Reich cleared the desert skies near Tucson, Arizona, of the DOR infestations, UFOs repeatedly poured the DOR back into that region. That was deliberate! Reich was forced to turn his Cloudbuster upon the UFOs and disable them!

S.B.I.:--You mention in your book, Planet in Trouble, that the U.S. Air Force was deeply interested in Reich's UFO research. Why then didn't the U.S. Air Force, or at least some representative, speak out at Reich's trial when he was fighting for his life?

Eden:--That's not an easy question to answer. You have to understand that the entire UFO subject has a top-secret classification even higher than the H-Bomb. All major governments are presently playing the same espionage game: They say "officially" that UFOs don't exist, while thousands of their top brains are feverishly trying to solve the secret of the UFO-propulsion system. Each wants the power. They want to use it for military supremacy; but they will never unlock that secret until they begin to comprehend the functions of orgone energy. And no one who is mechanistic or mystical can fathom the laws of orgone energy which obeys functional laws, unknown to classical science. That is why no one spoke up for Reich. The Soviets did everything possible to steal Reich's secrets, while simultaneously stating he was "crazy,"

so that no one would take Reich's discoveries seriously. They used the exact same tactics when they stole America's A-bomb secrets. I have received a half-dozen inquiries from Soviet scientists requesting information about my work in Orgonomy or Reich's work; but I never respond.

S.B.I.:--Wasn't there a top-level Air Force conference called to discuss Reich's disabling of UFOs?

Eden:--Yes, I wrote up that incident which was published in The Journal of Orgonomy. It was titled, "Reich's Contact With the U.S. Air Force." That occurred in 1954, when one of Reich's closest associates held a conference with top-level ATIC personnel--a conference which was, by the way, called by General Harold Watson--to discuss Reich's use of the Cloudbuster on UFOs. There is no doubt in my mind of deep Air Force interest. And now, some 25 years later, we know from the excellent work of Leonard Stringfield that the Air Force had several UFOs and their spacemen occupants under wraps at secret installations. Those UFOs had crashed! That's why General Watson was so feverishly interested in Reich's research. Conventional weapons have proven absolutely useless against UFOs. Yet Reich could make easy contact with UFOs through his invention.

S.B.I.:--Reich was ridiculed, harassed, derided, and finally destroyed. Do you think he threatened too much of the present social and political structure?

Eden:--Definitely. Governments do not burn books written by quacks; or throw bs-artists into penitentiaries. Reich's work threatened first all the fascistic, authoritarian power-blocs throughout our globe, both the Red Fascism of the Soviets and the Black Fascism of the extreme right. His discovery of a freely available cosmic energy--with which, incidentally, he ran electric motors--was simply too much for the oil and chemical interests. Also, and most important, mankind, as a species, is simply too sick to use his work rationally. We must ask ourselves why our best scientific minds, over the centuries, never saw, or identified, or recognized an atmospheric energy that is right before everyone's eyes! Why did they discover and use instead nuclear energy--the greatest destructive force our world has ever seen? Why do people, "ordinary, nice human beings," elect an Adolf Hitler or a Khomeini, and kill a man like Jesus Christ or Wilhelm Reich? These are important questions which must be faced. If anyone wants to begin to understand this crazy behavior he should read Reich's The Murder of Christ.

S.B.I.:--You've been publishing material on or about Reich and his work for many years now...

Eden:-- Since the mid-1950s.

S.B.I.:--Have you noticed any change in people's views toward Reich and his discovery of orgone energy.

Eden:--Yes, there has been a gradual change, thanks to a very few people, like Dr. Elsworth Baker who worked with Reich for many years and who edits The Journal of Orgonomy. His excellent book, Man in the Trap, has recently been published in paperback. I recommend it highly for all people who want to understand human character structure, what motivates us. (The book is available from Orgonomic Publications, Box 565, Ansonia Station, New York, N.Y. 10023, \$7.95, postpaid.) Dr. Baker actually witnessed Reich's disabling of a UFO, which he described in his Preface to my book, Planet in Trouble. There is now another excellent scientific journal on Orgonomy being published in Italy. And courses on Reich's life and work are being conducted by Professors Paul

Mathews and John Bell--as well as several outstanding scientists-- at New York University and elsewhere.

Still, however, very little is being said or published about Dr. Reich's crucial UFO research. That's still considered "too far out" for most people to touch. I believe I am the only one who has consistently espoused and advocated Reich's UFO research and findings.

S.B.I.:--Yes, we here at S.B.I. are familiar with your publication, EDEN BULLETIN. How did that get started?

Eden:-- Like most of what I have done in Orgonomy, it started because I was obstructed! Mainstream UFOlogy refused to consider Reich's work seriously. My articles were returned. They wouldn't review or even mention my books; or, if they did mention Reich or me it was only to be ridiculed. So I began with a modest newsletter, sent only to the scientists working in orgonomy. This was later expanded into my Bulletin, which now goes to about 14 foreign countries, although our readership is relatively small. EDEN BULLETIN is read by the relatively few people who can tolerate facts without throwing them into the incinerator or threatening the writer with mahem. My readers either drop their subscription after the first year, or, if they've got some courage, they stick with me. A recent issue focused upon the connection between Bigfoot and UFOs, also cattle mutilations and UFOs. Most people don't want to read such upsetting material. They prefer to believe that UFOs, like the Communists, just can't be that bad! A.S. Neill once wrote me saying, "You sound like a bloke who loves an uphill fight." Well, it's been a damnable "uphill fight" for twenty-five years now.

S.B.I.:--Do you think that mankind will ever come to recognize and use Reich's discovery of the Life Energy?

Eden:--If Life on this planet is to survive, we will have to learn to comprehend the laws of the orgone. But that will take a new breed of human being--a creature capable of love, not hate; a creature who is in contact with the laws of Nature and Nature's God; a creature who is willing to fight for truth and fact, not for deceit or falsity; a creature motivated by honesty, justice, and a reverence for life; a creature who places honor above greed, who reveres the wise man above the wise-cracker; a creature who distinguishes between what is healthy and what is sick behavior; a creature who would rather die a free man than live as a slave. Where does one find such a creature?

S.B.I.:--Do you believe that the DOR-infestations, which you mention so frequently in your EDEN BULLETIN, are contributing to much of the chaos presently seen around the world?

Eden:-- Yes, there is a definite relationship between atmospheric DOR and "DOR-ized" human behavior. The Earl of Clancarty referred to that relationship in an article he published in Saga Magazine some time ago. How can we raise "healthy" people in a "garbage dump"--and our globe is rapidly becoming a cosmic garbage dump.

S.B.I.:--What then do you recommend?

Eden:--What I've always recommended. Wake up! Start studying Reich as if your life depended on it; because it does. Reich gave us the seeds, but the soil has been ruined. The seeds are spurned, or they simply can't take root. People are frantically chasing after illusions, gods, mystical "saviors," or power-drunk Caesars. Meanwhile, our common enemy from outer space must be laughing his head off at us crazy Earth-people. We fight each other; we kill each other; we despoil our planet; we ruin our children; we can't distinguish between true gold and garbage.

S.B.I.: What about the Reich Cloudbuster? In your book, Planet in

Trouble, you make specific suggestions for the military use of the Cloudbuster against UFOs.

Eden:--Yes. But the danger of crazy people using the Cloudbuster is quite real. There are many irresponsible people using a Cloudbuster, which, as you know, can cause great havoc to our weather. I know of one case where a nut practically wiped out a Texas town with a Cloudbuster. What reasonable man would dare to perform major surgery after reading one article or one book on surgery? It takes years of hard work and study to use a Cloudbuster responsibly. In the past ten years I have worked with many people who thought they wanted to learn how to use a Cloudbuster. Everyone screwed it up! I now require the most stringent requirements before I will attempt to train any potential Cloudbuster candidate. First, they have to demonstrate a structure (I am talking about their physical musculature and contact with orgone energy) which is mobile enough to work with the energy. Second, they must study with me for at least two, sometimes three, years. Third, they have to evidence great courage and the utmost responsibility. Fourth, they must have a thorough working knowledge of Reich's work and duplicate most of his basic experiments. I have one young fellow now who might make it through the entire course. Most don't. It's simply too tough. As Reich said, Only the right man will do the right thing; the wrong man will always do the wrong thing.

S.B.I.:--You were the first Reich Cloudbuster operator to be licensed under regulations of the National Oceanic and Atmospheric Administration as a weather-modification operator, isn't that right?

Eden:--That's correct. But NOAA doesn't take this work seriously. They prefer to spend millions on cloud-seeding experiments that often harm the atmospheric pulsation and, eventually, contribute to further drought development. Someday--and I hope soon--new laws must be written to regulate planetary Cloudbusting. Weather-modification cannot be localized. The planetary orgone-energy is a continuum. That's why I make such rigid demands upon my students. We're dealing with the mightiest power known. It is not something to toy with. You can do great damage not only to towns, cities, homes, livestock and crops, but you can kill yourself through "energy overcharge" or chronic DOR-sickness. I recently received a letter from a British mother who told me her 15-year-old son was "disappointed" because his Cloudbuster didn't "seem to work." I wonder if she'd let him play around with an H-bomb!

S.B.I.:--Do you think we can learn to use the Cloudbuster responsibly?

Eden:-- If we are to survive, we will damn well have to learn how to use it! Otherwise we will discover our planet has turned into another desert wasteland, like the moon! The signs are clearly in the skies, if we'll just open our eyes and look without running away. The UFOs and their exhausted DOR will force us to use it. I've waited 25 years for the world to grow up to these facts. When their wells dry up, their crops shrivel and die, their cattle drop dead of thirst, maybe they'll start thinking of rainfall instead of oil...

S.B.I.:--And Wilhelm Reich.

Speaking at the public sessions of the convention will be Stanton Friedman, a prominent nuclear physicist; Betty Hill, whose UFO abduction several years ago stunned the nation; Art Ford, internationally known authority on UFO's; Bob Sheaffer, science writer and noted UFO skeptic; Rick Hilberg, famed UFO author and researcher; and Robert Easley, Chairman of the Northern Ohio UFO chapter.

Betty Hill, whose story was produced for national television, will discuss recent sightings and personal contacts, soon to be the subject of a new television production by a major network.

Public sessions featuring the above nationally-known experts will be held on Saturday, June 21st, at 2 p.m. and 8 p.m.

The National UFO Conference is a non-profit organization dedicated to basic research in the area of Unidentified Flying Objects, and reports to its membership the latest sightings and data available on the subject. The organization also audits research done by Government and other bodies on the subject of UFOs, and reports all pertinent data to its membership.

I am writing this letter from the viewpoints as a taxpayer and as a concerned ufologists. In regards to your latest flyer advertising your convention, the headlines states, "500 MEMBER NATIONAL UFO CONFERENCE VOTES TO HOLD ANNUAL CONVENTION IN NEW YORK CITY." This headline represents a blatant erroneous misrepresentation to the intelligence of the general public and my fellow ufologists. This flyer in question is full of erroneous statements that I will point out and prove with evidence herein.

In the first paragraph of the flyer it states, "New York, N.Y., April 25th -- The Board of Trustees of the National UFO Conference today announced that based on a survey of their 500 members, the 1980 National UFO Conference will be held in New York City. _ _ _."

- ★ POINT 1. Your Board of Trustees, which in reality is the Permanent Organizing Committee, consist of the magical nine that you always refer to. As of last year and to my knowledge to the present, there isn't 500 members in the National UFO Conference.

★ POINT 2. No survey picked the 1980 Convention site. The site of the Convention was put into nomination, voted upon and passed by the 51 people that attended last years Convention in Cincinnati. (I have the records of those who attended)

The second and third paragraphs are naturally full of totally erroneous statements.

The seventh paragraph is perhaps the greatest collection of falsifications ever put together concerning a non-active organization. This paragraph insults the intelligence of the general public and especially my fellow Ufologists, of which you claim to be one.

★ POINT 1. The National UFO Conference is not a non-profit organization, unless , either it failed to state so in its revised BY-LAWS of July 1, 1977 or it has since received this stature. I'm sure this can be verified through the Government Dept. of the IRS.

★ POINT 2. Starting with the word _ _ _ dedicated _ _ _ to the last word membership in this paragraph, many erroneous statements were made. I present excerpts from letters and post cards personally written by you to me. These clearly and bluntly tells exactly what kinds of research, what kind of reports and data that the National UFO Conference has been involved in over the years in supplying this data to its membership. Remember, I served as a P.O.C. member in 1978 and 1979, and at no time did I ever receive any of this so-called information on any research that was conducted by the National UFO Conference. (See the attached sheets that I submit for evidence)

It is therefore clear from my knowledge (and records that I have) of the National UFO Conference, that this flyer is full of erroneous statements and perhaps violates a Government Law of Stature in sending an erroneous piece of material through the U.S. Mail. This flyer clearly mis-represents a product in-order to sell something to the general public and my fellow Ufologists. In other words, your building up the National UFO Conference into something that its not, in the hopes that this impressive build-up will draw more paying individuals to your Convention.

As a taxpayer and as a concerned Ufologist, I feel that a retraction of this flyer is in-order and that the real facts be presented concerning the National UFO Conference. (I can help in this area if you need it since I was presented with the history and proceedings of the National UFO Conference when I was a P.O.C. member) Also an apology is in order, to everyone that received that flyer.

If you can present evidence supporting your claims in that flyer, I will personally write you a letter of apology. But if you can't and a retraction isn't made, then I feel that the general public and my fellow Ufologists should be informed of these erroneous claims and why they were made.

5Post Card dated Oct. 13th, 1979.






Youth claims seeing 2 green men from UFO

An unidentified flying object landed on a Malone farm Saturday night and two green men were seen briefly before they disappeared, according to a 15-year-old Malone youth.

Mark Ziegelbauer of Route 1, Malone, said he saw the green men after the object landed on a neighbor's farm.

The "saucer" was first spotted by his father Orville

who was working outside on the Ziegelbauer farm around 10 p.m.

The elder Ziegelbauer called to his son, and both saw the multi-colored lights which Mark said were "kind of low" and "kind of big." He said the lights were "going around" as it went past the Ziegelbauer's new silo and landed in a hayfield out of view.

Mark said he drove over to the area where the object had landed and saw the two green men when he shone the car's bright headlights. He dimmed the lights as the two men put their hands up, he said, and "disappeared somehow" in front of his eyes. Mark did not see the grounded flying saucer, he said.

One of the two men was slightly bigger than Mark, who is 5 feet 7 inches tall, he said. The other was smaller. He was so "scared" he did not notice anything particular about their features, he said.

The object, which was about the size of a "small camper-trailer," Mark said, was not seen when it left by Mark or his father. Mark said they both have seen almost the same thing, minus the green men, once before.

On Sunday, a woman from the UFO Education Center in Appleton came to Malone and spoke with the Ziegelbauers. She also showed them some photos, Mark said.

Mik Thompson, 17, of rural Campbellsport, reported Monday that he saw an unidentified flying object in the Dotyville area about 9 p.m. Saturday, an hour before the Ziegelbauer's sighting.

Thompson said it looked like a big meteor, but added he was positive it was not. He said he saw the UFO as he was driving with a friend along County Trunk W near County Trunk B south of Dotyville.

A NEW YORK man claiming to be abducted by a UFO says he was gifted with strange psychic powers after a bizarre close encounter with aliens from another civilization.

Marc Brinkerhoff, 26, told GLOBE the astonishing story of how he was taken aboard a strange spacecraft when only five years old.

"I was sitting in a large football field near my home in upstate New York. It was twilight, in the summertime, and I noticed a bright light that looked like a star moving across the sky.

"It got larger and looked like it was coming closer. Then I felt dizzy and noticed a strange sensation in and around me, sort of like a buzzing. Then I blacked out."

Marc isn't sure what happened next, but he's positive it was something astounding.

"I didn't remember anything until I found myself on the other side of the field sitting on a hillside three hours later!"

Marc didn't tell anyone about his strange adventure for several years.

"How could I when I didn't even have words for it at the time? I was only five

years old. My parents would've said it was just my imagination. But I know it was more than that."

Marc told GLOBE he had no idea what a UFO was as a child.

"I never watched science fiction movies or read fantasy books," he said. "I was too young for them."

Soon after the remarkable incident he started experiencing psychic flashes.

"During the day, when I was playing or at school, suddenly, brilliant and vivid pictures of landscapes or figures would leap into my mind. They weren't images of anything I'd ever seen on this planet."

Marc also felt a powerful urge to draw pictures of these visions. Several times he was awakened in the middle of the night, tele-

pathically seized by an obsession to sketch these supernatural scenes.

"These sketches may be of the aliens who took me away. Or it's possible they're trying to communicate through me."

Respected UFO investigators Pete Mazzola and Jim Fillow of the Scientific Bureau of Investigation in Staten Island, New York, put Marc through a battery of tests to see if he was telling the truth.

"We regressed Marc to the age of five years old using hypnosis and we're convinced something strange did happen to him," Mazzola told GLOBE.

He passed both a lie detector test and a voice stress test with flying colors.

Prediction

Mazzola said Marc's psychic abilities have increased over the years.

"He predicted a small earthquake in New Jersey recently within 15 miles and guessed its intensity — 3.5 on the Richter Scale — precisely."


The most bizarre proof of Marc's extraordinary telepathic powers occurred on July 14, 1979.

"A few days before I had a dream telling me to go to a certain spot that I sensed was somehow linked to UFOs," he said.

The S.B.I. handed him a map of an area that included a known UFO hot spot and asked him to telepathically pick the location he had dreamed of.

"It was amazing," said Fillow. "Without looking at the map he pointed to the exact spot where UFOs had previously been sighted."

Marc also told the S.B.I. there would be a railroad

nearby.

The trio went to isolated Wanaque reservoir in a wooded area of northern New Jersey, crossing railroad tracks on the way.

"Marc said that at 1:30 in the morning the sky was going to clear," Fillow told GLOBE. "We scoffed because it was pouring rain, but sure enough, the clouds lifted at the appointed time."

Suddenly, two gigantic golden-yellow UFOs swept over a nearby mountain ridge and swooped directly towards the men.

"It was astounding," exclaimed Fillow, a former New Jersey policeman. "The craft moved erratically and made no sound. I've seen lots of planes and helicopters in my day, but these were definitely something else!"

The trio watched the craft dip and soar for two hours until they finally disappeared.

Marc hasn't seen any more UFOs since, but thinks the aliens are bound to contact him again.

"It looks like we're in for a lot of UFO activity everywhere in the near future," added Mazzola.

"Statistics indicate sightings increase every 24-26 months and we're due for them soon."

UFO sighting lures TV's 'That's Incredible' to Escanaba

ESCANABA — With a little luck, a UFO informational program scheduled Tuesday at Bay de Noc Community College could, in fact, turn out to be "incredible."

That's because there is a good chance that the ABC television series "That's Incredible" will have a film crew at the meeting, according to Laura Paterson, a California research developer for the show.

Paterson added that if the film crew cannot make it to Tuesday's meeting, it will be in the area sometime next week gathering information for a feature on the March sighting of a UFO by four area police officers.

The Bay program is scheduled to begin at the college gymnasium at 7:30 p.m. Admission is \$2 and the public is invited.

Also featured at the program will be Jim Fillow and Pete Mazzola, two UFO investigators from New York and directors of the Scientific Bureau of Investigation.

Mazzola and Fillow arrived in Escanaba immediately following the March 12 sighting and said they believed the

report was one of the most important in years.

Also expected to take part in the program are Gladstone police officers Dave Mariin and Mark Hager, who will give their account of the sighting and answer questions. Program organizers have also indicated that David Huckstep and Max Streicher, deputies with the Delta County Sheriff's Department, who also observed the UFO, will attend.

Landsberg Productions creates "That's Incredible" for ABC.

Paterson said somebody in the production company's research development department probably came up with the idea of using the Gladstone sighting after reading news articles.

The idea was then brought to a producer where it was then approved for further development.

Paterson said the company just began discussing using the Gladstone incident last week, and since has been in contact with Gladstone police officer Mariin and New York UFO investigators Fillow and Mazzola for more information.

The production company picked this story for a television feature because "We think it's an incredible story, and that's the format for our show," Paterson said.

She said the Gladstone sighting was considered for telecast because of the validity of the reports. She explained that although UFO sightings take place everyday, a report by four police officers makes the sighting very acceptable.

She said the production company is attempting to prepare this feature for airing by the close of this season, which is expected to end in May.

If the feature is not ready to be televised by next month, Paterson said the show has already been picked up for next year, guaranteeing that Delta County will sooner or later receive network coverage.

The interest is an aftermath of the March 12 observance of an unidentified flying object by four area police officers.

The UFO was observed for almost an hour in the early morning north of Gladstone. It was described as having red, green and blue oscillating lights in addition to an extremely bright white light.

Mrs Alice Bullock, of Maldstone Road, Sidcup, was another with information. Her husband and son heard the noise recently. She heard it a few weeks before.

UFO sightings reported in Oconee

OCONEE COUNTY — Reports of unidentified flying objects (UFOs) may be easy to shrug off when they are reported in far away places such as Australia, but what about when they are reported locally? Not just by one crazed nut, but by a dozen individuals including an Oconee deputy sheriff and a well-known Westminster businessman?

Although descriptions varied somewhat, The Journal has received a number of reports of sightings of an unusual and unexplainable flying object Tuesday night, March 6. Persons in Greenville County also reported seeing the hovering craft, which reportedly had the ability to travel at an incredible speed with little or no sound, according to reports in a Greenville newspaper.

Oconee County Civil Defense Director June Black said he first heard about the UFO from Westminster insurance agent Ben Chastain, who saw the object Tuesday shortly after dark while he was working in his yard. Chastain reported seeing much the same thing that was reported in Jim McAllister's column in the Greenville News Thursday, but Black says Chastain reported the UFO before the News' article came out.

"He told me the same story before the article came out," Black said. "And Ben Chastain isn't the type of person to exaggerate. If he said he saw it, he saw it."

Black has contacted the UFO center in Washington state, which has promised to investigate the sightings.

Oconee County Deputy Sheriff Jimmy Roach also reported seeing the object, along with three or four other individuals who requested their names be withheld. But it appears that Chastain had the closest view of Oconee County's newest mystery.

"I was a doubter before this happened," Chastain said. "I watched Project UFO on television two or three times and then stopped watching it because I thought it was a bunch of bull."

"I sure never thought I'd be the one to see something like that."

Chastain said he was working in his yard at about 7:30 p.m. Tuesday when he looked up to the north and saw a bright light coming over the trees near a field by the Chastain's home. At first he saw a plane was coming, but then realized that the light was too bright to be a plane (Chastain knows because he's a pilot himself).

The round-shaped object, which Chastain estimates was about 12 feet in diameter, was moving very slowly and making no discernable sound. The UFO trimmed the tops of the trees and then disappeared out of sight. Although he was somewhat alarmed, Chastain said he would have gone back into the house but then his dogs "started raising a fit." Chastain looked up a saw the object again, this time coming in from a more easterly direction. At this point the object was less than 50 yards away, and Chastain said the light was so bright that it lit up the entire area.

"Usually its pitch black out there," he said. "But the light was so bright I could see the limbs on the bottoms of the trees."

"It scared the tar out of me, I don't mind telling you."

Chastain said the object's light on the flat, red-colored bottom flashed on and off, as though the object was looking for something. The light seemed to be located inside the red area. The UFO was also able to move upwards and downwards with ease to transverse the uneven terrain near the Chastain home.

After the object had circled the second time, Chastain said it moved away and appeared to land at a nearby electrical substation. Chastain immediately ran to the neighbors, where his wife was, and after Chastain caught his breath, they drove down to the area where it appeared the object had landed. But nothing was there.

Chastain doesn't believe the UFO meant him any harm.

"My son asked me if I called on the Lord," he said. "I told him I didn't need to. I don't believe whatever it was even saw me."

Oconee deputy sheriff Jimmy Roach, his wife and a neighbor also reported seeing the object, but from a further distance.

Roach, who lives just off the Westminster highway near Walhalla, said the object had a very bright light, and was moving too slow to be an airplane. He also said there wasn't any noise. After three or four minutes, the object disappeared from sight.

At about 8 p.m., the Bill Osborne family reported seeing a similar object on Highway 221 in Greenville County. Osborne said the hovering craft had a very strong light that penetrated into the car.

"We watched it hover for a long time in the same spot," Osborne said. "I'd say we watched it for about 30 minutes and then it moved toward the southeast. All during this time there was a very, very strong light that moved about and shined down toward the ground. Sometimes it would shine straight toward us."

Osborne said he and his wife were fascinated by the fact that the object had the ability to stand perfectly still and

then move off at right angles, either straight up or straight down.

The craft apparently "followed" the Osbornes about six miles to their house, and then came in closer.

"As long as it was in the distance there was no sound, but when it got within a hundred yards of the house we began to hear a sound. It was unlike anything I have ever heard."

Osborne believed the object was much larger than described by Chastain — about 80 feet long and 25 feet wide. But the large searchlight and other items including the time, coincide with Chastain's sighting.

The columnist who reported Osborne's sighting also stated he had received similar reports from two other Greenville families during the past two or three weeks.

And Civil Defense director June Black said the recent sightings aren't the only of their type reported in Oconee County. He said about a year ago two local doctors reported seeing a similar object in the mountains near Walhalla. However, the doctors never made public their sightings because "people might think they were crazy."

Chastain said he has also talked to local people who have seen UFOs, but didn't report them because they didn't think they would be believed. But that doesn't bother Chastain.

"I don't care who believes it and who doesn't," he said. "I know what I see when I see it once, and when I see it twice, I'm twice as sure."

2 'Chase' UFOs Over Barnegat

STAFFORD TOWNSHIP — Two women are claiming they spotted two unidentified flying objects over Barnegat Township Tuesday evening.

The UFOs, described by the women as box-like flying ships outfitted with various colored lights, hovered about 200 to 500 feet above homes in a housing development, the two said.

The women, Deborah Rante of Beach Haven West and Julie Stinson of Knightstown, Ind., say they made the sighting on Windward Drive in the Settlers Landing development sometime between 9:30 and 10 p.m.

Miss Stinson is visiting the area and accompanied Miss Rante, who was driving her boyfriend home at the time of the sighting.

Miss Stinson, who claims to have previously seen UFOs in Indiana before, was looking out the car window when she spotted the object first.

"We rolled down our windows to see if they were helicopters or airplanes but they weren't," Miss Stinson said. "They made a humming sound unlike any airplane or helicopter I've ever heard."

While the UFOs were in the area the car's dashboard lights mysteriously dimmed and, static on the radio developed, the women said.

"We followed them and when we speeded up so did the UFOs," said Miss Stinson, 18.

The two watched the UFOs for about 10 minutes before the phenomenon disappeared over the homes.

They returned home and on Wednesday morning called Barnegat police and The Press to report the sighting.

"We figured that nobody would believe us," Miss Rante, 18, said in explaining why they waited until the next day before informing the police.

Spokesmen at McGuire Air Force Base near Lakewood and the National Aviation Facilities Experimental Center in Pomona reported Wednesday that nothing unusual appeared on radar screens Tuesday evening.

"Our control tower reported nothing unusual," NAFEC Public Information Officer Michael Benson said. "It was a routine evening."

However, Benson said the Air National Guard conducted exercises from 7 p.m. Tuesday to 1 a.m. Wednesday.

"I can't say if that had anything to do with it, though," Benson added.

The National Investigations Committee on Aerial Phenomena, a citizens' non-profit UFO investigating agency based in Washington, D.C., said a similar sighting was made by a woman in Pittsburgh, Pa., Tuesday evening.

"She said she saw a craft with different colored rotating lights. It hovered for a while before it took off vertically, she told us," NICAP President Alan N. Hall said.

Close encounters at truck stop counters

STOCKTON — Reports of unidentified flying objects are a little hard to take in this conservative small town even when the reports are confirmed by local police.

"See this," restaurant owner Shirley Havens said to Dennis Jagodzinski, the Stockton police officer who confirmed a UFO sighting last week.

Havens held a paper plate in her hand and let it go, flying-saucer style, toward Jagodzinski.

"Know what it is?" she asked.

Jagodzinski held his tight smile. Before he could answer, Haven said, "It's a paper plate," and laughed hard, stirring laughs from other customers in the C & S Truck Stop.

Since Wednesday, UFOs and other related tales, including cattle mutilations, have been the main topics of conversation in the truck stop. Jagodzinski's CB, radio handle now is Luke Skywatcher, and Jo Daviess County Deputy Steve Allendorf's CB handle has been changed by his friends to Space Cadet.

Allendorf stood with Jagodzinski Tuesday night for 48 minutes as they watched something they can't explain hovering in the sky.

"I don't know what it was," Jagodzinski said. "But I know what it wasn't. It wasn't an airplane. It wasn't a helicopter. It wasn't a satellite or a weather balloon."

It was oblong with a red light, similar to a round taillight on a car, and the light always was on. The red light brightened in a regular pattern.

Surrounding the red light, the oblong shape appeared to be sectioned into quarters, with the upper left quarter having a white light, the upper right having a blue light, the lower left having a greenish blue light and the lower right quarter having a yellow-orange light, Jagodzinski said.

When the red light in the middle pulsated, a light in the outside portion of the object would dim and an adjacent light would brighten, in clockwise pattern, he said.

The UFO was reported to the Stockton Police Department at about 11:45 p.m., and Jagodzinski drove about a mile east of town, to U.S. 20 and Illinois 78 for a better view of the object. Deputy Allendorf heard police radio traffic about the UFO and met Jagodzinski.

"We watched it for about 40 minutes together," Jagodzinski said.

Warren police officer John Roth heard the radio traffic and drove to the south edge of town to look south for the UFO. He saw it but then turned back to Warren.

"He didn't want to get involved," Jagodzinski joked.

The UFO hovered in the sky, moved to the north-east, moved to due east and back to the northeast about four or five times, Jagodzinski said. It moved slowly, and then it moved straight east and upward until it was out of sight.

In addition, the radio transmissions on police channels that night were far from normal. Jagodzinski said he was able to communicate with Knox County squad

car three, about 150 miles away, on a radio which normally is only good for up to about five miles.

Truckstop owner Havens said drivers coming in that evening reported making communications with CBers in Alabama, and she said her television and some of her neighbors' have been on the blink since Tuesday night.

Havens' ribbing of Jagodzinski is good natured. It has to be. The night after Jagodzinski's sighting, Havens said she watched a UFO as she drove from Lena to Stockton.

And about 12 years ago, Havens said, when she lived east of Stockton near where Jagodzinski sighted the UFO, she spotted another UFO hovering over her brother's neighboring house. Her sister-in-law became afraid when she saw it hovering and didn't hear any noise, Havens said.

"She came to my house and we watched it together through binoculars," Havens said.

After a while, the UFO went higher in the sky, circled a field and went down behind some trees, Havens said. The next day her brother went to the field near where she thought it landed and he found a spot 20-foot in diameter where the tall grass had been burned to the dirt.

The police officers' reports of the most recent sightings have made it seem more credible, or at least less crazy, for others to tell publicly of sightings they've had — recently and way back when.

Farmers in the truck stop alternately tugged at coffee cups and adjusted the bills of their seed corn caps.

Between sips of coffee and jokes to each other about UFOs, they gave Havens the business.

"Where'd you put that bottle, Shirley?" one farmer asked.

"If we could get a little of that maybe we could find a UFO, too," another farmer chided, and the others laughed.

"They just razzle the heck out of me," Havens said. They weren't as hard on Jagodzinski.

"I can dish it out and I can take it," he said.

The rugged geography of this northwestern Illinois county lends itself to story telling. The wooded hills are tucked in between the Wisconsin border and the Mississippi River. There are colorful road names, such as Tiger Whip, Pilot Knob, Irish Hollow, Rocky Hill, Black Jack and Rush Creek.

While the farmers jabbed at Havens and the police officers, they stopped to read a National Enquirer newspaper article about cattle mutilations reported north of St. Louis. Accompanying the story was a picture of a uniformed police chief standing next to his squad car. The story said he thought UFOs and cattle mutilations might be linked.

And, after all, there was a report locally a couple of years back about a mutilated cow, and if a central Illinois police chief thinks they might be related, and local police officers have confirmed sightings of UFOs then, well just maybe . . .

UFO interest rekindled

ESCANABA — Approximately 350 people attended a UFO informational program Tuesday night at Bay de Noc Community College and learned a little more about those flying saucers in the sky.

Featured at the meeting were four law enforcement officers who sighted a UFO over Gladstone during the early morning hours of March 12.

But the big part of the show was Jim Fillow and Pete Mazzola, two UFO investigators from New York who presented the informational program,

including about 150 film slides of reported UFOs.

The two also had on hand hundreds of government documents which they said proved that UFOs do exist, that the U.S. government knows about them and are trying to keep that knowledge from the American people.

ABC's television show "That's Incredible," which was expected to be in the area this week filming a feature on the Gladstone sighting, had to postpone their plans at the last minute.

Mazzola said that a member of the

film crew, which was expected to be here had other commitments, and filming in the area has been rescheduled for around May 12.

In their accounts of the night that the UFO was sighted, the four area law enforcement officers brought up some new information that had not earlier been disclosed.

David Huckstep, deputy for the Delta County Sheriff's Department who viewed the UFO for almost an hour, said he was sure the object was not a conventional aircraft.

Huckstep said when he was in the Air Force he received a secret security clearance, and because of that he was sure "that the government had no aircraft — experimental or otherwise — that could move like that."

Huckstep also said he has learned from an unidentified source that about a half hour after the four officers lost sight of the UFO, for some reason between 20 and 30 aircraft took off from K. I. Sawyer Air Force Base near Gwinn.

Huckstep and fellow-deputy Max Streicher, in addition to Gladstone Police Officers Dave Mariin and Mark Hager, all viewed the object on M-35 north of Gladstone.


It was described as moving in rapid and unconviction "spurts." Reports said that the object traveled at an extremely high speed and made very sharp turns and abrupt ascending and descending maneuvers.

Fillow and Mazzola said the Gladstone sighting is very important because of the credibility of it being observed by four police officers.

Fillow and Mazzola are the international directors of the Scientific Bureau of Investigation, a UFO investigative group based out of New York. The two arrived in the area the day after the March UFO sighting and verified it as one of the most important to take place in years.

They said the government is covering up any knowledge it has of UFOs because it does not want any panic to arise because of the apparent threat to national security.

Another reason officials do not want to release information regarding UFOs is that it would be an embarrassment to the federal government because it is not able to prevent these objects from observing the country, they said.

Four startled police officers in hour-long car chase of an eerily silent, zig-zagging UFO

FOUR police officers have described an unidentified flying object which they watched for nearly an hour flying at speeds and with maneuverability impossible for any known aircraft.

The object, lit at the front with a brilliant clear white light and with red and green lights on its sides, was eerily silent as it made abrupt turns, flew an

erratic zig-zag course and produced phenomenal bursts of acceleration.

It appeared over the small town of Gladstone in northern Michigan about 1 a.m. on a recent night that was cold and extremely clear, giving the policemen an unimpeded view of its weird aerobatics.

Mark Hager and David Mariin of the Gladstone police received a call from a woman who said she'd seen a bright light in the sky and was frightened.

Before they left to investigate, they contacted the county sheriff's office and two deputies arranged to meet them.

Hager described their first sighting of the object: "We had left the office about five minutes and were in the north end of the town when we saw a very intense bright white light coming from the south.

"We stopped the car and got out because it was slowing down and was just overhead. There was no way it was a helicopter or any known aircraft.

"That was one of the things

that baffled us. Had it been a conventional aircraft or helicopter, we would have been able to hear it, but we didn't hear a thing.

"We really couldn't tell its shape or size or how far away it was. All we would see were red and green lights on its sides with a clear white light at the front."

The object started to move away and Hager and Mariin followed it by car to a bluff outside of town where they were joined by deputies Max Steichert and David Huckstep from the sheriff's office.

They took up the chase and Hager and Mariin stayed on their vantage point on the bluff.


Steichert said the object trav-

eled in an erratic zigzag with its colored lights changing in a kaleidoscope fashion. "They appeared to be oscillating and moving in a circular motion, changing color and intensity.

"When the object was orange-red it would descend vertically then rise up again and change to bluish-green and start traveling laterally while occasionally emitting a bright, white light."

The two police cars kept in radio contact and all four officers confirmed each other's observations.

Steichert and Huckstep followed the UFO for 10 miles until they lost sight of it in the densely wooded country. One of their last

sightings was the UFO making an abrupt right turn and rapidly ascending. Hager and Mariin confirmed this rapid ascent.

"The craft didn't have any problem making abrupt turns or moving abruptly up and down," said Steichert, adding "I've firmly believed that UFOs did not exist, but now I'm a believer."

One puzzling feature of the object's flight was that it was not detected by radar.

Capt. Frank Randall, public information officer at the nearby U.S. Air Force base, said: "The only aircraft we have for that night are bona-fide aircraft with which we communicate as part of our routine."

Acting Deputy Chief Carlton Mineau of the Gladstone police force said Mariin and Hager were officers with high credibility. Delta County Undersheriff Roger Good said of his deputies: "If these guys saw it, you can be sure there was something out there."

The sightings have impressed experienced UFO investigators and Peter Mazzola, director of the Scientific Bureau of Investigation, a leading UFO group, said: "This is the most authentic report I've come across in more than 100 investigations of such sightings.

"If the statements had not come from experienced observers they would have been hard to believe.

"There is no way the craft the officers sighted can be explained away as a helicopter or an aircraft as we know them," said Mazzola.

Another UFO studier, Dan Wright of the Mutual UFO Network, said: "A UFO sighting, is usually a brief, momentary thing. This was a lengthy episode filled with impossible aerial maneuvers, so we regard it as highly unusual."

A UFO described in local press reports as being a "large, windowed object what was round and noiseless" appeared March 1978, almost two years to the day before the Gladstone report, less than 10 miles away in a neighboring town.

Top cops probe scary mystery of giant UFO

One of the most terrifying UFO sightings on record and its chilling aftermath is currently being probed by a crack team of police investigators.

During the heart-stopping close encounter, a giant, cigar-shaped object chased two hunters in their car at high speed through a forest after one of them was paralyzed into rigid immobility.

Since the encounter one of the men has retired from his job, his other problems made worse by recurring nightmares and emotional upset. The other has developed uncanny powers of ESP.

"This incident happened on November 4, 1978, and we've been investigating it extensively since," said Pete Mazzola of the Scientific Bureau of Investigation.

Mazzola, a New York policeman, is co-director of the Bureau, which has 1,600 members nationwide, of whom more than half are law enforcement officers.

November 4 was a day of freezing cold in upstate New York, especially around Indian Lake where David Harman, 29, and Anthony D'Ambrosio, 34, had gone to hunt.

About 4:30 in the evening they set up camp. Harman, fearing snow, glanced at the sky — above him hung a cigar-shaped object about 1,000 feet long.

"What the hell . . ." Harman began. He turned to D'Ambrosio, but the big sanitation worker was paralyzed.

Fear made Harman angry. He shook D'Ambrosio roughly and the man tore his gaze from the light.

The men picked up their hunting rifles and ran to the car. Harman started the engine and drove on to a logging road, the needle pushing 90 as he tried to leave the UFO behind.

D'Ambrosio, badly frightened, yelled with relief when a forest ranger station loomed in sight at the end of the road.

Harman and D'Ambrosio babbled out their story to the ranger, who called the state police. When an officer arrived he

asked the hunters to take him back to their campsite. The terrified hunters refused.


"The officer told me he saw a large object in the sky near the campsite," Mazzola said. "He was later joined by three other people who saw three saucer-shaped objects leave the parenthesis and flash across the lake."

Within a few days, both Harman and D'Ambrosio started having chest pains and facial distortion — which a cancer re-

search consultant, called in by Mazzola's group, diagnosed as radiation sickness.

For days after his return, Harman's dog avoided him, sensing a weird change in his master. Harman had indeed changed. He suddenly developed psychic powers.

"We've subjected these men to intensive examinations including voice-stress analysis," said Mazzola. "Our conclusion is that they're telling the truth."

Local group asks:

Is there a UFO cover-up?

"The government has been covering up long enough. The public has a right to know the truth about UFO's!" Strong words. But the man who spoke them, Annadale resident Pete Mazzola, claims to have evidence to back up his statements.

Mazzola is founder and director of the Scientific Bureau of Investigation, a national and international organization headquartered on the Island, that exists to investigate and hopefully solve the UFO enigma.

Licensed as a non-profit scientific research organization by the IRS in January 1979, SBI has a current membership of over 1,300 investigators and consultants, almost half of whom, according to Mazzola, are police officers. Mazzola himself is a 12-year veteran of the NYC Police Department, currently with the Youth

Aid Division in Manhattan.

Other members are scientists, doctors, educators, engineers, astronomers, pilots and retired military personnel who use their expertise to investigate UFO sightings, photographs and artifacts. This is all done free of charge, said Mazzola, as SBI is supported by annual dues and private donations.

Mazzola, who has been involved in UFOlogy for 15 years, working for other, similar groups as a field investigator, believes his organization is uniquely equipped for its work. "The UFOlogists in SBI use the most modern techniques and procedures, and we are coming closer to solving the UFO puzzle," he said. These procedures include documenting statements from witnesses with the aid of voice stress analysis and polygraph tests, using sophisticated laboratory equipment for

the study of soil samples, photographs and other physical evidence, and employing regressive hypnosis to help witnesses remember details of sightings and possible abductions.

In addition to its investigative work, one of SBI's main concerns, according to Mazzola, is pressuring government agencies into releasing UFO data. SBI is, in fact, "in litigation with the U.S. Air Force, Defense Dept., and NASA and has issued a formal petition to the White House demanding that the truth about UFO's be told." Mazzola feels that the government's handling of the "whole UFO thing" has been "full of contradictions, misrepresentations, fraud and coverup."

UFO's became a government concern in 1947, after the first recorded sighting on June 24 of that year. Commercial pilot Kenneth Arnold reported observing nine disc-like objects zig-zagging in the sky over Mt. Ranier, Wash. His description coined the term "flying saucer."

Following this, the U.S. Air Force began a 21-year study, known first as Project Sign, then as Project Grudge and finally as Project Blue Book, an official, classified investigation of all UFO sightings.

Between 1948 and 1969, 12,618 sightings were investigated, and of these sightings, 11,917 were found to have been material objects, such as balloons, satellites and aircraft, immaterial objects, such as lightning, reflections and other natural phenomena, astronomical objects such as stars, planets, the sun and the moon, weather conditions and hoaxes.

Seven hundred and one cases are still classified as "unexplained."

The Project was terminated on Dec. 17, 1969, the Air Force concluding that "no threat to the national security" exists and that no evidence has been found of "technology beyond our own or extraterrestrial vehicles."

Project Blue Book reports were declassified and given to the National Archives. The Freedom of Information Act of 1975 insures that copies are available to the public.

Since 1969, although the government has had no official UFO investigating arm, UFO reports continue to be filed worldwide at the rate of 500 to 1,000 a year. They are reported to the police, the press, local UFO organizations such as SBI, and to NASA, who refers sighters to the National Investigation Committee on Aerial Phenomena, a Kentucky based UFO group licensed in 1956.

Mazzola said that these reports "are only the tip of the iceberg. Most people don't report a sighting for

fear of harassment, or ridicule." Yet times may be changing. A recent Gallup Poll indicated that 57 percent of the population believes in the existence of UFO's, up from 40 percent in the early 1950's.

Who sees UFO's? President Carter reported seeing one in 1973, when he was Governor of Georgia. Astronauts, pilots and military personnel have reported sightings from the sky and from the ground. Civilians in all areas of the country and the world, including Staten Island, have seen UFO's. Mazzola said he first sighted them in Vietnam and again last year over the Island.

There are many well-known, documented cases of unexplained UFO sightings. One of the "most puzzling," according to a Project Blue Book spokesman, concerned Patrolman Lonnie Zamora, who in April 1964, in central New Mexico, said he saw a silvery, egg-shaped object descend toward the ground with a cone of fire beneath it. He then spotted it standing on slender legs, flanked by two small individuals, about four feet tall, wearing what appeared to be "white coveralls." Upon inspection of the landing site, after the craft had ascended and moved off, imprints matching landing gear feet and impressions which could have been footprints were found, as well as signs that the desert brush had been burned. No satisfactory explanation has ever been given.

Another unusual and unresolved UFO case, which was the subject of a TV documentary, is the story of a New Hampshire couple, the Hills, who claimed to have been taken aboard a UFO. The Hills

brought their story to a private UFO investigating agency, and it was learned under hypnosis that Mrs. Hill was able to recall the experience in great detail. She also furnished scientists with new information about space which years later proved to be true. The case has yet to be proven a hoax.

Mazzola is not one to be outdone. SBI is currently investigating the "abduction" of two Staten Islanders, who, while on a hunting trip in upstate N.Y., said they encountered a cigar-shaped UFO 1,000 feet long. After they drove to the nearest Ranger Station to report the sighting, paced all along by the object above the trees, it was calculated that a gap of 15 to 20 minutes existed between the time they left their camp-site and the time they arrived at the Ranger Station.

The men are currently undergoing regressive hypnosis to see if they can remember the details of what happened during that time. Mazzola stated "An encounter seems to have taken place."

Both men had electromagnetic sickness for 10 days after the encounter. One lost his hair and his nails grew long; the other's face became temporarily deformed. And what is even stranger is that their pets became hostile and wild toward them."

Mazzola had advice for anyone who thinks he has

seen a UFO. First, he said, try to pinpoint the location. Take photographs and soil samples of the area if possible.

"Don't call Washington," he said. "You will get the run-around, you might be harassed and put on file." Call the police, who have SBI's number, he advised.

Mazzola issued a warning to would-be practical jokers. In order to rule out hoaxes, SBI gives an individual stress and polygraph tests to prove his credibility. Photos and other physical evidence are sent to staff experts for analysis. Regressive hypnosis may be administered. If, after thorough investigation, SBI concludes that a UFO was indeed sighted, the evidence will be cataloged into its computer system and publicized wherever possible.

SBI details all these procedures in its handbook "Step-By-Step UFO Investigating Manual," available for \$15 to non-members.

Getting back to Mazzola's charge of a 30-year UFO coverup perpetrated by the CIA and government officials, the SBI head claims to have evidence from a "highly-placed confidential government informant" of actual contact with aliens, "who looked very much like the beings in the movie Close Encounters." He also says he has been told that the government has films

showing aliens taking soil samples from the Earth, autopsy reports on aliens captured 25 years ago, fragments of UFOs and taped conversations between aliens and government officials.

"It seems that even the President may be a victim of his own government," charged Mazzola. In 1977 President Carter asked NASA if it would be prudent to reopen UFO investigations. NASA concluded that it would not be, and the matter was dropped. "Yet the reports kept coming in, so many, that in 1978 the U.N. opened UFO debates, which were "canned by the U.S. delegates," according to Mazzola.

Mazzola believes that the government is "covering up the truth about UFOs" in a bid for world power and a belief that the public will panic if the truth were known.

"I think it's time Washington gave the American people a vote of confidence. We have not panicked through 200 years of wars, natural disasters, economic catastrophes and international crises. We are ready."

He concludes that if all the UFO investigating agencies merge, combining their expertise, dedication and clout, the government can be pressured into releasing the evidence, "which clearly proves the existence of UFO's and shows we are not alone."

'Strange lights' over Essex

ESSEX COUNTY STANDARD, Colchester, England - March 2, 1979

SCIENTISTS have scotched rumours linking the geese deaths with a flood of UFO sightings in the area.

All this week, the Standard office has been inundated with callers reporting seeing "strange lights" in the skies to the east of Colchester.

Among those who say they saw the UFO is assistant borough planner Mr Ted Gittins.

Like all of the spotters, Mr Gittins, who lives in Francis Street, Brightlingsea, made his sighting on Sunday evening at about 8 pm.

"I was just going into a restaurant in Colne Road with my mother and son when we saw it," he said.

"It looked like four medium bright stars in a diamond shaped formation moving fairly slow from the east.

"Whatever it was it could not have been an aircraft. As well as myself and those who were with me, at least four other people stood and watched it. I have never seen anything like it before."

Mr Michael Hester, of Luxton Road, Alresford, was driving home with his wife and children that night when they caught sight of the UFO.

"We were driving along the Colchester bypass when I saw two fairly large white coloured brightly lit objects moving over Greenstead towards Clin goe Hill," he said.

"It seemed quite high up in the sky and appeared to follow us before we lost sight of it."

And observant schoolboy, 12-year-old Julian Appleton, made a diagram of the object after he saw the lights from the window of his Drury Road home that Sunday evening.

The drawing shows two large lights and two smaller lights in a diamond shape which he says was moving "in an easterly direction."

Many more reported sightings have come in from members of the public including amateur astronomers and aviation fans.

Mr Roger Diggings, of Colchester, saw the object with his wife Christine while on his way to a dinner engagement in Brightlingsea.

"I have studied aviation as a hobby for many years and it certainly was not any conventional type of aircraft," he said.

A spokesman for the Ministry of Defence said: "These things can usually be explained by odd meteorological conditions or civil aircraft activity."

UFO sighting changes local couple little

There have been no major changes in the lives of Mr. and Mrs. John Pozdro since their sighting of a group of unidentified flying objects the evening of March 6.

"We're just exactly the way we were before the experience," Pozdro explained Saturday afternoon. "I guess perhaps some people felt that because we made the sighting there would be something new and different in our lives, but

that hasn't happened. We saw something special, at least to us, just one of those things. I guess. It's still unexplained. We had some contacts from people about it for a day or two, but then things went back to normal."

Pozdro, a Kansas University professor of music theory, and his wife, Shirley, were walking near their home at 713 La. about 8:10 p.m. the evening of March 6. The

weather had turned pleasant after a long siege of winter and they were "getting some fresh air and walking our dog." Suddenly they both spotted about eight starlike objects traveling in a V-formation from east to west, high in the sky and at a high rate of speed.


Pozdro said the sighting lasted for about five seconds, then the formation dropped behind the horizon. Informed

by police that there was a Washington number to call, they telephoned what proved to be the UFO Reporting Service in Washington and were informed that such phenomena are fairly common and can be attributed to one of two things: either vehicles from outer space or time travelers. "There is no total explanation that we have," a spokesman at the UFO Reporting Service told

the Journal-World the next day.

"We had some contacts at first and heard from a number of people we know," Pozdro said, "but it soon died down and we haven't had anything unusual happen since. I was a skeptic about the UFO phenomenon before this happened, and I still have doubts about some of the things that people claim to see or experience. But I'm not so certain now as I was before. We're just chalking it up as an experience that was very interesting and intriguing and letting it go at that. We know what we saw; we just aren't sure what it was. And that's about as far as we can take it."


