

WILHELM REICH AND THE U.S. AIR FORCE

Introduction--

THIS ARTICLE is an amplification of the original article, "Reich's Contact With the U.S. Air Force," first published in The Journal of Orgonomy (May 1975) and in EB:2,4 (Oct. 1975).

More than a quarter-century ago, Wilhelm Reich was forced to focus his attention upon unusual events occurring in and around his laboratory in Rangeley, Maine, following his "Oranur Experiment." In that experiment he subjected a minute amount of radioactive material to high concentrations of orgone energy. The results proved nearly disastrous, as the normally benign atmospheric-orgone energy was driven to highly dangerous states of excitation, affecting everyone who participated. (Cf. Reich's The Oranur Experiment and Eden's Orgone Energy and Planet in Trouble.)

To make matters worse, blackish toxic clouds (which Reich termed DOR clouds) began appearing in armadas over his laboratory-estate, Orgonon. A blackish, material substance, Melanor, fell from the skies, blackening the rocks, and causing emotional & physical misery to the living. To combat this deadly intrusion into the environment, Reich invented his Cloudbuster or DOR-Buster, which functions according to the law of reversed orgonomic potential: drawing atmospheric-orgone energy from the weaker energetic system (clouds, atmosphere) to the stronger orgonomic potential in water.

It was during this period that observers, including Reich, spotted strange craft passing over or hovering around Orgonon. DOR-infestations worsened. DOR lacked oxygen & water, & was also associated with high background counts on the GM-counter. Repeatedly, Reich was able to draw off the DOR with his Cloudbuster and thus revivify the atmosphere.

What connection, if any, was there between the DOR-infestation and the strange silent craft over Orgonon? DOR had a slow but relentlessly parching effect upon atmosphere & soil. When these UFOs appeared over Orgonon, the DOR-situation appeared to worsen considerably. Finally, on May 12, 1954, around 10 p.m., Reich conducted an important experiment. He pointed his Cloudbuster at a hovering UFO and began withdrawing atmospheric energy from it. Reich describes this stunning event on the trial record, under secret code: "OROP DESERT Ea":

During this hour men on earth saw for the first time in the history of man and his science two 'Stars' to the west fade out several times when cosmic energy was drawn from them. The shock of this experience was great enough not to repeat such action until October 10, 1954....

Easy contact was made on that fateful day with what obviously turned out to be a heretofore unknown type of UFO. I had hesitated for weeks to turn my cloudbuster pipes toward a 'star,' as if I had known that some of the blinking lights hanging in the sky were not planets or fixed stars but SPACE machines. (Planet in Trouble, p. 195.)

In effect, Reich had succeeded in disabling UFOs!

Reich later proved the connection between UFOs-DOR-Desert development in his desert-reversal research near Tucson, Arizona, in 1954-55, described so vividly in his last published work, Contact With Space, and in my own book, Planet in Trouble.

What I intend to focus upon here, however, is the single question: WAS THE U.S. AIR FORCE SERIOUSLY INTERESTED IN REICH'S UFO RESEARCH?

During the court trial against Reich conducted ostensibly by the FDA, powerful political and financial interests, effectively organized & mobilized by the Emotional Plague, sought to destroy Reich and his research. They succeeded in banning & burning his published work, and Reich did die in a federal penitentiary in 1957. Nevertheless, the crucial truth & fact which Reich left to mankind continue to take root. To his slanderers, Reich's keen interest in UFOs was obvious proof of his insanity: "Orgone energy and UFOs do not exist!" The technique of the Big Lie was again effective.

The USAF, however, was handed the herculean task of somehow finding a way to cope with these alien spacecraft which were entering our atmosphere in ever-increasing numbers. Under strictest Government secrecy, the USAF had the incredible job of dealing with an advanced alien technology with no tools, no technology. Reich kept the USAF advised of his UFO research all along the way, while the Air Force was in the painful position of total impotence and silence imposed upon them. "UFOs and orgone energy do not exist!"

That, in rough outline, is the picture in the 1950s. Now let us move into 1980 with the publication of two astonishing books. The first, Project W.A.S.A. (World Authority for Spatial Affairs) by Major Colman S. VonKeviczky (reviewed in EB:7,2) proves, without question, how serious & urgent is the UFO problem. The second document reached me in late March, 1980, courtesy of its author, Leonard H. Stringfield, titled, THE UFO CRASH/RETRIEVAL SYNDROME*.

In THE UFO CRASH/RETRIEVAL SYNDROME (hereafter UCRS) the courageously persevering Leonard Stringfield, to whom we owe a great debt of gratitude, offers factual evidence that many UFOs and their occupants are under top-level security wraps in the custody of the U.S. Government at various locations in the United States! I consider both VonKeviczky and Stringfield as two of the most intrepid, straightforward, pioneering UFologists in the entire field. VonKeviczky proves the reality, factuality, & gravity of the UFO problem. Stringfield proves, by indirection, precisely why the U.S. Air Force was so willing to establish a high-level, personal conference with Reich or his associate, William Moise, concerning Reich's disabling of UFOs!

No one who has not studied Reich, VonKeviczky, and Stringfield can rationally render any judgement whatsoever on either Reich or UFOlogy. In the light of VonKeviczky's & Stringfield's new & crucial evidence, we can better understand why Reich and his associates were willing to "do or die"; why Wilhelm Reich fought so long & hard, and gave his life, to bring his vital knowledge to the attention of the world. It is no coincidence that one of the largest "UFO flaps" on Earth occurred in 1954, the year of Reich's Cloudbuster and Desert-Reversal research involving UFOs.

WAS THE U.S. AIR FORCE SERIOUSLY INTERESTED IN REICH'S UFO RESEARCH? Read VonKeviczky. Read Stringfield. The answer is clear.

WAS WILHELM REICH'S preoccupation with DOR, desert-reversal work & UFOs an indication that all the pressures of his work, his sequestration, & the FDA & Red Fascist attack upon him, by way of the injunction, were causing him to "slip into paranoia," as some of his critics claim? Was Reich's deep belief that the U.S. Air Force was deeply interested in his UFO research a further indication of this "slip into paranoia"?

These charges have been made in several books, e.g., David Boadella's Wilhelm Reich--the Evolution of His Work (Dell Publishing Co., N.Y. 1975) & by Jerome Greenfield in Wilhelm Reich Vs. the U.S.A. (W.W. Norton, N.Y. 1974). It should be noted that neither of these writers is qualified to pass judgement on Reich's sanity, and, from their scant references to UFOs, it is equally apparent that neither qualifies as a serious UFOlogist. Another factor appearing in both volumes is the eagerness of both authors to believe "the worst" about Reich, the lack of simple trust in the scientist's proven ability to observe, to experiment, to further observe & then to conclude, i.e., to form a correct hypothesis to explain the phenomena under observation.

Boadella's antipathy toward Reich & his deliberate distortions have been carefully & precisely revealed in Paul Mathews' review of his book (Jour. of Orgonomy, V.7, N.2, Nov. 1973). Mathews' conclusions are worthy of note:

Reich's scientific integrity, creativity, and genius, even to the end of his life, need no defense or confirmation from me; nor does his sanity need defense in the opinion of those who were closest to him and in a position to gauge his mental status, character structure, and work capacity at that time.

Thus, writers who have established no credentials in the field of mental health or UFOlogy have overstepped the bounds of responsible journalism to render judgements in areas where they are not qualified. They did not live any of the events they have judged; they did not accompany Reich to the Arizona desert in 1954. Nor is there any indication that either of these writers has ever used a Cloudbuster.

We have, however, every right to "judge the judges" on the basis of their own work, on how they function as journalists, on how they report facts, on what they document or deliberately omit, on how much evidence they give to specific events, on what they consider important or insignificant.

The question of Reich's relationship with the U.S. Air Force is therefore vital to our understanding of Reich's behavior during the last years of his life. This question is also most important for those interested in the UFO enigma & Reich's research in this area. But in order to render a rational evaluation of Reich's behavior, one must examine & weigh the pertinent facts, insofar as they are known. Many events pertinent to this discussion are still unknown. Only recently, for example, the publication of Major Colman VonKeviczky's PROJECT WASA, and Leonard Stringfield's The UFO Crash/Retrieval Syndrome (cf. "References") throw much additional light on this subject.

As our starting point, let us examine the attitude of Jerome Greenfield. Based on his own interpretation of the facts, Greenfield avers that Reich was, for the last six years of his life, legally insane (although court-appointed psychiatrists judged Reich sane) and that Reich's belief in the Air Force's interest in his UFO research was delusional. According to Greenfield, Reich simply misinterpreted events; and William Moise, Reich's associate, also misinterpreted the

events. Let us therefore examine Greenfield's interpretation of events dealing with Reich's contact with the U.S. Air Force:

On the way west, Moise stopped off in Dayton, Ohio, to report to General Watson of the Air Force Technical Center (!) on Reich's work with UFOs. Arrangements had been made beforehand for this meeting, but instead of the general, Moise was shunted to the deputy commander of the base, a Colonel Wertenbaker....Feeling that this was a significant meeting, that at least some breakthrough had been made in interesting the government in Reich's encounter with UFOs, Moise wrote that "The contact with Colonel Wertenbaker was excellent throughout the conference. He was serious, intent, and looked at me while I talked. He was the only one who did. His excitement increased as the report progressed." The FDA file, however, contains a letter sent by Colonel Wertenbaker several days after this meeting to the Directorate of Intelligence of the Air Force in which he writes in part: "General Watson did not talk personally to Mr. Moise, I am happy to say, but I interviewed this person....The information given us by Moise defies description and I'll not attempt to give you the details....The Air Force will do well to avoid any intanglements (sic)....but what is an absolute necessity from the standpoint of good public relations."

And Greenfield sums up this crucially important event with this interpretative diagnosis:

Thus Mr. Moise's interpretation, too, was typical of unwarranted optimism that seemed to influence everyone working with Reich at this time. This interpretation was, too, one of the circumstances that, in the following months and until the end of his life, led Reich to believe that the air force was keeping secret watch over him, and to see in every air force plane passing overhead confirmation of this belief.

Now let us clarify the central issue at stake here. Reich maintained, until the end of his life, that the U.S. Air Force was keenly & sincerely interested in his UFO research, especially in his disabling of UFOs. Greenfield, as well as many others, maintains that Reich's optimism was delusional--another symptom of his deterioration & insanity. We now turn to the recorded facts which will help us to establish whether Reich's or Greenfield's interpretation is correct. To do this, I refer to Reich's Contact With Space, extracting & tabulating the pertinent facts as Reich recorded them. (Cf. Table 1.)

After studying this Table of Events, let us review Greenfield's analysis more closely. Greenfield states, "On the way west, Moise stopped off in Dayton, Ohio, to report to General Watson of the Air Technical Center on Reich's work with UFOs." (Emphasis added.) It is significant that Greenfield omits the word "Intelligence" in naming this center--the full name of which is Air Technical Intelligence Center (ATIC).

Does it make any difference in evaluating the facts to know that Reich's research was discussed with top-level Air Force personnel in a "technical" center, as opposed to the Air Technical Intelligence Center, the focal point for national UFO reports & analyses? After all, what is a "technical center" to the average reader unfamiliar with Air Force UFO involvement? Granted, the omission of this word was

done unconsciously; however, all bias is "unconscious," serving to distort facts, muddy the central issues, or minimize important truths. If the U.S. Air Force did not, as Greenfield opines, take Reich seriously, then continuous distortions & minimizations in the prejudiced writer would only confirm the biased conclusion, regardless of facts! (An even greater minimization occurs in Greenfield's book during the earlier period in WR's life & work, when the author does not question Reich's sanity: The total absence of any mention of Reich's contact with Albert Einstein, or of Einstein's corroboration of the visual & thermal verification of the existence of orgone energy!)(Cf. Jerome Eden, Orgone Energy--The Answer to Atomic Suicide.)

But to return to Greenfield's charge of "paranoia"--Greenfield's only reference to Intelligence involvement is in his excerpts from Col. Wertenbaker's letter to the Directorate of Intelligence of the Air Force. We must note, however, that Col. Wertenbaker was no less a person than the Deputy Commander, ATIC, immediately under General Watson--no mere subaltern in anybody's camp. And it should be pointed out that Col. Wertenbaker's "in-house memo" just happened to end up in the FDA file, indicating: 1) "cooperation" between someone in the USAF and someone in the FDA; 2) "cooperation" between the Directorate of Intelligence and the FDA; and 3) what little regard the USAF had for the "FDA Injunction" and its allegations against Wilhelm Reich, inasmuch as Air Force personnel, despite the FDA Injunction, readily & eagerly sought information (as we shall see) concerning his UFO research.

Someday, if Wertenbaker is still available, historians might wish to question him on this odd communication to the Directorate of Intelligence. Why did Wertenbaker find it necessary to "report" on this meeting in the first place? Who requested such a report? And if "The information given us by Moise defies description," then what is the purpose of Wertenbaker's letter? Moreover, as far as becoming "entangled" with Reich's research, the events prove that Wertenbaker certainly did not take his own advice.

Arrangements for the Meeting--

Now let us return to this meeting between one of Reich's closest associates, William Moise, and top-level Air Force Intelligence personnel. "Arrangements had been made beforehand for this meeting," writes Greenfield. What arrangements? Who was personally involved in these unspecified "arrangements"? Is this merely another "unconscious omission" of the author? For what purpose? Boadella also glosses over the specifics of these "arrangements". According to Boadella, Moise went to Dayton "for a prearranged interview." Neither author, however, feels it significant enough to spell out the precise arrangements involved.

What does it mean to the unversed reader to be told "arrangements had been made beforehand for this meeting"? Somebody greased & oiled the automobile? Moise packed an extra set of clothes & his toothbrush? Referring to our Table of Events, the recorded facts show (and both Boadella & Greenfield were fully aware of them): 1) Moise had telephoned & talked in person with General Watson; 2) Moise had described Reich's disabling of UFOs to this commanding officer; 3) General Watson had personally arranged a face-to-face conference with Moise, stating, "If necessary we could continue the conference until after supper, until late in the evening"; and 4) General Watson asked specifically, "How did Reich know the UFOs were disabled?"

What is the impact that this omission of these facts has upon the

ignorant reader? No mention that Moise had actually telephoned General Harold E. Watson, Director of Air Technical Intelligence, Dayton, Ohio, and actually spoke to him! (Can any "crackpot" stranger telephone an ATIC General & get his ear? Is an associate of a scientist "slipping into paranoia" able to arrange a UFO conference with an ATIC General "until late in the evening"?) And both authors, in whose considered judgements Reich was insane, used the same judgements in "omitting" crucially important "arrangements"! Moreover, Greenfield fails to mention Moise's subsequent confirming telegram and telephone call to General Watson prior to the actual meeting.

The Meeting--

When Moise arrived for the ATIC meeting on Oct. 14, 1954, at 4 p.m., General Watson was suddenly "unavailable." (Watson had previously told Moise over the phone that a group from CIA in Washington was coming to the base.) Instead, Moise was met by Dr. W.H. Byers, an ATIC physicist, who told him he was familiar with the work being done by the Orgone Institute (Cf. Reich's Contact With Space, p. 81). So, uninterested ATIC physicists admit reading the published reports of Reich's Orgone Institute! (Don't bother to check Greenfield's or Boadella's book for this ATIC expression of interest, as it was obviously not important enough for either to mention.)

Dr. Byers escorted Moise to the conference room where Air Force Captain D.M. Hill and a Mr. Harry Haberer, described as a "civilian, working with the Air Force in regard to the history of UFOs," were present. It was here that Moise was informed that General Watson was suddenly "unavailable" for the conference. Angered, and justly so, Moise refused to discuss Reich's disabling of UFOs with anyone except General Watson. Moise stated that, if necessary, he would remain at his motel for two more days in order to talk with the General, and then he abruptly left the conference room.

Here was the perfect opportunity to end the entire matter. An amiable & courteous effort had been made to listen to this "crackpot" stranger regarding matters that "defy description" about UFOs. Col. Wertenbaker's letter to the Directorate of Intelligence later warned of avoiding "any entanglements...but what is absolutely necessary from the standpoint of good public relations." Okay. From the standpoint of "good public relations" the game was over. Three highly placed ATIC personnel were willing to listen to Moise, and Moise had refused. What more need be done if the Air Force is not seriously interested in Reich's UFO research? The logbook will simply read that Moise refused to cooperate & quit in a huff. And the boys in the back-room can laugh off the incident over cups of coffee. But that's not how the matter was permitted to end.

On the following morning, Oct. 15, 1954, Captain Hill telephoned Moise at his motel, apologized for General Watson's absence, and asked if "the Orgone Institute would report to Colonel Wertenbaker, the ATIC Deputy Commander?" The reader is asked to consider the significance of these events. UFO research, including Reich's work, was classified beyond the classification designated for the H-Bomb (Cf. Planet in Trouble, p. 200). Therefore, no "official" interest can be displayed. Yet, Reich has disabled UFOs, and the USAF--as Stringfield's work demonstrates--has several of these spacecraft in custody. Present military technology is helpless in the face of these alien craft which are flying rings around our fastest military fighters. Reich's Cloud-buster-Spacegun offers a positive approach. How then does the ATIC gain information while maintaining an official stance of "disinterest"?

We continue with the factual account documented by Moise in Contact With Space. Moise, after consulting with Reich, agreed to meet with Colonel Wertenbaker, and did so that same morning (Oct. 15, 1954) at 9:30 a.m. Present with Wertenbaker were Dr. Byers, Captain Hill, and our "historian," Mr. Harry Haberer. Moise spoke for nearly one hour, while most of these men took notes, describing the incredible events of how Wilhelm Reich withdrew cosmic energy from UFOs hovering in the night sky over Orgonon, of how these spacecraft dimmed in color, moved from side to side, as if attempting to flee from the power of the Spacegun, and then faded out entirely.

After Moise's presentation, he asked Colonel Wertenbaker if Reich's "Space Equations"--a copy of which Moise had brought with him & showed to Colonel Wertenbaker--might be "sealed & secured" by the USAF for safekeeping, in the event something untoward happened to Reich. Colonel Wertenbaker (who, we recall, advised the Intelligence Directorate "against entanglements") readily agreed to this request, advising Moise "that the Air Force would respect the confidence entrusted to it."

The Air Force Dilemma--

These are the essential facts regarding the meeting between Moise and members of ATIC. Prior to the conclusion of Moise's presentation, Col. Wertenbaker excused himself & left the room. The U.S. Air Force was caught in the middle of critical dilemma. Charged with the air defense of our nation, many fine pilots had already lost their lives to this elusive, technologically superior alien intruder from outer space. Publicly the Air Force must continue to deny the existence of this formidable foe, while government scientists worked frantically to solve the mystery of the UFO-propulsion system, because any nation that cracked the riddle of the UFO-propulsion system would, in fact, rule the skies.

Reich's work was, therefore, of supreme importance to us; in effect, it was--and still is--classified "higher than the H-Bomb," thus placing it beyond the pale of any classification. It is quite conceivable that Wertenbaker's letter to the Intelligence Directorate was itself a "cover" to protect the information for the U.S. Air Force and also to protect Reich. Someone was instrumental in recalling Moise to that conference room--someone who wanted very much to learn about the disabling of UFOs over Orgonon. It should be noted, too, that every branch of the military has its own intelligence-gathering arm, and they often compete with each other. Vying as they do for Congressional dollars, they have good reason to compete with each other.

Furthermore, the intelligence community has many excellent, highly competent & thoroughly dedicated practical career personnel who are cognizant of the fact that all intelligence agencies are vulnerable to enemy penetration. Thus, "telling everything to everybody" is never a good procedure in discussing matters of grave national importance. As an ATIC Deputy Commander whose loyalty is first & foremost to his own service, could Wertenbaker openly acknowledge keen interest in Reich's work?

In view of these documented facts, it is, to say the least, astounding that anyone could not believe the U.S. Air Force was vitally interested in Reich's UFO research. Do ATIC generals waste their time conferring with "crackpots" or "publicity seekers"? Do they suggest conferences with crackpots, "after supper" or "until late in the evening"? Do they encourage such "deluded" behavior by asking leading questions & arranging conferences attended by their

own top-level ATIC personnel? Do they instruct their aides to further abet such "deluded" behavior by telephoning Reich's associate (Moise) after Moise had quit the premises, and inviting him to return to ATIC headquarters for a conference with an ATIC Deputy Commander, an ATIC physicist, captain and "historian"?

No. This was not simply an elaborate hoax on the part of the U.S. Air Technical Intelligence Command--performed as Colonel Wertenbaker's letter suggests in the guise of "good public relations." If public relations was the motive, then why wasn't Moise taken in tow by a public-relations officer, and not by a Deputy Commander of Intelligence?

In the light of this evidence, it appears that Reich had more than ample indication of serious & bonafide Air Force interest in orgonomic research. To believe otherwise is simply inconsistent with the evidence. What is so disturbing, however, is this: Why didn't those in the Air Force who knew the truth about Reich's vital UFO research--why, I ask, didn't these people speak up in Reich's behalf when he was fighting for his very life? It is clear that Reich's innocent faith in American decency & justice, his trust in the U.S. Air Force, and his desire to protect America's national interest prevented him from revealing all he knew about these matters. Reich's UFO research meant the possibility of saving Air Force pilots' lives, of finding a practical approach to coping with these superior alien forces.

Yet the voices of General Watson, Colonel Wertenbaker, Captain Hill, and the "knowledgeable" Dr. Byers (not to omit the "historian," Harry Haberer) were totally, agonizingly.. silent! Reich pleaded "guilty" to the charge of refusing to obey an unlawful injunction designed by Hoodlums in Government to destroy his work, silence him forever, and steal his secrets for a foreign power. He told the Court he had to disobey the injunction. His work was too important to be halted. And so he went to prison, there to be found dead in his cell shortly before he was eligible for release. And not a whisper from Wertenbaker; not a gesture from General Watson; not a word on Reich's behalf from Haberer, Hill or Byers--even though the FDA prosecutors were mocking Reich about his "nebulous super-secrets regarding those crazy UFOs," the very same UFOs that are presently making a mockery of every impotent air force on Earth!

Looking back over events that took place more than two decades ago, I know I have only scratched the surface. Much more is involved--more than Reich published, more than the Air Force dares to acknowledge. Because of writers like Boadella & Greenfield I was forced to reexamine Reich's relationship with the U.S. Air Force, and document Reich's assertions with the historical evidence.

SOLVING THE MUTILATION MYSTERY:

A New Approach

Author's Note: This is a preliminary study which is part of an ongoing investigation. It will be revised and expanded as research uncovers new information.--Dave DeWitt

It is a curious comment on human nature that investigations into "paranormal" phenomena now generally dwell on the unknown rather than the known. By "true believers," astrology is given more credence than astronomy; UFOs are presumed to be extra-terrestrial and benign; ESP and psychic powers are taken as gospel (despite the fact that very little has been accomplished in that field). And when such quasi-science as "Chariots of the Gods" is blindly accepted as fact, we must face the truth: there is a new rejection of science prevalent today in our society.

Likewise, the bizarre cattle mutilations have produced mostly wild speculation rather than logical and scientific investigations. Many people interested in the paranormal, including a few sociologists, are now investigating not only the occurrences of strange phenomena, but also the effect that such occurrences have on the public. They are trying to answer the question of a human nature which, in the most enlightened age of mankind, readily embraces speculation in place of scientific examination. Why do seemingly sane human beings, from farmers to engineers, enthusiastically replace rationality with fantasy? One part of the answer probably concerns the enormous growth and popularity of science fiction, but the overwhelming reason is simple: they want to believe in such things so much that they easily accept

ideas and theories as facts.

The reasoning is this: since rational and scientific evidence has not yet explained such odd occurrences, their nature must therefore be controlled by a "parascience" that we do not understand. Many people desperately want to experience such an exciting event as extraterrestrial visitation, so they create their own reality. In fact, noted UFO researcher Jacques Vallee believes that the UFO phenomena have been embraced by many as a "new" religion, although the UFO cultists exhibit classical religious tenets like belief in an unknown, unseen, yet benign and omnipotent entity. They also demonstrate the classical need to belong to groups of people with similar beliefs. Hence the development of UFO cults which seek to exploit the phenomena which, in reality, after all the decades of study, we basically still know next to nothing about. But people need a religion, need to pray, and I'm reminded of Ambrose Bierce's famous definition of prayer: "to ask that the laws of the universe be annulled in behalf of a single petitioner confessedly unworthy."

The preceding has been stated to illustrate that this writer is not a true believer but very definitely a skeptic. But not skeptical of the existence of mutilations or UFOs--the overwhelming preponderance of physical evidence indicates without question that cattle have been mutilated and that people have spotted unidentified "objects" in the sky. I am skeptical though of nearly every "fact" about the mutilations except their existence. And I am particularly skeptical of the usefulness of current investigations underway, both official and private. I

question the motives and personnel of many of these surprisingly casual and disorganized studies, but more importantly, I question the methods employed in these studies. It seems that there has been an overwhelming effort not to solve the mutilation mystery. This may sound like an accusation of a conspiracy, but it's merely a reflection on the new rejection of scientific methods.

This paper is not a history of the mutilations--that would take a voluminous book. Rather it is an attempt to formulate a new approach to solving the mystery, an approach which takes into consideration my major premises: The mutilation of cattle in western states and provinces are terrestrial in nature, have a logical purpose and method, and can possibly be prevented. Through application of the scientific method, I believe that an answer, if not the answer to the puzzle of the mutilations can be found. The why and the how of the mutilations may already have been solved--but the exact who may take a little longer.

A detective uncovers a clue, then another, and forms a theory about who must have committed the crime, thus solving the case. The investigator has deduced the answer, right? Wrong. The detective has induced the answer, reasoning from particular facts or individual cases to a general conclusion. To use deduction is to reason from the general to the specific, as in formulating a theory about who could be responsible, then finding specific facts or physical evidence to support the theory. Thus the detective induced the answer by relating specific clues to a theory of whodunit.

The inductive method, currently the only one employed by mutilation investigators (and most UFO buffs) has failed to produce any leads at all in solving the mystery. There have been some attempts at the deductive methods, but all they have come up with are the three most popular theories about responsibility for the mutilations, but of course, no specifics. So far no one has completed the deductive process of doing research to find correlating evidence to support any one theory. The three theories, from most supported to least, are:

(1) That UFOs and/or their occupants are responsible, for an unknown purpose, *ufos presumably extraterrestrial.*

(2) That the U.S. government (or renegade researchers from some federal agency) are doing the mutilations for some nefarious purpose such as biological warfare experimentation.

(3) That members of a cult or cults are responsible and the mutilations are part of a satanic "religious" ceremony.

The once popular predator damage theories have now generally been discarded, as have tales of bigfoot creatures, giant pterodactyl-like birds, motorcycle gangs, time travellers, invisible "energy rays" from inside the earth and scientists looking for an eternal youth serum. There is no need to debunk any of the theories which have been offered because they must stand or fall on the basis of supportive evidence. That there is little, if any evidence to support any one of these theories is indication enough that new ideas must be explored. And remember, simply because it is a fact that unidentified aerial phenomena have been sighted in proximity to the mutilations does not prove that the mutilations are caused by extraterrestrial visitors.

Current investigations are being conducted on three levels.

First, the vigilante effort, where ranchers struck by the mutilators have formed patrols to attempt to catch the perpetrators in the act--a noble effort, but one doomed to frustrating failure due to the mobility and technology of the mutilators. Incidentally, the reaction of cattlemen's organizations ranges from indifference and disbelief (New Mexico) to hefty rewards for information (Alberta and Colorado).

The second investigation level is of the quasi-official kind, with the FBI alternating investigating and declining to investigate mutilations (crimes?) on federal reservations like national forests and Indian lands. Information about FBI progress in any inquiries is virtually nonexistent at this time. The other quasi-official investigation in progress resulted from a grant of \$50,000 from the Law Enforcement Assistance Administration to fund a probe in New Mexico. The latest statement as to the progress of this investigation was made recently in a radio interview with the director, a former FBI man whose name is Rommel. Since the summer of 1979, he has looked at about 20 dead cows. None were mutilated. Rommel thinks that "mutilation" is an inaccurate term for the phenomenon. It cost \$50,000 for this?

Finally, there are about a dozen individuals or small groups in North America who have undertaken independent investigations of the mutilations. Their major accomplishment so far has been useful--the collection of data from across the continent by collating and recording reports from the field and various newspaper and magazine accounts. At least two of these investigators have made

significant progress in their research, but have not as yet reached any formal conclusions. Tom Adams of Project Stigma in Paris, Texas has amassed quite a bit of data linking the mutilations to unidentified helicopter sightings. But he told me recently that he was no closer to solving the mystery than when he started and sometimes he feels that a solution may never be found. David Perkins of AMP (Animal Mutilations Probe) in Farisita, Colorado believes that there is a correspondence between the mutilations and known radiation sites (uranium mines and milling operations, reactors and waste disposal sites) but cannot as yet offer a theory as to why there is a statistical link.

All of the mutilation investigators utilize the inductive method of attempting to solve the mutilations mystery by examining individual cases. But very little new information is gleaned from these recent mutes. What we have are simply more "classic" mutilation cases, though with the summer and fall 1979 cases in Alberta, the mutilators seem to be expanding their range. And like the UFO flaps of 1954, 1962 and 1966 the mutilations seem to occur in "waves." These waves occur when a large number of mutilations occur in a particular geographical area over a short period of time. New Mexico and Colorado have already suffered through three or more waves dating since the early '70s and other states such as Montana, Arkansas, Texas, Wyoming and Oklahoma have at one time or another experienced similar concentrations of mutilated cattle, horses and sometimes others.

There is a classic pattern to the waves in both the nature of the mutes and public reaction. A classic mutilated animal is found-- usually a cow, dead in the field, usually fairly isolated from human

habitation. There are no tracks or other animals around the body. Generally the sexual organs have been removed, often the tongue, tips of the ears and tail, the rectum and patches of skin are also missing. The carcass seems to have been drained of blood. The rancher knows that predators cannot perform such selective and delicate surgery and wants to know who or what is butchering his cattle, regardless of the precise cause of death. The sheriff is called. "Yep, it's one of them mutilated cows," he says, and promises to investigate. A vet or brand inspector might take samples. The newspapers and radio and TV pick up the story and the mutilation is headline news, particularly if they've occurred in the area before. More mutilations are discovered over the next few days, often accompanied by reports of bright lights in the sky, mysterious helicopters or other UFO phenomena. A lab reports the first cow died of natural causes. Some organization offers rewards for information leading to arrest and conviction when they should be funding research projects. The mutilations suddenly stop--perhaps the total is twelve in a two county area. The press stops coverage and soon the public forgets--until the next wave. And all the investigators look at each dead cow and say: "Yep, another classic mutilation." After looking at hundreds of cut up cows, you'd think they'd get the message: The mutilations won't be solved by after-the-fact examinations of the carcasses. Because it's not what's left in the bodies that's the clue--it's what's been removed that is.

So the inductive approach has so far failed and we're left with the deductive method. This way initially requires an overall theory of who or what is responsible, then evidence to support the theory. To propose an overall theory we must first examine technology and motive. What person or group has the technology to perform thousands of systematic mutilations over about a million and a half square miles and escape undetected? And why bother? This is no small operation, and technology requires money and know-how. The scope of the mutilations requires instant deployment and rapid transportation, probably with support aircraft. An excellent knowledge of surgical techniques would be necessary, plus sophisticated equipment to drain blood from the carcasses. How much would it cost to duplicate this technology? What does a mutilation cost? Could two of us run out and perform one for a hundred dollars, especially if we used sophisticated aircraft? Very doubtful. A thousand dollars, if we rented a helicopter and all the surgical equipment? Hard to say, but just by using those figures, someone has spent at least \$800,000 or \$8 million to mutilate livestock over the past ten years, based on an estimate of 8000 known mutilations. The only motives such expenditures (and bother) would justify are military, profit or politics.

Wait, the UFOlogists scream, what about possible extraterrestrial involvement? Logically we must eliminate that from consideration because the only evidence we possess is terrestrial in nature. Just because scientists have not solved the mystery of cancer, do we automatically attribute the disease to outer space causes? Provide some extraterrestrial evidence and we'll fall all over ourselves examining it. To repeat: UFOs are simply

unexplained aerial phenomena--and no one has any proof that they from any world other than earth.

Back to motive and technology, who has the money and equipment to plan and execute such operations? Governments, certainly. The U.S. government has many agencies which could be responsible, from the CIA to the Air Force, and it's been in trouble with dead livestock before. Remember the flap over the dead sheep in Utah killed in nerve gas experiments? But to form this theory we need to include motive. Why would the U.S. government risk another Watergate with the clandestine butchering of thousands of cattle on ranches and grazing land all over the continent? Lots of possibilities have been advanced. Experimentation with new weapons is a possibility, including chemical and biological toxins and tests for dispersal in animal bodies. But no one can counter the objection that the U.S. government can certainly afford a hidden, top secret test facility for this sort of thing rather than marauding about the countryside zapping cows. And the thought of a foreign government operating like that in this country and Canada is frightening and hopefully far-fetched.

We'll return to the government later, but just for speculation's sake, what other groups have the money, access to the technology and a possible motive? Well, perhaps some sort of SPECTRE-type operation or cult, but why not stick to the obvious? Big business now owns their own satellites. Certainly large companies have the money and technology to perform operations on the scale of the mutilations, but what about motive?

Just for a moment don't think about government conspiracies or extraterrestrial mutilators. Think instead about good old American values--like profit and greed. Would, say, some large company accept the risks and spend the money to mutilate cattle if there was good profit in it? You bet your scalpel it would! U.S. corporations have proven they will literally do anything to make a profit, including poisoning us and our environment, manipulating foreign governments, conspiring with the CIA, contributing illegally to politicians and using spying, stealing, lying, cheating and other felonies as business tools. Would a few thousand cattle stand in the way of a profit? Hardly.

The theory from which I hope to deduce the culprits is this: the cattle and other livestock are being mutilated as part of an exploration/^{system}used to detect the presence of mineral deposits, and that the mutilators are probably scientists or technicians recovering tissue samples to assist in the exploration process. It is important to point out here that the majority of the mutilations have occurred in the general area of the richest mineral deposits in North America--the Rocky Mountain region of the U.S. and Canada. And minerals, like petroleum, are in short supply. World supplies of copper, zinc and other metals are dwindling and uranium demand is at an all time high despite the protests over nuclear proliferation.

There is an intense search underway for new mineral deposits utilizing new techniques and hundreds of millions of dollars. In 1977 exploration/^{expenditures}for uranium alone were \$258 million, up 50% from 1976. And who is spending this money? Over one hundred large corporations, led by oil companies like Exxon (largest U.S. corporation), Arco, Gulf and power companies like Commonwealth

Edison and Pennsylvania Power and Light. And they must spend the money to find new sources of uranium because traditional exploration methods are no longer efficient. Mining Engineering has observed:

Uranium exploration in the U.S. is currently undergoing a fundamental change. As shallow deposits in sandstones become more difficult to find, new depositional models are envisioned and tested; remote sensing plays a larger role in exploration; pathfinder elements become more important; and innovative, low cost geophysical techniques are employed for deep, rapid and precise exploration.

So to find uranium these days, the mining engineers must dig deeper, which is much more expensive. It is important to have the best possible information before springing for the bucks for a test drilling. "New depositional models" (translate: deeper deposits) are found with new sciences and technologies like geophysics, geobotany and biogeochemistry. Geophysics is the science where techniques of physics are used to study the earth; geobotany is a technique of analysing the siting of plant types or communities as a guide to subsurface mineralization. biogeochemistry uses analysis of organic tissue samples to find evidence of metal content or mineral deposits.

One important geophysical breakthrough was the development of the Airtrace System by Barringer Research, Ltd. It seems that minerals bound to rich organic topsoil migrate upward, into the atmosphere where the Airtrace System, in a helicopter, plane or balloon, collects samples. In 1976 Airtrace was assisting in the location of deposits of mercury, copper, zinc and silver. In

uranium prospecting, airborne radiometric surveys are checked for radioactive anomalies which may provide clues to deposits. Both of these geophysical techniques begin the narrowing process in the minerals search which involves our mutilated livestock.

Geobotanical evidence has led to impressive finds. By analysing multiband photographs and luminescence factors of certain plants, scientists have discovered significant deposits of molybdenum, copper, gypsum and phosphate.

After airborne analysis and geobotany, the next step is biogeochemistry. Literally thousands of plant samples from specific indicator plants are analysed for their mineral content, which is absorbed through subsurface water. Examples of indicator plants are locoweed and vetches for uranium, California poppy for copper, buckwheat for silver. Large numbers of samples are necessary because the area the survey covers is huge, and so if the area for plant samples could be reduced, there would be great savings of time, labor and money. This is the point where livestock enter the picture.

It is known from selenium poisoning incidents in cattle that many metals accumulate in the tissues of animals that feed on plants or drink the water in proximity to areas of high mineral concentration. (Incidentally, selenium and uranium share many indicator plants.) In volume 59 of Science Progress, P.J. Peterson observed:

A very large amount of work has been published on the analysis of mammalian tissues...It is now clear that the concept of "accumulator tissues" exists for many elements, for example the well known accumulation of iodine in the thyroid

and arsenic in the hair and nails. Lesser known accumulators are, for example, tin in the intestine, titanium and aluminum in the lung, vanadium in the hair and bone, zirconium in blood and selenium in the retina of the eye.

It is also known that certain metals accumulate in the liver, various bodily extremities and the mucus membranes. The missing organs of mutilated livestock correspond closely to those used in biogeochemical procedures. In 1971 a researcher named Warren first used the livers of 96 trout in British Columbia to locate zinc-bearing deposits which ran off into the trout streams.

Hints of the continuing use of animal tissue in biogeochemical research surface occasionally. A textbook on such procedures (Reeves and Brooks, Trace Element Analysis of Geological Materials) contains instructions for gathering plant samples for analysis and then ends it with these tantalizing ideas:

Animal material should be deep frozen upon return to the laboratory and kept in that condition until required for analysis. Samples may also be freeze dried and can then be stored at room temperatures for an indefinite period.

What animal material? we want to scream. But of course I didn't expect to find an article in the Journal of Biogeochemistry entitled "Clandestine Techniques for Acquiring Livestock Tissue Samples for Uranium Prospecting," but I did find the following eye-opener in Fredrick Siegel's Applied Geochemistry (1974):

...research into unusual accumulations of elements by plants and animals under varying conditions must be continued.... There is an

ample field of work open for innovative basic research such as the type of investigation made by Warren and his colleagues on trout livers....One may consider the use of animals employed as food and having known and limited geographic ranges for prospecting, as perhaps the sheep of Patagonia or the cattle of the mountainous and difficultly accessible areas of Columbia, by the analysis of some anatomical part before or after the animal enters the slaughterhouse.

Obviously I have not as yet accumulated enough evidence for a real scientific proof, but here's a possible scenario. Since the early 70's there has been rapid progress in biogeochemical techniques but little has been published because such practices would offend animal lovers as well as cattle growers. There is no question that the technology exists to enable scientists to test the tissues of animals that have come into contact with many elements through water consumption, skin absorption or the ingestion of indicator plants. From selenium poisoning incidents alone we know that hooved animals are susceptible to high metal concentrations in their tissues. And the organs and tissues involved are the tongue, blood, lips, eyes, skin, sexual organs, liver and mucus membranes.

The mutilation of cattle can then be viewed as the second step of an exploration process which begins with airborne surveys and concludes with a test drilling. The airborne survey locates a likely area where a certain mineral is suspected. Mobile laboratories are dispatched to acquire tissue samples of livestock, and because the cattle generally have a specific fenced range, it's relative easy to pinpoint a specific area once a positive

indication of the metal has been found. But many tissue samples covering hundreds of square miles must be taken, perhaps causing the waves of mutes mentioned before. Once a certain range is pinpointed, further plant samples can be analysed to narrow the specific area down to the position for a test drilling. If the drilling is also positive, then the prospectors must file a claim if the site is on federal or state lands (except National Parks) or lease or buy the land if it's privately held.

In this scenario the cattle are simply research tools in a larger process designed to bring profit to the perpetrators. The "bizarre mutilations" are then just excellent surgery, perhaps utilizing laser technology, to remove certain organs for chemical analysis. The "ritual" is scientific method and the UFOs are part of the equipment deployed in this research study. And how far can this study reach? Are the mutilators from the research departments of oil companies or the mining industry? Are they part of an independent research group which sells its findings to the highest bidder? Are they protected or assisted by U.S. government agencies? I've mentioned previously that the government would need to have sufficient motive to be involved, and the federal boys don't directly mine or refine valuable minerals, so it seems more likely that the mutilators must have some federal protection. Jacques Vallee has noted in Messengers of Deception that a classically mutilated cow was discovered beside the entrance gate of a NORAD facility in Colorado, apparently dropped from the sky. This and the audacity of "ghost copters" and other serial phenomena causes one to wonder about the vaunted U.S. air defense system, especially in the Rocky Mountain region where virtually everything in the air is tracked by radar. Private

aircraft are often warned if they approach too close to prohibited airspace, and ignoring such warnings around the White Sands Missile range in New Mexico will bring jets from Holloman AFB to escort trespassers away. It is difficult to believe that helicopters or other aircraft can appear with the frequency they did in northern New Mexico in 1975 and get away with it. One classic front page headline of the time in the Albuquerque Journal reads "Ghost Copters in N. NM." One craft over New Mexico as recently as spring 1979 was tracked by radar from Colorado after two Jicarilla Apache policemen surprised it shining a bright light on cows near Dulce. N.M. state policeman Gabe Valdez, who was on patrol south of the light-shining incident, said an unidentified craft, totally silent, passed over his head shortly after the Jicarilla police reported the incident over the radio. Radar confirmed his story that the craft was headed toward Albuquerque, but it soon disappeared from the radar screens. One cannot help but speculate that if some agency was assisting the mutilators, or covering up, it could be construed as acting in the interest of national security, since new mineral deposits could be vital to the national defense effort.

This initial study cannot claim to have solved the mutilations, because we need more than circumstantial evidence. Likewise, even presuming our scenario is correct, it cannot account for all the bizarre cases. It cannot, for example, explain the death and mutilation of livestock such as prize show bulls and race horses in corrals close to ranch houses. In fact, we may never track down the actual individual perpetrators--that will take undercover work and a lot of money. Isn't it ironic that the only funds made

available for mutilations research so far were given to an ex-FBI man who doesn't even believe the mutilations exist? Incidentally, it appears that \$30,000 of the \$50,000 grant is Rommel's salary and the rest apparently is "expense money." A further irony is that the rewards offered by various groups depend on "information leading to arrest and conviction," but there is no money made available to fund an independent investigation to accumulate such evidence. It would be better not to trust the government to investigate the mutilations, for like Project Blue Book's demise, it is far easier to whitewash the subject, sidestep the issue than let the public know what really is happening. This is not to suggest, however, that the government actually knows who is responsible for the mutilations.

My neat theory of the responsibility for most of the mutilations undoubtedly will be coolly received. The notion that common, ordinary profit-mongers are slicing the penises off of bulls instead of tripedal inhabitants of Rigel 2 looking for ingredients for an immortality serum, will not be a popular one for the true believers to swallow. Also, the prospecting theory has some holes, and raises some questions I will attempt to answer.

Q. How are the cattle killed, according to this theory?

A. Many probably were not killed by the mutilators but died of natural causes. Tested samples from mutilated cattle reveal a number of causes of death from tranquilizers to black-leg (*Clostridium bacteria* toxins) and other natural causes. I think most of the animals are found and mutilated after a natural death. This would solve the recurrent vision of silent helicopters chasing cattle all over the range in a kind of ghost roundup and killing them from the air. Remember that the mineral traces are

still present in decomposing flesh. And to those who would suggest that it would be easier and safer to buy cows directly from the ranchers, consider this: the prospectors would prefer the cows in the field, as close to indicator plants and water sources as possible. Once a cow has been located in the field, it would take a brand expert to identify the owner, and remember that in the West hundreds of thousands of cattle roam freely on federal grazing lands. Buying the cattle after roundup would render the animals useless for accurate scientific analysis--the researchers would have no idea of the exact place each cow grazed. It is possible though, and some small amount of evidence has been uncovered to suggest that some of the animals may have had the blackleg toxins injected into them. Other sketchy evidence has been advanced to suggest maybe that microwave technology in the form of MASERS may have been utilized to kill the animals. But a prospector coming upon a dead cow would be several steps ahead in the process because obviously the animal had been grazing and watering nearby. And isn't it possible that some of the animals could have died from the very accumulations of metals the researchers are looking for?

Q. How can you explain the technology of silent helicopters, bright lights and cigar-shaped craft often encountered near mutilation sites?

A. We have had the technology for quiet helicopters for years. In the early 70's the Defense Department Advanced Research Projects agency tested the OH-6, a very quiet copter. And in December, 1975 the Aeronautical Journal published an article entitled "The Coming Era of the Quiet Helicopters." No

one seems to know, however, if the technology exists for an extremely quiet or totally silent copter. This will take more extensive research to uncover.

Sorry to belabor a point, but no one should assume that aerial objects or UFO phenomena are extraterrestrial. The question should be phrased: can earthly technology duplicate these effects? The answer is an overwhelming yes. Aircraft that float or hover easily fall into three categories: helicopters, VTOL craft and dirigibles. By far the most silent is a dirigible, and a recent report from Goodyear Aerospace Corporation revealed an amazing new craft. This is a blimp with attached helicopter engines and props so it can maneuver quickly in any direction. These airships are called "skyhooks" because they can lift and carry very large cargos and who knows what such a craft would look like at night, equipped with a powerful beacon to locate animals. From much physical evidence it seems likely that many of the mutilated animals have been dropped from great heights, suggesting some sort of mobile airborne laboratory for tissue recovers. Blimps would fit in well here, especially if helicopters, quiet or not, were used as support craft. Also, remember that because of security reasons we know only a fraction of the new military discoveries-- who knows what toys have been developed in the last decade?

Q. How is the blood drained from the cows?

A. If there is an airborne laboratory involved, it may be equipped with machinery capable of draining a carcass of blood. But there is a growing suspicion that many of the "blood-drained" carcasses may have been lying around for a few days and the blood from the veins and arteries had been absorbed into the surrounding flesh, giving the illusion of drained blood.

Q. Why are the carcasses left behind as evidence? Wouldn't your mutilating prospectors have the technology to remove the carcasses?

A. There has been no need to remove the carcasses. Besides the fact that a carcass may weigh a half ton and is thus difficult to move or store, there is a simpler reason to leave it behind. So far they have provided no evidence at all to identify the culprits. All that a mutilated carcass proves is that animals have been dissected by means other than accident and predators. However, if the mutilations continue to receive extensive attention in national magazines, newspapers and electronic media, we may see an end to the mutilations but a rise in the numbers of missing cattle. Such an occurrence would make it even more difficult to track down the perpetrators because cattle disappear--run off, get rustled, or simply died--by the tens of thousands each year. So in that case we couldn't tell where the prospectors were working and we'd be even further behind them.

Undoubtedly I've overlooked some salient facts which other researchers will soon point out. But that is fine, because such a theory (like any other) must be able to survive analysis or it is useless. But as far as I'm concerned, a first step has been taken to solve the mutilation mystery and I know of no other reasonable theory this detailed. Perhaps more steps will follow.

UFO spotted Tuesday morning

An "oval shaped", white object emitting a wavy white light was reported over the Crescent Grade, between Crescent Mills and Greenville early Tuesday morning.

First report came at 5:05 a.m. from Sheriff's Deputy Richard Griffith. Deputy Griffith said he could not determine in which direction the bright object was headed, but it cast a bright light on the ground.

Two minutes later, Ruth Spear, who gave her address as being one mile south of Crescent Grade on Hwy 89, called the Sheriff's office with a similar report of a white, oval shaped object which cast a white wavy light on her entire back yard.

Both observers reported their sightings to the UFO Center in Illinois, a spokesperson from which told this newspaper that there were no other reported sightings in the area.

Two UFOs Reported

Two UFO sightings have been reported over the skies of Monrovia, but the Federal Aviation Administration says none were reported to the agency.

The FAA duty officer said there were no aircraft matching the descriptions of the sightings in the area Thursday.

One man, who would not identify himself, said he was walking out of an apartment about 8:45 p.m. when he saw the silent object.

He said it hovered for about 15 seconds before it tilted and sped out of sight.

About the same time, the sheriff's department received a call from the area of Euclid and California avenues near Monrovia to check for a UFO glowing with yellow and red lights.

The deputies called back to say they could find nothing.

"They've already gone back to Mars," one deputy quipped.

More people saw UFO Tuesday

The sighting of a bright object off the north shore of Kauai was confirmed by Judy Ochsenschlager of Wainiha, who said she also saw a brilliant light in the sky on Tuesday night.

Alan Reiser and Lou Kono had told The Garden Island that they had

watched the object "brighter than any star you can imagine" with, at times, a red flashing light.

Mrs. Ochsenschlager said that she saw the object from her bedroom window, which faces the ocean, but did not consider it a "UFO." She did not observe any red light, and had thought it was perhaps a star "falling

very slowly" through the sky.

It would seem that the UFO (or whatever) has been around Kauai in several places, since on Sunday a Westsider told The Garden Island that she had seen the same brilliant object ... with red lights ... in the sky late Tuesday night near Kalaeo.

in Springer said to be star

An unidentified flying object reported in Springer last night has been dismissed as a typical sighting of Venus by the chief investigator for the Center of UFO Studies.

Springer Police Officer Manuel Medina said he saw a "very bright and round" object floating through the sky at 9:30 p.m. Medina and several other Springer residents watched the slow-moving object travel across the sky and reported it changed color and direction before disappearing over the horizon.

Allan Hendry, chief investigator for the Evanston, Ill., UFO Center, said he interviewed Medina after the sighting last night and described it as typical.

"It is difficult to pursue these sightings when the obstacles of distance and darkness are so great," Hendry said. "We've taken the report as far as it deserves."

Hendry offered that Medina had probably observed the planet Venus, although the motion he attributed to the object sighted in Springer was "too fast for a star." Hendry added that the angle reported in the object's movement by Medina did not correspond with the position of Venus last night.

Hendry said the national center for UFOs receives an average of four calls daily which are similar to Medina's report. The center prefers to follow-up UFO sightings where some physical evidence or radar observation has been made, according to Hendry.

Medina said he was driving through downtown Springer, population 1,800, when he first noticed the object.

"When I seen it I thought it was a bright star in a cluster of four and I didn't think too much of it except it was a little brighter than the others," Medina said.

Medina then parked at a Phillips 66 service station and watched the bright object with four other people

for over an hour. He reported the sighting at 10:26 p.m., according to Lt. Rick Durham of the Springer Police Department.

"At first I asked Medina which bottle he'd been drinking out of," Durham said.

Medina said the object did not make any noises but appeared to change color into a pinkish hue. When he shone his squad car spotlight on the object it seemed to dip downward in its movement, Medina said.

Hendry stated the changes in the object's movement were difficult to analyze but might be explained by a power of suggestion from the motion of the other stars in the sky.

Medina admitted the object estimated at 10,000 feet, was "too far off to make out what it was" but because it was round and bright he judged it could be a weather balloon.

G.F. Bushear, meteorologist with the U.S. Weather Service in Albuquerque, said it was "unlikely" a weather balloon would have been sighted in Springer last night. Bushear reported high altitude balloons launched at Albuquerque airport burst within two hours of takeoff.

Hendry said he also checked with the Federal Aviation Administration in Albuquerque and had ruled out the idea that it was a weather balloon.

Herman Pino, air traffic specialist at Las Vegas Airport, reported nothing unusual on local radar and added that there were no authorized balloons in the area last night.

Medina, who has worked as a Springer Police Officer for three months, said he reported what he felt could have been a star or an aircraft in need of assistance.

"I was curious," he said. "I did enjoy watching whatever it was. I was just trying to do my job, that's all. I reported it."

Big Foot? Hard to Tell

PRINTS HUMAN-LIKE

A state wildlife biologist studying footprints thought to possibly be those of "big foot," said today it is extremely difficult to make a determination.

Officer Ralph Blotter, northern region, Utah Division of Wildlife Resources, said perfect plaster casts made of two footprints last week in the backyard of a North Ogden residence have human characteristics.

The footprints are 13 inches long and 4 1/4 inches wide at the toes. Officer Blotter said it appears as if whatever made the prints "slid a bit in the mud" which could account for their size.

A 13-inch foot, however, is not uncommon among humans, said Blotter.

The prints are very clear, showing toenail marks, the "pads" and

heel marks, and even the lines and grooves found on hands and feet.

He said the prints did not appear to be those of feet with calloused, worn areas, scars or cuts. There is also no scar tissue such as that usually found on the bottoms of bare feet constantly used in walking.

Blotter said he is at a loss to explain the depths of the prints that some said indicate the owner was extremely heavy, maybe 400 to 500 pounds.

Average-sized persons who made their own footprints in the same spot said their weight hardly made an imprint.


