


## ANALYZATIONS

Both of his articles are highly controversial subjects and he is honest enough to present his views on the matter. Although many researchers do not believe as he does, the SBI condones no one for either their opinion or beliefs.

Of course, no SBI REPORT would be complete without hearing from our Staff Writers; Marty Cannon's GRAPEVINE, Thomas Herberg's READER FEEDBACK and Dorothy Soultanokis' SPOTLIGHT articles are always cram-filled with new data.

At this time I wish to take time and express my gratitude to everyone who has sent us either a photograph(s), movie film, tape cassette for analyzation. Under the same thanking method, we thank everyone for all their letters or their contributions to the SBI REPORT. It is difficult for us to immediately return your correspondence or report of analyzation findings. Yet, we are on top of the situation and you will eventually hear from us either by letter or telephone. Once again, thanks for your patience and total understanding in these matters.

Most of our mail really asks the question, "What's going on in USA as far as UFO encounters?", or "tell us about some SBI cases that are presently being investigated or old cases that have progressed since our incorporation."

This may sound like it's easy enough to answer, but quite the contrary. We have at present 25 major cases being investigated in the USA alone. These cases cannot all be elaborated on since we as yet do not know the full particulars surrounding the case or suspect a hoax. But, on the other hand we can relate some that have been worked on.

In the USA we have seen an increase in mounting UFO activity in several areas; one, Washington state, Michigan, Ohio, New Hampshire, and several states that have had recent earthquakes. Abroad, places like New Zealand, Australia, France, England and South Africa still lead the race in UFO activity.

As to the USA cases, we are investigating several close encounters in central and lower Michigan. These sightings have involved police officers and civilians alike. Each sighting has taken place in or near an abandoned Nike-missile complex, nuclear power plant or high electric facility. In one such incident, the UFO was observed over a farm not more than 15 feet above the ground. Also in Michigan, the SBI was lucky enough to retrieve a movie film of 1974 origin showing a UFO over a major Interstate highway. A family of four endured the sighting, that is being looked into for possible abduction signs, and is by far one of the best UFO film footages of this decade (presently under analyzation). By no means is this the last such incident in Michigan. We are also looking into a possible abduction of a 15 year old boy on August 2nd of this year (Field Investigator Marcello Galluppi is documenting this case).

In the state of Ohio we see a tremendous amount of UFO activity throughout the entire state. At present we are trying to locate a female who claims to have been abducted in 1977 and never reported the incident to anyone. But no matter what takes place in Ohio, Chief Investiagtor Bonita Roman is on top of the story. She and her army of investigators make it nearly impossible for a UFO story to pass them by.

In Washington state, the recent volcano eruption has indicated an enormous amount of activity from UFO either before, during or after the Mt. St. Helen's eruption. New Jersey Field Investigator Elizabeth Christie (by sheer coincidence) was vacationing in Washington and has uncovered many tales of UFO origin in that area. She also traveled to Wyoming (naturally to the famous DEVIL'S TOWER of CE Of the 3rd Kind origin) where she experienced several strange happenings as well hear of many other tales of UFO in that area. Most likely, Liz is preparing some sort of article for us on her vacationing adventures that will be published in a future issue of this magazine.

New Hampshire, the home of the first documented abduction, is once again re-activating itself with constant UFO activity; everything from close sightings, formations, landings and even photos of them in our skies. An article related to one such case appears in this issue in our READER FEEDBACK segmentation.

In other states whereby earthquake fault lines are present, we have noticed the increase in UFO appearances. Many researchers believe

that UFO travel using the magnetic fault lines in the Earth's core. The SBI cannot say this for sure, however, it is highly unusual that UFO activity always picks-up prior to an earthquake or immediately afterwards. Perhaps one day we shall learn the true meaning to this theory.

I have only mentioned a few of the states that comes to my mind that have more, sort of speak, UFO activity than others within the US. Of course, there are alot of other states that have strange activity taking place. One such state is Idaho, whereby we have learned from one of our Consultants, JEROME EDEN, that DOR (Deadly ORgone) clouds are present more than ever. This type of cloud(s) (DOR) is emitted from UFO exhausts either in the immediate area or very near by. As a matter of fact, Mr. Eden has taken several beautiful color photos of these black-type looking clouds which are really spectacular. Those readers wishing to purchase a set of these photos, inwhich every UFO researcher should acquire for collection purposes, the following data is made known:

TWO of the best color enlargements of DOR-clouds I have ever seen Taken by my wife Desiree this past May 1980. These are toxic Deadly ORgone clouds which are the "exhausted energy" from UFOs---just as the gasoline engine emits carbon monoxide. DOR lacks oxygen & water and absorbs the oxygen & water from atmosphere, plants and people. Wilhelm Reich considered DOR clouds one of the best indicators of the presence or past-presence of UFOs.

Now to past SBI cases or future proposals of the organization. An excellent case the SBI has documented/investigated/analyzed is one that took place in November of 1978. The case, originally investigated and documented by NYS Chief Investigator DAN LOWENSKI, was passed down to the SBI Headquarters whereby the two International Directors of the SBI took over. Since this nearly 2 year incident, which at first only showed signs of a CE 2 nature, the SBI has learned through more and intensified investigating/documenting that the two witnesses involved were ABDUCTED. Through the process of regressive hypnosis we have found this to be the case. After several sessions with both witnesses (or rather abductees) we have regained knowledge of the events leading up to the abduction, during the abduction and the aftermath that followed. Hypnosis is still being used to determine even more startling facts of this incredible encounter with UFOs and their alien occupants. MORE TO COME ON THIS STORY AT A FUTURE DATE.

As to present proposals in the works already or on the drawing board. The "Step-by-Step" UFO Investiagting Manual is currently being revised. We have deleted alot of nonsense within our first attempt at publishing our Manual and added alot of new chapters dealing with an in-depth comprehension of regressive hypnosis, Voice Stress Analyzation (PSE testing), photographic analyzations and more essential Field investigating techniques or proven methods. Hopefully, we will even get it published by a professional publishing firm for all of the public to read.

Advertising for the SBI membership drive is near completion thanks to Staff Artist JOHN COLLADO. Shortly (few months) the SBI will be seen in many UFO periodicals, etc. using its own ad to attract new members and interested parties wishing to tell us of their UFO experiences.

Their are many great innovations on our drawing board, such as: a possible documentary type motion picture film presenting the SBI as narrators on the subject of UFOs; cable television programs, one in New York and another in New Jersey presenting the SBI's own TV program to the public on UFOs; a professional video-taped presentation of one of the SBI's lectures and then used for future obtaining of other lectures or even sold to a video-tape/photo firm for distribution to the general public or institutions; a new one-piece-type cover for the SBI REPORT which incorporates the present front cover, the rear page of the front cover at present, a Staff page and the present rear cover page--all into one long-type cover that is professionally printed and stands out attractively; our own SBI Headquarters photo darkroom, complete with accessories for enlargements and analyzation; our own SBI toll-free 800 number; a new Introduction Letter for Police Agencies within the USA (already completed but not distributed); and a host of many more new ideas to either motivate our membership or aid us in our organizational research programs.

We have many ideas, all we need is MONEY or LEADS for persons who will be beneficial to the SBI's progression. But, through positive attitudes we will succeed in doing exactly what we state above; just as in the very beginning of our existence towards overcoming obstacles confronting us and progressing to the level we are at the present. Just as a professional athlete, actor/actress, or person of professional occupation has to work hard, study, overcome obstacles or barriers to reach a certain level, and needs the stamina and will power to believe in himself/herself and the ones who teach them--the SBI follows this same pattern. Nothing will stand in our way for very long. 
\*\*\*\*EDITOR'S NOTE\*\*\*\*\*

## ARE These OBJECTS, DEVILS?

The arguments usually run like this. How can Ufo's do interstellar travel in those small saucers? Why are so many seen? They seem to take on the appearance of the expected technology or form according to the age they manifest in. They teach spiritual concepts contrary to the Bible. They defy laws of physics and seem to laugh at inertia and gravity. They capture people, hypnotise them and program them, and give exotic physical examinations. Ufo's have even shot beams at people, jets, etc.

These are the stock arguments for their being satanic, spiritistic, and out to damn your soul.

Consider these: Saucers are the equivalent to airplanes. They can only fly in the air space of a planet. They are carried through interstellar space by larger ships, the usual shape of which are cigar shape. So many are seen because many alien bases are established on earth, under the sea, underground, etc. They have a lot of interest in this planet because of its natural resources, it is still slightly primitive and some alien cultures are from dying planets and are desperately seeking other places to settle. Many alien civilizations have been living on earth for quite a long time.

That Ufo's seem to change appearance to deceive is patently groundless. Remember the three most typical Ufo shapes? The ovoid or saucer, ball, and elongated and larger cigar. Now consider these: "B.C. 223. At Arminium a bright light like the day blazed out at night, in many portions of Italy three moons became visible in the night time." (Dio Cassius, Roman History. Vol. II p. 47). From an article in Flying Saucers, magazine edited by Ray Palmer March 1975. Article called Flying Saucers in Saxon Times. p.35.)

This item is from Flying Saucers On The Attack by Harold T. Wilkins. The reader is referred to chapter 8 called "Flying Saucers of Other Days".

A.D. 919: "A thing like a burning torch was seen in the sky, and glistening balls like stars moved to and fro in the air over Hungary."

Now consider and consult Flying Saucers Have Landed by Leslie and Adamski. See pps. 22-Ch. 2 'The Flying Saucer Museum.' This one is from an old Manuscript discovered at Ampleforth Abbey in January 1953. The strange visit took place over the community of Byland Abbey in Yorkshire. A.D. 1290 'Took the sheep from Wilfred and roasted them on the feast of S.S. Simon and Jude. But when Henry the Abbott was about to say grace, John, one of the brethren, came in and said there was a great portent outside. Then they all ran out and, Lo! a large round silver thing like a disk flew slowly over them and excited the greatest terror. Whereat Henry the Abbott immediately cried that Wilfred was an adulterer, wherefore it was impious to ..."


January 12, 1836: Cherbourg, France. A large luminous vessel hangs over the city. It rotates on its own axis and seems to have a hole in the center like a doughnut.

Sept. 4, 1851 England: "...a vast host of luminous disks stream from the East and from the North. The procession lasts from 9:30 a.m. to 3:30 p.m., and are observed through the telescope of the Rev. W. Read.

Oct. 5, 1877 Towyn, Wales: "Eight peculiar luminous bodies fly around Wales in perfect formation for several nights in succession. They appear to be inspecting or charting the coastline. Inevitably they end their activities by speeding out to sea.

Space won't permit me to elaborate or quote very many of these cases. These should be sufficient to illustrate the continuity and consistency of these sightings. The objects are still the same, the basic disc, ovoid or ball, or elongated tube or cigar. If these Ufo's were out to deceive, may I ask, how? How would you deceive ancient people by looking like discs? Some cases where a Ufo sounds like it's taking on the exact expected form of that period simply are due to observation and expectation and what is read in to the sighting to accommodate the person to the unknown and fearful phenomenon.

The following pictures are from the book, Spaceships In Prehistory by Peter Kolosimo. They are found on pp. 11-19. These are ancient cave drawings. Dates for them are circa 30,000-10,000 B.C.



The researcher and explorer Aime Michel speaks about at least 17 caves in the Franco-Cantabrian region extending from the zone crossed by the river Vezere (Limousin, France) to the Spanish province of Santander, among the famous cave murals of Altamira. These are reproduced here and the reader is referred to the book mentioned and to the writings of Aime Michel.

These illustrate graphically that so called 'devils' or 'devilish manifestations' appeared to ancient cave dwellers just like they do today. I think they are lousy deceivers.

What about spiritual messages which conflict with the Bible? Not all of our spacemen who went to the Moon believe that

the Bible is inerrant and infallibly the Word of God. Not every worker at NASA is a Bible believer. Nevertheless they will in the future travel to other stars and worlds and will probably bring a confusing amalgam of religious beliefs to these worlds.

Later I shall give you references as to Ufo propulsion systems. Now to the fact that some cases seem to point to Ufo hostility. Bear in mind that the crews of our exploring ships in the past have often done nefarious things too. Remember the Conquistadors? Consider the history of the Indian on the American continent. These ships did not carry devils in the theological sense. They bore human beings with ill psychopathologies. Some cases of Ufo hostility maybe in hasty self defense too. See Aliens From Space by Donald Keyhoe. He cites case after case where Ufos were fired upon first, and the Ufos retaliated.

Well, you are probably thinking, what about those murky abductions? First of all, most of these abductions seem murky because we are not at all psychologically prepared to cope with even a slight sighting with an unearthly object. No less actual contact with an unearthly occupant. This is part of the reason for sudden quick actions on the part of the aliens. They realize they have to deal with half hysterical people on the one hand, and higher-ups who do not wish our public to know too much, especially about extra-terrestrial beings that come and go. The actual physical examinations are on the main no worse than a visit to the doctor. Hypnosis is utilized by psychiatrists to modify subconscious urges, and retrieve memories. Aliens cause the abductee via hypnosis to forget their experience because they probably realize how traumatic it is for an earthling schooled and taught that 'we are all alone' and that there is no other 'human' life in outerspace. But the abductees' memory usually surfaces in a few weeks.

I have an article from a Rockford newspaper concerning a man who was accidentally healed of blindness from lightning. Electricity, electromagnetism, and ultrasonics are being experimentally used in healing. This bears thought as you read of cases of Ufo encounters where the contactee has resulting healing of ailments. Psychic? Demonic? Hardly.

# Lightning bolt restores sight

FALMOUTH, Maine (AP) — A 62-year-old man, blinded in a traumatic accident nine years ago, regained his sight after he was struck by lightning near his home, his wife and doctor said Friday.

Doctors confirmed that Edwin E. Robinson, a former truck driver, could see for the first time since he became blind as the result of a highway accident nine years ago.

"It (his sight) isn't completely restored," said Robinson's wife, Doris. "But he can see straight in front of him, which he hasn't been able to do in nine years."

Robinson was knocked to the ground by lightning Wednesday when he took shelter beneath a poplar tree near his house in this Portland suburb during a thunderstorm.

"It sounded like someone snapped a whip. The next thing I knew, I came to, face down in the water at the foot of the tree," he recalled. His wife said he apparently was unconscious for 20 minutes.

Weak and dehydrated, he returned to his bedroom for a nap. "My legs were like rubber. My whole body felt like it was trembling," he said. The

lightning also broke his hearing aid.

"When I got up that evening, I was sitting in the chair in the front room. I could see the plaque on the wall, and I could see the clock. But the clock kept fading in and out," he said.

His wife found him in his bedroom. "I can see you! I can see you! I can see the house! I can read!" she quoted him as saying. She also said he was able to hear perfectly without his hearing aid.

Dr. William F. Taylor examined Robinson on Friday and confirmed he had regained both sight and hearing. Calling it "one for the books," Taylor said the rubber-soled shoes Robinson was wearing when struck may have saved his life.

Robinson's ophthalmologist, Dr. Albert Moulton of Portland, attributed the dramatic event to trauma.

"It was traumatic when he lost his sight, so maybe his sight was restored by this trauma. Anything is possible," said Moulton.

Mrs. Robinson said she was being deluged with calls from friends and well-wishers who heard about her husband's recovery.

Stanton Friedman, a famous nuclear physicist-Ufo researcher says: "In the first place, we know the human body can be influenced by all sorts of invisible but real forms of energy, ranging from ultrasonic radiation to X-rays to microwaves to neutrons to a variety of charged particles. One need only consider the use of radiation to knock out various tumors and cancerous tissues." Friedman recommends to the reader to refer to the recent article, "Augmentation of Bone Repair by Inductively Coupled Electromagnetic Fields". I'd like to no why some so called researchers and experts in UFO-logy continually discredit all contactee cases such as: Eduard Meir, Herbert Schirmer, Charles Hickson & Calvin Parker, Travis Walton, George Adamski, and Betty and Barney Hill.

When the (PSE) Psychological Stress Evaluator come long I beleaved it was the best way. to get the truth about a UFO contact.

According to what I have read about the PSE, it's so reliable that its results have been aditted as evidence by courts in at least five states. The PSE is now used by over 300 law enforcement agencies in the United States. ## ARTICLE #2

I'd like to tell you about a ufo case I read about in one of saga's UFO report magazines.

It was about a rancher that was driving west on Pumphouse road in Washington state. He was driving along one evening, and was startled to see a cow and two calves trotting down the road toward his truck. The cow was bawling, nervously looking back over her shoulder.

The rancher, a straightforward, intelligent observer who declines publicity, slowed his vehicle to avoid hitting them. He continued slowly down the road, wondering what the cattle had been so frightened of. He hadn't long to wait. At the top of a small rise, the truck's headlights fell on three "men" standing in a ditch next to the road. As the rancher drove closer, one of the tall figures moved out to the center of the road in front of him in a single jump—a distance of about 15 feet. The "man" put his thin arms overhead in a posture of surrender. "The leap seemed to have been in slow motion.

"The witness told Bill Vogel and an investigator for the center for ufo studies. But that was a later reflection. At the time, the rancher decided something strange was going on and he wanted to get out of there. In swerving to pass the figure, he got a good look from a distance of only two feet and it was frightening. Dressed in tight black clothing with a trapezoid insignia on the upper chest, the skinny body stood seven feet tall. Its face was extremely long. The upper lip was pulled back in a snarl and the matted, shoulder-length hair was described as "scroungy." Adding to the unreality of the scene was a purple object grasped in the figure's left hand from which a wire trailed; that and the fact that the elongated face was absolutely white, "as if covered with flour. As he speeded toward his ranch, the trembling man saw he was being followed by an oblong, lighted aerial object which paced his truck. The ufo blinked on and off. Suddenly, the inside of the truck lit up, "as if the dome light were turned on.

"The intensity of the beam blotted out his dashboard lights and illuminated a 10 foot periphery around him. It stayed with him until he reached his driveway where he ran in terror for the house to awaken his family. Then the object simply disappeared. Then in the first part of March 1976 a family living on South Harrah road (which intersects Pumphouse road) upon returning to their ranch were startled to see

Behind the loudly bawling cows was a tall humanoid black-garbed figure chasing them. The description given matched the aliens seen in December, But the one thing specifically stressed to the policeman taking their report was the extremely white face. After I read about this case, and how the FBI and other law officers were trying to find out who the cattle mutilators was, I'd like to help if I can.

I think the rancher and this other family got a good look at the cattle mutilators. So with this in mind I gave the description of the alien that the rancher saw in Dec. 1975 to a friend of mine, Kris Bjork who is also an investigator for the SBI. I ask her to do a composite of the alien. Well she did it, and I've inclosed a copy of it with this report.

No one up until now new what the mutilators look like ~~is my hope that~~ with this composite UFO investigators as well as the lawmen that has been working on these cases will no what they look like.

This is proof that beings from another planet are the mutilators. What's more, the ufo that followed the rancher was oblong and it just happens that there is another case that happen on July 17, 1973, about 10 p.m. three people witnessed an oblong shaped ufo descend close to the ground in a shallow vally several miles south of their ranch in the northern mojave. And as the object silently hovered, several dark shapes dropped from it to the ground, and seemed to amble off in all directions.

It was the Sasquatch that these people saw. And on the preceding night some people from the next ranch went out looking for the sasquatch and an woman who was one of the three people who saw the ufo and the dark shapes drop from it was with them. They found one of these things in a joshua tree grove. As they were looking at the sasquatch, a swarm of lights appeared from the direction of the military scss road. The rumble of heavy equipment shattered the silnce. The fear that they might be in jeopardy caused them to bolt back up the hill in search of hiding places.


They had changed their positions considerably up about 1,000 feet and hidden by a clump of shrubs they watch as a convoy of blue trucks descended on the grove and the glowing eyed thing. The trucks didn't bear no identifiable marks, went to the joshua grove and stoped.

A figure, apparently that of a man, was carrying a powerful light and moved in a hurried manner toward the creature. He seemed to make a violent back and forth motion with the light as if directing the creature to come to him. Suddenly, the creature stood up, its silhouette plainly visible against the bright lights of the smaller figure. Later estimates placed the creature at about eight to 10 feet tall, since its head seemed to reach midway on a 20 foot joshua tree. As the creature walked toward the amaller figure, its silhouette showed the unimstakeable shape of a man-like entity.

The creature walked slowly past the man toward a large truck. At that moment it let out a desperate, anguished cry, and several men swept the outlying fields with a flood light as though looking for something. The ranchers decided

that someone may have either heard or seen them so they all started running back over the crest of the hill in the direction of their ranch, a good five miles away. What I'd like to point out is that the ufo seen in Washington on Pumphouse by that rancher in 1975 and the ufo seen by those three people on the night of July 17, 1973 was both oblong in shape. I think the same ufo aliens that is doing the cattle mutilations are also the same ones that are controlling the Sasquatch. Some UFO investigators may not think this is true, but if they would take a good hard look at all of the cases of both the Sasquatch and the cattle mutilations they would see as I have that they related. Their are ufo bases here on Earth, but they are underground. This is the end of this article.

## Behind Ron's Viet bomb

WASHINGTON—When Ronald Reagan flew east from California last Sunday, the script called for a series of talks on national security that would show him to be a sober, prudent man of peace. Instead, by a single speech, Gov. Reagan demonstrated the same capacity for irresponsibility on defense that Jimmy Carter has so painfully put on the record in 44 months as President.

In consequence, the serious defense debate which the country deserves has been badly compromised. The most critical issue before the nation has become a football in a contest as to which candidate is the least competent.

Three speeches on national security were planned for Reagan's first campaign foray following the Democratic Convention. First, on last Monday he was supposed to talk about peace to the Veterans of Foreign Wars in Chicago. On Wednesday he would talk to the American Legion in Boston about the need to make the country strong. Finally, in Dallas on Friday, he would address the subject of friends and allies.

A draft of the Chicago speech was prepared by one of Reagan's well-balanced foreign policy advisors, Richard Allen, and sent to Santa Barbara where the governor was vacationing. Reagan found the text dull and began fiddling with it himself. He turned for help to some of his ideological advisers. As a result the language was made more spicy, and the thrust changed.

Peace, to be sure, was the central theme. "Clearly," Reagan said, "world peace must be our number one priority. It is the first task of statecraft to preserve peace."

In addition, Reagan made a good rebuttal to the charge his election would promote an arms race between the U.S. and Russia. "We are already in an arms race," he said. "But only the Soviets are racing."

But then Reagan introduced a wholly gratuitous reference to Vietnam. He called the war "a noble cause." He strongly implied that victory would have been possible if only "our government" had not been "afraid ... to win." Thus instead of uniting the country behind a prudent policy, he worked to redivide the country on a subject famous for fostering the most furious discord. At the same time, by implying the war had been winnable, he reopened an endless debate

that leads nowhere.

The diversion is the more grievous because there are truly important defense issues at stake. The fact is that the U.S. is not well equipped to meet its security responsibilities. Nobody knows it better than the Carter administration—which is why the President and his Assistant for National Security Affairs Zbigniew Brzezinski, have laid down a veritable artillery barrage of bogus claims and cloudy stories.

For example, there is the President's ceaseless talk of a Rapid Deployment Force — which far from being a force is merely a headquarters. There is the leak about a new bomber—called the STEALTH, because it is designed to minimize detection by radar—whose future development has apparently been made known in order to justify the administration's cancellation of the B-1 bomber.

Then, there is Dr. Brzezinski's leak about a new strategic doctrine that purportedly stresses nuclear bombardment of Rus-

sian military targets as distinct from large cities. The only reason for putting the story out is to give the impression that something big is happening in the defense field, when, in fact, almost nothing is occurring.

But the genuine case against the administration cannot now be effectively pressed home. President Carter can plausibly argue that Reagan only raises the security issue for partisan political purposes. The Democrats can fairly claim that Reagan is a beaky hawk who cannot be trusted to have a finger on the nuclear button.

Nothing in this is particularly surprising. However solid his instincts, Reagan is over his head in dealing with much of the serious business of government.

But no one should be deceived into thinking that Reagan's wrongs make Carter's policies right. In fact, the Carter administration has presided over a diminution of American strength. It has played politics with national defense—to the point where serious men could believe the story that Carter would order an invasion of Iran in order to help his election prospects. All of us, accordingly, suffer from the thoughtless way the defense debate has been broached by Reagan. The incident is one more bit of evidence for the proposition that while Carter may not be able to win, Reagan can certainly lose.

## What do UFOs see in Hillsboro?

HILLSBORO, N.H. — Billy Gould and Laurie Barr have quite a tale to tell.

But then so do a lot of other folk in and around this central New Hampshire community of 3500.

Last February, on their way home from a basketball game, Billy and Laurie pulled into a field behind the Gould family barn in nearby Henniker to park. The couple had recently become engaged, and the spot seemed a good place to be alone in their truck for a few minutes on a cold winter night.

A few moments after they stopped, Billy, 22, spotted something odd coming over the trees at one end of the field. Billy later described it as a big Contact capsule floating on its end. It glowed with a yellowish-bluish color, he said, and he guessed it was about 40 feet tall and 15 feet wide.

Both of them watched it drift across the field at treetop level until it was directly over their truck. At that moment, the radar detector on the dashboard went off with a buzz.

"Shut the truck down," Laurie said, startled. The 20-year-old New England College special education student slid across the seat and hugged Billy, scared.

The object hovered directly over them for about a minute. Billy rolled down his window and stuck his head out.

"It made a humming noise," Billy said later. "We were close enough to it so I know it couldn't have been a helicopter."

Then the object drifted away, until it was over Golf road, the road that runs past the Gould farm. Suddenly, the object accelerated and was gone in an instant. "It was like you could see a huge light and then it gets smaller and smaller and it's gone," Laurie said.

Billy and Laurie are not the only ones who have sighted strange objects and lights that hover and then disappear in the sky.

Over the last four years, more than 60 sightings of unidentified flying objects have been reported by that number or more individuals in the area. That's according to Robert Giglio, 51, a Hillsboro free-lance photographer who's spent much of his free time in the last three years interviewing and recording the experiences of people in the area who have seen unexplainable objects.

The Globe interviewed more than a dozen people who claim to have seen objects on different occasions. Five people had related encounters as close as

Billy's and Laurie's, while others told of more distant sightings of both spherical and saucer-shaped objects — objects that glowed in various colors and seemed to travel with ease and agility in and around the tree-covered hills that dot this sparsely-populated region.

The sightings have some people in the community concerned. "There are too many coincidences, there's got to be something going on here," said Ronald Ellis, the new publisher of The Hillsboro Messenger, the area's weekly newspaper. "The people who claim to see these things are too credible. It's not somebody's imagination."

Ellis published an account of the most recent sighting, in which a woman said she saw a large bright red and yellow object hovering at tree-top level on Rte. 31 in Hillsboro last June.

Some scoff at the sightings, however. To say that the whole community is buzzing about flying saucers would be incorrect. Until Giglio started becoming more vocal about his investigation this year, few of the people who had sighted things talked to one another.

"The town as a whole is certainly not concerned with UFOs," said Joseph Eaton Jr., chairman of the Hillsboro selectmen. "The only person who has ever discussed UFOs with me is Bob Giglio. I've never seen one, nor do I know anyone else in this town that alleges to have seen one. And I've lived in this town since 1946."

However, another selectman said he saw something he "couldn't explain to anybody" in the sky about four years ago.

Thomas McClure said he another lineman for the Public Service Company of New Hampshire watched "a bright glow" hover over Wolf Hill one night. When they turned on the yellow flasher atop their utility truck, McClure said, the object streaked into the sky at a tremendous speed.

Officials at both Pease Air Force Base in Portsmouth, N.H., and the state Civil Defense office said they had received no indications of unusual flying object activity in the area.

Giglio said if UFOs are not widely discussed or reported, it is because people who have seen them are reluctant to talk about them, for fear of being branded as slightly looney. Giglio said he would not have become so involved in the subject himself if he had not photographed an unexplainable object late one night three years ago.

On July 5, 1977, Giglio said his daughter and several friends watched a strange light descend onto the side of Craney Hill in Henniker, N.H., the town next to Hillsboro to the east. The light stayed in position long enough for Giglio to be brought to the scene by his daughter. He took several dozen pictures of the light from Rte. 202. Two police officers who came along that night also saw the light, which pulsed with a bright red glow for several hours.

Thomas Bourque and another officer, who asked not to be named, said they also saw the strange light on the side of Craney Hill that night.

Giglio had the negatives examined by a photographic image scientist at the Itek Corp. of Lexington, Mass. That scientist, who asked not to be named, said the photos were not fake.

"There is no question that when the pictures were taken, something bright was sitting on the side of that mountain," said the scientist, who has since left Itek. "We were able to judge the size of the object by blowing it up and it was 7 to 9 feet in diameter. It also appeared to be round, as it has the same appearance from two different positions."

Other tales of unusual objects are more bizarre. Among the most vivid is the story of George Hill, 47, who was driving back from a job as a maintenance man at the Washington, N.H., School along Rte. 31 one night last September when he saw an odd light on the highway ahead.

"It was a dome-shaped object just sitting in the road," Hill said. "It look like an inverted half of a grapefruit and it was glowing yellowish." Hill slowed and stopped about 400 to 500 feet from the object, he said, as he could not drive around it. He watched it for a few minutes. "Then it became two or three times brighter — I don't know if my eyes got used to it or what — and it began to slide off the surface of the road and into the swamp next to it.

"It stopped and then two things happened. It had another dome, like a conning tower on a submarine, on top. This conning tower began to rotate and give off three beams of light, one red, one yellow, and a darker color, like blue.

"Then something protruded from the conning tower out over the side. It looked like there was chute emerging out to the surface of the swamp. It looked like a child's slide, it was silvery.

"Then I saw it lift off the ground. I just saw it raise a little higher. Then it blinked out and apparently was gone. I don't know if it turned off its lights or climbed away," said Hill.

Three other people interviewed by The Globe also claimed to have seen large, lighted objects over the same winding and desolate stretch of Rte. 31 between Washington and Hillsboro.

James Gaskell, a former teacher and country store owner in Washington, said he saw a glowing "dirigible-shaped" object drift low across the road there about three years ago. He stopped his car, he said, and with his two children watched the "craft" hover silently for a few minutes and then dart away "at tremendous speed."

Other people talked about a concentration of sightings along Golf Road, near where Billy and Laurie saw their object. Charlie Hogg, a part-time police officer for the town of Henniker who lives on the road, said he saw a craft similar in design to the one Billy Gould described hover low over the hills near his home and then take off just like a flash, "one night last February.

Hogg said he saw flying objects "at least twice a week" for a stretch of time last winter. He said they pulsated with a dull red and flew in circles overhead. "But they were not planes because there was no noise," Hogg said.

Hogg was not the only police officer to have seen objects. Willard Campbell, the part-time police chief in the town of Deering, N.H., which is adjacent to Hillsboro to the south, said he saw two objects hover near some power lines in Deering four years ago. "People make fun of me, but I know what I saw," said Campbell, who is 30. Another area police officer, who asked that his name not be used, said he had seen large objects close up several times while

For one area as small as Hillsborough and the three towns surrounding it to have had so many claimed object sightings is very rare, said one expert on UFO's. "Generally speaking, most UFO sightings are fairly random," said Jerome Clark, an editor at Fate Magazine and the author of several books on UFOs. "But there have been sightings concentrated in one area for a period of time, like four years is an unusual situation," he said on being told of Giglio's work.

Giglio believes a federal investigation of the happenings in Hillsboro is warranted.

"My theory is that these are not extraterrestrial," Giglio said. "I can't believe anything from outer space would want to come down to this area. There are no mineral deposits, no military bases, nothing. They can hover over more interesting areas.

"I believe they are manmade objects and that somebody, some organization, has achieved a major breakthrough in electro-magnetic technology. And any objects which have the ability to hover, move away at great speeds, and change directions rapidly — if they are not in the hands of our government or a government of the free world — then they are a great threat to national security."


Giglio further theorizes the objects are operating from a base somewhere in or near Hillsboro. "I don't know where. I don't know what they are. But these people are saying something," Giglio said. "There is a pattern to the sightings. Many are large and roughly the same shape. They all make no sound. And the unusual thing is so many people have seen them so close."

After Billy Gould and Laurie Barr saw their first object last February, they spent other winter nights watching the sky over Golf Road.

They saw more objects, Billy said, although none were as close as the first one. "The others were high red ones, circling the mountains," Billy said. "they were big, too, but they were not planes. There's no way a 747 would be circling around here."

Recently, however, they stopped looking. Laurie has grown scared. She said she doesn't want to have anything more to do with them.

"I don't know what they are," she said. "But I think they are people a lot smarter than we are."

# Things that go bang in the night, in Northern Territory

Unidentified objects, believed to be large meteorites, are crashing into the Earth in the remote area around Rabbit Flat in the Tanami Desert in the Northern Territory residents say.

One large object exploded as it hit the Earth about 50 kilometers due south of 'Mongrel Downs' station in the early hours of June 7.

The flash and impact was seen and felt up to 100 kilometers away.

The regularity of the sightings and explosions — at least seven in the past 10 days — have led local residents to believe the Earth is spinning into an asteroid belt, or has hit the tail of a comet.

But they say the curious aspect about the matter is that "officialdom", apart from police at Alice Springs, has shown no interest in the sightings.

Mr Bruce Farrand, licensee of the Rabbit Flat roadhouse about 500 kilometers north-west of Alice Springs, said yesterday, that he saw the flash of the June explosion reflected on the roadhouse.

"I was doing some work outside when it happened", he said. "It was a queer feeling. At first I thought it was a car coming.

"The flash was followed about three minutes later by a noise like rolling thunder".

Mr Farrand said stockmen on 'Mongrel Downs' had reported seeing large bright objects travelling at "fantastic speeds" just above the ground. Other reported sightings had come from Balgo Mission across the border in Western Australia.

In one case a stockman reported seeing a very bright object disinter-

grate in the sky seconds later he heard a loud bang.

Mr Farrand said it was unlikely that the objects were "space junk".

"If they were I think we would have been told to be on the look out for it" he said.

"The most likely explanation is that we have run into a shower of meteorites, though some of the blokes reckon we've hit the tail of a comet.

"What we feel is curious is the fact that officialdom has not shown the slightest interest in what's been happening".

Mr Farrand said he had kept a detailed record of the sightings and had passed the information on to the Weather Bureau which in turn had given the details to the Department of Transport.

The American seismic station at Alice Springs had also been told but had since denied receiving any reports, he added.

Inspector Mike Gilroy, of Alice Springs, said a police Navajo aircraft had flown over two particular locations which had been given to the police but the pilot had seen nothing unusual.

"We have a report of one incident in which there was an enormous bang", he said. "Apparently the ground shuddered and there was a blinding white flash.

"At the moment we are considering whether to pursue our investigations or not".

## Jerusalem pilgrims sight UFO during vigil

Thousands of Christian pilgrims to Jerusalem held candlelight prayers at the tomb of Christ in a Holy Saturday Easter vigil, and many reported seeing an unidentified flying object (UFO) round and brightly glowing, high in the sky near the Church of the Holy Sepulcher.

Excitement and speculation about possible religious significance of the UFO sighting was later quelled when a resident of the area called police to say his son had released a large silver balloon, bought at a children's fair in Tel Aviv, about the time of the sightings.

At the Vatican, Pope John Paul II celebrated mass in the splendor of St. Peter's Basilica, leading the world's 720 million Roman Catholics in the commemoration of Christ's Resurrection. Despite misty, chilly weather, tens of thousands of pilgrims and tourists crowded into the magnificent basilica, the largest church in Christendom.

In Jerusalem, the litanies of the Roman Catholic, Greek Orthodox, Armenian, Coptic and other churches echoed through the incense-filled Church of the Holy Sepulcher in a quick succession of prayer services.


Protestants held separate services outside the walls of Jerusalem's Old City. They do not recognize the church as the site of Christ's burial.

In Ramallah, near Jerusalem, Palestinian youths participating in a religious procession tossed rocks at Israeli troops posted nearby. The city's deputy mayor said the troops fired tear gas at the youths and made several arrests. But the procession continued to the church, and the main celebration in Jerusalem was unmarred by political tensions.

No special security was visible in Jerusalem, where, in the past, troop reinforcements have been stationed to guard against possible Palestinian terrorist attacks.

# Murray ferry 'buzzed'

Flying saucers seem abnormally attracted to the meandering, sky-mirroring Murray River.

Since 1970, I have received dozens of reports of glowing disc-shaped objects emerging from or hovering above Australia's most important waterway.

Perhaps the most spectacular series of encounters occurred in 1974 near Morgan.

While 14 ferry passengers watched, amazed, a sky craft the

size of a double-decker bus beamed a brilliant light on to the river's surface.

One woman aboard the ferry became hysterical and spent 48 hours in hospital.

The ferry buzzing occurred at the height of an unprecedented UFO flap in the area.

Many sightings, one of which occurred over Penfold's vineyard, were reported to the town's policeman, senior constable Brian Brealey.

In one particularly uncanny incident, a cigar-shaped craft appeared above a local

ambulance going to an accident.

The ambulance's engine and lights died.

Mr Kevin McNeil, one of Australia's foremost UFO investigators, told me: "The Morgan-Cadell ferry was buzzed several days later.

"Witnesses include the ferry's captain, Mr "Aussie" Atkinson, said the first thing they saw was a light in the sky. It descended rapidly until it was visible as a bus-sized object about 60m upstream.

A brilliant blue light speared down from the craft.

Morgan, which is surrounded by lonely, uninhabited terrain, is only one of scores of Murray towns which have reported UFO activity.

Physicist Jacques Vallee wrote: "These mysterious objects are traditionally attracted, worldwide, to seas and rivers.

"Could it be that the chemical constituents of water provide UFOs with a source of power?"

## Life may be older than we thought

WASHINGTON: Fossil remains of the oldest cells ever found on earth have been uncovered in ancient rocks in the remote and arid reaches of north-western Australia.

They appear to push back the date at which such relatively advanced forms of microbial life are known to have appeared to 3.5 billion years ago — 1.2 billion years earlier than believed before.

The discovery, according to the scientist who made it, may compel some fundamental rethinking about when life began on this planet.

It shows that complex and self-contained bacteria-like creatures flourished when previous evidence suggested only primitive globules of organic matter without cell walls existed.

## Watch out—UFOs about, says Colin

Unidentified Flying Objects are being reported more frequently in SA according to Adelaide resident "Ufologist" Mr Colin Norris.

He says that over the past month he has received a dozen reports from the members of the public.

Of these, three stand out as being extraordinary, says Colin.

to find that it was coming from an object about a mile away.

He claims the object was shaped like a hamburger with two blue flashing lights on the top and the centre part had an orange window.

Mr Norris said: "The shed was vibrating because of the noise... McLaren Vale Hospital for shock."

## Hover

The third report came from a young man who was travelling with his fiancée, between Port Noarlunga and Christies Beach at about 8.30 pm on May 25 when he saw seven lights shaped like windows.

Mr Norris said: "Both told me they were rather shaken.

"The lights shot away out to sea and the two watched them move out towards Glenelg where they hovered then moved towards Port Adelaide.

"The seven lights were rotating in a clockwise direction."

GLADSTONE- Two UFO investigators from New York left for home this morning after verifying the sighting of a UFO Wednesday and saying it was one of the most important to take place in the U.S. in many years.

Pete Mazzola and Jim Pillow, international directors of the Scientific Bureau of Investigation, registered in New York, were in the area for the last day and a half looking into the sighting by six area police officers.

The six officers - two from the Gladstone Public Safety Department, two from the Escanaba Public Safety Department - all reported seeing the object at about 1am. Wednesday. The officers from Gladstone, Mark Hager and Dave Marin, viewed the UFO for more than 30 minutes near or on M-35 north of Gladstone. Both patrol cars from the sheriff's department and Gladstone reported chasing the object but lost sight of it as it flew toward the west.

It was described as having red, green and blue oscillating lights in addition to an extremely bright white light. K.I. Sawyer Air Force Base, the Coast Guard and the Department of Natural Resources all report that they did not have any aircraft in the area at the time.

When Mazzola isn't investigating UFO, he is a full-time New York City undercover police officer, while Pillow was a New Jersey police officer and is now a computer technician.

The SBI has some 2,000 members across the U.S. and half of those are police officers who act as investigators for the group. The goals of the non-profit organisation are to alert the public of the true facts concerning UFOs, protect the interests of the public officer involved in a sighting and primarily, to expose the U.S. Government concerning the suppressed evidence of UFOs that they contain, Mazzola said.

The group is concerned with police officers both because its two directors have police backgrounds and because "police officers are more apt to get involved with UFOs because they are out there, especially between midnight and eight when most of the public is asleep and when most UFO sightings take place," Mazzola said.

The directors of the group decided to come to Delta County from New York (720-mile distant) instead of sending one of their member investigators from Detroit because the case here was so unusual. Mazzola said the two started for Escanaba "as soon as we heard about it in New York from UPI news service."

This pair came all the way to the U.P. because "this was a case of major importance involving several different police officers from three different agencies, which made the report very valid," he added.

They usually only cover reported landings of UFOs, but they covered this case because it "was unusual due to the fact that you had not one or two cops involved but you had four, five, six cops reporting the same object from different locations, there was too much credibility here to let it pass," Fallow said.

The two said the case in Gladstone is one of the best and most complete cases they have worked on, and they have worked on between 45 and 50 what they call valid UFO sightings.

The two investigate reports of UFOs in much the same way as they would investigate a crime. "We try to build a case like a criminal investigation and if we went to court with this evidence we would win. We build the evidence to substantiate the fact that something unknown was up there, we ask if all the possibilities were eliminated, we ask if misidentification was eliminated, we did all this," Fallow said.

The pair were able to talk to the police officers involved in the sighting because of cooperation from the Gladstone Public Safety Department and Delta County Sheriff's Department, and they were even able to study the actual police reports concerning the matter.

They talked to and made reports on 24 witnesses of the sighting, but "eight will be eliminated because it seems they just jumped on the bandwagon, but of the rest we're sure that they did see the object," Mazzola said.

The investigators talked to the officers separately to double check their stories, and each one checked out. They also, for the brief time they were in the area, checked the officer's background and standing in the community.

Each officer reported that before Wednesday morning, they were skeptical of the existence of UFOs, but that is no longer the case. That's because now they "have been slapped in the face with reality, they believe in UFOs now," Fallow said.

Every officer told them that what they saw was not reflected lights but a material object. Quoting from the report of one officer, Fallow said, "It wasn't any aircraft that I ever saw before," the key word there is 'aircraft,' he did not say light or anything like that, he said 'aircraft'."

After talking to the officers and other witnesses and even after using the officers' reports and taking a "dry run" of the early morning's events, the two concluded that what was seen that cold, clear morning near Gladstone was indeed a UFO.

"We have reached a conclusion, what has happened here is that without a doubt it was a UFO. The speeds were incredible, the maneuvers were typical for a UFO but were incredible to those who didn't see them before, the colour changes were typical, everything was typical for a UFO," Fillow said.

Now that they have their findings, Mazzola said they "intend to make smoke we are going to call a press conference when we land in New York, this has made world headlines, and we want to make the public more aware of UFOs." One important point brought up by the officers who witnessed the object was that "The coloured lights were not standing still like they would on a plane, but according to the record the lights were revolving, at first they saw one colour, then another colour and then the next colour, not all at the same time," he added.

One apparent discrepancy the New York investigators said they uncovered dealt with the use or non-use, of radar at K.I.Sawyer Air Force Base near Marquette. Fillow said they received reports that air force personnel at the U.P. base said they did not have any idea if a UFO was out there because their radar was turned off, an explanation he called "a crock."

He explained, "This is a major defense installation in the Northern - mid-western U.S., and there's no way in hell they would turn off the radar!"

Agreeing with his partner, Mazzola said the two are "convinced that the Air Force did in fact have their radar on, because it did not sound logical, they are just evading the issue."

They said that right here in the U.P. this issue concerning the radar is an example of the Federal government trying to whitewash UFO sightings. But they added that they understand the air force's point of view.

"We understand the point of view of the air force base. Ufos aren't supposed to exist as far as the air force is concerned because of national security, panic to the public or whatever," Mazzola said.

Officials at the K.I.Sawyer Air Force Base said their radar operates on a 24 hour basis, so they say the radar was on at the time of the sighting. A misunderstanding becomes apparent between the two investigators and the base because a base officer said their radar has just a 50-mile range, not anything that could cover the northern-midwest. The base has weather radar in addition to tactical radar that is used for air traffic control.

Sgt. Jim Rosenberg of the base public affairs office said because the radar only has a range of 50 miles, a UFO sighted near Gladstone would be on the radar's fringes and there was a good chance if there was an object present, it would not be picked up by the base's radar.

The two were able to do such a substantial investigation because of the cooperation of the area police agencies. They were able to receive this cooperation because Fillow and Mazzola, both having some involvement with police work, can identify with area police and break down barriers that may exist for others.

"Pete and I both have cop lingo, we understand them, cops usually don't open up, and that's exactly what happened here," Fillow said, adding "there was a tremendous rapport between the two of us and the local police."

The two said they werewell received while in Delta County because "Many organizations, institutions and media have called in reference to this case from around the world, but we are the only ones who came here, that's a big difference," Mazzola said. The Scientific Bureau of Investigation is only just a little over a year old and was formed by the two because they did not agree with another UFO investigative group they had been involved with.

While they and other members of the group that are also policemen handle the investigative duties, other members of the organisation who have the ability handle the scientific and technical aspects of UFO research. They store all their information they gather in a computer in Houston and have Laboratories in New York and New Jersey. With them on their trip from New York to Delta County, the two brought thousands of dollars worth of equipment, which is just a small percentage of their equipment supply, Fallow said.


With this new equipment and technology, Mazzola said they have "been called the new breed of 'UFO-ologists' because we have new methods, innovations, techniques that have not been tried before.

NELSON AQUA-BLUE U.F.O. 5am. 7th. March 1980

Les White of Nelson has forwarded ZENOLOG the following report:- Mrs P.R. Paterson who lives in a position overlooking the Nelson Harbour said she witnessed a huge 'aqua-blue' UFO at 5am Friday, 7th. March 1980.


Her story reads:- "My husband was getting ready to leave for work, just a little before 5am. I was on my way back to bed, when I noticed from our bedroom through the glass doors to the patio, this strange large aqua-blue egg-shaped object coming from the south-west. It was silently travelling, slowly over the mudflats, across Haulashore Island, past the harbour entrance, (definitely WITHIN the harbour area, and still inside Boulder Bank and then disappear about 5am, out to sea to the North-East.

It seemed to be very close, its height was level to my position. I never let my eyes leave it until out of sight. I just couldn't believe what I saw. I thought to myself, 'Not a single soul will believe me!' I was a staunch disbeliever in UFO sightings, before I saw this strange object. It looked, nothing like any picture I have ever seen of flying saucers, and it worries me, as there was definitely something strange there.

It was no trick of the imagination, it was very clear, it seemed so very close. There were no windows, it was just a solid aqua-blue colour with a shaky sort of tail of the same colour.

To make matters worse, none of my neighbours saw anything, they would all be asleep at 5am. anyway. I rang 22M Radio Nelson, but I felt the announcer didn't believe me, as all he said over the "talkback" was:- "A woman on Britannia Heights saw an object." That's all, no time, no description. Some of the public rang afterwards, saying they saw lights - heard voices at different times, flashing colour etc.... But. nothing like the sighting I reported. The morning was warm, no cloud, no wind and visibility was unlimited." Ends report.


UFO HAD TAIL:-

A long tailed UFO was sighted early on Friday morning by two crew members of the fishing boat Waipori as it was heading for Port Nelson. (90km -55mls)

Mr Sean Garwood and a companion saw the mystery light at 5am. after the Waipori had travelled around Stephens Island and was on the run home. Mr Garwood described the UFO as being aqua-blue in colour, large and with a long tail. It was travelling in a horizontal direction toward the horizon. It was past of Maxwell Spit and toward a line with Jew Plymouth.

"We watched it for five to six seconds. It wasn't a shooting star, We've seen plenty of them", Mr Garwood said, "It's the first UFO I've seen."

LEFT:- Estimated size of object as compared to head of silhouette when passing harbour entrance.



