

POLLUTING THE WATERS OF TRUTH--by Jerome Eden

The May 1981 issue (Vol. 2, No.2) of UFO SIGHTINGS magazine is another product of deception produced and directed by publisher Myron Fass and brother Irving Fass. Unfortunately, like so many other spurious concoctions foisted on the unwitting public, it contains sufficient kernels of UFological facts. However, such facts are presented in fabricated wrappings and tied with so many tangled knots of nonsense and falsehoods as to make the entire package totally suspect to the serious researcher.

None of the major articles purporting to be "factual" are blessed by the names of their originators--so nobody can tell who is writing what! Secondly, fictitious names are obviously used for the proponents of the various science-fiction articles appearing in the magazine, and no sources are given for the information. The entire mixture is a cup of truth drowned in a gallon of sodawater, sprinkled with the usual sci-fi nuts and sugar-coated confections reserved for the comic-book set.

Into this mix of fruitcake and frenzy is carefully placed a major article on Wilhelm Reich by an anonymous chef who serves us a stew of truths carefully camouflaged in such a sauce of stupidities, claptrap and grotesqueries that the final mix--like the entire magazine--can neither be chewed, swallowed or digested. The article on Reich, complete with pictures purloined from various sources, is soberly titled, "UFO Secrets the Government Won't Tell." A few examples of its fruitcake mix should suffice:

"Wilhelm Reich's UFO research drew the highest praise from no less a figure than Albert Einstein," states the article in boldface headline. This is nonsense. Reich met Einstein in January 1941, some thirteen years before he ever became interested in UFOs.

Reich brought to Einstein "a bizarre black box." Another totally false statement. Reich brought an orgonoscope to Einstein's home, and then later delivered a small orgone-energy accumulator.

Reich, states the article, was interested in "shooting down" one or more UFOs. This is another blob of sheer fantasy designed to muddy the waters of fact. What Reich did demonstrate was the fact that he could withdraw the energy from certain UFOs which made them move in an attempt to flee, or they faded out partially or totally. In addition the author of this mishmash confuses the various names given to the orgone-energy accumulator as referring to different inventions (e.g., "oraccu") when they refer to the same invention. The author claims that no original plans for Reich's devices "survive" including a mysterious "black box". Again this is untrue--Reich's original drawings for the accumulator appeared in his book The Cancer Biopathy, which has been reprinted and is currently available. Furthermore, any "strange black box" exists only in the nameless author's mind.

Myron Fass et. al. once published a creditible UFO magazine, OFFICIAL UFO, to which the most respected writers submitted articles. Subsequently, OFFICIAL UFO became a cosmic comic book, the biggest laugh around. No serious UFologist writes today for any publication (one should say "fabrication") manufactured by Fass and friends. Fass and Fass are known as the "chameleon brothers" (because while they continually change the name and cover of their publication they always remain the same). They are either conscious or unconscious tools of someone or some agency that wishes to ridicule and destroy interest in Reich through association with the lunatic-fringe set. An Open Letter to UFO Researchers

March 1, 1981

DEAR FELLOW UFOLOGIST:

Those of us who have been seriously active in UFOlogy for any length of time know that something has been very rotten, not only in Denmark, but also throughout every major nation on our planet with respect to "telling the truth" regarding UFOs. There is, as Stanton Friedman continues to state publicly, a "cosmic UFOgate" of incredible proportions. The deep gravity of the situation is clearly spelled out in the works of such researchers as Keyhoe, McDonald, Stringfield, Fowler, VonKeviczky, and many others who have spent years trying to track down the facts, mostly by investigating and analyzing hundreds of UFO sightings.

I am enclosing a copy of "The Emotional Plague Versus Orgonomic UFOlogy" in order to attempt to open your eyes to another possibility. Let me, in the words of Charles Dickens, "put the case" in this manner:

Suppose that a brilliant, albeit controversial, scientist just happened to make some very extraordinary experiments dealing with the elusive phenomena we call UFOs. Suppose further that this "controversial" scientist actually succeeded in disabling UFOs by way of his new and extraordinary research. What would be the official, public attitude of "the government" toward this unusual scientist and his work? How could such work be kept a secret by so many for so long?

To answer such questions I remind you of the official, public attitude of government toward UFOs. They have kept this secret not merely by denials but by continuous public derision and ridicule of the entire subject! Few people have the courage to stand up to continuous ridicule. Once something or someone is publicly, and "officially" and continuously ridiculed, very few are willing to touch that subject or seriously investigate it. Only now, more than three decades after the Kenneth Arnold sightings, is the truth finally coming out.

The ridicule did its job, and did it very well. So too has the ridicule regarding the work of Dr. Wilhelm Reich done its job very well. The best means of "concealing" the important UFOlogical research of Dr. Reich was not to suppress it, but simply to cover it with ridicule. Proof of this is the fact that YOU have never seriously thought to study the work of Reich, isn't that right? He went crazy, right? For years now (as you shall see from the enclosed) your fellow "scientific" researchers have told you, time and again, that Reich was a nut! So why bother? I ask you, however, to consider these points:

In 1954, a top-level USAF-CIA conference was convened by General Harold Watson with one of Dr. Reich's associates to discuss Reich's disabling of UFOs (consult the enclosed for references). That same year, Reich was served with an Injunction by another

government agency which led to the banning and burning of all of his published works and the eventual imprisonment and death of this scientist! Dr. Reich discovered the existence of a mass-free, pre-atomic energy which pervades our universe. He named this energy "orgone energy." It was with an invention of his, based upon the principles of orgone energy, that Dr. Reich disabled UFOs!

As Reich's last work, Contact With Space, shows, it is this very energy that is used by the UFOs in their propulsion system. Dr. Reich did not go to prison because the "government" (whoever that is) proved its case against him. He went to prison because he refused to halt his research to answer a complainant who was out to destroy him and crush his work!

The Court Records--which are in the public domain--are still available to you, assuming you can see through the smokescreen of ridicule that has for more than thirty years sought to cover these vital matters with derision: "UFOs do not exist! Orgone energy is nonsense!" Unfortunately you fell for this trickery, and you are still being victimized by it. And the ridicule goes on:

On January 11, 1981, the nationally syndicated news magazine, Parade, featured a photograph satirizing Dr. Reich's inventions, with a totally spurious caption leading the reader to believe "the government" banned Dr. Reich's work! Reich died in a federal penitentiary November 3, 1957. Why is it necessary to continually try to "kill" the work of a man who was killed nearly a quarter-century ago?


On February 2, 1981, the same ridiculing display appeared on the national television show, "Good Morning, America."

During this same period, the 1981 inaugural edition of The UFO Encyclopedia appeared, edited by Margaret Sachs, wherein Ms. Sachs tells us, "according to biographers" Dr. Reich became "seriously insane and developed persecutory symptoms." Ms. Sachs fails to note that court-appointed psychiatrists, as well as the many psychiatrists who worked with Reich, judged him perfectly rational! 

My Dear President Reagan:

I was the only citizen of the United States, who as a military research scientist on the UFOs global problem became a persona non grata of the Lyndon B. Johnson administration, which in 1966, placed me illegally on the notorious security risk of scientists. The reason was that in February/March, 1966, as a public servant of the United Nations Secretariat, I proposed through verified evidences to my secretary General U Thant, and his Cabinet the following:

- 1/ The UFO forces potentially dangerous operation, as a global security and scientific problem, ought to be surveyed and controlled by the United Nations in a coordinated international effort. (Consult Encl. No.2, Blue Memorandum - BM 10-12, 22)
- 2/ The nations of our celestial body should seek contact and communication with THESE extraterrestrial forced through an established International Authority, because since at least 1952 (issue of the JANAP-126), the galactic origin of these spacecrafts had been confirmed by the military and space exploring superpowers, and the nations' military defense. (BM 32-52, 77, 79 and 54-77)
- 3/ The United Nations should prohibit any armed confrontation with the UFO forces and provide, as established in its charter, for the fundamental international security. (BM 105-113)

As a loyal republican, and sustaining member of the Republican National Committee (Enclosure # 1.) I, Colman S. VonKeviczky, directed my ICUFON organization to refer the above mentioned International Project to President Richard M. Nixon in October of 1973, and to President Gerald R. Ford in September of 1974, and now presently entrust it into your hands in order to ESTABLISH THIS AUTHORITY WITHIN THE UNITED STATES OF AMERICA. (Encl. #2, Project WASA)

A Thwarted Project: The vital necessity of the 1973 and 1974 motions was motivated with the following:

- over -

a/ The recent military secrecy and rash confrontation upon the superior science and technology of the exploring space civilization(s) constitute an INSANE ACT. - Speculating that we will gain by hostile action against them is, simply stated, an IRRESPONSIBLE GAMBLE WITH THE EXISTENCE OF OUR CIVILIZATION. (BM 85, par.3, and 132, par.4.)

b/ To seek and establish contact and communication with the exploring forces of the Galactic Powers is the only logical and common sense solution to the decades-long deferring UFO problem. (BM 114-122)

A face-to-face contact could bring immeasurable possibilities for the Earth, e.g. new energy sources, a revival in sciences and technology, etc., not only for the United States but for the whole of mankind.

c/ Solution: The United States should DONATE A SUITABLE TERRITORY TO ALL THE NATIONS to establish a WORLD UFO AUTHORITY. (Capitol Hill should ponder whether to allocate a budget for those scientists who, on the one hand, are hunting in vain for signals of alleged space civilizations 25 thousands light years away in the vast Universe, while on the other hand, they challenge and ridicule the competent military forces' effective UFO evidences. (BM 88-94, 130-135)

d/ Finally, this institution should be the Alma Mater of those selected post-graduate young generation of scholars, who will be considered for the leadership of mankind's SPACE AGE. (BM 127-128)

As usual, the Project was thwarted by the government and suppressed by the news media and the press. (BM 23, 25)

Time And The Pentagon Confirm

In spite of these unconstitutional and illegal actions against a project of vital importance for humanity, ICUFON's aforementioned warnings to the USA and all the nations have been UNYIELDINGLY CORROBORATED by approx. 4,000 documents recently declassified under the Freedom of Information Act by the United States Joint Chiefs of Staff; the Department of Defense, the Department of State, the Intelligence Community (CIA, FBI, DIA, NSA), and other governmental agencies (BM 29-53). - ICUFON's statements were additionally reinforced with similar declassified military UFO classics by the Chiefs of Staff of Argentina, Canada, France, Italy, Spain, United Kingdom, USSR, etc. (BM 54-76)

During your presidential campaign you emphasized that the time has come "to meet the challenges facing America and restore our nation's strength and security". I respectfully believe you may have added the scientific credibility and trustworthiness which has become particularly deteriorated by the government's narrow-minded national and international policy of "do something for nothing" on the UFOs global problem. (BM 82-94)

With the exception of distinguished UFO research organizations and scientists, this official policy followed during the past decades, has led the investigation, public information and responsibility for humanity's existential problem into the hands of unauthorized and mainly sectarian and hobbyistic so called "UFO research" groups. It is now the governments' grave problem that these large internationally organized societies, often supported by a non-profit status, are

controlled by "Ambassadors of the God", "Envoys of Jesus Christ", "Planetary Emissaries" and the like, who are posing as the "Saviors of Humanity" (REMEMBER GUYANA!). - Their concocted "intergalactic ideologies" with twisted parapsychological and "beyond the grave" evidences have undermined our civilization's chances of dealing seriously and officially with the UFO problem, as well as on the credibility with their governments regarding this issue. The same irresponsible approach has also thwarted any efforts before the United Nations (BM 14-27) and other official attempt (BM 127, U.N. University) at solution of this pressing international problem. (BM 114-122)

Hazardous Policy Beyond The Exposed Evidences

Mr. President, ICUFON's three decades of military research has been verified as a fact that the KEY TO THE UFO PROBLEM is concealed AT ALL THE NATIONS' MILITARY DEFENSE - as admitted - IN THEIR CONTINUOUS COVER UP WITHIN THE COGENT MILITARY SECRECY.

Evidence: On January 29, 1980, as invited speaker before the British House of Lords UFO Committee, during a closed session, I EXPOSED THE ABOVE INDICATIONS WITH HARD CORE MILITARY DOCUMENTATIONS OF THE MAJOR POWERS. - With the enclosed WASA (World Authority For Spatial Affairs) project, I urged Her Majesty's government and those of other esteemed nations to:

"LIFT UP THE COGENT MILITARY SECRECY ON THE UFO LEVEL ONLY!" - A final solution of the world-wide UFO problem should be adopted only after each nation's MILITARY FORCES, representatives from the SCIENTIFIC COMMUNITY, and the PIONEER UFO RESEARCH formally have convened for a final determination of the problem, and act if necessary before it is too late...

Great Britain's Ministry of Defense moved at once against the "DANGEROUS PROPOSAL" which jeopardized its CONSPIRATORY COVER UP POLICY with its covert 'D(defense) NOTE' to editors and media managers. As a result, ICUFON's Press Release and the WASA Project's documentation were immediately banned from the media and the BBC-TV documentary, and scheduled interviews at the SUNDAY TIMES and the GUARDIAN were not published.





MEMORANDUM FOR THE PRESIDENT:

The following is the information we have from GHQ at this moment regarding the air alarm over Los Angeles of yesterday morning:

*From details available at this hour:

"1. Unidentified airplanes, other than American Army or Navy planes, were probably over Los Angeles, and were fired on by elements of the 37th CA Brigade (AA) between 3:12 and 4:15 AM. These units expended 1430 rounds of ammunition.

"2. As many as fifteen airplanes may have been involved, flying at various speeds from what is officially reported as being 'very slow' to as much as 200 MPH and at elevations from 9000 to 18000 feet.

"3. No bombs were dropped.

"4. No casualties among our troops.

"5. No planes were shot down.

"6. No American Army or Navy planes were in action.

"Investigation continuing. It seems reasonable to conclude that if unidentified airplanes were involved they may have been from commercial sources, operated by enemy agents for purposes of spreading alarm, disclosing location of anti-aircraft positions, and slowing production through blackout. Such conclusion is supported by varying speed of operation and the fact that no bombs were dropped."



My Dear President Reagan:

In reference to the MEMORANDUM for a WORLD AUTHORITY FOR SPATIAL AFFAIRS set before your office on January 28, 1981, we, the Scientific Bureau of Investigation, Inc. (SBI), base the following conclusions:

1. A 1978 Gallop Poll indicates 57% of the American public believe UFOs exist. This is nearly 13 million people of which 11 million claim to have actually observed UFOs. 2. Through the Freedom of Information Act, almost 4000 documents have been declassified relative to UFOs. It proves the UFO phenomenon is global in nature & has been active over numerous military bases & strategic installations. They also lead one to believe there are things the powers-that-be don't want us to know as American citizens, tax payers and voters. The entire subject has become a COSMIC-Watergate crying out for an informant or the media to expose the truth once again.
3. U.S. Air Force Training Manual, entitled, Introductory to Space Science(Vol.2) does contain a chapter (#23), titled, Unidentified Flying Objects. I quote from it: "There are a large number of different saucer shapes but these may mean little. For example, look at the number of different types of aircraft which are in use in the USAF alone. It is obvious an intensive study is needed in this area. From available information, the UFO phenomenon appears to have been global in nature for almost 50,000 years. In any event, even if hostility is not the case, UFO presence is evident over every country on the globe. This alone can present unseen complications and possible retaliation from other nations who proceed a nuclear attack rather than UFOs.

In conclusion, no matter if the UFO cover-up is being initiated because of: a secret military weapon; a "face saving" policy since our government cannot explain the lack of control in its own air space; since no nation can intercept or **has** a defense against them; for fear of mass public panic; since UFOs may present a threat to our government's "financial or ego status" if UFOs become of a special interest to the public because of new knowledges & methods presented and thereby, reduces the power & ability to manipulate the public, is irrelevant. What is relevant, in any event, no matter what end of the scale human reaction may be weighed, there is one thing for sure: WE HAVE A RIGHT TO KNOW! So, subsequently, the SBI supports the ICUFON Memorandum wholeheartedly. We urgently suggest you implement the necessary steps in order to make the UFO cover-up known to the American people. It is imperative you do not become the "scapegoat" for the cover-up which has taken place for 3 decades prior to you taking office..

The SBI and its associated national and foreign representatives of UFO research would be honored and pleased to extend our services to the government of the United States of America in any capacity you may deem appropriate.

On behalf of the SBI, its International Directors, and our associated organizations, we wish you long life, good health, and the full support of the American people,





New wonder spy plane born on a kitchen table

A REVOLUTIONARY new spy-in-the-sky plane that can take off and land on a dime may give the U.S. Navy an edge over the vaunted Soviet fleet.

The airplane, known only as Design 698 is powered by two oversized, tilting jet engines which allow it to take off vertically like a helicopter from small ships, and still fly at 500 mph at altitudes of up to 50,000 feet.

Said Bob Kress, who designed the plane on his kitchen table using wood, styrofoam and attic fans: "With perhaps 30 or 40 special ships each carrying 10 of these aircraft, we can increase our ability to monitor Soviet activity five to seven times."

With special radar that can "see" over the horizon, and equipment to track enemy planes, ships, missiles, submarines and even moving ground vehicles, the Design 698 can take over the jobs of half a dozen special surveillance planes in use today.

"It's a new way of putting more surveillance at sea," said Kress, director of

advanced concepts at the Grumman Aircraft Corp. in Bethpage, N.Y. "The plane increases the 'vision' of the ship."

The military version of the plane costs \$10 million apiece, and the special ships that could carry 10 of them would cost \$500 million — compared to \$2.5 billion for a conventional aircraft carrier.

Kress sees the new plane also being used for civilian purposes in the future taking off and landing in the center of cities.

In the end, we shall overcome and force these "sewer mouthed" people to openly admit we are here and doing a good job. Futuramic 'Rail Gun' Could Revise Weaponry

DOVER, N.J. (AP) — U.S. Army technicians at the Picatinny Arsenal are working on a rifle so powerful that a marksman in New York might some day theoretically be able to hit a target in Los Angeles faster than he could get his finger off the trigger.

* * *
The experimental electromagnetic launcher is known as the rail gun.

Experiments on the device are being consolidated at the Army Armament Research and Development Command in Mor-

ris County.

Researchers say they have a long way to go on the weapon which could revolutionize certain aspects of warfare, but they also say the principle behind the rail gun has even more potential for uses in energy, transportation and space launch developments.

"Right now the rail gun technology can already contribute greatly to the solution of energy fusion, and work where other experiments have failed to produce energy sources," Dr. Harry Fair Jr., chief of propulsion technology at the Picatinny Arsenal, said Monday.

He said the rail gun also can be used to launch flights of aircraft and create ultra-strong welds of metal.

Fair said a model "magneplane" built by two American scientists, but not used by the U.S. Department of Transportation for unknown reasons, is being used by the Japanese to construct a train that is supported on an electromagnetic field and travels on a cushion of air.

The gun at Picatinny, unlike an explosive rail gun developed in California, operates by passing a powerful electrical current through two copper rails to create a magnetic field. A projectile between the rails is driven forward by the magnetic field that could, theoretically, thrust the projectile at the speed of light, Fair said.

A rail gun developed by the Livermore Laboratory in California and the Los Alamos Scientific Laboratory in New Mexico relies on a smaller power source and uses "any of your garden type variety of explosives" to compress the magnetic field, Fair said.

The rail gun has already fired a projectile at more than 20,000 feet per second, which is about four times faster than a bullet fired from the Army's best rifle, Fair said.

Fair said problems must be worked out on the gun, which originated with experiments by Norwegian scientists in 1900, and was considerably advanced by German technicians during

World War II.


But much progress has been made since the modern rail gun was built in the mid-1970s by scientist Dick Marshall at the Australian National University, he said.

* * *
Marshall was trying to use his device to achieve impact fusion for use in electrical generation. Fair described impact fusion as an attempt to fuse hydrogen atoms, releasing heat, by slamming a projectile into a target at high speeds.

Advances in launcher technology also came from two other physicists, Dr. Henry Kolm of the Massachusetts Institute of Technology and Dr. Jerry O'Neill of Princeton University.

Scientists are still working on reducing the size of the enormous power supply needed to operate the gun. Use of the rail gun as a hand weapon does not seem likely, Fair said.

The Soviet Union is working on a similar device, he said.

OBITUARY

IN MEMORIAM GENERAL CARLOS CASTRO CAVERO -- who opened some of Spain's military UFO secrets

Some Spanish Generals have been seen lately on a dark light, due to their truncated coup against Madrid's monarchic democracy. General Carlos Castro Caveró, former Commander of the Canaries' Air Zone and later Commander-in-Chief of Spain's Third Aerial Region, had nothing to do with the recent sabre rattlings. In fact, the General passed away a few months ago and that's why we are publishing this brief homage. But why, you may ask? What has a Spanish General to do with the SBI or with UFOs? The answer is simple. Although very little known by American saucer "experts", Gen. Castro Caveró was a key figure in relaxing official UFO secrecy in Spain (fueled by decades of military rule under Generalissimo Franco.) It has also been speculated that it was the General's close relationship with Spanish UFO journalist and author Juan Jose Benitez, which made possible for this one to obtain several hundred pages of declassified military UFO documents.

General Castro Caveró's openness with the public, however, went even further. In an interview with J.J. Benitez, he didn't hesitate to confirm and describe a UFO sighting he had witnessed personally. He was equally open to state his own position on the matter and to give a rare glimpse about the exchange of UFO data between the governments of the world. The final UFO legacy of Gen. Castro Caveró we know of, is contained in a personal and confidential letter to his friend Benitez, in which he apologizes for not being able to give an official report since, he explained, "you don't ignore that we are forbidden to make any type of official statement concerning these issues." Yet confidentially, the General confirmed to Benitez that yes indeed, radar UFO incidents had taken place during the same

period of a reported UFO wave in the Basque Region with some alleged landings in the mining location of Gallarta. Although Benitez was involved at the time in an acrimonious debate among ufologists with regards to the Gallarta close encounters, he had to keep the letter to himself. Now that Gen. Castro is gone, Benitez finally published the document in the August 1980 issue of Barcelona's Mundo Desconocido magazine. Before translating to English this valuable document, we feel it is appropriate to reproduce some quotes from Gen. Castro Caverro's classic 1978 interview with J.J. Benitez.

Air Force Division General Carlos Castro was then Commander of the Air Zone of the Canary Islands. As some of you might know, a few spectacular and highly dramatic UFO sightings had taken place in these islands on previous years (1975/76/78.) The General went straight-forward to the substance of the UFO issue: "Yes, I have been convinced for some time that UFOs are spaceships or devices of extraterrestrial origin. These assertions of mine are based on the various reports that we are receiving. When we can't identify 'something' as an airplane, a weather balloon or a meteorological phenomenon, we call it an OVNI, or 'objeto volante no identificado' (unidentified flying object)."

"And those unexplained cases," asked Benitez, "you call them spaceships or extraterrestrial devices?"

"Yes, those," responded the General. "For instance, when we are unable to identify with an aircraft its known movements with its ascending speed or its tactical maneuvers, then, summarizing, we call it unidentified aircraft."

When Benitez asked the General if he had ever witnessed the movements of that type of UFO, contrary to all expectations, the General responded candidly: "Yes, I have seen them.... I was in a ranch I have in Zaragoza, specifically in Sabada. I saw there a glittering object; it was still, at a height very hard to estimate

since I couldn't discern its size. But as I tell you, it was very brilliant and without moving. I called members of my family, friends, workers from the ranch, etc. and all of them could see it. Now, I took special notice of its movements.

The UFO was seen for over an hour on a bright morning at about 11:00 A.M. The object then took off rapidly, heading on a Southern direction, and covering a distance of 20 kilometers in two seconds, according to the estimates of the General. It stopped and then moved again for a short period. It finally disappeared out of sight with an "impressive ascending velocity." The phenomenon had been observed throughout the province of Aragon. It was later said that a French weather balloon caused the sighting, but the General viewed this quick explanation with skepticism. "Of course I don't believe that what I saw had anything to do with that weather balloon," he said. "Why? Because weather balloons don't move at that speed, nor can they ascend at the speed the UFO did--and even less to remain static for over an hour..."

Once he had warmed up with the description of his own UFO sighting, Gen. Castro Cervero confirmed that "everything is in a process of investigation both in the United States and in Spain, as well as in the rest of the world." The General then pointed out that, "I believe in the existence of UFOs, but what happens to the official elements is that they are very reticent to recognize that something exists, in a similar way, for example, as the Church is to verify that this is a miracle... Look, as a General, as a military man, I have the same position that the one officially held by the Ministry (of Defense.) Now, from a personal position, as Carlos Castro Cervero, I believe that UFOs are spaceships or extraterrestrial devices." The General was also of the opinion that there was no reason to be surprised with the fact that "somebody" was screening us. "Our world," he said, "is a very populated planet, with numerous characteristics and elements that could attract these unknown space visitors. I think, for instance, in the large illuminated complexes that are our cities,

in the intense traffic, in the huge human concentrations... It isn't strange that all this could constitute a motive for study or attraction."

Gen. Castro Cervero also confirmed that there were over 20 cases (in Spain) of unsuccessful interceptions by Air Force jet fighters. He speculated that the reason for the governments of the world to withhold the real UFO story from the public, "was perhaps because they can't give a precise and formal announcement of what they are." When asked if we are approaching the moment when the truth will be finally released, the General was emphatic in saying, "No, I don't believe we have reached this moment. The nations of the world are currently working together in the investigation of the UFO phenomenon. There is an international exchange of data. Maybe when this group of nations acquire more precise and definite information, will it be possible to release the news to the world."

With this historical interview, Gen. Castro Cervero went a step further in his statements from those of other famous military men such as Gen. MacArthur, Gen. George Brown, Air Marshall Lord Downing or French Defense Minister Robert Galley. Yet, General Castro Cervero was subsequently promoted to Commander-in-Chief of Spain's Third Aerial Region. As usual, journalist Benitez inquired with his "top-ranking military source" when the UFO wave in the Basque Region hit the local news early in 1978. The General obliged once again, but on a strict confidential basis. Benitez had to withhold his "ace" in the following ufological battle over the Gallarta landings. As a final tribute to Gen. Castro Cervero, as well as further confirmation of the existence of UFOs from a totally reliable and credible source, here is the English version of the letter published in Mundo Desconocido:

My dear friend J.J. Benitez:

I apologize for the delay in responding to your letter. I have finished reading your books, Another Humanity Existed and UFOs: S.O.S. to Humanity, and I expect to start soon the third one that you so kindly dedicated to me. As you know from our last interview in my house in Madrid, I firmly believe in UFOs. Your constant investigation enriches us all. I pass now to respond your questions with regards to the possible "landing", as you put it, of UFOs over the province of Vizcaya during the past months of February and March (1978.)

Naturally, as you know very well, I can't inform you officially or as Chief of the Third Aerial Region. You don't ignore that we are forbidden to make any kind of statements about these things. Personally, however, and trusting as always in your natural discretion, I am able to comment that throughout those months, our Radar Station "Siesta" detected on its screens up to a total of five echos or "unidentified" moving targets. These observations took place always during the night on three different occasions.

On the first, the radar identified two echos: one fixed at a height of some 9,000 feet, and a second always moving at conventional or subsonic speeds. On a determined moment, the moving echo--or "unidentified flying object" if you prefer it--experienced a descent at such speed that could not be achieved by current aircraft. Because of this rash descent, the echo escaped the radar detection and the corresponding code was no longer perceived. Although the radar comptroller moved the antenna in all the possible angles and to its utmost limit, he was no longer able to "see" the target. It is certainly within possibility that the echo, which corresponded to a solid object, came close to touching ground or flew at such a low altitude that the radar was not able to detect it.

On following occasions, "Siesta" had on its screens a total of two unidentified echos--one each night--whose flight manneuvres, particularly its turns and ascending speeds, are not known in current aviation. Curiously, and this coincides with

your news about those "landings" in the mines of Gallarta, the targets were located in the coordinates 330 - 360 degrees (Northern direction) and at some 150 miles from the Station. If you look in the map you will notice that the area corresponds precisely with the province of Vizcaya.

There was a fourth case of registration of unidentified echos on the radar, but on that occasion it took place outside the area you are interested in.

Finally, your information is equally correct with regards to the take off in alert of interceptors from the Air Base in Zaragoza on those same dates. There were "scrambles" on two nights and up to a total of three "Phantom" jets took off. Those flights were directly related with the presence on the radar of the previously mentioned unidentified echos.

This is all that I am able to confirm to you as a friend. As you see, the UFOs "chosed" your province on those nights.

Once again, many thanks for your books. Receive the warmest regards from someone who knows he is your good friend.

SBI Foreign Representative Antonio Huneus has been corresponding with Spanish UFO journalist and author, Juan Jose Benitez, for quite some time now. Benitez and Huneus are also working together in one, and possibly more joint projects, of which you will probably hear more in the future. According to Huneus, Benitez is one of the most prolific writers he has ever seen, putting together two or three books a year. One of the future possibilities would be precisely to translate some of his works to English, which by the way are both very informative and entertaining.

Como usted sabe por nuestra última entrevista en mi casa de Madrid, yo creo firmemente en los ovnis. Su constante investigación nos enriquece a todos. Y paso ya a responder a sus preguntas, en relación al posible "descenso", como usted lo califica, de ovnis sobre la provincia de Vizcaya en los pasados meses de febrero y marzo.

Naturalmente, como usted sabe muy bien, yo no puedo informarle oficialmente o como Jefe de la Tercera Región Aérea. Usted no ignora que tenemos prohibida cualquier tipo de declaración oficial sobre estos temas. A título personal, sin embargo, y confiando, como siempre, en su natural discreción y prudencia, sí puedo comentarle que a lo largo de esos meses, nuestra Estación de Radar "Siesta" observó en pantalla de exploración hasta un total de cinco ecos o blancos movibles "no identificados". Estas observaciones se produjeron siempre durante la noche y en tres jornadas diferentes.

En la primera, el radar identificó dos ecos: uno fijo a unos 9.000 pies y un segundo, siempre en movimiento y con velocidades convencionales o subsónicas. En un momento determinado, el eco movable - u "objeto volante no identificado", como prefiera - experimentó un descenso, a gran velocidad, que ningún avión actual puede desarrollar. A causa de ese brusco descenso, el eco escapó del barrido del radar, que dejó de percibir la codificación correspondiente. Se produjo un "scramble" en dos noches y despegaron hasta un total de tres aviones "Phantom". Estas salidas obedecieron precisamente a la presencia en radar de los mencionados ecos no identificados.

Esto es todo lo que, a título de amigo, puedo confirmarle. Esas noches, como ve, los ovnis "eligieron" su provincia.



Did a UFO really explode over Queensland, leaving strange wreckage, now held by the US Air Force? No, says UFO researcher Bill Chalker. Yes, say authors John Pinkney and Leonard Ryzman in their book "Alien Honeycomb". Both sides argue their case...

THE CASE AGAIN

By **BILL CHALKER**

DO TWO Australian writers, John Pinkney and Leonard Ryzman have in their possession "the first solid evidence of UFOs" — pieces of an exploded UFO? I along with many other UFO researchers do not think so. We believe the material is man-made and irrelevant to the subject of UFOs.

Pinkney and Ryzman made their claim in the book "Alien Honeycomb", (Pan Paperback, 1980), about material found in the Greenbank area of Queensland, on a property overseen at the time by Mrs Jean Fraser. The book was the subject of an article in PEOPLE on June 12.

The publisher's blurb on the back of the book assails us with the following extraordinary claims, none of which I believe are substantiated by the book's contents:

- A "richly-coloured UFO exploded over a vast, empty property in Queensland, Australia";
- "Most of the wreckage — strange, intricate, eerily beautiful — is now held by the United States Air Force in maximum security vaults";
- "These pieces contain unknown elements and configurations that will present science with new, fundamental problems."

As an industrial chemist-quality control manager by profession, with a deep interest in the UFO subject from a scientific point of view, I am particularly interested in alleged physical evidence for UFOs in Australia.

To this end, I co-ordinate, under the auspices of the Australian Centre for UFO Studies (PO Box 546, Gosford, NSW,

2250), the Australian Physical Evidence Study Group (APESG, c/- PO Box 6, Lane Cove, NSW, 2066).

The APESG promotes high-quality investigation and research of physical evidence for UFOs in Australia. Thus I have more than a passing interest in the claims made about the "alien honeycomb".

Let's now address ourselves to the main claims of the authors.

No coherent evidence is presented in the book to substantiate the claim that a UFO exploded. Even Mrs Fraser felt that the "honeycomb" did not come from the "UFO" she saw back in 1966.

As it was not seen exploding, this sighting appears then to be irrelevant to the discovery of "honeycomb" on the property two to three years later.

Again no hard evidence is given to substantiate the claim of a

"cover-up" of the "alien honeycomb" by the RAAF and the Pentagon.

The "honeycomb" was obviously manufactured and as Amberley Air Force Base was nearby, it is perhaps only natural that the RAAF were obliged to retrieve the material and check it out.

Unworthy of any mystery

Paul Hebron, a Queensland researcher, has discussed this situation with Amberley personnel. However, only the crash of a Canberra bomber in the area during 1965 is considered as possibly relevant. As an experienced aircraft engineer Paul knows that "honeycomb" material is used in the Canberra.

The alleged analysis of the "honeycomb" is treated in such a spartan manner in the book itself, that it tells us absolutely nothing about the real nature of the material. The book also carries completely subjective appraisals by anonymous scientists.

Through a lack of familiarity with the particular technology appropriate to what the "honeycomb" is, they added an order of mystery, which the material in no way deserved.

The authors preferred to make a somewhat naive appeal to the United Nations to study the "alien honeycomb", rather than allow any recognised laboratory in Australia to analyse their material.

Dick Smith, Sydney millionaire and electronics entrepreneur, took an interest in the "alien honeycomb" affair. With Dick Smith's involvement and his own interest, Gary Crapp of Sydney volunteered to go to Brisbane to investigate the matter further.

He succeeded in interviewing Mrs Jean Fraser, from whom the book's authors obtained their "alien honeycomb".

Crapp also obtained material from Mrs Fraser, which she confirmed as being the same material as the subject matter of the book, "Alien Honeycomb." Dick Smith had the material analysed by UNISEARCH Limited at the University of NSW in Sydney.

The university analysis indicated that the material they studied was entirely mundane and easily identifiable as "woven fabrics in plain and sateen weaves and woven from multi-filament fibreglass"! The analyst, Dr T.S. Hickie, senior lecturer in the school of textile technology, indicated that "there were no unknown elements present in the materials examined."

Furthermore the "configurations" were entirely explicable and similar to ordinary fibreglass. In fact, one weave (which appears in the so-called "honeycomb") is "the simplest of all weave pattern and has been known for thousands of years".

Dr Hickie added: "Fibreglass yarn has been manufactured in quantity in many countries throughout the world since production of commercial grades began about 1936."

In the absence of any other evidence, one has to dismiss the authors' claims of "unknown elements" as totally spurious, and probably more likely a consequence of an inability to properly analyse the material.

Just what is alien honeycomb?

Well what is the "alien honeycomb"? The university analysis indicates that the material is identical with high-strength honeycomb bonded structures, marketed by Ciba Geigy under the trade name AEROWEB. In the case of the Greenbank material, we appear to have woven glass (fibreglass) honeycomb, expanded and cured with polyester, or covered with phenolic dip-coated resins.

This material has wide applications particularly in the aerospace industry and is an integral part of aircraft technology. Its use is appropriate wherever light-weight and high-tensile strength are required.

At least three likely explanations for the "alien honeycomb" have surfaced:

- Aircraft debris. Three aircraft are known to have crashed in the area. One of them — the Canberra bomber — seems to fit the bill.

- Railway carriage debris. One large fragment of "alien honeycomb" was found alongside the railway line.

- Truck material, according to several local Greenbank area sources.

One does not have to soar as high as a UFO for a reasonable explanation.

The authors have certainly not satisfactorily exhausted the possibilities of a mundane origin of the fragments. If the material had survived this gauntlet (which it has not), then and only then should they have seen whether any UFO connection was of substance.

Mundane, man-made material

Enough said. With a critical assessment of the "evidence" presented in the book "Alien Honeycomb", and the facts collected by independent investigators, the obvious conclusion must be drawn. The "alien honeycomb" is not so alien and in fact is entirely mundane man-made material. The material is irrelevant to the UFO subject, except for what small niche it may find in the annals of "UFO folklore".

Such findings do not discourage me from the search for real "physical evidence" for UFOs. Already material exists which has a far more compelling connection with UFOs than "alien honeycomb."

I believe that the "alien honeycomb" affair is a microcosm of lessons that should be learned by both people who profess to investigate the subject and those who wish to gain a better understanding of it. Being a quality control manager thrusts home to me that the integrity of the UFO phenomenon, and its viability as a subject worthy of serious attention, has suffered considerably due to a lack of quality control in the UFO data. ■

WE STAND by the statements we make in "Alien Honeycomb".

As the book makes clear, we are determined that an independent, international body will re-analyse the material in our possession. Under stringent scientific analysis, this material does NOT check out as fibreglass.

UFO group co-ordinator W. Chalker and his unlikely collaborator, UFO-debunker Dick Smith, are welcome to the conclusions they are plainly anxious to draw.

Dick Smith was so intent on demolishing us that when he appeared with Pinkney on Channel 10's John Singleton Show (June, 1980) he dismissed the book's conclusions as rubbish — then admitted he had not even read it.

In the book itself we discuss this type of approach to the UFO phenomenon and give it as our reason for seeking the most independent and open re-analysis of our pieces.

Our further reason for seeking such an appraisal is dramatised by Mr Chalker's pronouncement: "We appear to have woven glass (fibreglass) honeycomb . . ."

Fibreglass theory was pursued

Mr Chalker presents this opinion about the material's appearance as a revelation, which shows us that he has either not read the book carefully, or has forgotten that we ourselves pursue the fibreglass theory in detail to its conclusion.

In fact, we refer 24 times to the fact that the honeycomb resembles fibreglass (see pages 96, 98, 122, 126, 127, 128, 135, 137, 138, 139, 140).

Mr Chalker also seems to feel that the "weaving" will come as news to us. In fact, we use the description "woven" five times in a single line (page 121). We also refer to the "weaving" on 14 other

occasions (pages 135, 136, 138, 139, 140).

In his apparent attempt to downgrade our methodology, Mr Chalker says we have "not satisfactorily exhausted the possibilities of a mundane origin of the fragments."

Indeed, we explode these possibilities on page 135, with the US test finding that the fragments are "not from an aircraft, rocket or satellite."

Fragments not from a plane

And certainly, we had exhausted the mundane possibilities first.

Mr Chalker infers that we had not bothered to look at the idea that the pieces were from a plane crash.

Yet again, he is wrong. If he troubles to turn to pages 128-129, he'll find that before we received the preliminary but conclusive test result, we indeed discussed the plane crash hypothesis.

Our evidence shows, however, that even if 50 planes had crashed en masse on Greenbank, they would not have accounted for our fragments.

Another of Mr Chalker's "revelations" is that the honeycomb is "obviously manufactured." This tells us that he has at least read page 136, from which, perhaps, he even borrowed one of our own scientific advisors' words: "Obviously it's been manufactured."

Mr Chalker also implies that we do not know honeycomb is used in aircraft. He quotes an aircraft engineer as saying that such material is used in the Canberra.

Once again, if Mr Chalker goes to the book, he can find our own interview with our own aircraft designer — and our own discussion of terrestrial aircraft honeycomb. We quote:

"Ted wondered if the piece could be from a jet engine. He produced a Rolls-Royce manual which pictured a metallic sheet in hexagonal form used to dampen noise."

The book's entire thrust is not that honeycomb is anything unusual — but that this, by definition and analysis, is alien honeycomb.

We will ignore Mr Chalker's absurd and rather desperate suggestion that this highly-sophisticated material might have fallen off a train or truck. Anyone who reads the book will swiftly dismiss so ludicrous a notion.

We are surprised at this dedicated debunker's apparent acceptance of the RAAF's word on UFOs.

Investigators world-wide are united in their conviction that air forces cover-up UFO incidents — and there is a mass of evidence on this subject. But Mr Chalker actually cites the RAAF as an authority (second-hand, at that) to back his argument against us.

Mr Chalker describes as "somewhat naive" our decision to offer the fragments to an independent UN committee (and not, we presume, to him and Dick Smith).

We point out that such other "naive" investigators as Professor J. Allen Hynek and ex-astronaut Gordon Cooper are also seeking an independent United Nations enquiry into UFOs and their residues.

Material is available to UN

Mr Chalker has never offered us the slightest aid in our UN campaign. He seems to believe he is the person to whom all (including sources' names) should be revealed.

In his STD telephone calls to John Pinkney, he has impatiently insisted that everything be disclosed to him, personally. In a letter (October 19) to the editor of PEOPLE, he even says: "If they have solid evidence (and so far they have not provided any) they should be compelled to release it for public inspection."

Compelled? That's a strong word.

We made it clear in our book — long before the excited Mr Chalker's advent — that we seek an open analysis of our UFO material, and that the material is freely available to the UN. ■

Look, in the sky ... it's a hoax

MOE — A 'War of the Worlds' style radio broadcast on a Victorian country station yesterday sent hundreds of people flocking to a park in the hope of seeing invaders from space.

But it proved to be a close encounter of the false kind.

In the best traditions of Orson Welles' famous broadcast in the United States in the late 1930s, radio station 3UL at Warragul interrupted breakfast programmes with grave sounding newscasts about an alien craft in a paddock at Moe, 130 km east of Melbourne.

'Urgent messages'

Local people — who were in on the hoax — cordoned off the area, controlled the crowds flocking to the landing site, and sent urgent radio messages back to headquarters requesting assistance to deal with the traffic and the extraterrestrial menace.

After two hours of tension, sounds were heard inside the three-metre high silver craft.

Before disbelieving eyes, the top of the conical craft slowly opened and up popped a 'martian' in a windcheater and a sign advertising a science fiction movie at the local drive-in.

The man who planned the hoax, 3UL promotions manager Alistair Doherty said: "I reported the craft had landed in the paddock.

"We crossed to the station five times between 6 a.m. and 8.30

a.m. "I didn't say the craft contained space invaders — I let peoples' imaginations work for themselves.

"Quite a few cottoned on, but quite a few were taken in."

He said the craft, made of fibreglass, was donated for the stunt by a local firm.



Strange radioactive holes & UFOs plague ranching area

The investigators say they were apparently caused by something that sucked up the soil as it took off.

The authorities say similar mystery holes have been found in England.

The investigators say it appears that the holes were made by landing gear devices on UFOs.

UFO terrorizes fishing boat's crew

The crew of a fishing boat was terrorized by a UFO that made repeated passes at their ship before plunging into the ocean in a cloud of steam.

Capt. Raul Martinez told authorities that the gleaming white spaceship swooped low across the bow of his ship as he fished about 30 miles off the village of Santa Cruz, Argentina.

Astoundingly the UFO made no noise — just the rush of wind. After several low-level passes at the ship, the UFO slowed and settled to the ocean and gently disappeared beneath the surface in a cloud of strange-colored steam.

Masursky says Mars is in the middle of an ice age but that it has been much warmer.

"Temperatures now dip as low as 150 below," Masursky reports.

"But during the warm spells between ice ages the temperature was nearly what it is here.

"In some ways, Mars was more hospitable for the development of life than earth."

Masursky says that during the warm periods frozen carbon dioxide gas melted,

covering the planet with a thick cloud which absorbed

even more heat and melted the polar ice caps. He explains that the combination of carbon dioxide and water could have resulted in life

spawned by a bolt of lightning or organic chemicals found in meteorites.

"It happened here," says Masursky. "It could have happened on Mars where conditions were better."

46 Light Views Is Taken Of Tahoe UFO Reports

SOUTH LAKE TAHOE — Scores of people in Lake Tahoe's glittering casino district were dazzled by mysterious lights in the night sky Thursday, but authorities say those close encounters may have been with spotlights instead of unidentified flying objects.

According to Douglas County sheriff's deputies, the hovering, amber lights that attracted a large crowd early Thursday were actually casino floodlights being reflected by moonlit clouds that shrouded the Tahoe basin.

The deputies also discounted an earlier UFO sighting, made by two patrolling officers riding in separate cars around 9 p.m. Wednesday. The officers reported that a light streaked across the sky for several hundred yards before it landed in the lake near its southeastern shoreline.

"We figured it was either a flare or a meteor," Sgt. Les Osman said. "There was a search conducted after the sighting, but no more lights were located."

However, later in the night, a crowd gathered on Highway 50 between the Sahara Tahoe and Caesars Tahoe casinos. Amber-colored lights, in what onlookers described as being in a distinct triangular pattern, floated several hundred feet in the sky.

"It was bizarre, really bizarre," performer Patrick Bagwell said. "It was hazy but you could see the lights clearly. They were just floating there."

The Douglas County sheriff's office at nearby Zephyr Cove began receiving calls around 5 a.m. Officers investigated, Osman said, and determined that the lights were reflections from Caesars' roof. Onlookers were not convinced.

"We have been getting calls all day, and most of the people I have talked to say, 'No way' — that is not what they saw," KRLT broadcaster Michael Bennett said. "They are convinced they saw something else."

"I know that is not what I saw," Bagwell said. "If those were lights from the casino, you would be able to see the beam, right? We saw no beam."

Bagwell said he fetched his camera and using a tripod, slow-speed color film and a short telephoto lens, shot several frames of the lights. They were quickly developed in a Sahara darkroom. "They came out pretty well," Bagwell said. "It looks like there is something up there."

UFO reports

The log at the Sonoma Police Station for the week noted that on November 13 (last Thursday) at about 10:55 p.m. several citizens called in reports of UFOs in the form of amber lights in the sky that danced around and then disappeared in a shower of sparks.

UFO's Or Missiles?

A mysterious display of light in the sky before dawn on Monday of last week caused a number of observers to query news media as to whether they might have seen a UFO. Investigation determined that a launching of two Minuteman III missiles—part of a Strategic Air Command readiness test—had occurred at Vandenberg Air Force Base at 6:31 a.m.

Glowing object is reported

Several people told Turner firemen that a glowing orange object crashed to the ground about 8:30 last night near Wiltsey Road and 36th Street SE.

Turner Chief Brent Jensen said three units searched for more than an hour last night but found nothing. Jensen said fog cut visibility to about 50 feet, even with a powerful spotlight.

There were no reports of missing aircraft, Jensen said.

Fireball lights Pennsylvania sky

PITTSBURGH — High-altitude sightings of a ball of fire falling toward the Earth coincided with a shuddering boom heard over western Pennsylvania, federal authorities say.

"We had two aircraft report seeing a fireball falling towards the Earth somewhere in western Pennsylvania northeast of Pittsburgh," said Homer Stamper, assistant chief of the Federal Aviation Administration's Cleveland Air Route Control Center.

Police stations, radio stations, and civil defense officials got calls reporting an explosion-like sound.

Ancient people used modern drug

Scientists have discovered that an ancient race of people living 1,400 years ago were taking large doses of an antibiotic that modern doctors began using — less than 30 years ago.

Researcher Debra Martin of the University of Massachusetts discovered the traces of the antibiotic tetracycline while studying the bones of an ancient people who lived in Africa's Sudan.

Incredibly, modern doctors just began using this powerful germ-killer in the 1950s.

The researchers noted that the ancient people had a low infectious disease rate and concluded that the tetracycline probably accounted for this.

The scientists believe the bacteria containing the powerful drug grew naturally in the grain storage bins used by the people.

Woman terrorized by hovering UFO

A young woman was terrorized by a UFO that followed her car and hovered over it while she was driving to work.

The UFO appeared suddenly as a bright light and began trailing after her car. Several times when she stopped at intersections, the light noiselessly glided directly over her car and hovered.

"It wasn't an airplane or helicopter," said the shaken woman from Long Beach, Wash.

"It wasn't anything I've seen. There was no sound. It stopped when I stopped and traveled with me when I traveled.

"It was scary."
Local police said they had several reports that day by witnesses who claimed to have seen a flying ball of light.

"Some people told me that was a comet," she said, "but I listened to the news all day, and there was nothing about a comet and it wasn't a satellite. The don't come down and hover over you." OCT 21-1980

SAN JOSE, Calif. (AP) — An unidentified flying object with a pulsating red light buzzed a plane over San Jose Municipal Airport, according to two Cupertino pilots.

Two airport controllers also said Wednesday that they saw the object, which was about 10 feet in diameter. But they were unable to detect it on their radar during the 10 minute encounter which started at about 10:40 p.m. Monday.

Pilot Gary Rounds, 21, said he was practicing takeoffs and landings when "I looked to my right and saw another aircraft."

"It was this bright, red pulsating light," said passenger Charles Shackleford, 20, who is also a pilot.

The object suddenly seemed to head directly at the airplane, a Cessna 150. "He was this close to us," Shackleford said. "I thought, Man, he's going to descend on top of us."

"We saw it," said air controller Rich Gutterud. "The thing was coming right at him. He had to extend upward from whatever it was."

"It was really wild," Shackleford added. "First it was right in front of us. The next thing we knew, it was right behind us."

The object followed the plane briefly, "making very tight turns," said Gutterud.

"It hovered. Then it just took off at an extremely high rate of speed," Gutterud said. "It was strange. We could see it. But there was nothing on the radar. It never showed on the radar at all."

All of those who saw the object agreed that it was not an airplane, a helicopter, balloon or hang glider.

UFO Group Faces Earthly Woes

The "crazies" are giving serious students of UFOs a bad name, says an Arlington group searching for signs of extraterrestrial life.

But that's not their only problem. The federal government is giving them a hard time, by hiding "spectacular" evidence of life beyond Earth.

Citizens Against UFO Secrecy, CAUS, is seeking documents on unidentified flying objects from the Central Intelligence Agency and the National Security Agency under the federal Freedom of Information Act. They have lost one round in U.S. District Court in Washington for those documents, but are appealing the decision.

The battle is being waged out of the South Arlington home of one of its members and is being funded by a UFO research group.

"It's a real David and Goliath thing," is how Richard Hall, a member of CAUS

characterized the suit. "It's a battle to eke out this information.

"For one thing, I think the CIA has hard data such as films that would be much more convincing than someone's report of a light in the sky," Hall said. "Obviously the CIA has the technology and resources to help determine if extraterrestrial life exists. I'm strongly inclined to believe they have spectacular material they are withholding."

CAUS is "a loosely formed umbrella group," members said, that is waging the legal fight on behalf of thousands of members of UFO interest groups throughout the country. It took over a freedom of information lawsuit begun by an Arizona-based group called Ground Saucer Watch, Inc.

CAUS has received a \$2,500 grant from the Washington-area Fund for UFO Research to finance the appeal. The fund is a non-profit group formed a year ago by scientists, engineers and

UFO writers in the Washington area. It is based in Mount Rainier, Md., and was formed to fund "high quality scientific research" on UFOs.

It disassociates itself from "unscrupulous persons who have flooded the popular press with distorted and inaccurate information" that has "confused the public."

"What we are hoping to get out of this lawsuit are some 200 documents the CIA has," Hall said. A reference to these documents was made in some 1,000 pages of UFO related material the CIA has released to CAUS under the Freedom of Information Act.

Hall has written extensively on UFOs and is editor of the Journal for Mutual UFO Network, a newsletter that deals with UFO data and information. He said he was a consultant for the U.S. Air Force office of scientific research on UFOs from 1966 to 1968.

Hall characterizes CAUS as a "serious" UFO group and disowned the "sensational" school of UFO literature that is widely circulated.

"There are numerous newstand magazines that are a scandal and are grossly misinforming the public and just confusing the entire issue." He said his journal, in contrast, is "a reliable publication."

A CIA spokesman said the organization would not comment on the pending litigation. He did say that the CIA does not release information that is classified and would either reveal a source or method of information gathering.

"Our position is that we do not collect information or do any kind of research on unidentified flying objects," said Dale Peterson. "We do have research to maintain a close watch on objects that could pose a national security problem. Consequently we do get information that could relate to UFOs. What has happened over the years is that many documents on UFOs have come to us."

Dr. Bruce S. Maccabee, a physicist for the U.S. Navy Department who is chairman of the Fund for UFO research, obtained documents on UFO sightings from the Federal Bureau of Investigation four years ago under the Freedom of Information Act. In that case the FBI deleted the names of sources and special agents before releasing the data. "If they (CIA) don't want to tell us how they got the information that's fine," Maccabee said. "But they should tell us what they have."

Some members of the Arlington group were reluctant to be interviewed. They are government employees and do not want to flaunt a lawsuit they are waging against the government. One member described the UFO lawsuit as "controversial."

Members of the Fund for UFO Research were asked if the group is taken seriously.

"I think the stigma of UFOs is over," said Fred Whiting, an aide for a Long Island Congressman who is publicity director for the Fund for UFO Research. "People are interested in what there is to know. I'm never laughed at or scorned because I spend a lot of my spare time on UFO matters."

Not every member of CAUS or the research group is convinced that extraterrestrial life exists. And that is one reason the lawsuits are being brought.

"The popular theory is that there is some extraterrestrial life," Hall said. "The more objective of us are trying to find out if that is the case."

"We don't take any stand on the outcome of our research," Whiting said. But, as Maccabee pointed out, "If we didn't think something was going on we wouldn't be wasting our time."


