

INTERNATIONAL REPORTS

BUENOS AIRES (AP) Reports of flying saucers over Argentina and Paraguay poured in Monday from varying quarters. All reports agreed ufo's flew over Paraguay and Argentina about 10 PM Saturday night. The reported number of UFO'S ranged from 6 to 16.

The control tower of Stroessner Airport at Asuncion, Paraguay, reported its radio and radioteletype equipment was heavily jammed for several minutes while round, brightly-lit objects flew in a north-south course at an altitude of around 2,500 feet.

In Argentina, reports from six provinces said UFOS flew over shortly after they were sighted in Paraguay. The newspaper - La Nacion said a pilot at Canba Punta Airport, Corrientes, described the UFO'S as "A perfect formation led by one big unit and followed by 15 smaller ones, all giving out a bright and changing luminosity." DENMARK - "FLYING SAUCER LANDED IN A FIELD OUTSIDE "HOLBAK"?????

A farmer from the neighborhood of Holbak reports about a strange experience he had at night. Today he has no doubt that the thing he saw was a "flying saucer." The observation is not quite new, but like many others, who has had a corresponding experience, he had chosen to keep quiet not to make a fool of himself. "I was looking out over the fields when I suddenly saw a strange light. It was not an usual light but artificial and LILAC", the farmer tells. "I got quite staggered. People do not use to be at that place in the night - then I knew something was happening and I went over there. But mid-way I suddenly noticed an object. In the darkness it was difficult to see how it looked." The farmer tells that light came from some windows which almost were oval. Thus he could see that there was a dome on the object, because he weakly + saw the outline of something below. He also was able to see something which seemed to move behind the windows..... The next day he went down to the field again and here he found a mysterious substance which he doesn't exactly know how to describe. "It looked like cottonwool, but it had a color I've never seen before. It was much, much finer than cotton. I could almost not feel it when I took it in my hands. The color was strong, I cannot say how." The farmer gathered a handful and placed it under a stone. He got very amazed because the matter DISAPPEARED little by little during 3 days. Today he is vexed that he didn't send it to examination. In the place where he had seen the object, he discovered that the grass was pressed down. Besides he noticed that the lowest wire from some pylons had been pulled down and out about 60 feet away. Therefore he means that the object must have flown under.

Although the sighting allegedly took place April 1st. the teen-agers - Jerry Egan and Leonard Evans - vow that their story was NO April Fool's Joke. Young Egan told the TIMES-PICAYUNE Saturday that he and Evans were near the lakefront in the vicinity of Franklin Ave. at about 4:30 PM taking pictures with Evan's new camera when the gray, saucer-shaped object approached in the air from the North. Although uncertain of the distance between them and the UFO, Egan said the object made no audible sound and was visible for only a short time. April 2 - 67 - Wanaque, N.J.: The TICAP Organization of Jersey City has made the following report: From 10:15 to 10:45 PM - 2 objects were observed moving in a straight line from left to right almost on a line with the Dan. One object was yellowish and seemed to pulsate and the other was white and appeared elongated... Both were a good distance away when they both appeared to turn red and disappeared behind the mountain. At 10:47 PM - 4 members of the Organization viewed a brilliant white object thru high powered binoculars. The object appeared circular in shape tho extremely high. It made a fast approach from the S.W. and disappeared in the N.W. ----- At 11:55 PM these same people observed an object estimated no higher in the air than 200 ft. appear almost from the top of the mountain which overlooks the resevoir, and cross in a straight line to the other side of the resevoir. Thru binoculars it appeared at first to be a yellow-white slightly flattened circle of light. Halfway across the resevoir it faded into a dark red disk. April 6 - 67 - Los Angeles, Cal. ( Personal report from Mr. Andrew Ruiz - 2801 Glenview Ave.) "The following is an observation which my nephew Carlos, age 14, and I witnessed at 10:05 PM (Pacific Standard Time) While watching TV, my nephews attention was drawn to the outside by a red light which was coming from the direction of the N.W. It was about 30° above the horizon and it was blinking.... After getting the binoculars which are 8x30 mm .... I was surprised to see that what I had discerned was a large, cigar-shaped object with a grayish-white body that was maneuvering or flying in an erratic way, in a clockwise-motion and direction". "We continued to watch it for 3 to 4 minutes as it was headed in a S.E. bearing toward a heavy cloud layer . The enormous-sized body was silent and trail-less. We regularly took turns on the glasses - and while he was using them, I saw what appeared to be a meteor-like object, white, in the general flight area of the cigar-shaped object. Another object of a similar type was also seen again by my nephew." "The objects seemed to merge and then disappeared from my vision/"

April 28 - 67 - Pine Bluff, Ark. Ken Kesterson, co-owner and manager of a Pine Bluff radio station, reported the sightings of an unidentified flying object over the city late Thursday night... Kesterson said he and three others saw the object appear at 10:44 PM. "It approached Pine Bluff from the NW and became stationary slightly west of the city in the center of the sky," Kesterson said. He said the group saw blue lights, which appeared to come from numerous windows in what looked to be the bottom of the craft. He quickly telephoned his station, KCLA, and told his announcer to tell of the UFO so that others could watch it. As soon as he announced it, the lights went out and it disappeared,..... May 1, - Miami, Fla. "Heck with it, says UFO Spotter"..... Dr. Dmitry Alexander doesn't think he'll report any more "unidentified flying objects" to governmental agencies around Dade..... "I was handled as if I was some kind of a nut," says Dr. Alexander, assistant professor in the Audio-Visual dept. at Miami-Dade Jr. College. Dr. Alexander witnessed a PARADE of UFO'S in Northwest Dade last night that lasted for perhaps 15 minutes. He phoned a string of official agencies and none would even look out of the window. "The thing that bothers me is if they had just sent out a plane when I called it could have been resolved." Dr. Alexander lives in the area where school children two weeks ago made a daytime sighting of a "flying Saucer". What he saw about 8:15 PM while driving-- and later studied with binoculars was this: "There were from 6 to 10 of these objects circling in a clockwise direction to the south and the southwest. On each was a configuration of lights red, white and green. "I have seen a lot of planes...These were not ordinary planes, whatever they were." CONTINUED NEXT PAGE

When they flew toward me they showed a red light, awfully large and bright, like a stoplight. "The oddest thing was they made no sound at all. If they were the size of an airplane - and I don't know if they were - they would have to be a mile away and perhaps 700 to 800 ft. high. Miami, Fla. ( We have received additional data on the "flap" that seemingly has been taken place in this area. April 13, 1967 Miami News carried an article about a Mr. John Wolf, who, being interested in the sightings previously reported went to the area of the school (see June issue S.S.) and made a report of sightings himself. "It looked like 3 or 4 things out there - hovering just behind a line of trees." "They seemed to change shape from oval to cigar-shape and back again. They seemed to change size. They were globs of white with red flashes in them. On top there seemed to be a dome - like the glass dome on a coffee pot." "Sometimes they would rise up in pairs. Then one would peel off to the right and one to the left. Both would rise a little more and then sit there." (there were planes in the area and John said that "Every time a plane would approach one of them, something astounding would happen. There would be NO motion but the 'thing' would suddenly NOT be there, when the plane left, it always reappeared almost in the same spot. They were like pogo stick jumping all over the sky.") This article is quite long - those wishing full details are urged to write to the newspaper for a clip..... On April 25, an article appeared in the same Miami News - of a prediction of mass landings in the Miami area.. This was made by Mark and Yolanda of Mark-Age Meta-Center.... " There's going to be a mass landing of outer spacecraft in Dade County within the next two months --- In fact, they added, the "Hierachal Board" of the solar system has decreed June 22 as the deadline. The Board has decided it is now time for the planets to reestablish solid contact with earth." Further statements in the article said: " Our main purpose right now," says Mark, "is to prepare the people for the landings so that they won't panic and greet them with guns." "The craft, he added, will stay around this area for one to three days and Miamians will probably be invited aboard.."

SCOOP NOTE: We have been following with interest the above happenings. We have had a sudden upsurge of sightings in Florida within the last few months. Some very low level. This does not imply, to our opinion, that anyone can predict how or why..... There are those groups who say the CAN predict. If this is so.. It should be most interesting in Florida around the 22nd. of June! It was not too long ago that one 'barnstorming' lecturer came into the Florida area - predicting such landings - (which never took place) also offering 'saucer-rides' (which never took place).... While Scoop feels that it is in the general interest to print such predictions for the knowledge of many in the country..... We do not feel that, at this time, ANYONE can say who or what will land when... I will say to them: PROVE ME WRONG..... Or RIGHT!....

May 1, 1967 - Philadelphia, Pa. (Personal report from Mr. Norman Schreiberstein - 1236 Greeby St.) "On May 1st. my international representatives and I witnessed what appeared to be four UFO'S. Three of the four objects were disc-shaped. They were traveling directly from North to South and were roughly 65° above the Eastern horizon. One - a cigar-shaped object - was traveling from N to S, but as it reached farther south, it swerved to the Western direction. Visibility of the objects was lost due to houses intervening. The cigar-shaped object had a reddish glow. At the time of the sighting we were using a telescope."

May 16 - 67 - New York. "More intensive scientific investigation of unidentified flying objects, sometimes called UFO'S or Flying Saucers, was urged by two speakers at the Design Engineering Show The Show, the largest industrial exposition to be held in New York this year, is at the Coliseum where 660 companies are demonstrating the results of their year's research and development programs. One speaker, David L. Morgan, Jr. an associate research scientist in the physics department of N.Y. University, while deploring the lack of scientific data, said that a mathematical analysis of the observations of UFO'S showed that they were more likely to be interplanetary vehicles than atmospheric conditions. He emphasized, however, that no conclusions could be reached on existing data. The other speaker, George W. Earley, of Bloomfield, Conn., president of the Connecticut affiliate of NICAP, asked for a computer system which would accumulate all data on UFO'S so that reports could be compared with others as they come in.".....  
(Scoop Note: Mr. Earley is well known by many of our readers and has just recently released the contents of the entire lecture that was given before the above mentioned body. It is very informative and timely, and extremely interesting to all serious researchers. Scoop certainly recommends this as a 'MUST' reading.....

May 18 - 67 - Ringwood, N.J. (near Wanaque Reservoir) "The Borough Council Friday put a damper on the enthusiasm of wouldbe ufologists by introducing a bill or ordinance to prohibit parking on Westbrook Road. A public hearing will be held on the ordinance June 9. Westbrook Road, which skirts the site of many a traffic tie-up when word of unidentified flying objects over the reservoir has been publicized. Police have, in the past, issued summonses to UFO watchers who have lined the road with their cars, creating a hazard. Councilman Lawrence Mark noted, "Ringwood may be the first borough in the State and possibly the first municipality in the country to pass an ordinance prompted by flying saucers." The latest sightings over the reservoir occurred earlier this year. Last spring and fall, reports of UFO'S in the area received nationwide publicity.....

May 18 - 67 - Philadelphia, Pa. (Personal report from Mrs. Ruth Snyth - 5101 N. 12th. Street) " I was driving about 6 miles out of Philadelphia .. I was following a large Greyhound Moving Van... I am quite sure that this 'craft' was following the Van, and not my car.. It was 6:35 Am when I noticed this craft.. It was a disc-shape craft, devoid of fins, wings, or other protuberances -- EXCEPT for an exhaust pipe type of thing from which came a thin stream of steam-like vapor. There was NO sound other than that of my car and that of the Van ahead of me.. This disc was a dull, dark, gunmetal color with a darker black or gray band around the middle with what looked like portholes, but they were unlighted... By using telephone poles for comparison purposes, I would say that this craft was no higher than the height of three (3) telephone poles,.. it could easily cover a tennis court.... It had a domed top which seemed to be rotating on a central axis. Below the middle or belt section was a rather flattened saucer shaped bottom... I had been observing this for about 3 minutes when it sort of SHUDDERED -- cherry-red sparks came from the exhaust, and the craft shot straight up into the overcast. AT THIS VERY MOMENT, THAT I SAW THE RED SPARKS, I SUDDENLY GOT THE MOST ANFUL TOOTHACHE!!!!!!!!!!!!!! A few minutes after the craft had disappeared, my toothache left as suddenly as it had come! Do you suppose that I was FEELING rather than HEARING ultra-sonic vibrations?" ..... (Scoop Note: WELL? Any researchers out there in Scoopland care to answer her question? INTERNATIONAL DATELINE BY ROBERT STIFF DIRECTOR -  
SAUCER SCOOP INTERNATIONAL UFO BUREAU

Readers will remember the column dealing with the mysterious UFO that flew out of the night to change the lives of a small Oklahoma farm family. This story was told in a previous issue of SS, and told of the subsequent promise of investigation by a Well known Senator from Oklahoma. It now seems that the able Senator will NOT reply to our continued pleas for an investigation -- and that the witness has changed his mind about the story and had decided that the less said the better. We are now faced with the possibility that the claims by various UFO investigative societies may be true ..... the Air Force may be trying to quiet serious UFO claims. That -- or the witness is lying. As an investigator of UFO phenomena for many years, I am forced to believe the former assumption.... the United States Air Force is working very hard to dispell the aura of truth surrounding the continued sightings of alien craft in our skies. True, we have our fakers and frauds .... any un-known phenomena has its lunatic fringe, but too many sightings are reported by too many reliable citizens for it all to be dismissed.

I had always continued to believe that certain well known personalities in the UFO Field were trying for publicity and book sales when they made the positive claim that the AF is debunking UFO sightings without any proof. This still may be true in some cases - but this author was the victim of an AF charade, as mentioned in last issue's editorial, and now is confronted with a bureaucratic brick-wall when further investigation into the aforementioned case is attempted.

Are we now the victims of deliberate government deception? If so, this means far more than a blow to the UFO field. If government deception can be used in this case, can it not be used in others, then others, until we no longer are being told the truth on any matter? The proof that a young girl was burned by a UFO is great... yet the witnesses have been frightened by someone into changing his story, the citizens that witnessed the Air Force at the victims home have decided they should say no more, and the agust office of a United States Senator refuses to answer my inquiry. Why this is being done is anyone's guess..... but the fact that it IS being done cannot be denied, nor should it be ignored..... If this is the case why \$300,000 for Dr. Condon? Two medals of Honor should be givento Jack and Mary Robinson were were the backbone of the entire Congress. They gave more than their share of time and effort - as did Mr. Harry Hoffmann - who made the beautiful flag-bedecked 'saucer' in the display of Colman Von Krivitsky.... I also learned that Orthon, Ramu and Firkon - 'visitors' were at the affair -- but -- sorry - I did not see them!

In part one we landed on Mars in the southern hemisphere about 100 miles south of the equator. In our first 10 hours we did make some amazing discoveries.

The sun is very low, the temperature is 30°. In 20 minutes the sun will be below the horizon. The sun has set. It did not turn red as it does on earth. The cold is biting. One hour after sunset the temperature was 0°. We do our best to keep warm. We noted that after the sun set, the darkness set in immediately. There is no twilight on Mars..

We eat and continually watch out of an east window in the ship for our first view of Phobos, the Martian Moon. It is a baby moon, only about 10 miles in diameter. It is less than 4,000 miles out in space. We watch-- but nothing happens. Finally we are disgusted and go outside to look for the moon - it is cold now -- 25° below zero, the sky is marvelous, not only a dozen stars, but thousands of them with a startling brilliance and beauty!! No where on Earth is a scene like this possible! The area between the stars is jet black, thus the stars in their setting appear as brilliant jewels..

We look into the west and there in this beautiful setting is Phobos. It is about 1/3 the size of our moon on Earth - but- we should have remembered that Phobos rises in the West on Mars and sets in the East! The speed of Phobos thru the star field seems very fast, our astronomical dictionary tells us that Phobos sets four and one half hours after rising. Eleven hours after rising- it will again rise in the West. Phobos comes up with full face illumination, but now we notice part of the face is in shadow - this is a way of telling us that it goes through certain phases in the four and one half hour period. Our attention is directed to a brilliant star directly overhead which does not appear to be moving with the star system, and as we watch it closely it appears to stand still as the other stars march by! We examine our celestial chart and find out that it is Demos, the other Martian Moon!

It revolves around Mars in 30 and one half hours - its movement is almost the same as the revolution of Mars on its axis - this is why it almost appears to stand still... It is now 50 below zero (remember - it is the middle of the Martian summer) .....

LET US CONSIDER A THEORY ON THE MARTIAN MOONS. This theory sounds like science fiction, but, I would not be surprised that someday we may find that it is TRUE! In back of this theory are several important men...

- 1 ) I. S. Shklovsky -- Russian planetary physicist.
  - 2 ) Dr. Fred Hoyle --- Astrophysicist at Cambridge University.
  - 3 ) Dr. H. M. Sinton - Astronomer at Yerkes Observatory, Wisc.
  - 4 ) Dr. S. Fred Singer-Astronomer at the University of Maryland.

June 28 - 67 - "A Lawrence County man snapped two pictures of a SAUCER-SHAPED object about noon. Gabriel (Gabby) Kozora of RD 7 - had positioned his son Jim under two trees near his home and released the camera shutter when, in his own words, he heard the "screeching of one hundred jets." Quickly turning around, Kozora said he saw a sky-craft approach from the south, hover for a quarter of a minute about 500 ft. above the earth, then speed away on a northwesterly direction. Kozora said that during the hovering duration, he snapped once, waited the interminable 10 seconds - for developing, then snapped again.... Asked to describe the UFO, Kozora said that it appeared to be the size of an Air Force C-37; that is, about 60 or 70 ft. long, was silvery or whitish in the noonday sun and seemed to cross the sky without revolving..... "Was it moving fast?" someone interjected. "Oh, I'd say a few thousand miles per hour were involved," said the ex- WW II airplane gunner..... State police Cpl. William Tilton who viewed Kozora's pictures, said the object shows 3 large windows underneath and 3 smaller ones and a black dome on top. The tops of trees come into view in the lower left hand corner of the photo.....  
..... Mrs. Paul E. Walter of Mt. Jackson Rd. told the News today that a grandson who lives on Ambrosia Rd. near Edinburg told her he spotted a UFO yesterday at about the same time as Kozora.....  
..... "Experts check UFO Report" - June 30 -.... Same source....  
Three representatives of the Pittsburgh NICAP - and a member of AFRO - walked the confines of the arca with notebooks and cameras.....  
Another group from the University of Colorado has scheduled an appearance at the farm today.....

July 1st - 1967 - Same source; "Girl quizzed here on UFO" .....  
University of Colorado UFO experts Dr. Roy Craig and James Wadsworth are continuing investigations in Lawrence County's reported UFO. Late yesterday they conversed with Linda Comer, 13, from Otsego, Michigan, who reported seeing a circular black object trace a three-quarter circle in the sky over Shenango Township. The girl, visiting with relatives in Willowhurst Circle, said the object appeared about 2 PM the SAME DAY that Gabriel Kozora or RD 7 snapped two pictures of a saucer-shaped object near his home.....

OPEN LETTER BY KENNETH LARSON

To V. L. Melikan, Office of the Director

Your recent letter stated that UFOS are the responsibility of the US Air Force, and the Jet Propulsion Laboratory is not involved in making an independent study. You said that Dr. J. Allen Hynek (who has been an AF UFO consultant and has studied UFO reports for 20 years) is a responsible scientist, and that the Jet Propulsion Laboratory is in agreement with his views and those of the Air Force. However, I do not think that it is possible for the Jet Propulsion Laboratory (the group associated with the flight of Mariner 4 to the planet Mars) to be in agreement with Dr. Hynek's published views on the UFO phenomena and -- at the same time -- be in agreement with the view of the USAF. That is, the Air Force has publicly stated that UFOS do not exist. Yet, at the same time, they have issued regulations to their personnel as to what to do when they see a UFO and pointing out that any release by military personnel on any UFO sightings is liable to a prison sentence!

Dr. Hynek has published his views on authentic and documented UFO sightings by military personnel - and he thinks that there is a very good case for the UFOS. Dr. Hynek has also cited the famous Socorro, New Mexico, UFO "landing". Patrolman Lonnie Zamora publicly stated that he saw an object land near Socorro on April 24, 1964 -- and the Air Force has stated that they cannot solve this case. Now, are we to believe those policemen and highway patrol officers who have said that they saw and chased UFOS -- or are we to call them liars? That is, do we support our police or not?

Furthermore, your letter seems to give the idea because the Jet Propulsion Laboratory is not concerned with UFOS nobody should be willing to study or check on the various reports. This seems to suggest the "need-to-know" policy (where people or groups not directly associated with any research, are denied any access to data or research). Any yet this same "need-to-know" policy was used during World War II and possibly earlier in Germany! Therefore, I am completely in favor of the American heritage of complete freedom of thought, action, research, writing - particularly in reference to the UFO research. However, this policy of "need-to-know" seems to have interfered with those Americans (Air Force personnel) who might wish to talk about UFOS and their eye-witness sightings. If the UFOS don't exist - then why does the Air Force tell them to keep quiet about UFO sightings and set-up prison sentences for those who do tell? Why should an AF Pilot have to wait 10 years after his military service before he can lecture and tell about his UFO sightings and aerial "chases" after UFOS?

And how can the military tell civilian airline pilots to keep quiet about sightings -- unless thru direct or indirect pressure on civilian airline directors?

I can only conclude that either the Jet Propulsion Laboratory directors do not know the various problems and questions concerned with UFO sightings or else they do know but cannot speak their mind on the matter. This, of course, seems to suggest that the military is more and more interfering with the God-given rights of American citizens for freedom of speech, thought, research and the need-to-know facts. "Without vision the people perish". It is impossible to ignore and reject the UFO reports from around the world and over the past 20 years -- and if we do, then we are fleeing from reality and entering into George Orwell's 1984 "big brother" description. I say that rejection of the UFO reports is rejection of "reality" and documentary records or a world wide phenomena. Being a realist, I think that we should study the "reality" by the scientists Hynek and McDonald (University of Arizona physicist) and not retreat into an illusionary world where such documentary records do not exist. UFO records do exist ----- and everybody should study them..

CATTLE RUSTLING UFO'S

BY RON CALAIS

Much has been said about the various repetitions of historical events, and of the subsequent speculation often attributing them to causes which seemingly preclude the chance of mere coincidence. The intriguing UFO phenomenon is not an exception... for the mountians of literature on the subject contain numerous cases of a repetitious nature.

The incident at Vernon, Kansas in April of 1897 is perhaps one of the most fascinating accounts illustrating this point..... On the night of April 19th, a prominent citizen of Vernon - Hon. Alexander Hamilton - witnessed the first UFO sighting of its kind... On awaking to investigate a disturbance among his cattle, he observed a cylindrical-shaped object with an undercarriage of transparent windows. Later he described the object as having a huge searchlight beam and containing several humanoid creatures who spoke in an unintelligible language. These features, by the way, match other descriptions of aerial objects seen over portions of the country during that year.

According to the report, the vehicle lowered a cable and entangled a three-year-old heifer (calf), lifted it and made off into the darkness. (This story, in its entirety, can be found in the April 1966 issue of FATE, under the title, "Cattle Rustling by UFO" by Lucius Farish.)

A similar incident, far less detailed, occurred on the ranch of E. L. Rayburn, an attorney of Twin Falls, Idaho, almost 60 years later. In Sept. 1946, a saucer-shaped object about 200 feet in diameter swooped down to within a few feet of the ground and it hauled away a 400 lb. steer. Two employees on the ranch confirmed the story. Mr. Rayburn, of course, could not have known of the nineteenth century report, as it was not uncovered from the newspaper morgue until 1966...

UFOLOGIST URGES 'OPEN MIND'      BY LARRY V. MURPHY

A West Virginia author and ufologist has conducted his own private investigation in this area and personally interviewed W. Derenberger at his home this past week, and has concluded that the Mineral Wells salesman's story of meeting a spaceman on I-77 near Cedar Grove on the night of Nov. 2 is "entirely plausible.2....."

At the same time he decried investigation methods allegedly employed by a group he refers to as a "Pittsburg flying saucer club." Gray Barker of Clarksburg, editor of the staff of SAUCERIAN PUBLICATIONS, in disclosing his conclusions following his personal and somewhat hasty investigation of the Derenberger case said: "They (the National Investigations Committee on Aerial Phenomena) are not an official organization, as their name implies. Instead, they are people just like myself, private individuals, who are fascinated by the subject of UFO'S." .....Barker seemed to be particularly angered by the "suggestion" by a group of investigators that Derenberger undergo hypnosis and various psychological tests. "I think those investigators should take those tests themselves," Barker stated. "I also think they plan to come up with a very negative report. And the people of the Parkersburg area should be angry at the treatment afforded one of their citizens by this innuendo." According to Barker, Derenberger had told him that the "Pittsburg group" insisted that he tell his story only to them and give it to nobody else. "This is definite suppression of news," Barker remarked..... Barker, a audio visual consultant for a Clarksburg school equipment firm, stated: "I found Mr. Derenberger a very sincere man."

In reference to Derenberger's claim that he had engaged in telepathic conversation with the spaceman he encountered on I-77 near State Rt. 47, about 2 miles southeast of Parkersburg, Barker pointed out: "A few others persons have claimed to have made various sorts of contact, by radio, by voice communication, and even telepathy." Barker said that since Derenberger told his incredible story to city and state police, an Air Force recruiter, and had a lot of ridicule.

Derenberger, according to Barker, "has no ulterior motives, and has displayed no interest in benefitting financially from what happened to him. Instead, it has caused him to lose valuable work time." Incidentally, Derenberger on more than one occasion since Nov. 2, has told a staff writer of the News: "This didn't happen to me for any personal profit. And, if I can help it, I'm not going to see somebody else gain personal profit from my experience." ..... "I do hope that the local people will keep an open mind about Derenberger's experience," Barker stated. "After all, everybody laughed at the Wright Brothers, and for years reputable scientists scoffed at meteorites and said they were hoaxes." "Within a few years," Barker added wryly, "I predict that Mr. Derenberger will be laughing at us!"
