

June 4 - Seattle, Wash. ... The sheriff's office has investigated numerous reports of UFOS in the Vashon Island area the past 2 months. Deputy Sheriff T. C. Allman, asked about the investigation, said it began after several reports that livestock had been frightened at night. These complaints began to tie in with reports of UFOS..... "About 15 responsible persons have seen the UFOS, he added." The Deputy, stationed on Vashon, said he and his wife saw a UFO Friday night. The first sighting he knows of occurred April 7.... Allman said he and his wife were returning to their home on the island's west side about midnight Friday when they saw the UFO about a mile away over Kitsap County. They watched it with binoculars..... "It was blurry," Allman said. "It was circular and looked like a magnesium flare but it didn't descend and it didn't go out." Allman, a pilot, said he was sure that it was not a conventional aircraft.....

Most of the sightings have been reported in the Maury Island and Burton areas. (NOTE: (BY UAPRO) Maury Island was the scene of much UFO activity in 1947 including the classical Maury Island Hoax Mystery)

"The animals have just gone completely crazy," Allman said. "Horses, cows, dogs and ducks have been running around." The disturbed animals have been in the areas where the UFOS have been reported. One witness told Allman he saw an object 30 to 40 ft. long with a light beam running to a bright object nearby. Most of the sightings of UFOS over Vashon itself have been reported as being over RADIO station towers and a NIKE MISSILE site.....

June 18 - North San Juan, California - Flying Saucer people come in three sizes - small, medium and large -- and they just might be dropping into this northern California mining town Saturday, according to a 12 year old expert on such things. Tony Spruill, said he took 6 photographs of a UFO two weeks ago as it landed, took off, and hovered over a hydraulic mining area. He also took a picture of the object, which was shaped like a cowboy hat, rising over an abandoned car. The auto has disappeared.....

"Tony said the UFO also was sighted by a nun from Mount St. Mary's Academy in Grass Valley. He said they agreed that the saucer people resembled humans and had children with them. They even talk like humans, explained the boy, who said the saucer people told him two of their ships have been shot down over military missile installations. Tony said 'they will be back this month' and then got more specific. He said the saucer will land Saturday. The Air Force isn't taking any chances. Joseph Nix, Information Officer at Beale AFB, said material gathered about the sighting will be taken to a conference at the University of Colorado.".....

July 7 - CORNING, CALIF. "UFO HOVERS NEAR SACRAMENTO".....

"Shaped like big cigar, two policeman declare"... Two policeman and a bowling alley owner say that they saw a flying saucer about day-break July 4, in this quiet Sacramento Valley olive grove community. "I was kind of skeptical about these flying saucers, but you couldn't convince me otherwise now," Officer Jim Overton, 31, said Thursday night. "I know what I saw." His words are supported by Officer Frank Rakes, a 23 year old for Corning patrolman now at nearby Orland, and by Jay Munger, 46, manager and owner of the bowling alley. ...As Munger puts it: "I noticed something in the air over the freeway (I-5) about 2 blocks south." "At first I thought it was an airplane," Munger said. "I set my coffee cup down on the counter again and locked up again. It was NO airplane."...The object was shaped like a big cigar and aluminum in color.... "the brightest light I've ever seen."..."There was No sound coming from it at all.".....  
"It had a huge white light on the top, very bright," Overton said. Down at the bottom it had a smaller, not so bright, light. Around the center of this object there was a band, either paint or a different kind of metal. It looked like a neutral gray except it was darker.... "We walked toward the middle of the parking lot. Then as we walked it suddenly began to move. It moved with a most terrific burst of speed... flew off in a westerly direction".....

REPORT FROM DENMARK ( Editor: Willy Olsen - Address: N.U.F.O.K.  
Jagtvej, 121, 3, Copenhagen N. Denmark )

TWO SMALL BOYS OBSERVED "FLYING SAUCER" -- Experts describe two kids' assertions about the behaviour of a "flying saucer" at low height across Sjellands Odde as most credible. A very heavy 'lump' which afterwards was found on the shore - seems further to certify the boys' explanation. (The institute - technological).. One of the boys meant that the flying object had thrown down some 'boxes'. A piece of the 'lump' was sent for an examination. The institute reported never to have seen the way in which elements ( some of which, lime and inorganic coal ) were mixed. The two boys' observation - which took place some time ago, has been kept back by the parents for fear of the school friends teasing. In the beginning the parents were skeptic too; but as the boys were very strongly kept their explanation, they were also convinced that the boys told the truth.

In order to get the question examined, the mother applied to - "rude Skov Satellite Tracking Station" (?) which referred her to the report central office of SCANDINAVIAN UFO INFORMATION. The Central Office sent a representative to Sjellands Odde, where he examined the boys, and found many details, which agreed with near observations from the whole world. In a report to the magazine --- of the organization "UFO -NYT" -, he reproduces the boys' report....

The two boys were playing in front of a big stack of hay; when it became dark they wanted to go home. As one of them happened to look up, he noticed a grey-dark object in the sky.... The boys' maintain to have seen the object go down toward the ground, while 3 'legs' were lowered through the bottom - at the same time it slowed down very strongly. It looked very much as if it were going to land.

When the object was 3 ft. over the ground the legs were nearly pulled up again and it speeded up. The boy tells that the object continued towards Kattegat (the sea) at low height, and when it was over the shore it threw something which looked like 'boxes'. It is believed that this is the heavy 'lump'. After a turn out over the sea - something - according to the boys, happened again - a big hamp or box was lowered, apparently hanging in a rope or cable as thick as an arm. Judging from the movements there was no stiff connection. As the box or hamp was down - 8 persons came out through a hole in the bottom of the flying object and at once climbed down the rope or cable. The boys' mean that they took 'binoculars or cameras' ..... the boy was not afraid and later he several times - told his mother that "they looked friendly". Half of the 'persons' waved their hands and smiled at him. They didn't wave their hands in the usual way, the boy tells. They held their palms vertical and made quick, horizontal movements. As the object disappeared the boy heard a sound, which he compared with the soft humming from a battery tape recorder. There was no breath of air or radiation or heat from the 'flying saucer'. The boys' describe the 8 persons as quite small - like the size of himself. One of them wore a blue suit and the others a striped one. According to the boy, they all had containers on their backs from where a tube led to their mouths. They all wore striped caps..... The person in blue did not seem to have a container.

Another remarkable detail should be that they all "had light on their shoulders". It looked like as if they had an electric torch on both their shoulders, and there was light in both ends of the electric torches, the boy says.

U.S. ANNOUNCES DISCOVERY OF 4 MYSTERIOUS SATELLITES (New York Times)

Washington -- A fourth unidentified satellite has been discovered. It fell from orbit Dec. 30. Its existence and the fact that it fell were disclosed in the latest issue of the Satellite Situation Report - a government catalog of American and foreign space objects.

The first three objects are still in orbit and are still listed as - "Unknowns" - objects that have NOT been identified "with any launching or country of origin." They were discovered last May and June by United States Tracking Radar. But their existence was kept secret until early October while government officials debated the pros and cons of admitting they had found objects whose origin could NOT be pinpointed. Secrecy policies prohibit government officials from discussing the sizes of the four objects. Tracking agencies have claimed the ability to find, by radar, orbiting objects as small as one foot long.

Yet - there have been indications that at least two of the three objects found last spring are much larger, and that they were in orbit for perhaps years before they were discovered.

SIGHTINGS OF UFO'S NEAR PEAK DURING 1966 Dayton, Ohio - UFO'S increased sharply last year, according to Maj. Hector Quintanilla - Director of Project Blue Book at Wright-Patterson AFB. But - whatever the sightings were - The AF contended they offered no threat to the National security and did not come from outer space. A total of - 1,060 sightings were reported to the AF during 1966 - the second highest total since Blue Book began keeping records 20 years ago... The record high was set in 1952 and was 1, 501. Of the 11, 107 sightings since 1947 - just 676 remain in the unidentified category. Only 30 of those checked last year have NOT been satisfactorily explained.....

REPORT ON THE CLOSED SESSIONS - 4th. Congress of Scientific Ufology.

The closed sessions of the 4th. Congress were well attended by representatives of organizations from seventeen states, the District of Columbia, Great Britain and Canada. A complete listing of the states as follows: Mass. - New York - New Jersey - Michigan - West Virginia - Georgia - California - Ohio - Florida - Washington - Maryland - Nevada - Connecticut - Delaware - Alabama - Illinois - and the District of Columbia.

While many people came from foreign lands for the open sessions -- only representatives from Great Britain and Canada signed the register for the closed sessions. It may have been that some of those people who attended the closed sessions - did not know of their right to register as Reps. for their organizations. This reporter knows of one Rhode Island publication - a UFO Mag - who was represented during at least one session without listing their presence. Many other reps. may not have registered either.

The attendance of the closed sessions was at all times well over the 100 registered delegates who were listed. The first meeting of the closed sessions opened on Thursday, June 22, 1967. The Chairman for the closed sessions, Mr. Allen Greenfield, called the first session to order at 2:00PM. There were three sessions held. One at 8PM Thursday evening, and the last at 2:00PM on Friday, June 23rd..... Since the order of the business consumed about 6 hours in all, I shall not do more than report the motions which were passed, the major motions which were defeated and the subject of some of the discussions that were held.

A vote of commendation was extended to Mr. James Moseley, for his efforts as Chairman of the 4th. Congress.....

A committee was appointed to define for public consumption the purposes of the Congress of Scientific Ufologists.

Mr. Allen Greenfield was appointed a committee of one, to gather taped recordings of the re-examinations of past saucer sightings, by all researchers who wished to work with him on what is termed --- "Private UFO Hearings".

A committee composed of Mr. A. Greenfield, Mr. James Moseley, Mr. Gray Barker, Mr. Rick Hillberg and Mr. Frank E. Stranges (Dr.) was appointed to establish the site of the 5th. Congress. Applications of those who wish to convene the Congress in their area are to be sent to this Committee. The Committee will establish the site of the Next Congress by Jan. 1, 1968.

4th. Congress Report

It was agreed that the members of the Congress would support the "Moseley for NICAP Committee". The Congress was in full agreement with the aims and principals of this committee, regardless of Mr. Moseley's lack of interest in his re-establishment as a member of NICAP.

The following motion was made and carried by a majority vote:  
"This convention disconnects itself in thought, deed and word from any individuals, groups and organizations; which seek to defraud, extort from or in any way entice people into schemes; that only have unethical commercialism and similar forms of personal profit as their sole aim." ---- The motion was further amended to include the following:

"That a Committee be created at this convention to actively involve itself in the investigation of and pronouncements about such practices to all members and groups of the Congress." The Committee named by the Chairman was the already established committee to locate the site of the next Congress.

Motion was made and carried that the Chairman set up a committee which will send to any inquiring organization, a copy of the Code of Ethics adopted at the 1965 Congress. This Committee upon official notice of the acceptance and adoption of this code by any UFO Organization or publication will officially enroll the said organization or publication as a member of the Congress of Scientific Ufologists.

A report of Project Gray File was given, to the effect that a great deal more work would be required on this project before any results could be reported.

Discussion was held on - Local problems, Various Movements within the field - Plans for the future and the UFO Grid System.....  
Motions made to condemn the Project Blue Book as well as the Condon Committee were defeated by a majority vote.....

ENGLAND - APRIL - 1967. A giant cone-shaped object hovered 15,000 feet above seven Coastguards. For more than an hour they watched it through high-powered glasses. As the object revolved over Brixham, Devon, it revealed some sort of 'door' in its side. An aircraft approached, flew around it, and then flew away. Eventually the object vanished behind clouds after climbing to about 20,000 ft. Scores of people along the Devon coast phoned police stations to ask about the object, sighted at noon, April 28. The Coastguard's report about the object was forwarded within minutes to the Ministry of Defense by the R.A. F. at Plymouth. Last night the Ministry's reaction to the report was puzzling the Brixham coastguards. For at first the Ministry denied they had even received a report. Later, a spokesman said, "further inquiries reveal that we did receive a report, but somehow it was not logged." "We can only suggest that the object may have been a reflection of car headlights or some sort of meteorological phenomena. I cannot comment further." A senior RAF controller at Plymouth said, "We reported all the details. I cannot tell you where the aircraft came from, and you will have a job to get anyone to admit that one was sent up." The object was allegedly tracked on radar.

At the Coastguard station at Berry Head, Brixham, last night, Chief Officer Harry Johnson said, "It's just laughable for anyone to suggest to a body of highly trained observers that this was the reflection of car headlights. It was mid-day!" "The object was obviously made of something very highly polished, and reflected the sunlight almost like a star." Coastguard Brian Jenkins said, "I was able to make a detailed drawing of it which I showed to an air Vice-Marshal who called at the station a few days later. His only comment was: "Most Interesting!"

MANGUM, OKLAHOMA - APRIL 27, 1967 - Witness- E. A. Griffith -

A man identified by the Oklahoma Highway Patrol only as "AMOX" was plagued Thursday night by a UFO. The Clinton, Okla. bureau reported the sighting near Mangum, Okla. Amox said he was driving down the country roads near Mangum about 8 PM and saw an object about 200 ft. above him. He said he stopped his car, and the object SHINED ITS LIGHTS on him and kept them focused on the car. As he would move forward - so would the lights. When he stopped - the lights did likewise. He attempted to go in the opposite direction, but was followed by the craft. The Clinton, Okla. detachment said the sighting was confirmed by the E. A. Griffith family near Mangum. Inquiries to the Highway Patrol by this office suggest that the sighting was considered to be authentic, as the witness, "AMOX" would not give permission to release his full name.. Griggith described the object as being "...dull grey, a cylinder, round on both ends, and something like a butane tank." The object made a loud noise, simialr to the sound of "ten jets", when it left the area and disappeared.....

FLORIDA REPORTS ( EXERPTED FROM " SAUCERS IN THE NEWS " )

Feb. 7 - Between New Smyrna & Deland - Two cars containing 5 eye-witnesses reported a "banana-shaped" UFO with a bubble dome on top and with 8 windows that approached their cars from the direction of New Smyrna and stopped their car motors, put out their headlights, and interfered with their car radios. The UFO made a sound like a "high pitched squealing noise". The object hovered over the two cars above Highway 44 East and was observed by the passengers for around 5 to 6 minutes between 10:30 and 11 PM. The UFO had bands around the object which rotated clockwise at an estimated 100 ft. The UFO appeared to be about 30 ft. wide and 75 ft. long. It was covered with greenish-blue and reddish lights. It disappeared after hovering - in about 30 seconds when it went straight up - it was out of sight.....

April 7 - Venice - Four persons in this community reported a glowing red object with intensely bright corona over the Gulf of Mexico. The object was huge and undulating like a pendulum. The "sphere of fire" moved up and down and hovered in an area, where many UFO sightings have been reported in the past. The sighting occurred at 9:15 PM.....

May 16 - Orange City - Several students of the Orange City Elementary School reported to their teacher, Mrs. Helen Brokenshire, that they had watched a 'flying saucer' through their lunchroom window at about 12:35PM....The object appeared to be about one half mile away - and just above the treetops. The witnesses reported that it appeared to be about 60 to 80 feet in diameter -- was black in color -glistered when the sun shone on it - its bottom was flat and the top of the saucer had a dome on it with an antennae type stick on top of the dome. In addition, the object had an orange bar on the bottom.. which flashed... At the edge of the disc, away from the central cabin - 2 small protrusions were noted.....

June 10 - Ormond Beach - Mickie Thomason, 8, told Mrs. Hank Stevens that she had heard a "sputtering sound", looked up and saw a round object with a ring around it (bigger than any airplane) with orange yellow lights and having a "window" high in the sky to the east. The girl was badly frightened and her face was white as a sheet.... The incident occurred at 10:55AM near Mrs. Steven's house. Mickie furthermore stated that the object dropped something like a net to the ground, picked up something in the net, and hauled it back into the object before flying straight up into the clouds.....

## PHYSICAL EVIDENCE

BY - R. Kenedy Carpenter  
Butler High Schhol Science Dept.

Let me define "physical evidence" as any REAL disturbance in our earthly environment which affects our biological senses or our mechanical instrumentation. This will, in such instances, rule out things like ESP, trans-space thought transmission, automatic writing, mediumship by controls from the "beyond", and dreams.

We will discuss some of these evidences without giving the documentation here. This latter can be found by searching through voluminous files of UFO literature. RADIATION OF LIGHT: The first evidence is that of sightings in the visual sense. Our eyes will function only if electromagnetic energy of a range of wave lengths known as "visible light" impinge upon the retina. Since there are literally tens of thousands of reported UFO sightings, of which 6% cannot be explained away as misinterpretations of natural phenomena, light rays must have emanated FROM, or reflected FROM some substance. Our science postulates a MATERIAL OBJECT NECESSARY to reflect light or give off its own. IF IT CAN BE SEEN, THERE MUST BE SOMETHING THERE.

Along the same line, UFO'S contrary to some statements from ignorant or intentionally misleading sources, have been detected and followed by radar. This means that the microwaves sent out as a beam MUST BE REFLECTED BACK to the receiver to be interpreted as a blip. Therefore, THERE MUST BE A MATERIAL OBJECT OUT THERE TO REFLECT these electromagnetic waves of longer than visible light length. Again, must UFO researchers, as well as many readers, have seen black and white, as well as color pictures of these UFO'S. In order to be recorded on light-sensitive film, THESE OBJECTS MUST BE REFLECTING, OR GIVING OFF THEIR OWN LIGHT in the visible-range. The chemical reaction of the silver atoms in the gelatin emulsion is physical evidence that a MATERIAL OBJECT is sending light rays through the camera lens. In addition, principles of optics indicate that the shape and size of the photograph is closely related to the shape, size, and distance of the photographed object,

Some investigators, like Trevor Janes, have taken sky photos with INFARED sensitive film. He has come up with some very interesting photographs. Assuming there is no defect in the film, there must be something up there radiating heat, like energy, which is different from the rest of the sky around it, and INVISIBLE to standard film and normal vision. Although many sighters have stated that these objects in the sky hover and move noiselessly, there are others who report a variety of audible sounds. Our Science says that sounds are produced by some physical object vibrating in our atmosphere and pushing air molecules (also true for solids and liquids) back and forth from between 16 to 20,000 times per second.

CONTINUED

These vibrations cause compressions and rarefactions in the transmitting medium which allows this mechanical energy to reach our ears. If the sounds do come from the UFO'S, then there MUST be SOMETHING producing this energy.

Several cases can be found in the literature in which animals have set up a din, howling or moving restlessly, obviously disturbed by something which is imperceptible to humans, in the presence of an approaching UFO. Since this occurred only in the presence of the visually sighted aerial object, it follows that this body must be emitting some kind of energy sensed only by the animals. Again, there MUST BE SOMETHING THERE to give off this energy, whether it be ultrasonic waves or an unknown form or radiance.

**MAGNETIC DISTURBANCES:** Scientists and navigators have reported great disturbances in magnetic compasses and magneto-meters during the passing or close approach of a UFO. This seems to be irrefutable evidence of some thing directly associated with the UFO radiating an electromagnetic disturbance. Scientific studies indicate that such radiations result from accelerating electrons.

An electron is a part of MATTER. Therefore, the UFO must be MATERIAL, either in its structure or in its propelling mechanism.

**LIGHT BEAMS:** The literature contains quite a few cases of UFO'S sending out some kind of beams of a 'spotlight' nature. A Florida scoutmaster was knocked out by one which also scorched his hat.

Europeans have reported being knocked down by beams. He also is evidence of energy reactions.

**GRAVITATIONAL EVIDENCE:** Places where UFO'S have allegedly landed have been more or less carefully investigated. In some cases the grass has been definitely pressed down. Sometimes there is evidence of nearby trees and twigs being broken or scorched, or both. In South America an asphalt highway was "blasted" apart when a UFO was reported taking off from a landing. Effects like these can only be caused by gravitational mass (weight) effects which is physical evidence of MATTER, or materiality. Again, when some form of landing gear has been observed - round holes have been found in the ground. These have been studied, examined, photographed. ONLY a HEAVY WEIGHT could be responsible for such depressions.

**HUMANOID VEHICLES:** The strange humanoids associated with UFO landings are also indirect evidence. It seems that these creatures are alien to our Earth. Thus they MUST be transported from somewhere outside our planet. Since physical evidence - contacts - indicate they are physically structured, it follows that their transportation, the UFO, must also be of this nature.....

It was on April 19, 1966 when I received the unexpected visit of Christian Vogt, who is the leader of an important UFO research group in Argentina. He announced his visit by telephone and arrived at my flat within a quarter of an hour.

Vogt is a tall, gook-looking fellow, health and muscular. His black eyes have a piercing look. As he is Swiss by origin we had our conversation in German. Years ago - for some very concrete reasons - I had ceased to trust Christian Vogt in matters of UFO research. However, I was careful not to show this fact at once and received him in a friendly way. I asked him if he had met Dr. Olavo T. Fontes who also lives in Rio and he answered, "Well, it's just him I hoped we could ask to take part in this conversation at your flat, we are all short of time." I consented of course, and in less than a quarter of an hour Dr. Fontes rang my doorbell. I did not feel too good to have them both unexpectedly with me because I was not prepared, but I decided to come to the point with them.

I may add that in former years Fontes and I had worked together but after a while we had strong differences of opinion and we separated... At the time of our separation I had NOT hidden my suspicion that he was working for another agency which he kept secret,..... On this April day, however, we put ourselves at ease, took off our jackets, and started a friendly conversation. Vogt and Fontes did not try to interrogate me. The latter told me about his visit to the United States where he had met APRO in Phoenix, and NICAP, in Washington, and also Dr. J. Allen Hynek. The latter, he said, was working with the UFO research department of the USAF. Then he added Fontes told me very spontaneously that Hynek was on the payroll of the Air Force. Then he added: "IT IS OUR WISH THAT YOU SHOULD JOIN OUR RANKS AND EXCHANGE YOUR RESEARCH WITH OURS. Hynek is in a position to pass on your information. He is very keen in getting information from private sources. That's what the Air Force wants him to find."

As he got no immediate answer from me, he told me that all I would have to do in their research program would be to fill in the questionnaires and keep to a certain scheme of questioning my witnesses and registering my interviews. I would, of course, receive financial aid to help pay for my work and expenses. (ED. NOTE: could this and the next few lines be referring to aid from the CIA?) I did not show any special interest in this proposition because I wanted him to be more specific. And indeed, in the course of the conversation, I learned that the financial aid which I would get through Hynek would be quite substantial, even to the point where I could make a full-time job of it if I so desired..... Continued next page..

As I am a medical doctor, I hid my astonishment but pointed out that through my bulletins Hynek would get all the news I could give him and it would cost him nothing..... Finally, I got impatient and said that in working for Hynek I would be working for the military and I did not want to do this. I made it clear that as a University-trained Doctor of Medicine I thought it slightly beneath me to work for any military body..... I asked Dr. Fontes laughingly if he did not think the intelligence quota of a medical doctor was slightly above that of the military. His answer: "That's why they engaged a scientist, Dr. Hynek. We could influence the military through his opinion and show them the new way to a correct research."..... Both visitors told me that there were two reasons for this wish: (1) The number of landings, sporadically before, which had recently taken on a systematic character. (2) The famous BLACKOUT over the New York area... which was believed to have been generated by UFO disturbances, and the belief that UFO activity would take on an accelerated crescendo in the future.../

... I told them that I had not yet forgotten how, in 1958 and 1959 certain members of the "silence" group had tried to intimidate me, and how degrading their behaviour had been. Fontes, who apparently knew the story quite well, asked me to which personalities I made allusion but I did not give him any names. Again and again Vogt and Fontes tried to convince me that only in cooperation with them could I get a maximum of information to which nobody else had access.....

I then told him frankly how Fontes's group was scaring people out of their wits instead of giving them confidence to tell their stories openly.... One co-worker of Fontes - Commander Aurefebus B. Sinoes was out to frighten people into silence, those people had made contact claims. His manner of putting questions and threatening those questioned was systematic and it showed a certain pattern behind which I suspected a plan from a higher agency. His being in close relation (i.e. Fontes) with the United States consulate general in Sao Paulo could not help to deny such stories.....

In ending my first interview with Vogt and Fontes in April, I made it clear that my own position with the contactees would be spoiled and worthless if they learned that I was working with Dr. Fontes and his group of silencers. They were not so silly, these simple people, and they soon found out the difference in tactics between Fontes and myself. I added, "And I am interested in getting the truth and nothing but the truth from these people, and I want to keep their confidence. Once it is lost you are out."

I had no other visit since then, neither from Vogt or Fontes. I am glad they were without too much tension, frank and honest despite the touchy subject. I still have no intention whatsoever to join the ranks of Professor Hynek and the United States Air Force.....
