PARAPSYCHOLOGY COMMITTEE TOURS "TWILIGHT ZONE"

Parapsychology Committee Chairman, Walter Palmer opened the meeting with a handout of Tempo, published in the October 28, 1990 issue of the Chicago Tribune.

The story of interest occurred October 16 when farmer Ed Lawson found a depressed circle 46½ feet in diameter in his corn field; it included ready to harvest husks punched into hard soil. None of the locals had seen anything like it and local radio broadcast insinuated the invasion of aliens in Rock Island County. That led to the invasion of the "Corn Stompers" according to Lawson. News media and curiosity seekers began bypassing the "Keep Out! Private Property" signs and climbed the property fences to get a better look. A full tour buss even ventured by.

"J.L. PALERMO UPDATES STUDY GROUP ON RECENT LOCAL & NEARBY SIGHTINGS"

The UFO Study Group of Greater St. Louis met at 2:00 PM on November 11, 1990 at Tyler Place Presbyterian Church located at 2109 South Spring at Russell. After welcoming members and guests and briefly outlining the history of the organization, John Schroeder, President, extended an invitation to the audience to join in the "sharing time" segment, during which interesting experiences, data and comments may be passed along to those present.

Always a source of entertainment, Frank Brown, group Marshall, read headlines from various exposé-type papers. Articles pertaining to UFOs, Big Foot, Nessie, crop circles and other possible "alien" activities.

Ken Hanke, Board Member, discussed a sighting which took place in the North County area of St. Louis about 6:00 A.M. on Sunday, November 4, 1990. Hanke, along with Study Group investigator Walter Palmer, initiated an investigation that same afternoon. The sighting, described by a young lady and her mother, was in a residential area and lasted from 4:30 A.M. to 6:00 A.M. They were looking across the street from one of their windows described the object they saw in their neighbors yard as a "cocoon with movement in it" which appeared to be three or four feet tall. Approximately 30 feet behind it the bushes were lighted. The object did not take off at the end of the sighting; it seemed to flicker out. Later, the ladies were able to pick out what looked like a pile of bubbles when asked to look through a UFO identification book. Hanke reported that while investigating the yard, he and Palmer found the grass matted down and swirled in an area that measured 11 feet in diameter, but there was no discoloration. Since that time, he notes that the grass has returned to normal. The only reason

this sighting was called in was because these people, who seem to be your "average working Joe's," were concerned about possible radiation.

J.L. (Joe) Palermo, Editor of the Enigma, reporting briefly on the last St. Charles Committee meeting, said it was mostly a review of the recent "SHOW ME UFO/IAC" Conference at Noah's Ark. Also, copies of an article from the MUFON Journal regarding a recent UFO sighting in Belgium were distributed and discussed. Palermo said the UFO Study Group in Belgium and the Belgium Air Force officials there are cooperating with information in this particular case. This is a milestone for ufology.

A report on the last meeting of the Parapsychology Committee was given by Walter Palmer. He said paranormal events were not the main topic per se, but rather they discussed a 46½ foot circle discovered by an Illinois farmer in his corn field while working on his crops (See article PARAPSYCHOLOGY COMMITTEE TOURS "TWILIGHT ZONE"). Palmer also said they reviewed some 1961 films from the Twilight Zone genre, which everyone found most interesting.

John Schroeder next announced that our next meeting on December 9 would be our annual Christmas party. While gifts will not be exchanged, he encouraged everyone to bring treats to be shared and enjoyed. A documentary video may be shown and we will play some Christmas games. At this point a fifteen minute break was called, during which coffee, soda and snacks, faithfully furnished by Myrtle Palmer, were available for a small fee.

The meeting continued with John Schroeder giving a brief introduction of our speaker, J.L. Palermo, who in his work for Missouri MUFON is one of the head investigators (Palermo holds the title of Assistant State Director of Investigations in the State of Missouri.). Palermo opened the discussion by reporting on the case of Lawrence Akers, a Bel Grade, Missouri farmer. The report goes that while in the course of working in his field, Akers discovered discoloration that formed a pattern on the ground. While

numerous rings and circles have been reported elsewhere, this was unusual in that it had twelve spokes in the formation. At the end of the circle it had a slight hooked appearance, and then continued the line a foot further. The grass between the spokes was a bright green, with the spokes being a light brown. The grass beyond the perimeter of the circle was the normal color of the rest of the field. When Palermo tested the field with a knife the brown area was very soft. It was about ten times harder to insert the knife in the soil of the bright green area. Inserting the knife in the soil outside the circle required an effort somewhere between the two areas within the circle. The roots appeared to have been killed off in the brown spoke area. Palermo said that once the news hit the paper and the radio, he got ten to twelve phone calls from other farmers who had experienced forms and imprints in their fields some years back and just never bothered to tell anyone, and other people who had seen lights and had experiences in the last six months (prior to May 1990). Soil samples have been taken from the Akers' property but have yet to be analyzed.

Palermo said that because of the many possibilities involved, it is very difficult to try to figure out just what created the formation in Akers' field, including whether or not it might have been manmade, caused by something hovering over it or formed by something as yet unknown to us. The Sky Chopper from KTVI Channel 2 did a fly over for their broadcast.

Of the other reports Palermo received, one was from the St. Charles area that coordinated with a report of a sighting near Black River. Palermo states that lights in the sky don't tell us a great deal or give the investigator anything tangible with which to work. Air traffic controllers and local police are not concerned after an incident therefore their follow up for information is negligible. Consequently, there is no way of confirming what the witness may have seen.

Palermo next reported on a sighting that took place around Christmas of 1989, which seemed to include lost time. A couple has been visiting friends who lived in Rolla, Missouri. On their way home to Poplar Bluff, Missouri, approximately at a point they said was 30 minutes from home, they encountered an object that looked like a spinning saw blade the width of a pick-up truck with sparks coming out of it. To the husband driving it appeared to be on a head on collision with them. The wife in the passengers' seat viewed it as making a side pass on the car. The car was traveling about 60 miles per hour and the sighting lasted 1.32 seconds. The husband was a salesman and had traveled the same route many times before. During the interview, he remarked about a bet he and his wife had made about how long it would take to get home. He had said 30 minutes tops (long before the sighting occurred) and yet, he stated that from the point on the road that they saw the object, it was one hour to home. The husband and wife began to try to logically explain the apparent missing time. They went back to a possible turn off they made and had to backtrack from. They couldn't remember if it was that trip or not. Palermo said he directed them back to the previous conversational bet about getting home in 30 minutes. The husband said that he had made the bet in honest, good faith. Palermo asked about the location of the sighting and the distance home. Palermo directed the husband to be factual and state how far it was from the point of the encounter to home. The husband apprehensively but firmly stated one hour. The wife said she felt foolish about the contradiction in time.

Palermo stated that "sometimes you pitch logic out the window and have to look at the facts. You have to go where the data lets you go." Palermo said his is waiting till the couple is comfortable enough to undergo regressive hypnosis. He stated, "In an investigation, it is very important to keep things on

track. People will start to second guess themselves because they can't accept the information that they are seeing because it doesn't seem logical."

Another interesting case report from Palermo took place in a subdivision in an area of West County on the Monday after Easter, 1990. The gentleman reported the sighting said he had gotten up in the middle of the night due to allergies, and decided to go to the window and look outside for some reason or another. He flipped the outside security lights on, observed for a moment and then flipped them off. There was a bright flash of light. The man, concerned he had blown some lights, turned them on again. Everything lit up fine. He shut them off. Immediately, the house was engulfed in a bright light. The support beams in the basement began vibrating so hard that they made a tremendous "moaning" sound. His work being in construction and developments, the man's first thoughts were to go downstairs and investigate but was unable to make himself go downstairs. His wife awoke. After asking "What's happening?" she got up and went into the adjoining bathroom. She stepped into the jacuzzi and looked out a window facing west. Her observation was different than her husbands in that she perceived the light as coming horizontally into the house while the husband perceived it coming from above. After 15 seconds, the incident was over and everything back to normal. The couple stayed up for a little bit talking about what happened. He checked the power systems of the house to find them all operable. All electrical items such as microwave, security systems, etc. have a "Power Failure " read out on them. There was no indication of power failure or interruption of systems. The couple went to bed.

In the morning, the husband observed that his wife's face looked sunburned. The odd thing about it was that the redness didn't burn and it was very specifically only her face.

Not her neck or ears or under her jaw. This condition lasted for three days and finally faded away.

On possibly the same night, another couple in West County potentially shared a UFO/alien encounter. The wife awoke in the middle of the night feeling thirsty. She got up, went to the kitchen and got a Coke. She opened it and practically guzzled it. As she stood there and her eyes adjusted, she noticed, consciously, a small figure of a humanoid being standing outside her glass door on the side of the house. She "purposefully" choose to ignore the form and started towards the living room. As she moved into that area, she saw numerous pairs of eyes peering in from the floor to ceiling window at the side and backyard corner of the house. She moved a few steps further towards her foyer area and saw another small figure standing outside the sliding glass doors leading to the backyard. The next thing she knew, there were several of the small beings milling about in her living room. She said they had heads like frogs. (Palermo noted at this point that a form of alien deception is to look like an animal or something else of human familiarity.) Suddenly, her living room had five or six of these being wandering around. She felt communication with one of them and asked, "Will there be peace?" It shook its head "No." The last memory she has is one of she and her husband standing by the double glass doors, watching this light in the sky that looked like a star until it sped off out of sight. (Palermo believes the two West County sightings are related.)

Palermo said there have been a number of things going on around the area but only a small portion is getting reported and investigated. There was a report from Defiance, Missouri, that a man and his wife were summoned home by the police because the interior security system of their home had gone off. The security system is based on detecting motion.

When they got home, they found their home absolutely secure, no sign of entry, yet the alarm had been set off. A family directly across the road from them experienced their medical alert alarm go off soon after. On investigation of the possibly endangered couple, they were found to be just fine. What had set the alarms off? Ray Nelke offered a wireless phone as the possible culprit. Due to the radio frequency they work on, it's very common for them to interfere with other electrical appliances.

Palermo informed the Group that people who have been abducted are disturbed by the title "abductees". A new term, "those taken", is what Palermo has opted to call them.

After a brief question and answer period, Palermo closed this interesting and informative presentation by stating that the bottom line now is to meticulously research the facts we have from investigations to see if we can more accurately determine aliens' purposes according to their activity.

In a book titled ELVIS: HIS LIFE A TO Z, it is reported that Elvis Aaron Presley saw a UFO.

Actor Lee Majors and his former wife, actress Farrah Fawcett, watched a UFO in Philadelphia one evening (the previous night, Majors had a dream about a UFO).

The only thing better the authors could have done was to have mentioned MUFON or a UFO Hotline phone number. As one involved in the entertainment industry, I'll see what I can do to verify these reports with those performers still alive. As an Elvis fan and performer (The Spirit of Elvis), I am absolutely fascinated by this information. And for those of you wondering, no, I have no idea if Elvis is still alive.

ALIEN WARFARE AND GOVERNMENT TRICKERY

Through hypnosis of abductees whom I am researching, I have learned that they call me a "helper" and an "activator." Apparently, I have the ability to help awaken programming and memories in those with blocked conscious recall of their experience. These races or civilizations of abductors are morally breaking the natural laws and principles of the "Universal Intelligent Creative Force Energy. I believe this UICFE consists of confederated and fully developed souls that are ever changing. These particular aliens do things by force slipping through protective warfare shields both interdimensionally and time wise, doing what they have to do. The Watchers cannot directly intervene in our affairs because of the Laws. They are "never to interfere, never to force anyone, only to give hints, but not too clear."

They have had military meetings with "Greys" in an isolated spot in South Africa, asking them outright to leave the planet (through various attempted telepathic negotiations). This was witnessed by several people who I work with. They told to me on a "need to know basis." Earth humans, generally speaking, are kept in the dark, consciously, concerning all of these activities. Those that have reached a certain level of development attract (biologically speaking) other life forms who require their unique "earthly human qualities and abilities." A particular race of Greys "retrieve" intelligence information from the brains of humans that have been deposited there by the Watchers, by putting a small needle into the back of their head, very quickly and painlessly, usually while they are asleep. The Greys then try to block the information from becoming useful, and insert their own brand of effective deception, sometimes posing as the Watchers themselves to gain the cooperation of the victim. However, to an alert individual on all levels, their methods and actions give away their disguise and purpose. Most of the information they are actively looking for has been implanted by the Watchers themselves to subvert these activities. Humans must act, as the Watchers have a policy of "Non-Direct Interference" and can only plant discreet ideas and suggestions, just barely skirting their own laws in order to protect the greater purpose.

The USA and Canadian governments are at this very moment trying to find out how widespread the abduction phenomenon is in the civilian population. They do this in several ways. One, by monitoring actively aggressive researchers and two, by slow infiltration into established organizations, filtering back material to the government. This has been documented in the NICAP organization. Thirdly, they place ads in the public domain through civilian medical groups, seeking out women with fertilization and miscarriage problems. To contact them, a cover story is usually placed having to do with administered drugs that may have possible adverse effects on babies. Once the

women come in scientists can do a variety of tests on them. Also, there are MAGNETIC DETECTION SYSTEMS (MIR & SQUID) which some Canadian universities (and U.S. as well) are using to try and locate implants, their operating frequencies and programming information. I have been approached by people who operate these machines but I refuse to send abductees to them. Thoughts produce electromagnetic waveforms which can be interpreted by intelligent computers. The new SQUID machine uses a non-intrusive means to pick up every individual cell firing frequency of the brain, identifying unusual patterns and localizing them. Together with the other machines and a screen, a great deal of knowledge can be gleaned from the abductees. There is a project going on right now to attempt to prove that abductees have brain illnesses. This gives government funded scientists the flexibility to bring them in for tests and possibly even incarcerate them "humanely" in a medical environment, the final information being filtered through to MJ12 operatives. I believe one such experiment is going on by Dr. Michael Persinger of Laurentian University in Sudbury, Ontario, Canada (although he may not be fully aware of the purpose.) As reported in The Toronto by freelance writer Howard Goldenthal in an article titled "Oppression in an Age of High Technology," "The U.S. Navy was tapped to check the viability of the new embassy protection plan. It went to Dr. Michael Persinger, head of the neuroscience laboratory at Laurentian University in Sudbury.

Persinger is acknowledged as one of the foremost experts in the study of electromagnetic radiation. He decided to accept the Navy's contract for purely humanitarian reasons he said. "Zapping terrorists or rioters would be better than gunning them down at the embassy gates". He does not know if any of his research was implemented. He is claiming that by firing magnetic waves into the brain he can induce UFO hallucinatory images in random test subjects. The possibility exists that one in five people have had contact with the

phenomenon. If this is the case, Persinger may actually be interfering with memory blocks induced by implants and superior technology (see OMNI Magazine; December 1988). The sad thing about all this is that it is being done in a "democracy" with guaranteed "rights" and "freedoms." Saying one thing to a citizen in trust and doing another without their "direct consent" is downright morally inexcusable. In my opinion, they should be exposed WITH DOCUMENTATION. The perpetrators are being monitored and, in due time, will be unmasked by the victims. The fault ultimately rests on the shoulders of the decision makers as well as the people with inside knowledge who turn a blind eye. (Readers may write to Mr. Goldfader in care of this publication.)

Lawson received a call from a woman warning him to stay out of the circle because he would be harmed by the poison left by the aliens. A man claiming to be a "government agent" took photos of the circle and then stated that "Yes, they were here. I saw their footprints. Their feet aren't like ours, they're on backwards."

Grant Callison, retired newsman from Galesburg and a State Director for MUFON, denounced one theory that the circle had been made by inserting a center post and then dragging a heavy chain around to depress the grain. "Everybody has a right to their own opinion and I think it could have been a UFO," stated Callison.

Robert Frank, head of the Physics Department at Augustana College in Rock Island, believes one or more pranksters made the circle. Others suggest that whirlwinds, witches, magnetic forces, subsoil rock formations, animals or space ships were responsible.

Rock Island County Sheriff, Mike Grehan, discounts the prankster theory. "It's difficult to depress corn that hard when it's 8 or 9 feet tall and if

it was kids, they usually have to tell someone who tells someone else. We haven't gotten any feedback like that at all," Grehan commented.

At Lawson's request, Frank took geiger counter readings inside and outside the circle. No appreciable variation on radiation was found. "My view is that if this was caused by some kind of space vehicle then there are a lot of questions about how it was done," Frank stated.

The meeting moved on with John Schroeder reading a publication from Monterey, Mexico which offered the "New Age" invitation to announce to the "Space Masters" that we represent the USA as "Eagles In Flight" and are willing to share their communications or go with them "to become missionaries of peace...(to) spread our Light, Joy and Love around wherever we go." No one present was inclined to go.

Ernie Joyce circulated Post Dispatch articles covering such arcane subjects as "Wildman Wanted" posters in China, "UFO Believers Await Day of Reckoning," "Solaris Film: Exploring Mysteries of the Universe in '76 Soviet Epic," and "Half of Americans Believe There is Life on Other Planets."

The last half of the program entertained with two episodes of the "Twilight Zone" series. The first brought a surprising twist to the alien invasion plot, and the second dealt with humanity's pervasive fear of death.

The next meeting will be held at 7:30 PM on Wednesday, December 5 at the Schroeders' home.

EXTRATERRESTRIAL FRIENDS AND FOES **(C)1990;G. Andrews & B. Bartholic**

(The following is an excerpt from the above titled book graciously offered for our viewing by our friend and colleague, George Andrews. It is being considered for publication by Avon.)

Diane Duurland lives in Amsterdam, Holland. She spent her childhood in the town of Beveren, which is now named Roeselare, in Belgium. During the winter of 1944, when she was 11 years

old, Hitler used to visit Beveren frequently and she would often see him being driven by in an automobile.

During that winter her mother was sick so she had to do all the errands. She worked very hard as the oldest of her mother's five children. In the darkness of the winter evenings, one of her chores was to walk to the farm of the Sommers' family and get milk. While walking on Grafeé road towards the Sommers' she saw a strange swift movement behind the hedge of the Belgium cemetery, which is next to the German cemetery. Something accelerated passed her. Her first thought was that Hitler had gotten a new car, but it didn't have any wheels. It had red, blue, yellow, green, white, and violet colored lights that kept changing. There were people inside it. It made a very strange zooming sound, not at all like an automobile engine. It hovered about a meter (three feet) above the ground. When she realized what a strange thing she was seeing, she became so frightened that she jumped into a patch of tall stinging nettles.

As she watched it, the thing seemed to dissolve. She thought it might have gone over to a field on the Wallekamp farm, but she didn't see it again. Instead of continuing on her way to get the milk, she returned home and told her mother what had happened. Her mother did not believe her and boxed her ears for telling such a fantastic story. Her mother did take a look outside, but unfortunately it was no where to be seen. Although she was very frightened she was sent out again to get the milk.

When she reached the farm of the Sommers' family, she told Mrs. Sommers what had happened. Mrs. Sommers said that there was a lot of these flying saucers around, but it was important to keep one's mouth shut because if the Germans found out anyone had seen this, the person would be shot or sent away to the camps.

What Diane Duurland saw on that winter evening in 1944 was circular and saucer-shaped, something like an umbrella with an edge on it that kept turning. The edge that kept turning was white. The red, blue, yellow, green, and violet lights that kept changing came from the

dome-shaped part of it. The object itself was a silvery, metallic color. It was about as large as the automobiles of that period. It was opaque or semi-transparent. It was a strange and wonderful sight that she will always remember.

When I mentioned to Diane Durrland that the term "flying saucer" was supposedly first invented by a journalist after the Kenneth Arnold sighting in 1947, she pointed out that the shape of the object so closely resembled a type of plate in common use in every household that it was natural to use that name.

Their talents show cased on methods to be applied and the various loopholes for which a hoax can hide. None was found! By and large, the credibility of both the organization and the investigators are on the line as second-rate methodology does not impress scientists.

A final statement. If the debunker-ufologist crowd are so swollen by avocational jealousy that they cannot accept investigations by those who unselfishly deliver every thing they can give; UFO research, period, will have no credence amongst the scientists, news media, and other professional groups of whom we are attempting to reach!
