Two Tell Of Seeing Object Here

Two more reports of "bright objects" being sighted in Rhinelander (Wisconsin) territory were recorded at the sheriff's office Monday night, with one of the sightings being made Monday evening and the other Saturday night.

The sheriff's office notified Alvin P. Dietz, city-county civil defense director, who in turn notified the state civil defense headquarters at Madison. The information then was relayed to the national civil defense headquarters at Battle Creek, Michigan, and to the air force.

Vince Rosselli, Rte.2, notified the sheriff's office at 7:10 p.m. that he had just seen a bright object moving across the sky from north to south. He said the object appeared to come to earth near Rhinelander.

William Kussman, Star Rte.2, reported that between 6:50 and 7:15 p.m. Saturday he noticed a bright object in the sky which appeared to be moving in a westerly direction.

Over the weekend the sheriff's office investigated a mail truck driver's report that about 8 a.m. Saturday he saw a bright object in the sky near Oneida-Forest county line east of Monico. (Rhinelander (Wis.) News, Tuesday, January 7, 1964)

Crandon Resident Reports 'Object'

A Crandon woman who has been reading of the various reports of "flying objects" sighted in the area, called the Daily News Friday afternoon saying that she saw an object similar to those described in the Monico area on or about Christmas day.

Mrs. Frank Bartz said she and her husband were driving toward Crandon from Monico on Highway 8 about 9 p.m. when she spotted a bright red object going across the sky. She said she saw the object for only a short time, adding that her husband did not see it.

She said she did not think too much of the sighting until she read of other persons reporting similar objects in the area. (Rhineland (Wis.) New, Saturday, January 11, 1964)

Morgan Family Watches Bright Object Plummet Into Mountain

STODDARD-A family of nine people living two miles north of Morgan reported today what they believe was a meteorite burning on the east slope of Francis Peak Wednesday night.

Virgil Barnes said he and his seven children were watching television near their large picture window when they saw "a red streak like a jet."

Mrs. Barnes said today at first they thought it was a jet airplane on fire. "There was a flaming tail following a big ball of fire," she said.

"Mr. Barnes immediately called the Utah State Highway Patrol who said they would notify the sheriff's office," she said. Their daughter, Gloria, was celebrating her 15th birthday that night, but it was 12-year-old Kay who saw the "flame in the sky first."

At 10 a.m. today Mr. Barnes and Donald Phillips of West Morgan went up in a ski-equipped two-seater plane to scout the area. There was no report at noon as to what they found.

From the Barnes' picture window a dark patch could be seen on the side of the mountain, but it could not be properly identified through binoculars. Those in the house were able to say it was not trees, just a large dark area in the snow.

The Barnes family reported the brilliant object burned and glowed for a number of minutes. It was located about 1,000 to 2,000 feet down on the eastern slope of the mountain near the radar domes. Other area residents questioned this morning said they had not seen the burning object. But the entire Barnes family-with the exception of the baby-saw it.

In addition to Mr. and Mrs. Barnes, Gloria and Kay, there were Barbara, 3; Diane, 6; Judy, 10; and Paul, 13. Mrs. Barnes said there was so much excitement Wednesday night that there was very little sleeping done.

"Virgil was so excited he could not work and decided to see for himself by plane just what landed there," said Mrs. Barnes. (Stoddard, Utah ?, January 16, 1964)

The second appearance of an unearthly visitor occurred on the night of January 10, (1964). Three youngsters noticed a strange moving light in the sky over the Slackwood area of Lawrence Township. The three observers, Kenneth Clarice of 128 Villanova Dr., Susan Petry of 2222 Brunswick Ave. and Marite Azzaro of 18 Graff Ave., all 13, told police the light appeared to have landed in a nearby wooded area.

When questioned, the trio explained the light was not an airplane, but rather resembled a shooting star.

Again police probed through the wooded area with searchlights and, as in the earlier Ewing Township sighting, nothing was found.

Mystery Fireball Seen Streaking Through Sky

At least three local area residents saw the fireball that streaked across the Pacific Northwest sky Wednesday. The descriptions by the three-David Lindsay, who flies for Pendleton Airmotive, and Mr. and Mrs. Henry Molstrom, who live in the DeSpain Gulch area-were similar.

Lindsay said he was apparently right in the midst of this fireball while he was flying from Portland. The whole sky lit up at 6:30 p.m. as he was flying at 5,000 feet. It was so close that it lit up his cockpit in a white light. He thought it couldn't have been more than one-quarter of a mile away.

The light seemed to be climbing and his first impression was that it was a rocket. He said it lasted only about 4 seconds. A United Air Lines pilot on the same frequency told him he saw it, too.

Mr. and Mrs. Molstrom, headed for Pendleton, were nine miles from town, going up DeSpain Gulch, when they saw it "coming from behind us." They said it was as though a car had streaked up from behind and had shined its lights full in the back window.

"I believe we could have read a newspaper, it was so light," said Mrs. Molstrom. She said it was a white light with a light green tinge. Molstrom said the object appeared about the size of a basketball. "It sort of melted," rather than breaking into pieces, he said. It was traveling toward the east.

"It happened so fast," Mrs. Molstrom said. "It completely lit up the hills to the north." She said the occurrence "completely startled us". In fact, she admitted, "it scared us for a few seconds." (Pendleton, Oregon East Oregonian, February 6, 1964)

Object Falls To Earth, Many Report

A brilliant object plummeting to earth somewhere south of Marshfield about 8 p.m. Sunday was reported to police by several persons over a wide area.

Robert Martin, route 2, Marshfield, called police at 8 to say he had seen a falling object which appeared "very large and bright". He estimated it had fallen 1 to 3 miles south of his place, which is a mile south of Highway 10 on County Trunk A.

The State Highway Patrol office at Rib Mountain also reported seeing a falling object in the southern sky, and Mike Engle, who lives on the west edge of Spencer, also called at 8:09 p.m., to report it.

Engle, who told police he has seen several meteors, said he had never seen a larger one, and that it not resemble a meteor. He said it was a brilliant blue and plunged straight down.

John Dressendorfer, 402 Wisconsin Ave., called the station at 8:20 p.m. to report that he was driving north on Highway 80, just south of Pittsville, when the interior of his car was lighted up for about three seconds, with a brilliant, steady light, about the color of a lightning flash. He said he did not see a falling object, but didn't say whether he heard a noise.

Police said the Wood County Sheriff's Department had also received reports about the object and was investigating. (Marshfield (Wis.) News Herald, Monday, February 3, 1964)

UFO Glows In Del Norte Area

CRESCENT CITY (Del Norte Co.)-A glowing unidentified flying object was reported in two different locations Saturday night and later seen in Cave Junction, Ore.

The object described as a ball that glowed in varying shades of orange, gold and white and having a tail was reported to the Federal Aviation Agency about 8 p.m. by Gordon Case who said he saw it over the foothill east of Crescent City from the Ninth and L street intersection.

Fishermen on the Fort Dick beach reported seeing the UFO on the beach area. One of the fishermen tried to catch the object with a flashlight beam and it fled. This incident was reported to the Del Norte Sheriff's Office. (Eureka, Calif. Humboldt Times, February 12, 1964)

UFO Sighted In Three Areas

An unidentified flying object was reported to both Del Norte county sheriff's office and the FAA Saturday evening. A call was received from a person at Ft. Dick Beach stating that he and a group of 17 others had sighted an object flying from north to south over the beach. The UFO was reported to be glowing and changing in color from orange to gold to white and seemed to have a long tail which did not glow. Some of the witnesses attempted to turn lights on the UFO but it sped off.

Further reports from other sources were received by the FAA at about 8:55 stating that the same object was seen over the foothills of 9th and L streets and a report of its being seen in the Cave Junction area was given to the Triplicate about 8:00 p.m. No explanations or further information has been received.

Area Residents Report Sighting Flying Object

Was it a jet plane, a satellite or some other unidentified flying object?

Reports began coming in to the Herald and News office early Tuesday morning from persons in the area who had sighted a flying object early Monday evening. Time of the sighting ranges from 6:30 p.m. to 7:30 p.m. with few persons noting the exact time.

However, reports dovetail on the details of the sighting. Two Kalmath Falls men, Anthony Matt and Harvey Blevins, were returning home from Beaver Marsh and were in the vicinity of Modoc Point. They reported a light first noted over the Kalmath Falls area, moving slowly with a streak of about 100 to 150 yards behind it. The object came to a cloud and disappeared.

Another report from an unidentified person five miles west of Kalmath Falls says they watched the object and then it appeared to explode.

Two carloads of persons were en route from Kalmath Falls to Malin when they first saw the brilliant cone-shaped object. These persons checked the time by their watches and said it was 6:30 p.m. Their report said it was huge and low above the mountains with a bright vapor trail wide behind the object and trailing to a sharp point.

Another report also place the sighting at 6:30 p.m. and reported it was traveling south to north and was first sighted over Mount Shasta. This report also termed it a triangular object with a long trail, reporting that it was visible for about 30 seconds.

Kingsley Field reported only that no jet planes were reported out from this base between 6:30 and 7:30 p.m. The last of their planes were reported back at the field at 8:00 p.m.

Valley Residents Also Saw UFO

The unidentified flying object sighted over south central Oregon early Monday evening was seen by at least four Rogue Valley residents.

Mr. and Mrs. Carl Hoskins, Jacksonville, described the object as "a blossom like" explosion following a wide band of lightning-bright light. They said the light and the explosion appeared three times before it disappeared in the sky over the Siskiyou mountain range.

Nicki and Steve VanDewalker, Wilson Road, Ashland, also saw the object at about 6:30 p.m. They said it appeared to be round and flat and that it "glowed." From the Ashland area the light seemed to angle up from Mount Ashland before it disappeared.

Several Kalmath Falls residents reported seeing the object shortly after 6:30 p.m. The Air Force at Kingsley Field said it had no planes in the air at the time.

In the last four reports the objects were later brushed-off as being rocket fired from Vandenberg AFB in California. The papers gave this "explanation" wide coverage, typical of most papers hungry for inside information and favors from various governmental offices. One look at these reports, however, and one will see that the objects described were not like rockets, as they were described as "round and flat", and triangular. Editor.....

Pilots See Mystery Blast Over Atlantic

Pilots of two jet liners saw an unidentified object explode with a tremendous flash high over the Atlantic today. What appeared to be fragments plummeted toward the sea, leaving trails of white smoke. The sighting was reported by Capt. E. D. Morrison, pilot of a Pan American 707 bound for London from New York with 42 passengers, and Capt. R. A. Bottos, piloting a DC-8 jet of the same line from New York to Frankfurt with 77 passengers. "We were about 100 miles west of the Irish coast at 29,000 feet," Bottos said at the London Airport, "I saw this object traveling high up on a north-to-south trajectory. Suddenly it exploded with a big flash and parts of it fell into the lower atmosphere trailing columns of white smoke. I have no idea what it could have been." Morrison, whose plane was in the same vicinity at 31,000 feet, said he saw the same thing.

Widely Separated Residents Report Firey Sky Object

At least two western Nevada County residents, in widely separated areas, reported a flaming object in the northern sky about 11 p.m. last night.

Nevada County Sheriff's office received a call from a Highway 20 resident, east of Nevada City, who sighted what appeared to be an airplane in the Blue Tent diggings. Shortly thereafter a Dog Bar Road resident, south of Grass Valley, reported a blue flaming object believed to have been a meteorite plunge down in the north sky.

N. M. Officer Reports 'Unidentified Object'

It's a good place for a flying saucer. Right on the edge of White Sands Missile Range on the wide open New Mexico desert, just 30 miles northwest of the site of the world's first atomic blast.

Socorro policeman Lonnie Zamora says he saw it, and police and military men seem inclined to believe him.

Zamora is a "very reliable witness," Army Capt. Richard T. Yolder, uprange commander of White Sands' Stallion Range, said. Holder (Yolder?), whose headquarters is near this central New Mexico town, was called in by local police after Zamora reported seeing the object Friday.

Deputy Sheriff James Luckie said he believes "it's something out of the ordinary, something very few have ever seen."

"I was scared," Zamora said. He said his experience taught him one thing: If it happens again, he will still run away like he did Friday.

Zamora said he spotted an egg-shaped object on the desert about a mile south of Socorro. He denied seeing any signs of life around the object (it has since been found that Zamora saw a small man-like creature near the saucer-Authors) and said the machine rose and flew slowly away until it faded from sight.

He said he spotted what appeared to be a pair of white coveralls near the saucer, but could not tell of anything or anyone was in them. The object, about the height of a car but larger, appeared to be made of a shiny, aluminum-like substance, Zamora said. It flew away after he got within 100 yards, he said.

Two investigating officers were at the scene Sunday from Kirtland Air Force Base in Albuquerque. Maj. William Connor and Sgt. David Moody used a Geiger counter to check the area, where the only evidence of an unusually visitor was a burned bush and four small depressions in the ground.

Flying Object Swooped Out of Sky Toward Car

State police officer Marvin Romero said two men, whose names he did not get, told him of seeing a strange flying object about 10:30 p.m. Saturday, which would have been about two hours before the Gallegos' sighting at La Madera. The men told the officer they were driving from Abiquiu to Esanola when the flying object came straight toward the car. It veered away. All they could see, they said, was a jet stream of blue flame. They said it definitely was not an airplane.

Flying Object Visits Region

A team of investigators from Kirtland Air Force Base, a group from Washington, D.C., and the FBI are expected to join State Police this afternoon are to investigate the two reported sightings of an unidentified flying object here. They were the third reports over the weekend, the first coming from a Socorro police officer. State Police also received a report from two men traveling in the same general area Saturday night that a flying object swooped down toward their car, then veered off. "There was definitely something there," Capt. Martin Vigil, state police district commander, said this morning, referring to the second sighting. "The ground was still smoldering 20 hours after the sighting." And, as in Socorro, there were footprints which resembled the paw tracks of a mountain lion around the charred area. The latest report came Sunday afternoon from Orlando Gallegos, 35, Santa Fe. He told of his sighting in this way: Gallegos and his family arrived about 12:30 a.m. Sunday at the home of his father, Frank, just north of La Madera on the Petaca Road. The younger Gallegos said he went outside to chase away some horses. It was then that he saw the thing sitting on the ground in a gravel area.

He said he was about 200 feet away and was afraid to approach closer. When he first sighted it, there was a ring of blue flame erupting from numerous jets around the bottom of the craft, he said. There was no noise and as he watched, the flames were turned off. He said he didn't see anyone or anything moving around the craft. Gallegos returned to the house and told his family, but no one ventured outside. His wife described him as being "badly shaken." He returned twice more to look at the object, he said. He described it as being a bright metal without windows, as long as a telephone pole and about 14 feet in circumference. He said it was egg-shaped and resembled a large butane tank. Sunday morning the object was gone, but the ground was still smoldering. Gallegos said he stayed away from the place, and Sunday afternoon as he was returning to Santa Fe he stopped a Espanola Police Officer Nick Naranjo and told him about what he saw. "I just had to tell somebody," Gallegos said. Espanola Police notified State Police Officer Marvin Romero, who with Officer David Kingsbury, questioned Gallegos at length. They notified Capt. Vigil. He radioed State Police Officer Albert Vega at Ojo Caliente and Vega went to the scene and verified the "evidence." Capt. Vigil, accompanied by Officer Kingsbury, went to the scene last night. "The ground was still smoldering and was charred over a large area," he said

Vigil said what looked like paw prints were found at the scene and depressions, similar to those found at Socorro, also were found. It was guessed the depressions were made by landing gear. Vigil said he telephoned a major at Kirtland AFB and described the scene and was told it sounded exactly like the evidence found at Socorro. The Major said he would send a team of investigators today. The team from Washington sent to examine the Socorro site is also expected at La Madera. Vigil offered no explanation of the object reportedly seen except to say that at this point there is no reason to doubt Gallegos' story "Something was there."

Flying Bathtub Seen By Motorist

"If you told me you saw it, I wouldn't believe it, but I saw it." George Mitroplis of Albuquerque was emphatic about both seeing and hearing an unidentified flying object. "It was up ahead of me and to the right when I saw it come over the crest and then drop back behind the mountain," Mitroplis said. He said he was driving north on U.S. 85 one mile south of the New Mexico 180 junction about 10:30 p.m. Sunday when he sighted the craft. "I wasn't just seeing things, because I stopped the car and after it went behind the mountain I could hear the noise like muffled jets. This thing was glowing like it was luminous. There were no lights," said Mitroplis. There was a glow underneath the craft like exhaust flames. He described the object as appearing as an upside down bathtub. The Albuquerque man said he caught up with another car that had been ahead of him. "I caught up with them and stopped them because I wanted to know if they had seen it too. There were two young men but they denied seeing anything...but they were acting strangely." He said he first reported his sighting to the Truth of Consequences police but they just got a laugh out of it. He said he went to Socorro where he first learned someone else had seen something like it, and he felt a lot better.

UFO Report Near Hays

A Fort Hays State College couple, Mr. and Mrs. Alvin Casey, reported sighting an unidentified flying object here at 10 p.m. Sunday.

Casey told police he and his wife were traveling toward Hays on US 183 about seven miles south of here when they noticed a glowing object in the sky west of them.

Casey said the object was about as large as the sun appears, and was brighter than a star. The yellowish-red object was flying parallel to the highway at nearly the same speed as his car, Casey said, and seemed to be at an altitude of about 1,000 feet.

Unidentified Flying Object Over Valley

King City-A California highway patrol officer, whose name was not disclosed, last night reported an unidentified flying object-better known as a flying saucer.

The object, which he said made no noise but showed a "bright red after-flame," passed over the officer's Pine Canyon home about 9 p.m. The officer said the object was flying "about 20,000 feet up and traveling at a terrific speed.

He reported the sighting to the King City police who in turn reported it to the county communications center in Salinas. A sheriff's patrol unit heard the radio report and said it had also spotted the object. According to available reports, the craft did not land.

Two More Sightings Of UFO Are Reported

Third and fourth sightings of the unidentified flying object seen Sunday in the North Lawrence and Wooster-Smithville areas were reported to the Evening Independent today.

A. E. Candusso of the Flying Saucer Investigation Committee of Akron said the UFO was sighted Sunday night by Steve Toth, who operates a service station in Burbank near Medina. Mrs. Marvin (Berdine) Veigel of 12406 Wooster St. NW (Cherry Rd NW ext.) a sixth grade

teacher at Harvey school, said a similar object was seen by her, her husband and 14 year old son Darryl Sunday at about 9:30 p.m. They were on their way home in their auto coming from Dalton on Route 30.

Toth said the UFO was a ball of light deep red-orange in color. It was hovering due east 25 degrees. After hovering for 5 minutes, the object started drifting south and rose to 45 degrees elevation, then proceeded across the sky changing to a pale white glow of light. The sighting began at 9:25 p.m. and lasted 15 to 20 minutes.

Mrs. Veigel said they saw two bright lights, as on a regular airplane at night. Her son, looking out the back window of the car, saw the object start to move away and said he thought there was a dim light in the back. The lights in front weren't lined up side by side she said so she knew it couldn't be an airplane with landing lights.

"I saw the Evening Independent story on the North Lawrence sighting and the one near Smithville and I realized it must be the same thing that I saw. We didn't see any shape, nor did we see any color. At first we decided it must have been a helicopter, but again we saw no flashing lights as on an ordinary aircraft, and we couldn't identify the object." Veigel is foreman at the roll shop at Republic Steel Corp.

Mrs. Frank Brakefield of North Lawrence told Henry Hodgson, Chief of the North Lawrence Volunteer Fire Department, that she saw a UFO make a landing in a field just west of North Lawrence Sunday about 9:30 p.m. With her were her two daughters and a neighbor girl. She described the object as a large round ball flashing on and off from orange to crystal white as it passed overhead.

Shortly after Mrs. Brakefield's sighting, a man who resides on Route 5 between Wooster and Smithville told the Wooster barracks of the State Highway Patrol that he has seen a similar UFO. His report said the object was seen north of the Wooster Airport and that it moved up and down. It remained over the area from 45 minutes to an hour. Again the object was described as a round ball changing from orange to crystal white and with two lights on it.

The FAA at Akron-Canton Airport doesn't investigate such UFO sightings. This is the job of Candusso for the Flying Saucer Investigating Committee of Akron, a private group of citizens.

UFO Spotted By Industry Woman

An unidentified flying object was reported spotted in the sky west of industry by an industry woman and her son Wednesday about 11:05p.m.

Mrs. Helen Jones of Fairview Road, a cafeteria employe at Snyder Elementary School told The Times that she and her son, Robert, 19, had seen the flying object for four to five minutes. Attracted by a flickering light in th sky at a great distance, Mrs. Jones said she got a pair of binoculars and focused on the slow-moving object, which appeared to be oval in shape and with lighted windows.

The object was bright orange in color and the windows reflected a pale yellow light. The object appeared to be rotating continually while it moved across the field of view of Mrs. Jones and her son. "It seemed to be spinning around like a top and I could see little windows, two of them. It made no noise. It was such a funny looking thing," said Mrs. JOnes. "It didn't move very fast. It didn't look like it had any wings. I knew it wasn't a plane, thet go over our house all the time," she added.

A check by the Times with Air Force officials at the greater Pittsburgh Airport said that thet did not keep records of satellite (low in the sky with two windows??-Editor) flights across Western Pennsylvania. (Beaver, Pennsylvania, County Times, May 23, 1964)

UFO Spotted By Youth At Stockbridge?

A Stockbridge youth reported to the Citizen Patriot that an unidentified flying object flashed across the sky south of his home Saturday night

Roger Nye, sixteen, a student at Leslie High School, said that he saw the object while looking out a window of his home Saturday about 9:15 p.m. "It was brighter than a star, and moved from east to west across the sky. It split apart then disappeared," he said. His mother, Mrs. Jewel B. Nye, said she saw a similar object in the sky Thrusday. (Jackson, Michigan, Citizen Patriot, May 24, 1964)

So ends the "flap" of the spring of 1964. It must be noted that in this report we have had to omit scores of smaller and more obscure reports, so the size of this series of sightings can readily be seen.

THE LINK

For some years there has been a feeling among certain UFOlogists that the UFO phenonema is linked with certain natural holocoets which strike at the world of man. There have been dark hints of UFO connections with ariline crashes, explosions, volcanic eruptions, etc. On most of these allegations, unfortunately, few attempts have been made to provide proof one way or the other. Because of this fact, most serious American researchers have nesitated to "stick their necks out" (or their noses in) on this subject.

However, in the Spring of 1962 a group of Japan's leading UFOlogists of the Cosmic Brotherhood Association (CBA) stuck their necks out and came up with some important facts which all UFOlogists should be grateful for.

This is not the first time CBA or its Chief Counselor Yuseke J. Matsumura have tackled something that the rest of serious UFOlogy has been afraid to involve itself with. In June of 1958 and several times thereafter, CBA attempted to contact who-or whatever flies the UFOs. Because of their impression, CBA has frequently been labeled a contactee group, and many of its findings have been immediately dismissed by their Western counterparts as ouright hexes. I think, however, that this is due to the old problem of the language barrier; American UFOlogists understand no JAPANĒĒ, WHILE THE CBA people write in somewhat faulty, child-like English.

So when CBA published its first issue of BROTHERS in 1962, it was for the most part ignored in the Western World as being nothing worthy of study. It was written in a style which was premeted with such phrases as "---who is a real contactman---" or "many statements and words spoken" etc. This, to the bigtoed UFOlogists, was enough to drop the whole matter. BROTHERS was therefore ignored.

But inside the shell of somewhat quaint language lies one of the most important links between UFOs and natural catastrophic events on record.

It concerns the relationship between Earthquakes, UFOs, and other unusual aerial phenomena. I elected to review the material CBA has presented, because it is my feeling that this demands some attention by North American investigators—attention which it has not received until now.

As early as the year 1816 a relationship between earthquakes and UFO reports has been noted. CBA reports that in this year (1816) a huge moon-shaped object was sighted glowing in the sky at the time of an earthquake in Great Britain. In December of 1869 (the 17th) an extremely brilliant lightning flash coincided with an earthquake in Hartford, England. An excellent report from Nicosia, Cyprus records that on January 20, 1941 following an earthquake two objects, one red, the other probably white (described by CBA only as "bright") were seen heading east following the earthquake. The objects were sighted separately.

On February 11, 1957, 5 flying objects were sighted over the earthquake stricken town of Mansfield, Midlands, England. They were tadpole-shaped. The following day two more objects were seen. In Algeria on September 19, 1854 an object of great brilliance which shone "like the sun" was sighted at midnight. One hour later, at 1 a.m. the area was hit by a severe earthquake.

On October 8, 1957 an earthquake struck in the state of Illinois. Just before the "quake struck a brilliant UFO was seen in the sky. Earlier in that year on January 4, the town of Aleppo, Venezuela witnessed a violent flash in the sky (described by CBA as "like the sun"), accompanied by an explosive sound. Long red UFOs then flashed over the town.

These facts present us with a myriad of questions and theories. CBA seems to feel there are two points which must be studied relative to the apparent earthquake-UFO connection:

- (1) Do they (UFOs) have an interest in the earthquake, a fluctuation of terrestrial magnetism within the earth's crust?
- (2) Do they (UFOs) cause the earthquakes?

The latter question poses somewhat uncomfortable implications. Nevertheless it seems to me that the presence of the UFOs at the

scene of a disaster might be strictly for observation—and when all is said and done, this could be only a long series of coincidences. However in view of other information given in the CBA article, this seems highly unlikely.

What follows is the CBA record of UFO-earthquake incidents taken from the year 1960. In reading over this listing it occurred to me that if this is the result of a typical year, then anyone who could compile and publish a five or ten year record would be able to prove the UFO-earthquake relationship beyond any reproach. As it is, this record of a single year is enough to convince most.

Frankly a few of these associations I can't see for various reasons. Some are three or more days apart, while others are too divergant in location for them to be considered related. But on the whole, the evidence here indicates a true and very real relationship between UFOs and seismographic disturbances. You will note that a very large portion of the reports occured in Japan. No doubt this is partially due to the fact that a Japanese group compiled the list. Never-the-less Japan is an area with a high number of earthquakes. It is also, oddly enough, an area of great UFO activity and public intrest. Is This a coincidence?? The CBA report would seem to show not!

If we accept the hypothesis that the relationship between the earthquakes and the UFO is one of intrest rather than cause on the part of the "Ufonauts" then we are led to the question of why. Are we being "checked up on" as to how we-as humans-react to a holocaust? If so newsreel films I have seen of panic and confusion, combined with looting and anarchy in the wake of disaster would not create a very favorable impression. But this, of course, is pure speculation and supposition. The only thing we can be fairly sure of is that there is some type of relationship envolved here.

What about the other supposed UFO relationships? If the earthquake phenomena is related to the UFOs in some way, think about such things as airline disasters, unusual aerial pheonomena (such as ball lightning) etc? The CBA article does not go into this in great detail, but does make a few tantalizing inferences which only makes me more curios about these various possible relationships between the "natural pheomena and the UFO."

For instance on November 26, 1930 at about 1 a.m. a number of Tokyo residents witnessed a "strange light" in the sky. At 3:50 a.m. Yokosuka City residents noted a display of strange lightning which "covered the sky". The display was abruptly cut off at the appearance of the "Ufonauts" taking photos the lightning being the flash bulbs of

a city which they knew was soon to be "changed" by the imminant'quake--- pure speculation on my part, of course!)

CBA has set the pace. Let us examine the statistics on these alleged (alleged??) relationships, and see what we can come up with. The UFOlogists or the Orient continue their work. It is high time we begin ours!!

THE ORVILLE PHOTO HOAX

It was back in April of 1963 while I was broadcasting over KYW's powerful station, that I was handed a color photograph of what appeared to be a flying saucer.

The program, "Ufology Rountable," was started on October 4, 1962 and was to last for just thirty minutes. Little did Harv Morgan, the host, realize when he asked Robert Grove, the physicist, and myself near the close of that first broadcast if we would both be willing

to return for one more night that here was a subject that was to snowball into KYW's most popular segment of "PM" and later "Contact."

The station receives letters and phone calls from people in many of our states and Canada. Recently a party in London England wrote and stated he had heard us on the "skip".

Naturally, we did not think it unusual when an envelope containing a typed message and a post card size color shot arrived at the radio station that read:

Dear Sirs:

The enclosed picture may be of interest to you. It was given to me by a friend that insists on remaining anonymous. That is all I know or am allowed to say. Please comment on it on your show and give your opinion of it. What is it? Where did it come from? I would appreciate your co-operation.

Thank You.

No signature appeared. Only the postmark, "Orville, Ohio" gave any clue as to its origin.

"What do you make of this photo, Earl,?" were the words Harv Morgan asked me while on microphone as he handed me the color print of what appeared to be a flying saucer hovering over a corn field. Having studied photography for many years I quickly evaluated the print, giving my reasons for believing it to be a genuine photo of a saucer taken by an amateur with inexpensive equipment and no light shade on the lens.

If it was not a genuine photo, it no doubt was photographed by one person throwing a small model saucer into the air from a depression or hole in the ground while another person clicked the shutter at the very second the object reached its maximum height.

Over a period of weeks we asked on the air that the person or persons responsible for the photo contact us. If they wished to remain anonymous so far as the general public was concerned they had our solemn promise we most certainly would not reveal their identity. All we wished to know from them was whether it was a genuine picture, and any data they could furnish us pertinent to the occasion. Much time elapsed and no word was forthcoming. On Thursday, October 24, 1963 on page one, THE COURIER-CRESCENT of Orville ran a three column reproduction of the original photo along with a column story---but still no one spoke to break the silence.

NICAP and the Cleveland UFOlogy Project became interested in the picture. NICAP's top photographic authority in New York stated he believed it was a fake.

Mr. Gary Davis of Medina, Ohio along with members of FSIC of Akron began intensive investigative work and finally telephoned me informing me that two young men in Orville admitted taking and mailing the picture.

Was the photo genuine or were they perpetrating a hoax? The stories told did not always compare in all details. A couple other shots had been made, they admitted. One negative had been lost and one was taken from them. The one chap said that while driving to work, a man in a car stopped him, flashed a badge and demanded the film be handed to him.

To me all this sounded like a very imaginative mind working overtime. Was this a hoax that now was boomeranging out to control?

Was this the reason the young men insisted that their parents not be interrogated? The boys and the parents admitted that phoney shots of saucers had been attempted in the past. The boys, however, claimed that this picture was genuine, but the parents did not believe it.

The services of a reputable detective agency had been called upon. The original negative was submitted for microscopic examination. When the negative was enlarged one thousand times, over one hundred small scratch marks made by a right-handed person were detected below the saucer-like object. Also the letters "USA", "UO", "AF" appeared scratched in the sky area. The scratches below the "saucer" were apparently made in an attempt to eradicate the tasse! on the corn stalk almost directly below the saucer.

The agriculture bureau was asked about the height of corn in the Orville area at the time the picture was reported to have been made. This information did check out. So did the Highlights on every ear and blade of corn correspond to that of the saucer.

On examination of the cornfield FSIC found it was level ground but due to the height of the corn, a person could easily have hidden behind it in the distance and not been seen when the small saucer was thrown into to the air.

The detective agency's photographic expert claims that a lens of 67mm. minimum to 8 Omm. maximum was used to create the particular depth of field recorded and that the object itself was actually only 18 inches in diameter.

The parents and the boys now admit that a model 18 inch in size was made some time ago by the boys. At one time they tried to take a picture of it by suspending it on a thread fastened to two trees.

The moral of this story is: you may think you can fool some of the people some of the time but don't fool yourself by trying to deceive UFOlogists who approach the subject scientifically and objectively.

ANTI GRAVITY CRAFT *

NATURE'S ANTI GRAVITY "DEVICES"

It is a well established principle that man does not and cannot create something out of nothing: he can only transform things which already exist. In fact, his so-called 'inventions' are really just discoveries, for, these devices, contraptions or whatever you want to call them were previously in Nature as such or at least in principle.

For instance, thousands of years ago some scientifically minded human realized what everybody simply knew: it's the wind, not goblins, that blows twigs, leaves and other such items, around and up. Furthermore, he took special notice of the well known fact that, everything else being equal, he invented the sailboat. This fabrication was easy for the simple reason that the 'distance' between the input and the output is very short and the connection between the two is crystal clear.

Not so with respect to the electrical motor: Homo Sapiens had been on earth for at least 700,000 years when he finally discovered electricity, and it took him 2,400 more years to harness it. Yet, this force had manifested its presence frequently in the clouds during thunderstorms, probably also in his coiffure and at his fingertips once in a while. 'Watt' took him so long to find it and put it to work? Here, the cause-effect link is long, tortous and hebulous.

Now, the socalled 'force' of gravity is far more universal both in time and in place than any other force what-so-ever, and yet, no one really knows exactly what it is and how it works. Once more I suggest that here also as with other man-made devices the reasearcher who looks into Nature for a "device" which somehow masters gravity DIRECTLY by creating something like antigravitons, will be the discoverer of the greatest scientific breakthrough of the century. Sooner or later he will come upon at least two such "contribances," and, while studying them carefully, he will find that Nature has generously produced several "models!" Strangely enough, this ingenious man will not be one who is involved in the fiels of mechanics. He

will be a chemist, more specifically, a biochemist. Indeed, it has been my contention for quite sometime that the chloroplasts, especially those of the genus *Heliotropium*, sometimes gyrate in a way which appears to cancel gravity itself and/or "create" its exact opposite: antigravity.

In the course of his investigation this biochemist will probably find that it's adenosine triphosphate which gives the chloroplasts their weird power to defy gravity and rise. As he peruses the literature on this topic, he will take note of the fact that recently it was demonstrated that this compound is the sine qua non for the rise of the sap in plants. Up to the time this great finding was made scientists couldn't account satisfactorily for the RISE of sap up tall trees. However, exactly HOW ATP does it, is not yet known. I suggest, as I shall explain later, that the crystals in it transform the thermal energy they receive, or produce, into coherent, uniform oscillations which cancel the gravitational waves under certain particles in the sap. At any rate, ATP is now known to play a fundamental role in most biological processes which either produce, or require energy. For example, when an animal oxidizes glucose, ATP is produced and later, when this compound is hydrolysed, energy is one of the products whereby the muscles are able to contract.

There is also NEGATIVE geotropism by which plants, including even some of the achlorophyllous ones defy gravity, causing at least some of their stems to grow vertically upwards. Here too, perhaps, we have a "mechanism" which generates antigravitons.

THE BRAIN PRODUCES ANTIGRAVITONS

Furthermore, some sentient organisms too, I believe, are able to chance the polarity of certain gravitational fields. Study carefully and openmindedly, if you can, the neoscientific experiments reported for instance by Dr. Andrew Puharich, by the late Dr. Nandor Fodor and by many other conservative researchers in the field of paranormal phenomena. You will probably find that you'll have to do like Galileo and break the shackles of traditionalism: admit that poltergeistism, apportism, teleportation, telekinesis and a few other ultranormal phenomena in that category are genuine, physical events. In a paper

which I entitled Psyhydro-synthesis, I gave evidence, I believe, that this telenergism is another exemplification of Einstein's theories: a gravitational field comprises waves which basically are a kind of electromagnetic wave; that mass can be transformed into energy and vice versa.

Now, gravity is inherent to and concomitant with mass. Hence, it seems logical to conclude that, since certain agents are able to convert matter into pure energy, these same agents should be able to cause this 'packet' of energy to travel with the speed of light, not only through empty space, as the "regular" electromagnetic waves do, but even through the densest substances just as the gravitational fields are known to do. Then, that agent should be able to stop this "packet" of energy and metamorphose it into its original state: matter. Numerous cases, considered with their circumstances, in my judgment, indicate that teleporters, apporteurs and others with specific ESP talents in that category are able to do that and/or cause objects to move visibly from place to place

CRYSTALS EXCITED IN VACUO YIELD ANTIGRAVITONS

Are there laboratory experiments which show that gravity can be "lassoed, tamed and harnessed"? Indeed, there are!! For example, according to Leonard Cramp, a British engineer, there is a Viennese physicist: Felix Ehrenhaft who weirdly lifted particles of graphite. He put these specks in a glass flask in which he then created a VACUUM. As soon as he focused light on the glass he saw some of the particles rise into the empty space and describe ellipses, circles and spirals. They came down as soon as the light was cut off completely or diminished to a given extent. Photographs prove the objectivity of the event, plus the fact that each particle rotated on its main axis while revolving in its orbit. Probably, the kind of glass used and many other factors are essential to the success.

In a previous paper, which I'll name later, I pointed out that in various manifestations of the elusive antigravitation there are a few conditions common to all: crystals (or crystalline state), extrinsic-rhythmic energization of these and vacuity.

Here, I must stress two facts: 1) the UFO's are physically real spaceships or probes from other worlds; 2) there are Superhumans on the

Moon and they definitely have interplanetary spacecraft. I most certainly do not expect you to take my word for it. On the other hand, I do expect that, before you deny these statements, you will study carefully at least a score of reliable books on this topic, plus a few hundred articles. If you don't do at least that much, you will not be one iota better than the pundits of the Middle Ages who refused to investigate thoroughly. In order to believe in the existence of Intelligences on the Moon you need not blister your meninges. Just clear your mind of prejudice and ponder over the very words of the seivity on the lunar surface. Begin with Schroter and run through the entire gamut including Greenacre and dozens of other astronomers, who, since the fall of 1963, have observed on and near the lunar 'crust' scores of gigantic spaceships hovering or moving in geometric formations/ Soon the Moon, a paper which I compiled this summer is a mere summary of the pertinent cases. Lest you misunderstand, let me state clearly that I don't pretend that I discovered something. In only uncovered what the astronomers, willy-nilly, had already discovered. The wonder is not that I did it, but that it wasn't done a long time ago...long before I was born.

SELENITES HARNESSSED ANTIGRAVITY YEARS AGO

How did they do it? To begin with, is that what they are using for "fuel"? I believe so, as I tried to show in an earlier paper: The UFO and Its Fuel. Their world being very different from ours and in many fundamental ways, Nature's antigravitational "mechanisms" may be as obvious there as the wind here, and that led to the invention of our sailboat. First, the Moon is immersed in an infinite vacuum. And, by the way, in case you are adamantly sure that life on the lunar surface is impossible read Soon the Moon, and you will see that many radiophysicists have discovered a luxuriant flora there, although they don't dare say so explicitly. As for the Intelligences, the selenographers found them 200 years ago. Incidentally, what the experts find in the Ranger-7-pics confirms my theory and its subdivisions; an extremely intelligent lunar race lives on the floor of a deep, thick, woolly, etc...forest, which, among other things, protects them as our atmosphere protects us.

However, our atmosphere does more than protect us: It kindles our "fuel" (food), "sparks" our engines, etc., etc. I speculate

that the so-called lunar 'crust,' being, in the very words of various teams of photometrists, radiophysicists, and other such specialists, "a fibrous material, finely divided, randomly ramificating, etc., etc.," affects solar radiations and/or perhaps cosmic particles in such a way as to cause some of them to "mysteriously" levitate certain loose objects from the floor of the forest. The surface gravitational field being only $g/6$ and there being no atmospheric pressure, no motion of air, an antigravitational field could easily be detected and then harnessed.

In the field of speculation, both the possibilities and even the probabilities are numerous. And so, it occurs to me that very likely the Selenites came to the knowledge and then the understanding of the baffling 'force' of gravity through, not one, but several avenues. Here on Planet-3 it took Homo Sapiens a million years to finally harness electricity. That's perhaps due, not so much to his inherent stupidity, but to the fact that on our world there are so many factors that hide the link between this mysterious energy and its effects.

On the Moon, however, since there is neither air nor vapor, electrical discharges must have some effects which are more outstanding and visible: the connection between cause and effect may be clearer. Piezoelectricity, for instance, discharging between two poles immersed in a vacuum would find no air nor moisture to resist and distort. Hence, in this gap it could produce a rather effective electromagnetic field. From that one can easily visualize that once in a while under very specific circumstances created by the position of the sun, the presence of certain crystals, etc. one of those fields would be of the proper intensity, frequency and direction to cancel out or even reverse the gravitational field between a loose object and the Moon, thus causing it to rise.

If you think that this hypothesis is too far fetched, recall that Einstein figured, among other things, that the gravitational field is just another species of electromagnetic field. As a matter of fact, it has been demonstrated many times since that a beam of light from a star is really affected by the gravitational field of the sun as it passes "near" it. As a result its spectral lines shift toward the lower frequencies, i.e. the red end of the spectrum, thus losing energy. But, our specific question concerns the opposite: do electromagnetic

waves affect gravity? As of last year, the answer seems to be "yes," for, Dr. Erwin J. Saxl after 10 years of experimentation, finally found that de facto gravity and electricity really react on each other.

And there is yet another channel through which the Selenites probably came to the real understanding and then mastering of this hidden 'force'. The theory is based mainly on a hypothesis propounded years ago by Nikola Tesla, a prodigious inventor. He told some of his fellow-scientists that he had plans for making an aircraft which would use sound as "fuel". Fearing that someone might steal his ideas, here as with all his many inventions, he never wrote down this fabulous formula. It has been for quite sometime my fond belief and hope that our scientists or engineers will rediscover this amazing principle. It will be those, I think, who are experts in high frequencies. That was Tesla's forte. Now, our scientists are constantly increasing the frequencies of ultrasonics. Dr. Donald J. Huges in his book: The Neutron Story, seems to say that if the energy imparted to an atom is successively increased, there will come a time when the atom itself, having reached the highest frequency possible, will no longer increase its acoustical vibrations. The added energy which it will continue to receive will henceforth be absorbed directly, not by the atom as a whole, but by some of the subatomic particles, namely the electrons. They, as a result, will emit infrared rays and perhaps visible light.

The re-discovery of sound as "fuel" for propulsion, etc. will probably be made accidentally as our astronauts walk around in that large vacuum chamber now being built near Houston, Texas. However, as I see it, all the basic environmental factors prevailing on the lunar surface will have to be present. One, which I'm afraid, will be ignored in this simulator is the fact that the so-called lunar 'crust' is actually a thriving vegetation which covers every square inch of the real lunar crust far below. Unless all these above-mentioned teams of specialists are wrong, the trunks, stems, branches, etc. of this exotic flora are completely covered by variously branching fibers, which, as individuals are invisible just as the droplets of water in our fogs, but which affect light in a way not yet duplicated although so far hundreds of models have been tested.

So, probably the solar energy which will strike the floor of this lunar chamber will have to pass through material structured according to those findings before it causes the crystals below to reverse gravity. I am almost sure that the "experts" will laugh at me scornfully when they hear about these, my very personal theories, and so I do not expect them to spend one red penny out of their multibillion-dollar program in order to comply with my "specifications."

However, I feel sure that someone, somewhere, here or abroad, will be open-minded enough to try to understand what I am saying and then will attempt some of the experiments I suggest. I visualize that perhaps this scientific breakthrough will be accomplished, not in a multi-million-dollar laboratory, but in a poor man's collar on a dingy workbench. And now, here is a summary of what to my mind, he should do in order to re-detect the principle and the "fuel" by which the above-mentioned trillion-dollar space craft, already on the Moon, are propelled.

There are good reasons to believe that the lunar crust contains a mixture of many kinds of crystals and other "building blocks" which are very much like what we find here on our world. However, there must be differences. For example, since the Moon is 'immersed' in an infinite vacuum, the inorganic substances on its surface must be absolutely dry. Hence, I suggest that the researcher obtain several kinds of soil, natural rock dusts, powders and the like so that probably at least one of them will suit the purpose. Then he should sift them in order to remove roots, leaves and the other such pieces of organic matter. In the meantime or afterwards he should mix them together randomly. Finally, the mixture should be placed in a bell jar within which a vacuum should be created while solar heat and light beam on the pile.

Maybe this simple procedure alone will be sufficient to cause some of these particles to rise weirdly. If that happens, the next step would be to find out what kind of particles rise: how are they structured? What is their chemical composition, etc.

However, the investigator will probably not be that successful so soon. In that case he should try to simulate more closely the real environment on the lunar surface. For instance, maybe the source of light, heat and/or other radiations must be in the vacuum itself, and

furthermore, maybe these waves and/or particles must be made to pass through a very finely divided, fibrous material with almost 100% opacity, etc. as on it is on the Moon. There is also the factor of gravity ($g/6$), which perhaps can't be ignored. Everything being equal otherwise, a gravitational field at that low level would obviously permit objects to rise more easily. Also, the Van Der Waals forces would probably be more effective, and this could bring about important structural differences. That in turn could very well give certain crystals the capacity to produce antigravitons out of the electromagnetic energy and/or cosmic particles.

If the above mentioned experiments with light, heat and perhaps radioactive matter fail, I suggest that the would-be discoverer try other sections of the long electromagnetic spectrum, for instance electrical fields. Recall that Dr. Saxl demonstrated experimentally that electricity reacts on gravity.

Now, on 'our' natural satellite here being neither air nor moisture, there is very little or no interference, and so electrical fields must be far more effective than they would be otherwise. From that consideration one can easily visualize how piezoelectricity, which is easily produced by various agents, probably yields weird effects when it discharges unimpeded at a gap between two poles 'immersed' in a complete vacuum. Maybe then it generates antigravitons.

Then there is also the probability that there are a few natural photocells on the Moon and that they are actually the antigravitational devices.

Finally, the would-be inventor should keep in mind the fact that a given gravitational field is very uniform in many aspects. So, if one wants to cancel it or reverse it, he will probably have to use an "interferometer" and/or reverser which is also uniform. The maser and its cousin, the laser, have, among other things, the ability to harmonize at least certain frequencies. Nor, perhaps Nature has planted several such and/or similar "devices" on the lunar surface. Why couldn't there be one for each species of the electromagnetic waves? Why couldn't there be an "infraraysor," an "X-raysor," etc.? These and other such "Contraptions" could very well have been produced by various members of the thriving lunar flora.

man for the Cleveland Ufology Project, heard the report
and said Boras undoubtedly saw a "mother ship which
launches the saucers."

"I think he under-estimated the size. It must have been
much larger. It was inter-planetary, and we don't often
get reports on them."

Neff said he had taped Boras' report and would play
it to the annual dinner meeting of his group at the Danish
Smorgasbord, old Rt. 21 Saturday night.
