


# UFOs IN OUTER SPACE: ASTRONAUTS DON'T LIE!

Even those who scoff at UFOs must be impressed by the fact that several of our astronauts have claimed to have seen UFOs while orbiting in space. Here are some of the most famous cases involving astronauts and their UFO sightings.

■ First, ordinary people began to report sighting strange objects in the earth's skies, some of them competent, trained observers like airline pilots. Next came the astronauts, a number of whom admitted they saw strange things in the heavens they never saw before. Credible people seeing incredible things. Finally, from the most credible group of all — highly skilled and trained astronauts — came the most incredible UFO reports of all.

A number of highly respected astronomers, who were completely skeptical about the existence of UFOs, blazed the trail for astronauts. The late H.P. Wilkins, world-renowned astronomer and head of the Lunar Division of the British Astronomical Association, was a confirmed disbeliever in UFOs. However, his views took a sudden turn one day. On a flight to Atlanta he spotted a shiny disc-shaped object maneuver near his plane. Wilkins suddenly became a believer. He stated bluntly, "In shape and performance it was unlike anything made by man."

The famed Clyde Tombaugh, discoverer of Pluto, one day watched with amazement from the famed Lowell Observatory in Arizona as a strange glowing craft flew over his desert home. His family also witnessed the sighting.

Said Tombaugh, "In all my years observing the skies, I had never seen anything remotely like it. It was controlled. I am sure. I felt that we were watching a space ship."


When the space program finally got off the launch pad, and astronauts started soaring through

space, reports came flooding in that they were sighting UFOs up there. How true were these reports? Certainly the U.S. government has never publicly admitted that astronauts in outer space were ever visited by UFOs. Are the accounts, then, fabricated? Did wishful, sensation-seeking and money-mongering UFO writers create these stories out of thin air, which they then fed to a gullible public?

This is exactly the case, say some writers, who deny that a single UFO has been sighted by any astronaut. We recently published an article in which an aerospace expert took this stand. We are to be commended for taking an objective look at the facts from the other side of the ledger. Unfortunately, a few UFO journals publish anything and everything that looks like a good story. If there is any area where fact should be separated from fiction, it is in UFO investigations.

Charges and countercharges of falsifying of seemingly genuine photographs have even been launched. Many of these photos, which are genuine, have been doctored and even distorted to the point of forgery. Bogus evidence and misinterpreted data have led to stories that spacemen of earth have, in fact, encountered spacemen from beyond this planet. But all this proves is that it's the people who buy and read such stories that have been taken for a ride.

We realize that many overanxious writers sometimes have gone overboard in reporting strange




objects in the skies; at times even reliable reports have erred on the side of mystery. I know, because I, too, have been taken in by sloppy reporting. Many UFO writers cite the purported UFO that X-15 pilot Major Robert White supposedly saw. They invariably reiterate his famous quote: *There are things out there, There absolutely are.*

I was taken in because I naturally assumed — at least, until I checked — that he had actually seen a UFO. Tracing the quote back to its original source — a top-flight national magazine — I discovered that what White was describing did not appear to be as impressive as some writers claimed.

One object, said White, "looked like a piece of paper," and he compared it to the size of his hand. It was very close to his plane; he estimates no more than 30 or 40 feet away. He watched it "for a full five seconds" before it "moved away."

What could it have been? A spaceship from another world? White admits that he had no idea, but the objects did appear to him to be "small, flaky objects." The X-15 pilot thought they might be the residue from the fuel that his plane





engine was burning. Another explanation is that they were flecks of ice.

Perhaps the most oft-repeated, misreported UFO incident is that of John Glenn's famous "fireflies" being wrongly interpreted as UFOs by a string of writers.

In February 1962, John Glenn, America's first astronaut to orbit

the planet Earth, reported seeing a flurry of glowing objects outside his space capsule. Many reporters have turned these "glowing objects" into spaceships from other worlds. They write as if these objects were legitimate unidentified flying objects and imply in their statements that they are indeed alien spacecraft. Clearly, an

objective study, even a cursory one, of these strange glowing objects indicates that they are merely particles which are the natural flaking, off the cone of the capsule, swirling around the craft. Astronauts on subsequent flights saw the same "fireflies," as the particles have sometimes been called.



However, not all unknowns are as easily identified, nor were all as badly misidentified. The **Condon Report**, a government-sponsored study examining the UFO phenomenon to see if UFOs actually do exist (and which has been severely criticized by such knowledgeable experts as Dr. J. Allen Hynek, as merely an attempt to whitewash

legitimate UFO sightings out of the skies), also tackled the astronauts-UFO problem. and believe it or not, even this skeptical, sometimes sloppily done **Condon Report** claimed that for at least three Gemini sightings they could find no reasonable explanation. So they labeled the sightings "unexplainable."

However, one overenthusiastic skeptic even takes the **Condon Report** to task for being too lenient or too careless in its conclusions. This critic belittles even the competency of Dr. Franklin Roach, claiming that he was not familiar with the basics of orbital flight trajectories and clearly unqualified to evaluate this difficult case.


Instead of believing the **Condon Report**, which most UFO writers criticize as trying to cover up the sightings, this aerospace writer claims the report was "too superficial" in its evaluation and conclusions. It missed possible legitimate explanations.

Stanton Friedman, nuclear physicist and long-time space scientist, now devoting full time to the problem of UFOs, does not agree with this assessment of Dr. Roach's work. Friedman, as a space expert, examined Roach's analysis in the **Condon Report** and calls it "one of the better chapters." And he even points out that the **Condon Report** summary failed to give due attention to that section in its final analysis of UFO sightings.

The critics of astronaut sightings do bring up many interesting aspects of the Gemini sightings that could be considered as possible explanations of the "unexplainables." Let us examine some aspects and try to analyze them objectively, to see if they tear apart the astronaut reports of UFOs.

One of the first of many "bogey" reports was from Gemini 4 (June 3, 1965), a sighting made by astronauts James McDevitt and Ed White, who described seeing a cylindrical object near their spacecraft. A check with the computer essentially explained and discounted all known objects in the vicinity where the cylinder might have been. All possible knowns were eliminated as potential answers to this "unknown."

One critic argues that it really was Gemini's own booster that the astronauts were seeing. Only they



did not recognize it. But shouldn't McDevitt have been able to recognize his own space booster, since the sighted object was so close to him? Not so, the critics insist, since McDevitt's eyes were watering at the time, and he had already misidentified the booster just a few hours earlier.

Apparently the astronaut did not learn from his previous experience. Or it might be pointed out that it is strange that NASA officials did not think of this obvious possibility. In fact, interestingly, McDevitt apparently would himself disagree with this oversimplified assessment. For in a recently released statement, an interview with McDevitt on Columbia records, this Gemini 4 astronaut who had given a detailed account of the sighting, claims he was "never able to identify it, and don't think anyone ever will." (Columbia Records: **UFOs: The Credibility Factor**).

Intriguingly, McDevitt did sight another UFO once more in the flight (38th orbit) — an object which he described as a "bright star, moving fast." It was a puzzler, for it was higher than his own space capsule and supposedly moving in polar orbit. Interestingly, the caustic critic of McDevitt's earlier sighting passes over this this reported sighting without comment.

This self-appointed critic of astronaut sightings next takes to task Soviet reports of UFO sightings made by their own astronauts. He speaks of one account, that allegedly came from Moscow, that tells of such a sighting of UFOs following Soviet spacecraft, but he discounts the entire business because "such secrecy surrounds the entire Soviet space effort, that stories cannot be checked."

Ah, but that is not quite true. They can be checked — they have been checked. At least in some instances. For this careless writer



forgets that these accounts, in the first place, leaked out precisely because some of the space missions were monitored by tracking stations outside the Soviet Union.

One such remarkable Soviet UFO sighting took place on Feb. 24, 1961. Tracking stations at Meudon, Urin, Uppsala and Boehum all were following the Soviet radio communications from Soviet cosmonauts. Things seemed to be going A-okay. The cosmonauts had reported all was well, when suddenly one of them began shouting: "Look out the peephole. Look out the peephole! I have it..."

A second voice interjected: "Here! Here is something! There is something! It's difficult..."

Then followed a slight pause of several seconds, and next the voice continued, "If we do not get out, the world will never hear about it. It is difficult..."

At that point, Soviet transmission from ground control broke in

to announce it was eight p.m. Moscow time. No further word from the Lunik spacecraft was ever forthcoming. What happened we will probably never know, because of the Soviet government's unwillingness (at least at this stage) to discuss space disasters, if indeed there was one here. Furthermore, if there was no disaster, given the Soviet government's penchant for secrecy, that also has never been verified. But though unverified, there is no question that a strange event took place, for several tracking stations outside the Soviet Union picked up the communications, as was widely reported in the media at the time.

Similarly, an American UFO sighting made by one of our astronauts broke into the news, because independent ground witnesses saw the UFO along with the astronaut!

On the very first phase of our space program, Project Mercury, through which the U.S. attempted to get astronauts into space and

bring them safely back to earth, reports of strange objects on the fringes of outer space were received.

U.S. astronaut Gordon Cooper, flying the Mercury capsule Faith 7, was among the first to see a UFO.

On May 16, 1963, while Cooper was passing over Australia, he radioed that he saw a "greenish object" with a red tail that was approaching his capsule. Cooper described the glowing object as being of "good size." He said, "It was higher than I was. It wasn't even in the vicinity of the horizon..." **(Condon Report)**

This indicated that the unknown object was not a star or other Earth object. The important thing to remember is that the incident was seen by all those present at the Muecha Tracking Station near Perth, Australia. And this included civilian observers as well as newsmen. In fact, the entire incident was reported to the world at the time by NBC News.

So something was seen out there — not fabricated by a UFO writer.

After Cooper was brought back safely to Earth, he was questioned by anxious newsmen interested in discussing the incident. But before he could be interrogated, the Public Affairs Officer, John J. Patterson, at the Manned Spacecraft Center, announced to anxious reporters, "Major Cooper has informed us that he prefers not to answer your questions."

The usually cooperative space officials at NASA refused to discuss the incident, and this was widely reported in the press at the time.

If this doesn't sound like cover-up and even censorship, what would these critics of astronaut sightings call it? The refusal to discuss what should rightly be public knowledge was a disturbing turn of events that naturally led many to conclude that NASA was trying to hide the truth about UFOs.

That interpretation has been the one held by many respected UFO organizations like APRO and NICAP down to the present time.

Interestingly, the chief critic of astronaut sightings of UFOs, now writing in many national journals today, is himself a United States Air Force officer on assignment at the Johnson Space Center of NASA. Is that assignment specifically to

counter the leaks in the curtain of secrecy that our government and space agency have thrown around the entire UFO phenomenon?

It is also interesting that this critic, who claims astronauts never saw UFOs in space, spends very little time with the many alleged Apollo sightings. But this author, going through the taped conversations of the astronauts with mission control that described "bogeys" (astronauts' term for UFO), found so many strange UFO sightings made by our Apollo astronauts that we included a chapter of these in our book **Our Mysterious Spaceship Moon**, along with another chapter on the Mercury and Gemini sightings. These are actual mission control-astronaut conversations and not secondary source stories.

Let us consider one such Apollo incident — that of Apollo 12. On this mission our erstwhile critic claims that the strange object that astronaut Conrad saw was all a joke. It was simply the lunar module panels which had been jettisoned into space that they were joking about. Despite his contention, he (the critic) does grudgingly admit: "APRO says that Conrad, under pressure from a secret government agency, is lying."

Let's look at the recording — in this case the actual mission control astronaut conversation:

#### MISSION CONTROL:

*As best we can tell, looking at things down here — on those sla panels, we assume that they weren't traveling...like anything more than one or so feet per second when they separated. Your sla panels would probably be only about 300 miles away from you right now.*

#### APOLLO 12:

*That could be true, but gee, whiz, when we turned around, I saw one of those sla panels leaving the area at a high rate of speed, and it looked to me like it was leaving us at a pretty good clip, like it got a lot more than a foot per second or so.*

#### MISSION CONTROL:

*Well, assume it's friendly anyway, okay?*

That doesn't sound like space panels, does it?



By now we have read — as has the UFO reading public — a few articles disclaiming such actual sightings. Strangely enough, except for this Apollo incident, the articles do not attack the many Apollo sightings. Perhaps it is because reporters couldn't find any way of dismissing them. So they skipped this segment — they pass over the Apollo "bogeys" — because they believe they are just that — bogus reports. However, if one reads the conversational record of mission control-astronaut communications, one will see clearly that on just about every moon mission our Apollo astronauts reported seeing strange, unexplainable objects — UFOs.

In the book, **Our Mysterious Spaceship Moon**, there are catalogued sightings, giving the actual log of the mission control-astronaut conversation and letting the reader decide for himself what may have been seen. We are convinced any intelligent reader will conclude that something was seen — that these "bogeys" were clearly not always space debris or mistaken satellites or parts of the space equipment.


Dr. James Harder, an engineering professor from the University of California, who is no stranger to the UFO phenomenon, and is considered to be one of the most careful researchers in the field today, also came up with the same discovery that we made — that several Apollo flights encountered UFOs. In a report carried by the

United Press Wire Service, Dr. Harder said that while reviewing tape recorded conversations between our lunar spacecraft and mission control, he came across clear evidence of UFO sightings. He said that the tape conversations clearly show that Apollo 11 spacecraft was followed halfway to the moon, and a UFO definitely trailed Apollo 12 on three orbits around the moon. Dr. Harder then confronted NASA authorities with these facts, and they shockingly admitted privately to him (at least one official did) that astronauts did indeed see UFOs on the Apollo expeditions, but they had suppressed the UFO incidents for fear of public panic.

Harder also claims that a member of the Apollo 12 space team (whom he declined to identify) admitted to him that while on the mission they had actually spotted UFOs.

This University of California professor points out that the official explanation that the objects were merely part of *space debris* trailing behind the spacecraft was not proven to be correct because the explanation was not supported by the speed observed on NASA earth-based instruments.

This explanation that UFOs were, in reality, merely "space debris" has become the handy handle that NASA and space officials have used to grab hold of and label away UFOs seen by astronauts. The **Condon Report** used the term several times. Gemini 7's astronauts, Frank



Borman and James Lovell, sighted a UFO in addition to apparent space debris. Here is the actual mission control conversation:

**GEMINI 7 ASTRONAUTS:** *Gemini 7 here. Houston, how do you read?*

**MISSION CONTROL:** *Loud and clear. 7 go ahead.*

**GEMINI 7:** *Bogey at 10 o'clock high.*

**MISSION CONTROL:** *This is Houston. Say again.*

**GEMINI 7:** *Said we have bogey (UFO) at 10 o'clock high.*

**MISSION CONTROL:** *Roger. Gemini 7, is that the booster or is that an actual sighting?*

**GEMINI 7:** *We have several, looks like debris up here. Actual sighting.*

The **Condon Report** concluded, "It might be conjectured from the launching of Gemini 7 that the 'bogey' and particles were fragments from the launching of Gemini 7; but this is impossible if they were traveling in a polar orbit, as they appeared to the astronauts to be doing."

The critics, again, simply concluded that the pilot guessed wrongly — the experts were in error, Gemini 7 was in polar orbit. One caustic critic dismisses the judgment of Dr. Roach and the entire Condon committee, insisting that the government is not trying desperately to cover up UFOs. Instead it was UFO writers desperately trying to create "counterfeit astronaut UFO evidence."

Let's be reasonable. Although, admittedly, some chiselers may have doctored a few photos, the **Condon Report** can hardly be described as an attempt on the part of "desperate outsiders" trying to "manufacture information." Nor is this simply to be passed off as a mistaken conclusion on the part of Dr. Roach and the Condon Committee.

Intriguingly, even the **Condon Report**, which has been accused by many expert scientists as a government-sponsored effort to explain away all UFOs, does candidly admit that this sighting and several others were "unexplainable." The explanation that their study is an incompetent analysis limps weakly, especially in light of testimony by NASA officials themselves that, indeed, UFOs were sighted by our astronauts.

Were our astronauts ordered to pass off "bogey" as space debris?

If we are to believe a report made by Robert D. Barry of the 20th Century UFO Bureau, thanks to a group of Japanese investigators, he got hold of classified documents (which he identifies as KMI-8610) that indicate there was a cover-up! For this document, he alleges, orders astronauts that "sighted objects not related to space vehicles (UFOs)... had to be reported as pieces of regular NASA spacecraft." Interesting, if true. For it just about sums up the stand-pat answer of so many astronaut sightings of unexplainable "bogey" — they are merely "space debris."

This same source also insists that a top NASA official stated: "Every manned mission we have sent to the moon has been under surveillance by UFOs."

I can just hear the UFO denier's answer to this one: "Look, another unauthenticated claim by another unnamed NASA official." Convenient but unconvincing."

Yes, we will admit it is just that —

unverified and, thus, unconvincing. But though unauthenticated and possibly another hoax, it should not be dismissed altogether as just a bunch of useless words. Could the NASA official afford to identify himself with that kind of a revelation?

Well-known space scientist, Stanton Friedman, makes this claim: "For those who have never worked on classified programs, I should stress that the classification guides for such programs are normally also classified, so it is, practically speaking, impossible to even determine what fraction of the astronauts' observation of the earth and space is classified. Contrary to some comments I have heard, much NASA data is secret. The penalties for breaking security are extremely rigorous, and it is often necessary to lie as a cover story. I believe I can guarantee, as a result of working under security for 15 years, that the government and its employees can indeed keep secrets — despite the fact that some secrets have been inadvertently revealed (UFOs — **Myth and Myster**, page seven).

Friedman claims he tried to talk to one of the Apollo astronauts who had attended his lecture and bought some of his materials and appeared to be very interested in what he was saying about UFOs. "But," says Friedman, he "would give me no information at all — not even that which turned up in the **Condon Report** — about astronaut sightings."


Nevertheless, cracks in the space agency's curtain of secrecy have developed. For as Robert Barry of the 20th Century Bureau relates, Donald L. Zystra, chief of NASA's Public Information Branch in Washington, D.C., did make this revealing statement: "While NASA has no record of UFO sightings as such, during the Apollo manned-flight missions there were sightings from the spacecraft which our astronauts were unable to explain."

This agrees with what a NASA reporter told Dr. Harder, who confronted him with the tape conversations describing the sightings of UFOs on their moon voyage.

Note that these admissions by a named NASA official do not refer to the **Condon Report** admissions of "unexplainable" UFOs seen by

Gemini or Mercury astronauts. These referred specifically to unexplainable Apollo sightings.

We have already seen that Dr. Harder's findings verify that this is true. Yet this critic mentions nothing about Apollo sightings except a weak denial in the case of Apollo 12, which we have examined and refuted.

There are verifications for at least one Apollo UFO which was seen and reported by astronauts Armstrong, Aldrin and Collins. This sighting took place on the way to the moon, one day out. At first the astronauts thought it might be the Saturn booster rocket. But that was soon discounted by NASA officials. Houston Mission Control told the Apollo 11 astronauts that the booster was over 6000 miles away!

The strange object appeared to take on different appearances at different times in the flight, as the astronauts watched and photographed it. In **Our Mysterius Spaceship Moon**, there is an official NASA transcript of the

astronauts' own testimony from a technical debriefing session in which they talk at length about this strange unknown. Here are some excerpts from the session:

**ALDRIN:**

*The first unusual thing that we saw, I guess, was one day out or something pretty close to the moon. It had a sizable dimension to it, so we put the monocular on it... what we saw appeared to be a cylinder.*

**ARMSTRONG:**

*Or really two rings...two connected rings.*

**COLLINS:**

*No, it really looked like a hollow cylinder to me... It was really weird.*

As the Apollo spacecraft, the Columbiad (the name an intentional echo of Jules Verne science fiction moon trip), approached the moon, the astronauts reported that they heard weird noises through their radio hook-up — sirens, train whistles, buzzsaw sounds and

even fire engines.

UFO-nauts acting as cosmic jokesters and tampering with the space communications systems? For a while UFO researchers like myself were mystified and considered this an intriguing possibility. That is, until Michael Collins, Command Module Pilot on the Apollo 11 flight, published his book **Carrying The Fire** (page 434) — a revelation that cleared up the mystery. As Collins explains:

*"...there is a jangling cacophony of bells, whistles, shrieks and unidentifiable sounds at the end of the tape. We amuse ourselves now by pushing our radio transmitter button and holding the screeching tape recorder next to a microphone. This gets an immediate reaction. 'Apoll 11, Houston. You sure you don't have anybody else in there with you?'"*

A solution to another seeming mystery. Another mystery exploded in the face of verified truth!

But other similar sound conundrums are not as easily cracked.

While Gordon Cooper was making his marathon flight on Faith 7 (just before he sighted a UFO), something strange happened to his radio reception. This took place while he was making his fourth pass over Hawaii. Cooper reported hearing strange voice transmissions which he said appeared to him to be "unintelligible foreign language."

One UFO writer claims that NASA has studied the language (if indeed it be a language) but has never been able to analyze it.

Besides this alleged incident, Apollo 12 astronauts also picked up strange noises. Apollo 12, which had been bothered by a trailing UFO on the way to the moon, also received unexplainable, sounds that appeared to be emanating from radio interference outside the space capsule or ground communications system. In other words, somewhere, somebody clearly was interfering with space communications. This time it was not seemingly a foreign language but strangely like the Apollo 11 noises: fire engines, beeps, whistles.

Is this another cosmic joke perpetrated by the astronauts themselves or from mission control ground communications setup? So far — to our knowledge — no one has come forth and volunteered an explanation or admitted, like Collins, to being the Apollo 12 practical joker.

Here is a portion of that Apollo 12 log:

*ASTRONAUT BEAN: Do you hear a lot of background noises, Pete?*

*CONRAD: Kind of static and things?*

*BEAN: I keep hearing a whistle.*

*CONRAD: That's what I hear.*

Ten minutes later, astronaut Dick Gordon, in the command ship orbiting the moon, reported to mission control:

*GORDON: Hey, Houston, do you hear this constant beep in the background?*

*MISSION CONTROL: That's affirmative. We've heard it now for about the past 45 minutes.*

*GORDON: That's right, so have we. What is it?*

But mission control never did determine the cause of these



mysterious sounds, and to my knowledge, never publicly explained them.

But then a lot of things about our entire space experience are unexplainable. For instance, there have been many mysteries uncovered through our lunar moon program for which no scientist has ever offered reasonable answers. Why does the moon ring like a huge going or bell for hours (up to four!) whenever our space lunar modules or third stages of our rockets crash into it? Why were many scientists reluctant to accept and explain the pure metal particles that have been found on the moon? The Soviet newspaper *Pravda* even announced recently that pure iron particles were brought back by an unmanned lunar probe in 1971 — iron particles that do not rust. They admit they can't figure it out. Can you?

Dr. Farouk El Baz, Egyptian born NASA scientist, who is no longer with the space program (now with the Smithsonian Institution) and who helped train the astronauts in geology, admits that "all the discoveries weren't announced" from our lunar expeditions. He even claims that secret experiments and probes (such as to see if the moon has hollow areas) have been carried out and the findings held secret. El Baz also claims that the


strange lights seen by our Apollo 16 and 17 astronauts were nothing else but UFOs.

Finally, claims have been made that no authentic photos of UFOs have ever been taken. However, Dr. Garry C. Henderson, Senior Space Research Scientist with the General Dynamics Corporation, insists that not only have American astronauts sighted UFOs but actually did take pictures of them — both movies and still photos.

This appears to obliterate the feeble claim of those trying desperately to disclaim any and all astronaut sightings. It also indicates that there has been a NASA cover-up. We have seen that despite NASA's attempts to keep silent about the truth (along with the secretive Soviet government) that visual and oral testimony regarding UFO sightings did leak out. Our astronauts apparently have seen UFOs in outer space.

In fact, we have seen that the evidence is overwhelming. Considering the testimony of NASA officials themselves, space scientists, the astronauts and the mission control tape logs, it is clear that the greatest Watergate we have on our hands in our times is not the political cover-up but a cosmic Watergate which hides truths of far greater impact and significance. ●

# The Most Famous UFO Sightings Which No One Knows About(?)



■ "An important finding (of a 1968 survey conducted by the Opinion Research Corporation for the Colorado UFO Project) is that 87 per cent of those who said that they had seen a UFO also declared that they had reported it to no one . . . Thus only about one-eighth of sightings were reported anywhere, and not all of these were reported to the Air Force."—*Scientific Study of Unidentified Flying Objects* (The Condon Report), Bantam edition, 1968, p. 45.

Following publication of the Condon Report, the late Dr. James E. McDonald challenged its negative findings in a series of lectures before military and scientific organizations across the country. He was a professor of atmospheric physics and meteorology at the University of Arizona. Time after time, impressive witnesses in the audiences—pilots, scientists, engineers—stepped forward to privately recount personal UFO experiences; sightings which they had not reported to any official agency. Here, from the author's private file of correspondence with Dr. McDonald, are glimpses of some hidden UFO sightings by witnesses of such caliber that their

testimony would strongly support the need for scientific investigation of UFOs.

Colonel Howard T. Wright, an experienced Air Force pilot, flew a B-25 bomber from Reese AFB, Texas to Birmingham, Alabama on January 16, 1957, to deliver two aircrews to pick up two other refitted B-25's. What should have been a routine flight turned instead into an experience etched vividly in his memory.

After dropping off the other crews, Col. Wright took off and headed back to his base near Lubbock, Texas. A half hour later the second crew took off, followed by the third a half hour after the second. In the vicinity of Fort Worth, Col. Wright noticed that visibility was exceptionally good so he elected to depart from the standard air route marked by flasher beacons and struck out on a straight course toward Lubbock through the "dark area." The second B-25, as it turned out, also elected to take the shortcut, but the third—piloted by a less experienced officer—went the normal route.

Near Wichita Falls at 8,000 feet Col. Wright had turned over the controls to his co-pilot, a captain, for a one-hour shift. He happened to notice a bright, luminous ball of light to the right and 30 to 45 degrees above the plane, and called out a warning to his co-pilot, thinking it might be another aircraft. Then he noticed that his "bird dog" (radio compass), which was tuned in on Lubbock, was pointing directly at the UFO—almost 180 degrees away from where it should have been. Whatever the thing out there was, it seemed to be emitting an electromagnetic force.

As they watched in fascination, the UFO moved rapidly away from its initial position, descending abruptly to a position off the right wing and proceeding to blink or pulsate. The strange phenomenon continued to pace the B-25 for nearly an hour, occasionally pulling ahead and then falling back to the 3 o'clock position. Each time it did this, the "bird dog" needle—eerily—followed it. The UFO also moved up and down, and once or twice came in toward the plane—in-

creasing in apparent size—then returned to its original size and distance.

On the final approach to Lubbock, the UFO abruptly soared in toward the bomber increasing dramatically in apparent size. For five tense seconds it hung there, its light now steady, then it accelerated away from the plane, disappearing on a straight course in 12 seconds as measured by a stopwatch. The shaken crew landed at Reese AFB and immediately called for the base operations officer and OSI (Office of Special Investigations—the Air Force equivalent of the FBI). While they were making their report, the second B-25 landed. The two planes had not been in radio contact. The second pilot burst into the room and blurted out “My God, did you see what I saw?”

Hurriedly, they refueled one of the B-25's and took off again, flying back and forth for several hours. One OSI man was positioned in the nose of the B-25 with a camera, another in the engineer's section aft, but the search was futile. Meanwhile, the third B-25 landed, but it had not flown through the dark area and had seen nothing. Next day, five Air Force investigators from Colorado Springs showed up and took detailed statements.

A little over a month later a

Catholic chaplain, who had heard of Wright's sighting, approached him and disclosed having seen a large disc-shaped UFO swoop down to about 50 feet from his car on a highway near Lubbock. The dust had swirled around and settled in a coat on his car. In that dust, the startled Chaplain Murphy wrote his name.

During a visit to Washington in May, 1970, Dr. James E. McDonald phoned Col. Wright at his residence in a Washington, D.C., suburb and interviewed him at length. Then in June, Dr. McDonald managed to locate the Air Force intelligence report in the Project Blue Book files archived at Maxwell AFB, Alabama, describing the UFO sighting that had taken place 13 years earlier.

As a meteorologist familiar with radar—and particularly weather effects on radar—Dr. McDonald also checked the Blue Book files for cases that had been labeled as “weather.” There he found dozens of intriguing radar-UFO cases—better than many of the classic known cases, he said—that had been glibly explained as due to weather when this explanation made no sense at all.

These are cases you haven't heard about that were reported to the Air Force. Then there are those that were never reported to any of-



ficial agency.

Among the approximately 700 UFO cases officially classified as unexplained by the Air Force, 21 “unknowns” were reported in April 1952 alone. This was more than were normally labelled “unknown” for entire years during the 1960's. And this was only a fraction of the sightings made. On April 25th two biological scientists employed by a West Coast corporation had a daylight sighting of a metallic-looking disc that wobbled “like a disc in a





water meter" as it maneuvered over their plant at 11:00 a.m. on a bright day. They did not report it to the Air Force.

Dr. McDonald later interviewed the scientists. They observed the UFO from the parking lot, and immediately went into the building and wrote a detailed account which was placed in the company research files. The disc, about 4-5 feet in diameter, passed directly overhead rotating around a central axis, making no sound and emitting no visible exhaust. As the two men gaped in astonishment, the UFO swept overhead in a large arc at about 50 feet altitude, then turned and headed back toward them.


About this time they noticed, much higher overhead, another apparently larger round, black object hovering motionless near a thin overcast of high clouds. "Suddenly," Dr. McDonald was told, "two other seemingly identical objects came into position, as if they had quickly dropped out of the cloud overcast. The three objects jittered around like boats in a stream but held a more or less steady position relative to each other, aside from this erratic motion."

Meanwhile, the small disc origin-

ally sighted had turned and slowly approached, stopped spinning, hung motionless for a moment, then rapidly climbed away towards the north-northeast. As the disc began its rapid climb, one of the three black objects higher overhead left the formation and headed in the same general direction. The two UFOs converged, then both seemed to disappear into the overcast. Finally, one of the remaining two black objects took off to the north, and the other went straight up into the clouds, terminating the sighting

at 11:15 a.m.


The experience proved to be disturbing to the two scientists, who had previously scoffed at UFO reports. They were forced to the conclusion that the UFOs must be extraterrestrial. "It utilized some propulsion method not in the physics books," one of them said. He had worried ever since about the effects on humanity, since human experience indicates that inferior civilizations tend to disintegrate when contacted by more advanced technologies. They started to report



the sighting to the Air Force, but fear of ridicule took over and they hung up the phone before completing the report.

Dozens of radar and radar-visual UFO sightings are on record, but it appears that they also represent only a small fraction of actual sightings. One chief of a Federal Aviation Administration (FAA) office in a major urban area, whom Dr. McDonald interviewed in 1969, had been involved in six radar-UFO incidents:

(1) Date unknown. In the early morning hours before dawn, a UFO was detected on FAA radar, moving slowly at first but then accelerating to supersonic speed. The chief went outside of the FAA tower, looked up to the south-southeast where the radar had indicated a UFO, and saw a brilliant round object in the sky. In this case an Air Force officer was sent to investigate, concluding that the "UFO"

was a research balloon. The FAA chief, however, checked the upper wind patterns and they did not coincide with a balloon launch.

(2) Date unknown. A UFO was detected on radar moving at extremely high speed across the scope from SE to NW. It was visually observed from the control tower as a bright streak moving horizontally, glowing white with red overtones. The ASR-3 radar set with offset scope tracked the unknown object out to about 75 miles.

(3) About April 1945. An object like a brilliant flare was seen to descend from high altitude, disappearing beyond the horizon in about five minutes. Other FAA stations hundreds of miles away also reported sighting the object.

(4) Early 1950's. A UFO was observed on radar moving from NW to due S of the station at a speed between 1,800 and 2,400 m.p.h. The





(6) About 1961. A UFO was tracked on radar, initially moving at about 30-40 m.p.h., then accelerating to over 150 m.p.h., also observed visually from the control tower and reported by citizens in the area. The UFO disappeared in a flash of flame, but police conducted a search and found no debris. At one point the UFO made a 90 degree turn, and it moved with variable speed.

In May 1970 Dr. McDonald gave a talk to the Southern Nevada chapter of the American Nuclear Society, and was given a tour of the Nuclear Rocket Development Station. "Got two sightings there," he later wrote me, "one a mid-fifty Navy airborne radar fast-track case, from a Westinghouse engineer who was at the time a radio technician." The wit-


UFO passed near a missile firing base, but checks with officials at all local military bases failed to turn up any conventional explanation.

(5) Early 1950's. Over a period of about six months the FAA station had repeated radar sightings of five or six UFOs in a more or less oval formation that would approach the area slowly, then accelerate. The radar-UFOs were seen day and night.





ness had been an aircrew member of a Navy P2V when a strong radar target was observed crossing the 400-mile diameter field of their APS-20F scope in five sweeps of the radar beam, indicating a speed of many thousands of miles per hour. The aircrew did not report the sighting. Why bother?


As a member of the American Meteorological Society, Dr. McDonald frequently spoke to AMS chapters around the country. There, too, fellow scientists disclosed personal UFO sightings. In February 1969 he attended the AMS banquet. "After the banquet," he wrote me, "I talked for about an hour or so with various people and was amused to find an ex-German scientist from some army research lab who discussed with me and several others a sighting that he and about twenty



other German scientists and technicians made in the spring of 1945 while waiting on a ship to escape from the Russians in a harbor in north Germany. It was a luminous spherical object at high angular elevation which took twenty or so minutes to cross eastward over the sky through an arc of about thirty or so degrees. None of the scientists present had the slightest idea what it could have been."

That same month Dr. McDonald was addressing a chapter of the American Institute for Aeronautics and Astronautics at the Pt. Mugu Naval Air Station, California. A high Navy officer at the Pacific Missile Range (name known) told McDonald of two UFO sightings, one involving a Navy captain and the other involving himself and 200 other Navy officers. At White Sands Proving Grounds, New Mexico, during the week of April 30 to May 4, 1956, instruments at missile tracking sites had tracked a huge metallic-looking object at great altitude hovering stationary over the launch area for several hours. The UFO, also observed visually, dis-







played an apparent size of about one-fourth that of the moon.

Most experts agree that only a tiny percentage of UFO sightings ever get reported. Dr. J. Allen Hynek, director of the Center for UFO Studies, noted in his book *The UFO Experience*,

*"It has been my estimate over the past 20 years that for every UFO report made there were at least 10 that went unreported. . . There has always been a great reluctance to report in the face of almost certain ridicule. It would seem that the more trained and sophisticated the*



*observer, the less prone he is to report unless he could be assured of anonymity as well as respect for his report."*

Dr. McDonald's interviews strongly confirm this estimate. It is easy to see that the hidden UFO cases constitute the submerged part of the iceberg. Real scientific investigation of UFOs is not likely to come about until ridicule ends and highly qualified observers feel free to talk about their sightings openly. Only then will the true dimensions of the UFO mystery become apparent. ●



# The Misty Side Of UFOs: CLOUDS OF DOOM

It seems that where UFOs go, clouds aren't far behind. That's right, in maybe cases of UFO sightings, the objects come out of clouds or disappear into clouds. There certainly seems to be a connection between UFOs and clouds, so let's see if we can find the silver lining to this mystery.






■ Whether the reader belongs to that majority who are on the fence concerning the subject of UFOs, or to that increasing minority who accept the evidence, he can hardly resist the temptation to contemplate another clue, a mystery within the mystery. And this is where clouds come in. . .

Mysterious "clouds," mists and vapors have so frequently coincided with UFO activity that there is no longer any doubt that "clouds" are a clue, perhaps even a solution, to the UFO enigma. UFOs vanish into clouds, shine through gaps in the clouds and masquerade as clouds. They may appear as featureless balls resembling puffs of smoke or as turbulent clouds of strange form. Many people say UFOs don't look like solid geometrical bodies from which light could emanate; rather the form seems due to the presence of the cloud. There are mysterious shapes like condensation trails appearing with UFOs.

Brinsley Le Poer Trench, the Chairman of Contact, one of the world's largest UFO-watching organizations, writes, "Modern ufology teems with references to cloud cigars. The distinguished French author Aime Michel cites many cases of cloud cigars seen over France. Michael states that these reports 'lend color to the idea that the great cloud cigar may be a mothership to which are attached, in some way that we do not understand, smaller and more mobile craft, which come and go within certain limits around the large ship.'" Such a ship as seen in France in 1954. . . "a large luminous object which he described as circular, red and surrounded by a sort of luminous vapor, the same color as that emanating from the object. He states the constant feature which accompanies the 'cigar' in vertical position: it appears only in a cloud." Trench witnessed such an object—surrounded by a "luminous vapor or eerie off-white appearance."

What is meant by the word "cloud" in ancient manuscripts and the Bible? It's quite certain that to the ancients the word "cloud" had the same meaning as our modern word "UFO" . . . especially a powerful chariot (flying saucer); the place where God resides (a powerful leader within a mothership); and/or an instrument used to take orders





from God (an intergalactic telephone).

The cloud that led the Jews out of Egypt to the promised land was no ordinary cloud... "And the Lord went before them day by day in a pillar of cloud to lead the way; and by night in a pillar of fire to give them light." There was something or someone in the cloud: "And it came to pass, as Moses entered into the tabernacle, the cloudy pillar descended, and stood at the door of the tabernacle, and the Lord talked with Moses. And all the people saw the cloudy pillar stand at the tabernacle door; and all the people rose up and worshipped, every man in his tent door. And the Lord spoke unto Moses face to face, as a man speaketh unto his friend..." (Exodus 33:9-11).

Ezekiel had a famous contact with a cloud, too... "And I looked, and, behold, a whirlwind came out of the north, a great cloud, and fire unfolding itself, and a brightness was about it; and out of the midst thereof as the colour of amber, out of the midst of the fire.

Consider these passages from the Bible: "God is shrouded in a canopy of thick clouds dark with water." (Psalms 18:9) "Ascribe ye strength unto God: his excellency is over Israel, and his strength is in the clouds." (Psalms 68:34); "... Who layeth the beams of his chambers in the waters; who maketh the clouds his chariot..." (Psalms 104:3); "The chariots of God are twenty thousand, even thousands of angels." (Psalms 68:17).

Translated, this story could be put thusly: God, a supreme leader, conceals himself, with his followers and assistants, in a cloudbank or in high-powered vehicles. And they shall return: "For the Lord himself will descend from heaven with a cry of command, with the archangel's call, and with the sound of the trumpet of God. And the dead in Christ will rise first; then we who are alive, who are left, shall be caught up together with them in the clouds to meet the Lord in the air, and we shall always be with the Lord." (Thessalonians 4:16-17).




as scattered Bible verses, unfolds something like this: millions of true Christians will very soon vanish suddenly and inexplicably from their jobs and homes to be snatched up to heaven as Jesus summons them from the clouds. Little known to a mystified world, this disappearing act called the 'Rapture' marks the start of a 3½-year period when the balance of world power shifts from the giant nations to a confederacy of European nations, possibly involving some Arab countries."

Cloud beings figure very prominently in the lives of the Pueblo and Hopi Indians. and according to the letter, when Turkey surrendered in 1918, "the first thing Britain demanded of Turkey was the return of the regiment. Turkey replied that she had neither captured this regiment nor made contact with it, and did not know it existed. A British regiment in 1914-18 consisted of any number between 800 and 4000 men. Those who observed this incident vouch for the fact that Turkey never captured the regiment, nor made contact with it."

To capture that many men would require a 'mothership.' However, the cloud kidnapers have also nabbed just two, or even one. Are these the same team that's supposed to be the good guys? Why and how does this happen?

Dr. and Mrs. Gerardo Vidal, who were driving home from a family reunion party at Chascomus and knew no more til they found themselves still in their car on a dirt road near Mexico City, some 4500 miles away. Forty-eight hours after leaving the party, Dr. Vidal telephoned friends in Argentina advising of their whereabouts. The Vidals could not account for what had happened during that elapse of time."

A Brazilian couple driving in Brazil encountered a 'white cloud' and they too knew no more til they woke up in Mexico, the most famous drop-off spot.

In Tokyo, several Japanese men witnessed a black car, with an elderly man sitting in the back seat, disappear into a puff of something gaseous, like white smoke or vapor... when this cloud dispersed (a matter of not more than five seconds) the black car had vanished.

Although I haven't decided quite how these disappearances are accomplished, Lieutenant Plantier of the French Air Force has a theory explaining how and why clouds accompany UFOs. "The column of air affected by the field 'weighs' little or nothing and will therefore produce a rising current of air strong enough to lead to condensation." Thus, the cloud is created by the action of this machine's force field—and can be used as a camouflage! He explains such a flying machine's operation as follows:

"There exists, distributed throughout space, an energy of as yet unknown form, which has not yet been detected by the physicists' in-

struments except in the guise of cosmic rays, whose 'clicks' may be heard in the Wilson cloud chamber at the Palais de la Decouverte.

"A way exists to liberate this energy, by transforming it into energy of a more degraded kind, in the same way, for example, as the stroke of a hammer against an anvil transforms kinetic into thermal energy.

"The liberation of this cosmic energy makes it possible to create, at the point where it operates, a local field of force that can be varied and directed at will.

"Such a vessel, using such a force field, would be shaped like a disk (perfectly symmetrical about its axis). It would be able to move at unbelievable speeds without noise, and to break the sound barrier without a boom, and passengers inside would not feel the accelerations."

Another theory connecting the luminous cloud phenomenon to the UFO mystery reads like this: Transform vibrations perceptible to the human eye into vibrations within the invisible range. Color would go first, then details and lastly general shape. In other words, you would see the general outline of objects but something like a fog where the details would have been. And then—pouff!! Just as many people have described the sudden disappearances of UFOs. This would be achieved by enveloping an object in a magnetic field, thus disturbing visual appearance.

Yet another theory postulates the idea of a parallel universe. To travel from one to the other, the UFO must reduce itself to its "etheric state" by the "condensing form." This is accomplished through the use of vortices or windows that perhaps may be magnetic faults of the earth and are located strangely and precisely on our globe. If these vortices are used as transformers or elevators by the UFOs, then perhaps we could more closely study these dynamic locations.

There have also been stories that suggest these clouds are DOR clouds, degraded orgone energy, which is orgone energy that has been used by the UFOs, a deadly form of pollution.

Whatever these clouds eventually turn out to be, I am convinced that they can reveal more than they conceal. ●



ror or pushing a button... and whoosh, we turn into a vague misty blur and disappear only to reappear at our destination. Not only will we be able to go to distant galaxies, but we'll travel to different dimensions as well. As far-fetched as this seems at the present time, there are stories connecting mysterious disappearances with clouds.

Trench cites the case related by Jacques Vallee in his book, *Passport to Magonia*, where a whole regiment was kidnapped or teleported. You decide.

"On August 28, 1915, during the final days of severe fighting at Hill 60, Sulva Bay, during the Gallipoli campaign, in which the Australians were participating, a most extraordinary event took place. August 28 was a beautiful clear day, but it was observed that six or eight 'loaf of bread' clouds, all alike, were hovering over Hill 60. These clouds, despite a strong breeze, did not move.

A British regiment of several hundred men, the First Fourth Norfolk, was seen marching up a sunken road toward Hill 60, but one of these clouds was hovering over the road. The regiment marched into the cloud, but did not come out to deploy and fight at Hill 60.

After the last file had disappeared into the cloud, it unobtrusively moved away, and so did the other clouds.

In this book, Vallee published a letter signed by several witnesses of the event. The regiment was posted as 'missing' or 'wiped out,'

# EARTHLINGS: ALIEN GUINEA PIGS?



It is a commonly held theory that earthlings may be the experiment of aliens, using our entire planet as a laboratory to carry out their experiments. It's time this controversial theory was examined once and for all!




■ On September 1, 1973 Edwin Fuhr, while busy harvesting his crops, was approaching a slough in the ground when suddenly he observed a symmetrical box-shaped object hovering about a foot off the ground. The grass underneath the object was being swept in a clockwise, swirling motion.

Fuhr, a farmer residing in a remote area of Saskatchewan, Canada, watched in amazement for a few minutes before he noticed the entire object was turning. Then off to his left he spotted four other identical objects performing the same function. For 15 minutes he sat there watching the objects and wanting to leave, but for some reason he just could not move. Suddenly the objects all left, simultaneously rising straight in the air and exhibiting a gray mist from underneath each one. An investigation by the Royal Canadian Mounted Police turned up a circular swirl of grass for each UFO position reported by Fuhr!

UFO's have been reported flying around the earth for hundreds and possibly thousands of years. It appears our planet has been, and currently is under intense observation by beings of superior intelligence. Their purpose we can only hypothesize, but one thing seems certain: we are specimens in someone's laboratory where experiments with our earth and its inhabitants take place at the convenience of these intruders.

When pilot Kenneth Arnold witnessed nine saucer-shaped objects while flying over Mount Rainer, Washington in 1947, it was the beginning of the modern era of UFO sightings. Since then our planet has been the subject of a seemingly widespread intelligent surveillance by alien beings. People have reported UFOs landing and performing all kinds of unconventional maneuvers. There have been many contacts between UFO-nauts and humans. Some of these aliens act friendly on the surface while the actions of others seem to indicate hostility on their part. But no one



knows their motives, and if someone in Washington does, they're simply keeping it to themselves.

We are like mice in a cage to these invaders. Their crafts fly rings around our foremost military planes and they come and go when they please. Sometimes they "invite" earthlings into their ships for what appears to be a full-scale physical and mental examination. The planet Earth is a giant laboratory and we as humans are guinea pigs as intelligent beings from an unknown source gather around, scrutinizing all of our actions.

Sometimes these UFOs leave behind evidence of their presence. Indeed, they apparently want us to know they're around. In just about every landing case their vehicles leave a visible impression in the ground. A 20 foot circle indentation is a familiar trademark of a UFO landing after a witness has reported viewing a cigar or disc shaped object taking off from the ground. Burned or dehydrated vegetation and swirled grass patterns also are noted around some UFO Landings. Sometimes traces of radioactivity have been detected around mutilated animals in areas where UFOs have been reported.

Some UFOs land in a certain spot and return the following night. On November 11, 1965, Anhava Filho and her grandson watched from their farm as a lighted object landed in a nearby field. They saw two small men dismount from the craft and walk around the field, picking up trees and branches. The visitors also inspected a mare which was standing by a fence.

When her husband returned home Mrs. Filho informed him of the strange happenings. So the next day he went into town and invited all his friends to come and watch these unknown strangers. Sure enough, on the night of the 13th they returned. There were three of them: one wore overalls; another, a pair of chocolate pants; the third had a squarish, flat head and wore what appeared to be a surgeon's apron. These beings and their ship glowed brightly all the time. Next they seemed to continue the chores they had begun the previous evening as they stalked around, uprooting



plants and plucking leaves and twigs from bushes. The beings moped around for a while longer before their craft and taking off at high speed.

A similar incident occurred in a Wisconsin cornfield in June 1972. The witness, a farmer who wished to remain anonymous, viewed a silver, egg-shaped object slowly descend into his cornfield about 100 yards away. Just as the craft seemingly was about to strike the ground, a pair of legs "grew out" of the bottom and the object landed. A door opened on the side and "some people" about five feet tall came out and "messed" around with the corn stalks for a while before they hopped back into their ship and sped away.

During the intense UFO flap of 1897 a farmer watched helplessly as a UFO literally stole one of his cattle. Alexander Hamilton of Yates Center, Kansas, was awakened at 10:30 on the night of April 19 by a disturbance among his cattle. Investigating the commotion Hamilton was amazed to see "an airship descending upon my cow lot about 40 yards from the house." Hamilton ran back to the house and called his son and a tenant. Armed with pitchforks they returned to the cow lot where the object hovered only 30 feet above the ground. In his sworn statement issued in the Yates

*Center Farmers Advocate* of April 23, 1897, Hamilton described a 300 foot long cigar-shaped object with a brilliantly lit undercarriage. The occupants flashed a beam at him and a second later "a turbine wheel 30 feet in diameter began to buzz and the vessel rose as lightly as a bird." When the ship reached 300 feet it hovered over a young heifer and, by means of a thick cable which previously had been tied around its neck, the object hoisted the cow in the air and took off.


Next morning, still not quite believing what he had seen, Hamilton searched around for his cow. He was soon shocked to learn a neighboring farmer had found the head, hide and legs of the butchered cow in his field. Hamilton, a former member of the House of Representatives, staked his honor upon his statement. He concluded his account with the following words. "I don't know whether they are devils or angels or what: but we saw them and my whole family saw the ship and I don't want any more to do with them." Hamilton wasn't the only one to see these huge airships. In the month of April alone, 20 states reported sightings of the same genre. Searchlights sweeping the ground were witnessed all over the country along with whirling machinery that landed for what appeared to be repairs and supplies.

Are those beings who took great interest in the United States in 1897 the same ones who are monitoring our world today? The answer will no doubt remain a mystery until direct contact is made between UFO-nauts and representatives of our planet. And though there are many different descriptions of these flying saucer occupants, should we assume they all hail from one world or are beings from several sources watching over our planet? Whatever the answer, they all at least demonstrate the same pattern. For one thing, they always seem to be keenly interested in our livestock and the earth itself.

Another case which indicates these invaders are concerned with our soil is the story of a lavender plant grower in France who was frozen to the spot while investigating the theft of some of his plants. In the latter days of June 1965, Maurice Masse noticed his plants had been "tampered with." At about dawn on July 7 he was standing near a hillock at the end of a field when he heard a strange whistling noise. Masse looked up and saw a football-shaped object about the size of a Dauphine car resting on six legs in the middle of his lavender field.

Astonished, he then saw "two boys of about eight years" emerge from the object and began swiping his plants. Masse was furious at these thieves and as he sneaked closer he realized these were not little boys but funny looking creatures with pointed chins, almond-shaped eyes which curved around the sides of their heads and slits for mouths. Instead of talking from the mouths the beings appeared to communicate by grumbling noises inside their bodies. Masse then rushed upon the creatures and was about five yards away when one of them pointed a pencil-like instrument at him and he was suddenly immobilized—conscious but frozen in his tracks.

The creatures, less than four feet tall and wearing close-fitting, gray clothes, were "bubbling up" a ladder of lights into their machine. The vehicle's legs whirled, then retracted, and the craft rose to about 20 meters before it just vanished.



The police investigated and viewed landing impressions on the ground. Several witnesses verified Masse's testimony and the withered spot where the craft landed was still there two years later.

Frank Edwards, in his fine book, *Flying Saucers Here and Now*, presented a vivid picture of how our government would correlate a systematic operation procedure of observing another planet. The plan resulted from a joint Army-Navy briefing conducted in Washington, D.C. in 1950. Edwards described the seven phases of contact they would initiate when surveying another planet. Condensed, the steps are as follows:

1. Approach, consisting of a cautious and careful surveillance of planet from a safe distance. Study planet for intelligent life.

2. Impart close range surveillance of planet by instrumented probes resulting in photographs and samples of the atmosphere.

3. If the results of these probes warranted further investigation, then present craft would be phased out to be replaced by faster and more maneuverable vehicles. The reason for this change would be to test the characteristics of the planetary vehicles to our own.

4. Manned craft approach to see if inhabitants are hostile. Check all military and radar locations.

5. Brief landings in remote areas for specimens of plants and animals and, if possible, intelligent beings.

6. If the results of the past phases indicate some kind of eventual contact, either direct or indirect, then this phase would consist of low level approaches and landings in populated areas to demonstrate our peaceful existence.



7. The last phase is a carefully planned step. We would not attempt contact unless we had reason to believe it would not be disastrous to both worlds involved. Even though

the results of the first six phases indicate it would be physically possible to land, there are some good reasons why it might never come to pass.

It appears our invaders are still deliberating on that fifth phase, though why they are hesitating there so long remains to be seen. In the old days of investigating the UFO phenomenon from the late '40s to the mid 60's, most researchers classified all contact cases as hogwash. But fortunately nowadays these cases are treated and examined carefully. One of the most controversial cases of the '50s—the Villas Boas affair—was laughed away by researchers, but with more contacts between humans and aliens more UFOlogists are regarding this case with a more critical eye.

Basically, Boas' story centered on the premise he was kidnapped by alien beings, put on some kind of space ship and seduced into sex by a beautiful blonde alien woman from the ship. This case was quickly placed on the dusty shelf and passed off for either a hoax, a wild hallucination or a sexual fantasy. But the late Dr. Olavo Fontes, APRO's former Brazilian representative, personally investigated the case and pronounced Boas to be probably telling the truth unless he was an extremely clever liar. Still, as Dr. Fontes pointed out in his summary the very heart of the story makes it almost too hard to believe.

The Boas incident occurred dur-



ing the South American UFO flap of 1957, which was almost as intense in sightings as the flap three years earlier which simultaneously struck both South America and France. These were the dwarfs, the little hairy folk three and a half to four feet tall, who usually wore huge bubble-like helmets over their heads. They were always seen running around, carrying rocks and soil into their ships, and then accelerating quickly into space and out of sight. Boas' description of his abductors generally matches alien characteristics in other sightings during this period.

Sometimes these beings like to show what they are capable of doing. They seem to know that we realize they are much more advanced in intelligence, but how about physically? In the following cases these aliens certainly demonstrated their physical prowess.

The first exhibition occurred in Vilvorde, Belgium, about seven miles northeast of Brussels, where the witnesses, a Monsieur V.M. and his wife, were sleeping. Arising for a trip to the bathroom, and not wishing to awaken his wife, he grabbed his flashlight and upon reach-

ing the kitchen heard what he thought was a shovel digging into the ground. He noticed a greenish-colored light which filtered in through the curtains. Puzzled, he parted the curtain to glimpse a three and one half foot tall being wearing a shiny green, one-piece suit.

The entity's head was encased in a transparent globular helmet, and a tube led from the rear of the helmet to join into a rectangular-shaped knapsack-type thing on his back. The being also carried a "small red box" on his waist which emitted a red light of continuing intensity. In his hands was a device which resembled a vacuum cleaner. He slowly passed this thing over a heap of bricks. M.V.M. then flashed his light twice and the creature appeared to answer the signal by raising his right arm and giving a "V" sign with his fingers.

The creature then transfixed V.M. by walking straight up the wall at the end of the garden. Without hesitation he placed one foot against the wall, followed suit with the other and simply scaled the wall with no change of pace or bending of the knees. Upon reaching the top of the 10-foot wall he walked over the top and down the other side. A few minutes later V.M. witnessed a round object slowly rising over the top of the wall. After hovering there for a few moments, making a churning sound with sparks emitting all around it, the object took off and disappeared into space.

In this instance the alien acted friendly, but that is not always the case. On November 28, 1954 in Caracas, Venezuela, Gustavo Gonzeles and his helper, Jose Ponce, were driving in a suburban warehouse to pick up some produce. When entering a street leading to the warehouse they spotted a luminous spherical object hovering about six feet off the ground and blocking their path.

After stopping the truck, Gonzeles stepped out to investigate as a three-foot tall hairy creature charged toward him. Attempting to grab the being, Gonzeles was struck

and knocked 15 feet. The creature then leaped at Gonzeles with clawed hands extended so Gonzeles drew his knife and stabbed the being, but the blade just glanced off like it had hit concrete.

At about this moment another creature emerged from a hatch in the object and directed a light from a metallic tube at Gonzeles. The light blinded him and the being he was sparring with leaped in the vehicle, which rose and departed from sight in seconds. During the melee Ponce watched two similar beings emerge from the street carrying rocks and dirt in their hands. Ponce ran to the police and told his story and very soon after this Gonzeles arrived. Both men were given sedatives and Gonzeles was treated for a deep red scar on his side.

There have been other cases where UFOs have appeared at the least unfriendly. The victim, James Flynn of Ft. Myers, Florida, had taken a couple of dogs with him into the Everglades. After pitching camp he was awakened at 1:30 in the morning by the dogs barking. Arising out of his slumber he noticed the dogs were watching a brightly lit object of an undetermined shape which was settling into the swamp. Flynn hopped in his small jeep and drove to the spot where the lights were visible. About 100 yards away he halted the vehicle and covered the remaining distance by foot.

About 30 yards from the object at his nearest approach, Flynn saw a circular object 100 feet in diameter with four rows of lighted windows on the lower ten feet of the vehicle. He took a few steps forward and suddenly found himself flat on his back. He saw or heard nothing, but something hit him hard and left a gash that later required medical attention. By the time he regained his sense the object was gone. Flynn later brought a group of citizens and police to the scene, where they found a circle measuring 75 feet in diameter in which the grass was seared. Also, some nearby trees were scorched on the side facing the burned circle.

So once again it seems we are but mice in a cage. Are we too far below these beings in intelligence to risk direct contact? From all the evidence, we still do not know how many different species of aliens are watching us. But what exactly do they want and why are they taking so long in their research? Recently there have been important new contact cases, such as the Hidgeon case in Wyoming and the Travix Walton affair in Arizona. But if these UFOs are making more contacts, why are they still concerned with pieces of our soil?

A recent issue of the *National Enquirer* contained an article about huge chunks of earth moved from the ground where a rash of UFO sightings have taken place recently: The little Canadian town of Cooper, located 60 miles north of Kingston, has been befelled by UFO sightings. Huge chunks of earth weighing hundreds of pounds have been cut from the ground and rearranged like pieces in a jigsaw puzzle in this aloof Canadian farming region.

Five people have reported close-up sightings while many others have heard strange beeping sounds at night. In just one example of this mysterious shifting of earth, three triangular pieces of grass and earth weighing roughly 600 pounds each were neatly cut from the ground and left intact about 15 to 18 feet from their original locations. There have been no tracks or trails around these movements and officials are left without an explanation for this rude tampering with our environment.

We are a part of what seems like a timeless experiment taking place over the planet Earth. Aliens from unknown sources are scrutinizing our planet for reasons we do not know. About the only thing we can say for certain is that we have been under observation for a long time, and still are. Until the mammoth day arrives when these aliens feel we are ready for contact, all we can do is speculate the reasons for their presence. ●


# MYSTERIOUS UFO CRASHES: FACT OR FICTION?

There have been many reports over the years of UFO crashes. How many of these actually happened and how many were just the creation of overactive minds? Well, let's take a look into this enigma and see if any UFOs really did crash land on earth!

The persistent rumors of crashed alien ships from space have plagued students of Ufology like a nagging headache as long as Ufology has been studied. It is, like it or not, an integral part of the phenomenon. While the amateur and the fringe element relish these tasty tales of mini-corpses on ice and saucers stowed in mysterious warehouses, the scientific investigator wants none of it (except perhaps a small metallic fragment now and then, suitable for loss in government channels). With few exceptions, serious Ufology regards these stories as pure fabrications of the worst sort, to be locked up in the saucer nuthouse along with George Adamski, Carlos Allende and the Hollow Earth Theory. Yet, by volume alone, these curious tales deserve the attention of those who would obtain a thorough overview of the UFO enigma.

Diving head first into the vast literature on aerial phenomena in search of crashed saucers, it soon becomes obvious that there is no shortage of spaceship accidents. In fact, if you throw in all the mysterious explosions and craters, these extraterrestrials begin to look like a pretty high-risk group, should any of them ever decide to take out earthly insurance policies.

The first well-documented case of reckless UFO driving in modern times takes us back to 1897, when spaceships were airships and the West had barely been won. In the little town of Aurora, Texas, an aerial machine sailed impressively over the center of town in the early morning and, in an unforgivably clumsy move, slammed into Judge Proctor's windmill, blowing itself to bits. These bits were scattered by the force of the explosion over several acres of ground, and as if destroying the judge's water system weren't enough, laid waste to his flower garden as well. The mangled remains of a single pilot were collected, deemed to be "not an inhabitant of this world" and given a Christian burial anyway. The International UFO Bureau, Inc. conducted an investigation of this incident from 1972 to 1974. Pieces of metal were recovered from the crash site, but the remains of the somewhat shredded alien were not exhumed as the Aurora Cemetery Association decided to block any attempt at disturbing the unwordly stranger's rest. Some of the metallic fragments found their way to a



■ Sometime in the spring of 1948, military defense observers in Colorado registered an unknown object descending into the mesas of northwestern New Mexico. Within a few short hours, Air Force officials had pinpointed the object and cordoned off the desolate area where it lay. Military scientists were flown in, along with a battery of instruments. They proceeded cautiously with their investigation, for apparently

what had softly landed in that harsh terrain was an alien space ship, the first flying saucer to fall into American hands. Inside the cabin of the 100-foot silvery disc, the scientists found the slightly charred bodies of 16 men, all seemingly normal adult humans except for their teeth, which were flawless, and their height, which ranged from three to three and a half feet. . .

Or so the story goes.



physics professor at North Texas University named Dr. Tom Gray. According to a United Press release, Dr. Gray found the samples to be 75 percent iron, but with the distinctly nonferrous qualities of being shiny, soft and nonmagnetic. Typically, no firm conclusions about the alleged Aurora airship crash were reached.

On the opposite side of the globe, a decade later, a more spectacular celestial accident took place. Although not exactly a crash, whatever it was that exploded above the Siberian taiga on June 30, 1908, left irrefutable proof existing to this day that something unearthly blew up over the desolate Tungus region. Long assumed to be the result of a meteor or comet, modern investigations have shown that the brilliant object that was observed that day had changed speed and direction before exploding with the force of a 10-megaton hydrogen bomb, and that the explosion was of a nuclear nature, to boot. Needless to say, the comet theory has gone out the window. The possibility remains, of course, that the Tungus explosion was not accidental. At any rate, the flattened trees and the altered growth rings of standing trees at the detonation site offer mute proof that something far beyond human or natural capabilities occurred that day.

John Keel has unearthed a perplexing incident which he reports in his recent book, *The Eight Tower*. Back in 1924, a farmer in Braxton County, West Virginia, saw a curiously huge wingless aircraft crash in the backwoods near Gem. Keel's informant, a Mr. John Cole, was a member of a group led by the sheriff to investigate. Before long, the group came across the wreckage of a 25-yard-long fuselage-like craft, wingless as reported. Busily engaged around the wreck were five or six small, dark-skinned men of oriental appearance, some in odd shiny

coveralls, some in the classic black business suits. One of these extremely strange (especially for 1924 Braxton County, W.V.) customers hurriedly explained to the local boys that everything was under control, that they would file a report with the sheriff later. As the "posse" was leaving, Mr. Cole pocketed a small metal part he had noticed on the ground. That night, he was roused at three a.m. by one of the "foreigners," dressed this time in a U.S. Army uniform. The "Army officer" demanded the metal piece, and upon receiving it, left without a further word. A check of the crash site days later revealed nothing more than trampled brush and grass. Keel relates that a similar incident occurred in Oregon in the 1930s.

Between the World War II Foo-Fighter era and the birth of the Age of Flying Saucers in 1947, there was a brief flurry of UFO activity in northern Europe. The objects involved came to be called Ghost Rockets, as they were assumed by the V-2 conscious post-war Europeans to be missiles. Apparently they came in several makes and models. The descriptions ranged from green fireballs and speeding spool-shaped objects trailing flaming tails to slow-moving 90-foot, metallic cigars. 1946 must have been a bad year for UFOs, as these Ghost Rockets showed a marked tendency to blow up and crash.

The crashing started on July 9, when something fell near Sundsvall, Sweden. Fragments examined by a physicist were deemed not of meteoric origin. The debris was alleged to have included some graph paper, some film and a cylinder. On July 11, three low-flying, cigar-shaped objects were reported to have slowly landed (one in a lake?) and promptly burned up. The total number of Swedish crashes was reportedly up to seven by the 12th of July. A week later, two Ghost Rockets flew in low over Lake Mjoesa, Norway, splashed down and sank into its chilly waters.

On August 11, AP reported that Swedish military personnel were dredging a lake in the frozen wastes of Lapland in search of one of the objects that was supposed to have sunk there. Reuters ran an article, also dated August 11, which stated that one of the "rockets" was said to have crashed and exploded that night near a central Swedish town,

the name of which was being withheld by the military authorities. Newspaper accounts on August 12 had the Swedish army rushing to investigate three separate crashes that had occurred the night before. One allegedly crashed north of Stockholm after swooping over the city. AP's August 13th rocket release included the tale of a Swedish couple whose afternoon of boating the previous day was livened up by the near miss of an exploding UFO. It seems they were rowing around, presumably minding their own business; when one of the now-familiar Ghost Rockets dove at them and burst into fragments which sank into the lake. Ghost Rockets did a lot of sinking into lakes.

The Swedish military announced on the 14th that they were examining possible "rocket" fragments. These were metallic, and one six-inch piece supposedly bore manufacture markings. Whether the marks aid "Product of Mars" or not, the public never found out, as said fragments were never heard of again.

The sensational account at the beginning of this article first appeared in an article in the October 12, 1949 issue of *Variety* by Hollywood columnist, Frank Scully. In 1950, Scully revealed the whole story behind his allegations in a book that has become a saucer classic. *Behind the Flying Saucers* stirred up a raging controversy which is still revived from time to time. In brief, the somewhat convoluted tale goes something like this:

One of the scientists called in to examine the crashed saucer was a magnetic specialist involved in government projects and given the pseudonym "Dr. Gee" by Scully. In



booklets, apparently dealing with navigational matters.

In the mad rush to prove this strange affair a hoax, the facts were hopelessly muddled. On March 8, 1950 (before the writing of *Behind the Flying Saucers*), George T. Koehler, staff member of Denver radio station KMYR, brought Silas Newton to the University of Denver. There he presented the story of the New Mexico saucer as an anonymous lecturer to D.U. science students. The press caught wind of it and played up the "mystery man" angle. Before long, through the magic of journalism, it was Koehler who had seen a couple of two-man saucers at a radar station somewhere along the southwestern border and it was all a hoax anyway.

By either strange coincidence or stranger design, on March 9, 1950 (the day after Newton's lecture at the University of Denver), a Los Angeles businessman named Ray L. Dimmick told the newspapers of seeing the remains of a wrecked saucer and the body of a 23-inch pilot at a military installation near Mexico City. This one was 46 feet across. The next day Dimmick changed his story, saying that two Latin American business associates had told him of seeing the wreckage and showed him a strip of mysterious metal taken from it. Prior to this, Dimmick had evidently been quite a solid citizen, not the type given to far-fetched hoaxing. He could actually have been on a Mexican military base, as his job was Los Angeles sales manager for an explosives firm, the Apache Powder Company.

UFO researcher Raymond E. Fowler ran across an ex-naval intelligence man who was allegedly ordered to the crash site of an oval object in Mexico on an unspecified date. On arrival at the scene, the man saw the wreckage of the object and its pilots being loaded into trucks, but was ordered away and told to keep quiet on the subject. After locating the witness years after the incident was supposed to have occurred, Fowler could not induce him to discuss the event.

One last note in relation to the possibility of a Mexican crash: an unusual (to say the least) photo was circulated in a Cologne, Germany, newspaper in the 1950s. It ostensibly depicted a 28-inch "Martian" corpse, the unfortunate victim of a very rough landing near Mexico Ci-

ty. In the photo were two trench-coated fellows in snap-brim hats looking like they just stepped out of *The Maltese Falcon*. They hold up by the hands between them a small humanoid figure that has been variously described as a wax mannequin and a shaved monkey. Two dark-haired ladies in the background look intently at the little guy who is garbed in nothing but a pair of tiny boots. Anatomically, the "Martian" does not resemble a shaved monkey. The real story behind the photo will probably never be known.


Raymond Fowler dug up two more cases where downed UFOs were supposed to have been seen, one in Arizona and one in the Syracuse, New York suburb of Matytale. The Arizona case took place on May 21, 1953. On that date an engineer employed by the Atomic Energy Commission in Nevada was flown on special assignment to Phoenix. From there he was driven along with a group of other specialists in a bus with blacked-out windows to an area he believes was in the vicinity of Kingman, Arizona. On the bus, they were briefed by an Air Force colonel on the nature of their assignment. It seems they were to evaluate different aspects of the crash of a top-secret Air Force vehicle. What the engineer saw upon arrival at the location of the crash was a heavily guarded silver object, a thirty-foot oval shaped like two saucers rim to rim. His job was to figure out the speed and trajectory of the craft at impact. At one point the engineer glimpsed inside a guarded tent and saw a four-foot dark-brown corpse, complete with silver suit and skullcap. After concluding their various jobs the specialists took an oath of secrecy. One year later the engineer was given the position of consultant with Project Bluebook. Regarding the saucer incident, he kept silent for 20 years before telling his tale to Fowler.



1940, no longer working for Uncle Sam, Dr. Gee went to work for a wealthy oil man named Silas M. Newton, an amateur scientist himself. The idea was to use Dr. Gee's magnetic talents for the location of oil deposits. Scully was a friend of Newton's and through Newton he met Dr. Gee and learned of his bizarre experience. As the story unfolded, Scully learned that in addition to the original New Mexico crash, two more saucers had crashed in Arizona and were also in government hands. The second one had come down near an Arizona proving ground and was identical to the first. This one also contained sixteen small corpses, only these weren't charred. The third disc, found near Phoenix, was a smaller two-man job and the two men were as dead as their thirty-two predecessors. Yet another saucer had supposedly smashed into the Sahara, destroying itself on impact.

The scientists found the saucers to be constructed without bolts, screws or rivets. The measurements of all three ships seemed to conform to a "system of nines." The little men were dressed in curious 1890s style blue uniforms with metal buttons. Air Force medics had dissected some of the little fellows and found them normal in most respects, without dental problems, and probably 35 to 40 years old.

Dr. Gee had in his possession some small disks and gears and a cigarette pack-sized radio without tubes or wires (it is worth noting that, while the transistor was invented in 1947, pocket-sized radios made with transistors and printed circuits were not a reality until the mid 1950s). Scully examined these trinkets himself. Also found on the ships were several pictographic



The Mattydale incident occurred sometime in late 1953 or early 1954 in the early hours of the morning. The witnesses, a Mr. and Mrs. Marsden, were driving home after visiting friends. Approaching an intersection where they had to make a turn, they saw the flashing lights of several squad cars. Assuming that an accident had taken place, they made their turn slowly. The Marsdens did not see an accident. What they saw a short distance from the road was a grounded ovoid object about 20 feet wide and 15 feet high. By the bright colored lights which dotted the object they could see several men milling around and examining it, apparently police. Their curiosity got the best of them the next day and Mr. Marsden phoned the sheriff's office, only to be told that the matter was a military secret. Later examination of the scene of the incident revealed nothing but trampled grass and tire tracks.

Early in 1952, the newswires carried a story out of Norway: a smashed disc had been found in the frozen wastes of Spitsbergen, a deserted island in the Arctic Ocean. Norwegian, British and American teams were said to have been rushing to the site. After the initial account went out, there was nothing but silence on the subject. Then, on September 4, 1955, when



the story was all but forgotten, a representative of the Norwegian General Staff issued a statement on the Spitsbergen saucer. Colonel Gernod Darnbyl stated that the board of inquiry which he headed was readying a big report on the crashed UFO. He went on to say that the materials composing the object were unknown to all the experts involved in the examination and that present technology did not permit the unraveling of all the disks' secrets.

The clincher was this unequivocal comment: "It has—this we wish to state emphatically—not been built by any country on earth." The in-depth report was to have been published following discussion of "some sensational facts" with U.S. and British representatives. Needless to say, the big report never followed. The subject was never mentioned again. One wonders if Col. Darnbyl wasn't transferred to Spitsbergen himself after making such rash remarks within earshot of the press.


The mysterious explosion of a UFO above the shallow surf near Ubatuba, Brazil, in 1957, has been well investigated and thoroughly documented by APRO. A fisherman who saw the event recovered some fragments of the disk, which were eventually analyzed and found to be extremely pure magnesium. A less well-known case of a foundering saucer occurred at Iguape, Brazil, on October 31, 1958: A dozen witnesses were startled at 2:30 in the afternoon by a loud roar punctuated by metallic clangs. In a scene straight out of the film *Earth Versus the Flying Saucers* a wobbly 16-foot silver disk loomed into view over the town. Apparently in trouble, it glanced off a palm tree, which seemed to make things worse. Lunging out over the turbid waters of the nearby Peropava River, the disabled object flipped on edge and slipped into the stream with a loud hiss. Mud from the river bottom billowed up from the area of the sinking as the water seemed to boil.

News of the event attracted an army of investigators although the search did not start in earnest for about a week. Divers combed the spot pinpointed by the witnesses with searchlights, probes, sonar and metal detectors. The search was hampered by the 15-foot deep layer of muddy silt lining the bottom of the lazy Peropava. Two weeks of



intensive investigation failed to locate any trace of the clanking craft.

An injured but still-alive alien was reported to have turned up after another water UFO crash in 1959. Ion Hobana and Julien Weverbergh start out their recent book *UFOs Behind the Iron Curtain* with a science-fiction-like incident which was supposed to have happened in the Baltic port of Gdynia in Poland. Dock hands looked up from their work on February 21, 1959, to see a glowing object drop out of the sky into the harbor. Divers sent down to search for the mystery object came up with an unrusty metal fragment which was promptly absorbed into various channels for analysis. Results of this analysis were not made public. So much for that, what about the battered alien? He was spotted a few days later crawling along the beach in a strange metallic get-up such as a spaceman might be expected to wear. Partially burned and obviously in bad shape, he was taken to a hospital where doctors had a hard time removing the metal suit. When they removed a sort of armband the patient died. The body was sent to Russia. It was





noticed at the hospital that the unfortunate fellow had an unusual number of digits, and his blood and organs were quite different from ours too.

What is going on here? Have there really been this many saucer crash hoaxes? Or this many saucer crashes? If the above cases are not enough, here are a few more:

Late 1940s: A witness sees a disk falling into an Idaho lake and snaps a picture. The photo, which ended up in Air Force possession, shows a blur and a huge splash.

1950: Leonard Strongfield of CRIFO reports in 1955 that he has details of a crashed saucer with dead little men found in Argentina in 1950.

1954: Newscaster Frank Edwards announces on his radio program that AF officials are examining a UFO at Muroc Field (Edwards Air Force Base).

1955: Something drops from the sky in east Hillsborough County, Florida, making a huge hole and starting a "fire that burned 40 days."

1956: Civil Aviation officials confirm reports of a silvery object crashing into Holston Mountain near Bristol, Tennessee.

1964: Newsmen in Alamogordo, N.M., start fevered speculation that AF brass have a UFO stashed at Holloman AFB. Someone had monitored base communications regarding a UFO discovered on the ground at the north end of White Sands Proving Ground before all radio communications were cut off.

1965: A UFO passes over Cleveland at around 1000 mph, makes a 25-degree turn and slams into a wooded area 30 miles south of Pittsburgh. State Police and Armed Forces representatives descend on the area.

If we discount some of these cases as meteors (and very few can, by any stretch of the imagination, be

classed as "meteors"), we are faced with three alternatives for the remainder of the incidents. Either (a) all the cases are hoaxes; (b) all the cases are actual UFO crashes; or (c) some of the cases are hoaxes and some are bona fide UFO crashes. None of these possibilities are comfortable to think about. Most readers will agree that we can discard (b) right off the bat. That leaves us with either a large number of seemingly pointless and often very elaborate hoaxes or some hoaxes and some real alien vehicle crashes. A large portion of UFO buffs, students, researchers or what have you will be ready to acknowledge that actual crashes could have occurred and been covered up or discredited by certain (government) groups.

How about hoaxes? Some of the cases could have been private hoaxes such as Scully's tale or Dimmick's Mexican saucer, but to what end? Scully, to be sure, sold some books, but he certainly never got wealthy from the affair. As a matter of fact he was (and still is, with regularity) subject to scorn and ridicule because of his book. He has gone down in UFO literature as one of the first great liars in the field. Likewise Dimmick, who as an established businessman had nothing to gain and everything to lose by telling such an outlandish tale to the papers.

Another possibility is government hoaxing. Some of the cases, especially the Kingman, Arizona incident, have all the earmarks of some sort of government psychological test. The glimpsing of a tiny corpse inside a guarded tent seems almost to have been set up for the engineer's benefit. But what would be the ultimate purpose of an extended program of government play-acting on this theme? Manipulation of public thought and opinion, of course, but what would be the desired end product?

There is another possibility by which all or most of these strange cases could be hoaxes. Suppose the saucer crashes are staged by whatever is behind the whole UFO mystery. More thought these days is being given (most notably by John Keel) to the concept of a collective "phenomenon" behind UFO, poltergeist, occult and related activity. Whatever "its" purpose, perhaps it also periodically produces saucer crashes, even down

to small alien corpses in some cases. Suppose also that the little men and maybe even some of the saucers behave like the often-reported "angelhair" and simply fade away after a while. Government scientists would be reluctant, to say the least, to discuss something like that with the general public. ●

# UFOs In Communist Countries: Soviet Plot Or Alien Warning?



While it is not commonly known, there are many UFO landings in Iron Curtain countries. The most important question concerning these landings would seem to be whether they're just a communist plot to scare the world or a true alien threat to all mankind!



■ On March 29th, 1976 at 7:15 p.m., ten children from Scaieni, Romania observed an impressive aerial phenomenon for approximately one full hour. Cotovanu gheorghe, fifteen years old, stated: "While walking with my schoolmates from school to home I saw some strange lights on a hill directly in front of us. the phenomenon I observed was in the western horizon and it moved around in a large area of the sky. At first, I thought that they were the headlights of a truck, but these lights were much too large for that

distance and they were too close to one another. Also, they were about fifty meters above the top of the hill (hill was 500 meters altitude). these lights were orange and made no sound."

"The lights moved simultaneously," said fourteen year old Duma Gheorge, "then they disappeared at a great distance. At times, only one light of red color appeared. It moved around and then back to its original position and then disappeared. Then, there were two orange colored lights again which were identical to the

first lights observed. This display of appearances and disappearances and changing of colors continued for about fifteen minutes. They moved very rapidly, surpassing the speed of a truck or tractor." By holding various coins at arm's length from the eye, the witness estimated the size of the UFOs to be as large as a pea. "Suddenly, after many movements to the left and to the right, the lights enlarged increasingly so that they converged into a large luminous sphere that resembled the disc of the sun at noon. Then, after some



additional irregular movements, it disappeared for a few minutes and then reappeared a bit less luminous." This sphere was estimated by the witness to be as large as a 1.5 centimeter disc held at arm's length. The distance was approximately one kilometer and the elevation of the lights was thirty degrees.

A schoolgirl, Corjos Rodica, fourteen years old, described the event in this manner: "Before it reappeared, there appeared a number of very strong light rays at the back of the hill and after a short while there appeared a bright yellow-orange light. After remaining stationary for a short time, it disappeared and after about five minutes it reappeared again. Then, it changed its color to red and it disappeared and in five minutes it again reappeared but in a new location. when it appeared and disappeared, it passed over the hill (like the arc of a circle). It continued to go lower and lower; I

believe it descended."

Another schoolgirl, Kiss Mino-dora, fourteen years old, described this circular movement in a different manner: "The red light moved to the north, where it became oval in shape. It was red at the extremity and orange at the center. Then it descended behind the hill and it reappeared about two minutes later in the same place. It had the same form (round) and the same color (red) and then moved off to the south. At the same time it rotated, but the color arrangement was reversed, with the red at the center and the orange at the extremity. It moved off and disappeared at about 7:30 p.m. and reappeared at approximately 7:40 p.m. Prior to this 7:40 p.m. appearance, some very strong light rays were seen and then the object repeated the same movements described above, only this time much more quickly and in a zig zag motion. It then did not disappear at the back of the hill as it had done the first time, but

instead it moved off to the south becoming smaller and smaller until it was impossible to see." In quick succession, fourteen year old Moraru Constant added: "Soon after this, there appeared two small orange red lights. They were initially stationary, and then they disappeared after a few seconds and reappeared in another location. Once again, they converged and became one and formed that bright light which was at the back of the hill. Then it disappeared and reappeared again only this time they were back to being two lights of a smaller dimension, not one light of a large dimension and these two small lights descended in a zig zag motion to the foot of the hill, where they remained stationary for a few seconds and then disappeared. Five minutes later, only one small light appeared over the woods. It remained stationary there and was still there when I left to go home."

Lastly, eleven year old Dordea Sanda declared: "On the evening of March 29, 1976, I observed a light that resembled a car headlight at a distance over a hill in the western sky near the Teleajen River. It changed its position in the sky constantly. The first time I saw it, it was over the hill, then it appeared to the left and then it descended to the ground near the river. It remained stationary for about five minutes and then ascended and disappeared in a few seconds leaving a long smoke trail behind. Before it disappeared it changed color from red to red-yellow. I was all alone when I observed this object because I was returning from the woods.

Others who observed this aerial display were Dita Valerica (11 years old), Stanila Maria (11 years old), Hromei Dina (14 years old) and Bitu Niculina (11 years old), all of Scaieni.

The weather conditions during the time of the sighting was as follows: clear sky, no precipitation, twilight, almost no wind and the temperature was approximately ten degrees Celsius. No sound was heard by any of the witnesses


during the entire observation, nor was there any visible means of propulsion noted.

#### WHAT WAS FOUND ON THE INSPECTION OF THE FOOT OF THE HILL MENTIONED?

On the following day (March 30th) the students decided to relate what they had observed the previous evening to their teacher, Mr. Balan Cristian; they had already told their parents about the incident. Mr. Cristian has had a keen interest in the UFO phenomenon for many years and has investigated several cases in the Prahova district of Romania. After thoroughly questioning all the children on exactly what each observed and where, Mr. Balan decided to visit this area to investigate the possibility that there might be a landing trace there. However, he had to wait until April 3rd before he could make this examination of the area.

On that day, Mr. Balan went to the place designated by the children. There on the slope of a hill was a strange burn mark, almost round with a diameter of about five feet. All of the grass inside of this round mark was completely burned to the ground, while the grass just outside of the blackened area was burned or scorched only on the upper portion, giving the impression that whatever caused this to occur could have been something similar to a "hotexhaust" which did not extend below the uppermost portion of this grass. There was absolutely no indication that this area was produced by ordinary means. Mr. Balan did recall that the children reported to him that at least some of them observed a smoke trail before the final disappearance.

The exact location of this burned area was on the second rung of the hill and interestingly enough only 267 feet distant from a high voltage line. (see photo). The capacity of these lines are 20,000 volts. It was impossible to find out if there had been any unusual draining of those power lines on the evening of March 29th that could be



connected with the actual observations.


Another very interesting aspect of this ground marking was that the burnt grass gave off a "very repulsive and stunning odor." The odor could not be detected at any distance from the marking. It was noted that even the ants would not enter this blackened ground. Even the grass which had been affected only on the upper portions gave off this same pungent odor which was impossible to compare with any other foul smell.

As for any holes or impressions either in or outside of the burned area, there was none to be found. Perhaps this object never actually settled on the surface of the ground but only hovered slightly above it, close enough to burn the area directly under or close to wherever exhaust might be emitted from a "take off." Mr. Balan did gather soil samples from inside the burned areas as well as samples of the soil from well outside it. The analysis of these soil samples has

not yet been completed as there is no funding from any source in that country to pay for such tests. Therefore, the expense must be incurred by Mr. Balance and to date he has not been in position to have this analysis performed.

As a precaution, Mr. Balan only handled these soil samples which he took from the affected soil with his right hand. Approximately one hour later, the palm and the fingers gradually became swollen and red — damage similar to a very bad sunburn. For some time, Mr. Balan had an itching sensation, first on the fingers and then on the palm. He also experienced some severe headaches that day. Because the hand condition disappeared after only a "few" days, Mr. Balan did not consult a doctor on the matter. Had he done so, it might have given us a clue to the type of heat or radiation it would have taken to cause this effect to the hand used to collect the soil samples.

Since no gieger-counter was





available to Mr. Balan and he did desire to check for possible radiation in the area, he employed the use of unexposed photographic film placed in a sealed container. By placing this container on the burned area and left it there for forty-five minutes. It was later

determined that indeed the area was radioactive as the film was strongly affected in the manner in which radioactivity is known to affect photographic film. How much radioactivity was present on April 3rd is only a matter of conjecture, but radiation was

present and we must ask why *it* would be present especially if it were a trick of some sort.

The final item regarding this blackened mark is that, as on June 11th of this year, the grass was again growing and at a much more rapid rate than the grass just



outside of the affected area. Why, we must ask ourselves, would this new grass grow at this greater rate than the other grass? Perhaps, once the analysis is performed on the soil samples, we will have an idea what is causing this increase in growth.

The case remains open until the proper analysis is conducted on the soil taken from the site. Until those results are known we can only surmise that some unusual, unnatural and possibly extra-terrestrial source caused this ground to be affected in the manner that it was.

Going back in time only a few years, we find that in 1972 there was yet another possible UFO landing in Romania. Between midnite and 1:00 a.m. of the night of September 27th-28th, an unidentified flying object was sighted near the city of Posesti in the Prahova district of Romania.

The lone witness to this appearance was a night watchman for the C.A.P. Company of Posesti. His name was Vasile Carabus and at the time of the observation, he was located on the slope of a hill called Tabacioi Hill, which is directly south of the village of Valea Plopului. His location that night was two kilometers southeast of the purported landing site.

Mr. Carabus described what he observed, "I saw a bright object in

the sky, like a very bright star with a tail of some kind. This 'star' had a diameter slightly larger than Venus and a burning tail of about two meters when it moved. I first noticed it in the northeast sky and after remaining stationary for a short while, it began to descend slowly at a forty-five degree angle until it disappeared from my sight at a place called 'La Odaia'. During the entire time I watched this thing I heard no sound at all, nor were the animals in the area in anyway disturbed.

"I didn't pay much attention to this event and I didn't mention to anyone what I had seen. It was not until three days later that I heard the news about the markings and disturbed ground that was discovered at La Odaia. That is what made me decide to tell what I had seen, as there might have been some connection involved."

The first to discover the strange markings and the impressions in the ground were the people of Valea Plopului. The area is cultivated with corn and some apple trees. Professor Turcu and two local farmers, Aurel Dumitru and Vasile Nicolae examined the site. Also, Professor Elena Nedelea and her students found this site while on an agricultural practice and they were very puzzled by what they found. After the site had been visited and trampled on by several hundred people, the Autumn rains came and it was not until November 28th of that same year (1972) that a serious investigation was begun. The first photographs of the markings were taken on December 1st of that year. It was a real tragedy that two full months had passed since the initial observation and discovery of the site to when a serious investigation was started.

#### WHAT WAS FOUND AT THE SITE?

The corn stalks were crushed to the ground and torn to pieces. They were thrown radially around giving the impression that whatever crushed the stalks was probably rotating at a high speed in landing or in taking off, or both. There were three trapezoid shaped depressions found.

Each was 1.5 meters in length and each was exactly 120 degrees arc distance from one another. It was estimated that the weight of the object supported on those three

traces was at least several tons but again, it was impossible to determine if this ground impact was the result of only the weight of the object itself, or because of the impact was the result of only the weight of the object itself, or because of the impact made in the landing or take off. there is no trace of any burnt or scorched areas at the site.

Even though the ground at the site was quite inclined, the area which is bordered by the depressions was torn and settled to make it horizontal platform between two power lines of high voltage (voltage (voltage capacity unknown). These high voltage lines are located at one hundred and thirty-five meters distance from the site. One is directly to the north, while the other is directly to the south. Both lines run east and west. The site is only two hundred meters north of a country road that connects Posesti with Starchiojd.

If the three trapezoid markings are connected with an imaginary 120 degree arc, the result is an area with an approximate diameter of 4.5 meters. In the very center of this area is a hole (see photo) which is carrotshaped with a diameter of 14 centimeters across the surface opening and extends down two meters to a point. The site is situated in an area which is bordered by three apple trees, two of which were five meters distant and one which was seven meters distant from the center hole. The information I received on this case included no mention of damage or deterioration to any of these trees on the perimeter of the site. There was also registration of light radiation at this site.

The radioactivity detected was gamma rays. The reading was eight milliroentgen per minute. This is light radioactivity, but the question remains why is there or was there any radioactivity in such a remote location. Also, it should be remembered that this testing for radioactivity was not done until two full months after the sighting and after much rain fall on the area.

All things considered, there is no other explanation for these "ground markings" except the possibility that a UFO did land on this spot on the night of September 27th-28th of 1972. I remain open to ideas on the origin of this find at "La Odaia," but for now I would say the facts point to a UFO landing. •





which even thirty years has not been identified.

**August 15, 1950. Great Falls, Montana**

Eight weeks later over Great Falls, Montana, the first color motion picture film of not one but two objects was taken. The photographer was Nicholas Marianna. Marianna was preparing to film a baseball game when he noticed two bright objects flying overhead. Immediately he grabbed his camera, and began filming. He took a total of 24 feet of film. Despite exhaustive photographic analysis of the Montana film, neither the Air Force nor skeptics have ever been able to come up with a valid explanation for the two objects that Marianna filmed.

**July 2, 1952. Tremonton, Utah**

Two years later, Warrant Officer Delbert C. Newhouse captured a fleet of UFOs with his 16 mm camera. The objects in Newhouse's film flew in formation, and were identical to those in the Great Falls, Montana film. After exhaustive frame by frame analysis of Newhouse's footage, the Air Force had to admit that they had something on their hands that could not be explained. Though they never went any further on this case at all.

**July 29, 1952. Miami, Florida**

Using 16 mm film exposed at 24 frames per second, Ralph Mayher obtained excellent footage of a high speed UFO. Calculations by a physicist at the University of Maine, revealed the object to be 27 feet in diameter and travelling about 7550 miles per hour. Mayher retained five frames of his film for personal study, and sent the main portion to the Air Force for further analysis. The film was never returned, and later the Air Force *denied* ever having it! Apparently, the film was so important that a CIA agent by the name of John Haren tried to silence Mayher. Enlargements of the few remaining frames, show the object to be a fiery-looking circular craft, symmetrical, with projections extending from each side of the object.

**August 1, 1952. Wright Patterson Air Force Base, Ohio**

Two jet interceptors chased an Unidentified Flying Object over Wright Patterson, with one of the planes obtaining gun camera footage of the craft before it disappeared. 

later rejected since the so-called "balloon" managed to outdistance the two fighters!

**November 16, 1952. Landrum, South Carolina**

At approximately 5:00 P.M., hundreds of people near Florence, South

Carolina, had sighted a large disc-shaped UFO. Nearly six minutes later, a group of round, glowing objects were sighted over Landrum. Mr. David S. Busch, one of the witnesses, took 40 feet of color film using an 8 mm camera with a telephoto lens.

The film was submitted to the Air Force for examination, but no information about it has been released.

A cursory analysis of the film indicates that it is probably authentic.



**August 12, 1953. Ellsworth Air Force Base**

Two jet fighters chased a flying saucer for several minutes which later turned around and followed the two planes *back* to the air base. During the course of the pursuit, the ob-

ject was filmed by gun cameras. Mr. Lawrence J. Tacker, then spokesman on UFOs for the Air Force, stated that the film had been viewed and all subsequent data had been checked, and the case was still unsolved. As in other gun camera incidents, the film

has *not* been released for scientific analysis.

**August 31, 1953. Port Moresby, New Guinea**

Mr. T.C. Drury, then Deputy Director of the Civilian Aviation Department, obtained motion picture film of a UFO at a high altitude leaving a clear vapor trail. The object climbed steeply and disappeared. Mr. Drury turned his film over to the Commonwealth Security Branch, who turned it over to Wright Patterson Air Force Base in Ohio, and the film has never been seen since!

**June 30, 1954. Scandinavia**

Three airplanes carrying scientists, newsmen, and numerous other observers, were flying near Liffjell, Denmark, on an expedition to study the total eclipse of the sun. At 2:17 P.M., two shiny discs were noticed flying past the planes and were witnessed by about 50 people on the three aircraft. John Bjornulf, chief cameraman of the expedition, managed to obtain approximately two seconds worth of motion picture film of the two objects with his 16 mm camera. The film was reportedly shown on American television in December of 1954.

**September 18, 1956. California**

Mr. Ray Stanford using a Wollensak 8 mm camera with telephoto lens, shot six feet of film of a tiny flickering object moving in and out of view. No other information is known.

**December 1, 1957. Los Angeles, California**


Mr. Ralph Benn was alerted by his son that there were some strange objects flying around in the sky. When Benn ran out, no objects could be seen. A few minutes later, Benn noticed six objects flying in formation, moving slowly west in the northern sky. They were oval in shape and dull white. Benn obtained approximately 6½ feet of color 8 mm film using his Keystone Capri camera. Four sizable, but undefined blobs of light show up on the film.

The footage was developed and analyzed by the Air Force which claimed that the objects were weather balloons. The only problem with their explanation, is that they failed to explain how four weather balloons flew *against* the wind, traversing the sky from horizon to horizon, and maintaining a different pattern with each pass.

**January 3, 1958. Hawaii**

At approximately 4:00 P.M., Mr. Cliff DeLacy took 90 seconds of 8 mm color film of nine UFOs flying in formation. A cursory analysis of the film showed that the objects were of





unknown origin, and were travelling about 900 miles per hour.

**July 28, 1959. Corpus Christie, Texas**

Mr. Ray Stanford and a friend took two motion picture films of an alleged Unidentified Flying Object. Mr. Stanford, using a K-51 Executive camera with a 75 mm Kern Yvar telephoto lens, obtained nearly 70 feet of color film. Though the object was allegedly filmed by two witnesses, neither of the films clearly show the object in question. According to Mr. Stanford, this was his second sighting.

**February 9, 1959. Imperial Beach, California**

At 4:20 P.M., Mr. James M. Purdon, an engineer with a west coast aviation company, obtained several feet of color film of a bright object with a halo around it. Because of the fact that the film contained a lot of personal scenes in it, Purdon would not permit the film to be submitted for analysis.

The sixties brought even more UFO films than during the fifties.

**April 11, 1960. Hazel Green, Wisconsin**

Miss Mary Jo Curwen, using an

8 mm camera, obtained several feet of color motion picture film of three UFOs oscillating in flight. Her verbal account of the incident, however, does not coincide with what the film shows. No analysis has been done to date.

**January 22, 1961. Eglin Air Force Base, Florida**

At 4:45 P.M., while taking movies of his son, Mr. Harry Caslar noticed a UFO approaching from over the water. He managed to obtain footage of the craft with his 8 mm camera. The film reportedly shows a cigar-shaped craft making a U-turn and receding out over



ington D.C. to Warrenton, Virginia in a car pool, Mr. Harvey Savage and his companions noticed an unusual object in the sky with an elongated pear-shaped tail. The object appeared to remain stationary until he reached home. When Savage started to film the UFO with his 16 mm Bell & Howell camera, the UFO changed position, then began moving away rapidly. Savage managed to obtain several feet of film showing the object. No definite analysis has been done to date.

**December 21, 1962. Angel Falls, Venezuela**

Mr. Ali R. Diaz was aboard a tourist plane on a vacation trip to the Angel Falls area when he sighted an object rising from the jungle below. Diaz managed to obtain color footage of the object. The film has passed every scientific photographic analysis that it has been subjected to, and constitutes one of the hardest pieces of pictorial evidence for the existence of UFOs. After the analysis was complete, however, the film mysteriously disappeared!

**1965. Central Germany**

Herr Friedrich Steckling was able to obtain nearly 30 feet of color film of a fleet of UFOs. The objects flew erratically at first, and then flew in perfect formation in groups of ten. Since there were trees and other shrubbery visible in the film, a detailed analysis was able to prove that the objects are of unknown origin. The Steckling film provides some of the strongest photographic evidence for the existence of UFOs.

**April 1, 1966. Cannock, England**

Joan and Thomas Oldfield were flying aboard a British Airways jetliner when Thomas noticed a strange object flying near the right wing of the plane. Quickly, he removed his 16 mm camera, and took several feet of color motion picture film. An exhaustive analysis of the film has revealed it to be unquestionably authentic, and it, too, provides some of the strongest photographic evidence for the existence of UFOs.

**April 15, 1966. Santa Catalina, California**

Mr. Leeland Hansen and an associate, were flying in a helicopter when they spotted a bright reflecting disc. Hansen took 11 seconds of clear, color, motion picture film. Exhaustive computer enhancement techniques have also shown this film to be unquestionably authentic. The Hansen film remains the clearest one on record, with the object in perfect view.

**July 23, 1966. Lost Creek, Virginia**

Mr. John Sheets and a companion were driving along a back road on their way to film a baseball game as a favor for a friend. Suddenly the two men sighted a huge flying saucer rise over the top of the hill. Immediately Sheets loaded his 16 mm camera with color film and was able to obtain approximately 10 feet of motion picture footage before the craft disappeared.

One analyst in the Clarksburg, Virginia area calculated that the size of the object was approximately twelve feet in diameter. The Lost Creek film remains one of the clearest on record though its authenticity has yet to be conclusively proven.

**March 9, 1967. Moline, Illinois**

Patrolman William Fisher was on duty at 1:30 P.M., when he sighted a bright luminous object flying overhead. Fisher managed to take several feet of good clear film of the craft before it disappeared. After a thorough analysis of the color film, the object has yet to be explained. The Fisher film, too, constitutes one of the hardest pieces of photographic evidence for the existence of UFO.

**Spring 1967. Alberton, Australia**

Mr. Ellis E. Mathews obtained 50 frames of a bright glowing object flying above his house. Though the film was taken at night, the details of the object do become visible when blown-up. An extremely scientific analysis of the film strip has revealed the object to be of unknown origin. Consequently, this film constitutes some of the hardest evidence around for the existence of UFOs.

**November 1, 1967. Sonora, California**

Though the object was not visible to the film crews when the footage was originally taken, a single bright glowing object very similar to the ones in the Great Falls, Montana film is visible. On December 27, 1967, the same film crew managed again—by accident—to film another strikingly similar object. The Colorado Condon Committee concluded that *both* films were not hoaxes, but declined any further comment on the two films.

**December 7, 1967. Torino, Italy.**

Mr. Alberto Bomini was out filming shrubbery when he saw an object rise up from a nearby field. Immediately he turned and started filming the object which began to depart rapidly. Bomini was able to obtain several feet of color film of the craft, and the film looks extremely interesting upon

the Gulf. The film has never been available for analysis.

**May 29, 1961. Newark, Ohio**

Mr. Craig Seese and four other witnesses reportedly sighted three glowing objects between the hours of 10:00 P.M., and midnight. The objects were filmed in color by Seese using a Brownie 8 mm camera loaded with color film. A cursory analysis of the film indicates that the objects could possibly be genuine UFOs.

**September 29, 1961. Warrenton, Virginia**

While returning home from Wash-

viewing. A thorough scientific analysis of the footage, however, has yet to be seen.

**Spring 1968. Benedum Airport, West Virginia**

A passenger, while waiting for his flight, managed to obtain several feet of clear motion picture film of an alleged UFO following an incoming plane. The witness used an 8 mm camera loaded with color film. A cursory analysis indicates that the film should be considered dubious. Though a thorough analysis has yet to be done.

**1968. Italy**

A man who prefers to remain anonymous, took several feet of motion picture film of a large, glowing, disc-shaped object. Though his 16 mm film is among the clearest on record, its authenticity has yet to be determined.

As the sixties drew to a close, the number of UFO films also declined. The seventies produced few UFO films.

**December 15, 1971. Oxfordshire, England**

Six members of an ATV film crew, observed a bright glowing object flying overhead. The film crew recorded the object on 16 mm color film. A thorough analysis has yet to be done.

**December 1973. Oakridge, Tennessee**

During the end of the 1973 UFO wave, Howard Whetsel and R. Clough were able to obtain the only known films of a UFO that year. The film sequences cover over 30 sightings for a sum total of slightly over 300 feet of film. The film sequences have been exhaustively analyzed by the National Investigations Committee on Aerial Phenomena and also constitute some

of the hardest pieces of photographic evidence for the reality of UFOs.

One of the objects filmed was 75 feet in diameter, 15 feet high, and flying about 7500 feet in altitude.

**March 31, 1974. France**

Michael Bonne was filming trees in his area when he sighted an oval object descending from the clouds and then returning to them. Though the film looks very impressive upon first glance, its authenticity has not been proved as of this writing.

**June 15, 1974. Prescott, Arizona**

A witness who prefers to remain anonymous, filmed a triangular-shaped object from his backyard for approximately 55 seconds using his super 8 mm camera. According to some preliminary analysis already completed, the film appears to be authentic.

**March 15, 1975. Hinwill, Switzerland**

Mr. Ralph Meier, who has reportedly taken hundreds of photographs of UFOs, claims to have filmed them as well. His 16 mm color film distinctly shows an object alleged to have originated from the Pleiades. Meier also claims to have had over 103 "contacts" with aliens from that same star system. The film is a hoax, and should be considered as reliable as Meier's claims of having gone back in time and photographed dinosaurs!

**December 31, 1979. New Zealand**

News cameramen were out covering a story on UFOs when several men from the camera crew spotted a bright round object flying rapidly across the sky. Immediately they turned on their cameras and were able to obtain several feet of motion picture

film of the strange craft. The film has been exhaustively analyzed by over 20 scientists and it is unquestionably authentic.

In our review of UFO motion picture films, several conclusions can be drawn:

1) There is an abundant number of existing films of UFOs, with a significant portion of them being *genuine*. In the light of this, motion picture films of UFOs should be considered extremely strong evidence for the existence of UFOs.

2) There is a significantly lesser number of hoax UFO films as compared to pictures of UFOs. For example, of the 850 UFO photographs that have been analyzed by Ground Saucer Watch Incorporated, only 49 have turned up as authentic. Thus we find a 95% hoax ratio. However, out of 49 films that are known to be in existence, only 8 have been shown to be hoaxes.

3) The clearest existing authenticated UFO films involve a daylight disc-type craft in the usual saucer shape. However, several of the films taken during the day as well as the night, show bright glowing round objects.

4) There should be a more in-depth study made concerning UFO motion picture films, and concentrated efforts should be made to put pressure on the Air Force to release the known UFO films that still remain classified.

# ALIEN CONTACTEES: WHY ARE SOME PEOPLE CHOSEN?

There seems to be a chosen few earthlings who are in contact with aliens and UFOs. Why were these people chosen and how can you become one of the elite? It's time to find some of the answers!



■ Here and there among the teeming earth's inhabitants are persons who seem to be the recipients of special attention by the intelligence behind UFOs. These persons are not our elite leaders. They are only common folk. Today's pleasure oriented world pays little attention, but these unbelievable experiences have far reaching implications for all humanity.

The eight scattered humans I want you to know about have had a variety of experiences. Let me explain that in these cases and in all others of this nature the search for the truth essentially begins with just the witness and the investigator. We know the true scientific approach is not possible in field cases. I cannot prove or disprove what the witnesses claim they experience with their various senses. So in a sense it's an exercise in futility because no physical proof acceptable to orthodox science ever seems to remain. But in spite of this, I believe we should care-

fully listen to and document these claims by sincere, reasonable people. We should not exclude anything because it is totally unconventional or bizarre. If one blindly examined only the elephant's tail, he would believe it was a snake! Therefore, let us at least listen and see if we can detect any mutual common threads running through the fabric of this grouping of strange claims.

Alan Seaton is a tall, 40 year old outdoors man who lives in Montana. He is a devout Catholic and prays one and one-half hours per day. He is also psychic. Durin 1975 and '76, Montana has been the scene of many UFO sightings. One sunny morning in November, 1975, Alan was climbing a ladder as he worked on his home. He was amazed to see an array of five large, domed discs fastened together with large, flexible hoses move overhead at low altitude. By the time he jumped off the ladder and ran around the house they were out of sight. Prior to this sighting, he had two dreams in which he stepped off his carport in his night clothes on his way to his car to go to work. A tremendous bright light appeared overhead and he found himself being drawn up to it. He remembers no more of the dream. In his life, he remembers one special precognition dream. Both he and his mother simultaneously dreamed that a Navy plane would crash in his back yard, killing two men. Such a plane *did* become lost in a snowstorm and crashed in the backyard of his Michigan home, killing the pilots. I have mentioned



the strange case of Alan Seaton because, although he is not a full fledged chosen one, I suspect that he could become one in the future.

Gene Eagleton, one of Indiana's few remaining indians, has also seen UFOs. However, the sum total of three separate UFO encounters plus a myriad of other related events is enough to send an objective investigator into shock. In 1965, a ball-shaped UFO with a ring around it paced his auto, then landed in front of it on a highway south of Indianapolis. All traffic was stopped, including a preacher's car which came to a stop besides the Eagleton auto. After the soundless craft departed straight up at phenomenal speed, the witnesses drove on to a place called The Pancake House. Here





a terror stricken manner. Followed by his wife and son, Eagleton rush into the back yard to see what was happening.

The witnesses' ears hurt, their heads were numb, their bodies tingling and weak. They fled back into the house. The son, who has *petit mal* form of epilepsy, immediately went into one of his sleep periods. He did not have another spell for four months. This had not happened before. On July 9, I received an excited call from the very agitated witness. The UFO had returned about 2:30 a.m. The effects were about the same, and the kitchen clock indicated that the visit had lasted nearly an hour. His wife was away in the hospital, and he chose not to awaken his son due to his condition. This poor, unfortunate chosen Indian said: "I'll tell you what! I am going to destroy that tree!" (The witness was referring to a large tree in the yard which budded out, then suddenly died after the first craft flew near it.)

"For some reason it hovers around that tree!" I suggest that it may be he who attracts the object, not the tree. Hereplaid, "No, it's not me, it's that tree! And those round and square lights in it, they are like no colors we have. I'd like to have a shirt that color. I watched it — everything just went blank. No thinking power at all! Like you are tapped in the head! You can't function! You just lay there



Eagleton said: "The preacher, he was a God lovin' man. He got into the back of his car and prayed." Frank Edwards, a well known newspaper man was summoned and he took photos of four places on the highway where the tar had melted. On a May evening in 1971, the Indiana State Police contacted me. An identical craft was back at Eagleton's small farm. The large silver craft with white lights on the top and bottom and multicolored lights all around the ring had approached the home, then hovered over the pig pen. A high intensity sound was heard, electric power failed, and an odor Eagleton daid was like Life Buoy soap and linseed oil filled the air. Pandemonium erupted as the pigs, cats, dogs and chickens reacted in



looking! Afterward I was sick for several hours." I suggested that we would like to use hypnosis and try to find out what happened while the craft was there, but the witness dismissed this idea in a bellicose manner. In later months, the witness expressed the desire to move. He had suffered a series of misfortunes, including three auto crashes! The high-pitched sound first heard in 1970 was also heard

after the last sighting. The hens had gone from 70 to 20 eggs per week. Nine pigs had died suddenly, overnight, with only a single tooth-like mark in their forehead. Eagleton said they had no blood in them. Eagleton also claimed a degree of ESP ability.

My next three cases have striking similarities. In each locality, the chosen one met a man-like UFO occupant, disappeared temporarily, and two say they received mental orders from the occupant. Twenty-two years ago a man we



will call "John Smith" claimed that he had mysteriously disappeared for some seven hours. Search parties walked right over the spot where he was later found. Smith now believes that experience is somehow related to what happened to him recently at his home in a small resort town north of Toronto, Canada. Smith describes the spaceman who visited him as looking very much like us, but wearing a fitted red

body suit. The man had no facial features. Smith and his wife describe the UFO he arrived in as tadpole shaped with large windows. Both met the man when he approached their home. Smith and the man communicated by thought projection. Later, Smith found his level of comprehension greatly increased. He found himself responding to mental orders. He felt compelled to go to the local library and take out heavy intellectual and philosophical volumes, which he understood! Neighbors have seen UFOs hover over the Smith home late at night. Many witnesses claim to have seen UFOs in this resort town. Mrs. Smith seems changed, too. One recent evening she informed her husband that something was coming and went out the door. A UFO came by and hovered overhead for about 40 seconds. It shot a beam down on her. She then turned around and came back in the house.

In April, 1964 atop shaped ship with a row of brilliant fluorescent lights around its rim, with a glowing, rounded bottom surface, began to visit the home of Mr. and Mrs. Allen Lund, who live on the side of a mountain east of Rattlesnake near Missoula, Montana. During its presence, no wild game was seen in the area, the stock stampeded to the other side of the property and the dogs rushed into the house. TV reception was disrupted and the oil furnace came on. One evening the craft projected a three-inch diameter beam of light





into the bedroom, at the feet of Mrs. Lund and her daughter, Mrs. Connie Savage. When they got up and walked around, it followed them. During a three-month period the UFO would go away temporarily, and reports of UFOs would come in from other localities. Mrs. Savage's little three and a half year old son Kyle told his mother and grandparents that he talked to a man in the barn. He tried to tell Mrs. Lund the man's name, but it was unpronounceable. He would not take anyone to see the man because, "We don't want you! That man don't like you!" The child would disappear for several hours, then show up as if from nowhere. Each time Kyle went to see the man, the furnace started up and the animals went into panic. Various personal articles would strangely disappear for a short time, then just

as suddenly reappear. Mrs. Savage's sun glasses and several articles of clothing vanished and showed up again in a different place.

Let us move on to our third case, in which the chosen person claims to have experienced things closely paralleling incidents elsewhere which they had no knowledge of.

From 1973 to 1976, southern Tennessee was a hot bed of UFO sightings and related phenomena. Stanley Ingram, a 60 year old former city judge and accountant, and his 14 year old daughter Becky, were two skeptics who were changed by the course of events. What they saw during late night watches from fire towers made believers out of them. Becky, incidentally, exhibits a high degree of ESP.

The UFO contact began as a

jumbled voice in her head. After several days, it came in clearly as she sat in school, frightening her and causing her to disrupt her classmates when she jumped. The voice urged her to walk outside.





Greatly disturbed, she disobeyed it. When the voice began the next day, she summoned her father, who told the principal and took her home. During the next day at school the insistent voice began again, and finally, as she waited in line to get on the school bus, she stepped out of line and walked to the football field. She was nearly across the field when she suddenly found herself inside bright, indirectly lighted room. A large ramp shut behind her with a "woomph." She tried to push it open, but she could not even tell where it had been. Two "men" who were there reassured her that she would not be harmed and instructed her to lie down on a hospital-type bed. Later, these men (who called themselves Alton and Tombo) examined her by moving something like a glove over her body. Her clothing was not removed. She tried to touch one of the men but her hand hit something hard about two inches from his arm. She was told she was being taken for a ride. She had an elevator sensation and heard a swishing sound. As she looked out a window, the craft seemed to pass over a desert, a large city and an ocean. Was all this simulated in her mind or in the window? Often, the truth does not seem to originate with the ufonauts. The two occupants conversed with her in a slightly higher-pitched monotone English. She noticed little movement of their lips. They told

her how long she would be gone and concernedly she asked them if their time was the same as ours. The men sat silently for a moment at the front windshield, surrounded by a console of flashing lights and buttons. Then one said, "Well, we won't say how, but it's different." the men appeared just under five feet tall and weighed about 100 pounds. They wore light grey, silky-looking, one piece suits, which bagged slightly at the knees. They did not seem to bend their knees quite like us. Their slippers had a bright look with turned up, pointed toes.

The occupants had a normal head, a long pointed chin, small ears, mouth, nose and small piercing eyes. The neck was long and the hands were long and graceful, like a woman's, with long fingernails. They were beardless with light hair and pointed sideburns showing under the edge of a stocking cap. After having been missing for over an hour, as near as her father could figure, the witness was let out again at the football field. She went down the ramp and hurried away but looked back to see a white, smoky, tank-shaped object about 45 feet long go up and vanish almost instantly. She also mentioned something about a pink color but it is not clear what she was referring to. As far as could be learned, three milk truck drivers at a plant near the field did not see anything. They did see Becky walk out of the field and sit

down on a nearby sidewalk. This chosen one's immediate physical reaction was confusion, fright, weakness, nausea, a desire for sleep that caused her to sleep in school and for hours at home, a kidney problem requiring frequent urination and dizziness. She fainted on stairs the following Saturday. Perhaps the greatest effect was her abnormal sleepiness. She was taken to a doctor and her father told him what had happened, but of course it was not believed. This event was only the beginning of a series of unbelievable experiences this person was destined to see. The events are so mind staggering few can believe them.

My last two chosen ones seem to demonstrate the different results that can follow UFO contact. Both Rachel Baker in southern Indiana and John Grey in central Indiana have above average ESP. Mrs. Baker's probably even surpasses Becky Ingram's due to her 56 long years of experience. Mrs. Baker, a devout Baptist, has for years regularly prayed at a certain place on her farm. In November 1966 and February 1967, she was followed by a UFO as she drove to her isolated home late at night. On the night of December 6, 1967, a large, orange, saucer object moved overhead, and she heard a humming sound and felt heat. The witness was paralyzed until her levitated auto rolled to a stop six



miles down the rural road. She then fell into a deep sleep and didn't know what happened or how much time she lost. At home she wanted to vomit, hurt badly in her neck and spine, and had bright spots before her eyes. Her entire body was swollen and covered with many little rust-like spots, the windows leaked, the water hose burst, and the battery and radio quit! Shortly after this event, and continuing for years, Rachel began to have some very strange nighttime sleep episodes with little people who greatly resembled the Trolls of Scandinavia. In case you are wondering, Rachel is a very sane and sensible woman. I should know. I spent nearly a year interrogating her. Her problem is that she is psychic — and has been chosen.

Our last selected earthling, John Grey, had about a dozen UFO sightings since a night in 1966 when he ran toward an orange glow that turned out to be a large, black, disc-craft. Later the same year, a disc hovered about 100 feet overhead after he had gone outside in response to a "mental urge." The object moved out of sight shortly before three jets arrived from Grissom Air Force Base. In one vivid dream, Grey found himself in a brightly lighted room where many colored lights were pulsating nearby. The occupant was shorter than Grey, with a large, grayish-white head and no hair. His big slanted eyes seemed to look through Grey. Mentally, he said: "I'm going to have to get you home. We have talked for a while but soon you are going to have to go to work, and I don't want anyone to miss you. I'll get you home on time so don't worry about it." This chosen one has not been able to recall much of what happened. Grey's most extreme experience was when, while accompanied by four others, he witnessed the appearance of a giant ape-like creature!

In this very limited look at those special persons whom I call "the chosen ones," have any common characteristics shown up? Yes! It would appear that a large percentage of these persons have above average ESP. Both the quality and quantity of the sight-



ings may be proportional to their psychic ability. Let me hasten to add that I'm not saying only psychic persons see UFOs. Far from it! Many thousands of ordinary citizens have seen UFOs. I am also aware of some two dozen psychic persons who have had no experience with UFOs. Several of our subjects suffered falls which knocked them unconscious, but this does not seem to be a constant



factor. It is tragic that a substantial number of these persons, who have had repeated encounters with UFOs, cannot be assembled at one special center where they would be thoroughly examined by parapsychologists and psychologists using all the latest devices and techniques now available. If this could be done with an open minded approach, we may be surprised at what we might learn. ●
