


# EDITORIAL

Of those who reported close encounters, through the years, many have given proof, by their own testimony, of the account of Antonio Villas-Boas. # THE FASTEST GROWING CHURCH IN THE WORLD

It's quite safe to say that of all the organized religious sects on the current scene, one church in particular stands above all in its unique approach to religion. The Universal Life Church is the only organized church in the world with no traditional religious doctrine. In the words of Kirby J. Hensley, founder, "The ULC only believes in what is right, and that all people have the right to determine what beliefs are right for them, as long as they do not interfere with the rights of others."

Reverend Hensley is the leader of the worldwide Universal Life Church with a membership now exceeding 7 million ordained ministers of all religious beliefs. Reverend Hensley started the church in his garage by ordaining ministers by mail. During the 1960's, he traveled all across the country appearing at college rallies held in his honor where he would perform mass ordinations of thousands of people at a time. These new ministers were then exempt from being inducted into the armed forces during the undeclared Vietnam war.

In 1966 Reverend Hensley was fighting the establishment on another front. The IRS tried to claim the ULC wasn't a legal church and proceeded to impound the ten thousand dollars in the church bank account. The feisty Hensley filed suit against the IRS in federal district court for return of the funds and to permanently establish the ULC as a legal tax exempt entity. On March 1, 1974 Judge James F. Battin ruled against the IRS in his decision which stated, "Neither this court or any branch of this government will consider the merits or fallacies of a religion. Nor will the court praise or condemn a religion. Were the court to do so, it would impinge upon the guarantees of the First Amendment." The judge then ordered the IRS to return the impounded money and to grant the Universal Life Church its tax exempt status.

Reverend Hensley has stated that he believes a church is people and not just a fancy building. He also believes in total freedom and equality for all people. The ULC will ordain anyone without regard to religious beliefs, race, nationality, sex or age.

The ULC's success formula is both effective and unquestionably legal. After a person has become an ordained minister, he or she can join with two other people and form their own Universal Life Church. These three people then make up the Board of Directors consisting of a Pastor, a Secretary and a Treasurer. The ULC will then grant the group the use of its legal church charter complete with both federal and state tax exempt numbers. The newly formed church may then open a bank account in the church's name. Any member of the church can legally donate up to 50% of his or her outside income to the church and take a corresponding tax deduction. The church in turn can pay the complete housing cost of its minister including rent or mortgage payment, insurance, taxes, furnishings and repairs. The church can also provide the minister with full use of an automo-

bile as well as pay for travel and educational expenses. None of these expenses are reported as income to the IRS. Recently a whole town in Hardenburg, New York became Universal Life ministers and turned their homes into religious retreats and monasteries thereby relieving themselves of property taxes, at least until the state tries to figure out what to do.

Churches enjoy certain other tax benefits over the common man on the street. For instance, a church can legally buy and sell real estate or stocks and bonds completely tax free. It can receive tax free income from bank deposits or mortgages. Many churches own large publishing, recording, or other related businesses like hospitals, clinics and schools without paying any income tax.

A church can sponsor any kind of fund raising event such as a concert, play or even bingo. Churches are also exempt from paying inheritance taxes. When the pastor of the church dies, the Board of Directors simply appoints a new pastor and the church goes on.

Reverend Hensley has stated that he personally doesn't believe in the tax exempt status of churches. However, if the government is going to give a free ride to Billy Graham and the Pope, then why not let everybody participate in these blessings. Furthermore, he backs his words up by offering to defend in court the tax exempt status of his congregations.

Since the church was founded in 1962, it has attracted members who are movie and TV personalities, businessmen, government officials, lawyers, and doctors as well as all types of regular working people. During the last 15 years the Universal Life church has blossomed into a full blown grass roots populace movement. Reverend Hensley is ordaining ten thousand new ministers a week and predicts that the church will have over 20,000,000 members by the early 1980's. In addition, requests for interviews and TV appearances continue to pour in.

Anyone who is a member of the ULC will tell you that the ULC is destined to change the world. By unifying mankind into a brotherhood of freedom orientated individuals, each respecting the other's right to live life as they see fit, the Universal Life Church hopes to put an end to all wars. Reverend Hensley admits that this is a pretty monumental task to accomplish, but he also points out that he is already well on the way to reaching his goal.

It's a fascinating place to visit, Mr. Goodbin. In fact, once seeing the spot, near Sardine Creek, about 20 miles from Medford, they say you will never quite get over the experience. For in the Oregon Vortex, gravity seems to play strange tricks on the eyes, as well as on the imagination.

The main area of the Vortex, an old wooden shed once an assay office, is its center. In fact, those who enter what is called "The House of Mystery"—the shed—find themselves leaning at an angle of 10 degrees toward the center of the 165 degree circle.

In the area, cigarette smoke makes spirals. Believe it or not, if an empty glass jar is placed on a board sloping uphill toward the center of the circle, the jar will roll uphill. Compasses won't work in the Vortex, and a light meter will register different readings. Birds and animals keep clear of the vicinity, and trees growing there have limbs that droop and lean toward magnetic north.

What's more, if two men who are of equal height stand side by side within the Vortex, and are viewed by a third individual standing a short distance away, one will appear taller than the other.

The Hollow Earth Society, Mr. Mark Warrian, is an international group with over 400 members living in more than 30 countries. The purpose of the group is to send an expedition to find the inside of the earth. According to Albert McDonald, president of the society, polar explorers have returned with stories of warm lands with unusual animals—including the mosquito. Dear Editor:

The joke of the century is the attitude that scientists— especially astronomers—take concerning outer space. **Young, a former aircraft inspector for McDonnell, who had worked on over 8,000 aircrafts during World War II, reported examining at close range, a strange winged contraption which had crashed in Oklahoma on August 15, 1972.**

**While walking out into his cow lot with his dogs, Mr. Young observed a brightly colored object approaching him from the west. The object appeared similar to objects observed before.**

**At the time, Young told International UFO Bureau investigators Daniel Garcia and Vic Johnston, "It was moving about as fast as a man at a fast walk. It slowed down about 50 feet west of me. The object then raised up to come over a fence that was covered with tall**

# UFO Update



## —LAKEPORT, CALIFORNIA

Phones at police headquarters began their incessant ringing shortly after midnight last October 12 from residents who reported seeing burning lights passing over Big Valley at low altitudes.

Although Vandenberg and Travis Air Force Bases were able to shed no light on what the array of eyewitnesses reported, the calls kept coming.

The first report came in at 12:10 a.m. from Lakeport resident Leroy Harris, who said he received a call from a friend on Cobb Mountain who said "some type of burning object" was falling from the sky.

The last report was registered at 12:40 a.m., by pilot Dick Hall, who said he'd swerved to avoid a "bright light" while making his landing approach at Lampson Field. Police logged a total of 26 other calls in between during that time period.

Hall said he was traveling southeast as he was approaching Lampson when he saw a bright light "about a mile away coming straight at me." He brought out that he made a sharp turn west to avoid a collision with the light, and when he came back on his original course minutes later it was gone.

## —TOWNSVILLE, AUSTRALIA

A description of what was said to be a UFO given to police by a 16-year-old Mackay youth was verified by people from areas miles away. Phillip Lawrence of Mackay said he was sitting on the boot of a car when he saw "this big silver ball coming down. It had a red, green and yellow fire behind it."

His report was corroborated by residents of Yarrabah, 1676 kms



north of Brisbane and south of Mackay by 964 kms. A1-1 reports, including one from a Townsville police officer and another from a commercial airline pilot near Palm Island off the coast, were similar in description.

## —ROME, ITALY

Several dozen witnesses said a fleet of UFOs, highly luminous discs emanating blueish rays, has been spotted over Chieti in Southern Italy last September 30.

Flying in near formation from the southwest, heading for the Gran Sasso mountains, the UFOs resembled "flying skyscrapers", according to witnesses.

## —BRUSSELS, BELGIUM

A "round thing that often changed color, surrounded by a ring" hovered in the sky above them for seven hours on October 13, two miles from a Belgian Air Force base.

The Royal Meteorological Institute in Brussels, offered no ex-

planation for the sighting, but said it could not have been a weather balloon, northern lights or other atmospheric conditions.

## —GLADSTONE, MICHIGAN

There was a time when officer Mark Hager of the Gladstone Police Department scoffed at UFO reports. But he doesn't scoff anymore.

Hager and fellow officer David Martin, while investigating reports of a UFO in a lonely spot north of this Upper Peninsula city, saw for themselves a sight for which they could offer no logical explanation. They reported what they saw had a bright white light, two red lights—one on each side—and a green light towards the rear. "As far as making out a shape of the body, we really couldn't tell," they reported. Within moments, Hager and Mar-



tin were joined by two other officers from the Delta County Sheriff's Department and the four men tracked the mysterious object

as it sped west, but lost sight of it after about one hour. Hager said, "I guarantee it wasn't a helicopter or an airplane."

**—STAMFORD, CONN.**

The pulsating ball appeared to hover over the city. Within seconds after it appeared, it was gone. But not for good. In eight minutes it appeared again, but this time far to the south.

George Slovan ran inside to get his family. "It looked like an orange ball," said his 6-year-old son, Joe.

Then the "ball" moved off to the north, diminished as if it were going straight up, and then disappeared.

"Sometimes I feel that Uncle Sam has things going on that he doesn't want people to know about," Slovan said. "They're explained away as UFOs."

As it was, Stamford police faced a busy Friday night last September 15. "It was a full moon," Police Sergeant James West said. "Usually, when there's a full moon, we get all kinds of kooks. But a full moon can't explain the calls we got— 60 calls lit up our switchboards reporting the phenomena, from 8 p.m. until midnight."

Sergeant West also tried the police departments of neighboring towns and was told that a Darien officer had seen what he described as a "Parachute flare" on the northwest side of town, which lasted for approximately 15 minutes. According to reports, it shot all over the sky and shot straight up before it vanished.

Three and a half miles to the north of Stamford, Mr. Stephen Cavanaugh and some guests at his home looked up to the night sky. It



was between 11:00 and 11:30. All saw a red light that seemed to be bright for three to five seconds, dim for one second and then bright again. It was to the northeast and it turned white before diminishing and disappearing, he said. They, too, called the police. Police reported that at that moment their switchboards were lighting up with similar reports.

**—EAST HEMPFIELD, PENN.**

A circular object, white in color with red and green lights hovered over the Cherry Hill Apartments early last October, bringing residents to their windows, gaping skyward.

The sighting occurred at ap-

proximately 9 p.m., last October 20 and was brought to the attention of the East Hempfield Township police, who arrived at the apartment complex to see for themselves what was reported by Mrs. Patricia Lau of 541 London Drive.

East Hempfield Township police officer Harold Gainer said the UFO seen by Mrs. Lau, "Looked like a star to us. We watched it for 10 or 15 minutes," he said. "It was off-white. There was no red in it."

Fred Wolf, 33, of 224 N. Shippen Street, who noticed the UFO heading northwest, toward Centerville, said: "At first I thought it was a plane with

landing lights on." Contradicting the officer's report, he stated, "there was more red in it than anything else." Wolf described the UFO as "moving rapidly, despite its size."

Both Wolf and Mrs. Lau said the UFO was the size of a jet plane. Wolf maintained the object looked as though it was pulsating.



#### —PORT KLANG, S. PACIFIC

Three people told police that a fire which destroyed two houses, was sparked by a laser beam from a UFO.

They said that a red ball of light hovering about 100 feet in the air suddenly shot a bolt of blue light at a home which burst into flames.

#### —QUEENSLAND, AUSTRALIA

An unidentified flying object skimming well over 31,000 feet was spotted by the pilot of a DC-9 last October, and is now thought to have been "space debris" re-entering Earth's atmosphere.

The UFO quickly sped away from the jet and left a vapour trail, according to an RAAF spokesman in Townsville. He brought out that few planes could fly at the object's reported altitude.

According to RAAF officials, the most likely explanation was space debris, such as an old satellite, falling back to earth and burning up in the atmosphere, was responsible.

Earlier speculation that the object might have been an American B-52 bomber, was dismissed.

#### —PERTH, AUSTRALIA

Four circular marks on the edge of a paddock on Eric Parker's property at Ogilville, may have been left by a UFO. The marks, 13m in diameter, 10 centimeters deep, and evenly spaced at 8.7m apart are embedded in a soft barley paddock, and rock-hard. "Whatever made them would have to weigh over 100 tons," said Parker, who brought out: "We drive an 11-ton truck loaded with seed and it doesn't make marks anything like these. Whatever it was couldn't have been man-made."

Kevin Chick, a farmer on a nearby property, said he saw a light rising from the ground on the Parker property on October 13, two days before the marks were discovered.

Said Parker: I don't know of anything the Russians or Yanks have that could have done that. I never believed in UFOs before, but I do now. My brother and I discussed whether we'd say anything about this and I decided I'd go cucoo if I didn't try to find an explanation or find out if anybody else had seen anything."

Mrs. Marlene Parker said: "It's

very scary. We would just like to know what they are."

#### —ROMEO, MICHIGAN

A large, unknown aircraft with numerous flashing red lights, hovered over Bruce Township for three hours last September 30, and according to Michigan State Police, it was the second sighting in a year.

The first sighting, in late February, was reported by two men who were camping in Ray Township.

This time, Dave Edwards reported a large unknown aircraft with numerous flashing red lights hovering over Bruce Township, two miles northeast of Ray. Edwards told police that he estimated the aircraft's speed was 40 miles per hour. He brought out that it was able to change directions rapidly, and had a green spotlight.

Edwards, according to the police report, spotted the UFO while driving in the Romeo and Roch-



ester Road area with two passengers identified as Tamara Edwards and Jeff Black, both of Romeo.

Upon hearing of the sighting, police contacted Selfridge Air Force Base in Mount Clemens, who said no aircraft had been sighted on radar in the area.



"It was a nice night to get out," Pozdro said. "I'd been working and wanted to clear my head, and suddenly we both spotted about eight star-like objects traveling in a wide V-formation from east to west, high in the sky, at a tremendous rate of speed.

"It lasted for about four to five seconds, then they dropped behind some trees in the west and we didn't see them again. We called the police station, they said they hadn't heard anything, but gave us a number in Washington to call. Shirley made the call while I waited outside to see if there was anything else."

The number from the police put the couple in touch with the UFO Reporting Service in Washington, a non-government agency staffed around-the-clock by individuals interested in space objects. The Pozdro's told the agency: "These things were simply traveling much too fast and covered far too much area at too great a height just to be some jets."

#### —LODZ, POLAND

A young couple living near the eastern border of Lodz, Poland, says three UFOs hovered over their home for an entire night. The terrified man and woman say they locked themselves inside until shortly before morning when the glowing balls of light mysteriously vanished.

#### —LAWRENCE, KANSAS

It started out as a peaceful walk with their dog on a mild September evening and ended with John and Shirley Pozdro believing in UFOs.

What they saw briefly on their walk has the UFO Reporting Center in Washington convinced it was not from this earth.

Pozdro, a well-known Kansas University professor of music theory, and his wife were walking in the area of their home at 8:00 p.m.



# THE MOST TERRIFYING UFO EXPERIENCE

**“As the alien approached I fired several shots at the figure, but the bullets went right through the creature without even budging it.”**

During August, 1979, the most remarkable UFO abduction in seven years occurred in rural Virginia. This case is particularly significant because it combines aspects of the classic UFO kidnapping with symptoms of demonic possession. Since his abduction, the victim has been visited several times by the same beings, their purpose is definitely malevolent.

Harry Joe Turner is a big man, the kind of person that cannot be easily frightened. The 28-year old, 255-pound truck driver was a Navy sharpshooter and amateur boxer with a record of 24-4. Yet something happened to this powerful man that has totally disrupted his life, and he cannot deal with it.

On August 28, 1979, Harry Joe left Winchester, Virginia, bound for Fredericksburg, an 80-mile trip. He was driving an 80,000 pound, 1974 Kenworth tractor-trailer loaded with ketchup and

mustard. Turner left the parking lot of Bigman's Restaurant in Winchester, stopped at a gas station a block away for a soft drink, then hit the road. It was a few minutes before 11 p.m. He expected to reach his destination within an hour-and-a-half.

“It was a rainy night,” he said. “There was a little lightning and stuff, but the strangest thing was there was hardly no cars on the road. Everything seemed— just deserted.”


Barreling south on U.S. 17; he had just crossed Paris Mountain, only 18 miles into his journey, when he saw the lights of an approaching truck. He called it on his CB radio.

“Hey, southbound 18-wheeler, where you going to buddy?” he asked.

“And from that moment on, it was like I walked through the door right there into another world.”

Suddenly, he heard an extremely loud, irritating sound, appar-

ently coming over the CB, and his truck lights started blinking. He put one hand over his ear in a futile effort to stop the noise. He turned off the radio, but the sound kept increasing, so he took his other hand off the wheel and placed both over his aching ears. Then, from behind, in the rear-view mirror, he saw an intense light, "like from a helluva light bulb," he said. The light, a beam that seemed to be thick enough to

touch, spread over the truck. From that point on, someone else was in control of the truck.

"It was like the whole truck was just floating, like it was being vacuumed up into this thing," Turner said. "Now I still don't know what to call these things, but one of them opened the door and there was another one on the roof."

An invisible "bionic hand" clamped onto his right shoulder,

causing a thunderous pain. "The thing had a grip like steel," he continued. Terrified, Turner had grabbed his 32. caliber pistol which was loaded with eight hollow point bullets and emptied them into the creature that held him.

"I just went blam, blam, blam, blam... eight times, but the gun just seemed to move right through the thing. Nothing happened and

then I started to just fade out. I shouted, 'My God, I can't kill the thing. What the...', and that was it."

The next thing Turner remembered, he woke up at his destination, a warehouse in Fredericksburg. He had no memory of driving there. Also, he was now in the passenger seat, and the driver's door was still locked. According to his watch, it was only 11:17, but it was actually three a.m. His watch must have stopped when the creatures attacked him. His truck is equipped with two mileage gauges. Both indicated that he had driven only 18 miles. Two antennas on the outside of the cab had been burned off.

"After I got unloaded, I headed back to Winchester as fast as I could. There wasn't anything that was going to stop me."

Arriving in Winchester, he checked his fuel gauge and discovered that for a trip of only 97 miles, he had used 114 gallons of diesel fuel, an amount that should have taken him nearly 500 miles.

Since that encounter, bits and pieces of what happened in four hours of missing time have returned. Of the aliens he said: "My best recollection is that they were like you or me, only they were dressed in white clothes like a surgeon. They also had white caps and when they lifted up the fronts of them there were numbers, like identification numbers, written across their foreheads."

Turner said the aliens spoke a language that sounded like Alpha Lazooloo. He could best describe it as a tape recorder played backwards. To communicate with him, the aliens simply spoke slowly. Physically, they were pale and cold to the touch.

He claims that he was taken away from Earth, a distance of 6.8 light years, and returned during those four missing hours. After a great deal of difficult effort, he

further recalled being taken beyond Alpha Centauri, a star familiar to astronomers and only 4.3 light years from Earth. Turner, who had never heard of the star, believes he was whisked to a city 2.5 light years beyond Alpha Centauri. He was also taken for a brief visit to the Moon where the young trucker was shown Neil Armstrong's footprints.

The city he visited had been decimated by nuclear war at an ancient date, and the purpose of the alien's visitation to Earth is to

prevent a similar fate from befalling our planet.

"They want to help us, but they say things have gone pretty far here and that the end is coming soon," the trucker said.

Since his encounter, Turner has been visited by invisible aliens on several occasions. He has also been unable to return to work and has undergone neurological and psychiatric care in useless attempts to help him deal with the traumatic incident.

There have been several appar-

ent changes in Turner— physical, mental, and emotional in nature. He has received great strength in his right arm and has developed an unusual craving for foods he never liked before, like deer, coconut, and bananas. His nerves are shot and the young man relies heavily on sedatives. Turner says that animals act curious around him, and he has fits of hysterical crying from time to time.

"I never used to read anything but the *Winchester Evening Star* and *Hustler* magazine," he said, adding that he now reads at lightning speed, primarily the *Bible* and religious magazines, searching for a purpose for his ordeal.

"The only trouble is that I have to do a lot of the reading twice, once for them and once for me. They're 'using' my left eye to learn about the planet, I think."

He says that a single bizarre thought keeps entering his head: that he should commit suicide. Also, the aliens occasionally pass warnings to him, of what type he will not disclose. He has been instructed by the aliens to find a certain symbol, its importance unknown, within a year.

"Ever since it all began, I've just been sitting here going over and over it in my mind trying to piece things back together. I'd feel pretty good if I could just figure out where I've been.

"If somebody would just come up to me and say I was drunk or something, that would be great because it would give me an explanation, a reason. But I wasn't drunk. Nothing makes sense.

"That's one of the reasons I'm willing to talk about all this. Maybe there's somebody out there who has had something like this happen to them. I need someone to help explain all this to me."

At one time, after the abduction, six of the invisible aliens came to him for what he interpre-



ted as a hostile purpose, and he managed to knock five of them down. Later, he was chased from his home by the invaders, and at another time, left the house and returned shortly so wet that he might have fallen into a lake.

The culmination of all this persecution occurred on September 3, 1979, when he left for a drive and found an alien sitting beside him in the car. The creature forced him to steadily increase his speed until he was being chased by 10 police cars in a scene out of "Smoky and the Bandit" as they rocketed through Clarke County.

"At one point I was doing 110 and I couldn't hold a candle to him," said a Berryville city cop who finally stopped Turner and arrested him on two charges: failure to stop for a siren and reckless driving.


This frightening example of the third kind of close encounters has a decidedly religious overtone. The subsequent visitation by these aliens and their influence on Turner's physical and emotional well-being is very suggestive of demonic possession. He also claims that he is being used to transmit information, and at the same time urged to terminate his own life. The most frightening aspects of these encounters is obvious to a fundamentalist Christian. The first is the string of numbers engraved on the alien's foreheads, which has long been thought to be a characteristic of the Anti-Christ. The second is the symbol Turner has been ordered to search for— which bears a great resemblance to the legendary "Sign of the Beast." Finally, a religious medallion is the only protection he has found effective against the creatures.

This terrifying spectacle, which occurred only 22 hours after a Minnesota sheriff was assaulted by a UFO, may open up an entirely new area of UFO investigation. □

# WHAT ARE EXTRATERRESTRIALS DOING IN ALASKA?

We jumped to our feet and instantly became aware of a giant, sphere-shaped object hovering directly above us, its underbelly pulsating weirdly.




It was Saturday, May 28, 1972, and the spring grizzly bear season in Unit 20 of central Alaska was closing in three days. My friend Paul Miller and I had begged a couple of days off from work to go hunting and had left home at 5 o'clock determined to get an early start. A cold wind was blowing toward us from the southeast, across the bare tundra. The winter snow was gone except in protected draws and under the thick clumps of brush found here and there. We had half waded, half paddled a small boat across the Big Delta River early in the morning and had gotten ourselves

soaking wet in the process.

It was now near noon and we were on top of a small foothill, below McGinnis Peak, overlooking a tundra-covered valley that was drained by Sager Creek. We had stopped to scan the valley when Paul suddenly pointed to the southeast. Through my binoculars I picked up the hulk of a large grizzly bear which had apparently been traveling north along the west bank of the Big Delta River and had now swung out into the valley floor. We studied the bear for a long time through our scope and it finally became clear that he was traveling around the base of

our small foothill. If he proceeded on his present path it would take him within yards of our present position. As the day was half gone, and we had exhausted the energy supplied by our hurried breakfast, we decided to stay where we were, eat our lunch, keep track of the bear, and hope that he would come to within shooting distance of our overlook position. We found a small depression covered over with small thick bushes and settled down, out of the wind, to wait. The late May sun was bright and warm in this protected place so we had

sprawled out on the moss-covered ground and soaked up the welcomed warmth. The wild strawberries were just ripening and we ate and waited, keeping track of the bear's progress every single moment.

Several hours passed and the bear was now only about 500 yards away. He was moving in an unhurried manner and investigating everything he came across. He would stop to dig here, turn over a rock there, but his path would take him less than 100 yards below us in the valley unless he made a drastic change. We now became aware of a small herd of caribou, perhaps 75 animals, located to our left in the valley and feeding their way towards our position, and towards the bear.

As the wind was blowing into our faces from the southeast, the bear was approaching from the southeast, and the caribou from the northeast, we realized that the animals would not get wind of us, nor of each other, and would be totally unaware of any presence until they actually sighted one another. We were now fervently hoping the bear would move within killing range of our rifles before the caribou arrived, but at present he was digging into a mound of dirt that had drawn his attention.

An anxious hour passed and the caribou were now within 500 yards of our position. The bear had left the mound of dirt and was moving, faster than before, directly towards the caribou. We were debating whether the bear was aware of the caribou or not when he raised to his hind legs, sniffed the air on his haunches, dropped on all fours again and actually seemed to try to flatten himself closer to the ground in a half crouch as he moved towards the herd. The caribou herd was now due southeast of our position at about 400 yards and the bear came moving out of a small draw directly below us at about 100 yards. The caribou were now

directly up-wind of the bear and he was intent only on stalking them. Nothing else seemed to matter to him. We had glassed the caribou herd, but it was only spring and their horns were just beginning to grow and were now only blobs of felt on each side of their head. We had flipped a coin to see who would get the first bear and Paul had won. We had decided I would shoot only if the bear did not go down after Paul's third shot, or if he turned to attack, or else if he was about to get away around the hill.

We were so intent on watching the bear and the caribou that we did not notice the cloud bank spilling over the top of Mount Hayes which quickly covered most of the sky. The sun was now slanting in from the far west but the bear was in a perfect spot and had no idea we were there. We were now in prone shooting positions looking through our rifle scopes at the huge bruin. We could also see the caribou in the background as our elevated position gave us a perfect view. Paul asked me to count to three slowly, and he would fire on *three*. As I began the count, a whirring, rustling noise suddenly began and I stopped to ask Paul what it was. He shrugged, smiled, and whispered that it was only the wind blowing a little stronger, so I began my count again.

As we watched through our scopes, the area seemed to get a little brighter but I continued slowly. *One... two...* Now I saw a blue ball of fire drop straight from above, strike the ground among the caribou, and split into many smaller balls of blue fire. Each fragment, as quick as a bolt of lightning, sped straight to a caribou. All of the caribou visible to me through my rifle scope fell to the ground as if struck in the head with an invisible sledge hammer. I quickly looked at Paul and could tell by the expression on his face that he had observed the same thing.

“What the hell was that?” I heard him whisper in an awe-struck voice. We jumped to our feet and instantly became aware of a giant sphere-shaped object hovering directly above us. Not knowing the size of the sphere, it would be impossible to say how high it was, but it gave the impression of being very big... and very low. Perhaps 500 yards or less off the ground. Its underbelly was a dull orange, the color of a red hot piece of iron, and seemed to be pulsating slowly from dark to lighter and back again. As we watched dumb-founded we saw an intense beam of white light flash down from the sphere.

One flash, two, three, and more. As we watched, we became aware that each time the light flashed another caribou disap-

peared. One cow and its calf which had fallen nearest to us, in plain sight, both completely disappeared when the beam hit them. I do not know what kind of thoughts Paul may have had at this time but a sudden fear gripped me and I dropped back to the ground in the depression among the bushes. Paul apparently felt as I did because he wasted no time in following my example. The sphere was still in full view above us and we realized we were no safer in the bushes than we had been while standing in the open.

Paul shouted, “they are going to get us anyway, so let’s protect ourselves”. He then raised his 7 mm Magnum, sighted on the sphere, and fired. The roar of the powerful rifle had hardly died when I heard his 170 grain bullet

“whack” into the bottom of the object. It did not “klunk” as I expected from a bullet impacting on metal, but rather it was the sound a cartridge makes when it strikes a solid block of concrete. Paul fired again and another distinct “whack” resounded down the valley. This is actually all I remember. It seems that a light exploded inside my head and the next thing I remember was being very cold and Paul shaking me awake. It was getting dark which means about 10:30 p.m. in central Alaska in late May. The sun had apparently just set in the northwest but there was still plenty of light to see by. We stood up and looked around. The forgotten bear was nowhere in sight. We could still see many caribou lying on the valley floor where they had fallen and we cautiously worked our way down to them. We counted forty-eight caribou lying dead in an area not much larger than fifty yards square. The animals showed no sign of injury but we noted a small trench cut into the tundra from each dead caribou to a circular hole near the center of the herd. We may have missed a few dead animals as we could not give the task our undivided attention. There was a very large grizzly bear somewhere nearby and a large sphere that was still fresh in our minds.

We climbed back to the top of the hill and after discussing our situation at length decided to camp on the spot until first light and then trudge back to the east side of the Big Delta River. We decided that since we both worked for a sensitive Nuclear project at Fort Greely our very jobs might depend on our keeping our own mouths shut and not telling what we had observed. We made a vow to one another that we would say nothing of what we had seen for the time being.

We kept our word and when the caribou were discovered the U.S. Army was first to be blamed as

kisses were small, playful bites. Villas-Boas believes that her sexual technique and respiration was pretty much the same as an earth-woman.

Does this sound like the work of an over-active, sexually-obsessed, science fiction writer? If you think so, you're wrong. The above scenario is the story of Antonio Villas-Boas, who claims that it is God's own truth. Whether Villas-Boas is telling the truth or not about his 1957 UFO encounter, UFO literature is still sprinkled with alien/human sexual unions.

Dr. J. Allen Hynek, astronomer and ex-UFO advisor to the United States government, lists three types of UFO sightings in his *"The UFO Experience- A Scientific Inquiry"*. To quote him, "Close encounters in which no interaction of the UFO with the environment or the observers is reported can be called Close Encounters of the First Kind... When the reported UFO leaves a visible record of its visit or encounter with human observers, this constitutes a Close Encounter of the Second Kind... Close Encounters of the Third Kind (are) those in which the presence of animated creatures (occupants) is reported."

There have been hundreds of thousands of UFO sightings, with

only a few hundred being Close Encounters of the Third Kind. And, of these, only a handful are what I term Close Encounters of the Fourth Kind... actual physical contact between UFO-nauts (i.e. occupants of UFOs) and humans. And these are the most bizarre of all UFO reports.

Physical encounters with UFO-nauts have been taking place since the early 1950's, with such classic examples as Mr. George Adamski and Mr. Daniel Fry. But, within the past few years, there has been a world-wide wave of UFO abductions.

The best known cases have received wide TV and newspaper coverage, including such classic abductions as Charles Hickson and Calvin Parker in Pascagoula, Carlos Diaz in Argentina, and Travis Walton in Arizona. Though physical examinations were conducted in most cases, none had the sexual overtones that is the theme of the Villas-Boas case.

Even the abduction of Barney and Betty Hill— the best known case of a Close Encounter of the Fourth Kind— had only one incident that could be remotely considered sexual. As reported in John Fuller's *"The Interrupted Journey"*, the only thing close to a sexual nature was when the aliens inserted a needle into Betty's

navel. The purpose of this action in unknown, although it has been theorized that the needle extracted an ovum (egg) from her ovary. But nothing else close to an actual sexual episode marked this 1961 encounter. The same can not be said for other episodes.

Late on a Friday night, in the Summer of 1958, Jason and Robert Steiner were driving home from New York City. On a lonely dirt road, two miles from the main highway, Robert was forced to slow the black Ford he was driving to a snail-pace as the fog became thick as pea-soup. Jason, who had been sleeping during most of the ride, awoke to an odd smell, just as the car reached the top of a small embankment. Before them they saw a hovering saucer with flashing lights about its center. It was then that Jason recognized the smell that prodded him awake. It was the odor of steel when pressed against your nose. They tried to "get the hell out of there" but found their car embedded in mud. Small lights like flashlight beams, appeared before them. Within seconds they saw the bearers of the light-beams— two small, humanoid creatures. What followed was brought out under hypnosis and reported in Malcom Kent's *"The Terror Above Us"*.

Somehow the aliens had put the Steiner brothers into a trance. Possibly the light-beams had a hypnotic effect, because neither remembered anything until they awoke aboard the saucer. Though Jason recalls briefly awaking to feel himself being carried aboard the flying saucer on a stretcher-like contraption.

Jason awoke endless minutes later to a feeling of powerlessness and the inability to see. His first thought was that he had gone blind, but soon realized that he just couldn't open his eyes. As he collected his thoughts Jason discovered that he was flat on his back and quite naked.

The sound of shuffling feet

filtered through the cold, clammy atmosphere of the room. Not knowing what the aliens wanted, Jason decided to act as though he was still "drugged". Considering what followed, this wasn't easy.

The aliens performed a variety of tests on Jason including an examination of his genitals. They raised his penis three times and let it drop gently back into place. Next they held his penis for a prolonged period, examining its scrotal sac. Afterwards, he returned to a trance-like state.

You may wonder how Jason was able to control himself while the aliens were, literally, playing with his penis. This was never covered in Steiner's testimony. A possible explanation might be that Jason was still in a semi-drugged state, though he didn't realize it, and could only feel the barest sensation of being touched.

Robert never awoke during this part of the abduction if such an examination was performed on him. His first conscious memory was awakening, on a bed, in a small cubicle. In the room was only a chair and a tiny table with a bowl of strange fruit. But the chair was more than that... in it sat a nude, beautiful, young woman.

Robert, with an inner feeling of euphoria, asked the woman who she was. Instantly she relayed a story about being captured by the aliens... that she had tried everything but there was no escape. Robert didn't believe her story. It seemed too rehearsed.

Robert felt hungry so he ate some of the strange fruit on the table. Immediately, he developed a drugged sensation. The woman, who also ate the fruit and showed no ill effects, made seductive passes at him, but he refused her sexual invitation.

"You don't," he said, "really expect me to believe they want to watch us having intercourse? Voyeurs from Outer Space?" He laughed at the thought... "voyeurs from another planet".

No. He didn't like the idea of

sexual relations with this woman ...who he believed to be an alien. He felt that having coitus with an alien would be the same as sexual relations with an animal... an act against God. Thus he refrained from such acts and soon fell asleep; only to awake momentarily to find the woman beside him in bed.

Jason awoke in a similar cell, possibly the same one, to find the same table, bowl of fruit, and woman. He also heard the same story from her. Yet, there was one difference between Jason's and Robert's encounter. Jason didn't have his brother's reluctance with the woman; whether she was alien or not. Jason figured that his best bet was to play whatever game his abductors wanted. Even if that included having carnal knowledge of an alien.

The brothers' next conscious memory was awakening in their Ford, over 37 hours after their kidnapping. At that time the Steiner brothers unable to explain the missing hours, and they would remain unaccounted for for many years.

Did Robert and Jason Steiner tell the truth about their UFO experience? Or was their story pure fabrication rooted in their libido?

The next thing she remembered was being awakened by her mother yelling, "Where have you

## A DISTANT SPACE: THE ENIGMA OF HOWARD MENGER

During the 1950s, when contactee lore flourished in the United States, New Jersey introduced Howard Menger to UFOlogical history. Artistic, inventive, and extremely self-confident, Menger presented his controversial claims of alien contact to over one million listeners who tuned in nightly to the wit and acidity of WOR's "Long John" Nebel, New York's best-loved connoisseur of the mysterious and "off-beat." Because of Nebel's popularity, the Howard Menger story spread from coast-to-coast, and evoked a public response which bordered on the fanatical. Volumes of mail from skeptics and hardcore believers poured in daily, some of it supportive, much of it intolerant and critical. Throngs of visitors soon began to flock to Menger's home in Highbridge, a small rural town which was now the focus of mounting curiosity. Those who spoke to Menger were captivated by his charismatic personality,


and were startled by his claims of alien "encounters."

Menger's first guest appearance with Nebel took place on October 30, 1956. Twenty-four years before, as a young boy, he told Nebel, he began to see strange "Disc-shaped" objects cavorting in the sky. The appearance of these objects, he said, led to periodic "Landings" in the apple orchard behind his home, and the visitation by a beautiful woman who engaged with him in a mystical conversation. Wearing what Menger described as "translucent, ski-type" clothing, the radiant blond-haired woman said she had travelled a "long way" to meet with him, and spoke of a "great change" that would inevitably take place on earth as a result of the wasteful wars, torture, and destruction brought about by the "misunderstanding of people." Speaking in a soft, melodic tone of voice, the mysterious woman left Menger with the


promise that he would have many future contacts, and explained that he would be drawn to "Others like himself" who would be selected to act as their messenger.

In 1942, while serving in the U.S. Army, Menger claimed to have encountered three people of "unearthly" origin, who purported to be from the same planet (Venus) as the "visitor in the forest", echoing her concern over growing social and political unrest in our country at that time. Leaving the military in 1945, Menger returned to his former occupation as a sign painter in Washington, New Jersey, some ten miles north of Highbridge. There, in the summer of 1956, contacts with the Venusians became long and frequent, and, according to Menger, glowing "bell-shaped" objects began to land in nearby fields, many of them sighted by neighbors, friends, and family.

In September of 1956, Menger allegedly accompanied the space-travellers on an extensive "trip to the moon," taking a series of Poloroid photographs while he was aboard their alien craft. Hundreds of copies were distributed within the UFO community as tangible "proof" of his journey, but skeptics saw them as another reason why Menger could be labelled an "imposter." The images captured by Menger with his camera were, in most cases, blurred and globular; figures seem disproportionate, while "flying objects" appear elongated and "Putty-like." Menger answered the critics by saying that the energy "field" generated by the alien's craft produced unnatural effects within the camera, and thus "fogged" the film considerably. Skeptics, such as attorney Jules St. Germain, refused, however, to accept this explanation, and continued in their fiery campaign against the beleaguered contactee.

A month following his widely-published "visit" to the moon, Menger met Marla Baxter, an attractive, blond-haired woman, whom he married after divorcing his wife of 17 years, Rose, in 1958. Marla, who Menger believed was the "fulfillment" of a prophecy made by the Venusian girl of his childhood, supported him enormously in his role as a spiritual "counselor", and helped him run his sign painting shop in Somerville.

Despite Marla's constant support, however, Menger found himself troubled by serious personal hardships. In 1957, his 15 year old son, Robert, tragically succumbed to a brain tumor, a condition, which, up until his death, Menger had vainly tried to cure by feeding the boy massive doses of Vitamin C. The death of his father quickly followed, and his business was fast becoming a financial disaster. The manager of one of his largest accounts called to tell Menger that because of

adverse publicity caused by reports of his alleged contacts with extraterrestrials, his services were no longer needed. "If at any time I felt ready to quit," recalls Menger, "that was it."

But while Menger's personal life soured, his fame as a contactee soared. On September 13th, 1958, Menger sponsored the "first Annual East Coast Interplanetary Spacecraft Convention" in Lebanon, New Jersey. More than 1000 visitors from 13 different states gathered to hear Menger speak about the benevolent "space brothers", and to listen to commentary by guest speakers on various "occult" matters. At the convention, Menger repeated his historical UFO claims, and presented slides and motion pictures of his sightings to an audience comprised of both skeptics and firm "believers." In 1959, Menger's book, *From Outer Space To You*, was published by noted researcher and writer, Gary Barker, and enjoyed a small sale of 3,000 copies, making it, at least in the field of UFOlogy, a literal bestseller. A photograph record, featuring Menger at the piano, was subsequently marketed, and purported to be a genuine reproduction of "Saturnian" music. It was entitled "Authentic Music from Another Planet," the long-playing album was originally recorded on Slate Records, and achieved quite a fair measure of success.

By the early 60's, public furor over the Menger phenomenon had almost completely faded out. Menger withdrew with his wife, Marla, into seclusion, and appeared to be abandoning the UFO field completely. Contrary to what was assumed by detractors, Menger had profited very little from his experiences, and was now preparing to devote more time to his work as a sign painter. Meanwhile, Nebel, whose popularity as a talk-show personality had surged on account of Mr. Menger's countless radio appear-

ances, had suddenly entered the competitive medium of television, and asked that the contactee join him on his new program. Menger agreed to be a guest on the show, (making his final public appearance on the subject) and was scheduled to speak along with celebrated contactee George Adamski.

The program opened with an introductory speech by Courtland Hastings, who prefaced an engaging lecture by Adamski who in turn related his own adventures with the "space brothers." Menger followed, but in stark contrast to his former self, *retreated* from his classic views, intimating that perhaps he had *misinterpreted* the nature of his experiences, sending waves of shocks throughout the UFO community. Producer Paris Flammonde described the occasion vividly: "Vaguely, aimlessly, rather embarrassingly, he avoided and vacillated..."

Howard Menger, Saturnian husband to a Venusian traveller in space, friend of extraterrestrials, annotator of 'authentic music from another planet', 'master of teleportation', and saucerological sage *extraordinaire* — recanted! Denied almost everything... His saucers might have been psychic, his space people visions, his and Marla's other planethood, metaphorical. As a matter of fact, so did he retreat from his tales of the unreal, the reality of the immediate surroundings seemed to fade momentarily. If he exuded a sort of translucent indefiniteness when he arrived, he was close to invisible when he left... To this day, the transition of the myth and personality of Howard Menger remains one of the most captivating enigmas of contactology.. Later, according to UFO expert John Keel, Menger termed his book "fiction-fact" (or in the modern vernacular, "faction") and implied in his letters to Gray Barker and *Saucer News* editor Jim Moseley that the Pentagon had given him photographic ma-

# INCREDIBLE INCIDENT AT ANDERSON

I am not a UFO buff. My interest in UFO's in fact runs deeper than that of the usual hobbyist/enthusiast. One day in the near future I may reveal why I follow the UFO phenomenon so closely, but for the moment I wish to state to the reader I do follow it closely. It was because of this interest I became involved in the nation's latest major UFO case.

A friend of mine who knew that I pride myself on keeping current on UFO phenomena telephoned me. She had called me to gloat. "Hadn't I heard the news," she goaded. Of course I hadn't heard any news. My T.V. is broken. I hadn't had a radio on for a while, and I don't take any newspapers. Furthermore, I live far down a dirt road on the side of a mountain in a remote section of North Carolina. I like my privacy, and I don't care for conventional news. I keep up with UFO and other paranormal news through private sources.



"What news," I sighed wearily? I was sure it would be of little interest. She then brightly informed me that a UFO had supposedly landed in the backyard of a man who lived in Anderson, South Carolina, I immediately perked up and pressed her for details. Her information was vague, sketchy, and left me completely dissatisfied.

I debated, forgetting the whole thing was probably a psycho or hoax sighting, but I felt an irresistible urge to delve into the matter further. I took out my Rand/McNalley to find out just where Anderson was. To my delighted surprise, Anderson was just outside of Greenville, South Carolina, and as I live only 40 miles from Greenville, I considered the area to be within reasonable driving distance.

The next morning I burned up the phone lines to get more information before attempting to

drive to Anderson. I called the newsroom of the local radio station, which in turn referred me to the local newspaper. I talked with a young reporter named Tony Kiss who gave me enough information to sufficiently tell me this was a "hot" case indeed. After acquiring the name of the main man involved I called him up and set up an interview. By now it was Thursday, September 18, one week after the original incident. I set my interview date for Tuesday, September 23. The man is Jerry McAlister, who is by now South Carolina's man of the hour.

Tuesday morning came. I was up at 6:30 a.m. An hour-and-a-half later, I was well on the road to Anderson. It was a pleasant morning, the sun glistened off the mountainsides, and inside I was dancing with excitement.

Arriving in Anderson around 10:00 a.m., I plunked a quarter into a pay phone. Jerry McAlister

came on the line and proceeded to give me further directions to his home. Shortly, I was tooling down a small two-lane country road. Jerry had said his was the last house on the left, with all the ham radio towers outside.

I spotted his house. It was a comfortable middle-priced brick rancher. I made a note of the nearness of neighbors. There were three fairly close neighbors as rural neighborhoods go. A trailer house across the road, I estimated to be 100 yards distant, and an immediate next door neighbor about 50 yards distant. The third neighbor was several blocks away.

As I pulled in the driveway, Jerry McAlister came to the garage door supporting himself on two wooden crutches. He invited me into his kitchen where I was introduced to his wife Faye, and then I began to question them

about the UFO.

Jerry was awakened shortly after 4:00 a.m. on that most unusual Thursday morning, I was told. (The official time is 4:20 a.m.) A loud intense sound was the cause of his disturbed slumber. Jerry shook off the sleep-induced grogginess, and reached down beside the bed for his crutches. He needed crutches to get around because he was still recovering from multiple leg fractures sustained in a fall. Bone pinning surgery had been required to mend the breaks so his recovery had been slow. The noise by now had reached earsplitting volume, days were to pass before the soreness would fade from Jerry's eardrums.

Jerry hobbled to the bedroom window, thinking vaguely that a helicopter was crashing in his backyard. A helicopter was the closest familiar sound he could think of to describe what the noise was like.

What Jerry saw when he had reached the window was not a helicopter at all. Hovering just inches above treetop level, in a grove of pine trees behind the house, was a huge saucer-shaped object which pulsed and glowed almost to incandescent brightness. The only color Jerry perceived was white.

"It was a perfect saucer-like shape," exclaimed Jerry, "it was just like some of those pictures you see in magazines or in movies, it was the most beautiful thing I'd ever seen".

Jerry quickly realized what he was seeing was unusual and momentous. He balanced himself on one crutch, and reached across the room with the other to tap his wife Faye, who had not yet awakened. She silently joined him at the window, and after a few moments of drinking in this breathtaking sight, she decided to awaken their five daughters so they wouldn't miss this apparent chance of a lifetime. Their daughters are aged 18, 17, 15, 13 and 7.

Faye crept toward the hallway and had just snapped on the light as Jerry, too late, warned her not to turn on any lights as it might frighten away what was out there. Sure enough, when the hall light came on the UFO began to bank and slowly, silently drift away. Faye quickly roused and ushered her daughters to the rear patio door, so they could at least get a glimpse. Only the oldest daughter was in time to get a close up view. She noticed something the others had missed. She saw a reddish beam of light that flickered rhythmically in and out defining an arc. She said it gave her the impression of things being scooped up.

Up until now nobody had felt fear, only a sense of awe and wonder. As the craft receded into the distance, excitement replaced awe, and bedlam broke out in the McAlister home. Everyone began talking excitedly at the same time. Jerry decided to call the sheriff's department on impulse. He told the dispatcher that a "flying saucer" had landed in his backyard. He was later able to hear the jokes made about his report, being broadcast over the police band on one of his many radio systems.

Meanwhile, the object of all this excitement was now a considerable distance up in the sky. It was once again holding a steady position. Jerry's next door neighbor had been alerted by this time. This neighbor happened to own a rather powerful telescope, which he set up outside. Soon everyone was taking turns viewing the UFO through the telescope. With the aid of the telescope, what appeared to be portholes could be discerned.

Shortly, the deputy sheriffs arrived. Jerry informed them he had heard their jokes about him over the radio unit, pointed to the still quite visible UFO and dared them to joke further. The deputies whipped out field binoculars and took some long looks. Apologies for doubting Jerry were forth-

coming. A radio call was sent out to have the Greenville, S.C. jet airport do a radar check to confirm their visual. Two more deputies and a few more neighbors arrived. The Greenville radar unit reported back a negative reading for the area in question. Deputy sheriffs Mike Burton, Joe Simmons, Roc Nations (and one deputy who remains unnamed) cannot explain what they saw. Their official reports are on file to this effect. The sheriff's department's radio dispatcher, a young woman who wishes to remain unnamed, admitted to the press later in the day that she had stepped outside behind the county jail to look in the general direction of the UFO report. She described a glowing object with flashing blue and red lights, which she said was larger than a star. She isn't sure she was seeing the same object as the Broadway lake residents, where the report originated. Altogether, an estimated 17 persons saw the Broadway Lake UFO in Anderson, before it faded into the dawn sky shortly before 7:00 a.m.

No one had called the press, but suddenly out of nowhere the McAlister home was under siege by the news media. Newspaper reporters were firing questions at Jerry and Faye. Photographers were snapping their pictures. Radio news reporters were taping them. A television crew appeared and began a taping session, and in the midst of this, a rival television crew began knocking at the door. The McAlister's quiet serene life was totally shattered. They are calm good-natured people and have so far managed to take all of this in their stride. Phone calls began coming night and day. Jerry says even the news media from Japan and Australia have called, as well as other places in the world.

By the following day, UFO investigative organizations began calling and arriving at the McAlister home. MUFON and SBI of New York were the main UFO

organizations as well as private investigators have shown up on their doorsteps. Jerry laughed, recalling one man who had so much equipment he had to make four trips to his car.

Radiation readings were taken, as were dirt samples and snippings from the trees the UFO had hovered over. By now both Jerry and Faye were noticing a painful burning sensation in their eyes. They described it as feeling like sunburn. Investigators found the McAlisters did indeed have ocular burns and irritation conjunctivitis. The oldest daughter returned from work also complaining of eye irritation. None of the four younger daughters showed any such symptoms, nor did anyone who merely viewed the UFO through telescopes and binoculars. Only the three McAlisters who had gotten the close up view suffered the burns.

The field investigators, with radiation detection equipment, found abnormal readings in the area below where the saucer had hovered. Readings of 2.8 roentgens were detected on and around a pile of firewood 75 feet from Jerry McAlister's bedroom window. Further back into the grove of pine trees, a reading of 2.10 roentgens was detected around two old refrigerators Jerry was planning to use in raising his own fishing worms. The refrigerators are approximately 300 feet from the rear of the McAlister home.

When questioned further about the size of the unidentified craft, Jerry replied that it appeared to be two stories in height and 70 to 80 feet long. "It was perhaps the size of a small office building. It was definitely larger than my house."

The question comes to mind: why Jerry McAlister's house? it is a rural area, but too populated to be considered remote. Broadway Lake is 3 to 4 miles away, and although it has a hydroelectric dam, its distance from the McAlister house rules out the almost


legendary attraction of UFO's for lakes and dams. Jerry said that someone he doesn't remember suggested the numerous ham radio and CB towers were the attracting factors. Jerry adds here that for several days after the UFO hovered over his yard, his radios were non-functional. Also the clocks in the house, that are battery powered, stopped for a full 45 minutes. The electric clocks were unaffected as were the automobiles.

On Monday following the incident, a neighbor from one nearby street phoned the McAlisters around 9:00 p.m. She told them to grab their binoculars and get outside, for there were two more strange, twinkling, pulsating, objects hovering over the area. Again the county sheriffs were called. The sheriffs again contacted the Greenville radar station, but this time they were told a formation of 7 military aircraft, were on maneuvers in the area. The two new objects were in sight for over four hours. There have been no further sightings since. A rash of crank reports have been coming in to the local news media, one crank claiming a UFO lands in her yard every night.

Jerry McAlister and his family are not complicated people. They are ordinary everyday solid citizens. None of the family drinks nor takes drugs. Before the UFO disrupted their lives, they never gave any thought to unusual phenomenon, other than to disbelieve. One sister-in-law of the family is an avid believer in UFOs, and they always made fun of her, now they take what she says a little more seriously. Jerry has decided to never discount anyone again when it comes to the unusual. He now believes UFOs exist.

There is no doubt in my mind that the McAlister's saw something. Was it a spacecraft from another world? If so, what was it doing in the McAlister backyard?

To investigate thoroughly any of the highly publicized UFO abductions and kidnappings, one must search recorded history.

One must analyze all possible UFO activity, from thousands of years to the present, that has occurred in China, India, and Africa, as well as North, Central and South America.

look exactly like men of earth, descending from "heaven" or space.

In Hebrews 3:2 it states: "Be not forgetful to entertain strangers, thereby some have entertained angels unaware." These "angels" seemed to be friendly. Logical analysis reveals that if these space-men look like us and can live here undetected, why would they abduct us and subject us to lengthy medical examination and the like, since we are no different in appearance than they? And surely, if we have been entertaining strangers unaware for over two thousand years of

recorded history, those strangers certainly have had the opportunity to learn about the earthman's body long ago, should they have had the need or desire.





hours after they should have run out of fuel. Examination showed that the fuel tanks were indeed empty, as they should have been.

Life has become increasingly complicated both economically and politically, and there exists great panic amongst those in power. All technical, economical, and spiritual progress is under their positive control.

They used fertilizer and produced 30 tons of produce per acre. The farmers who had been contacted and given this secret of high production, produced 106 tons, without the use of fertilizers. # UFOLOGY'S LAND OF MYSTERY

Once a year— in the fall— the flat pampas south of Buenos Aires— is the scene of the Argentine finals— a 39-day stock car race in which scores of racing drivers soup up their hot-rods for the miles jaunt over a hazardous obstacle course, each desirous of the grand prize.

At 4:30 a.m. last September 23, Carlos Acevedo and Angel Moya were fast approaching the final leg of the competition, their racing car zooming over the endless track.

Suddenly, the duo had noticed something in their rear-view mirror. It was a light closing in fast, too fast they reasoned to be a competitor— a weird flickering light of yellow and violet.

And then it happened. A very strange force shut off their ignition. Their headlights died. The next thing they remembered their Citroen CG accelerated noiselessly, seemingly of its own accord without benefit of motor power, and lifted their vehicle 15 feet off the dirt road, carried them silently through the air and dropped the car gently to a dirt road 75 miles to the north.

The incredible force also had drained the engine's gasoline tank.

The following day, businessman Alejandro Hernandez was

driving in southern Chile. In the car with him was his 13-year-old son. It was nearing 7:00 p.m. when Hernandez looked through his auto's window. He spotted a huge, cylindrical object zooming overhead.

The saucer, hovering over his car, suddenly swallowed it. Once inside, Hernandez later reported, five humanoid figures grabbed his son and stuffed him into a box while a sixth, much bigger than the others, began interviewing him, speaking in a metallic voice. Afterward, witnesses reported watching as the car, father and son inside, descended to the road, miles from the location it was picked up.

One month before the Acevedo/Moya episode and the Hernandez abduction, Serrano Silva, a Bogota, Columbia bank manager reported that a UFO of enormous proportions buzzed his car on a highway between Tunja and Bogota. The auto's engine and headlights died and the banker said he and his naval officer passenger suffered temporary paralysis.

South America, from Argentina

and Chile to Peru and Brazil, is a region strewn with strange occurrences. In fact, accounts such as those mentioned above make front page headlines constantly in the South American press.

So seriously do South Americans take UFOlogy that recently, hundreds of people were invited via a radio show to meet an extraterrestrial visitor. They even drove to Chile's Tenglo Island, only to learn that the whole thing was a hoax.

UFOs are big throughout South America, but Argentina leads the world in UFO sightings, according to a recent NASA tally.

In February, 1980, six San Luis Province fishermen had reported sighting an unidentified flying object. The saucer, they said, lit up the predawn sky.

They reported that a towering figure in a silver jumpsuit climbed from a ladder and waved, then returned to the saucer which immediately sped off. Police later found huge footprints five feet apart at the scene.

A week later, an oval-shaped translucent UFO which was ringed by a halo of light, flew silently over the Andes Mountains. The story landed on covers of half-a-dozen national news magazines. In South America UFOs are big news. □



So many questions, and so few answers. What happened in the Broadway lake division of Anderson, S.C. cannot be taken lightly. 
But now scientists are taking another look at Einstein's theory of relativity—the theory which seems to “forbid” anything from going faster than the speed of light. And

terial asking him to participate in an "experiment" to test the public's reaction to extraterrestrial contact.

Now living in Florida, Menger and his wife have adopted a far more secluded lifestyle, but mysteriously avoid questions regarding their highly controversial UFO involvement. Evasive and retiring, Menger refuses to explain his sudden loss of interest in UFO phenomena, but hints at the possibility of another book to settle the "lingering doubts" of historians studying the Highbridge incident. Menger will not commit himself as to when the "inside story" will be told, but claims it is certain to create more of a public sensation than anything revealed in the past.

Whatever final judgement one makes regarding the Menger affair, it is important to understand that it *cannot* be treated as an isolated event. In reality, the phenomena at Highbridge encompassed an incredibly *wide range* of unexplained events, all concurrent with Howard Menger's disputed claims of contact with extraterrestrials. One central figure in the Menger case was Carl Bradley, a salesman with university training in engineering and business administration, Bradley was one of 40 people who met weekly at a private home in Plukermin, New Jersey, to discuss UFOlogy with Menger in 1956.

Curious about Menger's bizarre claims, but at the same time dubious of their authenticity, Bradley suddenly found himself at the center of a series of inexplicable events. Listening to a radio program one evening on WOR while en route to a saucer meeting in Plukermin, Bradley and his wife claim to have heard an announcer interrupt the broadcast for a "special report". In an urgent voice, the announcer revealed that the British had communicated with a saucer in Eng-

land and planned to make arrangements to meet with the occupants! No further details forthcoming, Bradley said the station resumed its regularly scheduled program. Completely stunned, Bradley and his wife rushed to Plukermin, where they inquired with the guests as to whether or not they had listened to the broadcast during the interruption. Several members of the group acknowledged that they had, indeed, been listening to the same show at the time but *none* could remember any interruption of the sort having taken place. "I could hardly believe what I had been told," said Bradley. "The whole thing never made any sense to me at all. How could anyone have faked it? I often wonder about it still."

Bradley's experiences continued, however, as the familiar, rational world around him slowly began to recede from his grasp. In 1957, Bradley visited Menger's sick boy, Robert, who, at the time, was approaching death. While in the company of Richard Thompson, a close friend, and Rose (Menger's first wife), Bradley alleges he clearly saw a bar of bright light pulsating above the boy's head. The boy appeared to having a serious convulsion, and his pulse had slowed considerably. The light, which began as light blue, intensified, turning whitish in color, gradually diminishing until it had completely disappeared. Rose Menger and Thompson were present during the episode, and insist that it could not have been an illusion, and are, to this day, in doubt as to its explanation.

Approximately six weeks after the so-called "death-light" experience, Bradley took part in an even more spectacular event while in the Pocono Mountains of eastern Pennsylvania. Joe Bozoc, a reservations clerk at Mount Airy Lodge, who dabbled in experi-

mental hypnosis in his spare time, became acquainted with Menger through his reading of stories in some of the local newspapers. Accompanied by Thompson, Ben Gracca, and several others, Bradley drove up to observe one of Bozac's hypnotic sessions, hoping to interest him in an experiment in UFO contact. Bozac, impressed by the group's sincerity, accepted their proposal, and invited them back that evening to a small private cabin, where the experiment was held.

As a control, Bozac selected one of his own regular subjects (a UFO agnostic) to participate, and placed the individual within a deep trance. Posing various questions to the subject about UFO phenomena, the subject gave the location of a UFO sighting that would take place that evening, in an area less than one mile from Mount Airy Lodge.

Excitedly, Bozac and his group drove to the target area by car, finding themselves on a private road beyond the ruins of an old mansion. Thompson and Bozac both walked down into a nearby ravine, as directed earlier by the hypnotic subject, as Gracca, and four others stood watch from a ridge above. Reaching the bottom of the ravine, Bozac and Thompson suddenly heard a disembodied voice leap from the darkness. "Who's with you, Thompson?", it asked. "Friends," said Thompson. A single reply followed: "Do not be afraid." Unable to determine the origin of the voice, Bozac asked that the entity make its presence known. Both men then saw a bright flash of light appeared in front of them, describing an elliptical form, which then quickly faded away. Hearing or observing nothing further, Bozac and Thompson returned to the ridge, where they corroborated with the other members of the team who stayed behind. Leaving the area, Thomp-

son and his friends returned to the site the following morning, hoping to uncover physical evidence of the phenomenon.

Near the area where the mysterious light appeared to have manifested, several nearby trees and broken limbs near the top, and it appeared that the bark on some lower branches had been burned by some sort of physical object. There were no footprints found, however, except for tracks Bozac and Thompson had left the night before. Menger, who had learned of the experiences several days later, was in New Jersey at the time of the occurrence, and, it would seem, was not in any position to have concocted such an elaborate display.

Carl Bradley, who was present during the baffling event, claims that a *second* multiple-witness incident occurred shortly thereafter, in the town of Archbald, Pennsylvania. According to Bradley, Bozac had asked that Charlie Ball, an insurance salesman and amateur photographer, accompany him to an isolated, open-pit mining area, where UFOs had recently been sighted. There Bradley claims to have seen a UFO which produced an intense beam of light that swept from side to side and was then withdrawn into the hovering craft.

Armed with a small Canon camera, Ball took a series of four photographs of the object, before it darted off into the sky, and had the film developed by a private lab. Ball was impressed with the shots, and printed blow-ups, which he later displayed in his office window on Main Street (in Archbald). The photographs attracted attention not only from bystanders, but from governmental officials as well, who demanded Ball provide them with the negatives. The explanation offered by the agents (believed to have been F.B.I.) was that the UFOs were in the vicinity of a

reputed high-security, government facility (an armory), and, therefore, were considered of importance to the defense community.

Ben Gracca, who was told about the incident soon afterwards, decided to return to the site with Thompson, Ball, and a few members of the Plukermin group. Again, a craft, similar in design to the one captured by Ball on film, appeared, but was at a distance that precluded the group from taking any valuable pictures. Gracca claims one or two "small, disc-shaped objects" appeared to have *disengaged* from the hovering craft which circled above the government facility mentioned above. The small objects then quickly returned to the "mother ship", which then disappeared into the sky. The experiences of Bozac and the Plukermin group cast interesting light on the Menger story, and reveal important elements which have generally been excluded in historical profiles of the New Jersey contactee.

The interaction between Menger and these local residents, and, most importantly, the fact that the *geneology* of events in the Menger circle (roughly August 1956-September 1958) was almost identical to that described by Menger himself, raises serious questions about Menger's supposedly fraudulent motives, and invites a more extensive reassessment. The members of the Plukermin group, though generally incredulous of most of Menger's claims, did, after all, suspect that a small portion of those claims were, in all probability, genuine, and believed that their own experiences were tied to what was occurring in the area at the time. In this regard, it is interesting to note that few of the Plukermin investigators had ever *had* a UFO experience prior to the revelations of Howard Menger in 1956. The

experiences of Bozac, Thompson, Gracca, Bradley, and others appeared to have sprung forth almost collectively, and occurred in geographical locations cited by Menger himself as UFO "hot spots."

There is no question that a significant UFO flap was occurring in sections of northwest New Jersey, as well as in parts of northeastern Pennsylvania at the time of Menger's alleged encounters. What is even more curious, however, is that the experiences of Thompson, Gracca, and Bradley, ended with the waning of Menger's own experiences in 1958. While in no way completely authenticating Menger's claims, these factors do lend somewhat more credence to his story, and tend to diminish the overall probability of *total* fabrication in his complex account.

One critical problem with Menger's story is quite clearly the lack of corroborative testimony by reliable, independent witnesses. Although Menger claims his craft and occupants were sighted by virtually hundreds of witnesses, only a handful have come forth with their story. Dr. Tom Richards, who in 1956 was a graduate student of physics at Princeton University, is one of the few, it seems, to have actually witnessed UFO phenomena while in the presence of Menger, and is convinced that what he saw was genuine, and not the result of a hoax. Richards, who is currently the head of the department of physics at a Pennsylvania college, visited Menger in November of 1956, and was invited to witness a demonstration made supposedly by "space brothers" in a field not far from Menger's home.

Guided by Menger to a secluded wooded area one evening, Richards sighted two small, disc-shaped objects which pulsed irregularly and hovered in silence less than 20 feet in front of him. Over six feet in diameter, the discs radiated a variety of bright colors, and were seen for nearly

20 minutes by Menger, Richards, Rose, and a young high school student named Hotchkins. Richards, on fellowship at Princeton, and considered by his peers to be unusually bright and perceptive, was puzzled by the event, and unable to offer any conventional explanation. Menger, said Rich-

ards, told the group that the objects sighted were "observation discs", and explained their use by the aliens in recording psychological and emotional data— an explanation, which, under the circumstances, Richards found himself in no position to deny.

Because Menger had not permitted any of the witnesses to carry flashlights or come closer than 20 feet to the objects (due to the potentially "dangerous" level of electromagnetic energy Menger believed surrounded them) Richards' scientific curiosity was never fully satisfied. But Richards admits that he did find the experience striking, and finds it difficult, given the incredible sophistication of the display, to accept allegations of fraud freely advanced by so many of Menger's detractors. Such a perfectly random sequence of glowing lights, held invisibly in quiet suspension above the ground in an open field, was, to Richards, a most impressive sight, and one he finds difficult to dismiss as an optical illusion, or as a misrepresentation of a conscious fraud.

Richards world-view as a physicist was again put to the test later that very same evening, when he was invited by Menger to witness a second "demonstration" by the extraterrestrials near his home. For over 15 minutes, Richards watched as three beings of "above-average height" ran, bounded, and jumped in a swift fashion across a yard, at times, according to Richards, attaining almost "superhuman" speeds. The entities, surrounded by a whitish glow, hurdled fences over five feet tall, and exhibited incredible gymnastic prowess in their movements. This demonstration, said Richards, could have been duplicated only had Menger enlisted the services of professional gymnasts, for such a performance would require extreme agility and talent. Never in his life, said Richards, had he been stirred by such intellectual wonder, and the experiences that evening persuaded him that Menger's claims, unacceptable as they appeared to many others, may have contained more truth than is generally assumed at this time.

Richard Thompson, whose UFO experiences in 1956 were, in part, to *remove* his scepticism of Men-

ger, agrees with Richards that "first-hand experience necessarily carries the greatest conviction." Like Richards, Thompson suspects that the heavy clustering of reported phenomena in the Highbridge area during the mid-to late 1950's was more than just "coincidence", and does not understand how Menger, hampered by his limited finances as a signpainter, could possibly have perpetuated such a combination of hoaxes, each perfectly timed, and brilliantly executed. Thompson, while admitting he had not ever witnessed phenomena with Menger, still nevertheless credits him with having an important influence on his life, and believes him to have been a "catalyst" in establishing some of his many "encounters."

For example, Thompson recalls how beginning in 1956, he began to receive nocturnal telepathic impressions to "get up, dress, and drive to an unanticipated location" where he would meet several other men who had received similar mental commands. Most of those present, said Thompson, were regular members of the Plukermin study group, including Carl Bradley, who felt a strong "bond" existed between them and the manipulating "force." Thompson also remembers observing a "glowing ball" of white light which confronted him in his bedroom later night, and which stood silently above his head. The light, he said, returned many nights afterwards, and conveyed to him a subtle feeling of "warmth and power."

A climax, says Thompson, occurred in 1957, when a large number of unusual objects were discovered throughout various parts of his home in Plukermin, as well as in open fields near Highbridge, which he was drawn to by apparent telepathic means. The objects, all dehydrated vegetables, fruits, and nuts, had no logical origin, said Thompson, and appeared to have undergone an odd, "freeze-dried" process.

One of the items, a potato, was given to Menger, who suggested it be analyzed by a professional laboratory. Thompson, agreed, and the sample was brought to Rutgers University, which expressed an interest in the find.

Puzzled by the unusually high protein content, Rutgers suggested that a carbon 14 test be conducted next in order to determine the approximate age of the sample. The cost of the test being prohibitive, however, (over \$2000) Menger and Thompson regretfully asked that further testing be halted. Rutgers recommended that Menger take the sample to a government agency which, they said, would continue the research at no cost, and asked that he contact a doctor who worked at the facility.

In June 1958, the potato was submitted to the individual named by the university, who promised to keep them informed of any important developments. Upon speaking with the man a short time thereafter, however, Menger was told that the findings on the potato were unavailable to the public and had been recently "classified" by the agency. Thompson's feelings are that the potato was, in fact, "impervious" to radioactivity, and that it was meant to warn him of the "dangers" of "impending nuclear catastrophe." He believes that the agency deliberately withheld information on their research for fear that publicity over the matter

would have produced "panic and scientific disorder." A few of the remaining samples have been saved by Thompson, who claims they have not altered from their original state, a quality he sees as bearing dramatic witness to their unique mode of preservation.

Occupying a responsible position in the business community, Thompson prefers to share his telepathic/UFO experiences with only those people he trusts "by instinct", fearful that he may someday suffer the same financial and personal crisis as did Menger. He believes that Menger's tragedy lay in his extravagant and often unsophisticated public, and believes Menger was penalized for his "utopian" aspirations and dreams. As for allegations of fraud, Thompson suspects that elements of "untruth" may have been used by Menger to promote a more widespread belief in extraterrestrial life, but does not believe, based on his own experience, that deception was as pervasive an ingredient in Menger's story as his detractors were later to maintain.

The facts, when considered in the new light of this holistic setting, indicates that Menger's fraudulent motives may have arisen from a need to satisfy a public's incessant hunger for more sensational experiences, but only after authentic experiences had begun to dwindle from the contactee's life. Unlike Adamski, who conviction inspired mass acceptance of UFO phenomena exclusively by means of a disarming and benevolent persona, Menger emerges as credible on account of the rich backdrop of experience woven into his story by those independent witnesses represented in this report. There is no doubt in my mind that something quite out of the ordinary occurred in Highbridge during the 1950s, and that Menger was a prime source of inspiration for that occurrence. History says I'm wrong. I suggest we give history another long, hard look. □

been?"

Shane looked over at the clock, which showed six a.m., and replied, "Are you crazy? I've been right here... asleep."

"Look," her mother said.

Shane saw what had excited her mother. She was lying on her bed, with her slippers and robe on. This might not have been so unusual if not for the fact that her clothes and legs were covered with dried mud. Shane was really shocked. She couldn't remember any nocturnal trek and the only mud was in a nearby field. She couldn't explain it.

Two days later Shane found "two reddish, ring-shaped marks on either side of her lower abdomen and a little line running from her naval down". Soon her monthly period disappeared and she began to lose weight. Sometime in February everything returned to normal. This was nine months after the 1968 sighting.

Early in 1975, Shane Kurz was put under hypnosis by Hans Holzer, a practicing hypnotist. Under hypnosis Holzer regressed Shane back to her UFO sighting seven years before. Shane had been sleeping peacefully on that May night when she was awakened by someone calling her name. She had no control over her actions as she put on her robe and slippers. The caller was outside... somewhere. The cold night air blew across her face, as she saw people in the nearby field. Behind them was a landed saucer, with its central rim revolving. A bright light was shined in her eyes, possibly creating a hypnotic effect, and she was led aboard the alien craft. In a small, purified, white room, the UFO-nauts tried to get Shane to lie on the table. She tried to refuse, but they secured control of her and forced her onto the table. She got a good look at her abductors. They were about five feet tall, wearing (what Shane described as) "white-motorcycle" outfits. They had slits for noses and very thin lips.

They told Shane that they wanted her to provide them with a baby, because they believed her to be good "breeding material". Stripping her of her nightgown they examined Shane's young, tender body. As in the case of Betty Hill, the extraterrestrials placed a needle into her navel. Then the alien leader stripped his clothes as the other aliens rubbed some-type of jelly over the frightened girl. Without kissing her, even once, the leader proceeded to "make love" to the helpless Shane Kurz. His narrow, thin, white-grey skinned body upset her. He finished his pleasures and handed Shane her clothes. As the leader dressed, he told her she could leave, but that she wouldn't remember anything that had happened.

*And for seven years she hadn't!*

One last case comes from Emiles C. Schurmacher's "True Tales of Terror", and deals with a young Mexican-American named Larry Gomez. It was midnight, and Larry was en route to his father's sheep ranch, when he turned his pickup on to an old dirt road, just off US 80 (west of Tucson, Arizona). What he saw caused him to stop.

Fifty feet in front of him was a strange glowing object and his first thought was... "Flying Saucer!" The UFO descended on a tripod-landing gear. Larry got out of his truck to investigate. Although curious, he didn't want to get too close.

From out of nowhere, there appeared two figures dressed in strange overalls, who frightened Larry. Before they put him into a hypnotic trance with their large-slanted eyes Larry noticed their lack of noses and lips. He awoke from the trance, naked, on what seemed an air-mattress. Around him stood his abductors, who soon left, only to be replaced by an alien female. Her facial features and size was similar to Larry's kidnappers, but she was obviously female, Larry noted as she stood

naked before him.

Larry noticed no pubic hair, or other body hair, on the alien which stood in front of him... trying to be seductive. She approached Larry and tried to sexually arouse him with tactile manipulation. But nothing came of it. Perhaps Larry's subconscious libido was saying, "This is a sin. She isn't human." Yet, this soon changed.

The alien girl placed her satin-soft hand across Larry's forehead and "she appeared to change". He "saw an alluring woman with an enticing smile". Larry immediately became sexually aroused and they performed what was originally intended... sexual intercourse.

Afterwards, Larry passed out. He awoke outside his truck. The UFO was gone. His only proof was a few burn spots where the UFO had landed and dim memories of a sexual union with an alien female.

Larry Gomez was questioned by the Federal Bureau of Investigation and USAF officials about his UFO experience. It was then that he realized what had been bugging him. The transformed girl had looked familiar to him, but he couldn't figure out where he had seen her before. During the interview Larry realized that the "transformed" girl was the woman on a pin-up calendar that Larry had often admired. The fact that she changed into a desirable woman, to fulfill one's sexual needs, sounds like the legend of the succubi... demonic spirits who inhabit the bodies of beautiful woman to seduce men with sexual pleasures.

There have been other cases of sexual relations between UFO-nauts and Earthlings; but the ones mentioned her should serve to illustrate a sexual interest in humans by the aliens. Given that these cases are true, why are they (the aliens) interested in us?

The most conservative believers in UFO abductions believe that the UFO-nauts are only scientifi-

cally curious about our human actions. This idea seems to be supported by most abduction cases; most mention some type of physical examination having taken place.

Are they as interested in our sexual activities as we are in those of our fellow-Earthlings? If so, why resort to abductions? A few porno films should answer all their questions. Unless, like Earth zoologists, they want to study the creature under natural conditions. Yet, being dragged aboard a UFO hardly seems natural. They may be testing us under captive conditions... as much a psychological test as a physical one.

The supporters of the Ancient Astronaut (AA) theory, an old idea popularized in Erich Von Daniken's books, tell us that UFO kidnappings are nothing new, in fact they have been taking place since the beginning of time. They maintain that the reason for modern-abductions is that the UFO-nauts, descendants of the AA, are testing man's adaption ability. For, according to the AA theory, man is a hybrid species... a creature bred from ancient stock by these AA. To support their pet theory, the Von Danikenites point to ancient writings as proof. The Bible and writings of the Hindus, Chinese, Romans, Greeks and Egyptians all contain legends of "gods" (i.e. UFO-nauts) who mated with earthlings.

The best example comes from the Bible, Genesis 6, which reads, "That the sons of God saw the daughters of man... that they were fair; and they took wives... and they bore children to them". Supposedly, these "sons of God" (UFO-nauts whose super-science seemed God-like) mated with Earth women for one reason or another. The Von Danikenites believe that this purpose was to help man upon his evolutionary way.

As a zoologist I find this theory difficult to accept, without a great deal of modification. No matter

how parallel two planets' evolution might be, the chances of two creatures having identical (i.e. matable) genetic makeups is astronomical. And just because the UFO-nauts, given that they exist, are humanoid doesn't allow one to conclude that successful mating can take place... no more than a man can be crossed with an ape just because both are anthropoids.

If the AA were practicing genetic engineering (the manual manipulation of genetic material) then anything is possible. But the Ancient Astronaut theorists never mention this... only that the "gods" mated with Earthlings.

If we believe the cases of abductions, then it seems that breeding might be the purpose behind these kidnapping. Breed-

ing was mentioned by Shane Krauz and the Steiner brothers. And before the alien woman left Antonio Villas-Boas she pointed to her stomach and then to the sky... obviously indicating that their child-would be born among the stars.

Still other UFOlogists believe that the purpose behind these biological/sexual probings is sinister in nature. Could the aliens be testing our sexual and mating methods so that they will be able to infiltrate our society at even its most intimate level? Were the women who mated with Villas-Boas and Jason Steiner aliens? Or some type of "surrogate" female? An android or humanoid robot being tested to see if "it" could pass for human on all levels? Jason Steiner believed that the "woman" he made love to wasn't human, but some type of "fancy robot".

A possible solution for these abductions is the obvious one... that they are hoaxes. All the work of overactive libidos. A desire for something different. This is the view accepted by many serious UFOlogists. They believe that UFOs exist, but frown at reports of UFO-nauts. This is ridiculous, if UFOs exist and are physical in origin, wouldn't one expect to have reports of the creatures that pilot them?

There is no real answer to the questions posed in this article. Either you accept the cases or you don't. If you refuse to believe the cases cited, then the whys are easy; but if you do believe that these abductions took place, then the whys are difficult to come by.

In fact, the whole idea of voyeurs from outer space reminds me of an old joke. A young lady had just given birth to a horrible, green, one-eyed baby; to who she says, "Now, do you believe that I was raped by a man from Mars?"

Maybe an alien baby is needed to prove the case for human/alien sexual unions. The truth... only time or a UFO-naut... can tell. □



Imagine that you're deep in the country surrounded by the sweet smell of pine needles, running streams pouring forth fresh, drinkable, icy-cold water, and a healthy sun beating down, not too hot, rocking you comfortably off to a tranquil sleep.

If that's not your bag, then perhaps a snowy plateau, a white blanket as far as the eye could see, and you're leisurely skiing down its winding, twisting slopes. Now, beginning to feel chilled, you're coming within sight of a log cabin; its chimney belching forth the promise of a warming fire within, a welcome hot drink, served up by the lover of your choice, waiting to greet you.

Now, while you're emerged deep in one of the aforementioned paradise situations, someone offers a suggestion. A UFO onto which you're taken, by force, where you're interrogated and examined. You're then asked to describe, with as much detail as possible, your extraterrestrial inquisitors. What will you say?

This experiment has been part of a, "UFO sighting clinic" since 1977, where Alvin Lawson, a professor at Long Beach State University has observed more than 20 volunteers given imaginary UFO abduction situations by a clinical hypnotist, Dr. W.C. McCall of Ahaheim.

While under hypnosis, the volunteers were asked to imagine being threatened by a real-life

UFO abduction, while at their favorite recreation place. In turn, the descriptions of the hypnotized volunteers, were compared with documented abduction accounts which were related by UFO witnesses, who truly believe they have had authentic encounters.

Dr. Lawson found that the volunteers, many with no particular interest in UFOs, when queried under hypnosis, emerged with the very same or similar creature descriptions.

"The sketches provide the most compelling evidence of the exist-

tence of in-depth parallels between imaginary and 'real' abductions," said Lawson, of Garden Grove, an English professor who teaches an unusual course on the rhetoric of UFO literature.

"Many who report they have been abducted by extraterrestrials say a bright light focused on them and the light beam levitated them aboard the UFO through a tube," Lawson added.

Dr. Lawson has identified six categories of entities found aboard UFOs by both hypnotized volunteers and "real" abductees. These categories are: human, humanoid, animal, robot, exotic and apparitional (ghost-like or transparent).

Said Dr. Lawson upon comparing accounts of the hypnotized volunteers to the documented accounts of abductions of actual UFO witnesses: "Although we expected many dissimilarities an averaged comparison of data from four imaginary and four "real" abduction narratives showed no substantive difference".

Dr. Lawson concluded that UFO abductees' experiences are as valid as dreams, deathbed visions and psychosis.

"We have never before been able to say that UFO abductees are reliable," he noted. "Now, however, we have evidence that they really perceive the images they report. They report the experiences subjectively but truthfully".

the carcasses were on the military reservation of Fort Greely. First the Army said it was nerve gas, then an exotic artillery shell. Later the Alaska Department of Fish and Game issued word that the caribou were killed by an extraordinary large bolt of lightning.

Time had passed and Paul and I are no longer employed at the Nuclear project, which has since shut down. Now we are free to tell what really happened that day in May. This I have done above.

Knowing only what I saw on this one occasion I have been astounded that the people of logic in our society haven't drawn a concrete conclusion from all the events which have happened since 1967. Some of these things are listed below. You check it out and if you aren't convinced, I don't know what to say to you.

1. The Brooks Range caribou herd dropped from 200,000 ani-

mals in 1972 to less than 75,000 when the count was remade in 1976. What happened to those 125,000 animals?

2. The Chistochina caribou herd in central Alaska dropped from 20,000 animals to 5,000.

3. The Nelchina herd dropped from 20,000 down to approximately 5,000.

4. The Fortymile herd in northeastern Alaska had dropped from 40,000 animals to 8,000 in just three years.

5. The Delta herd (the one I watched slaughtered) lost half its number in a few years.

6. The Macombe Plateau herd lost half its animals.

7. The moose, once so abundant in central Alaska (twenty or more moose could be counted any day on an eighty mile drive from Delta Junction to Paxson) are now very scarce. Today this drive can be made over and over without

seeing a single moose.

8. The buffalo herd in Wood Buffalo National Park, Alberta and the Northwest Territories, dropped from 12,000 to 5,528 animals between 1970 and 1975 with no logical explanation as to where the animals went.

9. The buffalo herd north of the park dropped from 2,500 animals to 1,250 during the same period. More than 7,000 buffalo are unaccounted for.

10. Ranchers in the western states have reported many of their livestock killed and mutilated, and many, many more missing.

So, there it is. Combine the data with the account of what had happened in that mountain valley located in the foothills of the Alaskan Range in May 1972 and someone should get the message: extraterrestrials are draining our wildlife dry. □

weeds."

Describing the craft, Young said it was a dull, dark color, possibly black or red or even dark green, and that the red light on top made it almost invisible. "Whoever built the craft was a master at camouflage. You see only what they want you to see."

In all, the unusual craft was on the ground for perhaps five minutes. During that time, Young noticed that there were no rivets in the wind. "It was all in one piece. 





Dione, one of Saturn's inner satellites, appears as three colored spots just below the planet's pole. The Voyager Project is managed for NASA by the Jet Propulsion Laboratory, Pasadena, California.

The underside of Saturn's rings is shown in this photograph. This view of the rings is dramatically different from the appearance earlier of the rings' sunlit face. For example, the B ring, which is the brightest region of the sunlit face, appears dark when seen from the ring plane. Yet the normally dark Cassini Division now shows as the brightest feature in the rings.





The cratered surface of Saturn's moon Mimas is seen in this photo taken 264,000 miles from the surface. Impact craters made by cosmic debris are clearly shown. The largest is more than 62 miles in diameter and displays a prominent central peak.



This satellite photo shows two hurricanes. The immensity of Hurricane Allen, which brought devastation and loss of life to the Caribbean and other areas is shown clearly in this photo which was taken by the GOES satellite. The storm covers almost the entire area of the Gulf of Mexico.

# WHEN WE CALLED THEM FLYING SAUCERS

Newspapers, more than any other communications medium, are day-to-day barometers of the feelings and attitudes of the people. In 1947, unidentified flying objects broke onto the national scene. To gauge what was being thought on a national level, in the first formative week of the mystery, we must turn to the newspaper which had the farthest reach—the *New York Times*.

Although Kenneth Arnold experienced what is considered to be the first modern UFO sighting above Washington's Cascade Range on June 24, 1947, the first article did not appear in the *Times* until July 4. It may surprise many UFO historians, but this first article did not mention "flying saucers" at all. Instead they were called "flying disks".

The headline of the article states: 'Flying Disks' Fail To Stir Air Force'. A spokesman for the Army Air Force said that flying disk reports "have not produced enough facts to warrant further investigation."

Evidently the *Times* believed the spokesman judging from the "detailed" coverage. They referred to Arnold as a flying Boise (Idaho) businessman. Perhaps they thought all the excitement would die down and they wanted to spare Arnold any embarrassment when he finally "came around to his senses". One cannot blame them for thinking that this was merely a temporary fad, a product of the summer "silly season".

As far as the *Times* and the Army Air Force were concerned, there was no mystery. "The observers either imagined they saw something... or there is some

meteorological explanation for the phenomenon."

It was expected that interest would fade and then the sightings would taper off, ending completely in time. Events turned out exactly opposite, and two days later, the *Times* carried another report.

In a story by T.R. Kennedy, Jr. we first find the term "flying saucer" It is almost as if, unable to ignore the phenomenon as they probably wished, they compromised by attaching a ridiculous label to it and at the same time explain it away.

The headline to Kennedy's articles states: 'Flying Saucers' Mystify Experts; May Be Prank of Nature, They Say. Although he seemingly tries to pass off the sightings as "popular imagination... meteorological jitters with some mass hypnosis thrown in" the writer cannot keep his natural curiosity from getting the best of him.

Kennedy reported airline pilots and others said the objects were apparently traveling at very high speeds at altitudes of one to two miles and the "saucers" were vanishing into the northwestern sky. He goes on to state that the July Fourth holiday brought reports from all over the United States and Canada.

A little further in the article Kennedy credits Kenneth Arnold with saying something which, as far as I have been able to discover, has not been quoted by any UFOlogist since. Arnold says that he observed "nine objects flying at 1,200 miles an hour in formation, like the tail of a kite." Why everyone abandoned this description in favor of the rather silly

"flying saucer" is a mystery to me.

Gordon A. Atwater, curator of Astronomy of the Hayden Planetarium, was presented, by the article, as favoring a meteorological explanation, stating that it was possible that the sightings were caused by the formation of disk shaped ice crystals which then glided through the air, reflecting light like a mirror. Atwater later says, although it is hardly emphasized, that "we are inclined to believe they (flying disks) are neither meteorological or astronomical in origin." No wonder people were confused. Given contradictory statements such as these by the experts they were looking to for the answers to their questions, people were not sure whether they should laugh or run for the hills.

Another expert, Dr. Jan Schilt, Rutherford Professor of Astronomy at Columbia, was consulted by the writer. He said he believed that the flying disks were caused when light rays were distorted in the air turbulence caused by the passage of airplanes and birds. While this explanation probably received a few belly laughs from those who had observed the strange metallic disks, it really just added confusion to those who were already confused.

Dr. Newbern Smith of the National Bureau of Standards summed up his feelings on the subject: "It is like one of the Loch Ness Monster stories. Once these reports get about, everyone thinks they see it."

The next day (July 7), UFO's were being called "sky disks." the tone of this article is more

imagination." I am glad that journalists are an objective lot.

He then quotes an unnamed physiologist in Sydney, Australia as explaining that UFOs are "due to the effect of red corpuscles of blood passing in front of the retina." He said that this condition is brought about by staring at the stars for too long a time.

Schumach then seriously tells a true story of a collision between a UFO and a private plane. Those who believed him should have known better. The case was a hoax, he reveals.

A little unofficial officialdom got into the act when an Army doctor in Frankfurt am Main, Germany gave the phenomenon a scientific name—*muscae volitantes*. "This is a fancy way of saying optical illusions," said Schumach.

Then came the official angle. "The Army Air Force," he writes, "was smoked out and admitted complete ignorance. Just to play it safe, the Air Force issued a statement saying an investigation was underway. This gave the War Department the opportunity to say it was dumping the whole matter in the lap of the Air Force."

My opinion is that Mr. Schumach's article achieved the effect he was hoping for. UFOs received more laughter from those who were already skeptical of the whole matter.

There has long been a rumor among UFOlogists that the Air Force has in its possession the wreckage of a downed saucer. Many UFOlogists have expressed skepticism and it has been denied innumerable times by official sources but still the rumor is passed on and believed by many each year.

The rumor may have had its origin in a story which the *Times* carried on July 9, 1947, again written by Murray Schumach. Air Force Lieutenant Warren Haught told the press, "the many rumors involving the flying disks became a reality." The officer then went on to tell how a flying disk had

been found on a ranch near Roswell, N.M. The craft had been passed on "to higher headquarters."

Brigadier General Roger Ramey corroborated Lt. Haught's report and added that the disk was, "of flimsy construction" being made; "of some type of tin foil." Subsequently, it was reported flown to a research laboratory at Wright Field, Ohio.

The mysterious disk was ultimately identified as being a weather balloon. Just how the transition was made from balloon to flying saucer and why everyone, from lieutenants to generals, believed it, was not explained.



The July 10 article (the last in our one week survey) carries no by-line, but its tone is identical to those written by Schumach. The writer said that reports are being received from places which exist "in the astronomical area bordered by the upper reaches of the heavens and absurdity."

Soviet Deputy Foreign Minister Andrei Gromyko said he had not seen a flying saucer but "some attribute it to the British for exporting too much of their Scotch whiskey into the United States. Some say it is a Russian discus thrower training for the Olympic Games who does not realize his own strength."

Only one explanation is offered in this article—mass delusion.

First impressions are important. Our opinion of a person is usually determined within minutes after meeting. This was the case for UFOs.

My intention in this article has not been to ridicule the *New York Times* or its writers in any way but, rather, to show what kind of information was being given out to a curious and pliable public during the first important week of national coverage. Having examined that week it is not difficult to understand the general attitude toward UFOs which has formed since then. □

His only words to Jacob before retiring to his bedroom was, "Your mother won't be home for dinner tonight." □

## WHAT WAS IT?

According to Kansas meteorologists, there was no reason for anything peculiar to happen in the skies over Wichita at 3:00 a.m. last August 30. But something did. And whatever it was, it was seen and reported by Beccy Tanner.

On the early morning in question, Beccy, camping out, was deeply engrossed in her hobby of photographing stars and watching them through her binoculars as they lit up the darkened sky.

As she tracked a star in the northwest, she spotted what appeared to be a flight of something unusual, traveling from west to east.

As Beccy watched, noticing six of these strange things, she saw that each one contained a bright, white light, each blinking in unison. Alternating between long and short blinks, it reminded her of someone sending Morse Code.

To the woman's surprise, the "things" seem to stop, all for-



ward movement ceasing, and they just "hung dead" in the sky. Then they moved off, eastward, and disappeared.

The Air Force explained that it could not have been a conventional aircraft, since an airplane blinker is much like the turn signal on an automobile—it's next to impossible to get several to blink in unison.

And Mike Smith, meteorologist for KARD-TV in Wichita, said there had been no unusual weather conditions, and the phenomena did not fit into any sort of logical pattern, meteorological or otherwise.

Whatever it was out there, Beccy has her own explanation of what happened:

"I was camping out in a field and at approximately 3:30 a.m., I noticed what appeared to be six lights traveling from the west. They surrounded the northern part of the sky and proceeded to blink on and off in sequence and at random time intervals. I had watched this for about 15 or 20 minutes before they disappeared.

"As far as what it was or could have been, I really don't know. I did notice however that the Russian cosmonauts did land at approximately that time. It might have been them. It might have been a number of things. I really don't know what it was." □





It was described as “flat and round —saucer-shaped —and moving like a helicopter. There was a light on top of it, as though on a tall pole. And there were windows that went around (counter-clockwise), in a sequence of six lighted windows, then six unlighted windows”.

The witness who gave Oregon police the above description said she and her children were riding in their car just past the Minit Mart on Everett Road. At approximately 7:30 p.m. Christmas Eve when they first sighted the object.

The woman told authorities that one of her children felt there were lines, or wires, suspended from the unknown craft.

The woman said, “I’m assuming that it could have been a dirigible, but why did it go (rotate) around? There’s got to be a lot of other people who saw this, too”.

As it turned out, there were.

Another witness, driving from Portland to Camas, said the object apparently headed off across the Columbia River. “It looked like a long streak of light flying around with other, brighter lights, attached to it”. According to Charles Jameson, “It may have been Christmas Eve, but this had nothing to do with Santa Claus or his reindeer. I thought it just might have been a Goodyear blimp,” said Jameson, “but I

really think now that it was traveling too fast for that”.

A resident of Springfield, Joan Maxwell, came forward and reported she saw “something weird” on Christmas Eve high over Camas where she had been visiting.

“On the way home,” Maxwell told police, “en route from Camas to Washougal, we saw these lights just at the exit. The lights began in the northeast. I thought the illumination belonged to lights —house lights —on a hill. But as we continued driving, the lights seemed to come directly toward us, but moving along the road toward Washougal, too”.

Maxwell reported that the lights stopped short, “directly over our car and to our right, before they shot straight up and out of sight”.

The strangest report came from Mr. and Mrs. Alex Ginsburg who said, “We saw the damn thing on the road, about 100 yards in front of our car. It had no wheels, it just sort of floated about two feet off the road. I tried to tell my wife not to worry its just some kind of machine, when it suddenly went straight up into the dark sky”.




