## NIGHT VISION EQUIPMENT

Everyone knows that one cannot see anything in darkness. But imagine you are in a place that is cloaked in darkness and you are the only one who can see everything, even in the pitch dark. Technological advancements of the 21<sup>st</sup> century have made this possible, through the invention of certain night vision equipment that has done away with the obstacles of human beings in places where there is no light.

Remember it was Lt. Col. Donald Corso, who advocated the Night Vision Technology in use today was a product of extraterrestrial origin, removed from the “dark-matter” eye covering of an alien and back engineered. Whatever the origin, it is a technology that has revolutionized night surveillance in military operations, law enforcement and civilian projects.

With suitable night vision equipment, one can see a person or object positioned over 200 feet away in complete darkness. Night vision equipment can work in two very different ways, depending on the technology that is implemented. One is “Image Enhancement” and the other is “Thermal Imaging”.

In “IMAGE ENHANCEMENT”, light particles, called photons, are collected in small amounts. This amount of light includes the lower portion of the infrared light spectrum. The night vision equipment catches this light and then amplifies it to the point that we can easily observe the image.

With “THERMAL IMAGING TECHNOLOGY”, the night vision equipment operates by capturing the upper portion of the

infrared light spectrum. This light is emitted in the form of heat energy by the objects, in place of light reflections.

A Night Vision Device can be a 1<sup>st</sup>, 2<sup>nd</sup>, or 3<sup>rd</sup> generation unit. What this stands for is what type of light intensifier tube is used for that particular device. The light intensifier tube is the “Heart and Soul” of the device.

**1<sup>ST</sup> GENERATION:** is currently the most popular type of night vision in the world. Utilizing the basic principles described earlier, a 1<sup>st</sup> generation will amplify the existing light several thousand times letting you clearly see in the dark. These units provide a bright and sharp image at a low cost. You will probably notice a slight high-pitch whine when the unit is “on”. The image you see may be slightly blurry around the edges. This is known as Geometric Distortion. When you turn a 1<sup>st</sup> generation unit “off” it may glow green for some time. These are inherent characteristics of a 1<sup>st</sup> generation unit and are normal.

**2<sup>ND</sup> GENERATION:** is primarily used by law enforcement of for professional applications. This is because the cost of the 2<sup>nd</sup> generation unit is approximately \$1000.00 or more than the 1<sup>st</sup> generation type. The main difference between the 1<sup>st</sup> and 2<sup>nd</sup> generation unit is the addition of a micro-channel plate, commonly referred to as an “MCP”. The MCP works as an electron amplifier and is placed directly behind the photo cathode. The MCP consists of millions of short parallel glass tubes. When the electrons pass through these short tubes, thousands more electrons are released. This extra process allows the 2<sup>nd</sup> generation units to amplify the light many more times than 1<sup>st</sup> generation units, providing a brighter and sharper image.

**3<sup>rd</sup> GENERATION:** is the latest in night vision technology. By adding a sensitive chemical, gallium arsenide to the photo cathode a brighter and sharper image was achieved. However, it is vastly more expensive to purchase than the 1<sup>st</sup> or 2<sup>nd</sup> generation. Typically a 3<sup>rd</sup> generation unit will cost in excess of \$3,000.00.

**DISTANCE VIEWING:** There are many different variables that can affect the distance that you can see with a Night Vision Device. First, what are you trying to see? Let me guess. You are looking for “UFOs”. We thought so! Remember the larger the object is the easier it is to see. Are you trying to see details (recognition range) or are you just trying to see if something is there? There may be times you will detect movement, however you will not be able to determine exactly what it is. This is called (detection range).

Another variable is lighting conditions. The more ambient light you have at the time, (starlight, moonlight, infrared light) the better and further you will be able to see. You will always see further on a night when the moon and stars are out than if it is cloudy and overcast.

We are positive that “Night Vision Equipment” of various kinds, have been utilized by Ufologist for many years, however it was in April of 2008 when two UFO Researchers, Ed Grimsley and Charles Ostman, appeared on the popular radio show “Coast to Coast”, telling their spectacular stories and research in the use of night vision equipment to enhance their viewing UFOs. Everyone hearing the show wanted to run out and obtain Night Vision Equipment and enhance his or her own research.

Night Vision Equipment has come along way in recent years and has certainly enhanced the field of Ufology and will

continue to grow in popularity as the cost of this equipment is reduced due to time and further advancements.

We only urge that when using this type of equipment, especially the 3<sup>rd</sup> generation units, to always keep in mind that “DECTION RANGE” and “RECOGNITION RANGE” are vastly different. Do not attempt to place a positive identification tag on an object in the “DETECTION RANGE” only. The You Tube website is full of Fraudulent UFO identification claims that have been thoroughly examined by investigators, photographically enhanced and proven to be an “Identifiable Man Made Object”.

Shop around for the best deal. There are many outlets selling this type of equipment or ask your local group leaders to assist you.

Another question was how do I get permission to investigate a location? Ask the property owner or caretaker. If the location is abandoned, check with the local or State Police to see if that would be permissible.

### **Were there two crashes at Roswell?**

Retired Air Force Lt. Col. Richard French has claimed that there were two crashes at Roswell in 1947.

Conspiracy theories have surrounded the controversial events at Roswell, New Mexico for decades - some believe that a UFO and its otherworldly occupants had been retrieved and covered up by the military while others accept the official story claiming that the object was nothing more than a weather balloon. Now Lt. Col. Richard French has another take on the mystery - he claims that there were actually two crashes, both of them involving extraterrestrial visitors.

"There were actually two crashes at Roswell, which most people don't know," he said. "The first one was shot down by an experimental U.S. airplane that was flying out of White Sands, N.M., and it shot what was effectively an electronic pulse-type weapon that disabled and took away all the controls of the UFO, and that's why it crashed."

According to Richard French, reports of a second crash reached him a few days later. "It was within a few miles of where the original crash was," he said. "We think that the reason they were in there at that time was to try and recover parts and any survivors of the first crash. I'm [referring to] the people from outer space -- the guys who's UFO it was."

## **SASQUATCH STUNT TAKES DEADLY TURN**

A man dressed in a military-style "Ghillie suit" who was attempting to provoke a Bigfoot sighting was struck by two vehicles and killed on U.S. 93 South of Kalispell Sunday night.

"He was trying to make people think he was Sasquatch so people would call in a Sasquatch sighting," Montana Highway Patrol Trooper Jim Schneider said. "You can't make it up. I haven't seen or heard of anything like this before. Obviously, his suit made it difficult for people to see him."

The Flathead County Sheriff's Office identified the man as Randy Lee Tenley, 44, of Kalispell.

Schneider said Tenley's motivations were ascertained during interviews with friends who were not in the immediate area but were nearby when the man was struck at about 10:30 p.m.

"Alcohol may have been a factor," Schneider said. "Impairment is up in the air."

Tenley was on the southbound side of the highway, about a half mile south of the highway's intersection with Rocky Point Road.

"He was in the right-hand lane of travel and the vehicle was unable to avoid him and struck him," Schneider said of the first vehicle driven by a 15-year-old girl from Somers.

A second vehicle driven by a 17-year-old Somers girl also struck Tenley as he laid on the highway.

Ghillie suits are commonly used by military snipers and some that are advertised on the Internet have a Bigfoot-like appearance.

"This one was a store-bought version, just a commercial Ghillie suit that was pre-made," Schneider said.

Tenley was pronounced dead at the scene.
