

Consequently, while many of these purported encounters are described as terrifying, some have been viewed as pleasurable or transformative.






NORTHEAST FLORIDA UFOLOGY RESEARCH GROUP

PARANORMAL TIPS

How science rather than the spirit world is what really makes the Ouija board move

- Ideo-motor effect explains how actions are believed to be work of spirits
- Thought processes connected to movement and what caused it are not connected, which can cause confusion

To many, Ouija boards are a sign of dark magic, a way to allow people to receive messages from the spirit world by being guided around the board's letters. However, the Victorian parlor games and other 'spiritual' devices such as: dowsing wands, are guided by the people holding them scientists have found. Under a phenomenon known as the ideo-motor effect, muscles and movements can move without a person being aware of the action, leading many to believe they have witnessed some form of magic.



Is there anybody there? Scientists say the only thing moving the Ouija board is the players using it. The mystery therefore is not how these inanimate objects appear to move of their own free will but how people are able to make the movements unconsciously and attribute it to an imagined power.

With Ouija, the supposed link to dark magic took off when one of the boards, which were first invented by Parker in the 1890s as a parlor game for automatic writing, was used in the film *The Exorcist*. The boards were used as a way to try to contact the dead during the First World War, and during a rise in Spiritualism in the U.S. at the turn of the last century. Scientists say it is possible to recreate the effect by hanging an object such as a ring from a foot-long piece of string. When the string is held at arm's length the weight will swing in small circles, even if the arm is held still. The string helps to exaggerate tiny movements that the person holding the string is not aware of making, while the weight tied to it conserves the movement and helps turn it into a regular swinging motion known as Chevreton's Pendulum.

The same principle applies to so-called magic devices where, for instance, a person may ask a question and believe that the clockwise or anti-clockwise motion of the circles is providing an answer given by a spiritual realm. It can also be used to explain dowsing and 'radiation detectors' that are claimed to be able to detect health problems when waved over a patient's body. In an experiment similar to how the Ouija board is used, scientists showed how care givers believed they were able to communicate with disabled patients by guiding their fingers around a keyboard.

Trick of the mind: The results of dowsing or Ouija boards are caused by tiny movements the person is not aware of making. Researchers found that although the care givers believed they were responding to prompts from their patients, the 'facilitated communication' messages were actually coming from them. Psychologist Daniel Wegner, who died last month, explained in his book *The Illusion of Conscious Will*, that the mental processes that directly control a movement are not connected to the processes that decide what caused the movement. Because of this, if a person is under the belief that they have not moved their hand, they are less likely to make a connection to any small movements that they have made.




PENNSYLVANIA LEGENDS: TUGGY THE WITCH

The Harriton House dates back to 1682. It was a land grant given by William Penn. Mr. Rowland Ellis built a home on that site, in 1704. Richard Harrison bought it in 1719. Although a Quaker, Harrison was a tobacco farmer from Maryland. He grew tobacco at Harriton too, and employed slave labor to farm the crop. It's thought, in fact, that Harriton was the northernmost slave plantation in America. One of the slaves was named Tuggy, who knew some voodoo. She didn't like it in Pennsylvania and wanted to return to her Maryland family. She tried to kill her hated owner, first by poisoning his morning cup of chocolate. But at knock at the door saved him from drinking the concoction, and Tuggy came up with a Plan B.

She went to the graveyard with a wooden stake. Some think she tried to raise a body from the dead to do her bidding while others believe she was trying to cast a death spell on Harrison. Whichever, it worked - but on the wrong victim. A bloodcurdling scream was heard from the graveyard that night. Being superstitious, no one ventured into the bone yard until morning.

There they found Tuggy's body, staked to a grave. The legend says that she accidentally drove the stake through the hem of her dress, and thought that a dead man's hand was pulling her down into the grave to join him. She died of fright.


