

CRYPTO: DUFFY'S CUT

"Duffy's Cut," as it's now called, is a short walk from a suburban cul-de-sac in Malvern, an affluent town off the fabled Main Line. 57 Irish immigrants met violent deaths there after a cholera epidemic struck in 1832. A local railroad worker told the ghost story to his family every Thanksgiving. According to local legend, memorialized in a file kept by the Pennsylvania Railroad, a man walking home from a tavern reported seeing blue and green ghosts dancing in the mist on a warm September night in 1909. "I saw with my own eyes, the ghosts of the Irishmen who died with the cholera a month ago, dancing around the big trench where they were buried; it's true, mister, it was awful," the documents quote the unnamed man as saying. "Why, they looked as if they were a kind of green and blue fire and they were hopping and jumping on their graves... I had heard the Irishmen were haunting the place because they were buried without the benefit of clergy." In March of 2009, the twin Grandsons of the railroad worker who told the tale found the burial site and the human remains. A 178 year old murder mystery solved from Granddad's Thanksgiving tale.

PENNSYLVANIA LEGENDS

In 1943, with the Second World War under way, the German Navy Wolf Packs were winning in the Atlantic. Their U-boats were wreaking havoc upon Allied military and merchant vessels. The United States had a secret weapon; it was a device that could cloak a vessel from radar. A Destroyer named the USS Eldridge docked at the Philadelphia Naval Yard was to be used for the first trial of the device.

The Eldridge was equipped with generators and coils capable of enveloping the ship in an electromagnetic field. This field, its inventors believed, could bend the light and sound making the ship invisible. At 9 A.M. on July 22, 1943, the equipment was put to the test. The generators were turned on and a green fog surrounded the ship, before vanishing—and making the ship vanish with it. The trial lasted for fifteen minutes, and when the generators were turned off, the Eldridge reappeared. The crew was disoriented, in a state of physical shock, and violently nauseated. The test was considered a success, but the effects on the crew were too severe for the Navy and it was never deployed.
