

CRYPTO OF PA

Werewolves & Dogmen

Every year there are reports world wide of a creature(s) that has the head of a wolf (or canine) w/an upright walking body covered in fur, usually standing 6 to 7 feet tall. The prints from past castings suggest the creature has feet much like a wolf, only much larger, & the hands more like human hands, designed to grasp things. Dogmen have been sighted drinking water from a river by cupping their hands, & have reportedly maneuvered door handles & such.

Although reports come from all over the globe, the Midwest in the U.S. receives more reports every year than anywhere else. Wisconsin tops the list w/Michigan coming in second. Historically, the Werewolf/Dogman accounts go all the way back to antiquity worldwide. There is however, a technical difference between a Werewolf & a Dogman.

•A Werewolf is a human who turns into a half-wolf/half-man creature for a period of time (for various reasons) & then changes back into human form. An example of this would be as follows... Someone shoots a wolf & tracks it down to a body of a dead human who was just shot. Or a rare example being a werewolf seen in clothing of some kind.

•A Dogman is a species of Cryptid where the animal is always in the same form, that being of a half-wolf/half-man creature w/the head of a canine & a body that can stand & walk upright. There has been as many as 5 in one place reportedly & they generally seem more aggressive than not.

There is a third kind of Dogman that is often overlooked. A Skinwalker. This would be the a spiritual version of the Dogman talked about in Native American, Indian, Oriental & Egyptian legends & more often associated w/burial mounds & grounds. These have also been spotted in cemeteries. These are said to be guardians of the tombs & mounds. They are dark wolf like creatures/apparitions w/red eyes. Their main purpose is said to be to frighten trespassers, burglars, & vandals from the resting places where the dead lie.

PENNSYLVANIA LEGENDS

TED BUNDY MURDERED A STUDENT IN PATTEE LIBRARY AT PENN STATE

"The stacks" in Pattee Library are creepy enough without knowing that a murder took place there in the 1960s. This much is true. The legend is that the murder was committed by notorious serial killer Ted Bundy.

In late November 1969, Besty Aardsma, a Penn State graduate student, was in the level two stacks of Pattee when she was stabbed by an unknown assailant. She was found lying on the floor and, because her red dress disguised what little blood there was, she was thought to have suffered a seizure. She was then taken to Ritenour Health Center, where she was pronounced dead. Only after an autopsy was the death ruled a homicide and an investigation launched.

It is not known where the rumor of Bundy's involvement came, but supposedly Bundy discovered that his real father lived in the Philadelphia area and visited him there in 1969.

Rumors and speculations aside, Bundy's movements have been well documented. He was in California by

Thanksgiving of '69. Fingerprints found at the murder scene do not match any in the National Crime Information Center database, where Bundy's would be on file. And the single, fatal wound Aardsma suffered did not fit Bundy's criminal profile. So while the case has not been solved, it is pretty safe to say that the Ted Bundy Penn State urban legend is not true.
