

## THE LINCOLN CONSPIRACY (New Light on the Assassination)

### Question:

There has recently been a book published, and also a movie is making the circuit now on the old question: "Who killed Abraham Lincoln?" The controversy is still going on, over a hundred years after his death, and it's all based on the finding of 18 pages that were missing from the diary of John Wilkes Booth. These pages turned up in the family of Edwin Stanton, who had been Lincoln's Secretary of War, and who had been linked by rumors to the assassination plot. The question is: was Lincoln the victim of a secret conspiracy, reaching into his own cabinet? Was Frederick Douglas, the Martin Luther King Jr. of the Lincoln era, also marked for murder? Did the assassin, John Wilkes Booth, actually escape and leave another man's body in his place? Some of these questions, they think, have been answered by this missing diary, although there is more to this story, they're pretty sure, and they're not sure that the diary isn't a fake. Would Awareness please clarify, once and for all, the question of the Lincoln conspiracy, if any?
