





HOW GLOBAL 2000 CAME INTO BEING

(THE CLUB OF ROME AND THE ATLANTA MURDERS)

FIRST, THE BAD NEWS....

QUESTION:

A question from A.P., SPIRAL of Philadelphia:

"Would Awareness please comment on our impressions about the Atlanta murders? It is now our impression that racial strife was to have been a superficial or extra gain. We have attempted to pick up impressions about this, and what has come through is 'Khadafy... Black Muslims..' and a man's name-Koldar, Culder or Calder (spelt phonetically). This appears to be one segment of a study for population control by which interactions among sickle cells, male hormones having to do with maturing, and chemical substances were related to docility and aggression, and the corresponding changes in the brain for these two emotions. It may also involve the use of a chemical to produce a pituitary growth hormone deficiency, by which black boys would be prevented from maturing into men. Another sample of people in the over-all study were the white boys said to have been killed by Berkowitz. The total study includes youth and adults of each race and will include females in the future. It involves the *Club of Rome*, is an international study, and is being carried out in several countries at this time."

COSMIC AWARENESS:

This Awareness indicates that this is accurate. This Awareness indicates that this is including many countries and many forces; many of these not being fully aware of what is occurring. This Awareness indicates this is associated with the *Global 2000* plan of diminishing the population on the earth. This Awareness indicates that this plan was devised some time back, approximately 10 years previously, and has been in development for some time. This Awareness indicates that this is having certain justification from a particular viewpoint, if entities can accept such justification. This Awareness indicates that in looking at this from the viewpoint of the world planners, (those who manipulate the masses), to understand their thinking, (not to condone their thinking); this Awareness wishes to give you at this time, the scenario of why and how they came to this conclusion.

This Awareness indicates that the resources of the earth are quickly being depleted by the consumers of the earth, who are multiplying at alarming rates, mushrooming in terms of population growth so that proportionately, they are increasing in number in quantum leaps. The resources on earth, being in limited supply, are being depleted by these increasing number of entities, of hungry and desirous beings who, to the world planners, are of little more significance than numbers on a computer. This Awareness indicates that the use of these entities, the labor force of millions and billions of laborers to create cities, highways, homes, parks, waterways, ships, trains, airplanes, vehicles, to service and create these systems; the use of these many laborers to create such wealth and civilization has essentially run its course, and now machines, or few laborers are necessary for the maintenance of that which has already been created; and further creations are only necessary to accommodate the increasing population which is depleting the resources, such as food and oil.

This Awareness indicates that these world planners, therefore, see that to now reduce the population, rid the earth of approximately 3 billion entities, would be an economic move that would leave a kind of paradise for those remaining, whereby all of the fruits of labor from those entities now removed would fall to those who remain, whereby each nation around the world would have its own cities, its own resources in plentiful supply, and the choice of many places to go and to be. This Awareness indicates these entities would inherit the earth with all of its goodies. This Awareness indicates that these world planners see that the alternative would be to watch the population continue to grow, to develop from 4 billion to 7 billion within approximately 20 years. From 7 billion, the energies would be depleted much more quickly, starvation would follow, chaos and social strife would follow, and still population would continue to rise, unless some program were developed to stop the population growth.

This Awareness indicates that the world planners see the future as being bleak if they do not take some drastic action to limit population growth; and yet they see little efforts by those Third World countries to take such action, to educate the people to limit the population growth. This Awareness indicates that therefore, they see the necessity to bring about the destruction of these entities through famine, pestilence, biological warfare, disease and physical warfare. This Awareness indicates that this concept was briefly mentioned in the movie called *Executive Action*, that which dealt with the fictionalized version of the assassination of John F. (DEPOPULATION BY SLOW DEATH IS GOOD BUSINESS FOR A.M.A.)


This Awareness indicates that for entities to hope to survive through the end of the century, the survival will require that entities be very much aware of what is occurring. This Awareness suggests for example, the program is in effect whereby beef is being used to poison entities with certain additives put into the beef which has a growing effect on the system of creating various physical problems, including heart conditions, circulatory conditions, cancerous conditions, and a dullness of the mind, whereby the mind ceases to lose its ability to think clearly; these additives in the beef as that which has been introduced *with the knowledge of the medical profession.*

This Awareness indicates that this type of program can be expected to continue in other areas also; that these additives may also be added to chicken, turkey, pork, and other areas. This Awareness indicates that during the future years, those entities on a vegetarian diet will survive best in terms of food intake. This Awareness indicates that also those who raise their own or receive food from known sources, not using commercial feeds. This Awareness indicates that there are also programs being prepared whereby masses shall be destroyed through plagues and biological warfare.

This Awareness indicates that there is not a great deal of hope for the masses of humanity at this time, depending on whether new levels of awareness and planning can be brought upon this plane. This Awareness indicates that entities seeking security upon this plane shall find that it is a fleeting quest; and entities identifying with the physical, shall find it a poor foundation. THE CATHOLIC CHURCH CONNECTION

QUESTION:

Would Awareness explain a seeming paradox in relation to this, that as I understand it, the *Club of Rome*, which is one of the masterminds behind the *Global 2000* program, is a branch of the Catholic Church; yet it is the Catholic Church for the most part, in these undeveloped lands, Third World countries, with its stand against birth control that for centuries has created this very problem. Now, a few years ago the Pope issued a bull that told the Catholics that they could now eat fish on Friday after many, many years of being told it was sinful to eat meat on Friday, rather than just fish. Why couldn't the Catholic Church issue a bull reversing this stand on birth control, and therefore stop this population in these Third World countries?

COSMIC AWARENESS:

This Awareness indicates that the *Club of Rome* as associated with the Illuminati, rather than with the Catholic Church.

QUESTION:

Wouldn't it still be a good idea for the Pope to let up on his stand on birth control?

COSMIC AWARENESS:

This Awareness indicates this in the affirmative. This Awareness indicates that the reason for such loyalty to concepts of birth control, is that the more Catholics born, the larger the Church becomes, and the greater its power.* This Awareness indicates that the greatest population explosion is occurring in the Eastern and Mid-Eastern countries. This Awareness indicates that areas of South America are also increasing at alarming rates, this area being strongly, predominantly Catholic. This Awareness indicates that the United States as that which has curtailed its population growth; but that in the United States the lower number of birth has occurred in the middle-class and upper-class white section, while those of the other races, and of the welfare levels have increased. This Awareness indicates that these are also concerns of the *Club of Rome* and the world planners in that the non-producers are the fastest breeding of the masses, creating more hunger, more need, and producing less to answer or satisfy the needs.

In this sense, the Catholic Church is channeling these same evil forces and the question asked previously in regard to this is really only moot.

MASS MISMANAGEMENT AND IGNORANCE THE BASIC REASON FOR MASS POVERTY (THE AVATARS ARE NOT TO BLAME)

QUESTION:

In the message that was just given about not thinking of earth as being your home and what-not, was Awareness trying to tell us that Bill Sheppard's assessment is at least partially correct,--that the Avatars have messed up somehow, and we're not looking toward the kind of hopeful future that we had been speaking of earlier?

COSMIC AWARENESS:

This Awareness indicates that it is not an action which can be placed upon the shoulders of the Avatars. This Awareness indicates that this is the result of mass-mismanagement upon this plane, brought on in part by lack of education, lack of funds for education, through manipulation of money and its power, whereby certain nations were left to flounder in ignorance and poverty, while certain segments grew rich and wealthy and gained power, whereby education has been limited or curtailed by religious dogma, and by lack of energy, money, or dedication to the principles of healing and teaching.

This Awareness indicates that the mismanagement is that which began hundreds of years ago, and has continued in the pursuit of power, rather than in the pursuit of teaching, sharing and cooperation among entities, among nations, among cultures. This Awareness indicates that the only way that nations and people can survive at the present status, or level, or anything



to limit population growth through non-violent means, through education and through mass-teaching and technology; and to divert war machinery, energy, money and technology from principles of war and violence to principles of peace, whereby food may be grown and developed to serve and feed others.

This Awareness indicates that if even the tobacco companies were to cease growing tobacco and put their land into food, most of the population which now is starving could be fed. This Awareness indicates that as long as greed and profit motivates entities who have position, power, authority and influence, then there will always be those who suffer from the lack of proper management and dispersion of the energies, commodities, production and education that could otherwise be available.

QUESTION:

Would Awareness confirm that the *Club of Rome* has absolutely no connection with the Catholic Church?

When reading these various publications, keep in mind what Awareness has told us about frames of reference. 


This Awareness indicates that there need to be educational programs to teach the masses about the manipulations of corporations whose sole interest is in raping the earth to gain whatever power and economic

Now the question is: The last time we received this weekly paper was in August or September. This is the second long interruption of this newspaper, and the last issue had an editorial titled "*No Limits to Evil*, which was a long

editorial relating to the Club of Rome and how it has been perpetuating the *Global 2000* concept. I'd like to ask Awareness if the Illuminati has finally stifled the *New Solidarity* because of this information, or are they going to resume publication?

[ED's Note: shortly after this question was asked, C.A.C. started receiving the *New Solidarity* paper on a regular basis. This has continued to date. The paper announced that all subscriptions would be extended to make up for the missing issues.]

COSMIC AWARENESS:

This Awareness indicates that this appears to be a difficult time for this organization. This Awareness indicates that there appear to be opportunities in the future whereby publication will resume. This Awareness indicates however, that for this organization, and for many other organizations, there can be continued difficulties for some time. This Awareness indicates this appears to be more of a financial difficulty at this time. This Awareness indicates however, that there may, at future times, be other problems accompanying the financial difficulties. This Awareness indicates this including legal difficulties and political harassment.

This Awareness indicates that essentially, the noose is tightening on many levels; that there are bills being introduced into the Senate and House which can be used at later times, (if not in present time), to further curtail the freedoms guaranteed by the Constitution of this United States. This Awareness indicates that the future is not fixed, yet energies are in movement. This Awareness indicates that possibilities of reprieve and future freedoms are still available, even though threatened. There's a publication called the *Countdown*, * put out by Stanley and Elva Cronkhite of Polson, Montana, which we exchange with. In their September issue, they say, "D-Day for Central America is to be sometime in September in preparation for the Oct. 22nd, 1981, 22 nation North-South Summit meeting at Cancun. Dennis Small (8/8/81): 'Every single country in Central America

is now being actively destabilized, with the chaos in each converging on an areawide blowout sometime in Sept... the destabilizations are being executed on both the "right" and the "left" by a small cabal of Jesuits and Socialist International leaders, who are reportedly being coordinated by the Jesuit Father Avery Dulles, S.J.--the son of former U.S. Secretary of State John Foster Dulles' (and also a member of the Rockefeller family). As New York Times Gloats

'Global 2000' Plotters Starving 150 Million Africans

March 28 (NSIPS) Eight months ago when the Ad Hoc Committee for a New Africa Policy was urgently reporting that 20 million people in Africa were in immediate danger of starvation, and that up to 150 million faced that danger in only months ahead, the New York Times lyingly claimed that only 10 million Africans were in danger of starvation.

By deliberately underplaying the crisis then the Times report worked to undermine the efforts of the forces led by the Ad Hoc Committee to force a U.S. program that could begin to aid Africa before drought and famine became irreversible.

Now when it may be too late, the liberal New York Times printed a page ten article March 28 entitled "Famine

Confronts 150 Million in Africa," complete with a map showing the 30 countries most affected.

The Use of War

"The areas of Africa most hard-hit by famine," said Cynthia Parsons, a Committee for a New Africa Policy (CNAP) spokesman on hearing of the Times feature, "are now being targeted with wars and additional refugee flows, as in El Salvador, resulting from set up U.S.-Soviet conflicts."

"Coming on top of an already disastrous economic situation due to the conditionalities policy of the IMF, as well as the anti-industrialization policy of the World Bank," Parsons added, "these wars will cause the situation for increasing numbers of the victims of this holocaust in Africa to degenerate beyond

the point where it can be turned around even if the effort is made."

The Committee for a New Africa Policy was formed after an Aug 14 meeting in New York City attended by representatives from farm and labor organizations, corporations, and delegates from the Carter, Kennedy, and LaRouche Democratic campaign organizations. The Committee then petitioned President Carter to exercise his emergency powers to direct the U.S. Commodity Credit Corporation to purchase 18 million metric tons of wheat, grain, and dry milk to be shipped with dispatch to Africa to alleviate the worsening conditions of hunger and death.

The appeal was widely endorsed, but Carter responded by only shipping 800,000 metric tons of grain.

The New York Times has its own filthy reasons for reporting the emergency facing 150 million Africans now.

The article does list the reasons for the African holocaust:

- the rising price of oil, which depleted the budgets of African countries, making the necessary infrastructural investment in food production impossible;
- the switch by African countries from food to cash crops in a desperate attempt to make up for the balance of payment deficits resulting from the rigged oil price increase; and
- war.

The article does not propose attacking these causes of the crisis. It claims that reduction of the population of the already underpopulated continent is the

only way the crisis can now be resolved. The article quotes one family planning official saying Africa will "just have to go begging unless we can stop the population explosion."

The aim of the New York Times article is not to mobilize Americans to stop the death of millions. Its purpose is to accustom Americans to the idea of genocide in Africa.

The Times revealed the Global 2000 it demands for Africa in an op-ed published March 9, which advocated sending no food to Africa. Said its author James Harkin, there could be a crisis in which "millions would die in weeks. My guess is that they would go silently to their graves. Then at least the problem of hunger in Africa would be solved."

David Rockefeller Kicks Off 'Corporate Global 2000'

March 24 (NSIPS) - The supranational corporations backing "Global 2000" have formed a high-powered group to lobby for the report, which calls for the U.S. to reduce world population by 2 billion people through wars, famine and disease by the turn of the century.

Action for World Development was launched this week by David Rockefeller, chairman of Chase Manhattan Bank, at a farewell dinner for Robert Strange McNamara, the outgoing head of the World Bank. Addressing an elite audience at Manhattan's River Club, Rockefeller called for a "blue-ribbon panel of American opinion makers" to "re-examine" and reform U.S. foreign aid and credit policy to the Third World.

Rockefeller is floating a trial balloon for the Action Committee," said Paul Wilson of the U.S. Chamber of Com-

merce, chief corporate organizer for Action for World Development.

Action for World Development is officially dedicated to "reorient U.S. export policy... to reduce excess population in the Third World," according to Sharon Camp of the Population Crisis Committee-Draper Fund said. Action's official sponsors are the Draper group and the Committee for the Year 2000, the official support group for Global 2000.

Action for World Development has already placed one of its key spokesmen, William Draper III of the Population Crisis Committee-Draper Fund, as new head of the U.S. Export-Import Bank. Under Draper, Ex-Im will halt financing of heavy industry and food to the Third World, and turn instead to mining and other slave labor projects to extract raw materials.

Industrialization means a buildup of

population." Camp claimed, but mining does not. "I must stress that this is primarily a population program, not a strategic minerals policy."

Together with David Rockefeller, big-time corporate backers of Action for World Development now include:

- Donald Kendall, chairman of Pepsi Co. Kendall, the incoming head of the U.S. Chamber of Commerce, is stacking the Chamber with Global 2000 supporters, and has hired U.S. Chamber organizer Paul Gibson to recruit corporations to the Action Group.
- Armand Hammer, the chairman of Occidental Oil.
- Former Secretary of State Cyrus Vance, who initiated the Global 2000 study and co-chairs the Committee on the Year 2000. Vance reportedly helped David Rockefeller draft his speech.
- George Ball, investment banker of

Wall Street's Lehman Bros-Kuhn Loeb who set up the State Department Office of Population Affairs which wrote Global 2000.

'Give Us The Money'

Action for World Development will soon begin lobbying the Reagan administration for billions of taxpayer dollars to set up vast raw materials projects in the Third World, said Paul Gibson today. This will be sold at a national security program, to develop "strategic minerals deposits for the U.S. defense industry."

"If this administration wants to have a strategic minerals policy, we can't do it without foreign aid support," said Gibson. "Give us the money to play with" is our message to Reagan.

Instead of heavy industry and agricultural development, the big minerals and

oil companies behind Action for World Development want labor-intensive mining and labor-intensive building of roads, ports, and rail to "allow us to go in there and pull the stuff out of the ground," as Gibson put it.

"In order to slow population growth, it will be necessary to provide labor-intensive jobs," said Robert Keating, a consultant to the Action group, who described a construction program which would actually kill the workforce, as in Hitler's Nazi Germany. "U.S. aid should finance labor-intensive construction of infrastructure," railroad gangs and the like, to support the mines, he said.

"Secondly, the Third World mining uses too much energy. These countries are importing too much energy, and this must be reduced."



The New York Times ran this map of Africa last week, with a caption implying that every nation except those shaded it was suffering severe food shortages. Eight months ago, when action could have been taken to avoid mass starvation, the Times was covering up the extent of the problem.

Recently N.Y. Democrat Richard Ottinger introduced H.R. 907, the Population Policy Act of 1981 and is now before the Congress. HOW DID A HANDFUL of do-good organizations do it? How did men in beards and women in sandals, largely talking to themselves, puttering around the world with a good but unlikely cause, manage to reach the political heights of the World Health Organization and humble the United States, with its terrible lone vote against the worldwide ethical code for marketing infant formula?

It's enough to make you take dead seriously their current international boycott against the Swiss-controlled Nestle S.A., the giant multinational foodstuff company that is the largest producer of formula worldwide. American Home Products and Bristol-Myers also market formula around the world.

Infant formula produces "bottle baby disease" in millions of infants every year. In countries where water is polluted and resources are scarce, it is almost impossible to use the formula properly. The formula is so expensive that some women try to stretch a three-week supply for four months, and the baby becomes malnourished. Many become sick and die.

Only a year ago the national chairman of INFACT (Infant Formula Action Coalition), Douglas Johnson, was telling this sad story to the crowd at a Washington fund-raiser and saying: "It's time now to bring [the boycott] to Washington, to the international community and to the government." The issue had rattled around United Nations' circles since 1972, but it was Johnson and INFACT that focused attention on the boycott worldwide.

INFACT had started in Minneapolis in 1977 with 20 members and a \$500 budget. They toured churches and schools showing the movie, "Bottle Babies," relying on a grass-roots network to spread the word. While other groups focused on antiformal campaigns, INFACT focused on the Nestle boycott.

In 1979, INFACT received foundation funding for a direct-mail campaign and sent out 6 million letters, attracting more funding, publicity and the attention of television stars such as Linda Kelsey of "Lou Grant."

"The grass-roots effort was needed to make it an issue," says Johnson, "make it controversial so health professionals would be heard by policy makers in the various countries."

Meanwhile, frustration was growing among international health agencies and workers who every day saw the lethal consequences of marketing infant formula in developing nations.

Small groups all over the world who had been working separately pooled their resources. The British, for example, got 185 members of Parliament to support a code not only for the developing nations, but also for their own country. INFACT began building a coalition of respected groups in the United States and other countries, gathering under its umbrella organizations of women, churches and health professionals.

The turning point came in October 1979, when INFACT was invited to participate in an international WHO-UNICEF meeting despite its nongovernmental status.

"We brought with us a knowledge of the industry's practices in the field," said Johnson. "We had experience negotiating with corporation executives sitting across the room. We had heard their arguments. We knew what was true and what was not. We weren't cowed and they couldn't bully us. One of the things

that prevented industry from taking it over was our participation, and our history with companies, and our negotiations over time."

Before last month's meeting and vote, INFACT's international network had monitored the practices of companies selling the formula. Many are predicting that last month's WHO vote will step up the boycott against Nestle.

INFACT expects people to stop buying Nestle products to force the company to negotiate and stop promoting baby formula in the Third World. They want us to stop buying Taster's Choice, Nescafe, Nestle's Quik, Nestle's Crunch, Nestea, Libby McNeil and Libby products. They want us to forgo the products of Nestle's subsidiaries — including Stouffer's hotels, restaurants and frozen foods, and L'Oreal cosmetics.

The ethical point here is that these companies represent industrialized countries, and it is our responsibility to keep them under control, rather than foisting that responsibility on the overworked and underfunded health workers in developing nations.

The Nestle boycott gives us a way to use our economic clout to save the lives of babies. It's up to us consumers to call a halt to millions of babies dying a year, because the thirst for profits has put these companies on an unscrupulous path.

Business Week recently reported that Nestle's percentage of 1980 profits is sagging at least in part because of the worldwide boycott. Nestle plans to bolster its business, however, by going after a larger portion of the United States' market — a prospect we can diminish by refusing to buy Nestle's products.

A movement that took off after 20 people from Minneapolis decided to take a stand has become a force in the world. We should make certain that it remains a force at home, too.

Church Turns Nuptials Down For Paralyzed Man

CHICAGO (AP) — A Roman Catholic official says the church is just "expressing the law of nature" in telling a wheelchair-bound man that if he is impotent, a priest cannot perform a wedding for him and his fiancée.

Larry Bonvallet, 32, a Presbyterian, says he wants to be wed in the church because his fiancée, a 26-year-old nurse, is a devout Catholic. But he said a priest at her church refused to perform the May wedding, and the church law has angered and bewildered the couple, straining their relationship.

"She doesn't think it's fair either, but she wants to stand behind the church," he said of his fiancée, who does not want to be identified.

The couple met at Riverside Hospital in Kankakee while Bonvallet was recuperating from a fall five years ago that left him confined to a wheelchair.

Church officials maintain that if Bonvallet is incapable of sexual intercourse, he is incapable of marriage.

"We have a certain understanding of what marriage involves," said the Rev. James Nowak, deputy chief justice of the marriage tribunal of the Diocese of Joliet.

"If someone is not capable of that kind of relationship, he's not capable of marriage. All we're doing is expressing the law of nature," Nowak said.

He said if there is doubt about a partner's ability to consummate a marriage, the church always gives the individual the benefit of the doubt. Only in cases where the chances of consummation are nonexistent will the church refuse to perform the ceremony, he said.

Bonvallet is a member of the Illinois chapter of the National Spinal Cord Association and counsels other disabled persons.

Bonvallet said he and his fiancée were astounded when a priest at her church, St. Stanislaus Church in Kankakee, refused to marry them.

"I was stunned, in shock. I couldn't believe such a law existed. I said, 'Isn't love and understanding in a relationship between the two of us more important?'"

Bonvallet said he and his fiancée don't want children. "For my fiancée, sex is way down on the list on her priorities," he said. "She doesn't like it and I can't do it."

Bonvallet said he and his fiancée probably will appeal their case to a higher church official.
