

## The Conspiracy Against Musicians

( WHY THE BEATLES SPLIT UP )

### QUESTION:

There's a newsletter called *Candor*\* put out by Aries Research of Aptos, California, and we have a copy which has a radio interview with Mae Brussell on the assassination of John Lennon. I'd like to read to Awareness just a little bit of this—an excerpt.

The Interviewer says: "Then you apparently believe that there was a government conspiracy to assassinate and silence John Lennon which was conducted by the same people who murdered other political figures and musicians in the past 18 years?"

Mae Brussell says: "Absolutely! The federal government has maintained active programs to eliminate rock musicians and disrupt rock concerts. Senator Frank Church's Committee hearings in 1975 and the FBI Cointel-Programs clearly document the intent to break

up any gatherings of the "new left". Nothing brought anti-war demonstrators together with political messages more effectively than music festivals.

"There is hard evidence the CIA assigned agents to "investigate the music industry". After the murders of Tim Buckley, Jim Croce, and Mama Cass Elliot, more information surfaced about the earlier mysterious deaths of Jimi Hendrix, Jim Morrison, and Janis Joplin. Listed below, but not updated this past year, are some of the rock musicians who have died since the Huston Plan and the FBI Cointel-Program were activated. If these people had been taking any kinds of drugs, there is the distinct possibility that specific poisons were added to their drugs, enough to be fatal, to make it appear that they had died from a simple "overdose."

"The murder of John Lennon is the tragic finale to an entire era, the reminder that once an artist becomes as popular and as political as he was, his enemies will be waiting to make sure his messages never appear again to awaken the slumbering youth."

And the list of rock people she listed: "John Lennon, Elvis Presley, Buddy Holly, Otis Redding, Brain Jones, Jimi Hendrix, Janis Joplin, Jim Morrison, Duane Allman, Mama Cass Elliot, Gram Parsons, Phil Oakes, Marc Bolan, Keith Moon, Paul Kossoff, Jim Reeves, Berry Oakley, Tim Croce, Richard Earina, Lenny Bruce, Larry Williams, Bon Scott, AC-DC, Rickie Valens, J.P. Richardson, Ronnie Van Zandt, Steve Gains, Sid Viscious, John Bonham, Steve Parson, Bob Marley, Sal Mineo, Brian Epstein, Beatles manager. Michel Jeffery, Jimi Hendrix manager; Rod McKernan ('Pig Pen' of the Grateful Dead); Donald Rex Jackson, Grateful Dead manager."

...I'd like to ask Awareness if this entity's statement and deductions on this government conspiracy against rock stars has any basis in truth?

#### COSMIC AWARENESS:

This Awareness indicates this in the affirmative. This Awareness indicates that there are many others not mentioned, because they are not so well known. This Awareness indicates that the drummers of the various bands being the most vulnerable targets.

This Awareness indicates that the main reason the Beatles separated was because they recognized the danger and decided they would be safer separately. This Awareness indicates this particularly in the minds of two of these entities. This Awareness indicates that John Lennon as one who was beginning to resurface, to start again his career, and this entity's assassination was an effort to warn others, as well as to stop this entity from continuing any political statements.

This Awareness indicates that it is not simply an action of government; this as associated with that which may be termed the Illuminati and the Mafia and also other hidden forces as well. This Awareness indicates there is what may be termed a conspiracy against musicians, comprised of different segments of society; some working for profit, others for political purposes and for power. This Awareness indicates that it is not too difficult to recognize which of these musicians operated as a threat to certain concepts espousing certain ideas which would seem as a threat to certain segments. #### QUESTION:

Would Awareness explain how the battery acid was introduced into the body of the entity Jimi Hendrix?

#### COSMIC AWARENESS:

This Awareness indicates this as injected. This Awareness indicates that the Beatles' manager also was destroyed in a similar manner as a warning to these entities, and also to create a change in their financial plans and directions. This Awareness indicates that these drummers being destroyed, are.....This Awareness indicates that it is inappropriate to probe further in these areas, as there are forces which need to be exposed in other, more mundane expressions, rather than through this channel.

#### WHAT KILLED ELVIS PRESLEY ?

#### QUESTION:

The entity Elvis Presley was supposed to have had a heart attack at age 40 or 42, and right now they are having a jury trial of his doctor whom they claim gave him too many drugs, and the autopsy reported that the entity had many different types of drugs in his system. Was the entity Elvis Presley a victim of this conspiracy, or was it just carelessness on the part of his doctor?

## COSMIC AWARENESS:

This Awareness indicates this particular situation appears to be a combination of a continually growing demand by the entity Elvis Presley for drugs which could be used to improve his performing ability, the fear of his own falling career, the need to have some type of assistance to give him that which he was losing, and pressure mounting on the entity of a psychological stress nature, along with the physical reactions to the many drugs the entity had been taking; and the doctor, being somewhat overly accomodating rather than discerning what was needed, gave the entity that which he felt was wanted and could be beneficial for the short-range needs of the entity.

This Awareness indicates that there were others near this entity who recognized that he was slipping in health, in behavior, in his ability to be of service in the area of performing, and who could have assisted in helping to prevent the entity from continuing to slide. This Awareness indicates however, this entity Elvis Presley as having a strong determination, and would not easily be influenced away from any habits which he had. This entity as having a death wish at the end,--and even though it would have been possible for associates of the entity to influence some form of intervention that may have saved the entity's life, this did not occur,--in part because they did not wish to risk losing his affection, (many of these entities being followers rather than friends who would risk their own station or status with him, in order to be of benefit to him). These admirers and followers simply hung around, allowing him to dictate and to move as he chose, even though they could see he was destroying himself.

This Awareness indicates that this, in part, was due to greed factors; entities not wishing to lose the potential crumbs of economic splendor which this entity often dropped their way. This Awareness indicates that the cause of this entity's passing was not political, but rather was due to negligence and greed and to his own poor habits and falling career. This Awareness indicates there were however, forces which had some influence over this entity who could have attempted to intervene, but saw more profit by allowing the entity to continue in his direction, seeing that the entity, when dead, would be worth more than alive, as the past music would then be again brought into public focus, and the present career was not faring well. This Awareness indicates that these entities did not lead to this death, but did not intervene when recognizing the probability that would occur if the entity continued in his path. ## QUESTION:

One final question while we're on this subject of rock bands: During the Vietnam war, there were many many bands that were outspoken against the war and had

great followings, but since that war is now over, the majority of the rock bands today don't really sing about significant subjects like that, with a few exceptions such as Jackson Browne, who is very strongly against the nuclear power plants that are being built in the United States and actively goes against these. There are a few bands that are coming out with songs about the nuclear build-up, and I was wondering if these bands (the few that are beginning to speak out against some of these subjects), are more likely, even today, to be gone after by these powers than the less significant bands, or is that a problem anymore?

## COSMIC AWARENESS:

This Awareness indicates that this as being somewhat questionable in that many of the bands which had members removed from this plane become more popular after the assassination of these band members, and these forces recognize that destroying certain bands or their members merely increases the popularity of their message. This Awareness indicates while, on the other hand, some of these bands, not having such publicity to begin with, were not continued in terms of popularity after the loss of members or the break-up of the band.

This Awareness indicates that this depends on two major factors: the psychological profile of the entities involved; whether the remaining members of the band would be intimidated by the loss of one member; whether the entire band would be destroyed, such as in an airplane crash or similar accident,--or whether the band had reached such a point in its career that if destroyed, the music having already been presented, would be carried forth in consciousness, and if the messages already presented would be carried forth in consciousness with greater popularity than were the band to continue. This Awareness indicates also, the consideration of whether the band will become more and more outspoken, and more and more popular in the future.

This Awareness indicates there is no definite way to discern, except on an individual basis, as to the danger involved for these bands and entities. This Awareness indicates also, that because of those musical expressions

from the '60s and '70s, there are more people aware now; and it is more difficult for forces to silence those who are speaking out, who are singing, who are expressing and disclosing information. This Awareness indicates that it is essentially much safer today for entities to be outspoken than it was during the Vietnam war. This Awareness indicates however, there are certain forces in movement who may create laws and situations which would clamp down on freedoms, such as freedom of speech, freedom of expression,--and this could greatly affect these areas.

This Awareness indicates essentially, it is a race between forces who would silence the truth and forces who would disclose the truth. This Awareness indicates there are also those who could care little about the truth, so long as they can find ways of making profit and finding pleasure. These musicians often promote any type of gimmick or ridiculous absurdity in order to get some kind of reaction and profit.

### MARKED FOR DEATH?

#### QUESTION:

Could Awareness comment in a general sense, without getting into anything too sensitive, what *It* meant when *It* said that 'drummers were particularly vulnerable'?

#### COSMIC AWARENESS:

This Awareness indicates that those in the area of rock music are aware that many of the drummers of the bands have become the targets for assassinations. That these entities often are less popular; and therefore, when these entities are destroyed, the public is not so aware that anything has occurred. This Awareness indicates without the drummers, most bands fall apart. This Awareness indicates that it is the foundation for the band; and when a good drummer no longer exists, the band loses popularity when it attempts to find a less talented drummer to fill the spot.

### MAE BRUSSELL. ANOTHER REPUTABLE SOURCE OF INFORMATION

#### QUESTION:

This entity, Mae Brussell, according to the literature put out, is a noted assassination/conspiracy researcher, and she has been broadcasting for eleven years on radio station KLRB of Carmel, California, and that audio tapes of her many broadcasts are also available. I'd like to ask Awareness to look at this entity and see if she should be added to our list of those sources of information that entities can get which would not be considered part of the "controlled media"?

#### COSMIC AWARENESS:

This Awareness indicates this as absolutely correct. This Awareness indicates that this entity as having much information which is of great value. This Awareness indicates that the entity is giving information from various sources. That some of her information is, in part, speculation; yet in the general sense, she has acquired a grasp of the pattern which serves to allow her to unravel and understand what is occurring. This Awareness suggests this entity's information as being approximately 80% accurate in details, and approximately 85% accurate in generalities. This Awareness indicates that the volume of information available from this entity surpasses most other sources.

Your information is interesting. Some is fine. I mistrust any group that keeps quoting PETER BETER. He was OK years ago with missing gold, Ft. Knox. Somebody got to him, those SECRET SOURCES, that is. His Jonestown is so far off the wall it is laughable...and distracts from the truth. Paul told me Dr. Beter had never heard of Mae Brussell and we should send him one of her tapes.

We have never met anyone yet who has not at one time or another expressed some doubt about Dr. Beter's information, or at least certain specific information (Robotoids, for example). In fact, one of our 'very psychic' members has recently informed us that Dr. Beter has been programmed by the Skoptsis, perhaps psionically, and is not aware that this has occurred. His theory being that the Skoptsis are not really benevolent Christians at all, but a bunch of religious fanatics who plan to take over the world and castrate every man and woman in it, thus ending all reproduction and eventually returning all entities to the Source etc. According to the channeling of this psychic, the Skoptsis have put forth a 'curtain of illusion', created by certain Russian psychics, designed to influence channels like Dr. Beter and Paul Shockley, by introducing false data. 

## THINGS YOU SHOULD KNOW ABOUT THE DEPRESSION NOW OCCURRING

(Opening Message, C.A.C. General Reading )

### COSMIC AWARENESS:

This Awareness indicates that the economic situation appears to be that which at present time as being the most urgent concern of entities. This Awareness indicates that this appears to be that which needs to be looked at in deeper levels for clarification of certain events which are occurring, that entities might be more capable of understanding the events. This Awareness indicates that this particularly in reference to the economy of the United States, which is a central concern of the economies of the Western World.

This Awareness indicates that apart from the gold concerns in terms of currency backing, or the lack of backing, and considering only the manipulation of interest and taxes and the productivity; this Awareness wishes to call attention to certain programs which are being administered by this present administration and to reflect on the consequences of these programs.

"Are you better off today than you were 4 years ago"?

This Awareness indicates that you may recall during the campaigns the entity Ronald Reagan addressing the public, asking them to ask themselves: "Are you better off today than you were four years ago?"

This Awareness indicates that this question as that which assisted greatly in helping this entity to gain the votes needed to enter into the present position. This Awareness indicates the implication being that this entity had solutions which would bring about better situations for entities than they had experienced during the Carter administration.

This Awareness indicates that in looking at these programs which this entity is instituting,--the cutting off of many energy conservation and research programs, the cutting of welfare and humanitarian programs, medical programs, educational programs and service programs, eliminating those programs which serve the public, while increasing programs which serve private corporations, and which serve the military-industrial complex, increasing the military budget and war equipment;--this Awareness indicates that this budget creating a deficit that has no parallel, and creating a situation whereby unemployment grows more prevalent at a higher rate than ever recorded in this country, (the unemployed being approximately three times greater than during the Great Depression at this time, and increasing daily.)

This Awareness indicates *this as but the beginning*. This Awareness indicates that the situation being that the unemployed cannot pay taxes; that many who are faced with mortgage payments on property will lose those properties to the banks and to the corporations which control these concerns. This Awareness indicates that many of these entities will find their years of labor being brought to nothing, whereby they lose all they have gained from years of faithful and continuous work on their jobs and careers. This Awareness indicates that many of these entities being unemployed and desperate will turn to crime, thus there will become greater need for law enforcement of a heavier nature, more stringent controls, while at the same time, greater social upheaval.

This Awareness indicates that the institution of greater military budget will bring about contracts for various corporations to build equipment parts and machinery for war, and this will then serve as a way of swallowing up the unemployed, as these entities devote themselves to job-seeking in these areas; and once committed to a job, also commit themselves to the war production which the job implies.

This Awareness indicates that as these entities become involved in the mechanics and machinery of war, they will also give their support to the war efforts. This Awareness indicates that therefore, this administration has shifted from programs such as solar energy research and fossil fuels research and social programs related to education and to medical care and to various other social services programs, toward that which shifts the people's energy toward a militaristic society. This Awareness indicates that this effort may bring about a temporary stabilization of the economy for many entities so that they again will have jobs based on military contracts.

This Awareness indicates however, the deficit meanwhile, as that which will grow ever higher as taxes from the unemployed are not taken into your treasury, and the social unrest will create greater expenses and drains on local and state and national treasuries. This Awareness indicates that the economy in its move downward, while interest rates remain high so that the building and construction industries are falling and failing, thus eliminating housing and furnishings which go with new housing, and all of the occupations associated with

such (the auto industry also failing); this Awareness indicates that these high interest rates as that which is stifling the productivity of the people, for entities are not only unable to work, but are also not able to purchase when they do have work, because of the high interest rates.

This Awareness indicates that during this coming time, while taxes are increased in many areas, unemployment increases and poverty increases, and wherein the interest rates continue high and prevent the people from spending, thus closing off further jobs, and while the depression increases, you will increasingly hear politicians of different bureaucratic station point the finger toward each other, and begin blaming the other for the continuing decline.

This Awareness indicates that as the economy worsens, these entities will not point the finger at each other simply to shift the blame, as it appears, but rather this action will be designed to confuse the public, to make it appear that these entities themselves are confused in general, and do not know what they are doing, or are at odds with each other on how to do it. This Awareness indicates the message *It wishes you to understand*, is that these entities *know full well* what they are doing, and how they are doing it.

This Awareness indicates this depression is orchestrated by a certain formula which is being followed exactly as was written. This Awareness suggests that with this in mind, you may watch the orchestration, and better better understand the score.

## THE LONG HOT SUMMER COMING COULD BRING IT ALL DOWN UPON US

### QUESTION:

Awareness, with the unemployment, particularly among the blacks, so high,--25%, I believe is the figure currently being quoted; there has been information circulated by the blacks, that if this trend is not reversed, it is going to be "a long hot summer." ## Chrysler Gets Army Contract Of \$189.8 Million

WASHINGTON—Chrysler Defense Inc., a Chrysler Corp. unit, received a \$189.8 million Army contract for work on M1 and M60 tanks.

Ford Aerospace & Communications Corp., a Ford Motor Co. unit, got \$156.2 million in Army and Air Force contracts for missile and artillery parts and satellite control equipment.

General Electric Co. received a \$102.9 million contract for Air Force electronics work and jet aircraft engines.

Hughes Aircraft Co. received a \$78 million order for Army helicopter radar and armored vehicle equipment, classified facilities and Navy electronics work.

General Motors Corp. received \$55.8 million in contracts for Air Force jet engines and Army tank engines.

Emerson Electric Co. got contracts totaling \$39.9 million for Army work on anti-tank missile launchers and carriers.

ESL Inc. received a \$39.7 million Army contract for aircraft electronics work.

Fairchild Industries Inc. was given a \$35.2 million Air Force contract for A10 aircraft support.


#### COSMIC AWARENESS:

### COSMIC AWARENESS:

This Awareness indicates that this as in the affirmative. That there are certain areas wherein the underground water flow creates an emanation of energies which affects those who live above. This Awareness indicates that information has been given previously by this Awareness on putting copper wire around your home, if you live in such vibrations.
