



HOW KARMA IS DETERMINED

(Stepping on ants and spiders)

QUESTION:

A question from J.P., Pensacola, Florida. He'd like to know if Awareness has ever given any information on the vivisection of animals. He says, "A number of our group are involved in a big fight with county government, working toward making them stop selling pound animals to Tulane University, for the so-called medical research. The vivisection practices of the medical labs should make a good question for Awareness. One wonders what karma the vivisectionists are building? Would you ask Awareness to discuss this subject?"

COSMIC AWARENESS:

This Awareness indicates that there are many forms of violations which occur on the earth plane among entities who are insensitive to the feelings of others. That the violations to animals as another aspect of this type of insensitivity. This Awareness indicates that karma does indeed result from such activities. That karma results from any form of torture, or violations to other entities. This Awareness indicates that the degree of karma involved in an action that creates a violation to another being will be appropriate and in relation to the development of that particular being which is being violated, and to the degree of, or amount of violation being given, and the motive behind the violation.

This Awareness indicates these being the main three factors involved in the determination of the amount of karma one acquires from an act. This Awareness indicates that in reference to the violation of another being, and its particular status on the scale of evolution, the destruction of insects, which are on a very low development level, creates negligible karma for the entity who violates these insects, but as the being evolves into higher development levels, the amount of karma which is required from violation to these beings is higher.

This Awareness indicates that when discussing the evolution of a being, this is in reference to its spiritual evolution as well as to its physical evolution. This Awareness indicates that violation toward a wild vicious beast which is not highly evolved carries less karma than violation to a domesticated and sensitive and loyal animal. This Awareness indicates that likewise, the violation to an individual who is not highly evolved is a lesser karma than to an individual who is highly spiritually evolved.

This Awareness indicates thus, the violation to one who is such as the highly evolved spiritual being, or one who has great influence in serving humanity, who is violated in an equal manner to one who is a criminal in nature, one who has harmed others or who is of low development spiritually; there is a difference in the degree of karma in each of these violations. This Awareness indicates that this is but one factor however, the factor being that the more highly evolved the creature that is violated, the greater the karma for the one who violates that creature.

The Motive of the Violation

This Awareness indicates that the other concern or factor involving the degree of karma is in the motivation, the reason for the violation; whether this is perpetrated as a deliberate act, or whether this is enacted from a kind of insanity or confusion, or whether this comes about from a level of awareness, or from a level of ignorance, or from the result of what appears to be an accident. The motive behind the violation is that which also serves as a measure of the amount of karma one might acquire from such violation.

This Awareness indicates there also is involved the circumstances which lead to the violation. That is, for example, some circumstances such as circumstances in war-time as opposed to circumstances in peacetime, where a violation occurs, those entities who are caught up in the frenzy of confusion, chaos, and the energies of war, who commit a violation, will not likely acquire the same degree of karma for their violation as would an entity who is acting in peacetime with a kind of deliberation, without the confusion of the circumstances of war, and who, through no particular reason or confusion of energies or pressure, violates the entity.

This Awareness indicates that also, in terms of experimentation with animals, wherein this is an action of violation to the animal, wherein the circumstances are in relation to a search for giving greater assistance or help in the finding of some answer to a question that can serve many and to serve these many in a manner that reduces suffering at the expense of an animal; the karma involved in the violation to the animal may be offset somewhat by the motive to help others to live more harmoniously.

This Awareness indicates that the Laws of Karma are just, and do take into account the motives and the necessity and the circumstances of the action and the spiritual value of the entity that is violated, and the awareness of ignorance of the entity who is violating. For example, an entity who is insane or who is partially insane, or who lacks spiritual awareness, is not likely to acquire the same degree of karma for a particular violation as would the entity who was fully aware, knowing the consequences of his action, being aware that the action was a violation, and went ahead with the violation anyway. That entity, having higher awareness and still violating another, will be more likely to receive greater karmic repercussions than the entity who is more dull spiritually and less able to discern and evaluate the consequences of his act.

This Awareness indicates that the dullness and lack of spiritual awareness in itself carries a particular karma and obligation, and the entity must bear this karmic cross, along with the cross of karma which comes about through the violation, but the entity already having a karma of being unevolved, may not receive quite so much karma for his act which violates another as would an entity who was more highly evolved who committed the same act.

This Awareness indicates that *It* can only explain these things in the light of karma acquired according to the principles involved in the measuring of karma. That *It* cannot state categorically that these entities who violate animals are evil and should be condemned, nor would *It* do such. This Awareness indicates that it is obvious from the principles of karma and the way whereby these Karmic Laws operate, it is obvious that there is some degree of karma involved in this type of action, according to the motive, the circumstances, the degree of violation, and the degree of involvement of the parties involved.

This Awareness indicates that from this, entities can make their own conclusions.

HOW KARMA IS EXTRACTED FROM THOSE WHO VIOLATE

(...MORE ABOUT THOUGHT-FORMS)

QUESTION:

Would Awareness give some examples of how the karma would be extracted by those who consistently violate animals?

COSMIC AWARENESS:

This Awareness indicates that entities who become involved in actions which violate others such as butchery of animals, or beings, tend to develop a kind of insensitivity, a fascination for inflicting pain, and in time this fascination, becoming fixated in their consciousness, if not reversed by some experience of great sorrow and compassion, whereby regret is felt; if continued, or if this becomes commonplace and without personal regret; the entity in time develops a kind of consciousness that is without feeling, being self-sufficient and incapable of compassion.

This Awareness indicates that this can in itself create a kind of psychological karma which denies the entity the ability to have close rapport and affection for others, and creates an entity who has a kind of aloof coldness and a sense of supremacy. This Awareness indicates that this quality in itself is a karma which the entity must live with until something alters the experience, whereby the entity cannot have warm feelings, compassion, and love and affection without a double standard and a kind of insensitivity in one hand, and hypocrisy in the other hand, wherein he pretends to himself to love his own animal, or to love others.

This Awareness indicates that this can of course, wherein a double standard occurs, bring about schizophrenia. This Awareness indicates that beyond this psychological karma, there is also the repercussions in terms of future experiences whereby the entity in a future experience sees the opposite end of the event, wherein for example the entity passes over, a portion of himself, the emotional portions, may be cast off from the entity to form the souls or thought-forms, or magnetic centers that become the seeds for animals, which then incarnate into the flesh, wherein the entity may experience the reality of being an animal, and whereby in this experience, the entity may even himself become subject to such experiments or to other forms of violation.


This Awareness indicates that this being not the entire soul of the entity, but being certain emotions of the entity. This Awareness indicates that of course, wherein the motives of the entity are toward the discovery of actions which can benefit and serve others, such as experimenting with vaccines on animals, experimenting with certain types of surgery on animals which are intended to serve and help others, such as people or other animals; the entity's motives, naturally being to help, will create a lesser degree of karma, whereby the entity is himself not likely to suffer, although a portion of his emotions, portions of his aura or astral shell may suffer and experience the pains and agonies similar to those which he inflicted upon others.

This Awareness indicates that the Laws of Karma are such that wherein an entity expresses a violation, the violated action does not always return in the exact same type of repercussion to the inflictor of the violation; the pains may often come in psychological or emotional repercussions. This Awareness indicates that such experience in terms of karma is unique and different. There is no way whereby this Awareness can explain how an entity, or how entities in general will experience, as an example for others, how entities will experience their karma. There is no way to give an example that applies to all things, for karma is a unique and individualized experience which comes about in part by the entity's own feelings of regret or guilt, and the entity's own judgment of self, as to what is appropriate for actions which have been committed in violation of others.

When the Violator Faces the Clear Light

This Awareness indicates that wherein an entity has committed violations to others, and comes before the Clear Light after death, and the Clear Light is the Light of Truth, whereby the entity faces his own self, seeing himself as he truly is, then the entity must come face to face with all of his or her actions, and in so doing, determine what is fair and just as a kind of repayment for the errors which have been committed and for the rewards which have been earned.

This Awareness indicates in this manner entities select the karma which they themselves deserve, and the selection is done by the Light of Truth, the Clear Light, whereby the entities must look at themselves for what they are, for what they have been, for what they have done. This Awareness indicates that karma is a rather complicated law to explain, yet it is the most simple of any of the Cosmic Laws.



Karma is simply cause and effect, which is measured by the mind of the entities involved in an action, in a cause, whereby these minds must determine through their natural process of events, what the effects will be. This Awareness indicates that an entity chooses the karma for his own actions, yet this too is not totally accurate, for wherein one or more entities are involved in the action, one or more minds and souls partake in the process of determining the karma.

Violations by the Drunk Driver

This Awareness indicates for example, an entity may have committed an action out of sheer ignorance, such as being drunk and smashing into another car full of people, whereby entities are injured or killed, great pain is suffered by these total strangers. The entity being oblivious to his action, is taken out of this plane; the entity then, not having much awareness of what he has done, in himself may feel that not remembering this action, he has no particular reason to feel guilty. This Awareness indicates in such a case, the other parties involved, knowing the extent of the injuries involved, participate in the karma involved. This Awareness indicates that the concept of karma is best explained by the recognition of cause and effect, whereby energies which occur which violate others, meet with some form of reaction that reconciles and brings about justice. This Awareness indicates until justice comes about, the karma is not resolved.

This Awareness indicates there are many ways whereby justice may follow an act.

WHY SOME PEOPLE COLLECT CATS & DOGS

QUESTION:

I was wondering about these people, generally little old ladies who are simply fanatics about cats usually, and oftentimes dogs, and they go overboard; they will stock their house with 15 or 20 or 30 of these animals, and exist in pretty miserable conditions with them, but taking care of them; and I was wondering if that might be in a way a karmic thing, that they had mistreated an animal or animals in a previous lifetime, and they were overcompensating for that action in this lifetime?

COSMIC AWARENESS:

This Awareness indicates that this could conceivably be a way whereby an entity might overcompensate in one life, to balance out karmic actions in a previous life. This Awareness indicates however, that in most instances this is not the case. Whereby entities have a strong affection for animals, this Awareness indicates that this may be an aberration of their own mind, whereby having experienced good relationships with certain animals during their earlier lifetime experiences, while children or while adults, they then perhaps decide that since they have no close companions, since they have no children living with them; the mothering instinct which they still carry can be transferred to that of mothering cats or dogs.

This Awareness indicates that these entities may be simply concerned about the welfare of these little creatures who are homeless, or who need to be cared for, and their sympathy is that which gives them a sense of purpose, a feeling of being needed by this family of animals, and can enrich their personal lives by being of service to these creatures. This Awareness indicates that this not necessarily a karmic repayment. That it can simply be one person's way of enriching their own lives, and enriching the lives of animals.

THE EYES OF THE CREATURES HAUNT THE HUNTER AFTER DEATH

(..COMING FACE TO FACE WITH PANDORA'S BOX)

QUESTION:

I read one time somewhere, that an entity who hunts animals, kills them for game, whether he eats them or not, upon the passing over he sees the eyes of every animal he'd ever killed, watching him, and he suddenly feels an intense amount of guilt, or a realization that he did violate these animals. Is there any truth to that?

COSMIC AWARENESS:

This Awareness indicates this in the affirmative. This Awareness indicates that these psychic energies, wherein one violates another, these energies become entrapped in the subconscious of the violator, and remain with the violator, and the violator ceases or lets go of the physical form and his identifications and merges into the reality of the soul, and recognizes the essence of his being, all of these actions and violations which occurred during his lifetime come into consciousness; from the subconscious level, they move into the consciousness. The veil of the temple is rent, the division between conscious and subconscious is torn, and the entity must come face to face with Pandora's box, the bottle, the genie, the energies which have been stored in his subconscious for all of these many years, whereby the entity then sees everything which he or she has done during his or her lifetime which is of significance.

This Awareness indicates that this does not mean that every insect which has been stepped on or killed will come into the vision of the entity to haunt him, for these things may be insignificant to his consciousness; however, if the entity consciously tortured an insect, and this made an impression on his consciousness and lodged in his subconscious, then the entity would quite likely recall this incident with great vividness, and thus sense the guilt for that action.

The Agony

**ALTERNATIVES
TO VIOLATING
CREATURES:**

...End duplication
of experiments

QUESTION:

Does Awareness have any alternative, or suggestions that could be made as an alternative to using animals in these research programs?

COSMIC AWARENESS:

This Awareness indicates that there is far too much butchering of these animals for purposes of research, for the duplication of the same research occurs over and over, and even after the completion of a research program, entities still continue repeating the same research that others have already done. This Awareness indicates that this particularly is found in schools whereby children and students are trained in biology classes, and whereby many of these programs could occur whereby the students view these things on film rather than having to repeat the same torturous experiments on new animals each day, each year, each decade.

This Awareness indicates that the karma of the earth is such that it is difficult to point out the grossness of the behavior of entities on this plane, for the entire system is geared to producing, raising, creating animals for slaughter. This Awareness indicates that in order to stop this action, entities would almost need to stop creating and raising animals for slaughter or for any other purpose, thus the animal population would need to be cut down or totally wiped out, for the approach on this plane to animals is to use these creatures.

This Awareness indicates that the use of animals is that which implies the butchering for scientific research or for food. This Awareness indicates that the use of domestic animals as that which implies giving these animals some form of household rights in exchange for their services. This Awareness indicates that the problem involved here is that the animals, unlike robots, tend to proliferate and to continue their kind, even in excess, thus it leads to efforts at animal control. This Awareness indicates that wherein there are too many animals, and the animals need to be destroyed in order to preserve some kind of stability, then of course the destruction of the animals would be seen as a waste without some purpose; therefore the animals are either eaten, or are used for experimentation. This Awareness indicates that yes, indeed, there are many ways whereby entities can make discoveries without using animals. They can become involved in further types of mental research. They can use herbal compounds

and experiment on the people who are ill. They can experiment on themselves. They can experiment on vegetation, or on cultures of growing amoebas and biological forms in laboratories.

This Awareness indicates that the use of experimentation on animals is often more rewarding in terms of the research, and less dangerous in terms of the use of people for such experimentation. That were they to spare the animals and experiment on patients, there would be an outcry of violation in this regard. This Awareness indicates that therefore, the karma of the earth is such that it forms its own nature of entrapment, and must work itself out very carefully, as these diseases and the discoveries and the sensitivity of entities on this plane progress so that these violations in time, are seen as unnecessary and inappropriate.

This Awareness indicates that it would be futile for this Awareness to attempt to inform entities not to violate animals, for the violations, the research would continue anyway, until entities become more highly evolved and more capable of discerning without such gross methods of research.

WHAT KARMA WHEN AN ENTIRE SPECIES OF CREATURE IS WIPED OUT?

QUESTION:

There was a news program recently on that subject, that showed that there was a certain species of small monkey that has been used so consistently in research that it is now an endangered species. There is only several hundred of these entities left in the entire world. I imagine that wiping out an entire species would also increase the karma by those entities doing this, would it not?

COSMIC AWARENESS:

This Awareness indicates this in the affirmative. This Awareness indicates that the danger of the scientific mind is that it can very easily slip into insensitivity, a kind of dehumanized mentality that does not have any compassion, and the lack of compassion can very easily slip into actions which do not discern clearly the difference between violating this species, or violating another, if it advances science. Thus, the scientific mind can become so insensitive and so lacking in compassion that it can destroy its own kind, can destroy its own people if it advances the pursuit of the science which it seeks to discover.

This Awareness indicates that entities involved in scientific research can become just as obsessed as any criminal or insane entity can become obsessed with an insane or criminal act.

THE SADISTIC TORTURE OF ANIMALS IN GREECE AND THE MIDDLE EAST

QUESTION:

There was a reading sometime back, where Awareness discussed this idea of this Catholic Bishop in California, who suggested the solution to the animals running loose in the streets was for these Vietnamese entities to eat them, and during that particular reading Awareness mentioned that there was a great problem in Greece about the torturing of animals, and that *It* would give information and a program that might help entities solve that problem. Would Awareness give that information at this time?

COSMIC AWARENESS:

This Awareness indicates that this not limited to Greece. That this is common in many of these countries, particularly in the Middle East and in the Orient. That there appears to be a greater tendency in these areas to violate animals in a manner that is not simply a willful destruction of the animals, or a use of the animal for scientific research; that rather it is a sadistic enjoyment in torturing animals.

This Awareness indicates that this is particularly strong in areas of the Middle East, and in Greece. That it is not uncommon for entities to deliberately torture an animal, and laugh and enjoy watching the animals suffer. This Awareness indicates that *It* does not wish to go into vivid detail on this other than to inform entities who are interested in this that they check this out further.

This Awareness indicates also, that in these countries there is much eating of these animals. These being dogs and cats. This Awareness indicates that in order to best bring about some type of international protest to this type of action whereby countries enact laws to prevent such cruelty, such as have been enacted in the Western world, the best approach would be to form an organization much as the Greenpeace organization was formed to protect whales and other species, and to form an organization which represents and speaks for the tortured animals of the world, protesting action, researching the facts, and demanding through publicity and through the United Nations and through international law, but particularly bringing to the attention of the world press the names of the countries which allow these animals to be tortured, and their rights to be violated without any form of protection from their governments.

This Awareness indicates that this being handled seriously by entities, could form a non-profit organization that would receive widespread support. This Awareness indicates that this as an organization which could grow and have great influence in regard to this. This Awareness indicates that many entities will see this as being unimportant or insignificant in comparison to human rights and violations to humans throughout the world. This Awareness indicates however, not everyone can be involved in the protection of human rights and there does need to be someone who is involved in the concern for animal rights also.

AN "AMNESTY INTERNATIONAL" FOR ANIMALS IS NEEDED AT ONCE

QUESTION:

Has Awareness any suggestions how this project might be started? For example, where information could be researched showing where and how these violations to animals are occurring, and the magnitude of such?

COSMIC AWARENESS:

This Awareness indicates that the Society for the Protection of Animals, the various types of societies already set up for this do have some information on this. This Awareness indicates that there also can be found information in research through libraries and through animal societies, and through animal protection societies. This Awareness indicates that any entity who wishes to start such an action may begin the action just as one would any non-profit organization. That to consult an attorney for advice would be wise.

PUBLICITY NEEDED TO ALERT ENTITIES THAT ANIMAL TORTURE EXISTS

QUESTION:

Would something like a boycott of these countries, publicizing this information, and asking entities not to go to those countries and spend vacation money until the government of that country does something about the violations to the animals...would this be an approach that might make their government look into this?

COSMIC AWARENESS:

This Awareness indicates that this can be very effective in having influence into these areas. This Awareness indicates that this approach will best be accomplished when an organization has the funds and communication outlet to voice or to spread the message, and the organization should also be aware of the facts in regard to the country wherein these violations have occurred. This Awareness indicates that much research would need to be done in order to first use this approach effectively and with accuracy.

This Awareness indicates that entities could solicit by writing letters, could solicit investigative reporters to check out these countries and this story, and to present the information on national television to waken the attention of the public to this problem. This Awareness indicates that this could be an action which would help spread the concern quite rapidly.



COSMIC AWARENESS:

This Awareness indicates that these birds are often bred to be more vicious and violent. That they may choose to fight each other; this is not so much the concern. The karma lies in the bloodlust of those who participate in this so-called sport. This Awareness indicates that these entities considering this some kind of sport are in actuality participating in the enjoyment of bloodlust. This Awareness indicates that this does have a distasteful and ugly appearance. That in itself, it can be seen as grotesque and cruel. This Awareness indicates however, that you must recognize that the mills of the gods grind slowly, and that this is a much milder form of the bloodlust which once was involved in the arenas of Rome, or wherein entities participated in watching individuals such as the gladiators slaughter each other. This Awareness indicates that many of these entities who participate in this so-called sport, watching these chickens fight, are reincarnations of those same entities who once enjoyed watching the gladiators fight to the death.

This Awareness indicates that this bloodlust is still in the human condition and while it remains, there will likely be continued games of this type which are called 'sports'. This Awareness indicates that the name of sport, the actions which are classed as sports, are often nothing more than sadistic activities of killing and torturing.

This Awareness wishes to call attention to a game of concern. This is also called a 'sport'. This Awareness indicates that there are certain wealthy entities who have set up a kind of sport for the professional hunter, the highly wealthy hunters whereby they may, for a fee, be taken on a safari into Brazil, whereby they are sold a native and the native is then told to run, and the hunter then follows, seeking to capture and shoot the native; and in so doing, the entity considers this to be the most dangerous sport, the most dangerous game, and the greatest of sports. This has been occurring for the past ten years, and the governments in those areas turn their heads when confronted with the information relating to this action.

This Awareness indicates that there has been some press exposure to this. This Awareness indicates however, that it still continues. This Awareness wishes entities to send forth light energies to those natives in Brazil, so that the actions will stop, and so that the truth will come out, and the entities responsible for this will be stopped. This Awareness suggests that entities send forth Light and love toward those natives. In sending forth this energy, this Awareness will assist in directing this energy into the path which allows for exposure of this action.

COSMIC AWARENESS:

COSMIC AWARENESS:

This in the affirmative. This Awareness indicates that these are the agents who assist in setting up these safaris. This Awareness indicates the customers come from Europe, Great Britain and the United States,-- these as wealthy hunters. This Awareness indicates that some also are from the Middle East. This Awareness indicates that the victims generally are young persons, male and female. They are unarmed and have no understanding of what is happening until they are informed that they are to be shot and killed and that they must run and protect themselves. This Awareness indicates this being in an area whereby they cannot run far enough. That the swamps prevent them from complete escape.



The painkilling effects of the nationally known oil has been discovered by hundreds of arthritic sufferers who accidentally sprayed it on their painful joints and experienced almost immediate relief.

Although WD-40 is designed to stop squeeks, loosen rusted nuts and mechanical parts, it does a lot more as far as Barbara Yarborough is concerned. Miss Yarborough, an assistant professor in Health and Physical Education at Elton College in North Carolina, has long used WD-40 on athletic equipment. She also advocates its use by athletes with severe sprains, muscle spasms and other injuries.

"One student had a sprained back," she recalled. "When I suggested WD-40 she cracked up laughing, but I massaged it into the muscles and in about 20 minutes she felt fine."....

The article goes on listing several other testimonials, and mentions that the WD-40 company says "The formula is a trade secret, but none of its ingredients are hazardous", and also, the Arthritis Foundation isn't too excited about the spray oil's use as a remedy. Would Awareness comment on that article?

COSMIC AWARENESS:

This Awareness indicates that this appears to be effective on many kinds of sprains or pains. That the penetrating effect as that which allows for certain substances to be carried in and out of the joints.

This Awareness indicates that it allows for the energy currents built up in blocked areas to be dispersed, relieving pain in this manner. This Awareness reminds you that pain essentially is blocked energy, energy which cannot flow because of some tear, rip, cut or block in the flow of the energy. This Awareness indicates that this substance allows the energy to flow more freely.

Denominations across the country must now vote on whether this translation process should begin. If the answer is yes, the Lord's Prayer might one day begin, "Our parent, which art in Heaven..."


COSMIC AWARENESS:

This Awareness indicates that the nature of that which is called God as that which is neuter. COSMIC AWARENESS:

This Awareness indicates that keeping in mind the previous reading*, wherein the emphasis and priorities are to be placed upon the soul growth, wherein material concerns are of a secondary nature, wherein soul growth includes taking responsibility for one's life, for one's obligations in the physical world, in the material plane; keeping this in mind, this Awareness now wishes to comment briefly on the general trend of events, and the situation within this physical plane at this time.

This Awareness indicates that *Its* purpose is not to assist entities in gaining monetary worth, or having more pleasant physical livelihood; *Its* purpose is to assist entities in their soul growth. This Awareness indicates there are often times wherein this primary purpose appears to be overshadowed by material urgencies and obligations, and responsibilities which occur on this plane for individuals and for groups alike. This Awareness indicates that the concern for material matters will be presented through this channel from time to time, as urgencies occur, but *Its* priority through this channel will be the spiritual concerns as these occur in.... QUESTION:

Awareness has given a lot of information in the past about the police state that was coming down upon entities if certain things didn't happen, and recently there's been a number of bills introduced into the Congress of the United States that lend credence to this. That it looks like more and more this police state is gathering momentum. One thing is in the hard money area. B.A. in Florida wanted us to ask Awareness about some of these bills being introduced concerning the hard metals, particularly gold and silver, by these entities who want to get this bastion of finance that is not controlled by the Trilateralists; and it's their theory that if they can get these bills passed, they can keep the International Monetary Fund functioning and keep the guise going

that they're not really broke by these poor countries that have defaulted on their payments.

Anyway, a number of these bills have started on their way through, including a bill to take the capital gains tax advantage off of hard metals, claiming they're "unproductive", and there's one to tax the Krugers coming in from South Africa; there's one to confiscate gold and silver, and so forth; and she'd like to know...She says; "My immediate concern in reference to gold and silver, and the advisability of moving to an offshore location, such as a Swiss bank, or perhaps Montreal, Quebec, as a safe haven for precious metals, since Awareness has suggested to the membership that they purchase these metals in the past."

Does Awareness have any information or any advice for entities who have been thrifty and have been investing in gold and silver, and who are getting worried about all this legislation, and whether or not it will be passed by Congress?

COSMIC AWARENESS:

This Awareness indicates that there is a strong likelihood of a police state. There is a strong likelihood that the bills eventually will be passed. That there is a reasonable likelihood that entities will become active and put forth effort to prevent this from occurring. This Awareness indicates that at present time, the likelihood is more in favor of the police state and in favor of these bills being passed within a period of time, after some opposition.

This Awareness indicates that the concern for monetary and physical welfare as that which is a critical concern, and particularly wherein this is looming closer. This Awareness indicates that this has been forecast for some time, and that there has been some meager efforts to take actions to bring about an awakening in consciousness. This Awareness indicates however, these actions have tended more toward personal gain and growth and use from the information rather than as a general concern for the society as a whole.

Even more important, in my opinion, is the so-called "Postal Thought Control Bill", which entities had thought was killed last year, and certain provisions of it were, but according to the newsletter writers, this bill has quietly surfaced again with all the old provisions that were knocked out, plus a whole bunch of new ones, and it seems that the object of this is to make the entire Post Office Department--the mail carriers and everybody--sort of a Gestapo type of operation that can seize any type of mail that they deem is not acceptable to them, based on their previous ideas of what "acceptability" is.

And it seems like this is primarily an attempt to put the newsletter people, the uncontrolled press and certain book publishers out of business, and they're going to put their provisions in the bill, --absurd provisions like a \$20,000 per day penalty for non-criminal and non-fraudulent acts, and other equally absurd penalties; that information, mail, certain newsletters and publications that they deem to ban can not be sent out in *any* manner, which includes United Parcel Service, walking down the street and hand-delivering them, and so forth, or you'll be faced with this \$20,000 penalty.

It's a very heavy heavy thing, and it's surprising something like this could even be introduced by Congress persons who claim to uphold the Constitution of these United States. (It's scary!) I'd like to ask Awareness, is this another bill that's *going to be fought and do down in defeat, or does Awareness see this bill actually getting passed?*

COSMIC AWARENESS:

This Awareness indicates that this is an effort through the Post Office, through the use of the Post Office, to bring about a curtailment of the Freedom of Speech, Freedom of Expression. This Awareness indicates that wherein one cannot pass out through other means besides the postal purposes or methods, where one cannot pass out newsletters; this also prohibits entities from passing information on the street. This may also serve as an infringement of the freedom of expression.

This Awareness indicates that this is moving outside of the postal jurisdiction into exchanges individuals may wish to have with one another, as they pass notes to one another, or as they pass leaflets to one another. That the postal rules moving completely outside of their own area of business and into the streets, monitoring conversations or papers being exchanged by individuals.

This Awareness indicates this could also apply to the city newspaper, or the local or national news tabloids, or other magazines which are distributed through paper-box systems or handed out by individuals. This Awareness indicates that this is of such an insidious nature, that whereas it appears more harmless than it actually is, it could open the door to a complete infringement on the rights of expression and communication. This Awareness indicates that this provision as that which will be attempted again, and again, and that entities behind this expect it to be defeated again and again before it eventually will pass.

This Awareness indicates the intention and effort is to chip away at these Constitutional Freedoms through various rules and regulations of the many bureaucratic controls in the society so that the freedoms guaranteed in the Constitution become meaningless and mere tinkling words without substance. This Awareness indicates that the only thing which may prevent this from occurring is the vigilance of people, concerned citizens who in turn awaken others to these concerns.

This Awareness indicates that wherein entities have their particular vested interests, they are more concerned. This Awareness indicates therefore, entities wishing to awaken those who have interest in this may wish to send a flyer or brochure containing this warning and information to those many various newsletters or outlets for the printed word, such as newspapers and tabloids, suggesting that they in turn notify their readers to write and send messages

to Congress and to the various parties responsible for this infringement, to prevent these bills from being passed.

This Awareness indicates that for the members of this organization to write directly will have some effect, but it will require greater numbers than are available in this organization, therefore, the greater effect would be for members of this organization to alert persons who are responsible for newsletters or other activities which will be affected by these bills, so that they in turn can also inform their readers to write letters, to help prevent this from occurring, to help prevent these bills from being passed.

ED's note: The sponsors of the Postal Thought Bill are David Pryor (D-Ark) and Claude Pepper (D-Fla). The fact they have re-introduced this bill once again, is proof of how serious they are in censoring what you read in the form of books, magazines, newsletters, and even privately circulated or small town newspapers. We suggest that anyone concerned about the rapid erosion of their Constitutional rights and particularly this outrageous bill, should write to their Senators and Congressmen and remind them that the Post Office was set up to deliver the mail and not to play Big Brother over the taxpayers.
