

POSSE COMITATUS SAYS "TOTAL ENSLAVEMENT BY THE U.S. GOVERNMENT IS NEAR"!

Are babies being marked with laser numbers?
Are computer chips being made from aborted fetuses?

(Excerpts from a C.A.C. General Reading)

August 25, 1983

QUESTION:

I have a few questions sent in by David —, which seem like very interesting questions. He writes:

"A very strange article was published in the Minneapolis Star and Tribune, done by one of their independent investigative reporters, regarding the Posse Comitatus. The wives of Yorie Kahl, Gordon Kahl's son, and David Broer who helped Kahl until he was murdered by Federal marshals in Arkansas, are now going on the speaking circuit to talk about the threat of "total enslavement by the U.S. government."

"Janice Kahl and Joan Broer are making statements such as: "We must regain control of our government from the international bankers,—the One-Worlders. I just call them "the Conspiracy". We're only one step from total enslavement. The country is being controlled by the Jewish Masonic lodge. The Jews and Masonic people are grouped together in some form. I don't know what form. I don't have anything against the Jews personally, but they aren't working with us. If they're not in control, who is? It's not us, the people.

"I'd really like to know that myself. If they're not in control, who is? The people in control are already secretly using laser beams to implant invisible identifications on the foreheads of all the infants born in hospitals. Only computers can see them. Eventually the numbers will be implanted on people's hands and will be used to do away with the money system. Everyone will be given the same amount of purchasing power. Instead of using money to make a purchase, sales clerks will use computers to read the identification numbers.

"The computers will determine if the purchaser has enough in his credit allotment to make the purchase. The laser implanting system began January 1st, 1981. I don't know who exactly does the numbering, but I'd assume it would be either doctors or nurses. I have never seen a laser in a hospital, but I am sure that no one would admit to knowing about it if I did find one. I cannot give you a specific source for this information, but let me tell you this: the Posse Comitatus doesn't spread things around that aren't substantiated.

"We also know that the brains of aborted fetuses are being used to make the silicon chips for the super-computers. We, the Posse, want to see a society based on the Constitution. Concentration camps for United States citizens have been prepared. We have been conspired against through our churches, schools, our water and our food. This country is just like Russia. We're not free. We can't drive a car on the highway without a license on the car and the person driving it. Why do we have to register everything with the government?"

"Anyway," says David, "that's part of her speech. The information sounds like it came partially from the Awareness Readings and maybe a mixture of a few other philosophies. I have three questions relating to the above material: (1) Did they get some of their information from CAC, either directly or indirectly? (2) Is it true that there are lasers in the hospitals tattooing numbers on babies' foreheads?, and (3) What about the claim that aborted fetuses are used to make chips for super-computers?"

COSMIC AWARENESS:

This Awareness indicates that this information for this organization relating to the conspiracy of the money system and the laser markings as that which it has gathered through other sources other than through this Awareness or through these publications of this organization of *Cosmic Awareness Communications*.

This Awareness indicates that in reference to the second question, this Awareness suggests the second question be re-read.

(FOLLOW-UP QUESTION):

Is it true that there are lasers in the hospitals tattooing numbers on babies' foreheads?

COSMIC AWARENESS:

This Awareness indicates that this has been used in certain hospitals on the East coast. This appears to be in the area of New York and in hospitals of those upper Eastern states. This Awareness indicates that it appears that it has also been used in hospitals in Europe for some time. This Awareness indicates that this particularly in Belgium and the Netherlands. This Awareness indicates that this so far, however, has not been used on a compulsory scale, whereby every child or every hospital is involved in this type of marking.

This Awareness indicates that this as a kind of beginning stage. This Awareness indicates this has also occurred in the hospitals in Israel. This Awareness indicates that there is seen also some of this in Japan. This Awareness indicates that essentially it is the *beginning*, the beginning of an action in preparation for the marking of individuals from the time of birth. This Awareness indicates that in the religious hospitals (this particularly in the Catholic and Protestant hospitals) and in the smaller hospitals this practice has not yet been introduced.

This Awareness indicates that in reference to the third question, that this question be re-asked.

(FOLLOW-UP QUESTION):

What about the claim that aborted fetuses are used to make the computer chips for super-computers?

COSMIC AWARENESS:

This Awareness indicates that there is a process whereby certain experiments using tissues from aborted fetuses and also from the use of protein and human cells, also from the use of animal oils; these have been used in experimental levels in an effort to combine the activity of growing computer chips which have the ability to expand as protein tissue. This Awareness indicates essentially, that which has been more recently enhanced is the use of the brain material of aborted fetuses or of children stillborn (in some more rare cases), whereby the brain tissue has been used in certain experimental levels to combine with technologies using the protein and brain-cell growth similar to that which is used in crystal growing, whereby certain programmings are implemented in to this growth along with certain chemical catalysts that allow at a certain stage this growth to be aborted after certain implantations of experience, thought or programming of information has been implanted into the protein.

This Awareness indicates that this protein then is used in conjunction with a chemical type of material that allows it to be cut into chips which then are used for a computer or for storage of the information which has already been programmed. This Awareness indicates that this being a more basic level of information within the computer. This Awareness indicates that so far, this has been only on experimental levels and has involved very few aborted fetuses and it appears one entity who was stillborn.

This Awareness indicates that the practice as that which has yielded some results and which has not yet ceased. That it appears there will be further experiments along these lines. This Awareness indicates that there are other avenues of research progressing in other ways however, which may prove to be more efficient, workable and productive for better computer systems than through this particular approach, therefore rendering this approach as being of little value.

This Awareness indicates that the researchers of science do take bizarre turns. This Awareness indicates that this is but one example of such bizarre types of thinking in efforts to enhance technology for the sake of technology.

QUESTION:

In reference to the laser marking of those babies in certain hospitals; are the parents aware of this, or is this a secret process that's going on in these hospitals?

COSMIC AWARENESS:

This Awareness indicates that it appears that so far this has been in conjunction with the knowledge of the parents, whereby the parents in being concerned about the possible loss or abduction of their child in a future time have consented and agreed to have the child marked invisibly so that the child, if found, could be identified. This Awareness indicates that this appears to be conducted mostly in the Jewish hospitals and in hospitals that are run or controlled by the state or Federal government.

QUESTION:

I believe there's a hospital in New York City called Sinai General, or Mount Sinai General Hospital. Does Awareness see that as being one that is using this technique?

COSMIC AWARENESS:

This Awareness does not wish to reply to this question.

QUESTION:

Well, would Awareness agree that the public should be informed of this, and maybe particularly, the fundamentalists?

COSMIC AWARENESS:

This Awareness indicates that this as that which is important for entities to be made aware of and that entities must be vigilant and watchful to prevent their hospitals from marking their new-born children. This Awareness indicates that at present, most hospitals are not involved in this kind of activity. This Awareness indicates however, that those hospitals which do have this type of facility at present do inform the parents of the child and do get their consent.

This Awareness indicates that this policy may change in the future whereby consent is not required. This Awareness indicates that it is in this manner that entities should be cautious and watchful.

QUESTION:

Do the numbers that they're laser-marking on these babies have the prefix of 666?

COSMIC AWARENESS:

This Awareness indicates that these are not numbers in the sense of Greek or Arabic type or Roman numerals. This Awareness indicates rather, that these are computer markings, not too unlike the universal product code. That the number as that which is translated from the brand or marking into a number by the computer that reads the symbol or mark. This Awareness indicates that the mark placed upon these entities as an identification mark has a symbol which can be used or translated by the computer for reference to the 666 number. This Awareness indicates however, it is not in itself such a number.

This Awareness indicates that the entities involved in implanting these numbers are not fully aware of the nature of the program. That they are basically informed that they are making identification marks on the child so that the child can be identified if lost, kidnapped or separated from the parents.

QUESTION:

I've read several places that they are also marking certain babies, or tattooing them on the bottom of their feet. Does Awareness see this a growing practice?

COSMIC AWARENESS:

This Awareness indicates this is in the affirmative. That this has been conducted for some time, particularly in Europe. This Awareness indicates that this is seen as having been implemented for approximately the past ten years in certain countries of Europe. This Awareness indicates that particularly Belgium and the Netherlands, and also more recently, this has been introduced into Germany and England.

GORDON KAHL WAS SET UP... HOWEVER, HE IS STILL ALIVE

QUESTION:

In reference to the Posse Comitatus and Gordon Kahl, when he was ambushed, or when he killed somebody, an officer in South Dakota, the papers made a big to-do about how he 'murdered' these officers; but on the other side, Posse Comitatus and some other right-wing publications have written conflicting stories that Gordon Kahl was deliberately set up by the government, primarily because he was reaching too many entities with his information on how to evade income taxation. Would Awareness straighten out the true story on that?

COSMIC AWARENESS:

This Awareness indicates that there is much truth to the side of the story which was given by the Posse Comitatus. This Awareness indicates that this as essentially having been a set up. This Awareness indicates however, that the entity as having responded in the shooting in part with a sense of self-protection, but also the entity as having been somewhat too quick and too ready to respond in this manner,--this leading to the shooting. This Awareness indicates that it appears that the entity having been burned in a fire, was not actually the entity Kahl. This Awareness indicates that it appears that this was set up, using a corpse to make it appear that this entity had died when in actuality, the entity has escaped and is still alive.

MARK OF THE BEAST SYSTEM
STILL SCHEDULED FOR 1990

QUESTION:

Another question from David: "Since Awareness has stated, that the United States which is moving toward a war footing,--building armaments etc.,--has delayed the implementation of the EFT/Mark of the Beast system because of the fact that a country can't create an artificial depression and try to build the military at the same time. Does Awareness see the implementation of the EFT system as possibly being tied to credit card and food stamp fraud, (a multi-million dollar underground business)?

"Congress recently introduced tougher legislation in regard to credit card fraud and they are now testing electronic food stamps in Reading, Pennsylvania. Does Awareness see this as a continuing trend, leading eventually to the EFT/Mark of the Beast system without a depression?

COSMIC AWARENESS:

This Awareness indicates this as in the affirmative. This Awareness indicates that it appears that the efforts to bring about this Mark of the Beast through the Electronic Fund Transfer System as that which is aiming for the year 1990 as the time wherein total control over the populous shall be complete. This Awareness indicates however, you may recall that this Awareness indicated to entities previously that the years between 1981 and 1986 as being critical years in regard to the conflict between the Forces of Light and the Forces of Darkness.

This Awareness indicates that if the Forces of Darkness have not completed their conquest of the mass-mind by 1986, it appears that the consciousness on this plane shall be awakened to such a degree that it will be much more difficult for these forces to gain their victory. This Awareness indicates that the Forces of Ahriman, the Forces of Darkness have spread themselves very thin. This Awareness indicates that in reference to their ability to create destruction upon this plane in order to reap the rewards of aftermath from that destruction, this process has also been weakened considerably, the chances of victory as having been weakened.

No nuclear strike--but new weapons in works

This Awareness indicates that in reference to efforts to bring about a nuclear strike in March of '84, this Awareness indicates that this also has been weakened considerably in that the forces behind that plan have become cognizant of the immense power held by the Soviet Union in regard to its new technologies and that the attempts to create a First-Strike, which attempts in the past have failed, even in the simulated attacks; that wherein these attempts have failed in the past, and wherein these entities are now aware of the immense development of the new technologies which the Russians have at their disposal, they are becoming more realistic in the appraisal that the use of nuclear weapons is lacking as a means of conquering or destroying Russia.

This Awareness indicates that it is for this reason that the President recently announced a new effort to develop super-weapons for space war, including laser beam weapons and so forth. This Awareness indicates that essentially, what is not being discussed is the use of psionic weapons, which the Russians have developed to a high technology, and the use of rays which have been developed to the point of being capable of wiping out complete armies from a great distance, of dematerializing these forces, and this Awareness indicates that these many new military weapons, both of the United States



and its allies and of the Russians and their allies, being so advanced in development have created a totally new scenario, yet the public is still made to focus on the nuclear fears, while in actuality the military is concentrating on the development, the mass development of these new weapons.

This Awareness indicates these may be termed super-weapons. That they do not make use of nuclear weaponry but do make use of the laser technology and the technology associated with psionics. That these also making use of weather manipulation and of bacteriological warfare. This Awareness indicates that the Chinese as being most advanced in this area. This Awareness indicates that to assume a sense of relief because the nuclear threat is diminishing while the psionics and laser threat increases is not much compensation or does not give much sense of relief. It is simply likened unto the entities who, rather than threatening to blow up the entire building with a bomb in order to destroy an enemy, have shifted weapons which can be destructive, but not have the long-term effect.

Secret war in Central America
Mossad hit-men using computers

This Awareness indicates that this lowers the threshold of possible use whereby it becomes more thinkable to use those weapons which do not destroy everything, and therefore, becomes more possible for war to break out. This Awareness indicates however, that because there is still much disparity between the two super-powers in terms of the development of these super-weapons and because there is still room for rapid development of such, it appears that there will be some period of time before major conflict would be planned. This Awareness indicates that on a more conventional level however, this Awareness sees a strong possibility of a more conventional blitzkrieg-like attack in Central America on Nicaragua, wherein the United States is involved in a clandestine-type operation. This may lead to a more conventional war in that area in which the involvement of the United States is there, but not officially in a major involvement. This Awareness indicates the involvement being major, but not officially so. This Awareness indicates the use of computers by the Mossad in Guatemala for tracking down certain types of individuals to be annihilated in that area has been occurring for several years. This Awareness indicates that this in conjunction with the government of Nicaragua whereby the computer would be assigned to select certain classification of individuals and randomly choose names whereby these individuals being selected would then be picked up and put to death.

Infantile gratification—the way to enslavement

This Awareness indicates that this action as a kind of exercise or practice. That this was not a military necessity for the government, but was designed in part to intimidate the masses, keep the masses confused in states of chaos whereby they could not anticipate or read the proper actions to determine who would be next and for what reason. This Awareness indicates that this activity as having been kept as a kind of program, a social program monitored and recorded and placed into computers to determine the general effect in the area and to be applied to future actions in other areas as ways of intimidating the population for greater population control.

This Awareness indicates that this relates to the program of the Tavistock Institute whereby individuals are put under stress so that they are unable to make meaningful decisions because they do not have the power to make a decision or because decisions are being made for them in a manner that is haphazard or is unpredictable in nature and whereby being unable to make meaningful decisions under states of stress, the individuals are unable to formulate goals, and having little goals or meaning or purpose in their lives, the individuals then become susceptible to any type of momentary gratification, and focus on goals which are of little consequence other than as a momentary gratification.

This Awareness indicates the implementation of infantile gratification into a society whereby entities have no long-range goals and only pursue infantile gratification makes such entities highly susceptible to government control programs. This Awareness indicates you may note the application in the area of Central America wherein war and violence are creating such stress and chaos on the public so that infantile goals become commonplace in these areas, this being a kind of social experiment to discover the effects in war-time of the application of this program. This Awareness does not wish to imply that this is the only reason for the military actions in Central America, this is but one activity that is accompanying the military actions. The major reason being to acquire the minerals in this area.

This Awareness indicates that you may also note that the pursuit of goals in your own country in the United States and in other countries over the past 20 years has become more and more meaningless to individuals. This partly because entities do not know whether there will be a future due to the continued threat of war and the insecurities that accompany such threats, and whereby 20 or 30 years ago entities could pick a career and work toward this, today entities feeling that they may exist for only another 3 or 4 years, that war is just around the corner; such entities choose more short-term goals for their lives.

This Awareness indicates this particularly is true with younger individuals. This Awareness indicates that this leads to the individual seeking some short-term gratification, feeling that it does not matter for there will not be much time anyway. This Awareness indicates therefore, the pursuit of short-term gratifications by the multitudes and masses within these nations makes these masses much easier to control, for they do not have long-range plans, nor long-range hopes, and are easy to purchase simply by the promise of some short-term gratification.

This Awareness indicates that this in general helps to set up the masses so that when the time is right and the situations have been artificially created, the masses will accept whatever is given to them, and will reply with the courteous "thank-you" when they are given their short-term gratification. This Awareness indicates essentially this is part of a long-range program to enslave the masses using the infantile gratifications to trap them. This Awareness indicates that this as a facet of the effort to bring about the totalitarian controls over the masses.

WHY DID REAGAN
APPOINT KISSINGER
TO HEAD
INVESTIGATION
COMMITTEE?

QUESTION:

In relation to Central America, David has another question that many entities must certainly be asking: "What is the significance of President Reagan appointing Henry Kissinger to head the commission on Central America? Given his past record, he hardly seems like a brilliant choice. President Reagan knows very well that virtually no one, Democrat or Republican, agreed with the appointment and it may hurt him in his re-election campaign. Was he forced to do this? Who orchestrated it and why?"

COSMIC AWARENESS:

This Awareness indicates that this entity was selected by the group that dictates policy through the President. This Awareness indicates that this entity Henry Kissinger as being one of the important Bolshevik parties. That the entity as one who does play his part well and who has a certain flair for the type of activities which he has been selected or appointed for. This Awareness indicates that the entity is also one who does not alter his type of behavior or programming, and therefore, the predictability of this entity's manner of relating in regard to formulating policy as that which suits the administration and those who direct policy for the administration.

This Awareness indicates essentially, the entity Kissinger as one who will be totally ineffective in terms of bringing about any type of peaceful settlement in the area, and therefore will be completely effective in terms of the purposes for his appointment.

WHY IS THE NATIONAL SECURITY AGENCY SUDDENLY RECRUITING HI-TECH PEOPLE?

QUESTION:

Another question: The National Security Agency, which normally keeps out of the public eye has begun an intensive advertising campaign to recruit technical specialists. They won't say how many people they need, but they did say they would be happy if they could get several hundred people. The agency has always been reluctant to acknowledge its own existence. Now however, it is boasting in the ads that it is the 'recognized leader in the electronics field with one of the largest computer complexes in the world.' Why are they intensively recruiting these people, and are they gearing up for something that they know about, but we don't?

COSMIC AWARENESS:

This Awareness indicates this as in the affirmative. That this is part of the grand plan to fill the requirements of personnel for implementing the Electronic Fund Transfer System. That this also is to increase the number of government computers throughout this country and throughout other countries also, whereby a greater network of computers will be established that allow for linking up to the computers within the business and states.

This Awareness indicates that this training with these computers also involves a potential training for military purposes for computer operators of military computers. This Awareness indicates that this includes not only programming, but also work in terms of the technological development and maintenance of computers and of information data bases, and of the hook-up of storage bases for the various applications.

This Awareness indicates that it appears that there will be several thousand selected rather than several hundred. This Awareness indicates that this is but a smokescreen to hide the number of entities who will be selected. This Awareness indicates there is seen also involved in this program a part of the agency whose purpose is to serve as surveillance over populations through the monitoring of individuals through their electronics: the telephone, the amount of electricity used, the food storage and purchases made, and other reports and data received from agents in the fields. That these computer operators will be involved in recording and updating files on individuals during a period in the future. That these entities for this operation as being presently hired to learn the skills for these operations, and many of those presently being hired will become tutors to teach others when the program is brought into full procedure.

MORE AND MORE INFRINGEMENT ON RIGHTS AND FREEDOM HERE IN U.S.

(Entities in Peru & Colombia have more freedom)

QUESTION:

Another question from David. "If, as Awareness has stated, things are getting better in Russia in terms of human rights abuse, the United States seems to be picking up the slack. We have a prisoner chain gang revival going on to get cheap labor for the states and the Federal government highway program etc. The states are starting to demand work in return for a welfare check called Workfare, and the homeless are now being shipped from New York City to New Jersey to get rid of them. Mexicans and other illegal aliens in the deep South are being held in what is called 'Debt Peonage.' They are charged exorbitant rates to stay in the owner's shacks and get lousy food, some wine to keep them quiet and so forth. Their wages are so low that they can never pay the debt, and therefore are forced to stay there and work in virtual slavery. All of these things seem no worse than Soviet Gulags and labor camps. Does Awareness see this trend continuing and is it a part of the plan to turn the United States into a police state?"

COSMIC AWARENESS:

This Awareness indicates that this trend appears to be that which is increasing and whereby the rights of individuals are being infringed upon more and more by more and more legislation and rules. This Awareness indicates that Congress itself is beginning to recognize its own inefficiency because of its inability to function under its own rules. This Awareness indicates that many Congresspersons are beginning to express alarm about this and are seeking to find ways whereby they can alter Congress and the procedures so that they can become more efficient in working

with the legislature and in finding ways to create laws that are more efficient for the masses, in terms of helping the masses to enjoy life to a greater extent.

This Awareness indicates essentially, the United States which once held greater freedom than any other nation is in a path and direction wherein it is moving toward that kind of nation which does not have freedom. This Awareness indicates that the nation which has greatest freedom is Switzerland, that Sweden as second, and that Peru, Colombia and Brazil as having greater freedoms than in the United States.

Economic freedom in Russia

This Awareness indicates that the United States still as having more freedoms for individuals than is found in Russia, yet the Russians as slowly moving to accommodate the individuals whereby the movement there and the trend is toward allowing greater freedoms and whereas the trend in the United States is to deny freedoms more and more through the encroaching laws and rules that keep multiplying each year.

The rules particularly applying through the money sector in terms of IRS taxes and monitoring and auditing methods and in terms of the economic conditions and controls on the masses, whereby the individuals through the monetary system are becoming more and more enslaved. This Awareness indicates that they still of course have political freedom, freedom to speak and say what they wish to say,--up to a point. This Awareness indicates that in terms of the Soviet Union, the freedoms there end in terms of political freedom. That most individuals do not have political freedoms, the freedom to say or speak what they wish in terms of criticism of the state.

This Awareness indicates however, they do have the monetary freedoms up to a point, whereby they can express themselves monetarily with a reasonable amount of freedom. This does not mean that they are guaranteed wealth or the freedom that many think comes with wealth, but rather that they are not controlled through the use of money in the same manner that entities in the United States are controlled through the use of economies and the trappings of economy.

This Awareness indicates that other nations such as those in the Middle East are highly controlled by religion and culture. These also affecting the monetary and political areas so that there is even less freedom in these countries. This Awareness indicates essentially, the trend in these countries is to remain stagnant except for certain countries which have adopted Westernized values in recent times and which are receiving much influence from Western values. These values as having an effect on altering many of the customs of the countries and of altering the political powers also

Laws, permits, computers, equal controls

This Awareness indicates that in terms of the United States, the trend appears to be that which is encroaching more and more upon the individual's rights, this in part due to the two-fold prong of increasing laws and rules which close any types of loopholes whereby entities can trade, barter, sell, give or work and earn monies without being controlled by the government. For all of these types of activities, whereby entities being controlled by the rules and laws of the bureaucratic and the government agencies which require permits for almost every action and which tax the entity for almost every personal gain and which infringe upon his or her life in almost every event of significance, whereby these events must be recorded here and recorded there so that it can be computerized here and computerized there so that records may be kept of the individual in every manner of speaking.

This prong, along with the other prong which drives the entity from pursuing long range goals and toward

the pursuit of infantile goals which are attainable; these two prongs,--the economic and psychological--are quickly driving the American individual toward the state of being subject to a totalitarian system. This Awareness indicates that as this is increasing in the United States, in Russia it is moving in a different direction whereby more and more entities who have been subject to political intimidation are now finding it possible to speak out somewhat more with less fear, and in this manner the intimidation of political controls as that which is beginning to erode somewhat and which in a slight trend is beginning to allow greater freedom in that country.

This Awareness indicates that to say that entities are more free in the United States because they can speak out politically than those in the Soviet Union who cannot speak out politically without repercussion, is to measure the political freedom. But the measure of political freedom is not the full measure of human freedom, for individuals can also suffer from economic oppression. Many Russian individuals suffer from economic poverty, or of not having what they desire, just as many in the United States suffer from economic poverty, but the action of using economic systems or economic policy to control the masses is not as prevalent in the Soviet Union as in the United States, and therefore one can also argue that the American citizen is enslaved by the economic system, whereas the Soviet citizen is more free.

This Awareness indicates this is not intended to imply that one system is superior to the other. It is rather an action intended to point out the misconceptions which entities may have in regard to the concept of freedom. That freedom does not simply apply to one particular aspect of one's life. It must apply to many aspects, if not all aspects, in order to be considered as total freedom.

This Awareness indicates in actuality there is no such thing as total freedom without total responsibility. Responsibility and freedom go hand in hand, and when an entity is able and willing to accept responsibility, and when a society is geared to allow the individuals to have freedom and the society takes the responsibility for implementing and guaranteeing that freedom, the individuals have a greater chance at freedom, but freedom among the individuals requires that the many individuals be responsible for the freedom they have so as not to infringe upon the freedom and rights of others.

This Awareness indicates that those who cannot accept the responsibility for freedom and who want the freedom and misuse that freedom are candidates for having their freedom taken away. This Awareness indicates that this applies also to nations whereby when the nation fails to accept the responsibility for guaranteeing freedoms and wherein it begins to assume the position of parent and owner of the citizen, wherein it sees the citizen as a government resource which can be tapped to enhance its own power and structure, whereas the government of the people becomes the people of the government, the people who are *owned* by the government; wherein this occurs then the freedoms are taken away in order that the government might thrive.

This Awareness indicates that in the past this has been the policy of Russia, that the citizens were owned by the government. This Awareness indicates this trend as beginning to alter somewhat in Russia, even as in the United States the trend is in the other direction, whereby the citizen who owned the government is now beginning to have rights taken away by the government, so that the government is making claims upon the citizen upon his or her money, earnings, properties, expressions, activities and thoughts.

This Awareness indicates that if this trend continues, by the turn of the century the United States will be as Russia was 30 or 50 years ago. This Awareness indicates

that if the trend continues in Russia, the Russian people may be experiencing the freedoms which the United States had 30 or 50 years ago. This Awareness would like to see these trends modified so that both countries take the position that a government is designed to bring about the greatest good for the most people, and to give room for all entities to develop and grow spiritually, socially, individually and with the necessary sustenance to allow such growth.

Many bills to control entities now in Congress

This Awareness indicates that there may be those who in reading this message take offense and argue that the United States has the greatest freedom available. This Awareness indicates that there may be those who have not yet heard of the new postal bill that allows the post office employees to enter one's home, to confiscate material, to choose from material which has been mailed that which is suitable for mailing and that which is not suitable simply because of the ideas being expressed, or the postal employees who once having decided that your mail is not suitable for others to read, have the right to not only prevent you from mailing through the post office, but from mailing through private couriers such as UPS or other privately owned messenger services, or through your own hired messenger, or would prevent you also from passing your material out on the street to those who pass by, or to those who come to your house, or from allowing you to deliver your material from door to door, and that they can even come into your home and confiscate your material.

This Awareness indicates that this postal bill as that which sounds more at home in the Soviet Union, yet is that which is now in the works for entities in the United States.* This Awareness indicates that this as but one of many new bills and actions of legislation which are quickly being implemented to infringe upon entities' rights.

*ED's Note: Since this reading was given, the Postal 'Thought Police' bill, as it was called, was passed by the Congress. It was slightly watered-down, but it is expected that this year everything that was removed from it will be quietly put back in. CAC has been warning the membership about this bill numerous times, for it keeps coming up year after year. Sooner or later all these dictatorial bills eventually pass, and usually with little fanfare or notice by the controlled press. Another bill that was quietly passed without any comment from the press, was the so-called 'anti-hoarding bill'. This bill makes it a felony, punished by huge fines and imprisonment, if you purchase and store more than one week's food and provisions for your family. Although not enforced, to our knowledge, the bill is law, and just waiting till the police state fully arrives and citizens will find themselves at the mercy of the government. (Remember, Awareness said "even garden seeds will be taken off the market" and it will be impossible to grow even a small garden of vegetables in your back yard. (Avaton)

This Awareness indicates that another bill as that which relates to the purchase of precious metals, whereby entities who buy gold or silver will be required to have their fingerprints taken, their addresses taken, and whereby once this is given, this information is turned over to the IRS and any benefits gained from the purchase of these materials as that which *must* be paid as taxes.*

* This bill also has become law since this reading was given.ED.

This Awareness indicates that this may also be extended to other commodities. This Awareness indicates the rules here are not simply designed to allow for the IRS to take the money that is owed to it, but also it allows the registering of gold and silver so that at a future time, when the government decides, entities who are required to turn over their gold and silver to the government can be tracked down, and can be found and can be arrested if they have not complied with the new rules or laws.


Stolen Ft. Knox gold
for use of One-World government

This Awareness indicates that in this manner, the gold which was stolen from Fort Knox in the years between 1963 and 1972 will, having been removed and having been brought back into the market and sold back to the American public and to others, this gold when picked up by the government in a future time may be restored again to storage in Fort Knox or in some other depository so that it will appear that it has always been there and is still belonging to the nation.

This Awareness indicates that this can again restore stability to the economy and the entities of the nation will never know it was ever missing, or that they once held a part of the gold from Fort Knox. This Awareness indicates that essentially, the attempt being to finance the takeover and the set-up of a One World Government using the people's gold from Fort Knox to purchase energies necessary to implement the programs and technologies and activities that would bring about the complete buildup and restructuring of society toward that of One World Government, and the restoring of the treasury by recalling from the masses the gold which has been purchased by the individual citizens.

They have recently overturned the legislative veto provision which was the only way the legislative branch, Congress, had any say over executive orders, like the National Emergency Powers Act, and the War Powers Acts etc. etc. Was the Justice Department fully aware of the immense amount of power that they have transferred to the executive branch with that decision, and if so, was this orchestrated from behind the scenes? And does Awareness see this as having a significant impact on the average citizen, and the possibility of a police state being set up more rapidly now that the way has been cleared?"

COSMIC AWARENESS:

This Awareness indicates that this is in the affirmative. This Awareness indicates that at the time previously when this Awareness indicates the Justice Department was the least corrupt, this information as having been in reference to the corruption of individuals involved and the general adherence of the legal department to the laws that have been active and have been used in setting precedents in this nation. This Awareness indicates that essentially, this as in reference particularly to the Constitutional Laws, although during the past 50 years, the Constitution has been ignored considerably by the courts in determining the outcome of many trials.

This Awareness indicates that in the more recent years, the changes in the court have allowed a greater trend toward that which has been in compliance with the trend toward the executive branch and its goals. Posse Comitatus crackdown looms

KANSAS CITY, Mo. (AP) — The federal government is ready to launch a full-scale crackdown on the militant Posse Comitatus after the death of posse member Gordon Kahl in a shootout with authorities, The Kansas City Times reported today.

The newspaper said the death of the militant tax protester in a Friday night gun battle at Walnut Ridge, Ark., apparently cleared the way for broader action by federal authorities against the right-wing group.

The copyright story attributed the information to "well-placed federal law enforcement sources."

The legal framework for the crackdown was laid during the months that Kahl remained a fugitive after he, his son and another man shot

and killed two federal marshals who tried to arrest Kahl in North Dakota on Feb. 13.

The Justice Department granted federal authorities permission to conduct wide-ranging investigations of Posse Comitatus, The Times said. Although federal officers publicly maintained Kahl was sought only as a fugitive, they kept private their plans for broader operations against the group, it said.

Posse Comitatus, literally "Power of the County," is a militant group of armed survivalists who challenge all forms of state and federal authority, including the power to levy taxes.

Posse membership figures are not known, but leaders claim to have chapters in every state except Hawaii, with up to 2,000 members in 13 Wisconsin counties.

This Awareness indicates that the individual Justices who rendered this decision were not all totally aware of the full implications, but in general, recognized that they were handing over greater power to the executive branch and were weakening the power of the legislative branch, and in such judgment, these individuals did not concern themselves with the long-range effect that the rulings would have on the citizens of this country.

This Awareness indicates that in actuality, no one yet has fully recognized what the implications of this ruling can bring about. This Awareness indicates that it is totally awesome, as the expression goes, and any entity who *really* looks at this will be astonished at the implications of this ruling. This Awareness indicates that there can however, be moves which can alter the potential of this action. Congress itself is becoming alarmed at its own incompetency and if so alarmed, may react.

This Awareness indicates however, it also appears that Congress could likewise become even more incompetent because of this and that the further incompetence could lead to a complete breakdown of the system, whereby the Constitution itself would be seen as unworkable, and whereby the new constitution which was designed under the influences and control of the Rockefeller brothers* in the '60s, as that which could be used as a pattern or as the new constitution.

This Awareness indicates that it is a strong possibility that further breakdown of Congress due to this law as that which could lead to the collapse of the Constitution of the United States, but that this will require much publicity, arguments, and further erosion through laws and through government, and through the effects on the masses by the media.

That whereby the American public can be convinced that the Constitution is unworkable, then it can be scrapped and the new constitution may then be introduced that will help to more quickly enslave the American people.

THE PROBABILITY OF TWO CLASSES: THE MASTERS & THE SLAVES BY 1990

(Opening Message, Following Reading)

COSMIC AWARENESS:

This Awareness indicates that continuing from the theme or subject matter of the previous reading, this Awareness wishes to focus on the potential outcome of the efforts by those forces which would set up the dictatorial and totalitarian rule by the end of this decade. This Awareness indicates that this program has been put off twice already. This Awareness indicates that this was originally intended to occur in the mid-seventies; that by the year 1976 the intention of these planners was to have the Electronic Fund Transfer System in order, whereby entities would be involved in all trade *without* currency, using only the credit cards and Electronic Fund Transfers.

This Awareness indicates however, the technology was incapable of keeping up with that time-table, and the psychology of the masses was not prepared to accept that program, therefore, the program was put off, and the time table has been moving on a slower scale and has been/being set back on a kind of gradual implementation whereby the exact deadline or date-line for this program is not fixed, but is on a random course. That this is being implemented in this manner so that the forces attempting to bring this about may be more flexible and do not feel pressured to meet a time table or deadline and thus give away the secrets of their plan before it is acceptable to the public.

This Awareness indicates that the very slow implementation of this plan is that which creeps along steadily and which at present time is seen to be focused and coming together near the end of this decade, approximately 1990. That this is not an absolute fixed date. This Awareness indicates the probability of success of this plan for world totalitarian government and a creation of two classes,—the masters and slaves,—this probability of success is that which is unlikely, although there is a chance that it could be successful for a brief period.

This Awareness indicates the reason for it being unlikely is that the masses, while being willing to accept that which allows for convenience and which seems to be electronically efficient or economically efficient or socially efficient, accepting this plan up to a point, the masses are such types as to go along with the plan so long as they see benefits from the plan. This Awareness indicates that in order to implement the plan past a certain point, wherein it is seen as that which is becoming a threat to individual freedoms and rights, the totalitarian planners will need to have great cooperation from the press, from the media, and from individuals in the local areas who are essentially civic leaders, to continue persuading those who are feeling the crunch from this plan, persuading them to continue to accept the plan, when they actually see it is infringing on their rights and the rights of others.

This Awareness indicates that at this point there will be much backlash and objection to the program whereby voices will begin to cry out and demand that safeguards in the use of computers be implemented so that entities' freedoms are protected. This Awareness indicates that it is at this point that the use of force in order to continue creating a totalitarian system will need to be brought in to quell those who are disturbing the process, and whereby force is brought in, it is at this point that the backlash will automatically be enhanced, intensified, to deal with the force that has been brought to bear against those who objected.

This Awareness indicates that in other cultures, wherein entities have for many centuries been involved in and experienced and been conditioned to oppression from government, these entities, culture-wise, have accepted oppression as a way of life, and in other cultures such as these, totalitarian governments have been able to maintain a strong iron hand over the masses without great difficulty. This Awareness indicates that the nature of the American individualist is such that having been conditioned to believe he or she is a free person, having been conditioned to believe that he or she has a voice in the government, those entities involved in that culture to experience a totalitarian iron hand placed upon them are quite likely not to respond in the manner of other cultures, to simply accept the totalitarian government, but are more likely to begin a new revolution and throw off the totalitarian yoke.

This Awareness indicates that this as a possibility if the energies of this plan are carried through to the point whereby they use force in their efforts to impose the totalitarian government upon the American people. This Awareness indicates this particularly in terms of the United States and entities in Canada. This Awareness indicates that a more probable scenario is that wherein the forces attempting to implement this plan of using the economic system to control the masses and lead them into accepting a totalitarian rule, these forces in their efforts to implement this plan will run into a steady stream of resistance from the masses and from their own ranks, so that as they press for these oppressive laws and rules, they discover that the resistant forces are one step ahead in explaining to the masses what is occurring, so that as they continue pressing, they are also exposing their intentions to the masses and the masses and media and individuals in exposing these motives and intentions are awakening more entities so that a growing backlash occurs simultaneous to the continued pressure to implement these plans.

This Awareness indicates that this is the probable scenario, presuming that the individuals who are aware of this potential totalitarian state keep up their vigilance and continue communicating and exposing the efforts by those who would create the totalitarian state, and continue to awaken the masses.

This Awareness indicates that if for some reason these entities do not continue this effort and the masses should fall asleep or cease to awaken others and keep others informed, then it is possible that these totalitarian forces could implement their program and set up the totalitarian system for a period of time requiring extreme and intense energies in order to throw off the yoke of that system. This may take many years, or may take but a few years, depending on the cooperation or acceptance of the masses. LEADERS OF OUR COUNTRY ARE COMMITTING TREASON!

QUESTION:

Awareness, I'd like to read an excerpt of a long article I caught in a recent New York Times Magazine, concerning government secrecy and ask Awareness what the ramifications will be of this. It says:

"A few weeks ago, on Aug. 25, 1983, the Reagan administration publicly released a contract that has no precedent in our nation's history.

"To be signed by all government officials with access to high-level classified information, it will require these officials, for the rest of their lives, to submit for governmental review newspaper articles or books they write for the general reading public.

"The contract will affect thousands of senior officials in the departments of State and Defense, members of the National Security Council staff, senior White House officials and senior military and Foreign Service officers.

"Its purpose is to prevent unauthorized disclosure of classified information, but its effects are likely to go far beyond that. It will give those in power a new and powerful weapon to delay or even suppress criticism by those most knowledgeable to voice it.

"The new requirement, warns the American Society of Newspaper Editors, is 'peacetime censorship of a scope unparalleled in this country since the adoption of the Bill of Rights in 1791.'

"The subject of recent hearings by a Senate Governmental Affairs subcommittee, this latest attempt at information control by the Reagan administration is part of a far more sweeping policy. It is one unique in recent history--clear, coherent and, unlike that of some recent administrations, not a bit schizophrenic.

"More important, it seems at odds with the concept that widespread dissemination of information from diverse sources furthers the public interest. In fact, it appears to be hostile to the basic tenet of the First Amendment that a democracy requires an informed citizenry to argue and shape policy.

"In the two and a half years it has been in power, the Reagan administration has:

"Consistently sought to limit the scope of the Freedom of Information Act (FOIA).

"Barred the entry into the country of foreign speakers (including Hortensia Allende, widow of Chilean President Salvador Allende) because of concern about what they might say.

"Inhibited the flow of films into and even out of U.S. borders; neither Canada's Academy Award-winning "If You Love This Planet" nor the acclaimed ABC documentary about toxic waste, "The Killing Ground," escaped administration disapproval.

"Rewritten the classification system to assure that more rather than less information will be classified.

"Subjected government officials to an unprecedented system of lifetime censorship.

"Flooded universities with a torrent of threats relating to their right to publish and discuss unclassified information--usually of a scientific or technological nature--on campus.

... "It is a view that not only focuses on security but also equates security with secrecy, and treats information as if it were a potentially disabling contagious disease that must be controlled, quarantined and ultimately cured."

The article goes on and on, but Awareness can get the general idea of what is being published in this article. Would *It* please comment on Mr. Reagan's recent acts along this line.

COSMIC AWARENESS:

This Awareness indicates that the actions very well speak for themselves, and it is amazing that entities do not yet recognize what is occurring in this country. This Awareness indicates that unless entities understand what the American way of life *is, or has been*, as to its standard on which it was built, entities have no way of measuring their public officials to determine whether or not they are representative of the American way of life, or whether or not they are traitors to the American way of life.

'Anticrime' bills' repressive measures

During a seven-day period early in February, the United States Senate passed a series of four bills — S.1762, S.1763, S.1764, S.1765 — which in the words of the National Committee Against Repressive Legislation (NCARL) "assaulted the Bill of Rights" and "rode pell-mell over the Constitution." Below we reprint a summary prepared by NCARL briefly summarizing what these bills will do if finally enacted into law. All four bills are currently pending in the House of Representatives.

SOLICITATION: S.1762 creates an entirely new federal crime, making certain speech illegal even if no criminal act results. If you "endeavor to persuade" someone to commit a violent crime — even if it involves just the threatened use of force against person or property, you may be sentenced up to one-half the prison term prescribed for the crime itself. If, for example, you suggest in a meeting of an anti-nuclear group that people enter the site of a nuclear power plant and prevent construction by a sit-in, but after discussion the group decides against the idea, you can still be imprisoned. You can be imprisoned even if you encourage someone, during a discussion of political tactics, to engage in conduct you think is constitutionally protected but which in fact is not. This new crime inhibits the exercise of First Amendment freedoms and has serious potential for abuse. *Title X, Part B, pp. 351-353.*

EXCLUSIONARY RULE: The exclusionary rule was developed by the Supreme Court to enforce the Fourth Amendment prohibition against unreasonable searches and seizures by requiring that courts exclude evidence from criminal trials that was seized illegally. S.1764 would allow the evidence to be admitted if the police claim that they seized it in "good faith" that they were doing so legally. This "good faith" exception amounts to an abolition of Fourth Amendment safeguards against unlawful police conduct by removing any incentive for the police to learn about and adhere to constitutional requirements regarding searches and seizures.

WIRETAPPING: S.1762 expands federal authority for wiretapping without a warrant. *Title XII, Part B, pp. 397-399.*

GOVERNMENT APPEAL OF SENTENCES: S.1762 allows the government to appeal a sentence it considers too lenient if it is below the recommended guideline sentence. This conflicts with the purpose of the Fifth Amendment protection against double jeopardy, which is to limit government to one opportunity for conviction and sentencing. If the government fails to make its case, it cannot and should not be allowed to repeatedly threaten the accused.

Prosecutors could use this increased power to harass political dissidents. The threat of government appeal of a sentence could also inhibit

a defendant from appealing a conviction since the prosecutor would likely seek a stiffer sentence. This threat could also influence an innocent defendant to accept a plea bargain, thereby coercing a defendant to waive the right to a trial guaranteed by the Seventh Amendment. *Title II, pp. 187-88.*

HABEAS CORPUS: S.1763 would deprive the federal courts of their chief function under the Constitution, that is, the protection of the constitutional rights of its citizens. Currently state prisoners may file a writ of habeas corpus in federal court if they feel they are being incarcerated in violation of their constitutional rights. S.1763 would prevent a federal court from reviewing a state court decision on a federal constitutional issue if the state court's conclusion was "fully and fairly adjudicated," no matter how compelling the defendant's claims may be. Moreover, if a constitutional issue was not raised in the state trial, a federal court may not address the issue, even if failure to raise it was due to attorney incompetence, unless very specific conditions are met.

S.1763 violates Article I of the Constitution by cutting off the right of petition of a state prisoner after one year, and of a federal prisoner after two years.

Proponents of S.1763 claim that this bill is needed because the federal courts are flooded with habeas petitions and that most of these are frivolous. In fact, habeas petitions constituted only 3.67 percent of all criminal and civil filings in federal district courts in 1981.

WARRANTLESS CUSTOMS SEARCHES: S.1762 expands federal authority to conduct customs searches for currency. It eliminates the search warrant required currently before a customs officer may stop and search someone if the officer has "reasonable cause" to suspect a violation of currency transportation laws, a standard weaker than the "probable cause" showing required for a search warrant.

It also expands the scope of the law to cover a person who "attempts" to transport currency in violation of law, which the American Bar Association has testified makes the statute "dangerously broad and vague."

Moreover, it authorizes large-scale payments to informers, ignoring the dangers of informant testimony.

PREVENTIVE DETENTION: S.1762 ignores the due process requirements of the Bill of Rights and allows judges broad discretion to hold an accused person in jail for months — before any trial has taken place — if they decide that the person is "dangerous." It abolishes the cherished principle that a person is presumed innocent until proven guilty, and replaces it with a presumption of guilt if the person has a prior record — thereby punishing someone for conduct which has already been penalized — or if the person is accused of

committing a felony while using or possessing a firearm — thus allowing incarceration before trial based on the nature of the accusation. *Title I, pp. 1-29.*

S.1762 eliminates the Sixth Amendment right to confront and cross-examine witnesses by allowing defendant cross-examination only of witnesses who appear at the hearing, and by eliminating the right to compel the presence of government witnesses whose testimony is offered to the court to justify a denial of bail based on a prediction of the defendant's "dangerousness." *Title I, pp. 1-29.*

SENTENCING: S.1762 completely abolishes parole, increases maximum sentence lengths, severely limits good-time release, and requires mandatory minimum sentences for certain crimes. This bill will increase the prison population at a time when prisons are already dangerously overcrowded.

S.1762 takes discretion away from judges and significantly increases the power of prosecutors through its sentencing guideline scheme. The bill requires the Sentencing Guideline Commission to establish "categories" of defendants and to base guidelines on factors relating to the status — not the conduct — of the defendant, such as age, education, employment record, and family ties. *Title II, pp. 29-159.*

INSANITY DEFENSE: S.1762 effectively abolishes the insanity defense by limiting it to those cases in which the defendant was unable to understand the wrongfulness of his or her acts. It eliminates the current test of whether the defendant is able to control his or her conduct or to conform to the requirements of law. This means that a person who stabs another thinking s/he is cutting into a box may plead insanity, but a person who kills in the belief that voices ordered him or her to do so may not. Such a limitation on the insanity defense raises serious questions of Fifth Amendment due process protections and the Eighth Amendment prohibition against cruel and unusual punishment. *Title IV, pp. 201-228.*

FEDERAL DEATH PENALTY: S.1765 would re-establish a federal death penalty. The sanction of death would be available for such crimes that do not result in death as treason and espionage; attempted assassination of the president, as well as for various felony murders. The penalty was used in 1953 for political reasons against Julius and Ethel Rosenberg. Now, in 1984, the government claims the need for the penalty as it increases its attacks on democratic freedoms.

Orwell's '1984' believed near

MINNEAPOLIS (UPI)—A leading Protestant theologian claims the United States is closer to the kind of world depicted in George Orwell's novel "1984" than it realizes.

To forestall its arrival, Dr. Robert McAfee Brown said, Americans must take on the stance and courage of the Barmen Declaration, issued by Christians opposed to Adolf Hitler in

Germany 50 years ago. Dr. Brown is a Presbyterian and professor of theology and ethics at the Pacific School of Religion in Berkeley, Calif.

The Barmen document, largely the work of Swiss theologian Karl Barth who was teaching in Germany at the time, was signed in the city of Barmen by Lutherans and Calvinists who made up the so-called

Confessing Church. The declaration stated that no Christian can support Hitler and that all Christians must oppose him.

Brown said the signers realized it was impossible for Christians to support both Jesus Christ and Hitler.

In the spirit of Barmen, the theologian added, the church in the United States must move toward

unequivocal repudiation of the manufacture, possession and use of nuclear weapons by any nation under any circumstances.

As for his belief that this country is moving closer to "1984" than it realizes, Brown said the Reagan administration's ideology "gradually takes less and less account of dissent, manages the news to its own benefit, and holds it-

self entitled to act unilaterally regardless of what others say."

For example, echoing the Orwellian theme that "war is peace," the military invasion of Grenada was called "a rescue mission," Brown said.

In accord with another Orwellian slogan that "freedom is slavery," he added, the administration

has told public officials that if they have freedom to express their own opinions, they might destroy our democratic institutions and enslave us, so they must be censored.

"Barmen protests when government says, 'Hear, trust and obey us. We'll decide what information you should have,'" the theologian said.

Reagan Orders Concentration Camps

EXCLUSIVE TO THE SPOTLIGHT

Mass detention facilities—otherwise known as concentration camps—are being set up at a number of major U.S. military installations on the secret orders of President Ronald Reagan.

The SPOTLIGHT has learned that on April 5 the White House issued a highly classified National Security Decision Directive (NSDD) which sets forth urgent instructions for the "activation" of 10 huge prison camps at key defense commands located across the nation.

Less than 24 hours before this edition went to press, on April 11, The SPOTLIGHT received information from two trustworthy confidential sources—

patriotic career Army officers—stationed at Ft. Benning, Georgia, and Ft. Chaffee, Arkansas, revealing that preparations were being set in motion for an unprecedented roundup of aliens and "security suspects" coast to coast.

According to these sources, the primary goal of the vast police operation, codenamed "Rex 84," is to detain and deport illegal immigrants.

But these sources say "Rex 84" has another, even more closely guarded and carefully orchestrated objective: To apply so-called "C&C" ("capture and custody") measures against political opponents, resisters or even outspoken critics whom the administration considers "dangerous."

According to the information obtained—and substantially confirmed—by The SPOTLIGHT, the four principal civilian concentration camps to be established under the "Rex 84" program will be located at Ft. Chaffee, Arkansas; Ft. Drum, New York; Ft. Indian Gap, Pennsylvania and at Camp A.P. Hill in Virginia. Each one of these camps is being laid out to hold 25,000 civilian prisoners under the guard of American troops.

Additional emergency custodial facilities are being readied at Oakdale, California (reportedly for 15,000 detainees) and at Eglin Air Force Base in southern Florida, at Vandenberg AFB in California, at Ft. McCoy, Wisconsin; Ft. Benning, Georgia; Ft. Huachuca, Arizona; and finally at the southern Justice Department detention and interrogation center known as Camp Krome near Miami, Florida.

A major national task force of federal intelligence and law-enforcement agencies—including the FBI, the CIA, U.S. marshals, the Immigration and Naturalization Service, Customs, Coast Guard, and so forth—will join with local and state police in massive roundups to haul in lists of suspects who will fill these improvised stockades.

"The first roundup—and the publicly announced one—will be of illegal aliens and refugees," a military source told The SPOTLIGHT. "But under the secret provisions of 'Rex 84' there will be also broad arrests of security suspects, who can be held in these centers, under this emergency order, whether they're U.S. citizens or not."
Americans whom the administration

wrong newsletter—may find themselves hauled in with hordes of illegal immigrants if the bureaucrats find them "dangerous."

Suspected or "potential" terrorists, subversives and draft resisters may eventually also find themselves caught in the broad "Rex 84" net, according to these sources.

Another category of anti-bureaucratic activists which may be bound for administrative detention under this directive is that of "major, organized tax resisters," one source close to the program has told The SPOTLIGHT.

This informant—a Pentagon policy analyst assigned to the National Security Council (NSC) in the White House—has identified Kenneth de Graffenreid, a special assistant to President Reagan, as the NSC official temporarily in charge of coordinating the preparatory phase of "Rex 84."

Not a single source interviewed by The SPOTLIGHT could cite a Constitutional or legal precedent for such a staggering mass roundup of civilians by American authorities in peacetime.

The nearest analogy provided by one expert emerged from the security sweeps ordered by the Austrian government of Chancellor Engelbert Dollfus in the late 1930s.

Prefiguring "Rex 84," these crack-downs were officially targeted at "illegal aliens"—that is, the many German-born residents of Austria whom the Dollfus government suspected of being sympathetic to the National Socialist government of Adolf Hitler.

But the Austrian authorities' aim soon shifted to their own citizenry. They began tossing into camps like the giant Mollersdorf Center tens of thousands of Austrians whom the regime considered opponents or "subversives"—i.e., adherents of the banned National Socialist Party.

What criteria will be used in deciding who's "dangerous" and who isn't? Will it be based on the "hate list," drawn up by the Anti-Defamation League (ADL) of B'nai B'rith (SPOTLIGHT, Jan. 4-11, 1982, March 28, 1983 and others)?

In 1980, the United States Commission on Civil Rights (USCCR) signed a contract with the ADL to prepare a

report for the USCCR on "hate" groups in America. For \$20,000 in taxpayer money, the ADL produced a report that focused on groups that support the Constitution.

The report was completed, submitted to and accepted by the USCCR. But, following standard procedure, the commission sent portions of the report to various groups mentioned, soliciting comments. The responses were scathing, and the groups did not stop at letting the USCCR know their feelings, but wrote their elected representatives as well.

As a result of the responses from groups mentioned, and inquiries from Capitol Hill, the USCCR decided not to publish and disseminate the ADL-written report. But in early 1983, the ADL came out with its own report, which was a re-write of the report submitted to the USCCR.

Interestingly, the report carries no mention of the Jewish Defense League, best known for perpetrating violence against those with whom it disagrees.

FEDS ADMIT 'REX 84'
In response to an inquiry by a SPOTLIGHT reporter, Robert Blair, a

spokesman for the Federal Emergency Management Agency (FEMA), admitted that "Rex 84" was the designation of a "classified project" initiated only a week before our inquiry.

But Blair denied any knowledge of planned mass arrests. "I'm not aware of anyone having been detained," he told The SPOTLIGHT. "What you have (learned) may have been generated at a lower level of staff level—it's all mixed up."

But other sources confirmed that "Rex 84" was "the secret appendix"—as one official put it, asking not to be named—of a series of executive orders concerning emergency preparedness and national security being issued by the White House. The first phase of what is described as a complete revision of emergency and security preparation by the Reagan administration was marked on April 3 with the promulgation of Executive Order 12473, detailing the reorganization and federal control of national telecommunications systems in case of a major national emergency.

Sneak attack on democratic rights

History demonstrates that general assaults upon the citadel of civil liberties are preceded by repeated forays and frank attacks. The object is to weary the people until they can no longer arouse themselves for a defense of their interests. The decade-long effort in Congress to "codify" a whole range of federal laws is a case in point.

On February 3, the United States Senate, by a vote of 91 to 1, passed Senate Bill No. 1762, a 387-page bill intended to overhaul the Federal Criminal Code. That was simply one more step in the decade-long effort by members of Congress, during both Democratic and Republican administrations, to make drastic changes in the federal criminal code.

Camouflaged from the start as simply a codification of what is known as Title 18 of the United States Code, that long effort has repeatedly taken the form of a broadside attack on basic rights guaranteed in the Bill of Rights. Moreover, that effort has had the support of officials in the highest levels of federal law enforcement.

The effort got rolling with the introduction of S. 1400, a bill entitled "Criminal Code Reform Act of 1973," that languished in the Senate until it

was replaced by S. 1, "Criminal Justice Reform Act of 1975." The outrageous provisions of S. 1 drew an outburst of protest from a host of civil libertarian and grassroots organizations throughout the country. That eventually prompted the supporters of S. 1 to drop that particular attempt to revise the code.

They did not, however, give up their plans or objectives. In due course, S. 1 was followed (in 1977) by a bill known as "The son of S. 1." In 1979, it was S. 1722; in 1980, it was S. 1630. And there were others. For a variety of reasons, political, circumstantial, etc., none of these bills reached their intended goal.

As the years went by, however, each bill received less media exposure and elicited less public response or protest. The wearying process was having its effect. Thus, S. 1762, the bill recently passed by the Senate received relatively little media exposure. Even its passage in the Senate was given little attention in the media. And it is highly questionable whether a majority of the American people were or are aware of the bill or the threat it poses.

What exposure the bill did get in the media placed the emphasis on the anti-crime aspects

of the bill. Little was said of its blunderbuss nature and the effect it could have on what is left of the basic freedoms guaranteed in the Bill of Rights.

Accordingly, there is now the great danger that the bill — or the basic provisions of the bill — will be pushed through to final enactment.

The bill has yet to be passed in the House. There is still time, therefore, to raise your voice against its passage by writing members of the House voicing opposition to the measure and demanding its defeat.

There is little doubt that the forces of reaction are gaining momentum and must be resisted. But while such bills as S. 1762 can and must be opposed as reactionary and vicious assaults on what is left of the basic freedoms of the American people, the majority of whom are members of the working class, the ultimate defense against the imposition of political absolutism does not lie within the framework of this class-divided society.

The reactionary trend can be permanently halted only when that system is replaced with a socialist society democratically controlled and administered by the workers.

President tries to draw the curtain of secrecy

WASHINGTON — President Reagan has tried to draw a curtain of secrecy between the government and the people. What he wants the people to know, he would like to communicate to them directly or through government-controlled mechanisms.

Claiming a need to stop leaks of classified information, Reagan has done all in his power to keep a tight noose on the news. Here's how he has sought to control the flow of information to the public:

□ He'd like to shut up government employees by subjecting them to lie-detector tests. The tests would not, of course, stop the biggest leaks of all: the disclosure of classified information by the authorities themselves whenever it suits their purposes.

□ The White House wants to impose lifetime censorship on all government workers with access to classified information. The censorship wouldn't apply, of course, to the president and vice president, who would be free to write their memoirs. But no one else would be able to set the record straight, facts that contradict the official line could be censored.

Blinds pulled down

□ The Reagan administration has also issued an executive order allowing far wider use of the secrecy stamp. Invariably, the government uses its classification powers to censor the news. The people in power regularly stamp "secret" what properly should be labeled "censored."

□ The administration has pulled down the blinds of the CIA. A reporter can now be sent to prison for reporting news that might give a clue to the identity of a CIA agent. In the past, the CIA has instigated rebellions, undermined friendly governments, arranged assassinations, conspired with organized crime and engaged in other dark deeds that violated U.S. laws.



□ The administration has also obstructed press coverage of military activities. Reporters were barred from observing the Grenada invasion. The Pentagon's self-serving version of this major event, therefore, was all that was available to the American people.

There is another annoying obstacle to "secret government," and sure enough, the Reagan administration has set out to remove it. This is the Freedom of Information Act, a landmark law that permits individuals to learn what the government has in its files, within the limits of personal privacy and national security.

The administration has already pushed a bill through the Republican-controlled Senate to amend the act. Of the more than 40 changes the administration wants in the Freedom of Information Act, here are the ones that are most worrisome:

□ Federal agencies would be allowed to charge a fee for reviewing their files, instead of charging only for documents given out. This could increase the cost of FOIA requests 10-fold, effectively prohibiting them for all but the wealthiest.

□ A crucial change in wording could close off much of the law-enforcement information now available under the act. As the law stands now, such information may be withheld only if it would endanger informers, hamper investigations or violate an individual's right to privacy.

□ A real sleeper in the Senate bill would allow a government

agency to charge an additional fee — above the cost of printing, that is — for documents that contain "commercially valuable technological information." The change could conceivably let the government set prices for its popular "how-to" publications on the basis of their assumed value to the buyer, not the printing cost. This, in effect, would give the government copyright authority — a power it has never had.

□ At present, the information act makes no distinction among applicants, nor does it evaluate the merits of an application beyond waiving the printing fee for requests that are clearly in the public interest. But the bill would discriminate against three classes of applicants: foreigners, prisoners and anyone involved in litigation against the government. This would give the agencies the added burden of determining who is making each request — a costly and time-consuming task.

Mounting concerted effort

□ The Senate rewrite of the Freedom of Information Act makes a sneak attack on the public's right to even unclassified information. The law now requires agencies to release all unclassified portions of a document that are "reasonably segregable" from the parts that are exempt from release. Removing that requirement would allow agencies to refuse FOIA requests in wholesale quantities.

The politicians who govern us are mounting a concerted effort to undermine trust in any source of information that is not controlled by them. Preposterous lies can be told to make the powerful look good; grievous blunders can be committed by officials in the name of the government; the public can be cheated by people sworn to uphold the public trust. But let an investigative reporter make a mistake, and there will be howls of outrage.

IRS agents can adopt disguises

WASHINGTON (UPI) — The Internal Revenue Service has adopted guidelines that let agents pose as reporters, clergymen, lawyers and doctors — but only in rare cases with permission from Washington headquarters, the agency said yesterday.

Investigators can attempt to gain the confidence of people they are investigating through such masquerades "only when the field can demonstrate an extremely compelling need to do it and then there is severe doubt that we would approve it," a spokesman told United Press International.

Permission to adopt such disguises must come from IRS officials at headquarters in Washington, said spokesman Larry Baird. "The field offices cannot make a decision on that."

He said the guidelines, described in the Internal Revenue Bulletin, are patterned after those used by the FBI and apply only to criminal investigations. In use since October, the guidelines are distributed to field offices.

WASHINGTON (AP) — In an apparently unprecedented move criticized by a news media lawyer as a "judicious spectacle," the Justice Department is trying to block publication of a federal court opinion that chastises three department lawyers for possible misconduct.

"This is an impermissible prior restraint on publication, pure and simple. It's a judicial spectacle provided by the Justice Department showing that the level of insensitivity is appalling," lawyer Bruce Sanford said Wednesday.

Other lawyers who work in free-press and free-speech litigation called the government's effort an attempt at censorship.

Justice Department spokesman John Wilson disagreed. "This is not prior restraint," Wilson said Wednesday. "Wilson said the government's efforts are aimed at a federal judge, not at the pub-
