

TO HELL AND BACK... HOW TO LIVE THE HIGHEST AND BEST

The Measure of Spiritual Development

QUESTION:

We have a question from W.K. in Massachusetts. This question contains a number of questions, so perhaps after I read the question, Awareness can capsule an answer that might cover the major question:

"I have yet another question for Awareness on behalf of the membership. We are constantly exhorted to 'strive for the highest' and yet at the same time we are informed that all levels, even the lowest, are divine and have their place. Well, how are these two points of view reconciled? Is the whole purpose of the physical plane, the astral plane, the mental plane just to have us go through so much yearning to get out of those spaces, that we finally get enlightened enough to see that the whole trip was a big mistake anyway? Seems like a sadistic joke, doesn't it? Well, my imaginary guru, Swami something-or-another Ananda, sometimes hints to me that the sadistic joke wasn't God's fault. Maybe God only created the very highest levels, and on that level we all had free will and we decided to create the lower and slower levels, so we played a joke on ourselves and God has been permissive enough to let us have our way so that we could learn how unnecessary it is to have our own way when we could have God's way all along instead; but is this really true? Is the whole point of 'striving for the highest' to finally put an end to these lower illusory and cosmically unnecessary levels, or is there another meaning of 'strive for the highest'? Perhaps something more like 'strive to penetrate to the very highest levels obtainable' and then to integrate that highest level with the continuing and divinely intended outer levels so that they, while continuing to the lower and slower, are transformed from bare cloth, so to speak, to fine outer garments of the one life. Well, if the latter, which sounds more humane, is true, then why do ascended masters keep ascending and leaving it all behind? When is it irresponsible dawdling to keep liking the physical, emotional, mental plane to see how much of a paradise you can make out of it, and when is it responsible fulfillment of one's incarnation to do that? When is it proper evolution to get beyond this physical, conscious reality and when is it unwise impatience to try to do so and why? Thank you."

COSMIC AWARENESS:

This Awareness indicates the mind is a place of its own, can make a hell of heaven or a heaven of hell. This Awareness indicates that *It* would like to see entities capable of experiencing heaven regardless of where they travel or what they do or what they see; and in that experience of heaven, assist others who are experiencing hell to give up that identification with the lower levels of consciousness, the hellish levels, and move on into the highest and best.

This Awareness indicates that one entity may tread through muck and mire, through muddy fields, and may consider this as being a kind of punishment or a suffering; another entity may move through the same field and consider it to be a pleasure and an enjoyment. One entity may work at a job which requires much physical stamina and consider this to be a great opportunity; another may consider it to be a burden. One entity may see his or her life as tragic, even though the entity has many blessings; another entity living an exact duplicate life of the first may see the life being a great blessing, even though it has the same problems

as the first. This Awareness indicates the mind is a place of its own; can make a hell of heaven or a heaven of hell.

This Awareness indicates that the entity who enters each moment expecting and looking for the worst, and when finding the worst possible condition within that moment, laments and wails and moans and pities himself, --that entity is making a hell of his moment. The next entity entering the same moment, may look and discover that which is the highest and best available in that moment and may find great joy in that moment and make a heaven of that moment. This Awareness indicates that it would appear that entities should avoid the unpleasant and only seek that which is pleasant (as in the hedonistic philosophies), but this is not the complete message which this Awareness wishes entities to understand:

This Awareness indicates that you move toward the highest and best within each moment, but that you respond to the urgencies of each moment. That wherein an urgency drags one down and calls for your response, wherein there is one who is suffering and one who is offering you great pleasures, this Awareness suggests that you look at the totality of the moment, that you be aware of the totality of the moment. This Awareness does not suggest that you seek out urgencies, that you look for trouble, that you seek out the problems in order to be one who is a rescuer. This Awareness does not ask that you look for the beautiful and ignore that which is the ugly, does not ask that you look for those who will uplift you and ignore the downtrodden. This Awareness asks that you look at the total moment with an intense attention; and wherein you find yourself responding to an urgency, that you respond and then move toward the highest and best available in that moment, not in the portion of the situation which is best, but in the totality of the moment.

This Awareness indicates if one-half of the situation of the moment is unpleasant, the other half of the situation is pleasant,--this Awareness does not ask that you ignore the unpleasant and move toward the pleasant in order to seek the highest or best, nor does *It* ask that you move from the pleasant and search out the unpleasant, ignoring the pleasant to dwell in the unpleasant. This Awareness asks that you look at the totality of the moment, respond to any urgency and then move that total moment, the total situation toward that which is highest and best for all aspects of the moment.

This Awareness indicates a more concrete example: If one entity is suffering and three entities are having a great time enjoying themselves, and you enter in to the scene, you have the opportunity of either responding to the one who suffers or joining with the three who are enjoying themselves, or observing the totality of the situation and responding to that totality. This Awareness suggests that wherein you look closely at this situation, you will seek to discover what is happening, and as you seek to discover what is happening, you may question and address the entities involved to discover why this entity is suffering and why these others are enjoying themselves while this entity suffers.

This Awareness indicates that as you continue seeking to understand the situation, you may find yourself suddenly being compelled, without personal intention but simply because the urgency of the situation compels you, to respond to the one who is suffering or to join with the ones who are enjoying themselves and

ignore the one who is suffering. You may discover that there is a reason why these three are ignoring the one who is suffering and why they are enjoying themselves, and you may discover that the action is such that this is exactly what is needed for that one who is suffering; for the suffering may be self-inflicted, intentional and desired, or may simply be to impress others. Or you may find that you are drawn to the one who is suffering, assisting the one who suffers and may find yourself chastising those who enjoy themselves at the expense of or at the ignorance of the one who suffers.

This Awareness indicates that you cannot predetermine what your response will be to the situation of the moment until you have observed deeply, looked deeply, questioned and discovered what is happening in this moment; then from that deep observation, that awesome looking, that awareness, you will find yourself responding and moving the energies of the situation toward that which is the highest and best for all concerned. This Awareness indicates that in considering the highest and best for all concerned, you cannot ignore the parts and simply avoid the negative and accentuate the positive without dealing with the negative in some way.

This Awareness indicates the dealing with the negative could in fact require that you ignore the negative; however, this Awareness suggests that when you find yourself ignoring the negative, be sure that the ignorance is based on an awareness of the negative, not on an avoidance of the negative, and that you are deliberately and with awareness and with a wholesome understanding of the situation that you are ignoring the negative because you are aware that the ignoring of the negative is the proper approach or proper response. This Awareness suggests that those who ignore the negative of a moment simply to avoid and escape facing a difficulty, facing an urgency; those entities are only half present at the moment, are only partially aware in the moment, and are expressing an ignorance of *what is*.

This Awareness indicates that in relation to the question: that God, (as used by the questioner), did not create the world just as a joke, did not create situations just as a trick played against human consciousness. All of this came about by the interrelationship of entities being aware or being unaware or being partially aware, being responsive or irresponsible, being partially responsive. This Awareness indicates that all is what it is, and those entities who seek for some divine being on whom to blame conditions or from whom to receive guidance; those entities often are avoiding the issues of discovering for themselves, through their observation or through researches or through studies or through learning, avoiding the action of discovering more and more about what is. It becomes quite easy for an entity to create within ones consciousness or latch on to concepts which serve to indicate that a particular entity, scapegoat, deity or demon, is responsible for some type of situation and that the entity is but a victim of that situation, and therefore is unable and has an excuse to avoid dealing with the situation.

This Awareness suggests that entities who are present at a place, at a time, in a moment are the ruler, or co-rulers, of that time, place and moment and can have an effect and can play a role and can be either a dominate factor or a victim of the situation. Such entities can remain in that time, in that place, in that moment, in that situation or may change from that time, place, moment or situation or may change the nature of the time, place, moment, or situation and move into something else.

This Awareness suggests that wherein entities make the changes from moment to moment, that you keep in mind the admonition to move toward the highest and best from moment to moment, so that you do not find yourself moving from one moment into something more

terrible and again more terrible, as each moment passes, unless it becomes essential that you enter into the valley of the shadow of death or into the passage perilous in order to conduct those activities which are necessary for you to bring about that which is the highest and best in the future moments. This Awareness wishes that entities be capable of walking from heaven, down the steps to hell, and in hell conducting their business of reform and uplifting the spirits of those who suffer, and then again being capable of walking back from hell and into heaven without having been scathed by the fires.

The Work of the Descended Masters

This Awareness suggests that entities who ascend and who move into higher levels for the purpose of escape are still on the path toward spiritual progression. That many such entities look back on those who are involved in the physical world, who are making efforts to uplift humanity, and such entities can in their progressive spiritual snobbery, assume that they have progressed beyond the need to be involved in the negative aspects of life, and therefore are above those who are mingling with thieves and robbers, or crucified on crosses, or protecting harlots, or serving the lepers or the blind, or teaching the ignorant, or assisting in any manner the masses below. This Awareness indicates that often those who are mingling in the lower vibratory planes have descended from higher levels to assist in bringing Light to those lower vibratory levels and are in fact descended masters who have no need, no desire, no inclination to ascend at the moment until they have completed their work.

This Awareness indicates that there are indeed masters who descend from Celestria, from higher levels, from higher planes, who descend into those pits, who take on the karma of others, who are covered with boils and sores of the suffering of humanity, who suffer the spikes and piercing swords; yet even though appearing or being condemned as thieves, frauds or worse, can in fact, in spite of appearances, be of a higher spiritual development than those who, in their white, bright, clean, shining auras, with pious hands prayerfully placed before them and posed, light shining upon their forehead, looking as holy as is possible for the photograph of consciousness, --such entities appearing to be untouched by the filth below, may still not be as spiritually evolved as is the entity who mingles with the rabble, the sick, the needy and the criminal.



This Awareness suggests that entities be most cautious in measuring spiritual development by appearances or by "the good life," by rewards, or by the claims which entities present. For all who claim to be spiritual, all who have the "good life" to point to in their proof of spiritual expression, all who have the higher social contacts as proof of spiritual development, all who have memorized the proper words and scriptures and can rattle off these scriptures and words at the pace of an auctioneer, all of those who have piously been shown to present their action, the behavior, the properly accepted expressions of the guru, teacher or preacher,—all these entities whose reputations may shine like silver, may not necessarily be any more spiritual than any other actor in the play of life.

Number of poor in U.S. climbs to 35 million

WASHINGTON (AP) — The number of Americans officially in poverty climbed by nearly 900,000 to break the 35 million mark last year, the Census Bureau said yesterday in releasing a report sure to become an election-year political football.

The poverty rate for 1983 was 15.2 percent, meaning that 35,288,000 Americans — an increase of 888,000 — fell below the official definition of being poor, said Gordon Green, the Census Bureau's assistant population division chief for socioeconomic statistics.

That is up from a rate of 15 percent in 1982, when 34,388,000 Americans fell below the poverty level, he said.

The figures showed that 15.2 percent of the nation's population fell below the annual income of \$10,178 for a family of four set as the upper edge of poverty in 1983.

Quick reaction

Political reaction came quickly, with House Speaker Thomas P. O'Neill, D-Mass., saying "today we have the smoking gun of Reagan unfairness", and the Republican White House claiming credit for leveling off a rate of increase that soared under its Democratic predecessors.

Administration officials sought to soften the impact of the figures with an accompanying study that said there are really a lot fewer poor people than it seems — if you use a different yardstick to measure them. But O'Neill asserted that "under (President) Reagan, the poor are getting poorer."

In Santa Barbara, Calif., Sen. White House press secretary Benjamin Fitzwater said the report "points out

sent economic growth into a four-year stall, poverty went from 11.7 percent in 1979 to 13 percent in 1980 and 14 percent in 1981. Those policies also led to the recession, which raised the poverty level to 15 percent in 1982."

He said the report showed "poverty has leveled off from the disastrous increases of 1979 and '80," which he blamed on the economic policies of former President Jimmy Carter, a Democrat.

Green of the Census Bureau stressed that if such benefits as food stamps, public housing, school lunches and Medicare counted as income, the poverty rate would drop to between 10.2 percent and 13.9 percent of Americans.

Bureau studies about counting such benefits as income have drawn considerable criticism and an attempt to convene a panel of independent experts last spring to advise the bureau on this approach had to be canceled in the face of the public outcry.


While the administration's political opponents stressed the poverty rate, social action groups promptly attacked the alternate income measurements as an attempt to redefine poverty out of existence.

WHAT SECRETS LIE BENEATH THE LEANING TOWER OF PISA?


QUESTION:

A question from D.A. He says a tabloid recently predicted that the leaning tower of Pisa would collapse soon and that the sub-chambers under the tower would reveal the secrets of the Egyptian pyramids and other ancient esoteric knowledge. Does Awareness see this as valid or possible? And what exactly is the nature of the knowledge contained within the tower?

COSMIC AWARENESS:

This Awareness indicates that there are efforts to keep this tower from further eroding toward collapse. That it appears that more funds and efforts will be required to prevent this. This Awareness indicates that there are seen some artifacts beneath this tower, but that these do not appear to be related to Egyptian technology. It appears rather, that these are crude remnants from earlier civilizations; that these may not be of great significance in comparison to that which is implied in the question.

This Awareness indicates that it appears that the efforts to prevent the tower from collapsing as that which will be successful if the sufficient funds can be raised; that there are entities working to raise the funds to prevent this tower from collapsing.



WHY PEOPLE WEAR EYE GLASSES

(ALL ABOUT PHYSICAL & KARMIC REASONS)

QUESTION:

A question from V.W., Antioch, Tenn. 'Does 'spiritual darkness'-for instance sinning, like telling lies knowingly, stealing, immoral conduct,--believing it wrong, but doing it anyway and so forth, affect our physical sight also? In other words, does living on a higher vibrational plane make us able to have better eyesight physically and living on a lower, earthly vibrational plane make our physical plane make our physical eyesight dim or near blindness?

COSMIC AWARENESS:

This Awareness indicates this as negative. That often the entity whose vision is failing may be induced to develop spiritual insight in order to manage in the physical world of darkness. That the correlation between physical sight and spiritual sight as not nearly as related as the correlation between one's emotional insights and emotional ignorance with the physical sight and physical ignorance. This Awareness indicates that often an entity develops poor vision during times of stress. This can be a combination of psychological and physical problems, whereby the entity does not wish to see something which is happening in his world and the vision begins to fail.

This Awareness indicates that generally when this occurs, the physical is also under stress and there is a chemical imbalance which contributes to the poor vision. This Awareness suggests that for example, wherein entities develop near-sightedness, this as very commonly associated with a shortage of zinc, chromium, and Vitamin B6 and calcium and magnesium. The calcium and magnesium assisting in the nerves, the chromium and zinc relating closely to the adrenalin and pancreas, and the B6 relating to the stress factors; and the combined effect of not having enough these during times of stress can affect the shape of the eyeball, leading to near-sightedness.

This Awareness indicates this as an example of the inter-linking of the psychological, chemical, and physical relationships.

(FOLLOW-UP QUESTION):

Awareness, there is a new technique out that is supposed to work on people with near-sightedness, an operation this doctor does that is supposed to correct the shape of the eyeball so glasses are no longer necessary. (It is also supposed to correct astigmatism). Would Awareness comment on this method?

COSMIC AWARENESS:

This Awareness indicates that this as an action whereby microscopic incisions are made on the lens of the eyeball to cut and shape the lens in a manner which changes its shape to that which is more accurate in reflecting the incoming image.

This Awareness indicates that this may be likened unto taking a lens, such as a magnifying glass, but one which is pliable, made of jelly for example, and cutting this with microscopic slices until it is shaped properly for a different power of magnification, so that the image is seen clearly. This Awareness indicates that from the microscopic slices,

the parts then heal themselves back to a normal lens, so that the incisions are no longer present. This Awareness indicates that this action as being painless as there are no nerves in the lens, and as being effective in assisting the vision when properly done, as is this particular doctor able to do.

This Awareness indicates that this action as being a symptomatic cure, which can be corrective, not dealing with the cause of the near-sightedness, but dealing with the symptom which results in near-sightedness. This Awareness indicates that the cause often coming as a stress period in one's life affecting the lens through the chemical imbalances mentioned previously. This cause may no longer be present in the entity's life and therefore, no longer a continuing cause of near-sightedness. However, if the entity remains under similar stress periods or something new occurs, the same situation may re-assert itself and again cause problems with the vision.

This Awareness indicates however, that most near-sightedness starts when the child is young and progressively continues, either until the stress factors and minerals and chemical imbalance is alleviated and brings about a curing through natural means, or whereby the entity uses artificial means for curing the problem.

This Awareness indicates that this particular method asked about appears to be one whereby the operation deals with an artificial action of cutting into the lens with microscopic incisions, but dealing somewhat with the natural powers of the eyeball to heal those incisions. This Awareness indicates this ignoring other factors relating to the original cause, and does not appear to be totally effective in helping the problem by clearing away the cause, so that it would not reoccur.

This Awareness indicates however, that the action would be beneficial to assist, even if a re-occurrence did come about. That improvement would be certain from the operation (assuming it is done properly), although absolute guarantees could not be expected in all cases.

(FOLLOW-UP QUESTION):

Then most entities that find themselves wearing glasses, this is primarily what Awareness just explained, an occurrence when they were young and not necessarily a karmic carry-over, a reminder that they didn't "see" something in a previous lifetime that they should have seen (like a realization)?

COSMIC AWARENESS:

This Awareness indicates this as negative. That often an entity's physical body may be such that a particular vitamin or mineral is missing, causing the entity to feel less assertive; and the feeling of not being assertive in particular situations, can cause the entity to want to retreat; and the action of seeking to retreat, may cause the entity not to want to see what is occurring; and the action of not wanting to see what is occurring, may cause the entity's vision to dim.

This Awareness indicates this as the psychological affect of but one mineral in the body which has not been provided at a crucial time. This Awareness indicates that another situation may be one whereby the entity simply has a poor vitamin, mineral content which affects the

vision and has nothing to do with psychological needs at all. That still another may have a karmic problem. This however, if carried over from a previous lifetime, would generally show on one's horoscope, on the chart. That still in another sense, an entity may have a karmic cause within this present lifetime, wherein the entity loses vision, either willingly or through some artificial action.

This Awareness indicates that wherein an entity sees a situation which is traumatic to the point of causing a great trauma within the entity's psyche, so that this entity is unable to express the power of the emotions which the entity felt, this entity may find these expressions emerging in some kind of physical handicap, such as poor vision, or some other physical handicap, such as paralysis of a part of the body, or the loss of hearing, or the loss of speech. That such a sudden or shocking or awesome trauma can express itself in different ways if the entity is unable to express this verbally, in action, or in releasing of the emotions. This Awareness indicates particularly when the entity represses these feelings, the feelings will express themselves through other forms of inhibited expression.

This Awareness suggests that still another entity may experience karmic loss of vision through a physical accident or action which leads to violence to one's eyes. For example, the entity may believe that something he has done is unforgivable and this may be hounding his conscience, or perhaps the entity refuses to look at this situation and ignores this. This Awareness indicates either guilt or ignorance could bring about a repercussion from the energies of the subconscious, which would lead to an accident or a similar repercussion to force the entity to look closer to his own actions. Thus this also can be a karmic experience, based on a present lifetime situation.

This Awareness indicates that karma essentially as being an action of cause and effect; the cause and effect creating a pattern which may be carried from lifetime to lifetime, or from situation to situation within one particular lifetime. This Awareness indicates that karma also may be limited to one individual, or may involve more than one, and may in fact involve entire cultures.

THE LIVER IN RELATION TO EYE PROBLEMS

(HOW OUR MOST IMPORTANT ORGAN IS ABUSED)

FOLLOW-UP QUESTION:

A two-part question to tie this up on the eyes: It's generally been purported in health food areas that the liver is the cause of a lot of the eye problems. Would this be a secondary influence compared to the items that have been listed?

COSMIC AWARENESS:

This Awareness indicates that essentially the liver malfunctioning can be a cause of many problems. That when the liver malfunctions and becomes clogged or cannot properly cleanse the foods which are entering the system, then the other organs also must take on the improperly cleansed foods or toxins, and these organs then can begin to suffer under the prolonged, continuous strain of working off toxins which the liver has not been capable of handling.

As these organs lose their functioning ability, due to the overload of toxins, they do not produce the types of energies or allow the proper flow of nourishment which would be available if they had better working conditions. Therefore, many of the vitamins and minerals which would normally be processed through one's diet, may be passed off because of the toxins which are present in one's system, and these

toxins affecting the different vitamins and minerals and different organs, so that an imbalance begins to occur which can throw off even more organs, or the circulatory system, or the skin, or the various sense organs. This Awareness indicates that the imbalance of a system then may begin to be felt by the entity as a kind of disease or "dis-ease" that gradually emerges or erupts here and then there, and then again elsewhere, as a kind of chain reaction.

This Awareness indicates that the liver as being perhaps the most important organ in keeping the body pure from toxins; but the liver as also being the most abused organ, in that entities often become obsessed with ingesting toxins for the thrill of their effect--the temporary gratification which certain toxins give entities, even though the long-term effect is harmful--this coming down on the liver, as its particular function and duty is in purifying the body's ingested substances.

This Awareness suggests that wherein one can be cautious about what is ingested, the liver is not forced into such intense enslavement and duress in its performance of its duties, and therefore is capable of doing what it is supposed to do without spilling out its responsibilities onto the other organs; and therefore the other organs can do what they are supposed to do without having to work in polluted and poisonous environments, or with toxic energies; and therefore the entire body works in a more healthy manner, and health is much more easily balanced and enjoyed by the body.

This Awareness indicates however, that the liver as being intended as a filter for toxins, and therefore it is assumed that it has a purpose and some toxins are allowable. This Awareness suggests that entities not become too fanatical about avoiding any food which might contain a harmful ingredient to the body, for the liver as capable of handling great amounts of toxin. This Awareness suggests however, that you not make a steady diet of poison, nor that you continue giving poison to your body, through these toxic foods or drinks, when obviously your liver is unable to keep up the intense pace which has been put upon it. This Awareness suggests that you be discerning and cautious and aware of your inner parts.

This Awareness suggests that often the mouth and appetite are on stage, screaming and shouting for more, and the entities fail to notice the internal organs--the stomach and liver, and the back-up crew which must keep the show on the road. This Awareness indicates that the performer, the appetite out front, ready and willing to take on all foods, all poisons, all toxins to show the world that he is not afraid of any of "that stuff"--this appetite, filled with egotism and show, fails to inform observers that he is really working the back-up crew to its very limits, and that they deserve all the credit, if credit is due.

This Awareness suggests: Let's give a big hand to the stomach, liver, kidneys, heart, and the other internal organs, who are so often forgotten in this struggle to consume.



"All together now, folks!
Let's here it for the good 'ol liver' "

(FOLLOW-UP QUESTION): Back to the eyes:

One last thing on the eyes: would adding to the diet of the zinc, chromium, B6, calcium and magnesium to those who have near-sightedness now correct it in time; and if so, how long a period?

COSMIC AWARENESS:

This Awareness indicates this as relative. That this can be very helpful. That any entity who has a low zinc and chromium balance cannot expect to have good vision. That the zinc and chromium cannot guarantee good vision, for there may be other factors involved.

This Awareness suggests that essentially, the vision relates to the fire element of the tridocia. This as enhanced by those foods which are alkaline-forming in their nature. This Awareness suggests that there are also cell salts of the biochemical homeopathic type which can be beneficial in helping entities with their vision. This Awareness suggests that all entities in seeking better health should have a small booklet on the biochemical cell salts, so that they may consult this booklet for various needs as they arise and know which cell salt to use. That this as being a system of healing easily available to all entities, without much expense and more effective than entities realize. This as not always the answer to the total needs, but is part of the solution.

FOLLOW-UP QUESTION (Liver):

Awareness, one final question about the liver. There are numerous liver flushes on the market. We have used one, for example, for a number of years of cold-processed olive oil (one spoonful of olive oil and two spoonfuls of lemon juice,—these tablespoons). Now the theory as we understand it, is that if you do overindulge in substances like alcohol and or marijuana which assault the liver, when the flush is taken the following morning, it rebuilds or prevents the liver from having a problem. Is this true?

COSMIC AWARENESS:

This Awareness indicates this as much likened unto a toilet. This Awareness suggests that wherein entities continue to fill the toilet without proper flushing, or whereby the natural flushing mechanism is overloaded, there shall become a problem with the plumbing. This Awareness suggests that wherein too much is put into the toilet, even though you may flush considerably, you may still have a problem with the plumbing. This Awareness indicates however, that flushing does help.

(HOW TO LIVE THE HEALTHY LIFE)

(Closing Message)

This Awareness indicates that essentially, a healthy life is one whereby entities understand the whole picture: the interconnection in relationships between parts of themselves; the interrelationship between themselves and others; and the interrelationship between their group and others, and society in general; and the interrelationship of society in general with the universal flow of life. That wherein entities understand these things, observe these things, and do not become fragmented, partitioned off, where they only look at one particular area for their substance, security, and meaning; then entities in observing this totality will find their lives expanding, even as the light can shine forth in all directions when not obscured by divisions which partition off the light.

QUESTION:

A question from M.S. Many people are concerned about reports that raw honey can cause botulism poisoning in infants. We first heard about this from the Sue Bee Honey producers association which, as you may know, cooks all their honey, and it occurred to me that this may be simply propaganda. Would Awareness please comment on this?

COSMIC AWARENESS:

This Awareness indicates there does not appear to be any substance to this statement. This Awareness indicates that botulism could be introduced to the raw honey through carelessness or through improperly cleansed containers. However, it does not appear to have any integral part of honey or its processing.

ED's Note: despite what Awareness indicated above, news stories persist in the media that infants (not adults) can die from eating raw honey, and warnings are going out to that effect from various government agencies. If this in fact is true, then the above information from Awareness could be part of the 15% error which Awareness indicated does occur thru the channel of Paul Shockley. (SOME STATIC FROM THE DISTAFF SIDE)



QUESTION:

A question from M.L., Richland, Washington, and it's in the form of a letter, which I shall read:

"I recently read a book by E. Cecil McGavin, whom you might say was stirring up a hornet's nest about Mormonism and Masonry. I realize he was trying to defend his belief system (which will always need defending, because it is so offensive). Nevertheless, I was flabbergasted to read, and I quote from him: "Almost every secret society in the world has a pledge of chastity which pledges its members to abstain from sexual intercourse with any good or true woman."

"I was once married to a man who became a Mason several years after our marriage. I can now imagine that this pledge my husband took must have had a tremendous impact on his sexual drive. He never seemed the same after that, and until now I could not understand why the change. Couldn't this kind of vow make a man practically impotent, depending on how seriously and literally he understands things? I ask: Is a good woman supposed to not want her husband to love her? This is ridiculous! No wonder the world is so, pardon the expression, screwed-up in the sex department.

"Powerful and influential men all over the world are sparing the wife but spoiling the whore. Can't men see why the pendulum seems to be swinging the other way? Just imagine what would happen to a society that advocated all women to pledge that they would never again have sexual intercourse with a good and true man, because after all, a good man wouldn't want such a thing! What further incentive would the husbands and fathers have to remain 'good and true' if their wives were only loving bachelors? I think this theory is helping to lead to decadence of the society, and I'd like to ask Awareness to comment on this, please."

COSMIC AWARENESS:

This Awareness indicates that your observations in regard to such a pledge as that which are valid. This Awareness indicates however, that this is not necessarily followed by all secret societies, nor by all members of the various secret societies. That even after such pledges are made, the majority of entities making such pledges find them impossible to keep, and therefore recognize the pledges as being something of a sham which instills a certain type of guilt and alienation between themselves and the secret society which demands this.

This Awareness indicates the intention of such a pledge extracted from an individual member by such a society would be to cause the entity to feel greater bondage to the society, while simultaneously feeling conflict within himself; so that these energies of loyalty are in competition with personal desires, and the entity then becomes of such division within himself that the loyalty to the society and other oaths involved cause the entity to feel a kind of disloyalty to his personal life, giving the society greater leverage over him than would his family have.

This Awareness indicates this as an action by some societies to gain mind-control over the individual, so that the personal life of the entity becomes less important to the entity than the life with the society. That this is not too unlike the more than one hundred rules or laws which Jehovah placed upon his people, the Hebrews, requiring them to adhere to over one-hundred laws, which essentially were impossible to adhere to, and therefore forcing them to err and sin in their covenant with him so that they would see themselves as guilty and unworthy and therefore, assuming that since they are incapable of adhering to these laws and that the higher being is apparently abiding by the laws which are placed upon the lower beings, therefore, the lower beings assume that the higher beings have evolved or are superior in some way to them in terms of social behavior.

This Awareness indicates that likewise, in certain secret societies, restrictions can be placed on the members to cause them to feel inferior to the superiors, even while the superiors break the rules of the society. This Awareness suggests also that in some societies, there are certain rules given for those on the lower levels or lower ranks, and as the candidate or initiate moves upward, the rules are changed accordingly, until the entity realizes on the higher-rank levels that the rules below are nothing but a sham to keep the public and the new members from knowing the full purpose and nature and truth about the activities of the secret society. Essentially, this is a common type of mind-control technique used in many secret societies to serve as screens to filter out investigators who seek to discover the nature of the society, but who do not wish to move through the long ordeal which may take many years to rise to those levels whereby they are involved in the innermost sanctuary of the society to discover its true nature.


This Awareness indicates that in some societies, the candidates are taught certain rules, certain teachings, certain principles, and as they move up the ladder of promotion, reaching a certain point, they are then told that "everything which you have learned heretofore is false and we now will tell you the truth." At this point, the entity is given notice that there is no turning back, and if the entity discloses the information to be revealed, death will surely follow,--not only to himself, but to his loved ones. This Awareness indicates this becomes a method whereby some societies manipulate and hold power over others and force them into certain types of activities and control their lives, in efforts to control others through these agents.

This Awareness indicates that *It* will not disclose the names of organizations, for this would endanger entities involved in releasing this material. This Awareness indicates that *It* will not disclose the names of such organizations now or in the future times through this channel. That this may be disclosed through other entities at other times in other ways than through this particular channel or this organization.

This Awareness indicates the time comes when secrets of all kinds shall be made public, and all entities shall know the truth in regards to the forces which have operated openly on the surface and their relationship to those forces which have operated deep behind the scenes, manipulating and moving these surface features and surface events through various secret societies. This Awareness indicates that *It* has previously given much information regarding certain secret societies. That essentially the pressure-point has been touched, and the energies from

these societies shall be released as a result of such touching. This Awareness indicates it is not necessary to touch all the tentacles or tributaries or nerves running from that pressure-point.

HOW TO PROTECT YOURSELF FROM FATAL ACCIDENTS

(HOW TO TELL WHEN DEATH IS IMMINENT)

QUESTION:

A question from K.K. in Illinois. "How can people protect themselves and others against accidents that would otherwise be fatal? Is there a way one can clear out the subconscious of any programming or false belief that would lead that person to an early death of some sort?"

COSMIC AWARENESS:

This Awareness indicates that first, the entity must be aware of the potential problem developing toward that end; that if the entity is aware of such a problem, the entity then may be able to take action. This Awareness suggests that often these difficulties can be seen in one's horoscope; that often entities begin to perceive the event beforehand,—through dreams, through images, or through flashes of insight into feelings or moods which indicate the potential event. That some entities telegraph their potential death before the event by speaking with others, discussing certain things in their deeper feeling levels, as if to wind up and tie up loose ends before the event occurs.*

This Awareness indicates that wherein you see an entity who has spent a good part of his or her lifetime holding a certain attitude in a fixed nature, or wherein the entity having a certain attitude suddenly changes and takes an entirely different attitude,—one wherein the entity becomes heavily determined and intensely hostile toward a particular person who has long violated their value system, or wherein the entity who has long held a kind of hostility appears to want to make amends or to confess that hostility or to become more honest about his or her feelings, and wherein you see this entity doing this kind of soul-cleansing with various aspects of his or her life with different relationships; this can often telegraph the potential death of the entity, where the subconscious is aware of what is coming and wishes to clear out its deep-seated roots of antagonism and imbalance.

This Awareness indicates that otherwise, a horoscope can reveal much about an entity's future wherein the entity is in danger, that also sensitive entities can perceive from another's aura and behavior when the other may be entering into difficult times. That likewise, the accident-type of energy is not actually difficult to perceive.

This Awareness indicates that generally entities who are heading for an accident which may or may not be fatal, such entities generally begin moving in that direction with a carefree attitude, playful, wherein they appear to have a kind of devilish disregard for convention, for good sense, for opinions of others, and for what would be termed reasonable, moderate, and responsible behavior.

This Awareness indicates that most accidents result from irresponsibility; that the irresponsibility as not always that of the victim, but usually involved somewhere in the accident. That occasionally, an irresponsible action of one results in victimizing of an innocent bystander or an innocent party. However, that in such cases there often is involved a different type of energy which involves the victim into the circumstance. This Awareness suggests this may be that wherein astrological influences or karmic influences or influences which are not the responsibility of the entity who had the accident, but the responsibility of some force which is acting against the entity.

This Awareness indicates for example, an entity may be the victim of an accident not of his or her own doing, and the force acting upon that entity may create a great difficulty in that entity's life, which may not necessarily be karmic, but may in fact be an action which is negative to the entity but which, in the long run, propels the entity into deeper and more serious look at life, or takes the entity out of a particular attitude and propels the entity into a new beginning or new attitude for the remainder of his or her life.

This Awareness indicates that often entities having a close brush with death caused by the irresponsibility of another, such entities sometimes change their entire attitude toward life and then become more capable of greater actions and progress than they would otherwise have been capable of achieving.

This Awareness indicates that when an entity *knows* that he or she is protected and safe from harm, then the entity is indeed protected and safe from harm; when the entity wonders whether he or she is safe from harm, then the entity may in fact be in somewhat of a state of danger. That there is a tendency for entities who have a strong faith in their ability to survive, to be more protected than for those who feel themselves to be vulnerable.

This Awareness indicates however, that there also can be that attitude wherein the entity feels perfectly safe and becomes foolhardy, and in that foolishness, either hurts themselves or another, because of the unfounded belief that they were invulnerable and safe from harm or that there was no way that they could be harmed, even in careless and irresponsible behavior,—this as likened unto the opposite of paranoia.

That paranoia can influence, but does not necessarily influence, the thing feared. That wherein an entity has a fear of some event occurring, this can energize the event. That wherein the entity takes steps to protect himself or herself against that occurrence and therefore

eliminates the fear by a practical action, this can assist in preventing the occurrence. That paranoia in itself does not necessarily draw in the problem which the entity fears, but can create a wavelength that assists in drawing this in. That occasionally paranoia is healthy, so that the entity protects himself or herself against that particular thing which is feared.

This Awareness indicates that the reverse-type of energy from paranoia is that wherein the entity is so confident that nothing can happen that the entity becomes foolish and irresponsible, and does not protect himself or herself by reasonable behavior, and therefore allows the event to occur through the ignorance of not taking proper action or precautions.

That essentially, when one has taken the precautions, when one is aware, looks at situations with an awesome awareness, so that it can be discerned clearly, and the precautions are continually dealt with so as to have the appropriate actions when a precaution is needed; then the entity can through practical applications feel confident, not because of the ignorance of facts or dangers, but because of the awareness of the precautions which have been taken to avoid the dangers. Therefore, essentially it comes down to an action of being aware of the dangers and taking the right action to avoid any potential conflict with such dangers.

This Awareness suggests that in terms of being able to know when one is headed for an accident, this Awareness suggests that understanding one's horoscope, having good psychic insight,—through telepathy or through Tarot readings, or through other forms, being sensitive to one's behavior,—recognizing when one is becoming foolhardy, overenthusiastic, and playful, or when one is being irresponsible: this Awareness indicates any of these actions can be warnings or give warnings to assist entities in avoiding such accidents.

This Awareness suggests that when entities find themselves becoming obsessed in a particular direction and others warn them to watch their step, but the warnings only tend to drive the entity even more so into the action; those kinds of energies often lead to disruptions and problems and painful lessons. This Awareness suggests when you find yourself becoming obsessed in having your own way, that is the time when you should check your horoscope with a good astrologer or other entity, or check the Tarot or other psychic advisors.

This Awareness suggests that you be cautious about the psychic advisors, for there are many who are simply frauds and will attempt to take your money to remove some imagined curse from you. This Awareness suggests that wherein you have a good psychic advisor or friend or a Tarot card reader whose accuracy has become dependable, or wherein you can find a good astrologer to check your chart, this can be very helpful during those times wherein you find yourself being compelled by forces outside of your control and good judgment, through emotional energies compelling you in a direction or through circumstantial energies compelling you in a direction. This Awareness suggests that when you find these energies forcing you in a particular direction and when you find this as discomfoting to you, wherein you are not at peace with yourself,—this as the time to seek outside advice from professionals, counselors, or from those who you can trust, particularly those who you can trust in terms of their good judgment.

This Awareness suggests also that these may likewise be times wherein you would benefit from stepping back from the role you are in, taking a brief vacation or going to another place, in order to break the bond or break

the identification which compels your consciousness in the direction, this giving you a more objective look at your situation. This likened unto stepping out of the plot you find yourself in, looking at the plot from a different perspective, then stepping back into the plot and directing your life with that new perspective.

THE ACCIDENT-PRONE ENTITY



(FOLLOW-UP QUESTION):

Awareness, in reference to accidents, there are some entities who you could almost say are 'accident-prone,' who seem to have a long succession of accidents, each one appearing to be a little more severe than the one prior. Is this merely coincidence, or related to their lifestyle, or is this actually a warning that they are receiving that they are heading for a self-destructive and possibly fatal accident?

COSMIC AWARENESS:

This Awareness indicates that often the entity who is accident-prone is accident-prone because of a particular type of attitude or behavioral pattern the entity exhibits. That this behavioral pattern generally tends to that which is related to leaping before one looks. That wherein an entity takes an action spontaneously before looking at the action in the entity's mind, seeing the various possibilities or results possible which would come from that action; this can be disturbing and result in accidents.

This Awareness suggests you look at this from the point of an analogy, whereby an entity is walking through life. Along the path of life, the entity comes across many obstacles, stumbling blocks, or situations which could result in fatalities or injury if the entity does not take certain precautions.

This Awareness indicates that one entity may walk along the path of life, stepping over or around the stumbling blocks; the situations or circumstances that would injure and harm the entity. The entity may carry a light of awareness, examining the places where the entity will step before stepping, and the entity may make it along the path of life a great distance without accident or problems. This Awareness suggests you visualize another entity who is brave, courageous, carefree and considers the path of life to be a playful experience and one whereby he wishes to 'really move.'

This Awareness indicates this entity seeking to move regardless of any potential threats or dangers, feeling himself to be quite capable of meeting the challenge. This entity, perhaps having been held back by others for much too long, now finding a spot wherein freedom is available, may decide to "step on the gas and really move," only to discover that there suddenly is a huge rock which catches the entity right in the kneecap and downs the entity in a pile of accident.

This Awareness indicates that this entity suddenly is aware and awakened to the fact that there are obstacles which are more than he can handle. The entity may at that point discover caution, or the entity may get up, dust himself off, put a cast on his knee and have his friends sign the cast, talk about the big accident he had, make a big thing of it, enjoying the excitement and attention, then turn around and speed down the road of life again, assuming that this time he will be more

cautious and therefore, being more cautious, can move even faster.

This Awareness indicates again the entity may have an accident,—this time perhaps tripping over an innocent child, downing the child, injuring the child for life. The entity feeling, "Too bad about that. I guess I'll have to be more cautious." This Awareness indicates that the entity then may move on through life again, perhaps being fined or penalized for the injury to the child, but feeling that the penalty has balanced everything out, and therefore the entity is now free to move his direction. This entity again may move on and again may become careless, and again may move too fast and run into a stumbling block.

This Awareness indicates some entities never learn, and some entities learn too late, and some entities learn after much hardship, and some entities learn from the wisdom of others. This Awareness suggests that it is simply a matter of whether an entity wishes to move down the road of life without having great accidents, accomplishing things along the way; or whether the entity considers speed and excitement as the real purpose of his being on the path.

This Awareness indicates this is not to say that entities cannot play, but this is to suggest that entities play safely, in the proper areas designed for that play, within the proper rules of behavior, so as not to lead to injury toward yourself or others. That the majority of injuries come about from that excitement to excel,—whether in games or in violent competition of social struggle, social climbing, travel, speed, or in games of political and military intrigue. There are areas wherein entities can seek to excel that do not create the kind of danger. This Awareness suggests this in terms of excellence in one's own performance of actions which are not competitive or threatening to others, wherein one develops one's skills to the uppermost degree. This Awareness suggests that this can be an outlet for excellence with a minimum amount of danger to oneself or to others.

WHAT ABOUT THE DAREDEVIL?

(FOLLOW-UP QUESTION):

Would that apply to an entity such as the daredevil, Evil Kneivel, who has broken every bone in his body at least once during his exhibitions, but yet none of his accidents were fatal and he continues to do this? He's not risking the lives of other entities, but certainly the life of himself.

COSMIC AWARENESS:

This Awareness indicates that this type of excelling as that wherein the entity risks his own life and therefore endangers himself. This Awareness indicates that the entity as obviously taking a risk, but the entity also being very cautious to recognize his capabilities and limitations as he develops the excellence of his art; therefore minimizing the risks as much as is possible, considering the type of dangers which the entity faces.

This Awareness indicates that *It* prefers to see entities excelling in more constructive types of activities than in showing off their physical skills by flirting with death or injury. This Awareness considers this type of activity as foolishness. This Awareness does not condone the wasting of lives through the daredevil types of activities which threaten one's life or the lives of others, nor does *It* condone wasting lives through violence, intrigues, or other forms of game-playing and competition, regardless of whether under the name of sports, or war, or politics, or religion, or philosophy.



WHAT IS KISSINGER UP TO IN HOLLYWOOD?

MORE ON THE THEATER

AS A CUTTING EDGE

QUESTION:

A question from T.H., Green Bay, Wis. "In reading 81-15, Awareness spoke of the connection between the Atlanta murders, violence in society, and violence in movies and television, wherein by exposing society to greater and greater violence, individuals and society at large gradually accept this as a part of everyday life. It has recently been reported that Kissinger has been elected to the board of directors of one of the major movie studios. Is this a further attempt to influence the type of movies that will be produced? I was also wondering if the frequent occurrence of disasters, such as the hotel fires in Las Vegas, the recent collapse of the walkway at the Hyatt Regency, are all part of the same plan, or maybe I'm just getting paranoid?"

COSMIC AWARENESS:

This Awareness indicates that it does not appear that these were deliberately planned by a conspiracy of individuals. That in reference to the Henry Kissinger action of moving into the theatrical areas, this Awareness indicates that this appears to be that which could be misused, and there *will* be attempts and efforts for utilizing the position of this entity in these areas. However, it is not seen as an effort to have great effects on producing more violence in films.

This Awareness indicates that rather, it appears to be associated in part with the entity's personal career needs and capabilities, and associates, having many friends in this area; the entity's interests and inclinations in this direction, and also is associated with a more broad scenario whereby this entity can be of some service in this area, having influence among individuals and in the general business relating to this. That this as likened unto planting one's friend or agent in an area which may be of useful value for future purposes.

This Awareness indicates that the theatre and artistic expressions are far ahead of political capabilities; that entities who wish to know what the concerns will be in reference to political and social concerns, need only to look at the artistic expressions such as novels and films, to discover what tomorrow's concerns will be. That artists tend to look at the cutting edges of social expression, at the areas other than that which is the traditional norm.

This Awareness indicates that it makes greater artistic expression to paint the images that are unusual than to paint that which is commonly seen. Therefore, entities involved in politics may seek to control artistic expression, particularly when a nation is moving toward totalitarian or dictatorial tendencies.

WHAT WOULD HAPPEN IF THE ARABS WITHDREW THEIR MONEY FROM OUR BANKS?

(FOLLOW-UP QUESTION):

Awareness, speaking of new things coming out of the motion picture business, we recently saw a movie called *Roll Over*, with Jane Fonda, and this story was concerned with a possible scenario. It concerned the big banking industry and the international banking community and the fact that the Arabs were quietly on the side withdrawing their money from the banks and putting it into gold, and this was discovered by this one person, and once this was discovered it created a stampede. Before the word got out evidently, these Arabs started a run on these banks by withdrawing their money, and at the end of the movie, it showed the banks collapsing, and the presidents of the banks committing suicide, and a very bleak-looking future for the United States and the rest of the world. I'd like to ask Awareness if this scenario outlined in that movie was some premonitory situation coming out into consciousness, or was it just good entertainment?

COSMIC AWARENESS:

This Awareness indicates that this was an attempt to educate the public in relation to economic procedures, manipulations and consequences and repercussions of events which can be altered and manipulated in such a manner as to have such far-reaching effects. This Awareness indicates that it was essentially intended to awaken the public's greater awareness to the economic machinery which manipulates the masses.

ED's Note: when I saw this movie, I got rather excited at this possible scenario wiping out the greedy bankers and felt that this was probably the way it was all going to be coming down. People are funny though, I asked an old acquaintance I spotted idling in a local restaurant, if he had seen the movie "Roll Over". He shrugged and a woman who was with him announced that they "never go to see dirty movies since they found Jesus." Knowing how any following conversation would be going, I walked away, saying: "Oh, I wouldn't exactly call it a 'dirty' movie, I'd call it more a movie about dog-training." (It's getting damned hard sharing anything with anyone these days).

Quakers decry U.S. 'war' in Central America

WASHINGTON (UPI) — The American Friends Service Committee, the pacifist Quaker relief organization, yesterday called for a halt to U.S. military involvement in Central America, saying the effort was "a war by any other name."

"The march toward even greater U.S. military involvement in Central America must be stopped," the Philadelphia-based organization's board of directors said.

Stephen G. Cary, who heads the board, said the AFSC believes "a just peace cannot be achieved in Central America without a fundamental change in U.S. policies and practices. Wider and deeper military involvement will not provide solu-

tions."

The AFSC board said U.S. policy changes should include respect for the "legitimacy of the indigenous struggle for social justice and political participation," but it stopped short of endorsing violent revolution. The board said the U.S. should not "try to determine how other people and nations shall live and be governed."

In addition to calling for a halt in the U.S. military buildup in the region, the Quaker group also called on the U.S. to support efforts to achieve a negotiated settlement, to provide economic aid for the poor and to allow Central American refugees fleeing political violence to remain in the U.S.

Rabbi Kahane's oath of allegiance

Brooklyn-born Rabbi Meir Kahane, in taking the oath of allegiance to the State of Israel as part of the process of being admitted to the Israeli parliament, stripped himself of any valid claim to continuing United States citizenship.

Although under the U.S. Immigration and Nationality Act loss of citizenship for serving as an officer of a foreign government is not automatic, it is classified as an "expatriating act," and Kahane should be declared a U.S. expatriate as soon as judicial processes allow.

Kahane, founder of the militant and at times violent Jewish Defense League in this country, is an apostle of hate who advocates the expulsion of all Arabs from Israel and the occupied West Bank and Gaza. He denounces the concept of Israeli democracy and has called the Israeli guarantee of "equal social and political rights to all citizens, regardless of religion" an absurdity.

The radical rabbi, who is leader of Israel's tiny right-wing Kach party, was quoted this week as saying he wants to retain his dual U.S. citizenship because it makes it convenient for him to return to this country to raise money for his party. Hardly a good reason to renew his U.S. passport.

It is not, however, Kahane's divisive and inflammatory views that disqualify him from continuing U.S. citizenship. It is his new oath of allegiance to Israel. That act has made him no longer America's problem, but solely that of Israel.

Residents organize to stop horse mutilation

SPANAWAY — Pierce County residents upset about a series of animal mutilations met last night to announce the first organized effort in 10 years to stop the grisly attacks.

During the last decade, 28 horses have been sexually mutilated in southern Pierce County.

Many of the animals have had their genitals removed with surgical precision, authorities have learned. Police and veterinarians have searched for signs of drugs in the victimized animals but have found nothing.

Two years ago, residents thought they'd seen the last attack. But just a month ago, a mare was sexually mutilated and died in Spanaway.

"We thought it was all over," said Verna Sparks of Spanaway last night. "But we were still concerned. They've (disappeared) before and now they're back."

Six area residents have organized a series of meetings on the problem. They've also established a hotline, which can be used to call for information about animal mutilations.

"We're all angry and we've decided to unite," Sparks said. "It's been going on for 10 years and we're tired of it."

Neighbors said they have few leads in the bizarre mutilations, but are convinced that many more horses have suffered the attacks than were reported to police.

Sparks said many residents are afraid that the mutilations may be connected to an occult ritual, and thus fear coming forward with information.

Last night's meeting focused on ways owners can protect their live stock, such as improving lighting in their fields and installing alarms along their fences.

Nuns convicted

HASSELT, Belgium — A criminal court has convicted two head nuns at a Roman Catholic hospital of forgery documents in an attempt to use hospital funds to build a new convent.

Jacqueline Vandormael and Maria Truyts were three-month jail sentences, with two months suspended, and fined 6,000 francs — the equivalent of \$97 — after the prosecutor asked for light sentences.

Hunthausen wins a human rights award

The Most Rev. Raymond Hunthausen, Catholic archbishop of Seattle, has been named one of 14 award winners for 1984 by the Vienna-based Bruno Kreisky Foundation for Service of Human Rights.

The award, which carries a \$5,000 cash prize, will be received on

the archbishop's behalf in Vienna on Nov. 23 by the Rev. Michael Ryan, vicar general of the Archdiocese of Seattle.

The foundation, named for the former chancellor of Austria, hailed Hunthausen for advocating unilateral U.S. disarmament "in order to break

down the contemporary rationale for the nuclear arms race."

Other 1984 award winners included the founder of the Brazilian Workers' Party, the Union of Concerned Scientists and the Austrian Committee for Aid to Nicaragua.

Secret military funding up sharply in last 3 years

WASHINGTON — Hidden in the Pentagon's \$305 billion budget request for fiscal 1985 is an estimated \$18 billion or more for programs that are kept secret from the public, and in some instances from Congress.

The number of secret budget items, and how much they cost, has risen sharply since the Reagan administration took office three years ago, defense analysts say.

In some cases these so-called "black budget" items involve highly classified programs like research on the so-called "stealth" aircraft, a plane that would be invisible to radar.

Others involve intelligence-gathering activities by the CIA and the National Security Agency, as well as covert operations performed by the CIA or the Pentagon itself, according to administration officials.

Some of these are sensitive operations — such as the construction of airfields in Central America to support anti-Nicaraguan guerrilla forces — which the administration is loathe to disclose for fear of domestic political repercussions. The Central American airfield program, officials say, is hidden as an unidentified item in the Army's training budget.

The "black budget" programs pose

a serious problem for Congress — which is supposed to oversee defense spending — and, ultimately, for the public, which pays the bills. The problem is to balance the protection of legitimate national security secrecy with Congress' constitutional obligation to oversee the budget.

Few of the classified items are identified as such. In the \$103 billion military construction budget, for example, only \$116.7 million is marked classified. Elsewhere in the budget, secret programs are only hinted at.

Defense budget documents published Wednesday, for example, mention new security programs involving

Soviets deliver U.S. wheat to famine victims

KEMBOLCHA, Ethiopia (AP) — The 100-pound sacks of wheat being loaded from a truck onto a Soviet Mi-8 helicopter bore the stamp: "Furnished by the People of the United States of America."

Americans and Soviets, in one of their major emergency-response efforts since World War II, are putting their countries' differences aside to work together on the airlift taking food and supplies to millions of starving Ethiopian famine victims.

U.S. gives go-ahead to slaughter of 22,000 seals

WASHINGTON (UPI) — The government cleared the way yesterday for the slaughter of 22,000 seals in Alaska beginning early next month — a decision blasted by opponents as "inhumane, ethically repugnant and economically irresponsible."

The authorization, announced in a written statement, was made by Commerce Secretary Malcolm Baldrige.

It reduces the number of killings by 14.6 percent from those authorized last year.

But the clubbings of young male seals for pelts was immediately blasted as senseless by a leading animal protection group.

"The decision to proceed with the fur seal harvest is inhumane, ethically repugnant and economically irresponsible," said John Grandy, vice president of the Humane Society of the United States.

"The taxpayers are financing a slaughter which will benefit no one," he said.

"Termination of the harvest would have serious economic, social and cultural effects on the St. Paul (Alaska) Islanders who are just beginning to develop a new economy," a department statement said.

The government will pay native Aleut Indians \$500,000 to kill the seals.

But the Humane Society said the Indians already have 32,000 pelts they cannot sell.

Bachelorhood ends

STOCKHOLM, Sweden (AP) — One year into his second century, Artur Jonsson is about to try something new — marriage.

Jonsson spend his first 101 years single — mostly farming and dealing in horses near the town of Askersund, about 110 miles southwest of Stockholm. However, he began to feel his age earlier this year and advertised for a housekeeper, the newspaper Aftonbladet said today.

He found 55-year-old Ingrid Engdal, who moved in this spring to take care of Jonsson and became his fiance this week, the newspaper said.

Colorado students reject stockpiling

BOULDER, Colo. (AP) — University of Colorado students have voted against a proposal to stockpile cyanide capsules on the school's Boulder campus, to facilitate a mass suicide in the event of nuclear war.

Nerve gas weapons approved by Senate

WASHINGTON (AP) — The Senate yesterday approved 47-46 the production of nerve gas weapons, with Vice President George Bush casting the deciding vote on a key defense issue for the second time in four months.

The Senate then went on to pass, 86-4, a record \$253 billion defense spending bill that includes the nerve gas program.

The spending bill includes every major weapons program requested by President Reagan, including nerve gas, the MX nuclear missile and long-range B-1 bombers.

Earlier the House had rejected the \$124 million nerve gas program. Differences in the two defense spending bills will be resolved in a House-Senate conference.

5 banks may share electronic banking

The state's five largest banks have signed an agreement jointly to develop a shared electronic banking network.

Under the agreement, which has been under discussion for nearly a year, the banks will develop an electronic clearinghouse that shifts funds from a customer's account directly to a retailer's account at the time a purchase is made.

The five founding banks forming the Northwest Electronic Network are Seafirst, Rainier, First Interstate, Peoples, and Old National Bank. Other financial institutions will be invited to join the network.

Within five years, the network will process up to 50 million electronic transactions annually, said Robert Henderson, chairman of the Northwest Electronic Network Executive Committee.

Scientist who insists blacks are inferior wins libel suit — and \$1

ATLANTA (UPI) — A federal court jury found yesterday that William Shockley was libeled by an article in The Atlanta Constitution dealing with his genetic views on blacks, but awarded the Nobel laureate only \$1 in damages.

The 74-year-old physicist filed a \$1.25 million suit against Cox Enterprises, which publishes The Atlanta Journal and Constitution, and former Constitution reporter Roger Witherspoon.

The suit claimed Shockley was libeled in a 1966 article by Witherspoon that dealt with Shockley's view that blacks as a group are genetically inferior to whites.

The jury, consisting of three women — one black — and three men, returned the verdict shortly before 6 p.m., about four hours after it began deliberations.

Shockley said the outcome of the trial "failed to serve one of my purposes, which is to reduce the likelihood that such libelous statements will be so freely made in other cases."

Catholic bishops say U.S. poverty is a scandal

WASHINGTON (UPI) — Roman Catholic bishops, in a draft statement on the U.S. economy, said yesterday that the needs of poor people must be "of the highest priority" and called current poverty levels a "social and moral scandal."

The long-awaited draft of the National Conference of Catholic Bishops' pastoral letter on "Catholic Social Teaching and the U.S. Economy" said every decision regarding the economy must be judged primarily by the effect it will have on human beings.

President Reagan's but said, "We haven't tried to analyze them."

He said the commission "does not want to make out document partisan" and "the church doesn't think in terms of four years." He noted, however, the bishops were "biting" the notion that "you have to have high unemployment to bring out inflation."

Goodwill goes broke

PHILADELPHIA (AP) — Goodwill of Philadelphia, after 65 years of business, has shut its doors near the start of the traditionally busy Christmas season.

The charity was struggling under \$1 million debt and gathering insufficient revenue from its sales of used goods, said board of directors chairwoman Sandra Williams.

The closing of Goodwill's main office and four branch stores Monday put 100 employees out of work, as well as 125 "clients" — handicapped people who perform routine tasks, she said.

Did Tom copy Ben?

WASHINGTON — Ridicule and indifference from scholars has done little to shake the belief of Maurice and Mollie Freedman that Benjamin Franklin, not Thomas Jefferson, wrote the Declaration of Independence.

The heart of their case is a draft of the declaration dated three weeks before it was adopted July 4, 1776. Historians say the earlier date is a misprint, but the Freedmans contend that Franklin left the Continental Congress, went to his brother's home in Newport, Rhode Island and published the draft under a pseudonym — Solomon Southwick.

"Franklin was the mastermind. Jefferson was the copier," Mrs. Freedman said.

Convicts robbed

POMPANO BEACH, Fla. — Inmates at a minimum security prison are "still in shock" after a gunman robbed a convicted armed robber and his roommate of nearly everything in their dormitory cell, officials said.

The gunman walked into the inmates' room and announced: "This is a robbery. We're taking all your stuff." Fort Lauderdale police said.

Sermon spurs suit

BEAUMONT, Texas — A teenager who says a state trooper preached to him for two hours, forced him to make a list of his sins and then promise to dedicate his life to God has sued the officer for \$750,000.

Darryl Ray Craig says in his suit he was forced to sign a statement asking God to take charge of his life. He said trooper Douglas Fetters co-signed the document with the name "Jesus."

Spouses shoot back

BENTON, La. — Pearly Mae Grigsby and her husband Jimmy came out shooting when their cars collided on a rural northwestern Louisiana road, the Bossier Parish Sheriff's Office said.

"I guess they were pretty upset about having the wreck," sheriff's Lt. Richard Carroll said of the incident Monday.

Mrs. Grigsby was shot in the abdomen and shoulder. Her husband's eyes were hit by flying glass during the 6:45 a.m. shootout, Carroll said.

Meese: Let illegal evidence be used

SALT LAKE CITY (UPI) — Attorney General-designate Edwin Meese told a group of police chiefs yesterday that he wants the Supreme Court to eliminate a rule that bars prosecutors from using evidence illegally seized by police.

Meese told to the International Association of Chiefs of Police the exclusionary rule was the "bane of effective law enforcement" and hoped it could be ended.

"My fervent hope is someday to do away with the exclusionary rule altogether," said Meese.

Hooded witness says Ky is crime boss

NEW YORK (AP) — Former Vietnamese Prime Minister Nguyen Cao Ky, described to the President's Commission on Organized Crime as head of a crime network, called the charge ridiculous and said, "I'm not involved in anything."

Ky said Thursday he had not been subpoenaed, but "if the commission wants me, I am ready."

A hooded witness who identified himself as an "assistant boss" in one of the gangs comprising the extortion, robbery and marijuana-smuggling network testified Thursday that among Vietnamese, "everyone knows" Ky heads it.

He said the ostensibly anti-

communist organization committed crimes to raise money for "the jungle war in Vietnam." Below Ky, he said, are four or five former South Vietnamese generals who supervise 15 "state bosses" and a nationwide membership of about 1,000, organized in cells of 30 to 40 members.

"Go to the police, sheriffs or FBI, they can tell you I'm not involved in anything," Ky told The Associated Press in a telephone interview from southern California. "My first reaction is shock. It is ridiculous."

Asked why the witness might have lied, Ky said: "I don't know. I frankly don't know. You know, in my position, there are people who don't like me."

The witness, testifying in the third day of commission hearings into the rise of Asian-American organized crime groups, said the organization is made up of four major gangs: the Black Eagles in San Francisco, Fishermen in Houston, Eagles Seven in Chicago and Frogmen in Los Angeles and Orange County, Calif.

The commission staff said Vietnamese criminal extortion groups were active in California, Texas, Washington, Colorado, Alabama, Florida, Massachusetts, New York, Pennsylvania, Oregon, Louisiana, Virginia and Hawaii.

Law enforcement authorities who also testified Thursday seemed neither surprised nor

persuaded by the testimony regarding Ky.

"I have several disagreements with that witness," said police Officer Robert Casey of Houston. "For one, I've never heard of Fishermen gang."

"I had heard stories" about Ky, said New Orleans police Sgt. John Willoughby. "We have no indication there is a boss of bosses over these groups."

Commission spokesman Arthur Brill said anyone named at a commission hearing has the right to file a statement with the panel or testify before it.

"Ten years I have been here," Ky said. "Law enforcement never contact me for anything concerning crime."

Chicagoans go hungry, study warns

CHICAGO (AP) — Hunger is rampant in Chicago and has become a "shocking, frightening and inhumane" problem in almost all sections of the city, says the Mayor's Task Force on Hunger.

In a report to be released this week, the group says that over the course of a year, more than one in four residents may be affected by the "epidemic of hunger." The problem isn't a shortage of food, but inadequate food programs that have failed to reach some Chicagoans, especially the very young and old, the report indicates.

A separate study by a group of physicians who surveyed Illinois and Missouri found that hunger is on the increase in the two states.

The Physicians Task Force on Hunger in America said stealing of food is common in St. Louis, Mo., and that some hungry people raid garbage bins.

"Women come in with blisters around their mouths, having lived on oatmeal for weeks," nurses at one clinic told the task force.

The physicians' final report, based on surveys in 15 states, will be released in February.

The task force, consisting of 25 health and hunger experts from the city and private sector, will urge Washington to adopt a 14-point plan to fight hunger.

James Boynton, Boeing director of information, confirmed on Thursday that Haig, 59, had been hired within the past six months as a sales consultant.

"He will assist in the selling of commercial airplanes," Boynton said.

A public apology for KAL spy story

LONDON (UPI) — Korean Airlines accepted a public apology and a "substantial" sum of money yesterday from a magazine that suggested the KAL Boeing 747 shot down by Soviets last year was on a spy mission.

Lawyers for KAL said the article in Defense Attache, a bi-monthly British magazine devoted to defense matters, could not be "further from the truth."
