

## ALL ABOUT SPIRITUALISM...SPIRITS...GUIDES, ETC., AND COMMUNICATING WITH SAME

### QUESTION:

A question from P.S., in Michigan. "There's a topic I would like to see Paul Shockley discuss. It concerns spiritualism and spirit guides. This is a subject that is not frequently discussed when reading books on psychic phenomena. Edgar Cayce only mentioned not to rely on the "dead", for many who have passed on know less than we do. Ruth Montgomery often refers to Fletcher, Arthur Ford's guide, and in her writing does in general talk about spirit guides. Harold Sherman, in many of his books, does mention the spirits that are near us, trying to guide, inspire and uplift us.

In a book called *Communication With the Spirit World of God*, by Johannes Greber, it discusses at length both the good spirits and bad spirits. This book is almost an underground book. It is only published through the Johannes Greber Memorial Foundation in New Jersey, and was originally published in 1932. When a medium is in a trance state, there are various spirits or guides that speak through them. I imagine this is also the case with Paul Shockley.

Why is the spirit world not discussed more often than it is? How do spirit guides pick the people they work with? Is it because of a certain need, or the fact that they have had a former incarnation where they knew this person? There are so many questions that could be asked about spirit guides and spiritualism. My brother, who has belonged to CAC for quite some time, and I, were discussing this subject lately, and were wondering why we haven't seen much in the newsletter about it.

I am sure there are many CAC members who would be greatly enlightened to know more about the above mentioned subject. If this subject could be presented to Paul Shockley, it would answer questions that I am sure many people have on the subject. Thank you. P.S."

### COSMIC AWARENESS:

This Awareness indicates that there were a number of questions within this letter. This Awareness indicates that in reference to the communication with spirits, this Awareness indicates that there are indeed many who are capable of communicating with spirits. This Awareness indicates that too often these are not the essence or the actual soul of the entity, so much as being an astral shell, the emotions of the entity. This Awareness indicates that entities pass over and even as entities on this physical plane have different levels to their being: the physical, the emotional, the mental and causal bodies; likewise, in the afterlife there is the astral shell, the mental body and the causal body.

This Awareness indicates that many times an entity will assume that he or she is speaking to a departed spirit or loved one, and in actuality, the entity is only in contact with the astral shell. This Awareness indicates the problem with the astral shell is that it is even more incapable of learning than it was when it was in the physical form. This Awareness indicates that the astral shell being the collection of emotions and attachments that were formed in the body of the entity while on earth in the flesh.

This Awareness indicates therefore, to seek advice from an astral shell who calls himself by the name of someone you dearly loved, is to seek advice from a portion of the entity which is no longer capable of learning much, or assimilating the information gained from the passing over experience, and which is reactive more toward levels of emotions than toward the higher levels.

This Awareness indicates that the essence of the being, the loved one, having dropped off the astral shell and moved on as mental and causal bodies into the etheric levels, may not even be responding to you when questions are asked, in the sense of spirit communication. You may simply have at your disposal the astral shell which you relate to. This Awareness indicates that obviously, this can give you some information that is erroneous or is applicable to a limited frame of reference.

This Awareness indicates it is for this reason that this Awareness does not advocate that entities put too much credence in spirit communication, for most communication is with the astral shells. This Awareness indicates however, there are times when higher aspects of an entity can enter into the consciousness of one in the flesh and give a message of value from a higher plane. This Awareness indicates that these however, do not generally come through spirit mediums. That these communications will generally come about when the entities on the Inner Planes, or in the causal or mental planes seek to communicate with you. This Awareness indicates that they are not simply there to be "called up" because a medium has sat down and is at your disposal.

### Cosmic Awareness Not a Spirit

This Awareness indicates that the types you will get at that time are the astral shells which have been discarded by the entity. This Awareness indicates that in terms of the Interpreter, that this Awareness knows of only one incident in which a spirit was allowed to speak through this Interpreter, and that being when the entity was telling a story to his daughter some years ago. This Awareness indicates that the channel of this Interpreter does not allow for spirits to speak through. This Awareness indicates that this Awareness is not what may be termed a 'departed spirit.'

This Awareness indicates that *It* is the energy which is next to that which does not speak. *It* is the energy that permeates the universe and which, when touched upon, can yield understanding that can be described.

This Awareness indicates that *It* is not a person in the sense which entities would define a person to be. Rather, *It* is an energy that is personal to all things.

This Awareness suggests that other aspects of this question may be re-asked.

## WHAT ARE SPIRIT GUIDES ?

### (FOLLOW-UP QUESTION):

Would Awareness discuss the concept of 'spirit guides'?

### COSMIC AWARENESS:

This Awareness indicates that these beings are likened unto energies from the higher dimensions operating generally above the astral plane, this in reference to the higher spiritual guides. This Awareness indicates there are of course those entities who allow themselves to be guided by lower astral energy types and demonic types from the astral planes. This Awareness indicates however, that this in reference to the higher guides above the astral levels. That these are often entities who have at one time or another been associated with the entity, who have a loving concern or care about the welfare of the entity, through previous attachment or identification, such as having been friends or a relative to the entity. This Awareness indicates that this may be from previous lifetimes or from life on Inner Planes.

#### How to Tune Into Your Spirit Guides

This Awareness indicates that these guides or entities, not being in the flesh, assist in guiding the entity, not with words, but with attitudes. This Awareness indicates that the spirit guides do not use words or concepts or physical influence to move an entity into an action, but use as the main tool of guidance, an attitude. This Awareness indicates that to tune in to your spirit guides, all that is necessary is to become aware of the attitudes which you have,—the attitudes which you hold.

This Awareness indicates that if you hold attitudes which are hostile and negative in nature you will realize that your guides are hostile and negative, and you may wish to replace these guides with those which are of higher quality and more beneficial to you. This Awareness indicates that if you tune in to your attitudes and discover that there is an attitude which expresses a sense of humor, you may then realize that one of your guides has a sense of humor and the attitude is being expressed to you and through you.

This Awareness indicates that if you wish to develop this relationship more strongly, then all that is necessary is that you focus more on that attitude which emanates the sense of humor, and you will have a closer relationship to that guide. This Awareness indicates that one of your guides may emanate a sense of courage or a sense of duty. This Awareness indicates that the guide may emanate a sense of adventure and lead you into an attitude wherein you seek adventure. You move from place to place looking for thrills.

This Awareness indicates that these attitudes are emanated from your guides and the relationship that you have with a guide may be enhanced by focusing on the attitude and energizing that attitude. This Awareness indicates that entities essentially select their guides by free will, according to the attitudes they hold and allow within their psyche. This Awareness indicates there is always that struggle and effort from the astral plane for those lower energies to make contact within your psyche, to emanate attitudes of hostility, anger or deception or lust, or the pursuit of power.

#### How to Keep the Dark Forces Out of Your Consciousness

This Awareness indicates that these energies from the astral planes as those which are associated with the Ahriman Forces, and wherein you allow yourself to be guided by these forces, you will surely find it to be an accelerating action whereby the forces take greater and greater command over you. This Awareness indicates that all that is necessary to throw off this yoke of the Dark Forces is to simply say that you will not allow these forces in your life, and each

time an attitude is felt in your consciousness, you close the door to that negative attitude from the Dark Force level, and you keep the doors open to allow those Light attitudes to come in.

This Awareness indicates that wherein one's attitude is that of resentment, hostility or anger, or feelings of being abused; these attitudes encourage the Dark Forces to enter. This Awareness indicates that wherein your attitudes are that wherein you look for the best in the future, wherein you are hopeful, wherein you are encouraged, wherein you feel yourself to have strength, wherein you feel faith in the good...this Awareness indicates that these attitudes open the door to the Higher Guides to allow them to have greater say in your life.

This Awareness indicates that it is because of this opening of the doors, or closing of the doors, in relation to the attitudes, that prayer can be so effective in overcoming the Dark Forces. This Awareness indicates that wherein an entity is overpowered by Dark Forces and sincerely begins praying or pleading, and focusing on the Higher Forces of Light, the Christ Light, the very act of such focusing opens the door to hope and to the higher qualities and vibrations which allows this Light to enter in and to flood and overpower the Dark Forces of greed, lust, fear, anger, resentment and hostilities.

This Awareness indicates that essentially, these guides are there in part because you have a need for them, and their activity is to emanate an attitude toward you. From the viewpoint of a guide looking toward you, the guide looks at you, perhaps with love, and you feel from the guide an attitude of love. The guide, perhaps a different guide, looks at you with an attitude of courage, seeing you as proud and courageous, and you feel the attitude of pride and courage.

This Awareness indicates it is possible for these attitudes to become mixed and confused, whereby an attitude from the astral level becomes mixed with the attitude of pride and courage so that rather than simply pride and courage you feel vanity and power. This Awareness indicates that in such cases you have two guides: one from the astral levels and one from a higher mental plane, whereby you are influenced by these forces and the influence leads to a conflict within, whereby something needs to be resolved within you before you can come to a state of inner rest or inner peace.

#### Guides Also Have a Life of their Own

This Awareness indicates that pride and courage in a normal sense should not create inner conflict, but vanity and the pursuit of power does indeed create inner conflict. This Awareness indicates that often a guide, having been an ancestor, or a remote or distant relative or friend from another lifetime, the guide is living his or her own life in another plane but has formed an attachment through the Aka-cord in such a manner as to allow the energies of his or her emanations to reach to you.



This Awareness indicates that it is vain for entities to think that all guides do is stand around being a servant to those on earth. This Awareness indicates that they are not likened unto drivers of vehicles, driving the earth party or the body on earth from place to place. They have their own lives to live also, but as they proceed about their business in their plane, there is the psychic connection which they have attached to you, which you have attached to them consciously or subconsciously, from present or previous lifetime attachments, so that they, in their activities, convey an energy that is uplifting to you, or which influences you according to the vibrations which they experience and which you allow in your life.

This Awareness indicates that it is likened unto the concept of the master who lifts the disciple, who in turn lifts others as he or she becomes a master. This Awareness indicates that this is essentially a kind of hierarchy-type system, but it is also to be recognized that the master is living his or her own life with his or her own struggles, and it is only the attitude of this entity which, filtering into your psyche allows you to be attached to this vibration and to be guided by this emanation. This Awareness indicates the guides are guides because their attitudes vibrate and enhance the attitudes which you accept in your life.



### THE FUNCTION OF INDIANS AS GUIDES DURING SEANCES

#### (FOLLOW-UP QUESTION):

Awareness, in the literature of the spiritualist movement, there is many references that Indians, American Indians in particular, are often or usually guides at these seances. That these entities dwell on a certain plane of the astral or beyond, and that they make good protection for these seances in that they drive low spirits away and keep low forces from coming through. Is there any truth to that?

#### COSMIC AWARENESS:

This Awareness indicates that this as absolutely so. This Awareness indicates that the American Indians as those who after long centuries of spiritual recognition of the various planes, these entities moving into these planes, recognizing the chaos in the physical plane, have dedicated themselves to be as servants or guides to many on the physical plane. This Awareness indicates that this as likened unto the same concept as the Wanderers, those who enter from other planets or planes, upon the physical earth in order to raise the vibrations.

This Awareness indicates that the Indians have similarly, many of these Indians have made a kind of pact or dedication that they would reside on an Inner Plane long enough and serve as guides long enough to help raise the vibrations by assisting individuals who are in the flesh to rise to their full potential. This Awareness indicates that this is not exclusive to the American Indians. This Awareness indicates that there are also guides who are Egyptian, from ancient Egypt, and are also many from other civilizations such as the Orient, India, the Middle East and also some European guides as exemplified by some of the White Brotherhood masters and teachers.

This Awareness indicates that there are also guides from each and every culture. As these entities grow and mature spiritually, the guides reaching levels wherein they see themselves as being capable of assisting or helping to raise the vibrations of others. This Awareness indicates that this is the same as in relation to the hierarchy system of the Inner Planes, is the same as is experienced in any culture or civilization. That those who are the more highly skilled or talented or evolved in certain things will rise accordingly.

This Awareness indicates that those highly evolved spiritually rise accordingly. This Awareness indicates that the hierarchy system wherein entities in the Inner Planes are given positions of greater and greater responsibility according to their ability to respond, this is but another reflection or dimension of the responsibilities which entities accept in the physical or third-dimensional world. This Awareness indicates that the statement: "As above, so below," relates also to the dimensional changes; that as there are hierarchy systems in the physical third-dimensional world, there are also hierarchy systems when it comes to the Inner Plane networks.

#### Reliance on Guides Not Necessary

This Awareness indicates that it is not necessary however, for entities to become reliant on guides, for when entities rely on a guide, it simply means that the entity has locked on to a particular attitude and this Awareness wishes entities to recognize that while these attitudes may be of great significance and value, for particular experiences and for certain circumstances, and the guides may be helpful in dealing with these circumstances, this Awareness wishes entities to recognize that the greater attitudes are those which have been expressed through the Cosmic Laws, and that you not let yourself be stifled by attitudes of guides when there are higher attitudes that lie beyond those available through your guides.



#### Hierarchy System No Longer Valid

The Higher Attitudes being those which are exemplified by the Cosmic Laws. This Awareness indicates that it is for this reason that this Awareness once indicated that the hierarchy system as that which was no longer valid in the sense of presenting the highest and best for entities. This Awareness indicates the Highest and Best for entities is to look beyond the hierarchy system to the Cosmic Laws, and to understand the Cosmic Laws and to apply the Cosmic Laws, for these will create the highest guides and highest attitudes available, and your life then will be more wholesome in all ways.

#### HOW SPIRITUAL HEALING WORKS

##### ( HOW JESUS WAS ABLE TO HEAL )

#### (FOLLOW-UP QUESTION):

Awareness, there was a spiritual healer in England called Harry Edwards, who for many years made a name for himself healing entities, and he always acknowledged that this was done through his guides. The CAC Absent Healer who formerly did this type of work, acknowledged that it was through guides that she was able to do this. I'd like to ask: is this another example more or less of a placebo at work, being that entities (if they understand who they are and so forth), are capable of healing others anyway?

#### COSMIC AWARENESS:

This Awareness indicates that this has two answers, in the sense that both are effective. This Awareness indicates that this may be seen as a placebo in the sense that if an entity has developed fully, he or she would have the ability to bring about this type of healing. This Awareness indicates however, that if the entity has not developed fully, it is possible that even before the entity is capable himself or herself, of such healing, that the entity would be capable of allowing guides to heal through the entity.


This Awareness indicates that wherein one does not have the self-confidence or the recognition or realization of one's own divinity, but wherein one feels that there are Divine Forces which can work through the entity, then this Divine Force acting through the entity can bring about the healing and the entity gives forth the credit to the Divine Force. This Awareness indicates that wherein the entity recognizes the divinity within himself, or wherein the entity becomes one with the Divine, the entity then has the capacity or capability of giving forth such healing and would express the action as being an action of his or her own, but in such expression the speech would be delivered from the consciousness of the Divine, rather than from the separate ego self.

This Awareness indicates that when Jesus spoke and healed, it was the Christ Consciousness that was speaking through the man. This Awareness indicates that likewise, wherein an entity attuned to the Divine, heals another and takes credit for it, it is the Divine speaking through the entity that is so healing and so taking credit. This Awareness indicates that wherein the entity separates himself or herself from the Divine and then begins to speak of having healed another, this is in error, and it is the ego-self claiming to have healed when in fact it was the Divine Self working through the ego-self that did the healing.

This Awareness indicates that wherein an entity reflects on his or her accomplishments, such as speaking of what he or she can do, or has done in the past, such as the entity who says: "I healed this person, and I healed that person, and then I healed this person who had this terrible disease"....this Awareness indicates that such a discussion is a discussion that comes from the ego of the individual and not from the Divine. This Awareness indicates that wherein a Divine Force is acting, It may for some reason speak and say to an entity: "I heal you. You are healed," or It may say: "I am the Way, the Truth and the Light."

This Awareness indicates that this speech or statement from the Divine may be genuine as a Divine expression, but wherein the entity separating from the Divine begins to tell others: "And then I healed him, and then I told him I was the Way, the Truth and the Light, and then they began to follow me"....or wherein entities begin speaking in this manner in terms of past accomplishments, this is a separation of the ego from the Divine Superconscious. This Awareness indicates that this is where the error is seen.

This Awareness indicates that likewise, wherein an entity projects upon the healer and says: "Then George healed him, and George told everyone that he was the Way, the Truth and the Light"....This Awareness indicates that when this occurs, entities have confused the issue, and confused George with the Christ Light which was actually speaking through George in stating that he was the Way, Truth and the Light. This Awareness indicates that therefore, entities should be most cautious in personalizing that which is in actuality the Divine Energies.



#### Interpreter Paul Shockley is Not Cosmic Awareness

This Awareness indicates that this Interpreter is not this Awareness. This Awareness is speaking through the Interpreter. This Awareness is not the Interpreter, nor is the Interpreter this Awareness, although when in trance, the Interpreter's consciousness merges with this Awareness, and this Awareness allows information and expression to be emanated through the Interpreter's vocal chords; through the Interpreter's consciousness. This Awareness indicates that entities must be cautious not to confuse the messenger with the message, or the individual with the Divine.

This Awareness indicates that likewise, in terms of spirits, the spirits which speak through entities may be speaking from Divine levels; the spirits may be channeling forces which are higher than themselves and delivering messages which come from higher planes than they themselves are on. This Awareness indicates that there are such things as spirit mediums in the sense of interpreters who are on the spirit plane, or on an Inner Plane out of the body. This Awareness indicates that these messengers may serve as messengers to other messengers or may serve as interpreters to other interpreters.

This Awareness indicates that much of the so-called Great White Brotherhood and the hierarchy system associated with that is made up of these Inner Plane mediums or Inner Plane Interpreters. This Awareness indicates that this is a way whereby messages may be passed from plane to plane through entities who are mediums between dimensions or planes. This Awareness indicates that It does not recognize for *Itself* dimensions or planes, and therefore is not blocked by the walls or forces or boundaries of planes, and therefore is able to address all planes simultaneously, to address all dimensions simultaneously. It is for this reason that these messages which are given through this Interpreter on your plane are also heard by entities in other dimensions in other

( HOW TO ATTRACT HAPPINESS TO YOUR LIFE )

(Closing Message)

(FOLLOW-UP QUESTION):

This Awareness indicates that there are a multitude of vibrations and energies coming at each individual every moment. It is impossible for entities to escape these many vibrations and energies, and these vibrations and energies may carry any type of message or attitude. This Awareness indicates that it is likened unto being a receiver, a radio which is capable of receiving from the thousands or millions of stations which surround the radio. This Awareness indicates that each of you is a radio, and around you are transmitters sending out attitudes and signals aimed in your direction or in the direction of any anything that is willing to receive.

This Awareness indicates that each of these transmitters is also a receiving station and wherein you send forth your message or attitude, they also have the option of tuning in, or turning off to your signal. This Awareness indicates that each of you being capable of receiving a channel, receiving an attitude or frequency, may turn your dial to any attitude of your choice and select and stay on that station, dwelling on that attitude to the point of obsession, or may switch from attitude to attitude, or may select an attitude which you use for a period of time for some accomplishment, and then may switch to another.

This Awareness indicates that those who allow themselves to tune in to the base attitudes of greed, lust, power and the lower vibrations, will find themselves attuned more and more to those energies which

bring about sorrow and suffering, enslavement and entrapment. This Awareness indicates that those who attune their channels to the Higher Frequencies of Love, Light, Happiness and Joy, spreading and giving Joy to one another, these entities will find that their lives are being filled with the same energies which the attitudes emanate.

This Awareness indicates that like attracts like in the higher spiritual activities, and therefore, if you wish to attract a beautiful harmonious existence with happiness in your life, you must first tune your channels to those attitudes of happiness, then you will be flooded from the guides and energies of those planes which emanate those attitudes.

This Awareness suggests that in your Meditation for the Alteration of Consciousness that you recall the attitudes of the Higher Vibrations when you find yourself in those attitudes which are of lower vibration. This Awareness suggests that the altering of consciousness is nothing more than the shifting of attitudes.

## QUESTIONING 'ASCENDED MASTERS' CHANNELS

(PROVING "FRAUD" IS NOT AN EASY MATTER)

### QUESTION:

A question from S.S. in New York. "I have a quick question for Awareness. Is it possible for a person who is essentially a fraud, to accurately channel material from the ascended masters? I don't want to mention names, but I suspect some of you may be able to guess who I'm talking about. It's very perplexing to me that I can lean so much on the channelship, while having such dislike and cynicism for this woman."

### COSMIC AWARENESS:

This Awareness indicates that the term 'fraud' as that which is a catch-all term which must be examined before answering this question. This Awareness indicates that an entity can be in error, an entity can be mistaken, an entity can be pretentious without being a fraud. This Awareness indicates that for an entity to be a fraud, there must be the deliberate intent to deceive another. There must be the misrepresentation, whereby the other is deceived, and there must be some form of damage, whereby the other is damaged by that deception.

This Awareness indicates that whereby an entity seeks to kid another, telling the entity for example an April Fool's joke, and the other entity is deceived into believing this as true, this April Fool's joke is not a fraud, for the entity has not been damaged. This Awareness indicates it takes all elements before fraud could be claimed. This Awareness indicates that the entity who makes a claim, who misrepresents or who gives false information; such an entity may be in error and may be misrepresenting and may be false in certain areas. This Awareness indicates however, that the term 'fraud' in its general and legal sense is that which requires a very strict set of situations before it can be proven.

This Awareness indicates that it is however, possible to answer your question in reference to general terminology as implied, wherein the implication being that this entity may be *misrepresenting*, and the question being: "Is it possible for an entity to misrepresent information and still be a channel, a clear channel?" This Awareness indicates that it IS possible that entities can channel clear information in some areas, and faulty information in other areas.

This Awareness indicates that it is possible that entities can be quite clear and exemplary in their lives in certain areas or at certain times, and faulty and unclear at other times or in other areas of their lives. That essentially, your question in reference to this entity as associated with certain claims the entity has made in terms of personality claims, and personal expressions as an individual, when measured according to a standard as a channel, and the public image which this entity is required to fulfill.

Even the Saints Pass Wind

This Awareness wishes you to remember that there is a tendency among humans not to allow their gods to get their feet muddy, but rather to visualize their deities and saints as being perfectly clean and away from all taint of dirt or grime and cares of the world. This Awareness indicates that obviously, even those who are of high development spiritually still have their human frailties and still have the biological urges which are available to all entities. Obviously, these biological urges require that even saints use rest-rooms and toilet facilities.

This Awareness indicates that this is generally considered as unrighteous or lacking in sacred respect to think of such things. This Awareness indicates however, that it is what IS, and is necessary to keep things in perspective, so that you do not simply live with illusions, and fail to recognize reality, particularly when these illusions affect your own development.

This Awareness indicates that this entity as one who has a certain personal life, a private life of her own, as well as a life in which she channels and gives information, in which she opens herself up to certain areas in consciousness and gives messages, as is possible through her clarity and openness to these channels. This Awareness indicates that *It* has indicated before that it is the message, and not the messenger which should be given the great significance and the examination for credibility; that the messenger may have absolutely no credibility, but if the message is correct, then that is the important concern.

This Awareness indicates that wherein an entity runs to a village, warning of a coming storm, or fire raging through the forest toward the village, that the action would not be to ask the entity for his credentials, to explore the entity's credibility, but rather to rush out and look to see if the message is correct. Likewise, it is of little concern that an individual's lifestyle measures up to the demands of one's listeners, if the message which is being given is meaningful to the listeners.

This Awareness indicates that this individual's personal lifestyle is for her own growth and development according to her own particular needs, and has nothing to do with the message or its credibility, and should be allowed to her, according to her own integrity and personal growth. This Awareness indicates that the personal life of an entity, even a public figure, is that which while often coming under scrutiny of the public and is said to be the price one pays for being a public figure, nevertheless, in terms of an ethical understanding, such entities must be given some privacy and some tolerance, so that they may work out their own personal needs along with fulfilling the role of the public servant.

This Awareness indicates that obviously, the entity having a career, and role to play with the public must keep her act together, and must be able to account for her actions at least to some degree, so that the various demands and code of lifestyle which the public may require of her, be kept in some standard that is acceptable to them. This Awareness indicates that this as a very difficult task for any entity, and therefore, an entity who makes claims of being an ascended master, individually, as being a master or adept of spiritual and exemplary lifestyle, such entities are putting themselves on stage, whereby they are serving as a standard for others, and thus are challenging others to find any flaws in their lifestyle, any falsities in their claims.

This Awareness indicates that wherein an entity simply channels information, without making claims of being a master, and the messages channeled are given the significance, then the individual is free to be who he or she wishes to be, and needs not live up to the expectations of others, even though others may wish the entity lived a different type of lifestyle more suitable to their own particular taste.

This Awareness indicates it is only when an entity makes a claim and fails to follow through on such a claim that the question of personal lifestyle should be made a public issue. This Awareness indicates also, if that personal lifestyle is an affront to the standard of society in general. This Awareness indicates that in

examining this entity's personal claims, wherein you see areas of pretentiousness, this Awareness suggests that you recognize this as but perhaps something which is reflective of an attribute that you yourself once possessed, and felt an urgency to rid yourself of.

This Awareness indicates that often entities see the flaws in others which they have managed to root out from their own being, and that they could not tolerate within themselves. This Awareness indicates that often, also, such areas and flaws that were not tolerated within oneself are projected on others and seen in exaggerated form, wherein they are perhaps not as strong as imagined.

This Awareness indicates that this entity you speak of does have certain fears, certain frailties, certain image which needs constant protection and certain forces which are operating in conflict with other forces which create some turmoil in her public and private life.

#### (FOLLOW-UP QUESTION):

Would Awareness explain the repercussions when *actual* fraud is involved? I can think of an instance, approximately 10 years ago, the *Psychic Observer* paper for example, came out with a full expose of some shenanigans going on in Chesterfield, Indiana; it was a spiritualist convention or something. They published photographs of equipment and devices which certain 'mediums' used to defraud the people in these individual seances to believe that certain real spirits were communicating, and there's the case of another spiritualist minister who *does* channel an ascended master (so-called). This entity has been accused of all sorts of things. I don't know how true they are; he has spent time in prison, and there have been articles that the apports that he 'manifests' during some of these seances are fraudulent and not correct.

My question basically is, these entities on the spiritual fringe that do defraud, but at the same time rationalize that they only have so much energy, and they do give true channelings in seance as long as the energy lasts, but the public demands more channelings from them than they are capable of doing, so they have to resort to fraud to compensate for this,—how is this type of situation dealt with?

#### COSMIC AWARENESS:

This Awareness indicates that the situation wherein fraud does come in is in the misrepresentation and damage done. That wherein an entity involved in such activities makes claims which are known to be false, intentionally given, and are false to the individual, plus, wherein this individual misrepresents to others and causes damage, then fraud is active. This Awareness indicates that the individual however, needs not be fraudulent in those actions; the individual can in fact carry on the same actions without being fraudulent at all. This Awareness indicates it all has to do with the claims being made.

This Awareness suggests that rather than misrepresenting, the entity can simply state that he or she is an entertainer seeking to please the public by doing psychic tricks and in some cases may actually do things which are of a psychic nature. This Awareness indicates that in so describing an act in this manner, there would be no fraud involved,—it's all entertainment, and the guests and audience watching such would have no complaint. This Awareness indicates however, when one makes a claim that everything he is doing in this regard is from a particular frame of reference, is an apport, or a creation out of thin air, while in fact the entity is doing slight-of-hand



## HOW TO RID YOUR BODY OF DANGEROUS X-RAYS

( ALL ABOUT VIVAXIS )

### QUESTION:

A question from S.R., Smithtown, N.Y. "I have a question of personal concern which I hope you will find of general interest to CAC readers. While in labor with my first child, I was given a series of X-rays which seems to be quite a common practice these days. It is now believed that some of the children exposed to these X-rays are developing leukemia. My daughter, age five, and in seemingly good health, did have a low hemoglobin count. Since X-rays are almost routinely given to women in labor who might experience complications during childbirth, I am sure that there are many parents who are concerned as I am about the possibility of leukemia striking their children. I am asking Awareness to comment on what steps can be taken to lessen the possibility of my child developing leukemia during her childhood or developing some other form of cancer years from now as a result of these X-rays.

### COSMIC AWARENESS:

This Awareness suggests that the use of miso in the child's diet as that which can be beneficial; also the use of the stabilized aloe vera which has been previously mentioned as that which can be beneficial. This Awareness indicates selenium as that which also can benefit. This Awareness suggests that you review the information regarding radioactive fallout of the Three Mile Island situation and the information given on Kim Thompson.\*

This Awareness indicates that also there is information in a book regarding the Vivaxis, that this can be of benefit in shaking off the effects of X-rays for any entity. This Awareness suggests essentially the information is this: that the entity take two rods, or take one rod (this being made from wire such as from a coat hanger), this being placed in a small copper tube or pipe; that the entity then begin turning, and when the entity faces the direction of his or her birth, the rods being held in two hands will cross. This Awareness suggests that these as rods bent in 90 degree angles, with the vertical angle of the rod moving through the pipes which are held in both hands. The horizontal angle as that which is then held in front of the entity, and these rods then held out while the entity turns in various directions, very slowly, until the rods cross. That when these rods cross, essentially if these rods are held level and this is done with sensitivity, the rods will cross, indicating the direction of the entity's birth.

This Awareness indicates that when this has been found, the entity is to place the rods down, stand in the direction of the birth and areas where X-rays have occurred are to be struck with soft blows such as from bean bags or from boxing gloves, or from socks filled with sand or similar types of objects. That a closed fist gently striking the area to break up the X-ray energies, this also has been used to alleviate and eliminate the effects of the X-ray on the cells of the body. This Awareness indicates that this information is available in this book and may be researched by those interested. This Awareness suggests however, that essentially, this is the procedure recommended and that this does have great effects in breaking apart the fixed energies of X-rays from the past. That in terms of your child, that this direction may be found or the entity could be

tricks, bringing in gems and gemstones which have been purchased elsewhere, and are being brought in from the mouth and eyes, to appear as though they were apports; such tricks are entertaining and demanded by the audience, but the excuse that the audience demands this is no excuse for misrepresenting.

This Awareness suggests rather, that the entity needs not claim these to be apports, but may simply say that he is an entertainer of the highest degree, pretending to be one who is capable of apportioning, and if in fact this does occur, then the entity may state that: "Along with these slight-of-hand techniques, I also occasionally cry a real ruby tear, or a real emerald tear." This Awareness indicates that it then becomes the obligation of the audience, who wishes to challenge this statement, it becomes their obligation to prove that he is fraudulent in his claim. This Awareness indicates however, wherein an entity claims to be crying tears of stones, jewels and so forth, or apportioning these, and it is found not to be the case, that these are slight-of-hand techniques, then indeed, the element of fraud has entered in, for there is a misrepresentation involved.

### (FOLLOW-UP QUESTION):

I think probably the basic question the entity was getting at in the prior question, was that a lot of people would feel that if you have a spiritual gift, and it appears to you and maybe to a lot of others that this gift is being misused, that the gift should disappear.

### COSMIC AWARENESS:

This Awareness indicates that: "If it appears to others that the gift is being misused," as a phrase which could lead to many questions. This Awareness indicates that wherein an artist of great worth is painting a picture, and others stand around watching his paint brush as the paint is placed here and there on the canvas, and it appears to one entity that he should have put the paint-brush elsewhere, it appears to another entity that he should have put this color there and that color there, and these entities gradually grow into agreement that the artist is not using his talents properly, and therefore should be deprived of his brush; this Awareness indicates that this can best be achieved by the audience simply walking away, and not giving credence to his creation.

This Awareness indicates that so long as there are those who see value in the creation, obviously those who walk away may not have satisfaction in believing that the entity was a fraud and should be exposed. This Awareness indicates however, that to take away the tool of an entity because one does not agree with the entity's interpretation and use of that tool, is to create a rule of law which allows entities to judge each other, and to violate each other's expressions.

This Awareness suggests that if such tools are to be taken away, these must be taken not by each other, but by the circumstances which allow the entity to become aware that he or she is not the artist claimed, and therefore, perhaps could serve some other action better than pursuing this career which does not produce the artistry desired.

This Awareness indicates that to the degree that entities misuse their talents, to that degree the talents suffer. To the degree that entities use their talents, to that degree the talents grow and develop.

placed in the area of birth and simply slapped gently over the entire body to eliminate and break up the crystallized patterns of the X-rays.

#### (FOLLOW-UP QUESTION):

Does the Vivaxis method help in any other area other than eliminating these accumulations of X-rays over an entity's lifetime?

#### COSMIC AWARENESS:

This Awareness indicates that this as in the affirmative, particularly in terms of illnesses caused by certain poisons or radiation-type of energies such as poisons related to radiation energies, and also to maladies affected or caused by radiations from solar or from chemical or from microwave energies.

#### HOW THE VIVAXIS METHOD WORKS

#### (FOLLOW-UP QUESTION):

Well, many entities over the course of their lifetime, receive radiation in many different areas, particularly men who've been in the armed forces are subjected to X-rays many times in many different places. How is it then that by tuning in with the Vivaxis method to the place of your birth that this can also eliminate X-rays that occurred elsewhere?

#### COSMIC AWARENESS:

This Awareness indicates that the effect of X-rays is that it causes a particular energy pattern upon the area being X-rayed, which tends to remain with the body. This is likened unto an action of affecting the cells and the plasma between the parts of the cells; that this has its effect even on the atomic level and atomic structure within the cells. This Awareness indicates that this is a form of radiation and this radiation moves these atomic particles or vibrations in a particular way, which affects the pattern of their movements and fixes them or stabilizes them into these patterns and this has its effect over the years of inhibiting certain natural flows of energy and vitality. This Awareness indicates that by facing the direction of one's birth, by concentrating on the origin of one's life, the psychic energies of one's being tunes in to that beginning and the striking of these areas allows a break-up of that pattern in the atomic levels. This Awareness indicates this as extremely difficult to explain in terms of modern present-day terminologies and words, that the entity has attempted to explain this in her books and has indicated through the results the effects of this, yet there is still much which cannot easily be explained. This Awareness suggests that entities who wish to work with this, experiment with this, may do so, that those who cannot understand and do not believe need not bother with this.

#### Eliminating X-Rays with Aloe Vera Juice

This Awareness suggests that other methods of dealing with X-rays are available through diet, and that the use of aloe vera, particularly the drinking of the stabilized juice of that which is known as the Better-Living Products, in particular, that this can also assist in relieving some of the effects of radiation. This Awareness indicates this use of aloe vera has been used in previous times in the treatment of X-ray effects, particularly in the early 1930's when X-ray machines were still crude and often entities were given too high dosage. This Awareness suggests that this also can be researched and that those wishing to experiment with this may do so. This Awareness indicates it appears there are other forms of stabilized aloe vera

besides the Better Living Products brand which have benefits also. This Awareness suggests that the pure juice of the aloe vera plant is also beneficial in treatment of such radiations and in treatment of other maladies. This Awareness suggests this information can be researched through literature which is available.

#### ED's Note:

The Better Living Products aloe vera being plugged in this and other readings (particularly personal readings), are sold on a pyramid-type marketing plan (illegal in some states, including Washington state) and at a price double or more of what a similar product can be bought in healthfood stores and other places. At the time this particular reading was given, the Interpreter was involved in a multi-level marketing scheme which promoted the Better Living Products brand of aloe vera juice. Whether the plugs for this particular brand is Awareness giving the Interpreter's enterprise a little boost or whether it is part of the 15% error Awareness says is present in these communications, the fact remains that there is a lot of aloe vera around that is just as good as the Better Living Products stuff, much much cheaper, and you don't have to join a pyramid scheme in order to buy it. CAC has previously published information on where this product and many others can be obtained at fair prices. (And don't let words like "stabilized" fool you. Most brands of aloe vera juice are stabilized one way or another I have been told). While putting this reading together, I checked to see what the current price of Better Living brand aloe vera was going for (they have since since changed their name to "Forever Living Products") and the price was \$15 a quart. One dealer on the pyramid was selling it for \$11 just so she could obtain it herself for her own family's use at that price. However, those of you who do not wish to be intimidated into their pyramid plan scheme in order to buy their aloe vera, even at an inflated 'dealer' price, we suggest you order by mail from Nutrition Headquarters, 104 W. Jackson St., Carbondale, Illinois 62901. They will ship you a full gallon (4 quarts) of 99% pure aloe vera juice, stabilized, with no artificial flavors, sugar, starch etc. added, for \$9.95. And this includes freight delivered to your home. (Why be ripped-off and pay 4 times that much on pyramid schemes? Like aspirin is aspirin, aloe vera juice which is 99% aloe vera is the same as any other 99% aloe vera juice, regardless of what the ads may trumpet.)

In reference to Vivaxis, Vicki T. and yours truly went to a 3 day workshop some years back that taught the Vivaxis method of healing. It was given in Canada by Frances Nixon, the author of several books on the subject, including "Magnetically Yours," and "Vivaxis-The Spiral of Life." CAC has a few copies of these books left, but does not stock them anymore. More info can be found by writing Frances Nixon, Magnetic Publishers, PO Box 718, Chemainus, British Columbia, Canada.

In case the instructions given by Awareness were not clear, you can make the Vivaxis tool quite easily. We recommend the rod be that used in welding shops (copper-colored and about as thick as a wooden kitchen match), the sleeve to hold these rods being made from copper tubing (the size used in cars that feed gasoline into the carburetor). These welding rods in a welding shop or hardware store cost about 30 cents each. (Get 2). These are made of steel, and are 1 yard long. Bend each about 8 inches from one end so you have a right angle piece 8 inches which you insert into the copper tubing, also about 8 inches in length (You will need pliers to bend the rods). Now you have two steel rods, approximately 28 inches long with a 'dog leg' right angle that slips into your 8 inch copper tube. The diameter of the tube is slightly larger than the rod which slips into it, thus giving the rod ample room to freely swing around. Hold a rod in each hand, grasping the copper tube as a handle, and you will note that the rods start to swing around. Turn your body slowly in a circle and when you are pointing directly to the town or place of your birth, the 2 rods will cross one another. This point is called your Vivaxis, and you should mark the direction you are facing on your

floor or sidewalk, so you won't have to do this all the time. Then, when standing over the line you drew which faces your place of birth (you can check it with a compass and a map and you will find it does indeed line up with your place of birth), all you need do from that point on is to go and stand on that line which faces your birthplace, and then proceed to bang away on your body (gently as Awareness has suggested) with a rubber hammer or mallet or something similar. You can also jump up and down over your Vivaxis line, smartly striking the back of your neck or other places where X-rays have been applied. To get them out of your head (X-rays applied by your dentist), Mrs. Nixon suggests you chew ice, breaking it up with your teeth as you straddle your Vivaxis line. Do this periodically and it is supposed to remove all your prior X-rays. When you go to your dentist and he gives you more X-rays, just straddle your Vivaxis line and chomp away on some ice. The entire Vivaxis method is rather weird and hard to explain to anyone, but it evidently works. We were glad when Awareness confirmed the method. If you read the books on the subject you will find that the method can be used in quite a few other cases where healing is necessary. (I have also personally used these rods as dowsing instruments to locate ground water, underground pipes and even minerals). (Avaton)

### CAN BROKEN NERVES BE REPAIRED? (MORE ON THE POLARIZER IN HEALING)

#### QUESTION:

A question from L.J., whose wife was involved in a car accident that left her paralyzed with a broken neck between the sixth and seventh cervicle. His question: there are hundreds of people who have had this type of injury and whose nerves were broken. My question is simple: Is it possible for broken nerves to be reconnected; and if so, what is the method?

#### COSMIC AWARENESS:

This Awareness indicates that it appears that science is presently on the verge of a breakthrough of leading into this area as a new field, through the gene-splicing techniques which are presently being developed; and that through gene splicing, not only can nerves be repaired, but this can also eventually lead to curing many of the so-called 'incurable' diseases, and also can be beneficial in re-growing arms or legs or other extremities which have been severed.

This Awareness indicates that there appears to be another avenue also, which has not yet been developed, but which can move into rapid development: this through the use of ultrasonics, the use of sound.

This Awareness indicates also, that the field of electromagnetism as being an area which can be effective in assisting this action. This Awareness suggests that large amounts of calcium, magnesium, Vitamin A and Vitamin D taken daily over a long period of time, can also be very beneficial in regards to this.

This Awareness suggests that the Polarizer of Sam Millar as also being beneficial in assisting in this action. Also, the use of the biochemical cell salt combination known as bioplasma taken regularly at intervals of approximately every three or four hours,--this with each meal, prior to eating, approximately six to ten of these bioplasma cell salts three times daily or prior to each meal,--over a period of approximately 18 months, this can have profound effect on assisting in the healing process.

### HOW TO HEAL USING CRYSTALS (MORE ON PSIONICS)

#### QUESTION:

We received a letter from P.K., of Worcester, Mass., who sent along some crystals, some regular quartz crystals. He's sending them around to various groups and entities. I'd like to read what he says and ask Awareness if this information is valid and whether it should be acted upon.

"I just talked to T.M. about an experiment to focus through the use of crystals, healing energies on Washington, D.C. I'm of the opinion that September 24th and October 20th may be times when powerful planetary healings may be sent psionically through use of crystals.

"The planet Mars will be, on the 24th, 26 degrees Leo, forming a harmonious aspect, a trine with Neptune at 26 degrees Sagittarius. This aspect gives hidden protection to Light workers. It also is powerful for sending and receiving healing. It is the ideal aspect for encouraging non-violence. Mars action and Neptune compassion work in harmony.

"These energies could be amplified and focused by crystals to Washington, D.C., El Salvador, Tel Aviv, Brussels, by way of sympathetic transference. The map of Washington enclosed is Washington. It can be placed on a schematic of a psionic device to further boost the energy. The crystal should be cleansed before and after this operation.

"This aspect won't happen again at 26 degrees, the harmonic frequency of quartz, until December, 1996. On Oct. 20th, the sun will form the same aspect. Wherever this energy is directed, lies will be brought to light. Why not send it to the land frequented by our illustrious leaders?

"Enclosed is a map of DC, Israel and El Salvador. Give one map each to Avaton and Sam. I hope Paul will do a trance on this. I am spreading the info anyway until we find out for sure how heavy the effects will be. I suspect they will be very heavy.

"The crystals should be left in the sunlight at noon on the above dates on the map, only one map to each schematic. Don't stay too close to it while it is charging, as its vibrations may be too powerful. It is also important to be in a peaceful frame of mind at the time. Then around 1 PM remove the crystal, being careful not to speak. This is critical, as the 'imprinting' is still occurring. Cleanse for 10 minutes in the vinegar, water, sea salt solution, wrap the crystal in dark cloth to retain energy."

And he sent a map with further instructions that you could wind copper wire around the base of the crystal so it would stand upright, and you place it on the map of the area you want healed. He says: "Copper coil around a crystal is essentially a radio; this one for celestial frequencies."

And he goes on about the use of psionics: "In using a psionics schematic, place the witness (the object to be effected) on the coil marked 12 on the illustration, and once your crystals are charged with Mars trine Neptune or Sun frequencies, they will become very powerful tools for sending and receiving of absent healings."

And he gives instructions to place in the sunlight between 11:00 AM and 1:00 PM on Sept. 24th and Oct. 20th, which is coming up. Would Awareness please comment on this information?

**COSMIC AWARENESS:**

This Awareness indicates that the general principle as that which is accurate. This Awareness indicates that the quartz crystal being that which forms at 26 degrees; that the use of this in terms of a psionics transfer of energy as that which can be of some value. That when used in this manner, it can be enhanced through deep breathing prior to meditation while this is being energized by the sun.

This Awareness indicates that to combine the Kahuna prayer with the psionics format will be helpful in increasing the potentiality of the effect. This Awareness indicates that *It* suggests the crystals be placed as indicated; the entity step back to an area away from the crystal, breathe deeply for several minutes until becoming slightly dizzy or high in oxygen content; then with eyes closed, visualize that map with the crystal sitting in place, and send forth through the breath, blowing upward through the upreached hands toward the Light which may be symbolized by the sun, to that Light, the energies of your mana which have been gathered through the deep breathing process, along with the image of the area which you wish to be healed.

This Awareness indicates that you may visualize this as a kind of snap-shot of your crystal sitting on the spot on the map. Visualize this crystal being carried upward by rays of Light to the sun or to the Light, along with the mana which is sent for purposes of healing that area on the map; that this will increase the effect of this action by approximately 10 times the strength.

This Awareness indicates that it may also be accompanied by a prayer to the Light, that the crystal be endowed with healing powers that may be used in future prayers.

**(FOLLOW-UP QUESTION):**

Is the date of October 20th as significant as he implies?

**COSMIC AWARENESS:**

This Awareness indicates that this as important in that the angles of these planets correlate or correspond to the angles of the crystal; the crystalline structure being angled in relation to those planets mentioned, therefore; it will pick up the influence or vibration of those planetary aspects. That wherein this aspect in the heavens is not equated with the aspects of the crystals, such as would occur after that time period, then the crystal does not pick up the influence of this aspect. This Awareness indicates this as a combination of astrological and crystallography as was used in times of Atlantis wherein crystals were commonly used for purposes of healing and of bringing about various influences.

This Awareness indicates that at that time there were many types of crystals used, based upon their crystalline structure, color and vibration, along with planetary charges and a complete healing system was developed whereby each crystal had its function in the affairs of man and could be used for certain specific purposes, and the selection of crystals allowed the priests to use these for a wide variety of services.

**Amulets & Talismans are Placebo Suggestions**

This Awareness indicates that it is from this science that the later tendency of relying on amulets and talismans for support resulted. That many of the amulets and talismans of today are little more than placebo-suggestions, having their effect from the belief in them rather than any inherent quality. However, in earlier times this was an exact science.

This Awareness indicates that this entity as one who was such a priest in Atlantis, and as one who understands this science quite well.

**HEALING THROUGH PSIONICS  
& THOUGHT-AMPLIFICATION****(FOLLOW-UP QUESTION):**

Disregarding astrology and the particular day of the year, how effective, if any, would it be in healing an entity for a person to set this quartz crystal with copper wire wrapped upon it over the picture, a photograph of the entity who needs healing?

**COSMIC AWARENESS:**

This Awareness indicates that once the crystal was charged with the healing energies of the planetary qualities or aspects it could serve as a powerful healing device. That without such a charge, the crystal itself would not be of great significance, except as it is believed to be so by the mind that places the crystal upon the picture.

This Awareness indicates that if an entity is placing a crystal or a sprinkle of magic dust on the photograph of another with the intended purpose of bringing about a healing, it can have an effect in the sense of it serving as a psionics-type device, in that it too operates as a thought-enhancement activity. This Awareness indicates this being a thought amplifier; that thought amplification is the nature of the psionics device; that there are energies in space, in light associated with photons; that these energies can be affected by thought or consciousness, and these energies can also be caught in photographs, wherein the light travels from the subject to the film, carrying with it the energies of the vibration of the individual.

This Awareness indicates therefore, the picture holds the vibration of the individual and can be affected by thoughts sent toward the picture. That through sympathetic vibration, these energies can be stimulated according to the thought projected toward the picture; that wherein there is a crystal placed above this picture, or magic dust sprinkled on the picture and the action is symbolic of an action intended to heal, in which the *intent* is what is important, the *intention* to heal; then the thought of healing becomes amplified by the physical ritual, and the physical apparatus attached.

This Awareness indicates that by further charging a crystal with the influences from the planets that are beneficial for healing, an entity can enhance the thought amplification to a much greater degree. That also, through the heavy breathing which builds up mana, a surcharge of mana, the entity can project higher thought amplification through this technique. This Awareness indicates that even without the picture, the heavy breathing and the thought of an individual, whereby mana is built to a surcharge, sent to the High Self with the intent and request that the energy be used to heal this other entity; this too is effective; that the picture and the crystal may simply add further to this action.

## The CIA and the Vatican

In a *Mother Jones* article, investigative journalist Martin A. Lee takes on two of the world's most secretive and sensitive groups—the Central Intelligence Agency (CIA) and the Vatican.

Lee charges that the CIA is using the Vatican as a source of foreign intelligence and is attempting to influence the Vatican's foreign policy through both overt and covert channels.

For centuries, the Vatican has been a prime target for foreign espionage. One of the world's greatest repositories of raw intelligence, it is a spy's gold mine. Ecclesiastical, political, and economic information filters in every day from thousands of priests, bishops, and papal nuncios who report regularly from every corner of the globe (and most importantly for the CIA, from Eastern Bloc countries) to the office of the Papal Secretariat. After World War II, the CIA reportedly created a special unit in its counterintelligence section to tap and monitor development within the Vatican.

Unbeknownst to most Catholics and many others, the Vatican, which carefully maintains an apolitical image, not only has a foreign office and diplomatic corps but also has a foreign policy. With Polish Communists embracing Catholicism and Latin American Catholics embracing Communism, the U.S. government and particularly the CIA have recently taken a much greater interest in the Vatican.

In his article, Lee charges that since World War II, the CIA has:

- Penetrated the American Section of one of the wealthiest and most powerful Vatican orders, the Sovereign Military Order of Malta (SMOM) of which William Casey, director of the CIA, and Alexander Haig, former Secretary of State, are members.

- Employed undercover operatives to lobby members of the *Curia* (the Vatican government) and spy on liberal churchmen on the Pope's staff who challenge the political assumptions of the U.S.

- Collaborated with right-wing Catholic groups to counter the actions of progressive clerics in Latin America.

- Supported factions within the church that were instrumental in promoting and electing the current Pope, John Paul II, whose Polish nationalism and anti-Communist credentials make him a perfect vehicle for U.S. foreign policy.

The issues presented in this brief synopsis are only a small part of a complex issue, one which has received minimal attention because of the secrecy and sensitivity associated with both the CIA and the Vatican.

## Complaints filed against boy, 15, for feeding kittens to his pet python

LA GRANDE, Ore.

A 15-year-old boy who fed kittens to his pet python says he was not being cruel, and his mother says the feedings are no more inhumane than allowing the Humane Society to gas them.

"He doesn't look at it as being cruel," said his mother, Pam Lewis. "He looks at it as just feeding his pet snake. We don't feel like we're killing pests, we're keeping one alive."

Several complaints have been filed against Tim Barricklow with the Oregon State Police, the La Grande Police Department and the Humane Society.

The boy said he got the kittens by responding to newspaper classified ads offering free kittens.

He also said he received three kittens from a La Grande pet store, two of which were fed to the snake. The third was returned to the store because the snake refused to eat it, he said.

"To me, it's no more inhumane than the Humane Society gassing them," his mother said.

The youth insisted the diet is part of the natural food cycle and said using the animals as food is not as bad as making snakeskin purses and boots.

He said he has not fed kittens to his python, named Apache, for about "two or three months" and does not plan to do so in the future.

## Reagan launches own news service

WASHINGTON (AP) — The White House, guided by President Reagan's repeated complaints that his views are distorted by the reporters who cover him, is launching his own "news service" to distribute presidential speeches and announcements.

Among the first clients of the fledgling service is Citizens for America, a conservative organization headed by Lew Lehrman, unsuccessful New York gubernatorial candidate in 1982.

But the White House hopes to establish a market for the service among radio stations and small newspapers around the country that don't have White House correspondents of their own.

Sue Mathis, acting director of the White House office of media relations, said people who contact her office for more information after reading a news story about some event often remark upon hearing the official version that it "wasn't at all like the news report" they had heard.

HEALTH FOOD CRACKDOWN. The federal government has made its boldest move to date to control the health food industry by charging General Nutrition, Inc. with defrauding the Food and Drug Administration (FDA) of its regulatory powers. The seven-count indictment accused the health food chain of promoting a food supplement as a drug. The product, Gammaprin, is a capsule made from the oil of evening primrose. It has allegedly been promoted as a treatment for various ailments, including cancer, arthritis, high blood pressure and asthma. An attorney for the FDA argued



that it is not a question whether the product works but that it may interfere with individuals using "known remedies" for these illnesses.

BOOK RETURN. Two copies of the book "The Hoax of the Twentieth Century," which had been seized earlier this year from the University of Calgary, have been returned by the Royal Canadian Mounted Police. The work, which contends that the German government in World War II had no overall plan for a systematic genocide of the Jews, had been banned from importation into Canada by Canada's Customs Service after it had been deemed "hate literature" under a recently passed law. The seizure of the opus prompted a huge outcry from the public and newspaper editorials. The specific reason for the return of the books is not known, but it is thought that it was done because the books were purchased before enactment of the law dealing with "hate" literature.

## Jackson warns of accidental war

LONDON (UPI) — The Rev. Jesse Jackson arrived in Britain yesterday for talks with anti-apartheid leaders on racial segregation in South Africa and immediately turned his attention to the Soviet cruise missile incident in Scandinavia.

"If that missile had been heading for the United States," he told reporters at Heathrow airport, "its response would be computer controlled and we would have been ushered into nuclear war."

## Russia apologizes for stray cruise missile

OSLO, Norway (UPI) — Russia admitted yesterday that a Soviet cruise missile streaked over northern Norway last week and apologized for the violation of Norwegian airspace.

Foreign Minister Svend Stray announced.

In a meeting with Stray, Soviet Ambassador Dimitri Polyanski also promised "the Soviet Union would take the necessary measures to avoid any recurrence in the future." Polyanski said the missile carried no warhead, Stray said.

Stray said Polyanski requested the meeting to apologize for the incident, just as Norway was delivering a formal protest in Moscow that called it "a serious violation of Norwegian airspace."

Stray expressed "deep satisfaction" with the Soviet response and

said it would "strengthen mutual confidence between Norway and the Soviet Union and between East and West."

The minister also said suggested the apology could ease the atmosphere for next week's arms control talks between U.S. Secretary of State George Shultz and Soviet Ambassador Andrei Gromyko.

The Soviet ambassador said the incident occurred during a Soviet naval firing exercise when an older-model cruise missile went off course into Norwegian airspace, Stray said.

The cruise missile was launched from a Soviet submarine in the strategically important Arctic seas off northern Russia but veered off course, roaring over northern Norway and disappearing into the Lake Inari area in Finnish Lapland.

As the Norwegian ambassador was delivering an oral protest in Moscow, Finland, a neutral country, asked "for clarification" of the incident.

"The Foreign Ministry has contacted the Soviet Union via the Soviet embassy in Helsinki asking for clarification," the brief statement said.

Finnish border guards, meanwhile, continued the search for remains of the missile in the frozen wilderness around the lake, which has some 3,000 islands.

The search yesterday moved northwards towards the Norwegian border but was hampered by bad flying weather, the arctic command of Finland's frontier force said. No results were reported.

## Air war grows

Only three blocks from this newspaper I feel my house shake daily from the bombs dropped at the nearby military base. With each tremor I try to understand what it would be like to be the victim of those bombs: to live in constant fear, to have my friends and children maimed and killed, to have my food supply destroyed, to live in El Salvador.

The death count there mounts as napalm and white phosphorous bombs drop from military aircraft on civilian populations in the countryside. These bombs have destroyed vast areas of dry land and crops, burning rapidly in clouds of thick black toxic smoke. Contributing to the psychological toll of this air war are weekly to daily surveillance flights that thunder over villages, creating a constant threat of bombardment. This is the report of a delegation to the country sponsored by Medical Aid for El Salvador.

Dr. John Constable, a Harvard burn specialist and delegation member, examined several burn victims, three of whom had suffered injuries identifiably caused by napalm. A woman and her children described being hit by a gummy, spattering, fiery material. In his examination, Constable found "scattered, healed, deep, partial-thickness burns" which he diagnosed as consistent with napalm.

The air war in El Salvador is the most rapidly expanding front of the U.S. war in Central America. New levels of U.S.-supplied weaponry are being introduced and changing the nature of the Salvadoran conflict. If the U.S. expands its role in direct combat in the region, air strikes against rebel zones in El Salvador are a likely next step.

## Big Brother is listening

"The privacy questions raised by the new Telecommunication Age represent the single most important issue facing Congress today," said John Shattuck, ACLU Director.

Advances in computer technology have now made it possible to monitor the computer or telephone transmissions of thousands of private citizens at one time by programming eavesdropping computers to pick-up key phrases, selected buzzwords, peoples names, addresses, or phone numbers and then routing these calls to the human eavesdropper or recording them for future reference. These sophisticated super computers can develop "Personality Profiles" on the unsuspecting telephone user using "non aural" techniques.

In 1983, a federal appeals court ruled the National Security Agency could lawfully intercept messages between U.S. citizens and people in foreign countries, "even if there is no reason to believe that the Americans are foreign agents." Also, because computers turn transmissions into "digital bits," a loophole in the 1968 Wiretap Law makes it lawful for any government agency to monitor and intercept such transmission without a search warrant.

Again, in 1983, the Reagan administration gave the okay to randomly require government officials to submit to lie detector tests, even if no unauthorized disclosures are suspected. The "New Order" requires officials with Sensitive Compartmented Information clearances to sign agreements binding them, for life, to submit writings that might contain "sensitive information," even if unclassified, to government censors. Despite Congressional protest, government employees continue to be required to sign such agreements.

Despite all the protestations that George Orwell's 1984 did not arrive, it would seem that Big Brother is somewhere and listening very quietly to what we are saying.

## Parents lose fight in drafting of sons

NAGAROTE, Nicaragua — Infuriated parents said yesterday they battled Nicaraguan police with sticks and rocks in a failed effort to stop their sons from being hauled away to serve in the military.

Residents of Nagarote, a town about 29 miles west of Managua, said truckloads of police arrived early Thursday morning and started banging on doors and yelling threats, demanding that all boys at between the ages of 16 and 23 present themselves for obligatory military service.

Angry parents, led by the parish priest known only as Father Abillo, began to battle the police with sticks and rocks to protest the violence of the authorities' methods, residents said.

Parents said police took about 300 boys, who after undergoing basic training are pressed into service against anti-Sandinista rebels battling the government.

Some 800 boys were reported to have tried to escape Sunday from "La Granja" military base, 8 miles east of Managua. Mothers of the boys said their sons had been taken off the street, out of movie theaters, out of markets and from bus stops.

## Priest defends world's hookers

ASSISI, Italy (AP) — Brazilian priest Leonardo Boff, who was called to the Vatican earlier this year to defend his controversial writings on liberation theology, told a Roman Catholic youth convention Saturday that "prostitutes, according to the Gospel, will precede us to the kingdom of Heaven."

Boff told 1,000 youths in this central Italian town, "It's one thing to see poverty on television. It's another thing to live it." He said that because prostitutes are among the world's poor, they "will precede us to the kingdom of Heaven."

# Privacy? There isn't any on a cordless telephone

SCRANTON, Pa. — University of Scranton freshman John Sullivan was warning for the more than 9 million people who use cordless telephones: Eavesdroppers might be listening.

Sullivan, 18, said no elaborate monitoring equipment is needed to listen to the private conversations of people using cordless phones.

"Just about any radio will do it," he said. "Turn an AM radio past the 16,000 mark. And the older the radio, the better chance you'll have. The older ones don't have solid-state."

Sullivan ought to know. He has listened to conversations on subjects ranging from drug deals to the sexual exploits of cheating spouses and stock-

brokers discussing the details of a prime purchase. Sullivan does most of his listening on a ham radio, and often calls people to tell them he eavesdropped.

"I've called tons of people after listening to their conversations, and no one knew this was happening," Sullivan said. "One woman asked if I'd read 1984, and another said she'd call the police."

Sullivan, of Haddonfield, N.J., says people usually give their names during conversations, and he just looks them up in the phone book. Many people, he added, think interception of the average phone conversation hurts no one.

"But any conversation has the potential to be damaging if taken a certain way," he said. "If nothing else, a burglar could hear you say you'll be out of the house. This whole thing is a mess, and it's just going to get worse."

The Federal Communications Commission says cordless telephones have been improved since they burst onto the market a few years ago. Conversations from the newer phones probably can't be picked up on a conventional radio any more, but a ham radio operator has a clear shot at eavesdropping on any cordless phone, an FCC official said.

"It's perfect for a burglar," said the FCC's Jeff Young. "Although we don't have any numbers to support it, I would imagine the number of people eavesdropping has risen over the last few years."

"I really don't think the public, as a whole, are aware of people listening to their conversations," he said. "They're buying the telephones like crazy."

Young said there is no move to make such eavesdropping unlawful, but it already is illegal to divulge any informa-

tion gained. Sullivan contended technical efforts to block such eavesdropping would fail.

"Their efforts to make listening impossible won't work," he said. "There's always going to be a way to beat it."

Sullivan said conversations on the new telephones may be monitored by a scanner — a device most ham operators have. He said companies claim to have built the newer phones to reduce static, but it probably was an attempt to limit the distance over which the signals can be received.

The average ham radio may monitor a cordless phone conversation up to five miles away, Sullivan said. However, with flat terrain, such as in the Southwest, the distance can increase to 400 miles, he said.

# A cold Christmas for homeless workers

This holiday season is again one of sharp contrasts. In San Francisco, for example, streets are jammed with shoppers in areas like Union Square where many shops cater to the well-to-do. Yet, a few blocks away, one will meet homeless people who beg passersby for spare change and sleep in the doorways of stores along Market Street.

Like scenes are repeated in cities from coast to coast. As winter comes in, the plight of the estimated 2.5 million homeless people in the nation is growing graver by the day.

In San Francisco, mentally ill homeless persons have flooded emergency psychiatric wards, and hundreds are turned away to go back to the streets.

In New York City, 150,000 families are on a waiting list for public housing, overcrowded shelters turn people away, and many end up sleeping in bus terminals and train stations, on the streets and even in welfare offices.

In Philadelphia, some of the homeless sleep in the Amtrak station.

In St. Louis, the homeless have to wait four to five years to gain admittance to public housing while 1,500 people a month are turned away from emergency shelters.



No excuse for suffering  
There is no acceptable excuse for this human suffering. There is no acceptable excuse for homeless

people to dip of exposure to the cold for want of shelter. There is no rational excuse for untold others to double up in cramped quarters with relatives and friends or to eat at soup kitchens in order to be able to pay the rent.

There is no acceptable excuse for such suffering because our society has the wherewithal to provide housing — not just adequate housing, but good housing — for all who need it. We have the material resources, the industrial capacity, and hundreds of thousands of skilled, but unemployed, construction workers.

Indeed, some of those resources could even be put to use to immediately ease the suffering of the homeless by rehabilitating vacant and boarded-up houses and other buildings in the nation's major cities to provide emergency shelters for the homeless.

But these resources are not put to use to help the homeless. Quite the contrary. The government, for example, has actually cut back spending for housing from levels already inadequate, and further cuts are under consideration.

This reflects the material interests of the capitalist class, which

AIN'T GONNA STUDY WAR NO MORE. A Baltimore couple who say their religious beliefs prevent them from contributing to America's military build-up have received a \$4,741 refund from the Internal Revenue Service (IRS). Joseph and Barbara Jensen decided about half their taxes went to the Pentagon, so they claimed half as a credit on their return, along with a written explanation. They got the money, along with \$202 in interest. An IRS spokesman refused to comment specifically on the Jensens' case but said the taxing bureau does not read enclosed explanations until a later audit, because of the high volume of tax returns. A computer simply issues the check, if the arithmetic is correct.

## Nuke strike considered in 1954

LONDON (AP) — Military leaders from the United States, Britain, France, Australia and New Zealand considered the possibility of using nuclear weapons against China in 1954, according to newly disclosed British government papers.

The previously secret papers, released by law from the Public Records Office on Tuesday after 30 years, show strong U.S. pressure on Prime Minister Winston Churchill's government in 1954 to join a coalition to rescue the French facing a humiliating colonial defeat at Dien Bien Phu in Vietnam.

A military conference of the five allied powers was held in Washington to discuss the matter and plan a response to China's expected intervention on the side of the Vietnamese Communist insurgents led by Ho Chi Minh.

The British chiefs of staff added in a secret report to the Churchill Cabinet's defense committee, that the conference had resolved that:

"Should war with China be precipitated by Chinese Communist aggression in Southeast Asia, air attack should be launched immediately, aimed at military targets. To achieve a maximum and lasting effect, nuclear as well as conventional weapons should be used from the outset."

But the British chiefs of staff added in a memorandum to the Cabinet on June 17, 1954: "Although the use of nuclear weapons from the military point of view obviously has more effective use of conventional weapons, their employment would have a serious effect on Asian opinion generally."

Dien Bien Phu, which had been under siege from March 13, 1954, fell to the Communist Vietminh on May 7 that year, leading to the partition of Vietnam.

## Ariel Sharon's deceit documented

WASHINGTON — Every once in a while, a book comes along that so clarifies our most controversial recent history that it deserves study outside the book pages. It becomes foreign policy history, not as the politicians pretended it was, but as it really was.

That is why "Israel's Lebanon War," written by the two men who are widely recognized as Israel's greatest journalists, is most reading for people who care to know about the future of Israel and the Middle East, about the vagaries of America's inconsistent and too-often tethered policies there and about the propensities of dictatorial mentalities.

This book, by the Israeli newspaper Ha'aretz's pre-eminent military correspondent Ze'ev Shohat and Israeli television's Ehud Ya'ari, only now published in English by Simon and Schuster, for the first time clarifies what really happened in that horrible and pointless war in Lebanon in 1982.

But let us start with its conclusions, which end a story that should shock any decent, thinking person:

"One individual — Defense Minister Ariel Sharon — arrogated the authority to conduct a major military venture as he saw fit and encountered no effective opposition from his government colleagues until the nation hovered on the brink of disaster," they sum up. "Promising what he never meant to deliver,

Sharon transformed the war in Lebanon into a personal campaign, even though the Cabinet had disqualified his approach, the country's intelligence community cautioned against it, and the senior ranks of the army ... forthrightly opposed it."

What had happened? "Crudely put," the authors conclude, "one could say that just prior to the war an extraordinary kind of putsch occurred in Israel. ... It was a very subtle one-man coup."

"They continue, 'Instead of trying to take over or disperse governmental institutions, as in the usual course of a coup d'etat, Sharon devised a formula for bypassing the decision-making process and evading the supervisory prerogatives of the country's parliamentary system.'"

The authors describe how Sharon, wanting to invade Lebanon at all costs to destroy the Palestine Liberation Organization and establish the beginnings of a new Israel-imposed order on the Middle East, deceived Begin and the often-naïve American administration.

to compile them. But two deserve special attention:

— The authors establish without a doubt that those Israelis with Sharon who wanted to invade Lebanon used the terrible assassination attempt against the Israeli ambassador to London, Shlomo Argov, as the excuse, knowing full well that the PLO were enemies of the attackers, the anti-PLO group of fanatic Abu Nidal.

In this profoundly revealing and disturbing book, the authors sum up on the last page, noting that "of Ariel Sharon's grand design, nothing remains." Unfortunately, that line is not quite complete.

Ariel Sharon stands in a New York courtroom these days suing Time magazine for beamrching his good name. The new Prime Minister Shimon Peres, is in power, but the Sharon group remains close behind, lurking threateningly and totally without remorse. The American professional Jewish establishment steadfastly backed Sharon and has never apologized to anyone.

The implicit message of this book is that once a diabolical drama like this one gets started, everyone who does not immediately protest and fight back is compromised. That, indeed, is what happened and the final chapter has not been written.

# \$1-a-month phone 'access' fee approved

WASHINGTON (UPI) — The Federal Communications Commission approved a plan yesterday to add a \$1-a-month "access" charge to residential telephone bills but slash long-distance rates by about \$1 billion.

The unanimous decision to adopt a compromise worked out last month by a panel of state and federal regulators came as 40 protesters representing a coalition of consumer groups picketed commission headquarters.

The meeting was briefly interrupted when a man with a bullhorn paraded through the chamber, shouting, "Stop siding with the big companies and start siding with the people."

The decision will allow the \$1 charge, effective in June, to increase to \$2 a month in late 1986 but go no higher without an extensive investigation. It is substantially lower than last year's FCC plan to impose access charges of as much as \$4 a month on customers with one telephone line.

"My view of this decision is if we don't move this way, local telephone rates are going to be higher, much higher," said FCC Chairman Mark Fowler.

Congressional leaders blasted the

said it was pleased by the action. But the U.S. Telephone Association, which represents most of the 1,400 local phone companies, said \$1 is not enough.

The new plan calls for "lifeline discounts" that would wipe out the access charges for customers defined as low-income by state and local governments. It also will allow states to offer special discounts to keep businesses from building their own phone systems to bypass the local network.

If state regulators decide business discounts are needed, residential access charges could be raised by a maximum of 35 cents per month to help cover the revenue shortfall.

But every dollar paid in access charges must result in a dollar reduction in long-distance rates. It will lead to a 3 percent to 5 percent reduction in rates charged by American Telephone & Telegraph, which handles 66 percent of the nation's long-distance business.

Consumer groups argued that 73 percent of residential telephone customers spend less than \$10 a month on long distance.

"Consumers will be spending up to \$2.35 a month more in two years for the privilege of saving 30 cents a month," said Sam Simon, head of the
