

THE EVOLUTION OF SPIRIT AND THE LONG SLOW ROUTE TO COSMIC CONSCIOUSNESS

ED's Note:

Whenever Awareness refers to insects, creatures, or life-forms of any type, it usually refers to these as "entities", which is disturbing to some readers who feel only the human being should warrant this term. Awareness in past readings has explained at great length how all cells in the body of God have the potential to evolve and return to its Source. QUESTION:

A question from C.P., of St. Joseph, Minnesota. "I am presently doing a study on butterflies and I have to catch and kill these in order to study them closely. I would like to know if I am causing any bad karma on my life or that of the butterflies I catch? I feel badly for killing anything, including insects. I usually pray for the butterflies that I catch. Do you have any suggestions on how to keep any pain or suffering from these I may cause to a minimum? Would Cosmic Awareness also comment on how humans should relate to animals and other living things, such as plants? I wish to avoid any intrusion on the lives of any living thing and would like to know how I can live in harmony with all life around me. Thank you for your consideration."

COSMIC AWARENESS:

This Awareness wishes that entities understand that in the development of the spirit of an entity that there are movements of life forces which pass through many experiences; that the movement of Spirit in its progression may pass through the experiences of insect life hundreds of thousands, or millions of lifetimes. That the movement of Spirit through microscopic life as it develops, may pass through several million different entities or cellular or microscopic beings, which live and die, again live, again die, before becoming evolved to the insect level, and in passing through hundreds of thousands of insect experiences, the Spirit may then move on to the smaller animals and creatures and live several thousand lifetimes in these levels, gradually gaining more and more of a center of gravity.

These spirits, with their center of gravity, may then move on into experiences of the larger animals, gradually moving toward those of greater levels of awareness. These spirits then, as they evolve further, eventually may make up the spirit which serves as the elemental soul of what would be a primate type of being, a mammal, or the basic elemental part of the primates; and when these evolve even further,

through many lifetimes or experiences, these spirits may become the rudimentary soul energies which serve as the subconscious for humans; and as these evolve even further, these energies may become better organized, more capable of deductive and inductive thinking, until they can evolve to the point of serving as a conscious spirit.

The Evolutionary Stages of Consciousness

This Awareness indicates that the energies of the lesser levels of Spirit may be referred to as unconscious spirit; there may be that which is the unconsciousness of the unconsciousness. That prior to this, there may be the unconsciousness of consciousness, followed by the consciousness of unconsciousness, and the consciousness of consciousness, followed by the consciousness of superconsciousness, followed by the superconsciousness or superawareness of the superconsciousness or the superconscious awareness of that which is Cosmic Consciousness.

All of these different stages may be in varying degrees, and the expressions of these levels of consciousness may take place in various types of life forms; that the nerve networks and sensitivities of these various life forms may have different degrees of development. That the higher on the scale toward consciousness, the more the creature is capable of abstract and rational awareness; and the more capable of abstract concepts and awareness, the more the entity moves from mere instinctive behavior to objective, directive, purposeful behavior.

That wherein small insects move about from place to place with no conscious plan or guidance, these insects are moving simply as spirit caught in a body; the instinct is not even to survive, but to move and to satisfy impulses from the nerve network within the insect,—this as unconscious movement wherein the insect is even unconscious of its own unconsciousness. The insect does not even stop to think, "I am", nor does it stop to think, "I wish to continue being what I am." The insect simply IS, and moves and experiences until it no longer can experience. The nerves react to the energies which stimulate the nerves, but the insects do not experience terror or fear as in the sense of higher evolved beings.

Likewise, even those beings of higher evolution are much more capable of accepting torture, pain and death if they are unconscious of higher spiritual vibrations and energies, for their own unconsciousness is such that they do not perceive or think abstractly about death, about pain; they simply experience these actions.

However, this does not mean that the entities do not feel pain as violently as others, but that they do not feel the broad consequences or intense meaning of life, of change, of death, of terror, of uncertainties if they are essentially unconscious of these concepts; they react instinctively through the unconscious process, rather than from an awareness of what is occurring to them in a conscious way. That there are some higher animals whose consciousness has evolved to such a degree that they know consciously when they are about to be slaughtered or when they are in great danger. These beings are close, indeed, to the level of consciousness of humans.

Likewise, there are humans who allow their consciousness to become so stupefied that they do not perceive when they are endangering themselves or are endangered by others, and therefore these entities are, in a sense, less aware than are some animals who recognize they are about to be slaughtered.

This Awareness indicates that these levels of consciousness tend to vary with different entities of each species, regardless of the level of development of the particular species on the scale of evolution. There are, for example, certain insects which may recognize danger and seek to escape; there are also certain highly evolved beings who are involved in situations which are dangerous, but who have allowed themselves to become so deadened through insensitivity or some form of stupefying drugs or other influences that they cannot move and cannot even seek to escape the danger.

That in all of these various experiences of Spirit, the degree of awareness will determine the reaction of the being, whether the reaction is from a conscious level or an unconscious level, or from a superconscious level, and to what degree of consciousness is involved. That there are those of the superconscious level who recognize also the nature of Spirit and who can move through the transition of death or pain without resistance or terror, and therefore appear in consciousness to be immune to these things.

When to Respect Insects, Plants, Animals

That in terms of treating animals, insects, birds and other living creatures, in terms of relationship with these creatures and with plants, this Awareness asks only that you respect all of life for what it is, and that you respect more importantly those forms of life which give benefit to other forms of life, which in turn, give benefit to still other forms of life. That wherein creatures do not benefit other forms of life, but violate other forms of life, it is not essential that these creatures, whether insect, plant or small animal or fowl, be given such respect.

Liberating the Spirit of the Spider

For example, the spider whose bite can kill a young child, this creature needs not the preservation and respect and sympathy which one might give to another creature such as a kitten, a dog, a rabbit, goat, sheep or calf. That the spider, although having a spirit, being such that its demise only liberates the spirit from an unwanted, a disrespected, a type of form which is not useful to the majority of living creatures; therefore, to destroy a spider such as this, cannot be considered as error. That similarly, on the opposite scale, the human whose life is valuable to the welfare of others cannot be destroyed without great error from the destruction of that life.

That likewise, those whose lives can be redeemed, wherein there is the possibility of redemption of a life, whether of an animal or human, even though that life may be in error or having some difficulty, illness or some social or psychological maladjustment, wherein that life can potentially be redeemed, though the entity may be as dangerous and deadly as the black widow spider or some other poisonous creature, the taking of such a life is a greater error than that of taking the life of the insect or lower evolved creature.

Humans Criminals for Violating Nature?

This an Erroneous Concept

This Awareness indicates that all is relevant to the scale of development, the potential for redemption, the potential for benefit to the life scale, the potential value of each entity, each creature, each plant, each living thing to give service, benefits or sustenance, energy, or life of value and significance to other living creatures, which in turn, have some value on the scale of development. That wherein there are some entities who feel that the human creature is the greatest enemy of nature on the planet earth and that the human creature as being the criminal for its violation to the plants, animals and living creatures of the earth; and therefore, that of all creatures on earth, the human should be eliminated to allow the other natural beings to inhabit the earth with greater freedom,—this as an erroneous concept, not recognizing the place of the human creature on the scale of evolution. For even as these other creatures of nature pass up the scale, they must, at some point in their evolution, pass through these levels of consciousness which are familiar to the human creature, and must wrestle with the concepts which are part of the human nature, its evolution, including all of its social and political efforts, as the spirit of these creatures evolves and moves up the ladder of consciousness toward the superconscious levels. That essentially, with all of the error involved in human experiences, with all of its violations to other creatures, it still is a necessary step in the evolvement of the higher consciousness, and the consciousness of the lower evolved creatures must pass through the human experiences.

Onward to the Christ Consciousness or Evolve Backwards

There are many in the human experience whose consciousness is low, near that of animals. There are many animals whose consciousness surpasses certain levels of human consciousness, and some humans may find themselves reincarnating into bodies of animals as part of the regression of the evolutionary cycle of their spirit; while some animals may reach their final experience as an animal, and may move into the action of being a subconscious mind in a human, or in gradual movement toward being a conscious mind of a human.

Likewise, some conscious minds of humans may evolve to such a degree that they are capable of moving into that level of consciousness which is the superconscious being or the Christ Consciousness. That beyond this, there are the co-creative unions or conventions of superconscious minds which serve as group or cultural guides or Gods or unity forces to guide cultures and groups of entities; that the hierarchy of the Light Beings moves up the evolutionary pattern toward the central sun of the universal forces.

The Proper Course to Follow in Respect to Life Forms

This Awareness indicates that the action of the butterfly, the action of the moth, the action of all creatures is to move toward the Light of evolutionary development of certain portions of their own consciousness. That often, these creatures move in erroneous directions and move toward darkness, ignorance or error or toward the false light, and such creatures find themselves eventually being destroyed, even as those who seek the Light may be likewise destroyed; but the Spirit moves on, from being to being, from entity to entity, from creature to creature back toward the creator, or from the creator back toward the miniscule particle which comes to life for the first time and begins its long journey back.

This Awareness indicates that *It* does not wish to moralize on the taking of life by one portion of the creation over another portion of the creation, other than to suggest that entities love one another, and as you recognize the life-force and spiritual development occurring in creatures, whether above or below your status, and wherein you respect that life force in those creatures to such a degree that you wish to assist and help in their development, this is the proper course, and this will be beneficial for your own growth.

That wherein it becomes necessary to kill a virus in order to preserve a child or an animal, this is an action which is appropriate and necessary; for the greater evolvment is that which is the priority, and the lesser evolvment,--such as the insect or the virus, the bacteria or other small and lowly-developed creatures,--these are but brief lifetimes for these creatures,--one of many thousands or millions; and if that lifetime is cut in half by a higher being, it matters little in terms of consequences, for the being may then move on to a more highly evolved expression, or may simply appear again in another place to finish out the similar experience.

This Awareness indicates that in taking the life of butterflies, the greater harm is that the butterfly is not able to reproduce more of its own kind for entities to enjoy watching. But wherein you desire to capture the beauty of the butterfly, to still its life, but hold its form for others to observe, for yourself to enjoy, this is according to your own will and your own conscience is your only judge. Wherein you feel guilt for this, that guilt is your punishment. Wherein you feel no guilt and no remorse, that is your reward. Wherein you have a reason which satisfies your own mind in taking the life of the butterfly, this appears to have little consequence in terms of karmic energies, wherein these reasons are satisfactory to yourself.

How Guilt can Create a Karmic Pattern

However, wherein your mind becomes fixated on the significance of having taken the life of a butterfly, and wherein you perceive that act as an act of murder, and wherein you dwell on such an action for long periods of time and develop great feelings of guilt for this action, you will, indeed, eventually find yourself to have developed a karmic pattern within your psyche which requires of you that you suffer some form of punishment or repercussions for your action. That this is obviously, nothing more than an action of one's own mind creating a significance out of a simple action of taking the life of a butterfly.

That wherein one considers this as a killing or murdering of the butterfly, the karma may develop to cause much trouble to that entity. Wherein the entity considers this to be liberating the spirit from one incarnation as a butterfly to allow it to move on to another, the entity may feel that he or she has done a service for this insect, and therefore, has done some form of good karma which will bring a reward to the entity.

The Definition of Sin and How it Occurs

This Awareness indicates this as all being subjective, according to the entity's own rationalizing process, for this Awareness does not see any karmic law of the universe which would deny the being from taking the life of a butterfly, other than the law which asks that entities respect all life, be aware, be sensitive to what you are doing, and not to be unconscious once you become conscious of your action. That sin occurs when entities become conscious of error and continue acting in error, even though aware that the action is in error. That wherein entities unconsciously act in error, this may be mistake, this may be error, but it is not evil. The cat which catches the mouse, teases and tortures the mouse, is not evil; but the entity who catches the mouse, teases and tortures the mouse and is aware that the action is in error, and continues taking that action in error, this may be called an expression of evil action.

The degree of awareness is that which entities must consider when evaluating the deeds of others or of oneself; and the degree of evolution of creatures is that which also must be considered, and the usefulness and value and benefits and service of creatures,--whether plant, animal, fowl, reptilian or mammal,--this consideration of the usefulness, the benefits offered by these creatures for others, must also be considered when deciding on the value of life.

What Concerns Cosmic Awareness

This Awareness indicates that *It* is extremely displeased to see entities killing, torturing and harming one another. *It* is somewhat displeased to see entities killing, harming or torturing animals. *It* is less displeased in seeing entities killing, torturing and harming insects and the creatures of the lower scales of development; *It* recognizes the necessity for entities to kill and destroy certain of the harmful bacteria, insects or creatures which are harmful to other life forms.



This Awareness indicates *It* is somewhat amazed to see entities who can become extremely concerned and sensitive to the welfare and life of small plants, animals, flowers, creatures, pets, birds; yet, while loving such as these, go to their place of employment to build weapons, bombs, guns, or to plan for wars, violence, or to work in systems that support wars, violence or destruction to other people, other nations, other highly evolved beings. That this kind of consciousness,--which values the pet, the flower, the houseplant, the friendship of a dog, cat, horse or similar creatures above the lives of other human beings,--this as a concern to this Awareness.

(FOLLOW-UP QUESTION):

Awareness has given that there are real positive aspects when giving thanks and appreciation when picking a flower or harvesting food to eat. Is there a real negative effect if, when you're taking the life of this insect or fly, you're just angry at it or expressing hostility?

COSMIC AWARENESS:

This Awareness indicates that wherein an entity takes the life of a small creature, such as the flower or insect, and sends forth mental energy to that creature which is one of affection, love or blessing, that energy sent toward that creature merges with the energy being released by the entity's demise, as the energy of spirit leaves the body of the creature, and this enhances or increases the vibration rate of the spirit, to allow the spirit to move toward higher evolved levels of creation, which would be more beneficial to the higher evolved creatures. That wherein the human sends loving energy toward such a creation, that energy which is sent merges with the energy released from the death of the creature, and allows that energy to move toward some expression which will, in time, benefit the human, as the human moves through experiences.

Plucking a Rose with Love & How to Kill a Fly

For example, in picking a rose, the energy which the entity sends toward the rose as it is plucked: if this is plucked with love rather than hostility, the plant which gives forth this energy emanates a vibration which merges with the vibration sent by the entity, and this merging of energy then moves into

the atmosphere and eventually serves to feed other elements in the atmosphere, which in turn, return to the entity because of the vibration which is attached to the vibration of the entity who originally sent that energy to the plant, to the rose. Similarly, when an entity swats a fly and sends the vibration of hatred, that vibration will eventually return to the entity who expressed the hatred; that wherein the entity swats the fly with the concept of liberating that energy, so that the energy of the fly may move on to something more beneficial to other life forms, this allows the vibrations sent to be used for more beneficial purposes.

Releasing Hostility While Swatting the Fly

There also can be benefits in allowing some entities to express hostility toward the fly as a substitute for hostility which the entity may be holding toward others. For example, wherein an entity is hostile toward others in his environment or toward his occupation, the entity may find that swatting flies relieves much hostility; and therefore, with less hostility locked within the entity, the entity does not need to swat his boss or to attack those around him. That in this sense, some entities benefit by releasing their hostility on lower creatures, rather than on the object toward which they feel hostile.

Wherein an entity is truly aware, the entity may be discerning enough to release hostilities, or not to build up hostilities, but may still find it necessary to remove the fly, to swat the fly; and therefore, in destroying the fly, the entity may do so without emotion involved, and may simply do this as a necessary action to clean the area of the interruptions and the presence of the fly. When this occurs, the entity's attitude may be one of nonchalance or of a semi-pity for the fly, but recognition of the necessity that it is in the wrong place and must be removed and that this is the quickest and easiest way to remove the creature.

This Awareness indicates the entity may also recognize that the fly has very little 'going for it' in terms of its evolutionary movement; therefore, liberating the fly from the body, liberating the spirit of the fly from its body, is no great violation. This Awareness asks you: 'If you were caught in the body of a fly, would you object to someone liberating you from that incarnation?'

IF ALL ELEPHANTS & WHALES DIE OFF, HOW WOULD THIS AFFECT CONSCIOUSNESS?

(FOLLOW-UP QUESTION):

One question in relation to the evolution of spirit toward the Light: Awareness has indicated in the past that two of the very highly evolved creatures, namely the whale and the elephant, these are now on the endangered species list. In the event that these creatures will all be wiped out from this planet, what will happen to those lesser evolving forms below these creatures when they reach that point whereby their next evolutionary step would be into the whale or the elephant? Does it all stop there?

COSMIC AWARENESS:

This Awareness indicates that this could set back the level of consciousness on this planet a great deal; that the whale, the elephant and the porpoise and the dolphin, being highly evolved consciously, (along with the human) do have high spiritual and consciousness vibrations which emanate into the atmosphere, as well as into the planet itself, and assist in keeping poise, balance and harmony. The exception being some of the humans, who disrupt that poise, harmony and balance of the planet.

Wherein these creatures which emanate consciousness promoting such poise, harmony and balance in the aura of the earth, in the magnetic fields and patterns of the earth, these creatures, if destroyed, could well throw the earth's aura and magnetic fields into imbalance which would result in geophysical upheavals, disturbances of weather patterns and of the molecular cohesion in the very substance of matter itself, to such a degree that strong changes on the earth would occur which would be highly disruptive to the world, as presently known; this as already having effects, along with other influences, and as a contributing factor, to some degree, in the changes which are occurring on this planet. Particularly the dolphin, which is, in fact, more highly evolved than the human in terms of its consciousness levels.

The Cosmic Consciousness of the Dolphin

This Awareness indicates that the dolphin as having a consciousness level which is essentially Cosmic in nature and capable of creating miracles, such as storms or calm waters, such as intense seismic activities or peace, depending on its own will, and the channeling of spiritual energies through its consciousness. The dolphin as being one of several life forms through which the Elohi, the Elohim, the Els, communicate and channel energies into this plane, into the physical world, the dimension or realm known as Terrestria.

ANIMALS AS THERAPY

FOR CRIMINALS

(FOLLOW-UP QUESTION):

I saw on TV a therapy used in a mental or criminal institution using animals to give the inmates something to care about. Would this be a universal therapy; and does it, or how does it, relate to the evolutionary development of those involved?

COSMIC AWARENESS:

This Awareness indicates this can be of extreme value in assisting entities whose consciousness and sensitivities have been so disrupted, that their own capability of clear relationship with human entities is damaged or impossible. That wherein an entity cannot relate to another human, the entity may, indeed, be capable of relating to a small animal which is placed in his or her care. When this occurs, it is the beginning of training for relationships of a higher nature, and can be of great value in assisting these entities to grow and develop a social consciousness and sensitivity.

WHY DO ENTITIES HAVE EMOTIONS?

QUESTION:

Why are people so constructed emotionally?
Why do we have to have these emotions?

COSMIC AWARENESS:

Suggested that there was mentioned in those ancient books of the dead the division, the tearing asunder of that entity that was Apep, and that this ancient divinity was that which was later considered the Evil One, the Satan, or the Alien Force. That when this entity was torn asunder, that this symbolic rendering has created all those parts that this Awareness has referred to as error, as disease, as difficulty, and that these parts are yet within the minds and bodies of entities at this time as well as in the past and in those days that shall be. That entities are thus constructed through the separation they effected from this Awareness at that time when individual souls were created, and that this implicit weakness is that which reminds entities of the necessity of joining that which is the complete and whole body of that inner divinity which is also involved, not torn asunder,—that of the objective mind force, or God, which has been referred to as AMEN RA.

THE CAUSE AND CURE OF MOTION SICKNESS

QUESTION:

A question from M.S., of Gulfport, Mississippi, who would like to know: "What causes motion sickness, and how can it be prevented, and what can be done for it when you have it?"

COSMIC AWARENESS:

This Awareness indicates this generally is caused by some aspect of the psyche refusing to move with the external forces which are moving the body,—this such as resisting the movement and flow of the energies. That wherein one aspect of the consciousness seeks to hold the energies still and resists against the motion of the energies; this creates a sense of panic or fear in the subconscious level, and results in a kind of nausea.

It is sufficient for an entity to pick a spot which is stable, such as the horizon of a sea, and even though the ship is moving and the waves are causing great motion, the entity can fix his or her vision on some stable action and consciously allow the body to move around while identifying with that stable point, thus feeling in tune with the stable point while not resisting the movement. This can also occur even when there is no stable point in sight, by the entity simply looking at a point such as on a ship, wherein the point moves up and down or back and forth, and the entity can move with that point; that this gives the entity a sense of stability by identifying with that point, rather than a feeling of being out of control and unable to stop the movement. It is this feeling of being out of control and unable to stop the movement and desiring to stop such movement that creates the resistance which leads to the nausea.

(FOLLOW-UP QUESTION):

Awareness, I've never been able to get on a boat of any size on the ocean swells without getting deathly seasick, particularly after crossing the bar at Westport or on the Columbia at Astoria while fishing for salmon. My mother had told me when I was a little boy that the spirits told her that for most people, and specifically myself, that this seasickness was a warning to stay off of the ocean. (It just occurred to me that it might have been *this very suggestion* that created my seasick problem). Is there any truth to her theory. If so, would that apply to seasickness in general?

COSMIC AWARENESS:

This Awareness indicates that essentially, there are some entities who have the psychological makeup who simply require stability,—not only in terms of their social, financial, and emotional life, but also in terms of their physical vehicle. That others enjoy the flight of energy and enjoy sailing in fantasy, in emotion, in social affairs, and in physical experiences, and such entities will pick the air or water as experiences for physical flight, and are not psychologically upset by instability. That often this instability is enjoyable to such entities.

On the other hand, some entities have a fear of instability which reaches back into previous lifetimes in which they were terrified at the loss of the foundation on which they stood,—this symbolic or real,—and this terror of this previous experience still lingers in present life and, in fact, can also serve as a forewarning to avoid instances which might again create the instance or experience of instability. That wherein an entity, having experienced such things previously in other lifetimes, the entity is also inclined to re-experience such events in present lifetime; for there is a tendency of the psyche to have recurring experiences. Therefore, in this sense, your mother was correct in warning you against the action of sailing upon the sea, for there can be certain dangers, except when the psyche has been prepared and cleansed of these past memories which tend to have an unconscious effect upon you.

This Awareness indicates that as a New Age sailor, as an ancient mariner in the Sea of Consciousness, there appears to be no problem in terms of your ability to sail through these waters of time and space in this Passage Perilous, and the other experiences. That in the event that a trip upon the sea becomes necessary, (this the physical water), that you may wish to first recall previous experiences of past life situations wherein you became terrified from the circumstances of that life experience. The recollection then as that which can release the energies to prevent further effects from surfacing during your present life voyage upon physical waters.

(FOLLOW-UP QUESTION):

Is there a practical way an entity can recollect a past life for a specific reason, such as Awareness just suggested?

COSMIC AWARENESS:

This Awareness indicates that there are a number of different activities and methods whereby entities can recollect past life experiences. However, that in this particular reading, it would be very time-consuming to attempt to discuss these, and the energy levels are not presently sufficient for this. That this may be discussed in further questioning.

HOW TO OVERCOME FEAR:

AN EXERCISE FOR SEA SICKNESS AND FOR THE FEAR OF FALLING

(FOLLOW-UP QUESTION):

Would this same method be the one to use in application of a severe fear of falling from high places?

COSMIC AWARENESS:

This Awareness indicates this in the affirmative. That essentially, wherein entities have a fear of anything, it often is a reflection of previous lifetime experiences or something influencing them in this present lifetime to have that fear. That wherein this occurs, one of the simplest methods for helping to diminish that fear is to simply put yourself into a position of relaxation, and either through your own imaging or with someone else describing the imaging for you, move through the very experience which you fear. In moving through this experience in your imagination, attempt to feel all of the fear and terror which you would normally expect

to fear if it were actually happening.

For example, the one entity should attempt to move through an imaginary trip upon a boat which is in churning waters, moving up and down, up and down, back and forth, in a kind of terrifying dance upon these waters which are out of control, and imagine this for as long as it contains any significant energies, until it becomes fun. That likewise, the entity having the fear of falling may, through imagination, visualize oneself hanging by a thread or rope over a cliff, and finally realizing that he or she is unable to climb the rope and it is simply much easier to fall; and in this action, imagine yourself considering, "Well, if I'm going to fall, I might as well have one great time of it and really enjoy the trip." That in that split moment of decision, you then imagine yourself as a bird, falling, falling...and in that flight, reaching the heights of ecstasy. That if this is not sufficient to rid yourself of the fear, that you repeat this action again and again.

This Awareness indicates however, that there is certain value in certain types of fear, so long as these are not problem-causing fears. That entities should, in fact, be afraid of drowning; entities should, in fact, be afraid of falling from high places,--but if those fears become unwarranted or extreme when there is no danger, or the danger is so minimal as not to be of any real logical concern, but does have an intense effect on one's emotions, then the entity needs to work with that emotional quality; for when one's emotions have a fear that is unfounded, then the emotions are, in fact, out of control and can cause problems which may be just as dangerous as the danger in reality, or can cause the entity to build up so many different fears as to become one who is incapable of normal experiences without being terrified at every turn.

That essentially, fears not based on logic or clear discernment, but based on emotion,--fears such as this tend to devitalize one's energies; and when these fears are unlocked, entities find themselves having greater energy and vitality for creative purposes. That essentially, the Aquarian Church is presently preparing to put to test the concepts which many of the Awareness readings have presented, and putting these into a structured program to be presented when the *Relationship* is launched, wherein entities desiring to re-experience past life blocks or circumstances, or wherein entities seeking to discover more about their own deeper self, may have the opportunity through this system to tune in to these energies and unlock the forces within themselves. That this program to be presented through the *Relationship* will be prepared in such a manner that various groups can use the system to assist in such depth psychology; this being one wherein the individual applies the techniques to oneself, with some assistance from others involved in the process, but one which is likened unto self-discovery through the probing of one's feelings and these points within the psyche which have crystallized around experiences of the past.

Now He Belongs to the Ages

Richard Nixon's Presidency, as summed up by Watergate conspirator E. Howard Hunt in an interview with the *Herald-Tribune* of Sarasota, Florida: "The principal achievement of his Administration was that he avoided going to prison and he walked off with an awful lot of booty."

QUESTION:

Jack Anderson has been running a series of articles on the South Pole, and I'd like to ask Awareness if It can reveal what exactly is going on there. I'll read a little bit of one of these:

"In a development that gives literal meaning to the phrase 'cold war', President Reagan's intelligence advisors have warned that the Soviet Union may take the top position at the bottom of the world. A classified report, now under review by the National Security Council warns that the United States is in danger of losing its leading role at the South Pole, just when decades of investment might begin to pay off.

"In recent years, the scientific research, mostly by Americans and Russians acting independently, has revealed that there's a lot more to Antarctica than penguins and paralyzing cold. The continent could be another Alaska in the value of its natural resources. For example, Antarctica has been found to have huge beds of Krill, a shrimp-like species that may well be the world's richest marine protein resource, an important consideration for a country like the Soviet Union, whose agriculture routinely fails to meet the demands of its huge population.

"Antarctica is also known to have oil underneath all that ice. Some experts suspect it has more than Alaska, and scientific studies indicate that minerals are abundant. But now, top secret CIA and National Security reports an exhaustive review by 14 agency Antarctic policy group that in part, documents note that the Soviet Union's presence on the frozen continent has increased greatly in recent years. The Russians now have eight bases in Antarctica to our four, though the US scientists are still ahead in research."

It goes on to say that under the Reagan economic program they are cutting funds to the point that it looks like the United States will have to abandon its research center there, and that the Russians will take it physically over. I'd like to ask Awareness to comment on what exactly is going on at the South Pole?

COSMIC AWARENESS:

This Awareness indicates this as largely research as indicated in the article. There also are research projects in areas of magnetism and in relation to more subtle physical...this in terms of physics and in terms of testing and using instruments of measurement for exploring the forces of the earth and the atmosphere, as associated with the poles.

This Awareness indicates that the greater activities center around exploration for minerals and food and for securing a lifestyle in the area; the research into what would be required for establishing bases of operations in those areas.

(FOLLOW-UP QUESTION):

Then the Soviet presence up there has nothing to do with the entrance to the Middle Earth that's supposed to be up there?

COSMIC AWARENESS:

This Awareness indicates that this as also a significant factor, but this Awareness does not wish to go into this area at this time.

THE "HEALING CRISIS" WHEN FASTING OR USING A CRASH PROGRAM

(MORE ON MAGNETISM)

QUESTION:

M.G. of Winnipeg, Manitoba asks: "Would the simultaneous use of the magnets, the TDK necklace, D-Cells, Polarizer, and negative ionizers have any type of conflicting or cumulative effects as to be harmful to the physical, etheric, or mental bodies? All studies mentioned so far in your articles are individual assessments."

COSMIC AWARENESS:

This Awareness indicates this as negative, that these are essentially complementary to one another.

QUESTION:

J.B. of North Carolina, returned a magnetic necklace, saying, "I'm sorry, but this necklace has had bad effects for us. My wife is allergic to the metal, and I end up with a sore throat when I use it." I'd like to ask Awareness if it was the magnetic necklace that was responsible for these conditions?

COSMIC AWARENESS:

This Awareness indicates that this appears to be correct, that the entity as being allergic to the metal on her skin. In terms of the sore throat, it appears that this has an effect which was beginning to assist in the elimination of certain toxins within the entity's system, and this as affecting through the glandular release of these toxins, creating a sore throat; that this as a symptom of the type of healing known as the "healing crisis," wherein one becomes ill as the healing occurs. That for those who prefer not to experience such critical healings, that often slower methods are available. Such healing crisis takes place also for some entities when indulging in a fast—that the fasting creates a release of toxins which leads to temporary illness, and entities often prefer to follow through this illness and receive maximum healing; others prefer to move more cautiously, without experiencing the illness.

This Awareness suggests that it is important for entities to be sensitive to their own capabilities; for in some instances, entities have passed through healing crisis and become overly ill by releasing too many toxins too fast. In some instances, entities have died from such intense healing crisis. That in this particular case, this entity was affected by these energies and a healing crisis began to manifest. Suggested that this appears to be a rare effect from this device, as being unusual for it to have such powerful effects on an entity; that normally entities would not experience this type of reaction. This Awareness suggests that the entity would benefit more by wearing this on occasion, such as 30 minutes daily, or even 15 minutes daily.

This Awareness suggests that entities receiving this type of device may prefer to experiment with the timing to determine whether it is having any adverse effects; that in most instances there will not be such effects, but it can be advisable for most entities to remove the device at least part of the time, such as each day or each night, rather than using this as a permanent attachment to the body.

QUESTION:

A final question on magnets from L.D., of Foley, Minnesota: "There has been a great deal said about the effects of magnetism. Would a solid magnet in the shape of a pyramid be more powerful than an ordinary magnet? Also, can magnets be used to alter the state of consciousness?"

COSMIC AWARENESS:

This in the affirmative.

QUESTION:

I still have one question in relation to wearing the magnetic necklace when using the Polarizer; Does the field the Polarizer puts out have any effect on the standard magnets?

COSMIC AWARENESS:

This Awareness indicates this as a temporary effect; however, this may be removed during such times. That the effect of the Polarizer as no more harmful to the necklace magnets than would be experienced by any magnet coming in contact with another magnet; that the poles will either be attracted or repelled, depending on their polarities. In terms of the magnetic effects on the body, that this is negligible in this circumstance. However, entities may remove those necklaces to have a more even flow of polarization.

THE LAW OF UNITY



IS GOD REALLY ON YOUR SIDE? ...

IF YOU LIVE A GOOD AND SPIRITUAL LIFE, WILL YOU SURVIVE WAR AND HOLOCAUST?

(HOW DID 8 PEOPLE SURVIVE HIROSHIMA'S BLAST?)

QUESTION:

One of our members in England, Patricia of the Axminster Light Center, sent a copy of her newsletter which quoted from another newsletter in England called the *Solar Age Pathfinder*, and it brings up an interesting question. I'll read the quotation:

"In the Bible we are told that Lot was warned to leave his home area before Sodom and Gomorrah were destroyed by fire and brimstone; but where could one fly to in the event of a major polar shift, a cataclysm not uncommon in the history of the earth, or will those of us 'living truly' be saved by Divine Intervention?"

"For example, when the atomic bomb destroyed Hiroshima in 1945, eight men living near the blinding center of the nuclear flash miraculously survived the searing hurricane, a blast of gamma rays, while everyone within a mile radius perished, and others residing further afield continued to die from the lethal effects of radiation. For over 30 years, some 200 scientists have examined these 8 men, trying to determine in vain what could have preserved them from incineration.

"One of the survivors, Father H. Schifner, SJ, gave the dramatic answer on television in America: 'In that house we were living the message of Fatima.' "

Could Awareness explain why or how these entities survived while practically at the center of blast? Is this Father Schifner's explanation the correct one?

COSMIC AWARENESS:

This Awareness indicates that essentially, the blast occurred in a manner which blew upward and over these entities, and then out and along the ground for a mile radius. They appear to have been in a kind of pocket or vacuum in which the blast did not actually strike; as the explosion and cloud mushroomed, there was a pocket in which this explosion avoided hitting these entities; this in part due to a deflection from material near the explosion, causing the energies to move up and over these entities; this being more of a coincidence or accident than a miracle.

This Awareness indicates that in the event of a polar shift, or nuclear war, in the event of atomic blasts or great holocausts, earthquakes or other types of devastation, storms and so forth, the fact that one is living a good and spiritual life does not guarantee the entity will be safe, for Hiroshima was a Christian city moreso than any other in Japan. That it is not a fact that living a good and spiritual life is an insurance policy against hazards of the earth, but living a good and spiritual life *can* guarantee greater happiness on earth while living, and can guarantee greater happiness in afterlife experiences; that essentially, living a good and spiritual life is its own reward, for entities who fail to live a good and spiritual life are generally unhappy in many ways, and will find according to their error, greater and greater unhappiness, to the degree of error which they create; for guilt and repercussions for the errors which entities experience always follow and

drag the entity into greater suffering. This is the *Law of Karma*.

It is suggested that entities who would like to think that because they live a good and spiritual life that there is some kind of guarantee for them that others would not have in the event of a crisis; that this is totally unfounded. That it is often heard by survivors of storms and survivors of critical chaotic experiences that they prayed during the storm, and God answered their prayers, and this becomes, to listeners, evidence of the power of prayer.

This Awareness indicates however, that there is no way to measure how many of those who perished in the storm or chaotic condition prayed equally hard, or perhaps lived even more spiritually up to the time of the storm, because these entities aren't around to tell that their prayers were unanswered and they died in the storm. That likewise, there is no way to measure how many entities who died in chaotic conditions, wars and violence, might have been saints and might have been extremely great and wonderful people in their future experiences had it not been for the storm or chaotic conditioning taking their lives prematurely.

An Action of Ego: 'God is on my side!'

It is generally assumed, because entities like to believe that way, that the survivor is lucky or has God on his or her side, because it justifies the belief that survival of a storm was because of a 'Higher Power', or alignment and attunement to a Higher Power, which is an implication that the one who survived was somehow superior to the one who died. This is not always the case, even though the entity survives and claims to be closer aligned with the Divine, and uses survival as proof of that. That this is actually an action of ego.

That the ego likes to make claims for every event that shows the entity to be superior in some way, and since the entity's own capacity to survive, personal effort to survive, was not part of the survival process, the entity must make ego claims by showing that he or she was aligned with God, and God intervened against the storm or chaos to allow the entity to survive. That this is not necessarily fact. It may be nothing more than the entity's ego, or an attempt of the rational mind to make some kind of logical explanation for something which happens only as chance; the chance that the entity was in the right place to survive, while another entity who may have had greater strength, greater spiritual strength, greater understanding, greater wisdom, greater expression of his life, who might have given greater service to others, perished in the storm.

This Awareness indicates that it is alright for entities to thus justify their survival, but *It* suggests that entities recognize that this is not necessarily so. That in reference to future conditions, chaotic conditions that may occur, entities should be aware that your future is not guaranteed simply because you are a good person, but this Awareness suggest that you recognize, even though life is temporal, even though your life may have its fate and destiny, and even though you may be destined to live another 20, 40, 60, or 100 years, and even though you may live a good and harmonious life, it is not necessarily guaranteed that this future life is occurring because you are particularly good, nor is it guaranteed that

in the event of war or crisis, that you would survive past that allotted time for your own personal destiny.

This Awareness indicates that even your allotted time is not necessarily guaranteed, for you may cut this short, or speed up your demise by failing to follow your destiny and path. However, you may also extend your time on earth by altering the destiny you have chosen toward another path more beneficial to longer life. Essentially, the destiny you choose is the destiny that follows for you.

AN UPDATE ON THE WEATHER MODIFICATION PROGRAMS

QUESTION:

Awareness, reports by scientists indicate the phenomenon known as El Nino is ending. El Nino is supposedly the cause of the bizarre weather we are having, but Awareness has said that it is merely a symptom and not a cause. That the cause is the Russian weather modification techniques now currently in use.

Because El Nino appears to be abating (the razor clams on our beaches, for example, are starting to return), can we assume that the Russians are slacking off in this area? With the heatwave last summer, the various draughts, and the strange and unusual weather experienced just this winter here in the United States, it doesn't look like it's over yet. Could Awareness please comment on the recent weather, and about using El Nino reports as a guide to Soviet weather modification activity?

COSMIC AWARENESS:

This Awareness suggests that you also note that the United States and Soviet Union signed a treaty to allow the sale of wheat to the Soviet Union for the next several years; that you will remember that it was at the time the Carter administration stopped the sale of wheat to the Soviet Union that the weather modification programs began. However, it does appear that the unusual weather extremes will be curtailed; that there is however, a change in the weather patterns. The jetstreams having altered their course, are not seen as coming back into the previous patterns, but rather there are seen changes which allow certain areas to have weather patterns that have not been historically common. For example, there is seen more wet weather in the area of California for several years to come; that there is also seen drier weather in the Pacific Northwest than has been common. There is seen a balancing out of the extremes in the Eastern states, a balancing of the extremes in the sense of the extremes of the past several years. That this is in reference to the United States which has had the greater effect, which has received the greater effect of this weather war; that in other countries there have been some effects also, but not to the extreme as in the United States.

This Awareness indicates that the Russian weather as that which these entities wish to keep and preserve in the level which it has enjoyed during the past year

wherein there has been much prosperity in the agricultural areas, and the weather has been unusually pleasant. That rather than directing the weather program toward a punishment of the United States, the Russians can be expected to desire to keep their weather comfortable, even if it does not allow conditions to return to normal elsewhere. That this is a shift in the weather modification program, although it does not completely end the weather modification programs; that rather than attacking the United States with weather modification, the Russians appear to be planning to simply improve their own conditions, and if that improvement adversely affects other countries, this would not hinder their efforts to improve their own.

WILL WE ALL BE CASTRATED CHEMICALLY BY THE DRUG DEPO-PROVERA ?

(MORE ON GLOBAL 2000)

QUESTION:

A question from D.A. "A drug called Depo-provera is now being injected into mentally retarded people in institutions, and sex offenders in prisons as a condition for probation. The drug was used as an injectable contraceptive in Europe and elsewhere. It was not approved for the United States because it was found to cause cancer in lab animals. It is now being used to change the hormonal balance and lower the sex-drive.

"The drug is a female hormone that causes men to become more mellow, relaxed and nonaggressive." His question is: "Is this part of a population control program that is being tested on prisoners, or a part of the Global 2000 program (people without sex-drives don't produce), or are the Skoptsis behind this as a form of chemical castration for the masses? Are they planning to administer this on a mass basis, possibly through the water-supply in order to defertilize the masses as a part of Global 2000."

COSMIC AWARENESS:

This Awareness indicates that this is negative; that essentially the drug as that which is in experimental stage and which has been found to be effective in rendering certain types less volatile in the social sense; that it therefore is used as an experiment in dealing with entities who are socially hard to handle. That the continued testing and research into chemical combinations, creating drugs that have their psychological effects upon entities, this as that which does and can and *may* be used in programs of all types of social control and for various purposes. These drugs being classified so that if there is a need for or plan to diminish population through the use of drugs, the classification of the various drugs available would be considered, and looked at as to determining which of these drugs would be used for this purpose. However, that in terms of this specific drug being designed and used for this purpose, or intended for this purpose, this is negative, although it *could* be considered if that scenario should come into play in the future plans.

OH, LADIES...ARE YOU WEARING RADIOACTIVE JEWELRY ?

(MORE ON THE STOLEN FT. KNOX GOLD)

QUESTION:

A question from D.M., of Ridgecrest, California.
"A while back I asked a question about the possibility that the radioactive Fort Knox gold being circulated and causing the Biblical prediction that gold would cause canker sores to come true. Well, a few month later, radioactive jewelry was sold in our country which was coming from a place in the Orient; it therefore was being recalled." He'd like to ask Awareness: "Is this radioactive jewelry that was recalled originate at Fort Knox?"

COSMIC AWARENESS:

This Awareness indicates this as in the negative; that this information as that which has two sides; that in one aspect, this is in the affirmative. There is seen metals that have been used in jewelry which are radioactive: this in reference to the metal gold; that also there are certain semiprecious jewels, gems which have been used in jewelry which are radioactive. That the gold radiation as that which is associated with that from Fort Knox...that this as a small amount of gold from Fort Knox; that this does not appear to be any large amount.

That in terms of the gems, there is seen a system whereby gems are colored, given greater coloring, as though aged by several million years, by a process using radiation, thus giving these gems greater value by causing the gems to become more colored and colorful through the use of radiation; that this creates a dangerous condition for those who are exposed to these gems.

There is however, a recognition of this danger and the importation of these gems is that which is being watched carefully. Wherein entities have any doubts about their gems, this should be checked with a Geiger counter or with authorities who can check the radiation level.

In terms of the gold from Fort Knox that is allegedly radiated from the plutonium placed in the central core as indicated by Dr. Beter, that this as a very small amount of radiation and from gold which was left in the Fort after the removal of the greater portion of gold; that the plutonium was not placed in this fort until much later, after the removal of the greater portion; that there was a small amount of gold left in the fort which has a degree of radiation as the plutonium nearby has had an effect on this; that this was not in the same vault as the plutonium.

QUESTION:

What is the place of personal love in the life of a person who has reached full Cosmic Awareness?

COSMIC AWARENESS:

Indicated that it is non-existent; that love in its physical, emotional, and spiritual manifestation for those who are aware does never identify with one personality or another, but with all. That those who are aware and who reached higher states of consciousness love the beggar, the child who is ill, the old man and woman who are departing for a long journey, as well as the fair-haired youth or the beautiful maiden.

WILL THE PYRAMID D-CELL PRODUCE VIVID AND REMEMBERED DREAMS ?

QUESTION:

In a letter to Vicki, J.W. mentions the following:
"The pyramid D-Cell really works as far as dreams. I have very vivid dreams almost every night, easily remembered. I really, really like it. Some of the dreams have been easily interpreted and very meaningful." I'd like to ask Awareness if this is an exceptional case, or would the pyramid D-Cell work for other entities in the area of dreams?

COSMIC AWARENESS:

This Awareness indicates that this appears to be valuable for many entities in this respect; however, it does not appear to be universal in this effect; that some entities will receive benefits, while others may receive none from using this in this manner. It appears that some entities will sleep more restfully, others will have more vivid dreams, others will experience healing energies through the use of this, and others may experience nothing.

This Awareness suggests the letter from this entity be forwarded to Joe Sloan for his records and further research. Also, entities wishing to obtain Kirlian photographs of S-Cell, D-Cell and Pyramid-Cell energized water droplets should be given the opportunity to obtain these colored photographs through new techniques of color Xerox machines at a reasonable price. That this Kirlian photography showing the aura around each of these droplets of water, can serve as excellent sensual data for entities who wish to prove the value of the D-Cell and S-Cell and the effects on water.
