

## HOW CAN WE DEVELOP THE FAITH TO HEAL BROKEN BONES, CANCERS, ETC ?

### ( CAN WE DUPLICATE THE MIRACLES OF JESUS ? )

#### QUESTION:

A question from K.G. of Chicago. "Does Awareness have a technique to develop faith? We saw a lady, a Christian lady, create gold and platinum fillings in teeth and heal bones in people. She generated tremendous energy and since such energy is from Awareness, please inquire as to how we as C.A.C. people might also generate this healing energy in a narrow, concentrated form to materialize objects, to heal immediately broken bones, to dissolve cancers, all in the name of God? How are we lacking? How can we surrender enough to do these things? Should we devote more and more time to prayer and meditation? Thank you very much."

#### COSMIC AWARENESS:

This Awareness indicates that much of the technique involved in this is given in the Scorpio Correspondence Lessons; that this also available through the Huna philosophy which explains the secret science behind miracles; that essentially, this as an action which requires more than faith alone. This Awareness indicates that it also requires that the entity have a clear channel to the Christ Light, the Christ Consciousness, the High Self, or whatever name one chooses to call that which is known as the Father in Heaven.

This Awareness indicates that essentially, the entities are composed of three basic selves: the subconscious, conscious, and superconscious; or that which may be called the Son of God as the conscious, the Holy Ghost as the subconscious, and the Father in Heaven as the superconscious; that these having a certain correspondence with other religious terminologies regarding the concept of Trinities; that essentially, this will be explained in greater detail in the Scorpio Correspondence Lessons on magic.

However, the secret in regards to the method of healing bones and creating with one's High Self is to have perfect rapport with all three selves. The conscious mind giving energy, through mana, passing through the subconscious, which has contact with the superconscious or the Christ Consciousness,-- that this as a channel which needs to be cleared from any forms of blocks or, as described in various terminologies, tangles, fixations, engrams or obsessions or compulsions which are of a repressive nature to the subconscious.

This Awareness indicates that any of these actions within the subconscious that serves as a knot, a tangle, or what is often referred to as a 'demon', or feeling of guilt or traumatic experience,--all of these are blocks in the communication between the subconscious and the superconscious, or in the Huna terminology, between the low self and the High Self; that essentially the middle self, the conscious mind, must send its energies and requests through the low self to the High Self.

This Awareness indicates that there are the common, lesser miracles performed by the low self, or the subconscious mind, which are basically already understood in many areas of human research,--this in levels of hypnosis, in certain types of self-help books and techniques; this includes various types of activities to assist one in recalling the details of past experiences, of past occurrences or past circumstances, either in this life or another. This also includes communications such as clairvoyance, clairaudience and the telepathy between entities.

This Awareness indicates that the high miracles that go beyond the work of the subconscious mind, include more than the normal types of healing techniques of the subconscious or the communicative techniques of the subconscious, and move into those types of magic which are not understood well on this plane. This includes such things as levitation and the instant healing techniques and healing at a distance. This also can include such things as instant healing from laying on of hands, and those which were spoken of in the question.

#### The Basic Secrets Behind Miracles

This Awareness suggests that briefly, the review of the total concept of magic in reference to the Scorpio Correspondence Lessons will be necessary to understand the basics of magic; but along with this, this Awareness will now present the essentials for entities to basically understand the means by which broken bones may be healed and other similar miraculous healings may occur.

This Awareness indicates that first, the conscious and subconscious must be working in harmony. The subconscious must also be in touch with the superconscious. The channels between each of these must be open. Mana, the magnetic energy from the subconscious, must be made available to the conscious mind, and the conscious mind must

have a will that is strong enough to direct the mana, or magnetic energies, to the superconscious, through the subconscious and its channels which lead upward to the superconscious. That then, this mana may be stored for use by the superconscious. This Awareness indicates this occurs as the conscious mind sends appreciation, worship, attention and energy to the superconscious, through the subconscious. This Awareness indicates that the use of will to send this energy to the superconscious is such that it speeds up the magnetic current, the mana, and creates a different type of energy which, upon reaching the superconscious, is again stepped-up to higher vibratory levels.

Explaining the term "mana"

This Awareness wishes at this time to explain the term mana as used. That the terms for this being mana for the low self, m-a-n-a,--mana mana for the middle self, or in modern terms this describing the word m-a-n, meaning mind,--and manna, m-a-n-a, describing the third type of manna of that of the High Self. This Awareness indicates that the low mana as that which is the magnetic field of energy, the aura around an entity which gives the vital force to the entity's body. This Awareness indicates the mana mana, or the mana squared, may be recognized as the vital force put into motion or directed by will or thought in the symbolic language which this Awareness has given. Directed thinking equates to this type of mana. This Awareness indicates that the High Manna as that which this Awareness has referred to as electro-magnetic energy,

This Awareness indicates that the understanding of the three selves, the understanding of the three types of mana, are essential in understanding how the magic works. This Awareness indicates however, that entities can effect the magic without fully understanding how they are doing this; and in some cases, entities become open channels for miracles, but cannot explain how it happens other than with words such as 'faith',--faith in God or some other deity.

This Awareness indicates that *It* does not intend to thoroughly review all of the material given previously in the Scorpio Correspondence Lessons on magic, but suggests that entities thoroughly understand this part before proceeding with the desire and pursuit of high magic, as is indicated here.

This Awareness indicates that essentially, once the High Manna has been fed to the High Self or the Christ Consciousness, the Light, or the Father in Heaven,--whichever terms the entity wishes to use; or, if entities prefer to use the word 'Jesus', that is in many cases even more beneficial, because the subconscious is more cooperative with this word for some entities. That whatever the title entities wish to give to the High Self, this, along with the surcharge of manna, or magnetic energy which is sent through the low self, through channels to the High Self, and is made up from breath, food, and will to serve; This energy, upon reaching the High

Self, can then be directed by the High Self toward the area which has been injured or damaged.

### How to Heal a Broken Bone

This Awareness indicates that in the case of a broken bone, the image which is visualized by the High Self or the Christ Consciousness, is to look at the broken bone only briefly, and to transmute, in the conceptual level, the energies of the broken bone, so that it is not looked at in a physical sense, but is seen in the etheric sense as a complete bone, without a break.

This Awareness indicates that to do this, the entity must see an imaginary bone, or that which may be called the image of a bone which has been cracked or broken, but whereby the bone changes from physical to an etheric image with cracks in it, and then is restored to the proper shape in the etheric level, and then given an extremely strong charge of the stored-up high manna, this manna being blue in color and held by the High Self or the Christ Consciousness. That therefore, the image is what the entity is working with, and when this image is filled with the Christ Consciousness manna, the healing power of the Christ Consciousness, then it may be brought back into the physical experience, the physical reality.

This Awareness indicates that all of the healing process is created, not in dealing with the physical bone itself, but in dealing with the image in an etheric level. This Awareness suggests that in another sense, if you can image the healed bone and fill that image with High Manna, then the healing occurs instantly, or to the degree of your ability to follow this direction. This Awareness indicates that in some cases, entities may not have the full capability of instant healing; but even so, following this direction will allow the speed-up of any healing of the bone. This Awareness indicates that as entities practice more and more doing this type of healing, the faith increases, and the ability to direct such energies increase.

This Awareness indicates that in terms of the healing force coming from the Christ Consciousness, rather than from one's own personal will; this occurs when the entity's personal will is set aside, or given over to the Christ Consciousness. This Awareness suggests that in order to effect such an instantaneous miracle or miraculous healing, an entity must let go of personal identification and personal will, and give up one's will to the Christ Consciousness, becoming but a tool or an agent to assist in the imaging process,--imaging the complete, totally-healed bone.

### The Importance of the Seed-Image

This Awareness indicates that if doubt interferes, and the entity includes within that imaging process a recollection of the broken bone or a recollection or restatement of the broken bone, the action will not be successful. For example, should the entity say, "Please heal this broken bone," the entity is including within the prayer and the image the break

of the bone. This Awareness indicates that therefore, the seed-thought being sent to the Christ Consciousness contains the flaw within the seed, the flaw being "the broken bone" or the break within the bone. This Awareness indicates that the prayer and the seed-image must not contain the flaw which you wish to rid yourself of; therefore, the prayer must be spoken in a totally different way,—the seed-image must be seen totally different. The prayer may be spoken: "Please make this bone healthy and perfect and whole." The image must be presented in the seed as a healthy, perfect and wholesome bone. Then the surcharge of manna must be visualized filling in that image with such intense power and compression that the image becomes more and more physical in appearance; and as it becomes more and more physical in appearance in the field of consciousness, it will also begin having that same effect in the physical reality levels.

This Awareness indicates that if you cease imaging too soon and check to see if the bone is improving, you will lose your image, and the image which has been building and solidifying in the field of consciousness will begin dissipating as you check the physical bone. This, in turn, will cause a reversal in the physical bone, so that the healing does not continue. Therefore, this Awareness suggests that as you begin solidifying the image to perfection in the field of consciousness, you hold this image, and hold the image, and hold the image, and hold the image, until the image feels so absolutely complete that you are confident you can let go of that image and it will remain.

#### Grounding the Seed-Image

This Awareness indicates that as a kind of grounding action for the image which you are holding, to make sure it stays in place, this Awareness suggests that you mentally may wrap that image three times in each direction with Manna, with rings of Light. This Awareness suggests you may even visualize putting a bow on the image, wrapping the image with a ribbon and placing a bowtie on the image to keep it in place.

This Awareness indicates that you may also make a sound, such as OM or the chant of "Love", or you may say, "In Jesus' name, I thank you," or some similar term which serves as a grounding and final step to the process. This Awareness indicates the term "Amen" has often been used for this. The phrase, "As it is written, so shall it be," has often been used for written documents, to make them solid. The action of putting a seal upon a written document serves a similar purpose. The action of putting a period at the end of a sentence serves a similar purpose.

This Awareness indicates at the end of your imaging process, you must create some kind of physical action: clap the hands, chant OM, praise the Lord, or do something to indicate that it is finished, it is done; and when this occurs, the mind may then stop the process of further changing the image, and the image will remain intact. This Awareness indicates that as this is completed and

the mind no longer changes that image, then the physical reaction follows the image which was planted in consciousness. This Awareness indicates that practice of this process is that which improves one's skills; that practice is what creates the faith, along with the success of the practice. Therefore, entities must not attempt to perform miracles which they cannot possibly believe in, which they cannot possibly accept, and must be satisfied with a gradual increase in their capabilities. This Awareness suggests that you begin simply, and progress, as you improve your skills in effecting such magic. This Awareness suggests you not become discouraged and not to attempt an action ill-prepared, so that you end up discouraging yourself from pursuing this course of action.

This Awareness suggests that entities wishing to practice this, may take the action step by step, not seeking results at first, but practicing by learning to build mana; clear out blocks; communicate with the low self, then the High Self; establish a good, integrated rapport with the three parts of oneself; blend these together, so that they all are in unity (at least part of the time); begin getting better acquainted with the low self and the High Self; discern the personalities involved, the subtleties of each of the selves and how each functions.

Then, after this has been fairly experienced and you really know yourself well,—including all of your parts,—begin feeding mana to the High Self through meditation, worship, and the surcharge of excess mana from your will, giving forth this mana on a "Thy will be done" basis to allow the High Self to use the mana, not according to your will, but according to Its will. Watch this action for some time, continuing to serve the High Self mana; and then eventually, you may find yourself being directed by the High Self to move into certain types of activities whereby you become an agent for such healing or similar miraculous actions.

This Awareness suggests, however, that if you approach this as an individual, a middle self, seeking to gain control of the low self and the High Self to use and to show your spiritual advancement by performing miracles in hopes, (consciously or subconsciously) that others will look at you in awe, then you will find that it is all in vain and it is all vanity on your part.

This Awareness indicates that the action occurs not by attempting to use the High Self and learn how to use the spiritual energies to perform miracles, that you might be noticed or significant in this lifetime; the action occurs by learning how to let yourself be used by the Christ Consciousness, by the High Self, that you may become a channel used by these forces in this lifetime. And the significance which comes to you will not be acceptable to you, for you will find yourself passing this on to the High Self, recognizing that It does the action; you are but a carrier, a messenger, an agent, and a servant to the High Self, to the Christ Consciousness, the Light, the Father in Heaven.

## IS PHYSICAL CONTACT NECESSARY IN HEALING AN ENTITY ?

(HOW ABSENT OR DISTANT HEALING IS DONE)

### FOLLOW-UP QUESTION:

Awareness, does the entity who is channeling the healing Manna from the High Self physically touch the entity being healed, or that part of the entity that is being healed, or does it make any difference?

### COSMIC AWARENESS:

This Awareness indicates that it does not necessarily require that the entity touch the other; that for some entities, the surcharge of manna may be transmitted best by physical contact, wherein the entity can physically touch the other. This particularly occurs when the patient has great faith in the healer, wherein the patient needs the suggested influence of having been touched by the healer, and this extra influence helps the patient to be more receptive.

This Awareness indicates that wherein there is no physical contact, the High Selves of each entity,—the patient and the healer,—are in fact contacting each other, and the subconscious, or low selves of the entities are also in touch with each other, or at least capable of being in touch with each other. Therefore, one may be at a great distance and still may be able to effect a healing through one's High Self in communication with the High Self of the patient; that much of this, of course, will depend on whether the patient has a smooth flow, an open channel, or whether there are great blocks and tangles between the patient and his or her Higher Self. That it is for this reason that some distant healings are more effective than others.

This Awareness indicates there also is further reason why some distant healings are more favorable than others; this being the degree of mana, or the amount of mana available from the healer to the healer's High Self. This Awareness indicates that if you can visualize a healer sending a surcharge of mana to his or her High Self, with the intention of this being used to heal the patient at a distance, and the patient having a certain number of blocks in the aka-cord between the High Self and the low self, and it requires a certain amount of charge to burn through those blocks to get to the low self in order to heal the patient; that whereby the patient's High Self has not been given much worship, much attention, much praise, much mana, and whereby a healer is called and the healer's High Self sends a charge of energy to the High Self of the patient, and this charge of energy moves down the aka-cord and burns out the blocks, and therefore, the healing energy reaches into the subconscious, and then into the conscious, and begins its healing effect on the patient,—this is the way whereby one may be healed at a distance.

This Awareness indicates however, that in the case where a healer does not quite have enough mana for his or her own High Self to send to the High Self of another, and this charge sent to the High Self of another is not sufficient to burn out all of the blocks in the aka-cord from the patient's High Self to the low self, then the energies reaching the patient may be insufficient for any significant healing effects. (There may be some effect, but not to a great degree, or there may be no noticeable effects at all.)

### Things Required for a Healing to Work

This Awareness indicates that therefore, it must be understood that the healer must have the aka-cords open to his or her High Self, and must send a sufficient charge of energy to that High Self, and the patient must have enough of an opening in the aka-cords between his or her High Self, so that the surcharge can either get through, or can burn its way through the blocks and tangles, the crosses, the fixations which are causing the blocked energy from the High Self. This Awareness indicates that if the charge is strong enough, the entity will feel the healing force; if the blocks are not too many, and if a charge is strong enough to burn through those blocks which are there, the entity can be healed. If the entity, however, has had a death wish, or has insisted on harming others, or has great feelings of guilt, or has filled his or her mind with so many complications and fixations and confusions and tangles, the energy from a healer may not be sufficient to burn through, to bring forth the healing.

This Awareness indicates that it may be possible for a group of entities working through their High Selves to send such a charge of energy to this entity, that it then can burn through and bring forth the healing; or it may be possible that a series of readings, healings, and surcharges of energies may be sent to the patient and the patient then, on a more gradual basis, may move toward greater health.

## If You Want to be Healed

## --Give up Something

This Awareness indicates that with the cooperation of the patient attempting to clear out personal blocks so that a clarity between the subconscious and the superconscious, whereby the aka-cords are cleared, this can also be of great benefit in helping to bring forth the healing energies properly. That it is for this reason that many healers request that an entity seeking to be healed, should give up something of himself or herself, should do some service for others, should pay, or should give a kind of penance for past deeds which have been harmful to others, or which have left guilt-feelings in the patient.

This Awareness indicates that when a patient unloads one's guilt or gives service to others, the patient creates a cleansing action and feels deserving of a return to fill the void created by the elimination of guilt or by the loss of some personal valuable; and therefore, feels deserving to receive a healing. This helps the healer's energy to get through from the patient's High Self, through its low self, and to perform the necessary healing. \*

This Awareness indicates that essentially, in all of these situations, it is a matter of unblocking the path, that energies might flow, and creating the flow of energies for their intended purposes.

\* ED's Note: This is precisely how and why the CAC Healing Wednesday operates and why it works so successfully for many of the membership. The third Wednesday of every month, the CAC membership is requested to send energies of healing directly toward Olympia, Washington, and the CAC healing center, symbolized by a giant glass ball suspended from the office ceiling by macrame-type rope. Beneath this ball is a large pile of letters from the membership, requesting various kinds of healings: physical, monetary, mental, emotional etc. This combined energy of hundreds of entities meditating for 20 minutes or so, imaging in their minds that healing energy combining with others, seeing that great White Light emanating from that hanging globe and pouring over and into that pile of letters, each requesting a healing; this creates a powerful conduit of energy that is used by Awareness to send to those entities in order that they, themselves can create the healing requested. (It really does work). The following day, Vicki T. and myself conduct a ritual outside, whereby all those letters are burned and the negative energies they contained are dissipated back to the elements.

This is also precisely why CAC requests that all members who request a healing, to give up something of his or her self, to give service of some sort to others for one weekend, or to send in a donation of some kind so that the Law of Gratitude makes sure the magic will work and is balanced.

This Awareness suggests that entities may also wish to visualize this, for clarity of the concept, as though you were watching a set of pipes running from the conscious mind to the subconscious, then up to the superconscious, and from the superconscious, over to the superconscious of another, and from there, down to the subconscious of that other, and back to the conscious. That also there can be pipes connecting the subconscious of these entities. This Awareness indicates that you may then visualize these pipes occasionally being clogged, whereby energy from one pipe may squirt water from one entity to another in an effort to unclog the pipes of the other, so that a cleansing or healing process may occur within the other entity. This Awareness indicates in this analogy, the water is that which is the mana, and the moving of these energies may be understood in the following manner: This Awareness suggests that the subconscious be visualized as a tub of water, whereby the mana is stagnate, is simply lying there. The conscious mind as a pump which directs the water, and the pipes which carry that water in its direction to the High Self. The High Self being a kind of furnace-like system which heats up the water, turns it to steam (which creates a totally different kind of manna), and that steam or High Manna then is sent at high speeds to the furnace of another to increase and enhance the steam from the High Self of the other, so that it may force the pipes clear as it moves down toward the subconscious; and once cleared and into the subconscious tub of water, then the conscious mind may begin to pump the waters again, having the pipes unplugged. This Awareness indicates this may be a more simplified analogy for entities to understand the process of magic. This Awareness suggests this as likened unto a plumbing system for explaining the movement of these energies.

### THE USE OF MAGIC TO CREATE MIRACLES IS UNLIMITED

#### FOLLOW-UP QUESTION:

Awareness, this technique just given is not confined strictly to the healing of bones. I assume it can be used for healing just about any ailment in another entity, and perhaps even in driving out low spirits in the case of possession. Is that correct?

#### COSMIC AWARENESS:

This as in the affirmative. This Awareness indicates that the Manna of the High Self is capable of creating anything whatever. That the manna of the High Self brings into reality whatever is held in the imagery level as that manna is poured into the form of the image. That it is through this process that many of the unusual stories of yogis and magicians creating such things

as smells out of a wave of the hand, creating an orange out of thin air or creating a second body in a distant place or teleporting one's body to a distant place. It is through this technique of being totally in harmony with the Christ Consciousness to such a degree that it becomes one's lifestyle that entities have left legends and stories which heretofore have been unexplainable to the majority of conscious minds on this plane.

This Awareness indicates that likewise, there are occasional reports of entities who return life to those who have been dead for several hours, or even for several days; that this also requires the cooperation of the High Self, the Christ Consciousness. This Awareness indicates that this requires that the soul of the entity be brought back to the body and restored into the body that it become animated again.

### The Era of Magic Approaches

(Closing Message)

This Awareness indicates that it appears that within approximately 20 years, the majority of entities on the physical plane, (this planet), will have reestablished a close contact with their super-conscious mind, the Christ Consciousness.

This Awareness indicates that during the past century, a realization of the subconscious has grown and developed, so that this is clear for those who wish to understand its significant purposes and its special qualities. This Awareness indicates that during the next 20 years, it appears that a broad realization of the superconscious will become more and more in vogue among psychologists and therapists and entities studying religion, philosophy, and the nature of the mind.

This Awareness indicates that the future understanding of the relationship between these three selves shall bring forth a totally new, (in the modern sense) understanding of the great religions. That this will, in turn, change the very face of the planet and the way entities relate to one another. This Awareness indicates this also shall change the basic concepts of medicine and of some of the sciences.

ED's Note:

The following reading is the closing message of a CAC general reading given back in September of 1980. An old friend, Margaret Nicholson, one of the original founders of the Organization of Awareness, had dropped by and we invited her to sit in on the reading. Margaret is one of the very few entities who has stuck with the various Awareness organizations down through the years and who actively participated in the various projects given by Awareness through these organizations. As we usually do when a guest is present at the readings, we ask Awareness in Its closing message if It has a message for that guest. ( Although we usually do not publish these personal messages of our guests, I am publishing this particular one because it is indicative of why so many CAC members have stayed with us for these many years, and how, in their own particular ways, are somehow creating magic and transmutations that are helping to raise the general consciousness of this planet). This particular editor has been associated with four Cosmic Awareness organizations, has related with (and at times been at odds with) five previous Interpreters of Cosmic Awareness in an ongoing attempt to keep the messages of Awareness flowing into consciousness and help to maintain at least a skeleton crew of ministers on this plane. (That ministry and that directive were given to me many years ago by Cosmic Awareness through the Interpreter Ralph Duby. It has not been an easy assignment. Even today, after we finally were forced to form our own organization in order to keep the messages freely flowing, the same problems persist in dogging me: certain entities, through various forms of intimidation, half-truths and threats of legal action, are undermining this Awareness organization, attempting to shut it down completely and stop the free-flow of the messages Cosmic Awareness has placed in our care and which we have pledged to release into consciousness for the betterment of all entities on this plane. There have been many times when I have almost said, 'to hell with it all, I quit!'

And then Awareness, as in this particular closing message, drops another little hint of how important our little part has been in this ongoing scenario, and like a good toke of the holy weed, it produces another high, another lift, and so we roll up our sleeves again and go back to work on the next issue of our publication, once again feeling that regardless of all the hassle, it somehow must be worth the while and the effort. ### QUESTION:

In closing the questioning for today, I'd like to state that we have with us today the entity Margaret Nicholson, who is one of the original founders of the Organization of Awareness and one of the first ministers ever appointed by Awareness, if it is alright at this time, I'd like to ask Awareness if It has a message for this entity today?



COSMIC AWARENESS:

This Awareness indicates there is seen that which appears to be likened unto a beam of light; this light tracing an aka-cordlike movement which ties together the aka-cords of many entities; that this may be likened unto the spinal column which holds together the bones of various sections of a skeleton. This Awareness indicates that one section known as the Organization of Awareness, another as Servants of Awareness, another as Cosmic Awareness Communications, and another as the Aquarian church. This Awareness indicates this light, this ray, which moves through all of these, touching all of these, serves as a kind of conduit to carry forth the energies of one to another. This likened unto a way whereby energies are carried forth from place to place, so that all of the energies of all who have been touched by this Awareness are joined together. This Awareness indicates that you as this energy, that Avaton as also a similar energy, and these energies form a kind of cohesiveness which has an alchemical effect in bringing the energies of many different people together, that the Awareness movement may continue its uninterrupted flow.

This Awareness indicates this action also has its reflection in previous lifetimes, whereby the two of you, and others, assisted in moving certain energies through time and space, according to a divine plan, to help bring about the speeding-up of spiritual evolution on this planet. This Awareness indicates this as a connective cord between different time-and-space circumstances in the history of civilizations upon this planet, whereby the groups of old reincarnated from place to place as a family or group, for certain predetermined purposes of directing the energies of spiritual development upon this plane at various key points and locations in the unfoldment of history.

WILL THE WORLD BE RESTORED AND NOT DESTROYED ?

( DOES ANYONE REALLY KNOW?)

QUESTION:

We received a flyer on a new book put out by Devorss & Company publishers in California. It's called *The World Restored, Not Destroyed*, by Solar Questor, the astounding revelations of the Solar Quest. I'd like to read this brief blurb and ask Awareness if this is valid:

"Our planet will not be destroyed by man. God has intervened to prevent it. This is reality and should be understood by all people. This tremendous process of intervention is the basis of the book; the ongoing process is described together with the resulting effects upon mankind and the other kingdoms of nature. These changes are already apparent in climactic, political and social conditions and will become more marked with each succeeding year. This book is intended to help the reader to go along with the changes and to contribute to them without too much discomfort to themselves, for awareness of what is happening is the key to a smooth transition. The promise of a successful outcome for the planet is assured. There is no need to despair. This immensely positive and encouraging book, *The World Restored, Not Destroyed*, points the way."

COSMIC AWARENESS:

This Awareness indicates that in the commercializing of concepts and ideas in order to sell a concept or idea, there are many different types of approaches, and there are those who peddle fear and chaotic predictions, and there are those who peddle hope. That there are also those who are not necessarily after the commercialized sale, but truly believe in what they are peddling, truly believe that there is despair in the future, --the doomsday prophets,--and there are those who portray the future and believe that all will be positive in the future, healthy and beautiful; that often the books which they represent reflect their own wishes and beliefs. Thus, there are those who peddle their beliefs and wishes and want to share this with others, or their warnings, and there are those who peddle simply for the commercializing of information, hope or despair, or warnings. It appears that this particular work is not intended simply as a commercializing, but is intended to share feelings of hope with others.

This Awareness indicates that it is intended to assist others in feeling good, in feeling hopeful regarding the future; that it is not however, based on any great hidden insight that has been withheld from all others, whereby this entity, the writers have insight into absolute knowledge regarding the future; it is simply presenting material to make entities feel better about themselves and about the future, with the intent of not only creating greater hope for entities, but also with the intent that entities having greater hope can



contribute more positively to that future.

It appears the commercial value of the book, while important, is of a secondary concern to those who have presented this information. This Awareness suggests that entities may enjoy reading this, to help balance much of the negative information which they receive, but should read this with the realization that no individual has absolute insight into what will happen in the future. This Awareness indicates that *It* does not reveal this information to *anyone* on the earth plane.

The future plans for this earth in the absolute sense, are *not* revealed. This Awareness indicates however, that *It* can and often does give predictions on conditional levels, conditional basis, if this or that occurs, or if the energies continue, then *this* will occur, on the condition that things are not altered, this or that will occur. By giving conditional information it allows entities to make choices that are necessary to bring about the conditions that will benefit the planet.

This Awareness indicates that there are always potentials for change and as long as there is life upon the planet, anything is possible. However, no entity, no individual is capable of indicating precisely the outcome and the destiny of this planet, particularly not at this time, for the scroll that keeps the information in regard to the destiny of this planet, the absolute destiny, has not yet been opened. This Awareness indicates that this will not be opened, to be revealed, until the Abriman Forces have run their course and have ceased in their actions and whereby then, and only then, will entities glimpse the Higher Planes and Higher Levels and Higher Wisdoms.

### WILL CLOROX REMOVE PESTICIDES FROM FRUITS AND VEGETABLES ?

#### QUESTION:

E.D., of Louisville, Texas, writes that in his search to find ways to purify food that is contaminated,-- fruits and vegetables with pesticides, herbicides and toxic metals, such as lead and mercury and so forth,--he ran across a book written by Wendel H. Hoffman called *Using Energy to Heal*, and he writes that his food purification involves Clorox bleach in water. One teaspoon of Clorox per one gallon of water, and then you put your fruits and vegetables in it for ten minutes, then rinse and let soak in clear water for ten minutes. His question is: "What I am concerned about is, is it safe, and does it work?"

#### COSMIC AWARENESS:

This Awareness indicates that this can destroy bacteria on the fruit; it may leave some residue of the chlorine and chemicals of Clorox on the fruit also. That in reference to its ability to work, it appears to be effective in cleaning surface bacteria to some degree, just as chlorinated water kills

certain substances in the water, but who is afraid of those substances on fruit anyway? There are many types of bacteria in food which the body can easily handle.

In reference to the pesticides on the fruit, it does not appear to be sufficient to actually deal with these pesticides to remove them totally, although it appears that it can have some moderate effect in removing these; that the Clorox might be somewhat less hazardous than some of the pesticides, but it could also have some slight detrimental effect. It appears to be more effort involved in this than it is worth, and it appears also that there is not the great degree of success, nor any particular savings or benefits of a considerable value, nor any great hazard in doing this, but a very moderate and limited value for the efforts involved.

This Awareness indicates however, that *It* does not see that this would be especially hazardous to entities if the fruit is then soaked in clear water for approximately ten minutes and washed afterwards. This Awareness suggests that the use of D-Cell water for these is also beneficial; also that entities can peel many fruits and avoid the contact with the pesticides. This Awareness suggests also that entities can ask questions of the grocer in regard to the source of the fruits and what types of pesticides may be on these fruits.

This Awareness suggests that entities **DO** need to be more attentive to this, for there are some fruits which are sprayed more than others and which entities often eat the peelings of, and there may be pesticides on these. This Awareness suggests strawberries for example, kiwi fruit, avocado; these particular fruits wherein the peelings are eaten such as peaches, apricots and so forth, pears, apples; kiwi and avocado fruits often receive much pesticide and should be carefully washed before spreading the pesticide by hand onto your hands.

This Awareness indicates that peeling these fruits, entities may think they are getting rid of any pesticides but may actually be picking up pesticides on their fingers and transferring it onto the meat of the fruit. This Awareness suggests that entities should wash all fruit from the grocer's and be cautious in regard to pesticides. This Awareness suggests that there appears to be more attention and awareness to this, and it appears that in the near future new types of pesticides will be developed which will not be harmful to the human; that these and biological types of insect control systems will be used in the near future; that this then can eliminate much of the problems which exist at present in regard to commercial fruits and vegetables.

**"DIRECT CENTERING"-- A COURSE  
IN BECOMING VULNERABLE**

**QUESTION:**

I got a letter from S.D., which wasn't a question about Awareness, but I would like to read this letter and ask Awareness to comment on this group that he mentions. He says:

"Dear Vicki and Avaton; there's something I'd like to share with you. I'm a little confused right now, but here goes. My sister took a course a couple weeks back in New York City called Direct Centering. I noticed a profound change in her disposition after she returned. Well, I had to see what this was all about, so I went with her to a Direct Centering meeting in Philadelphia, where we did an exercise entailing the holding of a partner's hands, and just looking into their eyes for one-half minute or so, then switching partners. This was interesting, but a little unsettling too. They then had people who had taken the course speak about what they had experienced and how they had changed. I talked to a number of these people, during a break, and there was something about them; they were happy and warm, but there was something else, something I can't put my finger on. They talked a lot about how we are limited. This I can understand, but experiencing it is another thing. I've never experienced anything so powerful, so wonderful, yet so confusing. I registered, and am taking the course this fall. One more thing: I've been out of that meeting for about 6 hours and have already cried three times. I haven't cried for years. Funny thing though, I don't really know why I'm crying. I just had to share this with you. I'll write back after I take this course, to let you know how it went, if that's okay."

Would Awareness please look at this technique called Direct Centering, and give some information on it?

**COSMIC AWARENESS:**

This Awareness indicates that this as related to and similar to the Transpersonative material which this Awareness has given some time previously. That by looking into the eyes of others in this manner, entities are also seeing themselves. That as you recognize that you are being looked at directly in the eyes by another, you must become aware of yourself; that wherein there is no judgment in this looking, you will become more aware of what you are. That as you look at others, particularly in the eyes of others, energies are exchanged between these entities,--this being energies of a psychic nature; whereby areas of yourself which you felt were private, are brought up to your consciousness with the question of whether or not that entity

This Awareness indicates this makes you look closer at yourself and at those areas of yourself which you may have ignored previously. That this technique as one which creates greater self-awareness, and also this allows one to become more vulnerable; and one's becoming vulnerable allows one to become more capable of accepting the observations of others, the expressions of others, and the criticisms of others. It also allows one to accept one's own criticisms of oneself. The action of becoming more vulnerable, in short, makes one more lovable; that it takes away the armor, the covering, and the shells which entities often place around themselves.

That other techniques used by this organization follow similar patterns, and that the general effect of this is that the people involved, becoming more vulnerable, can let down their guard with each other; and in this manner, express affection toward one another and toward themselves. This Awareness indicates the crying as a result of the inner child within you being allowed to have its place and being accepted by you; that most entities do not like to see themselves as vulnerable, and most entities do not have a space whereby they can afford to be vulnerable, even to try it out. This kind of activity, (and there are others of a similar nature), can help to create that space where entities can become vulnerable and experience the joys of such.

**THE ADVANCED TRANSPERSONATIVE MATERIAL  
--SHOULD C.A.C. RELEASE THIS INFORMATION?**

**FOLLOW-UP QUESTION:**

Awareness, there were a number of Advanced Transpersonative exercises given through the channel of David Worcester, and at that time I was instructed by Awareness not to publish that material; that only entities who had gone through Basic Development Class should have it. Since these aren't available to the membership at this time, should that information still remain unpublished, or is it alright now to put those together in an Advanced Transpersonative booklet? (It has been a long long time that these have just been setting around waiting to be published)

**COSMIC AWARENESS:**

This Awareness suggests that these be withheld for approximately 1 year further to allow opportunity for the Development Classes and programs to be put together through the Aquarian Church and through the college; that if this is not yet together, that these may be released to your members. This Awareness indicates however, that essentially these techniques should be accompanied by trained entities who have completed the Development Classes, and who have a deeper understanding of the transfer of psychic energy; that entities without this understanding

receive the same benefits as those who have completed the Development Classes; that it would be better that this be used as originally intended, following the Development Classes.

(QUESTIONER):

Okay, we won't publish that info then.

\*\*\*

Ed's Note: This particular reading was given in 1981. Today there is some beginning effort to get Development Classes going. The big problem is that these classes must be taught by ministers of Awareness—entities who have previously taken the classes. As more and more entities take these classes and then go out and teach others, eventually there will be enough of them that CAC can publish the Advanced Transpersonal lessons and exercises.

CAC, however, is releasing the basic Transpersonal exercises in a booklet channeled by Ralph Doby. These various techniques are to be practiced by entities who plan to take the Basic Development classes, as these exercises are integrated into the classes themselves, and those who practice these and understand these before hand will have a more powerful and fulfilling experience when they do eventually take the classes. Even if you never take the classes, the basic Transpersonal exercises can and should be experienced by entities in their homes. If nothing else, they will develop your extra-sensory perceptions, your ESP.

## IS KRISHNA THE SUPREME PERSONALITY IN THE GODHEAD?

(Excerpts from a personal reading)  
The following 3 questions

QUESTION:

The *Bhagavad-Gita* as it is and the *Sumad-Bhagavatam* states that Krsna (pronounced Krishna) is the Supreme Personality of Godhead. Would Awareness please comment on the information in these literatures in fact?

COSMIC AWARENESS:

This Awareness suggests that you note the use of a word describing that which is spirit. This Awareness suggests that you understand that all words are lies and are but reflections of the thing, or signs pointing toward the truth. This Awareness suggests that you understand also that forces do move in the universe, that some forces focus and some forces oppose each other, and some forces split and separate from one another, and some forces come together. This Awareness suggests you also understand that some forces do move into materialized forms while others remain in spirit or spiritual forms.

This Awareness indicates that you also understand that these forces can be labeled and named, that the labeling and naming of such forces as according to that force which chooses to label and name such. This Awareness indicates that in the ancient past of this planet Earth, there was a language which was scattered throughout many tongues. This language did contain certain aspects which has been used in the formation of various

religions. This Awareness indicates that you understand that at a certain point in the evolution of this planet that many of these terms were used to describe certain features. That at one point entities drew pictures to convey messages. This Awareness suggests that you also understand that the Egyptian gods Ra and Isis, that all these gods were drawn out as entities yet all these gods were simply principles. This Awareness suggests that you also understand that the concept of Krishna or Christ or the Crystal clarity as also a principle which has been presented in a personality story form whereby entities could perceive this in their limited three dimensional sense level of consciousness. This Awareness indicates there have been many who have moved into this crystal clarity and have taken on the name of Krishna, Christ or such. This Awareness indicates that you also may look carefully and understand that any of these entities who are clear may be worshiped as a god if that is where you wish to stand and what you wish to do. That this worship of others as a way of heightening your own clarity and your own consciousness and moving toward that crystal clarity yourself.

This Awareness indicates that you may also understand that the Christ or Krishna consciousness is within yourself, that you need not worship an entity in name or in physical image of today or in the past, that you may simply worship the Christ Consciousness or Krishna Consciousness or 'clarity'. The words 'Christ', 'Krishna', or 'clarity' may be interchangeable with these concepts and names. That you may think up any other name and use this for your triggering mechanism to bring you into that clarity.

This Awareness suggests it matters not to this Awareness how you become clear, but that you become clear.



## SHOULD ONE SPEND TIME CHANTING "HARE KRISHNA"?

QUESTION:

I am now chanting the Hare Krsna Maha Mantra. Should I continue?

COSMIC AWARENESS:

This Awareness suggests you may chant whatever you wish as long as you wish, but cautions you to be aware of what the chanting is doing. This Awareness suggests that repeated chanting is hypnosis. That wherein you are chanting certain words and certain terms and certain images, there is no room for any

other concepts within your consciousness. This Awareness indicates that wherein you are chanting these words and excluding other concepts from your consciousness you are focusing your consciousness; and wherein you continue focusing your consciousness, you are excluding a large portion of your possible experiencing including a large portion of that awareness that could lead to Cosmic Awareness. Wherein you are consistently focused on a small portion of the universal experiences, you are limiting your soul growth, wherein you continue focusing in this manner with an intensification of the intensity, you can blow yourself out, likened unto an overcharge. This is not an action to be taken casually for the intensity of the focus may call forth an action that, because it is focused and narrow with intense energy, can lead to actions that are separative, exclusive, self-centered or divisive in nature. However, if one moves on beyond that point of selfishness, desire and focus to the point of surrender of self to the Universal Life Force, then the intensity of energy used in focusing up to that point of surrender, becomes likened unto a compressed propelling energy that rockets the consciousness to an experience that may be considered mystical, or enlightening as it allows one to see ones concerns from a higher more expanded viewpoint.

This Awareness indicates this is a type of consciousness climax that relates to information given earlier in this reading, and this experience takes you back to where you began, having gone full circle in search of truth and swinging around to surrender to that *which is*.

This Awareness wishes you to understand that *what is* at any moment is *essence* and *essence* is what is the ultimate truth.

### The Law of Essence

This Awareness now indicates the *Law of Essence*: \*  
The *Law of Essence* states that what *is*, *IS*, and *what is*, is not changed by any opinions or beliefs about it, but *IS* what *it is*, while *it is*. This *Law* states that actions and motives which are the highest and the best, the most inclusive and encompassing, the most appropriate and essential, create those movements that lead to the Gates of Essence, behind which all things are exactly as they are, *while they are*, for Essence is the ever-changing truth that was, is and forever shall be.

chant, for any of these things which pop up before you are there for you to deal with by giving or denying your attention during that moment, for these are *what is*, and the *isness* is where it is, and it is here and now.

This Awareness indicates when you become totally aware of the here and now you have moved into the fourth dimension. This Awareness suggests you may become a dweller of both the third and fourth dimensional levels with equal ease and may be capable of changing your lifestyle on a moment to moment basis, as a magician of high order which does not exclude any part of the Universe.

Should I continue to visit the International Society for Krsna Consciousness Temple at 2015 Q St., Washington, D.C.?

### COSMIC AWARENESS:

This Awareness suggests this as in the affirmative, that you also continue visiting yourself, that you also continue visiting your Christ Consciousness, your own clarity consciousness and the consciousness of those around you in the world of Essence.

# 'Star Wars' bomb test conducted in desert

LAS VEGAS, Nev. — A hydrogen bomb buried in a boxcar-size canister was detonated in the Nevada desert yesterday in a test to determine if X-ray lasers could thwart a nuclear attack as part of the "Star Wars" missile defense system, officials said.

The bomb, with a payload equivalent of 150,000 tons of TNT, was detonated 1,800 feet beneath a desert mesa at 11 a.m. PST, said Chris West of the Department of Energy.

West refused to confirm whether the test was related to the Strategic Defense Initiative program, but Pentagon sources confirmed earlier this month

that the detonation was related.

The sources said the test was the fifth in a series dating back to 1980 to see if X-ray lasers powered by a hydrogen weapon could be focused to knock out enemy missiles.

Code-named Goldstone, the test had an explosive punch 10 times the force of the atomic bomb that devastated Hiroshima.

On Dec. 6, 30 members of Congress asked Secretary of Defense Caspar Weinberger to delay the next X-ray laser test, saying news reports had led them to believe the weapon's design was flawed. Federal officials have confirmed that there were unresolved technical problems in the weapon but

characterized them as minor.

Tass, the official Soviet news agency, swiftly condemned the test, saying "an evil New Year present has been made to humanity by the U.S. administration."

Three weather-related delays in the past 10 days prompted speculation from Moscow that public pressure was stalling the experiment.

The blast at Pahute Mesa, 100 miles northwest of Las Vegas, registered 5.6 on the Richter scale, according to John Minsch of the National Earthquake Information Center in Boulder, Colo. It measured 5.3 at California Institute of Technology in Pasadena, Calif.

## Khadafy warns of 'tit for tat' conflict

TRIPOLI, Libya — Libyan leader Col. Moammar Khadafy warned yesterday that Israeli or American retaliation for Arab airport terrorist attacks would spark a "tit for tat" cycle of violence.

Khadafy, speaking to a small group of Western reporters, said any attack on Libya would mean outright war in the Middle East and Mediterranean.

Khadafy warned that Libya would respond to harassment of Palestinians in Libya by harassing Americans and Jews.

"We have the right to follow American citizens in their own streets, and we have the right to follow Jews in occupied Palestine" if they retaliate, he said.

## Naturalist buried with the gorillas

MONT VISOKE, Rwanda — Slain American naturalist Dian Fossey, who for 18 years studied and befriended the rare mountain gorillas who live on this dormant volcano, was buried New Year's Eve in a cemetery she built for gorillas killed by poachers.

The burial in the gorilla cemetery in this central African nation was in accordance with the wish of Fossey, 53, who was hacked to death last week by an unidentified assailant.

About 50 friends and co-workers placed flowers at a temporary grave marker. The marker was a stick bearing a color picture of Fossey with three young gorillas, taken from an issue of National Geographic magazine.

Fossey had said she wanted her grave stone to bear a single word, "Nyiramahebelli." In the local language, the word means "the lady who lives alone in the forest."

## Order still going strong

SEATTLE — The federal racketeering convictions of 10 members of The Order have not weakened the white supremacy movement, defendants in the trial said.

"There are thousands and thousands of people out there who believe as I believe," said Gary Yarbrough, who faces a possible 60 years behind bars for his role in The Order conspiracy.

"They're afraid, because when you speak out on these beliefs, the government comes down on you," he said. "... But for every one that has left because their faith wasn't strong enough, five more came."

Yarbrough and nine co-defendants were convicted Monday following a trial that lasted 3½ months and cost the government more than \$1 million.

The defendants face maximum prison terms of 40 years to 155 years when they are sentenced Feb. 6-7 by Judge Walter McGovern, who presided over the trial in U.S. District Court.

# Disguise N-missile tests, Weinberger tells Reagan

WASHINGTON (AP) — Defense Secretary Caspar W. Weinberger, backed by the chiefs of the U.S. armed forces, has recommended to President Reagan that he disguise nuclear missile tests and not dismantle two Poseidon nuclear submarines in May, administration officials said yesterday.

In the past, the the Joint Chiefs have not always taken as hard a line as Weinberger and his top civilian assistants in U.S. strategy toward the Soviet Union. The Pentagon recommendations are designed to respond to Soviet practices that Reagan has told Congress violate arms control agreements with the United States.

But another official said the proposals were challenged by other sectors of the U.S. government

as being in conflict with the unratified 1979 Strategic Arms Limitation Treaty and other accords.

"You could argue if we're saying to do these things we're violating the treaties," the official said. "I'm sure he will run into opposition."

Reagan will be faced with a decision on multiwarhead U.S. nuclear missiles when the eighth new Trident submarine becomes operational in May. The United States would move above the 1,200 limit on such land and sea-based missiles established in the 1979 treaty unless he decided to retire older Poseidon submarines or Minuteman III missiles.

Exceptions to Weinberger's recommendations are being sent to Reagan as he weighs a decision. But since the Pentagon has the

main responsibility of framing a response to Soviet actions under the treaties, Weinberger's views could carry special weight with the president.

He also suggested the United States step up research on biological and chemical weapons, the officials said.

After intense debate within the administration, Reagan decided last June to dismantle a Poseidon nuclear submarine and its 16 intercontinental missiles to adhere to the 1979 treaty when the seventh Trident began sea trials in September.

Putting two Poseidons in dry dock, as Weinberger reportedly suggested, would mean they could be reassembled quickly. Dismantling the submarines and their missiles would, in effect, destroy them.

## Gypsies demand recognition for their loss of 500,000

SPOKANE (AP) — The American Gypsy nation is prepared "to make it embarrassing" for the U.S. government if the extermination of an estimated 500,000 gypsies during World War II isn't fully commemorated, says a colorful Gypsy senator from Spokane.

The Gypsies want a seat on the U.S. Holocaust Memorial Council and a visible part in the Days of Remembrance ceremony April 18 in Washington, D.C., in honor of the Holocaust victims and the 40th anniversary of the liberation of concentration camps.

During that ceremony in the Capitol rotunda, six prominent Jews will each light a candle, symbolizing the 6 million Holocaust victims. But James Marks II says a Gypsy should also light a candle to signify the equal suffering of Gypsies during the Nazi reign.

"We were the first to be destroyed by the Nazis," says Marks. "If they want a genuine Holocaust remembrance, they have to accept other people that were destroyed."

The Gypsies have been trying for a year and a half to get on the Holocaust Council, said Marks, accusing government officials, including President Reagan, of ignoring them. "We have not had a 'yes' or a 'no,' just 'maybe.' We're going to take the stand that we're from Missouri — show me," Marks says.

"We're not asking for a grant or a helping hand. We want commemoration for our people, too. This here is very dear to us. We still

mourn today, because it could happen again."

Marks first applied for a seat on the council 18 months ago. Last June, the U.S. Romani Council was formed in Los Angeles to back Gypsy claims for representation on the council and in planning for a Holocaust museum in Washington.

Micah Naftalin of Washington, the acting director of the Holocaust Council, said it was apparently an oversight that no Gypsies were seated when the council was appointed in 1980 by President Jimmy Carter. He said Reagan has filled a half dozen vacancies, and that terms on the council will begin rotating next Jan. 1.

"Considering how well balanced the council is, it's a glaring oversight," Naftalin said. "We're supportive of it, but we have no power of appointment. It's a White House appointment, and we can't just add people. I would guess the chances are very good that one or more Gypsies will be appointed."

Marshall Breger, special assistant to the president for public liaison, was not available for comment, and no one else in the office could comment, said a secretary.

Naftalin said allowing a Gypsy to light a candle at the Days of Remembrance ceremony would be a major tradition change. "Even the other non-Jewish members of the council have never done that," he said. "That's something that will have to be thought through carefully."

## Four men flogged for raping, selling Bangladeshi girls

HYDERABAD, Pakistan — A crowd of several hundred men and some women clapped and cheered as a guard broke his cane while flogging four men convicted of raping and selling Bangladeshi women.

Three of the men given 15 strokes at Hyderabad's Juma (Friday) bazaar ground were policemen, including one who ran an official inquiry into gangs smuggling girls for sale but who got involved in the trade himself.

Martial law, under which the men were tried, convicted and flogged, is due to be lifted by Dec. 31, but flogging will still be allowed under Pakistan's Islamic law.

## Second-hand cancer

Chain-smoking co-workers helped cause the lung cancer death of a 55-year-old woman — and should pay compensation to her family.

That was the ruling in a court in Stockholm, Sweden, in the death of Gun Palm, who never smoked but shared an office with six smokers for 18 years. "This does not represent scientific proof that her illness was caused by passive smoking, but there are very probable grounds for believing that passive smoking caused the injury," said court official Anders Fridh.

The court did not set the amount of compensation.

## Girl, 13, charged with kidnapping

PHOENIX, Ariz. — A 13-year-old girl was arrested yesterday and charged with kidnapping and molesting a 4-year-old girl who was buried alive and left overnight in the desert, officials said.

The victim, found Sunday in a 3-foot-deep hole covered with plywood, had been missing since the previous afternoon.

The suspect, who was not identified, was being charged with kidnapping and child molestation, said Cpl. Jay Ellison of the Maricopa County sheriff's office. She was being taken to a juvenile detention center, he said.

## Pirates kill 50 Viet boat people

GENEVA — Pirates killed 50 Vietnamese boat people in a murder and rape attack in the South China Sea last week, a spokesman for the United Nations High Commissioner for Refugees said yesterday.

Spokesman Leon Davico said there were 30 survivors — women and children except for two men.

Davico said the survivors reached the Malaysian coast on Dec. 19.

It was one of the most barbaric attacks reported since the exodus of boat people started after the end of the war. Close to 600,000 Indochinese have sailed to safety.



## Chemical OK for coffee, not cosmetics

WASHINGTON (AP) — The Food and Drug Administration has proposed banning the use of methylene chloride in hair sprays because it can cause cancer in animals, but would allow its continued use in decaffeinating coffee.

Two prominent consumer advocates were quick to condemn the proposal, which was carried Wednesday in the Federal Register and reported Saturday in The New York Times.

"It's an insane policy to allow the use of an unnecessary and acknowledged carcinogen," said Dr. Michael F. Jacobson, director of the Center for Science in the Public Interest.

Dr. Sidney M. Wolfe, head of the Health Research Group, said that the proposal violated an amendment to the Food and Drug Act that bars the use in food of any substance that has been shown to cause cancer in laboratory animals.

Methylene chloride is a volatile chemical used as a solvent and flame suppressant in hair sprays, in which it serves to speed the drying and setting of applied resins, the FDA said. It is also used by some manufacturers as a solvent to remove caffeine from coffee.

And 19-year-old Janelle Lynn Peery of Cheyenne, Wyo. — who lost her right leg to cancer — will get a medal for helping other cancer patients.

The medals will be presented by Reagan in a Rose Garden ceremony Jan. 16.

Every Christmas Eve for the last 16 years, Albert Rosen, a Jew, has volunteered to work for a Christian on Christmas Eve so that person could spend the night with his or her family.

"I'm of the Jewish faith," Rosen says. "I don't celebrate Christmas, but I wanted to celebrate it by helping someone else."

SPOKANE — A Spokane woman found dead in a hot tub at her home earlier this month had a blood-alcohol level of more than 25 percent, autopsy results show.

Donna M. Packard, 38, drowned after apparently passing out while alone in the hot tub, medical officials said Thursday.

The combination of alcohol and hot water apparently caused the woman to lose consciousness, they said.

Imagination takes off when no explanations are offered

Somebody knows.

Somebody — probably many somebodies — knows why those 60 flying machines washed over Tucson in waves in the wee hours of Monday.

But why does no one seem especially curious to find out? The uniform shrug of shoulders from the Air Force, the Federal Aviation Administration — even from Jim and Coral Lorenzen of Aerial Phenomena Research Organization — reads like the opening scenes of a Steven Spielberg script.

Officialdom agrees that there were no reports of U.S. military activity in the area at that hour. The idea that it could have been foreign aircraft is dismissed out of hand.

Foreign aircraft would have been detected somewhere else in the nation before being spotted over Tucson. Surely they would have been picked up by scanners at the North American Air Defense Command, in Colorado Springs, as they

headed northeast from Tucson. But not a peep of explanation from NORAD was forthcoming, either.

Evidently it was not a convention of crop dusters out on the town, or the filming of some new cross-country-race movie. If it was, no one was talking.

The fertile fields of imagination begin to bloom. Perhaps they weren't aircraft at all, but multiple laser beams bounced off the ionosphere from a new "Star Wars" transmitter that a U.S. space shuttle put in place last week. The nature of the shuttle's mission was, after all, kept under wraps.

Maybe the vibration explains the rash of disasters in the world of late — the earthquake in Mexico, the mudslides in Puerto Rico, the hurricane on the East Coast and the dozens of tragic airplane crashes. Some journal or other will no doubt make such a connection soon.

Maybe it has something to do with the upcoming summit meeting between Ronald Reagan and Mikhail Gorbachev.

There should be some sort of explanation, if the Air Force's tried-and-true swamp-gas emission, or that it was a freakish reflection of northern lights would be better than a cash strag.

The FAA says that aircraft going over a city 7,000 feet or so don't have to check in with the city's air-traffic controllers. Davis-Monthan Force Base says that military planes that fly more than five miles from a military field do have to check in either.

But 60 of them? Flying in "waves"?

## Military vehicle is a menace, say critics

WASHINGTON (AP) — Tests of the Army's new personnel carrier showed the weapon is more vulnerable and the soldiers inside are more likely to be killed or wounded than the service is willing to admit, sources say.

# Reagan Seeking Health Alternatives From Foreign Cancer MD?

EXCLUSIVE TO THE SPOTLIGHT

While the government-supported suppression of freedom of choice in cancer therapy continues unabated, the president of the United States is apparently seeking one of the suppressed alternatives.

According to reports from European newspapers and magazines, the White House has been quietly in touch with Dr. Hans Nieper—purveyor of "forbidden" cancer remedies.

The German publication "*Neue Revue*," in an article headlined, "A Call From the White House: Save Reagan!," said that Nieper, a world renowned physician who gained additional fame by treating such celebrities as Yul Brynner, has been in contact with the president and his physicians.

Adding fuel to worldwide rumors that the outlook for the president's cancer condition is not so rosy as the U.S. media has reported, the German feature said, in translation:

"Probably later this fall [1985], Dr.

Nieper will fly to Washington—he is supposed to treat the American President Ronald Reagan, 74. Reagan will—after numerous phone calls between his physicians and the cancer expert from Hannover—be supplied with Anavit and Carnivora. Besides this, Dr. Nieper recommended to the president a diet of lots of vegetables and fresh fruit. Prohibited are meat and shellfish.

## HERBAL REMEDIES

The two products mentioned, Anavit and Carnivora, are herbal materials Nieper recommends to his cancer patients along with other natural products such as carrot juice, magnesium supplements, fish-liver derived "carnitin" and "squalen," which is evidently a German term for the extract of cabbage juice, now considered even better than beta-carotene found in carrot juice as an aid to cancer patients.

Nieper products shipped to other American cancer patients was halted by the postal authorities last July.

Anavit is essentially pineapple-derived enzymes and Carnivora is an extract from a South American carnivorous

plant. This product was hailed for its effectiveness in treating Yul Brynner several years ago.

Nieper told "*Neue Revue*": "I bet fully on Carnivora. With the exception of breast cancer, we were able to achieve good and long term success with this remedy. Provided it is administered early enough, it also can stop cancer of the intestines."

The feature writer then added: "And for this was Ronald Reagan operated on four weeks ago."

## TAKEN ABACK

On December 12 Allen Stang, a veteran reporter, interviewed Dr. William Jarvis, chairman of the National Council Against Health Fraud, a front for the American Medical Association, the American Cancer Society, the American Pharmaceutical Association and the Food and Drug Administration. Stang told Jarvis about the Reagan-Nieper connection being reported in the European media.

# Jets Israel downed were no threat

TEL AVIV, Israel (AP) — Defense Minister Yitzhak Rabin acknowledged yesterday that two Syrian MIG-23s shot down by Israeli jets last month never intended to intercept the Israeli aircraft.

In a televised question-and-answer session with military officers, Rabin said that "from different sources we now know that

the Syrian planes had no intention of intercepting Israeli planes on a routine reconnaissance flight over Lebanon.

But he added: "Things sometimes happen even when the two sides don't want them to happen."

The Nov. 19 incident led Syria to move SAM-2 missiles up to the Lebanese border,

within range of Israeli planes surveying Palestinian guerrilla bases in Lebanon.

Israel announced the Syrian deployment on Dec. 15 and warned it could lead to war.

The Israelis have asked the United States to intercede with the Syrians to move their missiles out of range of Israeli

planes flying over Lebanon.

Rabin said he did not believe that if Syria initiated war with Israel other countries would join the fighting.

In a poll last week, almost 60 percent of 1,200 Israelis surveyed said they believed there was the likelihood or certainty of war with Syria within a year.

## Computer hacker irks Jerry Falwell

ATLANTA — For now, at least, the Rev. Jerry Falwell has exorcised the Demon Dialer.

But an angry self-styled computer commando, as a protest against TV evangelists, vows to keep right on bedeviling the \$100 million fund-raising machine of the Moral Majority (or the Liberty Federation, as Falwell recently announced

his group will be called) with his \$200 Atari home computer.

"I'll give you a demonstration," says Edward Johnson, 46, a bespectacled computer consultant, pecking away at a keyboard in his one-bedroom walk-up apartment here.

That activates his modem's auto-dialer. Bleep, bleep, bleep goes the video-arcade echo on his speaker phone as his Atari rings up Falwell's world headquarters in Lynchburg, Va.

"Old Time Gospel Hour," says an operator. "Can I help you?"

Johnson grins. His computer is programmed to tie up the line for 30 seconds, then it hangs up and dials again, as it has every 30 seconds, 24 hours a day, seven days a week, for the last eight months.

"Here we go again," he says. And the computer dials 1-800-446-5000.

"Old Time Gospel Hour," says the operator. "Help you?" Click. "You can tell by their tone of voice they're not too happy," he says.

Indeed, Falwell officials estimate their first high-tech protest cost them close to \$1 million in lost pledges on a blessed WATS line, which fields some 1 million calls a year, before Southern Bell detectives ordered Johnson to hang up on Dec. 20 or face criminal charges — using the telephone to harass is a federal felony. The besieged switchboard raises at least half of Falwell's \$100 million budget, used to support a TV ministry, missionary work, Bible study, an antiabortion crusade and the like.

"He has robbed the poor and needy of many thousands of dollars," said Falwell.

But Johnson accuses TV evangelists of persuading elderly viewers to part with money they can ill afford to spend, buying religious trinkets and false hope while the on-the-air preachers use their tax-free status to subsidize and promote often incendiary views.

"They're making millions because there aren't any laws to protect the gullible from such a powerful medium," says Johnson, who says he nearly lost his family farm to TV evangelist Jimmy Swaggart.

After one rip-roaring TV sermon, he says, his 68-year-old mother, Mary Johnson of Sylvester, was ready to sign over the fam-

ily's 150 acres in south Georgia. A virtual shut-in, she lives alone on land his father, who died 12 years ago, once planted with soybeans, peanuts and corn. But Johnson stepped in and, along with an older brother, Raymond, talked her out of it.

Johnson's lone crusade began one Sunday morning, April 7, when, he remembers, Jimmy Swaggart on a local affiliate accused gays of "spreading AIDS like flies" at bathhouses.

A political activist and card-carrying member of the American Civil Liberties Union, Johnson got angry. "He was implying that you should treat those people like flies," he says. He considered it unfair and inflammatory. And, of course, he'd almost lost the farm.

## Bear OD's on cocaine cache

BLUE RIDGE, Ga. — At least one bear died of a multi-million-dollar high after eating part of a shipment of cocaine that was dropped into a north Georgia forest by drug smugglers.

Forty packets containing an estimated 88 pounds of the sweet-smelling powder had been torn open and the drug eaten or disbursed when agents found it Friday. The body of a black bear was found not far away.

The ripped duffel bag and shredded packages were believed to be the last traces of a drug shipment dropped from a small plane by a 40-year-old former Kentucky narcotics investigator who fell to his death in Knoxville, Tenn., Sept. 11 when his parachute failed to open, said Gary Garner of the Georgia Bureau of Investigation.

"The bear got to it before we could, and he tore the duffel bag open, got him some cocaine and OD'd (overdosed)," Garner said. "The bears have apparently scattered them (the packages) all over the hillsides. We don't know how many bears are involved. We know there was one, because we found him. There's nothing left but bones and a big hide."

## Burglar shoots dog

## 'Super' gonorrhea hits all 50 states

ATLANTA — Federal health officials said yesterday that a "super" gonorrhea resistant to penicillin has spread to all 50 states and a major program has been launched to control it.

The national Centers for Disease Control labeled an explosive epidemic of the resistant gonorrhea in south Florida as "without precedent in the United States."

During the first nine months of 1985, there were 6,020 cases of resistant gonorrhea reported among civilians across the country, more than double the figure for the same period in 1984.

Outbreaks in Florida and New York City forced health officials to abandon penicillin for other antibiotics up to 10 times more expensive in an effort to halt spread of the strain, Jonathan Zimman said.

## 10-year term in killing of black

NEW YORK — A car mechanic was sentenced yesterday to 10 years in prison for manslaughter stemming from the 1977 Christmas Eve slaying of a young black man who kissed a white woman.

The mechanic, Robert Alvarez, 24, who pleaded guilty to manslaughter, drove the gunman to the scene of the crime and saw the shooting. William Brennan, 25, was sentenced to life in prison Nov. 13 for the murder.

Brennan shot Michael Johnson, 23, in the back after he left midnight Mass at the chapel of Fordham University with a white woman and kissed her good night on the street. Police, acting on tips, arrested the men July 10, 1984, more than seven years after

# It might be all right to kill Khadafy, senator suggests

CLEVELAND (AP) — Ohio Sen. Howard M. Metzenbaum, a liberal Democrat who has criticized covert activities by the U.S. government, suggested in an interview published yesterday that Libyan leader Col. Moammar Khadafy be assassinated if he is behind recent terrorist attacks.

"A singular action may be justified," Metzenbaum said in an interview with The Plain Dealer of Cleveland.

Metzenbaum also mentioned assassination in an interview Wednesday with WKYC-TV in Cleveland.

"And maybe we're at that point in the world where Mr. Khadafy has to be eliminated," he told talk show host Dick Feagler.

"You mean, literally?" Feagler asked.

"Literally, literally, why not?" Metzenbaum said. "If he's a party to killing innocent Americans, innocent people from all over the world without any compunction whatsoever, then why need we have such compunction about seeing to it that he personally..."

"So we assassinate him?" Feagler asked.

"It would not be the first time," Metzenbaum answered.

Metzenbaum said in the newspaper interview that he had qualms about approving an assassination when he had objected to such activities in the past.

"Frankly, I have difficulty with my own thinking on it," said

Metzenbaum.

Metzenbaum's press secretary, Drew Von Bergen, said yesterday that Metzenbaum stood by his remarks but would have no further comment. He offered no explanation for how Metzenbaum proposed carrying out such an action.

## Burglars grab gifts collected by mission

Somebody stole Christmas yesterday from the children of as many as 100 low-income Seattle families.

Burglars broke into the Union Gospel Mission's youth services center in the early morning and took about half the presents donated for needy children, police said.

As a result, the mission is at least 200 gifts short for the many neighborhood children's parties scheduled this week.

"Just when we thought we had our act together, somebody did us in," said Steve Burger, director of the mission. "We also lost things like a small computer, which the young people used, our telephone answering service and a VCR camera."

### Inner-city kids

Gifts are now needed to replace the lost presents, said Gerry Autry, director of the youth services center, at 601 21st Ave. He estimates the center lost another \$3,000 in electronic equipment.

"The gifts which were taken are all that many low-income inner-city kids will receive this Christmas," Autry said, "and we have nothing with which to replace them."

The mission distributed gifts to about 400 families last Christmas during neighborhood parties.

Replacements for the stolen 200 presents are needed by Thursday, Friday and Saturday, when most of the parties are scheduled for this Christmas season.

Autry said replacement gifts should be for youngsters from first grade through junior high. Toys, stuffed bears or clothes are high-priority items.

## Sanctuary backers laud Seattle vote

SEATTLE (AP) — The Seattle City Council's decision to declare the city a sanctuary for refugees is a "tremendous boost to morale" for the sanctuary movement, a leader of that movement says.

The Rev. Donovan Cook of University Baptist Church in Seattle, the first church on the West Coast to give sanctuary to Central American refugees, warmly praised the resolution approved Monday to make Seattle a "city of refuge" for those fleeing persecution in their homelands.

The resolution, passed 8-0, says there is evidence that people fleeing violence in Guatemala and El Salvador are discriminated against when they try to get permission to stay in the United States, and urges a "fair and impartial enforcement of federal immigration law."

Councilman Norm Rice said it was fitting the resolution passed in the same month as the birthday of Martin Luther King Jr., because "it is an extension of his principles and ideals."

"I do not believe we can close the door to individuals who are fleeing for their lives and say you cannot enter," Rice said.

Seattle joins at least seven other U.S. cities that have passed similar resolutions.

Cook lauded the Seattle resolution as "a statement that reflects the best of the city and of the American people, that they will not tolerate the discrimination and violence directed against Salvadoran and Guatemalan refugees."

Seattle's resolution is the strongest statement yet by a city on the sanctuary issue, Cook said.

It calls upon the state's congressional delegation to ask Congress to investigate the application of refugee laws to people from El Salvador and Guatemala.

## Troops build U.S. camp in Honduras

CAMP BIG BEAR, Honduras (AP) — National Guard troops from Missouri are building Camp Big Bear in mountainous northern Honduras as part of another joint military exercise that will bring about 5,000 guardsmen from nine states here.

A U.S. military official said the outpost is a "physical demonstration of U.S. commitment" to the region. He spoke of possible combat if Nicaragua's left-wing government brought in Soviet jet fighters or Cuban troops.

"To intervene in the internal affairs of Nicaragua is not in our best interests, but if they bring in MIG-23s or put a Cuban battalion in there, that's a different story," said the official, who spoke to reporters at Palmerola Air Base in central Honduras where 1,100 U.S. military personnel are stationed.

The guardsmen landed Saturday at Palmerola and then came to Camp Big Bear, 100 miles north of the capital of Tegucigalpa and about 150 miles northwest of the Nicaraguan border.

## Soviet poet blasts 'warnography'

## Green River toll up 2 added to list after discovery of their bones

The toll of Green River murder victims increased to 34 yesterday after police officially linked two young women whose bones were found in Auburn this week to the 3-year-old serial murder case.

Green River Task Force spokeswoman Fae Brooks said evidence of the women's violent deaths and the proximity of their remains to where another Green River victim's remains was discovered two years ago led task force commander Capt. Frank Adamson to add the two women to the list.

The King County medical examiner's office said yesterday both women died of "homicidal violence of an undetermined nature" and have been dead two to three years.

The office identified the victims as a 20- to 30-year-old black female, 5 feet 1 inch to 5 feet 4 inches tall, and a 14- to 17-year-old white female 5 feet 4 inches to 5 feet 8 inches tall.

Virologists there have demonstrated that the AIDS virus, usually described as weak and fragile, can survive outside the body at temperatures of 22 degrees Celsius for as much as 10 days. This finding confirms the increased possibility of transmission of the virus, through dry, as well as wet, material.

Israel's debt to the United States for direct and guaranteed military loans is now about \$25.5 billion—by far the largest of any foreign government.

It amounts to 42 percent of the total of \$60.7 billion of debt for military aid owed America by all foreign nations. The \$25.5 billion does not include the billions of dollars in military debts America has already "forgiven."

This is the finding of a new General Accounting Office report to the Congress, "Military Loans—Repayment Problems Mount as Debt Increases."

The \$25.5 billion is approximately \$113 for every man, woman and child in America or about \$6,375 for every man, woman and child in Israel.

Unlike military aid to other countries, the amounts and types of assistance to Israel have been particularly tailored for that country. Israel receives significant amounts of concessional military aid in the form of loans with the repayments forgiven or waived. Through 1985, Israel received a total of \$19.7 billion not counting interest, of which \$8.5 billion was on forgiven terms.

The remaining loans to Israel have 30-year repayment terms—longer than the 12-year term usually authorized for foreign military loans.

For fiscal year 1986, Congress has approved increased amounts of concessional assistance to Israel—specifically \$1.8 billion in forgiven loans, an increase of \$400 million over fiscal year 1985.

#### CASH ASSISTANCE

In addition to concessional and for-

given military loans, Israel receives cash assistance, which has enabled it to make required repayments of existing military loans.

Section 534 of the Foreign Assistance and Related Programs Appropriations Act of 1985 establishes a policy that cash assistance must equal or exceed Israel's annual debt repayment to the U.S. government. Thus, in fiscal year 1984, Israel received \$910 million to repay \$903.5 million in interest payments.

For fiscal year 1985, Israel will receive \$1.2 billion in cash grants to repay obligations of \$1.1 billion. Additionally, the fiscal year 1985 supplemental appropriations provided an additional \$1.5 billion for cash assistance for military purchases.

"Although cash assistance has precluded Israeli defaults on military loan

repayments, Israel's indebtedness poses serious problems for the country's economy," found the report. Israel's debt service ratio in 1983, according to Department of Treasury data, was 35 percent and its balance of payments, including trade balance, was a \$4.1 billion deficit.

The need for Israel to undertake economic reform measures was pointed out most recently in the Reagan administration's fiscal year 1986 budget justification. Israel has no arrangement with the International Monetary Fund, and according to State Department officials, none is likely to occur for political reasons.

Most observers believe all of the \$25.5 billion owed the United States for military assistance loans, including interest, will be paid by U.S. taxpayers.

**IRS LOSES—AGAIN.** Retired grocer John Hoefker of Covington, Kentucky was confused by all the complicated requirements involved in filing his income tax forms, and when he saw that he was filing his 1040 under "penalty of perjury," he added a note that said, "This was not signed because you all have so many thousands of laws and regulations there is no way I can be sure I complied with all of them." The IRS didn't like it and assessed penalties, saying his return was "frivolous." They began adding interest to the penalty Hoefker had refused to pay, and then seized money from his bank without a court order. Hoefker didn't like that and, acting as his own attorney, filed suit against the United States. U.S. district Judge William Bertelsman ruled that the IRS's behavior was "shocking" and he ordered the federal agency to return Hoefker's money, plus interest.

## Acid rain report dismays Canada

OTTAWA — Canada's special envoy William Davis said yesterday a report on acid rain drawn up with his U.S. counterpart was the best that he could achieve for now with the Reagan administration.

Canadian environmentalists said they were disappointed by the report drafted by Davis and President Reagan's special representative, Drew Lewis because it proposed no targets, timetable or concrete measures for curtailing the pollutants.

Davis, a former Ontario premier, said he would have liked a report that called for specific targets to control acid rain.

But he said Lewis felt strongly that would not be acceptable to the President and should not be included in the joint report, which Davis said was already "contrary to U.S. policy."

Canadian complaints of acid rain from the United States have become a major sore point between the two countries.

## French Missile May Use Neutron Charge

Ready for Production

As of 1992, the new Hades missile that will enter service in the French Army may be equipped with a neutron nuclear charge.

This was first stated officially in an article prepared by Army headquarters which was published in the French Defense Ministry journal L'ARMEE D'AUJOURD'HUI. The most important features of the Hades missile system, the article notes, is that it has the technical potential to utilize a neutron charge in the event of a decision being taken to inflict a massive strike.

According to LE MONDE, the Hades missile, which has a range of more than 350 km, will replace the existing Pluton missiles. Four artillery regiments will be equipped with the new missiles. The newspaper points out that the French president and the Defense Council have not yet taken the decision to embark on series production of a neutron bomb. Despite the Socialist's previous statement that they reject the production and deployment of neutron weapons, commentators are noting that a French neutron bomb is ready for production, which could be organized in the space of a few months. (2/25/86, p. 14)

Simi Valley, Calif., officials have given up efforts to buy a tract of mountain land from comedian Bob Hope that they had wanted for a park.

For almost two years, park planners had tried to get hold of China Flat, a 706-acre plateau Hope owns in the mountains 40 miles northwest of Los Angeles.

The grassy area, home to golden eagles, prairie falcons, deer and an occasional mountain lion, was valued at \$1,100 an acre by the Hanchi Simi Recreation and Park District in Ventura County, and \$20,000 an acre, and park officials have dropped efforts to persuade him to cut his price.

# Government bugging great outdoors

WASHINGTON — Is Smokey the Bear hiding a transmitter in his hat and using that famous shovel for an antenna?

Could be. Incredible as it seems, hikers, campers, climbers, anglers, hunters and other Americans who like to get away from it all in government parks, forests and wilderness areas may not be getting away at all. No matter how remote the site, they may be well within range of federal employees using sophisticated surveillance systems.

In fact, according to a recent congressional study, some of the unlikeliest federal agencies are enthusiastic users of super-snooper devices. The National Park Service, National Forest Service, even the Fish and Wildlife Service, all make extensive use of electronic surveillance technology.

The solitude you seek could be

shared by rangers many miles away without your knowledge.

The congressional Office of Technology Assessment did a study of federal agencies that have electronic-surveillance systems and found that their use has begun to encroach on citizens' privacy. Rep. Robert Kastmeyer, D-Wis., wants to bring legal protections into the high-tech age. Some of what the congressional investigators told him was puzzling. For example:

□ The National Park Service — those benign folks who run the guided tours, answer your kids' questions and keep the traffic moving — use nine different electronic-surveillance technologies to keep track of who does what on the 79 million acres under its control, according to the OTA report. The devices included: radio sensors, miniature transmitters, night-vision systems, vehicle trackers, satellites and hidden sensors.

An official of the Rangers Activities Branch told our associate Donald Goldberg that many of the gizmos were used for building security and law enforcement functions. But he added candidly: "I can't imagine an application for some of these."

□ The Fish and Wildlife Service, with more than 90 million acres to oversee, including wildlife refuges, fish hatcheries and research areas, uses or plans to use nine surveillance systems, and will probably add six more to its observation arsenal. The ones already in use include satellites, telephone taps, miniature transmitters and vehicle-tracking devices. Officials also want to use "pen registers," which monitor numbers called from targeted telephones, and voice-recognition apparatus. ("Hello, that you, bomb?")

□ The Forest Service favors night-snooping systems for its 229 million acres, including mail inter-

ception, telephone taps and closed-circuit television. Most are used for law enforcement, the service told congressional investigators. In addition, sensors are used to monitor forest land where "costs of physical protection are excessive."

□ The National Oceanic and Atmospheric Administration uses six different electronic surveillance technologies, including the dial-reading pen registers, body wires and telephone taps.

□ The Agriculture Department has other sub-agencies besides the Forest Service that use electronic surveillance systems. Its inspector general uses nine technologies, including satellite interception, mail monitoring and the ever-popular telephone taps. The Agriculture Stabilization and Conservation Service, "in support of ongoing criminal investigations," uses nine techniques, including satellite interception, electronic mail monitors, pen registers and closed-circuit TV.

Six Soviet cosmonauts said they witnessed the most awe-inspiring spectacle ever encountered in space—a band of glowing angels with wings as big as jumbo jets. According to *Weekly World News*, cosmonauts Vladimir Solovlev, Oleg Atkov and Leonid Kizim said they first saw the celestial beings last July, during their 155th day aboard the orbiting *Salyut 7* space station. "What we saw," they said, "were seven giant figures in the form of humans, but with wings and mistlike halos, as in the classic depiction of angels. Their faces were round with cherubic smiles." Twelve days later, the figures returned and were seen by three other Soviet scientists, including woman cosmonaut Svetlana Savitskaya. "They were smiling," she said, "as though they shared in a glorious secret."

### Army 'fleeced' out of \$170 million

WASHINGTON — Poor Army debt collection procedures have allowed former servicemen to skip out on nearly \$170 million owed Uncle Sam since fiscal 1980, Sen. William Proxmire, D-Wis., said yesterday.

Proxmire, who gave the Army his monthly "Golden Fleece" award for the distinction.

"Every year the Army discharged battalions of soldiers who owe the service tens of millions of dollars for everything from unpaid bar tabs to re-enlistment bonuses they didn't deserve," he said.

Not only that, he said, congressional investigators found one case in which a woman who left the Army owing money tried to arrange to pay it back but was turned down.

### Troops harass peace caravan

SAN SALVADOR, El Salvador — Roman Catholic Archbishop Arturo Rivera y Damas and leaders of a peace caravan across Central America said yesterday the army arrested a marcher and harassed other participants throughout their return trip to the capital.

"Before this Mass, I was told that participants in the march were detained various times, almost every 10 minutes," Rivera y Damas said in his sermon at the Metropolitan Cathedral.

Some 400 marchers, including several Americans, on 12 buses returned to the capital after officials refused to allow them to carry out their planned demonstration in the eastern war zone.

### Human bombs hit Israeli radio station

METULLA, Israel (AP) — Suicide bombers with explosives strapped to their body attacked a radio station run by American missionaries in south Lebanon early today, and sources said three guerrillas, a Lebanese militiaman and a radio station employer were killed.

Guerrillas attacked the Christian station, the Voice of Hope, 2½ miles north of the Israeli border town of Metulla at about 1:15 a.m., the sources said.

Israel Radio reported that a spokesman for the Israeli-allied South Lebanon Army militia said the guerrillas' own men took position on the walls surrounding the radio station and shot at their colleagues to detonate the bombs.

### U.S. ready to foreclose on farmers

WASHINGTON — The Farmers Home Administration yesterday began preparing to notify thousands of farmers, who owe the government nearly \$6 billion, that they must bring their loan payments up to date or face foreclosure.

In effect, the action ends a 25-month moratorium on farm foreclosures by the agency, which is a division of the Agriculture Department.


The action comes at a time when growers face the worst farm economy in half a century, with little prospect of improvement in the near future, according to agricultural experts.

The 1985 farm bill, signed last week by President Reagan, will lower the price the government pays to farmers for their crops. Critics of the new law contend it will cause farmers' income, which has been dropping sharply since 1981, to continue to decline.

## Military officials worried over formation of two-state Civilian Guard

NASHVILLE, Tenn. — A quasi-military force forming in Tennessee and Kentucky is "all wet" if it believes it can be recognized as legitimate, Tennessee's top military official says.

A membership drive by the Civilian Guard, which claims to be a replacement for the National Guard should that body ever be called to federal duty, is drawing worried and sometimes angry responses from state military officials.

"It's unstructured and has no authority and will not be recognized," said Adm. Gen. Carl Wallace, who oversees the Tennessee National Guard. "We have a group that is already recognized by the government to fill that role."

According to press releases issued by the Civilian Guard, the force was created in 1979 to assist local

authorities during natural disasters if the National Guard is on federal duty.

Merlin Gage, commander of the group based in Middleboro, Ky., and Greeneville, Tenn., said his group will have 10 squadrons of 50 to 100 volunteers in Tennessee by the end of 1986.

"Due to the threat of major earthquakes in the near future and the concern over terrorism hitting our communities at any time," the group's statement says, "a group of concerned and dedicated men and women established the Civilian Guard for the purpose of laying the foundation for volunteers who wish to provide manpower for defense of the civilian population at the city, county and state levels."

It goes on to say the Civilian Guard has received "confidential" information about earthquake conditions in the Tennessee-Kentucky area that "makes time very important." Both states were affected by a

severe earthquake along the New Madrid fault in Missouri during the early 1800s.

Asked where the group got its earthquake information, Kube M. Greer, one of the organizers, declined comment.

Greer, who said he is organizing the first squadron in Greeneville, said the volunteers would be trained in the use of firearms. The group intends to form squadrons wherever there are military armories and plans to receive military equipment from the Defense Department once it is chartered by Congress, Greer said.

But according to state military officials, Tennessee already has a force to take the place of the National Guard in a disaster situation — the Tennessee Defense Force.

The TDF, recognized by the last session of the Legislature, would get Defense Department equipment to assist local authorities during a disaster, said Defense Force chief of staff, Harrell Webb.

"We are under the direction of the governor and we will take over the armories if the National Guard is federalized," Webb said.

Webb said the Civilian Guard hasn't been recognized by either state or federal government.

"They are certainly not going to get any federal equipment," Webb said. "They have no authority to bear arms."

Bill Preston, chief of public affairs for the Tennessee Defense Force, called the Civilian Guard "clandestine" and "dangerous."

In its statement, the Civilian Guard said present and former Kentucky Sens. Wendell Ford and Walter Huddleston helped the group achieve tax-exempt status from the government.

But a spokeswoman for Ford said the senator has never aided the group.

## U.S. needs money that Israel wants

According to the Dec. 16 analysis page article, "Government retirees will feel first pinch of Gramm-Rudman," by Peggy Simpson, about 3 million government civilian and military retirees will forfeit \$1.3 billion in benefits for 1986. Additionally, an unknown number of recipients of some low-income program benefits will receive less than expected. The maximum budget cuts in these two minor programs will total about \$5 billion.

Another of your news items indicates that this budget cut will be completely offset by economic, military, and diplomatic aid to Israel. Israel has requested nearly \$4 billion in aid, a supplemental amount of \$750 million has already been considered by Congress for 1986, and we will spend additional millions for U.N. expenses on behalf of Israel for peacekeeping and other expenses in Lebanon, West Bank, Jordan, The Sinai, Gaza, etc.

I intend to notify all members of Congress from Washington that I think it is improper to continue aid of any kind to Israel in view of the mandated savings from the Gramm-Rudman Act, which would in effect take promised benefits from about 3 million U.S. citizens in order to give it to about the same number of Israeli citizens.

The ban would be in line with a 35-year-old Arab League decision to boycott companies doing business with Israel. Coca-Cola is on the boycott list of the 21-nation league, to which Sudan belongs.

## Boy Scouts hoping to 're-elm' the country

CONCORD, N.H. (AP) — The Boy Scouts of America and a New Hampshire-based group hope next summer's re-dedication of the Statue of Liberty will be a catalyst to help a national "re-elm-ing" program take root.

The Elm Research Institute is growing tens of thousands of trees resistant to Dutch elm disease and distributing them nationwide with the Scouts to replace millions of elms the disease has mowed down.

Institute and Scouting officials are coordinating the planting of tiny American Liberty Elms with the Statue of Liberty ceremony July 4. New York state has named the tree a symbol of liberty, to be included in many Statue of Liberty centennial events.

John Hansel, the institute's executive director, said plantings are to begin at the statue's base — or as close to it as possible — and continue for 450 miles in communities along the Hudson River to the river's source at Lake Tear-of-the-Clouds in the Adirondack Mountains north of Albany.

According to the plan, while Scouts plant 6-foot trees along the Hudson, thousands of tiny elms

will be planted in Scout nurseries around the country.

"The New York planting will be the torch being carried through the statue's home state," Hansel said, adding "it's up to the Scouts to take the torch to communities around the country and have simultaneous plantings. We hope many troops will start nurseries on that date."

Under the Institute's "Johnny Elmseed" program, Scouts who choose the tree-planting project survey communities to find mature elms, which can be treated with a new fungicide that wards off Dutch elm disease. They ask private elm owners and communities where the trees are on public property to buy a new tree or the chemicals to treat an existing one for \$25.

For each purchase, the institute donates a tree tagged with the donor's name to the troop, which will establish a nursery. After two or three years, when the trees become 8 to 10 feet high, they are replanted in a public place.

The institute donates a 6-foot elm ready for planting for every 10 trees sent to a nursery.

"The Scouts show remarkable

resourcefulness in their ideas of community service," Hansel said. "They think nothing of going into the mayor's office and asking for a plot of land."

He said plots the size of parking spaces yield 100 trees.

"By next spring, we hope to have 100 nurseries, and if we can get 100 properly located, such as Central Park or fairly close to the White House, they will be an inspiration to everyone who sees them," Hansel said.

The link with the Boy Scouts was established after a 12-year-old Scout in Sebago Lake, Maine, read of the elm restoration project and asked the institute for help in an Eagle Scout service project.

Sean McNitt planted 70 new elms 2 1/2 years ago. The institute publicized his effort in a newsletter and was inundated with requests from Scouts around the nation. The institute got in touch with national Boy Scouting officials, who endorsed the program for their 412 councils.

In Tewksbury, Mass., Scout leader Richard Hill and Troop 47 plan to approach conservationists, business and community leaders,

service organizations and senior citizens' groups to donate plots or buy trees.

"So much of the town is getting developed," Hill said. "This is a good way to restore some trees."

He hopes to have 60 trees donated this spring.

In rural eastern Illinois, Don Parker, executive of the Two Rivers Scouting district, plans to use national Scouting Environment Day, April 26, as the focal point of an elm-planting project in conjunction with local service organizations.

He said the environment day and another scouting program, "Save Our American Resources," are geared to conservation projects and "increasing the boys' awareness of conservation and fact that everything on Earth is interrelated to everything else; if you damage one thing, you tend to damage the entire Earth."

He hopes to be able to plant 20 to 25 elms in his district, near the Indiana line about 130 miles south of Chicago, and eventually to spread the program to the entire Frankfort Scouting council in Illinois.

# Weinberger warns Americans to be ready to fight

WASHINGTON (AP) — Military intervention may be needed to counter Soviet-sponsored aggression around the world, Defense Secretary Caspar W. Weinberger said in a speech warning against major cuts in Pentagon spending.

"One out of every four countries around the globe is at war," Weinberger said in remarks prepared for delivery to the opening session of a two-day Conference on Low-Intensity Warfare. "In virtually every case, there is a mask on the face of war. In virtually every case, behind the mask is the Soviet Union and those who do its bidding."

Secretary of State George Shultz was scheduled to address the conference today.

Weinberger deleted his remarks on U.S. intervention from the speech he made Tuesday night. The text provided in advance by the Defense Department said some of his prepared remarks would be deleted from the delivered speech for the sake of brevity.

Fred Hoffman, the Pentagon's deputy assistant secretary for public affairs, was asked whether the remarks were dropped for any reason other than to shorten the speech.

"I don't think it has any significance," Hoffman said in a telephone interview Tuesday night. "The long version was for the record. The short version was for brevity."

In the prepared text, Weinberger said low-intensity warfare includes terrorism,

insurgencies, guerrilla wars and those conflicts described by the Kremlin as "wars of national liberation," a phrase the defense secretary called "an Orwellian corruption of language."

Americans should not rule out military intervention, despite bitter memories of the Vietnam War, he said.

"We must decide if our interests justify intervention. We must decide if the leadership of the country threatened is capable of using our assistance to proper effect, which is to say for the security and well-being of the nation, rather than merely to sustain itself in power, and to reinforce those abuses which may have contributed to the nation's difficulties from the beginning."

"We cannot permit our disdain for some imperfect regimes to bring forth far worse alternatives," he said.

In his actual speech, Weinberger repeated his warning against reversing President Reagan's military buildup, as may be required under the balanced-budget law passed by Congress late last year.

He urged Americans to "discover not merely how to end the destruction of liberty, but how to reverse it, and restore what has been destroyed," he said, citing the Soviet allies of Afghanistan, Angola, Cambodia, Nicaragua and the "new colonies" of Eastern Europe — Poland, Hungary, Czechoslovakia, Bulgaria, Romania, and East Germany.

## Girl gets heart of boyfriend who said he would die

PATTERSON, Calif. (AP) — A 15-year-old boy who learned that his girlfriend needed a heart transplant told his mother three weeks ago that he was going to die and that the girl should have his heart.

Felipe Garza Jr. died Saturday after a blood vessel burst in his head. His family followed his wishes, and Felipe's heart was transplanted Sunday to Donna

Sanchez said he had thought Felipe was in perfect health, but some friends told him after the death that the boy had been having headaches and blackouts.

Donna, 14, who also lived in this farming community 75 miles southeast of San Francisco, had just learned that she had an enlarged heart and needed a transplant.

## Moscow on 'Rocky IV' — not exactly a rave review

Reuters MOSCOW — A Soviet newspaper today said that "Rocky" and "Rambo" star Sylvester Stallone made up for his lack of eloquence in movies with his hatred for communism and the Soviet Union.

In a report from Washington, the government daily Izvestia centered its attack on Stallone's latest success, "Rocky IV," in which the heavyweight hero of the first three "Rocky" films takes on a villainous Soviet boxer.

"Don't worry," it soothed the U.S. cinema audience, "although the one with the hammer and sickle is a head taller, your favorite will not let you

down — he sweats rivers and loses a bucket of blood, but he stays on his feet."

Quoting the publicity posters for the film, Izvestia said they were like an ax handle beating on the head with the message "Get ready, the third world war is coming."

The report, by Alexander Palladin, Washington correspondent of Izvestia, said the actor makes up for his screen reticence "with his overflowing hate for communism and the Soviet Union, contaminating his fans with the same feelings."

In the United States, "Rocky" has been one of the most popular movie releases of the holiday season.

#### QUO VADIS ORDER OF MALTA?

From sources in Rome and Paris, we have lately received some shocking information concerning certain most unwholesome 'goings on' among the Knights of the Sovereign Military Order of Malta. These happenings threaten to create a scandal of dimensions comparable to the scandals revealed some years ago in Roger Peyrefitte's illuminating book 'The Order of Malta'. Indeed, some of the characters mentioned in Peyrefitte's remarkable work again feature in this latest scandal.

It would appear that a certain well-known High Dignitary of the Order and a member of its Sovereign Council has for the past three years been carrying out a campaign of denigration against one of his 'Conferrés', an Ambassador of the Order who is of British nationality, who had for many years been active on behalf of the Order overseas at his own expense, in the diplomatic and charitable spheres.

The apparent reason for the attacks on the British Knight is that he has refused to hand over the beneficial results of his work to a young and intimate friend of the High Dignitary in whom the British Knight does not have full confidence.

The campaign of denigration commenced by the High Dignitary began three years ago when he made a series of false allegations concerning his Conferré as a pretext for his dismissal. These allegations were immediately officially disproved. The High Dignitary then attempted to bring a Court Case against the British Conferré alleging inefficiency and faulty book-keeping. This case got nowhere. Thwarted in his purpose, the High Dignitary then induced another retired Ambassador to accompany him to the Embassy of the Country where his British Conferré was working, and denounced him secretly, stating that he had been involved in espionage, currency manipulation and other crimes. As a result the wretched British Ambassador of the Order was arrested in his office by the Police, and severely interrogated — but set free as soon as his innocence was established. In a case brought by the British Knight against the

High Dignitary, the latter swore an oath in Court that he had never made this denunciation, thus committing perjury.

The High authorities of the Order have so far taken no steps to obtain justice for the maligned British Knight. On the contrary, they seem to be trying to cover things up. The Vatican Authorities are now investigating the matter in the light of the Order's principles and Canon 220 which states: "No one may unlawfully harm the good reputation which a person enjoys, or violate the right of every person to protect his or her privacy."

## Flights to Soviet Union to resume

NEW YORK — The Soviet airline Aeroflot and Pan American World Airways yesterday announced schedules for the resumption of service between the United States and the Soviet Union for the first time since 1983.

Service between the two countries is scheduled to start April 27, a Pan Am spokesman said.

President Reagan revoked Aeroflot's landing rights in New York and Washington on Dec. 29, 1981, in response to the Kremlin-backed imposition of martial law in Poland. He reaffirmed his decision in September 1983 after Soviet jets shot down Korean Air Lines Flight 007 over the Sea of Japan.

Landing rights for Aeroflot were reinstated shortly after the Geneva summit between Reagan and Soviet leader Mikhail Gorbachev.

## U.S. kept N-tests secret, group says

WASHINGTON — The United States conducted at least 12 and possibly as many as 19 unannounced underground nuclear weapons tests between 1980 and 1984, an environmental group asserted yesterday.

Citing research based on public sources of information, the Natural Resources Defense Council said the tests defused the Reagan administration had stepped up the pace of nuclear weapons research, despite government figures indicating a stable rate of testing from the Carter administration.

Eight of the unannounced tests could be confirmed based on information obtained from the U.S. Geological Survey or the Hagfors Observatory in Sweden, which detected them in 1983 and 1984, the report said.

# Reagan mystifies reporters with punch line minus story

WASHINGTON — Is Ronald Reagan tiring of his famous anecdotes? Has Don Regan told him to knock off the suany stuff and get down to business? Is the president, perhaps, beginning to worry that he may go down in history as the Henny Youngman of Pennsylvania Avenue?

Whatever the reason, at his Tuesday night press conference he delivered a punch line but left out the story.

On the subject of tax increases he had approved, Reagan argued that he'd been promised "\$3 in

spending cuts for every dollar of increased revenue.

"I never got the \$3," he said. "So I'm like the fellow in the story, I'm still yelling, pay the \$2 — only three in my case."

What story? An informal poll of reporters at the news conference drew a blank — no one got the reference.

What Reagan had in mind, it seems, was a variation on an ancient joke. White House spokesman Pete Rousell said Wednesday that it goes something like this:

A man is charged with a traffic violation, or with spitting in a subway, or whatever, and is fined \$2. He hires an attorney, who proceeds

aggressively to challenge the charges in court. The louder the attorney protests, the higher the judge raises the fine.

Finally, in frustration, the defendant yells to his attorney: "Pay the \$2! Pay the \$2!!!"

Dan Brenner, an attorney at the Federal Communications Commission and a local stand-up comedian, said the story is an old vaudeville routine. "The way it goes is that the guy is saying from the beginning, 'Pay the \$2,' and the attorney is saying 'No, no. We'll fight it.' Soon the guy loses his house, his clothes, his car, and the skit ends with him walking around the stage in a barrel."

"Yeah, yeah, yeah, I remember the story. PAY THE \$2! PAY THE \$2!!!" confirmed the real Henny Youngman, when reached in Florida where he was performing with Milton Berle. "You see, the president was in show business, so he remembers all these stories. It's a hundred years old. I did the skit once. Everyone did it once.

"This guy gets a ticket, and his lawyer says, 'Don't pay it, I'll handle it.' So he keeps telling the lawyer, 'Pay the \$2! Pay the \$2!' So the guy ends up getting thrown in jail and losing all his money. And he says 'Will ya pay the \$2?' It's funny. The point is, don't make a federal case... just pay the \$2."
