

## DID YOU KNOW YOU HAVE AN EXACT DOUBLE LIVING ON VENUS ?

### HOW A MESSENGER FROM VENUS ALMOST LOST HER MESSAGE FOR HUMANITY ( THE IMPORTANCE OF PLAYING DOWN THE PHENOMENON )

#### QUESTION:

We received a letter from an entity in Ventura, California, who goes by the name of Vi Venus. I want to read a little of her letter and some excerpts from a book called *The Psychic World Around Us*, which did a little talking about this entity who came from Venus. I'd like to ask Awareness if we should get involved with the publications she is referring to and also several things listed in the book that she channeled, I'd like to ask about. She writes:

"Dear friends in the light. I do not know how my name and address reached your mailing list, but I am grateful, for it affords me the opportunity to explore a new road. You found me, and I wonder if you know that I am from the planet Venus. I have been on earth for 20 years, serving God and all as the spirit within me guided. For the past 13 years my identity has been known. From 1967 to 1972 it was headlines in the city of New York, Detroit, Michigan and Portland, Oregon. In this past year it was news again in the cities of San Jose, San Francisco, and Oakland. In the in between years I walked away from the glaring lights to walk this nation and meet one to one the children on earth who hungered for truth and thirst to know the reality which is Divine Love.

"I have written works and tape recordings which, for the most part, have been on hold for a very long time. I write to you because I have been blessed with the go-ahead to make these works available to all. Now is the time, for so many of us.

"*Between Two Worlds*, copyright 1967 by Vi Venus, a 78 page book sharing this Venusian's life on earth before and after she began again in the truth. *Heart to Heart with Vi Venus; To Lighten This Planet with Love*, copyright 1969; a two hour cassette tape recording telling by Vi Venus, of how she got here to earth, why she came, life on Venus, and how to solve the problems on earth. Transcript copyright 1972 by Vi Venus, 41 pages handwritten of a tape recording done in that year also telling the whole story of Venus and earth; *Enter Venus*, copyright 1968 by Vi Venus, the truth in a story form with a cast of four, gentled by humor that the earth may see, and *Letters to the Children of Earth*, a 2382 word article on the background of Vi Venus and the solution for earth. There is more, but these are all I shall list for now. I write to you to alert your interest. If you publish works other than bi-monthly reports, would you be moved to consider any of the above work for publishing; and if you have your hands full, would you know of any group, publisher or individual who might show interest? *Between Two Worlds* has had three editions printed through love offerings and 1300 copies given away until said publisher is found. If God provides I shall have a fourth edition printed for distribution. As for the tapes, I shall once again, until said recording publisher is found, send these forth one by one as orders come in.

"I'm available for speaking engagements, in speaking and singing. (Yes, I have songs too), and I shall be looking to advertise as Love provides in publications here and there. Whatever help you can be I will appreciate. Whatever interest you show will simply be part of the plan. I write to you because I feel that through each other we can enrich our efforts for a glorious cause. Gratefully. Vi Venus."

## COSMIC AWARENESS:

This Awareness indicates that there appears to be some value in the message which is available through this entity, particularly reinforcement of concepts of Unity, Love, Mercy, in human affairs. This Awareness indicates that there are many various energies connected with this entity which can bring about increased need for activities and concerns wherein excessive involvement with the entity occurs.

This Awareness indicates that wherein some light relationship is effected to allow for examination of the material and a kind of evaluation as to which of the manuscripts would be of value to you, that this kind of relationship can occur without excessive energies and may be of some value to your organization and to the entity.\*

[ED's Note: Later when Vicki noted my enthusiasm and interest growing in this beautiful blond creature from Venus, she reminded me that the examination would be confined to her tapes and publications.]

This Awareness indicates that essentially this entity as having moved through a particular type of experience such as could be characterized as a psyche warp,--this not being a time warp or space warp, but rather a warp in the psyche in which the entity has reflected back into other vibrations as memory; and essentially, the entity believes the memory to be real and part of this present incarnation or flow of energies into this incarnation, and the entity perceives this to be a unique experience which can and should have great attention, and can have great value to humanity. That this again, is a situation in which an entity needs first to sell the phenomenon in order to receive the attention that would allow entities to focus on the message. That the message again, being similar to that of others who give spiritual guidance to entities on this plane, the message being presented by one who makes certain self-claims. That this method of presenting a message is that which does have a certain value in terms of human consciousness. This Awareness indicates it also has certain limitations.

This Awareness indicates whether the claims of an entity are true or not, the phenomenon involved is that which will either turn on or turn off a listener before they get to the message. That they need either to accept the phenomenon of the messenger or to reject the messenger and thereby avoid the message. That in any case, this method has certain liabilities as well as certain benefits.

This Awareness indicates in this particular instance, it appears that the liabilities are greater than the benefits in that entities who accept the entity's claim to be from Venus, while giving this much attention, are so fixated on the claim and the phenomenon that they do not care to pay attention to the message, and the message is totally lost and overshadowed by the claim of being from Venus. That whereby the entity

could play down the claim and promote a message which has great value to the earth, this then could be worthy of such attention; otherwise, it appears that it simply is attention wasted on the individual and lost on the message which the individual has to offer. This Awareness suggests that this can, of course, be brought into balance wherein the individual chooses to put greater significance on the message which is to be offered, and allows the personal significance to be but supporting of that message.

### The Cosmic Awareness Channelings Fit this Category

This Awareness indicates all that has been stated in this message regarding this entity can equally be applied to the present phenomenon of the present Interpreter channeling this Awareness. That this phenomenon as also something which can attract attention to itself, and if overemphasized, can result in a loss of the message; and whereby this would occur and the phenomenon of the messenger be overemphasized, then the activities of this channel, this organization, and these energies involved would become of little meaning, other than to give attention to the individual for his accomplishments or some other significance in effecting the phenomenon.

This Awareness indicates that there are hazards in delivering messages out of the base built on phenomenon; yet in some ways there are certain benefits, and when this is done in balance, this can be quite useful. The action of channeling in this manner through this Interpreter is such that many entities, particularly the various religious groups, can be turned off, or spiteful toward this Awareness, toward this channel, and toward these messages without ever, in fact, looking at the messages, simply because they reject the phenomenon. That likewise, others can be turned on, their consciousness heightened, their curiosity increased because of the phenomenon, and will look more deeply at the message than if someone simply spoke these messages while sitting in a chair, across the table from them.

This Awareness indicates that in this sense, the messages gain attention because of the phenomenon. However, if the messages are not worthy of the attention gained, then they eventually will be overlooked, discarded, and the interest in the phenomenon will be lost and forgotten also. Therefore, there are hazards and benefits in this type of communication. Sometimes there are also necessities to rely on such extreme measures to communicate to humans, particularly when the other forms of communication systems are controlled by those forces which do not wish to encourage concepts of Universal Laws, concepts of Unity among all living things, concepts of Love for all nations.

This Awareness indicates when the communications systems are being used mostly for forces which would divide, which would promote deception, hostilities and violence, then often it becomes necessary for the forces of Light to rely on unusual messengers or unusual phenomena to allow the

messengers to give forth their words. That for this reason, entities may find many entities making self-proclamations, many claiming to be the Divine Channel, and many claiming to be Divine incarnations on the physical plane, some even claiming to be the Son of God returned for the Second Coming and Rapture of the souls of humanity.

This Awareness indicates that all of these entities making these various claims can be believed or rejected. This Awareness would prefer *Its* listeners, those reading this message, to think more deeply about the message offered from these entities and to forget their claims of supernatural powers or status. This Awareness suggests the truth is in the message, if it is there at all. The proof is in the pudding. The container is but a covering and advertisement; and the phenomena should be minimized, while the message maximized and examined under a microscope to determine whether it has value, truth, and meaning, or not. This Awareness suggests that you take the microscope off of the phenomena, and place it over the message.

### WHAT LIFE ON VENUS IS REALLY LIKE

(HOW TRUE IS THIS ACCOUNT BY VI VENUS?)

#### (FOLLOW-UP QUESTION):

This entity Vi Venus sent a copy of a few pages from a book called *The Psychic World Around Us*, written by Long John Nobel, with an introduction by Jacqueline Suzanne, and since we have never asked Awareness for a description (to my knowledge anyway) of life on Venus, I'd like to read a little excerpt of what she claims is life on Venus. (This author is also a radio announcer who is writing this story).

"...During the next half hour we learned, among other things during this interview, that every person on earth has his exact double somewhere on Venus. Unlike the situation here, all is peace and tranquility on Venus. There are no wars, no famines, no diseases.

"In terms of our calendar, Venusians live to be hundreds and thousands of years old. The planet has cities and farms, theaters and TV sets, Negroes, Protestants, Jews, Catholics, Moslems, etc., schools and shops, horses, camels, dogs, parakeets and ice cream. In fact, no matter what it is, if we've got it here, they've got it there.

"The problem of earning a living as we know it has been solved on Venus. You can have anything your heart desires simply by utilizing your mental energy, and presto! It is yours. People can travel from one point on the planet to any other, in a matter of seconds, again through mental powers that the good people of the planet have developed. There are no cars on Venus so there is no air pollution of any sort. As Vi Venus described her home, "Venus is everybody's definition of paradise."

"A half hour passed and we stopped for a couple of commercials. When we came back I gave the questioning chores to the panel. As time went on, a more complete story of Vi Venus and her trip to earth developed. According to her, the only time a Venusian can make the voyage to earth is when his counterpart here dies. At the exact moment of death, the Venusian can step into the earth body and assume that role. Vi Venus claimed to have taken over the human body of a girl here who had committed suicide..."

It goes on and on, but you get the idea. I'd like to ask Awareness if that's a more or less accurate description of life on Venus and if that is the way entities from Venus incarnate on the earth plane?

#### COSMIC AWARENESS:

This Awareness indicates that there is much accuracy in regards to that message. This Awareness reminds entities of Nikola Tesla, who also was one who claimed the heritage of Venus. This Awareness indicates that essentially, this as a different vibratory rate which is being discussed in this message, this on a different frequency. That entities of physical body who would attempt to move to Venus in physical form would find it impossible as a place to live, under present conditions, without much great alteration. This Awareness indicates that however, in terms of psychic energies of an entity, that this can traverse vibration fields and octaves so that entities can live in what might be termed 'uninhabitable places' as far as physical life is concerned, and find these places as being almost paradise. That likewise, entities can live in different vibration rates which are essentially almost a Hades or hell. This Awareness indicates that the physical plane is but one of many mansions in which the soul may travel; and when entities are locked in to the physical plane, it is difficult for them to recognize any other existence outside of that physical plane. This much as an entity who is totally hypnotized by a television set, watching with great interest the performance occurring, the story line, the plot, and



failing entirely to recognize what might be occurring outside, behind, and in the world round/about the entity.

This Awareness indicates that this entity, as having experienced through this psyche warp, or this kind of movement through the vibrations, and capable of recalling into that other vibratory rate, or what may be termed "dimension", does have a powerful message and the message essentially is one of peace and harmony; that it is a message which everyone has heard before, but is told in a new way. It is in this sense that the message has value. For even though entities are fed from spiritual-minded teachers which consists of Love, Mercy, and Harmony, entities often like to have these meals prepared with some imagination, some concern, some dash of flare and garnishment, to make them interesting, intriguing, appetizing and palatable.

This Awareness indicates that this can be found in this entity's messages and, in this sense, has value. This Awareness suggests that entities need not make a religion of this entity's message to be able to enjoy and learn from the message; -- that entities may in fact benefit greatly by this message without necessarily even believing it to be true. For in all things there are ways of extracting something of great benefit when entities desire to do so.

### DOES EVERY PERSON ON EARTH HAVE AN EXACT DOUBLE ON VENUS?

( MORE ON THE PHYSICS OF SOUND )

#### (FOLLOW-UP QUESTION):

Would Awareness expand a bit more on this concept that every person on earth has his exact double on Venus?

#### COSMIC AWARENESS:

This Awareness indicates that this is better understood not as an exact double; that it is better that entities recognize the physics of sound, whereby a note is played on a string, the string is vibrated and sounds, because of the movement back and forth of that string. The string vibrates not only in the middle, but the string is slapped in such a manner, whipped in such a manner, that the quarters also vibrate; and when the quarter strings vibrate, it creates another octave of sound which is heard simultaneously, but not with the same volume as the sound of the string being plucked; and these two sounds being of different octaves, resonate together. That each quarter of the string also whips in such a manner as to create a further division, causing each eighth part of the string to vibrate, creating still another sound with diminishing volume, which is one octave higher yet. This Awareness indicates therefore, in one sound you have at least three octaves available in terms of vibration, -- one being of strong volume, another

of much diminished volume, and still another diminished even further than that.

This Awareness indicates that each of these notes may be termed C; the note C on the scale. That while each of these notes is C, it is of a different octave, therefore is not identical in nature, not exact double of each other, but is in fact an alteration, while a similar frequency, and of different octaves.

This Awareness indicates that in a similar way, the notes or knowers, the nodes of consciousness that are prevalent within an entity's being, have contact through vibration to all those other notes or nodes of consciousness wherever they may be within the universe, which are on the same octave frequency or which are on higher octave or lower octave frequencies akin to their own.

This Awareness indicates that in this sense a portion of one's being may be in various places throughout the universe if the entity includes in his or her definition of one's being all of those frequencies or vibrations which are attuned to the entity's own vibrations.

This Awareness indicates that entities who prefer not to think about the metaphysics of sound, and prefer to think only of the physics of sound, the one note and not the many, may also find that they prefer to think of themselves as absolutely unique, having no similar reflectors anywhere in the universe, and having the absolute control and only system of this unique vibration they call "self". This Awareness indicates that others may recognize harmonious vibrations extending from themselves toward others, may recognize harmonious vibrations extending from others to themselves, may also recognize distortions in vibrations when coming close to certain entities, may even recognize dissonance in a relationship with another, and in this manner the entity may become very acutely cognizant of vibrations of one's being.

This Awareness indicates that such entities may also in meditations, learn to tune themselves to the vibrations of a planet, and to feel those vibrations, and in so doing may travel on those energies and vibrations into that dimension on which that planet's energies sit; and in the action of entering on those vibrations, the entity may in fact begin to envision, or have visions of life on that planet. The life of course, would be as presented by the vibrations of the planet.

This Awareness indicates that Venus as being a planet of Sensitivity, Harmony, Love; therefore the vibrations take on these characteristics when entities are attuned to this planet, and the entities who would attune themselves to other planets will find themselves experiencing different kinds of feelings and attitudes as they approach the vibratory rate of that planet.

This Awareness indicates that in terms of the astrological interpretations of these vibratory rates, that these may be used with complete acceptability in terms of the types of interpretation given to the vibrations: That essentially the astrological interpretations of planets is an accurate description of the vibratory energies emitted by these planets. And wherein entities wish to attune themselves to these vibrations, they may simply focus on the astrological interpretations of the planetary influences, and in this manner will begin moving along these vibratory chords, or lines, to those dimensions, those vibratory dimensions, and may experience life on those planets.

This Awareness suggests however, that entities in doing this, not to make this so significant that you become egotistical about your experiences, but to simply become aware of your abilities to extend your consciousness beyond the confines of your physical dimension. This can add to your awareness of the universe. This Awareness suggests however, that it is important to know the acceptable norm of the levels of reality within your world, so that you do not move too far away from acceptability, and in so doing, alienate yourself from other entities in your society.

### ALL ABOUT RAMTHA -- THE 25,000 YEAR OLD SPIRIT AND HIS CHANNEL

(MEDIUMSHIP, CHANNELING, AND WHAT COSMIC AWARENESS IS NOT)

#### QUESTION:

There is an entity named RAMTHA who is supposed to be 35,000 years old and who speaks through a person named J.Z. Knight of Washington State. This entity is very popular and is reaching ever-increasing numbers of people. We have watched about five videos and find the information to be very much

#### COSMIC AWARENESS:

This in the affirmative. This Awareness indicates that the entity Lobsang Rampa also as having had a similar (though somewhat different) experience, in which he traded bodies with one who wanted to die, and he himself sought to continue living through the healthier body.

like Cosmic Awareness messages. It is very moving emotionally, with lots of love generated. RAMTHA claims to be "The Ram" father of the Hindu Indian race and part of a group who left Lemuria and became outcasts in Atlantis. Would Awareness please comment about this action or movement?

## COSMIC AWARENESS:

This Awareness indicates that this entity having a very profound purpose at this time in communicating with the mass consciousness on this plane to allow the mass mind to experience certain vibrations which have not been felt on this plane for approximately 25,000 years when the higher Lemurian energies began to diminish rapidly. This entity's reappearance at this time as that which is associated with the resurgence of the Aquarian Age energies which occurred approximately 25,000 years previously. And this energy as that which is assisting in the preparation of consciousness to accept and to understand and to receive the vibrations that are available in the Aquarian frequencies so that those beings who are sensitive and open enough to accept these energies and concepts, will begin to explore in ever-increasing interest those metaphysical ideas, concepts and records of the past which will eventually lead entities into the recognition of their own divinity and into the experiencing of the divine forces which can begin to express through the individuals who are open to these energies.

This Awareness indicates that there are different ways whereby entities can express through so-called mediums; there is that which is the conscious medium, there is also that which is the active medium and the inactive medium.

This Awareness indicates that this entity J.Z. Knight as one who operates as an awake and active medium. She simply allows this entity's energies and consciousness to express through her. This Awareness indicates that it is seen as being a mutually agreeable action, one wherein she is not violated but shares herself to allow this entity a stage from which to speak. Many entities are opposed to mediumship in any form, and see it as a violation to the individuality and free will of the medium and to those who receive the messages, even to those who speak through the medium.

### The Many Pitfalls of Mediumship

This Awareness wishes to comment on this briefly, for it is true that in many cases mediumship can be quite dangerous to the medium; this also can have an effect adversely to those who listen to the messages of the medium if those messages are false or distracting to one's soul growth. Even when messages are valid, mediumship can have many pitfalls for an entity, particularly when the entity does not have the discernment to determine what kind of force is speaking through or entering into the body of the medium; for the spirit world is not that much different from the physical world, in that it contains frauds and imposters and deceivers who give you just enough to get you to trust them, then steal away your energy for whatever motives they may have. But also like the physical world, there are many highly evolved and sincere beings in the spiritual realms also.

This Awareness indicates that because of the dangers involved, many entities simply state that you should avoid mediumship altogether as a way of preventing any possible violations to an entity. As a general rule this is good advice. In reference to some particular entities however, when they have developed to a particular state of consciousness, whereby they have a vibration level which is such as to not permit the lower spirits to speak through them, these entities are able to channel a very high quality information that allows the medium to benefit from the association. Unless an entity has fully formed his or her individuality to a degree where further development on this plane is not needed, the individual should not become involved in mediumship, as his or her will and individuality could be overpowered or hindered in its development by an imposing spirit.

This Awareness indicates that if one thinks of a body as paralleling one's home and if one fails to be discerning and allows the body to let just any spirit enter, (just as one can allow any outsider to enter one's home), one can see that the body or the home could be in jeopardy by the intruders and one could lose control of oneself or the self's "housing". Using this parallel one must realize also, however, that many entities invite others into their homes and benefit greatly from such invitations whereby the visitor gives many benefits to the host of the home. But one must keep in mind that the body is more sacred than one's home, and needs to be guarded and protected with greater concern, thus the analogy is not a true parallel in comparing the body to the home in relation to guests and intruders.

Likewise, in reference to certain entities who have fully developed their rightful domain over their own body by having fully developed their individuality and know, in fact, who they really are, and are well established, disciplined, and know what they are doing, invite a spirit of high quality to enter,—this may be likened to a welcomed visitor in the home. This is a less dangerous situation for mediumship, wherein such a one allows the visitor to communicate through the door or mouth of the individual. This Awareness indicates that some such actions can be quite beneficial to the channel and others who wish to hear what this spirit has to say.

Yet it can also be very dangerous if the wrong combination of intrusion occurs wherein an entity allows spirits to enter his or her home, his or her body, or take up residence in such body. Possession by spirits is not uncommon among mediums, though most do not hear of these problems. And many mediums can be led into insanity by ill motivated spirits simply because they trust these intruders in their body-home. Becoming a medium is easy since there are so many spirits who wish to speak through anyone who is open to them; but it is also a very dangerous business with far more losers than winners.

Because the dangers of mediumship are generally greater than the benefits received, this Awareness indicates therefore, *It* wishes entities to understand that as a general rule mediumship should be avoided, though there are exceptions to the rule. This Awareness indicates in most cases mediumship involves those low level spirits which can have extremely hazardous effects on individuals, even leading to insanity or death of a medium.

In the case of entities such as Jane Roberts channeling Seth, or J.Z. Knight channeling RAMTHA, these are exceptional in that the entities in the channeling position play host to very advanced beings. Such exceptional actions and relationships do bring profound information to this plane.

#### The Difference Between Mediums and Interpreters

This Awareness wishes to comment on the difference between mediumship and interpreters for this Awareness, as Awareness interpreters are not spirit mediums since this Awareness is not a disincarnated spirit. There are so many people who cannot grasp the difference and erroneously refer to this Awareness as a "he" or "she" as if *It* were a disembodied spirit.

This Awareness, being Universal Mind, impresses the Interpreter with feelings and images that translate into words which the Interpreter then speaks. Thus, far from being a medium allowing this Awareness to enter or take over the body of the Interpreter, it is the other way around: The Interpreter surrenders self to merge with the body of this Awareness to read or interpret answers to questions while in attunement with Cosmic Awareness, thus getting a "Cosmic Awareness perspective" on the issue raised by the question.

This Awareness indicates that *It* is a state of perpetual Universal Consciousness and the Interpreter must temporarily move into attunement with that state and interpret information from a brief encounter with Universal Consciousness. There is no spirit union involved in this action, there is no entity speaking through this Interpreter, but rather the Interpreter is attuned to this Awareness and interpreting information from this state of consciousness.

This Awareness indicates that there has been much confusion in regard to the role of an interpreter due to the misconception that this was a kind of mediumship role and that this Awareness was an entity. This Awareness indicates that many entities in fact refer to this Awareness as being an individual person in spirit form, whereas this is not the case and this Awareness emphasized from *Its* first communications that *It* did not wish to be named and personified, but wished to be considered as "Awareness" which is not a name for a person, but rather is a word defining a state of consciousness. For those still having a problem with this, this Awareness suggests you

refer to *It* as "The Awareness" or "The Universal Consciousness," as such a term will be more difficult to translate as a name for a personality. Just remember, this Awareness has no spirit or physical face, but is behind every face in the universe.

#### IS RAMTHA J. Z. KNIGHT'S HIGH SELF ?

#### (FOLLOW-UP QUESTION):

In mediumship, what is observed typically is for the channel to go into a very relaxed state and another entity speaks through as the possessed channel body sits in a chair. With RAMTHA, this entity actually gets up, moves about and touches, hugs, etc. for quite long periods of time. Is this a different kind of mediumship? For example, is RAMTHA J.Z. Knight's High Self coming through?

#### COSMIC AWARENESS:

This Awareness indicates this is a conscious-active mediumship. This Awareness indicates that the term "J.Z.'s Higher Self" as that which can be seen as somewhat appropriate in describing the relationship, for the union between J.Z. and RAMTHA is greater than that of spirit and medium.

The past life relationship between J.Z. Knight and RAMTHA is best researched through RAMTHA as some information has already been given and as the RAMTHA channel has more energy to reply and explain this information. This Awareness indicates that it appears the vibration or energy composing J.Z. served as an energizing force for assisting the entity RAMTHA in his earlier incarnation in Lemuria. This does not mean that these two entities have always been linked together throughout time from that point to this point, but rather that they have had a relationship that stretches back many thousands of years and this relationship has allowed them to come together many times, and in this particular sojourn their purpose and relationship is such as to have an impact of considerable significance on consciousness at this time.

This Awareness indicates that the energies of RAMTHA could not presently be expressed in this manner except for this entity J.Z. Knight.

ED's Note: the importance of playing down the phenomenon, as indicated by Awareness in the previous reading regarding Vi Venus, could also apply to the RAMTHA phenomenon. Although this particular reading was given in September, 1986, and Awareness made no mention of this fact, it probably means that even with all the hype and TV covering of J.Z. Knight and the controversy she and RAMTHA are creating, the message RAMTHA is presenting to this plane IS getting through to a huge mass of people. Also, their team is slowly conditioning millions of TV viewers and the thousands who read the books and attend the RAMTHA seminars

into accepting the phenomenon of channeling and the notion that channeled information can have importance. The recent spate of Shirley MacLaine books and TV mini-series etc. is more evidence that the time for the acceptance of channeled material has finally come, if for no other reason that it makes entities think and question and ponder and react and discuss the phenomenon and the messages brought forth.

However, the channelled messages of RAMTHA, like the messages from other mediums and channels, including those who channel Cosmic Awareness, must be examined closely and questioned with discernment, for there is almost always some error involved. Awareness indicates that approximately 15% of the material it brought forth through the various Interpreters is in error, colored by the mind of the Interpreter who in such cases is not deeply enough into trance, or that the subject being discussed is too highly charged and freaks the Interpreter out.

Personally, I like the basic message RAMTHA is bringing forth, but some of the stuff he is saying is coming from less lofty heights. For example, RAMTHA has informed entities that "Mother Nature wanted to get rid of homosexuals",--hardly a message of love and assurance to millions of these entities on this plane at this time. He is also making apocalyptic, paranoid predictions such as California is about to sink into the ocean from earthquakes, Florida also will sink and New England's water supply will be poisoned by acid rain. He also advises entities that the Pacific Northwest is the safest place to live and has created a massive flight of entities into this area, many selling everything they own in order to make the trip. Of course, we have all heard this message before and if enough people continue to give it energy, it will all probably really happen. However, Awareness has given humanity the information that the future is not fixed, that consciousness can change the direction of energies in motion, and that there are enough aware entities on this plane who know this, that many of the calamities being forecast by psychics have been averted or at least lessened in intensity and impact. Evidently RAMTHA 'the enlightened one' somehow missed out on that one.

While on this subject of RAMTHA, quite a few of you have written to CAC asking our opinion of RAMTHA and his channel J.Z. Knight, after all the adverse publicity they have

recently received, particularly in the 20/20 TV story and the stories being put out by anti-New Age people, fundamentalists in particular. Also, many of you believe that because J.Z. charges so much for her seminars and 'intensives' that her message and her whole operation should be suspect. To all of this, I say: examine the message! How do you feel about the basic message RAMTHA is presenting? Does it ring true? Do you feel it rings false? Have you talked to anyone who took an intensive? I have, and they told me the message rang true to them, that somehow their life has been changed for the better, and if they had received the information without having to pay for it, they would probably have felt it was not all that significant.

So forget the fact that J.Z. is making millions, that her original operation was a church, a non-profit organization which she later discarded and became a profit-making corporation (Claire Prophet is supposed to be worth millions too), forget all that and examine the message she and RAMTHA are offering.

If you can't stand the theatrics and the oftentime over-bearing personality of this ancient spirit who speaks through J.Z. Knight, his simple, basic message can be found in the white book "RAMTHA" (which CAC lists in its book catalog, by the way)--forget the paperback "Voyage to the New World". And please, do stop writing us about how we feel about RAMTHA, for now you know!

I must confess, however, when I drive through Yelm (the home of J.Z. Knight) on my way to Mt. Rainier to ski, (Yelm is about 13 miles East of Olympia), I slow down as I pass her gigantic house and complex, recently fortified with a 12 foot wall and heavy iron gates that could have come out of "Citizen Kane". As I eyeball this incredible scene, which the local paper says runs into the millions of dollars, I am filled with a sense of awe and wonder, and perhaps a little envy that here at last is a psychic channel who actually MADE it big, who has no compunction about flaunting her wealth or even trying to justify it. This is a lady who understands the cosmic law of prosperity and has rejected that invalid premise that so many of us still have ingrained within, that true Spirit can only be expressed by the humble and the poor. Yes, as I drive through Yelm, I tip my hat to J.Z. and wish her all the luck in the world, for she is becoming a true mover of consciousness in some areas, and the 'Law of Gratitude' is returning the energy she has been giving in the manner she desires and enjoys. But to me the most impressive thing of all is that she is sowing seeds, important seeds, with great flair and style, making no sappy, saccharine attempt to 'religion' up her act, no cries and pleas to the hierarchy etc. She simply lays it all out with a straight face and laughs all the way to the bank. A really ballsy lady. (Avaton).

## IS THIS THE ENGINE OF THE FUTURE?

( WHO HAD THE INVENTOR MURDERED ? )

### QUESTION:

A question from J.M., Poteau, Oklahoma, which he has submitted twice, as he feels this is an important issue. "Would you please consider asking Awareness about U.S. patent 3679494 by Joseph Papft (?) an Hungarian, describing a new and revolutionary atomic engine which runs for thousands of hours without additional fuel, producing both mechanical and electrical energy without excessive heat build-up or dangerous radioactive substances?" [ Now, he's included an official one-page description of the device, which I shall read. ]

"The engine is a closed one cycle reciprocating engine which has no intake, therefore uses no oil and has no exhaust whatsoever. An hermetically sealed gas chamber is created by telescopic fitting of two cylindrical units, each open at the middle, permitting extension and retraction of the unit under the cycling pulses of the varying gas pressures confined within the chamber. One cylinder end connects to a rod and crank shaft, converting the linear motion of this cylinder to a rotary motion. The fuel is self-contained and hermetically sealed in the cylinders. The cylinders are charged initially at the time of manufacture, and this power supply will last for example, 60,000 to 75,000 miles of automobile driving with no fall-off in efficiency.

"The fuel consists of a combination of noble gases. After excitation by electrical pulses, a plasma beam is created momentarily from the gas with the lowest atomic number. As excitation ceases, the plasma beam destroys itself and a minute fission occurs with a small amount of neutrons ejected. The gases expand with great force, contract on signal, ready to repeat the cycle for the lifetime of the charge. This takes place in one millionth of a second, which is so brief that the ultrahigh temperatures cannot be absorbed in the cylinders. A layering of the gases also provides an insulative barrier. Only purified natural elements are utilized to create excitation. No man-made radio isotopes are utilized. These exciters are enclosed in separate containers within the cylinders. The almost instantaneous creation and destruction of the plasma beam signifies that no harmful radiation could be released accidentally, even if cylinders were ruptured at the precise moment of fusion, such as in an automobile accident. In addition, a number of safety features have been incorporated into the latest fusion engine. The engine in its hermetically sealed cylinder system emits no radiation, exhaust, or any chemical pollutants. It is the clean, practical and powerful engine of the future, based on an energy source that is inexhaustible."

His question is: "Does the engine really work substantially as described, or is it a hoax? And is it really

safe against radioactive leakage, and why was Papft really kidnapped soon after revealing the engine to President Nixon and Henry Kissinger, and was he shot while escaping his captors?" And he also wants to know if there is a real possibility that the engine eventually will displace conventional power plants in cars, trucks, airplanes and so forth?

### COSMIC AWARENESS:

This Awareness suggests the information as valid; that when assembled properly, this as workable and safe. This Awareness suggests the questions at the end be asked one at a time.

### QUESTION:

Is it safe against radioactive leakage or contamination under all possible conditions?

### COSMIC AWARENESS:

This Awareness indicates that this can be effected.

### QUESTION:

Was Papft, the inventor, really kidnapped soon after revealing the engine to President Nixon and Henry Kissinger, and was he shot while escaping his captors?

### COSMIC AWARENESS:

This Awareness indicates this appears to be in the affirmative, that the only area of unclarity is in the manner of his death.

### QUESTION:

Is there a real possibility that the engine will displace conventional powerplants in cars, trucks, airplanes, irrigation pumps, and other uses, or will the oil and other interests succeed in stopping its manufacture or distribution?

### COSMIC AWARENESS:

This Awareness indicates that this would not be possible at present time for such an engine to be built. This Awareness indicates however, that with proper atmosphere and conditions in terms of the political atmosphere and the economic conditions,--in terms of the power structure, wherein this was acceptable to this engine, this could be accomplished. That it appears the engine might be built for other purposes rather than public use during its initial stages.

This Awareness indicates that it appears that this will not be made available to the public on a large scale for quite some time; that the power structure must first fall or undergo radical change before this can be made acceptable. This too, is a possibility,--that there will be many major changes during the next seven years in all levels of economics, politics, and the power structures.

## WHAT CAUSES POOR EYESIGHT?

(LAX-OPTIC --A NEW WAY TO SEE WITHOUT GLASSES)

### QUESTION:

Member J.W. would like to know how much of poor eyesight is caused by childhood agonies, frustrations, angers or repressed feelings, and/or is some of it simply a structural inherited genetic defect? I have heard that nearsightedness is caused by the child being unable or unwilling to look to see what is happening in their life, in their family, in their environment, and this non-looking turns into eyes that don't see right. Would Awareness please comment?

### COSMIC AWARENESS:

This Awareness indicates that this does have some truth to it in that the child who becomes afraid of that which is "out there", may tend to close off, attempt to shut off the outside world, and in so-doing may shut down his or her vision process, not looking "out there", but looking only up close. That this can lead to the eyes becoming unable to focus outward.

This Awareness indicates that likewise, another entity may always be looking outward, and not interested in that which is present, and this entity may become farsighted rather than nearsighted. However, these are often attitudes which require many years to develop the reaction on a vision level. That in some cases the vision can be hindered over a very short period if the entity is experiencing great and heavy trauma during that short period and develops an attitude to deal with that trauma.

This Awareness indicates that *blind anger* is a term which is often heard; that entities who become excessively angry and who cannot express themselves and attempt to close off their own world, shut down their shop, refuse to look out at what is the reality,--this likened unto pulling shades,--such entities can indeed have great effect upon their vision. This Awareness indicates that this is not always the cause of poor vision; there are also chemical and biological causes which often occur.

This Awareness indicates that psychological causes are as common as biological and hereditary causes; that biological causes may result from poor diet, from a lack of zinc, or of chromium. Also, Vitamin A deficiency can lead to poor vision; that there are other combinations which in a deficient diet, may lead to poor vision. This Awareness indicates that a tendency toward diabetes, which is also associated with repressed anger, can also lead to poor vision.

This Awareness indicates that the diet and the psychological factors are not exclusively the cause of poor vision; that there can also be hereditary factors. That some entities are born with a particular horoscope which will indicate to a good astrologer that the entity will have problems in vision. That this can be pinpointed to such accuracy that entities

even working hard in terms of psychological, and in terms of dietary efforts, may still gain only a percentage of benefits from such effort, for they have an inherent weakness in their eyes.

This Awareness indicates however, even a horoscope or astrological weakness can be helped, and in many cases can be overcome by the proper efforts, but these efforts may need to be ongoing, over long periods of time, for the weakness and tendencies may remain. That this is also true when such weaknesses are of an hereditary nature. This Awareness indicates that occasional disease of a parent, prior to birth may have an effect on the offspring, hindering vision, or causing other problems. This is also included in the hereditary concerns.

ED's Note: Several years ago I was bothered by severe eye strain and occasional blurred vision, this probably the result of copying thousands of words and setting them into type for this newsletter, along with other close work it requires. Interrupting my typing and gazing off into a distance often helped, but this took valuable time and didn't solve the problem. One day a folder crossed my desk, and attached to it was a memo from Vicki T. with a simple directive: "Avaton, read!" It was from The Institute for Vision Improvement, P.O. Box 7840, Johannesburg 2000, South Africa, and they were selling by mail lensless spectacles called Lax-Optic. The ad stated: "You are invited to test this remarkable aid to good eyesight. Try them for 10 days on a money-back guaranteed basis." The ad contained other questions such as: "Do you hate to wear glasses? Reading too much, doing close work, watching TV, movies, sewing, bookkeeping can leave the eyes strained, dull and bloodshot. Now, in one minute you can read or watch TV without glasses--try it!"

Being an old advertising man and a real sucker for interesting mail order products, I read this fascinating little brochure which assured me that Lax-optics are used world-wide by pilots, sportsmen and film stars to relax their eyes and improve their eyesight without glasses. The photo showed what looked like a pair of sunglasses, only it contained no glass. Instead of lenses, there was a solid piece of plastic, but each contained about 70 tiny little perforations, which evidently cut down the light and enabled the wearer to somehow look through these tiny little holes. Of course I ordered a pair. Actually 2 pairs, one of which I gave to the Interpreter Paul Shockley, who was utterly fascinated by them when I suggested he give them a try. Well, to make a long story short, I was really pleasantly surprised that my pair of Lax-optics did exactly what the ad said they would. Whenever my eyes get tired from typing or close work, I put them on instead of my regular glasses and the eyestrain goes away. In fact I can read and walk around etc. with them on just like with my regular glasses, and when out in public they appear much like a regular pair of sun glasses and do not attract much attention. A special frame is used which easily adjusts to fit all sizes and is suitable for men, women and children. In short, I recommend Lax-optics to everybody who wears glasses, regardless of how bad your eyes may be. I received a brochure the other day from The Institute for Vision Improvement stating a price increase would be in effect soon, but if one orders now

you can get a pair for \$27 (US funds) or two pairs for \$47. This price includes airmail postage and you will get your new glasses in 8 days. Since you are guaranteed a 10 day free trial, if you don't like them you can return them at that time for a refund, you have little to lose. I suggest you order two pair as you will want to give one away to some friend or loved one who wears glasses. If you don't wish to order right now, write them for their free brochure anyway. Lax-optics are really something new and different in the field of eye wear and eye care. Believe me, I have read about six different books in my life on how to get rid of my glasses and none of them worked. Lax-optics did not get rid of my regular glasses, but they are a darned good substitute and most certainly a welcome aid when the eyes get strained and tired. (Incidentally, I don't get any kickback from this eye institute for plugging their product. They are unaware I am even doing so. It's just that I was skeptical and then pleasantly surprised, and I felt I ought to pass this info along to you guys out there who are tired of wearing glasses. (Avaton).

PS: airmail postage to South Africa is 44 cents, or two regular 22 cent stamps. They will accept your personal check, but prefer the international postal money orders available at your post office.

### CHELATION AS A METHOD TO TREAT ARTERIOSCLEROSIS

#### QUESTION:

A question from D.P, New Hope, Kentucky. She wants information about DMSO. We have published some of this, but she want to know if this can be used for arteriosclerosis, a disease "which I am battling," she say. "If this information cannot be released publically, is there a chance that you can send some information to me? I have purchased a bottle of liquid DMSO. Do I take it by mouth, rub it on, or what? Due to poor circulation in my legs, my ability to walk and even to think is diminishing. I have had surgery for this circulation blockage once, and I never want to go through that again! Would you help? It is not easy for me to ask this, but I am desperate!"

#### COSMIC AWARENESS:

This Awareness indicates that this substance does not appear to have sufficient powers in dealing with this particular need, to warrant your reliance on this as a way of curing or benefitting from this. This Awareness indicates that it may have some benefits of a slight degree, but it would not be recommended as being beneficial to the degree which you need.

This Awareness indicates that for your particular needs, it appears that chelation therapy would be the most dramatic and effective and the quickest. That this chelation therapy as that which opens the veins and arteries to allow more blood to flow to the various parts of the body, - this as through the bonding process wherein the substances bond themselves to the sodium and calcium deposits and cholesterol deposits within the arteries and veins, and remove these from the system.

This Awareness indicates that less effective, but still somewhat beneficial would be the use of certain vitamins and minerals which have a similar effect. This Awareness suggests for example, lecithin, which bonds itself to such particles, and assists in removing cholesterol from the arteries. Lecithin, selenium, SuperOxide Dismutase, that which is known as SOD, nucleic acid, or that which is commonly called RNA, GH3, garlic, cayenne, lemon juice...that these appear to be the main substances which can be beneficial in dealing with this. That the chelation as that which will be most dramatic and most effective.

This Awareness suggests that you should work through a doctor who has been trained in chelation therapy, who also recognizes the need to restore the vitamins and minerals which are removed during chelation, and one who carefully monitors the kidneys. This Awareness suggests that a listing of doctors who have been trained in this may be obtained through the Academy of Medical Preventics in California.


