

SHE FEELS UNWORTHY BECAUSE PEOPLE ARE STILL PRAYING TO HER

(The Significance of legends and archetypes)

QUESTION:

A question from A.M., Northridge, California.

"Sometime back I read a book about a mystic who lived in Spain during the late 16th, early 17th Century, in the city of Avila, home of two other famous saints. The nun to which I refer was called Maria Vela, and the book was written by Francis Parkington Keyes, who came across Maria Vela's writing in a convent there while in the process of researching other material.

"Maria Vela apparently was able to levitate during prayer, hear voices and see visions, and her body apparently did not deteriorate after her death. Certain miracles have also been attributed to her. I was quite fascinated by the story, and during a psychic reading I had sometime later, asked what my connection might have been with this Maria Vela. I was told that I had been this individual! I felt no particular emotion other than curiosity, and of course, as always, when I've been told or felt that I have lived other lives, have treated the information with a certain amount of doubt.

"My question is this: Obviously, from what I've read and understand, one can develop soul-wise very highly in one lifetime, and yet come back and regress in another. I do not find this hard to accept; however, what confuses me is many of these "saints" are being prayed to and revered as holy people, and unbeknownst perhaps to them or others, they are living normal lives on the earth, far from sainthood. If there is the faintest possibility that I may have lived as Maria Vela, and in the city of Avila where she is still revered and honored by the local people, the burden of the thought overwhelms me. I live this life as best I can, but certainly feel I fall short of my development in what may have been another life as a very developed mystic. This confuses me.

"Can one be a saint in one life, and just a regular individual in another, and if so, how does one help when they are prayed to in another role?"

COSMIC AWARENESS:

This Awareness indicates that it is not important whether the entities are praying, in fact, to you or whether they are, in fact, praying to the myth of your being, that legend of your being. This Awareness indicates that if you were to walk into that area, those entities would not see you as being any more special than they, and would continue their prayers to the legend. It is very difficult for entities to recognize the reality of myths, or the reality of legends; for most entities see these things as either hallucinations, superstitions, or of having no substance in reality. That wherein a myth is created; wherein King Arthur and all of his knights were created from real living flesh, or whether these were of myth and legend created from fiction,—they still have the same effect on consciousness at a particular time.

The Value of Legend and Myth

This Awareness indicates that the value of legend or myth is that it gives the mind an archetype, an archetypal energy on which it can fixate, and lead the other aspects of consciousness into certain ideals. This Awareness indicates myths, legends, whether based on truth or on fiction are in fact as real to

the conscious realms as are living beings real in the physical sense. These archetypal concepts of myth and legend affect consciousness in such a way as to give some form of meaning to ideas and concepts, so that they become significant and that significance has its effect on the programming of one's consciousness, which in turn has its effect on the programming of one's behavior, which in turn affects the activities and interactions of that entity with those around. In this manner, myths affect societies in the same way that a basic archetypal piece of information affects the rest of the system which comes under that archetypal bit of information.

Jesus as an Archetypal Force

This Awareness indicates that in the allegory of the computer, an entire system of operation may be programmed under a code word; when that code word is issued, the entire system may be brought forth for the computer to have at its disposal. That likewise, when a myth or legend has been programmed into consciousness, that word in itself, the name or the concept, serves as a code to draw up all of the images conveyed under that code. This Awareness indicates that the more popular example of this is the word *Jesus*. That this word carries with it all of the images that have been associated as described in the gospels and as described in history, and as described by cultures, and as described by religions down through the ages, and also as described by personal experiences with this name.

Therefore, this name *Jesus*, as an archetypal sound or word, conveying entire feelings to an entity when the name is spoken. The context in which the name is used allows other feelings to be brought in also. For example, the term *Jesus Freak* brings in certain types of feelings and energies. The term *Jesus Saves* brings in other types of feelings and energies. The name *Jesus*, when used in connection with Christmas, brings still other types of feelings. Therefore, archetypal energies, combined with other associative words, bring forth collections of feelings and energies, according to those which are called forth.

This Awareness indicates that to speak of the archetypes of a local area, wherein legend has given these entities a memory and legend of one who was of significance to the local members of the community; and whereby this legend has grown and developed and been nurtured by time, by stories, by the retelling of the story, and entities have become identified with this legend; many of these entities may find themselves comforted by the legend, and comforted at feeling a closeness in proximity to the vibrations of that archetypal legend;--the holiness of the location in terms of its connection with the archetype.

What a Prayer Really Is

This Awareness indicates that therefore, the concept of prayers to this entity as that which is not unusual or which would be considered strange, particularly if entities recognize that prayer is in fact an effort to

attune to a particular archetypal vibration. This Awareness indicates there are prayers to God, there are prayers to Satan, there are prayers to saints, there are prayers from a child to her parents. This Awareness indicates praying is essentially attuning, petitioning and seeking from a sympathetic vibration some form of reaction and response.

This Awareness indicates attuning one's vibration to a sympathetic or harmonious or compatible vibration with the one who is chosen as the archetype of that prayer,--whether this be the Universal Divine Force, the concept of God, the concept of Allah, Buddha, Christ, Lucifer, Satan, Kali, or any number of saints or demons;--all of this action of praying is attuning to a concept which carries certain vibrations, and attempting to tune yourself to that frequency, to that vibration, just as one tunes the channel of a radio or television to a particular frequency in order to receive the program which is offered by that archetypal station, that archetypal energy being transmitted by that station.

This Awareness indicates that as entities pray or tune in their channels to those archetypal energies, they receive certain frequencies and vibrations,--depending on their clarity, the quality of their receiver, their ability to receive those vibrations. That as entities tune themselves more and more to a particular energy, they sharpen up their ability to tune in to that frequency, even as one may work on a radio, attempting to zero-in on a particular wave-band that is difficult to monitor, but whereby with greater patience or finer attunement techniques, the monitoring eventually occurs.

This Awareness indicates that the local area wherein certain events have occurred always assist in such attunement. Therefore, entities may find themselves more able to tune in to the vibrations of a particular transmitter, or archetypal energy, so that they reap the rewards of that transmission,--they receive the program from that transmission more clearly. That if one is attuned to a particular frequency, it becomes much easier for these transmissions to be channeled through the entity.

This Awareness indicates therefore, many entities spend hours and years of devotion to a particular archetypal energy, such as Isis, such as Ra, such as Christ, such as Mohammed, such as Buddha, or Jehovah, or other archetypal energies, in order to bring their attunement closer, to benefit from those programmings available from that being, from that archetype, from that legend.

This Awareness indicates that it is not necessary for the individual who played the role, who conducted the action which left the legend in consciousness, to continue everafter being a hero and repeating the same role, or trying to live up to the standard which was previously set,--this would be likened unto playing old reruns time after time. It is better that the legend carry the story, and the individual go on to other experiences. This Awareness indicates that

even as a movie is filmed, and remains forever 'in the can' to be pulled out and played again and again, and even though the actor or actors involved in the movie have gone on to other things, the legend which was filmed remains intact for future entities' enjoyment, and for future showing.

This Awareness indicates likewise, entities who experienced great circumstances and who left legends of these circumstances for others to reflect upon, to speak of, to write about; that these entities who acted in those moments and in those circumstances need not forever be bound to continue playing the same role in the same legend. This Awareness indicates if this were expected of those of high order, such as the heroes of the legend; then likewise, entities would also expect those villains to forever remain villainous in their future activities also.

This Awareness indicates that the importance is not *who* you were, or *what* you did, but rather the *effect* of the legend, and whether or not you are what you wish to be at *present* time. This Awareness indicates that you need not be influenced or controlled by any past experience, nor need to deny others from their enjoyment and pleasure of replaying the old movie scripts and films portraying the saint who levitated, or whatever other legend leads them to feel better about themselves, or inspires them to higher levels of attainment.

THE SIGNIFICANCE OF BEING SIGNIFICANT IN A PREVIOUS LIFETIME (AND IN THE PRESENT LIFETIME)

FOLLOW-UP QUESTION:

Awareness, this is a pretty good representative example of situations that crop up over and over again with entities that write in. Usually they say they have had a reading of some type from various kinds of seers, often many different readings, and still they keep looking for more readings, hoping that eventually some seer will tell them they were someone of significance in some past lifetime. Evidently, until they hear this, they somehow feel they're less developed than they should be, or less developed than others. Ironically, in cases like this one here of some nun who could levitate during prayer and hear voices and see visions, and was made a saint for this, all of that does not seem particularly productive to me, and probably was not nearly as productive during that lifetime doing stunts like that as was this entity A.M., asking the question, in her *present* lifetime.

Would Awareness comment a little bit on this significance of being significant and those various entities and spiritual groups that are constantly asking this same question?

COSMIC AWARENESS:

This Awareness indicates that the need to be significant in some manner is that which is a valuable concept in understanding the nature of consciousness and its development. That the word *significant* relates to the word *sign*, -- a significator, or a sign. In the past, entities have asked, "Give us a sign," needing a sign in order to have faith. That entities have been asked to "sign" your name, "give us a sign of your name, that we may trust you and believe in you." This Awareness indicates the use of signs as associated with belief in something. When an entity says it is 40 miles to the next town, you may or may not consider this a sign of significance; if an entity paints this and puts this upon a wooden plaque, you feel that it is a sign that the next town is 40 miles away, because no one would put so much energy into that sign if it were not so.

This Awareness indicates that wherein an entity seeks some form of sign or significance, the need for significance is in part a need for believing in oneself. Without some form of significance, an entity would have little in himself to believe in. Therefore, many entities seek significance by acting in certain manners to get a reaction from others, so that others see this entity as significant because of behavior patterns. Another entity may seek significance from accomplishment, and the accomplishment is a sign of importance. Another entity may find these as not being satisfactory and may seek significance through problems; the entity may find that the more problems he or she has, the more significant he or she feels. Another entity may tire of all of these different forms of significance and may tire of pursuing wealth, glory, power, or other types of significance, and may also feel a personal insignificance in the present life, and may begin to wonder about one's own future or past. "Where did I come from?"

This Awareness indicates that an entity in making the past significant, feels that, "perhaps there is something greater in me than I realized, or perhaps there is something terrible in me that I do not understand," and the past becomes significant in itself; which in turn brings about a curiosity, wondering, "what was that back there that I have totally forgotten about?" That other entities look to the future with curiosity, making the future significant, feeling that, "perhaps there is something in the past that is significant; but it is gone, and I want to know what is important in my future. What am I here for, what can I do, what can I be?" Thus, entities may look in past and in future: "What have I been; what can I be, and what am I now in the present?"

This Awareness indicates that a healthy and balanced individual may keep these things in harmony so that the present is always recognized for what it is. Others may accent past or future, and ignore present; still others may accent the past, forgetting the present and future; still others may accent the future, forgetting present and past. This Awareness indicates most entities accent the present and forget

the past and future except when these entities have become blocked in their present expressions; that most entities in your present age are blocked in their present expressions; therefore are locked in the past, apprehensive or hopeful about the future, and have very little interest in present experience.

This Awareness indicates that the significance of knowing who one was in the past, or of having accomplished something in the past; the value of such significance is that it gives one a psychological base of operation to feel that "I have accomplished something. I did this once before; therefore, I can do it again, or I can do greater things." This Awareness indicates that this past is the springboard from which one can leap from the present into the future. That the more one recognizes significance in one's past, the greater one recognizes the ability to perform in the future. If one has entered a contest and has eaten two watermelons, the entity knows that in the next contest, he can eat two watermelons or more. That if the entity has never eaten two watermelons before, the entity has no past significance to draw on.

Likewise, if an entity has accomplished dire deeds in the past of a negative nature, the entity may be likewise apprehensive of having any form of opportunity to repeat such deeds and action, and therefore, fearful of looking at one's past, -- fearful of exploring that which is within, and in many cases fearful of future experiences which would be of a similar nature to those areas which are hidden from the past.

Why Some People Can't Hold Power

For example, an entity who has held great power in the past and has misused that power, may in present time be experiencing certain blocks from childhood, unable to recall, unwilling to recall childhood experiences wherein he or she violated others, misusing personal power over others in a small degree; and the entity may also in present time look to the future, seeking power, but always making sure that it is blocked and kept from him. That the entity, having misused power previously, may be fascinated by the collection of power, but also may have built-in checks to keep from ever attaining any form of power, even in a small degree. This entity therefore, may pass through several lifetimes being inept in the acquisition of any power and may not for some time grow to develop and use power, even for good purposes. This Awareness indicates that the entity may be weak in any way, -- physical, emotional, economic, socially, or whatever, -- simply because of having misused that energy in previous times; but afraid of discovering about oneself, the entity rather than learning from the lesson, programs himself to remain without any power.

This Awareness indicates that this is one facet of the way in which the mind works. It is not the only facet: there are many ways whereby the mind compensates for its experiences, and the varieties of compensation are endless, -- much too great to discuss in this question. This Awareness indicates however,

that the mind is capable of making significance, finding those areas of accomplishment which pull the entity in the direction which either frees the entity to become greater than the entity believes himself to be; or if the mind fixates on negative experiences, can create significance from these negative experiences which lead the entity into being much worse than he presently would be.

This Awareness indicates if an entity fixates on a negative image, experience, or memory, that entity can be pulled by that archetypal force and energy into personal oblivion. If the entity latches onto and makes significant a positive or beneficial memory or event, that event and the significance of that event as that which can lead the entity into greater and higher accomplishments. This Awareness suggests you accent the significance of positive accomplishments in your life, and that you minimize and remove the significance from negative events and experiences in your life.

This Awareness indicates that in pursuing through conscious retrieval methods,--in pursuing your memories of negative experiences; this Awareness suggests you not seek these negative experiences in order to dwell on your inept approach at the time of the experience, but rather to retrieve the information so that you can look at that from a new and positive perspective; that this allows the negative to be dissolved, even though it may have been significant. This Awareness indicates the greater significance being to dissolve the negative, rather than to retrieve and hold onto that negative.

This Awareness indicates that significance of the negative is important when understood in this manner, whereby these negatives may be resolved. This Awareness indicates that in all other instances, negatives should be given little significance, and positives should be given greater significance. That likewise, in the events of one's present circumstances, wherein a negative can be resolved, then it should be given significance. Wherein there is no resolution or reconciliation for the negative, then it should be ignored.

WHEN NEGATIVE PREDICTIONS ARE APPROPRIATE

(Closing Message)

This Awareness indicates that in reference to the future, wherein the negative events of the future can be resolved, then predictions are in order; wherein there is no way that these negative events will be resolved, then it is inappropriate to inform entities of that fate. This Awareness indicates *however*, wherein the future event is of a negative nature, such as a terminal disease, and whereby there are potential or possible ways whereby this can be resolved or prevented, or whereby the knowledge of that future event can be beneficial in helping to alleviate problems for others concerned, then it becomes more appropriate for that negative prediction to be expressed and stated.

This Awareness indicates that for example, if an entity is experiencing a terminal disease, and though there is no hope whatsoever that the entity can find relief, if the entity can have the opportunity to straighten up the areas of his life before passing over, then it is appropriate that the entity is informed of this condition. Thus the significance of a negative event in the future as that which is important in being communicated in order to help bring about as much reconciliation or resolution as is possible under the circumstances.

This Awareness indicates likewise, as in the book *On the Beach*, a fictional novel, wherein the world itself was on the brink of annihilation, and entities were informed of the certain future of the planet, that the radiation from the various bombs had destroyed most life on the planet and it was only a matter of time before it reached Australia; this as also being a fictionalized version of a negative prediction or significance based on future occurrences. That wherein entities involved in such a situation can straighten up their lives, in reference to clearing out unspoken or hidden feelings, so that they become more honest with each other as the time grew closer; this as being more appropriate than would it be for entities to not be informed of what was happening to them.

The Significance of Negativity

This Awareness indicates that therefore, the use of communicating and making negative significance in the future, where there is the opportunity to diminish the degree of negative, and wherein the negative is looked at from the past, and there is the opportunity to diminish the degree of negative from the past, and wherein the negative is looked at in the present and there is the opportunity to diminish the degree of negativity in the present: this is appropriate. This Awareness indicates that the significance of negativity is in the ability to reduce that negativity to some degree. That wherein this cannot be reduced, and wherein entities enlarge the negativity by dragging up the past, by warning about the future, by making the present more negative than necessary, by enhancing, exaggerating and reinforcing the negative; this is the inappropriate form of making the negative significant.

This Awareness indicates that in enhancing and reinforcing the positive in the past, future and present; this is appropriate,--but the negative of past, present and future should be negated to some degree,--negating the negative brings about the positive. This Awareness indicates that ignoring the negative, keeping it from being significant may allow it to continue in its present state: but wherein the significance is placed on the action of negating or diminishing the degree of negativity; then the significance of the negative is that which is appropriate, for it is being chipped away, and the significance of chipping away at the negative is that which is important and is significant in creating a greater positive.

This Awareness suggests that those entities who look at the positive and enlarge, reinforce and build

upon the positive, enhancing that which is positive, are working for the Light Forces, creating that which is good and positive. That those who look at the positive and search for flaws, and enlarge upon those flaws,--not for the purpose of improving and ridding the positive of its flaws, but rather for rejecting the positive because of its flaws; these entities are essentially working for the negative or Dark Forces. (This Awareness suggests the Interpreter be brought from trance).

(WHO REALLY SITS ON THE THRONE OF GOD?)

IS KRISHNA "THE SUPREME PERSONALITY OF THE GODHEAD"?

(PROBLEMS INVOLVED IN CHANTING 'HARE KRSNA')

(Excerpt from a Personal Reading)

QUESTION:

The Bhagavad-Gita as it is and the Sumad-Bhagavatam state that Krsna (pronounced Krishna) is the Supreme Personality of the Godhead. Would Awareness please comment on the information in this literature and whether it is fact?

COSMIC AWARENESS:

This Awareness suggests that you note the use of a word describing that which is spirit. This Awareness suggests that you understand that all words are lies and are but reflections of the thing, or signs pointing toward the truth. This Awareness suggests that you understand also that forces do move in the universe, that some forces focus and some forces oppose each other, and some forces split and separate from one another, and some forces come together. This Awareness suggests you also understand that some forces do move into materialized forms while others remain in spirit or spiritual forms. This Awareness indicates that you also understand that these forces can be labeled and named, that the labeling and naming of such forces as according to that force which chooses to label and name such.

This Awareness indicates that in the ancient past of this planet Earth, there was a language which was scattered throughout many tongues; this language did contain certain aspects which has been used in the formation of various religions. This Awareness indicates that you understand that at a certain point in the evolution of this planet, that many of these terms were used to describe certain features. That at one point entities drew pictures to convey messages. This Awareness suggests that you also understand that the Egyptian gods Ra and Isis, that all these gods were drawn out as entities, yet all these gods were simply principles.

This Awareness suggests that you also understand that the concept of Krishna or Christ or the Crystal clarity as also a principle which has been presented in a personality story form whereby entities could perceive this in their limited three dimensional sense level of consciousness. This Awareness indicates there have been many who have moved into this crystal clarity and have taken on the name of Krishna, Christ or such. This Awareness indicates that you also may look carefully and understand that any of these entities who are clear may be worshiped as a god if that is where you wish to stand and what you wish to do, that this worship of others as a way of heightening your own clarity and your own consciousness and moving toward that crystal clarity yourself. This Awareness indicates that you also understand that the Christ or Krishna consciousness is within yourself, that you need not worship an entity in name or in physical image of today or in the past, that you may simply worship the "Christ Consciousness" or "Krishna Consciousness" or "clarity". The words "Christ," "Krishna," or "clarity" may be interchangeable. This Awareness suggests you understand the virgin purity of spirit as that which is also interchangeable with these concepts and names, that you may think up any other name and use this for your triggering mechanism to bring you into that clarity. This Awareness suggests it matters not to this Awareness how you become clear, but that you *become* clear.

CHANTING HARE KRSNA COULD PRESENT PROBLEMS

QUESTION:

I am now chanting the Hare Krsna Maha Mantra. Should I continue?

COSMIC AWARENESS:

This Awareness suggests you may chant whatever you wish as long as you wish, but cautions you to be aware of what the chanting is doing. This Awareness suggests that repeated chanting is hypnosis. That wherein you are chanting certain words and certain terms and certain images, there is no room for any other concepts within your consciousness. That wherein you are chanting these words and excluding other concepts from your consciousness, you are focusing your consciousness; and wherein you continue focusing your consciousness you are excluding a large portion of your possible experiencing, including a large portion of that awareness that could lead to Cosmic Awareness. Wherein you are consistently focused on a small portion of the universal experiences, you are limiting your soul growth; wherein you continue focusing in this manner with an intensification of the intensity you can blow yourself out, likened unto an overcharge. This is not an action to be taken casually for the intensity of the focus may call forth an action that because it *is* focused and narrow with intense energy, can lead to actions that are separative, exclusive, self-centered, or divisive in nature. However,

if one moves on beyond that point of selfishness, desire and focus to the point of surrender of self to the Universal Life Force, then the intensity of energy used in focusing up to that point of surrender, becomes likened unto a compressed propelling energy that rockets the consciousness to an experience that may be considered mystical, or enlightening as it allows one to see ones concerns from a higher more expanded viewpoint. This is a type of consciousness climax that relates to information given earlier in this reading, and this experience takes you back to where you began, having gone full circle in search of truth and swinging around to surrender to that which is.

The Law of Essence

This Awareness wishes you to understand that what is at any moment is essence, and essence is what is the ultimate truth.

THE LAW OF ESSENCE* The Law of Essence states that what is, -IS, and what is, is not changed by any opinions or beliefs about it, but is what it is, while it is. This Law states that actions and motives which are the highest and the best, the most inclusive and encompassing, the most appropriate and essential; create those movements that lead to the Gates of Essence, behind which all things are exactly as they are, while they are; for Essence is the ever-changing truth that was, is and forever shall be.

The essence is the is-ness of what is happening at any moment regardless of the length of time included in that moment. IS A CERTAIN NEW AGE ORGANIZATION AN APPENDAGE OF THE COMPUTER BEAST?

(HOW CIA AND FBI SNOOPS OPERATE)

QUESTION:


A question from A.C., of Tempe, Arizona. "I was at a lecture given by Frank Alper, at which the lecturer claimed to have knowledge of a New Age organization that kept written and computer data on all known New Age activists and Star Children, and entities of the new root race of man. The object of this being that one can go anywhere in the world and link up with these entities by plugging into the computer and receiving information on their whereabouts.

"The lecturer also claimed that many high ranking individuals of many nations participate in this organization. I would like to know if this organization is legitimate, and in fact if it is a New Age organization at all, or merely a disguised appendage of the Beast; and also, what's the ultimate goal of all this?"

COSMIC AWARENESS:

This Awareness indicates that this appears to be that which in its conception was intended to be a linking of lights, of New Age energies, of those in the metaphysical levels, and essentially as being such. That there are, of course, as in many organizations, infiltrated energies from other agencies which seek to keep tabs on what is occurring, and what is going on within the activity. This Awareness indicates the organization as that which is essentially watched by those forces which could misuse computerization of these entities and their names.

This Awareness indicates however, entities must understand that it does not matter whether entities are in one organization or another,—wherever entities are, there are those eyes of the Beast which are watching, and are keeping tabs on them at any time they do anything which is peculiar, or out of the ordinary. This Awareness wishes entities to understand that paranoia in regard to belonging to one



organization or another is often unwarranted. This Awareness wishes entities to also understand that even many local taverns or restaurants, or places of business, or schools and classrooms have CIA informants, or FBI informants within the ranks.

This Awareness indicates that essentially, these agencies,—the CIA and the FBI, and NASA, will recruit those entities who have certain qualifications in their schooling. Those of the higher intelligence levels are prime candidates for being recruited into these organizations, either as agents or informants. Entities should understand that there are more of these entities around in local areas than one might normally suspect. That many of these entities simply will sit around in a tavern, observing people who may be somewhat unusual or have some form of perversion, some quirk, or some particular interest out of the ordinary, and once spotting such an entity, may follow the entity and observe the entity for some time. These agents, often discovering that the entity being observed lives in another part of town, will inform an agent in that area, and that agent will simply keep tabs on the entity for a period, making a report on the entity. That this then goes into a file, and the entity may cease being watched for a period of time, until something unusual occurs, which again draws attention to the entity.

This Awareness indicates that there are many entities who think they are a nobody, but if you contact these agencies using the Freedom of Information Act, you may find that there is quite a file on you. This Awareness indicates that even your own teenage children may have files on them, perhaps only a paragraph or two. This Awareness indicates that to belong to a New Age group is not a particularly threatening type of involvement or activity. That the CIA does have certain classifications for these entities. It is not seen as a national threat, and these entities, or the classification of these entities is simply intended to assist in the event certain circumstances *might* occur, whereby they need to know your particular philosophy.

The CIA Understands Metaphysical Concepts

This Awareness indicates that you could very well be surprised to discover that the CIA does in fact have much of its own philosophy involved in the metaphysical realities which this Awareness speaks of; that the metaphysics of these Cosmic Forces of the Forces of Light and Forces of Darkness are well understood by many entities in the CIA, and these entities do not consider such concepts as necessarily being unusual, or being different from their own. It is essentially, a kind of domestic surveillance, yet at the same time, it helps to bring a kind of security: national security, cultural security, or social security, in regard to knowing your kingdom, knowing your people.

This Awareness indicates that if an entity becomes paranoid or fearful that belonging to “this” organization, or “that” organization might cause them to get on some computer somewhere, and if the entity drops out from those organizations because of this fear, their file may simply then be altered to state that they dropped out of “this” organization, and “that” organization, and are now belonging to no social organizations whatsoever, and appear to be a recluse, and therefore perhaps need to be watched as a possible danger to society, or as a potential individualist, an individual thinker, or a “dangerous” individual thinker. This Awareness indicates that there are many ways of being classified, and if you move from one classification thinking you are escaping being classified, you may simply be classified into another, which may or may not be any more acceptable to those who are classifying you.

This Awareness indicates that this organization named in the question is seen as one which does appear to have a potential for being used, either for good, or for ill, depending on future events and circumstances. This Awareness indicates that wherein the Ahriman forces should become more powerful, and seek to harm those who have metaphysical views, this organization could be used as a means of tapping the names and locations of such entities. However, this organization also could be used in the event that forces wish to unite, or to assist in helping to remove those Light Workers from the danger which befalls others who

are caught in materialism. This could be beneficial in helping to locate those Light Workers for that which might be referred to as a kind of rapture, or deliverance program.

This Awareness indicates that as in the past, *It* does not wish at this time to indicate to entities where to run and hide from trouble, for *It* is not interested in helping entities to preserve themselves out of fear. *It* is interested only in helping entities to move toward that which is the spiritual, and wherein entities are fearful that the spiritual path may lead to trouble, it could be a hindrance if this Awareness were to tell entities that a movement, or involvement in a metaphysical organization could land them in trouble, or put their name on some computer.

This Awareness indicates that it also could be a hindrance to an entity's growth and development to tell that entity that their name being on this computer would guarantee that they will be raptured. This Awareness does not wish to inform entities which choice to make, as it denies them the chance to move as a spiritual being, rather than clinging to material security out of fear.

This Awareness indicates that it does appear that this organization mentioned exists, and does have many of these names of various organizations listed. This Awareness indicates also that New Age organizations may be found listed on mailing lists. That you may contact mailing list outlets and discover, by asking for metaphysical groups, or New Age groups, the spiritual organizations and religious organizations, the names of multitudes. That there are literally millions of entities' names in these computers from mailing list companies which are available to anyone who asks for these names, if entities wish to purchase such mailing lists.

This Awareness indicates that likewise, you may ask for mailing lists of names of entities from homosexual groups, from radical groups, from political groups, or entities whose interests are in real estate, or money-making opportunities, or entities who are interested in sports, or theatre, or any other type of activity imaginable. These mailing lists are available whereby you may start your own computerized system of classifying entities according to their interests, or according to their philosophical preferences.

This Awareness suggests that every time an entity purchases a book by mail, or leaves one's address at a seminar, risks having his or her name placed upon a mailing list; and once this is placed upon a mailing list, listing the classification of that entity's interests at that time, it may then circulate to many other mailing lists from that first initial involvement.

This Awareness indicates for example, when you purchase a book on real estate from some mail source, you may find that you are soon receiving many other book offers and advertisements relating to real estate, or money-making opportunities. If you purchase information from one organization relating to some invest-

ment program, you may find that soon you are receiving in the mail other information relating to investment programs. If you send a donation to a particular group, such as an environmental organization, or charity organization, you may find that soon you are receiving requests from dozens of other charity organizations seeking donations from you. This is because these organizations often sell the names of entities to others, or these names go onto the computers of those who run mailing lists.

If you are interested in finding out whether the FBI, CIA or any other federal agency has a file on you, the way to obtain it under the Freedom of Information Act is as follows:

(1) Make a photocopy of your driver's license or some other form of acceptable identification.

(2) Send a NOTARIZED letter listing your full name, date and place of birth, your current address, along with photocopy of your driver's license. State that you are requesting copies of all information on file in that particular agency.

(3) Mail to: The Federal Bureau of Investigation, the J. Edgar Hoover Building, Washington D.C. 20535. Mark on the envelope: "Attention: F.O.I.A."

Note: They will probably charge you a copying fee for each page of information they have on file, but should notify you of the fee. Many people simply enclose a check for \$5.00 to cover any expense and to avoid delays.

This Awareness indicates that entities may look in the Dr. Schuessler cell salt or biochemistry book for research purposes, to find those cell salts which are most beneficial. WAR BUILDUP IN PERSIAN GULF

Falsified Reports To Blame

As it masses military forces in the Persian Gulf—where the largest American air-and-sea armada since Vietnam has been deployed this month—the Reagan administration is acting on intelligence it receives from an alien espionage service whose goal is to goad the United States into war.



According to The SPOTLIGHT's best-informed Middle Eastern sources, not just the current crisis in the gulf but other disastrous recent U.S. moves were set up by "deception operatives" working for the Mossad, Israel's secret service. A flag-rank gulf defense official cited the following example in a recent confidential conversation with a SPOTLIGHT correspondent:

When President Ronald Reagan sent a handful of Marines into war-torn Lebanon, his decision was based on secret Mossad reports assuring him that the small contingent would be able to "stabilize" the country around its newly installed "national government."

"That 'national government' was a coalition of Israeli puppets, installed by the Mossad," explained this highly placed strategist. "But Reagan was misled about that.

"He was not told that his Marines would have to prop up a government without authority, a government hated by the people. When the Marines landed in Lebanon, they were new meat, fed into a boiling cauldron.

"They were doomed to be decimated—as it turned out, by a suicide bomber. But the real culprit behind those 241 lost American lives was the Mossad."

FED BALONEY

Other Middle Eastern diplomats, agreeing with this assessment, added that the Mossad fed the CIA, the State Department and the White House what one source called "literally dozens of fake and lying agent reports" in order to needle the United States into a violent showdown with Libyan strongman Col.

Muammar el-Qaddafi.

"The confrontation between Reagan and Libya, which led to the death of Qaddafi's adopted baby daughter in a U.S. air strike, was a textbook, world-class Mossad deception operation," confirmed Werner Knopke, deputy foreign editor of a major German news magazine, who has recently returned to New York from a tour of the Middle East.

"Early in the game, in mid-1982, the Mossad dispatched a special officer courier to Washington with a top-secret report alerting the White House that a hit squad sent by Qaddafi was on its way to assassinate the president," he said.

This particular piece of disinformation, Knopke noted, is now generally known to have been fabricated by the Mossad. "There were others," the veteran journalist added, "all designed to make Qaddafi appear, as 'Newsweek' magazine captioned his cover photo at the time, 'the most dangerous terrorist in the world'."

In the view of experienced analysts, Qaddafi is an Islamic zealot and a militant Arab nationalist, with a streak of violence. But he has never, in the opinion of sources who know him well, intended to murder Reagan, or, in fact, to sponsor violent incidents in the United States, where, as more than one Arab observer noted, it is the adherents of Israel who organize and carry out the most vicious terrorist outrages.

Elaborately planned Israeli disinformation was the hidden factor behind the president's decision to authorize secret arms deals with Iran and the Nicaraguan anti-communist forces known as the "contras." These moves, which led the Republican administration into its most damaging confrontation with Congress, were wholly manipulated by the Mossad, which pursued its own goals, regardless of American interests.

Could the United States really accomplish something if it made private approaches to Iranian leaders—and prepared the ground for them with shipments of weapons? The Mossad "suckered" the United States into that game—as Secretary of State George Shultz put it—with a long series of deceptive and mendacious intelligence memoranda.

To make sure Reagan fell for this fakery, Middle Eastern experts say, a succession of high Mossad officials, led by Deputy Director David Kimche, visited the White House in 1984-85 to lobby the president.

"For the past five years, the Mossad has systematically and deliberately misinformed and deceived the White House about the realities of the Middle East," said a senior Arab delegate whose account reflects the prevalent view among Middle Eastern diplomats. "Now they have persuaded the president that the way to make his presence felt in the gulf is by massed gunboat diplomacy.

"The United States is being suckered into yet another wrong move, because the way to peace and a welcome U.S. presence in our region lies in the opposite direction."

North memo stuns

MIAMI — Marine Lt. Col. Oliver L. North helped write a plan in 1982 to suspend the Constitution and place the country under martial law in the event of a national crisis, the Miami Herald reported.

The plan, outlined in a June 30, 1982, memo obtained by the Herald, was a revised version of contingency plans for dealing with nuclear war, insurrection or military mobilization, the newspaper reported in today's editions.

It proposed a scenario calling for suspension of the Constitution, turning control of the United States over to the Federal Emergency Management Agency, appointment of military commanders to run state and local governments and declaration of martial law.

North, who was assigned to the National Security Council in late 1981, was FEMA's contact with the NSC and helped the agency draw up the plan, the Herald reported.

The proposal was written as part of an executive order or legislative package that President Reagan would sign and hold within the NSC until a crisis arose.

The proposal alarmed Attorney General William French Smith, who wrote to Robert MacFarlane Aug. 2, 1984, stating his objections and urging a delay in signing the directive.

"I believe that the role assigned to the Federal Emergency Management Agency in the revised Executive Order exceeds its proper function as a coordinating agency for emergency preparedness," Smith wrote. "This department and others have repeatedly raised serious policy and legal objections to the creation of an 'emergency czar' for FEMA."

The Herald said it was not clear whether the executive order was signed with the proposed martial law plans. Congressional sources said they believed Reagan did sign an executive order in 1984 that revised national military mobilization measures to deal with civilians in a crisis.

The memo outlining the martial law provisions of the contingency plan was written by John Brinkerhoff, deputy to then FEMA director Louis O. Guiffrida. The martial law provisions resembled a 1970 paper Guiffrida wrote in which he proposed such actions in the event of a national uprising by black militants.

The Herald also reported Saturday that several Reagan advisers

formed a parallel government behind the Reagan administration to carry out activities that extended beyond the sale of arms to Iran and aid to the Nicaraguan rebels now under investigation. North was said to be the center of the group.

Israeli defendant reports beating

JERUSALEM (AP) — Mordechai Vanunu, the Israeli nuclear technician accused of treason for saying Israel makes nuclear weapons, was beaten by guards today on the way to the second day of his closed-door trial, his attorney said.

Access to the courtroom was blocked and its windows were boarded up today as the Jerusalem District Court heard the testimonies of secret service agents who have questioned Vanunu in Israel.

Defense attorney Avigdor Feldman said Vanunu, 32, was forced to wear a helmet to conceal his face and, when he attempted to remove it, was beaten by his guards as he

was transported under heavy security to prevent him from making contact with reporters.

"There were blows," Feldman told reporters, adding he had com-

plained to the court. He said the judges would decide whether Vanunu would be compelled to wear the helmet.

Vanunu was charged with betraying Israel after The Sunday Times of London ran an article Oct. 5 based on information he provided. The story said Israel had stockpiled 100 nuclear weapons, was able to make hydrogen and neutron bombs and ranked sixth among world nuclear powers. If convicted, he faces life in prison.

Israel never responded directly to the newspaper's account.

Burmese students set fires in protests over currency

RANGOON, Burma — Up to 1,000 students set fire to cars and buildings after the government declared three denominations of currency worthless, witnesses said yesterday.

The witnesses said between 500 and 1,000 students joined in the protests Saturday night and police made some arrests.

No injuries were reported in the first student disturbances since 1974 in Burma, which is under tight one-party rule.

Government radio later an-

nounced that all schools and universities would be closed beginning today for "Thadingyut," a Buddhist festival usually celebrated in October. The broadcast gave no reason for advancing the holiday period and did not announce when classes will resume.

On Saturday, the government announced that the 25-Kyat (\$3.72), 35-Kyat (\$5.21) and 75-Kyat (\$11.16) bills were no longer legal tender. Protesting students said they could not pay their expenses because of the action that would not allow them to exchange those bills.
