




THE HUNTING AND THE EATING OF ANIMALS AND THE KARMA INVOLVED IN SO DOING

QUESTION:

A question from J.C., Newark, Delaware. This question concerns hunting. "My father and mother own a sporting goods shop, predominantly hunting and fishing, and we periodically are involved in discussions concerning the necessity of both. Their opinions are, "Of course it is necessary, because of the numbers of the creatures, or else the game will starve to death." Secondly, it puts food on the table; third, it's a sport and it gives my father something to do; and fourth, it is their business.

"I feel that being a vegetarian is a better answer; secondly the animals would not starve to death, at least not if we treated them as fellow inhabitants of this earth. Thirdly, it is no longer a food-providing necessity when hunters mount the head on a wall. Last, but the proverbial not least; one can have a business, but does not have to participate in outside activities related to it. Could Awareness elaborate on this issue? Also, the NRR and the anti-gun people have raked the coals over this issue, and you have probably heard as many things about it as I have. Please help. How does consciousness feel about hunting in today's world?

COSMIC AWARENESS:

This Awareness indicates that there are various levels of evolvement; that there are movements between the gross material level, and that which is of a higher spiritual level. This Awareness indicates that the higher the spiritual development, or the

evolutionary development of a creature, the greater its universal value or spiritual value. That therefore, the principle of consuming those creations which have taken millions of years to evolve, as that which becomes a karmic type of consideration.

This Awareness indicates that the consumption of simple organisms as that which carries very little karma; but the more complex the organism, the more karma is created in any violation to that organism. Therefore, in the sense of karma, cannibalism as that whereby a creation or organism eats one of its own kind and, in the process, creates a gross violation of its own species. There are also those organisms which create some karma from eating organisms of a slightly lower nature of development than their own; the degree of karma as being lessened, or diminished, the further down the evolutionary ladder. This Awareness suggests that as the degree of evolvement is increased, the karma likewise increases.

This Awareness suggests that the movement of energies toward more spiritual evolvement as that which requires that the more spiritually evolved being must also partake of more spiritually evolved energies; and wherein these energies are of such a position on the ladder of change, there comes about a point whereby a shift in consciousness occurs, and the type of sustenance required can alter.

This Awareness indicates the human being as capable of shifting into vegetarianism from that which is the carnivorous state; that this has much to do with the energy level, the genetic coding, the particular emotional and cultural and psychological make-up of an entity, along with certain physiological qualities, and also has much to do with past life experiences. This Awareness indicates that many of the Western vegetarians are in fact reincarnated Hindus, and it is more natural to them to avoid meat; that this as being basic to their soul development.

This Awareness suggests that the changes which are occurring in consciousness are those which move slowly; yet it must be remembered that at the turn of the century, cannibalism was still prevalent in the African continent, and in many other areas of the world, whereas today it is almost nonexistent; that the present tendencies toward the eating of animals, toward the growing of animals for consumption, is that which within 100 years will be altered considerably in a similar degree as has cannibalism been altered during the past 80 years.



This Awareness indicates that these things occur in their own time as consciousness changes, and as influences are allowed and expressed; that as entities become more and more sensitive to the reality of the being or creature that lives within the body of an animal, and as they become less concerned with personal appetites and more concerned with spiritual growth, development and the sharing and cooperative energies, as opposed to competitive energies, --then these things shall begin to change on a more rapid basis. To become frustrated that the changes do not occur fast enough, is appropriate so long as it is not harming yourself or others in a greater degree than the frustration merits.

This Awareness suggests that as more and more entities speak out on their views, and as more and more entities awaken that force within each other that calls forth for mercy; these things shall occur. That even as smoking, which was so prevalent less than a decade ago has now become a topic of major concern for many entities in that it is no longer fashionable to smoke in public places; that likewise, within the next 30 years, it shall cease to be fashionable to eat and order and cook meat of the cattle and pigs.

This Awareness indicates that along with the change in diet, many of these animals will have less purpose and value in terms of food, and therefore the animal kingdom upon this earth shall begin to diminish in a form of population control, so that the animals are not consuming foods which the humans would consume; that therefore, there are benefits in one hand to the animal kingdom, while these benefits are denied from the other hand. That which gives growth and sustenance to animals that they might live in order to become food for man, may change to deny these animals their livelihood, so that they do not consume food from man when man no longer wishes to consume these animals.

This Awareness indicates that the wild animals also can either become a detriment to man as they increase in population, if man ceases to use these for food; or these animals can become overbearing in their presence, so that bounties will be placed upon them to diminish their numbers. This Awareness indicates that there can not be simply the refusal to acknowledge situations wherein population grows and the various forms of life develop in such a manner as to consume one another without some form of dominion of one species managing, either by might or by reason. That if mankind became totally and completely merciful and protective of all animals in the manner some entities would request, then it would be but a matter of a few decades before the animals would be devouring the people, or the food of the people, and people would be starving from an overpopulation of certain numbers of various animals.

This Awareness indicates that it has been given that man was given dominion over the beasts of the fields, and over all living things. This Awareness indicates that this was given that man could use the forests, the trees, the plants and animals, --in a manner which would benefit as much as is possible and bring about a harmony as much as is possible for all concerned upon the planet. That this as a tremendous task placed upon the shoulders of mankind to attend to the needs of the planet; to this garden, that the fruits be bountiful.

This Awareness indicates that there are always those who are more merciful and those who are more severe. There are always those who are more highly evolved, and those who are laggards. This Awareness indicates that there is always room for sharing insight, feelings and messages that help those who are laggards to become more awake. There are always going to be violations which need to be looked at and examined and called to the attention of those who can find a justice.

This Awareness suggests that in your efforts to save the suffering animals against the barbaric hunters, that this noble cause should not be such that it fails to also seek to save the barbaric hunters from their own lack of sensitivity, and that it not recognize that there are also within these barbaric hunters certain elements which may be in part necessary at this point in the scheme of things, in

the evolution of the planet, to keep the balance. This Awareness suggests that it all creates a cacaphony as that of an orchestra tuning up, wherein although harmony may not exist in all things, each instrument, each voice adds to the total reality, and calls forth for itself to be noticed. Those voices which call for the protection of animals; those voices which call for the protection of humans; those voices which call for the protection of trees, those voices which call for the protection of jobs which require that the trees be cut...all of these need to be heard. All of these need to be examined for their message; and from this dialogue of all of these voices, perhaps a balance can occur whereby these energies do not become overburdened in one area, so that chaos and total imbalance throws the entire system out of order.

This Awareness indicates that for those of you who wish to speak out for the vegetarian diet; let these voices be loud and clear. For those of you who still feel the need for certain meat on your plate, let this be clear as to your desire. This Awareness indicates that when each has been heard and the issue has become loud and clear, then changes may begin to occur; but wherein these actions occur in soft whispers and shadows, then these actions may continue for long periods of time with nothing being done to bring about changes.

This Awareness indicates that evolution of any culture, of any species, occurs mostly through the awakening process, whereby entities become awake and aware of that which has previously been automatic, habitual, or subconscious. This Awareness indicates that man being a more conscious creation, has greater responsibility for the protection and management of wildlife, of vegetation, of the seas, of the land, of the weather, and of the social conditions. That as man becomes more aware, more capable of controlling the weather, the social conditions, the economies, the seas, the earth itself,—the responsibility for that control is handed more and more over to those who are aware of these powers, and the mismanagement of these powers creates the karma. That wherein these powers are handled with proper management, the karma is that which may be termed as good.

This Awareness indicates that any entity who picks up a gun, a knife, or any weapon, is responsible for its use, and the awareness of that weapon and its use, and misuse is that which relates to the karma involved. This Awareness indicates that if an animal accidentally pulls the trigger of a rifle by stepping in the wrong place and shoots the hunter, the lamentations of the hunter's friends and relatives and all of the cries of injustice will not necessarily create karma for the animal. However, if a hunter shoots an animal, that hunter has created a certain amount of karma.

This Awareness reminds entities however, that all entities upon this plane, in one degree or another, have at least some degree of karma, and can never



be totally free of karma while in the physical body, except by the grace of the Divine. Therefore, although entities may violate each other, or violate animals and incur karma, they also may be given Grace for their salvation. This Awareness indicates that even as Grace is offered from Divine levels, let those who are merciful to animals and critical of hunters be willing to share their own understanding of these hunters and their level of consciousness, and give certain forgiveness or Grace as this is given. This being likened unto forgiving those who trespass against you. This Awareness suggests you also be willing to forgive those who trespass against those who you have loved, whether animal or otherwise.

This Awareness indicates that these changes in consciousness occur in sequence rather than in simultaneous experiences, and those who are vegetarians in one life, may return in another life in a family or condition whereby they are indulging in meat and may take some time to again return to the vegetarian path. This Awareness suggests therefore, that you recognize the overall process and not become so narrow as to condemn to extreme those who do not yet eat the same diet as you; that there are more areas of the spiritual life than mere food consumption,—this being a more recent concern in the Western world.

This Awareness indicates that the food consumption as a concern in one's spiritual growth and development has taken a center-stage spotlight position for many entities, even as the sexual concern which was prevalent 30 years ago, has been moved to backstage and is no longer given such attention by many of those in the spiritual movement. Yet, each of these concerns is legitimate and is wrestling with a question of serious magnitude as to whether or not things are being handled properly in terms of the right use and management of this particular issue. Whether this is sex or food consumption, it can be a spiritual question as much as a scientific question.



This Awareness indicates that therefore, all these voices should be allowed and should be heard, so that the focus on these issues can become clarified with all input available. This is that which allows for the evolutionary process to occur, and the conscious awakening of that which is within each individual; so that the entity, having heard all sides of an issue, is more able to determine for himself the path which he or she wishes to follow.

What Makes a Flavorful Bird?

ATLANTA—Let us say you are having a power lunch. The guy across the table says, "Steak, rare." You say, "Chicken breast with lime butter and dill."

You lose—as certainly as if you had ordered cottage cheese. A chicken lacks authority. Cowboys, not chicken farmers, tamed the West.

Yet while Americans cling to a self-image of beef-eating heroes, their diet is actually at a turning point. This year, the government says, the U.S. will become a nation of bird eaters.

In 1987, according to the Department of Agriculture, per-capita consumption of poultry will rise to 78.2 pounds. At the same time, per-capita consumption of beef will fall to 75.7 pounds. That will mark the end of more than three decades of dominance by beef (before that, pork was king).

Adjustments may be necessary. Can the nation's self-esteem handle it?

"Yes, there will need to be some sort of lift in our self-image as we become a nation of chicken eaters," says Emmett Miller, a member of the California Task Force to Promote Self-Esteem and Personal and Social Responsibility. "We may find other macho images that no longer include steak."

DO MACHINES HAVE A CONSCIOUSNESS ?

(HOW TO MAKE YOUR CAR DRIVE BETTER)

QUESTION:

A question from J.B. "Is there a machine consciousness? Is there a form of consciousness in machines, aside from the consciousness of the atoms and molecules? And what about computers? Is there the potential for higher consciousness to inhabit a computer if it reaches a certain level of sophistication and complexity?"

COSMIC AWARENESS:

This Awareness indicates that this is in the affirmative; that the consciousness involved in machines, such as the automobile, actually exists due to the aura of the material involved, the thought-forms of the one or more who possess and use the automobile. The energies cast off by an entity are often picked up by the machine, and these energies become the aura of the machine; thus an automobile being driven by a person who is highly paranoid of continual breakdowns, or of other things, may tend to develop a kind of aura which carries vibrations of paranoia.

This Awareness indicates that likewise, the automobile which an entity has great affection for may in turn run somewhat better, and run more efficiently simply because the aura, or thought-forms of the owner are more beneficial to the automobile. That all things in the universe are vibrations, even metal is vibration, and all vibrations in the universe, all energy is a carrier of consciousness.

The consciousness may be more dense in certain forms of material, and lighter in other forms of material, or may be in the space between matter. The consciousness of an aura is that which is generally higher than that of the gross matter. Thus, an aura set up around one's home or around one's automobile can serve as a protective device, or can draw in negative forces, depending on the types of thought-forms or the energizing of that aura. That for this reason, entities who wrap their vehicle in White Light for protection can in fact add to the protection of that vehicle. Entities who throw off and cast off hostility toward other drivers, and who see themselves as in constant conflict with the world and with other drivers, see themselves as aggressive, and their vehicle as a weapon, --these entities generally tend to create a thought-form around their vehicle which is aggressive and hostile toward others, other vehicles, and this kind of thought-form, when the driver's mind becomes somewhat tired, the thought-forms around the vehicle can outweigh the thought-form within the driver's mind so that those thought-forms around the vehicle can begin to direct the vehicle toward collision or toward violation of those automobiles which the thought-forms dislike.*

*Maybe this explains the current rash of wrecks and violence on the freeways, particularly in California.

Don't Curse Your Car or Your Computer

This Awareness indicates that in terms of a computer, entities who have good rapport with their computer generally have better luck with their computer. Entities who are in constant battle with their computer tend to enhance the computer's mistakes; that the cursing of one's computer can in fact cause the computer to develop thought-form energies which work against the user.

This Awareness indicates that this does not in any way mean that the machine, or the computer has an inherent quality or ability to think, but rather it does mean that one's own thought-forms, cast out and placed upon a machine or computer, can have an effect on oneself at a later time, whereby the effect may be of a nature that overpowers the present mind because of the thought-forms that have built up around the object and which are stronger than those of the user.

This Awareness hopes that this is clear. It is a difficult concept to explain. Essentially, it is likened unto the mind dealing with its own reflection,--energies which have been sent forth, which now come back to influence the sender.

COULD AN ALIEN FORCE TAKE OVER A COMPUTER?

FOLLOW-UP QUESTION:

There's no possibility of an outside Alien Force ever taking over a computer, is there?



COSMIC AWARENESS:

This Awareness indicates that this was not stated. This Awareness indicates that even as an Alien Force can lift an object and hurl the object across a room, likewise, an Alien Force could affect a computer. It is not however because it is a computer that an Alien Force would inhabit it; it is that an Alien Force can inhabit anything which it chooses to inhabit, so long as there is no stronger will opposing that inhabitation.

This Awareness indicates that an Alien Force could affect the circuitry and electronics involved in a computer so that the program would be lost or fouled up. However, this would require extreme energy, and that it would not be able.....This Awareness does not see any possibility of an Alien Force inhabiting a computer in a manner whereby it altered the message to a significant degree, or took control of a computer to cause it to give messages for the Alien Force, to allow it to control others.

This Awareness indicates that while this is theoretically possible, it is highly impractical and unlikely for an Alien Force could operate so much easier through an individual than through a computer. The energies involved in affecting a computer to deliver messages would more likely create computer malfunction, so that garbled messages occurred. This Awareness indicates that an alien energy, or spirit, attempting to inhabit a computer would need to be operating in such high consciousness levels in order to manipulate the vibrations, current, and energy fields that would result in a meaningful message; it would require such high intelligence that it is unlikely that such a spirit would be involved in that type of activity.

This Awareness indicates however, that a spirit can more likely operate through the user, through the programmer, through the entity who is using the computer, and thus present messages through this entity, placing these messages into the computer; that this is not an unlikely action by a spirit. This Awareness suggests however, that entities should not anticipate such possession, but should assume that they are immune to spirit possession.

When using a computer, entities should simply consider it a private action, just as taking a pencil in hand and writing a letter does not call for fear of being possessed by a spirit. This Awareness indicates that

there is a kind of fear of computers which is unfounded. That essentially, the computers are extremely stupid creations and can only function according to the programmings which they have been given; that they can however, function very rapidly in terms of those programs, and that is their great skill and the great value.

This Awareness indicates that in the near future, a great leap forward in computers will occur, whereby computers will be able to operate so much more quickly that it will obsolete present computers; that the future computers will operate not on electrical currents of on and off, but will operate in terms of light currents or light rays, on and off, and this will speed up the computers by approximately 1000 times the speed of present computers.

This Awareness indicates that there also appears to be in the very near future, new types of programmings which will allow the computers to better deal with probabilities and possibilities, whereby these computers will appear to be able to think, to evaluate circumstances. However, all of this is still nothing more than the programmings which have been put into these machines.

This Awareness indicates that it is not the computers themselves which are good or bad; they are simply a tool. It is *how* the computers are used which entities should concern themselves with. A knife can be used as a tool for good or for evil. A computer can be used as a tool for good or for evil. This Awareness indicates that the *motive* behind the use of the computer is that which entities should be aware of.

DOES A BERSERK COMPUTER LIE IN OUR FUTURE

(Closing Message)

This Awareness indicates it is conceivable, that in some future time when computers are highly evolved, that an entity who wanted to take control of a computer could send forth a transmission that would be picked up by that computer, to allow it to appear to have its own individual mind, such as was presented in the movie *2001*. This Awareness indicates however, that this would only be an appearance and would still need to come from outside programming; that there is no possibility of a computer initiating its own programming, except for that which is already put into the computer, upon which it may act.

This Awareness indicates that such a program that would allow the computer to reprogram itself, this is a possibility, and yet even that would need to occur only on the condition that the programmer allow the computer to have that capability; that it is not seen as a likelihood that such a computer would be created that could build upon its own thoughts, upon its own programming without the consent of some previous programmer.

This Awareness indicates that the computer does have the capacity to repeat commands, and to initiate

commands which have been given, or to repeat commands which have been initiated, but these all must come from an outside programmer. This Awareness indicates that there is the possibility that an outside programmer *could* make a mistake and *could* create a computer that was essentially berserk, or which gave directives that were detrimental.

This Awareness indicates that in terms of a computer inherently becoming evil or of taking on its own personality, or its own individuality without outside programming creating this; this is not a possibility. That the only way a computer can function is through the programming which has been given to it.

HOW TO MAKE CORRECT DECISIONS

QUESTION:

A question from J.W. in Ohio. "Could you please give some guidelines or meditations for making decisions? The kind of decisions we are all faced with, and with which I have noticed almost everyone struggle so: whether to marry, to have another child, whether to move or take this or that job... I'm referring to the decisions which require a yes or no, in many cases, fairly quickly. I can consult the cards, the Tarot, the pendulum, do some meditations, ask for a revealing dream. However, a lot of times I am not comfortable with my decision, and often I feel the decision is made higher up without all of my gyrations really affecting the decision, except to make me uncomfortable with decision-making. Anything else on the topic of decision-making will be very appreciated. Thank you."

COSMIC AWARENESS:

This Awareness indicates that you are generally correct in assuming that most of your decisions are made from higher levels. Essentially, the action of the rational mind is to justify the decisions which are made on higher levels to the consciousness, and to the philosophies of the rational mind. This Awareness indicates that the purpose of the rational mind is not so much to make decisions, but rather to examine and analyze all of the ramifications, all of the parts of a situation, to determine the ramifications of those parts, and of the alternative choices at hand. That if the rational mind examines the alternatives and the various parts of a situation, that is sufficient for its purposes; then, when this is accomplished, the decision will come from the intuitive levels of consciousness, and will be made for you in such a manner that you feel compelled to act and to move in this direction, even if it goes against your rational choice.

This Awareness indicates that part of the decision-making of the rational mind should include looking at the various consequences of becoming involved in an activity, if the choice leads in that direction, and what it would take to extract oneself from the activity if it turned out to be the wrong choice, and the cost of involvement in such an activity, and any possible or potential unseen costs or problems in connection with this. That also, one might consider how much has been or will be invested in that decision if the choice is made to go in that direction.

This Awareness indicates that another area of consideration by the conscious or rational mind, is to ask, "If I make this choice, what other choices am I foregoing?" Often, a choice in one direction excludes all other options available; that this may also cut off future options. This Awareness indicates that still, there are consequences which must be considered by the rational mind in making its evaluation relating to the choice of not moving in this particular direction, or in not doing anything at all.

This Awareness indicates that wherein the mind examines this action and considers, "If I do not take a movement or make a choice at this time, will this opportunity ever come up again?" The question might also be asked, "If I do not jump at this opportunity, will I be disliking my decision hereafter for not having moved in this direction?" Or, the question might be, "If I do not move in this direction at this time, what will I do instead, and will I simply continue along the path of letting opportunities pass me by?"

This Awareness indicates that another area which may be considered by the rational mind is, "Am I fearful of making this choice because of some personal insecurities, or am I refusing to choose because I lack the sense of adventure and faith?" The question may also be asked, "Am I jumping into this project for the adventure, rather than for a clear understanding and clear motivation?" This Awareness indicates that in asking yourself your motive for deciding or not deciding toward a particular mode of action, you become more aware of your own self, and this allows the rational mind to have a better understanding of the objectivity and subjectivity aspects of your choice. That once these are clearly understood by the rational mind, it can then be included as part of the subjective or intuitive decision-making process.

This Awareness indicates that you may also be under pressure from external forces to make a decision. The decision may be in part due to an impending deadline, or due in part to requirements of various conditions that something be done to change your present situation. This may be in terms of a financial need, or in terms of an emotional need, or in terms of a social requirement that is expected of you which has a deadline. An entity may not wish to wait any longer, this requiring you to make a decision quickly. This Awareness indicates that if you find yourself unable to make a clear decision because of the pressure and the deadline, it often is possible to change the

deadline. (It is often impossible also to change a deadline). But wherein it is possible, then you may be able to forestall the ultimatum and deadline and to have more time in making a clearer decision; that often, the pressure of a deadline assists an entity in focussing on the totality, and making the decision. However, in some cases, the pressure creates a bad decision.

This Awareness indicates that wherein things are of a harmonious nature, without these pressures, the energies generally tend to flow along in a course of action according to the influences involved in a circumstance, so that decisions are made spontaneously,—sometimes immediately, and other times, over a period of time. That some relationships, for example, are cultivated over a period of years, others are brought about in a single meeting, and the decisions are made instantaneously in regard to contracts, marriages or agreements.

This Awareness indicates that these things are often the result of astrological influences, along with personality types involved; some entities have no patience, others have great patience. This Awareness indicates the entity Jimmy Durante having been engaged for approximately 15 years; whereby his fiancée was asked how she could wait so long, the entity answered that, "Jimmy enjoys making careful decisions." This Awareness indicates that others may find themselves moving into a marriage or close partnership agreement in but a single meeting, whereby it is called "Love at first sight." Therefore, the personalities involved, and the astrological influences often determine whether a decision is made instantaneously, or over a period of time.

How Handwriting Reveals a Decision-Maker

This Awareness indicates that you look at your handwriting, particularly at the cursive m's and n's, and wherein these come to a quick, sharp point at the top, looking somewhat like w's or U's, rather than m's and n's; this is an indication of the personality which would make a decision rapidly, without having the full evidence at hand. This shows an executive-type of mind which can make decisions based on very little evidence. On the other hand, the m's and n's which are rounded at the top or which appear to be wedge-like in shape; these entities take a longer time and more evidence is gathered before a decision is made.

This Awareness indicates those with the rounded m's and n's, tend to make their decisions based upon familiar and secure data; those whose m's and n's look like saw-teeth,—sharp, triangular shaped points at the top with wide teeth in their movement upward and downward,—these indicate the entity who gathers data for the decision, and reaches the conclusion when the data is gathered. It matters not whether the material is familiar or requires new research to this entity, but the decision is based on researched information; whereas the entity whose decisions are made spontaneously, with little information, the teeth of

the m or n , the upward points, are generally of a thin line in the upper parts, with very little wedge at the bottom.

This Awareness indicates that in making your decisions, you may wish to consider which type of personality you are; that you may also wish to consider the astrological influences which are influencing the need to make a decision, and whether these astrological influences will be to your benefit. This, however, cannot be used in all decision-making, but should be considered in those decisions which are of great importance. This Awareness indicates that when all of this information, research, and evidence is gathered, before making your decision you may wish to then put it aside, recognizing its value, but laying aside the information, and then simply looking again at the decision and asking yourself, "How do I honestly feel deep inside? What is my intuitive reaction to this situation?" This Awareness indicates that this will include all of the information you have received, but will shift this into the intuitive machinery of your system.

This Awareness suggests you allow this to be placed into the pressure-cooker of your subconscious, or subjective mind, to allow it to come up with the clear answer necessary for your proper decision. This Awareness suggests you also may call upon your Higher Self, or to call upon the Divine Forces, and request these to give you the proper decision on this matter. At that point, you may release concern from the rational side of your consciousness, and turn this over to the Divine and intuitive sides of your consciousness. You may also request that these Divine and intuitive forces not only give you the answer, but give you enough information so that you will feel comfortable as to the reason why this is the best choice, and decision. This Awareness indicates you may receive your answer in a dream, or awaken at night with the answer, or this may come to you during a time of relaxation and pleasure; that usually the intuitive answers arrive when the rational mind is disengaged and you are involved in subjective levels of pleasure or rest.

This Awareness suggests that some decision are of little or no consequence; and if an entity is in continual disarray over making decisions, if the rational mind is continually frustrated at having to make decisions, you may also play a game whereby you create an option and flip a coin as to which to do. For example, the question of whether to go to a movie, or to go downtown and shop, or to do some other action, such as visiting a friend; these things are of little consequence. Therefore, it may be of value to you to settle these questions by the flip of a coin, in order to cultivate the realization within your own consciousness that your decisions need not be so difficult; that this will begin to allow more ease in making decision, so that they do not seem quite so significant to you.

This Awareness indicates that there is also a Bach Flower remedy available for entities who have difficulty in making decisions, so that you may be more inclined to look at the evidence and make the decision without fear. That often, even with evidence, an entity is fearful that the evidence might not be sufficient to make a proper decision; therefore, the entity remains paralyzed in the face of the decision. This Awareness suggests that this as an attitude which can be balanced and brought into alignment by the use of this Bach Flower remedy.


"I'LL SLEEP ON IT"

This Awareness indicates this answer from the blue cannot occur as long as the rational mind is engaged and thinking logically.

COSMIC AWARENESS:



4,500-year-old mummy has a heart that beats!



PAPYRUS found in tomb describes the mummy as a teenager.

Dutch researchers claim to have found a 4,500-year-old Egyptian mummy that still has a beating heart!

"It's not alive — but it's not dead either," said Dr. Tom Houwert, an archaeologist from Leiden, The Netherlands. "It's more like the mummy is in a state of suspended animation.

"Our job now is to find out what technology the Egyptians had discovered that enabled them to accomplish something that, even in this day and age, would seem to be impossible."

In a report published in a European archaeological journal, Dr. Houwert and a colleague, Franz Dekker, said the mummy was recovered from "a previously undiscovered chamber in a known tomb."

They said that artifacts surrounding the mummy's body were carbon-dated and appear to be at least 4,500 years old. The mummy itself has skin as supple as that of a baby, a single heartbeat every 20 to 25 seconds — and a strange, oxygen-laden

chemical coursing through its veins instead of blood. The tomb suggest that the mummy, which appears to be that of a boy in his middle teens, contracted an incurable disease," said Dr. Dekker.

"Because the hieroglyphs are quite unlike any we have ever seen, our translation is coming along slowly.

"But it looks like someone intentionally placed this boy in a state of suspended animation so that a future generation could revive him when they found a cure."

Analysis of the strange yellow chemical in the mummy's body,

so far, has been inconclusive, said Dr. Houwert.

The mummy has no brain waves, he continued, making it "highly unlikely that it could ever be revived." The mummy is currently be-

ing studied at an undisclosed facility in Egypt. But permission to take it out of the country has been applied for and could be granted by fall, Dr. Dekker said. "We need to get the mummy to our own lab so that we can study

it properly," he continued. "What we are dealing with here is nothing less than a form of immortality. "Not only is the heart of this mummy still beating, the body itself hasn't aged a day."



WILL MEDITATION CHANGE A HURRICANE'S DIRECTION?

QUESTION:

A question from A.M. of West Palm Beach, Florida. "When a hurricane or a great storm is heading for a location where one is residing, is there a way to change its course, send it out to sea where it could do no damage? Could one entity meditating on this redirect a hurricane, or would it take a group of entities. If so, what would be the procedure in doing this?"

COSMIC AWARENESS:

This Awareness indicates that this would require great psychic energies, that this is a possibility but not under present circumstances with the human condition as it is. That this would require a consciousness that supercedes that which is now on this plane. This Awareness indicates that the consciousness would need to be of such magnitude as to be in contact with elementals of nature, with that which may be referred to as certain angelic forces or as certain nature spirits. This Awareness suggests that wherein the consciousness was in close communication with these forces, it could have some influence on changing the course of these storms; however, that generally once the storm is set in motion, there is a reason for this and those forces creating such storm are not likely to change for one entity's desire or for the desires of many entities, for this has already been considered before the action began.

This Awareness indicates these also have much to do with electronic and magnetic forces emanating through the atmosphere and caused by certain planetary alignments, temperature alignments and air currents which were previously set in motion, resulting in this particular storm. This Awareness indicates that to head off a storm which is already in motion would be much more difficult than entities might realize, that wherein there were great numbers of entities together in extremely high states of consciousness, the possibility of diverting a storm into another direction, this as that which could occur. Yet, even if this did occur, only those who participated in this action would believe this occurred as a result of their actions and many of these themselves would have certain doubts.

This Awareness indicates that these energies required to change the course of nature are not likely to occur through the actions of one or two persons or even a group of persons seeking to create a change in natural phenomena; that the course of history in terms of natural phenomena will be more likely changed through the changing of the consciousness of the people of a nation or of an area. This Awareness indicates that an example might be that wherein

enough of consciousness is changed, an earthquake which would have occurred without that change in consciousness, that earthquake might be diminished or completely put off or at least delayed. That this however, would require a great change in the consciousness of such entities.

LSD and California Earthquakes

This Awareness indicates that an example of this is in the state of California, that the introduction of LSD and marijuana into the society as that which created in the last decade a certain type of change in the consciousness of masses of persons which also had influences into other areas, so that the static goal-seeking, career-oriented, competitive consciousness which existed in the early sixties, began to be transformed wherein more tolerance crept into this consciousness, the rigidity broke down and the static energies began to be diminished. That this left consciousness with greater pliable expressions. This Awareness indicates that what is occurring in the consciousness of entities also occurs in the aura of the area in which those entities reside: the aura of California as that which is no longer quite so rigid and crystallized as it had been in the early sixties and is more pliable; this affects the cells, the magnetic bonds in the molecular structure of the earth itself. This change in consciousness has affected the earth in that area and has delayed certain earthquakes which were prophesied to have occurred earlier, and has diminished many others which would have been much more devastating without this change in consciousness. This Awareness indicates that storms such as hurricanes can be diminished by the consciousness of entities meditating, by the consciousness of entities coming together as a group, or these storms may be diverted somewhat; yet this as being so minimal as to be imperceptible to the masses; that there would be no way to check or evaluate how much the storm was diminished, how much it was deflected, or whether the meditation had any effect at all.

This Awareness indicates that it would be more to your benefit to start out on something small, such as the dissolving of clouds or the clearing away of clouds or creating rain over an area where rain is needed; then when these have been mastered so that you and your group have repeatedly shown an influence on these levels, then you may tackle the big storms.

The "Gray Men"

Last month we promised you an article about earthquakes and earth changes, featuring interviews with geologists and oceanographers. However, in the week since Ramtha predicted an imminent economic collapse (at the poolside event on July 11), information has been pouring into Windwords at an amazing rate! We have received phone calls, articles, books, and a videotape from many diverse sources, and we feel that perhaps this is the most pressing of Ramtha's predictions. We'd like to share some of this information with you. First, here are some of Ramtha's comments on our economy:

File, March 1, 1987: With that which is termed changes in the earth's crust, to that which is termed the climatic changes, already your banking system is stressed and that which is called the paper money is only an illusionary thing, for there is not enough gold to back up its substance. . . . Climatic changes will bring great stress upon the whole of the world. In regards to physical endowment of paper money, it will be a collapse in the year to come.

Seattle, March 14-15, 1987: Money is futile to the men who control it. It's not your money. It is owned by the Federal Reserve, who is owned by the most powerful families since the days of Napoleon, and they're not about to give it up. . . . Though the paper is owned by the one who created it, every government, save India, is owned by world bankers. You didn't know that? Shocking! If you are aware of that, you begin to assess what it is you want. A dream that is not so fulfillable.

Governments and international powers sit on your wondrous emerald globe as players on a chess game. The one who pulls the strings owns the money. Your government doesn't go to war because of noble virtue; it goes to war because it's good business. . . . The moment gold no longer backed up the paper, you were breaking on thin ice. Your money is not yours, and someone is going to call the loan due.

Yelm, July 11, 1987: The government is in the last throes of agony and many new opportunities and beginnings are yet to come. Nature will be very slow in her evolution. Your opportunities are going to change dramatically. The whole world is on money, and it must come into balance. You will realize your dreams, but perhaps not in the limited fashion you've thought of them.

Eventually money will have no value. Make a tangible purchase of gold. The market will go into collapse and gold will be hard to come by. Your government will confiscate gold. By the latter part of September into October, be sure that you have bought gold.

Those of you with property and mortgages: your money becomes worthless in a market that has gone "cow" (not bull—it has no horns!). The dollar will have a value as low as seven cents, and your gold will reach the heavens.

Take gold and free yourself. Pay off your land and your absolute obligations. This monetary collapse is coming in the year to come. You must purchase your gold by the end of October. Prepare your food and your necessities—you are on borrowed time, literally! You are coming into critical times, more critical than you are even aware.

Of all the information that we have received at Windwords, the most startling is a videotape made on February 28, 1987, by Lindsey Williams. Mr. Williams is an ordained Baptist minister who for the past seven years has been travelling across the country as a speaker at thousands of functions. He went to Alaska in 1974 as a chaplain for the men working on the Alaskan Pipeline, and his experiences as an executive on the "inside track" with nine major oil companies led him to write *The Energy Non-Crisis* in 1980. This expose revealed that there never was an energy crisis and that the American people were being controlled by their government.

Several years and two books later, Mr. Williams now realizes that it is not the government which controls the U.S. but the powerful few who control the Federal Reserve. In his book *Syndrome of Control*, Mr. Williams asks, "Did you know that the Federal Reserve. . . is not an agency of the Federal Government, but is a privately-owned corporation established in 1913 by an act of Congress? Don't let the word *federal* fool you. The Federal reserve is no more a part of the Federal Government than is Federal Express! Over one-half of the controllers of the Federal Reserve are not even citizens of United States, yet they control our currency, interest rate, and lifestyles."

It is interesting to note how close Mr. Williams words are to those that Ramtha uses in March at the Financial Freedom workshop: "Your Federal Reserve system was formulated by international bankers. It is not owned by your country. You would be amazed how many think

because it says *federal* it means the government owns it. It doesn't. It's owned by very powerful entities who for eons through religious dogma have created war. And those same entities no longer back your dollar with gold because your country has not got enough to back up the paper monies. It is not you who create inflation, deflation, it is not you who create rises in stocks, bonds. It is they who control the world through money."

On the videotape, Mr. Williams shares a cassette tape of a conversation with Jonathan May, who spoke with him over the telephone in December 1986 from a Federal prison in Minneapolis. May revealed the details of a world-wide plot called System 2000, which has the ultimate goal of bringing a total economic collapse and putting the American people under the control of the international bankers. May was working to implement an International Federal Reserve System, which would undermine the bankers' plan, but his life was threatened in his native England, and when he fled to America he was immediately imprisoned.

On the tape, May began by explaining that thirteen families effectively control the central banks of all the hard-currency countries. These central banks all practice fractional reserve banking, which is perfectly legal in the United States. Fractional reserve banking means that the bank is only required to hold on hand the small fraction of money (5%) that is needed to cover the fraction of deposits likely to be drawn upon and cashed. In other words, if you place \$100 in a savings account, your bank is only required to keep \$5 of that money. The other \$95 they can loan out and collect interest on. It is important to understand this concept in order to understand the larger picture.



In the mid-1970's, the final stages of the final phase of System 2000, a "global creditors' unilateral totalitarian plan," were put into effect. A Pentagon official and three other U.S. officials went to the Prime Minister of Nigeria and offered him fifty million dollars in cash to double the price of light crude oil. Nigeria is one of only two countries in the world that produce light crude, which is an extremely pure form of oil whose price sets the standard for all other forms of crude.

Armed with the knowledge that, because of their deal with Nigeria, the price of Mid-east oil was about to skyrocket, the international bankers went to the Arabs and said, "We will send the price of crude oil as high as you want, if you will promise to invest some of the money you make in the United States."

Nigeria doubled the price of light crude, the price of oil from the Mid-east went up, and the price of a gallon of gasoline in the United States jumped to \$1.20. Unwillingly, Americans began to finance System 2000 with every tank of gas they bought.

As the money began to pour into the Arabian countries, the sheiks fulfilled their promise to invest in America and began buying stocks, bonds, and real estate. More importantly, they put money into thirty-year timed certificates (drawn up by the international bankers). Remember that the Arabs went from camel-riding nomads to wealthy international investors in a very short period of time, and they had no grasp of how the banking system worked; in particular, they did not know about the concept of fractional reserve banking.

The international bankers now had millions of dollars locked into timed deposits, and they took that money and loaned out *twenty times as much!* In 1983, the international bankers created two holding companies to handle all this Arab money. One of the holding companies bought farmland and successful businesses; the other took the funds coming in from the Arabs and loaned it

out to Third World countries. The purpose of the holding companies, as you will see later, was to remove the responsibility for the money from the actual banks to a less accountable entity.

The international bankers were aware of the fact that most of the Third World countries knew nothing about running a country or allocating funds. Most had been colonies of some other nation and had only recently begun to govern themselves. The bankers were counting on the Third World countries to squander their money in a short time; they fully intended for these countries to go bankrupt and to be unable to pay their loans.

The Philippines are one example of what happened to the Third World countries in the next stage of the plan. The international bankers went to President Marcos and presented him with a way out of the enormous debt his country faced. They said, "We will forgive your loans—you'll have to pay none of the principal, none of the interest—if you will just sign this agreement." Under the agreement, the country would have to do three things: (1) do away with its national currency; (2) go to a debit-card system, where each person is assigned a number and his purchases are debited from his account on a computerized system; and (3) sign over perpetual rights to all natural resources in the country.

The offer was tempting, since it would put much of the labor force back to work and solve many of the country's economic problems, but Marcos realized that because of the word "perpetual" he was virtually giving away the sovereignty of his country. He refused to sign the agreement. Weeks later he was deposed and his country was torn apart by riots which May says were incited by the international bankers.


Other countries decided to accept the agreement when it was offered to them. Recently Brazil, Argentina, and other nations have announced that they do not plan to pay back their loans. They failed to mention that the loans had been excused in exchange for rights to their natural resources.

At this point, all of the dominoes are in place and the international bankers are waiting for their opportunity to topple them.

Here is the plan. When enough of the Third World nations sign the agreement saying they are not going to repay the loans they received from the holding company, the international bankers can declare the holding company insolvent. (This is where it becomes apparent why the money was put in holding companies instead of in banks. The holding companies were designed to go bankrupt! Chase Manhattan or Chemical Bank would not have to be sacrificed, since they were not responsible for the loans.)

Once the holding company is declared bankrupt, they can legally avoid payment to the Arab Nations. The international bankers will say, "Sorry, Arabs. We lost your money. You are broke!" When the Arab nations realize that all their money is gone, they will immediately liquidate all of their other assets. They will dump billions and billions of stocks and Wall Street will collapse. They will put all of their farmland and real estate on the market, and land values will plummet. Farmers will have no collateral to borrow against to plant next year's crops, and food will become scarce in the grocery stores.

The effect this will have on the American economy will be chaotic. This catastrophic collapse has been purposely designed to throw the American people into a state of confusion. Then the benevolent bankers will step forward, say "Look what these dirty Arabs have done to you!" and offer a solution to our problems.



Their solution will be to abolish our currency and institute a new form of money. Each person would be issued a government ID number and would need a debit card to do any business transactions.

Perhaps the biggest shock in May's story is that the Star Wars system is only 40% concerned with defense, and 60% concerned with banking! These Star Wars satellites would link the debit system to a central computer base—a superbank. Transfer of funds between accounts would be instantaneous, and the international bankers would finally have complete financial control. May says the debate over Star Wars is all show because the satellites are already in place!

How close are we to the final days of this scenario? The fractional reserve banking idea works in reverse also! When only 5% of the debtor nations sign the agreement, the holding companies can be declared bankrupt and the rest of the plan can be implemented.

We called Mr. Williams to get an update on how the situation has changed since February, and he says the figure is probably close to or even over the 5% mark already, and the international bankers could put their plan into effect at any time. Their main focus is power rather than money, and they may "play" a little before lowering the boom. For example, they could create a war situation or increase inflation.

For a man who had not heard of Ramtha's predictions, Williams' advice sounded remarkably familiar: Get out of debt! Have a roof over your head that is paid for, and stock up on food and provisions. He says gold is an excellent bartering item and historically has been a good hedge against economic woes.

Ramtha has talked extensively about the "gray men" who control our economy and he says that they have conspired to make our financial world collapse and send us back to a Marxist state. The picture is not without hope, though, for the gray men had not counted on two things.

First of all, the changes in nature are going to do much to thwart the plans of the men in power. Secondly, Ramtha says that the American people are beginning to question who owns their money; they are beginning to take back their power and stand up against the international bankers. At the one-day event on July 18 he urged us to support this movement—"give your energy to it."

At this event, Ramtha again urged us to buy one-ounce gold coins and silver coins and put them away. If you desire to do this, we can suggest a couple of ways. Some banks sell gold coins, and you can check with them about current prices and registration policies. A reputable coin dealer can also sell you coins, or gold bars if you prefer buying gold that is not minted by a certain country.

Dealers will quote you the spot price of gold, which is the current delivery price of a commodity traded in the spot market (sometimes called the cash price). In addition, there will be a commission charged by the dealer. As an example, we called one of the dealers listed above on Friday, July 17, and he quoted a spot price of \$448 plus a \$12 charge for a South African Kruggerand or a \$22 charge for the Canadian Maple Leaf, which means you would pay \$460 and \$470, respectively, for these one-ounce coins. It is wise to contact several dealers and check their prices as well as what services they offer as far as delivery and commissions, and find one that you feel comfortable with.



Windwords is not a financial planning institution—we're still learning about the gold market, too! If you plan to do any large-scale investing, we suggest you contact a professional dealer for more information. Also, remember that at some point you will be selling your gold, so it might be wise to inquire about that procedure at the same time you check on buying.

The "Gray Men"—Part II

Last month we shared with you the summary of a videotape called *International Financiers: Conversation with Jonathan May*, which came to us just before we went to press. This video, narrated by a man named Lindsey Williams, told the details of a plot designed to destroy our economy and put control of the world's finances in the hands of a few powerful men—the "gray men" Ramtha has spoken of. After the release of our August issue, Ramtha was asked if the information in the tape was true. He indicated that except for some details, it was.

Now we'd like to back up a bit and explain the background behind the story. Who are the gray men? How does the Federal Reserve System work? If it's unconstitutional, why doesn't anyone challenge it? Let's start with the story of America's Federal Reserve.

In 1791, Alexander Hamilton wrote a proposal for America's first Central Bank. It was debated hotly in Congress and strongly opposed by Thomas Jefferson, but it passed and was in operation for 20 years. When the time came to renew the charter in 1811, Jefferson opposed it again, saying it was unconstitutional and "more dangerous than any standing army." This time it did not pass.

In 1816, the bankers tried again with a Second Central Bank almost identical to the first one. When the charter was up for renewal 20 years later, it was vetoed by President Andrew Jackson after passing Congress by a narrow margin.

It was almost 80 years before the bankers tried again. In 1910 a small group of influential men met for two weeks at Jekyll Island off Georgia and planned America's monetary future. They drafted the "Aldrich Plan." After three years of refining, it was renamed the Federal Reserve Act, even though it had nothing to do with the Federal government. On December 23, 1913, the Federal Reserve Act was passed in Congress with little debate since most congressmen had already left for the Christmas holidays. Many scholars say that Woodrow Wilson received support from the international bankers for his presidential election in exchange for getting the Federal Reserve Act passed.

The Act divides the United States into twelve district banks which hold the reserves of member banks throughout the system. The Fed (a private corporation!) prints up money and its district banks then loan out the money to the member banks and charge interest on it, adjusting the rate as they please. By making the interest rate higher or lower, they control the amount of money a bank can afford to borrow, thus the amount of money in circulation. At crucial times in U.S. history, they have used this power to tighten or loosen credit and create chaos.

A few examples. The Federal Reserve Board charged low interest rates prior to the crash of 1929, and this "easy money" contributed to America's wild spending spree. During the Depression in 1931, they drastically raised the rate, which tightened the market just when the opposite was needed. In 1937 the Fed increased the reserve requirements of the member banks, which tightened credit and sent the economy into a tailspin; unemployment soared. In 1970 the Fed again tightened credit, resulting in a stock market crash and a national recession. In the mid-70's President Ford encouraged the Federal Reserve Board to tighten credit again, and this action prompted the worst recession in 40 years. In 1979, the Fed raised its interest rates, sending mortgage rates up to 15 percent and the prime lending rate to 20.

While in retrospect it may seem obvious that the Federal Reserve Act was not a desirable piece of legislation, if you consider the state of the union at the time of its creation the situation becomes easier to understand. The country had been going through a series of recessions, and legislators were promised by lobbyists that this act was going to control this "boom and bust" cycle. It was implied that the Fed would pay the government for the privilege of printing money for the nation, when in fact the government pays the Fed for the privilege of using it. The Fed was supposed to provide free banking services for the government, when in fact they have charged for these services all along. The Fed supporters promised to manage the nation's money in a way that would keep the economy stable; instead, it has been devastated. Perhaps most importantly, the Act was supposed to save farmers and small businessmen, when in fact these are the people who have been hit hardest.

Again, it is important to realize that Americans do not have federal government notes or gold certificates as currency; we have Federal Reserve bank notes—fiat

money issued by a private corporation. The Federal Reserve is not a government agency.

If you look at a dollar bill, you'll notice that in the spot where it used to say "silver certificate" (meaning it was backed by silver and you could go to any bank and exchange it for a silver dollar), it now says "Federal Reserve note." These notes are loaned by this private corporation to the U.S. government at full face value, and the government pays an annual interest on them in gold. Since by law you cannot buy something with money that is not yours (the notes are only on loan), everything you have bought with Federal Reserve notes actually belongs to the Federal Reserve!

If the Fed did not exist, the U.S. government could print its own money and save billions of dollars each year in interest! The whole concept of the Federal Reserve System goes against the Constitution, which states in Article I, Section 8 that only Congress has the power to "coin money and regulate the value thereof." If it is unconstitutional, why doesn't anyone challenge this system? A few have tried.

Charles A. Lindbergh, a congressman from Minnesota and father of the famous flyer, spoke on the floor of the house on the day the Act was passed, saying "the worst legislative crime of the ages is perpetrated by this banking and currency bill." Just before his death, Woodrow Wilson expressed regret over his part in the Federal Reserve Act, saying, "Unwittingly, I have ruined my country." William Jennings Bryan, who had a great deal to do with getting the bill passed, said later, "That is the one thing in my public career that I regret—my work to secure the enactment of the Federal Reserve Law."

Others have done more than just express regrets. In 1933, Congressman Louis McFadden actually brought impeachment charges against the members of the Federal Reserve Board and the heads of the 12 district banks. His shocking indictment was moved to the Committee on the Judiciary, where it still awaits reporting to the House floor! In 1957, Senator George Malone conducted a fact-finding session with the chief of the Federal Reserve and concluded that "it all adds up to a pre-conceived plan to destroy the economic and social independence of the United States." Nothing ever came of his report.

In a speech at Columbia University, President Kennedy said, "The high office of president has been used to foment a plot to destroy the Americans' freedom, and before I leave office I must inform the citizen of his plight." He was assassinated ten days later. More recently, Congressman George Hansen of Idaho revealed the "Gestapo tactics" of the I.R.S. and published the true story of the Iranian hostage crisis. He is now serving one year in prison for not reporting his spouse's bank account in a financial disclosure statement, a "crime" for which Geraldine Ferraro was convicted but never punished. Last July, Jonathan May was imprisoned under false charges with no chance of parole after he tried to establish a World Bank which would circumvent the Federal Reserve (see article below).

Perhaps the best defense the international bankers have against these protesters is influencing the public's opinion through the media. In his book *The Naked Capitalist*, Cleon Skousen says that "Nothing panics the

international Establishment like the possibility of a threatened exposure. Whenever the public has become dangerously aware of the conspiratorial processes operating around them, the vast, interlocking power structure of the whole London-Wall Street combine has immediately shifted into high gear and raced to the rescue. Radio, TV, newspapers, magazines, government policy makers, college officials, and other opinion molders in high places have all commenced a recitation of a carefully prepared line designed to pacify the public and put them back to sleep."

Who actually controls the Federal Reserve? Who are the stockholders of this private corporation? In a legislative session regarding abolishing the Fed, the following eight family banks were named as the owners of the Federal Reserve:

Rothschild Banks of London and Berlin
Lazares Brothers Banks of Paris
Israel Moses Seif Bank of Italy
Warburg Bank of Hamburg and Amsterdam
Lehman Brothers Bank of New York
Kuhn, Loeb Bank of New York
Chase Manhattan Bank of New York
Goldman, Sachs Bank of New York

In his book, *To Seduce a Nation*, Lindsey Williams lists the same eight banks.

As we reported in August, the ultimate plan of the international bankers is to bankrupt the Arab nations, which will force them to sell all their stocks, bonds, and real estate, thus collapsing the stock market and drastically lowering land prices. After this economic collapse, business will still go on but with one major change: everything will be in control of the bankers. Farmers may still live on their land, but only as tenants; the farm will be owned by the bankers. Transportation will be owned by the international bankers. Your house will be owned by the bankers, and you will rent from them. Currency will be banned, and you will make purchases with a debit card that is tied into the bankers' supercomputer.

How can you remain sovereign and not be indebted to the bankers? Ramtha suggests buying gold and silver. As it is seen now, the bankers are planning to collapse the stock market in May of 1988, and the dollar will drop as low as seven cents, while the price of gold will "reach the heavens." If you own gold, you can pay off your debts and be sovereign.

It is interesting to note that we legally have been allowed to own and hold gold only since 1975. In 1933 President Roosevelt issued an executive order to recall all privately-owned gold, and for more than 40 years it was illegal for Americans to possess gold. Non-compliance brought a \$10,000 fine and 100 years in prison.
