

WITH THE AQUARIAN AGE NOW HERE, IT'S TIME TO FINALLY RECOGNIZE THE ESSENCE OF CHRIST AND THROW OUT THE RIGID RULES AND THE STRUCTURE

(GOD ? WHAT'S IN A NAME?)

(Opening Message, C.A.C. General Reading, February 2, 1988)

COSMIC AWARENESS:

This Awareness wishes to assist entities in putting things in proper perspective in regard to the title or name of the Divine Being. This Awareness indicates that to this Awareness it is of no consequence what name you wish to use in addressing this Awareness. This Awareness indicates that there are those who promote one deity or another, who feel there is something extremely sacred about a particular name, and this sacredness of the name often becomes more important than the deity itself, for these entities often are so enraptured by the name, they forget to look behind the name, at the deity.

This Awareness indicates for example, entities speak of God, but do not know what they are speaking of. When asked: "Who is God or what is God?" they look at you blankly, and simply say: "God is God!" It is but a word to them, a name. This Awareness indicates there are those who say Jesus, and see Jesus as the only deity, and yet they do not make

a great effort to worship the message, the essence of Jesus. They worship the name, and feel the name is sacred, and it is the mouthing of the word Jesus which is most important to them.

This Awareness indicates there are many who wrap themselves in the name and the cloak of Christianity, then go about doing those things which are not in the teachings of Jesus, or Christianity, yet because they have the cloak, and the appearance, and the claim and the title and the label of 'Christian', they call themselves Christian. This Awareness indicates It wishes at this time to look carefully at what the spiritual life actually is, rather than that facade and title and name and label which entities often use in order to benefit on a worldly level, by the claim of being a follower of this or that deity.

This Awareness indicates were you to assume that the title or name was the important factor in being an adherent to a particular philosophy, and that the Universal Creator insists upon you using that particular title or name of that particular deity in order for you to truly be salvagable or 'saved,' as is often taught by some entities, then indeed, it would be important to put this teaching to the test, and ask yourself: If you were the Universal Deity, in charge of the entire creation, having as part of your creation billions of stars, billions of galaxies that stretched endlessly throughout space, and one of those billions, at a particular split second in time, a split second in eternity, had an event occur on one of Its planets, in which an entity was placed in a situation of expressing the Divine Message, and a condition of salvation presented to those entities on that planet, whorling around one of those billions of stars, a condition for the salvation of a group of entities was that you had to use that particular name, which luckily, was familiar to the tongue of the people, for it was a common

name among entities in that particular culture. If this is a universal condition for salvation, and that all of the experiences on all of the planets, on all of the stars, the billions of heavenly bodies that exist before and after the life of that planet; if this was a universal condition that that particular name had to be used, then indeed it would be fair that all of the other planets on all of the other stars, all of the entities on all of those planets, in the ancient past, from the beginning and in the future, would all have a standard requirement of using that particular name in order to have salvation.

This Awareness indicates without such standardization this use of a particular name on one particular planet would be an aberration of Universal Law, rather than universal in its nature. This Awareness indicates that it is unlikely that all of the planets in the universe would have the exact dogma and requirements of the Christian religion, even down to the requirement that entities use the same name. This Awareness indicates that on these billions of stars and the planets which are inhabited among these, did the story of Christianity get enacted for the masses on all of those other planets, so that there is a universal standardized method of salvation, or is the earth singled out, whereby the earth is divided even to the point where only a portion of the earth is singled out, and required to use this particular religion and not vary?

This Awareness indicates that by thinking carefully, regarding the immense distance in terms of time and in terms of space, is it truly likely that a Universal Deity would present such a narrow philosophy, a particular routine or methodology as described in the Christian religion for salvation as opposed to the punishment of not choosing that particular routine or methodology? This Awareness indicates there are many who see this method of salvation as being the absolute and only way to avoid the fires of hell throughout all eternity (all eternity, a concept that is unfathomable by the mind); long before the universe came into existence, long after all planets and stars burn out.

This Awareness indicates this essentially is what the teaching, as many present it, is all about. Entities come into this plane, are introduced to this teaching, become frightened, and are threatened by the coercion of the fear of eternal flame, eternal damnation, eternal suffering, if they do not choose to follow this particular teaching of a very small group of entities, on a very limited part of a planet, which, in itself, is quite small in an obscure solar system, on the outer edges of a galaxy filled with millions of suns, a galaxy which is but one of millions of other galaxies which stretch throughout a universe which is but part of a still greater reality.

This Awareness indicates putting this into perspective, allows entities to look at the probability

of whether or not there is any absoluteness to this, or if it is simply words misunderstood, and misused, as a form of brainwashing. This Awareness indicates that it is not to say there is nothing in the Christian religion of value, for indeed there is, but rather, this Awareness is indicating that the interpretation, as given by many, is very limited, and for a particular level of consciousness which could benefit approximately 2000 years ago when it was first given, and in that benefit the consciousness would be expanded by such a teaching, to grow and evolve into something higher than what was normal at the time, but whereby entities in this present day understand that the world is not the only part of the universe; this planet is not a flat piece of ground which God created, with little spots hanging around in the sky called stars which were perceived as mere lights, but a small speck of dust in an enormously large universe having greater heavenly bodies; whereby entities see the entire universe in a different perspective, with a different frame of reference, the view of the early Christian dogma, as presented, is outdated, and the higher interpretation, the greater understanding of Christianity in its symbolism must take on new meaning, must be understood as something more than simply a method of getting the people into a programmed setting, whereby their society agrees on some abstract concepts which boggle the mind and influence behavior according to social dictates.

This Awareness indicates essentially, it is not the name that is of utmost value, but the essence of the Divine Being. If you were the Divine Being of the Universe, and there were certain microscopic individuals, would you indeed demand that those microscopic individuals call you by your right name, even though they have not the ability to be absolutely sure that the right name they think is yours is actually your right name? This Awareness indicates and suggests that you visualize a cell in your body as representing the earth, and on that cell, microscopic creations or beings, tiny atoms on the cell as representing individuals on the earth. Ask yourself, if you were indeed this Divine Universal Being, would you demand those microscopic atoms worship you by a particular name, or be cast into everlasting punishment?

This Awareness indicates the Deity is not so vain as man would have him be. The deity is not so proud, nor even so absolutely concerned about such trivia. The deity only wants to assure that all the cells, all the parts in the universe are healthy, are evolving, are growing. This Awareness indicates that entities on this plane exist as a part of the body of the Deity. Entities on this plane help to keep the cell known as the earth alive and well, or they turn against the cell and work toward its destruction.

This Awareness wishes that entities help to keep the cell alive and well. It is not concerned that a part-

icular name be used in mouthing allegiance to this Awareness, nor that a distinction be given to the terminology or the methodology of serving this Awareness. This Awareness indicates that *It* doesn't even require that you refer to *It* as this Awareness, or as God, or as any other particular name; these things are not important. It is not important that entities worship this Awareness or any deity, except for the value the entity may receive from such worshipping.

This Awareness indicates if you were the Universal Deity, would you require the cells in your body to worship you, or would you not simply wish to take care of the cells in your body, hoping to keep them in harmony? This Awareness indicates that entities tend to turn around what is of significance and to put their own projections on other things, and put their own values on their higher beings. This Awareness indicates in the past, when entities were highly ambitious, and felt that the greatest thing would be to have power over others, entities projected this feeling to their deities, and believed that that was what made a god; that power over others created a god, and that this was the great importance and value of being a god.

This Awareness indicates that later, they saw the power over others as a god that rescued, rescued them from their dissatisfaction, thus, the Saviour of Man was created as projections of consciousness; that these projections of human values onto the deity as that which often creates the qualities that entities attribute to their gods, depending on what culture they live in. This Awareness indicates that different cultures project different qualities on their gods, according to what they think are important values. This Awareness wishes entities to start thinking in a different way, to recognize that their deities do not necessarily correspond to the projections that entities seek to put upon them. This Awareness indicates that the deities simply are there. They are of an order and of a level and they have their particular nature, and energies that are presented to those deities by individuals may be used according to the nature of the deity.

This Awareness indicates that those who are of the higher order, those deities of high vibration, those who are called pure, which are called gods; those entities are energies; they do not necessarily require that you use your particular language, your particular culture. It is for this reason that when the Hindu give praise to Buddha, or give praise to Krishna, or to any deity; it does not matter, as long as the entity believes the essence of the deity hides behind the name and that the name can simply serve as a hook to catch the attention of the deity. It does not matter whether one is Hindu, Buddhist, Krishna devotee, Christian, or some other, but what does matter is that the essence of the being as symbolized

by the terminology or label or name, will be attached to the consciousness that seeks to locate that energy.

This Awareness indicates therefore, the entity who prays to Krishna, will conceive of Krishna as having certain concepts according to the philosophy of Krishna, according to the way the Krishna entity has been presented and is perceived. The entity who prays to Christ, to Jesus, perceives this Jesus according to the information he or she has heard, has read, has received about Jesus. The entity who perceives Jesus may see a totally different entity than another who perceives Jesus, for one may be taught of Jesus in one way; another may be taught in a different way, and each entity may see a different Jesus when the name is spoken.

This Awareness indicates words are not the absolute truth. The truth lies behind those words in the essence of the being, but many entities attribute and project their own experiences and their own attitudes to that name, that label of the being, and therefore, they do not discover Jesus, they do not discover the reality of the being, rather they use the name and call forth the energies of the past experiences which have been associated with the name in their own life, and those associations which they have learned through their experiences, in terms of the use of the name Jesus, are the energies which they tap.

To See Truth, Strip Away the Words

This Awareness indicates that it has been said that if you strip away all of the words in the universe, then you will see the truth. This Awareness indicates that most animals are without words, live with very few words in their consciousness. Some animals will know their name, some animals will know the sound and meaning of words spoken; that certain words mean: "Come get your food!", that other words mean: "Get out of the way!" They do not say these things in terms of sentences or words. They simply know to move one way or the other because a certain sound has been given. Yet these entities see and recognize and understand reality, partly because they are not affected by words. Words are said to separate mankind from the animal world, yet words also create shields and blocks that hinder the entity from seeing what is real, for an entity will look at something and see the word and the entity will become so enraptured by the word, and all of these other words that are brought to mind by that word, so that the entity cannot actually see the thing that lies behind the word.

This Awareness indicates there are certain entities who promote, for example, the word: 'democracy' or the word: 'freedom', and these words are banners, likened unto flags, to be worshipped, and yet, if you were to ask the entity: "What does freedom mean to you?", they may describe the freedom for their own selves to do what they want to do, regardless of what it does to anyone else. This Awareness indicates that

this is not freedom, for entities cannot be free until *all* are free and are freeing each other, and one cannot free another without being willing to compromise on some levels, so that there is room for others to also be free of oneself, of one's selfishness, of one's greed. You cannot have everything without hindering the freedom of others.

This Awareness indicates entities often speak of democracy and see this as a great and noble ideal, and entities will promote democracy, even at the point of a gun, even at the point of great devastating weapons, even at the point of possible global suicide. Is that democracy? Or is that not just a word which leads to potential for destruction?

This Awareness indicates that it is not the word that needs to be worshipped, it is the essence which the word intends to stand for which lies behind the word. This Awareness indicates that down through the past 2000 years, Christianity has been presented as a structured form, and Christ's teachings have been presented not for entities to follow so much, but for entities to promote and impose on others, even at the point of a gun.

Perverting the Essence and Spirit of Christ

This Awareness indicates that the structured Christianity, the religion, the promotion of Christianity is not an example of Christ's teachings. The teachings of : Love One Another; the teachings which were given to entities cannot be presented through military means, through the knights who went out to slaughter the heathens, to the conquistadors who invaded Peru and destroyed the Incan empire, to those who worked to inquire as the Grand Inquisitors, to find out whether or not you were a true Christian or whether you should be burned at the stake for heresy. Were Jesus to be there in those times, in those places, would Jesus be nodding his head and saying: "Right on! Give them Christianity! Let them learn! Help them to develop! Burn that one! Slaughter that one! Kill that heretic!" This Awareness indicates that was not Christianity, that was the outward form, using the essence and spirit of Christ in a perverted way.

It's Time to Throw Out the Old Structure of Christianity

This Awareness indicates it is time, in this Aquarian Age, for the spirit to be worshipped, the essence of Christ to be recognized. It is time now that the structure, the formation, the rigid rules and regulations be thrown out, except where they promote the teachings and essence and spirit of Christ in such a manner that Christ himself would agree as appropriate. This Awareness indicates that were Christ here today, walking among you, he would not worry that you proclaim yourself his disciple, or that you tell everyone that you are a follower of his; this would not be a requirement for your salvation, for this entity needs not your adoration, this entity needs

not the vanity that would demand absolute obedience and worship. This entity would be more inclined to worry about whether or not you were treating others properly, whether or not you loved yourself sufficiently, whether or not you were evolving spiritually.

Jesus on Reincarnation: "Whom do they say I Am?"

This Awareness indicates there were many things attributed to Christ which he did not actually say; that there were many distortions in the Christian philosophy which have not fully been explained. This Awareness indicates that when the entity Jesus spoke of himself, he often spoke of the Son of Man, but there were times when there was a reference to the Son of God. This Awareness indicates Jesus recognized the Higher Self, the Christ which spoke through him, and he also recognized the human self, the man, Jesus. Thus, when he spoke to his disciples and said: "Whom do they say I am?", he was asking who people thought Jesus the man was, and his disciples answered: "Some thought he was Elias, or one of the prophets, others thought he was John the Baptist." This Awareness indicates that he answered to his disciples that: "Elias had come and was John the Baptist."

This Awareness indicates this entity was speaking of reincarnation. This entity was explaining to his disciples that he was not the one people thought was the reincarnation of Elias. This Awareness indicates this refers back to a prophecy of Malachi, who indicated that Elias would return. This Awareness indicates that in this passage, the entity was referring to himself as a man; the Son of Man is a reference to the physical Jesus, yet, this Awareness suggests the entity also spoke of himself as the Christ, and when doing so, the entity was actually channeling the Christ Consciousness, and when the Christ Consciousness spoke through Jesus, *It* was identified as the Son of God.

This Awareness indicates that when Jesus's words expressed as a channeling: 'I am the Way, the Truth and the Light,' he was not speaking as the son of Man, or as a human, the being known as Jesus, rather, it was the Christ Consciousness, speaking through him, even as this Awareness speaks through this Interpreter. This Awareness indicates *It* is not the Interpreter, nor is the Interpreter this Awareness. There is a distinction between these two. The Interpreter is but a channel through which this Awareness can communicate on this plane. Likewise, Jesus was a channel through which the Christ Consciousness could speak to entities on this plane, and the Christ Consciousness defined *Itself* as being the Way, the Truth and The Light.

This Awareness indicates that in the Huna philosophy from Hawaii, the High Self is defined as a certain terminology, which when broken into syllables is composed of words which mean the loving parent, the path, the light, and this Awareness indicates this essentially

is the same terminology used by the Christ speaking through Jesus: the Way, the Truth and The Light. The Truthful One of the Hawaiian version of the High Self, is also spoken of as a parent, a loving parent who always is truthful, is Light. This Awareness indicates this entity is also expressed as a Path or Way, thus, it is the Father in Heaven, in the terms of Jesus.

When the Christ spoke, or when Jesus spoke saying: "I and the Father are One,"--this was another parallel reference to the High Self defined in the Huna philosophy. This Awareness indicates essentially, Jesus was a Kahuna; Jesus was the son of a carpenter. The word Kahuna in Hawaiian means carpenter, one who works with wood. This was a coded name to assist, to inform entities that this Kahuna or carpenter or builder, is a teacher. This Awareness indicates in the Hebrew language, the priest was called the Kohena; the name Cohen coming from this word. In Egyptian, it was the Kohenna (Kahenna); the term is found in variations throughout the world and is related to that of the builder, the carpenter and the priest.

This Awareness indicates that the Biblical Jesus as having been presented in story form in such a manner as to convey a secret message for those who were initiates, while also conveying a message for those who were the masses, who could not comprehend such inner teachings, and those masses could read the story literally, without ever understanding that there was a hidden philosophy, a hidden philosophy which explained how the miracles took place, which explained the workings of Divine Reality. This Awareness indicates it is not necessary that entities take the *New Testament* literally in order to find salvation, for its deeper meanings are given in order that entities might learn, evolve and grow, to become one with

God, to merge with that which is the Highest and Best, rather than standing back as laggards and worshipping a name which is likened unto a sign post pointing to the destination.

This Awareness indicates that those who receive the outer or exoteric teachings of Jesus, are those who are the seekers, who follow the path to where the Eternal are, who seek the answer to spiritual truths; those who enter into the inner teachings as initiates, understand the deeper meanings and become not worshippers of the sign pointing to the destination, rather, they become one with the Father; they merge with the destination. This Awareness indicates as entities become more attuned to their own Higher Self, they discover they and the Father are One, and share in the same being, and become integrated as a Triune Self.

This Awareness wishes entities to begin perceiving Christian religion from a higher frame of reference, as being a carrier of a deeper meaning, a meaning that has been hidden from the masses, but which is priceless when studied for its inner teachings. This Awareness highly recommends that entities study the works of Max Freedom Long, in his study of the Hawaiian language, which contains secrets and concepts in coded languages; the codes of which reveal the inner teachings of Jesus.

ARE TERRORISTS PLANNING TO DISRUPT THE OLYMPIC GAMES?

QUESTION:

Awareness, the South Korean government has announced that they've uncovered a plot that a world wide conspiracy of terrorists, supposedly instigated by North Korea, are going to descend upon the Olympic games this summer, to disrupt them and turn it into a blood bath. The FBI says that's news to them; their intelligence hasn't seen anything at all like this coming down the road. Does Awareness see any problem with the Olympic games in relation to terrorists etc?

COSMIC AWARENESS:

This Awareness indicates that this does appear to be something in the making. There have been training and efforts accompanied by certain forces from the United States working in

North Korea in regard to this allegation. This Awareness indicates that it appears that this is something which has been planned; that there is some exposure of this, and there is considerable chance that it will be brought more to light before this is carried out; that it may begin surfacing and be prevented. That this relates in part to a recent exposure several months back, whereby a woman was brought into a situation wherein she thought she was making a movie, but wherein this entity discovered she was actually brought into a situation where it was part of a training program.

This Awareness indicates that this was released in part to television, for television viewing; that many entities may have witnessed this release. The

entity recognized that it was part of a plot and exposed what she knew; that this as part of the exposure of this plan, and the training that was being carried out for affecting a disruption of these games. This Awareness indicates there is indication that more will become exposed in the period prior to the games. The likelihood of this occurring is greatly diminished because of the announcement of the South Korean government.

WILL NORTH AND SOUTH KOREA EVER REUNIFY?

(FOLLOW-UP QUESTION):

The South Korean students over there are rioting and have been rioting for months, by the thousands, demanding that "Yankees go Home!", that they want to unify with the North once again, that the United States is keeping Korea separated; that they really want to go back and become one country. Does Awareness see this occurring, this unification occurring, and the Americans actually getting out of there?

COSMIC AWARENESS:

This Awareness indicates that much of the conflict there has been brewing over several decades and as being such that it does tie in to activities from North Korea. This Awareness indicates that there have been governments whose activities are seen as corrupt by the general masses in South Korea, and many of these entities would prefer to move back into a relationship with North Korea, believing that this would be more to their benefit. This Awareness indicates that it does appear that this area will again become a more troublesome area in regard to international relations, as it presently is troublesome in regard to its own domestic concerns.

This Awareness indicates that the chance of reunification is seen although at present, it does not appear to be during the near future or does not appear to be certain. There are forces working toward this direction. Nothing is seen as fixed in terms of the future. This Awareness indicates the likelihood of this occurring in this century is not high.

WHAT CAN SENIOR CITIZENS DO TO PROTECT THEIR SAVINGS?

QUESTION:



A question from V.D., San Leandro, California. She writes: "Everything seems to be so out of balance. I am rather concerned about the banking and saving and loan situation. I know that Avaton has mentioned this before; however, what does a senior citizen like myself do, living on a fixed income, to protect the little they have in savings? I would appreciate Awareness's advice or opinion in regard to this subject. The small interest is barely enough to supplement a person's Social Security checks, then too, landlords are constantly raising a person's rent to the point that forces one to move constantly and the situations are devastating,--so many families, including myself are forced to move, some even onto the streets. I'm trying to find another place in the country at the moment, out of the big cities, but where?" Will Awareness answer this lady's question regarding her savings?

COSMIC AWARENESS:

This Awareness indicates that the lady has bought into the big lie. This Awareness indicates that entities have in the past been given, and still are being given, the impression that if they save money and invest their money in the banks and receive an interest, that over a number of years that interest will grow and given them some kind of large return in the future. This Awareness indicates the money system is designed so that entities who invest in the banks almost keep up with inflation, so that their money doesn't lose value as fast as it would if they simply stuffed it in drawers.

This Awareness indicates that the interest that entities gain from their checking and savings account is seldom ever able to keep up with the inflation and increases in expenses so that over the years the entity is actually losing money while the money is in the bank, but the banks of course, are making money on the entity's savings. This Awareness suggests that the only way entities can come out in regard to their savings is through investments that bring in more than the current inflation rate. That in such case the entity must be most cautious as to what investments the entity engages in, whether it be some kind of bonds or stocks, or some kind of investment of money into certificates or into other forms of negotiable paper. This Awareness indicates that *It* cannot advise an entity in such a question as this as to what she personally should do, but it would be good for this entity to consider the possibility of going into partnership with someone who can invest her money into some project or business or other venture, perhaps into a real estate project that would be profitable, in such a manner that the partner puts up some assets



and some knowledge and perhaps some labor or management ability, and she puts up some of her assets in an investment that would bring in a higher rate of return for her.

This Awareness indicates that this could be quite dangerous to the entity if she doesn't know what she is doing or doesn't have a good financial planner or advisor in the operation. However, she could benefit considerably if she had a good advisor that she could trust, and a good partner whereby they could work together. Any action she takes should be represented by a professional who would be held responsible if her money is lost. This Awareness indicates that it is important that entities who are not familiar with investment procedures have good professional advice, yet even that can sometimes be costly, and it is even better if the entity learns enough about investing to be able to at least have a general understanding of what's happening when she hires a professional to help her invest her money.

This Awareness indicates it may be that the entity will prefer to simply take what little she can from her private investment with the bank and make do with what she can. However, it may also be possible that the entity could shop around and invest in some kind of business that is stable and proven over long periods of time, which would offer higher interest rates to her. If the entity is indeed seeking to increase the amount of money she has, and wishes to become involved in some kind of investment, it does appear that joining in a partnership of some type could be a way of assisting in that growth.

This Awareness wishes entities to understand however, that there are many types of partnerships and unless you have a trusted partner, the agreement should be put together, so that the partner cannot cause you to become indebted and take off with the assets of the company. There are many ways whereby partners can foul up a relationship, causing the other partner to become liable while they have taken the money.

This Awareness indicates for example, a partner could mortgage or sell or cause an indebtedness to the property or assets of a company that is formed under a partnership, and either partner in some of these partnerships can be held liable for the debts; that a corporation would be a better arrangement for individuals cannot be held liable for the debts of the corporation. There are still other ways that could be more favorable to protect individuals in their investments; that it would require a long, or several long, dissertations to present all of the options, and there are professionals who can do this in a more concise and complete way.

This Awareness suggests that the entity may wish to contact some of those who produce books and information in this regard, when she becomes more focused on how she would like to better improve her situation. This Awareness indicates that her position

at this time is likened unto one whose assets are at square one on the Monopoly board and there are many moves that could be made, but the entity may not even wish to play Monopoly, therefore, there is not much at this time that can be done other than to perhaps explain the game of Monopoly to see whether or not she wishes to proceed in such game playing.

This Awareness indicates that it is a question of whether or not she is willing to risk her assets that she now has in order to play the game, or would prefer to hold on to the little security that she now has in order to make sure that nothing is lost; that otherwise there is not much that can be done except to express sympathy for her situation which is echoed throughout this society among millions of other individuals who have been caught by the big lie of the money changers. This will grow worse as time progresses, and the big lie is finally recognized as entities become more disenfranchised.

HOW ABOUT UTILITY STOCKS FOR A SAFE INVESTMENT?

(Some Options to Preserve your Savings)

(FOLLOW-UP QUESTION):

There are quite a few financial advisors that are saying that because the economy is so uncertain, the stock market churning up and down, etc., that a pretty sure bet for conservative investors is to put their money into utility stocks, those stocks that are not affiliated with the nuclear industry; that these will be able to pay dividends and interest regardless of how the economy ends up. Does Awareness see that as being valid at this time?

COSMIC AWARENESS:

This Awareness indicates that these are already high, but appears that they will be solid for some time to come; that there are also municipal bonds which can be beneficial for some time to come. However, if and when there is the economic collapse, which does appear to be near, within approximately a year or so, even these areas could result in losses. This Awareness indicates that you can look to relatively good times throughout the rest of this year, but it appears that in 1989 there can become some disturbing economic problems.

This Awareness indicates that the investment in precious metals, at least a percentage of your assets in precious metals can prove to be of benefit during the next year, for inflation is quite likely. This Awareness indicates that the Middle East and oil prices can become quite volatile and lead to extreme inflation rates throughout the coming months so that the value of gold may begin to increase, accompanying the inflation rates and the value of land and real estate may also begin to increase, although these are not seen as being for long periods of time.

This Awareness indicates that there are so many aspects of economy in regard to the entity's question

that it might be her best option to look around or even advertise, or work with some large credible organization, to invest in something quite safe; that when investing with a stable organization or group of investors who have a reputation to preserve, then your investments can be more beneficial and more safe. This Awareness suggests that if you received a little more return on your money than the bank offers, it could be helpful to your need to at least break even on your investment.

This Awareness suggests that the other option is to think in terms of starting some kind of cottage business in which you make at home, or in which you sell something that you can purchase easily and can distribute easily, such as some kind of product easily acquired, with little money that can be sold through the mail, wherein you advertise the product, mail out information, and then supply those who order the product. This can be a way of supplementing your income to help you meet your current and monthly obligations.

This Awareness indicates the options this entity appears to have are to either add more new money to her coffers, or to decrease the expense of her lifestyle, or to use whatever money she has available to make more money through investments, or through improved investments. There are many ways to proceed under each of these four options.

U.S. TREASURY PLANNING ENTIRE NEW LINE OF COINS TO REPLACE OUR PRESENT MONEY

(TIME TO QUIT SQUIRRELING AWAY OUR COINS?)

QUESTION:

A question from A.E., New York City. She sent in a news clipping from the *New York Post* asking, "Dear Vicki. What is this? Is it true? All I heard from C.A.C. up til now was to save some coins because the bills were going to be changed. What to do now? I have some quarters saved, but don't want to be stuck. Any new info on this from your end? Would appreciate hearing from you."

I'll read the article she sent in, it's a brief one. It's titled: "New Coins Could Yield Billions for Treasury."

"Advocates of redesigning the nation's pennies, nickels, dimes and quarters held out the prospect yesterday that excited coin collectors would hand the Treasury a multi-billion dollar, deficit-reducing, windfall profit.

"Sen. Alan Cranston said any profit from a re-designed coin would be welcome.

"I suspect that glimmer of black ink in our deficit-plagued world is, in itself, adequate reason for passage of this bill," he said.

"The bill requires all profits be used to reduce the nations's deficit. Sixty-one senators and 90 House members have co-sponsored legislation authorizing the most sweeping redesign of the nation's coinage since the early years of the century.

"Diane Wolf, a member of the U.S. Commission of Fine Arts who has been campaigning for redesigned coins for more than a year, said the change could result in a \$2.3 billion profit over six years."

That's the end of the article, and this entity evidently is worried that the change,—the quarters, dimes and nickels she's been saving,—won't increase in value 10 times or better when the paper money we now have is recalled and the new money manifests. Does Awareness have any comment about that?

COSMIC AWARENESS:

This Awareness indicates that there are so many economic options open through the efforts of the banking system to gain greater and greater power over the masses, that nothing is fixed in terms of the future in this regard. This Awareness indicates that energies which were in motion several years ago are now being reconsidered. There are many various options open in this regard; that were these actions to include coins of a different kind of substance such as using plastic to make the coins, then indeed there would be a great profit for the government to recall these metal coins, and if this were to be used to pay the national debt, it would simply be put into the banker's coffers for the national debt is essentially owed to these international bankers.

This Awareness indicates that were plastic to take the place of these coins, this would mean that metal was being exchanged for plastic and the coinage available to the American people would become represented by plastic instead of metal. However, unless there were some kind of inflation involved, the price of the metal would not be significant or great enough to truly merit such exchange. That when metal from these coins becomes more precious and valuable, such as the cost of copper, then it would be beneficial for this kind of exchange.

This Awareness indicates that otherwise, if it is in regard to merely redesigning metal coins, the cost of such redesign is not seen as being sufficient to benefit the designers or those marketing or presenting these coins. This Awareness indicates that this bill appears rather to be something which would serve as an excuse to open the door to a reevaluation of coins, which would be designed to take the place of the present coins in circulation, at the same time as the release of the new currency. It appears this is the true purpose behind this action.

This Awareness indicates that it appears that a time of approximately 3 to 5 years is expected for the introduction of the new currencies. This Awareness suggests that in the time period beginning or near the early part of the coming decade, the energies at present suggest a disruption in economics on a global level, to coincide with currency exchange and to coincide with changes in Europe in regard to the boundaries and nations of Europe, and to bring about a gradual movement toward one world currency and one world government.

This Awareness indicates that there is also occurring at this time a counterforce to this action, this in regard to efforts by certain forces and energies within the United States to take the power away from the Federal Reserve banks; that this would throw a monkey wrench into the works of the international bankers and could reverse the efforts of these internationalists to gain control over this country. This Awareness indicates that more on this can be found in what may be termed the conspiratorial class of information; the works of Lindsay Williams and also information that has been compiled by the entity Roberts in the book: *The Most Secret Science*.*

This Awareness indicates that in this regard there are entities who are working toward spreading the awareness that the Federal Reserve, being privately owned, has operated illegally, out of bounds of Constitutional rights, and that all the money of the national debt owed to this Federal Reserve is therefore illegal, and does not need to be paid. This Awareness indicates that apart from this recognition, all debts by these banks to foreign countries would otherwise be owed by the American tax-payer; rather than the banks losing money to these foreign third world countries for their default, the American tax payer would be obliged to pay the debts.

This Awareness indicates that this effort by the patriots seeking to show that the Federal Reserve has been operating outside the law of the Constitution, would wipe out this obligation of the American tax payers, and would restore the monetary responsibility to Congress and take away the power of the Federal Reserve and the private corporation that owns the Federal Reserve. This Awareness indicates that it is important and would be of great benefit for all entities in the C.A.C. organization to understand this information, to study the works of Lindsey Williams and the book *The Most Secret Science*, relating to the Federal Reserve and what the States are doing in regard to regaining power of the monetary system from the Federal Reserve.

This Awareness indicates that these states need the support of individuals, and that individuals need

to understand and to write to their Congress representatives and senators so that the entities representing them will have more courage to promote the dissolving of the Federal Reserve or switching it to allow Congress to control its activities with greater force so that it represents the people rather than the shareholders of the Federal Reserve bank,--the 300 private individuals who have shares in the bank. This Awareness indicates that these shareholders being a few families, and the banks which the families own as being the ones who benefit from the activities of the Federal Reserve, which in turn have more or less robbed the American people over the years, diverting the money system from a government controlled system to one which allowed the Federal Reserve to operate much like a lending company, loaning money to the government and people of the United States, fomenting wars which they would then loan money to the government so that it could fight the wars and thus create debts for the people to repay.

This Awareness indicates the debt owed by the masses essentially is an illegal debt because the Federal Reserve is unconstitutional. This Awareness indicates that as entities understand this and help to spread this information to more and more people who have influence in further spreading the information, or who have influence in directing things, this can prevent these internationalists from ever accomplishing their world totalitarian system, because their efforts are being accomplished through the manipulation of the money system. This Awareness indicates that this is the way by which their efforts can be thwarted or hindered, and whereby instead of them controlling the masses on the earth, the people of the earth can use the system which they have begun to create and the system can be used to serve the people, rather than the other way around.

In reference to the money call-in, this appears to be still in motion. Several members who work in banks and one member with a relative who works in D.C. for the Treasury Dept., claim they have actually seen the new money, secretly stored now in most Federal Reserve banks around the country, awaiting that day when the planned 'national emergency' occurs. (They say it's red in color). Former Congressman

Ron Paul, in his latest newsletter, *The Ron Paul Investment Letter*, says what the planned currency switch is really about is not counterfeiting, as the Treasury is putting out, but that the real reason is surveillance. The first stage of New Money involves weaving into the new bills a polyester thread that would be visible under a bright light and difficult to counterfeit. Paul points out the thread could easily be changed from polyester to metal without the public knowing; and a metal strip can hold all sorts of information. Paul quotes a 'well-connected scientist' who says we will soon get used to feeding our cash through machines that will read information from strips on the money, and "once you've got all the cash-reading equipment out there, the government could inaugurate a federal deficit card system without major modification. It's the first step to a cashless society." The cashless society, says Ron Paul, is the consummate dream of the IRS. ---total knowledge of and control over the finances of every single American. His advice: Buy gold and silver.

In regard to a one-world currency, C.A.C. has previously published copies of various paper currencies now being used in other countries, and without exception they are printed with a mysterious large blank spot, usually a circle or a square, about 2 inches in diameter, obviously designed for some kind of imprint. The one world planners are getting these countries into line, even the latest Japanese bills are now coming out with this mysterious blank spot. But, will one-world banking, one-world government, be such a bad thing in the long run? According to Awareness, the intention of those who are pushing all this at this time, is not to the well-being of entities, for they plan to enslave us all via the money system. However, the scheme could be of great benefit to humanity if those behind it would change their motives, which they will probably do when fully exposed to the public eye. Either that or the entire nest of these vermin will end up in the penitentiary for their many years of criminal activity and the flagrant breaking of our Constitutional laws.

ALUMINUM---THE MAIN CAUSE OF ALZHEIMER'S DISEASE

QUESTION:

A question from S.V., a registered nurse in Beaconsfield, Quebec. "Please ask Awareness regarding Alzheimer's disease being contagious. Wholistic practitioners think that it is in part caused by aluminum toxicity, from cooking pots to the hydroxides used in deodorants."

COSMIC AWARENESS:

This Awareness indicates that indeed, the aluminum cooking pots contribute to this; also that the aluminum in deodorants also contribute to this; that this can be helped through the action of chelation which takes out aluminum and other heavy toxic metals from the system. There also can be benefits from certain enzymes taken; that tryptophane as beneficial; that there can also be benefits from magnesium. This Awareness indicates that there is also benefit from various amino acids, and Vitamin C, Vitamin E, Vitamin A, especially from Carotene, and from improving the circulatory system through the use of antioxydants; that SOD can be quite beneficial, along with its various enzymes.

This Awareness indicates that L-Tryptophane as that which can serve as a kind of relaxant which can be helpful. This Awareness indicates that Gotu-Kola can be beneficial. That in terms of diet, Kiwi, which is high in Vitamin C, can be beneficial; that Kiwi is approximately four times more Vitamin C than oranges; that the Vitamin C in fruits is beneficial. That vegetables, such as that from the cabbage family, including broccoli and brussel sprouts,--these are seen as beneficial; that greens are beneficial.

This Awareness indicates that detrimental foods in terms of diet are fatty fried foods, meats, and foods containing high calcium, especially the calcium that has been cooked such as fried cheese or melted cheeses, and pasteurized milk, and foods in which milk or milk products have been heated excessively; that this tends to create calcium deposits. For this reason, magnesium is helpful and chelation is especially helpful in removing many of these calcium deposits and calcification that becomes part of the cell tissue.

CAN ALZHEIMER'S DISEASE BE REVERSED?

(FOLLOW-UP QUESTION):

These are preventive measures are they not? Once a person actually has the Alzheimer's disease, there's not much that can be done to reverse it, is there? the memory loss and all that?

COSMIC AWARENESS:

This Awareness indicates that much can be done to reverse this; there are certain memory losses, but the body can, in many ways, be rejuvenated in such a manner as to help reverse this tendency; that much of the problem comes from aluminum and calcium poisoning the cells in the body and in the brain, and when these toxins are removed, the cells become more useful and pliable, and though many of the memories will not return, the ability to remember can return to some degree.

This Awareness indicates that the removal of free radicals in the system with the use of SOD, especially that of high quality/quantity, can be quite helpful in reversing the effects of this disease.

IS ALZHEIMER'S DISEASE GENETIC?

(HOW TO CHANGE YOUR GENETIC STRUCTURE)

(FOLLOW-UP QUESTION):

Is Alzheimer's disease genetic in origin for some?

COSMIC AWARENESS:

This Awareness indicates that this appears to be somewhat in the affirmative; that there is a tendency that can be spread through heredity. However, you must understand that genetics does not necessarily remain unchangeable in an entity's lifetime. One can change the genetic structure of oneself through environmental influences. This Awareness indicates that the brain is constantly able to make new impressions and to alter the genes of oneself so that the genetic coding is changed. It is not necessarily

an easy action to accomplish but it can be done and is done in almost everyone's lifetime through the experiences one has. If one catches a very strong disease, this can alter the genetic coding of the individual's genes. It can create a genetic code that is then passed on to the offspring, and the offspring may develop some kind of other environmental shock to the system, or develop some kind of attitude that would reverse or create an immunity to that particular genetic quality that was handed down.

How Chronic Diseases are Handed Down

This Awareness wishes entities to understand that many of the so-called chronic diseases have been handed down from other diseases, from one's ancestor; that often such things as syphilis of one's grandparents can erupt in future generations as cancer, or tendency for cancer in terms of the genetic code of an entity's genes. This Awareness indicates that there is a theory which is relatively accurate, that a few diseases genetically passed from one generation to another will lead to many different types of diseases as they are passed, so that the entity in the third or fourth generation may have a certain disease which is but an offspring of a totally different disease passed down from one's ancestry.

This Awareness indicates also that it is important to understand that diet and environmental influences as well as mental attitudes can alter one's genes, and improve one's chances of avoiding diseases that have been handed down genetically.

IS ALZHEIMER'S DISEASE RELATIVELY NEW OR HAS IT ALWAYS BEEN AROUND?

(FOLLOW-UP QUESTION):

Is there any particular reason why Alzheimer's disease is so prevalent now, when over three million aging Americans have this? Has this always been around or is it just a new awareness now that so many entities are aging and it is getting attention by doctors and researchers?

COSMIC AWARENESS:

This Awareness indicates that this is relatively new and is the result of excessive reliance on aluminum. That is one of the major causes. There are other toxins in the environment that also contribute such as lead from automobiles and also from water pipes and from canned foods, in which lead has been used to seal the cans. This Awareness indicates that this lead contributes to the weakening of the system, so that even smaller amounts of aluminum than would normally be necessary will have the effect.

This Awareness reminds you that aluminum is also found in baking powders and that these aluminum ingredients in baking powders are eaten and enter into the system. There has been much absorbence by the people of this nation during the past 50

years of aluminum into the system. The quickest way to rid aluminum from the system is through chelation, but there are also ways that aluminum can be removed through the use of proper homeopathic techniques and vitamins and minerals; that this is a more complicated method, and time consuming. The simplest and quickest way is through chelation.

This Awareness indicates also the Super Oxide Dismutase (SOD) can be of great benefit in removing these toxic metals. This Awareness wishes entities to understand that the word 'chelation' means to bond; that this substance bonds with the atoms of the metals and toxins and calcifications within the system to take these out of the system; the bonding action as that which breaks these things free and carries them out.
