



What did the megabankers do with your money?

COSMIC AWARENESS:

This Awareness indicates there are certain benefits that would occur were entities to help support efforts to encourage the audit of the Federal Reserve Bank. This Awareness indicates that there are bills in both the House and the Senate in this regard; that in the seventy-some years in which the Federal Reserve Bank has been in operation as a private banking establishment, it has been in charge of public money, the issuance of Federal Reserve Notes, which have become the substitute for lawful money, but as a private organization, the Federal Reserve Bank has never been audited.

This Awareness indicates that there is some growing concern that this bank, privately owned, should be audited, since it is in control of the nation's money, and since it is to this bank that most of the national debt is owed, amounting to trillions of dollars, and that this bank and the Federal Reserve Board has power to make and adjust the economic climate in the United States to its stockholders' benefits; that no other private organization has such a monopoly without any federal auditing taking place.

This Awareness indicates that it is only in recent times, within the last few months that a growing awareness by the public is creating an opportunity whereby the possibility of an audit of the Federal Reserve Bank could even be considered. This Awareness indicates that it would be to the advantage of all Americans to have this audit take place before such is too late. That when the currency exchange takes place, which is scheduled for some time between 1991 and 1995, and most likely around 1992, it will be too late to do anything about the fact that the bankers will have taken over the government of this country through means that will be legally binding.

An Introduction Into Common Law

This Awareness indicates that the United States of America, as a democracy, under the Constitution, has removed the nation from the state of being a Republic, to that of a democracy under a kind of contract or agreement, wherein the Articles of Confederation and the common law of the land at that time essentially left the nation as a Republic. Once the Constitution was drawn up, it formed a charter, a government of the people, by the people and for the people, and wherein entities joining this charter, the United States of America as citizens, they gave up certain freedoms that were basic to common law, and entered in to the agreements that were or would be formed under the Constitution, which in turn guarantee certain freedoms, even though those freedoms in many cases were already guaranteed under common law.

In one respect, many of the freedoms that had been in existence as a Republic were then turned into privileges instead of rights being granted by the law, rather than rights given by God, in accordance with the previous and earlier definitions of common law, so that the new laws that developed under the Constitution and through the states and Federal governments as statutory laws which were supposed to parallel the laws of the Constitution, but which in many cases as statutes were in violation

to Constitutional laws and in other cases were challenged by Constitutionalities, and statutes in turn were overthrown.

Many of these statutes created certain infringement on the guarantees of the Constitution or made it more difficult for entities to have their Constitutional guarantees without first challenging the statutes and then appealing to the Supreme Court which is bound to examine certain cases according to Constitutionality and their interpretation of the Constitution. This Awareness indicates the problem is that many of the cases going to the Supreme Court were not heard, and statutes which were in some variance with Constitutional guarantees were therefore left intact, because the higher courts did not hear the case or did not overturn the cases.

Thus, over 200 years, many of the statutes on the books deprive entities of certain Constitutional guarantees to some degree. In referring back to earlier statements in this message, common law is that law that accompanies the land which is in accordance with the laws of ancient texts, such as Biblical law, the Magna Carta, and other great documents such as Roman Law in which the law of the land was based upon what is conceived of as a kind of divine justice. This Awareness indicates that common law as that which reigned for thousands of years down to the early days of this nation's Republic, prior to the Constitution; that the Constitution, basically was an effort to put into words the higher principles of common law so that these principles might be equally applied, but in the practice of putting this into the Constitution, the action also created a union called the United States of America, and created a contract in which the concept of the free man of the land was given the opportunity to participate in this union and abide by the laws and contract known as the Constitution of the United States, which in its earlier days carried many benefits.

The illusion over these past two centuries of the benefits has come about not because of the Constitution; in fact it is the Constitution which has protected these benefits for so long, but has come about because even in spite of the Constitution there have been efforts by certain private and personal and vested interests to eat away at the guarantees of the Constitution, in certain ways that would allow an individual certain benefits from society in exchange for giving up certain rights guaranteed by society.

Some Examples of Common Law

An example of this, for instance, is the welfare system. As soon as an entity agrees to participate in receiving welfare, the entity also agrees to allowing the government to have certain control over the entity's private life, including the children that came out of a marriage. This Awareness indicates that as soon as a couple agreed to let the government license their marriage, they also agreed to allow the government to have say in the offspring of that marriage. It is for this reason that some entities choose not to marry with a license, but to marry under common law.

This Awareness indicates that in some instances they seek to marry through the church, but in most

3. instances the government has so become involved with religion that it now has licensed ministers or has convinced, through attorneys and other sources, convinced those who would form a church, that the church should be incorporated; in other words, through incorporation should have its creation under charter of the state. This Awareness indicates once a church is chartered under the state, it is under the state's jurisdiction.

Some Churches are Religious Trusts

This Awareness indicates that those lawyers who advise on setting up a church are themselves licensed under the state and are taught under the state to have churches incorporated. This Awareness indicates however, that not all churches are incorporated. Some churches are created as common law trusts, and as such, register as a trust, as a religious trust in the county; without seeking permission from the state, they simply declare themselves a religious trust, a free and sovereign religious trust by filing in the county.

This Awareness indicates that this allows certain of these religious trusts, such as that formed by Mary Baker Eddy, the Christian Science group, to have their own sovereignty apart from the state creation or corporation, separate from the state. This Awareness indicates that there are now entities in certain religious movements and in certain patriot groups who, having researched or having the advantage of information from those who have researched these matters, are now readjusting and are now reexamining the roots and source of the freedoms that are available under common law.

You Are Not Supposed to Know About Common Law

This Awareness indicates that if you look in encyclopedias, you will find very little in regard to common law, but if you look in encyclopedias prior to 1957 you will find a considerable amount of information regarding common law, for common law was the law of the land and held greater power than the statutory laws which are prevalent at this time, and those who understand common law are still able to use common law, for it is the basis of law, including statutory law. This Awareness indicates there are however, many technicalities in regard to this which must be studied carefully.

This Awareness suggests there is a school in Idaho, -Barringer Common Law School,-which has released tapes on the subject. There are others in the patriot movement who have studied, researched and presented and offer information on common law. It is at this stage however, still on uncertain or shaky ground, not because it is lacking in substance, but because political factors can overpower the common law with statutory laws, by totally ignoring common law, and it takes one who is very aware of common law to know what to do when a judge violates the basic tenants of the law of the land by using certain statutory laws that are not Constitutional, or which do not follow the common law.

Patriot Movement Jeopardized for Use of Common Law

It takes a great deal of courage for these entities, in some cases, to follow through on common law to the point of filing suit against a judge or putting a distress lien against the judge's property or against the county for some statutory law imposed on the individual by the courts which the individual feels is not proper. This

Awareness indicates however, there are entities who do have this kind of courage, who have the courage to go against statutory law and to follow common law. In many cases they end up in tragic situations because they did not know enough, or were not aware of the political factors involved, or the realization that even though they had common law on their side, and were legally right, they did not have the power of the political machines of society.

Thus, you hear of these unusual stories in which some individual is cornered in some farmhouse somewhere by sheriff's deputies and shot to death by a hail of bullets, and you ask: "What did he do?" "He was a tax protestor," they say, "A real criminal!" This Awareness indicates often such entities are patriots going back to common law, following the tenants of which this country was based, recognizing that some of the statutes are unconstitutional and while having just enough information to know that they are right in what they are doing, they put themselves in jeopardy by not fully realizing the powers against which they are opposed.

This Awareness suggests therefore, *It* does not encourage entities to take these steps of following common law to the point of defying these political powers, but *It* would encourage entities to learn more in regard to the common law realities, and especially those patriots who are moving in that direction. *It* would encourage them to know more than enough in order to assure that they do not put themselves in jeopardy just because they think they have the common law on their side, for there have been too many in the patriot movement who have been politically crushed by these statutory laws and those who enforce them.

Some Drive Without Licenses and are Not Arrested

This Awareness wishes for example, to point out, especially in the Western states of Idaho, Oregon, Washington; there are entities who have chosen to destroy their driver's licenses, and do drive without a license, based on the understanding that the original licensing process required a license for those who used vehicles for commercial purposes, and that these entities were not driving their cars or vehicles for commercial purposes, whereas the original licensing was a grant from the state to allow the entity to drive a commercial vehicle for business purposes. The individual who was not driving for business purposes had a guaranteed right in the Constitution to move from point A to point B unimpeded and there was nothing in the Constitution that said he or she had to do it on foot or on horse.

This Awareness indicates that in the earlier days of the automobile, entities drove without licenses, but the license was required when a business was formed and a vehicle was used for transporting goods or for other services relating to that business. This license was part of the contract for doing business. This Awareness indicates that there are now entities in certain areas of Washington, Oregon and Idaho, especially these states, who do not drive with driver's licenses and the police know these vehicles, know these people, and allow them to continue to drive without licenses, and they are not arrested.

4 The question is: How can they do this? This Awareness indicates that it is because they have gone to court, used common law and shown that the requirement for a license is based on a contract for those who have agreed to use their vehicles in accordance with commercial purposes, whereas these entities have chosen to avoid any commercial involvement and drive as free men rather than as employees of the state or employees of some company. In order for them to do so, many of these people have given up their citizenship in the state or in the United States, as recipients of the social security or of unemployment or of any other government program that benefits them, and in so doing they have given up any obligation to pay taxes or to be licensed. In so doing, they practice common law rather than statutory law, and in knowing how to do this, and what to do, the courts are at a loss as to how to stop them, and therefore have gone along with it to keep it quiet so that others do not discover what they are doing, or how they are doing it.

This Awareness indicates that this patriot movement is something which is growing very slowly underground, in silence. It is not that this Awareness is advocating this action. It appears that this patriot movement does have certain validity and value in helping to inform the masses. It is likened unto being at one extreme on the scale of those who know what's going on and in opposition to the other extreme of the scale, of those who haven't the slightest idea of what's going on, but are totally dependent on the government to tell them, and to give them some kind of handout.

Implications of the Coming Currency Exchange

This Awareness indicates that those who are on the extreme end of the patriot movement, are well aware of what it is going to mean when the currency exchange occurs, for there was the movement from the Republic in which there were the free people who then moved into the Democracy called the United States of America which was likened unto a charter agreement, a contracted agreement in which the entities gave up their freedom based on the land to become part of the group action known as the United States and therefore, became citizens or participants, which afterwards, many of these people became encumbered to corporations or states or other subsidiaries of the United States of America, by rules of those corporations, companies, states or subsidiaries, and those rules were then extended, augmented, added to, more defined, increased, refined to the point of becoming multitudes of rules, laws, statutes, reflecting not only the laws of the corporation exemplified as the United States through its Constitution, but also including all kinds of laws relating to such things as parking, spitting on the street, excessive noise and so forth.

These laws then, were created that would allow entities to be taxed, allow taxes to be paid for this, that and other programs; the programs then contained their own rules and laws so that if one is receiving some benefit from a government program the entity is under further laws or rules relating to that program, so that

each entity is under a myriad of laws, rules and controls which deprive the entity of certain freedoms while giving certain privileges. This Awareness indicates that even as this has become so complex, there has also been that economic change that has occurred down through the 200 years, in which Congress, having been given the right to mint and coin money and the power thereof, has given over this power to the privately owned Federal Reserve Bank, which quit making United States dollars, and started making Federal Reserve Notes, which are I.O.U. notes, or substitutes for dollars.

In other words, they are likened unto a promisory note: "I owe you a dollar and will pay you a dollar." The only problem is the Federal Reserve Note is never paid off in dollars. It is a note that can be used in lieu of dollars, of United States dollars. It is a Federal Reserve Note which is the substitution or facsimile dollar, and it still carries the name of dollar, but in the Constitution, the dollar, which is to be the currency of the United States is not defined as a Federal Reserve Note, but is defined as a certain amount of coinage.*

*ED's Note: "Payable in lawful money." The Constitution clearly defines 'lawful money' as gold or silver and nothing else.

This Awareness indicates that the Federal Reserve Note is not the Constitutional dollar nor is it the Treasury dollar. It is a bank note that is substituted for the Treasury dollar. The Treasury dollar which was backed by silver has been called in some years ago during the Johnson administration, and is no longer available except as collector's items. The Federal Reserve Note is but an I.O.U., posing or passing as a dollar imposter. This Awareness indicates that up to the time when these notes are called in, they are legally bound or legally issued and backed by Treasury dollars. They are to be paid by dollars. If one were to technically request Treasury notes for them, the Federal Reserve bank would be legally bound to give one United States money in exchange for these notes, but once the currency exchange occurs, the new notes are no longer backed by the United States government, they no longer have the backing of United States currency. They are simply bank notes, having the backing of the Federal Reserve bank. This Awareness indicates that at such time, the legal requirements that entities be given United States currency in exchange for Federal Reserve notes, this legal requirement will come to an end as entities turn over their Federal Reserve notes for these new bank notes. This Awareness indicates that this will create a totally different change in the nature of the system, and it will be then the Federal Reserve Bank that issues money legally and without any controls of the government of the United States. It will in fact be the power that makes the money and the United States Treasury, if it exists at all, will be but a figurehead.

This Awareness indicates that the power will have been transferred from the government of the United States to the banking system represented by those stockholders who own the Federal Reserve Bank, and

those counterparts in Europe working with the banks in Europe will experience much the same thing. It is suggested that this is all most likely to occur at or around the time of 1992, when Europe becomes open in its borders as a kind of United Countries of Europe, when the economic movement in Europe allows for free travel between countries without the need for passports and visas which is scheduled to take place in 1992.

This Awareness indicates that this will be the beginning of a kind of world currency and it is very likely that shortly thereafter, a single currency, (this may be within 25 years), a single currency will be used world-wide, as these currencies of the various nations begin to move toward a common value. This Awareness indicates that as these currencies move toward a more common value, they may be substituted by a world currency so that one can change so many of the American/Singapore/Japanese/German/British/African currencies for this world currency that becomes an international currency.

Once Currency is Withdrawn, People are Easily Controlled

This Awareness indicates that as this single currency becomes acceptable world-wide, it then creates the situation in which trade around the world can be tracked by computer with greater ease. Buying and selling can take place with greater ease, and there can be many benefits. There can also be the complete elimination of currency at such time, whereby computers are able to transfer information in place of currency being transferred between buyer and seller at the terminals in which transactions occur. It can open the door for greater commercial benefits, but it also carries the potential for misuse, whereby individuals can be controlled through the economic system as their freedoms can be more easily curtailed when there is no currency available in society, except through electronic transfer systems.

This Awareness suggests therefore, that entities be aware of the dangers as well as being aware of the potential benefits of these changes which may occur. This Awareness suggests that anyone who loves freedom needs to be aware of the special relationships that exist in regard to contracts and agreements which entities form not only with each other, but with their governments, by being involved as a citizen, by being involved in the changes that occur through statutory laws that are enacted, through the changes that develop when currency which is based on an agreed upon contract, is exchanged for a different kind of currency. When entities accept such, they are accepting the new agreement and all the implications that go with it.

They are, in effect, accepting the rules of those who offer them the new currency, and when entities apply for

welfare or apply for food stamps or apply for something else, they are accepting the rules that go with such application and receipt of benefits. Thus, entities give up something to gain something, and it is important that entities know what they are losing in exchange for what they are gaining, when they think they are really clever for ripping off the government or for getting something for nothing; by avoiding the job the entity gets food stamps or welfare or some other benefit, but the entity has given up something.

Always Find Out What is Going On!

This Awareness indicates there are those who pretend to be mentally insane in order to get social security benefits, but they are giving up something to do so. They are giving up their own freedoms as a sane being. They are being classified as insane in order to receive some benefits that allows them not to work for those benefits. This Awareness indicates that if that is what you want, and you can get by with it, and you are willing to sell part of yourself and your freedom, then do so, but be aware of the loss involved and all of the implications and ramifications of what it is doing to you in the long run. Do not go into these things blindly. Do not sell your soul without knowing to whom you sell, and for what price, and for how long, and for what purpose, and the outcome of the transaction, the nature of the transaction.

This Awareness indicates that too often entities act without knowing what they are doing simply because someone 'over there' told them to do it. The loudspeaker said to get in that line and go follow that direction. Someone will tell you what to sign. So they do it. This Awareness suggests you become aware of what you are doing before you sign away, before you join, before you give away your freedoms, your rights, your privileges. What you gain: Is it worth what you give? This Awareness does not wish to discourage you or frighten you. It simply wishes to alert you into becoming more attentive, into finding out what is going on before you leap, before you are led into an action, before you are directed toward an operation, before you are ordered to the dressing room, before you are put in to the showers. Find out what is going on before you are led to the gas chamber, before you are led to slaughter, before you are brought into slavery. Find out what is going on before you take out food stamps, welfare, before you take a job, before you enter into a contract, before you enter into marriage, before you take an action that might lead you into court, before you take an action that might put you into jail, before you take an action that might cause someone harm. Look before you leap.

If the path is unclear, if you cannot see to where you will leap, and if you must leap, then look and see as much as is possible. No one can expect to know everything or to have an absolute clear view, but if you do not at least try to see where you are moving, if you simply move because someone said to go there and do that; someone said for you to take your money from the bank and put it into their business and you

would prosper, or to give it to them and they would manage it for you;—just because someone says to do something doesn't mean you should do it. Think about it, look at it, check it out! You are responsible for your decisions.

Just because someone says "this is the way to heaven!" doesn't necessarily lead you there. They might be leading you to hell. Even Satan might be tricking you into thinking you are going to heaven when in fact you are going to hell. This Awareness indicates that *It* is speaking in metaphorical terms; that heaven and hell exist symbolically in everything, in every choice; you are moving toward benefits or you are moving toward difficulties and detriment. Just because someone says it's benefitting to you does not necessarily mean it will be so. This Awareness suggests you learn to discern for yourself, make up your mind on what you find, what you can discover, not just because someone tells you this is how it is.

Why should you trust this person whom you do not know as well as you trust yourself when you yourself has the most to lose? Many entities cannot trust themselves because they do not think they have the knowledge they need to make the right decision on something, but why do you think you can trust this other person to have any more knowledge than you have? Find out if the other person really knows what they're talking about! Question them. Question them in depth. Question others who know them, and then check out all the areas you can to find out whether or not the path they advise is really open and really leads to where they say it goes.


This Awareness indicates that most people follow the advice of others even against their own intuition which tells them 'no'. Most people follow the advice of others simply because they do not wish to take the time to put forth the effort to find out the truth for themselves, and therefore, they rely on someone else to lead them to their glory, and most entities suffer from their mistakes of relying too much on the words of others.

This Awareness indicates that in regard to the currency exchange and things that may occur in the future, *It* does not wish you to become overly concerned at this time for there are forces in movement that control the destiny of this planet, so that freedom and evolvement for the masses will come in its proper time. It is not required that entities must attempt to change the course of history. It is requested that entities become alert to the changes and potential changes that may occur, and to use that alertness to discern the direction of these changes and what the implications are.

It is a process that may take considerable time before entities become fully aware of what is going on, in regard to these monetary changes during the coming years, in this early part of this next decade.

Each paper note contains a large blank circle or space where an imprint can be placed. The new U.S. paper money soon to be presented, also will have a large blank space available for future imprints. Legislation that would audit the Federal Reserve for the first time in history, and make it accountable for what it has been doing with your money all these years, is now wending its way, very slowly, through the Washington process. As of this date, it has 31 sponsor in the House, but only 3 in the Senate. If you would like to help promote the growing national grass-roots effort to pressure Congress into passing legislation that would require a General Accounting Office audit of the monetary policies of the Fed and related agencies, here's what you can do:

First of all, write and /or call--preferably both--your congressman and both your senators. (If you do not know who these are, simply telephone your local library or send a SSAE to Vikki T. and she will tell you who they are). Urge your congressman to become a co-sponsor of H.R. 844, the House bill by Rep. Phil Crane (R-Ill.). And tell your senators to cosponsor S.734, the Senate companion bill by Sen. Harry Reid (D-Nev.).

You can write your senators C/O The U.S. Senate, Washington D.C. 20010.





AFTER ALL THE BLOODSHED IN CHINA --WHAT CAN WE EXPECT IN THE FUTURE?

QUESTION:

This bloody crackdown in China by the army, which was commanded by this ancient ruler; does Awareness see all of this lessening as soon as this entity either passes over or steps down from power, or are there others behind him that will maintain this iron fist type attitude?

COSMIC AWARENESS:

This Awareness indicates that there are several entities working with this individual who act in the sense of a team, holding these views which are much like that of a parent dealing with an unruly child, wherein they see themselves as authorities, not wanting the influence of this unruly child to affect others in the family. This Awareness indicates that often a tyrannical parent will punish excessively a child in order to prevent the influence from affecting the other children, and to intimidate the child and the others by the punishment.

This Awareness indicates that in the case of these entities, it is far extreme because they are dealing with the deaths of so many in a manner of setting examples to intimidate the masses. This Awareness indicates however, that many of those who were slaughtered were the children of high ranking communist officials, were the children of wealthy Chinese business people. Many of those who were slaughtered were highly educated and came from very influential families and these entities do not feel intimidated or accepting of the party line in regard to the slaughter, that it did not take place, and that their children were thugs, and these individuals are simply biding their time and the time will come when they begin to merge together.

These are the more influential individuals, not simply idealistic students, and these entities will, in time, bring about a change in the higher echelons. This Awareness indicates that there is already seen a kind of seething undercurrent quietly building behind the scenes. QUESTION:

I ran across an interesting item in one of Ophiel's old books, and I'd like to read just a little of this and ask Awareness if this is valid and if *It* could expand on this. It says:

"The occult law we will study here is called the Occult Law of the Treasure Chest. We will now consider another tool which can be used by you and your creative visualization work. This Treasure Chart tool is a rather well-known device, being an application of some very old magical principles. I have reason to believe that the pictures and decorations on Egyptian tombs were early Treasure Charts. As soon as a royal child was born in Egypt a tomb was immediately started for him.

"On the walls of the tomb were painted pictures of his life, up to his death, and this while he was still an infant. These pictures show the child as having all the good things in life, right up to his death and even beyond that. The pictures show him winning all the wars and capturing large numbers of prisoners; in other words, setting up a fine life for him, in advance. These pictures were painted on the walls of the tomb and made alive and powerful by the magic of the priests. In all cases, unless the priests withdrew their magic protection, these pictures preserved him throughout his whole life and he lived this protected path this whole physical life.

"Still earlier in the history of man, pictures of game were drawn on the inside walls of caves. These pictures showed a hunter killing food game successfully and bringing it back for food. It can be said that Treasure Charts or maps are oldest of man's magical devices to help him through life."

Is that information valid?

COSMIC AWARENESS:

This Awareness indicates that this is absolutely valid, in the sense that if one is to succeed in anything, one has to first *imagine* succeeding. This Awareness does not advocate that entities should present picture maps to their children, especially such as these picture maps, but this Awareness suggests that *It* does indicate or demonstrate the power of imagery; that if you are to accomplish anything you must first visualize yourself accomplishing it, and if you can draw that picture that you visualize, it strengthens the vision. Once it is put on paper or in a drawing, the power of that vision becomes magnified and enhanced greatly.

This Awareness indicates that it also is available for repeated magnification and visualizing because all you have to do is keep looking at the picture. This Awareness suggests that especially valuable is to have that

picture available in your bedroom so that you see it when you awaken and just before going to sleep. This Awareness indicates that it is important however, that you be careful not to draw pictures of something, thinking you want it, only to discover that it is not what you really wanted, or that you left something out that is part of the treasure map you wish to achieve or acquire.

This Awareness indicates that many times entities project a goal, and see that as bringing them happiness, only to discover that it brings them misery. This Awareness suggests for example, if there is a person you feel you must live with, you must have this person, yet you know that this person does not like you, cannot stand you, and you draw a treasure map showing yourself with this person; you had better add to the treasure map that this person loves you and enjoys you, enjoys being with you.

This Awareness indicates treasure maps can be quite difficult because the person whom you wish to influence may never like you in spite of all your efforts and treasure maps. When you begin to interfere with the will of another, you are not relating, you are coercing. This Awareness suggests that you may use treasure maps in a manner that allows you to present a concept, an idea and a wish to achieve something, but when you begin using it as a trickery to coerce someone to do something they don't want to do, it generally will backfire on you because you are not respecting that person's wishes. You are not being fair to the other entity and you are more or less attempting to cast a spell on the other entity, and this kind of coercion through the use of magic is creating a negative karma for you in the relationship which will end up causing you greater problems.

This Awareness indicates that so long as there is no conflict whereby you see a person you wish to be with, you create a treasure map showing yourself with the person; that person has no adverse feelings toward you at the time, and if you then can simply allow events to take their course, having created your treasure map; you then no longer worry about the outcome, you just forget the treasure map and go on with your relationship and life experiences; then the treasure map can be helpful in bringing about a harmonious relationship with this person. This Awareness indicates in this case you are not violating the person's will, you are not attempting to coerce the person to move against his or her will. You are simply willing that the person would like you, and share with you according to your treasure map.

This Awareness indicates that when it comes to using psychic powers to manipulate another person against their will, this can lead to tremendous problems, but when it comes to using psychic powers to visualize a goal in which everyone involved is happy, is content, is satisfied, is pleased, then, if those are the conditions you want, you want the goal to occur only if everyone is satisfied and the satisfaction of everyone involved is as important as the goal itself, then you have a clear

and untainted treasure map in which no karma would be accumulated, and few problems, if any, would occur.

This Awareness indicates that when it comes to pursuing a goal that does not adversely effect anyone else, you need not worry about these things; you simply create your treasure map accordingly, according to your wishes. The treasure map being that which presents the images and if it requires various steps along the way, for example, you may wish to become a doctor, and if so, you may wish to show yourself entering college, show yourself graduating from college, entering medical school, and then being given your doctorate's degree, then being given your license to practice; you may wish to have drawings or symbols on your treasure map showing each of these steps along the way.

This Awareness indicates that it would be more powerful than if you simply showed yourself receiving the doctorate degree or business license to practice.

QUESTION:

R.A., Bremerton, Washington, asks: "With the recent death of the Ayatollah Khomeini, what is the prospect for a more moderate government in Iran, and will the Moslem fervor against the West be toned down?"

COSMIC AWARENESS:

This Awareness indicates this as that which will occur, but on a gradual basis. There are many factions in Iran, individuals who recognize the need to have closer ties with the West, to have closer ties with the outside world; this as more of an economic need, but they also recognize the power and influence which the Ayatollah has had on the Iranian people and do not want to appear to be allowing this movement toward outside involvement to be seen as a weakening of the Ayatollah's position, therefore, they will allow time to pass, so that the influence of the Ayatollah will diminish gradually, and then slowly and carefully they will make overtures to Western countries to open negotiations and trade.

This Awareness indicates it is not something that will occur quickly. It may take several years, and it may not move as far as many entities would hope, but this Awareness suggests it will modify considerably in comparison to that which has been during the reign of the Ayatollah.

WHY DOES THE KORAN NEVER MENTION LOVE?

(MUSLIMS NEED WOMEN'S LIB)



QUESTION:

A question from N.M. of Calgary, Alberta. "In view of the Salman Rushdie case, re: the author of the controversial book, *The Satanic Verses*, would it be possible for Awareness to comment on why the Koran never mentions about love, and why there are so many references to hell and eternal damnation in it? Could it be that the Koran has been tampered with?"

COSMIC AWARENESS:

This Awareness indicates that the Moslem religion springing out of the offspring of Abraham as that which carries an extreme masculine overtone, in which women are totally subjugated as servants to men, along with the qualities associated with femininity such as mercy, love; and men are conditioned fanatically to accept the Koran and its violence as a way of life, and women are conditioned to accept their subordinate position. They are subjugated in so many ways that they are in fact, in many cases, without the same respect accorded to camels, or horses. They are but properties in many cases.

This Awareness indicates that it is this lopsided quality of the Moslem religion that has created the fanaticism. It has frustrated both men and women, created a psychological imbalance in each of the sexes. The philosophy or religion is such as to promise life and heaven after death for those who slay their enemies, the enemies of the Koran. This Awareness indicates essentially it is a religion that is out of date, that should have been modified hundreds of years ago, before it grew so large.

This Awareness indicates that fortunately, there are many professed Moslems who do not take such extremist view and do not hold such radical positions, much as there are Christians who do not act with such extreme as do others. This Awareness indicates however, that regardless of what a religion is, there will always be those who use it to satisfy some inner need for themselves, either ambition or bloodlust, or hostility or power needs or greed, for these entities are often religious devotees who select and choose certain passages to please themselves and their own aberrations.

SOME CONTRADICTIONS IN A BOOK ABOUT THE LIFE OF JESUS?

(DO WE WANT TRUTH OR MYTH PERPETUATION?)

QUESTION:

A question from E.O.L. in Canada. He found in Max Freedom Long's book, *What Jesus Taught in Secret*, what he thought were some contradictions. He says, on page 90, Mr. Long says the gospels of Thomas is said to be written by Jesus's twin brother, who then gave it to Mattheus. Is this correct? Is this gospel valid? I have read that Jesus had two brothers, but not a twin, he adds.

COSMIC AWARENESS:

This Awareness indicates here again is a question based on a presumption in terms of a premise, which in itself is assumed. This Awareness indicates that the story of the historical Jesus is not altogether accurate; that there is a composite of many other stories and legends based on other information from different sources that have gone in to these gospels. Even the name Jesus was composed at a later time, and added to the story afterwards. Originally, the story of Jesus was to have been called Zeus, but because it was a Greek god, many of the Romans objected, saying: "We want no part of Greek gods in Rome! We want a different name!" In this they then began to look for a different name, and came to the name Jesus which meant 'Neither he nor she,'--it was a word implying no polarity, neither positive or negative, a word that was used as a common name, an Aramaic name derivative, and it was decided that this name would be used as the name of the Roman god for the religions.

This Awareness indicates you must understand that there were many factions, many religions in Rome at the time of the Nicene council; that Constantine set forth to bring these religions together, so that one catholic, which means universal, religion for Rome could be developed to stop the warring between the religions which were about to plunge Rome into civil war, because of so many fightings between the various groups. It is much as might be seen in Lebanon today. This Awareness indicates that by forcing these entities of these various religions, the priests of these religions, to go into a large building, to convene, and to come up with a common religion which they could all accept, allowed Rome to develop a unified religion from these fragmented religious groups and the many stories, the many aspects of the gospels were compiled, based on these basic premises of the many combinations of these religions.

This Awareness indicates that other books of the time were often destroyed so that little record of the many different factions and religions would remain so that few records of the *sources* of these early religions and the origins of the stories would remain; however, you can find earlier versions of many of the stories of

Jesus in previous works, especially from other countries prior to the story of Jesus, through their sacred writings. Many of these were lifted almost intact from these earlier writings and put into the gospels. This Awareness indicates that when you speak of whether Jesus had a twin brother, or whether this or that was true, the question has to be considered in light of the myth or in light of the historical realities.

In terms of the myth, there are even versions of the myth that vary, so that one must consider whether facts of the myth that were omitted here or there should be included as part of the myth-information,* or whether it should be excluded because it is uncommonly acceptable, or you must consider whether this question should even be considered since it is myth, and relates to a mythical story. This Awareness indicates there were entities who existed, and some of these entities did things, and some of their exploits and stories were recorded, and some of these entities received followers, and some of these followers insisted that their leader, their teacher, was the messiah, and some of these came in conflict with others who saw their messiah and teacher as being supreme, and these many factions of small religious groups were scattered throughout the Mediterranean, and many of them had factions in Rome, and Rome did not know how to deal with an unofficial multiheaded religious group of religious fanatics, so under Constantine they attempted to bring together all of the groups to form one catholic or universal religion, and since that time, with all of the composite stories that this group agreed upon as part of the scenario of that officialized religion; since that time, entities have continued to ask questions in regard to historical events, as though the composite was an historical reality. *Ed's Note: Heh heh heh!

Why Were the Dead Sea Scrolls Never Released?

This Awareness asks you, why do you think the Dead Sea Scrolls have never been released to the public? This Awareness indicates it is because these scrolls would destroy the fabric of the myth in terms of its historical reality; that much of what is attributed to the gospels came from earlier material, available through these scrolls, relating to other than Jesus, relating to other people; that there are considerable amounts of information in these scrolls that the churches simply do not want released because it would not perpetuate the myth which they have built their fortunes on, and the myth has its purpose and value, just as the myth of Santa Claus, giving people comfort and cheer and bringing out the best in them, has purpose and value, but if entities want truth, they must look at the myth for what it is

and seek realities of the highest and best that lie beyond the myth, for there are greater values there and greater inspiration in knowing that each of you is part of the Christ Light, and can be One with the Father, and that the myth can serve to teach each individual that unity with the Divine so that the individual can become greater than just a devotee to a myth, can take the myth and apply it in such a way as to help others to have deeper understanding of the meaning behind the myth.

This Awareness indicates there have been many Christs, many beings who channeled the Christ Light, and each of these is but an example for each of you; that every entity has the capacity to be One with the Heavenly Father/Mother/Creator. This Awareness indicates that *It* could answer the question asked in regard to Jesus's twin brother as: "Yes. He had a brother who was a twin," but it would only be a statement perpetuating some trivia in regard to the myth. It is likened unto asking whether Luke Skywalker had a cousin, and if so, what happened to the cousin? Should this Awareness answer these kind of questions, and if so, how should they be answered? Within the framework of the myth or in a manner that exposes the myth, and addresses the full picture?

Do the questioners want to know the full picture, or do they only want to perpetuate the myth and keep other things out?

ARE SETH'S SIMULTANEOUS TIME THEORYS A PRODUCT OF THE DARK FORCE?

(MORE ON THE LAW OF KARMA)

QUESTION:

A question from D.C. in Ohio. (Awareness has covered the simultaneous universe question, but there's a question in here on something else, so I'll read this.) He says: "Awareness has recommended the books channeled by Jane Roberts with an entity calling itself Seth speaking through her. This Seth states that time is simultaneous and the past, present and future goes on simultaneously, including all these so-called future lives.

Seth stated that the past is not dead, that it is going on *this instant, and so is the future. If the future lives already exist now, then how can the Law of Karma operate? I always believed the Law of Karma determined the place, time and condition one is born into. If these future lives are going on now, then karma doesn't mean anything in selecting these future lives. There is an entity calling itself Hilarion channeled through Maurice B Cook in Toronto, Canada, that states this simultaneous time theory is a product of the Dark Forces and stated it does not allow for the Law of Karma in determining future lives. Can Awareness say anything in order to clear up this matter of Seth's simultaneous time theory as being a product of the Dark Forces, as stated by the Hilarion entity I mentioned?"*

COSMIC AWARENESS:

This Awareness indicates the ever-present moment contains future and past in a way that is difficult to understand when thinking in terms of tangibles, or matter. The ever-present moment exists in consciousness. Consider if you can, an entity dreaming. That entity dreaming is capable of any creation at any moment *within consciousness, and any creation in any moment can be perceived as a total reality in that dream, thus, a future dream could theoretically come into that entity's consciousness, instantaneously, at present, were the entity to choose or select that total reality of future dream, and the dreamer would perceive this as happening now, instantaneously, even though it were taken from a future dream, the entity also could perceive a dream that had occurred previously as still being there for him or her to select and run through again as a total reality.*

The actual truth is there is no time in relation to the selection of these dreams; they are not in linear layout. They are there in the dreamer's consciousness, to be selected, dreamed, portrayed, or discarded at any time the dreamer chooses. One cannot say that because the entity has dreamed of tying his shoes and finding a frog inside that the dream is now passed and gone, and no longer exists, because the entity can bring up the past dream in which he was tying his shoes and suddenly felt the frog inside. The dream can be replayed just as any cassette movie can be replayed time and time again. Is the movie gone when it is finished, or is it still on the recording in present time?

This Awareness indicates that as long as entities perceive reality as being measured by matter, placed on a linear line called time, they will never understand these things. They will never comprehend reality or that which is the supernatural, but when entities begin to realize that all is consciousness, as is the dream collectively experienced by all entities in each dimension, as reality, for that dimension; when entities begin to realize that they are more or less part of a collective dream moving here and there collectively in that dream, and that time itself is an artificial creation in the dream measured by relationships and movements of things, one to another, and duration of things, one to another, and that time is no more real in actuality than is the matter on which they stand, and that if the dreamer were to awaken, all this would simply disappear, and they would cease to be; if entities can understand this, then perhaps they can understand how supernatural beings can enter and leave a dream, much the way in your own dream someone can speak to you, cause you to half awaken and half become aware of them before you go back into your dream.

This Awareness indicates that karma is but cause and effect, and the karmic seeds for a cause to come are implanted in consciousness as part of the effect of previous deeds and actions. If you watch a movie, or participate in an action, then go to sleep that night,

you may dream of events that reflect those previous actions or participations, and the dream then is the karmic reaction to the previous day's events. It is the reaction from the previous cause. This Awareness indicates that it is not that your actions simply pull a trigger to create a trap that sits and waits for you to step in it, rather, it is that your action creates a memory in your consciousness that says: 'this polarized event is not yet balanced, and must eventually be balanced'--and so when time is right, when events are right, when energies are right, a balancing action comes about, and the energy is released, and that is the karmic result of the cause that brought it about.

These things exist in consciousness as states of mind, not in matter or time-lines carrying matter from place to place, from moment to moment. The moment is now, and all things exist now, but only in consciousness. The past does not exist, the future does not exist, the present does not exist in material form, but exists only in the collective mind, the collective consciousness of entities and it can be highly vivid, as in your normal wakened state, or it can be very Neptunian and fluid as in your normal dream state, but it must be understood that your wakened state is but a vivid collective dream, much like living in, and as part of a hologram, projected by Higher Beings.

QUESTION: A question from E.N. in Brooklyn in regard to the drug problem. He writes: "The drug problem has become so widespread in America if not on the entire planet. Is there a special meditation that Awareness recommends we as Light Workers use to help correct this drug epidemic?"

COSMIC AWARENESS:

This Awareness could make up a meditation for you to use, if that would be sufficient. This Awareness suggests that you could perhaps more easily wrap those entities, symbolically wrap those entities in White Light so that they are visualized with strands of Light being wrapped around them, so that the drugs which they hold cannot be passed to others and so that the only thing that can occur is that they continue to hold the drugs, if that is their choice, or to flush the drugs down a toilet.

This Awareness suggests you wrap these entities with White Light with nothing present other than the drugs and a toilet; that in so doing, creating this image, you can send this picture and image to these entities in a generic sense; you need not even know their names. Just visualize some generic drug addict holding drugs and paraphernalia, standing by a toilet in which the entire scene is wrapped in White Light and the entity can either use the drugs, use them up or can flush them down the toilet, but has no way of exiting from the Light and giving them to any other.



"BUT BURNING THE FLAG GOES TOO FAR!"

This Awareness indicates that this can be meditated on as you visualize strands of Light being wrapped around and around and around this entity, and the scene, for several minutes at a time. This Awareness indicates that it is much more powerful to express visions, images, than to meditate on something of this nature because meditation is an action of being receptive, whereas visualization is an action that is assertive in nature. How can one be receptive to a drug scene or problem and effect a change? This Awareness indicates it is better that entities assert themselves in a visualization and express the wrapping of Light around this entity; that they may also participate in this wrapping through the movement of their hands around the image which they hold before them.
