





## HOW THE MANIPULATORS ARE FORESTALLING AN ECONOMIC COLLAPSE TODAY UNTIL A LATER TIME WHEN THEY CAN IMPLEMENT THEIR PROGRAM OF SLAVERY ...( An Economic Forecast by Cosmic Awareness )

(General C.A.C. Reading, August 12, 1989)

### QUESTION:

Awareness, we're here for a general CAC reading, with questions sent in from the membership. Does Awareness have an opening message?

### COSMIC AWARENESS:

#### Repercussions from the Savings & Loan Bailout

This Awareness wishes to comment on some new developments in regard to the economics of this country: the United States. This Awareness indicates that during the 1980s, under the direction of Ronald Reagan's administration, and into the present time, the national debt of this country has doubled. This Awareness indicates that at this time, the danger of collapse of the economy as that which is being forestalled by efforts such as the government financing of the Savings and Loans banks; that this financing of this program as that which on the average will cost each household approximately one thousand dollars or more, depending on how much the price is increased.

This Awareness indicates that if you will recall, during the Kennedy administration, when there was the beginnings of a slight downturn in the economy, John Kennedy instead of raising taxes to finance programs that were needed, lowered the taxes with the presumption that it would stimulate spending, which it did, and this allowed for the government to gain because of the additional spending that was triggered by the lowering of taxes. This Awareness indicates that in comparing the bail-out of the Savings and Loans institutions with a tax

thousand dollars from every household, so that the spending in the public area is curtailed, the dropping of interest rates on borrowed money through the Federal Reserve and subsequently through the other banks is foreseen as a way of stimulating the economy, thus, break, you will see that this is essentially, just the opposite, wherein rather than infusing the public with extra spending money to get the economy going, the thousand dollar per household or per tax payer, on the average, being taken from the public to pay for the savings and loans banks as that which is likely to have the opposite effect on the general economy, causing a depletion and a shortage in expenditures so that a downturn results.

This Awareness indicates there is not much else that could be done, for were these Savings and Loans companies not to be bailed out and were they to be allowed to collapse, you would have already experienced the beginning of a deep recession and downturn in the economy; this bail-out of the Savings and Loans is simply an effort to forestall the collapse. This Awareness indicates that in order to minimize the effects of taking a on the one hand, the economy is being curtailed by what is equivalent to a major tax hike of great proportion, and on the other hand it is being stimulated by a diminishing of interest rates, so that money can be borrowed with greater ease and with less expense.

This Awareness indicates that this will stimulate more of the debt while also affording the public to pay off the bank debts of the Federal loans associations and will result in a semi-balancing act in regard to the economy, so that while on the one hand the rug is being pulled out from under the money system, there is, on the other hand, an attempt to shore up or prop up the money system with the lower interest rates. This Awareness indicates that the economy is not being healed, it is being artificially kept alive while certain elements are being withdrawn from it. It is much like a patient who is having a vital organ removed while being put on a machine that takes the place of the vital organ. The problem is this does not pay off any debts. It simply creates more debts. The public debts, through borrowing money, though the borrowing is at lower interest rates, while the public is expected to pay off the Savings and Loans, is somewhat ironic in the sense that the Savings and Loans are essentially part of the banking family that has to be

bailed out because it cannot meet its obligation, and the public is asked to do so, but the public is also offered some slight reprieve of the heavy burden by being allowed an interest rate cut, so that the public can borrow easier from the other family of banking institutions, thus, getting in debt on the one hand, to pay off the debt of the banking system; the individuals, the public, picking up the tab for the banking system by borrowing from the banking system at a slightly lower interest rate.

This Awareness indicates it is a clever action to assist in keeping the banking system balanced a little longer than would otherwise occur, so that the nation can forestall the collapse of the economy to a time when it is more suitable for the banking system and the plans of those who manipulate the economy. This Awareness indicates that the likelihood of a reasonably harmonious economy throughout the remainder of this year is seen, and there is some continuance into the next year of 1990, after which time, things may become more disturbing in terms of downturns in the economy. This Awareness suggests also however, that as the stock market reaches new heights, there is seen the dangers of a sudden drop which could trigger the downturn in many other areas, particularly if it is sharp enough and sudden enough to create an emotional reaction among the investors.

This Awareness indicates essentially, you are approaching a time of economic uncertainty in which the past decade of semi-stability in the economy will be regarded as likened unto a party thrown on credit and that the bill collectors for the party are now knocking at the door, and that it will soon be time to pay the piper; that this appears to be only months away and that within the next year, the downturn will become obvious which will lead to the long predicted currency exchange, this being seen presently as occurring in approximately 1992; that this is not absolute and can be altered.

This Awareness indicates that more can be presented on this, as the energies unfold.

#### HOW WILL THE BANKERS PROFIT FROM THE S & L BAILOUT?

(Follow-Up Question):

This bail-out of the Savings and Loans, how will this profit the huge banking systems like Rothschild and Rockefeller? Is it that they'll be able to buy up these Savings and Loans at a dirt-cheap price later on, and make all kinds of money; is that how they're planning it?

#### COSMIC AWARENESS:

This Awareness indicates that many of these have already changed hands. There are also investors getting involved and through the stocks or investment programs taking certain percentages of these, and there are also the actions whereby many of these are selling certain of their holdings to those banks that are more solid. That once these are being properly paid, these flaky securities will become more solid securities. This Awareness indicates that it is not simply however that the big banks

3. are profiting from the Savings and Loans, it is also to be considered that the Savings and Loans companies in failing, would cause a loss of confidence in the banking establishment, and this is very dangerous to the big banks, therefore, it is to their interests that the Savings and Loans be propped up for a period of time.

### THE MASTER PLAN FOR THE ECONOMIC COLLAPSE & THE COMING MARKET CRASH


...LIVING IN THE EYE OF THE STORM

#### QUESTION:

Larry Abraham, who puts out a newsletter for investors, sent one out the other day called *Wipeout*, and he says the next financial firestorm will scuttle the ranks of those who managed to survive 'Black Monday.' A devastating red tide of disasters will sweep away all but a tiny grateful few and it will catapult the already huge fortunes of the power brokers who planned it all, and when you know their signals, you can hitch a ride all the way up, he says. Also, he says there will not be one crisis in the next 12 to 36 months, he believes there will be a lot more than that.

I quote: "We've been living in the eye of a hurricane. The relative calm we've had since the planned crash of '87 is just a misleading lull. The full lashing fury of this storm is still to come. When it happens, some will lose everything and a few will strike it rich. That means big money is about to be made, since crisis driven profits are the greatest profits, but there's something even more incredible than the huge scope of this series of disaster," he says. "The shocking truth is this wipeout is being planned. What's about to hit us is not just a market correction, not just a symptom of a rapidly devaluing dollar, and not just a reaction to chaotic world events. America is being set up to take a steady, but sharp fall, so a handful of the not so idle rich can triple or quadruple their fortunes, in a series of cleverly designed maneuvers. We call the schemers behind all this the "insiders", and they've been playing this dangerous but very profitable game with world finances for generations. They've got it down to a science, a very lucrative science."

Does Awareness agree with him, that this whole thing is being planned?

## COSMIC AWARENESS:

This Awareness indicates that this is absolutely correct. This Awareness has indicated this repeatedly over the past decade, that the economy is never accidental; that these things are planned and mathematically precise. This Awareness indicates that it is possible to plan the manipulation of currency as easily as it is possible to project and direct the electronic currents through certain lines and transistors, resistors and circuit boards. It is the same formula used in electronics that is applied to the economics and with that same formula being reapplied to economics, entities can project and manipulate to an exact science where the monies will go, where the currency will flow, how to stop it, how to start it, how to make it jump, how to make it fall, how to make it rise.

### WILL A MILD RECESSION PUT 14 MILLION ENTITIES ON THE STREET?

(THE PLAN BEHIND THE DISPOSSESSED)

#### QUESTION:

There was an article in the paper the other day that said that if there should be a recession, it may put millions on the street. I'll read it. Its caption is: "Millions perch on an economic 'knife edge'. Up to 14 million American families are 'living on the knife edge of homelessness' and may be forced onto the streets by a mild recession, according to a Rutgers University study released yesterday.

"They are one pay check, one domestic argument from the streets," the study said. The report by the American Affordable Housing Institute, a research center at the university in Brunswick, N.J., said the homeless rely too little on prevention, are badly underfinanced and uncoordinated and are conducted by officials often unaware of the available resources.

In a mild recession, homelessness in America is likely to double and triple almost overnight. Estimates on the current number of homeless people range between 655,000 to 4 million, but the total is growing 20 percent to 40 percent annually, the study said.

"People are falling through America's too loosely meshed safety net," David C. Schwartz, director of the institute, said at a news conference. "People aren't getting the services governments say they want to provide."

The report said the law's broad range of programs covering temporary and permanent housing, drug counseling, health care and educational services are the right steps to take, But it complained that the legislation is not effective." (End of article).

If this report is true and a recession is around the corner, what would be the effects, if that many more millions of people are out in the streets? Wouldn't this almost start a revolution or something?

## COSMIC AWARENESS:


This Awareness indicates that this is *precisely* the intention behind the coming recession; to create such chaotic social conditions that the masses will accept

whatever is presented as an alternative. This Awareness indicates that in the likelihood and probability of the coming recession, the likelihood being that it will be of a very deep nature and it could well be much worse than a mere recession. This Awareness sees this as a potential depression lasting for half a decade; the devastation from this could be almost like that of a war because of the way people have been conditioned in this generation.

This Awareness indicates that there are very few people who understand how to get food from the land. There are very few people who know how to plant or have any place to plant seeds because they live in a cement world. There are very few entities who know how to survive off the land and therefore, they will seek to survive off of each other, off of those who might have something, and this will cause violence and conflict over small things such as food. This Awareness indicates that many of those in the cities will leave the cities in search of land, or in search of a place to escape the violence of the cities and to find a more peaceful setting on which to live and to plant crops, but those who live in the country will not welcome these and will see themselves attempting to protect themselves from invaders. That this too can lead to violence.

This Awareness indicates that those who live in the countryside will of course have the greater opportunities than those who live in metropolitan areas. This Awareness suggests that wherein entities in large cities are caught in the conflict over food crises, that this can lead to certain degrees of conflict, depending on the area, the type of city, the type of people, whether there are drug users who become even more desperate than the hungry, whether these entities are violent in nature, hostile, or feel personally deprived, whether they are the kind who would work together, or whether they would become hostile toward any and everyone.

This Awareness indicates that some areas within cities will be safer than others, some cities will be safer than others; that there will be some times in which these cities will be safe, times in which these cities will be cooperative, wherein people will work to help each other, but there will be many times and many areas in which entities will become violent in their search for survival and appetite satisfaction. By appetite, this Awareness refers not only to food, but also to those entities who simply want something and are willing to become violent for it, whether it be drugs, money or something else.



### HOW TO STORE FOOD AND WATER

#### QUESTION:

A question from L.D., Phoenix, Arizona. I'll read it and then I'll turn the tape over. She says: "I found your 89-5 issue, *The Vanishing Farm and the Coming Food Crisis* to be one of your best yet. Twenty years ago, I first heard of the coming food shortage. I was baptised into the Mormon Church, and one of the first things they teach you is to store up a food supply because they know the shortage is coming. I keep a one year supply, but I don't have adequate water storage. Has anyone ever asked Awareness about the best way to store water? That is as important as food storage. If one stored several hundred gallons of water, should it be replaced every so often? Maybe every 6 months? What kind of containers and what size should be used? I'm grateful to Awareness for alerting us to the coming events. How would we ever get along without it?"

#### COSMIC AWARENESS:

This Awareness indicates that in the storing of water, that there are many different ways whereby entities can do this; particularly if living in the countryside entities can often store water in large tanks. If living in a more urban area, small barrels would be helpful. This Awareness suggests however, that if one is to store water for more than one or two weeks, it would be beneficial to have a distiller, to assure that when the water is used it is still fresh and pure; that this is assuming that you do not have running water or that for some reason your running water would be contaminated or stopped in its flow.

This Awareness indicates that for most entities, this would not be a problem, but depending on the individual circumstances, there may be problems in this regard for some entities. That in regard to the storing of food, it is wise for entities to store approximately one year's worth of the basic food that would be necessary to prevent one from starving; that even 6 months would be beneficial, as not just a hedge against starvation but as a way whereby you could become and remain more calm in the middle of a crisis. This Awareness indicates that the storage of basic foods such as rice, powdered milk, wheat, beans, barley and grains as that which can be beneficial, helping to supplement those foods that you might normally find on a day to day basis, even in difficult times, or which might in an absolute emergency become the only foods available.

This Awareness indicates that when storing foods in this manner, it is good to continually use them and replenish them in order to make sure that they do not become stale. It is a good idea to have bins available in a storage room, and use from such bins, and then replace that which is used periodically so that the turnover of the foods continue and the foods do not become stale or stagnant. This Awareness indicates that canned foods can also be stored; frozen foods are not as desirable because there can be shortages in terms of power outages or in the event your income is cut, you might have your electricity shut off; even for one or two days could cause the loss of all the frozen foods that were in storage, and this would be quite wasteful.


This Awareness indicates that there will be many entities who will become sick from weakened conditions. This Awareness indicates that it appears that when things get bad enough, there will be introduced those programs which allow entities, by giving up certain freedoms, to participate, and it is at this time that the real meaning of the depression and economic maneuvers will be understood. This Awareness indicates that it is likely that this will occur on a world-wide basis; the likelihood is that it will begin abruptly, gradually as indicated in the previous remark by Abraham, in that there will be a series of crises spanning a period of time, leading to a very low point in economic conditions which should reach its lowest level in approximately 1992 or 1993, and then gradually begin to improve, to a semi-normal situation in 1996 and thereafter, continued gradual improvement.

#### What You Can Do to Help Change the Scenario

This Awareness indicates that even this will not likely be the end of the difficulties, because there will be international disturbances that will have resulted from the conditions brought about by the economic crisis. This Awareness indicates that this scenario is not seen as being an absolute prediction of absolute certainty, but it is seen as having approximately 75% probability of occurring as indicated. The one chance in four that it will not occur as suggested lies in the changing of vibrations on this plane, in which, if enough people emit enough spiritual energy during the coming months and this energy emanates harmony and proliferates to the masses and to those who are also in positions of power, much of the karma of this plane can be reconciled or balanced so that this scenario needs not occur or may occur in a much modified manner with much less of the extreme conditions.

This Awareness indicates however, at this time, with the energies as they appear to be, in the direction of their present movements, the suggested scenario is that which has been described. This Awareness asks that entities not be fearful, but rather send light, love and spiritual energy in their meditations, in their mental imagery, to project a more healthier and more vibrant future with a diminishing of polarities and an increase in harmony for all on this plane, for that can help to pacify the storm, to bring about a calming of the waters.

This Awareness indicates that dried foods in packages is another way of storing. It is important that such foods be in areas wherein vermin and mice do not get to them. This Awareness suggests that you need not worry about this at this time, but that as the indicators of a recession begin to pile up, you may wish to move more quickly toward this type of food storage program. This Awareness does not wish to cause entities to become nervous or fearful. *It* rather, wishes to have entities mentally prepared so that they can physically prepare in time, if necessary, for when an entity is prepared and an event occurs, the entity is better able to not only weather through the event for his or her own sake, but is also better able to assist others at such a time, or at least not to be such a burden to others.

This Awareness suggests that depending on your environment, if you are storing food, you may wish to consider placing the food in a place that is safe from those who would pilfer or rob, so that you have the option of giving the food to whom you wish, rather than having it taken against your will. This Awareness indicates that this is to suggest to you that you consider your own environment, your own situation and prepare for your particular situation; that the generalities which this Awareness can offer may not apply to everyone, and that you yourself will have a more clear picture of what your needs might be.

This Awareness indicates those who live in the countryside, who live on a farm for example, or who live near those who farm, have options that are unavailable to those who live in the cities. This Awareness indicates that those who have money put away in safe places have more options than those who are living one month ahead of disaster. This Awareness indicates that you must consider your own situation, and do the best you can and plan the best you can, for the events may unfold, but this Awareness suggests that you not panic or become totally frightened, rather, that you mentally become aware of the potential that is presently facing this nation, so that if and when the crisis does begin to occur you are not kept caught napping and awaken only when you discover that the stores have been looted, the banks are closed and you have no money and no food to feed your family, and you had no forewarning.

This Awareness wishes to forewarn entities that this is a strong potential for depression or recession in the next two years, within the next two years to begin.

**COSMIC AWARENESS:**

This Awareness indicates that this does appear to have a process that would be acceptable and beneficial in this regard. The particular process is acceptable and correct. The question might be in terms of efficiency, the size and amount that can be processed by any particular brand and the cost involved. These would be considerations entities considering such would wish to pursue. This Awareness indicates also that there are certain wild herbs and weeds that are edible and can be of good benefit to one's diet in times of need.

This Awareness indicates there are available books describing these edible wild herbs and plants and it would be beneficial for entities to purchase such books with information regarding plants in their own area; that this should be pursued when they begin to recognize the potential for this coming economic crash, for during the times of the Great Depression, many families survived against starvation by eating polk, lambsquarters and other weeds that most people nowadays do not even recognize or would not consider as something quite edible.

## TRIAL BALLOONS: A NATIONAL I.D. CARD AND "OPERATION BOLD STROKE"

(WHERE ARE THE GUARANTEES IF WE ACCEPT THESE?)

### QUESTION:

Former Congressman Ron Paul puts out a newsletter which we subscribe to, and in the latest one he outlines a couple of trial balloons that apparently are going up in relation to national ID, and I'd like to read this and ask Awareness if this is part of what *It* said might come down on entities after the recession and people are crying for help. He says: "Our so-called Justice Department has just published a 20-page blueprint for a national ID smartcard, to be introduced as a national gun registration card. Eventually, it would include your fingerprints and retina scan, and some of the technology Justice proposes using will also be used in the New Money.

The Bush administration's 1988 drug bill called for such a card, and the Justice Department, IRS, FBI, and Immigration and Naturalization Service have long pushed for one. But the ACLU immediately condemned the plan on privacy grounds, as did supporters of our Second Amendment rights, and two days later, a high administration official told the *Washington Post* the proposal was an "official trial balloon."

This is the way the feds wear down public opinion against new statist measures. First they broach the subject, then they set about changing or stifling public opposition.

A hologram, also called a "wiggle picture," which the Treasury has proposed be included on the New Money, will also be used on this "biometric ID card," to include retina scans and fingerprints. But the Justice Department lists several potential problems, however: 1) it would cost a lot; 2) "There may be public resistance to systematic fingerprinting"; and 3) the "creation" of a massive federal data bank of this size "may be controversial."

What about the plan's obvious unconstitutionality? Not only would it violate the Second Amendment, there is no warrant in the Constitution for federal surveillance of law-abiding Americans. But the Justice Department says there are "no constitutional impediments." What about privacy? Justice says the only concern is making sure private businesses don't get access to personal information only the bureaucrats should know. But somehow, while I don't want Sears knowing all about me, I'll take them over the IRS and FBI any day!

The Feds have backed off for the moment, but gun owners and all of us have good reason to be concerned. Big government is willing to use any excuse to implement an Orwellian State, whether counterfeiting, drug dealing, tax evading, money laundering, or felons buying guns.

But no matter what the excuse, the target remains the same: middle-class, law-abiding Americans whom the government wants to control. The feds will do anything to eliminate our economic liberties and financial privacy."

He goes on: "Liberal *Washington Post* columnist William Raspberry recently floated a trial balloon for his friends in the government: the smartcard plan of William G. Ridgeway, a former State Dept. official.

Dubbed "Bold Stroke," Ridgeway's plan would outlaw all cash, bills and coins, which he refers to as "the very mother's milk of the spy, the terrorists, the thief, the

drug pusher, the drug user, tax evader, and the embezzler." Adds Raspberry: "Cash, in short, is the root of a heck of a lot of the world's evil."

To replace evil cash, we would be issued a foldable card the size of a dollar bill on which would be encoded, says Raspberry, our "bank balances, credit limits, medical records, passport, driver's license, photograph, welfare eligibility, and other data," plus our thumbprint. "Every single transaction would create its own record which could then be used for criminal investigation." It would also, he says, lower credit-checking and bill collecting costs for companies.

Big government in Washington would love to track our every move, and to abolish the last vestige of financial privacy with this kind of Big Brother surveillance. However, cash is the mother's milk not of crime, but of privacy. But to an ever more ravenous bureaucracy—and its Trilateralist corporate allies—privacy is itself a crime.

The correct view—morally, Constitutionally, historically, and economically—is that of Supreme Court Justice Louis D. Brandeis, who said in 1928 that the Founding Fathers in the Constitution "conferred, as against the government, the right to be let alone—the most comprehensive of rights and the right most valued by civilized men." The right to be left alone doesn't have much resonance in today's Washington, but that is all the more reason we should cherish it."

Would Awareness comment on these 'trial balloons', please.

### COSMIC AWARENESS:

This Awareness indicates that the information as that which has analyzed correctly the nature of the situation. This Awareness indicates that essentially, that card which the entity spoke of, would make each individual read like an open book, open to the government. This in itself does not necessarily sound so disturbing as long as the government is benevolent, and most entities today believe their government to be benevolent. But where are the guarantees that the government will remain ever and always benevolent toward the individuals, toward the citizens? Where are the guarantees that the government does not become Fascist or Communist, or take on some other kind of dictatorship and totalitarian qualities?

This Awareness indicates that once these laws are implemented, even under a benevolent government, the laws do not simply go away because the government becomes totalitarian in nature. Where are the guarantees that a government which decides that once the cards are in place and all entities have their national ID cards, with their bank accounts and all of the other information that they perhaps should also have their nationalities, their religion, and their families' names included? Where are the guarantees that with this other information of beliefs, nationalities, political preferences, family names, that a totalitarian government might not decide that people with

this belief, persuasion, nationality, race or family should be eliminated from society? This Awareness indicates it has happened before, even without the cards to identify entities, but with the cards it would be far more efficient to rid society of certain types.

This Awareness indicates that is where the greater concerns might lie; not so much that a benevolent government simply wants entities to be law-abiding, abiding by laws that are fair to everyone, but that a benevolent government might be followed by one that is totalitarian or is of a persuasion which does not allow room for a certain nationality, a certain genetic type, a certain racial type, a certain age group or a certain religious belief.

### WILL THE NEW MONEY CONVERT ONE-TO-ONE OR TEN-TO-ONE?

(More on the coming Currency Call-In)

#### QUESTION:

J.B., of Syracuse, New York, writes: "Enclosed is some info on the currency conversion. Some people think it will be only a one-for-one exchange. I think Awareness may be tuning in to some people who would like the conversion to be more than a one-to-one exchange. The problem is, that just because some people are planning something doesn't necessarily mean they will be able or allowed to do it. Also, some other people in positions of power may want only a one-for-one exchange. I asked another channeler who was very good at predicting future events about the currency conversion. His predictions were different than Awarenesses.

It's important that we all follow this because of the large scale economic consequences of such an event. I hope Awareness can keep CAC members posted on when the government plans to enact this conversion, and whether it will be more than a one-for-one exchange or not. I think it's important to follow the economy because it affects all of us so much. I read *Surviving the Great Depression of 1990* by Ravi Batra. The first part of the book explains how we are going to pay the price in the long run for the eight year joy ride we've had with Reaganomics and supply-side thinking.

It would be good if all CAC members could prepare themselves for economic hard times. Rather than being knocked around by the oncoming economic forces, it would be better to prepare for the worst, and hope for the best. I think the best current book on the subject is *How To Survive The Money Panic*, by Martin Weiss, Weiss Research, Box 2923, West Palm Beach, Fla. 33402. The price is \$19.95 and the phone is 1-800-228-1188. With this book, along with Awareness's monitoring of the situation--maybe all of us can weather the storm. Thanks very much for your kind attention."

Would Awareness comment on this one-to-one exchange, or whether it's going to be as previously indicated, ten-to-one, or something to that effect?

#### COSMIC AWARENESS:

This Awareness indicates that the situation as more likely that a ten to one exchange would be implemented because of the cost and time involved in printing such amounts of money: that a one to one exchange requires



ten times the amount of printing whereas a ten to one exchange means that one-tenths of the money in circulation would be printed as new money. There is a big difference, not only in time, distribution, bookkeeping and printing costs, but also there will be a reduction of the vast amount of record-keeping on the documents.

This Awareness suggests that the new money would have a different symbol from the dollar sign so that entities would know it referred to a ten to one value, and so that new references to transactions could easily be converted to the old references. This Awareness indicates that the need for large amounts of circulation is not seen; that when there was an economy in which the dollar was worth ten of the present dollars, the economy functioned just as well as it does today, but it is the nature of a healthy economy to be in continual inflation. Wherein inflation can be allowed over a period of time to a small amount, the economy is healthier, thus, if the inflation can be allowed with the new currency, it could last for another 50 years or so before another call-in would be necessary.

This Awareness indicates that in the past, the currency backing, the gold or silver behind the currency was reevaluated, but with the gold and silver taken off the currency, the currency has been inflated to the point wherein it takes much more currency to accomplish the same thing as earlier currency. This is due to the inflationary spiral. This Awareness suggests that by a ten to one turn-in, the currency could again begin its inflationary spiral within a reasonable level, one or two percent inflation, and could hold that for some time. That without such a ten to one turn-in, within 50 years there would be one hundred times as much money in circulation as at present, whereas the dollar bill would be worth equivalent to present time ten cents or less, and it would take many sacks of dollar bills to pay for a simple purchase at a store, but wherein with the ten to one turn-in, the dollar bill, the new dollar bill would replace ten of the old, and would serve with greater convenience.

It is a matter of practicality and practicality weighs heavily, so that in considering the practical approach, the cost of printing, the distribution and the future use of the currency and the need to have a continual inflation and to start afresh with something that can be inflated; this needs to be considered by those who are practical. This Awareness suggests therefore the ten to one is not unreasonable and is very likely as the way in which this will proceed.

OUR POCKET COINS TO BE REVISED ALSO  
--ANY SIGNIFICANCE TO THIS ACTION?

(Follow-Up Question):

The Treasury Department recently announced that they plan to revamp the coins of the United States, saying that some of them haven't been changed in 85 or 100 years or so, at least on one side they're going to redesign. Is this part of the plan? Is this a legitimate thing to do, or is behind this a plan to keep entities from increasing the value of the coins that they put in storage when the ten to one money recall happens?

COSMIC AWARENESS:

This Awareness indicates that this appears to have two reasons; it appears to be part of a plan to, number one: discourage entities from saving clad coins for reasons being that it wouldn't do them any good; number two, ....this Awareness indicates it does not appear to be valid or a likelihood that the coins presently in circulation will be changed; this would create too much confusion and too many discrepancies. Those who held on to coins and stored them while other coins of the same nature were being changed, would essentially be creating a numismatic market for unchanged coins and the value would be increased of those such unchanged coins.

This Awareness indicates that it does appear that such could be an action but that the likelihood is that it is not the way the Treasury would proceed on this. This Awareness suggests however, that what is more likely is that certain types of plastic coin would be created; that the plastic coins could have certain metallic or composite elements within it, so that they could not be counterfeited. This would be a unique element within these plastic coins to be introduced into circulation as the other coins are drawn out of circulation, much the way silver was taken from circulation when the copper quarters and dimes were introduced.

This Awareness indicates that as the plastic coins are introduced, the metal coins would then be taken out of circulation. This appears to be the scenario in the not too distant future. This Awareness indicates that copper as having greater dollar value than the amount of copper in a penny, thus, the one cent of a penny does not pay for the copper that is in the penny. This copper as increasing in value as time passes and the demand for copper increases. This Awareness indicates there is also the copper in quarters and dimes. There is also a certain amount of silver in quarters and dimes that could be retrieved if these coins are brought back and melted down. It would more than pay for the plastic coins that would be introduced into society. This Awareness indicates however, that in order for these plastic coins to have any acceptance, they would need to have certain metallic elements added to them, in order that they could be usable in coin machines and stamp machines and money changers. This Awareness indicates that it appears these coin changes, the changing of coins to plastic would be an evolving process, a slow, rather than a sudden overnight event.

ED's Note: The question still remains: should we continue to rathole our coins, putting the change in our pockets each night into a jar, so when the ten to one conversion occurs, our little stashes will go up ten times in value, along with the new paper money? Some years back, Awareness recommended we save these pocket coins for just such an event. Since it is not clear at this time that plastic or other new coins are going to be introduced, I for one will continue to sock away what few coins I have left after taking Vikki T. to dinner.

## CAN A ONE-WORLD GOVERNMENT BRING PEACE TO OUR PLANET?

(ENTER THE WORLD COURT)

### QUESTION:

A question from P.P., San Ramon, California. "If you please, ask Awareness about an issue which I am quite concerned about. In the past, Awareness has expressed that there has been underway for some time now a movement toward the creation of One World Government, yet one which has malevolent forces behind such. I have just recently read the book *Planethood*, by Benjamin Ferencz and Ken Keyes, Jr., in which the basic message is that there will need to be an international system of law and order for world peace to be assured. Also in the book are numerous noteworthy quotes made by some of the world's greatest men.

For instance, Albert Einstein is quoted as having said "Mankind's desire for peace can be realized only by the creation of a world government." I would like Awareness to comment on this issue and to explain how world peace can be accomplished if not through the creation of a world government?"

### COSMIC AWARENESS:

This Awareness hasn't indicated that world peace *could* come without a world government. This Awareness has warned entities in regard to a One World government that was based on and directed by those who were of the mind to enslave the masses. This Awareness in 1975 suggested that the approach was not to fight a One World government, but to take that energy and direct it as one of the martial arts takes the energy of an attacker and direct it in such a manner that it works against those who would misuse the power and for the people. This Awareness suggested that the masses might use the One World government as a promotion for democracy on a worldwide scale.

This Awareness now suggests that this is beginning to be recognized as a movement in which democracy is taking hold in areas that were previously alien to democratic principles. This Awareness suggests also that *It* has indicated the need for a World Court; that the World Court in the Hague as that which could and should be modified to serve the role of preventing warfare between nations. That to prevent wars between nations, there needs to be law that supercedes violence, just as in the old days of the West in the last century, in the United States, wherein two gunfighters would enter a town and determine who ruled the town by having a shoot-out; this kind of might-makes-right ruling was replaced when law entered the town, and the rule of law replaced the gunfighters, or the settlers who had their dispute over a fence line who might at one time have settled their dispute with violence, now would go to court and the court would weigh the evidence and decide where the fence line was supposed to go.

This Awareness indicates that it is the same need in terms of the World Court; the World Court could have easily determined who rightly owned the Falkland Islands,--the British or the Argentines, or if there was not a clear ownership by either, the World Court could have settled on a compromise, giving a joint rulership

or joint ownership or could have divided the islands. The war could have been prevented in the World Court. Likewise, Iran/Iraq in their war over the border dispute, had it gone to a World Court, the countries, each presenting their own evidence could have had a settlement that would have prevented the loss of the many thousands or hundreds of thousands of individuals who suffered from that border dispute.

### How a World Court Would Work

This Awareness indicates that it is the same with all wars: these could be settled in court. They are no different from the gunslingers trying to settle their disputes with their guns except that these are much larger in scope and have greater repercussions on more people. These disputes are between nations and the international court or World Court, should be specifically designed to settle international disputes. This Awareness indicates the attempt earlier in this decade of the World Court to determine the dispute between the United States and Nicaragua, ended with the United States totally ignoring the World Court and its decision; the decision and the Court having no teeth to enforce the laws or the ruling of the World Court.

This Awareness indicates without teeth in the law, the law is nothing. It is a rule that entities break. It is as though playing a game, and if the entities don't like the way the game goes, they simply knock the board over and walk away. This Awareness indicates that in order for the World Court to have teeth, to have any power over nations, it is necessary that nations agree with each other to give allegiance or commitment or some kind of surety to the World Court and to gain some kind of privilege and protection from the World Court, in exchange for what is given. You gain from the law, and you give to the law. You respect the law, and for that respect, you gain certain protection.

This Awareness indicates that if in the beginning only ten people agree to abide by the law and a hundred people decide not to abide by the law, then it is necessary that those ten people join together in such a strong pact that in support of the law, they do not break and scatter, and that they seek to bring in others and give some kind of reward to others for joining with them in support of the law. Gradually, as more and more join, and as only a few lie outside the law, those who have joined in allegiance to follow the law, gain power, and the law then gains power, and those who lie outside the law lose power, and it is the same with a World Government or World Court, wherein if a favored nation group were to be formed so that those groups, those nations belonging to the favored nation group, or an alliance of favored nations, all agreed to abide by the World Court and its rulings, if this were to occur, and more and more nations joined and for joining they received better trade benefits than those in other nations that would not participate, and if, in receiving better trade benefits they also received from each other mutual protection and pledges of mutual protection, much as

the NATO alliance and Warsaw alliance, pledging together to follow the laws of the World Court,—if this were to occur, and those nations that lay without or outside of that grouping of favored nations were to find it inconvenient to have to pay higher tariffs to trade, to be on their own in a crisis, without support, they too might wish to join, and gradually, as more and more joined, the teeth in the World Court are strengthened.

This Awareness indicates that as this strengthens and more and more nations come under the rule of the World Court, then gradually, those cases between nations wherein there are disputes, come to the court for review and the court decides, much as individuals come to your courts to decide on cases, but instead of individuals, you are dealing with nations, and if a nation violates its own people, is it not much like an entity in a family who is violating those in his family?, and if there is a complaint against that entity for having violated those members of his family and this gets into court, the entity can have his family taken from him, or the entity could even be thrown in jail.

#### How the World Court Would Deal with Outlaw Nations

Likewise, a nation which is oppressing its people, such as occurred recently in China, or in the case of Idi Amin in Africa during the last decade, such people oppressing their own people within their own country, are essentially outlaw nations, living outside the rules of decency, not respecting human rights of their own people, and this could come before the World Court and a ruling could be passed that no favored nation shall deal with or conduct business with that country.

This Awareness indicates that the very action of quarantining a nation is the same thing as throwing a nation into jail. There can be of course modifications and degrees. There can be certain degrees of quarantine or degrees of trade that are allowable, other degrees or types of trade that are not allowable. This would be for the World Court to decide, but whatever the World Court decides, all nations would abide by that ruling. That likewise, the question might come up: How does the World Court decide? Who are the jurors?

#### Who Are the Jurors in the World Court?

This Awareness suggests the jurors could be selected from nations that are not involved in the issue, the nations that are impartial, and who are the counsellors, the attorneys for the defense or the attorney against or for the plaintiff? These are those who represent the respective nations. They send their own counsellors to argue their case, for or against the other, and they are listened to by jurors from impartial nations, and they are judged by those judges who know the law, who understand international law, who explain the international law to the jurors, and if there is an agreement by the jurors in favor of one nation over another, they then reflect back to the judge their finding, and the judges then go their lawbooks and determine the appropriate sentence or decree.

(For example): "This nation shall be quarantined for 6 months in regard to all military materials. None shall be sent in. Food stuff, hospital supplies, clothing is allowed, but no trading of military supplies." This Awareness indicates that this 6 month quarantine may


be sufficient for that particular case, or they may at that time decide to review the situation within 6 months to see if the nation has come into compliance. This Awareness indicates that these things can be handled simply by mimicking the laws that are already on the books in regard to individuals; that the oppressed people are much the same as one who is a ward of someone else, and should be treated much like a ward of someone, and if those who are in charge of a ward are violating that entity, they need to be removed or to cease and desist in that action.

You do not violate a minor. The court does not allow such violations, nor should the court allow a ruler to violate the people without some kind of repercussions, but those repercussions can only come when all nations work together as a whole community, for it is in that respect for the law, for the rules, that allows a community to be civilized. The rules themselves mean nothing unless everyone respects those rules and if one does not respect the rules, then all involved must turn against that one and bring that one back in line. It is in this manner that law, a One World Government, a World Court, can be beneficial to humanity.

This Awareness suggests that the World Court can serve as much as the United States Judicial Branch; that the United Nations can serve much as does the United States Congress, and the Administrative Branch; that there can be the writing of laws and the administration of business and the judicial actions of carrying out those laws, enforcing those laws. This Awareness suggests that a presidio to serve as the administration could well be established by bringing together representatives from all nations, much as the United Nations, but there does need to be a separation of the powers,—those who make the laws and those who administer the laws and those who enforce the laws; that you are very close to having this pattern of your United States government implanted as a World Government, and this can be most satisfying.

This Awareness does caution, as has previously been indicated, that those who manage the money are not the proper ones for governing the world; that there does need to be a branch of government, nationally as well as world government, to oversee the issuing of money and the control thereof.

NEW MUSIC THROUGH AN ITALIAN PEASANT?

PROCESSING UNIVERSE)

COSMIC AWARENESS:

This Awareness indicates this as in the affirmative. This Awareness indicates however, that you must understand that the entity Mozart as not necessarily the incarnated body or spirit that is channeling to this entity; rather, it is the *energy* that was set in motion by Mozart which continues as a kind of information processing subset, or subsystem. This Awareness indicates that as *It* has been attempting to convey during the last several months, an information processing universe carries information that has been input into the universe by the Creator, and has been modified by other subsystems that have been created by the Creator, so that these subsystems, be they human, spirit, or other types of beings, when perfecting some kind of information processing, being perhaps in such a case a musical style, that the musical style, the system, the process, once started, continues until something enters in to modify or change that style or subsystem of information processing.

Likewise, the entity who was involved in that action, in many ways himself may have simply tapped into some information processing that was occurring in consciousness and channeled that material with his name attached to it, and likewise, the entity may have moved on into another lifestyle and another adventure while the subsystem of information processing continues, awaiting for someone else to tap into it and channel it. It is in this manner that occasionally entities become genius in the sense of channeling, even though they themselves do not necessarily create the information that they bring to this plane, as in the case of this peasant woman.

This Awareness indicates that likewise, Mozart, in his youth, was not really capable in himself of bringing this music out of himself, but he was capable of

tuning in to the Universal Consciousness, and hearing the music and conveying it through the mechanism of his musical talent, the playing of the music and the writing of the music. In other words, what he learned to do was to play music and to write music and to channel the music that he heard.

This Awareness indicates in the case of this peasant woman, she is not able to play or write the music, but is able to hear and hum the tunes, so that others who can write and play may bring the music to this plane.

#### DID MOZART PROGRAM HIS LIFETIME TO BECOME A MUSICAL GENIUS?

(FOLLOW-UP QUESTION):

Before a musical genius such as Mozart comes down to this plane to produce his music, does he program himself in some manner to have this ability to tap in to this Universal Consciousness, to hear the music that most people do not hear?

#### COSMIC AWARENESS:

This Awareness indicates the entity did not come to produce this music; the entity came and was taught by his parents to play at a very young age and was taught how to write music. The entity was sensitive and open enough to music that the playing and the writing developed within him a love for music which then influenced the entity's sensitivity toward music, which allowed him to tap in to that which was available in the Universal Consciousness along those lines which he enjoyed, thus, he tapped in to that particular type of melody which was enjoyable to him, which seemed perfect to him, and then brought this forth. It was not necessarily that the entity came to write music. The entity came to experience life and ended up writing music.

This Awareness indicates likewise, there are many entities who come on to this plane with a certain intention, but never fulfill their intentions, and instead are directed into other activities due to parental wishes or environmental and human influences that insist they go in a different direction. There are many entities who would have enjoyed doing something particularly enjoyable with their lives, but were influenced into war or into business or into some occupation that to them was mere drudgery throughout their lifetime.

#### IF NOT FOR MOZART'S PARENTS, WOULD HE BECOME A GENIUS ANYWAY?

(THE IMPORTANCE OF EXPOSING KIDS TO THINGS OF VALUE)

(Follow-Up Question):

Had not Mozart's parents got him interested in music at such an early age, like 1 or 2, I believe it was; what would the odds be that as he grew up later, that he would be a musical genius? In other words, is the musical genius and geniuses in other areas mainly dependent on the parents or exposure at a very young age to something like music which he gets excited about and decides to make his life profession of it?

#### COSMIC AWARENESS:

This Awareness indicates that it was the exposure to music at a very young age that allowed this entity to become the genius he was. The entity did also have a sensitivity and a certain degree of inherent talent, but had this entity not been exposed to music; had the entity been born on a farm in which cattle and sheep were the focus of attention, the entity is not likely to have developed much of a musical skill or talent, unless someone somehow just presented a piano for the entity to play around with which might have led to some degree of musical interest.

This Awareness indicates that had the entity been given a job shining shoes at the age of 3 or 4 instead of being taught to play the piano, there would not have been a famous Mozart. This Awareness indicates that any child at a young age who is taught something of a skill at that young age, be it computer use or piano or musical skills, any child at a young age is going to become proficient, and if the entity also enjoys what he or she is doing, the entity will learn at a rate much quicker than an adult who just begins to study that field.

#### How to Make Your Kid a Computer Genius

This Awareness indicates you have those entities termed 'computer whiz kids' or computer geniuses. These are children who begin at a very young age playing with computers, and as they get older and have more stimulus for the various aspects of the computer and programming, they become the giants of the computer industry. This Awareness indicates it is the same thing; if you wait until you are 15, 20 or 30 years old, to begin a study, it is much more difficult to become expert in that field. It is for this reason that children are able to learn a language with such ease in comparison to an adult trying to learn a foreign language.

The child's attention and every-day activities may be centered around learning to speak out of necessity, whereas an adult already knows how to survive with one language and does not need a second language unless the entity lives in a foreign country, in which case, the entity then may also learn the language very quickly, out of necessity. This Awareness indicates that if you give a child building blocks and construction parts for creating houses or buildings at a young age, and this entity learns to assemble these things, that entity will have skills that can be reapplied at a later time, which could stimulate the interest in the building trade, as a career.

#### Guiding a Child Into a Constructive Life Level

This Awareness indicates if the child is young and learns the use of words and spelling at a young age and enjoys these things, the entity is likely to become quite prolific with the language and writing skills as the entity grows older. All of this of course is on condition, or on the assumption that the entity will not suffer some kind of disruptive trauma that inhibits his learning path. This Awareness indicates that those parents who simply let children fight with each other and then try to calm them down when they get on their nerves, and wherein the children are involved

more in terms of physical activities and do not have any stimulation in terms of musical or verbal talents, but are provided instead with guns and swords and knives and weapons of war, or allowed to fight with each other or with the neighbor children,—these are not going to grow up to be geniuses. They may grow up to be soldiers or wrestlers or fighters, but they are not likely to contribute anything of great constructive nature to the world. This Awareness indicates they may become lawyers at best, or some kind of competitors in business.

#### A Child's Life Character is Set by Age of 5

This Awareness indicates that children who are taught to be competitive, grow up to be competitive. Children who are taught to make music, to entertain, to produce something of a constructive nature, tend to grow up being that type of person. This Awareness indicates there are always changes that occur in the child's life to take one from one form of behavior into another, but the general trend of character molding takes place before the child passes the 5th birthday; that 90% of the child's character is developed prior to the age of 5; that this is in reference to the basic underlying character. Of course, the entity will develop refinements and philosophies and concepts which can help to modify the character somewhat as the entity continues throughout his or her lifetime, but the essential character is set by the age of 5.

This Awareness indicates of course, traumatic experiences after that age can have a profound effect on the entity and cause disruptions that may disturb the character or may otherwise modify the character. There can be a reprogramming of the character, based on either traumatic experiences, or on going back through the psyche to those times to the age of 5 to modify the character. # Fed Waives Restrictions On Drug Cash Transfers

EXCLUSIVE TO THE SPOTLIGHT

All of the restrictions and advanced cash monitoring systems in the world will not be able to stop the flow of drug money, since the Federal Reserve System waives reporting requirements for all transactions linking the Fed to U.S. and foreign banks, thus serving as the largest conduit for drug money.

According to an August 14 report in the *New York Times*, bank examiners have found that "as much as \$100 billion from selling cocaine in the United States is being sent from the country annually through the electronic transfer of money from American banks to . . . the violent and powerful Medellin drug cartel in Colombia."

The *Times* story follows in the footsteps of earlier reports in this newspaper that exposed in detail the key role played by major U.S. banks in laundering and managing the tidal flow of drug cash (SPOTLIGHT, April 10).

## UNTRACEABLE

According to the *Times*, the bankers themselves now recognize this problem. "Once drug money gets into the banking system, there is very little that can be done [to trace it]," admitted John Byrne, general legislative counsel for the American Bankers Association.

Congressional leaders, the *Times* found, were also "concerned." Sen. John Kerry

(D-Mass.), chairman of the Senate Foreign Relations subcommittee on terrorism, narcotics and international operations, revealed that he was "introducing legislation to require the Treasury Department to use sophisticated scanning technology to make paper money more traceable."

What the story does not disclose is that such gadgetry will make little or no dent in the drug-money problem. The *Times* report discreetly avoids any mention of the key fact, exposed by this populist newspaper: The main channel for laundering and smuggling drug funds—and thus the heart of the problem—is the Federal Reserve System.

Banks are required by law to report money transfers of \$10,000 or greater. But these controls—in fact, all restrictions—are waived for electronic money transfers linking the Fed to U.S. and foreign banks. The drug magnates know it, and they have found easy ways of pumping their vast funds through bank deposits, and across frontiers, by using the Fed's electronic money-laundering network.

## SURPLUS CASH

There is readily available evidence of these transactions in the Fed's own statistics. In 1985, the Miami branch of the Fed reported a \$6 billion cash surplus; bank officials admit that this is "narcotics revenues."

By 1987, as the drug trade moved west, the cash overflow shifted, too. The Miami deposits dropped by some \$2 billion, while the Los Angeles Federal Reserve Bank reported a sudden spurt of \$3.8 billion.

"Law enforcement officials consider the Federal Reserve statistics to be a reliable indicator of drug money laundering activities," reported The SPOTLIGHT in its previous article.

In the opinion of narcotics investigators and fiscal analysts interviewed by this populist newspaper in Miami, New York and Washington recently, Kerry can save taxpayers the expense of new banknote-tracing optical equipment if he throws his weight behind legislation (H.R. 844, S. 734 and H.R. 2795.) to audit the Fed and reform its criminal money-transfer system—now serving as the largest single pipeline for drug money in the United States. ©

# Fed Given License to Steal by Congress

The crux of the argument against the Federal Reserve System is that this privately operated scheme run for the benefit of the biggest banks in the United States has, in effect, a license to steal.

The Fed each year reports only a small profit; but where does it get the money to buy U.S. bonds and other securities?

The annual report of the board of governors of the Federal Reserve System states that, for example, the 1985 income of the Federal Reserve banks was \$19.432 billion. Their reported operating expenditures were \$1.127 billion, leaving a surplus of \$18.305 billion. Out of that amount \$17.796 billion was turned over to the U.S. treasury as interest payment on Federal Reserve notes (currency).

After paying that interest, the Federal Reserve reported having \$509 million left for other purposes.

How then did the Federal Reserve buy or acquire \$18.575 billion worth of U.S. securities in 1985, when the system's own records showed just \$509 million to work with after paying all expenses? Did the Fed borrow \$18.575 billion to pay for the securities? Did it sell Federal Reserve "bonds" to raise the money for those securities?

The beginning of this article might

sound strange or even ridiculous to 99.9 percent of the public, which apparently also includes Congress, which has never been educated how to finance a sovereign national government with government money to keep it out of debt and deficits. The American taxpayer is led to believe that a national government is financed just like any domestic or corporate household.

This is the oldest and best entrenched canard of historic as well as modern bankerism (alias capitalism).

#### HUGE DIVIDENDS FOR BANKERS

Congress, in 1913, abandoned its Constitutional right to regulate the money supply and handed it over to the newly created Federal Reserve Bank system. This central bank was, and remains, a machination of private bankers who saw a way to reap huge dividends from the hard work of Americans.

It creates money literally out of nothing and lends it, for a fee, to its member banks; these in turn lend it at even higher interest rates to commercial banks. Finally

the money is made available in the form of loans to the public, which is charged the highest fees of all.

The Fed tells the U.S. Treasury Department how much money to print, then charges—and collects—interest on those bills from taxpayers. These profits are used by the Federal Reserve to purchase taxpayer-guaranteed bonds.

It's the classic confidence artist promise, but in this case it works: Those in on the scheme truly do get something for nothing.

Most Americans, and even many members of Congress, apparently are unaware that it is their labor which generates the Fed's operational expenses—and its profits.

To demonstrate how high and widespread is this fallacy, on a *Me-the Press* television broadcast a member of the National Economic Commission claimed, "It's [financially] no different running the federal government than running your household."

Such misguided thinking can be of little help to President George Bush, who might well prepare himself to watch in frustration as the federal debt and deficits grow, not necessarily because of his or congressional extravagance, but because bankerism through vulpine legalism has ensnared our government.

It is hoped that legislation pending in Congress to force, for the first time, an open audit of the Fed (H.R. 844, S. 734 and H.R. 2795) will lead to this realization. ●
