



IF THE HUMAN RACE WERE TO DISAPPEAR, WHERE WOULD ENTITIES AND CREATURES GO?

(C.A.C. General Reading, September 10, 1990)

QUESTION:

Y.M. of Escondido, California writes: "The latest issue of "Revelations" is once again just filled with super information. It really makes me think and has changed my whole perspective. If the human race were to disappear from the earth plane, would we go to another planet and incarnate there and take up our evolution? If the dinosaurs are gone from the earth, and any other species that is extinct, their energy would still be in existence, but on another level or other planet or star. Would you ask Awareness about this?"

COSMIC AWARENESS:

This Awareness indicates that energy continues to exist. It may change and alter. This Awareness indicates that entities who are highly identified with the human form will tend to continue in that form, unless they choose another form which is more satisfactory to them. This Awareness indicates that in the case of the hypothesis of humans being removed from the earth, it is likely they would go to another planet that was suitable for human shape and human types.

This Awareness indicates that *It* does wish to assure entities that the likelihood of this earth being made such that it becomes uninhabitable for human form is of a low likelihood. It is not seen as being likely within your lifetime in the sense of other aliens taking over to make it uninhabitable. This Awareness does indicate however, that it could alter in terms of vibration to the point where things shift into another dimension, leaving this dimension relatively blank in terms of human habitation.

This refers to the potential of a major shift in the dimensional vibratory rate of approximately 2012, or 2013; that there is that potential. This Awareness indicates that apart from this, *It* does not see as a likelihood the human race being totally wiped out. *It* sees rather, that there could be a situation in which Reptoid types inhabit to a greater degree underground caverns and occasionally raid the surface for food or to bring entities underground for breeding purposes to stockpile food.

This Awareness indicates that even this is not seen as an absolute. It is seen as a potential. This Awareness suggests there are forces within the government, there are forces in regard to other more benevolent aliens who would work against such an outcome. There are also entities within your population who would, upon discovery of such, work against such an outcome.

This Awareness indicates that the mini-series named *V*, which ran in the early part of the last decade and was repeated since, has more relevancy to it than most entities would realize. The entities involved in this had inside information. This Awareness indicates there are connections between this mini-series and other events that are very close to reality.

IS THERE A VIRUS OR DISEASE ON EARTH THAT COULD KILL OFF ALL THE REPTOIDS?

FOLLOW-UP QUESTION:

Is it possible, like in H.G. Well's original story that there is some virus or common disease germ on this planet that the Reptoids might have a weakness to and which might defeat them?

COSMIC AWARENESS:

This Awareness indicates that is a possibility and it is for this reason that there are grants being given, there are studies underway, there is much research being done in regard to reptiles; this is a large scale research at this time on this plane. If you will notice, this kind of research, or different types of research on Reptilians is becoming more and more common. It is mentioned not only in scientific magazines, but also in the more popular magazines and on some television shows.

In regard to new studies and new discoveries relating to Reptilians, there is a concerted effort to discover more about Reptilians in order to be better prepared for what may be coming down the pike, in the future.

HOW TO PREVENT BEING ABDUCTED BY ALIENS

FOLLOW-UP QUESTION:

Y.M. had a post-script to the last question she asked. She writes: "It seems to me we must work continuously on ourselves to raise our vibrations and evolve beyond the energy field that can be contacted by the aliens, and then there could not be the abductions, mutilations and so forth. My question is: Is it possible to raise our vibrations to a point the aliens can't contact? I understood the aliens operated through all the vibratory levels.

COSMIC AWARENESS:

This Awareness indicates there is a kind of self-awareness that expands one's awareness to include so many areas and so much information that the entity cannot be programmed. This Awareness indicates that because the entity cannot be programmed without extreme difficulty, the aliens will leave the entity alone.

This Awareness indicates that most entities who have become involved with messages from this Awareness or in some cases, other metaphysical materials, and in a sense anything that is highly complex in terms of self-awakening, it makes it more difficult for the aliens to convince or deceive and manipulate the entity's consciousness, and because of this, they don't usually even want to try.

It would be too difficult to keep the entity in line, and they prefer not to get into conflict with those whom they handle. They prefer to have cooperation from them. In other words, it takes a relatively naive person to satisfy their needs, and one who is independent and self-aware is not as likely a candidate for the abduction process. The aliens prefer those who cooperate completely and give themselves to the aliens rather than those who would be rebellious.

This Awareness indicates entities who have a self-independence and self-awareness, tend to think for themselves, are not as susceptible to the suggestions from aliens. They are not as naive and accepting of alien explanations, and they are not so ready to participate in alien experiments, and therefore are not as likely to be satisfactory to the aliens' desires or needs. This Awareness indicates this is in addition to the fact that the aliens prefer to use those

who have made pacts with them from previous times.

This Awareness indicates that entities who have their loyalties elsewhere are not prime candidates to these entities for abduction purposes. The loyalties to other things create a block, a psychological block that is more difficult for the aliens to break and makes it difficult for them to form a bond with the entity, when their loyalties are toward something else. This Awareness indicates of course, if they can persuade the entity that they are representatives of that which the entity is loyal to, then they can turn the entity's loyalty around to themselves.

Aliens Often Use Promise of Sex to Abduct Humans

This Awareness suggests however, that for most entities who are aware of the dangers of the aliens' plans and techniques and intentions it will become extremely difficult for them to manipulate to their satisfaction the minds and loyalties of the entities. That one of the tricks and techniques the aliens tend to use, especially on younger people, is to create images and sexual fantasies to lure the entity into a mind-frame with the enticement that the entity could participate in some kind of sexual encounter with an entity from another planet or another state or another being, another realm, and in such an enticement or seduction, they use entities through sexual pull, to try to get them involved with the aliens and to give themselves to the aliens for experiments of a sexual nature, which then leads to implants and other forms of bondage.

PREVIOUS CONTRACTS AND AGREEMENTS WITH ALIENS

(Old Legend of Selling One's Soul to the Devil Contains Truth)

FOLLOW-UP QUESTION:

These contracts, pacts and agreements with aliens made by entities in previous lifetimes, were these contracts clear and above board, or was there some fine print they overlooked? It's very hard to understand how someone would knowingly sign over permission to be eaten or experimented on in a later lifetime.

COSMIC AWARENESS:

This Awareness indicates that the contracts have to do with entities who would sell their spirituality for something of a materialistic gain or would sell themselves spiritually for something that satisfies a lust for power, prestige or personal aggrandizement and do so consciously and knowingly that they are willingly trading spiritual essence, their own soul essence for that, and especially when doing it in concert with the realization that there are other beings to whom they are making such a pledge.

This Awareness indicates therefore, entities who are playing with such concepts as Satanism and selling portions of their soul to Satan in order to gain power are actually relating to some alien essence or energies and making a pact with these entities for future times. In this sense, the story of *Faust* and *The Devil and Daniel Webster*, there is much to this, based on actual bartering between an entity on the physical plane and an entity of another dimension or of another species.

This Awareness indicates that generally, if it is an action of mere ignorance or of unconscious bad behavior, doing things out of personal greed or need without the conscious willingness to give away something good for themselves in order to gain something of power; generally this kind of inadvertant behavior of a bad nature, what entities would term 'bad,' this is not sufficient to classify as a contract with these types, these alien types.

This Awareness indicates that it is only when there is the conscious realization that you are bartering away to some other being that represents you, that which would be classed as evil, or one who would be alien to what you class as good, it is only when you are bartering to such an entity the goodness of yourself in order to gain something that you are actually making such a pact with such an entity.

This Awareness indicates there are entities who are willing to give up their innocence, their goodness; there are entities who are willing to sell their spiritual qualities to that which they consider evil in order to gain some temporary power or financial advantage. This occurs frequently on this plane. It has occurred for many in other lifetimes, and unless an entity has repented of these pledges, the entity may still be under such a contract.

Contracts Can Be Broken!

This Awareness reminds you that any contract can be broken. There are consequences involved, but there are also ways whereby in breaking the contract they can create a new contract that redeems them and thus, there is no one who is totally bound by such contracts. There is no one who must abide by contracts made, for there is no higher laws of the universe that acknowledge the right of anyone to sell their souls, to sell the best parts of themselves, to prostitute themselves in order to gain some temporal advantage.


When in the act of committing a crime you create a contract, the contract is null and void because it was created in the act of a crime, and entities who create contracts with aliens which are criminal in nature such as the selling of one's own soul, or such as giving up Divinity for some temporal gain, the very act itself is not recognized as a legal act in the spiritual sense, and therefore, even though a contract may be established, it is invalid.

If the entity decides to void the contract there is no enforcement of it. There is no cosmic enforcement of such a contract as that, because the act itself is cosmic-ally unlawful. This Awareness indicates however, if the entity does not recognize the cosmic right to void the contract, if the entity does not make the effort to void the contract and is acquiescent to it, then of course the entity is willingly giving himself or herself to that action.

It is the same with any kind of worldly contract. No entity is forced by higher worldly laws to continue in prostitution. If they want out, they may be forced by a contract with some pimp or such to continue in prostitution because of something they agreed to, but such agreements in themselves are unlawful in the higher laws of the land, and therefore unenforceable, and if you appeal to those higher laws, those lower contracts that were unlawful, can be made void, can be set aside.

To Break a Contract, Start Praying!

It would require that the entity seek higher beings, the help of higher beings to break free of those contracts held with lower beings or beings of an unlawful behavior. This Awareness suggests that entities involved with aliens in any kind of such contract, should turn their face to those beings of a higher nature, praying, soliciting the help of that type of being that they hold to be most high. If Christian, then pray to Christ. If Jewish, pray to God. If Moslem, pray to Allah. If Buddhist, pray to Buddha. Whatever it takes to give you the feeling, the essence, the reality of a connection with the Higher Forces that can be part of your own essence, and when that essence is established, then the aliens will realize



they cannot any longer control you. They cannot control you psychically, emotionally or in any other way and they will leave you alone.

WHY ARE THE REPTOIDS SO DRIVEN TO CONQUER? (Universal Sharks Seek Prey on Many Planets)

QUESTION:

Dan C. of Toledo, Ohio, asks the question a lot of us wonder: "Why are the Reptoid aliens so driven to conquer and enslave the universe? Don't they have enough space and enough slaves working for them already?"

COSMIC AWARENESS:

They are very prolific in their reproduction of themselves and they are very evolved in terms of appetite, and they are very unevolved in terms of respect for others, and in terms of compassion. They are much like a universal shark, highly developed in the art of conquest, being a kind of ultimate predator. It is not in their thinking to ask themselves: "Do we really need any more?" This kind of thought would never occur to them.

This Awareness indicates their thought is more complex in another direction, such as "How can we get more without expense to ourselves?", and their ultimate plans will often include causing their prey to fight among themselves so that they can have the victor, the spoils of the war, at the expense of the victims of the war, and not themselves need to suffer any losses, thus by creating half-breeds, half-human, half-Reptoids to fight their battles, they send out these, and also implant humans to be part of their army, and in so doing, turn human against human.

All they need to do is sit back and wait.

FOLLOW UP QUESTION: (VIKKI):

That sounds just like the bankers.

COSMIC AWARENESS:

This is in the affirmative.



QUESTION:

Like reptiles on this planet, do they reproduce more like the reptiles here and lay eggs?

COSMIC AWARENESS:


This Awareness indicates that these entities have different ways of reproducing, including that, including also the use of the cloning mechanism. The way which is most commonly used in reproducing the half-breeds is to extract eggs from human females, then to link them with sperm from Reptoids and often they implant this along with a chip, back into the female donor to carry for three months or less, and then extract the growing fetus and finish its development in a kind of water-bag incubator.

There can be many such fetuses growing at once in the same breeder bag. This Awareness indicates that once the entity is in the breeder bag it grows very quickly. They fill it with certain nutrients that cause rapid growth. It is like an egg in a sense with many little creatures developing quickly inside. This Awareness indicates that these half-breeds grow quickly once they are removed from the breeder bags and exposed to the air and can be full grown in a very short time.

How Robotoids are Created

This Awareness indicates that in the making of such things as robotoids and synthetics, the creatures usually are formed in a kind of factory-like setting in which many are grown without features, and the duplication of an individual occurs by the implanting of the electromagnetic current or energy field that is associated with that individual; that by taking features, the electromagnetic features from an individual, electronically doing so, and transplanting it onto one of these faceless creations, the features then begin to adapt to the magnetic field which has been implanted on the creature, until the entity begins to look, speak and sound like, and have patterns of thinking like the original.

This Awareness indicates that in terms of Reptoids creating their own, they generally have offspring, not like that of mammals, giving birth to eggs, rather than through the childbirth process. This Awareness indicates that it is for this reason that the *Book of Genesis*, in condemning the new creation for falling from grace, getting involved with the Tree of Knowledge, eating of the Tree of Knowledge, which essentially was the tree in the branch of genetic science that has to do with individuality, the ability to think and make decisions, to reproduce oneself through offspring and so forth; this action in its condemnation in Biblical terms referred to a curse placed upon woman, that she would bear children with great pain.

This as being part of the mammalian genes used in the new creation as opposed to the Reptilian genes in the first creation which would have allowed offspring from the laying of eggs.

WHY DON'T THE GREYS JUST CREATE HUMAN BODIES AND SIMPLY MOVE INTO THEM ?

QUESTION:

Dan C. in Ohio asks: "If the insectoid space aliens are having so much trouble with their present bodies, then why don't they just use their technology to make human bodies and then transplant their souls into the human bodies? This avoids all of the sadistic horrors they make up trying to invent a new body, or are they so worried about their Reptoid masters that they don't want human bodies in order to avoid most of the discomfort the Reptoid aliens intend to inflict on the human population?"

COSMIC AWARENESS:

This Awareness indicates the Greys who have for millions of years become infertile, and who produce themselves through the genetics of cloning, have no reproductive organs and although there have been efforts, cannot merge with the human body to bring back that which allows them to reproduce themselves. They have, through genetic engineering, made considerable effort to rid themselves of that which would be termed a soul; emotion, astral energies and the like, and are essentially conscious thinkers, a being of a mere robot, a bio or living robot type.

This Awareness indicates that they do not have enough of a substance to be termed a soul except in the sense of some slight spirit energies associated with living fields, or vibrations that can be transferred and superimposed over energies of another, so that they can, in a sense, take over another's body if the personality leaves, but wherein the personality in leaving the body allows aspects of the astral and the entity's soul to remain, these entities can, in other words, use or take over a being when the being removes his or her personality from the body.

They cannot, because they have no actual soul, in the sense of a human soul, they cannot just create a human body and move into it, without the human body having first developed its own efforts through some soul growth of its own. This Awareness indicates that it is possible for bodies to be created having a soul and the personality not being developed at the same time, and a being transferring in such a manner to fill the void of the personality. This is rarely done, but it does happen.

In which case, one would not really know the difference, whether it was the personality that was originally intended for the body or whether it was an alien personality that took over and pushed out the intended personality. This Awareness indicates that the aliens cannot, do not have the same kind of blood as humans. The bloods are not interchangeable, and they just simply cannot transfer themselves from their own body into a human body. It is not within their technology.

They can affect human bodies of those who are willing, and can sever the souls driving part of the entity out, and to some extent, forcing themselves in. This is not necessarily a common practice. It is not their major intent or purpose or desire. They would like to have their own selves to be immortal, but they are not immortal in the sense of a soul. They are long lived, and they continue in genetic reproduction and the closest they can come is in creating half-breeds of themselves or half-breeds for the Reptoids.

HOW MANY TYPES OF ALIENS ARE NOW ON EARTH?

QUESTION:

Dan C., among others, sent in a tabloid story about an alien abduction and mutilation. I'll read his question.

"Enclosed is an article from *Weekly World News*, June 5th, 1990. Gloria Garcia, of Belo Horizonte, Brazil, had her face burned off with a red laser when captured by space aliens described as "hideous men with long noses." The picture shows the woman before and after. The after picture shows a horrible skull-like face on the woman.

"This description of aliens with long noses and the artist's sketch in the paper does not appear to fit the insectoid type aliens. Is there a third group of diabolical sadistic aliens other than the insectoid or Reptoid types, or, I might add, is this whole story a fake?"

COSMIC AWARENESS:

This Awareness indicates the reference to the insectoid type is somewhat misleading in that these entities appear much like praying mantises in some ways. They also have certain Reptilian qualities themselves, and also they have certain qualities associated with plants. There are in fact seven different types of Greys, the most common being the Orion types; the tall Greys with large noses; and the short Orion types as Belletrax, and the Greys from Betelgeuse in the Orion constellation being taller, and there are the Zeta Reticuli, several types of these, with two main divisions: those who are extremely hostile and those who are less hostile toward humans.

There are some that are essentially friendly and business-like with humans. They still however, carry on their actions in a manner that supports the general overall goals of the Zeta Reticuli. Then, beyond this there are the several types of Reptoids. This Awareness indicates that one of the types of tall Greys from Orion often appear to people in an appearance like that of pirates. They dress like pirates. They enjoy such appearance. This Awareness indicates that it appears this was such a group that this entity encountered in this tabloid story.

This Awareness indicates there are besides these, approximately 70 types of alien beings, either on earth or in dimensions that interact between the earth dimension and others, so that beings enter into and leave various dimensions, and in so doing, they enter into the earth dimension. Most of these other types are of little consequence, and the ones mentioned are of more serious consequence. There are of course other beings too, of a more friendly nature to mankind.

WHY DID ALIENS CUT OFF THE FACE OF A HUMAN?

FOLLOW-UP QUESTION:

In the tabloid story, this woman was lifted up by the saucer-shaped UFO and they performed this operation that was very painful. She said: "They cut off my face and kept it like it was a mask!", and then she found herself in a field, without her face. The authorities wonder why they would want this woman's face is beyond comprehension, which is a good question...why would they want this woman's face?

COSMIC AWARENESS:

This Awareness indicates that these entities gather body parts frequently from different sources. Usually they get them from abductees whom they later kill or they grow them in laboratories and use these for transplanting or for sale to those organ places or they do experiments with them. It appears that in the case of this

entity, they wanted to use this face as a kind of human mask for one of their own to mingle with humans without being easily noticed.

This Awareness indicates that they have the ability to transplant not only organs and limbs, but also faces if they so choose, and they have little compassion for humans; in fact, as one researcher stated: they look at humans as though they were weeds in a field. They are for their own use or for their destruction, according to their desire. Because humans are of such little threat to them there is little respect for humans, and they simply see humans as cattle are seen by ranchers. They see them as possessions.

QUESTION:

Leon B. wrote me a letter recently. He wasn't asking a question, but the letter was interesting. He writes: "I imagine it is difficult enough for Awareness to put across the concept of UFOs that many people see, no less the etheric basis for them. What I am perceiving with clairvoyance--which by the way is not unique to myself, since I learned to use my brow chakra by trial and error--is in the etheric levels where these aliens function. It ties in with Steiner's Ahriman and Lucifer. It also ties in with Reich and Trevor Constable's *Cosmic Pulse of Life*."

One of the factors I have found in numerous books is reference to Snake People. Throughout the world, whenever a benevolent spiritual leader arises, the Snake People follow in the intervening centuries and destroy all of the good works promulgated by these leaders. Pythagoras, Socrates, Apollonius of Tyana, Jesus Christ of course, Guatama Buddha, etc. Even Reich was destroyed in very unusual circumstances. Add Tesla. At this period of time the world conspiracy is an outgrowth of the Snake People. The burning of the library at Alexandria. The death of Alexander. The erasure of knowledge from the appurtenances of Egypt. This is a pattern dating back to Sitchin's work.

These Snake People are what I perceive in the etheric levels.

The psychic attacks on Paul and yourself is based on these beings. And that is my greatest concern. People who follow CAC are subject to these psychic attacks. It requires an extraordinary perception and knowledge to protect oneself. Plus a strength of character and purpose, which is much diluted in most people. Especially those who are involved with ordinary pursuits and lifestyle.

However, life is above all a learning process. It is what we live and exist for."

Does Awareness see most of that information about the Snake People as being accurate?

COSMIC AWARENESS:

This Awareness indicates that this is not seen as being a proper interpretation. It may be correct in the sense of this entity's symbolism and perception in accordance with the symbolic interpretation of his perception, in the sense that he may perceive certain energies as being related to what he terms Snake People. This Awareness indicates that *It* wishes to clarify this in a different way; that the entity's perception of Snake People following and destroying the works of others who have done good, is not based on anything of substance.

This Awareness indicates that *It* sees rather that there are two basic classes of ancients in terms of symbologies involved. There are those who were the founders: these were deities, and these early deities could take on any form desired. This Awareness indicates that there were those who took on forms of power and that power allowed in the ancient times, often expressed itself in the form of what became the more acceptable standard, that of the Reptoid. It was the dragon, and the Reptoid.

Some species of this became that which was the serpent, such as the sea serpent, and gradually this evolved into other forms, less scaly and relates to those entities from Sirius. This Awareness indicates of course there are further energies in other directions. *It* is speaking strictly in

terms of earth history. These were two of the major influences on earth's history in terms of your *Book of Genesis* and other Biblical references which were taken from earlier writings from Sumer, Acadia, and Babylonia, and the Serpent People, or those who were called the Serpent People, and the Bird Men, or those who were called the Bird Men, were basically much the same types, but the entity Enki, or the one representing Sirius, altered the genetic creation of Enlil to create that which had more genetic qualities to include the mammal, thus, this became the homo sapien. This has been discussed previously. This Awareness indicates that in this sense, the Sirius people have been the benefactors of humanity, and yet they are the ones who are known as the Serpent Race, and many have said that Jesus was of the Serpent race, and that other great teachers and leaders were of the Serpent race. This Awareness indicates that this refers to past lives that reach back into Sirius. This Awareness indicates that to say that Snake People follow and destroy may be a confusion or may cause a confusion. It is the Reptoid people that tend to follow and destroy things that were created by Enki of Sirius.

Many Draconians Now In Human Bodies Walk Among Us

This Awareness indicates that the Reptoid people do not necessarily appear as Reptoids when they reincarnate as human beings. They are simply humans in appearance, from human parents, but they have within their soul and background Reptoid genes and memory and are essentially from Draco in their origins, and there are many on this earth who are Draconian in nature and their purpose is to gain power and destroy anything that preaches or attempts to establish a great harmony on earth.

This Awareness indicates that these may be seen as related to the Hindu god Kali, the Destroyer. This Awareness indicates that it should be recognized that the Draconian factor as that which is the more destructive and the so-called Serpent or Sirius factor as that which has been attempting to create greater harmony on the earth. This Awareness indicates the Pleiadians as being distant cousins of humans, and they also being benefactors.

DID A CAMERA CAPTURE A DISAPPEARING ALIEN ?

QUESTION:

A. P. in Philadelphia, asks: "In the attached photo, the back of the man's head is missing. Is he becoming invisible? Is he an alien vibrating at a different frequency?" And she sent in what looks like a page from a very slick financial magazine, possibly *U.S. News and World Report*, with a full color photo reproduced of a couple standing in front of Macy's in New York City, and the story is about Robert Campbell who bought out Macy's, I believe. And it does show, everything is correct except, if you look carefully, you can see the top of the head and part of the left ear disappearing in the photograph and you can see the building on the other side of the street through that part of the entity. It doesn't seem to be a mechanical error.

COSMIC AWARENESS:

This Awareness indicates that this appears to be a situation in which the frequency and vibration of this entity is altering to such a degree as to allow a change in the molecular substance so that in fact, the vision can penetrate the entity's head. It appears in fact that one looking at such an entity would not see this, but the camera itself is able to focus right through the entity's head and film the wall behind.

This Awareness indicates it appears this entity is one of those referred to as an alien. This Awareness indicates it is of the type described earlier, in an earlier tabloid, wherein pictures were taken at an airport and many of those in the airport exhibited holes around them, the camera being used as that which could discern radio-activity. This Awareness indicates that it appears that it is one of this type of aliens.*

There are those who can take on human form and move about unnoticed in the streets or in public places, looking like humans and who can then at another time, another place, revert to their own true form. This is in reference to Greys who are masquerading as humans. This Awareness suggests that this is very rare, and *It* does not wish to create paranoia, wherein entities see someone and then begin to worry that the entity is a Grey disguised as a human. This could very easily become a problem for entities who are easily influenced or who have paranoia tendencies.

This Awareness suggests that such entities should simply forget what this Awareness just said rather than energize such information as to create that kind of paranoia, for it is extremely rare. This Awareness indicates however, you will probably have a few examples or may receive some letters from entities who believe they were followed by a Grey because of this message.


SECRET OF INVISIBILITY REVEALED IN 1934 ISSUE OF 'POPULAR MECHANICS'

She writes: "How was a man in a booth made invisible in 1934 as shown on page 645 of the May, 1934, *Popular Mechanics* magazine?" She sent in a copy of the article and it has 5 photographs that does show a man becoming invisible. He's standing in this box with a weird contraption over his head, like some kind of a diver's helmet.

The article reads in part: "After years of research, a young British inventor claims to have produced an apparatus which can render a man invisible, although he still stands before you in the flesh. Operation of the device which is being used for exhibition purposes is a closely guarded secret, but the man who is to disappear is clothed in what was described as an electro-helmet, and spectral mantle.

In this garb he looks like a deep sea diver, as he stands in a cabinet, open at the front, on a brilliantly lighted stage. With both hands he touches contact gloves above his head and an electrical current is switched on.


Audrey believes that since this was many many years ago, the secret could probably be revealed because there's been no other information given on this man since.

CLOSING MESSAGE:

This Awareness indicates that there are many things on this plane, on this earth that will never be understood by everyone; that often a mind of an entity will spend a lifetime learning something that allows the entity to pursue a narrow and very specialized field of study, becoming an expert in that field, and attempting to learn and to create and develop things in his field. There will be others whose interests go in other directions, and in their pursuit of interest they may have a curiosity at some point in asking: "How did he do that?," pointing to the one who has spend much of his lifetime in his particular field.

In some cases there will be many minds working to develop a particular field of knowledge which can result in some creation. This Awareness indicates that if in the past 50 years entities had worked on the television set in absolute secrecy and no one had ever seen a television set, and someone were to bring one out today, and someone were to see that television set functioning and report it to others, others would say: "That's impossible! I won't believe it until I see it myself! There is no way they can create my face or the President's face on a screen three thousand miles away, and have the President speaking in his own voice!" It would be absolutely impossible in the minds of many, if they had not seen it for themselves.

This Awareness indicates it is also possible that an entity would believe it and ask: "How did they do that?" This Awareness indicates that it is not an easy thing to explain, even when there are billions of television sets around the world, as to how they do it. It is not easy to explain to those whose minds have not studied electronics to understand the nature of television sets and the principles involved. This Awareness indicates that if there were invisibility booths around the nation, as common as phone booths, where people could walk in and become invisible and walk about, remaining invisible until they walked in again, people would gradually take them for granted, and see this as part of society.

They would not necessarily care to know how it is done. It would be enough to know that in fact it was possible. This Awareness indicates that most entities don't know how their automobile works. Most don't know how their telephone works. It is extremely difficult to explain even the common things to such entities. This Awareness indicates that in understanding this difficulty in explaining even the common things, do not be too disappointed that you cannot understand those things which are extremely uncommon.

THAT BOOK: "EMBRACED BY THE LIGHT"

-WHY DID AUTHOR RENOUNCE REINCARNATION?

QUESTION:

Another question from F.K. in Indiana . Awareness has briefly touched on this, but he has a specific question about it. He asks: "What does Awareness have to say about the accuracy of Betty Edie's best-selling book *Embraced by the Light?*, on Betty Edie's near-death experience, specifically: why does she claim to have been shown that reincarnation does not occur?"

COSMIC AWARENESS:

This Awareness indicates that much of this entity's experience was based on her own belief system, and on attempting to please a certain audience for her book. This entity sought not only to capture what may be termed the metaphysical audience, but also the Christian audience, and for her to denounce reincarnation, fit in her Christian leanings for the belief in reincarnation was hostile to Christian teachings.

The entity was not aware that there are Biblical passages, including statements by the entity known as Jesus that indicated this entity also believed in reincarnation. Had she understood this, she might have felt compelled to put in such a statement in her book denouncing reincarnation.

This Awareness indicates that the entity's material has value for many in the Christian religion. They will find it interesting and somewhat enlightening. Not all will accept it. Some will consider it as being alien to their beliefs. This Awareness indicates that many entities in the metaphysical field will find it very interesting, even if they do not agree with the renunciation of reincarnation.

Some entities will wonder about this, and others may even believe she is correct, however, this Awareness indicates much of her information is simply inspired by her own belief and by the way she perceived her near-death experience. To have a near-death experience and to write about it does not necessarily mean that everything she perceived is absolutely correct. Even if you believe most of what she says is true, she may be in error in her perception of certain experiences.

This Awareness indicates there are other entities who might have near-death experiences and write about them, and realize that had they moved on into the death experience, they might surely have reincarnated.¹⁰

This Awareness indicates that you cannot take one writer's perception of reality as being the absolute truth for everyone, for some entities may not see everything clearly, particularly if their personal beliefs blind them to certain realities.

MARY MAGDALENE: WHAT WAS HER REAL RELATIONSHIP WITH JESUS ?

QUESTION:

A question from J.W., Danville, New Jersey. She writes: "Recently there was a TV presentation about Mary Magdalene, the so-called prostitute in the New Testament. It was stated in this TV program that Mary Magdalene was not always considered thus, but only since the reign of pope Gregory. From that time on she was considered to have been a repentant evil woman. Would Awareness tell us just what *was* her real relationship with Jesus the Christ? Early writings referred to her as Jesus' "companion"; and what was she repenting for?", she adds.

COSMIC AWARENESS:

This Awareness indicates that this was an entity, a member of the tribe of Benjamin, and the tribe of Benjamin was a tribe much closer to the teachings that Jesus espoused, and in many ways carried the brunt of hostilities from other tribes. This entity was a companion of Jesus. She is one who is written of in the book *The Holy Family*, the book *Holy Blood, Holy Grail*. This entity is the companion who went with Jesus into the North, through France and into Brittany.

This Awareness indicates that Joseph of Aramathea as another in the tribe of Benjamin and this entity helped these companions. This Awareness indicates there was a wedding of Jesus and Mary at his home and many entities were disturbed by this, thinking that he should not marry. This Awareness indicates that it appears there was some confrontation between this entity Mary and another at that wedding ceremony which created a kind of rift among some of the followers of Jesus which has led to many stories slanderous to Mary of the Benjamin tribe.

This Awareness indicates that entities may find further information on this subject in the *Holy Blood, Holy Grail* if inclined to search. This Awareness indicates that the official Roman church did not want people to know of this relationship and also wanted the story of the entity Jesus to follow the script written by Piso in which

the entity was crucified and resurrected, and then going to heaven, rather than going elsewhere and getting married or having a further life.

The entity was scripted to die at 33. The symbolism being that of a 33rd degree Mason, and thus dying, being resurrected as in all of the other stories of other cultures of their crucified saviors, and to have one of their prototype beings, one of the prototypes used in the story written by Piso in the New Testament story to get married and go somewhere and have books written about him after he is supposedly dead and ascended into heaven; to have stories of his going elsewhere, floating around; this was offensive to the church.

This Awareness indicates it was only because of the Templars that the story of this entity's continuance was maintained down through the years. It was essentially related to the protection of the Holy Family that concerned the Templars and their movement into Brittany, into England, and their association with Druids that allowed this story to remain alive, in spite of the church's desire to have it destroyed.

This Awareness indicates there are still considerable efforts by the church to prevent such books as *Holy Blood, Holy Grail* from being written. This Awareness indicates there is in fact one book that warns people not to write of these things on fear of their life. This Awareness indicates that the Interpreter *does* have a copy of this book which was loaned to him. The book title is not seen clearly at this time, but the Interpreter can provide this information on request.

DID JESUS AND MARY HAVE A FAMILY ?

FOLLOW-UP QUESTION:

In that book *Holy Blood, Holy Grail*, the researchers suggest that when Jesus and the Magdalene went to France, that they had a number of children and that to this day their bloodline is present and that this has much to do with the Holy Grail and the Knights Templar, who supposedly protected it; that they were in on this and that they protected the family and this bloodline down through the ages. Does Awareness see this as being basically valid?

COSMIC AWARENESS:

This is in the affirmative. There was a problem that occurred, however, in that these entities were originally in an agreement to meet, it appears every 50 years, and the times and places for their meeting were understood in advance

from one meeting to another. They knew where to be for the next meeting 53 years later, and either they or their descendants would show up.

The problem came about when the church changed the calendar and when the Georgian calendar was introduced, or other changes made to the calendar, it threw off the meeting places and the timing, and the entities would appear and no one would be there, or the entities would have already have come and gone before others had arrived.

This Awareness indicates therefore, the meetings were no longer timed properly and the whole plan or program began to lose its momentum and cohesion and many of these entities fell apart and forgot much of what they were all about in terms of their ancestry and their purposes in keeping the bloodline together.

Eventually, many of these entities totally lost track of the story and have no idea at all as to any bloodline connection they may have with others.

Templars Hid Gold on Oak Island

This Awareness indicates that the Templars also moved gold to be used and to protect this family and its bloodline; that Okido, or Oak Island spot in Newfoundland was such a place wherein the gold was stored. There were other places also, some in Canada, some in France. There was an entity, Eberre (sp) who was a strong entity protecting the family and holding it together. There were certain other priests of the Catholic church who worked with these entities to help protect their movements in Canada and down into the United States.

IS IT POSSIBLE THE GREYS COME FROM THE FUTURE? (Movie "Official Denial" Suggests This is True)

QUESTION:

A question from J.S. in Seattle. He writes: "I watched a movie recently called *Official Denial*, which was about a Grey alien captured by the military. It wasn't a documentary, but a story dramatizing the UFO/abductee scenario Awareness has sketched in over the last decade. In fact, the movie had quite a lot of parallels. The secret MJ organization whose motto was 'Official Denial'. The Greys were depicted as described and even revealed they were a dying race, seeking answers through abducting and experimenting on humans. But the interesting revelation at the end of the movie was that the Greys did not come from outer space, but were in fact from earth in the future. They came back through time to try to change their history, since they had evolved technologically to the point of laying waste to their world and to themselves. It was quite a twist and departure from the Awareness material, and the commonly accepted notion of the Greys, which made a powerful statement at the end of the film, and filled in the missing pieces of the plot-line. I wonder, however, since the film, more or less, was faithful to the established picture of the Greys, as Awareness and others have spoken and written on, could there possibly be any truth to this notion, that the Greys are from the future and are in fact what humans eventually evolve into?"

COSMIC AWARENESS:

This Awareness indicates the imagination is capable of many interesting scenarios. This Awareness indicates that you could take this a step further and ask if the Greys living upon Orion, who have moved through space on earth, might not also be from the future, and the records of their having lived in ancient times on Orion and in past history on the earth simply be caused by their having moved back from the future, further than present time.

Thus, the Greys who are said to be from Mars, at the time the base on Mars was created, which are the tall Greys that originate from Orion, may also have thousands of years ago been from our future, having traveled back into thousands of years prior to present time, to form a civilization on Mars. There are many ways that entities can create scenarios when the imagination is free to roam at will.

This Awareness indicates that you yourself might be from the future, coming back to try to change the human race, or you may see yourself as actually from the past, a Neanderthal, or earlier being who has projected into the future, which is our present time. This Awareness indicates how far do you want to follow such thoughts? None of it is provable, nor can it be denied. Is it possible that all time is now? And even the future is part of now?

This Awareness indicates if the Now includes the future, then the future *is* Now. If the Now includes the past, then the past is now. Perhaps time doesn't exist and everything *is*; now and future, now and past are nothing and only What *is*. Does that wipe out the future and the past? Or does it wipe out the present? These are terms, these are words. If you strip away all words, what does that do to the future and the past? Does it put it into an ever-present Now?

Montauk Projects and the Philadelphia Experiment

This Awareness indicates the story described appears to be a very fascinating story; something that would be of great interest to most entities who have a good imagination. This Awareness cannot deny the potential reality of this story, because it could be, if you accept the premise of the future containing the Now, or the past, and who is to say that things of the future cannot come back to the present, or that things of the present cannot project to the future, for the experiments of Bielek in the Montauk Projects are indications of entities doing just that: going forward and back in time.

This Awareness indicates that this essentially is connected to that story of the Philadelphia Experiment. If it can be done in this situation, or with the Montauk Project, can it not also happen on a larger scale, a greater scale? Who knows, but some day entities will be able to pay a fee, get on a tramway, move into a time capsule and go back and vacation in the Middle East at the time of the beginning of the Christian Age, or even further

12. back to a time where the pyramids were being built.

This Awareness indicates that it is simply a matter of new technology and new understanding of physics, coming into a new type of science. This Awareness indicates that when the science reaches a state of recognizing all matter comes out of consciousness and consciousness permeates the entire creation and makes the creation what it is, and that consciousness can be moved by vibration so that individuals, in their consciousness, can attune to other frequencies of other consciousness; when entities begin to build a science and research in that field, and years and centuries of research in that area are conducted, who knows but what time travel will become a very commonplace activity?

This Awareness indicates that if that is possible for humankind today as part of their future, is it not also conceivable that there are already beings who are evolved to that point, who have that understanding and technology, who are able to travel forward and back in time and in space, simply by vibrational physics, the physics of attunement to vibrations of places and times?

WILL MAN STILL LOOK THE SAME AS HE EVOLVES THROUGH TIME ? (Will We All Have Pumpkin Heads?)

QUESTION:

Does Awareness see the evolution of humans as they more or less appear today in the physical form; does *It* see way down the road in the future as they evolve; will they evolve into some other, what we might consider today strange-looking species, like the Greys or something, or will they maintain their basic human characteristics?

I've seen pictures, for example, that scientists predict that just in a few hundred years man will look like a pumpkin-headed entity because of his increasing brain development.

COSMIC AWARENESS:

This Awareness indicates that there is a common quality in living beings that where there is stress, energies, vitalities go those areas of stress and cause a formation in the area to build or grow. If you take a muscle and cause it to experience repeated stress, after a time that muscle becomes bigger. If you put pressure and stress on a bone, that bone will develop more calcium and grow stronger where the stress is to compensate for the strain.

Thus, if the brain of a human grows greater in size, it may tend to put pressure on the skull to open up, to become more loose in its platelets and where those bones of the skull come together which are being pressed apart from as growing brain, more calcium, may form to parts of the bones so that the head actually grows slightly larger over a lifetime, filling in some of the openings that have been caused by the pressure of the brain growing inside the skull.


This Awareness indicates it is conceivable that after centuries of brain growth, that the head could become slightly larger than at present time. This Awareness indicates, however, if you look back in history, some of the more crude humanoid forms had very large heads. Did the shrinking size of the Neanderthal head mean that humans were becoming more ignorant, and had lower IQ? It does not appear to be the case.

If these entities had large heads, were they more intelligent than the entities today whose heads are smaller than the Neanderthal head? This Awareness indicates of course, you cannot ignore that there are Neanderthals with large heads and Neanderthals with small heads, modern day people with large heads, modern day people with small heads, but this Awareness is referring to the average sized head, the hypothetically average sized head.

Is it actually increasing in size with the increase in intelligence? This Awareness indicates that it appears the size of the brain is not necessarily the measure of intelligence, and therefore, it may not be that intelligence increase in mankind actually causes the brain to increase in size or causes the skull to grow in size.

This Awareness indicates that there may be other reasons why the skull grows larger or smaller. It may be that there is some kind of effect from the atmosphere or from the food or from the moisture or radiation that causes some heads to become large or others to be smaller in different times of one's evolution.

This Awareness indicates that as far as looking at the future, this Awareness indicates that the human body is more likely to be altered through genetic influences than just environmental influences, however it should be understood that environment can have an effect on genetics also. To that degree the environment may genetically affect humans to give them a change in appearance over long periods of time, not just centuries, but millennia.

This Awareness indicates that the person who lived 100 or 200 years ago had an environment in which hard work was common. There were few machines and hard work was necessary to produce shelter, to build, to cut timber and to refine the timber into building supplies, or to make furniture. All of these things were physically demanding. Now entities can sit at a desk and earn money to build houses or to make furniture. Does the new environment alter the shape of the human body from that which was prevalent 100 years ago in the acquisition of a home and furniture?

It would appear that indeed it *does*, for the entity who worked hard had considerable need for strength and muscles and probably had stronger bones from the work because there was more stress put on the bones and skeletal structure, if one were involved in lifting heavy loads or doing heavy work than is common for the entity who works at a desk.

This Awareness indicates that some entities working at desks will work out in some exercise shop, but many just relax and take life easy in a physical sense, while keeping their brain and productivity active in a way that does not require great physical stress.

This Awareness indicates, however, where the strength of the body in the past was built largely through exercise, there is a new kind of diet and supplements that can help offset a loss of body strength in present time. When entities eat better and eat foods that help keep their strength and their muscular and skeletal frames stronger, so that where a compensation of dietary benefits helps to offset the hard work of the past, the body doesn't change that much.

Some entities can work at desks throughout their lifetime, never doing great physical labor and

still may retain a relatively good shape and frame, and their muscles remain relatively strong, even without all the exercise of their ancestors.

In fact, some of the ancestors may have had great problems from the excessive hard work. Their backs may have been weakened, their bones may have been hardened so that even with all of the exercise that many would think should have been good for them, they may have had broken bodies by the time they were middle-aged.

This Awareness indicates in other words, there are ways whereby certain obvious benefits may not be practically correct, and may not be beneficial, and there are ways wherein what would obviously be a type of growing weakness might not develop into a weakness at all.

If scientists were looking at mankind in the future, seeing him becoming physically lazy and mentally strong, they would project the idea of a depleted body and a growing head, but this is mere presumption. It is not based on full reality, because the head may not grow strong or big like a muscle just because someone thinks more clearly or has to think more often, or must work more difficult projects and problems on a mental level, nor does it mean that the body will shrivel up just because the entity does most of his work at a desk.

This Awareness indicates that humankind will not change that much, except if genetic engineering or other substances such as pharmaceutical drugs or genetic substances that affect the genes are introduced into human consumption. Then there could be some major changes that occur.

This Awareness indicates that the most likely change in human form will be through genetic use and technology. There will be people who seek this out, and there will be a science that finds genetic benefits for humans, helping them to develop more grace and beauty, helping them to genetically become stronger in terms of their physical shape, in terms of their muscular development.

It is possible that a great market for genetic improvements will become very common in 50 years, so that a young person can be given proper genes to make the entity grow into a strong handsome more youthful person. It is possible that these products of genetic engineering will develop an entity to look just like the ideal person he or she would want to look like, whereby the person

14. could even select the color of hair, the color of eyes for his or her children.

This Awareness indicates that because of the study, the research into the genome projects, searching out the genetic codes for diseases and human qualities, there will be a science that evolves from this which will help humans to make considerably important and striking changes in their appearance, in their health, in their genetic qualities, and indeed, in the appearance of the individuals who partake of this new science.

This Awareness indicates that this of course assumes that when entities have moved through the photon belt or into the next dimension, that the need for this science continues and that the individuals involved will still be dedicated in keeping the science going. Otherwise, perhaps entities can, in the 4th dimension, simply change their shapes with their mind, and not need genetics and the genetic engineering field might just shrivel up as an activity or science that is outdated.

This Awareness indicates if you are in the 4th dimension, where everything is built not on material reality, but on imagination, you may simply be able to create your image with your own imagination. You may simply become what you want to see, or it may become what you *fear* to see if you are plugged into the negative attitude.

THOSE METAL DISKS FOUND UNDER CROP CIRCLES: WILL ALIEN TRACKING SYSTEMS BE DISRUPTED?

QUESTION:

A question from B.B., Honeydew, California. "In regard to the three metallic disks found buried inside of the crop circles formation in Germany, does removal of the disks from the formation disrupt or neutralize the alien tracking of guidance systems?"

COSMIC AWARENESS:

This Awareness indicates that this would depend on whether the tracking or guidance system used the metal disk as part of the guidance or if this guidance system made use of geometric shapes and figures. This Awareness indicates it appears in this particular instance that the ships had a dual purpose: The one purpose was to be part of the guidance system, with the second purpose being that if discovered, if found, they would serve as a message to humanity, that this was the work of extraterrestrial visitors.

In other words, they could have used metallic objects that were not shaped like UFOs, and if such objects were found, it would not carry a message or image of extraterrestrials, but by using the UFO-shaped disks, the message would be clear to any finder of these objects that these were miniature UFOs and essentially likened unto pictographs as a kind of signature on the crop circle.

In other words, if an entity creates a crop circle as a kind of artist and leaves the UFO buried there somewhere, it implies that the UFO was the author of the crop circle. It is a kind of humor

WHAT PERCENTAGE OF CROP CIRCLES ARE FAKES?

FOLLOW-UP QUESTION:

Awareness, I saw a documentary recently on TV of current crop circles created last year and some earlier this year. Some of these are incredibly beautiful, but included in this was some skeptical looking illustrations and also an immense bicycle, which I'm pretty sure was a fake, but it looked pretty genuine and it extended across the field. Also, one of our members, an artist, is doing very realistic crop circles of his own imagination on very realistic looking fields and selling these paintings. And I was wondering if Awareness could give us a rough estimate on these crop circles that are coming out recently as to what percentage are fakes and what percentage are real?

COSMIC AWARENESS:

This Awareness indicates that approximately 20% are fakes; that this fakery is growing faster and therefore, the percentage is likely to change next year. This Awareness indicates that it was only a few years ago that the first fakes began to appear; now it is becoming more of a fad, entities getting caught up in this, wanting to go out and put their mark on life.

This Awareness indicates the fakery is much like the child who enters an environment and wants to knock something off, pick something up and place it somewhere else. All of this action of the child moving things around, messing with other's property, is really just a way of making his mark, in the same manner that a dog or a cat may make his mark on a territory.

This Awareness indicates it is likened unto a child saying, "I am here! Look what I can do! I can do this! I can do that!" The child simply

15. thinks, "This is a new world, a new place for me. I'd like to affect it so that it shows I was here!" The child may not think that consciously, but subconsciously that is what he or she is acting out when messing up an environment.

This Awareness indicates that it is the same mentality that happens when entities seek to create crop circles mimicking others that have been created from extraterrestrial sources. It is like the entity saying, "Oh! These extraterrestrials can create crop circles that awe everybody. I wonder if I could create something like that, that will awe everybody?"

They are not thinking so much in terms of the importance of a genuine crop circle, they are thinking more in terms of the artistic requirements that are involved in making the crop circle and they see themselves as facing an artistic challenge: "Look what I can do!"

CROP CIRCLES NOW APPEARING IN SNOW AND ICE: ARE THESE REAL OR FAKES?

FOLLOW-UP QUESTION:

I've seen some serious reports somewhere, maybe a UFO magazine, that these designs are now appearing in such places as on the ice and frozen lakes in wintertime, in various snow fields, and in the ice in the Arctic. Is that basically true, or are most of these fake?

COSMIC AWARENESS:

These are correct. This is true. There are many extraterrestrials using these crop circles as a form of communication with humans, and wishing to make it clear that they can do this in places that are not limited to hay or wheatfields.

This Awareness indicates if all of these crop circles could be photographed and studied, especially considering where they were taken and also when, researchers might begin to recognize a message in them and learn the language contained in the shapes and features.

This Awareness indicates that psychologists can look at art and look at geometric designs and tell about the author, much in the same way that handwriting can be analyzed to tell about an entity. For example, triangles indicate a person who is very cerebral and thoughtful. Circles indicate an entity who is very sensuous. Squares indicate an entity who is very secure-minded, wanting things to be made secure.

This Awareness indicates that if these principles used by psychologists in analyzing

people were to be applied to the crop circles, you could tell certain psychological characteristics of the artists, the extraterrestrial, from the drawing or design of the crop circle, and it could become a way of establishing some kind of communication with these entities, or at least of reading some of their intentions and purposes in providing these designs for humans to observe.

This Awareness indicates also, in the nature of designs, those things which are above the middle generally equate to abstract or philosophical or higher mental concepts and those below the middle tend to equate to materialistic or down to earth physical concepts. Thus, a design that is based on a heavy foundation would indicate a solid placement at the bottom where the foundation is drawn.

You could tell that as being the bottom because the foundation appears stronger than the other part and you can see these other parts as being more of the abstract, and therefore, using placement of the designs in a crop circle or picture as also being part of the evaluation or reading of the crop circle design.

Thus, the shapes and the placements can both be beneficial in helping entities to evaluate the meaning of the design. This Awareness indicates that direction may also play a part. All of these possibilities can be explored in trying to learn how to read the meanings of these crop circles.

A question from L.K. in Indiana. He writes: "If prophecies about the various tragic conditions in the world before Christ returns were not in the Bible, would there be any fewer problems in the world today? Once people are convinced something is inevitable, they stop trying to prevent it and more easily accept declining standards and less civilized behavior," he adds.

COSMIC AWARENESS:

This Awareness indicates that this is true, although there is no reason why entities should accept negativities and not try to improve on things. The only reason would be that a belief that it is inevitable would cause them to feel "What's the point in trying to help? What's the point in trying to do anything? This is prophesied Biblically and is inevitable. Therefore, why should I worry or give my energy in trying to help?"

This Awareness indicates that this is a common attitude that many strong believers have, voicing, for example: "Why worry about the environment? It's all coming to an end anyway, so I might as well have my fun and use what I want in terms of cutting timbers and getting a piece of everything before it all goes down the tubes. Everyone knows it is coming to an end!"

This Awareness indicates this is an attitude that many entities have, and it is generated largely by the belief in the prophecies of the End Times. This Awareness indicates that in reality, the end of the world is not so much the concern, it's the end of an age, and the end of the third dimension, and some of the corruption that entities need to consider.

UNUSUAL CASE OF BLACK MAN SUING IRS
(Could Open Door to End Income Tax in U.S.)

OPENING MESSAGE:

April, 21, 1995

This Awareness wishes to call attention to the Spotlight of April 12th. In this issue there is an article relating to a black man who is suing the IRS, claiming that he is not required to file taxes and requesting or directing the IRS to prove otherwise. This Awareness indicates the importance of this is that if the entity wins his case, it will effect all black entities in the United States who are classed as citizens and tax-payers.

This Awareness indicates his argument is that his ancestors came to the United States as slaves and eventually were freed as slaves and made citizens. His argument is that nowhere in his research has he found any indication that his ancestors chose to be citizens or agreed to become citizens of the United States, and therefore could not legally have had citizenship imposed upon them without such agreement.

This Awareness indicates that he sees the event as being one in which as slaves they were freed without their consent and made citizens without their consent, all being done by white people. The question is: If they are not citizens, why must they pay taxes to the country? And therefore, his suit is asking the IRS to show any documentation that makes him a citizen with his consent, or that they cease in their efforts to tax him.

This Awareness indicates that this is a case which entities may wish to watch as it progresses. This Awareness indicates, of course, if these 70 million blacks in the United States are freed from paying taxes, it is going to result in further tax revolts by whites. It is for this reason and many others that there is a growing interest in eliminating the IRS and imposing some other kind of taxation.

The Constitution originally allowed an excise tax which was simply a tax on the movement of products, every time they changed hands. In the early days, prior to the income tax, the change from the retailer to the customer was not taxed, but taxes had been added to the product from the farmer or manufacturer all the way to the retailer and this was authorized by the Constitution.

There are some who want to go back to that kind of taxation, but who would also add further, the customer paying tax on the product when it is bought from the retailer.

This Awareness indicates that this would increase the cost of the product, much as the same way that a national sales tax would affect a product.

Of course, this kind of tax hits the poor person harder than the wealthy because the wealthy doesn't spend all of his or her money for consumption, whereas most poor people have to spend most of what they get on consumption products, those things such as clothing, housing, and the products they need in order to survive. If they spend 100% of their earnings on consumption, that means they are being taxed on 100% of their income as they pay their sales tax, their consumption tax, whereas the wealthy person who only spends 10% of his or her earnings on consumption, will be paying tax on only that amount spent for consumption. This Awareness indicates the entity could use the other 90% for investments.

There are some possibilities the entity would use some of the other 90% for purchases of large expensive items such as real estate, and would need to pay tax on such, but it would be possible for the wealthy to avoid paying taxes on most of their money through that system.

This Awareness indicates at any rate, it is something that is being considered as a substitute for personal income tax and the IRS and its role in collecting on these taxes. This Awareness indicates that keeping an eye on this case may be of interest to some entities for its implications in the future.

WOULD A "FLAT TAX" BE ANY BETTER ?

FOLLOW-UP QUESTION:

If they *should* issue a flat tax or something similar that would eliminate the IRS, would this mean that the taxes raised from the citizens would no longer be funneled into the Federal Reserve and those 13 families that have controlled the money for so long?

COSMIC AWARENESS:

This Awareness indicates that this appears to be irrelevant to the concept. It would depend upon how or where the taxes go as to whether it would go to the Treasury or to the Federal Reserve. This would be a separate matter, depending on how it is set up.

This Awareness indicates that there are some who argue that a flat tax which is somewhat like the consumption tax, would hurt the average consumer more than the

wealthy person because the flat tax is somewhat different from the idea of a sales tax. The flat tax is essentially that wherein there is no gradation among tax payers. In other words, the poor pay the same percentage as the wealthy. The flat tax for example might be set at 17% and everyone would be charged 17% of their income and this 17% would come from the wealthy who earn millions of dollars per year, and 17% would be taken from the very poor who might earn only a few thousand dollars per year.

Thus, some think the flat tax is more fair because they do not get special tax write-offs on anything. It would simplify the tax returns, but this Awareness indicates that it is only considered fair by those who do not need credit for any areas that are normally considered write-offs.

There would be no write-off for charity donations, there would be no write-off for business losses, et cetera. This Awareness indicates that this is somewhat different from the idea of a consumption tax, even though there is some similarity also. A consumption tax of 17% would affect only that which is used for purchases for consuming or acquiring properties and goods and services.



Much more than mere gun control

Rock's firearms bill tramples freedoms for everyone, not just gun owners

In English common law the principle that anything not prohibited is permissible has existed since time out of mind, says Calgary lawyer Ronald Cantlie, an expert on jurisprudence—the study of the origins and philosophy of law. "Whatever you were up to was taken to be innocent unless you were known to be breaking the law."

The only period when this fundamental freedom was suspended, Mr. Cantlie explains, was from 1653 to 1658 after Oliver Cromwell had executed Charles I and ruled as Lord Protector. During those five years, agents of the state were free to enter private homes at any time to check for sinful as well as illegal behaviour. Attendance at church was mandatory and the joyful celebration of Christmas outlawed. Cromwell and his parliamentarians passed dozens of laws that overnight made criminals of ordinary citizens. "That period ought to serve warning that even when the best people start a revolution they never can guess where it will end," Mr. Cantlie says.

Now there are fears that a second Protectorate is on the horizon, this time in Canada. Mr. Cantlie and others are worried that Justice Minister Allan Rock's gun-control law, Bill C-68, which the Liberals forced through on second reading two weeks ago, will undermine at least four basic liberties that residents of common-law countries such as Canada have enjoyed for 800 years or more.

Legal experts and gun owners charge that among other things, the Firearms Act will allow police to search private homes without a warrant. It will suspend citizens' right to refuse to co-operate with police and may force them to incriminate themselves or face jail for failing to do so. It allows for the confiscation of private property by the state without compensation. And it creates a "reverse onus" on those accused of offences under several of its sections. In other words, it requires those charged to prove their innocence, rather than assuming they are innocent until proven guilty.

"The principles of justice and democracy are under attack," says Reform MP

Jay Hill (Prince George-Peace River). The police have never had such wide discretionary power, he says. "Now we're going to a police state with this bill. That doesn't scare people? It scares the hell out of me."

Until last month, most criticism of Bill C-68 had focused on two issues: the ineffectiveness of universal gun registration as a means of crime control and the high cost of registering Canada's six million to

But John Hardy, legal counsel for the group Saskatchewan Responsible Firearms Owners, says more and more people are now reading the bill, and have found that its provisions go well beyond establishing a national firearms registry.

"This bill gives police the broadest range of powers found in any Canadian legislation," he says. "[It] encroaches so much more on individual rights than any previous law that the whole concept of personal rights and liberties is endangered."

The contentious sections are 99 through 102, which cover "inspection." They empower police to enter businesses and homes without a warrant, for the purpose of insuring compliance with registration and storage laws. Section 99, for example, says "a police officer may at any reasonable time enter and inspect any place in which the police officer believes on reasonable grounds there is a firearm, [or] prohibited weapon..." It even allows for unwarranted searches of homes suspected of containing ammunition or any record of a gun or ammunition purchase.

It also authorizes police to "examine any firearm and examine any other thing that the officer finds and take samples of it," disposing of those samples "in any manner that he or she considers appropriate." Police do not have to return property seized, even if it turns out to be legal.

On first blush, the wording of section 100 seems innocuous. It says simply that citizens must "give the police officer all reasonable assistance to enable him or her to carry out the inspection...and provide the police officer with any information relevant to the enforcement of this Act." However, Mr. Hardy points out that this provision, in effect, removes the protection from unreasonable search and seizure that homes have traditionally enjoyed and that is guaranteed in the Canadian Charter of Rights and Freedoms.

Until C-68 passes, homeowners have the right to refuse to let police officers search their property until the police obtain a warrant. Before the search occurs, the homeowner may go to court, where a judge can decide whether it is reasonable. After C-68 becomes law, citi-

18 million handguns, shotguns and rifles. zens must first allow a search or face arrest. They may challenge it only after the fact.

Sections 100 and 102 have the combined effect of removing the common-law protection against self-incrimination. Section 102, which Mr. Hardy calls the "big stick" of the Firearms Act, reads: "every person who...does not comply with section 100 is guilty of an indictable offence and liable to imprisonment for a term not exceeding two years." Thus a homeowner who has not double-locked his shotgun as the law demands must lead the policeman at his door to the offending weapon, thereby incriminating himself.

Mr. Hardy concedes that section 101 states: "a police officer may not enter a dwelling-house except with the consent of the occupant or under a warrant." Yet it then says a police officer may apply to a judge for a warrant on the grounds "that entry to the dwelling-house has been refused."

"This law represents a complete erosion of individual privacy," Mr. Hardy continues. To be subject to inspection, a homeowner need not own guns; just be suspected of possessing documents pertaining to firearms registration or be guilty of refusing police entry without a warrant. "If this law is upheld by the courts it could become a precedent allowing agents of the state to 'inspect' for compliance in any number of areas," he says. "I could see social services, for instance, gaining the right to enter anybody's home to see how they are treating their children."

Christopher Manfredi, professor of political science at McGill University in Montreal and author of the book *Judicial Power and the Charter*, is concerned that Bill C-68 hastens Canada's drift toward collective security at the expense of individual liberty. "To infringe on individual rights in the name of a social good," he explains, "you have to be able to show compelling evidence that there will be benefits. Gun control does not meet that standard."

Furthermore, he scoffs at comparisons between registering guns and registering cars. "We don't register cars to reduce accidents," he says. But more importantly, ownership of an unregistered automobile is not a crime as long as the car is not driven on the streets. Mr. Rock's new law makes a criminal act out of possession of

an unregistered firearm. Moreover, he adds, criminalizing passive behaviour and ownership of property may mean Canada is sliding into despotism. "If the government can successfully trample on personal rights behind the smokescreens of gun

associate of" someone already prohibited from owning guns. "This is a direct assault on the Charter of Rights' protection of freedom of association. There seems to be an assumption on the part of the government that firearms owners are all unstable people just waiting for a chance to break the law."

What upsets Mr. Cantlie the most is that the freedoms threatened by C-68 are mostly hundreds of years old, and were often hard-won. Protection from unwarranted search and seizure, for example, was first codified in Magna Carta, the foundation for England's unwritten constitution and common law, in 1215.

The presumption of innocence, according to Mr. Cantlie, also goes back at least as far. "Prior to that time most questions of guilt were settled through trial by ordeal," he explains. "If you were suspected of a crime you would be thrown into a pond. If you floated, you were innocent." This, though, was a pre-Christian practice that the Fourth Lateran Council in 1215 forbade priests from endorsing, effectively ending it. At about this time it was established that a defendant should not be placed in prison until proven guilty.

The right to avoid self-incrimination was widely recognized by at least 1686. That year James II charged seven bishops with sedition. One of them is recorded as saying, "I never thought the day would come when I would claim the right to remain silent, but I'm claiming it now." This, asserts Mr. Cantlie, shows that the principle was already well established in common law. The idea that silence proved guilt died with the abolition of the Star Chamber trials in 1641.

Compensation for confiscation of property, another right undermined by Bill C-68, also has a long history. "Confiscation of property couldn't be done except for defence purposes," says Mr. Cantlie. "And there was always an obligation to pay for the property taken."

The origin of the right to refuse cooperation to the police is murkier. When most sheriffs were volunteers, judges expected citizens to help them. But this expectation was limited mostly to assisting with the arrest of suspects. As more and more police officers became full-time professionals, the right to refuse to go along with their investigations evolved, as did the obligation not to obstruct them, Mr. Cantlie says.

control and, presumably, crime control, this enhances the power of the government to do the same thing in other areas," he says. "Anyone concerned with personal liberty should be bothered by this law."

Returning to the common-law notion that anything not illegal is considered legal, Mr. Hardy adds that should the government get away with setting the dangerous precedents contained in C-68, "this could eventually allow the government, in the name of public safety, or environmental controls, or whatever, to criminalize everything in the country."

He points out that the legislation even amends the Criminal Code to give each provincial or local firearms officer the power to prohibit someone from owning guns because he "cohabits with, or is an

Just when the common law forbade courts from judging anyone guilty by association is also unclear. "Conspiracy and being an accessory to a crime have always themselves been crimes," says Mr. Cantlie. "But in ordinary times English law has never sought to implicate anyone not actually involved with the crime."

Reform party Leader Preston Manning shares gun owners' concerns that C-68 goes too far. "This point hasn't been stressed enough," he says. "Since it looks like the Liberals will ram this bill through, I hope one of the provinces will challenge it in court."

Jack Ramsay (Crowfoot), Reform's gun-control critic, is even more emphatic about the threat posed by Mr. Rock's law. "When this bill passes," he says, "our freedoms are gone."

However, Mr. Ramsay is convinced that gun owners take their rights seriously, and rather than give them up without a fight, will disobey what they believe to be an unjust law. "Mr. Rock is being absolutely unreasonable and irresponsible when he moves in this fashion to make criminals out of law-abiding citizens," he says. "If [the government] will seize guns, which in themselves are personal property, what will stop them in future from seizing anything they want?"

Mr. Ramsay also points out that the economic consequences of the government's anti-gun bill are starting to manifest themselves. "American hunters are promising to keep the millions of dollars they have previously spent annually on hunting trips to Canada at home," he reports. "They won't register their guns at the border because their constitution guarantees them the right to bear arms. They don't want Canadian bureaucrats sharing registration information with their American counterparts."

Predictably, Mr. Rock and his officials deny their bill constitutes a threat to Canadians' freedom. Jim Hayes, co-ordinator of the justice department's firearms control task group, says: "It's not our intention to let the police get out of control. Firearms officers need freedom to act in situations of imminent danger, such as domestic violence cases. But afterwards they will have to go before a judge to justify their actions."

Asked whether Bill C-68 represents a trend toward the criminalization of prop-

erty ownership, Mr. Hayes replies, "No, the legislation does not lead in that direction." He adds, "the minister has a different perception, and besides, every property owner in the country is already affected by the Criminal Code." He also insists most of the provisions of Bill C-68 were proposed by gun clubs worried about people taking out bogus memberships just so they could qualify to buy restricted weapons.

Reform MP Bob Mills (Red Deer) says Mr. Hayes's denials are dishonest. A federal justice department official told

him that "an unidentified enforcement agency would be sent from house to house if necessary to implement the gun registration system." And a senior federal bureaucrat, who insisted on remaining anonymous, explains that "the government does not use the terms 'search and seizure' but rather an 'inspection power.'" In this way federal officials hope to get around the Charter. "But what they are proposing is quite wide. They are going to have to clean up that part of the act or it won't pass constitutional muster."

"To say that the justice department consulted with gun clubs is baloney,"

says Jim Schille, co-chairman of the Saskatchewan Responsible Firearms Owners. "Mr. Rock came to Saskatchewan in 1994, but when he met with us he asked no questions and took no notes. Nor did anyone with him do so."

Mr. Schille reports that at the time Mr. Rock revealed himself to be ignorant of existing gun-control laws. "We told him that judges don't like to be constricted by mandatory sentencing laws so they routinely deal them away," says Mr. Schille. Mr. Rock denied that happened, but his

bureaucrats were later forced to admit it was true. "I can't believe a man who used to be a trial lawyer could know so little about basic criminal law," he says.

Paul Steckle is convinced Mr. Rock doesn't know much about politics, either. Mr. Steckle is one of the three Liberal MPs thrown off standing legislative committees because they voted against Bill C-68 on second reading. "Mr. Rock is not being sensitive to Canadians," he says. "Sure, people want safer streets, but they don't want their freedoms trampled on either. We didn't campaign on this at all. There was nothing in the Red Book about warrantless searches and seizures. There was nothing in there about criminalizing every gun owner in Canada. And there was nothing about confiscation."

Within 10 hours of his being exiled from his committees, Mr. Steckle says, "I had over 100 phone calls. They came from every province except Newfoundland. Every one of them supported the stand I took. It's a shame that so many voters remain unrepresented by their government."

It is difficult for Mr. Steckle to fathom why Mr. Rock is pushing so hard to pass a bill detested by such a huge block of committed voters. He thinks the minister's efforts will prove the first step toward a decline in the Liberals' unprecedented popularity. He also postulates that Mr. Rock may be captive to a registration-crazed bureaucracy.

Reformer Ramsay believes there is a third, more important, reason for the government's haste in putting C-68 into law: it is worried that if the legislation does not pass before summer, Liberal backbenchers will be persuaded to oppose it when they get back home.
