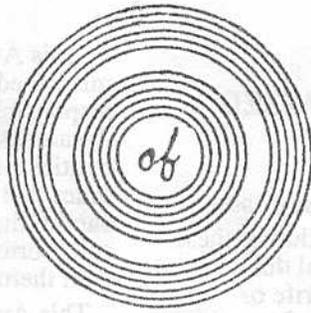

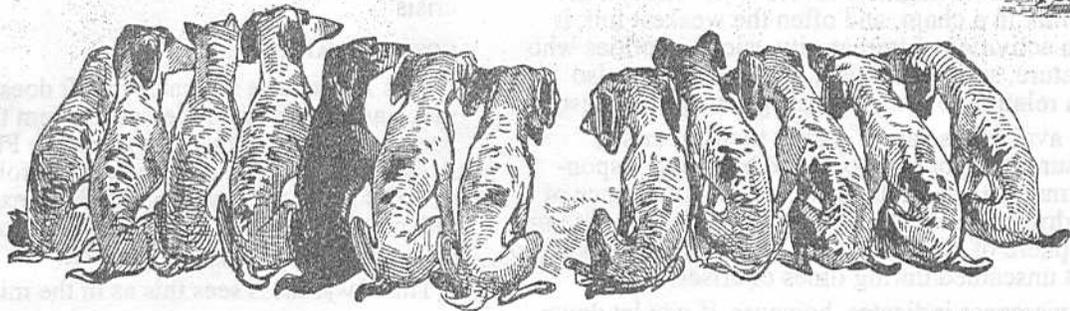
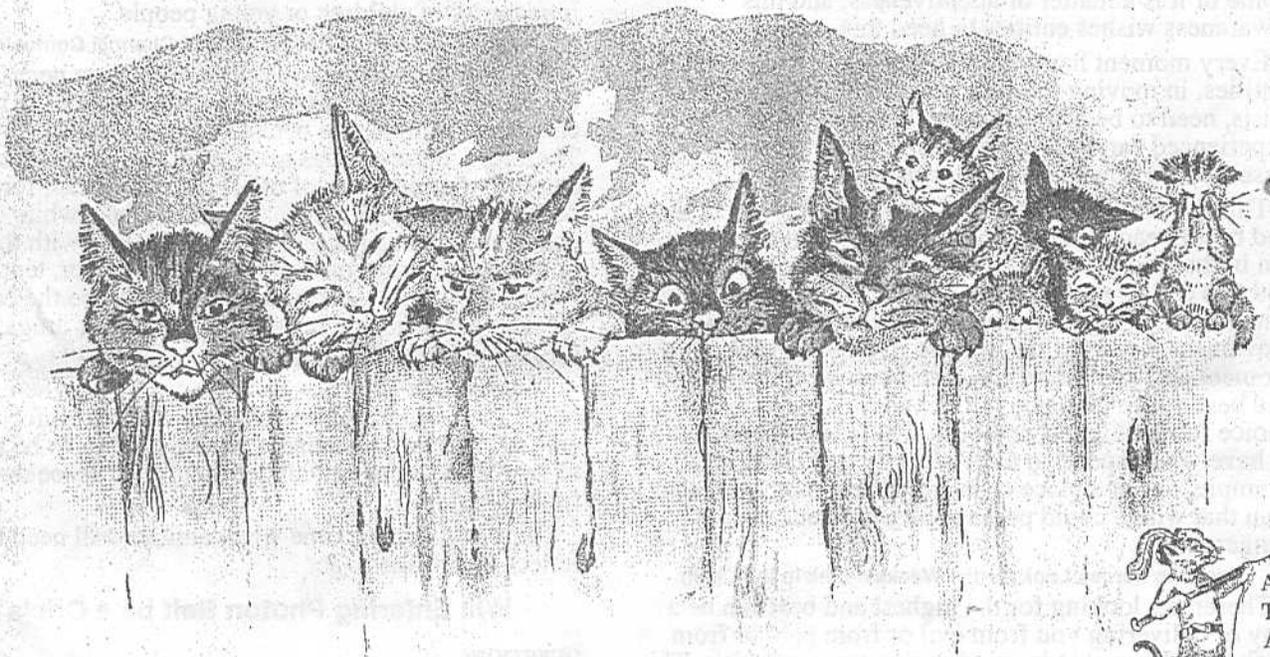

ANIMALS AS PETS AND WHY YOU CHOOSE THEM

HOW TO AVOID BEING VICTIMIZED IN THE COMING CRISIS

OPENING MESSAGE: (CAC General Reading, Sept. 6, 1995)

This Awareness wishes to advise entities during these coming months and during times of potential difficulties; that when there are intensities, stress, strife or danger in your life, it is extremely important for entities to behave in such a manner as to avoid the dangers and to assist their loved ones in avoiding such dangers.

This Awareness indicates that there are entities who can go through crises unscathed; others who are caught in a crisis become victimized by the crisis. This Awareness indicates it is not all simply a matter of luck. Some of it is a matter of attentiveness, and this Awareness wishes entities to heed this suggestion.

Every moment has within it certain choices or options. Entities, in moving through a moment during times of crisis, need to be aware that the moment being experienced can lead to something higher and better, or to something lower, more dangerous and worse.

This Awareness indicates if your eye is on the highest and best in each moment, you will likely pick a direction in that moment that leads to the highest and best, and this can be the luck that you need to get you through critical times. This Awareness indicates that if your movement is toward the highest and best in each moment and you act within that moment in the highest and best, it can lead you into another moment of another choice for the highest and best, which in turn may tend to have you respond in a certain way that leads you, for example, out of a place or in a different direction other than that which could perhaps be hazardous or dangerous.

Negative Forces Look for the Weakest Link in the Chain

Therefore, looking for the highest and best can be a way of delivering you from evil or from pain or from difficulty. Keep that in mind during times of crisis. This Awareness indicates also, another precaution: Recognize that the negative forces work through the weakest link in a chain, and often the weakest link is related to activities of immaturity, such as entities who are immature, selfish, childish or careless, and also activities relating to drugs or deception or dishonesty.

If you avoid those areas during times of crisis, making sure that young people are behaving responsibly, as much as possible, avoiding any allowance of alcohol, drugs or deception or confusion in your life or in your sphere of influence, you are much more likely to come out unscathed during times of crises.

This Awareness indicates, however, if you let down and try to celebrate or just have some fun during times of crisis, you are likely to find yourself in deep trouble. This Awareness indicates that these are the main areas that entities need to concern themselves with during times of crisis. Whether this time of crisis is a social crisis or financial crisis, or during times of war; whatever the crisis, this Awareness cautions you to avoid those areas that can cause confusion such as the areas associated with drugs, alcohol, mental and emotional confusion, and the areas of juvenile and immature behavior.

This Awareness indicates avoid also the areas of misplaced sex, wherein entities are not being totally responsible, for these can also lead to difficulties. This Awareness indicates that by watching these areas, entities can keep their lives in a kind of harmonious order that allows them to remain alert, attentive and careful during times of crisis in ways that others would call "fortunate", wherein entities will feel that luck is with them during times of crisis.

This Awareness indicates it is not "luck"; it is attentiveness, and fortune that follows attentiveness and responsibility. This Awareness indicates that if you wish to consider this more deeply, watch entities whose behavior touches into those areas of misbehavior, irresponsibility, deception, use of drugs, or of inappropriate sexual activities, the immaturity of emotional expression and that which is the uncontrolled immaturity of children or young people.

Children & Young People Tend to Channel Confusion

It is not that children or young people are necessarily the cause of immature behavior, but they tend to be channels for immature behavior and confusion. Therefore, these entities need to be watched more carefully during times of crisis than do adults, for most adults will recognize the nature of a crisis, while children or young people, or those dealing with the use of alcohol or drugs or irresponsible behavior, tend not to focus on the crisis, but rather seek to escape the crisis, by such irresponsible behavior or by use of drugs, alcohol or playfulness.

This Awareness indicates there are times when playfulness can become extremely dangerous for entities, and this Awareness wishes entities to be aware of how those areas can hinder their good sense during times of crisis.

There *will* come a time when entities will need to reflect on this message.

Will Entering Photon Belt be a Crisis?

QUESTION:

Does Awareness see that entering the Photon Belt is a crisis?

COSMIC AWARENESS:

This Awareness indicates that *It* does not see this so much as a crisis as a redemption from the crisis that may be coming prior to that entry into the Photon Belt. This Awareness sees this photon entry as following the time of crisis so that entities will begin to experience a redemption from the crisis as the Photon Belt entry becomes more and more apparent.

This Awareness sees this as in the mid-'96 period.

WHAT CAN WE EXPECT AS THE PHOTON BELT APPROACHES?

(How Can Entities Survive the Cold?)

QUESTION:

We're getting deluged with questions about the Photon Belt. I feel obliged to ask some of them. Some of the information will be redundant, but perhaps Awareness can give a little different frame of reference on some of these. Some of the member feel that this is the

most important information we should concentrate on. This first one is from R.B. in Ewing, New Jersey.

He writes: "Awareness has stated that the publication *You Are Becoming a Galactic Human* is essentially correct. Many of the statements in the book are similar to statements that were made by Awareness in the Cosmic Awareness Communications. This leads into my question for Awareness.

"Would Awareness give the members the signs that will be seen as the earth approaches the Photon Belt? What should we expect about two years prior; 18 months prior, 12 months prior, and then 6 months prior to entry into the Photon Belt?"

"It is unclear from the readings whether the movement into the Photon Belt is to take place in a few years or not until the year 2013 or so. Apparently, when the earth begins to enter the Photon Belt, the world will experience absolute total darkness. I do not understand how humans can survive the absolute cold when nothing electrical will function and there will be total darkness for five days!"

COSMIC AWARENESS:

This Awareness indicates absolute cold could not contain life; this concept is not correctly expressed. This Awareness indicates absolute cold, or what in terms of scientific terminology is described as Absolute Zero, is so cold that nothing can exist in terms of living creatures or living matter. This Awareness indicates that a rubber ball would simply shatter if dropped.

This Awareness indicates that the source of such terms is apparently using a word that is not commonly accepted by the masses in describing cold. This Awareness indicates that it is simply a matter of semantics, but this is not the proper terminology. This Awareness indicates it is seen as a time when things will be cooler, and can be cold because the solar energy is not effecting heating at the time.

The Days of Darkness Will Come on Suddenly

This Awareness indicates that this so-called entry into the Photon Belt will nullify polarities for a short period of time which causes light to diminish and which will last for approximately less than a week. This Awareness indicates that when it occurs, it will be relatively sudden. It is not as though there will be two months warning or six months from the time it occurs that entities will witness this or that. It will occur suddenly; that light will tend to change and things will grow dark for a period of time, and the atmosphere will be much cooler during that dark period of time.

This Awareness indicates that the entity describes in the book the probable sequence of events and entities can read this for the information. This Awareness indicates that those event sequences are of less importance than the effects on consciousness itself, for entities will be experiencing certain changes in consciousness that will assist them in accepting what is happening in the environment.

Photon Belt Energies are Like Psychic Powers

The photon energies, when coming in contact with earth, will have an effect on consciousness to give entities more of that which is likened unto "psychic powers." They will be able to sense that which they cannot see, to communicate psychically. Even though

the telephones are not working and that electricity is not functioning, they will know what is occurring because the photon energy mingles with consciousness and the energies of consciousness in such a way as to help carry information.

What Octave of Light Will Photon Belt Create?

QUESTION:

A question from O.R., Little Rock, Arkansas. He writes: "In past newsletters, Awareness indicated that we on this plane are in the 49th octave of light. When we go into the Photon Belt and emerge into the 4th and 5th dimensions, will we be in an octave higher than the 49th? And if so, what octave will we be in?"

COSMIC AWARENESS:

This Awareness indicates that it is not so much that you will be in another octave, it is more that *other* octaves of light will be made available to you in addition to the 49th octave of light so that you will have further insight, not necessarily distinctly different insight. In other words you will have additional perception into other dimensions without being totally yanked out of this dimension.

This Awareness indicates that the dimension you presently experience allows you to have access to the 49th octave of light; that which is the seven colors of the spectrum. This Awareness indicates that when entering into the higher frequencies you will have other vibrations of light available to you in addition to the 7 colors of light that make up the 49th octave.

More Light Colors Will Activate Chakras

This Awareness is speaking of light colors, not pigment colors: the light colors being vibrations or frequencies. This Awareness indicates that these different frequencies tend to activate the chakras according to their sympathetic vibration to the chakras and when you enter into the higher dimensional frequencies, the chakras will be able to vibrate harmonically and sympathetically with the frequencies from higher dimensional colors and vibrations.

Thus you will have an enhanced or increased type of awareness. Your consciousness will alter into higher frequencies and higher perception. This Awareness indicates this can allow you to see things that were previously hidden from you. It can allow you to become more aware of things that were previously unavailable to your consciousness. Thus, you will appear to be more knowledgeable, more psychic, more sensitive and more aware.

DRUMIVALO MELCHZADEK'S VERSION OF PHOTON LEVELS

QUESTION:

A question from Loretta I., Jacksonville, Florida. She writes: "Are you familiar with Drumivalo Melchzadek and his Flower of Life teachings? He states that we are all going to ascend to the 4th dimension, 10th, 11th and 12th overtones, and that the grid was placed around earth in 1989 by the Sirians for this purpose. What do you know about this?", she asks, and wonders if Awareness can comment on that.

COSMIC AWARENESS:

This Awareness indicates that this appears to have a reference to certain vibrational frequencies that were introduced when those from Sirius took on the responsibility for assisting earth as the Pleadians relinquished their responsibility. This Awareness indicates that this reference to entry into the 4th dimension in itself is somewhat confusing to entities because the 4th dimension essentially is imagination or that which is the dream state.

However, the reference to the overtones modifies the technology of the 4th dimension and can be this entity's way of further defining what is meant in his reference to the 4th dimension. This Awareness sees the entity as referring to certain reflections from the so-called dream state or from imagination into areas of substance in regard to the use of imagination with a certain degree of discipline and control.

Imagination Could be Called the 4th Dimension

This Awareness indicates it has long been recognized by certain individuals that imagination uncontrolled is chaotic; imagination controlled can be extremely creative. Therefore, with proper control, imagination as a dimension; call it 4th dimension if you chose, can be the kind of environment that allows entities to create a new world, a world that can be molded and modified to the benefit of all, and this Awareness indicates that the entity's reference to the overtones may suggest that this entity is referring to certain controls placed on the 4th dimension of imagination.

What Happens if the Interpreter Hasn't Read the Book

If so, then this can be seen as beneficial and appropriate to the coming times. This Awareness indicates essentially, when entities ask this Awareness to comment on the concepts and ideas of others, whether they be channeled entities or entities whose ideas are being expressed, that it is simply a matter of this Awareness interpreting or attempting to interpret what the entity means by his or her expressions and it is not to be assumed that channels can place ideas on a kind of cosmic blackboard with which this Awareness has the answers relating to those ideas, so that *It* can run through a check-list and mark them "correct" or "erroneous" like a teacher in a classroom might do for students: place their ideas on a blackboard.

This Awareness indicates it is more likened unto attempting to make sense of what the entity says in relation to the reality as seen by this Awareness in a cosmic environment that is constantly changing by certain procedures in the realm of consciousness, for to this Awareness the entire universe is a kind of consciousness environment. Everything is alive, is part of consciousness, is a kind of cosmic consciousness, and things change within it, and as words are spoken or ideas are placed upon the cosmic screen, this Awareness must look to see if these ideas are part of the reality, or if they are simply some artificial creation placed there, much like a cartoon is drawn in what you call your "real" world.

This Awareness indicates that of course, a cartoon drawn in your real world is real, but is it part of the real world? And in that kind of distinction, one recognizes that cartoons are simply castoff images from the imagination and are not necessarily what is commonly

called the "real world." However, this Awareness also recognizes that some entities interpret cartoons as part of the real world. Does the cartoon not exist in the real world? Therefore, entities must admit the cartoon is part of the real world.

This Awareness indicates that when asked to discern whether someone who channels information is correct or whether the message channeled is correct, this Awareness can only view it from the standpoint of what is meant by the one who channels the information in relation to what is intended in the question relating to whether it is correct.

This Awareness presumes, as part of the interpreting of this question, that the entity asking the question wants to know if the messenger giving the message is giving the message in relation to his or her discernment of reality. Of course, the message is part of reality in the same way that the cartoon may be part of reality, but the question of whether the cartoon is real or whether the cartoon is simply a reflection of imagination placed on the screen of reality, becomes a real issue.

This Awareness indicates as you can see, it becomes more of a matter of semantics for this Awareness to answer yes or no to such a question. It becomes a matter of interpreting what is meant by the various part of the questions by the Interpreter of the message, by the channeler of the message and also by what the questioner and his or her question might be seeking.

This Awareness indicates it can become quite difficult to answer a question of this nature, particularly relating to asking this Awareness to evaluate some other channel and the message of that other channel. This Awareness indicates that it is quite different for example, a history class in which a teacher asks a student: "Is it true that Washington's feet were cold at Valley Forge?"

This Awareness indicates that this of course can be answered quite clearly, because the history recording of the incident at Valley Forge has described the situation for George Washington and his soldiers, and therefore, it can be quite clearly related, but a question asked to this Awareness about what a channel has said in regard to something else and whether it is right or wrong depends entirely on what the channel intended in his or her answer and what is meant by the channel in giving information.

Therefore, to ask someone: "What did Joe mean when he told Jerry that Sunday wasn't a good day to do it?"; this Awareness indicates this kind of answer in a classroom is not so easily gained from a question by a teacher, and to ask a student: "What did Joe mean when he told Jerry that Sunday wasn't a good day to do it?" gives the student very little clarity in the question, and therefore, the student cannot answer the question in a truly meaningful way, as the student could answer about George Washington having cold feet at Valley Forge.

This Awareness indicates it is very much the same thing for this Awareness when entities ask: "What did the channel mean and what was the correctness of his message when he stated such and such?" This Awareness indicates that to describe the correctness of an entity's message requires first that you understand each word meant by the channeler and what reference the channeler was concerned with, and within

what context, and a host of other concerns about the channeler's statement.

This Awareness indicates that therefore, *It* does not particularly find a clear answer to this question; however, this Awareness does see that there is a substance of correctness available from the entity's message regarding the Sirius involvement in altering the grid system on this plane, and suggests that it be taken as an accurate message with certain reservations regarding semantics and what is meant by some of the terms used in this message from this entity.

This Awareness indicates that *It* also sees that the grid system manipulation that was done by these entities was in part preparation for the Photon Belt and its approach, for the benefit of humans.

Ed's Note: This is WHY we usually refuse questions about other channels and their books. So stop it!

Will Photon Energies "Enlighten" the Masses? (The Use of the Term "4th Dimension" is Clarified)

QUESTION:

A question from JD in New York. She writes: "Awareness has described moving in to the 4th dimension as akin to uniting with the divine, at least in the effects. Does this mean that a large portion of earth's populace will become rapidly, effortlessly, "enlightened" or liberated, will take a quantum leap in evolution within the next 20 years due to passing through the Photon Belt?"

COSMIC AWARENESS:

This Awareness indicates essentially this is in the affirmative, with notable attention to the use of the word "4th dimension." This Awareness indicates there are what appear to be different meanings or uses of terms. Many entities referring to this as 4th density; others calling it 4th dimension, and others speaking of frequencies.

This Awareness indicates that the 4th dimension is the imagination and the movement into higher frequencies or higher dimensions may require a greater use of the imagination, but the movement through the Photon belt is not strictly imagination.

This Awareness indicates that when entities enter into sleep and dream, they are essentially in the realm of imagination and in the 4th dimension, but there is a difference in regard to the entry into the Photon Belt and into the new dimension which is coming. Perhaps it can be described as the previous channel that was mentioned as being a kind of overtone of the 4th dimension.

Will the Wise Get Wiser After Density Change? (More Frosting on the Cake)

Will those already more advanced in spiritual evolution remain the wiser after this change? or will parity somehow be achieved?" she asks.

COSMIC AWARENESS:

This Awareness indicates that wisdom is never taken from entities because of enhancement in consciousness and those who enter into a more highly refined society or a society that is wiser than they are, generally, when gaining more personal wisdom themselves, will be looking to the more enlightened entities for guidance.

This Awareness indicates in other words, wisdom is seen as frosting on the cake, and will not necessarily be provided to everyone in a way that gives them all the same amount of frosting. If one has already received frosting, that entity is likely to receive even more as the higher enlightenment appears. It is likened unto the entity who is covered with snow, when entering a snowstorm with others who are not covered with snow: The one who already has been covered with snow will be covered even more.

More Wisdom Brings More Temptations

Entities who are already relatively wise and enlightened, will be given further enlightenment and further wisdom. This Awareness indicates that they also are given greater temptation because when wisdom becomes important to others, as will happen, and when spirituality becomes important to others, as will happen, these people will be tempted to see themselves as being superior to those who are not so well enlightened or so spiritual and they will be tempted to look upon those as followers.

This Awareness indicates when entities see others as in need of their enlightenment and spiritual superiority, there is a great temptation for them to play on those energies, to become egotistical, perhaps even vain about their spirituality and enlightenment or their special wisdom, and they can find themselves being degraded by vanity, the self-aggrandizement, so that the new enlightened become in their humility, even more spiritual than the one who was so highly enlightened as to become vain about it.

This Awareness suggests therefore, that entities be very cautious about measuring their enlightenment in relation to the enlightenment level of others or comparing spiritual development between themselves and others.

Are the Spiritually Evolved Already There? (Brownie Points and a Pat on the Head From God?)

QUESTION:

She also asks: "Are those presently highly evolved spiritually *already* living in 4th dimensional expression?"

COSMIC AWARENESS:

This Awareness indicates that this is in the affirmative, depending on how they may have evolved in their spiritual development. Some moreso than others. This Awareness indicates that it really doesn't matter that much, for when entities discover where in fact they really are, they will recognize that they are loved by the Divine Forces; that they are where they are, and it is proper for them to be where they are at that particular time, and that when it is time to become something different, they are capable of the change required, and that they need to accept themselves totally for what they are, where they are, at any moment in time.

This Awareness indicates it is essentially less important for them to compare themselves with others who are allegedly more evolved, allegedly more spiritual or allegedly more wise. It is unimportant, and it is often a hindrance for them to make such comparisons or concern themselves with such matters. This Awareness indicates what *is* important is that

entities surrender themselves, here a little, there a little, here a little more, increment by increment, to the Highest and Best, to the Divine Creator. Surrendering to the Divine Creator without glorifying themselves for doing so allows the entity to become more highly evolved spiritually.

Surrender, Not a Diploma Is the Goal

This Awareness indicates the goal is not to rack up spiritual points for surrendering to the Divine. The goal is to surrender to the Divine and become One with the Divine without concern for spiritual points or credits, without seeking to graduate or get some kind of spiritual diploma or initials on one's name; simply surrendering to the love of God, because one loves to surrender to God, not to get a pat on the head from God for being so spiritually great. That is not the purpose of one's surrender to the Divine.

ARE THESE DISTURBANCES CAUSED BY PHOTON BELT ENERGIES

QUESTION:

Another question from JD: "Awareness has referred to disturbances in energies fields related to effects of the Photon Belt. In the past two months I have observed, (1) frequent electrical and telephone outages; (2) hand-tremors; and (3) a fluttering sensation in my abdomen in the absence of any mental agitation which might account for it; and (4) also mental /emotional effects I never have much experienced before: feelings of depression, desolation, doom, despair, isolation, paranoia."

And she asks: "Are any of these the cited "disturbances" Awareness indicated? And if not, would *It* specify the types of disturbances we can expect?"

COSMIC AWARENESS:

This Awareness indicates that this is in the affirmative as types of experiences which you and many others are frequently encountering. This Awareness indicates that the effect appears to relate to certain unusual situations that entities may encounter relating to the mind and emotions and physical health of entities, wherein these energies are being experienced in such a way as to create disturbances within the energy fields of the individual.

The Interpreter's Bumbling Escapades

This Awareness indicates those which you gave served as one good type of example. This Awareness indicates as another example, the Interpreter also experienced some strange events recently, wherein upon awakening, he noticed his vision, in a peripheral sense was not clear. There appeared to be lights, or lighted energy in the peripheral area of his vision, to the sides of his vision or to the sides of his focus; above and below and to the sides, and it was feeling to him as though he had awoken with his eyes open, but his brain continuing to sleep.

This Awareness indicates the entity, upon arising, noticed that the room seemed to be in a sea of light vibrations, but without objects being clear or standing out, as in a lighted room. The entity's focus on something was essentially all that could be seen, and that which was off to the sides was not clear because

light interfered with his vision of those things that were not in direct focus.

This Awareness indicates the entity later walked outside and walked along looking straight ahead at the path he was following and walked directly into a post holding up his carport. It knocked against his glasses, and suddenly came into focus. The entity could not understand why he had walked into this post. This Awareness indicates that the entity then walked on out into the street to go to his daughter's house, but where he was supposed to turn, he continued walking straight, where his focus was, eventually realizing he had walked almost a block beyond the turning point.

He turned around, went back and crossed the street, and went up the street toward his daughter's house. The entity had to turn around, and turning left, walked down the sidewalk toward his daughter's house only to find that he was walking past her house, when his grandson called him. Upon going back and entering her home, he told her of the incidents and she asked, "Perhaps you have low blood sugar. Have you had anything to eat?", and gave him crackers and cheese.

This seemed to help a little, and the entity felt that possibly it was low blood-sugar. The entity then went back to his home and walking into his driveway, walked up toward the carport. Looking along the path he intended to walk, he suddenly slammed into his automobile, causing his knees to be hyper-extended in a backward position, where he bumped the bumper with his knees, and his body flew forward onto the trunk.

He wondered: "How could I have walked into my car without seeing it?" The entity then went on into the house, to his computer and began typing on a project, but found that his fingers were typing the wrong keys and that he could not type properly because his fingers kept moving in the wrong directions, and that the only way he could type properly was to look at each key with each stroke and make sure that he was on the right key.

This continued throughout the rest of the day. This Awareness indicates the entity appeared to recognize his ability to think clearly in all other ways except when it related to his vision, particularly the peripheral vision. This Awareness indicates that by the end of the day things were back to normal.

This Awareness indicates that there have been other reports from other entities of similar and somewhat different circumstances, wherein their own bodies reacted in somewhat different ways. This Awareness indicates that it would be of benefit for entities to send in their own reports of how their bodies are adjusting to these photon energies, if there have been any unusual circumstances or situations in which the emotions, physical, visual or mental experiences of a very unusual nature have affected them, and to keep a running record of such events as they develop.

Start Making Notes on Weird Happenings

This Awareness suggests that what is happening here is that entities are making slight adjustments to the photon energies and that these photon energies are having effects sometimes with the entities in such a way that the entity is not adjusting quick enough or completely enough to accept the changes and energies that they experience. This Awareness indicates therefore, if you keep a record, and if you wish to share

some of this information with others, this could be of significant interest to many.

This Awareness indicates that also, if you can keep a record even for yourself, you may see a pattern unfolding over a period of time that is of significant interest to your own understanding of what is happening,

This Awareness indicates obviously, with things such as this occurring, entities *do* need to be especially attentive. It is not always good to indulge in activities during such times. For example, driving in traffic, when you are not totally balanced or completely in control of your faculties would be a risky activity.

This Awareness indicates that there *does* appear to be some connection to low blood-sugar or energies as they associate with the rational mind, and therefore, this Awareness suggests that you be cautious during such times. Raise the blood-sugar if necessary by eating small but more frequent meals. This Awareness indicates that *It* does not suggest you eat large amounts of plain sugar or candies, but crackers, cheese, or grains can be beneficial during such times to help restore a balance.

This Awareness indicates that other entities may not have such a need for blood-sugar balancing and may simply need to sit and rest or meditate or re-focus, or perhaps a cold cloth on the forehead or back of the neck will be sufficient. This Awareness indicates that whatever it is that helps you to re-orient yourself to your normal state of consciousness is encouraged.

This Awareness indicates that *It* is not suggesting or encouraging entities to have these strange experiences. This is a kind of distortion caused by imbalances in the system as the Photon Belt adds new energy into the chakra system of an entity's body. This Awareness indicates in some cases it will reflect in part, because of stress the entity experiences. If you are not experiencing unusual stress, you may not even be having such experiences. You may be adjusting in a more harmonious and smooth way to the photon energies.

Do not worry if you are not having such experiences. It may simply mean that you are better balanced physically, emotionally and mentally than those who are experiencing certain distortions. This Awareness *does* wish to say however, that if you are experiencing such distortions in your being, it may simply be the photon energy affecting your body and its effect on certain blockages in your system that need to be released.

Will Fears Manifest From These Energies?

QUESTION:

One other question from D.J in New England, who asks: "If the photon effects cause our thoughts to manifest, will fear of falling say, cause a fall or fear of theft result in a theft? I have been experiencing inexplicable feelings of despair, dissolution and impending doom. If I do not manage to identify and correct the cause, would these thoughts then materialize real disasters for me?"

COSMIC AWARENESS;

This Awareness indicates that this is not likely to occur. It is very unlikely to occur at such early stages. That if you were far into the Photon Belt, this as long

after the complete entry,--the days of darkness, et cetera, and you enter into the realm in which everything is imagination, and imagination creates the totality of your realm of reality; at such time your thoughts may manifest into a kind of immediate reality.

This Awareness indicates this happens every night in dreams. When you are dreaming, your thought becomes the reality within your dream. This Awareness indicates that it is not a crisis in your dreams, nor will it be a crisis in your 4th dimensional experience any more than it would be in your dream, for essentially they are one and the same, with only slight differences.

This Awareness indicates that the greater concern about these thoughts is that when it becomes more of a reality, and your imagination appears to create reality instantaneously; you will find it unpleasant to have negative thoughts, and you will gradually learn to focus more on the pleasant things. You will find yourself creating flowers and pleasant scenery simply because it is much more enjoyable than creating negative concepts and fears. .

You will gradually learn from witnessing your own thinking process to have more positive thoughts, more enjoyable images.

THAT ALIEN AUTOPSY FILM SHOWN ON TV: IS IT REAL OR FAKE?

(And Why Is It Being Released Now?)

QUESTION:

During the last several months there's been a lot of information coming through the Internet from England regarding a film made of the Roswell Crash in New Mexico in 1947, I believe, and this was shown in England before it came to America where part of it was shown a week ago I believe on *Encounters*. I'd like to read a little of this that came in on July 25th. This comes from the *Guardian* newspaper in England. It says:

"Almost 50 years ago something crashed at the Roswell Air Force base in New Mexico. What was it? UFO buffs always said it was a flying saucer. Now they have evidence. Martin Walker reports a body! Imagine a pubescent but pregnant girl, humanoid, but distinctly alien, with a bald and giant head and lizard eyes. She could come from the garish cover of any science fiction magazine. Under the scalpel, the flesh gives and bleeds. The joints flex and the limbs bend, and the great wound on the thigh suggests muscles and ligaments.

"The scalpel cuts the flesh away to reveal a vast skull of unusually thick bone. The surgeon wielding the saw pauses to rest in his work. When the contents of the skull are removed, they are flesh-like, but most unlike a human brain with its grooves and folds. If brain this is, it looks like a chunk of liver on this grainy soundless black and white film that claims to have been shot in 1947.

If these large elliptical lizard slits are eyes, they are covered with a black film, which is then carefully removed by the surgeon revealing white orbs. The scalpel goes down the trunk to the swollen belly, which suggests that this small being might have been pregnant. There are female genitalia, but no navel, and no hair.

Once the body cavity is exposed, there are no familiar coils of intestine. The body organs are again fleshlike, soft and yet distinctly odd. There are six digits at the end of each long slim arm, six toes on each foot. This is eerily familiar from the visions of sci-fi illustrators and also from the medical books of

anatomy, as if this being under the surgeon's knife were a composite of four or five different human pathologies.

There are no prosthetics. This does not look like some creation of the Hollywood special effects labs. This seems convincingly to be the autopsy of some kind of being. There are two films. The first lasts about 18 minutes and takes place in some kind of operating theatre with surgeons in masks and gowns. The second film is shot from inside a tent, in the half-light of emergency lanterns. The being is largely covered by a sheet, and male and female medical attendants flex the limbs and conduct what seems to be a preliminary examination.

A man in civilian clothes is present and seems to be in charge. This film lasts about 3 minutes, and there is no sound on either film clip. "If this is a hoax, it is the most elaborate and convincing and believable one!", said Congressman Stephen Schiff of New Mexico, as he sat and watched the films last month in his Washington office with his staff and other government officials around him. "We were shown the clips and sworn to secrecy, until now, by the British documentary film-maker John Purdy of Union Pictures."

On August 28, these two brief clips of film which purport to record the US Air Force autopsies of two crashed alien beings will be screened simultaneously as part of Purdy's Roswell documentary on channel 4 in Britain, on FOX TV in the U.S. In Japan and in Europe. This film is the first hard evidence to emerge from the most celebrated and best documented UFO event of all, the mysterious crash of a strange aerial craft near the Roswell Air Force base in New Mexico at 11:30 PM on July 4th, 1947.

"Forget about Whitewater and Watergate, and even the unsettled issue of who shot President Kennedy. The biggest conspiracy of all, that earth has been visited by aliens and their bodies autopsied on film is clamoring out of the bizarre underworld of the occult and into the realm of the rational and verifiable world.

"Prodded by his New Mexico constituents and his own curiosity, Congressman Schiff began his own probing of the Roswell mystery three years ago. His first success was to force the Air Force to drop the cover story it has maintained on Roswell since 1947; that the crash was an experimental high altitude weather balloon, and the strange metal was ordinary tinfoil.

"Last year, the US Air Force changed its story, telling Congressman Schiff in an Official Report that this had been a cover story for an important secret. The crash had been a balloon, but not concerned with weather. It was "Operation Mobile", an experimental high-altitude balloon designed to detect radiation and monitor an eventual first test of a Soviet atom bomb.

Unsatisfied by what he calls "The most unaccountable stone-walling I have ever encountered!", Congressman Schiff and other legislators have succeeded in ordering the Government Accounting Office, the watchdog of the federal Government to mount its own news inquiry, to track down all documents relating to Roswell held by any US government agency. That report will be delivered to Congressman Schiff on Friday and will be publicly released next week.

"The GAO report finds no smoking gun or smoking UFO, but does report a large number of documents destroyed, stressing that this is not necessarily unusual, given an event that took place nearly 50 years ago. Conspiracy theorists will seize on what has been destroyed. Less prejudiced historians will question whether an event of this importance could possibly have had all of the paper trails erased."

And there's no doubt that something *did* happen at Roswell. It's a long report, but basically, since they've

shown part of this film in the United States, everybody on the Internet anyway, it seems, and probably the members, will be sending in questions asking Awareness to tell them what really happened in that film. Was it a genuine alien? Was it a fake? And if it IS real, why is it being given to the public at this time?, and so forth.

COSMIC AWARENESS:

This Awareness indicates that this appears to be genuine. This Awareness reminds you of a recent movie starring Kyle MacLachlan as an officer who became the scapegoat for the original release of the story of the crash at Roswell and was made a kind of fool for thinking it was an extraterrestrial craft.

This Awareness indicates that the entity spent most of his life being ridiculed after the government gave forth the story that it was a weather balloon, while making it appear that the entity who released the story of the alien craft crashing at Roswell didn't know the difference between a weather balloon and an alien craft.

This Awareness indicates that those who are interested in this may recall or may view the film, and note the scene in which an associate tells Mr. MacLachlan, playing the officer, of how there was a lot of high-level activities at a certain place and how he went there to see his girlfriend nurse who, upon seeing him, became somewhat panicky and told him to leave the base where he was visiting. He wanted to know what was happening. She appeared quite frightened and said she would meet him after work.

After work they met briefly, having a cup of coffee, and he wanted to know what was going on. She was terrified of telling him, but eventually informed him of the alien bodies that had been brought in and how they were being examined, and drew a picture for him. The nurse then, feeling extremely nervous, left, and he was told to destroy the picture. He *did* destroy the picture after having seen it. It was simply a picture of an alien's face.

This Awareness indicates that the entity then reported that she was killed shortly thereafter or some kind of other similar accident. This Awareness indicates that this story within the Roswell Incident movie is that part which refers to the autopsy that is the discussion of this question and the entity, the nurse describing her role in this essentially was describing the incident of the autopsy taking place at that base which this entity was not allowed to know about.

This Awareness indicates in other words, you are now allowed to see the alien who was the topic of discussion between these two entities in that movie clip at that base in reference to the incident in which alien bodies were taken by the military and the incident covered up.

This Awareness indicates that the autopsy was authentic in the film shown. That film was never intended to be released, just as the story of the Roswell Incident was never intended to be released as a movie, and had it not been for the determination of certain entities to get the information out, including the entity Anderson who was but a child at the time of the crash, who retold what he knew of the incident in recent years, and rekindled interest in the incident by retelling the story.

The movie would not have been made or released had it not been for the fact that the story and the interest in it never died, because there were entities who were aware of the cover-up and who felt it was their duty to get the story out before they died of old age, even though their lives had been threatened and they had been told never to speak of it.

This Awareness indicates that this is the classic UFO story and cover-up. It is amazing that the 12 minute film clip has been made available for the public. Perhaps it is a sign that the government is ready to let people know what has occurred.

"Perhaps It's Time to Play the Extraterrestrial Card"
--(Henry Kissinger)

This Awareness indicates that there was a statement uttered by Kissinger recently that related to the movement to the New World Order that it was time to play the extraterrestrial card, or something to that effect, implying that it was time to play the extraterrestrial card in order to promote the New World Order. It is seen that this may be part of the playing of the extraterrestrial card, alerting the masses that there has been a government cover-up of extraterrestrial contact, and from there, other parts of the ET card can then be introduced to influence entities into accepting the idea of a New world Order.

This Awareness indicates that this is seen as a potential for the reason of releasing this information. It is not seen by this Awareness as absolutely clear or certain that this was part of a plot, but this Awareness does see it as a potential. Perhaps it will clarify later, to become more certain or less certain. This Awareness is not actually focusing at this time to determine this as a reality.

What Type of Alien Was Being Autopsied?

QUESTION:

Awareness has indicated that those were Greys that Crashed at that time. This description of a female, a pregnant female, with genitalia, doesn't sound like a Grey.

COSMIC AWARENESS:

This Awareness indicates that these were not the types of Greys in recent UFOlogy. These recent Greys did not arrive until the early Sixties. Those that crashed at Roswell in the late Forties were a different type. This Awareness indicates that these were larger than the small Greys described in recent UFOlogy. This Awareness indicates that these earlier beings were classified as connected to the earlier group, those Greys or entities referred to as the large Greys.

This Awareness indicates that these entities associated with Orion. The body of the entity described in the film being lighter and more closely resembling Caucasian flesh than the small Greys described by Whitley Strieber in his book *Communion*. This Awareness indicates that this entity being female and being less dark in terms of Greyness than many other tall Greys that have been described as tall Greys with big noses, or the big-nosed Greys.

This Awareness indicates that these entities are not the same Grey hue and the short Reticuli type of Grey. This Awareness indicates that skin can be described as Grey

without being dark Grey, and essentially, the skin on this entity would resemble that of some of the Middle Eastern people more closely than it would compared to Zeta Reticuli Greys.

FOLLOW-UP QUESTION:

Well evidently, this variety had not cloned themselves out of existence, for it appears that they have regular reproductive organs.

COSMIC AWARENESS:

This is in the affirmative. This Awareness indicates that the Zeta Reticuli Grey should not be even considered in this regard, in the relationship to Roswell. The Zeta Reticuli Greys did not appear on the scene for another 15 years, approximately.

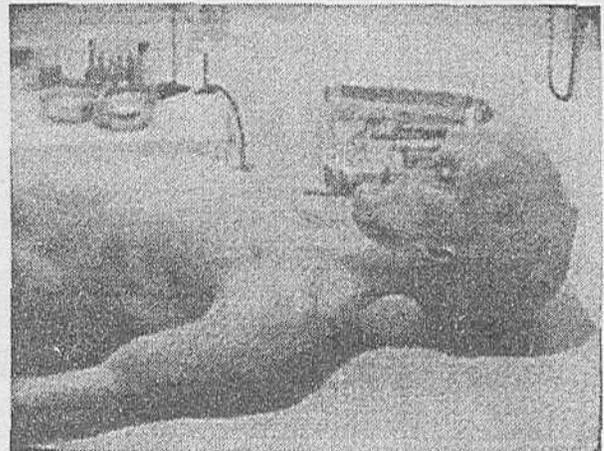
Film Will Have Profound Effect on Consciousness

ALL ABOUT ANIMALS AS PETS TO HUMANS

QUESTION:

JD in New York asks "If Awareness would please discuss the benefits of various common animals as pets, to both the human and to the animal

COSMIC AWARENESS:

This Awareness indicates certain benefits associated with the dog relate to helping entities cope with a sense of paranoia and a need for security because the dog serves as a kind of alarm system against any kind of intruder in one's territory or space. The dog is a protector of that space and its loyalty to a human master helps to protect the human master's space as well.

Dog Owners Often Have Unrecognized Paranoia

This Awareness indicates that often humans have a deep unrecognized paranoia, a fear of having their space interrupted without actually calling it or realizing that is what the problem is, and these entities are often attracted to dogs, and having dogs in their area helps them to rest easier regardless of their paranoia.

By "paranoia", this Awareness refers to unfounded fear. They can also have a justified fear and want a dog to help protect their space. Not all people who have dogs are paranoid. They may have good reason for wanting a dog. There may be a threat or a potential threat to their space and to their area.

Also, some entities want dogs simply for the enjoyment of the dog and companionship. This is commonly seen in young children. This Awareness indicates that most children, if they had a choice, would pick puppies rather than large watch-dogs. The kind of dog an entity picks also can reflect on his or her psychological attitude toward the animal or toward the need for the animal.

Owners of Cats Often Have Psychic Needs

This Awareness indicates that a person who selects cats as pets tends to be more involved in a psychic need, a psychic attachment to the cat for protection in a mental or psychic sense. They are not as concerned about physical threats. They are more concerned about psychic emotional, more subtle feeling disturbances to their world.

This Awareness indicates entities who enjoy petting a cat find comfort to replace their need for deeper love through companionship from others. The cat serves as a source of physical tactile affection. The cat also indicates to an entity that the entity is appreciated for what the entity does and the entity knows that it can make the cat feel better by doing little things. It helps the entity to feel important and needed.

This Awareness indicates that the dog does similar feelings for his or her master, making them feel important and needed. Some entities do not prefer the dog because the dog appears to have no discernment and simply is totally devoted to the point of annoyance for some entities. They do not like the constant attention

that dogs tend to give and others prefer the cat, as it is more independent and does not constantly feed off of the master's energy for its own sustenance.

Worship and Devotion from a Dog to Its Master

This Awareness indicates that often the dog will stare at the master for hours, simply because the master is there and the dog wants recognition, and the dog feels a closeness and an attachment to the master in such a way that it cannot be broken and any movement by the master only turn the dog on to expressing absolute devotion and worship toward the master.

This Awareness indicates that many entities like this. Other entities prefer not to have this kind of special attention, because it can be so distracting to them. The entity who like cats tend to like them in part because they can give affection to the cat when they feel like it and do not feel guilt at walking away from the cat when they are through petting it.

There is little attachment to cause guilt. Usually when the cat has been petted for a few minutes it is also satisfied and if the master walks away the cat simply turns its attention elsewhere, such as to lick its fur or find a place to curl up and sleep. It does not follow the master around trying to get more petting time.

When Your Pet is a Bird

This Awareness indicates for the entity whose pet is a bird, this entity may feel a sense of appreciation for what is seen as a freedom, a natural freedom which the bird has in that it has the ability to fly and not be trapped by gravity in the way that the entity may feel trapped. This Awareness indicates that the problem, however, is that in using a bird as a pet, too often the bird must be kept in cages.

In some cases, the bird may be free to fly elsewhere, such as in the homing pigeon, but in too many cases, the bird must be kept in, and after a few months, the entity may stop seeing the bird as the symbol of freedom and see the bird as a creature in captivity.

Therefore, the entity may not get a symbolic message from the bird of freedom, but may begin to feel a sense of entrapment, so that the bird symbolizes the entity's own feelings of entrapment in some situation or condition. Of course, there is always some protection in the cage, and likewise, an entity who has a bird that is caged may feel a certain amount of security and protection in his or her life or lifestyle. At any rate, it can be a reflection on the entity's concern about security versus freedom.

Entities Who Like Snakes & Other Exotic Pets

This Awareness indicates that entities who like exotic pets such as snakes, alligators, iguanas, are usually entities who have a tendency to be somewhat antisocial or who may like getting personal attention from bizarre activities and behaviors. This Awareness indicates that this can be a way whereby these entities may shock associates or friends. Having someone come into your home to be greeted by an alligator, an iguana, a serpent, or some other creature, is it is a way of making a statement to society about oneself.

It says: "I have unusual tastes and interests! I'm a very interesting person because of my unusual interests. I'm not the ordinary run-of-the-mill person. This Awareness

indicates that the more these animals are incorporated into an animal's house, the more likely the entity is living his or her life vicariously through or with the animal pet.

People Who Own Pot-Bellied Pigs

QUESTION:

Would the same apply to people who have more or less novelty-type animals like the pot-bellied pig; it's supposed to be a miniature pig from Vietnam, and is now a fad, even in some of the big cities; however, they do grow up.

COSMIC AWARENESS:

This Awareness indicates that the novelty types, the very unusual type of animal generally signifies a person who has a desire for special attention. This Awareness indicates the entity who has a skunk or possum or raccoon as a pet, is more inclined to be interested in shocking or offending his or her guests, which would imply that the entity seeks to be frank and fiercely independent without any care of what others may think of him or her.

This is a person whose handwriting would reflect a short "d" stem, a sense of independence. Such a person is basically saying "Sure I have a skunk!", or "Sure I have a raccoon! What are you going to do about it? There's nothing you can do! It's my life! I can do as I please!"

This Awareness indicates that the more unusual animal such as the pot-bellied pig and the ferret and such similar unusual creatures are indications of an entity who has a need for attention. They will do things differently just to get attention. They will do things out of the ordinary or in a way that disturbs the concept of the norm, simply so that they are noticed.

They like having something of a novelty to show that they are not run-of-the-mill people. They are more unique in their values and in their expression of themselves.

Those Women With White Poodles

QUESTION:

What about this, what appears to be a stereotype of particularly wealthy women who seem to all have these white poodles that they take with them everywhere, and spend considerable amounts of money grooming them?

COSMIC AWARENESS:

This Awareness indicates that these are decorations. They are extensions of the women's jewelry, furs and clothing. It is part of the self-image the woman wants to manufacture and maintain. It makes them appear to be sophisticated, even snooty, to have a white poodle that is trimmed, which they can extend from a leash, to show that they, like the poodle, are very sophisticated and very well trimmed for society's admiration.

This Awareness indicates that of course they also have their affection for the poodle. It is not to say that they consider the poodle as simply an object of decor, but generally there is an element of decoration in the entity's life whereby the poodle decorates the entity's general appearance.

This Awareness indicates that in the previous century, men would wear watches with gold chains hanging down from their belts up to the watchpockets so that entities would notice that they had a watch in their pocket because the watch obviously meant that they were relatively wealthy in order to afford a watch, a time-piece, and the gold chain indicated wealth also.

Some of the men might walk with a cane, not because they needed the cane, but as decoration for their general self-image or social-image that they wished to portray. This Awareness indicates that walking cane might be elaborately carved or have special qualities that made it more than just a stick to help them keep their balance.

This Awareness indicates that in the case of today's modern woman with her poodle, the poodle serves in much the same way as the 19th Century man's walking cane and other similar paraphernalia, to create decoration for his social image.

This Awareness indicates of course, many of these woman truly love their poodle, in the same way that others might love their child.

Animals as a Child Substitute?



QUESTION:

How much, if any, of female animal owners, unconsciously or consciously, use their animal as a child substitute?

COSMIC AWARENESS:

This is quite common. Many times women do not have the full number of children or as many children, nor have them as long as the hormones in their mothering instincts would dictate. Therefore, by having a substitute such as a poodle or some other small animal, they can continue enjoying the role of motherhood, transferred toward the animal of their choice without the responsibility of raising real children, or if they are unable to have children, the animal can become a substitute and satisfy this hormonal need.

Bonding With Humans: Any Benefits?

QUESTION (VIKKI):

How do pets benefit from the human contact or bonding?

COSMIC AWARENESS:

Dependency. They have someone to provide them with their food, their shelter, their affection, and companionship. Some pets even gain a sense of spiritual assimilation from the bonding with humans. They will begin to feel a certain kind of energy that might be quite different from what they might normally feel were they not associated with this person.

Some pets become very docile, very friendly. Other pets might become more responsible in their behavior so that they do things for their master. They will fetch slippers, fetch the paper, or help to clean up some area in one way or another. These pets are unusual, but they can be very helpful when they do have that kind of training necessary for being responsible to their master.



The Horsey Girls: Obsessed with Horses

QUESTION:

How about women who are obsessed with horses, who usually start riding and training horses when they're children, and it lasts through their lifetime?

COSMIC AWARENESS:

This Awareness indicates that this kind of relationship for a woman helps her to develop certain manipulative power, or empowerment over larger animals so that she feels herself to be more capable than she might otherwise experience. This Awareness indicates for a young small person who has had very little experience in dealing with large objects or large beings, to be able to train a horse can really make them feel they have accomplished something of a great nature.

To be able to pull a rein or say certain words and cause this large creature to turn around or to stop or to go or to jump; any action that the horse has been taught becomes very significant to the entity whose physical strength is limited, whose body is small. This Awareness indicates it is the empowerment that appears to be the real key to their enjoyment of the experience with such large animals.

People Obsessed with Horses

QUESTION:

Is there anything to the theory that people who are obsessed with horses, that this is somehow a carry-over from past lives, back when they did ride horses, and horses were the main means of transportation?

COSMIC AWARENESS:

This Awareness indicates that there can be some carry-over in a sort of instinctive familiarity, so that an entity who has ridden horses in an earlier life might feel quite comfortable in riding horses in the present life. This Awareness indicates it does not necessarily mean that an entity who rode the pony express would want to be a UPS truck driver or mail man, but it can suggest an entity's interest and fascination with horses, if the entity has had a heavy past-life with horses.

Are Biker Gangs Old Cowboys?

QUESTION:

I've always had the feeling that biker gangs that ride motorcycles were reincarnated cowboys of some sort. Is there anything to that?

COSMIC AWARENESS:

This Awareness indicates that this is on occasion. It is not necessarily the common thread between bikers. There are some bikers whose background had to do with serving in a troop or in a group or with buddies and friends in a certain company or clan-like situation. In other words, a group of field-hands might tend in a later life, to be drawn toward a motorcycle group simply because of the group camaraderie and their comfort with such group camaraderie from the past-life experiences.

This Awareness indicates that the motorcycles for some of these entities might simply be extraneous of the cause for bringing them together. Others in the same motorcycle group might have common connections such

as through horseback riding and having been together in a group at that time. This Awareness indicates that it is not something that can be put into a hard and fast rule that entities who rode horses in one life will ride motorcycles in the next, or other forms of technology in a still future lifetime.

Those Who Keep Chickens as Pets

QUESTION:

How about chickens? I know of a man who really likes chickens, not to eat, but as a child he usually had two or three chickens as pets and even had them in his room sometime. Is that descriptive of anything?

COSMIC AWARENESS:

This Awareness indicates that sometimes little children are given chickens as Easter presents and develop an affection for small chickens and this may carry over into an entity's adult life wherein the chickens imply a sense of comfort and security of the child's home life from his early age. This may help an entity to like living chickens as pets. However, it does not necessarily imply a reincarnation connection.

This Awareness indicates however, if of course an entity has had heavy incarnation with chickens such as Colonel Sanders, there could be a karmic carry-over from one life to another in which chickens are a major part of the entity's second life or following life.

People Attached to Frogs

QUESTION (VIKKI):

Well, there's a few of us that had an attachment for frogs. Is there any reason for this?

COSMIC AWARENESS:

This Awareness indicates that often it stems to a childhood memory of frogs making their calls and sounds in the night during the Springtime or Fall wherein the child remembers these sounds as a pleasant time of the year and a fascination with the frogs may come from that childhood memory, or memory of childhood.

It is not likely to be carried over from past-life experiences so much as something that is a reminiscence in a nostalgic sense to the child or experiences within his or her present lifetime.

People Who Own Aquariums & Exotic Fish

QUESTION:

Many people have aquariums with fish, even exotic fish like piranhas, tropical fish. Is that indicative of anything?

COSMIC AWARENESS:

These entities may have a great affection for things that are out of the norm, things that are from other realms or from other cultures, and their fascination with fish could also be a fascination with color and shapes. They may have certain artistic propensity or latent artistic interests which may never become fruitful to them, but they may have such artistic interests and may be fascinated by the curves and shapes of the exotic fish along with the movements and colors of these creatures,

partly because of latent artistic qualities within their own psyche.

This Awareness indicates that often entities tend to be drawn to animals or creatures that carry certain expressions that signify something not in words, but in actions or appearances that are meaningful symbolically to the individual.

This Awareness indicates for example, an entity fascinated with an exotic fish might have a subconscious desire to explore unknown realms or to have more grace and color and beauty in his or her own life, and the fish might simply express all of that feeling in a way that is totally fascinating to the individual.

This Awareness indicates that likewise, an entity who is fascinated or obsessed with baby sharks or piranha may have a subconscious feeling of wanting to be able to have more power over his or her environment, or may simply have an unconscious fascination with a fear of such creatures and like to see them entrapped behind glass, knowing they can't get to the entity, because if the glass breaks, they would suffocate anyway, and therefore, they are safe in their chair to view the creature that frightens them from their dreams, their nightmares or their childhood fascinations.

This Awareness indicates who would not find some enjoyment in seeing a creature who had almost killed them or who had frightened them heavily to be put into some kind of cage or glass, so that he could not be a threat, and yet, you could examine very carefully and closely what this creature that once frightened you so much really is?

Fascination with Jack the Ripper & Billy the Kid

This Awareness indicates this is also why entities often are fascinated with characters such as Jack the Ripper or Billy the Kid or some other entity of historical origin, that was once powerful and dangerous, because the entity can now look at this powerful and dangerous person up close, even if it is only a wax image or a picture. They can look at this creature or this entity up close and know that they are safe while they examine this formidable being.

It is a kind of voyeuristic action where you spy upon that which once caused you terror. It is the same joy that entities might get after being stalked by some beast and suddenly having the beast killed. They are then curious, and want to go up and look closely at the beast and realize that "This is the beast that almost ate my head off!"

It makes them feel very victorious, to be able to study a creature that they know could be very dangerous to them, if it were not for the fact that the creature has been subdued in some way; either killed or put behind bars or in a cage or behind glass or something to disarm the creature's ability to harm you.

CAN CATS RETURN AS GHOSTS?

QUESTION:

While on this subject, there's a couple of interesting stories in one of Vikki's cat magazines called Cat Fancy, there was an article called Ghost Cats, and it claims that not all ghost stories about cats are spooky. Many cat owners are comforted by heart-warming visits from spirited feline friends, and one of these says:

"Typical of many friendly ghost cats, was Fingo, a Siamese, owned by a Celia Dale in England shortly after World War II. In life Fingo had been Celia's constant companion. Like most long-time friends they had established routines. Fingo had his own chair in the sitting room and he always dined with Celia. After dinner he took a short jaunt outdoors, returning at dark and scratching at the sitting room window for Celia to let him in.

After Fingo died of old age, Celia was heartbroken. Meals were so lonely and the sight of Fingo's empty chair set her weeping. But one rainy, windy evening a familiar scratching came at the window. "At first Celia thought wet leaves were tapping the glass, yet the noise was so insistent she could not ignore it.

Hesitantly she walked to the darkened window and slowly opened it. Wind rushed in, tousling the curtains, and raindrops spattered the stone sill where Fingo had always perched. A moment later, something softly brushed by Celia. Then the cushions of Fingo's favorite chair sank with the weight of an invisible occupant.

The following evening, she opened the window at the usual time Fingo had gone out, and again felt his unseen form brush past. When darkness came, his phantom claws were again heard at the window, and Celia gladly opened it and watched as the cushions revealed his presence. This supernatural ritual continued every night thereafter and was sometimes observed by Celia's friends. Everyone agreed that Fingo had overcome death and had returned to offer comfort and companionship to his grieving owner.

Does Awareness see that story as factual or as fiction?

COSMIC AWARENESS:

This Awareness indicates that stories such as this do appear occasionally, and it is not unusual for some trail of evidence to appear after a spirit or ghost has intruded into one's home or life. It is very questionable to most entities. This Awareness suggests however, that it appears in this case to be a correct depiction of what happened.

This Awareness indicates that there is a question of whether entities, in seeing what may be termed ghosts, are accurate in their viewing or are hallucinating. Usually, when there is an hallucination involved, it comes as a kind of awakened dream experience, so that an entity may be quite tired, may have time and interest in looking at something, but may not have the full focus, and therefore the entity hallucinates slightly and sees things that are not totally present, which others in the same time and space segment may not witness.

But there are still other situations in which more than one entity testifies and acknowledges the same kind of action as having taken place. Thus, the action is corroborated by two different people.

Is the Cat's Ghost Merely an Astral Shell?

QUESTION:

In cases like that, is it like the cat has an astral shell that is returning, or is it actually the spirit of the cat?

COSMIC AWARENESS:

This Awareness indicates it appears to be the kind of rudimentary soul of a cat. There are some animals that are developing rudimentary souls simply by their proximity with humans. The soul, essentially, is a magnetic center, and it can develop to the point where

the soul's magnetic center takes on a personal identification, and its identification may be connected to the nature or attributes of the physical creature, so that an entity who is a cat, which develops a rudimentary magnetic center soul may also carry a kind of personality that has developed from its close proximity to humans, so that the human may recognize not only the fact of the cat's soul, but that it is the same soul of the same cat the human fraternized with before. This Awareness indicates that the proper word would not be fraternized. It would be better said as "bonded with" before.

The Blind Man and the Ghost Cat

QUESTION:

I'll read one more of these stories, because Vikki gets quite a few letters from cat people asking that we put out more information on animals.

A story from the depression era that is still told in Philadelphia remains one of the poignant examples of a cat's devotion to its owner, and it reminds us that perhaps what we love most about a pet is not its physical form, but its inner spirit.

"Many years ago there was said to be a blind man who spent his days in one of the city's parks humming and making bead necklaces. Passersby would drop a few coins in his jar, making a loud tinkle that would cause him to smile and offer a necklace as payment. Usually the necklace was declined, but no one could pass up the chance to stroke the man's big calico cat with its distinctive raspy purr.

Years rolled by, and the cat became feeble and tired. When it died quietly one afternoon, the old man grieved so that he stopped his humming and put away his box of beads. Day after day he sat on the park bench, despondent and unsoothed by the sympathetic words his friends offered. Sometimes he would weep softly until he fell asleep, and the woman who cared for him would find him slumped on the bench long after everyone had left the park.

One evening, however, she found him humming again and found that he had resumed stringing the colorful beads. He smiled when he heard her footsteps on the pavement and cautioned her to be careful where she sat, though there was nothing on the bench she could see other than his box of beads. She looked into his sightless, but joyful eyes and was about to ask what had caused his sudden happiness.

Then she heard it: that familiar raspy rumbling purr, and she saw the old man's hand affectionately stroking the air over the bench.

Is that another case of an actual spirit cat, or imagination?

COSMIC AWARENESS:

This Awareness indicates that this has a reality, particularly to the man, although another person doesn't see what he sees, and therefore would say it was not real, but the lady heard the purring of the invisible cat which the man could see, therefore, the two of them tapped into a similar reality which others might not recognize.

This Awareness indicates that one man's reality is not necessarily the reality



OUR WEATHER AND THE PHOTON BELT: ANY RELATIONSHIP?

(More on "Operation HAARP")

QUESTION:

A question from Kate R., in Chino Valley, Arizona. She writes: "Dear Vikki. Spring is passing into Summer, and what a lovely time it is! Mild weather, some rain, very mellow for Arizona, and the Chino grass, which Chino Valley is named after is making a big comeback. There hasn't been much of it around due to overgrazing and other environmental assaults, but this Spring it has sprung out all over.

"Could it be the weather, or is it the times?, our new movement into the Photon belt perhaps? Maybe that is a question for Awareness. How does, or do the energies of the Photon Belt affect the environment, weather and other species besides our own?"

Does the incredible hot weather around the world we've been experiencing have anything to do with the Photon Belt?"

COSMIC AWARENESS:

This Awareness indicates that this is not seen as being directly related to the Photon Belt. It is seen as being related to certain weather modification devices that affect frequency and vibration and which in turn move the jet stream from its proper place to areas that are not commonly used by the jet stream and this is affecting the weather.

This Awareness indicates that the Spring weather in Europe in the year 1995 was extremely cold and wet and set records in part due to the use of these weather modification programs and technologies. This Awareness indicates the devices in Alaska under the project known as HAARP have been instrumental in altering the weather patterns in Europe and in Russia and this has created some political problems between those countries who have been affected by this program and the United States, wherein entities affected are aware of the HAARP program or project as being responsible for negative weather patterns in their country.

This Awareness indicates of course there are some countries affected by this that are not aware of the cause of these weather patterns. This Awareness indicates if entities wish to read more in regard to the HAARP program, the Leading Edge publication in late Winter or early Spring of '95 has information in which various scientists discuss this project and its ramifications in regard to the weather.

This Awareness indicates that this publication contains a number of discussions of new technologies that are being used and have been developed for use in ways that affect the masses of people or can have an effect on the masses. Some of these technologies are frightful, when it is realized that they are all ready and usable and some being already used.

WILL THIS RAISIN RECIPE RELIEVE OR CURE ARTHRITIS?

We received, over the Internet, what is called "An unusual recipe for relief". I'd like to read this and ask Awareness if there is anything to this. The source is sort of vague. It says:

"(1). Empty one box of golden light raisins into a large shallow container. (2) Pour enough gin, (cheap as you can buy) to completely cover raisins. (3) Let stand uncovered until all liquid disappears. About 7 days. Stirring occasionally helps the evaporation process. (4) Then place raisins in a covered container. I use a Cool-Whip carton and eat just 9 raisins a day. If you don't like raisins, put them on your cereal or in a salad.

"I began eating 9 raisins a day on October 10th. By November 10th, my calcified knees, which sounded like castanets whenever I bent over, no longer clicked so loudly, and I was able to walk up and down those small steps from the sidewalk to the street outside our building without turning sideways to go one step at a time or hang on to a parked car.

"I could bend my head back to look at the stars without leaning against a tree or fence or holding the back of my neck for support. A couple of weeks later, the swelling and pain was gone from my arthritic toes. By December I could again close my fingers into fists. Before October 10th, a silver knife would slide through either hand. I can now hold a nut pick.

"My whole body feels more limber. I can again do floor exercises including hugging my knees to my chest, and rock back and forth without pain and again handle needles and pins with greater ease. A dear friend in Hyannis, Massachusetts, gave me this recipe last September. She learned about it this past summer from her podiatrist who noticed her difficulty in getting up to leave the office.

"He learned of it from one of his patients whose hammer toe and knees were no longer swollen. She then could stretch her crippled hands flat upon a table, all after just a day. Before her retirement she was a school assistant dean of the Medical School at Georgetown University. The podiatrist and his friend have been eating these raisins and have been playing their best golf for more than 30 years. They are in their seventies.

"Why does this recipe bring such fantastic results? As far back as early Biblical times, the people of India and Egypt discovered the healing properties of juniper berries. Gin is made from natural grains and juniper berries. Even if you are on medication that advised against alcohol, you can eat nine raisins a day. Most of the alcohol has evaporated and a small amount would be insignificant. That comes from my own physician."

Would Awareness comment on that recipe?

COSMIC AWARENESS:

This Awareness indicates that the recipe appears to be that which helps to cleanse and heal the liver. The effect of the liver cleansing is that which has an influence on most of the other important organs and also on the purification of the blood. This Awareness indicates that the glucose sugar of the raisins of course give energy and it is of a small enough amount so as not to create high blood sugar for entities who are diabetic, therefore, it appears to be safe for most everyone, when used as directed.

If an entity has excessively high blood sugar and cannot comfortably use 9 raisins at a time, the raisins can be spaced out over the day. This Awareness indicates that it does appear to have certain other properties, such as enzymes that are beneficial in helping the physical body and the hormonal and lymph nodes of the body. This Awareness indicates that it *does* appear to be of significance for entities, especially for those who have a tendency toward arthritis or stiffness in general or whose liver may be sluggish.

Ed's Note: For a long time I have had one joint on my ring finger painfully swollen, probably arthritis inherited from my mother who had it really bad. Vikki went to the liquor store and bought a pint of cheap gin and at the healthfood store a large packet of golden light raisins (not the black ones). It took the entire pint of gin for the pack of raisins. I have only been on this recipe for about 10 days, but the pain in the joint appears to have mostly disappeared. The joint, however, is still swollen. (I told Vikki she should have just given me the pint of gin; that would have killed the pain almost instantly). I'll keep you posted if the swelling goes down. In the meantime, anyone using this recipe, please drop a line to Vikki and let her know whether it is working as described in this reading. Thanks.

SHOULD CAC CHARGE CRYSTALS DURING THE TRANCE SESSIONS?

(Will These Help Develop More Interpreters?)

QUESTION:

We had a suggestion from one of our members who was into researching crystals, that we charge crystals during the trance sessions to offer to the membership. This would be done by Paul holding one in his hands as he goes into trances or possibly a bowl with some near his head.

Would Awareness comment on the effect that would be achieved, if any, by such charging and what possible ways members could use such charged stones? Also, would there be a particular type of stone most effective for such linking to trance energies in this manner?"

COSMIC AWARENESS:

This Awareness indicates that the use of quartz crystals being held by the Interpreter as he enters into trance, or being placed close to the Interpreter's head could give the crystal a certain charge or frequency attunement to the trance level the Interpreter enters so that the frequency of this Awareness, the vibratory rate of this Awareness could be transferred into the crystal.

The entity receiving that crystal could then hold the crystal, either in his or her hand during times of meditation, or place the crystal to the forehead during meditation and attune to the crystal, and thus, by letting their own vibration merge with the vibration of this Awareness in the crystal, experience to some degree the frequency of this Awareness.

It will require that entities surrender themselves to the frequency of this Awareness, and holding the crystal to their forehead can be helpful as a tool for this to occur.

This Awareness indicates that this would be a kind of meditative experiment which should be helpful to entities wishing to become more attuned to this Awareness. This Awareness suggests however, that the crystal should be placed immediately into some flannel cloth when taken from the Interpreter and not touched by human hands until the recipient receives it.

This Awareness indicates the recipient should keep it in a spot wherein others do not handle the crystal, so that it is simply charged with the frequency of this Awareness, and available to the recipient only. This Awareness indicates the recipient should also wash his or her hands before handling the crystal without the cloth being around it.

This Awareness indicates that the size of the crystal is not seen as significant, but that the larger sized crystals could be more potent than extremely small crystals. The vibration would be basically the same however, but not as much potency in the smaller sized crystal.

A BOWL OF CRYSTALS WITHIN THE INTERPRETER'S AURA?

QUESTION:

Did Awareness say that a bowl of crystals, placed within the Interpreter's aura, not necessarily handled by the Interpreter; would these be charged essentially the same way?

COSMIC AWARENESS:

This is in the affirmative. This Awareness suggests that the bowl should be within eight to twelve inches of the Interpreter's head in order to be within the aura during this trance session. This Awareness wishes to clarify this. The crystals should be within eight to twelve inches, preferably within eight inches of the Interpreter's head in order to receive the vibrations of this Awareness.

This Awareness indicates in other words, a rather small eight-inch bowl or less, that is relatively deep would be capable of fitting within the aura of the Interpreter, so as to receive the greater amount of frequency and vibration from this Awareness. This Awareness indicates a more flat bowl that is larger would be suitable, but the further crystals may not receive sufficient energy, particularly if the aura is not well-formed at the greater distance of twelve inches.

This Awareness indicates essentially the entity's aura extends approximately twelve inches above the crown of the head but the aura is stronger at points within eight inches. This Awareness indicates in fact, the eighth chakra of an entity is approximately eight inches above the Interpreter's head, and this would lie in the midst of the crystal energy, if placed within that eight-inch aura.

CLOSING MESSAGE:

This Awareness indicates that entities using such crystals are encouraged to leave the crystal lying above their heads when they lie on a flat surface, at approximately the same distance, within eight inches of the crown of their head, and move into a state of meditation by raising their right hand to their forehead, and visualizing mind or all ideas, words and concepts going into that right hand, and when this has been completed, bring the hand down to their side, near their hip, below their hip.

This Awareness indicates then raise the left hand to the middle of the forehead, and visualize all emotion, attachments, fears and desires entering into the left hand, and bring this down to their side, and letting go of mind and emotion; then bringing the empty hands back up to the side of the head at the temples, and from there, moving into the center of the forehead and visualizing feeling, the concern for that which is happening around one, that which is going on in the room or in the local area, which one is aware of; visualize all of this concern going into the fingers, and bring both hands down to the sides, by the hips.

This Awareness indicates at that point, the entities may raise their hands to serve as antenna, to draw in this Awareness to themselves, and at such point where the hands are drawing in this Awareness, visualize it going up into the middle of the head and shooting out the top of the head to the crystal that lies above one's head, and visualize the crystal lighting up. Then the entity would be attuned to this Awareness, and the entity can then experience oneness with this Awareness in the meditation, and you may let that meditation continue for several minutes until you are ready to exit.

At this time, you may then bring the hands down, pick up the feeling, place it back into your forehead, pick up the emotion with your left hand, place it back into your forehead, pick up the mind with your right hand, place it back into your forehead and open your eyes and be whole again.

This Awareness indicates that this will be a very pleasant meditation. You may also find yourself able to answer questions that you may ask in meditation. This Awareness suggests that this may come to you in pictures. It may come to you in images. Be careful to avoid the word "I", because it will break the union with this Awareness, for there is no "I" or personal self when you are attuned to this Awareness. This Awareness indicates that the "I" is placed aside, the self is placed aside when you place aside mind, emotion and feeling. Therefore, what is left is this Awareness.

Thus, rather than answering a question with the word "I", you may find yourself muttering or uttering the words "This Awareness Indicates", and the indication will be followed by certain information. You do not need to speak aloud. It can be done silently.

This Awareness indicates that some may find it not easy to think when in trance. You may find instead that the words disrupt your state of consciousness, and you may find it necessary to avoid thinking or allowing words to interfere with your state of consciousness. In such action, you may find it easier to simply observe, looking at pictures, images, or energies, and recalling later those things that you see.

This Awareness indicates that in order to speak while in trance, in order to think while in trance, the thoughts need to be generated not from within your own mind, because your mind has been placed aside, but as a response to the urging or prodding of this Awareness. You may speak in reflection to that which this Awareness indicates, but you cannot initiate thought and stay in the state of consciousness necessary for this Awareness to remain.

This Awareness indicates in other words, something else has to initiate the thought or the words that you speak in behalf of this Awareness. Perhaps an assistant or perhaps you can float to the surface long enough to ask a question, then move deeper into contact with this Awareness and find a response at that time, but the initiation, while in attunement to this Awareness must come from somewhere other than your own mind, for initiating something from your mind would bring the mind back into your consciousness and would cause you to leave your state of attunement with this Awareness.

This Awareness indicates you could put a question on a tape recorder and allow the tape recorder to play the question after you have entered into the trance and attunement with this Awareness. It is seen as possible to push the button on the tape recorder without it interfering with your attunement and a question asked via a tape recorder, then turning the tape recorder off, or to record, would allow you an opportunity to respond in accordance with the energies from this Awareness to record your message or to speak your message in response to the promptings of this Awareness.

It is simply that you cannot initiate a thought or spoken words while attuned to this Awareness because technically, there is no "you" there to do so, unless you bring your mind back into yourself, and in so doing, you displace this Awareness so that you are no longer attuned to this Awareness.

This Awareness indicates however, you can perhaps attune yourself to this Awareness and look for some message from this Awareness, then displace this Awareness and become your personal self and recall and speak of what you have seen from this Awareness while attuned. Thus, without a recorder, you could search by attunement to this Awareness for information, then separate from this Awareness and recall what you saw.

This Awareness indicates it is simply a meditation that you can play around with that can be beneficial in helping you to become more attuned to the energies of this Awareness. This can be rejuvenating to you if you do it properly, if you do not over-indulge for too long, and if you enjoy the experience, it can help to bring a greater vitality to your system.

This Awareness suggests you start out with not more than 15 minutes. You may later expand to long periods of time, according to your energy levels and according to that which is pleasant for your meditation. The key points are to place aside mind, emotion and feeling, and have your focus to where you can turn your attention up through the pituitary to the top of the head and to the eighth chakra, where the crystal lies, and attune yourself to the frequency or vibration.

Ed's Note: This reading was given in March, 1995, and beginning in the September session, Vikki began placing a few experimental crystals within the aura of the Interpreter during the sessions. She plans to give these to certain entities she knows who are trying very hard to become channels for Cosmic Awareness and possibly future Interpreters for CAC.

The procedure outlined by Awareness in this reading is precisely what the Interpreter Paul Shockley does each time he enters the trance state; he places aside mind, emotion, and feeling by touching

his forehead and then carefully placing the hands aside. You may be interested to know that Ralph Doby, the first Interpreter for Cosmic Awareness would sometimes use the tape recorder when no energizers were present. He would tape questions on one recorder that he wanted Awareness to answer, leaving five minute or so blank tape between the questions, then start a second recorder to begin recording the Awareness response to his questions. He would start both recorders, lay down and place aside mind, emotion and feeling and enter the trance state. When the first recorder plays the first question Ralph had recorded on tape, Awareness then responds and the second recorder records the answer to the questions. In this manner Ralph was able to contact Awareness for important information whenever he wished. One of the most eloquent of such messages was given only a few weeks before Ralph passed over. This concerned "The New Creation" and the coming of the New Being and was published by CAC in issue number 85-1 (\$1.50 from CAC).

WHEN ONE SPOUSE DENIES THE OTHER A SPIRITUAL PATH

QUESTION;

A question from R.H., of Lake Zurich, Illinois

"Twice before, I turned back from my spiritual path because my husband demanded that I stop, or he would divorce me and leave me with two small children to care for. Now the children are older. I have a small amount of money that I earned for myself, and I chose to be about the process of being responsible to myself and Source. Forcing anyone to accept responsibility for themselves is impossible; yet one person in the marriage is trying to control for fear of change, and one wants change for self and the entire planet. One attacks, one avoids and retreats. We are polite to one another, and a sense of duty to the children holds the 16-year marriage together so far. I feel his pain as well as my own. My own inner sense tells me, "Let it be. Let it go." It is very painful to watch. This seems to be a thoroughly common problem between "awake" persons and those they love that hang on to the past. Would Awareness care to shed some light on this rather general problem?"

COSMIC AWARENESS:

This Awareness indicates that many times, one entity will experience certain types of impulse to move along a spiritual path, developing these aspects of consciousness for a period of time. Much of this is associated with astrological influences or with psychological influences from childhood, or with psychological influences based upon interest that has developed from the past, or based upon insecurities, or based upon an inner calling of the soul. That this may be in terms of an entire lifetime, or for a major portion of that lifetime, or it may simply be a small cycle of development, such as three or four years, or a decade.

This Awareness indicates that another entity may be experiencing a great need to be more involved in the material realm, or in the social realm, or in the economics of the society, or in the areas of personal prestige, reputation or accomplishment; or in the area of rational and scientific exploration, and this entity may have very little interest in the spiritual areas; that this also may be of a long duration, existing through an entire lifetime, or it may be for a short duration, for a cycle of four or ten years, for example.

This Awareness indicates that when entities come together with some common interest, they often have expectations of each other, thinking that since they have this area in common and are attracted to each other because of this or that particular common interest and compatibility, that therefore they are mated or suited for one another in other respects also. Usually such entities soon discover that there are areas where they are not compatible at all, or wherein the other areas are to be avoided and not discussed for fear of conflict.

This Awareness indicates that often such entities move along the path together relating in those areas where they are compatible, and avoiding those incompatible areas, until one or the other becomes bored with the simplicity of the relationship and the lack of totality or fullness in the relationship, and therefore, attempts to expand and enter into those areas that are taboo in the relationship; and wherein this occurs, conflict may follow.

This Awareness indicates that wherein one entity is involved in a cycle of spiritual development and the other entity has little or no interest at a particular time; this conflict may be of a temporary duration, and therefore, the conflict may be that which needs not be considered as of great urgency and of needing resolution, for the entities involved may eventually switch roles; the one on the spiritual path may find a kind of inclination to move into some rational study, or into some physical security pursuit which also may be of a cycle or of short duration.

That wherein these cycles are kept in a level of balance and not made to be of extreme purpose; whereby the entity pursuing the spiritual path also is able to exist on the physical level, attending to the needs of the economic, social and the rational pursuits of family and domestic needs, in the mundane sense; such an entity is basically well-rounded and is not neglecting the lower vibratory needs and escaping from reality into spiritual concepts; and therefore, this entity can be flexible enough that it is not a problem.

This Awareness indicates wherein an entity pursues the spiritual path to such a degree as to become negligent of all mundane needs and responsibilities to those who are dependent, or somehow tied with that entity; this can often create some difficulties in the entity's life. That likewise, when an entity is in such pursuit of material interests and social interests as to not have any interest at all, and in fact perhaps being afraid of anything of a spiritual nature; that entity may be so immersed in the concept of physical reality as to not be in touch with spiritual realities.

This Awareness indicates that wherein this is extremely polarized between two entities and is not on the level of a brief cycle, then it creates much difficulty and stress in the relationship; and even though there are some areas wherein entities have qualities and interests that are compatible, there may be an outweighing of those compatible interests and qualities with incompatible interests and incompatible qualities.

That when this becomes overbalanced in a negative sense, and the incompatibility between entities becomes too strong, then it is appropriate that the entities either seek out outside assistance in finding some form of counseling to help bring about a greater compatibility, expanding the area of compatibility and diminishing the area of incompatibility; or, if entities do not wish the outside, third-party counseling effect, and can communicate with each other and discuss these areas, or to meet in confrontive energies, regarding the incompatibilities and the compatibility areas; wherein entities can either work this out alone, or with outside assistance; this becomes the key question as to whether these entities can remain together, or whether they will move in separate paths.

This Awareness indicates that in order for entities to remain together, the area of compatibility must be expanded. Compromise or recognition of each other's

rights and interests to be involved in certain areas of interest and certain activities; this recognition and respect for each other's rights *must* be allowed in order to enhance the compatibility area: for if one entity dictates and refuses to allow the other to have certain rights and freedoms, this area of compatibility will diminish in the manner and proportion that the entity's expression is stifled.

That wherein the interests are similar and compatible; this is the area which glues the relationship together. Wherein the interests are separate and incompatible, this area is a potential for trouble. But wherein even the incompatible areas are respected and acknowledged by both parties, wherein the parties allow each other to have the space for their own being, even though they are not in agreement on the activities, qualities or expressions of each other; that mutual respect which allows each to be the individual which he or she wishes to be; this mutual respect of each other's rights is that which can allow for incompatibility areas to exist in the relationship without destruction of that relationship.

The Master/Slave Relationship

This Awareness indicates however, when one entity is intolerant of another's expression or right to be, and the incompatibility areas are not allowed, and the entity insists that the relationship must center around the compatible areas, and no incompatible concepts or activities or interests can be allowed from the other partner, then this becomes a slave/master relationship, a dictatorship, wherein one is the possessor not only of the relationship, but also of the partner's life and soul.

This Awareness indicates that this possession of another entity is that which is, in a spiritual sense, grounds for separation from that one who would possess. This Awareness suggests that *no* entity should be in bondage to another. Entities may willingly be loyal to each other; but to be in bondage, in particular in bondage to think and act in such a manner, as is opposed to spiritual development and growth; this form of soul bondage is that which is inappropriate. For each entity's personal life, personal soul-growth and spiritual development is that which not only is guaranteed by the Divine Forces as a Divine Right; this is also exemplified in the Constitution of your country, wherein entities have the right to believe and worship according to their dictates.

This Awareness indicates that for an individual to deny another the right to think or to pursue a spiritual growth; this is a gross violation to that entity's soul. This Awareness indicates that it is the responsibility of each entity to pursue the path of spiritual development according to one's own understanding, inclination, and ability. That in order to minimize the conflict involved in such a relationship, the entity seeking to escape from such bondage can express the affection, love and loyalty that the entity feels toward the other person, but also can express the urgent need, and how it feels, and why it is necessary for that entity to pursue the spiritual path.

This Awareness indicates that you do not need to totally reject your husband; you may simply reject that one demand of his, and simply inform him that you love him, you care for him, you wish to stay with him, but you *must* have that freedom to pursue your spiritual growth and development.

This Awareness indicates that you have as much right to lay down ultimatums as does he; and it is a matter of how these are stated, whether they are diplomatic,

whether they are stated in ways which do not appear as threats, or whether they must be stated as threats. That depending on how you relate to this entity, and how threatened he feels, will determine whether the impact of your statement allows you to be free with his good graces to develop and grow, or whether you must move on your path in spite of what he states.

This Awareness indicates it does not appear to this Awareness that this entity would be so rigid as to curtail your interest and ability to move toward spiritual pursuits. It appears the entity has some fear of what might develop if he does not control your thinking; the entity appears to have some insecurities in regard to your loyalty toward him, and also in regard to his own self-image and desire to be all-important to you. This Awareness indicates that the entity needs to be informed through words or actions of any magnitude necessary, that you are *first* dedicated to your own soul-growth and development, and also to your loyalties to him and to your children.

This Awareness indicates that once this has been clearly stated, the chips may fall where they will; the pieces will arrange themselves. Even if the entity somehow refuses to allow you to move in your spiritual pursuits, he will see his dictations as being futile in controlling your soul.

This Awareness indicates that you *cannot* sell your soul, even to your mate. Your soul must be dedicated to that which is the universal creative forces which give you your life and soul. This Awareness indicates that entities who put the Divine first shall have little difficulty in reorganizing and setting priorities; this in spite of various demands of petty demagogues and entities who wish to pursue power over others.

This Awareness reminds you of the song by Leonard Cohen, wherein he speaks of "those who must lose everything that you cannot control; it begins with your family, but soon it comes round to your soul." *

*ED's Note: From *Sisters of Mercy*: Leonard Cohen's first LP titled, *Songs of Leonard Cohen*. (If you are not familiar with the mystical songs of Leonard Cohen, we suggest you check him out next time you are in your favorite tape and record store.)

In relation to the message just given by Awareness, CAC recently received a letter from a lady, who has been a member of CAC for many years, that her husband is not only divorcing her for reading the Awareness material and other things of a similar nature, but is taking her copies of *Revelations of Awareness* into court in an attempt to show she belongs to a "cult" etc. Evidently he believes this action will sway the judge into granting the divorce and the property settlement in his favor. Over the years we have had several letters like this one, each time making Vicki T. cry as she reads them, for it is such a frustrating feeling of helplessness as to what to do about it. (We usually put such letters into the Healing Wednesday energy field, where it is turned over to Awareness to deal with.)

When the Interpreter, Paul Shockley, underwent his four-year lawsuit ordeal to drive him and his church off their rightfully-held property in Oregon, a similar tactic was dreamed up by the opposing lawyer; he too, came into the courtroom waving a batch of our *Revelations of Awareness* newsletters, and crying out to the court: "And here, your honor, is proof that this man is involved in a cult!"

(I have a feeling there is a special place in the afterlife for people like that). Avaton

COSMIC AWARENESS: (OPENING MESSAGE): 6/8/95

This Awareness suggests that entities not forgot occasionally to spend time in silence, to spend time meditating, just getting centered and feeling a quietness, a solitude, attuning to Divine Energies. It is easy in a hectic world to feel the need to be constantly busy, trying to keep up, trying to deal with things that seem urgent, but this Awareness indicates you will find yourself better able to handle the various types of energies and the crises in your life if you spend time in solitude, in getting centered, in being attuned to the Divine energies.

THOSE WHO ALMOST MAKE SUPERSTARDOM--AND THEN DIE

(CHECKS AND BALANCES OF THE SOUL)

A question from John Y., in Oklahoma. I'll read it as he's written it here. It's sort of informal.

"What is the karma, if any, to guys and girls, like Freddy Prince and John Erik Hecston (sp) and countless rock singers (remember the Big Bopper?) who climb all the way up and finally reach that last rung to stardom; I mean these people have the world *almost* at their feet, and then they die? This is weird, and it bothers me, as an out-of-work extra for the movies.

"And the list is endless: Patsy Kline, Buddy Holly, who was ten times better than Elvis. George Reeves, TV's Superman, Gene Roddenberry; and I'm sure you people can add to the list. I don't mean people like Hank Williams or Steve McQueen or Bruce Lee: these people were *already* stars. I mean the "Almost-There's."

COSMIC AWARENESS:

This Awareness indicates the entity appears to be focused on the entities who didn't quite reach Superstar status, but were so close, and the question being: "What kind of karma brings on this type of situation wherein they die prior to reaching their goals?" This Awareness asks if this is the correct interpretation as the questioner sees it?

QUESTIONER:

That is correct.

COSMIC AWARENESS:

This Awareness indicates entities have deep within their psyche certain expectations of themselves as well as certain feelings of limitation. Often an entity will set a goal that he or she feels is really beyond their ability, beyond their capacity, but the ambition and the desire is so strong that they pursue that goal, and in some cases, it comes easier to them than they would expect.

This Awareness indicates that there may still be within the psyche a kind of self-destructive quality or tendency so that on a subconscious level, they do not want the total success they consciously strive for. This Awareness indicates that often it is set up on a subconscious level to have them reach, but at the last moment, to lose that which they reach for.

In some cases, the entity may have a feeling deep within the subconscious that he or she would misuse the power and prestige that would go with the total success and therefore, they have a subconscious check to stop them from reaching that ultimate goal. This Awareness indicates in other words, the subconscious of an entity may stop them from achieving their ultimate dream for fear that they might misuse the prestige, power and

influence that goes with such success.

This Awareness indicates that in other situations described, there are other forces that destroy the entity which are not of his or her own making. A dark inimical force, for example, might take the life of someone in order to prevent them from doing good things for humanity, might cause the entity to have a fatal accident or to bring about some kind of incident that stops them from further pursuit of their career, simply because such a powerful force for good would hinder the efforts of the negative force.

Dark Force can Still Get the Spiritually Enlightened Entity

This Awareness indicates that this is generally quite rare, but it does occasionally happen, that the Christ Light of entities would be crucified by a Dark Force is not something new. This Awareness indicates that most of the time the spiritually enlightened being is able to overcome the darkness that may pursue or seek to destroy the Christ Light, but there are times when the Dark Force destroys the innocence of an entity, and when entities are spiritually enlightened, but somewhat naive, they become especially vulnerable to the Dark Force energies that would prevent them from carrying out their full potential as a Light Worker.

The Murder of Jimi Hendrix

This Awareness indicates that on other occasions, great talent is often the target of evil entities or entities who have diabolical intentions. This Awareness indicates the case of Jimi Hendrix, for example, wherein this entity was forced to drink battery acid, and was thus killed by entities who did not like the influence this entity had over young people in his music.

This Awareness indicates that it was neither suicide, nor was it a drug overdose as it was purported to be, nor was it a karmic event, nor anything the entity consciously brought upon himself. It was outright murder. This Awareness indicates there are many different areas covered in this question, different ways by which entities have been terminated. It is not always a karmic problem.

This Awareness indicates probably the closest aspect to karma would be the subconscious attempting to block the success of an entity. In that case, the karma would be carried out by the entity's own subconscious which could bring on an accident or some incident stopping the entity's further success.

WILL THESE ENTITIES HAVE TO TRY AGAIN?

FOLLOW-UP QUESTION:

Awareness has indicated that in the case of the suicide, the entity invariably must come back and reincarnate and work himself back to the same point approximately in that new lifetime where he took his life in the former, and to be challenged once again by whatever it is he came to overcome during that lifetime.

There isn't, in the case of entities like in the question here whose lives were taken in a non-suicidal way, a similar thing, wherein after their departure, they are compelled to come back and try it over, and this time become the Superstar and this sort of thing. Is there a law like that?

COSMIC AWARENESS:

This Awareness indicates that this is negative. This Awareness indicates that it is not a situation in which entities are compelled to come back and pursue Superstardom because they had fallen short in a previous lifetime. This Awareness indicates that it is possible, however, that an entity may *choose* to come back and pursue that course he was denied in a previous lifetime.

Thus, the entity may seek to achieve that which fell short in a previous lifetime so that he may still seek the fruit of success in a subsequent lifetime. This Awareness indicates that this is not something of a principle or common law among entities. It would be a matter of personal choice.

This Awareness indicates an entity who is pursuing a certain dream and is cut short, may come back in a subsequent life and have a great desire to finish that which was not finish in the previous lifetime and thus, the entity may then pursue something of significance, perhaps not the same thing, perhaps something totally different.

For example, an entity in one life may pursue a political career, seeking to become president or something, and fall short and perhaps die before reaching the success he or she pursued, but in a future lifetime, the entity still pursuing a goal, might have a totally different focus.

The entity might seek some kind of Superstardom in drama or in sports or in business, but the pursuit might not have anything to do with the politics of his previous lifetime, but he may still have as much ambition and drive, and the entity might in fact become successful in his new venture, in his subsequent lifetime.

This Awareness indicates that normally, *It* speaks of "this" or "her"; and in this reading *It* was negligent in using the old English format of using the word "his" in a way that implied "his" or "her" but did not speak of "her." This Awareness indicates that *It* did not mean to exclude "her" from the references of the entity being discussed.
