

NEW WORLD ORDER PLANNERS HAVE NOT GIVEN UP

OPENING MESSAGE:

This Awareness indicates that the efforts and movement toward the New World Order are still in force. There has been considerable set-back because of the delays and the timing that may work favorably in preventing this from developing as planned, but the entities involved have not given up their efforts and are still working to bring about this New World Order.

This Awareness indicates that there has been a doubling of effort on the part of some of these entities to bring off the plans and programs of the New World Order. The NAFTA and GATT programs have been effected and are being worked on, which could have considerable negative effect on the United States' economy; although there appears to be some temporary benefits from the NAFTA program that can give the impression of a long-term benefit, it does appear that this will be short-lived in terms of its overall effect on the economy.

The Hildebrand Suit Against the Federal Reserve

This Awareness indicates that the case against the Federal Reserve Bank has had two set-backs in the courts, wherein Schwasinger and Hildebrand have both suffered certain convictions, the courts being part of the effort to get rid of this case once and for all. This Awareness indicates, however, that the roles played by Hildebrand and Schwasinger have long passed their importance and these entities are more or less expendable to the efforts of those who are working on this case.

Hildebrand as having turned over his responsibilities approximately 6 months ago to others, and Schwasinger having given up his responsibilities approximately one year or so previous to that. This Awareness indicates that there are still many things happening in regard to this case that cannot be discussed publicly, as it would allow for an exposure of plans and procedures being used by those involved in the suit against the Federal Reserve Bank

This Awareness indicates, however, that if there are entities who feel that they have been cheated or that the court's ruling is the final word, entities are still able to receive their three hundred dollars back simply by requesting it. Of course this will invalidate any of their claims, but This Awareness indicates that if you have any apprehension about the situation and believe the case is settled because of these court rulings, then you might choose to get your three hundred dollars returned to you.

This Awareness indicates that both Hildebrand and Schwasinger expected that their cases would possibly be ruled unfavorably because of the nature of the proceedings, wherein certain information would not be allowed by the judges. It was what many called a Kangaroo Court, wherein the information that is crucial to their case, relating to certain Constitutional points of law were kept out of the case, and therefore the rulings went against the entities.

This Awareness indicates that this of course allows these entities to have legal rights to appeal and by following Constitutional Law, the entities would have a good chance of winning in the appeals court. This Awareness indicates that in another area regarding another issue, there are certain rumors of a great number of alien spacecraft surrounding the earth in what is presumed to be military formations. This Awareness indicates that these rumors are in part nothing more than misinformation as part of a disinformation program to be used over a period of time to convince the masses that there is a threat of extraterrestrial invasion of the earth, so that the suggestion of Kissinger from several months ago, "that it was time to play the ET card," can be recognized as the reason for these rumors.

"He also asserts the government, for 50 years, has kept secrets about UFO's and alien beings on earth, and that the secret may not hold much longer.

"Some say Clinton is threatening to come out with the alien story if he is hounded any further on White Water" Leibovit writes: "One or more of these events could be enough to send the financial markets into panic". ..

"In an interview, Leibovit said that his conspiracy theories aren't central to his investment strategy, but he's bearish on stock markets anyway. "We may be in a topping phase now, and starting a multi-year bear market," he says: "These things may not come to fruition for 10 years, but the day they do, if you're in the market, forget it"

So, one of the questions here is the information about Clinton coming out with the alien story if they continue to press him on White Water. Is there any truth to that?

COSMIC AWARENESS:

This Awareness indicates that this appears to be a minor consideration. It does not appear to be something that is being heavily considered. The entity has groped about in many directions for way to end the White Water investigation, as it has become likened unto a nuisance to him, very distracting from his purposes and goals for his administration.

This Awareness indicates that it does not appear to be something that he is considering very seriously, but it is something that was brought up as a suggestion, and is on a back-burner, very far back, one of many optional things to consider.

THAT AMTRAK TRAIN SABOTAGE

QUESTION:

What can Awareness tell us about the Amtrak train sabotage recently, which was a very sophisticated act of terrorism, some people are saying, and there were notes left by the so-called "Sons of the Gestapo", claiming that they were doing this in retaliation to Ruby Ridge and the Branch Davidian murders. Some of the information going through the Internet is that this was a set-up to connect the militia and particularly with the investigation coming close to that bombing of the Oklahoma building.

Can Awareness shed any light on that information?

COSMIC AWARENESS:

This Awareness indicates that it appears that there is a connection between government agencies and the event, whereby it is an attempt to further the investigation and connection of the militia groups to terrorist labeling of these groups. This Awareness indicates it does not appear to be connected to any of these groups in reality, but it appears that there will be the effort, and that if this is not successful, that it will result in still another terrorist type activity in an effort to get public opinion rallied against the militia and patriotic organizations so that if and when a government crackdown on these organizations occur, the public will be in agreement with the government activities.

AMTRAK DISASTER DESIGNED TO HELP PASS ANTI-TERRORIST BILL

FOLLOW-UP QUESTION:

Is this yet another outrage to help get this anti-terrorist bill passed that's moving through Congress?

COSMIC AWARENESS:

This is in the affirmative. The anti-terrorist bill is one part of the reason for this action. There are other things that are valuable to the government's policies in having this kind of event occur. This Awareness indicates that the more outraged the masses are from such activities, the more welcome will be any crackdown on patriot and militia groups. In the event of such a crackdown, those groups that are merely patriotic and have no militia qualities will also be confined and accused of being a militia, though they have no military qualities in the organizational activities.

There's a great amount of distortion that is being planned and is being presented in regard to patriotic groups and their connection with the so-called militia groups, and even though there is no clear connection of some of these patriotic groups, their research being strictly in legal areas and research; the plan is to make them appear to be part of the anti-government conspiracy. By referring to anti-government conspiracy, *It* refers especially to anti-New World Order conspiracy.

These patriot groups are very government oriented, as government is described by the Constitution of the United States, which is the law on which this country is based, but they are not necessarily aligned to the New World Order faction of the U.S. government; the government being created as a kind of shadow government serving the New World Order against the Constitution of the United States.

THE U.S. SOLDIER WHO REFUSES TO WEAR UN UNIFORM

QUESTION:

Along that same line there's been a lot of information going through the non-controlled press and the Internet, about a U.S. soldier in Germany who refuses to wear a UN uniform. I only saw one actual notice of this in a controlled press paper, but essentially, it says here in the *Spotlight*:

When Michael New enlisted in the US army more than two years ago, he swore to " support and defend the Constitution of the United States, against all enemies, foreign and domestic." Although New knew he might be asked to give his life for his country, the 22 year old Conroe, Texas, native jumped at the opportunity to serve in Europe. New was thrilled when told his unit would move to Macedonia as part of a peace-keeping operation, but when New, a medic, was told he would be serving as a UN troop, wearing the blue beret and armband, the thrill turned to disappointment.

"At the time of his enlistment, New did not know he would be ordered to fight and possibly die for the New World Order. The soldier never promised to do that, so he told his commander he would not don the UN blue. The army is expected to order New's unit in the 3rd Infantry Division to begin wearing UN patches. New has said he won't do it. The army has threatened to kick him out of the service with a less than honorable discharge."

And it goes on. But does Awareness see that as being a significant occurrence? The beginning of something

positive, when a US soldier refuses to wear a UN uniform?

COSMIC AWARENESS:

This Awareness indicates that already this entity is being spoken of among the patriotic groups, and also among the militant groups, as a U.S. hero. He is being applauded for his action. He will have considerable support, and will be given sufficient support in terms of funds to be provided with good attorneys for his stand, if it should go that far.

This Awareness indicates that *It* sees this as being more likely something that will be settled quietly so as to keep from becoming a media phenomenon, and *It* sees this as something that will result in the entity being given a different post, a different job where he is not in the public limelight, whereby he can continue to serve the role for which he enlisted, but without great publicity.

This appears to be the probable direction for this incident in its future evolution. This Awareness indicates that if it does indeed become a major issue wherein the military does not back down and does insist that he serve in the UN, it will become much more significant and can backfire on the efforts of the New World Order in their use of US troops for UN purposes.

The Hale-Bopp Comet: What Exactly Is It?

QUESTION:

A question from Ted H., on this Hale-Bopp comet, which has generated a dozen questions. We asked Awareness about this last time, and *It* was very vague. He writes: "The October issue of the Art Bell Newsletter has a story about a newly discovered "comet", named for its discoverers the Hale-Bopp comet. This so-called comet is estimated to be one thousand miles in diameter, but it's described as "diffuse with some condensation and no tail." This object is coming from the direction of Sagittarius, although the article doesn't mention it, I believe I've heard from other sources that it is headed toward our solar system and due to arrive late '96 or '97. If I remember correctly, this seems to fit very closely with what Zecharia Sitchin claims the Sumerian writings said concerning the return of the planet of the Reptoid aliens."

Would Awareness please comment?

COSMIC AWARENESS:

This Awareness indicates that this does appear to be the same as that suggested by Zecharia Sitchin, although he did not describe this as the Reptoid-inhabited comet. It does appear that this is very much the same as what was described by Sitchin and that it is inhabited by Reptoids in a frozen state. This Awareness indicates that it appears to be that which was connected with the previous comet that plowed into Jupiter which had served as an advance ship of these entities; that this appears to be main body of the military group of Reptoids.*

This Awareness indicates, however, because the first contingent contained the leaders, this group will be much more in a state of disarray if they are successful in approaching earth. It does not appear that they would have a great ability to hold together as a military unit, but that they would be more scattered and confused were they to be successful in reaching earth.

IS OUR CALENDAR IN ERROR?

(When Will the Hale-Bopp "Comet" Really Appear?)

QUESTION:

One other question about this from Gerard R., Holly Wood, California. He writes: "The Hale-Bopp update: Richard Hoagland was a recent guest-host on the Art Bell Show. Hoagland heads the team documenting the existence of ancient Structures on the moon and Mars. His observations indicate Hale-Bopp is not as large as originally thought. Its visible brilliance is therefore something of a scientific puzzle. Comets derive their brightness from proximity to the sun, and this one is too far off to be flaring up as dramatically as it is. According to Hoagland, the only possibility is that Hale-Bopp's brilliance is artificially induced by some advanced technology to serve someone's purpose."

"The "someone," he speculates, is some part of what he terms "the dysfunctional human family, now spread around the universe". These unwelcome relatives want to take over our turf without having to fight us for it. As part of their plan, they are firing up Hale-Bopp and "nudging" it toward us in hopes of diverting our attention from another threat of critical importance.

"Hoagland states that our modern calendar is in error, and that our year when Hale-Bopp is due to arrive, stretching half-way across our skies, is *really* the year 2012, the final year of the Mayan calendar. At that time we face a world geologic catastrophe, which, if unheeded will extinguish the entire human race. "We can save ourselves" he says, by devoting our resources to building advance structures, similar to the great pyramid, based on the true physics, hyper-dimensional physics, which can stabilize the land-masses and prevent terminal earthquakes from occurring, but our unwelcome cosmic relatives will trump-up an invasion scenario, spearheaded by Hale-Bopp, to frighten our military into wasting our resources on the wrong threat.

"What about all this? Has Hoagland basically got it right, with maybe the substitution of the New World Order and their alien allies as the "someone"? Is our calendar really in error, as he says, and could Hale-Bopp be the harbinger of world geologic Catastrophe?"

Could Awareness comment on that information?

COSMIC AWARENESS:

This Awareness indicates that it *does* appear that the calendar used in the West is in error; that it has been in error long before the efforts of the Gregorian team in

their attempt to correct the calendar by adding the leap year; that the thousands of years prior to this effort allowed for a number of years to be clocked that were not corrected in their effort, and that the Mayan calendar year of 2012 and the Western year of 1997 do appear to be quite close, perhaps even synonymous.

Artificial Satellite Launched from "Comet"

This Awareness indicates that it does appear that this movement from the comet is an artificial satellite, launched in an effort to effect certain technological information to help determine position and distance. It is likened unto creating a triangular arrangement so that technology can be used to calculate distance and location.

QUESTION:

On October, 18th *Night Line* program with Ted Koppel, about two-thirds of the program was devoted to the discovery of the new planet called 51-Pegasus, and they interviewed the astronomers who discovered this, and they were shaking with excitement and said they

couldn't even sleep because it was so exciting and so forth to them.

They shot a video of it, but the interesting thing about Pegasus was it sort of moved up and down. You could literally see it on the videos they took, and they claimed it was definitive proof of a solar system other than our own, and its year is like four and one half days, and the main question they were asking, was: Do they think that the discovery of this new planet is going to prove that there's other life-forms in the solar system?

I was wondering if there's anything to them putting that out at this particular time. Is this anything other than just it's sort of newsworthy, or is there something else behind this?

COSMIC AWARENESS:

This Awareness indicates that it appears to be in the rudimentary stages; that there is still something further to come from this story that has not yet been released. That the further information is that which is the purpose of having released this information at this time. This is likened unto a preparatory bit of material to make room or make ready for something more significant to follow.

This Awareness indicates that the information appears to be incomplete and not totally correct as given. That it appears there will be further information following to help clarify this story. This Awareness indicates that it appears that the story should require some skepticism as to its reality.

Gen. Colin Powell: Can He Be Trusted?

QUESTION:

A question from Steve N., in Ajax, Ontario. He asks: "Who or what is behind General Colin Powell entering politics, and would he be a positive to the U.S, or is he part of the New world Order Agenda?"

COSMIC AWARENESS:

This Awareness indicates the entity has played a balancing act in which he tends on occasion to play both sides, at one point suggesting opposition to the New World Order in one way, and in another suggesting he is being manipulated by the New World Order. It appears that this entity is one who could bring a coalescing of the political arena in the United States, bringing together the heart of Republicanism and democratic qualities, bringing together religions and races, and serving both the patriots and also the New World Order, so that everyone thinks he is their own, to some degree.

The entity, once acquiring the support from all sides, could then very easily make a movement toward a particular direction that would serve either the New World Order or serve the patriotic order of the Constitution followers. This Awareness indicates it appears the entity has an ability to bring people together and to hold them and lead them so that whatever agenda he chooses to follow the people will tend to follow also.

This Awareness indicates that it appears that this entity could become a great hero to this country, but on the other hand, could also become one who betrays the country, and it appears the entity has not yet reached a point in his lifetime or in his philosophy or in his motivation so as to determine his own motives and purposes in life.

At this point, he is simply considering his options from a personal standpoint. This Awareness suggests

that the approach that entities can use in dealing with this man is to pray for him, that he will make the right choices for the good of humanity, for this entity has not yet chosen which side of the fence to be on, and therefore, he cannot be judged as to his worthiness for this side or another.

The New \$100 Bills Start to Appear

QUESTION:

Bill C., in California asks: "Does Awareness see any ulterior motives for the government introducing the new \$100.00 bills at this time?"

COSMIC AWARENESS:

This Awareness indicates that this is that which has long been predicted. The purpose stated as being to prevent cash from being used in drug transactions. The fact is that it can allow the government to track *any* kind of transactions involving cash so that even in the purchase of automobiles or real estate or any other legitimate transaction, the moneys used will have their own particular identifying marks, so that the movement of money from one place to another allows the government to know where the money came from, where it went to, and who followed in the receiving of it thereafter.

This Awareness indicates that even laundering, where it passes through several hands, will become less possible and more trackable with the new currency, for each bill having its identifying mark will be likened unto a check with its coded mark, where the paper trail that many entities fear will be now present in a cash trail, and therefore, entities in government can trace cash transactions much more easily, knowing where the money came from and where it goes.

Why Are Box-Cars Outfitted With Shackles?

QUESTION:

Richard S., in Grants Pass, Oregon, in a letter to Vikki mentioned that he had heard reports that were leaked regarding many box-cars outfitted with shackles to hold at least a million individuals. Is there any truth at all to that?

COSMIC AWARENESS:

This Awareness indicates that this is a leap in logic to assume that a box car with a shackle is necessarily for humans. It could be used for escorting animals. This Awareness indicates, of course, it depends on how these shackles are placed, and this Awareness indicates that it *does* appear that this does have some truth to it.

This Awareness indicates that this appears to be an exaggeration, but this Awareness suggests that it may well be the beginning of something that grows as time passes and as the escorting of entities from one place to another becomes routine, more such box-cars could be outfitted with shackles with very little difficulty.

This Awareness indicates that this is a bad sign and fits into the suggested agenda of the New World Order wherein entities who are seen as potential trouble-makers could be escorted away from their home and into concentration camps or death camps.

Find Evidence, Photograph It! Send to Media!

This Awareness suggests that entities should find evidence, and photograph such evidence, if possible, and write to newspapers and to political leaders around the country, presenting these photographs. Send such photographs to churches, and civic leaders. The more the information is released, the greater the chance of defusing it and the plan for exterminating the masses.

This Awareness indicates that the Nazi death camps would appear almost as kindergarten compared to the events that would follow in the event the New World Order death camps are set up for the extermination of the masses in this country who might oppose the New World Order.

This Awareness indicates once such a program is started, those involved in selecting who is exterminated can simply choose on the basis of their personal subjective whims. They don't like the way this person parts his hair, or the way that lady looked at him, and therefore, those entities are selected to go on the trains.

This kind of subjective extermination based on whims will become part of the procedure when anything of this magnitude occurs. It is not as though there is some kind of rule to follow now to avoid being put on the train. It is not as though you can control your life by being obedient or courteous or favoring up to someone: you may look too much like the person's father, whom he hated, or his ex-wife, and therefore, you are put on the train.

This Awareness indicates that there are many entities who think: "Well, if the New World Order comes down with its program to get rid of people, I'll just compromise myself and become one of them." This is not likely to be of any benefit, for there are too many ways wherein individuals put in power can simply distort or break or modify any of the rules and do whatever they want without fear of punishment.

This kind of thing happened in Nazi Germany and it will even be moreso in the future in this country if this kind of thing begins to happen.

Is China Preparing for All-Out War?

QUESTION:

Catherine W. asks: "Is China preparing for an all out war?"

COSMIC AWARENESS:

This Awareness indicates that *It* does not see this as "preparing" so much as becoming capable or becoming prepared in the event something requires an all-out war in the future, however this does not suggest that they are prepared. This Awareness indicates they have been testing nuclear weapons for some years, and it is possible that they will have nuclear weapons for the purpose of war within a few year, if not already.

This Awareness indicates that they have the potential for making huge armies, which they have not yet done, but the potential is there, so that if they should, at some future time, decide they need a gigantic army, they could very easily draw the army together. This Awareness indicates you cannot say they are "preparing" for all-out war. They have contingency plans on how to prepare if they choose to do so.

This Awareness indicates that it is recognized by the leaders of this United State that China is likely to be the next great super power, even surpassing the United States if things continue at the present development, for China's economy is growing faster than any other nation, and it has the potential for greater armies, and it has the understanding for making nuclear weapons.

China Soon a Super-Power, U.S. a Thlrld World Power

Give China another 30 years and it could well be the major super power in the world. Give the United States another 30 years of its continued present state, and it could be a third world nation.

This Awareness indicates that it is for this reason that many in the U.S. don't want to get on the bad side of China. It is also for this reason that many in the U.S. do not want to help China grow economically stronger any faster than is necessary. It is also for this reason that many entities in the United States do not want to create hostilities in China that would disrupt the friendly relationship with the United States.

Therefore, some argue that to make too great an issue out of civil rights in China would be dangerous. Others argue that to cater to China too quickly in its demands without their own changes in their behavior would also be a dangerous situation. Therefore, you have entities within the United States that view the same situation from two sides, each seeing the other side as a problem.

One thing is for certain: China, with its approximately one and a half billion people, is not going to go away. Therefore, it is a potential problem. It is also a potential market for the economies of many countries and to boycott China in hopes of shutting down its economy is not likely to be of much benefit, or to supply China with great amounts of energy is not likely to slow its development into a super power.

Therefore, a considerable amount of careful planning must be used, and much concern as to what happens with the aging leaders of China must be considered in any form of planning.

Project Deep Probe: What's Going On?

QUESTION:

Elana M., in Montana, sent in a news item out of the Billings, Montana, Gazette, dated August 3rd of 1995. It's a long article. It's about a study of the inner earth using explosives. I'll read a little bit of it:

"Come Monday night, an earthquake will erupt 200 feet underground inside an abandoned Uranium mine in the Gas Hills of central Wyoming. It will not be a big one. Few people will feel the rattling, unless they are nearby, when scientists detonate the roughly five tons of explosives that will trigger it.

"But the man-made tremor, and another four like it at sites from Alberta, Canada, to Southern New Mexico, will send sound waves rippling through miles of ground. As echoes rebound toward hundreds of electronic ears lining southern Alberta, central Montana and northwest Wyoming's Big Horn basin, they will paint for scientists a picture of the inner earth.

"In a geological experiment of unprecedented dimensions, both U.S. and Canadian researchers will in the next two weeks call upon methods commonly employed for oil exploration to peer far deeper into the planet than anyone has before. It's called Project Deep Probe, and Billings will serve as its base.

"This weekend, close to 100 scientists from around the world will lay out an effort that will employ many tons of high explosives and more seismographs than are available in North America. Nobody has ever put together this much equipment on as large a scale before.

"Geologists hope the project will sharpen their hazy view of the earth's vast insides, while also deciding practical clues that will ensure compliance with nuclear testing and improve our understanding of forces that molded the continent."

Anyway, Deep Probe will rely on nearly 800 self-contained seismographs, all synchronized to within one hundredth of a second of each other so their results mesh. It says "It's funded by the National Science Foundation and the Air Force; the U.S. portion of the project, and military scientists need to understand the mantle so they can tell the difference between tremors, and earthquakes and those triggered by nuclear bombs tested in violation of international treaties."

Is that story basically on the level, or is there

something more sinister behind that project?

COSMIC AWARENESS:

This Awareness indicates that this is essentially on the level along with other information being sought. These entities are also seeking information regarding the underground tunnels and networks of subterraneans and the underground bases that do or may exist under the surface of the earth.

This Awareness indicates there is some suspicion that great underground bases and tunnels and caverns may exist underground either from natural or from artificial activities of the past, and the scientists, particularly the government, wants to know about such places, for they could be useful for underground bases, or could be used by subterraneans presently alive, or could be used for storage of certain waste products, or products to be saved.

There is much that could be valued from such information. It would be far easier to use a natural underground cavern than to dig an underground cavern in order to store certain military secrets or military materials, for example.

This Awareness indicates also the potential of aliens living underground, which most scientists would reject, but which many in the government know is true, becomes of significance when considering these underground caverns.

This Awareness indicates there are also ancient legends of underground highways linking continents together which could be of interest to government, particularly if found to be true.

Space Telescopes Microwaves: Any Danger?

QUESTION:

One last question from Ray D., here in Olympia. "In the September, 1995, issue of Popular Science on page 82 and 83, an article called "Globe-Spanning Telescope", and that "ten radio telescopes from one giant eye in the sky are sending or picking up pictures." And he asks: "Are they firing microwaves in to space to get their information? And if so, what effect on earth and mankind are we to expect?" And he says also: "The local weather stations and police and military installations are firing microwaves all around us. What effects can we expect from all these microwaves?" Actually, there's two questions here, the first about the radio telescope.

COSMIC AWARENESS:

This Awareness indicates that these microwaves are not of such great strength or magnitude as to have any serious effect on humans, however, if such technology becomes more widespread and the use of this technology increases considerably in the coming years such as when or if people find more uses for firing microwaves and the microwaves become more and more pervasive, it could, at some future time become extremely hazardous to humans.

This Awareness indicates that it is likened unto X-rays being given to an individual. They are not particularly dangerous if they are few and far between, or if they are of short enough duration, but if an entity begins receiving mass numbers of X-rays or prolonged doses, then the entity is in serious trouble. At this stage, it is not a serious problem.

FOLLOW-UP QUESTION:

Does that include the microwaves locally, some running out of weather stations, police, military installations and so forth?

COSMIC AWARENESS:

This is in the affirmative. This Awareness indicates that the microwaves that are in use locally are relatively minor, even though the increase of these has quadrupled in the past five years. This Awareness indicates that it is seen that a hundred times as many microwaves could be tolerated without great negativity to humans, but at some point, beyond that, there would be an increase in damage; cellular damage could result in cancer increases and in other type of damage to the cells and to the immune system.

The metabolism and hormonal system could be damaged in humans, and entities might not even realize what caused the damages they suffer. This Awareness suggests that in approximately ten years, this could become a serious concern. At present, entities can counter the damages, which would be very minuscule, by using certain free radical antioxidant supplements that help to diffuse free radicals and supplements that strengthen the immune system.

However, even without such it is not seen as being a serious concern at present time.

Aging Blamed for Environmental Assaults**CLOSING MESSAGE:**

This Awareness indicates that the degree of damages from environmental assaults such as microwaves and viruses and bacteria can result in minor problems causing an entity to feel less energy, less vitality, or perhaps more susceptible to colds or sicknesses, but unless these are very strong assaults to the entity, most entities will not even notice any particular problem.

This Awareness indicates most entities should also notice that if they have lived a long enough life, the action of aging gets blamed for many things that are actually environmental assaults. You think that you are more tired now because you are older, but perhaps it is because there are more microwave energies in your area, or bacteria that are resistant to treatment.

There is more pollution in the air, and in the water, and perhaps much of what you attribute to aging is actually environmental assaults. This Awareness suggests that entities become aware that many of the ills of aging are not necessary, and with proper supplements and proper attention to the environment, one can stave off the aging process for many more years.

WHAT PORTENDS FOR THE U.S. AS A RESULT OF THE O.J. SIMPSON VERDICT? (Now that "the Juice" is Loose: What Next?)

QUESTION:

A question from Tom K., in California. In a letter to me, he writes: "And of course you could ask of Awareness: What does the result of the Simpson trial portend now that Simpson has gone free? What of race relations? What of the so-called "Justice system" in this country? And what is being done to promote race contention now by those who would divide and conquer this country?"

"Of course you must have hundreds of questions in this area, and I hope that Awareness will fill us in on the greater significance. A usually perceptive friend of mine has suggested that Simpson may not live all that long. How strong is this potential opportunity to create chaos in this country from his death, for example, by those who desire to create chaos?"

COSMIC AWARENESS:

This Awareness indicates that this is indeed a potential problem. This Awareness indicates that the blacks perceive this as a unique situation in which a black man being tried has been exonerated by the justice system and that even the blacks who perceived him as being guilty see this as vindication of blacks who have been found guilty when innocent and that it is a victory for blacks by the justice system of today.

Should Our Justice System be Revamped?

They see it as a unique situation in which blacks have finally received some justice in this country. This Awareness indicates that on the other hand, many of the whites perceive it as a sign that the justice system has broken down and that a guilty man has been freed. This Awareness indicates that it is for these entities a time to rethink the justice system, to study the idea of juries and peer groups as jurors in a trial, whether it is workable or not.

This Awareness indicates that for some entities, this is a time when the jury system should be discarded and judges be given the full decision-making power over the courts. This Awareness indicates it could, if these entities have their way, lead to a justice system similar to those in some of the foreign countries in which there is a totalitarian system of law that does not provide for the defense of entities, but whereby the entities themselves are like pawns in the justice systems of such countries.

Many Woman Angry Because of Spousal Abuse Issue

This Awareness indicates that there are many very angry people, particularly some of the women's groups who see this as an injustice because of the spousal abuse involved. They would have preferred that this entity be convicted even if innocent, because of his spousal abuse to his ex-wife, regardless of whether he killed her or not. This Awareness indicates that some of these entities are so hostile about the verdict that they are leaning toward and influencing others to become more racist in attitude than they would have ordinarily perceived themselves to be.

Simpson's Life In Grave Danger

This Awareness indicates that it is polarizing the nation between whites and blacks more than any issue since the Civil Rights Movement in the late Fifties and early Sixties. This Awareness indicates that it has been reported that a Mafia don has put forth a contract against O.J. Simpson to have him killed. It has been rumored that there are others who also want the entity killed and it is suggested that the entity's life is being threatened. The entity as having received threats, and it is highly likely that he will not live for more than approximately five years.

This Awareness indicates that the chances of finding the real killers in his case have more or less been dissipated due to the lack of any immediate police follow-up on the situation after it occurred. This Awareness indicates there is a general principle in police work that if the killer isn't found within 72 hours, the likelihood of ever finding the killer will diminish by approximately 90%. It is in part this principle that led the police to focus in so quickly on Mr. Simpson, because they had no other clear leads at the time and wanted to have someone who would satisfy the need and provide for a conviction within a 72 hour period, or the case might be unsolved.

This would not look good for the police in a high profile case of this type. This Awareness indicates that it is a possibility that with the amount of money offered by Mr. Simpson and the detective work of his assistant, Mr. Kennedy, and work that has already been done in terms of research by this entity, and the leads that have been developed, that the real killers might yet be found, but the potential is less than 50%.

This Awareness indicates that until the real killers are found, Mr. Simpson's life will always be in jeopardy because most people will continue to believe him guilty of the crimes. This Awareness indicates there is also rumor and suggestions, even by relatives of Mr. Goldman, the father of Ron Goldman, the victim, that Mr. Goldman has desires to have a contract to kill Mr. Simpson, or do so himself because he is so distraught over what he perceives to be the killer of his son being set free.

If Verdict Had Gone the Other Way, Rioting Would Have Occurred

This Awareness indicates that had the verdict gone the other way, there would have been riots throughout the country and the polarization would have been even stronger than it is now. This Awareness indicates in general, the black community, the black culture, having endured so many years of injustice, is much more inclined to react in a volatile way than the white culture, which has experienced this for the first time in such a strong and such emotional level.

Therefore, there is still enough restraint in the white culture that the polarization does not, has not yet and probably will not spill out into violence between the races over this issue unless some unusual further actions occur to antagonize the conflict. This Awareness indicates that while in general, much of the white community is very incensed and angry about the verdict, there is a certain degree of restraint and as one person stated, the whites will rebel in the way they usually rebel in racial matters, by simply moving out of the cities, moving away from blacks and getting more isolated from contact with them.

This Awareness indicates this will not help inter-relationships between the white and black communities but is less dangerous than the way in which the blacks rebelled after the Rodney King verdict. This Awareness indicates that the whites have more to lose in a violent conflict than do blacks, and therefore are able to afford greater restraint, whereas the blacks in their situation in which the world has not been so favorable to them have less to risk losing and can afford to become radical in times of extreme conflict, and thus, many whites see them as more violent because they are more willing to risk violence when freedom and rights are denied them.

This Awareness indicates that it *does* appear that unless some new and unusual situation occurs that the event will gradually diminish and relations between blacks and whites will grow back to that which is more balanced and harmonious, but it does not appear that true harmony will exist until entities can begin to trust each other and can find true justice within the law.

This Awareness indicates that when the justice system, which includes the police in various communities around the nation, functions in a way that is a guarantee of justice for all: until this occurs, no true justice will be available for both cultures, and until both cultures feel they are protected equally by law, there will continue to be a question of whether anyone is free or whether there is a prejudice in the justice system that gives some people justice at the expense of others, who are denied justice.

Until All People Are Free, No One Is Totally Free

This Awareness indicates that until true justice is balanced between the cultures, no real justice will be available for anyone. Until all people are free, no one is totally free. This Awareness sees the future as being quite likely to bring a gradually harmonizing situation. The only real hitch in this prognostication is if indeed someone does execute Mr. Simpson, for that could set off the race war that some of the whites want to occur. It would justify some of the Neo-Nazi plans, and help to bring on conflict between the races. It would be exactly what Mark Fuhrman, for one, would like to promote.

This Awareness indicates that this kind of action would result in far greater violence than people could imagine in this country, for the blacks see this victory not so much as a concept of a black man getting away with murder: they see this as a justification at last, wherein the law worked for the blacks as well as for the whites. They see this as a vindication that even the black man can receive justice in the white courts.

Did Money Buy the "Not Guilty!" Verdict?

This Awareness indicates there are many who say the entity receive his "Not Guilty!" verdict because he could afford the money to buy such a verdict. This Awareness reminds you that the court system and the Los Angeles county spent \$9 million dollars *trying* to convict this entity. If money were buying the courts, they would have won *their* verdict.

This Awareness indicates that this was a situation in which a black man could afford a group of lawyers who would work very hard in his behalf. His legal expenses were far less than anticipated and far less than most people realize. The lawyers were quite careful in not simply going for the money. They truly believed in his

innocence and forfeited some of the money they could have acquired in defending him.

This Awareness indicates that to say he had the best defense money could buy may be true, but he also did not buy his "Not Guilty!" verdict because money was not the determining factor, as has just been indicated. This Awareness indicates that it is a situation in which a certain degree of Divine influence helped to determine the outcome, but is also partly due to the number of blacks on the jury, and their personal experiences in knowing how the Los Angeles police force had in previous circumstances treated blacks in the area over long periods of time.

Most of these jurors as having had either personal friends or personal experiences on their own with the police force who had certain prejudices against the blacks in the community and this of course did have some influence in their reaching a "Not Guilty!" verdict. This Awareness indicates, however, the facts of the case that were presented to the jury were quite different from the facts of the case presented through the media, which capitalized on making money from the story, when presented in the media.

Media Misled the Public in Order to Sell Papers

This Awareness indicates there were many stories the media promoted which helped convince entities that O.J. Simpson was guilty, and many of these stories that were so convincing never proved to be true. This Awareness indicates for example, early in the summer there was a washing machine full of bloody clothes at O.J. Simpson's home. This was released in several of the newspapers, but this never was true. It never came out in court.

There were also stories of a bag of bloody clothes being taken to the airport, and this bag of bloody clothes was never found or shown to exist. The lawyer friend of O.J. Simpson was alleged to have taken a bag of bloody clothes from him after he had flown back to Los Angeles. This bag of bloody clothes never was found. His housekeeper said when Kardashian, the lawyer, brought the clothes to her, she simply took the clothes out and hung them in his closet. It was a bag of shirts and such every day clothing as Mr. Simpson wore.

This Awareness indicates that the entity Kardashian explained that he tried to take this bag into the home of O.J. Simpson, and the police had blocked it off as a crime scene and would not let him take the clothes in. He insisted that these were Mr. Simpson's clothes and had to go into the home, but the policeman said, "Nothing is coming in here! Go away!" Thus, the entity took the clothing away from the scene and the press reported that he "fled with the bag of 'bloody clothes'."

Media Lies About the Famous Police Chase

This Awareness indicates that much of the conviction that entities received regarding O.J. Simpson had to do with the way the press presented the information. He was alleged to have taken some \$50,000 with him in his vehicle on the so-called police chase, but it really was a matter of \$8,000 that was taken with him, and this was to go to his daughter and son so they could use the money in upkeep of the home while Mr. Simpson was in jail. He had been arrested and knew he was going to jail and wanted them to have the money needed for upkeep in care of the home for paying the staff, et cetera.

This Awareness indicates that it was not \$50,000 as reported by the press, but a matter of \$8,000 dollars. This Awareness indicates that there were so many distortions in the media release of information, much of which never came about, or which was never correct, that people became convinced early that the entity was guilty. There was a so-called "murder weapon" that was purchased from a store which later was presented in the envelope to the court, still in its package, still new with no traces of blood on it, but the press reported the purchase of the knife without ever presenting the information as to the production of the knife to the court and its lack of any blood evidence.

This Awareness indicates that this Awareness is not intending to present another version of the trial or recap of the trial, for there is much that was left out of the trial, but this Awareness simply is pointing out a few things that the media was responsible for doing in presenting to the world the so-called "evidence" or proof of this man's guilt.

This Awareness indicates that the jury did not hear all of this media evidence; they only heard the evidence as presented in court and therefore, they were not contaminated by the false evidence presented by the media, and it is largely for this reason that these entities in the jury found Mr. Simpson "Not Guilty!"

Media Pundits Refused to Eat Crow

It is of a great affront to many of the media pundits who were so convinced of this man's guilt, partly because their stand was so strong that they could not ever rethink the situation, or could not conceive it without thinking in terms of all of the information they had received from the media reports, and therefore, to hear of the jury making its "Not Guilty!" verdict, to them was not only an affront to justice, but it also defined their expertise, and they did not wish to acknowledge that perhaps they were wrong, or even to rethink their position on the matter.

This Awareness indicates that therefore, they helped to feed the continuance of the assumption of the guilt of the man and to help make many people hostile to the jury and to help feed the conflict between the whites and blacks who now were in part opposed to each other over the matter.

Mountains of Evidence for Either Guilty or Innocent

This Awareness indicates that there are two sides to the issue, two ways of looking at the same issue. If one takes the position of his being guilty, there is ample evidence, indeed, what many called a "mountain" of evidence of his guilt. If one takes the position of his innocence, they can see ample evidence of his innocence, indeed, a "mountain" of evidence of his innocence.

It is likened unto the story of the boys who were walking down a road and saw a man run behind a bush ahead of them and then saw a snake crawl out from behind the bush and then saw the snake bite a goat. The boys reported that the man had turned into a snake and then bit a goat.

After much questioning, it was determined by an investigator that they had seen a man go behind a bush and had seen a snake come out from behind a bush and that perhaps the snake was not necessarily the same man who had gone behind the bush, and that it was not the

man who bit the goat in the form of a snake, but simply a snake who bit the goat, and that the same picture for one observer may be quite different when viewed by another observer.

This Awareness indicates that this is also symbolized in the story of the elephants in which different people find a different description for the elephant because they were blind when they felt the elephant; one feeling the trunk, the other feeling the body, the other feeling the legs. This Awareness indicates that if an entity were to hypothetically take the view that Mr. Simpson was indeed innocent, and all of the things that followed occurred to an innocent man; all of the evidence is explainable when considering that perhaps two people planted a certain amount of evidence.

That Blood In the Bronco and the Leather Gloves

This Awareness indicates in fact, the blood in the Bronco was determined to be approximately 7/10ths of a drop, which could have been smeared by the use of a glove being smeared in various places in the Bronco. It could also have been placed there at any time after the Bronco was placed in storage. This Awareness indicates that the evidence, when looked at more carefully, as the jury was allowed to do, became less strong to them.

This Awareness indicates perhaps the most compelling action that influenced the jury was the event when Mr. Simpson was directed by the prosecution to put on the murder gloves, the gloves that had been determined as being used in the murder, and it became extremely clear that the gloves did not fit this entity, and anyone who understands that type of glove, leather gloves, knows they do not shrink that much. In fact they do not shrink.

This Awareness indicates there are gloves that *can* shrink, but this particular type of glove does not shrink and would not shrink simply from being smeared with blood. This Awareness indicates that these evidences indicate why the jury voted the way they did. It was not strictly a racial matter, although there is little doubt but what some of their own personal experiences of racial issues with the Los Angeles police and their knowledge of the Los Angeles police probably did have some bearing in their weighing of the evidence.

The Lies of Mark Fuhrman Influenced a Courageous Jury

This Awareness indicates that the incident of Mark Fuhrman's use of the "N." word, as it was called, did show the jury that the entity was lying and had lied on the stand under oath, and therefore, they could reasonably assume he may have lied about other things also, and therefore, he being the one who had the responsibility of providing the hardest evidence, the most compelling evidence for the prosecution, also presented the jury with reasonable doubt, because of his falsification of information under oath.

This Awareness suggests that reasonable doubt by law, is all that is required to a finding of a "Not Guilty!" verdict. This Awareness indicates that the jury itself acted with great courage in this case, but they have been condemned on many levels by the media. The media has determined long ago that Mr. Simpson was guilty. This Awareness indicates in some case, some of the tabloids vacillated back and forth, giving evidence that O.J. Simpson was totally innocent, was being framed, then,

several weeks later, presenting arguments that he was guilty or that he got away with murder.

Newspapers and Tabloids Did Not Promote Facts

The purpose of similar stories and tabloid positions was simply to sell papers; they cared not whether they were promoting truth or facts. They simply wanted to sell papers, because the public wanted to know what was happening, and to argue in favor of O.J. Simpson at one point in time and against him at another point in time was arbitrary and determined simply by whether one argument would sell more papers than another, and therefore, the same paper would take one position at one time and at another time take the opposite position in regard to his guilt or innocence.

This Awareness indicates that it is a very sad thing when newspapers are more interested in making their fortunes from these tabloid stories than in presenting something meaningful or true to the public. This Awareness indicates that extreme distortion is expected in some of these tabloids, but this Awareness suggests that when it becomes an obvious act of selling one story at one time, another at another time, where the stories are opposite in their statement, in their expression, then it becomes clear that the tabloid is simply prostituting itself in order to make money off of the life blood of others.

WHAT ABOUT SIMPSON'S WIG AND DISGUISE FOUND IN BRONCO?

QUESTION:

In regard to the Bronco ride, did the media also misinform the public that they discovered, in addition to the large amount of money in the Bronco, a wig and a disguise, and a passport?

COSMIC AWARENESS:

This Awareness indicates that the wig and so-called disguise, was simply his desire to have some privacy, some anonymity, when he went to visit his wife's grave. This was his intention in taking the ride. He had not yet had a moment to grieve her loss and wanted to go to her grave before going to jail, and the entity had this wig and so-called disguise, which was simply a pair of dark glasses, brought to him so that he could be in public without being noticed by the masses. He wanted to go to her gravesite for a few moments before turning himself into the police.

This Awareness indicates that the passport was simply something that had been given to him by one of his children, thinking that maybe he should leave the country, and the man being in such disarray, took this in part to satisfy the child. It appears that this was his son who gave him the passport. He had already acquired a passport for other purposes, for his business and his travels, but his son got it from his home and gave it to him prior to his taking the Bronco ride.

This Awareness indicates that there is no way the entity would have left the country even if he had \$8,000 and a passport because for one thing, the entity had assets over some \$6 million dollars and a family and children, and had he left the country he would have risked losing all of that, and they could have seized his property because he would have been a fugitive, and therefore, it would have been totally foolish of him to

flee with \$8,000, and for the entity to have \$8,000 with him when he possessed \$6 million dollars worth of assets is not the sign of a great escape or the sign of an entity planning a great getaway.

Were this an ordinary person whose assets totaled perhaps \$30,000 or 50,000 dollars, then \$8,000 might have been a significant amount. The likelihood is that the entity probably carried \$8,000 dollars with him quite often, or would have credit cards on which he could draw that much money just for local traveling or for activities of domestic movement such as moving from one place to another.

This Awareness indicates how far could the entity go on \$8,000? Perhaps to Mexico, but then his \$6 million and his family and his children would have been lost if he had moved that far. With \$8,000 he could exist for a short time incognito, but without his name, without his persona, what could he do to earn a living, even if he were in Mexico? The moment he showed himself to be O.J. Simpson and to try to get some kind of business activity he would then be the subject of a fugitive search and would have been targeted for extradition back to the United States.

This Awareness indicates that it just simply doesn't make sense that the entity would try to travel to a foreign country with \$8,000 and a hat and glasses for a disguise.

Why Isn't Mark Fuhrman Punished for Perjury?

QUESTION:

Perjury is a felony crime. Is it because Mark Fuhrman is an ex-cop? Is that the reason he has not been tried and imprisoned for perjury?

COSMIC AWARENESS:

This Awareness indicates that there appears there is a reluctance in the District Attorney's office to try this entity so far; however, it may yet happen. But one of the reasons there is some hesitancy is because he now resides in another state, and to extradite him back to Los Angeles for perjury would require certain legal hassles, and the District Attorney's office uses this in part as an excuse not to pursue it any further.

If enough pressure is put on the District Attorney to bring him back and try him for perjury, it may yet happen.

Beware! Police Always Assume a Spouse Is Guilty

This Awareness indicates that there is something further that needs to be noted here. The police investigation procedure is always to look at the spouse or ex-spouse as the first suspect in a crime such as this. This Awareness indicates that this is something for everyone to be aware of. If you, as an individual, and your spouse should for some reason decide to take a vacation from each other; for example, if your spouse wants time alone or you want time alone, and you aren't getting along in some way on some issue, and you need time to be alone and rethink your life, and you separate and live in two different homes or in two different apartments, and if something should happen to your spouse, especially if you are a man, such as, perhaps your spouse is attacked while walking home from work, you will be the prime suspect.

It is important for you to realize this. Guilty or not, whether your wife is attacked by a mugger, a rapist or some other serial killer, you will be the prime suspect simply because you are the husband or ex-husband. Likewise, even if you are living together and something happens to your wife, you are the prime suspect until there is reason to look elsewhere. This Awareness indicates that this is a very dangerous situation for any man.

This Awareness indicates that if the police have any evidence that you might have wanted to kill your wife, for example, if she has insurance or if you have had extramarital affairs, or if *she* was having extramarital affairs, or if there was anything that indicated a conflict between you and your wife, you may find yourself being booked for murder, if something of this nature should happen to your wife.

This Awareness indicates that it is something to be very concerned about. It is important that you not ever verbally threaten your wife. It is important that you not abuse your wife in any way because you never know what is coming around the corner, next month, next year, or whatever, and there are reasons why the police will always look at the spouse as the prime suspect. It is their observation, correct or not, that half of the domestic slayings are done by the spouse. They assume that if a spouse dies, that the other spouse, particularly if it is a man, was the one who killed the wife.

This Awareness indicates that it is a situation in which you almost have to prove yourself innocent and you have very little time to do so, or you will be seen as the one who is the prime suspect. This Awareness suggest that entities be very much aware of this. It may be a matter of life and death to you.

SHERMAN SKOLNICK REVEALS WHO SLAUGHTERED NICOLE AND GOLDMAN (“The Atom Bomb of all Scandals!”)

QUESTION:

Along the same line, we received a very interesting bit of information over the Internet sent out by Dave Alexander’s SPIRAL, through an organization called Conspiracy Nation, which did a transcript of an interview with Mr. Sherman Skolnick, who has his own cable TV show and radio show which exposes conspiracies in Chicago. We’ve asked Awareness a number of times about this entity, and *It* has confirmed the information he puts out.

This is titled “The Atomic Bomb of All Scandals!” and I’ll read quite a bit of it here. When information comes via a computer, it’s sometimes confusing. But he calls it “The Atomic Bomb of All Scandals!”, and it’s a transcript of an interview with Mr. Skolnick by Conspiracy Nation, and it reads:

“Secret reports of the United States Drug Enforcement Administration, (DEA), reportedly detail the who, what and when of the double murder.

“According to the reports, DEA undercover teams had been tracking Ron Goldman, part of a major homosexual drug smuggling force: dope on credit to fancy people at fancy restaurants, like where Ron was a waiter.

Ron was a *major* DEA target, not Nicole. She had taken over the ownership of O.J.’s fast food stores. The

real owners/operators, the report contends, have been corrupt top California police.

“As fingered by the report, the dope loot was washed through banks headquartered in California owned mostly by the Yakuza, the Japanese Mafia: Wells Fargo Bank, interlocked with Household International and Household Bank, and Bank America, holding firm for Bank of America, now owners of the Continental Bank of Chicago.

“Tracking Nicole, the report states, were O.J.’s private detectives-- his jealousy. They, along with DEA teams and extreme low lux video, *witnessed* a dope-hit team butchering both Ron and Nicole, Samurai-style.

“The reports hint O.J. trial Judge Lance Ito is a cover-up artist. The judge’s wife, Margaret York, has been a top L.A. police official in charge of investigations of police corruption. The report identifies *her* as liaison to DEA and quite familiar with details in these DEA documents and files.

“Judge Ito blocked efforts of O.J. Defense council Johnny Cochran from putting in details relating to all this. Defense council Robert Shapiro, however, has reportedly been very close to major drug traffickers.

“Since O.J. *knew* of the double murder through his detectives, is O.J. a murder accomplice by going along with the cover-up?

“The DEA is bitter. They have been blocked, reportedly, in targeting Ron’s father, Fred Goldman, who has mobilized public opinion in the cover-up.

And then there’s the CN transcript of October 13, 1995, interview with Mr. Skolnick.

Conspiracy Nation asks: “So there’s a video of the murder?”

Sherman Skolnick: “Yes. Extreme low-lux. They’ve got cameras that work in minimum light.”

Question: “So there is a video of the actual murders?”

Sherman Skolnick: “Yes. .

Question: “Something else: this room-mate friend of Ron Goldman’s....”

Sherman Skolnick: “I mentioned that in the previous story; that he’s been *murdered* recently and that he also worked as a waiter.”

“Conspiracy Nation: “Why are they keeping these DEA reports secret?”

Sherman Skolnick: “These reports would rip the lid off Los Angeles and the country. They would show that there is a **tremendous** cover-up. And, as I reported in previous stories, Judge Lance Ito, his wife Margaret York, **some** of the defense attorneys and others, would have to be *prosecuted themselves* and put in prison.

“At the murder scene there were, reportedly, three teams: there was a DEA undercover team, there were the private detectives of O.J., and there was the dope hit-team that, Samurai style, committed the double murder.”

Conspiracy Nation: “Do you know how many were in the hit team itself?”

Sherman Skolnick: “I will describe that in a separate story.”

Conspiracy Nation: “The press is playing up this thing big time, like it’s “white versus black.”

Sherman Skolnick: "Yes. We've already taped a one hour cable TV show. But because public access cable is not "spot news", it won't go on the air until Monday, October 30th.

On the program we mention that actually 6 journalists in the United States are familiar with the DEA report. I am one of those. The other five, because their editors are chicken, or whatever, are not going with it. But I'm not the only one that is working on these stories or is aware of these reports.

Margaret York, as liaison to DEA, presumably *knew* of these reports. At key points in the trial, Judge Lance Ito blocked one of the defense attorneys, Johnny Cochran, from putting into evidence details that *relate* to these reports. Whether Johnny Cochran did or did not have knowledge of the actual DEA undercover team reports is not the point. He apparently *knew* of the situation and *tried* to put it in evidence, testimony relating to it. And the *judge*, as the evidence gatekeeper, *blocked* him. And that, under the circumstances, is *very* incriminating.

"As to why Ron Goldman was the target of the murder squad, there's various explanations. He may have, in some way, crossed-up the Yakuza. He was the *principle* target of the murder squad, (although that is not to say that Nicole could not have also been the target because of her role in the thing).

"Notice that the mass-media have put the principal target as Nicole, and that Ron Goldman was there at the wrong time and the wrong place, simply by accident, because he was bringing back Nicole's mother's glasses, reportedly left at the restaurant where Ron was a waiter.

Conspiracy Nation: They've got this "Million Man March" coming up this Monday. And the press has so far played this thing up like there's a "huge" racial divide on this murder trial. And with the Million Man March coming up, that would play into the press's hand.

Sherman Skolnick: "Well, as mentioned on our cable TV show, I say that the ultra-rich rule us in this country by the British method of "divide and conquer". And everybody on the panel, on the show, agreed that that possibly was happening. Because the press is *causing* this race relations nightmare. They're causing it. They go around interviewing blacks, and then they interview whites, and then they play it up with shows, with pundits and all that. And they fan the flames.

There has been a somewhat better atmosphere in recent times on race relations. It was getting a little better. Now, it has gone back to the extreme, where, in some offices, where blacks and whites work together, because of the O.J. verdict and the commotions, there's some people at each other's throats.

Conspiracy Nation: "One final thing: You've seen this DEA report?"

Sherman Skolnick: "I have to carefully state what I say: I'll answer in this way: The government presumes that we have a copy of the report. And what demonstrates that presumption is a threat by a pair of government sources, directed against me and associates of mine.

Conspiracy Nation: "That's all the questions I have unless there is something else you wanted to say.

Sherman Skolnick: "This is the atomic bomb of all scandals as far as I am concerned."

That was the end of the information. Would Awareness comment on that information?

COSMIC AWARENESS:

This Awareness indicates that as indicated, as stated as clearly as the information is in this report, this Awareness sees this as accurate. This Awareness indicates that there is still more that is not stated fully in this report but as much as has been given, it is correct.

Verdict Could Have Created "Hot August Night" Scenario

This Awareness reminds you that many months ago, this Awareness suggested that the O.J. Simpson trial was *designed* to create a second opportunity for the so-called "Hot August Night",* a race war effort to be caused to occur in this country, which would then allow for the National Guard troops to enter and wherein some of these troops are then shot at or violated or killed, UN troops would then be brought in to quell the conflicts, and once UN troops are brought in, all freedoms will be lost.

The Martial Law plans would be implemented. The UN troops would be brought in to set up the controls. At that time the plans for rounding up patriots and any perceived troublemakers would then be the agenda. This Awareness indicates that the press and its role in the O.J. This Awareness indicates that it is important, if possible, for entities to warn each other. The fact of this information being put on the Internet will help to defuse the plans; the more this information is dispersed to the masses, the greater the chance of a defusing the plans for this takeover of this country. That any racial war that occurs is simply to be used as an excuse for UN troop domination of the masses in this country.

Why The Media Needs This Information

FOLLOW-UP QUESTION:

If this information just read actually gets into the hands of the mainstream media, that there is actual videotape of the murders themselves, and so forth, it's going to change a lot of the consciousness in this country as a result, is it not?.

COSMIC AWARENESS:

This is in the affirmative. This Awareness indicates however, that it is going to be a major event if the information does somehow get into the mainstream media. There will be all kinds of efforts and attempts to block this from being shown in the mainstream media.

The Information Needs to be Presented in Video Form

This Awareness indicates that if the information could be presented on a video along with any other activity or proof or evidence such as the alleged night-time video of the murder scene; if this could be presented in a

video along with the narration and the video scene of the murder and made available to the public for dispensing around the country to the patriot groups and to anyone interested in purchasing the video, this could be of great significance and could inform many people, even if it does not get on the mainstream media television.

This Awareness indicates that you may recall the impact of Linda Thompson's video on Waco, and how this spread across the country through the release of that video. It was not long before most of the informed entities around the country knew what had happened in Waco. Regardless of the efforts to cover-up, even regardless of the subsequent hearings on Waco, the video of Linda Thompson is still strong in the minds of entities around the country.

This Awareness indicates if this were presented on a video and made available, it could be of extreme importance. This Awareness suggests that the entity should consider having someone create a video for the purpose of distribution and sale to the masses. It could be done in such a way as to create a minimum of danger for the entities producing the video by having it secretly produced in multiple places once the initial video is completed, then having the video produced in many different places, whereby with each sale a certain royalty could go to the persons making the video in order to help make the effort worthwhile.

This Awareness indicates that by having the video coming from many different sources, it would become very difficult for the powers that be to stop the production of this information or the sale of the video. This Awareness indicates that in the meantime, the very information that has been presented in this report for this question also could be and *should* be presented far and wide as much as is possible.

Will Racial Issue Sweep Buchanan Into Office?

QUESTION:

Jack Katchmar * is so convinced of the racial division in this country that he's putting out that as a result of the O.J Simpson verdict, that right-wing Republican Pat Buchanan will be "swept" into office as president.

Is this just wishful thinking on his part, or does Awareness see that this is a possibility?

COSMIC AWARENESS:

This Awareness indicates it could result in a few more votes for this entity. This Awareness indicates that it is mostly wishful thinking on the part of Mr. Katchmar. This Awareness indicates that Pat Buchanan is not seen as the racial bigot that some entities might want as president. This Awareness indicates that he has certain right-wing extreme ideas, but the entity is fairly balanced in terms of his realization of the rights of entities, regardless of their color.

This Awareness indicates the entity has not publicly come forth with extreme prejudicial statements against blacks. It is simply presumed because he is more of a conservative than most that he must likewise be bigoted against blacks. The entity appears to have made some statements about Affirmative Action which might, for some, imply he is opposed to blacks, but this is not necessarily a correct assumption.

*ED's Note: Jack Katchmar is an acknowledged racist and bigot and his anti-semitic and anti-blacks diatribes may be familiar to some readers who were unfortunate enough to get on his mailing list. For years he has been sending in the same questions to CAC, mainly how come Awareness won't lead "God's chosen white light workers" to secret hoards of money so they can put up the good fight against the Dark Force, which to Katchmar is mainly the Jews and the blacks.

He fancies himself as some high exalted being who has reincarnated for this mission. The entity lives in the Detroit ghetto, where I am certain he keeps his hostility toward his black neighbors a deep secret. WHERE DOES ONE LOOK FOR ONE'S OWN CLEAR PERSONAL CHANNEL?

QUESTION:

In a different area now, a question from Kathleen V., Houston, Texas. She writes: "Dear Awareness, I am searching for my own channel that I can understand. I need one that speaks to me in a clear language that I can easily interpret and *know*. I seem to get different communications from different parts of my mind, and different parts of my body.

"For example, there was a fairly clear "speaker" in the upper left side of my head, but I questioned its intentions and it went away. I see pictures when I concentrate on the very middle of my brain, but the messages are not clear enough to fully understand. When I center on the deep part of my chest, there's something there, but sometimes I think it is only my rational mind conversing with me.

"Where specifically do I look for my clearest channel? Above, below, behind, right, left, in the middle, or where?"

COSMIC AWARENESS:

This Awareness indicates that generally, *It* suggests that entities prepare themselves through the use of Development Classes which this Awareness has given which are made available through the Aquarian church. However, depending on where you live will determine whether these are available to you at any given time. This Awareness indicates that also *It* wishes to remind you that not all good channels have been given Development Classes. Edgar Cayce was not given the Development Classes, for example, and this entity was a good channel.

This Awareness suggests that in regard to your question as to where to put your focus when seeking to channel, this Awareness suggests that you recognize there is an eighth chakra. This Awareness wishes the 7 chakras to be open for channeling, the 7 chakras leading to the pituitary. The 8th chakra is above the head, approximately 6 inches to one foot above the head.

How to Focus and Locate Your Personal Channel

This Awareness suggests that to find this, you focus on the area of the pineal which you find by focusing first in the area between the eyebrows. Turn 180 degrees backward, looking back toward that which focuses. It is the pineal that focuses to the area between the eyebrows and that if you take that focal point between the eyebrows and look back, you will be looking back upon the pineal.

If you go straight up, vertical to your body, above the head, you will pass the pituitary which allows the pineal and pituitary to connect to each other, and then from that connection, focus straight up above the head, approximately 6 inches to one foot above the top of the head. If you are lying down, this will of course be horizontal to the earth. If you are standing it would be perpendicular to the earth, above the head by approximately 6 inches to one foot.

This Awareness indicates at that point, approximately 6 inches to one foot above the head, you will feel an energy at that location. It will feel like a bulb of light. Keep your focus there, and address the Divinity. Open yourself by being receptive to whatever *It* offers. If you wish to ask a question, ask the question, then focus on that Light and be receptive to its answer. The answer will come to you in a symbol or in some kind of image or perhaps in words.

Do not try to limit how the answer comes. Simply be receptive. If it is a symbol, then you look to allow the meaning of the symbol to be clarified. If you do not find the meaning easily, look again to the Light and seek the meaning of the symbol.

This Awareness indicates that if it is a picture, an image, and you do not understand the meaning of the image, look again to the Light, 6 inches to one foot above the head, as you try to be receptive to the meaning of the picture or symbol or image. This Awareness indicates that if words come, allow them to come without trying to anticipate what is being presented. Simply await the release of the words to you.

This Awareness indicates that this may be of some benefit to you, but keep the Light centered as if it were moving up the spine, out the top of the head and approximately 6 inches to one foot, (the average being approximately 8 inches), above the head. This Awareness indicates that once you locate it, let your focus move to that position. Look down upon your body, upon your head from the top of the crown, from the Light that you reside in.

This Awareness indicates that the questioner may descend to the point of the pineal/pituitary connection, wherein, in the middle of your head, the questioner resides, and the Speaker or Divinity you contact resides in the Light at the top of the head in the crown position above the head. This Awareness indicates that *It* will also assist you if you attune to Divinity; make sure that all areas of darkness are out of your system; that you wrap yourself in White Light, that you set aside mind, emotion and feeling, if possible, and not have any personal agenda occurring in your channeling.

Anytime you have a personal agenda or motive/purpose, you are not going to channel clearly. This Awareness suggests also that you surrender *only* to the

Divine Light; that you not allow yourself to have any darkness or ulterior purpose of energy or fears when you are involved in channeling, and this Awareness suggests that as soon as is possible, that you involve yourself in the Development Classes which this Awareness has made available through the Aquarian Church.

ED's Note: When Development Classes are being formed, CAC informs the membership. At present time, the only classes being given are in Tucson, Arizona.

How Do We Recognize Our "True Self"?

QUESTION:

One last question; this also from the same lady. She asks: "How do we recognize your true selves? What is the sensational feeling one should be aware of?"

COSMIC AWARENESS:

This Awareness indicates that your true self is Divinity; that you find your true self or your Divinity by surrendering your personal self. Let go of personal self and give yourself to the Divine. Give yourself to that which is called God. Give yourself and all of your ambitions and all of your personal agenda or purposes to Divinity, and recognize your Divinity as being that which is everywhere present as a Divine Force that permeates all of the universe, all of that Which Is.

When you give yourself totally to the Divine Creator, which is everywhere present as CosmicMind or Cosmic Consciousness, then you will discover your true self, but you will also realize there *is* no self for you to claim, because you are All That IS, and All That Is allows everything to be what it is without a personal agenda.

Move Into Divinity Briefly, Then Return to Self

This Awareness indicates that of course you cannot, while in physical form, remain indefinitely in a state of absolute Divinity, so you must move into Divinity for brief moments and then return to self, which is the artificial self, the non-real self, the self of the realm of illusion or maya, for entities who live in the material world live in a state of maya or illusion, but they are in the state of maya or illusion for a purpose, and until they have completed their purpose, they must remain there as a self that is not fully Divine.

This Awareness indicates that you may experience the DivineTotal Self for a few brief moments at a time, as often as desirable. This Awareness suggests if you attempt to remain perpetually in the Divine State, you will find yourself becoming less able to function in the world of maya, and less able to serve the Higher Divine Will, because your physical energies and awareness begins to dissolve as you become more and more into spirit.

This Awareness suggests that it would be a violation of your mission to deny your physical being in the world of illusion *until* you have completed your reason for being there, in that world of illusion. This Awareness indicates that any entity in physical form has a reason, or purpose for being such. The value of tuning into your spiritual essence or the Divine Self is to help you have a greater understanding of your purpose in the physical world of maya or illusion.

What is the Cause and Cure of Psoriasis?

QUESTION:

A question from Dr. S.K, MD, in New York. He asks: "What is the biological basis for the disease psoriasis, and what treatment does Awareness recommend?"

COSMIC AWARENESS::

This Awareness indicates this is a problem of the bowels. There is great toxicity in the bowels of most entities, wherein they gather toxic wastes and the toxic wastes of the bowels go into the blood stream and the blood attempts to eliminate this waste through the skin.

This Awareness indicates that colonics can be helpful, enemas can be helpful. Careful diet, avoiding those foods that putrefy such as hard-to-digest meats, can be helpful. Most of the bowel problems respond well to colonics, but most require long-term treatment or care. Eating fruits and vegetables can be helpful, over a long period of time, at least a year. If entities use colonics and enemas it can be of a shorter period of time.

This Awareness indicates that laxatives are not a good solution because laxatives tend to throw off the regularity of the bowels. This Awareness suggests that the use of acidophilus culture is good. It helps to strengthen the healthy bacteria in the bowels to make them function better.

This Awareness indicates the K-Lonic is beneficial in that it helps to clean up the bacteria that is toxic in the bowels. It also acts as a kind of laxative, but is not the same as a laxative. It works more in breaking down the hard compacted toxic material that collects in the bowels.

This Awareness indicates that psyllium seed, such as that used in Metamucil and similar products can be used without too much concern because this does not cause habit-forming reliance on laxatives. It is not a laxative. It is a natural fiber, and this can be helpful in helping to cleanse the bowels, not in a long-term or permanent sense, but on a temporary level; short-term levels.

This Awareness indicates that the use of colonics is one way of cleansing some of the hard compacted tissue or toxic tissue from the bowels. This Awareness indicates that coupling colonics and acidophilus culture can be of considerable benefit. The acidophilus culture may be necessary on repeated levels for a period of several weeks or even months, depending on how compacted the toxins are.

Many People Are Really Full of It!

This Awareness indicates it is possible for some people to have so much toxic material in their bowels that after weeks of elimination, there still is a number of pounds. Some people have been known to carry fifty pounds of toxic material in their bowels and lower intestines and upon elimination of this they regain great vigor, vitality and health.

This Awareness indicates there are books written on this kind of cleansing program. There is information by Dr. Gensian (sp) at most health food stores. His book on cleansing...the name is not clear. The title referring to health Through Internal Cleansing deals with a clinic and its long-term work with many patients for the cleansing of the bowels, and the entity goes into great detail on many different cases and how to proceed with

cleansing as well as good diets for maintaining a clean bowel system.

This Awareness indicates the skin tends to act as a secondary liver; whereas the liver tends to cleanse the blood of impurities, when it becomes polluted with toxins, then the skin has to start filtering the blood, and take out the toxins, and they begin to erupt from the skin as pimples or rashes or various types of skin diseases.

How to Cleanse and Clear up the Skin

This Awareness indicates that essentially, the best way to cleanse and clear up the skin is to clean the low intestines, and to avoid digesting foods that cannot easily be digested, to take enzymes to help in the digestive process, and to use acidophilus or that which are the friendly bacteria that helps in digestion.

This Awareness indicates that certain types of baths can be beneficial. The baths that draw, such as epsom salts in bath-water which can help draw toxins from the skin. This too can be helpful. This Awareness suggests that some entities will be quite benefited through the use of psyllium seeds as part of their diet. It could be placed into cereal or other foods or sprinkled on foods or taken as a kind of Metamucil-like drink.

Regular roughage in one's diets, such as the use of corn. The roughage of corn, for example, helps to scrape the insides of the intestines. This Awareness indicates that some entities will have as many as nine or ten or more meals in their body at once, and some entities go for as much as two weeks without a bowel movement.

Humans Need at Least One Bowl Movement Daily!

This Awareness indicates that this toxicity in their system is not helping their general health. Entities should have a bowel movement at least once daily. Entities may wish to ingest more liquid and more acidophilus culture and enzymes to help clear up their system. If a case is very extreme, entities may need to check the Yellow Pages for doctors who can administer colonic treatments, but be very careful that you get one who is well qualified so that you do not have improper assistance or assistance from someone who is not properly concerned about sanitary conditions.

FOLLOW-UP QUESTION:

I think I read that AIDS can be spread sometimes by that method.

COSMIC AWARENESS:

This is as when the equipment is not totally sanitized. This Awareness indicates that entities may find it easier to simply buy a hot water enema combination at a drug store or department store and administer the enema to themselves on a repeated basis for a period of time; perhaps on a daily basis for one or two weeks, then moving into the use of psyllium seeds and roughage in the diet and the use of acidophilus culture. There could be some relatively beneficial results.

This Awareness indicates if an entity has extreme chronic problems or heavy disease, it may require more drastic assistance from someone who can properly administer colonics. This Awareness indicates there have been cures for cancer and other extremely chronic and fatal diseases through the clearing of the lower intestines.

This Awareness does suggest entities who wish to know more about this or who have serious problems

such as cancer or similar toxic diseases should read the book written by Dr. Gensian (sp) which is available through most health food stores. You can ask someone about a list of his works, his books, and find the book on bowel cleansing by this entity for it appears to be one of the more complete and well-documented books on the topic.

DID BIG GAME HUNTERS FROM MARS GUN DOWN OUR DINOSAURS?

QUESTION:

I ran across in my file, a little tabloid story I'd like to check out. It says that "Big Game Hunters From Mars Gunned Down Our Dinosaurs", and that the "Giant reptiles were helpless against the alien onslaught."

It says "Interstellar hunters regularly traveled to earth 50 million years ago to shoot dinosaurs and were so successful that they wiped out the giant reptiles. "That's the opinion of a Czechoslovakian archaeologist who claims that he has found fragments of giant skulls punctured with neat round holes. In a letter to the scientific journal "Discover", the professor said the projectiles are unlike anything that has ever been used in human weaponry. Even more mind-boggling, he said the trace minerals in the UFO bullets are consistent with minerals America's Viking I space probe found on Mars!

"He says, "I believe aliens came to earth on hunting trips that were catered and arranged by travel agencies on other planets. I wouldn't doubt that one of those planets was Mars before it grew cold and airless and died. To date we have found the remains of five skulls and three projectiles all within a 25 mile radius in Northern France."

And the article goes on, but that's basically the gist to it. Is there anything at all to that theory?

COSMIC AWARENESS:

This Awareness indicates that this is in the affirmative; that this was welcomed on earth at the time. In fact, the civilizations on earth were relatively well-evolved and had communication with space travelers from other planets and helped in the arranging of such tours.

In part, the action was welcomed because the dinosaurs were becoming a threat to many areas of civilization on earth and people were seeing them as a great nuisance and danger and it was an arrangement to help eradicate the dinosaurs, particularly those that were seen as dangerous.

FOLLOW-UP QUESTION:

Was that timing correct? Fifty million years ago?

COSMIC AWARENESS:

This is in the affirmative. This Awareness indicates that this was not the total eradication of the dinosaurs; that it eradicated many of the types of dinosaurs that were most dangerous to humans; that many other types were left. These other types met their demise at later times.

What Really Killed Most of the Dinosaurs

The crash of a great comet on earth helped to destroy the remaining dinosaurs, causing a great cold when the sun's rays were blotted out by the soot from the crash of the comet or asteroid.

The Kobe, Japan, Earthquake: How to Cope With the Emotional Aftershocks?

QUESTION:

A question from Barbara C., in Kobe, Japan. She writes: "Thank you for your concern during the chaos of last Great Hanshin earthquake. I continue to Survive, but the daily encounter with devastation and destruction wears me down. I'm now happily in America, having escaped for my annual summer holiday.

A local psychic has been predicting much destruction for Japan, saying that Kobe was only the beginning. He explained that the Chinese characters for Kobe, (and she draws them out, three ciphers) mean "Gateway To God" and that this holds some significance as to why Kobe was struck.

"Could you ask Awareness about this and ask for advice to survivors of disasters on how to cope with emotional aftershocks? Thank you."

COSMIC AWARENESS:

This Awareness indicates that *It* sees this earthquake as having been artificially created; that it was one of a number of earthquakes to follow. Because of its placement it has had an effect on other geological areas in Japan and they in turn will eventually have their day of reaction. This Awareness indicates that it does appear there will be some continued earthquakes that result from this earthquake, although the connection is not likely to be recognized.

This Awareness indicates that it is not easy to have solidity of one's world fall out from under oneself. When one is in a physical form there is a need for security in order to have any kind of stability. This Awareness indicates that most entities consider the ground beneath one's feet to be the ultimate security, and when that is disrupted, a great insecurity follows.

A New Way to Look at "Security"

This Awareness indicates that *It* has suggested to entities that there is a new way to look at security. This Awareness reminds you of the story of Capilla, some three thousand year old story, in which he spoke of the river blowing and the tree on the bank, and the river-bank which stands by the river, wherein an entity is given the choice of whether he wants to be the tree, or the river-bank, or the river, and the entity sees that the tree on the river-bank could easily be destroyed and there is no security there, or very little; or the entity could be the river-bank which will remain for a relatively strong and long existence, but that the river-bank itself will eventually be washed away.

This Awareness indicates the entity says: "I will be the river. I will flow eternally." This Awareness wishes entities to look at this even further. There is something that even can outlast the river: It is the air, the space that sits above the river, sits above the earth, the river-bank, and sits above and around the tree. This Awareness suggests that entities who wish to have something truly secure as a base for their existence, can identify with the space that makes up the entire universe, and recognize that space, *not* the material realm that inhabits the space, but the space that exists in the entire universe as a housing for the vibration and frequency for the Divine

Consciousness, which always was and always will be, even if all material reality fades and falls and disappears.

The Real Security Lies with the Divine Attachment

This Awareness suggests that you attune your foundation, your origin and your real self as an attachment to that frequency vibration that fills the space of the universe. In other words, become One with the Divine Creator. Then, whatever happens to your physical body, to your home, to the land on which you stand, will not devastate your reality because your reality of your essence, your self, is attached, is bonded with the Divine Creator.

This Awareness indicates this will give you a base on which to build a security that never can be taken from you regardless of what occurs, anywhere, at any time. This Awareness suggests you not think of yourself as a physical body, you not think of yourself as a bag of meat covered with skin.

This Awareness suggests you think of yourself as a vibratory entity that has created this bag of meat covered with skin as a kind of housing in which to rest and reside, but that you yourself are the electrical vibratory being that resides in that bag of meat covered with skin.

This Awareness indicates that as you redefine yourself and become spirit in your body and recognize the spirit is surrounded and encased in the mind and vibration of the Divine creator, you are safe in the lap of God. This Awareness indicates that God fills every inch of space in the universe. That space beside you, above you, below you, in front of you and behind you is filled with Divine Light and Consciousness. It even permeates into your own spirit, your own spiritual body.

That Physical Body Is Not You!

This Awareness indicates that bag of flesh and skin that you carry around with you to use for picking things up, which the spirit might have difficulty doing since it is spirit and is dealing with material things; that body you have is simply a tool for you to use in regard to the physical material realm. It is *not* you. You are the vibration and spirit that is encompassed and enfolded in the vibration of the Creator God.

This Awareness indicates once you realize this, you are free from insecurity.

Dr. Chopra's Meditation on the Cells

QUESTION (VIKKI):

We caught part of one of the Dr. Chopra lectures in which he had the people of the audience do a short meditation where he has them focus on every cell in their body as being intelligence, energy and bliss, and it seems to be something you could *feel* for a couple of moments.

COSMIC AWARENESS:

This is in the affirmative. This Awareness indicates that intelligence of Divine Origin is everywhere present. The entire universe is alive with the intelligence of Divinity. It permeates all space around you, all space out beyond your solar system, within your solar system, and within your body.

You have your molecular levels and your atom level of self. The atoms that are present to make up your

molecules; those atoms contain electrons, protons and neutrons, but those electrons, protons and neutrons, if laid out on a football field, enlarged to the size of a football field, would be but small dots.


The electron and proton would be but likened unto pinheads on a football field, and the neutron would be likened unto a football lying there on the field, with all the rest of the field as nothing but space; yet this Awareness suggests that all that which is space around those substances that are matter: the neutron, proton and electron; all that space is alive with the consciousness of the Divine Creator.

This Awareness indicates even the electron, proton and neutron can be further enlarged, hypothetically, to discover that there are spaces within them that also contain Divine Creative Energies. This Awareness indicates that the electron and proton and neutron are not actually material. They are but collected vibrations. They are likened unto a fulcrum or crossing of vibratory forces, and it gives the appearance of something solid happening there.

This Awareness indicates if you throw a stone into a stream, the ripples go out. This Awareness indicates that these ripples give the appearance of being something in themselves, but they are still just water. They are no different from the rest of the stream, and the spot in the middle is still just water. It is all the same thing. It has created an illusion of being something different.

Likewise, all matter is still the consciousness and vibration of the Creator, even if it leaves an impression of something solid. If you could enlarge it far enough, you would see it is a void, with certain illusions created, and that void is the consciousness of the Divine Creator. This Awareness indicates in other words, your world of reality is but a world of vibration reflecting off of the consciousness of the Divine Creator, and there is no solid substance anywhere. There is only the Divine Creator vibrating and creating consciousness in many different forms, and in many shapes that serve to create the illusion known as maya in the Hindu philosophy; maya being the realm of the so-called physical reality.

This Awareness indicates that if you identify with any of the illusion of maya and place your basis of security on that illusion, you will surely suffer insecurity, but if you attach yourself to the World of spirit and the vibration of Divinity, the frequency of that which is non-material and spiritual, then you are permanent in your being and there is nothing that can destroy you. Only your illusion, your image, your reflection in the form of some material illusion can be destroyed or hindered. Your essence will remain forever intact in the attunement or attachment to the Divine vibration of the Creator.

YOU, AS A TOOL FOR DIVINITY, NEED TO ASSIGN EVERYTHING A PROPER PLACE

CLOSING MESSAGE:

This Awareness indicates there is a need to assign everything to its proper place. There is a need for the ordering of properties here or there according to their purpose, according to their category. This Awareness indicates that in the old English rhetoric system there is a figure of speech called taxis. The taxis figure of speech assigned everything to its place, and in assigning a thing to its place, it would describe "this as going there, that as going there."

In Biblical examples, there was the statement by Jesus in which he said of the various animals and birds, that they all had their place. The birds had their nests, the foxes had their dens and so forth, "but the Son of Man hath no place to lay his head." This Awareness indicates this assigning of each thing its proper place is that which is of great importance to people. It is what helps to separate the mature from the immature.

If you will notice, children spend enormous amounts of energy taking things out of their proper place and putting them where they should not be, and adults follow afterwards picking up after the child, putting things back in their proper place. This Awareness indicates that likewise, the more mature you are, the more you are able to recognize the time and place for something to be put in its proper place or removed for proper use and then returned to its proper place.

You Do Not Mix Divinity and Maya Together

This Awareness indicates that when you move into a state of meditation, you are putting your self into a place with Divinity, and when you have completed your meditation, you must take self and put it back into the world of maya, the world of illusion, the physical world, and leave it there as long as it is being used as the tool intended by the Divine Forces.

Therefore, as a tool for Divinity, you remain in your proper place. You do not attempt to mix Divinity and maya together. The entity who seeks to play God while in physical maya relationship is totally confusing and mixing places, so that he can say: "I am really God! I am a great being!", and the entity may get off on convincing others that he or she is God, and it is often suggested by some of the New Age gurus who tell entities: "You are God and you should acknowledge your Godhood!"


This Awareness indicates that while it is true that you are God *when* you surrender self to Divinity, to the God, it is not true that you as an element of maya or physical reality are God.
