



CURRENT EVENTS UPDATE

That Sinister Rider on the Health Insurance Bill

This Awareness indicates there is that which may be termed good news and bad news, depending on how you look at things. This Awareness indicates that there was recently passed through the House and Senate what is termed a "Health Insurance Bill." The Health Insurance Bill passage was hailed as a great victory, but it contained what is termed a 'rider'; a small amount of information that was passed quietly, without fanfare, without much attention, that undid everything entities worked for several years ago when they voted through a Bill giving permission for the masses to have and use vitamins and herbs as alternative health products without the FDA interfering.

This Awareness indicates that this rider was not an FDA program, but from the World Health Organization Codex program, which is a program that regulates the medical rights, in this case preventing the use of herbs, and vitamins as food supplements, and making it so that when it takes effect, entities will need to have prescriptions even to use vitamins, such as Vitamin C, and herbs for their health needs.

This Awareness indicates it has effectively gone through the process and will have its adverse effect on the alternative health approach which has been growing with great speed and acceptance by the American society.

Bill Will Eventually Close Health Food Stores Across U.S.

This Awareness indicates that this is indeed bad news for the alternative health business. It can and will likely cause the eventual closure of health food stores across the country. This has already occurred in Norway, whereas over half the health food stores have closed after this law was passed in Norway.

Globalists No Longer Use Term: "New World Order"

This Awareness indicates that the other news having much to do with the continued accomplishments of those who work to hinder the New World Order. The Globalists do not even use the term 'New World Order.' It is a derogatory term only used by Patriots and others who wish to bad-mouth the Globalists in regard to the concept of the New World Order. This Awareness indicates that those who are promoting a One World Government stay away from the term because it has become extremely unpopular in the United States.

This Awareness indicates that programs under the name of the New World Order have been very much hindered with great setbacks, and it is becoming more difficult to promote the idea of a New World Order, but the individual programs of the New World Order are still being pursued in a kind of separate or isolated manner. For example, gun controls, to take away any weapons that entities might use against those who would deny the sovereignty of the nation, or to protect individuals from an international dictatorship.

Million Man March on Washington Planned for September 1st

This Awareness indicates that likewise, there are other projects and programs such as that which has been termed the Fifth Column, and the movement of Patriots promoting a return to the Constitution, which has begun gathering more and more momentum. This Awareness indicates on September 1st of '96, the plan is for a million persons to arrive in Washington DC, demanding a return to the Constitution, and for the officials of government to restate and pledge themselves to the Constitution.

A Million Lawsuits and Subpoenas to be Filed Against Officials

This Awareness indicates that there are plans to have a

million lawsuits or indictments against officials who are not following their Pledge Of Allegiance to the Constitution, their sworn oaths to the Constitution, and these are to be put into semi-trucks, taken to the Republican Convention in San Diego, driven to Washington DC, with people across the country in a caravan, arriving in Washington DC, delivering these subpoenas and lawsuits to the officials or rather, to the courts for the arrest or suits lodged against the officials of government who have vacated their oath of allegiance to the Constitution of the United States.

This Awareness indicates that these lawsuits are planned as a million individual suits, realizing that they cannot be dismissed by one action of a judge in the same way that a Class Action Suit of a million people might be dismissed. The plan is to glut the courts with paper to the point where something has to be recognized; something has to be done, and they cannot simply be wiped away with a paid judge making a single ruling, for each of the cases needs to be given its own ruling by a judge and cannot be dismissed in such a way as to wipe out all other suits as could occur with a Class Action Suit.

Hildebrand Lawsuit and Claims Against Fed is Alive and Well

This Awareness indicates that in regard to the Hildebrand claims, it is still alive and well, but of course, it is also bogged down in the battle of those Globalists who want it ignored, want it tied up, want it held so that it does not proceed on schedule, and therefore the struggle continues with this; but this Awareness wishes entities who have interest in this to know that it is still alive and well as of this time.

Redress of Grievances Being Ignored by Congress

This Awareness indicates that the petition for Redress of Grievances that was produced in Congress some time back has been ignored by most of those senior congressional and senatorial incumbents, but the younger, newer congressional and senatorial entities have indicated that they understand, want to be kept informed as to how things are going, and will be of help where possible. Therefore, it is making some minor inroads with some success, but for the most part, the more influential senior Senators and Congresspersons who have some stains on their reputation are trying to ignore the Redress of Grievances in hopes it will simply go away.

This Awareness indicates that many of these entities are the ones being targeted by the Fifth Column, and many are found to have skeletons in their closets which are being brought out to haunt them or to force their resignations. This Awareness indicates that as has been indicated previously, there is a quiet war going on in areas of information that is of considerable significance in terms of the historical crossroads of this nation. It is quiet at the moment, but it is the kind of thing that could very easily erupt into violence and noise at almost any time.

Freemen of Montana in Very Precarious Position

This Awareness indicates that likened unto the standoff of the Freemen in Montana, everything is relatively quiet, but for entities to become complacent or to think that the quiet indicates the Freemen are safe or are winning would be premature, for although the Freemen do have a clear understanding of law, and all of their actions are based on the use of law, and could be easily explained in a court of law so as to win the legal argument, they are also very much in a precarious position against entities who have the audacity, strength and power to change the law to suit their own interpretation and to ignore the law, or areas of the law that do not fit their agenda, and therefore have the power and authority to use force to impose their own version of law against these entities, just as occurred in

Waco.

The Freemen Understand Statutory Law is Not the Law of the Land

This Awareness indicates that there are some entities who understand a more basic law than do others; wherein for example the Constitution is considered the Law of the Land and is held as a sacred document for several hundred years, and then someone begins to pass statutes under the Federal Government guidelines, and entities begin to think the statutes are the Law of the Land, and people begin to focus more on the statutes, and forget that the statutes are supposed to follow the Constitution to be legal, but wherein entities focus more and more on statutes, and the statutes begin to take on a distortion that is askew from the Constitutional Laws, then powers and forces begin to accumulate or gather to enforce the statutes and ignore the Constitutional Law of the Land.

Patriots and Loyalists Realize They Must Make a Stand

At some point, Patriots or Loyalists to the Constitution will feel it is essential to make a stand based on the law of the land as exemplified by the Constitution. This Awareness indicates that wherein the courts are established to follow the statutes and to ignore the Constitution, only giving lip-service and pretense to the Constitution, then these are tricks whereby the deceivers can confuse the public to make it seem as though anyone following the Constitution is criminal in behavior, is doing something wrong because the statutes prevent it, or the courts rule against them.

Why the Freemen of Montana Reject Federal Courts

This Awareness indicates that when the entity Bo Gritz entered the compound in Montana and talked to these people, he stated that he believed they had a chance to win their case in the courts of law. These entities recognize that the courts of law are not willing to recognize Common Law or Constitutional Law when it comes to a difference of which law is to be used. These entities in entering the Federal Courts, recognize that the Federal Courts have no jurisdiction over them unless they allow that jurisdiction. By pleading 'Guilty' or 'Not Guilty' they have acquiesced to the jurisdiction of the Federal courts.

Washington DC Has No Jurisdiction Over Freemen

Therefore, they avoid pleading in the court, refuse to acknowledge any jurisdiction, because they see themselves as coming under the Common Law and the Constitutional Law of the Land rather than under the statutory laws of the corporation known as the Federal Government, residing under the name of the United States of America incorporated, in Washington DC.

This Awareness indicates that these entities recognize that Washington DC is not a state, is not one of the United States, and therefore, has no jurisdiction over them or over the states except if the states give that jurisdiction to the corporation known as the United States of America, which is incorporated in Washington DC.

Some States Like Texas Have Declared Sovereignty

This Awareness indicates that some of the states have declared their own sovereignty from the corporation known as the Federal Government because it is understood by these states that the Federal Government was simply acting as an agent for the states to help coordinate activities among the states, and had no authority or power except that which the states granted to this Federal Government for its work in coordinating the states and the activities of the states, and therefore, as in Article 10 of the Constitution, the 10th Amendment, wherein the Federal Government can hold only the power given by the people and the states, and the rest is held, reserved for the people and their states; and these entities recognizing this

in many of these states, have recently re-declared their state sovereignty, and are no longer under the jurisdiction or control of the Federal Government.

When 38 States Declare Sovereignty, No More Federal Government

When 38 such states have done so, the remainder of the states can then reclaim control of the United States, through the Constitution, and the Federal Government can be dissolved. This Awareness indicates there are still many of these states that have not yet claimed their sovereignty, and people like the Freemen understand all of these ramifications, understand that it is essential for them *not* to give acquiescence to the Federal Government.

Why the Freemen Do Not Have Driver's Licenses

It is for this reason that they do not have driver's licenses, because the driver's license originally was for insurance purposes, relating to commercially operating companies, such as transit companies, trucking companies; any vehicle that was used for commercial purposes, and was never originally intended for the individual driver of vehicles, but after the various commercial vehicles were licensed, private individual began to feel or be convinced, that they also needed driver's licenses, and therefore, they joined in and got their driver's licenses and licensed their cars, and began to pay a Head Tax, which was originally against the Constitution.

Why the Income Tax is Illegal

They began to pay a tax on what they were told was income, though the 'income' as defined at the time is not the same as personal earnings for work given. That was an exchange of 'like for like,' of energy given for energy received. The idea of 'income' was wherein a commercial person or business earned money for an owner or shareholder of that business, and therefore, the entity received income from the sale of products or services of a number of workers.

In other words, if one had services that involved hiring out others, and you made a kind of profit from this, it would be considered 'income' but if you did the work yourself, this was not income, this was simply your own earnings, and therefore, many of these entities understanding how this tax-situation got distorted, refused to pay income taxes, using the claim that they do not have 'income'. They only have the earnings from the sweat of their brow; from their own labor.

This Awareness indicates that all of this is based on definitions of Common Law that were around for hundreds of years and which have only in recent years been distorted by implications and misrepresentations or by confusing the people into thinking that indeed they are earning income, must have a license, et cetera, et cetera.

This Awareness indicates that the Freemen are simply following the basic law which allowed corporations to be formed, which allowed commercial vehicles to be taxed or licensed, and which allowed commercial business to be taxable, but they also recognize that the basic Common Law was the Law of the Land which gave that kind of permission to tax certain activities of a commercial nature.

The Freemen's Philosophy is Closer to Constitutional Reality

This Awareness indicates that these entities have gone back to the basics of Common Law, and in so doing, are closer to the reality of the foundation on which the legal system was built, and the distortions that have come from statutory law that usurp Constitutional and Common Law have become so clearly familiar to the masses, that the masses believe the Freemen are a bunch of extremists, where in reality they are closer to the truth and the extremists are those who follow the statutory laws.

How the Corporation in Washington DC Expanded Into Our Lives

This Awareness indicates it is as though you live in a country in which the Law of the land is clarified, is perfectly clear, but someone comes into the country; supposing this country is called Wonderland; someone comes into the country and finds a piece of land that is just on the outskirts of Wonderland. It is a kind of small territory, just outside the border of Wonderland, and the entity says "This is where we'll create the headquarters for Wonderland!" and the entity incorporates in this small territory, what he calls Wonderland's Headquarters, and this company: Wonderland Headquarters, resting just outside the borders of Wonderland, makes an offer to the various counties in Wonderland: "We will help take care of the bookkeeping in your counties. We will run all of the mathematics, the computers and data that your county produces, keeping track, and giving you the information you need, and we will only charge a reasonable fee for this.

All of the counties say "Hey! Sounds good! I'm sick of this math and all of this bookkeeping; all of this effort! Sure! We'll give you our work! Take care of our books for us!" Thus, Headquarters of Wonderland begins to do the math, do the bookkeeping, do all of the data processing for each of the various counties in Wonderland, and gradually, over a period of time, everybody begins to recognize the good job being done by Headquarters of Wonderland, and it becomes acceptable and loved for its good work.

At some time, Headquarters of Wonderland says "This is beginning to be a little too difficult for us because there are discrepancies in the various counties. Some of you spend more on your police force. Some spend more on your entitlement programs. Some spend more on parks and recreation, and we need to have a more consistent management of these affairs, so that the counties are more similar in nature, so that entities going from one county to another do not have great distortions in the services made available."

This Awareness indicates that they then begin coordinating the activities of each county, creating little suggested rules that are not necessarily the Law of the Land, but for convenience. This Awareness suggests that after some time, something happens, whereby the Headquarters of Wonderland becomes aware of the need for inter-relations and trade agreements with other countries or places outside of Wonderland, and therefore, rules are created by Headquarters of Wonderland for an international trade. These International Trade Rules are accepted by the counties of Wonderland, who decide "Yes, this is beneficial to have these International Rules!", and therefore, Wonderland Headquarters becomes the spokesman, or spokes-entity for the counties of Wonderland, and all agree, and at some point, they have also gotten into electing the representatives of the corporation known as Headquarters For Wonderland, so that officials from the various states are elected to work in the corporation in their behalf.

At some point, the Headquarters for Wonderland might find that a problem occurs when neighboring countries want to dispute territories or get involved in war-like behavior, and the counties, rather than organizing amongst themselves to determine what to do, simply look to the headquarters of Wonderland for guidance because they have been so good at coordinating things of a domestic nature, and therefore, the Headquarters of Wonderland determines how to deal with this outside threat from these other countries.

Gradually, over several hundreds of years, the Headquarters of Wonderland begin to seem as though they are

the Headquarters of all of the counties of Wonderland, as though they were the leaders, even though they are simply representatives elected from the states or counties, and are supposed to be representing the county. It is likened unto having an attorney who is supposed to represent you, but who treats you as if you were a stupid idiot and runs your case, as though he were the authority in charge.

If you do not have control of your own case, then you are simply dependent on your attorney, and hopeful that he will do the right thing according to your wishes. This Awareness indicates that many entities have the same attitude toward the government, hoping that the Federal Government will behave properly in your behalf. This Awareness indicates that the Federal Government or the attorney that you have hired to represent you may have other plans in his or its agenda, and your interests may be of little concern in regard to his or its interest.

This Awareness indicates that at some point, some of the entities within these counties may begin to say "Wait a minute! This whole thing has gotten confusing, has gotten out of line. We hired that corporation known as the Headquarters for Wonderland to represent us and to help us in coordinating things, but now they think they own us. They think they own the counties. They think they own the people. They are passing laws that cause us much expense, much grief, much difficulty. Let us go back to the original common law of the land and denounce the rights and jurisdiction of the Headquarters of Wonderland. And let us call ourselves Freeman. Let us think of ourselves as free people, likened unto the forefathers who created this country at the beginning, for we have never really given up this claim as citizens of Wonderland."

This Awareness suggests that these entities realize then that they should not follow or obey any of the Federal mandates that have been handed down by the headquarters of Wonderland, because it is simply a corporation. It is not the land, or the Law of the Land, which had its own United Counties law, wherein the United Counties agreed on certain things in a Constitution that reflected their interests, and these entities realize that the Headquarters of Wonderland is just a corporation, and it is trying to pass Laws of the Land and enforce those laws on the people.

Why the Freeman Can't Surrender to the Federal Agencies

This Awareness indicates a corporation only has control over its own dominion, not over others in other lands or other states, or other counties. This Awareness indicates that these are the arguments of the Freeman. These are their essential basic arguments as to why they cannot go into a surrender to the Federal agencies or Federal courts, because the Federal courts do not represent them or their essential citizenship.

This Awareness indicates that there are many who will say "Yes, but the Freeman are writing bad checks or bad money orders, which are fraudulent," and these entities have a clear and very logical argument in return.

Why the Federal Reserve is Illegal and Unconstitutional

The Federal Reserve Bank in 1913, the night before Christmas Eve was pushed through Congress when most Congressional members were gone home for vacation, and gave the Federal Reserve Bank, which was a privately owned corporation, the right to solicit from the legal Treasury Department, the opportunity to have bank IOU notes printed with the appearance of the government being a participant and backing the IOU notes from the Federal Reserve Bank, the privately owned bank, so that the notes would pass for Treasury Notes or would pass for the equivalent of a Treasury Note in the form of an IOU.

Thus, the Federal Reserve Note indicated a debt: "I owe you a Treasury Note" and it was called a Federal Reserve Note. This occurred all over the country at this time, and in the century before, wherein banks could write notes, even mining companies could write notes which were good for a certain amount of value. The mining company, for example, could write a note of a certain value which the worker could redeem at the company store for goods or services, and banks could write notes based on their own values so that entities could go from one bank to another, carrying over some note that says "Bank 1 in Madison will pay 'x' amount of gold for this bank note, for this IOU note." Or it might say "Pay to bearer 'x' amount of gold. The bank in Madison will make it good." Or to some similar type of indication that the bank stood behind the note being passed by the bearer.

Federal Reserve Writes IOU Notes Not Treasury Notes

This Awareness indicates the various banks wrote these notes to one another and entities took these notes and would buy things, passing the notes from one person to another, and later the notes would be redeemed at the issuing bank. This Awareness indicates that thus the Federal Reserve Bank was writing IOU notes. They were not Treasury Notes. Treasury Notes were good for the exchange of silver or gold, and were backed by the United States of America, the corporation that was managing the affairs for the various states. This Awareness indicates that some of the Treasury Notes were backed by the various states in their state of being united, and issued or represented through the corporation known as the United States of America.

This Awareness indicates that at any rate, the Federal Reserve Bank was simply issuing IOU notes, and it would have to give the Treasury Department an exact amount of value to be allowed to have the Treasury Department print a similar number of IOU notes, (sic) Thus for, example, a hundred thousand IOU Federal Reserve Notes could be purchased from the Treasury Department for a hundred thousand Treasury Notes, and the Treasury would accept a hundred thousand Treasury Notes and print up a hundred thousand IOU Federal Reserve Notes in exchange for this, and thus the Federal Reserve Bank, for example, would have Federal Reserve notes backed by Treasury Notes, redeemable by Treasury Notes.

Federal Reserve Notes Increase at 10 to 1 Ratio

This Awareness indicates that the (Federal Reserve) bank was allowed to go a step further. Since the Federal Reserve Notes were now valuable, it was allowed that the Federal Reserve Notes could be used to purchase more Federal Reserve Notes, and the Federal Reserve Notes, having been backed by a hundred thousand Treasury Notes, could be increased, so long as it was assumed that all bearers would not trade in all of the Federal Reserve Notes for all of the Treasury Notes that stood behind the Federal Reserve Notes. Thus, they could take Federal Reserve Notes and give them to the Treasury and have the Treasury print more Federal Reserve Notes at a rate of approximately 10 to 1.

Thus, for a hundred thousand Treasury Notes, a million Federal Reserve Notes could be printed. It even reached higher proportions at times, so that eventually the Federal Reserve Board was simply printing Federal Reserve Notes at the cost of printing; whatever it took to print. Thus, the Treasury Department would pay perhaps one to three cents per bill, regardless of the amount on the face of the bill, whether it is a one dollar or one hundred or one thousand dollar bill; it would cost the same: one to three cents per bill; and this is what the Federal Reserve

Bank would pay.

The Freemen Understand Why the "National Debt" is a Sham

Thus, these entities in the Federal Reserve Bank were making money at printing cost, just as a counterfeiter might attempt to do in his profession. This Awareness indicates that the Freemen have watched this as it has occurred for approximately 83 years, as it has evolved into a situation in which the Federal Reserve Bank has amassed a five or six trillion dollar debt against the American people by lending money to the Federal government to carry on its programs or fight its wars, so that any time any Federal project takes place, the Federal Reserve Bank loans its notes, its IOU notes, and the Federal Government then in borrowing, must pay interest on the face of the bill, not on the cost of printing the bill, but on the face of the bill. Thus, over the 83 years since the Federal Reserve Bank was created, the National Debt has accumulated to over 5 trillion dollars.

If an Act is Illegal to Begin With, It Makes it Null and Void

This Awareness indicates that by Common Law and by most law used in the court, any action that is illegal, makes all further benefits or residual activities based on an illegal act null and void from the beginning. Thus, if one embezzles something from a bank and in the process uses that embezzlement to amass a fortune, all of the fortune amassed would revert to the bank and would be lost by the embezzler. One cannot commit a crime and escape the crime by paying for it out of the profits of one's earnings that have occurred from the crime.

This Awareness indicates that since the Federal Reserve Bank was illegally operating against the rules of the Constitution from the very beginning, many of the Freemen see that the 5 trillion dollar debt is null and void because it was based on deceptive, fraudulent actions from the beginning. Therefore, these Freemen see that if the Federal Reserve Bank can make money based on Federal Reserve Notes being loaned and invested to the government or to pay for projects of the Federal Reserve Bank from their counterfeit money, "Why can't we who have amassed liens against these corrupt officials and their properties, use these liens on these properties as collateral to print up our own money orders? If it is legal for the Federal Reserve Bank, it is also legal for us!"

Freemen Can Prove by Law That They Too Can Create Money

So, they go to the law books and can quote the laws that indicate this. They can also go to the law books and quote the laws that allow them to put these claims against these officials who are practicing malfeasance and acting in ways that are illegal, and whereby they can justify putting liens on their properties. This Awareness indicates in other words, they have it all figured out legally in the sense of what is going on in this country, and why they are doing what they are doing becomes very clear from a legal sense.

Controlled Media Can Make the Freemen Look Like Crazy Villains

This Awareness indicates the danger however, is that one can be 100% right legally and still be slaughtered by some Neanderthal or by some rogue policemen, or some rogue government officials or by some tyrant that cares nothing for the law, except the law that he or his henchmen create, and because these entities control the media, the communications systems, they can color history or color a situation in any way they want it to look. They can put the spin on it to make these entities look like idiots. They can make them look like crooks, like villains of the worst kind.

The problem also is that the Freemen, being so logical and correct in their legal understanding, are not thinking about the dangers, or if they are thinking about the

dangers, they see it as being so critical a time, so necessary, that they are willing to risk their lives and will *probably lose* their lives in making their stand. Right or wrong may not matter to those who are more concerned with power and control, for they can turn to the people and say: "Look! These idiots brought it down on themselves! There was nothing we could do! We were patient for 'x' number of days! We were so patient! We waited for so long! They continued to defy us, and to make a mockery of the law! There was nothing left for us to do!"

People Will Eventually Wonder Why They Lost Their Freedoms

This Awareness indicates the majority of the masses will agree. Some will say "Well, I'm glad that's over! It was really getting boring! Now what! What's next?" And they wait for the Federal Government to encroach upon their further rights, coming in to their home at some time in the future and taking claim to more tax money or to other rights that they thought they had, which they gradually begin to realize do not any longer exist. Then they will ask: "What happened? When did we lose our freedom? What about the Constitution? Doesn't anybody remember it?" And they will wonder how it all disappeared.

Today as Critical as it Was at Time of Boston Tea Party

This Awareness indicates that this is equally as critical a time in the history of this country as it was after the Boston Tea Party during the heyday of the Declaration of Independence and that revolutionary war which followed to create the history that lies behind the freedoms that entities so proudly parade in their current and modern lives. Most entities are so proud of their heritage, as if they helped bring about the freedoms they enjoy, but most entities do not even want to take the time to understand how fragile those freedoms are or what they are allowing to happen to those freedoms, and how those freedoms are being eroded day after day.

Bob Dole or Bill Clinton May Not be Presidential Candidates

This Awareness does wish to say something further in regard to the current situation; this is in reference to the political situation of the presidential election. This Awareness does not see the entity Bob Dole as being a likely winner in the presidential election, nor does *It* see William Clinton as being a likely presidential winner in this coming election. *It* sees both of these entities as more likely *not* to be in the election in the final weeks, so that someone totally different may take the reins of the country.

This Awareness indicates it is a relatively uncertain situation, but this Awareness wishes to inform you that there is a great potential for both of these men to be out of the race before the election.

Brandy Schweitzer, Freeman's Daughter Cries Out: "My Dad Has Been Tortured!"

QUESTION:

The entity Leroy Schweitzer who has been called the brains behind, or one of the main brains behind the writing of these so-called phony bank notes which is what the government is using as an excuse to get these Freeman; this entity answered the door, and it was an FBI agent in disguise who asked him if he would help him get his car out of a snow bank, and the entity went to help him, and he was arrested.

"The following affidavit, reproduced for the Internet, was made on April 11 by Brandy Schweitzer, Leroy

Michael Schweitzer's daughter. As well as being extremely moving, it is compelling evidence that the United States has tortured Mr. Schweitzer. Please distribute as widely as possible. It is in the interest of all that hope for the day we shall return to "Innocent Until Proven Guilty in a court of law."

"To begin this affidavit," she says, "I learned of my dad's, Leroy Schweitzer's arrest on Monday morning, March 25, 1996. He was taken to the Yellowstone County Detention Center in Billings, Montana. Beginning that same evening, through Wednesday the 27th, I heard repeated reports of my dad's mistreatment. By 'mistreatment' I mean he was being beaten. These facts were affirmed by friends and family members who both saw and talked to my dad on Tuesday and Wednesday.

"By mutual agreement, my three brothers and I decided to travel to Billings and visit with him ourselves. On Friday the 29th we visited our dad from shortly after 3:00 PM to around 4:00 PM. During that time we learned that he was not just beaten, but rather tortured. To 'torture' means 'to inflict or subject to extreme physical pain,' according to the Funk and Wagnalls standard dictionary. He described in detail how the Federal Marshals put shackles around his ankles and wrists so tightly that he bled.

"He said they strapped him in a chair and kicked him in the legs, hit him in the face, grabbed him by his hair and yanked his head around, pushed in on his ears with their fingers until he almost passed out, and pressed on the backs of his fingernails. They turned down the heat in his cell, took his blankets and his mattress and left him in only his tee-shirt and pants. I state all of this because in spite of it, he was in very good spirits.

"He quoted the law, as he often does, and recounted the past week's events. He joked with us and asked us if we remembered some of the particular camping trips we went on. He told us that only good would come out of this. He said that they would never break his spirit. He kept saying that to them this was a 'hot potato' and they didn't want him to keep uncovering all the corruption. He was extremely optimistic, sound of mind and full of conviction. This was how he appeared to me on Friday afternoon.

"On Friday evening, around 6:00 PM we visited dad again. Again he quoted law after law, recalled past events, explained his reasoning for not allowing them jurisdiction or granting them venue. He said he felt great. He got excited, when he told us about God providing for him and that this was all in His plan. He said he had faith that God is in control. He talked with two receivers so two of us could talk to him at a time, but his voice was so strong that the two of us without receivers could sure hear him most of the time.

"We were allowed to visit for close to two hours. He smiled and said he loved us when we were done. He waved to us through the glass divider. This was how he looked on Friday evening the 29th, just before 8:00 PM. On Saturday morning around 10:00 AM I received a phone call from a family member saying that they had moved my dad. I spent most of the day on the phone. I called the Yellowstone County Detention Center, the Marshal's office, the FBI, the US Attorney's office, the governor's office, Senator's office, and the US Medical Center in Springfield. Not one person gave me an answer as to what was going on and why we were not notified that dad was being moved.

"Sunday, March 31st I began to make travel plans to go to Missouri. Monday, April 1st, I made some more phone calls. I finalized our, (my friends, my brother and

I), travel plans. When I called the Marshal's office, we had a conference call with the Medical center. I was told they wouldn't guarantee that I could get in to see my dad. Tuesday, April 2nd, we traveled all day. Wednesday, April 3rd, four days since I had seen my dad, at around 9:00 AM I called the Medical Center to ask if my brother and I could visit. We were told we could have an hour's visit, granted by the warden.

"At about 1:45 PM, we arrived at the Medical Center. After we were "approved", we waited for about ten minutes in the front desk area. Officer Daniels, who supervised us the entire time of our visit, told us that our dad would have an N-G tube in his nose that they used to force feed him, but he told us not to be shocked or alarmed. After we walked through two electric doors, we were shown into a room where my dad was standing and waiting. He had an N-G tube hanging out of the left side of his nose. There was white tape across his nose, probably for the purpose of holding the tube in place.

"Dad walked slowly over to a group of chairs where we sat next to each other. He held out his hand to me and I grabbed it. He said hello in a faint slow voice. He grabbed Scott's hand and said hello. He was dressed in a short-sleeved tan prison suit with thin blue slippers. For the first few seconds he didn't speak. He just looked at us. He wasn't smiling. He just seemed almost surprised that we were there. He asked us how we found him. He didn't appear disoriented. He simply looked like the last four days had been very rough on him.

"He told us about the tube in his nose. He explained that he is X-rayed every time they put one in. It goes up his nose and down his throat. It is extremely painful, and it hurts him a great deal to talk to us, but he said they told him if he pulls it out, they'll put a bigger one in, so he said he would leave it in and stand the pain as long as he could. He did not want to be X-rayed anymore. He told us he couldn't believe how corrupt and Satanic the system is, and then he held out his arms in a gesture to look at what they were willing to do to a person who threatens to expose their evil ways.

"It was a sight enough to make you sick to your stomach, but he reminded us that even if they destroyed his body, they would never touch his spirit. Then he added, "May God have mercy on their souls!" And it was evident that he had seemed something truly evil, while the rest of us were kept from knowing all that happened those four previous days. He told us of some of the threats he received, such as if he didn't do as he was told, they'd start breaking bones.

"He said that he was visited by a young doctor from New York whose threat was that if dad ever did get released, they could always shoot him up full of cancer first. He looked at Scott and I and said: "You don't deserve to live in a system like this!" He said "It's very important that the people know I didn't eat." He said he made a vow not to eat or drink until he got a grand jury trial, and he kept his word.

"At that time he was having a hard time talking due to the pain of the tube down his throat. He had bruises on the inside of his elbow. I asked him if he had been given any medication. He said "They've stuck me here", pointing to the inside of both of his elbows, "and put an I.V here", pointing to the top of his hand. He said he didn't know what type of drugs they were using, but he could smell them when they put them through the tube in his nose. He kept talking about the family.

He talked about our country and that I was too young to remember how good it used to be, but that if he could help it, it would be that way again. He said "I love my

country!" At the end of our supervised visit, it was hard to say good-bye. He gave us a long hug and told us he loved us. He looked at us and said "Keep your faith." He didn't smile. He just looked at us before we were told to leave. We all cried.

"This is what has been done to my father. I affirm that I am 21 years of age, of sound mind, and capable of listing in this affidavit the events which have taken place without the assistance of another. The statements contained herein are true, correct and complete to the best of my knowledge and belief, as of this date, April 11, 1996, signed (and notarized) by Brandy Schweitzer."

Does Awareness see that as being accurate?

COSMIC AWARENESS:

This is in the affirmative. This Awareness indicates that these entities in pressing for their New World Order are willing to go much further in terms of controlling the masses at whatever cost. If Patriots Can't Awaken the Masses, Cosmic Energies Will



SINISTER UN CODEX BILL PASSED IN U.S.

(Prescription by Doctor Required to Buy Herbs and Vitamins)

QUESTION:

(4/30/96)

A question from Michael C., in Ontario, Canada. Awareness gave some information last night about this. He said "Would you ask Awareness to comment about the United Nations' world health organization Codex, Alimentarius Commission, and its influence on the availability of dietary supplements to consumers around the world?"

"Is it true that under GATT, member nations must harmonize their rules governing the manufacturing of health products with new international standards so as to be in line with them? And if member nations must conform to GATT's standards on cost benefit analysis, and on creating and reviewing scientific data for risk assessment, could this not be considered the greatest threat to health freedom in the world today?"

COSMIC AWARENESS:

This Awareness indicates that this is in the affirmative; that this has already taken shape in this country in the health insurance bill that was passed approximately a week ago, or two weeks ago in early April, which contained a provision within that bill to adopt the plan from the world health organization Codex, for the purpose of bringing all herbs and vitamins in the United States under the standard rule of the program so that entities would need prescriptions for the use of herbs or vitamins and similar health supplements in order to have them for their own health purposes.

This Awareness indicates that this could and is likely to be felt in its control over the masses within the coming year, whereby these vitamins and herbs will gradually be removed from the marketplace, made available only from prescription, meaning that entities would need to have an office call and prescription in order to purchase Vitamin C, Vitamin B, or any of the other vitamins.

This Awareness indicates that this may also include minerals. It will depend on how the interpretation of the act is presented, and how soon it is adopted in its entirety. This Awareness indicates that while this is an absolute and total affront to all entities, and is extremely repressive to entities seeking to attend to their health needs. This Awareness indicates that it is also perhaps to be the straw that breaks the camel's back, that turns the masses against the United Nations' programs and encroachment into the freedoms of individuals in this country.

It may have a completely reverse effect in their efforts to gain control over the masses. It is likened unto winning a battle over a law, but possibly turning the tide of the war against them. This Awareness indicates if all of the health field and industry and people concerned about health care should turn their anger toward the Bill and toward the United Nations World Health organization, it may actually turn around the thinking of the masses in this country and move them from any tendency to support the New World Order or Globalists' agenda, to that of opposing it.

Is There Any Way to Reverse this Law?

FOLLOW-UP QUESTION:

A couple of other questions along this line from Michael C. He writes "A German proposal for Codex has proposed radical changes in the rules governing dietary supplements, called "Proposed Draft Guidelines For Dietary Supplements." These guidelines would become binding on GATT member nations, which means that individual nations' rights to set their own standards would be eliminated.

"Would you ask Awareness if there is a way of stopping this from happening, or if this control can be reversed?"

COSMIC AWARENESS:

This Awareness indicates that it has *already* happened in the United States. It is likely that it will continue because there is so little attention being given to this in other countries, and the people are not being notified, just as they were not notified in the United States, and it passed as a rider of a different bill, the health insurance bill.

This Awareness indicates that it is one thing if people know about something so they can oppose it. It is quite another when it is slipped in unnoticed into a Bill that most people would not oppose. This Awareness indicates that it is possible for you to contact some of your Canadian representatives, seeking to be informed of anything related to this, so that if it is something that comes up in the near future, you will have the opportunity to notify the press or the public or rally some of the health food stores and proponents to oppose it, but this Awareness indicates that this does not appear to be a task that would be easy for you to accomplish.

It would require great effort. The more entities working with you, the better chances you would have.

FOLLOW-UP QUESTION:

He goes on: "Is it true that delegates to the Codex committee are represented by the giant pharmaceutical corporations and that the general public has zero representatives on this important committee?"

COSMIC AWARENESS:

This is in the affirmative.

Does Codex Control the FDA?

QUESTION:

"How much control does Codex have over the FDA?"

COSMIC AWARENESS:

This Awareness indicates that the FDA is simply a national version of the United Nations' Codex. This Awareness indicates that the Codex does not necessarily 'control' the FDA through the United States as a direct influence, but it has its own channeled control into the affairs of this country through the various treaties, such as the GATT treaty so that it does not matter whether the FDA works with them or not.

This Awareness indicates the FDA did make a similar attempt to help these pharmaceutical companies several years ago and it was loaded down with a bill giving entities a kind of freedom of choice in terms of the right to use health care products, but this did not in any way slow down the efforts of the GATT treaty and the influence of Codex on this GATT treaty which now has its effect over the masses in the United States, regardless of their previous victory over the FDA.

HAS CANADA AND THE U.S. GIVEN UP THEIR SOVEREIGNTY?

FOLLOW-UP QUESTION:

And he asks: "Have our governments of Canada and the United States given away most of our sovereignty as a nation in these issues? Are we down to only a few delegates that are outvoted on this committee? How can our countries gain control with and without sanctions against them?"

COSMIC AWARENESS:

This Awareness indicates that it is only a question of whether the masses will awaken and rally and regain

control of their own destiny. It is not a matter of a method or steps by which entities can legally act to gain control of their country after it has been lost, to regain sovereignty after it has been given away through negligence. It is a matter of whether the masses wake up in time and have enough initiative to do something.

This Awareness indicates that there is always the question of "What can happen that will make the masses awaken?" This Awareness indicates that these things do occasionally happen; the masses will awaken for a brief time; but most people are so busy trying to earn a decent living, to meet the demands of their financial requirements from one payday to the next that they do not really have time to even study and examine and learn what the problems are. Therefore, it becomes very difficult for anyone to expect the masses to compete with those who have the unlimited funding to do whatever they wish in the higher levels of government.

The Fifth Column and Other Positive Energies at Work

This Awareness has already indicated some of the more positive actions that are occurring; the 5th Column activities; the claims against the Federal Reserve Bank, and the various things of this nature that have been occurring. These are not necessarily enough to save the masses from enslavement by the powers that control the economies, what may be termed the 'World Management Teams' but these are what exist, what are there for entities to be aware of, for there is indeed a struggle going on, and 95% of the masses are untouched and uninfluenced by the struggle; but if this other 5% who are involved in the struggle fail in their efforts, then the 95% along with the other 5% will become enslaved by these World Management Teams and it may be hundreds of years before anything like present freedoms are experienced again.

The Spiritual Aspect Also Can Have an Effect

This Awareness indicates that there is always that spiritual aspect, things that can happen as has been suggested by this Awareness which can have an effect that even the best-laid plans of mice and men cannot prepare for. This Awareness indicates that *It* wishes you not to despair, regardless of how difficult things may seem, or how bleak and dark things may become. FOLLOW-UP QUESTION:

Michael sums up his questions with this statement: "These power mongers, control addicts and greedy select few are really getting to me, the way they behave. They don't seem to have a concern for anything except power and the bottom line. We, like sheep, because of lack of knowledge or trust in our leaders, are being led to the slaughter.

"It's time we quit buying their products and put the control back in the hands of the people. If the elected officials do not comply, they should be removed from office. It would be nice if we could get members of

government to run for election every year so we could replace them sooner, if the need arose."

COSMIC AWARENESS:

This is in the affirmative. This Awareness indicates that there is still another paradigm that entities may wish to hear about. A paradigm is a kind of model reality that is different from anything else, and This Awareness indicates that just as the free energy sources were discussed recently as a kind of paradigm, there is also a program already in action that is a financial paradigm, a program that does need to be understood by the masses so that they can get involved, but at the same time, this program needs to have a certain amount of time in which to develop without too much attention.

This Awareness has hesitated in speaking of this because of that danger of overexposure too soon. This Awareness indicates it is likened unto the situation in which the Christ Child was born, and the word went out, and King Herod, hearing of the birth of the Christ Child, set out to have all young boys slain, in order to make sure the Christ Child was killed before being able to do anything that might threaten the king.

This Awareness indicates that it is the same with this program in a financial sense. It is a program that could totally turn around the economy of the world, but it also could be wiped out from being too widely exposed too soon. WHEAT FUNGUS INTRODUCED TO U.S. TO CREATE FOOD SHORTAGE

QUESTION:

We received over the Internet, an excerpt from a Montana update dated the 9th of April, and the update of the subject was a piece about food shortage. "People may be interested to know that a fungus has infected wheat crops. Secretary of Agriculture has declared an extraordinary emergency and placed wheat in the entire state of Arizona and in some counties in New Mexico, Texas, and

California under quarantine.

"Among other things, transport of crops is prohibited and the land may not be used for five years for growing. You've not heard about it, but the situation is extremely serious. United States is a large wheat exporter and reliability of the product is paramount. Canada decided, but may reconsider, that US wheat cannot travel through-out that country.

"It is thought that the fungus came in courtesy of NAFTA through Mexico, where fungus has existed for some time. Finally, US tax-payers will have to compensate the effected wheat-growers for the loss of their crop now and in the future."

Does Awareness see any truth to that?

COSMIC AWARENESS:

This is absolutely true. This Awareness indicates it occurred at a time when the United States' wheat storage has been almost totally depleted. For years the United States has had a super-abundance of stored wheat, but has in the past several years depleted its storage of wheat which makes the loss of wheat crops very serious in terms of the food supply. This will run the cost of all bakery goods to a sky-high limit or price, and will create a serious problem in the price of foods across the country.

This Awareness indicates it is perfect for the New World Order agenda, almost as if it were planned. It could not be better for them if it had been planned to be this way. This Awareness indicates that it causes one to wonder if perhaps it was planned. The food shortages that will follow as a result of this, particularly if it continues to spread into more counties can be totally disastrous in terms of the food budget of families.

Learn to Garden and Stock Up on Tools

FOLLOW-UP QUESTION:

I take it Awareness would continue to recommend entities starting their own gardens if possible, and stocking up on certain grains and so forth.

COSMIC AWARENESS:

This is in the affirmative. This Awareness indicates that even more basic, this Awareness suggests that entities have on hand garden tools in order to be able to start gardens. If they do not wish to start a garden this year, have tools on hand so that next year you can, if you absolutely must have a garden, for it may be the very least will be for you to have the tools necessary for you to have a garden in your back yard or in your community which you can share with others, but the important thing is to have tools on hand so that you can plant food if necessary.

This Awareness indicates there are many entities who are so spoiled by the system that they would not think of growing a garden when they can simply go to the super-market and get fresh-picked produce, but This Awareness indicates one cannot be sure that the fresh picked-produce will always be there, just because it has always been there for the last 40 years, for there are things that are being manipulated in your world so as to create a crisis that can be handled with a particular result, and that food shortage is a manipulated problem that can lead to a desired result and if these people who want more control over the masses resort to that food shortage, your security in your supermarket may be misplaced, and it will be of great value to you to have the tools on hand so that you can plant a garden if it becomes necessary.

The Three Most Important Tools to Own

You should have, at a very minimum, a shovel, a hoe, and a rake. Not a grass rake, but a rake that can be used

for pulling out weeds that have been cut. A rake with strong tongs. This Awareness indicates that this rake could be a kind of hand cultivator with three prongs and this would work fine, or perhaps even better than the wide grass-rake. This Awareness indicates that the shovel and hoe are the two most important tools that everyone should have in these dangerous times that are coming for entities.

This Awareness indicates in the meantime, you need to purchase 50 or 100 pounds of rice and wheat. This can be of great benefit. You may even wish to buy a grinder so that you can grind your wheat to make your morning cereal or meal for cooking. This Awareness indicates also beans are a good food to store; dried beans.

How to Store Garden Seeds

QUESTION:

Several people have written in asking what the best way is to store seeds, garden seeds that is.

COSMIC AWARENESS:

This Awareness suggests that these are best stored in glass jars that are not necessarily air-tight, but moisture proof. This Awareness indicates that they can be kept dry in these jars and may remain in their packages within the jars. This Awareness suggests that this in the event you purchase seeds in packages. Paper packages or plastic packages can either be satisfactory.

FOLLOW-UP:

Is freezing seeds recommended?

COSMIC AWARENESS:

This Awareness does not recommend freezing seeds. This can have some effect in terms of moisture and could also be a hindrance to certain types of seeds, and could damage some of the seeds, although some of the seeds can withstand freezing. If the seeds have moisture in them and are frozen, they could be damaged.

"Mad Cow" Disease and its Implications

During the past month or so there's been a lot of stories about so-called 'mad cow' disease hitting Europe which has terrified a lot of people and the government has told them to stop eating cow's meat and that they're talking about slaughtering millions of dairy cows, and there's stories that it has spread to other countries, including the United States, and that it's associated with a fatal brain illness. Others claim that it's some kind of a conspiracy, and so forth.

Would Awareness discuss the 'mad cow' disease and its implications?

COSMIC AWARENESS:

This Awareness indicates that this came about through efforts of some of these cattle producers to find a way to feed their cattle more growth hormone. This Awareness indicates they found that by giving growth hormone in meat and then grinding the meat with the growth hormone and putting it in with other cattle feed, they could feed the cattle more growth hormone. They began using growth hormone on sheep, and when the sheep were saturated with growth hormone, would grind the sheep meat, mix it with cattle food, then feed it to the cattle, and fill the cows with more growth hormone so that they would grow faster.

This Awareness indicates that the next phase that began occurred when they began to grind cattle that had been over-saturated with growth hormone and give cattle meat to their cattle mixed with their food so as to saturate the cattle with more growth hormone. Essentially they were involved with cattle cannibalism, feeding cows meat from other cows, and using meat as a carrier for growth hormone.

It had an adverse effect in that it created the disease that became known as 'mad cow' disease and it began to spread, not relying on the feeding of meat and growth hormone anymore, but simply spreading from cow to cow through other contagious means. This Awareness indicates the effect of the 'mad cow' disease is mostly on the tissues, especially the brain, whereby the brain turns to a kind of mush and falls apart.

This Awareness indicates that it also cannot be killed by high heat. Extremely high heat that would burn the meat, turning it into char or charcoal will not kill the 'mad cow' disease, therefore, cooking the meat thoroughly does not rid the meat of the danger of spreading the 'mad cow' disease. This Awareness indicates that there have not been any publicized cases in the United States of individuals yet having this disease or getting this disease from the cows, but it is only a matter of time.

Eating Beef Today is Like Playing Russian Roulette

There was a report of an elk having a related type of disease. The elk was not one of the wild elks but was in a game reserve and it was not explained how the elk got its disease, or if it was in any way related to the 'mad cow' disease, but the symptoms were similar. This Awareness indicates that entities do need to think carefully about eating beef products at this time, or in the future, for it is likened unto a game of roulette. Today there may be one or two cases of 'mad cow' disease in the United States, but it could spread, just as AIDS started with one or two isolated cases.

Therefore, entities need to be most careful and consider perhaps switching to a different kind of meat or avoiding meat by switching to some other kind of protein source. This Awareness indicates that this could be important, at least until entities become more secure and can tell which way the wind is blowing, whether this is the beginning of a plague or whether it is simply a fluke of nature that will quickly pass.

Maybe things will return to normal next year. Maybe things will not. But entities need to be very thoughtful every time they think of biting into that hamburger, even if it is well-done.

FOLLOW-UP QUESTION:

The British government put out a statement that there was no scientific proof that this disease BFE can be transmitted to man by beef. That's the 'mad cow' disease. It's got a long name: bovine spongiform encephalopathy ; but evidently they're in error with that statement.

COSMIC AWARENESS:

This Awareness indicates there have already been reports of individuals who have suffered this disease and died from it. Whether these reports are true could be argued. This Awareness indicates that it is a matter of entities being careful. Keep in mind that for 50 years, the tobacco industry has argued that there is no scientific proof that cigarettes or smoking has led to cancer or that nicotine is addicted.

These statements can be made by authorities, but authorities are not necessarily without error, nor are they necessarily always credible.

FOLLOW-UP QUESTION:

So this problem is caused as Awareness explained, by hormones put in the feed. It has no connection whatsoever to the Global 2000 planners?

COSMIC AWARENESS:

This Awareness indicates that there may be some connection. It did not allude to any connection, It simply described how the growth hormone was being engineered to be put into meat, which could then be put into other

food, which would then be ingested by the cows and how this led to the 'mad cow' disease; but connections take place between the actions and the eruption of the 'mad cow' disease are questionable, and It does not see any intended or absolute intention by Global Planners for creating this 'mad cow' disease. It does not see this at this time.

Why Some Questions Can't be Answered Immediately

This Awareness indicates that It has not put forth a focus of energy on this and therefore, it is not part of the concern being addressed. This Awareness wishes entities to understand that when questions are asked of this Awareness, energies need to be focused for enough time to receive the information that resides in the energies, because information is energy, and energy is information. Therefore, the energizing helps to bring out the information, but many times the information is not instantly discerned, particularly if there has been very little energy focused on a particular concern.

This Awareness is not ready at this time to say that it is or isn't a part of the Global 2000 programming. This Awareness indicates that It will have to have more energizing to answer that question.

WHAT IS THAT SECRET UNDERGROUND COMPLEX IN RUSSIA?

QUESTION

There's an article reprinted from the New York Times I'd like to read and ask Awareness what's going on here. It's dated : Moscow.

In a secret project reminiscent of the chilliest days of the Cold War, Russia is building a mammoth military complex in the Ural mountains, Western officials and Russian witnesses say. Hidden inside the Yamantau mountain in the Beloretsk area of the Southern Urals, the project involved the creation of a huge complex, served by a railroad, a highway and thousands of workers.

The project, some Russian officials say, was begun during the era of Leonid Brezhnev, when the Soviet Union was locked in an arms race with the United States, the Communist Party ruled the country, and the military budget seemingly knew no bounds.

Russia's decision to proceed with the costly venture underscore the continuing influence of the military at a time when the government is struggling to pay back wages to its workers and to cope with a growing budget deficit.

The construction of the project, which has been observed by U.S. spy satellites, mystifies American specialists, who speculate that it may be anything from an underground nuclear command post to a secret weapons production plant.

But while there is uncertainty over the purpose of the project, it has already become a politically delicate issue for the Clinton Administration.

The United States is spending hundreds of millions of dollars to help the cash-starved Russian government dismantle old nuclear weapons. To win Congressional approval for the money, the Clinton administration has had to certify that the Russians are not undertaking new military projects that go beyond their defensive needs.

The project is also being carried out despite complaints from Russian lawmakers that the government does not have the money to comply with new treaties slashing strategic arms and mandating the destruction of chemical weapons.

"We can't say with confidence what the purpose is, and the Russians are not very interested in having us go in there" a senior US official said. The Russian Defense Ministry refuses to say anything about the project, which is proceeding with virtually no public debate.

Whether the project is worrisome from a military perspective is a question that divides American specialists. Senior Pentagon officials say they believe that it will serve as a command and control center for nuclear weapons and a bunker for military leaders. According to this view, the project appears to be defensive in nature, but other top Clinton Administration officials are more worried, asserting that the Russians have refused to provide a full accounting of the project.

Recalling the underground sites that North Korea has built, these officials fear that the Russian project may encompass weapons production facilities as well as other programs that the Russian military wants to keep from US spy satellites.

Can Awareness explain what exactly is going on there?

COSMIC AWARENESS:

This Awareness indicates that it appears to be a kind of research and development center in which all types of technologies that are of interest in terms of military, in terms of weather controls, in terms of extraterrestrial technologies, are being studied and set up for future research and study. This Awareness indicates that it is not that unique or is not exclusive that the Russians are involved in this, for the United States also has its own Area 51 and similar secret research bases. What is frightening about this is that the majority of experts outside of Russia do not have a good understanding of what is occurring and can therefore speculate on their wildest imaginings.

Cosmic Geometry: Instant and Total Destruction of a City

It does not appear that the research has much to do with atomic bombs or any of the old conventional methods of destruction. There is a different kind of science that has emerged, having to do with Cosmic Geometry, some of which has come from what may be termed 'extraterrestrial technology' having to do with the use of geometric energies that can be used to create forces that are capable of totally destroying a city in an instant, leaving nothing but the bare earth; no rubble, no residue, nothing but the bare earth where the city used to be.

This Awareness indicates this is done through the use of frequencies and vibrations and geometric uses. This Awareness indicates that this technology was discussed on one of the Art Bell Dreamland radio shows some time in the early part of 1996 or late part of 1995, and may be found in his index of topics for anyone wishing to pursue this further.

This Awareness indicates that it appears that this is one of the areas being researched in this Russian base. This Awareness indicates that it does not necessarily follow that Russia is seeking to destroy cities in the United States. Just because there was once a conflict or hostility between the Russians and the United States does not necessarily mean that this has gone underground, but continues, as many would like to think.

This Awareness indicates that this technology may be useful to the Russians for other ambitious purposes, not necessarily relating to reviving the Cold War. It may simply be that they, like others, want to have the power to be a formidable adversary if it suits their future purposes or plans. This Awareness indicates that they may have fears of aliens. They may have fears of other nations on earth becoming adversarial in the future and may simply want to be ready and prepared with super-weapons if the need should occur for them to use such.

This Awareness indicates *It* is not saying this to downplay the dangers of such technology; *It* is simply not wishing to play up the fears that entities may have and exaggerate and blow them into greater than necessary

concerns.

AN OVERVIEW OF RUSSIA TODAY

QUESTION:

Greg S., Parkville, MO, asks if Awareness can give an overview for Russia for this year because of the elections coming up in June and July, and there's about 5 candidates, some of which want to go back to Communism, and others which want to break entirely with the U.S. There's talk of Gorbachev coming in and there's also running is Vladimir Zhirinovsky, whom Awareness has discussed in the past, who seems to be a very radical individual.

Does Awareness see anything coming up in this election that might warrant a change in direction for that country?

COSMIC AWARENESS:

This Awareness indicates that there is seen a threat of conflict which may be internal rather than external, wherein the conflicts are not necessarily to involve outside countries, but may involve nations within that which was once the Soviet Union, or may involve groups, or for lack of a better word: 'tribes' within Russia, these being cultures within Russia. The Communists being categorized in this example as a culture.

This Awareness indicates that the conflict appears at the moment to be nonviolent, but having deep, strong emotions that could very easily be manipulated and disrupted so as to become violent as various efforts by different individuals and leaders are thwarted or repressed. This Awareness indicates as for the various types of conflicts occurring, there are also many new Capitalists in Russia.

Many of these new Capitalists are essentially the Russian version of what you would think of as gangsters or Mafia types in other parts of the world. These Capitalists often will use violence or other means to get what they want so that it is not only the military, it is not only the conflicting political parties, but it is also money barons who want to control their piece of the pie and are willing to be violent in order to maintain their control.

Therefore, the nation is in a very unstable and volatile condition, and the peace that is presently recognized in Russia is a very fragile peace. This Awareness suggests that there is a non-certain or non-clear chance for Boris Yeltsin to be re-elected. It is not clear that this will occur, and it is more probably than not that he will be re-elected, but there is also considerable room for doubt. It is likened unto approximately a 55% chance of re-election, but this could also change in the coming weeks if the events occur that hinder his standing.

This Awareness indicates in other words, there is no clear victory seen for any particular individual, but the energies of Boris Yeltsin appear to have the edge at the moment.

Russian Mafia in Cahoots with Federal Reserve (Billions of U.S. Dollars Flown Daily to Gangsters)

We got a transmission on the Internet from the Conservative Consensus. I'll read a little bit of this:

"The Fed, Republic bank and the Russian Mafia. U.S. one hundred dollar bills valued at over one hundred million are flown every week night from New York's John F. Kennedy airport to Russian banks controlled by the Russian Mafia. The sales, by Republic National Bank have been sanctioned by the US Federal reserve.

"Since January, 1994, over 40 billion in new one hundred dollar bills have been shipped to Russian banks. That amount far exceeds the total value of all Russian

Rubles in circulation. The money is used to finance the Russian Mafia's growing crime syndicate, alleges U.S. investigative journalist Robert Friedman in an article in New York magazine. Friedman said that a U.S. State Department cable in his possession indicated that Russian organized crime now controls 50 to 80 percent of that nation's banks.

"Russia has become one of the world's premiere money-laundering centers. The Russians have figured out a loophole and have been able to infiltrate the international banking systems" he said. The State Department cable quotes Victor Milnikov, Russian Central Bank Director for Foreign Exchange Controls who "warned that much of this imported money was being used for illegal purposes, including narcotic trafficking."

"Friedman also quotes a former New York banking official as saying, 'Republic is guilty of willful blindness, though not in technical violation of any law.' He also quotes an official in the Federal Comptroller of the Currencies Office as saying 'that money is used to support organized crime, is used to support black market operations. In my personal opinion, this is an absolute abomination. It should not exist. Yet, it appears that at least part of the Federal Government sees nothing wrong with it.'"

So evidently, Russia is going to be a new shipping point for drug into the United States if that report is true. Does Awareness see this as being valid information?

COSMIC AWARENESS:

Federal Reserve Bank in Cahoots with NWO Mafia

This is in the affirmative. This Awareness indicates that the Federal Reserve Banks in the United States now working with the Russian Mafia indicates that these Russian Mafia types will be major players in the plans of the New World Order. This Awareness indicates that this may be shocking to some of the entities who thought the Federal Reserve Bank was represented by the United States government and that these were all good loyal honest officials behind the banking activities.

This Awareness indicates it is not surprising to others that the Federal Reserve Banking system would be working hand in glove with criminals known as the Russian Mafia-types, supplying them with billions of Federal Reserve Notes and to play their power games with. After all, the Federal Reserve only has to pay for printing costs for these moneys. They do not have to pay the face value of the moneys. Therefore, giving 40 billion dollars to the Russian Mafia might only cost them a few thousand or hundred thousands to print, depending on the number and denomination of the bills that were presented to the Russian Mafia.

WHY IS NEWT GINGRICH HELL-BENT ON BALANCING THE BUDGET?

QUESTION:

Phyllis V., of Yelm, Washington, asks "Why is Newt Gingrich so insistent on balancing the budget? Is there something else going on here in the United States, or somewhere else that he is trying to just divert our attention from?"

COSMIC AWARENESS:

This Awareness indicates that the Patriot Movement has been trying for years to show that the Federal Reserve Bank has no honest or legitimate claim to the national debt, the 5 trillion dollars owed to the Federal Reserve Bank; that this debt is false because it was incorrectly created from a criminal act to begin with.

There are others who would pay attention and listen and think about these things so as to keep people from

becoming focused on such concerns. What can be better than to create a great focus of attention balancing the budget or dealing with the economic problems through some other means?

If for example, someone in a company is embezzling company funds and there is the danger that someone in the company who knows of this embezzlement will spill the beans and tell about the embezzlement, or has already made remarks and talked about it, what better way to hide the situation than to create some massive focal attention-grabbing concern about how you are restructuring the company finances, or how you have decided to balance the budget so that it begins to work more effectively and to the benefit of the shareholders?

Thus, by creating a greater focus on this or that part of the finances, it helps to take the attention off of the fact that someone has embezzled money from the company. Likewise, the fact that the Federal Reserve Bank has embezzled 5 trillion dollars in counterfeit money and has not been caught and that someone who is trying to say "This money is counterfeit" has not been heard, but that the focus is on 'balancing the budget'; this seems to be keeping everything confused enough that no one hears of the Federal Reserve Notes being counterfeit.

No one pays attention. They are too focused on what's happening in terms of balancing the budget. The balancing of the budget act is simply an attention grabber. There is little of value in it. It is impossible to continue for long trying to balance the budget when there is the counterfeit 5 trillion dollars which is drawing billions of interest, whereby all of the taxes being collected to pay the national debt cannot even pay the interest on the national debt and the interest keeps climbing.

All the talk of 'balancing the budget' is simply designed to make people think someone is doing something to try to fix that which is broken. "Don't tell us about how it got broken or who broke it, or why it is broken! Just tell us what you are doing to fix the broken budget!" On the other hand, the Democrats wish to create the impression that they have the answer to the balanced budget, but that the Congress and Senate won't go along with them, and therefore they are thwarted by each other and the budget continues to thrash about without being fixed, for even if it were fixed, it would not fix the fact that there is a 5 trillion dollar counterfeit debt and the interest on it requires billions of dollars in counterfeit money to repay it.

Entities need to stop and think: "Hey! If this is all counterfeit money: Federal reserve notes...what is the big deal anyway? It is simply monopoly money. Does Awareness see that as being a signal perhaps that other states might institute the guillotine?

COSMIC AWARENESS:

This Awareness indicates that this is seen as a possibility. There are always entities whose fascination with death and with means of killing never seem to stop stretching the imagination. This Awareness indicates that those involved in such activities often want change just for the sake of change. When you've seen one person fry in the electric chair, do you need to see a hundred more? Or would you rather see one have his head lopped off with a guillotine?

This Awareness indicates it is simply a matter of people choosing their means of killing and finding excuses to justify changing from one method to another.

COMET HAYUTAKE: ANY SIGNIFICANCE?

QUESTION:

One last question. A number of members have written in asking about that comet that was named for a Japanese man (Hayutake) that came over recently. This one from Nora S., Roseburg, Oregon. She writes: "Please tell us the significance, if any, of the new comet in our sky discovered by the amateur astrologer in Japan. What is the spiritual and physical influence it brings?"

COSMIC AWARENESS:

This Awareness indicates that it appears to have had a slight astrological influence causing a disturbance in the auras of some entities in a way that caused a kind of psychic distortion. It does not appear that there was anything of great significance, or anything of great spiritual value other than as a kind of symbolic gesturing of the ushering in of a higher state of consciousness.



In other words, if troops are ordered to control an area or to round up prisoners and the prisoners speak the same language, it could break down the discipline, causing the troops to disobey orders. Therefore, by using troops from another country that speak another language and having interpreters there for the purpose of interpreting, it defuses the opportunity for troop discipline breakdown in terms of their orders.

A Contrived Crisis Involving Militias Will Send in UN Troops

This Awareness indicates that this is still a planned program for a future crisis that will call for UN troops to come in and settle the conflict. The approach would be to have the militias in this country start a conflict. It may be that the militia will actually be agents of the country masquerading as militia people, but it could be designed so that it will lure militia activities, so that an excuse is made whereby the UN would be brought in to help the national guard or what few troops are still available as the US military would be sent into other countries at the time and because there is not enough of a force to protect the masses, the call would be for UN troops to come in to help.

Of course, the UN troops would already be here, or would be close by so that they could be brought in quickly and easily; the equipment already being present and the takeover becoming complete very quickly, wherein each neighborhood would be taken over and the names of entities who would be seen as militia or other trouble-maker types would be rounded up and taken to the detention centers.

This Awareness indicates that this essentially is the Globalists' plan. This Awareness indicates that whether it is to be effective or whether it would fail in its planning will depend largely on many factors that are not always available to those best laid plans of mice and men. This Awareness indicates It is not going to discuss the outcome of such a plan. It simply wishes entities to know that this is the reason for these UN equipment placements in the United States and that there are these plans and that the plans are not necessarily insurmountable or guaranteed to be effective.

In a letter by Dorothy C. in Windsor, Ontario, Canada, she mentions: "All of the items in the store here are getting smaller and smaller as the prices go higher and higher, and the powers that be think the consumers are too stupid to notice. We seem to have been getting more cheated here in Canada since they've switched to the metric system."

And she says "Another question: Canadians are having a hard life: layoffs, no jobs and so forth, yet our government keeps bringing so many Muslims, Africans and so forth, people here. Many are concentrated here in this town. The social services get them housing, furniture, welfare; they get food from churches which they don't eat, but sell.

"Also, there's more stealing in the store since we've had this influx of Muslim people. A lot of them get government funds to open stores or factories. And she wondered if Awareness would comment on that situation in Canada.

COSMIC AWARENESS:

COSMIC AWARENESS:

This Awareness indicates that it appears to be a secret war going on between military loyalists and those who are loyal to the United States and its Constitution, and those who are loyal to the Globalists and their New World Order. This Awareness indicates that this does appear to be a way by which certain entities are being destroyed through these airplane crashes and whereby there is a concerted effort to thin the ranks of those who would object to the New World Order. "The report said this was needed in case any of the ships might try to enter Cuban territorial waters and possibly result in further attacks by Castro's military forces. This latest order follows on the heels of an earlier order by the same judge banning the book from distribution anywhere in the United States or Canada, even for free.

Later, on 7th January, 1996, Judge John E. Sprizzo ordered author Bryan Ellison to destroy all copies of his book. Although he legally cannot distribute the book anymore, Ellison is determined to alert the public to this blatant cover-up, nor is Ellison alone in his activism. Nationwide, hundreds of angry citizens are quickly banding together to form a grass-roots movement to expose the war of censorship by the AIDS establishment. Already this movement has spawned the "Save the AIDS book" legal defense fund which is using the Internet as a primary vehicle for releasing information. Computer users can now access the "fabricated epidemic" page at the "Censorship Bypass" World Wide Web Site.

"What makes this book so controversial is that Ellison and Duesberg belong to the ranks of hundreds of top scientists, including Nobel Prize-winners and members of the National Academy of Sciences at major institutions worldwide, who now believe that the United States Federal government has attributed the AIDS epidemic to the wrong cause.

They maintain that the HIV virus, blamed in 1984 as the official cause of AIDS is actually a harmless germ against which the government has wasted over 40 billion dollars in research and prevention.

"If the public would find out about this disastrous mishandling of the War on AIDS, tens of thousands of government-funded scientists and gay rights organizations would lose their funding over-night" says Ellison. "That's why they have to stop our book, and that's why we can't let them silence us!"

The "Censorship Bypass" web site features internal government memos and other documents never before shown to the public.

And then it gives their web site address and so forth, and the address of the Save The AIDS Book Legal defense fund. Would Awareness comment on this book and whether the statements it's based on are true?

COSMIC AWARENESS:

This Awareness indicates that it appears the information is correct and that there has been an enormous amount of research that has gone into the book and that is of extreme importance to entities concerned with this issue. This Awareness indicates that there are likely to be enormous repercussions against those entities who are continuing to promote this book, but it **does** appear the information will continue to be disseminated to the masses in one way or another.

Entities who have the ability to tap into the web site as addressed would be wise to do so for it might not be available at that address for any extended period of time. This Awareness indicates that it would be of benefit for entities to get copies of the information, if possible, and help spread the material for others to have the opportunity to read and evaluate according to their own senses, rather than being the victim of some other censorship.

This Awareness indicates this is a situation that is reminiscent of activities in Nazi Germany under Hitler's regime, where he spent some effort in book-burning, wherein the book-burning of the time was intended to stop certain kinds of thinking, and this Awareness suggests that this is an action of a judge who wants to stop certain kinds of thinking by forbidding or banning the distribution of a book. FOLLOW-UP QUESTION:

How can a Federal Judge who is sworn to uphold the Constitution of the United States ban books under our constitution?
