



# Vampires and Werewolves— do they really exist?

--The Killing of Princess Diana

## A HEALING FOR THE MEMBERSHIP

OPENING MESSAGE:

(9/13/91)

This Awareness wishes at this time to extend a healing for the organization, the organization of Cosmic Awareness Communications and for the Aquarian Church, for the membership and for the staff, and those working for these organizations. This Awareness is gathering energy at this time for this healing. This energy is being gathered in order to be used for purposes of protection and to create greater health and harmony and livelihood for the individuals involved and the organizations. (Long pause)

This energy having been gathered. This Awareness suggests this energy now being sent in various directions to the various entities of the organization and to the organization itself, and to the protection of those who work for the organization. By the word "organization" It includes the Aquarian Church and the various branches and ministers thereof. This Awareness indicates the energy has been sent and the energy will, as a seed planted, begin to have its fruition and growth.

This Awareness wishes also to inform entities this includes those entities who are members living in foreign countries and on other continents; that this healing reaches and touches all those who are in contact with the messages from this Awareness or who are members or friends of those who are associated. The purpose of this healing being to diminish the sorrow and suffering of these entities and to enhance the well-being of these entities. This Awareness suggests the questions for this reading may now begin.

### The Goddess Religion: Why the Resurgence?

#### QUESTION:

A question from Mark S. in Gainesville, Florida." He writes: The last few years has seen a mushrooming of interest in Goddess religions; the role of the Goddess in history, nature grounded spiritual ritual, and the implications of all this. Books such as *The Once and Future Goddess* by Elinor Gadon, *The Language*, by the archaeologist Marija Gimbutas, and *The Chalice and the Blade*, by Riane Eisler, make a number of revolutionary historical arguments based on a new analysis of archaeological evidence and mythological accounts.

According to the emerging view, in the period prior to about 4000 B.C., men and women lived together in egalitarian, matrilineal (or matrifocal), generally peaceful social groups, practicing nature-based religions which frequently employed female imagery representing divine forces. The goddess was seen as representing the divinity within nature.

About 4000 B.C., according to these theorists, waves of white Indo-Europeans, which Gimbutas calls "Kurgans," swept out of Central Asia with an aggressive, warlike, patriarchal, hierarchical culture that conquered the peaceful goddess-worshipping peoples. The conquerors suppressed the goddess religion and established religious forms—Judaism, Christianity and Islam, for example—with exclusively male deities and masculine imagery. Over the years, these patriarchal religions, particularly Christianity, sought to destroy all remnants of the old goddess religion, with the result that as many as nine million women and men were burned or otherwise killed as witches in medieval Europe over several centuries.

According to the supporters of the goddess interpretation, the cultural effects of the dominant male-oriented religious imagery and the patriarchal, hierarchical social organization that went along with it, represent the

primary underlying problem of modern civilization, from the excesses of capitalism to environmental degradation, sexism, injustice, and war.

Many people, mostly women but some men as well, are "rediscovering" the goddess through books like *The Spiral Dance: A Rebirth of the ancient religion of the great goddess*, by Starhawk; *Casting the Circle: A Women's Book of Ritual*, by Diane Stein' and *The Holy Book of Women's Mysteries*, by Zsuzanna Budapest. Many women, including a number of my close friends, are forming women's circles and participating in nature-based rituals on the full moons and solstices, and they appear to derive much satisfaction and fulfillment from such participation.

Would Awareness please comment on these phenomena. To what extent is the general historical analysis correct or incorrect? What are some of the implications for the emergence or reemergence of the language and ritual of the goddess? Might there be some cultural and spiritual benefits from balancing out the male and female images of deity? Are there any problems or pitfalls to beware of in following the way of the goddess? How does the goddess philosophy relate to the Awareness teachings?"

#### COSMIC AWARENESS:

This Awareness indicates that the historical background given as that which is based on fact; that there have been some references in the past by this Awareness to the feminine origins of religion prior to Christianity. This Awareness indicates actually, this goes back prior to Mithraism. Mithraism as that which

h was the first male dominant religion that left a history in Western society.

#### Wicca Originally Witchcraft and a Nature Religion

This Awareness indicates that the so-called White Goddess religions of the past also are reflected in that which is described in history as the origins of witchcraft. This Awareness indicates that witchcraft essentially was a nature religion, under the name of Wicca. This Awareness indicates that there are many, even today, who still follow these concepts and ideas of nature religion based on full moon practices and rituals.

This Awareness indicates that a book from the early part of this century titled *Isis Unveiled*\* as that which also touches into the negative aspects of the feminine religions and their influence on the more ancient societies. This Awareness indicates that this book as showing the connection between the Isis or feminine religions and cannibalism.

#### Cannibalism the Result of Early Feminine Religions

This Awareness indicates that the questioner asks about any pitfalls that might be associated with the feminine religion. That cannibalism as that which resulted from some of these earlier feminine religions. This Awareness suggests that the outgrowth of the masculine religion being that which leads to war and violence toward others, and may be seen as a counter to those qualities of the excessive feminine religions in which secrecy and cannibalism and internal revolutions became the outcome of excessive feminine religious practice.

#### Sacrifice a Part of Feminine Religions

This Awareness indicates also, sacrifice was part of the outgrowth of these feminine religious practices; that the internal movement of feminine religions as that which equates to many of the fertility rites and sacrifices in terms of fertility rituals and sacrifices to gods and goddesses for crops, et cetera. This Awareness indicates that the counterpart of the masculine religions

is to go out and conquer and rape and pillage the spoils of others in war.

This Awareness indicates a balance is that which would be most likely to occur in the coming age. Being an age of qualities that are less masculine and yet, less feminine in nature, Aquarius serves as a kind of neutered age in which though extremes may occur at the beginning, gradually they begin to subside and a balance eventually is reached near the mid-part of the age.

The second ten decrees of Aquarius being reflective of Libran qualities, having to do with harmony and balance will bring about a kind of reconciliation between the extremes of the male and female religions, but during the early part of the age which is ruled by the decanates of Aquarius and the planet of Uranus, the extremes are likely to be present, creating extremes of feminine and extremes of masculine acting in competition, thus, the early part of this age may witness both of these religious resurgences to the point of detriment to many.

This Awareness indicates that as entities can consciously become aware of things, the influences' of nature can be somewhat modified, and in the modification, the extremes need not be in control. If nature has its course, it can become quite violent in some of its expression. If man has control and operates in ignorance, man too can create great disturbances to nature and to his own kind. Therefore, wisdom playing a role can balance nature and the artificial creations of mankind so that harmony can be experienced in a kind of reconciled balance.

#### The Results of Absence of Feminine Influence in Christianity

This Awareness indicates that in the Christian religion, the entity Mary, the mother of Jesus, was given greater prominence in the Catholic church to help create a sense of balance in that religion. This was ignored by the Protestant reformation, and left out of many of the teachings of the more recent fundamentalist expression of Christianity. The action of leaving out the feminine influence from the Christian religion as that which has helped to make the religion more violent in its expression, more assertive and more aggressive and less compassionate than its original founders envisioned.

This Awareness indicates that on the other hand, the god of the Christian religion was presented as having the feminine qualities himself: qualities of compassion and love and tenderness in regard to others and toward children especially. This Awareness indicates that this was a way of balancing or reconciling this masculine religion to have some feminine expression in it.

#### Do Nature Rituals Accomplish Anything?

(FOLLOW-UP QUESTION):

These women who do these rituals for nature; it seems like more and more of them are doing it. Is this a fantasy they're acting out, or will these rituals actually do something, like they think they will?

COSMIC AWARENESS:

This Awareness indicates that it gives them a certain sense of identity with nature itself, a feeling of oneness with the Mother Earth, and with the moon. It helps them to feel integrated in their lives with the environment. It is like the concept of being one with God, wherein an entity might perform rituals that make the entity feel as though he or she is one with God.

In this case, the entities' rituals help them feel one with the universe. The universe perhaps that they focus on is more likened unto their home planet and its accompanying moon, whereas another might focus more on the concept of the sun or an imaginary male figure

somewhere up there in the sky representing for them the concept of God.

#### Possible Dangers of the Goddess Movement

FOLLOW-UP QUESTION:

There was an article in the Utne Reader titled: *New Goddess Worship Troubles Skeptic*; Is there a danger of new eco-orthodoxy? And there's several questions they bring up. I'll read this. It says:

But while countless individuals have clearly found inspiration in Goddess Consciousness, others warn against its uncritical acceptance and its use as part of political strategies. A healthy debate has emerged over some key questions. Is there danger that when women are identified with the Great Earth Goddess, they'll be relegated once again to their former soul role of nurturer and caretaker?

Another question: "Are some political groups, notably the Greens, embracing the Goddess's thoughts to the exclusion of other viewpoints?, and lastly, is the picture typically portraying Goddesses and their society as peaceful, completely accurate?"

COSMIC AWARENESS:

This Awareness indicates that the typical traditional role of women in the symbolic sense as representing the nurturing approach and expression in life and creating a home or environmentally safe place; the nest-building concept; the idea of becoming concerned about the ecology of the world and creating an environmentally safe world to live in, fits perfectly into this traditional role of women, and therefore it is a natural inclination to move into this direction by many of these entities, seeing that if you are going to have an environmentally safe place to live, a home for mankind, human-kind, then you must take care of the home and make it environmentally safe and comfortable.

This Awareness indicates that the hostility that many of the environmentalists feel comes from entities who are oriented more into the masculine concepts of getting out there and conquering the world, or in other words, conquering nature. There is that inborn tradition among men that they must get out and fight against forces that would oppose their will to dominate, and therefore, they approach nature as a kind of semi-passive force that they can dominate if they have a strong enough will and can conquer, if they have strong enough force of their side, and therefore, they enjoy conquering nature.

#### Masculine Excess: Men who Conquer Nature

This Awareness indicates in the conquering of nature, they have become so adept at it, that with the new technologies, machines and abilities, they could almost totally destroy nature on earth if they so desired. Many of these men see themselves as being more potent in this kind of conquering expression, and even though they realize that they might be wiping out important sources of medicine or nutrition or the very livelihood that the earth depends on, that people depend on, such as oxygen from the forests, they cannot seem to stop themselves from wanting to make their mark on the earth and prove themselves to be truly a man. (sic)

This Awareness indicates that it is quite likely that this extremism of the fanatic approach of Christianity has contributed much to this masculine excess and will either destroy the nutritional value of the planet and therefore all humanity, or will eventually cause the feminine values to become even more potent and stop the rape and pillage of the earth and its resources.

#### What Happened to Easter Island and Its Inhabitants

This Awareness indicates that without such, the earth will become a dead planet, just as Easter Island, which once was covered with trees and vegetation became

barren, with nothing left but rocks as reminders of a civilizations that once was there. This Awareness indicates that the stones of Easter Island were basically calls for help from those who might pass by, because these entities used all of the vegetation on the island to build boats to which they could depend upon for fishing and to build homes, and nothing was left to re-seed the island, and when all these homes and boats decayed or fell apart, and began to rot, they were left with a barren island, without homes, without boats, without any way to feed themselves.

They then began turning to calls for help in creating these stones as reflections of themselves to wait for visitors to come to help them, to rescue them. These stones represented different individuals on the island. This was a masculine society, a society ruled by masculine values that left itself without any nurturing values whatsoever.

This Awareness indicates that the earth itself may become the next type of Easter Island with tombstones, monoliths, buildings and markers to symbolize the fruitless efforts of man in his conquering of nature. This Awareness indicates that entities do need to learn harmony and balance in their expressions and creations.

#### Epitome of Feminine Consciousness: Eating Grandma for Lunch

This Awareness indicates that wherein Easter Island was the epitome of masculine consciousness, the jungles of Africa became likened unto an epitome of feminine consciousness, wherein there was not enough organization and the tribes began to turn on their own and on each other for sustenance. This Awareness indicates that in some cases, these entities would end up eating their own relatives and family members, and consider it a great honor for those entities to be served at the meal, in their honor.

This Awareness indicates that somewhere in between lies a harmonious balance that best serves all. It is the duty of entities to find that harmonious balance that lies between the extremes.

### The Political Aspect of the Goddess Movement

#### FOLLOW-UP QUESTION:

In this article, it states "For many, the Goddess represents the divine as embodied in nature. In the words of pagan author Starhawk, worshipping the Goddess means choosing to take this living world, the people and creature on it as the ultimate meaning and purpose of life, to see the world, the earth and our lives as sacred.

And they add: "This explicitly ecological spirituality which recognizes and reveres nature is also seen by Starhawk and other eco-feminists as being implicitly political." Does Awareness agree with that?

#### COSMIC AWARENESS:

This Awareness indicates that this concept of political as that which may be interpreted in different ways by different individuals; that essentially a thing is political if it is able to influence the masses, and in that sense, this statement is correct.

### VAMPIRES: THE TRUTH ABOUT THEM?

(How Valid is the Anne Rice Concept of Vampires?)

#### QUESTION:

A question from Janet R., Garland, Texas. She writes: "In reference to the vampire books written by Anne Rice, her way of saying how vampires came into being here, in this material world, makes so much sense; one wonders what truth there may be to it." Would Awareness please give information on vampires?

#### COSMIC AWARENESS:

This Awareness indicates that this appears to be a kind of aberration of nature that occurred in part through accident, in part through necessity. This Awareness indicates that the genetic modification of some entities in part from accident, in part from necessity led some of these entities into a situation that caused or contributed to their reliance on the blood of others.

This Awareness indicates that the side-effect of this for these entities included longer lifespan, provided they received the blood of others on a periodic basis. This appears to be a situation wherein there are very few of these entities. This Awareness does suggest, however, that these entities are not simply mythological or fictional creations, but that there are indeed real vampires among you, though very few and far between.

This Awareness suggests an entity named Kaplin (sp) as having spent much time researching and locating vampires in the United States and researching these entities, has discovered much about their behavior and their needs, including their ages, many of whom are some 400 years of age, or more. This Awareness indicates that the book mentioned by the questioner as one which can also give some insight into these entities. Some of her work, however, is personal speculation and not to be taken too seriously.

### How are New Vampires Created?

#### (FOLLOW-UP QUESTION):

Most of the movies on vampires, the Count Dracula movies and Nosferatu and so on, depict the vampire as creating new vampires each time he victimizes an entity by sucking blood from this person; that the person whose blood is sucked then becomes a vampire. Anne Rice, in her books the Vampire Trilogy, claims that that isn't true; that the vampire does create other vampires, but not very often, and they do it in a certain way by sucking the blood and then reingesting it back or something to that effect. Is there any truth to that method that Anne Rice claims is the real way?

#### COSMIC AWARENESS:

This Awareness indicates that in order for the victim to become contaminated with vampire genetic qualities, the victim would need to be contaminated sufficiently so that the victim's immune system could not fight off the contaminants injected into his or her body. It would be a situation that unlike exchange of fluids or blood which could cause AIDS, it would be much more difficult for the vampire to take hold in the victim's body, because the victim would have a sufficient immune system to fight off the foreign bodies in most cases.

This Awareness indicates that the entity's evaluation as that which is more correct than that registered in movies. This Awareness suggests that most actual vampires do have donors or have sources whereby they can draw on for their blood supply. Some of these entities may work in areas where they can draw blood supplies or have access to blood supplies. This Awareness indicates that *It* sees fewer than a hundred vampires in the United States, much fewer, perhaps half that many. World-wide, there are probably not more than a thousand of these entities who depend on blood for their continued survival and longevity.

### Is AIDS Killing Off the vampires?

#### FOLLOW-UP QUESTION)

There have been several tabloid stories that AIDS is wiping out the vampires in Europe because they've been getting infected blood, evidently. Is there any truth to that?

**COSMIC AWARENESS:**

This Awareness indicates that this would create a problem for these entities, in the event they devoured AIDS blood from a victim. It would be fatal to them. It could also spread AIDS to others whom they victimize. This Awareness indicates that this is a fascinating topic, but relatively trivial in the sense that there are so few of these entities. Their influence on the greater population of humanity is trivial.

**Do Vampires Exposed to Sunlight Die?****FOLLOW-UP QUESTION:**

Are the legends, as perpetuated by Bram Stoker and these other writers, that about the only way they can die is if they are exposed to sunlight? Is there any truth to that?

**COSMIC AWARENESS:**

This Awareness indicates that it doesn't appear that sunlight necessarily will kill these entities unless perhaps over a long period of time. It is very annoying to them. It is difficult for them to endure sunlight. It bothers them. Their eyes are not accustomed to or able to adjust to the bright light and therefore, they prefer twilight and night time.

**Are All Vampires Related to the First Vampire?**

(More on John Keel's "Mothmen")

**FOLLOW-UP QUESTION:**

Are all vampires descendants of one another, leading back to the first vampire, or have they sprouted up historically in unrelated areas?

**COSMIC AWARENESS:**

This Awareness indicates they appear to have been a kind of genetic offshoot of cross-breeding between that of a human and that of an alien type being, similar to that which was described by John Keel in The Mothman Prophecies; the Mothman type of alien would be a good candidate for the grandfather of all vampires, or the prototype of all vampires.

**Do Vampires Have Souls?****FOLLOW-UP QUESTION:**

Does the vampire have souls like most entities, and when they do eventually die do they go through the Clear Light experience or the Bardo experiences?

**COSMIC AWARENESS:**

This Awareness indicates that this will depend on the extent of the cross-breeding with humans; that humans have souls. The so-called Mothmen are not seen as having souls and the cross-breed vampire would have a rudimentary soul, not as progressed as the fully developed human, but not totally lacking, as in the Mothman type creature.

**Do Vampires Really Turn Into Bats?****FOLLOW-UP QUESTION:**

Is there any truth to the legend that these vampire creatures can turn into bats, and back again into humans?

**COSMIC AWARENESS:**

This is negative.

**Will a Wooden Stake in Heart Kill a Vampire?****FOLLOW-UP QUESTION:**

Is there any truth to the legend that only a wooden stake driven into their heart will kill these creatures?

**COSMIC AWARENESS:**

This is negative.

This Awareness indicates the Mothman described by John Keel was said to be about 7 or 8 feet tall with wings, and had red glowing eyes. This Awareness

indicates that this as a particular type of entity from the constellation of Draco. These were the rulers of the Reptoids; that there are a number of these entities in a kind of ruling-class position in the Draco Constellation.

**WEREWOLVES: DO THEY REALLY EXIST?****QUESTION:**

While we're on a bizarre subject like this, a related one is werewolves. There have been a lot of books written about werewolves, and movies produced on them, and scholarly research. Montague Summers (sp) I believe did research on that. Here's a recent tabloid article. I'm going to read this and ask Awareness to comment on this.

"Real Life Werewolves do Exist" Say top Experts. A rare mental illness makes people bay at the moon, run on all fours and prowl cemeteries by night.

Victims of the illness, called lycanthropy, don't physically change into monsters as in horror movies. But they do think they're wolves—and sometimes kill and eat people, the experts reveal.

"The individual actually believes he becomes a wolf, complete with fur and claws," said Richard Noll, author of the book *Bizarre Diseases of the Mind*.

"They engage in animal-like behavior, such as growling, howling and even crawling on all fours. They desire isolation from human society, preferring to stalk wooded areas and cemeteries.

"Many have the desire to assault or even kill humans."

Noll, a Philadelphia psychologist, said that documented cases of lycanthropy span the centuries.

In 1572, Frenchman Gilles Garnier was convicted of murdering four children "while in the shape of a werewolf." More than 50 witnesses testified they saw him tear apart and eat the flesh of the victims. Garnier was burned alive as punishment.

In 1928 famed psychiatrist Carl Jung reported this case: For years three girls suffered from horrible dreams about their mother, in which they saw her as a dangerous animal. They couldn't understand it since their lovely mom was devoted to them.

Years later, the mother went insane and ran around on all fours, grunting, barking and even growling like a wolf.

In 1975, two psychiatrists published a report about a 20 year-old Appalachian man. One day the man, a drug user, went into the woods alone and took a dose of LSD. He suddenly felt a shocking sensation: He thought he was turning into a werewolf!

"He watched fur growing on his hands and on his face. Panic set in—he felt like chasing and eating live rabbits. The delusion that he was a werewolf refused to go away, and he was finally admitted to a psychiatric unit," said Noll.

Dr. Harvey Rosenstock, former clinical associate professor of psychiatry and behavioral sciences at the University of Texas Medical School, co-authored a 1977 paper on the case of a 49 year-old woman suffering from lycanthropy.

"She was obsessed with werewolves and believed she'd change into one, seeing a wolf's head in place of her own in the mirror," he said.

One day, she snapped and sprang to the floor on all fours like a wolf.

The woman was admitted to a psychiatric ward where she was given antipsychotic drugs—which worked until the next full moon, when she began to snarl, howl and act just like a wolf again.

Added Dr. Rosenstock: "Lycanthropy is a rare mental disorder—we have no statistics as to the number of people afflicted with it."

Would Awareness comment on werewolves please?

#### COSMIC AWARENESS:

This Awareness indicates the article as expressing the situation clearly and is valid in its content. This Awareness indicates that these entities are not what would be actually termed "werewolves" in the sense that, though they may see hair growing, they are hallucinating and imagining what they perceive to be as hair growing on them. This Awareness indicates that what is occurring is a mental disease associated with a kind of schizophrenia and psychosis that allows them to fantasize clearly and assume a dual personality in their fantasizing.

This Awareness indicates that it is not a metamorphosis in the physical sense, but in the psychological sense. It takes place in the mind, and of course the mind can have its effect on the physical body to some degree, but not to the extent of growing hair on the body in an immediate time-period, or causing teeth to grow extensively during the full moon,—these are but embellishment by writers and story-tellers.

### Any Effect From the Wolfsbane Plant

#### FOLLOW-UP QUESTION:

How about their supposed eating of the wolfsbane plant? This is supposed to help them become a wolf. Is there any truth to that?

#### COSMIC AWARENESS:

This Awareness indicates that this appears to be similar to that of a placebo, having a strong suggestive power, and if entities use this with the belief it could help to serve kind of on the order of an hypnotic tool to make them believe this is occurring. It does not appear that the plant itself has any intrinsic causes toward this psychological disease.

#### FOLLOW-UP QUESTION:

Then there must be no truth to the legend that goes back hundreds of years, that werewolves did exist and prowl and ran amok, and the only way they could kill them was with a silver bullet?

#### COSMIC AWARENESS:

This Awareness indicates that this as but story; that there were no doubt many psychotic people playing out psychotic roles which would be interpreted by others in various story forms and ways and handed down with further embellishment each time the story is told, but this Awareness does not see that the classic story of the werewolf has any substance other than this psychotic problem which some entities identify with.

### How Many Werewolves are There?

#### FOLLOW-UP QUESTION:

How widespread is this dementia? Are these entities that are called werewolves, is there a lot of them in the world, or just a few of them?

#### COSMIC AWARENESS:

This Awareness indicates there is one behind the couch waiting to pounce.

This Awareness indicates that there are very few of these in relative proportion to society, but even one entity who is psychotic in society can make news and the story can be spread far and wide, giving many people the awareness of this one incident. This Awareness indicates it is much like the concept of heterosexuals having AIDS. You hear a few stories of heterosexuals having AIDS and you begin to think it is spreading throughout the heterosexuals.

This Awareness indicates that whereas two or three percent of AIDS victims may be heterosexuals, if the focus is on those 2 or 3 percent, it *appears* to be very widespread among heterosexuals. This Awareness indicates that it is much the same with the concept of the werewolf. If you hear these stories and everybody else has heard the same story, you begin to think that everybody is hearing about werewolves, and it must be very widespread, but the story may be all that is really widespread.

It appears that there are very few cases of this psychological disease, but that it is such a bizarre and unique disease that when it appears it is told and retold and retold so many times that it seems like there must be many people who are experiencing this problem.

### The Classic Werewolf: Does It Exist?

#### FOLLOW-UP QUESTION:

So all the legends of the werewolves down through history relate to this particular bizarre illness and there is no such thing as a werewolf that might be of a metaphysical nature that might come or be able to come between different vibratory levels and prowl around on earth and disappear?



This Awareness indicates this is in the affirmative. There is no such thing as the classic werewolf except in literature and in fiction. This Awareness indicates that there may be hairy men who are berserk, but they don't turn back into normal men when the moon goes from full to half or quarter moon, and likewise, they do not move back from quarter moon toward werewolf type, as the moon becomes full.

#### The Full Moon can Give Superhuman Power to Psychotics

The full moon, however, does have its effect on emotions and some entities become more psychologically unbalanced in times of the full moon and this kind of disease could become more out of control at such times, giving rise to the legend of the werewolf reacting to the full moon.

This Awareness indicates a psychotic person, having a psychotic fit can have superhuman powers compared to most entities who are not experiencing this kind of psychosis, and therefore, legend can also develop around those powers of the entity during times of psychosis.

### CAN A PENDULUM DIAGNOSE AND HEAL?

#### QUESTION:

We got a letter from CN in Colorado, and he writes: "A few months ago we purchased a copper pendulum which was purported to be able to align the chakras, pulsate with the chakras which were out of balance. This it appeared to do. By holding the pendulum over the body, the area, section or spot that is out of balance or needs healing, the pendulum will make a circle until such time as the body part is in synchronization.

In the meantime, we discovered that by holding the pendulum over any part of the body that was out of balance, any area that was hurting, it would make a circle and put that part back into balance. We have used it considerably and it works. It also will answer questions which can be answered "Yes" (circle) or "No" (to and fro, a straight line). The pendulum is constructed from one-half inch new copper tubing, 3-3/4 inches long, with a fine copper wire wrapped around it. Two small holes are drilled very near the top where a small wire is placed to connect the holes in order to put a chain on it to suspend the pendulum.

Later, I got the idea (probably through my Higher Self—Cosmic Awareness) to make a copper coil by using 1/4 inch new copper tubing 25 feet long, and wrapping it around a 45 ounce juice can to get the circle and proper circumference, then remove the can. Then we took two nylon cords (more like strings) and wound one up and then down around each of the circles on opposite sides of the coil to keep the coil from spreading apart, but also to keep the circles from touching each other. By suspending the coil over the body, it heals. To find the area over which to suspend the coil, we use the pendulum over the body and also ask the pendulum how long the treatment should be: 5 minute, 10 minutes, 15 minutes, etc. It is usually 15 minutes but has been 30 minutes and one occasion was one hour.

When asking questions, we have been told that the question asked goes from the pendulum to the left brain, then to the right brain and "out" to the Universe, then the answer returns in the reverse order to the pendulum. We have noticed that the operator of the pendulum must keep his/her eyes on the pendulum when giving a treatment or the pendulum "wanders". Have you heard or received any such information regarding using copper for healing and especially in the form of the description of the pendulum and coil as I have noted here?

We are very interested in healing and use several methods if they sound reasonable and work if we try them. We are also using magnets: on our water lines, a

bed pad containing magnets, small magnets on eye glasses or rather on pinholes, etc. We ask the pendulum what to eat and if we follow its advise, we feel better. We are pretty healthy compared to others 72 and 81. Please ask Awareness about these things. Thank you."

And that was the end of this letter.

#### COSMIC AWARENESS:

This Awareness indicates that it appears the entities are into areas that are very rewarding and effective and this Awareness suggests that they continue in their research in these areas and to keep records sufficient to substantiate their findings and to verify the accuracy of the pendulum from time to time as it is used. That this will allow them to have something from which to draw on when passing the information to others.

This Awareness indicates that they may also wish to consider either making such items for others or creating a booklet or pamphlet describing how others may make this for themselves. This Awareness indicates that it may be safer to create the pamphlet than to create the item and try to promote it as a healing device for the FDA will have grounds to seize the operation if there are claims or expectations of healing expressed in the promotional material, but if the entities are simply telling others how to make their own pendulums and coils, then these coils and pendulums become creations of the customer and would not have any reason to object to your selling of the idea.

#### How to Advertise the Pendulum

This Awareness indicates that the uses and effects from the uses could be put into separate reports, mailed separately from the diagrammed plans so that you are not accused of selling something of a bogus value. This Awareness indicates you can also sell it with the recommendation that entities experiment and find out what effect it has. You can also promote it by asking questions rather than making statements: "Does it really heal the pain?" rather than saying "It really heals the pain!"

This Awareness indicates that these are ways whereby you may help others with the item and also receive some compensation for your efforts, if you so desire.

#### FOLLOW-UP QUESTION

Is this correct where he says: "We have been told that the question asked goes out from the pendulum to the left brain, then to the right brain and out to the universe. Then the answer returns in the reverse order to the pendulum?"

#### COSMIC AWARENESS:

This Awareness indicates that this appears to be valid.

#### Where does the Information Come From?

#### FOLLOW-UP QUESTION:

He also wants to know if the information they particularly received through these two instruments come from the same source as the information received through Edgar Cayce and through This Awareness?

#### COSMIC AWARENESS:

This Awareness indicates this will depend on the intunement,—that depending on how attuned the entity is. This Awareness indicates that it appears in the higher attunements, this is so. This Awareness indicates it must be understood that even this Interpreter, if not properly attuned, may receive information that comes from levels less than the highest. Therefore, *It* does not wish to say that all information you receive comes from Cosmic Awareness. If you become careless or lax in your attunement, it may come from a lesser source.

**FOLLOW-UP QUESTION:**

A lot of people do seem to use a pendulum for various things: testing foods for example, to see whether they should eat it, or whether it is fit for eating. Can Awareness recommend a specific way an entity can attune themselves before using their pendulum?

**COSMIC AWARENESS:**

This Awareness indicates that you attune your consciousness to whatever you focus on.

**THREAT TO CLOSE DOWN C.A.C. COULD CREATE SOME CHANGES**

**CLOSING MESSAGE:**

This Awareness indicates that there may soon come a time wherein these messages, even perhaps this organization, will be stopped from further work. This Awareness wishes to keep this open as long as is possible, but there are seen major changes coming in the future which may prevent freedom of speech as is required and necessary for this kind of operation to continue.

If the threat of closure comes, the possibility of continuing with a curtailment of certain topics being discussed would be an option, for a time perhaps, so that within limits, this Awareness could continue giving information as long as certain topics or subjects were not discussed in full. This Awareness indicates that those who have received these messages over the years do not realize how fortunate they have been to have had the right and opportunities to receive information of this type.

This Awareness indicates there are many countries wherein this kind of information that has been given would never have been allowed under any circumstances and entities attempting to give such information would have been shut down or stopped in some drastic manner within the first few weeks of operation. This Awareness indicates that *It* is saying essentially that *It* does not wish to give entities the impression, or does not wish entities to hold the impression that everything will continue in the future as it has in the past, wherein entities can always receive directions or information from this Awareness simply by subscribing (to CAC), for the future at this time does not look as hopeful as does the past in regard to freedom of speech.

This Awareness indicates however, that *It* will continue from time to time sending healing energies in order to keep the operation active and open as long as possible.

OPENING MESSAGE: (9/16/97)

**A Rebalancing for the CAC Staff and Interpreter**

This Awareness wishes to express a hearty welcome and congratulations from the return of a brief absence, which was necessitated for the rebalancing that is occurring in the entities involved in this specific channeling process. This Awareness suggests that certain changes in the mental environment within the facilitators as energizers, as leaders of the organization, and as human beings; that certain changes have been taking place on many levels, manifesting ultimately in the physical energy balances and healthful exuberance experienced.

This Awareness suggests that the recent events involving the health of Avaton and Vikki; the apparent viral infection which not only provided a physical down-time for certain rebalancing, but that also afforded a spiritual down-time through which certain energies that have been under-emphasized in the past, which have been recently perhaps over-emphasized in a relative sense, can begin to attain the necessary balance.

This Awareness suggests that the Interpreter Grace also experienced a certain rebalancing in that her energies are inexplicably entangled with those of every entity involved in this organization, particularly those of the leaders. This Awareness suggests a congratulations is in order for the rebalancing physically as well as the conscious insights that have been received as the result of this practice.

This Awareness suggests that there has been some concern regarding the nature of the specific illness of the viral invasion as experienced by Avaton; in one capacity as experienced by Vicki, and as experienced by the Interpreter Grace in yet another. This Awareness suggests that various interpretations of the experience can illuminate the various belief-systems in place within the entities, given the personal interpretation of the reasons, the sources, the course, and the value of such an illness.

This Awareness suggests that one interpretation was that the viral invader was the manifestation of efforts of those involved in a government conspiracy who have infiltrated the American population with a genetically devised virus, and that this was the suspected source of the illness experienced in at least one of these entities.

This Awareness suggests that alongside that explanation rested several conflicting ideas that would tend to minimize the power of this particular belief or explanation. This Awareness suggests that the entities have a spiritual consciousness of their own participation with experiences such as illness. They recognize how utilizing belief systems within mass-consciousness regarding nutritional supplementation, diet, and exercise can bolster and reinforce the innate healing processes that the body possesses.

They recognize to a large degree the personal power which they possess, which if channeled against any external manipulator or manipulation, can annihilate it, and yet, seemingly conflicting belief systems created seemingly conflicting experiences within and between the individuals involved.

This Awareness suggests that the varying intensity of the viral experience is in direct proportion to the intensity of the dis-empowering belief systems, rather than the empowering ones that conflict and lie alongside them. This Awareness suggests this is an excellent example of the normalcy, the state, the functionality of human beings, given the misunderstandings and traditions that now exist.

This Awareness suggests that these entities need not indulge in self-flagellation for such normalcy and indeed, to give themselves a hearty pat on the back for gaining the understandings as well as offering this initial example of how the interaction occurs between beliefs, emotions, events, and physical health.

This Awareness suggests that many such health conditions can serve such a rebalancing, physically, emotionally and spiritually, and that if belief systems are in place which promote empowerment, vitality, self-protection and health, that physical maladies, the ups and downs, the ebb and flow of physical energies can cease to be as debilitating or self-reinforcing of belief systems which counteract or dis-believe in the utter vitality, spiritual purity and continuity of the human being as spirit in flesh.

**FOLLOW-UP QUESTION:**

Well, that virus, or whatever it was, seems to be resistant to antibiotics, so does Awareness have any suggestions for people who get this, on how to get rid of it? Because it seems like everyone is getting it nowadays.

ED's Note: Somehow both Vikki and I contracted this mysterious virus in early August. It quickly settled in both our lungs. Vikki lost her voice for 6 days and we both lost about 75% of our energies. There was no bed time but we both slept more than usual, but sleep was troubled and non-restful. I had headaches, fevers, night sweats and at one time uncontrollable shivering which stopped only when I jumped into a very hot bathtub. Vikki phoned Dr. George who prescribed Ampacillin, an antibiotic. We both took this for the prescribed 10 days. It didn't work, we stayed the same. I lost 8 pounds and to date have only regained two of them. Because of this virus invasion, we were both getting behind in the production of the next newsletter. I allowed Vikki to drag me to her local doctor, who at first diagnosed the problem as "walking pneumonia," but since the fevers had ended, he called it "bronchitis" and prescribed the antibiotic Doxycycline (in the Tetracycline family). We took this for 10 days also, but I don't think it worked either. However, we gradually regained most of our energy and could put in a full work shift. We also had enough energy to begin working out at the gym again. After almost 2 months, I can still feel whatever it was, still sitting on the edge of my lungs, like a spider waiting to strike its prey. Vikki is in better shape. This Awareness suggests that certain belief systems can facilitate and bolster the innate healing energies and resistances and defenses that exist within the body. This Awareness suggests that it is a natural outcome of what has been termed 'evolution' for species great and small to evolve upon adapting to environmental changes.

This Awareness suggests that the over-use of antibiotics around the world has perpetuated a mutation of certain bacterial and viral entities which in certain cases can be beneficial and helpful to the body, and under certain conditions, one in which involves belief systems, can be physical disrupters and invaders as experienced in this situation described.

This Awareness suggests that there is a continuous evolution and change in viruses and bacterium as is apparent in any and every other species and that this is perfectly natural. This Awareness suggests that humans have been indiscriminate of the use of antibiotics to the degree that these virus's unusually virulent effect is symptomatic of the assumptions within mass-consciousness that they control their health externally without crediting the underlying spiritual and psychic impetus and natural innate healing ability which constitutes nearly 85% of health maintenance.

This Awareness suggests that resistance is the key to viral and bacterial invaders and that such resistance can be maintained through conscious, willful care of the physical form, utilizing the dominant belief-systems

which facilitate health mentioned, such as nutrition, exercise, hygiene and other such strategies.

This Awareness suggests, however, that a tremendous amount of the defense and resistance against such invaders lies within the mental realm, wherein beliefs are empowered, either those that facilitate and build and contribute to the health and well-being of the physical form, or those that invest belief and power in such explanations as 'external,' 'inevitable,' 'manipulation,' or invaders from which no defense is possible.

This Awareness suggests that the feelings can direct entities toward the source beliefs that motivate their actions and create their life events so that they can eliminate those that are dis-empowering or in conflict with those that are empowering strategies and beliefs.

#### Use the Clock Meditation for Good Health

This Awareness suggests that entities utilizing the Clock Meditation\* can benefit substantially, focusing upon that quadrant wherein individual health becomes the focus. This Awareness suggests that the visualization of the body in complete control of the health and vitality; that this completion includes a perfectly efficient defense immune system, and that these beliefs be empowered with a positive emotion.

This Awareness suggests that upon this practice, any conflicting beliefs that are not conducive with this image shall be called to the attention of the entity through the feeling signals so that any beliefs to the contrary of this image can be reconciled and eliminated. This will be far more effective than any antibiotic. This will be far more effective than any medicinal cure. This will even be more effective than nutritive supplementation, for this is the work of the spirit, freed from its limitation.

### Where do Psychics Get Their Information?

#### QUESTION:

A question from JD in New York. "Where or how do psychic readers get their information?, i.e., how do they tune in on their impressions, and where do they come from, such as a certain mental plane, or the Akasha or Universal mind?" she asks.

#### COSMIC AWARENESS:

This Awareness suggests that ultimately, such impressions and communication is made possible through the inter-connectedness between every unit of every entity: animal, vegetable, mineral, cell, atom, or subatomic particle, each being a spiritual apportionment of All That Is.

This Awareness suggests that psychics, to varying degrees, have access to the Universal Consciousness that is the source of this Awareness. This Awareness suggests that every human being possesses the ability to attune to this source, but that severe limitations exist due to the interference of human mind.

This Awareness suggests that entities can also attune to the physical vibration of the spirit of other entities, which is in one sense, that same attunement to the Universal Consciousness, yet specifically relates individual mind to individual mind, rather than individual mind to Universal Consciousness.

#### Most Energy For Psychics Come From Questioners

This Awareness suggests that a great proportion of psychics, regardless of the medium they choose to attain this communication or attunement, are essentially receiving energy directly from the entity involved with

the psychic or the situation as experienced by the entity involved with the psychic.

This Awareness suggests that there is a wide fluctuation in clarity in such communications, depending upon the energies, the intents, the beliefs and the feelings of both parties involved. On the part of the psychic, there must exist a capacity to orient the consciousness away from the personal realm of mind and experience and to orient it toward the Universal Mind and Universal Experience, so that impressions can be received from universal sources, rather than internal experiential ones.

This Awareness suggests that clarity and success in communication can be obtained on the part of the seeker due to the clarity, intent, and sincerity toward a goal of spiritual empowerment. This Awareness suggests that entities merely interested in mind games or in tricking the psychic or in self-deception, or in any other attempt or motivation which is less than that of spiritual intention, will receive muddled, conflicting and less valid guidance and information due to the intention and beliefs, which either limit or facilitate the goals and desires of the spirit.

This Awareness suggests that for this reason there is a great suspicion as well as a following of psychics, for some information is strikingly accurate and useful and spiritually uplifting, while others can be much less. This Awareness suggests that entities interested in consulting the services of a psychic be aligned to their intention; legitimate and sincere, and that the most successful belief systems are in place; that they desire the best and highest benefit.

This Awareness suggests, however, that psychic intermediaries are unnecessary for ultimately the connection and communication can be achieved and maintained by any and every individual when the limitations in the realm of mind are removed.

### What Gives Psychics their Ability?

(Must they be Spiritually Advanced?)

#### QUESTION:

JD has a number of follow-up questions on this. She's interested in this subject because she's written a book on channelers, and she's gone all over the world checking out these channelers and various organizations, and then evaluating them in her opinion, in this book. (The Cosmic Awareness channels, by the way, are Number One in her book). Okay, she asks: "What gives excellent psychics their ability?, and need one have a certain degree of spiritual advancement?"

#### Cosmic Awareness:

This Awareness suggests an alternate concept for that of 'spiritual advancement'. This Awareness suggests that spirit is just that: 'spirit.' It cannot be advanced, nor reversed. This Awareness suggests that the concept generally understood as 'spiritual advancement' would be more accurately conceived as 'spiritual expression.'

#### The Purpose of Human Existence is Spiritual Expression

This Awareness suggests that the purpose of human existence is spiritual expression, and that spiritual development of physical and mental and spiritual realms represents accurate reflections within the mind which can facilitate spiritual expression. This Awareness suggests that people, entities, souls who are considered spiritually developed are in fact experiencing higher levels of spiritual expression in the physical realm.

This Awareness suggests that there is some connection between spiritual expression and psychic ability, simply due to the fact that if spiritual expression has

been achieved, then spiritual development must have paved the way. This Awareness suggests that what is described as 'spiritual development' is that impetus and responsibility within each entity in a given lifetime to design and refine the individual mind in any and every way to accommodate the needs of the spirit.

This Awareness suggests there is tremendous flexibility in this process and that each and every individual mind can be as completely unique and separate as each unique and separate genetic individual, yet the uniqueness is virtually unlimited. The choices are virtually unlimited. The only legitimate limitation to be placed upon the contents of mind is that limitation of spiritual intention, and that limitation is simply a directive to keep the mind with its creations, ideas, beliefs, cleansed of any such contribution that frustrates the spirit, rather than facilitates its expression.

#### The Spiritually Advanced Entity is Defined

The spiritually advanced entity is that entity who has created a mind, treasure trove-like, which is filled with a virtually never-ending variety of ideas, beliefs and tools which serve spiritual expression and a minimum of those which limit it. Without such spiritual restrictions, the spiritual communication remains free to flow unabated, and that this is what is witnessed among those psychically astute and those spiritually advanced.

This Awareness suggests that the concept of 'spiritually advanced' need not necessarily include the active pursuit of psychic communication or channeling, yet, that in individuals who have achieved that level of clarity, should they so choose this practice, that their state of clarity will facilitate their success.

This Awareness also suggests that although some beliefs can be in place which severely limit spiritual expression, there can also be mental constructs which allow portals, so to speak, in given specific areas which allow entities who may otherwise appear to be dysfunctional in many areas of their own life, a corner of sheer genius or enlightened, heightened abilities that defy explanation.

This Awareness suggests that at the core of all such successes and failures lie the beliefs within the mind as designed by the individual.

#### Is Psychic Work a Form of Service?

##### QUESTION:

She goes on: "Psychics often speak of trying to help people. Some specifically withhold things they see, knowledge of which they feel could be harmful. Do some people incarnate to do psychic work as a form of service?" she asks.

##### COSMIC AWARENESS:

This Awareness suggests that that is one of the many choices that entities can decide upon as a course toward the unfolding of the Destiny Path. This Awareness suggests that the concept of 'service' and 'helping others' springs from the innate spiritual need for connectedness, and the preservation of the Universal Wisdom of the innate connection that every entity and every unit does indeed share.

This Awareness suggests that although the concept has been distorted and has enjoyed multiple mutations, in essence the goal remains the same. This Awareness suggests that the first part of the question be repeated. (question is repeated)

#### Psychic Communication not Limited to Psychics

This Awareness suggests that many people, particularly those with a psychic focus do indeed withhold

information at the risk of overwhelming the participant and sometimes, at the request of the participant. This Awareness suggests that emotional signals not only communicate within entities to keep them attuned to their own belief systems: good and bad, and how well they work at creating desired outcomes; but that emotional feelings and impressions also provide tremendous communication between entities.

This Awareness suggests that this type of communication is not limited to psychics. In fact, it is a universal and extremely common, albeit less conscious, form of communication that exists among humans as well as animals. This Awareness suggests subtle emotional undertones exist within and between entities during communication, during interaction, providing a constant measure of the relative comfort, safety, direction and intention of the entities involved.

#### Non-Verbal Communication Between Entities

This Awareness suggests that in ordinary communication, this is what has been termed 'non-verbal' communication, and in many situations, in fact in normal human interaction, this type of communication operates outside of the conscious focus of the entities involved. This Awareness suggests that the understandings which can bring this type of communication into the conscious awareness of entities can greatly empower individual self-understanding as well as relationship maintenance and improvement. This Awareness suggests that during interaction entities make continuous responses to each others' non-verbal cues, which adjust to the 'safety' level on emotional boundaries of each other. Some are spiritually desirable, others are self-preservationary.

This Awareness suggests that within the Lessons of Enlightenment there are specific directions and concepts offered to facilitate understandings of such interactions so that self-preservationary responses can be identified and replaced with those that are self-developmental and expressive as the spirit intends. This Awareness suggests that with these understandings, a tremendous amount of individual and social progress can be made once this communication, this source of information that has yet to be mined, is exploited and benefited by mankind.

#### Can Anyone be Trained to be a Psychic?

##### QUESTION:

She asks: "Can anyone be trained to have good psychic ability?"

##### COSMIC AWARENESS:

This Awareness suggests there are certain genetic predispositions that build brain-structures more conducive to certain sensitivities and certain of the human functions that are natural to the species. This Awareness suggests, however, that psychic ability can be developed most effectively by removing the limitations to what is essentially a natural intuitive function.

This Awareness also suggests that there can be accidents and injuries to the brain which seemingly increase psychic ability. Yet, any genetic predisposition or such accident or event which occurs to an entity, is a feature of the Destiny Path upon which that entity has chosen for spiritual expression in that given incarnation, and in that sense, there are no accidents.

This Awareness suggests that the most powerful and most effective techniques toward developing the psychic channel potential is more in what humans choose **not** to do, than what they choose to **do** toward development. The most successes will come through

beliefs that do not contradict such innate abilities as a psychic intuitive communication.

This Awareness indicates, however, that such beliefs are rare and well outside of most religious traditions in that psychics are generally classed among those few who are receptive to Divine Communication, often relegated to positions of authority within religious or social arenas.

This Awareness suggests that this very concept immediately places the power outside the individual, as it is embodied in another: a holy person or a learned person, or an empowered peace-keeping person, yet that in instilling this belief, the power is taken away from the individual so that it does not occur to he or she to attempt to use such a capacity within themselves.

This Awareness suggests that entities interested in spiritual and psychic development shall set about the task of eliminating those beliefs that have been allowed to accumulate within the mind which directly conflict with the goals of the entity, and that through listening to the wisdom of the body in all of its sensory systems, this can be achieved.

### Does a Psychic Reader Take on Karma?

#### QUESTION:

One other question from JD on this subject. She writes: "Since psychic reading information can and does often change lives, such as diverting someone from a potential karma, does the psychic reader take on karma from this?"

#### COSMIC AWARENESS:

This Awareness suggests that the concept of karma has as many incarnations and as many uses, and as many abuses and distortions as there are individual creative minds. This Awareness suggests that nothing can be imparted upon an entity that is not specifically chosen, whether it is chosen inadvertently through acceptance of external dictates or chosen purposefully, yet does not fulfill the purpose for which it was chosen.

This Awareness suggests that karma relates to movement, to the cause and effect, and that many interpretations of karma place the control in the genesis of events outside of the entity's given control or incarnation and that this is a dis-empowering belief to entertain. This Awareness suggests an alternative concept of karma in which the cause and effect relationship is noted between belief systems and the events that they create.

#### A New Definition of Karma

This Awareness suggests that karma, as it is understood in the context of a negative thing happening for no apparent reason, is actually an explanation used to justify the **lack** of connection made between belief systems and the events they create. This Awareness suggests that entities embrace, mentally and emotionally, the understanding, the utter free will to create events through the medium of belief is the *right* and *responsibility* of every human being,

This Awareness suggests that if the life is not exactly to the pleasing of the spirit of that entity, it is due to the belief system that the entity had entertained either purposefully or inadvertently through the teachings of outsiders which have established beliefs which create events which mirror those beliefs. **This** is karma: the creation of events that spring from unknown sources, but the sources are, in fact, the beliefs.

This Awareness suggests that if entities of the psychic variety who entertain and empower beliefs such that they can't take on certain karma from others, it will be

that belief that creates the validity of subsequent events which will assure the entity that that belief is accurate, for it will be a mirror of that belief.

This Awareness suggests, however, that this is not necessary and that spiritual expression facilitates a condition of understanding of the trust and the faith in the utter infallibility of the Universal Divine. Entities operating within such Light never experience what you refer to, in the way you refer to it, as 'karma.'

### Should CAC Hire Cosmotone Psychic?

#### QUESTION:

We got a letter from Jim Jacomini of Harmony, California, speaking of psychics. This entity for a few years has been publishing a newsletter called the *Cosmotone*, and it covers just about any question people send in-- current events, information on past lives, people of significance in the past, historical people like Jesus and so forth; in other words, he gives answers to just about any question.

He writes: "Dear CAC, I am writing to let you know of my interest in doing readings for *Revelations of Awareness* newsletter. I have been interested in working for CAC for years, and recent events have brought me to writing you today. JD Rabbit suggested that I contact you, and I have recently stopped writing the *Cosmotone* newsletter. I look forward to hearing from you. Salutations, Jim Jacomini."

I'd like to ask Awareness to respond to his question.

#### COSMIC AWARENESS:

Is his question the suitability of his association in performing readings for this organization?

#### QUESTIONER:

Well, yeah. He wants to do readings, and I'd like Awareness to sort of check him out, to what his source of information is, and whether this would add to the service of the newsletter. He would definitely answer questions that Grace has indicated she...

#### COSMIC AWARENESS:

This Awareness suggests that you, Avaton, are asking for a back door into this Awareness, such that the focus that is now suggested from this Awareness is replaced or diverted into other myriad directions. Is this not true?

#### QUESTIONER:

Let's say "supplemented". We have a newsletter that we, of necessity, need to keep interesting and covering a variety of subjects.

#### COSMIC AWARENESS:

This Awareness suggests that the editor can decide without the suggestion of this Awareness whatever inclusions he may so choose in the newsletter that is disseminated. This Awareness suggests, however, as has been previously stated, that the focus is to remain upon personal empowerment and that any and every question can be addressed to this Awareness, but that any which are based upon assumptions and belief systems that minimize and negate personal empowerment will not be energized through this source.

This Awareness suggests that if this is not in keeping with the goals of the organization of Cosmic Awareness and that supplementation is necessary, that this is at the prerogative of the editor, and that this Awareness makes no comment regarding rightness or wrongness of the sources of information, particularly as they relate to this entity.

This Awareness suggests that this entity can offer intriguing, insightful information that **does** spring from the source of this Awareness, but this Awareness

indicates that many such sources outside of the Interpreter Grace, who has been delivered to you for the express purpose of empowerment and enlightenment, is accessible from many sources, in that accessibility to certain levels of understanding and insights as they relate to the energy and the vibration of this Awareness; that many contributions of those with a genuine channel to this Awareness can be limited.

This Awareness suggests that the editor confirm for himself the veracity as he defines it of this channel, following the explanation offered by this Awareness in that if the information is suitable for his purposes for continuing certain contributions to provide entertainment, enjoyment, or simple mental exercise; that this certainly is within his right of choice.

This Awareness cautions, however, that information be analyzed by the emotional system within each individual as a measure of the value of any given belief system, idea or explanation that comes to them from any source, to ensure that the contents of their individual mind remain empowering and supportive of spiritual development and expression.

This Awareness suggests that any explanations that promote beliefs in external manipulation, disempowerment, that perpetuate self-preservationary responses to fear, such as paranoid actions and defensive postures which separate entities from their very spirit, are to be particularly guarded against.

### Photon Belt a Metaphor?

#### QUESTIONER:

I believe one of the more interesting comments Jim made in one of his newsletters some time back was about the Photon Belt. He said it was not a physical thing, but it was a metaphor, the term 'Photon Belt'. Would Awareness agree with that?

#### COSMIC AWARENESS:

This Awareness suggests *It* has made similar statements regarding certain changes in the energy, certain understandings, a certain readiness within mass consciousness for humans to experience accelerated understanding and empowerment after thousands of years of certain misguided notions and self-preservationary reactions; that this energy is the energy that has been defined from many sources, including the Photon Source.

This Awareness suggests that it is a harmless conception or belief to entertain the idea that there is in fact a cosmic alignment and that if the shifts in the energies produced from the shifts of heavenly bodies can influence bodies in positive ways, then that belief can be empowering. It is not the Photon Belt or the Photon Energy that is empowering, it is "belief" in it.

This Awareness suggests that certain metaphors have been utilized in the past to the extent that the focus has become more upon certain features and accouterments of the beliefs, rather than the process of empowerment in any given belief, such that the process and the causal relationship is lost. This Awareness suggests that such metaphor is powerful and positive, as long as it is contained within the proper context, and that this entity has been successful in communicating such.

### The Books: "Conversations With God"

#### QUESTION:

Speaking of psychics, there is a recent article in the local newspaper. I'd like to read a little about this and ask Awareness to comment. It's called 'When he heard

God talking, he started writing it down'. "God exists and talks to people: literally! About 5 years ago, Neale Donald Walsch says at a particularly difficult point in his life the Deity began talking to him. Walsch had just finished writing an anguished angry letter to God on a yellow legal pad. "Abruptly, the pen began moving on its own" he writes, in *Conversations With God*, published by Putnam.

"I had no idea what I was about to write, but an idea seemed to be coming, so I decided to flow with it. It was God talking in Walsch's own familiar colloquial English, through Walsch's pen. The first words were "Do you really want an answer to all these questions, or are you just venting?" That, he says, got his attention.

"Truth told," the author says "God was talking all along," but it wasn't until then that Walsch paid attention. That communication became "*Conversations With God: An Uncommon Dialogue, Book 1*," published in 1995 by Hampton Roads Publishing and reissued last year by Putnam books. Book #2 is due this month.

"The book has since lived near the top of best-seller lists. Enthusiasm for its non-denominational message of spiritual self-determination has put Walsch on the road in the United States and Canada with *Conversations With God* lectures, workshops and retreats. It has generated *Conversations With God* study groups across the country and sometimes heated Internet chats that occasionally include Walsch himself.

"Among the topics of Book 1: The Secret of Life, Right & Wrong, Free Will and God's Will, Death, passion, Sex; simple--and sometimes not so simple--answers to complex questions. The book's basic message: "Every human being is part of God and has Free Will, and God talks to everyone, not just Neale-Donald Walsch."

"I think it would be a great mistake for anyone to think this is something that only happened to me!" Walsch says. "I'm the first one to have something like this published, but now, out there in the market-place I've seen several "Sons of Conversations With God." What we're hearing in our mail is that this is a very common experience with many people. In addition, I also have come to know and think that people are being communicated with by God every day in their life. They just call it something else. Most call it "inspiration"."

"RE-CREATION, the umbrella organization that coordinates his appearances and sells *Conversations With God* related products: tapes, signed first editions, prints of the book's cover paintings, and so forth, is based in Portland. Walsch is an ex-newspaper reporter and editor and now is suspicious of journalists, who he says have painted him as "some kind of a nut, even just this side of a charlatan."

"His book's central premise: that he conversed directly with God, apparently raises the suspicions of cynics, but he says that two-way communication is not new. Historically, we have accepted the fact that God routinely inspires the actions and the words of man, he says. "We say: Where did Thomas Jefferson get his inspiration for the Declaration of Independence? and we say: From God! In addition, the poet says, "I feel truly inspired by God!" and you know what?, no one blinks an eye.

"God talks to us all in the forms of musical notes and the lines of a poet, but cynics say, he certainly doesn't talk to us in the form of conversation. "The books says "I am not a metaphor. I am real! My influence over the affairs of men is real. I really **did** inspire Mozart! I really **did** inspire Jefferson. Where do you suppose that

beauty came from? I did it with dozens and dozens and hundreds and hundreds. One of them was Neale Donald Walsch!"

"Speaking now for himself, Walsch says: "What's so unusual about that?" "Nothing at all!" says Karen Hodges. Hodges is administrator of Unity North Church in Marietta, Georgia, where Walsch spoke to 300 people in November. "It was fabulous," she says. "We have quite a challenging crowd. Every denomination imaginable and some that you can't imagine come here. And for one person to hold that many diverse minds captive for 4 hours is fascinating to me!"

"His main message is that there are no mistakes. You can't do it wrong. Get that out of your head. You are here right now to hear, do and feel. God is good all the time and there are no mistakes. It's pretty simple until we get our egos in the way and try to make it hard. That's what people call 'Satan'."

And the article goes on and on. I will quote one "Message From God" on the subject of sex. God says:

Of course sex is okay! Again, if I didn't want you to play certain games, I wouldn't have given you the toys. Do you give your children things you don't want them to play with? Play with sex. Play with it! It's wonderful fun! Why, it's just about the most fun you can have with your body, if you're talking of strictly physical experience alone. But... don't use it for power or hidden purpose, for ego gratification or domination; for any purpose other than the purest joy and the highest ecstasy, given and shared--which is love, and love recreated--which is new life! Have I not chosen a delicious way to make more of you?" God asks.

Now, 4 or 5 members have written in asking us to ask Awareness to comment on these best-selling books called *Conversations With God*, and since I've just read about the author and an excerpt of Book 1, would Awareness care to comment on these books that he's written?

#### COSMIC AWARENESS:

This Awareness suggests that this entity is very well attuned to this Awareness and that he is manifesting his individual destiny as an apportion of the group destiny of those entities many now will recognize as Light Workers, who are now operating feverishly to usher in the new Millennium.

This Awareness suggests he is but one of an example of many, albeit he is a powerful example in the direct format his contribution has been received; yet, one of many from the varying realms that contribute to the growing consciousness, the raising awareness, and the imparting of the understandings of the Universal Oneness that is shared between each and every entity: the removal of unnecessary cultural boundaries such as religious tenets that define individual separation and illusory factions among entities which are, in fact, not separate, but One.

This Awareness states that the concept of a dialogue with God is one and the same as the concept of receiving information from this Awareness, whether it be in the form of insight, creative impulse, direct thought, impression, or a two-way conversation. This Awareness suggests that the phenomenon that occurred with this entity was a very successful example of the communicative channel that exists of the conversations that can occur if entities would merely listen.

#### Why Many Do Not Listen to God

This Awareness suggests the reason entities do not listen is because they do not believe they can, or that they do not believe they **should**, or that they believe certain understandings can only come through spiritual

intermediaries of the cultural and religious traditions that exist. These are beliefs. These are choices.

This Awareness suggests that God, as he is known, would not empower entities as is stated in that particular book, with toys, if he did not expect them to use or play with the toys. This Awareness suggests that God has given the toy of Free Will, and this has not been a toy with any strings or conditions, but that it is just that: Free Will. God does not place judgment on the choices of human beings, nor does *It* place restriction. However, God does insist that human beings retain their spirit, for it is the Spirit that Is the God, that is the connection, that is the energy of All That Is, that is the energy of God.

#### The Wondrous Toy of Free Will God has Given Entities

Therefore, God has given human beings the wondrous toy of Free Will, but *It* has also given human beings the safety of a playground which signals those choices, those acts of Free Will, those creations of belief that do not facilitate spirit. That playground, that information, is embodied within the cells. The safeguard speaks through human feeling.

The ultimate and only judge upon the choices of Free Will is that of spiritual intention, of whether or not the creations fulfill or frustrate it. This Awareness suggests that the reason most entities do not have conversations with God are due simply to the belief systems that they entertain.

This Awareness indicates that the focus upon personal empowerment and an understanding safeguard system, that God has given human beings to safely play with their toys must now be understood. There is no putting the cart before the horse. There is no other avenue of information that can be valuable without this essential understanding of how the human system is intended to operate.

This Awareness suggests the information contained in the books mentioned are extremely useful concepts in direct keeping with the insights of this Awareness. This Awareness suggests that every outlet for such concepts that can be achieved at this time will be beneficial toward ushering the ultimate empowerment in the Age of Enlightenment, which can now be enjoyed.

This Awareness suggests that there have been contributions such as this within the spiritual New Age psychological community as well as the scientific community, as well as changes in the political tones. Such contributions are from within the realm of art and music, and if entities seek in any of these directions, they will be able to pull together the strands of thought that are interwoven from seemingly diverse sources, in seemingly diverse languages and formats and concepts, the central message of the task that is upon humanity at this time.

#### The Central Component that is Missing

This Awareness suggests that a central component which is missing from other sources, and is of the utmost importance to the basic understanding are the concepts set forth in the Lessons of Enlightenment regarding the nature of the human physical, mental and spiritual system. Without understanding the basic tenets of human nature, entities cannot hope to achieve the level of full humanity.

### The Mysterious Death of Princess Diana

(What was there About this Entity?)

Let's see...Lloyd K. sent E-mail over the Internet: “Why do I still need a tissue for tears each time I hear Elton John's song? Maybe I mourn the loss of what Princess Diana represented. Do I cry because every fairy tale my mother read to me involved a beautiful princess ended “happily ever after”?

“Princesses are a piece of the foundation of security I relied on in my childhood. Princess Diana embodied much of the compassion and beauty we all idolized. How could a beautiful princess die in a situation where she had to rush into a small sedan with a drunk driver who speeds through a tunnel in a frantic escape effort. Why a princess that precious could not be protected from harm destroys a piece of my security. The truth is, I wanted her to live forever. I guess in some ways she will.”

Let's see. Cheri Patch writes: “The issue that instantly surfaced for me with the death of the real Queen of England, was of joy and happiness... specifically, the lack of both. Why does it seem on this planet that we humans are not supposed to enjoy a life of joy and happiness. As soon as we experience either, we become ill or die, sometimes never recovering from illness.

“Princess Caroline of Monaco, lost her husband in a very tragic manner, and their relationship was of love, joy, and happiness. Are there that many of us on the planet who must learn this lesson the hard way? And what is the lesson of attaining joy and then having it snatched away before we have had even the slightest chance to experience it?”

Now let's see. Bob Conner, in Gap, Pennsylvania, writes: “I assume you'll devote a newsletter to Princess Diana.” {We could if you readers request it, and. You submit enough questions. Ed.] “Enclosed is \$3.00 for it.” (He's even paying for it before we publish it!) “I'm sure you'll get many letters like this. I was very touched by her death. She seemed a very high-minded soul to me.

“What sort of person was she really? What was it in her that caused so many people to be touched by her? Why would a person choose to live the kind of life that she did? Why did she choose to pass on when she did? What kind of effect will this event have on the world in a general sense? How is she doing now?” he asks.

Asbjorn Erikson, in British Columbia writes: “In order to get things off my chest, I have to write you a few lines with regard to what happened to Diana in Paris, France. I don't know if everything I am writing is my imagination or not. The first thing that came to mind when I heard that Diana had died in an awful car crash was that she was killed by a car that was sabotaged, as was the case with grace in Monaco.

“After seeing what the car looked like, it came to me that an undetectable bomb had been planted somewhere, where it could be triggered by remote control, damaging the connections to the steering wheel, so that it would look like the driver lost control of the car. What more “convenient” place for this to happen than in a tunnel underpass?

“To further make it look like the driver was at fault, (who knows?) he could easily have been injected after he was dead, to make it look like he was drunk. The only problem with this is that whoever did it, *overdid* it. Somebody, who, according to the press, was 2 to 4 times over the limit, wouldn't be able to get unnoticed, into the car.

“Who believes the media anyway? I am not excusing the Paparazzi in any way, but I find it a bit too convenient to have somebody like the press to blame it on. If one is to kill somebody, then one also has to have somebody to blame it on to make it a “perfect” scenario. How come after the first car left the Ritz as a decoy, Diana and her friends, shortly thereafter were followed by the Paparazzi ?

“Another thing that I have to mention is a dream I had the night of September 5th. I woke up after I could see 3 people playing the piano in Westminster Abbey. The music was awful and sent shivers down my spine as well as fear to all the people present. I could see the pleasure in the faces of the 3 people as they were celebrating on the behalf of the New World Order or the Dark Force. Could Awareness answer if my imagination is running wild, if I am out to lunch or what?

“This has been a very sad story, and I hope that Diana's death will bring something good for humanity.”

Let's see...that's pretty representative. There is one I can't put my finger on, where a member asked if Awareness would give a little past-life information on Diana, who she was, and why she was here, and the impact on consciousness and so forth, so that's all I'll read about Diana.

I'd like to ask Awareness to comment.

#### COSMIC AWARENESS:

This Awareness suggests that there is insight to be gained from each and every question mentioned regarding this situation involving this quite powerful entity known as Princess Diana. This Awareness indicates in an overall statement that each and every entity can take a giant benefit from the life and death of

Princess Diana by examining the individual belief systems that they possess and how each emotion, positive and negative, that has been roused within them due to the life of this woman, and how each feeling exposes a belief system, whether positive and beneficial or negative and detrimental; that the Princess would be quite pleased if certain benefits could continue following her brief life.

#### Part of the "Grand Design" Carried Off with Polish and Panache

This Awareness suggests that the different perspectives and varieties of the questions set forth reflect the belief systems of the entities, yet each contains the common thread of powerful emotion connected with this entity. This Awareness suggests that this is no accident. This Awareness suggests that this is, in fact, Grand Design carried off with the polish and panache that personified this woman in life and will continue to personify her in the history of the world.

This Awareness suggests that the entity Diana had the express destiny of arriving on earth with the message of love, compassion and personal integrity, and the dogged persistence in the belief that the spirit is acceptable, that the needs of the spirit will be fulfilled, regardless of position, regardless of protocol, regardless of external dictates.

#### Princess Diana Knew and Chose her Time of Death

The Princess chose to be a human above and beyond any external cultural role that the world might foist upon her. This Awareness suggests that as part of her Destiny Path, she chose the essential life experiences, including the sudden, seemingly tragic circumstances and time of her death. This Awareness suggests that every entity has such choice, and at levels generally outside of conscious interpretation, each entity knows of their own sketch and life plan.

This Awareness suggests that certain entities choose dramatic exits that force entities left behind to come to terms with their own beliefs, their own understandings, their own concepts of life, purpose and death, and that the death of Diana was most successfully dramatic for the purpose that attention has been called to many, many issues in addition to those which the Princess invested her time and energy to focus the ever-present lens upon something useful that could contribute.

This Awareness suggests that from this one event alone, entities can ponder not only such issues as potential manipulation, freedom of the press versus freedom of privacy, speeding, safety belts, drunk driving, or the nature of alcoholic tolerance, duty, spiritual freedom, but most importantly, love.

The single most sentiment that has been expressed throughout the world following the death of the Princess has been an understanding of the love that she decided to impart. This Awareness suggests this was no accident. This Awareness suggests that a world in mourning is now asking the very questions that need to be asked to usher the understandings that are now at hand.

#### Is Happiness and Love Destined to be Denied?

One entity questions whether or not happiness and love are right or wrong experiences, and suggests that when happiness is attained, either infirmity or even death is soon to follow. This Awareness suggests this is an excellent example of a belief which is ever-present and abundant throughout social systems, but is, in effect, a poison to the system.

This Awareness suggests that entities could relate to the experience of a common person placed in an uncommon situation, and that through the Princess, entities could experience vicariously, and this is why such an intense connection and grief upon her passing is being experienced. This Awareness suggests that entities know at a gut-level that the urges of the spirit should take supremacy over the urges of the world, the urges of the culture, the dictates of the church, of the politics and of the religions, or in this case, the royal monarchy.

Princess Diana was the living example of someone who tried to subordinate her spiritual needs to the dictates of protocol. She was the one commoner who lived up to those standards at the expense of her own health and personal well being, yet this choice did not work for her. Her spirit cried out for freedom, for love, for control, for compassion.

She rejected the royal protocol and the illusory freedoms and titles and accouterments and glamour that came with them as the royal family continued to subordinate their spirit and trod along in a seemingly broken state of sub-humanness. This Awareness suggests that each and every entity interested in the life of Princess Diana was relating to the tension between the needs of spirit and the needs of mind, which are represented in the cultural traditions personified by such institutions as the monarchy.

As Princess Diana made her human errors and learned through them, and the world paid attention, they could not help but rejoice and celebrate her tenacity for choosing the needs of her spirit above and beyond the dictates of the "royal" family. This Awareness suggests that for this very reason, her brother, in eulogizing her, requested that people please resist the temptation to canonize Diana, to treat her in the same capacity that one might the passing of Mother Teresa, for the messages, although similar, were distinct, in that Diana chose to be human.

She chose to validate the needs of her spiritual self rather than to subordinate them. Each and every entity rejoiced in this choice, for they know that this is a choice that must be made, and as they rail against the restrictions of their own cultures, their own religions, their own legal systems, they know that her choice is the correct choice, and was the correct choice.

However, Diana chose to exit in a sudden and extreme fashion, partly due to the fact that she had achieved a powerful love and connection with someone who represented a lifestyle which would call different belief systems to the fore, which would cause conflict and confusion for the message she had spent 36 years developing.

She ultimately made a choice for spiritual expression in this love relationship, but not to continue it in this particular arena or incarnation. This Awareness suggests that in doing so, she preserved, and in fact intensified the message of compassion and love and trust in the spiritual impetus to place you upon your own path of guidance.

This Awareness suggests that each of the entities asking questions regarding this situation offers specific

and unique insights, and if time permits, a reiteration briefly of the key components of each question, and they can be addressed, one by one. First, the last question which indicated a deep sense of loss and compassion, and an anger and a fear that there may have been external forces at work to have taken Diana against her will.

#### The Dream Where 3 Evil Entities Laughed at Diana's Death

This entity can be assured that he has not lost his mind, however, he has empowered a belief that does not do justice to the grand plan of his own life, let alone the grand plan of Diana's now which he mourns. This Awareness suggests that the answer came to this entity in the dream regarding the music and the 3 entities he perceived to be as evil, and laughing in the enjoyment of their wicked success in taking Diana from this plane.

This Awareness suggests, however, that this dream was intended to offer an alternative interpretation and one which replaces certain personal empowerment concepts, under emphasized within the entity. This Awareness suggests that the 3 individuals celebrating and laughing were in fact the three entities who had died in the car accident which brought about this grand opportunity to focus world-wide attention on certain issues and ideas; that this success, was a celebration of positivity and goodness rather than the interpretation chosen.

#### Happiness and Joy are Indeed Spiritual Goals

This Awareness suggests that the woman asking about happiness and joy can assuage her fears; that happiness and joy are indeed the spiritual goals, and that pain is simply an indicator of the absence of beliefs which facilitate spirit. This Awareness suggests that if she continues to harbor a belief system wherein pursuits of happiness are evil and will be punished, that this is the reality she will experience.

This Awareness indicates that this is why she chooses this particular interpretation; the same way the entity that has felt controlled and pushed by external forces as a tumbleweed blown about by the winds of change experiences events that are disempowering in his life. This Awareness suggests instead that she emphasize her belief that lends her to refer to Diana as the *real* queen, for she *knows* at her very core that happiness is indeed the highest spiritual goal.

#### Diana as the Fairy Tale Princess

This Awareness suggests that the entity who personified Diana as the Princess, who manifested the dreams of perfection and fairy-tale endings to one individual: this has been a reflection of the experience of many due to the hope and desire that life does indeed have meaning, that there is indeed magic, and that there can be happy endings.

This Awareness suggests that each of these desires and hopes spring from spirit, for they are in fact valid, noble spiritual goals, and that the only obstructions which lie between these goals and the events created are the reactions to the belief systems themselves. This Awareness suggests that entities can continue to derive a tremendous amount of benefit from the life of Princess Diana in the compassion that she personified, the connection that she facilitated between peoples of all walks of life without the rigid lines and illusory boundaries that the royal protocol insisted she maintain.

She innately communicated the love and compassion and the connectedness to each and every spirit. Again, an action and a faith and a trust which resonates within the spirit of every individual, for it is spiritual truth.

This Awareness suggests that there will be many

social changes resulting from this singular incident, and that if entities can place the life and mission of Princess Diana within the framework of the usherance of the Age of Empowerment and Enlightenment, they can ensure that her legacy will live on.

## The Aspect of Conspiracy

#### QUESTIONER:

There's one thing I would like to add to this discussion, that came in over the Internet. It indeed focuses on the conspiratorial aspect, but included in this is some very interesting information that, for the record, I think should at least be included. This comes from Brian Redman and Sherman Skolnick out of Chicago, who is very well known, and is very cognizant of these various conspiracies.

I'll just read part of this.

"Princess Diana and her soon-to-be husband Dodi Fayed were fatally injured in the Pont de l'Alma tunnel. The site is ancient, dating back to the time of the Merovingian Kings, (circa 500-751 AD), and before. In pre-Christian times, the Pont de l'Alma was a pagan sacrificial site. Note that in the pagan connotation, at least, sacrifice is not to be confused with murder: the sacrificial victim had to be a willing participant.

"In the time of the Merovingian Kings, the Pont de l'Alma was an underground chamber. Founder of the Merovingian dynasty was Merovaeus, said to be descended from the union of a sea creature and a French Queen. Merovaeus followed the pagan cult of Diana. In Middle English, "soul" (Alma) has as etymology "Descended from the sea." "Pont" has a Latin root: "Pontifex", meaning a Roman high priest.

"One translation of Pont de l'Alma would be "bridge of the soul." Another would be "passage of nourishment." All true European royalty is descended from the Merovingians which are believed to be descendants of Jesus Christ. During the Merovingian era, if two kings had a dispute over property, it was settled in combat at Pont de l'Alma.

"According to legend, anyone killed there, goes straight to heaven and sits at the right hand of God, watching over all his foe was to do. The person killed in combat was actually considered to be the "winner" since he became God's eyes on earth and even could manipulate events.

"The current British royal family are impostors. The House of Windsor is a fraud. But the lineage of Lady Diana Spencer goes back to Charles II of the House of Stewart. The house of Stewart is of "true" royal blood. Diana's sons, William and Harry, have 3-quarters true nobility in their blood.

"Princess Diana was in a powerful position. Two main factions vied for control over her: (1) the new World Order faction, founded on an alliance between King William III (Bank of England, modern system of finance, and "national debt" all beginning during his reign) and later, the Rothschilds, and (2) the true nobility of Europe.

"Within the New World Order faction, there are smaller, warring factions exemplified by Rothschild vs. Rockefellers. The plan of the New World Order faction was to marry Lady Diana to an American. Even though Bill Clinton has bastard roots in the Rockefeller clan, he is rejected by them and is aligned with the Rothschilds.

"Bill Clinton was the designated future husband for Lady Diana, with Hillary Clinton to be eliminated through divorce, or even murder. The Rockefellers were furious; in no way would they allow a marriage between Bill Clinton and Lady Diana. In Great Britain, Prince William would be on the throne by age 25. If Prince Charles did not abdicate, he would be assassinated.

"Then, Prince Harry and the living Lady Diana would have moved to the US. Harry would become a US citizen and go

into politics, perhaps becoming a US Senator. By then, whoever controlled the two boys--Prince William and Prince Harry--would control the world. But in her last visit to the White House in January 1997, Lady Diana informed Mr. Bill Clinton that in no way, shape or form would she ever marry him.

"(While in America, Lady Diana also met with John Kennedy Jr.) Diana chose, instead, to marry for love. (Jackie Kennedy married Aristotle Onassis for power; he could protect her.)

Dodi Fayed, beloved of lady Diana, is a cousin of Adnan Khashoggi, a CIA asset involved in sales of arms to Iran--he and Oliver North. Adnan Khashoggi is part of the Saudi royal family. Through marrying Dodi Fayed, Diana would have been marrying into the Saudi royal family. She might have had to convert to Islam.

"British intelligence (MI-6) arranged the deaths of Lady Diana and Dodi Fayed. It was imperative that the Saudi royal family not have control over Diana. The driver of the ill-fated Mercedes was a "Manchurian candidate" (brainwashed tool) with connections to the French military. How did so much alcohol get into his system? Amounts suggested in mass-media reports are truly staggering--so much alcohol that the driver would have had to have been *carried* to the car!

"The way it happened was, the driver was made to swallow special slowly-digestible balloons containing high-potency alcohol. While he drove, the balloons were slowly digested and he became dangerous behind the wheel.

But even within British intelligence there are factions. A rogue faction in MI-6, powerless to prevent the assassination, arranged for the deaths of Lady Diana and Dodi Fayed to happen at Pont de l'Alma.

"Cleverly, it was known that a death at that historic location would not only send a signal, but it would eventually lead to a creation of a "Saint Diana". In Roman paganism, Diana is "Queen of Heaven," a triple Goddess. "Al-mah" in mid-East language, means "Moon Goddess." One aspect of the Roman triple Goddess is the Lunar Virgin.

"The "al-mahs" served as maidens of Diana, the lunar virgin. In France, the Cult of Diana was so powerful, that it wasn't until the Middle ages until the French gave up worship of the pagan goddess. The "true" Knights Templar (not to be confused with impostors) are sworn to protect the Merovingian blood, i.e., that of the "true" royals, such as Lady Diana."

This last paragraph is the main reason I read all this.

"Before too long, Project Blue Beam holographic imaging will be used to create "miraculous appearances" of Lady Diana. Children at various locations will be randomly selected to witness "saintly apparitions." These children will receive a 'message' from Diana." Some of the children will claim that "Diana" has given them healing powers--and what is more, these children will be able to "heal."

"Locations of these "miraculous appearances" will become known as places of healing and sacred shrines. Saint Diana's two children, William and Harry, will become akin to two living Jesus Christs, walking the earth. It will be the start of "the new religion." Who controls the new religion controls the world."

Does Awareness have any comment to that information?

#### COSMIC AWARENESS:

This Awareness suggests that this entity has a rich and creative soul which he expresses in many forms such as that we have just witnessed. This Awareness has several comments on his information. First, given the historical context which he places the demise of Princess Diana, including the tunnel itself in France, provides rich soil

for metaphor, both meaningful and uplifting, or negative and dis-empowering.

This Awareness suggests that the entity Diana was indeed operating upon a chosen destiny path that involved far more than this particular incarnation, and did perhaps coincide with certain historical events, locations, as well as fit well upon myth that also exists. The benefit from such metaphor can be derived through examining the many diverse complex details that converge together in the event that took her life.

This Awareness suggests, for example, that the location of the accident did indeed bear significance for many reasons, the central of which being that Paris, France and the area of the Pont de l'Alma tunnel in close proximity to the edifice of the Eiffel Tower, which is a physical image that exists within virtually every entity of the free world; that this location served to further the parameter and the scope of entities who could relate to the life and death of Princess Diana.

There may be some historical significance as indicated, however, there is a great degree of distortion also, and this Awareness reminds entities that certain scenarios promote and perpetuate belief systems either of the empowering or the limiting variety and that metaphor should not be used to limit entities in any way.

This Awareness suggests that the entity has constructed an intelligent and well-researched scenario regarding the various conspiracies, and who, in fact, can control the world, and who, in fact, *will* control the world. This Awareness suggests that the entity examine his conclusion regarding the "new religion" and who shall be in control of this new religion, for this Awareness indicates now, as before, as *it* will again, that there is to be a new religion; the seeds are being planted presently and have been for the past 50 years actively, but that this religion will be controlled by no one, for it is the ultimate religion of self-empowerment.

#### The "New Religion" for the Millennium

It is the religion that will teach and perpetuate the human spirit on its course of development and expression, enlightened to the mistakes that have led humans to be motivated instead by self-preservation. This Awareness indicates that there shall be no more external control, and that it is such a belief that perpetuates the fear, that dis-empowers individuals who entertain it.

This Awareness suggests that this entity continue to create such lyrical intelligent metaphor and analysis of such events, but this Awareness suggests the entity examine his beliefs regarding his own level of empowerment, and that he, in particular, attune himself to the Lessons of Enlightenment.

If we have completion, we can continue.

ED's Note: Since this reading was given, new information has come to light which reinforces this theory of a conspiracy to slay Princess Diana. (1) That another car, a small black Fiat, was involved. Black paint on the front of the wrecked Mercedes attests to this mysterious Fiat. (2) There were no skid marks, which, according to *The New Federalist* newspaper, is proof the brakes of the Mercedes had been tampered with. (This is a very common practice of the secret government when it needs to assassinate entities in an inconspicuous manner). There is other evidence being published in Europe and over the Internet which also confirms the conspiracy theory. The controlled press in the US, of course, ignores such information.

"Understand that our own personal computers are also vulnerable, not to mention what the stock market will do, or foreign investors in our government bonds. Just thought I'd ask. Is it back to the small family farm and self-sufficiency, including the outhouse, the rain barrels, chickens and so forth? Or am I wrong?"


#### COSMIC AWARENESS:

This Awareness suggests an attunement to the sentiments of Gunther. That this entity, like many entities, experiences a feeling of an overwhelming, over-stimulated, over-taxed technological world, that seems to be spinning out of control in a way from what can be considered a more natural, intended state of communion and direct affiliation with the earth.

This Awareness suggests, however, that there shall be no such luck with events as catastrophic as those described by this entity regarding the computer era and the collapse of certain systems that depend upon this technology. This Awareness indicates that there shall be some necessary changes to the existing technology and the strategies involved regarding its use as the technological evolution continues to unfold, but that there are many enlightened creative entities who can accomplish the necessary adjustments, whereby such a catastrophic scenario need not come to pass.

**QUESTION:**

A question from Bob C., Portland, Oregon. He writes: "In a recent reading, Awareness said pycnogenol was good for enlarged prostate. What causes the enlargement? Is there anything else we can do to prevent or stop this? I have been told that glutathione which is used to stop or reduce tumors, is also good for this. Does Awareness see this as effective? Anything we can do for this condition?" he asks.

**COSMIC AWARENESS:**

This Awareness suggests that there is a biological benefit from both of these substances upon the condition described, but that the condition described is the result of blocked energies within the physical system, wherein certain beliefs and limiting strategies have allowed for continued emotional dissonance, a perpetual stress-like condition which alters the physiological chemistry, weakens the immune system, and ultimately can wreak havoc upon certain organs and organ systems, such as the prostate.

**Sexual Belief Systems Block Energies and Create Problems**

This Awareness suggests that certain belief systems within males regarding their nature, regarding the nature of feelings, specifically that such feelings are associated with femininity weakness; this Awareness suggests that such misconceptions and misunderstandings regarding gender, sexuality, femininity, masculinity, can contribute to blocked energy, specifically within those organs that relate to the sexuality and reproductive activities in both men and women.

This Awareness suggests that entities: males in this case, with this condition, would find benefit in identifying those limiting beliefs which disallow them the full and complete expression and utilization and understanding of emotional energy, wherein replacement strategies can be adopted, which can free up lost energy and allow for a more natural, more spontaneous emotional interactiveness with the world.

I read in a book sometime back that there was one herb and one only, according to this author, that would shrink these enlarged prostates, like in two months, and it was a certain variety of willow that grew in Europe.\*

\*Small Flowered Willow Herb (\*Epilobium parviflorum).

Does Awareness see any validity to that?

**COSMIC AWARENESS:**

This Awareness indicates that there is an herb in addition to the one described; that the green mint leaf has certain medicinal properties toward this end, but this Awareness emphasizes that *belief systems* empower herbs and concoctions and preparations far above and beyond the chemical contribution, in that if the belief system is sufficient, it in fact stimulates natural systems within the body to produce necessary chemicals and hormones to bring about the balancing conditions that are necessary to restore health.

This Awareness suggests that entities who have found success with herbal preparations and have a degree of energy invested in such a curative belief system, that either of the two herbs mentioned, and several others, in other literature have been energized through mass consciousness in such manner they connect with the belief system and provide certain benefit.

This Awareness indicates, however, one needs the necessary understanding of how it is a spiritual energy at the disposal of the individual, yet filtered through the belief system, which actually brings about the desired positive results. If we have completion, we can continue.
