



THE UNIFIED STATES OF AWARENESS  
(The Government of the New Age)

(Paul Shockley, Trance Interpreter)

Question:

Awareness, we're here on this June 10, 1977, for a reading on the York "Summit" Convention of July 1977 for the Unified States of Awareness. Is there an opening message?

Cosmic Awareness: This Awareness suggests that the count of 12 be given again; that great energy be poured toward the head of the Interpreter at this time.

(Count of 12 given)

Cosmic Awareness's Most Important  
Message Ever Given on this Plane

This Awareness indicates the messages to be given on the York Convention as that which is of the utmost importance upon this plane. That this Awareness has given thousands of messages through this interpreter, through David Worcester, through Dan Spivey, through Tom Mooney, through Ralph DUBY, through Edgar Cayce, and through others.

This Awareness indicates that the messages to be given at this time as the foremost material this Awareness has given upon this plane to date. This Awareness suggests that in essence all other material given by this Awareness through its various interpreters as being of preparatory level for this information.

Mankind has Come of Age...The Hierarchy Now Ends

This Awareness indicates that mankind upon this plane has come of age. That the time has come whereby responsibility may be given to humanity, may be released from the Lords of Karma, from the spiritual Hierarchy, from this Awareness, to entities upon this plane.

This Awareness indicates that wherein entities act in a manner that is responsible, wherein entities become responsive to one another's needs, that this information shall be of great benefit to them.

This Awareness indicates that wherein entities fail in their responsibility toward one another, that this information shall be that which is the pronouncement of judgment upon this plane.

This Awareness indicates that in essence the releasing of power to the people at this time shall either lead to destruction and chaos, or shall lead to the millenium and freedom for all.

This Awareness indicates that mankind has come of age and must be given, by all levels of the spiritual hierarchy, must be given responsibility for his action upon this plane and in relationship to one another.

This Awareness suggests that whatever actions come from this, whatever reactions are felt from this, are out of the hands of the spiritual hierarchy, are no longer the obligation or duty of the Lords of Karma. Essentially, the power has been given over to the masses. That wherein these messages from this Awareness have been given, entities upon this plane who have been calling for freedom, who have been calling for power to the people, shall have that power, and shall use that power according to their own inclination and ability to work together.

The Choice Now is Self-Destruction  
or Heaven Upon the Earth Plane

This Awareness indicates that in releasing this power to the people, there comes about the potential for total self-destruction upon this plane; there comes about the potential for a heaven upon earth, a new kingdom upon this earth.

This Awareness indicates that whatever comes from this is the choice, and is based upon the response-ability of entities upon this plane. That the individual karma for these actions shall continue. That entities who are responsive in the possible civilization which becomes destructive toward itself, such responsible entities shall remain without adverse karma as individuals, yet the fact of the society, the identifications with this plane, shall have their effect upon these entities as well.

This Awareness indicates wherein entities are involved in activities and the use of power in a manner that is destructive, these entities shall suffer not only the consequences in terms of the social effects, the physical effects of their actions, but shall also inherit the individual karma that comes from their misuse of power.

This Awareness suggests that no longer shall the Lords of Karma, the spiritual hierarchy, nor this Awareness, withhold power to the people through the various hierarchy systems on the inner plane.

This Awareness indicates that in releasing this, mankind has come of age and this Awareness, the spiritual hierarchy, the Lords of Karma, can only make suggestions, recommendations and requests from entities upon this plane, and shall no longer control the affairs of human kind.

This Awareness indicates that essentially, the ball game of life is out of the hands of the managers, and is placed in the hands of the players.

THE PURPOSE OF THE YORK CONVENTION

Question:

Would Awareness please explain the purpose of this York Convention and what It wishes to present for the spiritual gathering of the New Age group leaders?

Cosmic Awareness:

This Awareness indicates that at this gathering the information now being given and other information pertaining to the release of power to the people as that which shall be presented to the various groups, to the leaders.

This Awareness suggests that the new world government which this Awareness shall present as a concept, shall be of a suggestive nature, shall not be imposed by this Awareness nor by spiritual hierarchy nor by any individual or group representing a spiritual hierarchy. This shall be that which is presented through levels of suggestion, through levels of recommendation, and without any authority by those presenting this information.

This Awareness indicates that those leaders who wish to participate in this action shall find themselves without power, other than the power which comes from making a suggestion, a recommendation, or from requesting that which they would request.

This Awareness suggests that the nature of the information to be given is that which shall be handed down to those who are capable of responding to these levels without any desire for power of their own, and these entities then shall present this material to others, which then shall be presented to others, which then shall be presented to others, until the meek have inherited the earth, until the masses indeed are in the control of power. That where this leads shall be determined by the level of intelligence, of spiritual development of these masses.

This Awareness suggests that essentially, the power being released from the inner planes upon the earth at this time shall be given with suggestions as to its use. And from these suggestions, entities may evaluate and make use of the power according to their own inclinations. That misuse of this information, misuse of the power being given, shall lead to chaos and destruction upon this plane. That the proper use, wherein entities serve one another, wherein entities are merciful, follow the Law of Love, exclude none who wish to be excluded, this shall lead to the new world government which has been long prophesied upon this plane: the Kingdom that shall be ruled by the Christ within each entity who walks upon this plane.

#### WHAT IS THE UNIFIED STATES OF AWARENESS?

This Awareness indicates this as a system of suggested use of power whereby the system does not control, but holds the positions, structures the energy to allow entities to use the power in proper proportions, in proper directions, and in the appropriate manner which shall give service to the most without duplicating that service, or without competitive activity that is unnecessary, or which creates division among the members of the society.

This Awareness indicates the Unified States of Awareness is the structural pattern for the New Age Government, the New World Government, which this Awareness has promised.

This Awareness indicates that, essentially, this may be thought of as the structure for the Kingdom of Heaven. That this is based upon the Zodiac, based upon the fact that there are seven rays of light, five magnetisms in each particle of light; that these seven and five as has been indicated in depth in the October 1976 reading in York, this as a natural phenomena throughout the universe.

This Awareness indicates this also within each atom, within each cell, within each entity, and within the levels of consciousness. That the zodiac which is used for astrologers, which is used by astronomers, is but a duplication, an application of this principle of twelve upon this plane in terms of the effects of energies emitted by the directions in the Universe wherein signs are named and classified according to their qualities, and wherein planets play their part in affecting those energies which are directed toward entities upon this plane.

This Awareness indicates that the entire universe is composed of these forces of seven rays and five magnetisms. That the seven seals, the seven chakras within the entities, the five senses, the five organs of sense, correspond to these. That there are many systems which have moved into these studies in depth.

This Awareness suggests that essentially, the use of twelve throughout various religions, throughout various systems, can easily be incorporated as a system whereby the humanities, the qualities of human existence, can be classified.

This Awareness indicates that the necessity for classification comes about as a need to have order so that actions are not duplicated, actions do not bump into other actions, a collision resulting, so that activities can flow, likened unto gears of the machinery of the cosmos, the wheel working within the wheel whereby accidents do not occur without purpose which may be understood from higher levels.

This Awareness suggests in releasing power to the people, the use of this power must be given: for an entity who would turn over the entire works of an electric company, from the production of electricity through to the various wiring systems, the transportation of that electricity and the wiring systems which lead to the outlets of the electricity, and the electronic and electrical appliances which derive their energies from this electricity: this cannot be given to a child without giving instructions on how it is to be used, how it functions.

This Awareness indicates that power to the people can only be given with clear instruction so that as the power is transferred, the understanding and wisdom for use of that power is transferred also.

#### How to Visualize the Unified States of Awareness

This Awareness indicates that the Unified States of Awareness may be visualized in the following manner: This Awareness suggests you visualize a zodiac, that each of the twelve signs of the zodiac has within it another zodiac, (twelve signs within each sign). That each of those twelve signs also has twelve signs.

Presented in another way, you visualize this as likened unto a wheel with twelve wheels between each spoke, and those twelve wheels between each spoke also have twelve gears with twelve different teeth on each gear.

This Awareness suggests that another way of viewing this pattern is to think of twelve trees in a garden, planted in a circle, each tree being a different sign of the zodiac. Each tree having twelve main branches, each branch being a different sign of the zodiac, each limb having a different sign of the zodiac, the branches having twelve of these limbs. Upon each limb are twelve stems. Upon each stem are twelve twigs; upon each twig are twelve leaves, and upon each leaf are twelve veins. Upon each vein are twelve capillaries. Upon each of these capillaries shall be twelve cells. This Awareness suggests that this may move on infinitely unto the size of the atom and its parts.

#### How to Visualize the New Government

This Awareness indicates that in terms of government using this principle, that the government has twelve branches: that these branches are classified according to astrological qualities in their effect and in their application upon human affairs.

This Awareness suggests that within each of these twelve branches, there is a division of twelve applications, or classifications of that activity of that branch, and each of those is likewise classified. This Awareness indicates in this manner efficiency, without duplication, can come about.

This Awareness suggests that the branches of this government shall be given at a later reading. This Awareness indicates that likewise, in terms of the levels of the New Age Government, the Unified States of Awareness, this Awareness suggests that you visualize twelve levels of this activity. This Awareness suggests that in order to visualize this clearly, that you picture a pyramid with twelve layers of stones (twelve tiers). That each of these different tiers is of a different color. This Awareness suggests that the lower tier is red, corresponds to the note C in the musical scale, and is related to the sign of Aries, the head.

This Awareness suggests that the second tier from the bottom related to Taurus, color orange, note C#. The 3rd, Gemini, yellow, D. The fourth, Cancer, Lemon or yellow-green, and D#. The next E, the color green, the note E and the sign Leo. The next F, the color turquoise, the sign Virgo. The next blue, the note F#, the sign Libra. The next G, the color indigo, the sign Scorpio. The next G#, the color violet, the sign Sagittarius. The next A, the color purple, the sign Capricorn. The next A#, the color magenta, the sign, Aquarius. The next B, the color scarlet, and the sign Pisces.

This Awareness indicates that these twelve tiers are the levels of administrative actions. That at the top of this pyramid there is one more position, the 13th position.

This Awareness indicates these twelve tiers are the levels of administrative actions. That at the top of this pyramid there is one more position, the thirteenth position: that the color is white, the sign is the zodiac itself, and the note is Om.

This Awareness indicates that in terms of individuals upon these positions, that the entity in the white Om position is without power, other than to communicate and clarify. That beneath this entity are twelve others, corresponding to the twelve branches of the government, these being on the twelfth tier from the bottom, these entities being twelve in number, each representing a different branch of the twelve-branched government, each being likened unto a coordinator for that branch.

This Awareness indicates these twelve may also have assistants wherein they work together and wherein they share the duties. This essentially making up twelve positions with two entities in each position; that one has priority and the other is likened unto an assistant coordinator.

This Awareness indicates that these coordinators have no power other than to coordinate and make suggestions and recommendations, and requests from those on the tier below.

This Awareness suggests that the representatives of each level form the level above. Or in other words, each level on the pyramid, each tier, is composed of representatives from the level on the tier just below.

This Awareness suggests that each representative may be allowed as an option to have an assistant which relates closely with the tier below, assisting in the work of coordinating information and gathering facts. This Awareness suggests this assistant may be termed the "Examiner".

This Awareness suggests that the Examiner may be chosen by the representatives, or the representative may allow the group which he or she represents to choose this Examiner.

This Awareness suggests that wherein the Examiner is chosen from the ranks of the group, that the Examiner be given the same rights as the representative in terms of being promoted or demoted by vote by the group. This Awareness suggests that wherein the Examiner is taken from outside the group, that this not apply. This Awareness suggests that the rules for whether an examiner be taken from the group or from outside the group may be subject to vote, subject to the general policy as determined later when the organization begins to function.

This Awareness suggests that the representatives of each tier handle the coordinating of activity relating to the tier below. Yet, the coordination and information gathered from the coordination be presented to the tier below as advice, recommendations, and suggestions or requests, as previously indicated.

This Awareness indicates that the next tier down being that which corresponds to Aquarius, has twelve groups. These 12 groups making 144 entities, or positions, with their assistants. That under each of the 12 entities in the Piscean, or scarlet tier, each of these coordinators has beneath 12 entities who are functioning on the next tier down.

This Awareness indicates that each of those also has 12 entities functioning on the tier directly below that. That this moves on infinitely to the bottom tier.

This Awareness indicates that, essentially, this may be seen as the first tier being that of 12 positions (with the assistants, making a total of 24). That the 2nd tier being 144, or  $12 \times 12$ . These also may have their assistants, or secretaries. That the tier below this being  $12 \times 12 \times 12$ , or 1,728 entities: 12 groups within a circle of 12, within a circle of 12. Each branch of that government on the 3rd tier having been divided into 12 limbs, each having 12 stems.

This Awareness indicates that the 4th tier down becomes multiplied again by 12. This being 12 to the 4th power; the 5th tier being 12 to the 5th power; the 6th being 12 to the 6th power, and so forth. The bottom tier being 12 to the 12th power.

This Awareness indicates that the power is transferred downward as the organization grows. That the upper levels can only suggest, recommend and request. That the level directly below that can request from others below; but for those who are on the tier above, that level can order, direct and make rules. That the rules being made from the tier directly below for the tier directly above. That the requests always must move downward, the suggestions must move downward; that the orders always move upward, and the appointments always upward. The masses on the lower levels appoint among themselves, from their own group, through an elective process, one entity to move to the next tier up to represent their interests.

This Awareness indicates that the 144 are divided into 12 groups by an election process whereby each of these 12 groups chooses one entity (the 13th entity), to be their representative upon the next tier above them. That these 12 representatives of that 144 then can make recommendations, suggestions, after viewing all information available, after compiling and discussing everything among themselves, these 12 can send recommendations to the 144, but the 144 are not bound to follow these recommendations.

This Awareness indicates that wherein the recommendations which are passed down from the tiers above are not followed by those below, those entities who do not follow the recommendations take full responsibility for their own use of the power. That the entities directly below them, then, can veto or recall their actions, recall them from their positions as representatives, if these entities wish to do so. This Awareness indicates that it is the level below that holds the final say, that controls the actions and application of the recommendations which have been handed down.

This Awareness indicates that this continues down the pyramid to the level of the individual upon the street: the public, the citizen who, in effect, has the final say on everything. This Awareness indicates that in this sense, the government positions are truly filled by servants of the people; that these become the public servants: their actions being to recommend, suggest and request.

This Awareness indicates that in this manner, the effects of having positions on higher levels, more general levels, is such that these entities can see what is happening, can view the total picture without being caught in the details, the millions of various details and viewpoints of the general public. Yet, these entities, seeing the over-all picture, must communicate clearly to the general public what they see, and why they see, and suggest this type of action in dealing with the situation. That communication then becomes the key and the important factor, rather than authority. The final authority rests in the entity who receives that suggestion. And that entity who receives that suggestion may or may not follow the suggestion: this being an action of free will. That wherein this entity is in a position of responsibility upon the pyramid, and refuses to follow a suggestion, that the entity then has full responsibility for his own action.

This Awareness suggests that if this turns out to be the proper action, favorable to those who the entity represents, then the entity has made the proper choice, and those who are represented shall be strengthened in the admiration for this entity. That if the entity refuses a suggestion passed down, and the refusal leads to problems and difficulties to those who are represented by this entity, then those represented shall have the opportunity and the justification, to withdraw or recall this entity from his position as a representative.

This Awareness indicates that the use of the word "his" as a grammatical use rather than as an indication of masculine domination of this situation. This Awareness indicates that male and female alike shall be chosen, not by culture or by precedence, but shall be chosen by the 12 entities who select a 13th to represent them; and in their selection, join into a tier to fill a position upon that tier.

This Awareness suggests that the organization shall begin at the top, adding to itself groups of 12 until the first 12 shall be chosen. That these 12 then shall each gather 12 beneath them, forming the next tier down. That the tier once formed, wherein there are 12 groups of 144 total (12 dozen groups), this then means that the next 12 who wish to join must begin on the next tier down. They then decide which of the branches they wish to work under, and begin forming their new tier under that particular branch of their choice. That once the tier is filled, the next tier down begins to come into being.

This Awareness indicates that this continues on as the organization develops. This Awareness indicates that once 12 entities have gathered underneath on a tier below, underneath a certain entity, these 12 then can replace that entity with a representative of their own; but the entity being replaced must be moved no further down the ladder, down the tiers, than to the position of those whom he previously represented.

This Awareness indicates that the 12 reaching up for the 13th entity who represents them, and pulling this entity down into their midst as a group member, then may put another representative up to take his place, thus leaving 12 entities on one tier and the 13th entity as a representative on the next tier up.

This Awareness suggests that the tier above any entity may make suggestions to the tier below that entity's performance, but does not have the right or ability to fire or to remove the entity from the tier below. Only those on that entity's level can deal with the entity through their own rules, or those on the tier below may remove that entity from that position: that recommendations can be handed down, but orders are handed up. Directions are handed from the bottom upward. This Awareness indicates that more may be given on this in further questions related unto the voting and legislative processes.

HOW THE ECONOMIC SYSTEM WILL WORK UNDER  
THE UNIFIED STATES OF AWARENESS

Question:

How does the economic system work, particularly the banking system and the use of money under the Unified States of Awareness?

Cosmic Awareness:

This Awareness indicates that there are several points of power which must be released to entities upon this plane: that there is the administrative power which this Awareness has just explained, and how this may be released; that there is the legislative power which may be released; that there is the judicial power which may be released; that there is the economic power which may also be released; and there is property ownership, which is a power that may be released.

This Awareness suggests that in terms of releasing the economic power, that the banking system of the Unified States of Awareness is such that the money, or energy used as money, shall be owned by the members. That the members elect the tellers, the tellers elect the managers, the managers elect the overseers and supervisors of the banks or credit unions, and so forth, until those who are making and minting the money are elected.

This Awareness suggests that the banking system, then, becomes a system which through its activities of changing money or keeping records of entities transactions: the banking system is filled with elected representatives in the same way that the government, previously described, is filled and has its offices attended.

This Awareness indicates that the profits from the banks shall then be placed back into the general public's use for that which is requested through the legislation by the people in their voting system, and as response to the budget which may be recommended and suggested by those on the higher levels.

This Awareness indicates, essentially, the money system is owned by the people as though the people owned shares in the banks.

This Awareness indicates that more details relating unto how the social budgets are filled from this may be explained in a question related unto the trade centers, the credit systems. This Awareness suggests a pause at this time where this be looked at. (Pause)

This Awareness indicates that the bank membership (entities who place their money into the bank: the customers) essentially are the owners of that particular bank. That they select the tellers, the bookkeepers, the managers, as a co-operative store would select these persons to represent them. That no entities receive salary other than that of an employee of some type. That no particular entity owns the bank. It is owned as a co-operative, whereby the membership in general owns the fund.

This Awareness indicates that there can be many such banks, and that the memberships can be of varying sizes.

#### The Use of Talents as a Money Substitute in Banking

This Awareness suggests that these banks may then begin to honor each other's currency, or service points, or credits, whatever these may be called. This Awareness suggests that the use of the word "Talents" as being appropriate for a substitute of the use of the word "Money".

This Awareness suggests that wherein entities begin to store so many talents in their account that these talents then can be used in lieu of money for trade of services or items among others in the Unified States of Awareness membership who recognize and honor these talents.

This Awareness suggests that communication systems whereby these entities may be in touch with each other to share these items, to share these services, to trade and to find places of gathering where these services and items may be exchanged, or to advertise in papers or on telephones those services and items of each other wherein switchboards can be arranged, or among individuals, membership, who come together and wish to transfer items from one checking account to another: that all of this may be arranged as part of the economic system, the co-operative economy.

#### An Example of Exchanging Talents

This Awareness suggests that wherein an entity wishes to purchase a certain object from another member: the entity charging, for example, 100 talents for a refrigerator, and the other entity deciding that he is happy to sell the refrigerator for 100 talents, meets with this entity and a check is written, whereby both entities sign the check, (one giving 100 talents and the other giving the refrigerator), and this check then is sent to the bank or credit union so that the talents may be exchanged between the bank accounts.

This Awareness suggests that as this occurs, the bank writes itself 10 talents for the services of doing this action:

This Awareness indicates this as likened unto 10 percent going to the bank; but the 10 percent is not coming from the exchange of points or talents, but is literally created out of thin air for giving this service.

This Awareness indicates that every transaction which the bank makes for individuals results in the effect of the bank receiving, creating 10% on each of those transactions.

#### The End of Taxation... The Banking Systems Pays Instead

This Awareness indicates that when the fund of bank earnings is examined by the membership and the budget is drawn up, these earnings then shall be distributed back to the people for various services: social services, services that would normally be paid by taxes received and distributed by a government.

This Awareness indicates that in this system the bank creates its own interest without taking that interest from the members: and in creating its own interest, gives back that interest to its members. For the members themselves are the owners of the money system.

This Awareness suggests that you use the word "talents" rather than money, so as to keep a distinction between the Unified States of Awareness and present systems of government which may wish to infringe upon your use of money, but would not infringe upon your exchange of talents.

#### In a Similar Manner, Trade Centers and Properties Owned by the Group

This Awareness suggests that along with the banking system, the organization can also set up trade centers and situations wherein items are exchanged and pooled among the membership: group ownerships, for example, of various tools, tractors, trucks, or whatever properties.

This Awareness suggests that when the group purchases with these banking points various properties, that these properties then become owned and managed by elected officials of the group, for the group, and by the group: this being for the general membership, or the people themselves.

This Awareness suggests that the upkeep of these items may also be paid by the membership. That the membership may elect to charge for the use of the items, but may also elect to simply allow their profits from their banking system to pay for these upkeep expenses.

This Awareness suggests that recreational facilities may also be purchased by the group. Wherein the group, the membership, for example, buys a yacht, and allows certain days, or certain amount of use shared by various members of the organization.

This Awareness suggests that the same can be done for property purchased, for retreat settings, for recreational activities and goods.

This Awareness indicates that the same can be done for group-owned motels or hotels.

#### How Many Can Live Like Millionaires


This Awareness suggests that gradually the people shall begin to own the same things among themselves which have previously been owned only by the few:

This Awareness suggests that one entity may own several hundred hotels, may own several thousand acres, may own several houses: but one entity can only live in one place at one time. That through special communication systems, those other places may be used by other entities while that entity is not using those places:

Wherein the group owns the various places, and order is such that entities can have access to those places, then a few places owned by the group can lead each entity within that group to live the same life that a millionaire or billionaire would have lived previously.


This Awareness suggests that the Interpreter be brought from trance at this time; that a following reading shall continue along this same vein.

THE UNIFIED STATES OF AWARENESS TIER DIAGRAM


(Showing Colors and Number of Representatives)



The floor below always holds the power over the floor above; as each new floor is formed, the power and control is passed to that floor, and the floor above becomes only advisory in nature: giving suggestions, recommendations, evaluations. Those above can move down at will, but one must be elected by one's own floor to move up to the next floor. The floor below makes the rules for its own floor and for the floor directly above, and follows its own rules and those imposed from the floor below. Each Cell (dozen), each Pod (12 Cells), or each Cluster (12 Pods) on any floor may also have its own particular rules. (See circle diagrams for pods and clusters). Each floor must enforce its own rules or request help from the floor below. It may solicit or demand advice from the floor above, but the floor above can not give orders or directions to the floor below. Each floor controls only the immediate floor above, and through those representatives may influence the floors above that, but does not vote for affairs or representatives on any floor above the floor directly above. Each Cell, Pod, Cluster or floor must be complete and organized to hold its power over the floor above, or its representative above.

(144 or 12 times 12 plus original equals 13)




(Each of the 12 responds to the area of concern symbolized by their placement on the Zodiac pattern. (This has nothing to do with the personal Zodiac signs of individuals))





TWELVE BASIC AREAS OF HUMAN AFFAIRS



Each Cell, each Pod, each Cluster, each Tier is divided into these twelve basic areas of Human Affairs, with further breakdown into the specifics being made by astrologers working in the Logistics and Evaluation Services. For example, the Cultural and Recreational Branch will be broken into Literature, Arts, Drama, Music, Parks, Boating, Beautification Projects, Clothing Design etc. as the topic is expanded from branch to limb to stem, to twig etc., down the tiers, so that even the dental office would have an area of cultural concern (paintings, music, etc.)

The design below could typify a municipal government, its branches and a breakdown to the fourth tier from the top or center, (1728 department heads, controlling 144 representatives, who control their 12 representatives, who elect their one advisor and representative in the center of the diagram.

The Unified States of Awareness  
as Opposed to the "United States of Awareness"

Question:

Awareness, we are here for a continuation of the readings on the United States of Awareness (slip of tongue) and the information about the York Convention in July. But first, Vicki had one question in relation to something that was given in the prior reading.

Cosmic Awareness:

This Awareness suggests, prior to this, that the term as being the "Unified States of Awareness as opposed to the United States of Awareness. This in a subtle sense being a difference. This Awareness indicates that there is total unification of all forces within the universe: that United actions come about from choice after separation.

This Awareness indicates that in this sense, the Unified States of Awareness is not coming about by choice, wherein entities may choose to belong, may choose to unite. The action is coming about because of a unification of forces within the universe, which exists at all times regardless of the illusion of the choice.

This Awareness indicates, essentially, what this Awareness is saying is that you do not actually have a choice in the matter; that you do not actually have free will on this particular level of awareness. That on other levels of awareness there are those concepts and illusions of free will; but wherein entities reach certain levels of awareness, there is no choice: the action becomes one of unification, integration of all forces within the universe, and the action is choiceless. This being the highest level of awareness, wherein the power of the word, the power of the experience is that which emanates on all other levels, and allows the other levels to have the illusion of free will.

The Meaning of "Excluding None  
Who Wish to be Excluded"

Question:

In the first reading on this topic there was a sentence that said "excluding none who wish to be excluded".

Cosmic Awareness:

This Awareness indicates that there is a term in your field of psychology known as the "Freudian slip". This Awareness indicates this as likened unto an entity who steps aboard an elevator, pushes the button, and steps off on the wrong floor. This Awareness indicates the entity suddenly realizing he is on the seventh floor and intended to exit on the 6th floor.

This Awareness indicates this as likened unto what appears to be an accident, that the finger did not respond accurately and pushed the wrong button. This Awareness indicates in reality, this was no accident; that the mind did not push the finger to the right button, and the mind therefore, being lax, did make the appearance of an accident. This Awareness indicates that this also as not being an accident: that behind the mind which appeared to make the accident, there was a purpose for that action of exiting on the wrong floor.

This Awareness indicates that on one level, wherein the statement, "excluding none who wish to be excluded", appears to be an accident, and the meaning is implied that it intended to state: "excluding none who wish to be included". This Awareness indicates it did mean that to some extent, but also, and to a greater extent, meant: "excluding none who wish to be excluded", for in the Unified States of Awareness, in those levels of consciousness of the universe, none can be excluded, even though they wished they could.

This Awareness indicates that no entity can exclude himself from being. It is in all levels impossible to cease to be something.

This Awareness indicates that in terms of the society, this information which is being given, shall begin opening up the doors from the present plane into that which has been

called "God's Kingdom on Earth". This Awareness indicates that the doors being open, none will be excluded who wish to be excluded, but they may think themselves excluded. This as their own illusion.

This Awareness indicates that the entity, Lucifer, also had that illusion...for a brief time.

The Co-Existence of Two Economic Systems:

The Unified States of Awareness and the Present System

Question:

Would Awareness comment on the coexistence of the two economic systems: the Unified States of Awareness and the present system?

Cosmic Awareness:

This Awareness indicates that in relation to the co-existence of these two orders; that which was based on hierarchy systems wherein power was at the top, and that which is based on the present system which may be called "Cosmic Democracy", wherein the power is to the meek, the power to the people. These two systems, being in opposition to one another, likened unto positive and negative poles of a magnet, there appears to be an incompatibility between these systems: that positive cannot exist in the periphery of negative. This Awareness indicates this is an illusion, for positive and negative have for eons of time existed side by side. This Awareness has indicated that the reconciliation of "yes" and "no" is occurring: that positive and negative are being depolarized, that right and wrong are being depolarized, that extremes of good and evil are being depolarized.

This Awareness indicates that the use of power through administrative, legislative, judicial and monetary controls is being diffused by these concepts which this Awareness now opens into consciousness: whereby all of consciousness, tapping into the flow of these concepts, begins to rush through the watergate that has been opened beyond the realization of those who first tampered with the release of secrecy.

This Awareness indicates that the floodgates are open and power is on its way out. That the monetary controls used by those who created money from thin air, who created by their presses, by their pencils and papers monies which led to wars and violence, which led to nations against nations, which led to famine and starvation, which led to great empires and great slavery: those who used the pen and ink for such power are now to discover that they are on the wrong end of the totem pole.

This Awareness indicates that the pole is being turned upside down: that those who were on top shall be those who are on the bottom. This Awareness indicates that there is nothing which any entity can do to stop this from happening.

This Awareness suggests that all of the efforts to bring about change in this shall only come down hard on those who create those efforts, and those entities shall find themselves coming under the weight of their own energies.

This Awareness suggests that in relation to the two economic systems, whereby the monetary system is in existence in any form, in any country or culture, that there is the opportunity for entities to bypass the monetary system, going directly to one another and exchanging their services or goods, without using money at all. This Awareness indicates that there is also the opportunity whereby these entities in bypassing money can keep track and keep record of what they gave each other in terms of their exchange of energies. This Awareness indicates that in keeping track of their exchange of energies, their debts to one another, or their transference of items or services, the entities in effect are keeping books.

This Awareness indicates that there is also the opportunity for entities in keeping books on their transactions, while bypassing money, to hire another entity to keep books for them without paying that entity money, but giving a service in return. This Awareness suggests that in this manner, the entities may exchange with one another and the bookkeeper may keep record, and in turn be given certain rewards for keeping records.

## Using Talents to By-Pass Money

This Awareness indicates essentially what has developed, is a system whereby entities have an opportunity to exchange with one another, to write checks to one another, checks which do not use money, but rather use points, credits, or some other energy service exchange title.

This Awareness suggests the title "Talents"; that you exchange talents with one another; that this may be stored in items.

This Awareness suggests that wherein these entities begin to hire their bookkeeper, that the bookkeeper is simply keeping records and keeping accounts for those who hired him or her into that action. This Awareness suggests that as this grows larger, the bookkeeper may also need assistance to help in keeping these books: that these also may be hired by those who wish their books to be kept. This Awareness indicates in this manner, entities, while bypassing money, may create their own banking system: exchanging items and goods with one another, but using a different term entirely for storing those energies which they are exchanging; and using this different term, this may be of any term any of these entities wish to honor. This Awareness suggests that the entities then, having their own cluster of friends within their trade club, honoring each other's point system, credit system, or talent exchange system, now have the opportunity to trade with each other items and services. They also have the ability to create actions and more services from the trade network: Therefore, one entity may choose to start a small tabloid newspaper for the club to allow the club to know what is available by other members within the club, and what other members would like to receive from the club members for their own benefit; and in general, the items and services which are needed, or which are available to club members are presented in the small tabloid.

This Awareness indicates that there is that opportunity for entities to bypass the money system and set up their own club for trading of energies and services. This Awareness suggests that when this is accomplished, there is also the opportunity for various clubs to begin to honor the point systems of other clubs, whereby they may exchange with other clubs, exchanging credits or points or talents with other clubs.

### How Forming Clubs Can Change the Economic System

This Awareness indicates wherein this occurs, then the clubs begin to form a greater base of exchange, so that if the talents and services are not available in one club, the entities can contact a neighboring club and exchange services with that membership.

This Awareness indicates that as this continues to grow, an entirely new economic system begins to unfold which is publicly owned by entities who wish to start their own clubs. This Awareness indicates that there may be efforts by certain perverted entities who still seek power to create situations where there are only certain types of talents and certain clubs which are authorized to accept points and other clubs being excluded, their point system being of non-acceptance:

This Awareness suggests that wherein this occurs, that you simply begin with your own organization, building it larger and larger, allowing your club system to grow so that you eventually do not have to depend upon the union of other clubs, but have bypassed their system, even as they bypassed the money system.

This Awareness suggests that there is no way that entities can be economically bound by any system of economy except if they, themselves, desire such bonds.

### The First Club to Form is During the York Convention of New Age Groups

This Awareness indicates that in the Unified States of Awareness that these clubs shall begin to grow and to expand. This Awareness suggests that the club which this Awareness would like to see initiated at the conference in York, is one wherein entities who join the club at this time, between 1977 and one year thereafter, in 1978. This Awareness sees the time as being July 16th or 15th. This Awareness suggests that the entity, Kenneth Breckon,

as being the astrologer, to determine the exact time whereby this club is to be initiated.

This Awareness suggests that this club, from that time until one year later at the exact same time, shall give each member 300% of the point, or talents which are earned by trade or service given to another club member:

#### How the Club Will Work

For example, an item of 10 talents value is given to a club member. That club member writes a check to the seller and the seller takes this check to their bookkeeper and points are taken from the buyer's account, placed in the seller's account to the amount of 10 talents.

This Awareness suggests that at this time, for one year, that the seller also be given 300% the amount, so that instead of just the 10 talents given for the exchange, the seller receives 20 more talents from this Awareness for being brave enough to sell his item or service for these points, for these talents, which are not based on the money system so familiar to most entities.

This Awareness indicates that these 20 extra points may be added to the account of the seller: so that the entity in selling a service or item worth 10 points, worth ten talents, now has received 30 talents, and can use these talents to purchase more from other willing club members.

#### A Bonus Incentive For Those Who Join Now

This Awareness indicates that this 300% system exist for the first 3 years. That after 3 years, this then be dropped to 200%. This to continue for 6 years. That thereafter it be dropped to 150%, and this continue for 12 years. This Awareness indicates that thereafter it be dropped to 125% and continue for 24 more years. That thereafter it be dropped to 110% and remain.

This Awareness suggests that those entities who become involved in this club at the beginning will be encouraged to put their possessions and their services into the action by the prospects of receiving more talents in their account. That these talents at present are only concepts, but as entities begin to agree to accept these talents, the talents become as real and tangible and as meaningful and as valuable as is present-day money.

This Awareness indicates that as these talents are exchanged and more and more entities begin putting into the club their talents, their items, their services, the value increases on the talents, and entities shall literally become wealthy in but brief moments. This Awareness indicates that the system which this Awareness gives now is that which shall make entities, who begin early, very, very wealthy. Yet, as this progresses, entities who begin later shall also be very, very wealthy: for the talents which shall be exchanged shall belong to the entities on this earth, and not to any particular individual--that you, yourself, may have your private ownership, but that there is no way whereby you could acquire the ownership of other entities.

#### How Talents will Accrue in the Bank

This Awareness suggests that each time an entity trades services or points with another entity, and it moves through the bookkeeping system of the credit union or bank, or bookkeeping system being used: each time the bank, credit union or system shall credit to the public 10% of that exchange. This Awareness shall create that 10%.

This Awareness suggests that, for example: the item, a refrigerator, being exchanged for 100 points or talents to another member. The member purchasing the refrigerator will give to the seller 100 points form his account; that this be exchanged by their bookkeeper. The seller then, is given by this Awareness, through the bookkeeper, 300 points for this action (if this is taken during the time indicated).

This Awareness indicates that these 300 points now enter into the account of the seller; that the bookkeeper also enters into the public fund 10% of the amount which was exchanged in value. Whereby the buyer exchanged 10 talents, the bookkeeper places 10% of this on the books for the public use.

This Awareness suggests that this 10% then is that which is available for the club members and is appropriated for them by those who they hire and appoint as representatives to administer the disbursement of the social funds, the social wealth.

This Awareness suggests that the wealth of this society being disbursed into various activities, according to the membership's votes: (because the people on the bottom of the tier control their representative above, and they pass the orders upward, receiving only downward advice and observations which are understood from those who are their representatives). This Awareness indicates that those on the lower tiers shall determine the disbursement of funds and the budgeting after being advised by those on the upper tiers.

### "An Infallible System"

This Awareness indicates that this system, if put through a computer, will be seen as being infallible in terms of changing the entire economic system upon this plane in but a few short years.

This Awareness suggests that within 20 years dramatic changes will be seen upon this plane. Within 50 years, this shall be an entirely new civilization as has never been dreamed of by most entities in their quest for gold, money, and power.

### How Power Will be Transferred to the People Without Creating Chaos

#### Question:

Will Awareness explain the administration of the release of power to the people and how this power can be given to the people without creating chaos?

#### Cosmic Awareness:

This Awareness indicates this as that which is handed down with each person who joins the club, joins the Unified States of Awareness. This Awareness indicates at York, that It would like to see 12 entities elected, but these may also be appointed. That it matters not at this point whether these 12 are elected or appointed: for once they enter the office, those beneath them have the right, at any time, to remove them from the office.

### 12 to be Elected or Appointed at York

This Awareness suggests that It wishes to see 12 entities get together at York with the purpose of beginning this action. That as these 12 get together, and 12 more form around each of them, that a pact be drawn up, a charter for the 12 be drawn up, which creates the rules of relationship between these 12; and that these 12 then select, vote or appoint a 13th to be their representative. This Awareness suggests this 13th entity, corresponding to that which was previously given as the capstone of the pyramid. This entity having no power except to communicate, request, suggest, and to release indications and observations about what is seen in relation to the 12 and their work.

This Awareness suggests that the 12, at any time by a vote of 7 to 5, may remove this entity from that position as representative and may place another entity into that position. This Awareness indicates these 12 must choose that entity from their own numbers, and the entity removed can only be brought down to their own tier, and no further, by this action.

This Awareness indicates that the next tier beneath these, each of these 12 having gathered 12 more for the next tier, shall be as advisors to those 12 so that 12 times 12 forms the 2nd tier. Once this tier is complete, the power is transferred to that tier and the tier, itself, becomes the administrative branch of the organization; the 12 then being only advisors to the administrative branch.

### Each Entity Will Pick 12 Disciples

This Awareness indicates that once this administrative branch on the 3rd tier (this as the level of 12 times 12), once this is completed, the next tier is to be gradually formed,

whereby 12 x 12 x 12 groups and individuals are formed beneath these: each entity picking 12 disciples as it were. This Awareness suggests this as the key. The tier formed below is formed by the entities who pick 12 disciples; but those disciples then become the master, and the master becomes only an advisor: one who suggests.

This Awareness suggests that the disciples on the next tier down, (now as masters of their destiny, being able to direct and tell their supporters what to do), may decide to remove the superior from that position and put in someone else.

If this occurs, they can only bring that superior down into their midst among the other disciples, making a similar disciple of him while moving that replacement up.

This Awareness suggests this as likened unto exchanging positions in musical chairs, but that this musical chair's action as that wherein the one standing in the center represents the group on the next tier up.

This Awareness suggests that the power lies on the tier below, that the general understanding and wisdom lies on the upper tiers: but the further down the scale, the greater the power to the people. That the people have the power at any time to remove that entity on the tier above which they have appointed to represent themselves.

This Awareness indicates that they cannot remove the entity which they have not appointed nor can they remove the entity two or three tiers up, but they can remove those entities which they have appointed, which in turn assisted in the appointment of others on those upper tiers; and in this way, the entities can, likened unto pulling on a chain, pull the last link down the pyramid.

#### The Power Structure of the Pyramid

This Awareness indicates that in this sense the power is on the bottom of the pyramid, and the upper levels are only advisories, are only able to give suggestions, recommendations, and make requests for the good of the society.

This Awareness indicates that each time a tier is created it holds the power, but its power is meaningless because it has power only over those few, (only over those which it has chosen to represent it).

This Awareness indicates that the masses themselves, below that power, are not controlled by the power, and therefore, each tier, having only control of the one person appointed by each of the 12, having only that much control, can not affect in any way the fate of the masses other than through suggestion and recommendation and request.

This Awareness indicates that entities on a tier such as the tier wherein there are 1,728 dozen entities: these dozens... (This Awareness wishes you to recall the earlier mention--12, 144, or 12 squared, 1,728 or 12 to the 3rd power, 12 to the 4th power and so forth, each tier growing larger). This Awareness indicates that these tiers in moving down--the power continually spreading wider and wider into more and more areas--that never in this organization does any group of entities have power by the organization over more than one person.

This Awareness indicates that each of these 12 on any level have elected their representative and do have power over that representative, but they do not have power over any other person in the entire organization.

This Awareness suggests that these 12, and those constituents of their own tier group, can join together in clusters of 12 and reach conclusions and advice and can work for certain concepts, and shall then be able to communicate through their group action to more than just the one entity they have chosen to represent them. These entities then can, as a cluster, communicate with all of those entities who are chosen as representatives of that cluster. This Awareness indicates in this manner, the entities may join together and communicate larger amounts of information with each other so that greater understanding can be shared by all.

This Awareness suggests that still, regardless of any situation, the entities do not

have power over others beneath them in this organization. They only have power as a collective among themselves, through their own rules and regulations which they place upon their own dozen, and which the tier of dozens may choose for itself; that you only make the laws for yourself and those above you.

This Awareness indicates this be repeated: Each tier, regardless of where it is on the pyramid, can only make laws for those among themselves and those above.

This Awareness indicates that in making the laws and the regulations for self-government, (each of these dozens), there shall be different levels of legislation. That each dozen has its own rules of order according to how they wish to work this out. That each of these dozen, the entity who represents the 7th position being representative of the sign of Libra, (not necessarily his or her personal sun sign: this has nothing to do with individual horoscopes).

This Awareness indicates the 7th position in the circles of dozen being that which is the Libra quality as being associated with law. So that the dozen entities who join together, choosing one who represents them on the tier above, and the one who is the number 7 position who represents them to the other groups on their own tier as their lawyer. That in each of these 12 positions, each of these entities has a special purpose, a special job on that particular tier, in that particular activity which their cluster, their branch and their dozens are involved in.

This Awareness indicates this as needing greater explanation in future trances. This Awareness indicates that the example of the number 7 entity in the cluster or in the dozen being the lawyer for the group, this entity then communicates with all of the other similar lawyers on that tier, and together they work out a series of rules and laws for each other upon that tier, so that the laws of the tier are created by the people on that particular tier. This Awareness indicates that the other laws for that tier come from the tier beneath.

This Awareness suggests that there are 3 sets of laws governing entities: Those within their own group of 12, those within the tier in which they are, and those from the next tier down.

This Awareness indicates that the power of the law is being passed downward. The legislative actions also being passed downward, the administrative actions being passed downward, and the monetary actions being passed to the masses. This transfers power without any entity ever being in control: whereby no entity is able to stop that power from being transferred, for there is no head of the organization except that which is continually spreading among the masses as each entity joins and forms a new tier.

#### After the Third Tier, Nothing Can Stop It (Cancer in the Heart of the Beast)

This Awareness indicates that once an organization passes the 3rd tier, there is no way that organization can be stopped by any force. That any organization that passes the second tier may possibly be disrupted, but will reform and sprout at least one dozen other similar organizations, and these shall spread the release of power even more quickly.

This Awareness indicates this may be thought of as a cancer in the heart of the beast. That this may also be thought of as seeds, planted in consciousness, to bring forth beauty, harmony, and plenty: plenty for all.

#### How the Judicial System Will Work

##### Question:

Under the Unified States of Awareness, how would the judicial system work?

##### Cosmic Awareness:

This Awareness indicates that the legislation being created among each of the cells, wherein 12 get together and make their own rules and then pick representatives to communicate with others on their tiers: these entities also able to direct and make rules for those above, are also responsible for their own regulation of these rules. That wherein entities create rules of their game, they also must discriminate and discern among themselves whether they

are clearly following the rules or not. This Awareness indicates in this action, entities shall be chosen by each of these cells, by the dozen members of each cell, (this could just as easily be termed branch or limb), to interpret the rules which were created by the members of that cell, and to recommend changes or actions in relation to those interpretations.

This Awareness indicates that the judicial system, essentially, is that wherein entities must govern themselves because there is no power above them; therefore, they must learn what their rules are saying within their own cell, and their cell must learn what the rules are for the tier in which it lives.

This Awareness indicates this may be explained more clearly in the allegory of the tree: The leaf makes its own rules, but is also linked to the stem, and the stem has its rules. The leaf then being subject in part to the stem, the stem and the leaf in this situation... This Awareness indicates this as being rather confusing... that the image is seen and the words are difficult. This Awareness wishes to pause.....

This Awareness wishes you to visualize a cone, likened unto the shape of an ice-cream cone turned upside down. That this is wider at the bottom than at the top, and around the bottom are 12 more ice-cream cones turned upside down; and around the mouth of each of these cones are 12 more, making 144 sitting beneath 12 cones and one above that; and below the 144: 1,728, or 144 dozen ice cream cones.

This Awareness indicates that in the level of 144, there are individuals working in groups of 12. There are also 12 groups of 12. This Awareness suggests that beginning at the top of this pyramid of ice-cream cones, the 1st entity may be equated to the trunk of a tree. The 2nd entities, the 2nd tier of cones, equated to the branches of the tree. The 3rd tier of cones equated to the limbs of the branches. This Awareness indicates that the 4th being the stems of the limbs.

This Awareness indicates that now visualizing this and looking at the 3rd level, the trunk, the branches, the limbs; the limbs are made up of 12 groups of 12. This Awareness indicates the limbs being made up of 144 entities, or 12 dozen.

This Awareness indicates that the next group below that as being 12 gross of 12 dozens, (that the gross being 144 dozens).

That the action of legislating by the entities involved as moving among those within their own tier, but also being responsible on that tier, not only to the 12 within their own particular dozen, but also to the rules which are created by the gross (or dozen dozen) on which their tier and their actions are centered. And as this passes on downward, there are the..... This Awareness indicates this as extremely complicated to explain. That the Interpreter shall be more adept at drawing this out. That this Awareness now asks for a pause while this image is impressed upon the consciousness of the Interpreter so that this may be presented in a diagram form..... (long pause). ED'S NOTE: See Illustrations A thru F.

This Awareness indicates that this shall be made more clearly available as colors, notes and shapes are presented in a diagram. That the legislation on each of the tiers relates not only to the group, but to the group of groups and the group of groups of groups. This Awareness indicates that representation between these groups and those on that particular tier gives the law, the rule-making ability, and the enforcement of the law to those members upon that tier, and that each tier is also governed by the laws of the tier below. That the number of entities on the tier below as always 12 times greater than on the tier above, and the law and enforcement of the law being with the masses among themselves and over those who are their servants as public servants in the offices of the government.

What Happens to Free Enterprise  
and the Concept of Private Property?

Question:

Under this new system, what happens to free enterprise and the concept of private property?

Cosmic Awareness:

This Awareness indicates that not all entities will wish to be part of the governing bodies, nor will all those who are part of the governing bodies wish to devote their entire life to this. This Awareness indicates that many entities (the majority of entities), shall have their own outside interests, and shall pursue these interests. The pursuit of living in terms of the right to life, liberty, and the pursuit of happiness, can only occur wherein entities do have those rights; and whereby power is given to the people, they shall have those rights.

This Awareness indicates that in the sense of free enterprise, that all entities shall remain free to be enterprising as they desire: shall trade, shall do business with one another; shall, in fact, own the banks, collectively, just as a co-operative store owns the store; shall be responsible for governing the behavior of members within their own activities, within their own ranks; shall be responsible for keeping each other in line: and in general, free enterprise shall be given its complete release upon this plane.

COSMIC DEMOCRACY--A WORLD-WIDE  
REVOLUTION WITHOUT BLOODSHED

This Awareness indicates that until now, there has never actually been a democracy, nor a free enterprise system upon this plane: for these were not free. They were controlled from power. They have been controlled from money systems, from executive positions, from legislative positions, and from judicial positions. That free enterprises as given through the Unified States of Awareness shall become a reality--that Cosmic Democracy shall become a reality.

This Awareness indicates that there is no way that this can be stopped. That actions shall be such that it will inevitably exist in but a short time in every nation on earth.

This Awareness suggests that these actions of the Unified States of Awareness can begin in the most totalitarian country. That the powers of totalitarian countries will be the last to be interested in what is occurring, because these entities will see that there is no power held by those who are advisors to the group. And because of this, they cannot do anything about removing the leaders, for there are no leaders. There is only the group which keeps selecting representatives.

This Awareness indicates that the majority of totalitarian countries would tend to ignore this action as being totally meaningless because the entities are not competing with them for power.

This Awareness indicates that because of this lack of competition for power, these totalitarian countries shall find themselves being taken over by the people without any violence, without any bloodshed, and without any objection.

This Awareness indicates that the entities who are holding the power shall essentially discover that the people are walking out from under him and moving over to another pyramid: and that as his pyramid of power melts, the other pyramid grows, which is owned by the people.

...And the Meek Shall Inherit the Earth

This Awareness indicates that the last shall be first and the first shall be last.

This has been the riddle of the Universe for some eons of time: The meek shall inherit the earth.

This Awareness indicates those who cling to the old ways, seeking power, shall be the last to join this action of giving the power to the people:

And those who join in the latter ranks shall have the power, for they shall be the people; but that they shall have no power over the people; that no entity shall have power over the people.

The Unified States of Awareness:  
An Atomic Blast in Consciousness

Question:

Concerning the Unified States of Awareness, and the information Awareness wants to be printed up to be presented at the York Conference, does Awareness have an opening message for this reading?

Cosmic Awareness:

This Awareness indicates that this action may move slowly at first, but shall begin to pick up momentum in various places around the nation. This Awareness suggests that this entire action of bringing the Unified States of Awareness into fruition upon this plane shall be likened unto the effects of an atomic blast in consciousness: which essentially is blowing apart power, so that power is being scattered to all ends of the earth.

What Freedoms Will Exist Under  
The Unified States of Awareness

Question:

Under the Unified States of Awareness, what are the economic freedoms?

Cosmic Awareness:

This Awareness indicates the freedom to life, liberty, and the pursuit of happiness depends on part on the governing structure and the environment of the society. That one can have the right to life, liberty, and the pursuit of happiness, but if one is in the midst of the battlefield, the right does not give the life, liberty, and pursuit of happiness the meaning.

This Awareness indicates that the governing society must make certain things possible for entities if it is a government of the people, by the people, and for the people. This Awareness indicates that action which was begun in Yorktown 200 years ago, wherein the Articles of Confederation were signed on November 15th, 1777, wherein these were signed and the United States of America came into existence: a new creature was born in consciousness with the idea that people could govern themselves. Self-Government, known as Democracy, was being given its chance.

This Awareness indicates that even in this action there were controls by the Spiritual Hierarchy which did not allow the masses to have absolute control of their destiny.

This Awareness indicates that the United States of America has relinquished upon this plane many levels of responsibility and power from the inner plane onto the physical plane; that the Unified States of Awareness is a continuation of this action, is the off-spring of that which the founding fathers of this nation began 200 years previously.

This Awareness indicates that the United States of America was the preparation, the staging ground, for this Unified States of Awareness to be born.

This Awareness indicates that the Unified States of Awareness is such that it may be scattered like seeds across the plains, across the valleys, from city to city, across the seas, beyond boundaries, into nations, into cultures, into the minds and hearts of entities everywhere. And the scattering of these seeds, these ideas, as that which brings about the change.

The Twelves Rights of Humanity  
Under the Unified States of Awareness

This Awareness suggests that the question be repeated.

Question:

Under the Unified States of Awareness, what are the economic freedoms?

Cosmic Awareness:

This Awareness indicates that the economic freedoms are the right to life, liberty and the pursuit of happiness, with guarantees by the government of these rights, including an economic freedom: the Bill of Rights plus the freedom of the right to economic well-being, this being health and food, shelter and clothing.

This Awareness indicates in addition to the Bill of Rights as now written, the economic freedom, and that there be also the freedom of morality, wherein entities may express themselves through their own moral code without interference from others, so long as they do not offend the rights of others in any manner.

This Awareness indicates that those actions which are offensive to the masses, or to the general code, the moral code of the society, may be dealt with by the society through the counseling and legal and legislative systems. But that in general, freedom of morality be included as a principle for entities to look at and to consider so that the concept of guilt may be eliminated from the psyche of entities.

This Awareness indicates the Bill of Rights as now written, plus the Freedom of Morality, so long as the morals do not offend the rights of others, and the freedom given as economic freedom: these be included as the Twelve Rights of Humanity in this Unified States of Awareness. (Ed's note: see back of book).

This Awareness suggests that in terms of economic freedom, that the governing society can give food, shelter, clothing and medical care, plus the general environment for an entity to pursue happiness; but that the legislative body of a society, the administrative body, nor any other levels can provide happiness to an entity: for happiness must come from within, and even though the environment may be perfect, an entity may choose not to be happy.

This Awareness suggests that the duty of the society is to make happiness possible for each entity. That the economic freedom: food, shelter, clothing and medical assistance being provided by the society through a guaranteed annual income, presented monthly through the banking system, attributed to the accounts of the entity on a monthly basis, wherein each entity in the organization is given a certain number of talents which is just enough to provide for food, shelter, clothing and medical care.

This Awareness indicates that this provision, of course, cannot come about until the society is formed and operating. This Awareness indicates that it is possible, however, for the talents to be given to the accounts of the entities who join this action so that they have the talents, or credits, which may eventually be used for their well-being as the organization grows and more and more entities honor these points, these talents.

While the Organization is Growing  
You Still Relate to the Present System

This Awareness suggests that at present time the concept of talents is difficult for entities to substitute in lieu of money: for there are always the bill collectors who will not accept talents.

This Awareness suggests that this action is one which shall grow slowly, but shall benefit those who are involved, even from the beginning. This does not substitute the need for entities to relate to the present economic structure while this action is in transition, while this action is growing.

This Awareness suggests that in a sense this action will help you to stretch your dollars through the use of the trade services and the talents and credits by exchanging services and items with club members.

This Awareness indicates as this begins to grow, the value of this and the income level shall rise for each of the members. This Awareness suggests that in the example previously given whereby an entity sells an item for 100 talents, and for selling this item is given a check for 100 talents from the account of the buyer, and also given 200 more talents from this Awareness to stick into his account for being capable of taking a chance during these first three years while this action is forming, and the account crediting the General Fund

of the members with another 10%, or another 10 talents, for the item which was sold, (the points which were transferred from one account to the other). This Awareness indicates that each time a transfer of points from one account to another passes through the bookkeeping system, 10% is added to the General Fund. This 10% to be divided annually among the members according to their own discretion, through their representatives and the budgeting system which they control, which they accept as being appropriate by the general membership.

This Awareness indicates this may mean that the 10% profit goes back to the membership and is put into their own accounts. This may also mean that part of this is credited for certain other kinds of activities or expenses due the membership.

This Awareness indicates that these points shall continue to build for the General Fund as well as for individuals in their present bank account systems, using these talents in these centers. That within a certain length of time, the local trade center wherein your group has set up its own accounting system and banking system for exchanging talents, for exchanging points or credits, may grow to such a size that it wishes to be included in the group actions of others who are doing similar banking situations. This Awareness indicates that when this occurs, you select a representative who contacts the general central banking system and links in your group action, whereby the credit system which you are using is linked into the credit system of the Unified States of Awareness.

#### Credit Systems To Be Self-Regulating

This Awareness wishes entities to understand at this point that the credit systems of these various bookkeeping levels shall always remain under the control of the group which they represent, rather than from a group or power above.

This Awareness indicates that there is, however, the need for self-regulation, and when entities become involved in joining their credit union with other credit unions, the general tier on which these credit unions exist shall have its own regulations as to how these credit unions are managed.

This Awareness indicates that for the time being, while we are still involved in duality levels, the credit union of the Unified States of Awareness and the national credit union in the United States of America will need to be compatible. This Awareness indicates, therefore, the banking representatives of the Unified States of Awareness will need to understand certain economic principles relating unto what is compatible and legal so that the legalities are not in conflict. This Awareness indicates, however, these credit unions do not need to be involved in money as such, but may instead use talents; and in this way, need not even be connected, or in any way under the domination of the credit union laws of the United States Government.

This Awareness indicates this as but a suggestion as to how you may proceed. This Awareness indicates that in a sense the money for credits of a trade center, of a bookkeeping system may be but a parallel pyramid, paralleling the same pyramid described in terms of the government or administrative actions: that those who are above are but advisors, representatives of those who are below. This Awareness indicates, in this sense, the members of a credit union control and elect their representative who is their advisor. This Awareness suggests that these representatives of these credit unions, in turn, join together and elect a 13th position who is their advisor; that this continues up the pyramid.

#### Trade Centers to be Called USE-IT

This Awareness suggests that these trade centers may exist either in rooms and buildings wherein items may be brought and stored, or may exist over telephones where entities call a certain number and ask for information as to where this or that may be obtained, and are given the name of one who has this or that service; and in contacting this entity and hiring the entity to conduct the service, transfer points by sending in a written check to the person at the other end of the telephone who is running the switchboard of services to be exchanged.

This Awareness suggests the term "USE IT" as being a term for the trade centers; that

the UNIVERSAL SERVICE EXCHANGE and ITEM TRANSFER SYSTEM, the USE-IT SYSTEM, which may be created by any entity who has access to communicating with others, and who has the capability of helping others to exchange their goods and services.

This Awareness indicates that this entity, using the term, the USE-IT SYSTEMS, not to make money on this, but to use points and talents or credits rather than dollars and cents. This Awareness indicates that when the entity joins the Unified States of Awareness with his or her USE-IT SYSTEM so that a broader base of exchange may occur, the entity follows the rules of the economic structure of the group, according to that which they set.

This Awareness indicates that in terms of the 10% suggested by this Awareness that goes into the banking accounts for the general fund, this 10% as being that which is arbitrary and can be regulated up or down in order to create more points for the society, or fewer points to be distributed if inflation occurs, or if depression or recession occurs. This Awareness indicates that in upping the points, whereby more than 10% is attributed to the General Fund, the tendency is to create more points and to create a kind of inflation. That in lowering the percentage whereby, for example, six or eight percent is attributed to the General Fund, the tendency is to lower the number of points and bring about a recession or a depression in the economic sense. This Awareness indicates that those understanding economics shall understand the implications of the foregoing message in relation to property owned by the various entities involved in the situation.

This Awareness indicates that as the power lies with the people, and the wisdom lies with the advisors, that a mutual arrangement and respect must come about on all levels: economically, judicially, executively, and in terms of legislature.

This Awareness indicates that this may be likened unto creating 12 pyramids of power which coexist together as one, with the power being on the bottom and the wisdom being at the top, and the branches moving up and down, giving communication from the bottom to the top, and from the top to the bottom, through mutual representatives who are known to those who relate in their general circle.

This Awareness indicates that each cluster and each dozen and each tier may have its own credit union or bookkeeping system which is linked into the other. This Awareness suggests this likened unto a group of 12 selecting one who is the bookkeeper, who keeps records of the group's energy exchange; and that bookkeeper is monitored by the bookkeeper for the cluster of 12, and that cluster is monitored by the bookkeeper who is representative of that cluster of dozens.

This Awareness indicates that this continues until the entire tier is covered and monitored so that the bookkeeping and points are registered on that tier. This Awareness indicates that then becomes the information for which the General Fund is created; the percentage received for the General Fund then distributed on that tier according to the votes of those who are there and involved in that action at the advice of those who are their representatives and advisors.

This Awareness indicates that much of this may be somewhat confusing at this time, but that as it begins to unfold, entities shall create the necessary rules and see the problems and situations that are involved in the monetary, or talentary system, so that they create the legislation which appropriates the energies according to that which is appropriate. This Awareness wishes that questions be asked wherein there can be clarification; that questions be asked wherein there is seen confusion.

#### Where Do the Talents Come From?

##### Question:

Awareness, in reference to the new system, using talents: where do the talents come from when you first start the action?

##### Cosmic Awareness:

This Awareness suggests that this be determined by the membership of those who are involved in the central beginning in this Unified States of Awareness. The 12 who begin the

action shall determine how many talents are given to the entities who join as members. That these talents may be given as arbitrary, according to the wisdom of these 12 coordinators, or advisors, who shall begin this action. This Awareness suggests, for example, they may decide that 100 talents be given to each new member and this be credited to the account of the member, whereby the member agrees to use these talents to trade services and items with other members of the organization.

This Awareness indicates that they may decide to give 1000 talents to each member who joins, whereby these 1000 talents are available and can be used by the individual in trade for services and items among the membership. That the amount shall be created out of thin air to begin with, for this is nothing other than creating a new game in consciousness, just as the old game was created in consciousness, and maintained through violence and war. This Awareness suggests this as likened unto a monopoly game wherein each entity is given so many 100 dollar bills, so many thousand dollar bills, so many 500 dollar bills, so many 20 dollar bills, and so many 10's, 5's, and one's.

This Awareness suggests that whatever talents you give to the new member should be fairly given so that all who join in the game receive the same number of talents to start; that thereafter the points and credits can be exchanged, the talents may be exchanged through services and through rewards, through exchange of items and exchange of services, through trade and through the banking interest which goes into the General Fund for the public and is given out annually as a subsistence type of funding for those memberships. This Awareness suggests this as likened unto bonuses: this relating to the 10% created by the exchange at the bank which becomes public funds. This being given also to the members according to the regulation decided by that membership through their representatives.

This Awareness indicates that essentially, the points are created out of nothing, just as money was created out of nothing, just as gold was created out of nothing, just as you and all that which appears to be physical form, was created out of nothing. This Awareness indicates that it matters not where the talents come from. What matters is that they be distributed in a manner that is fair for all the players in the game.

#### What About Personal Interest on Talents?

##### Question:

Would a personal interest rate on talents saved be appropriate to the system? In other words, a person saving so much by the end of the year, would they get personal interest back?

##### Cosmic Awareness:

This Awareness suggests that this as negative. That the term USE-IT SYSTEMS implies the use of the talents brings about a greater profit. This Awareness reminds you that wherein you buy an item, that the talents are transferred from your account to the account of the seller. The seller then receives your talents plus twice that many more during these first three years of this operation. Therefore, the seller has profited 300% and you are out one hundred percent of that, but have the item.

This Awareness indicates that with this item, you may now sell to someone else; or, with the advantage of the service which you have purchased, you may be able to function and give service to someone else. Wherein this occurs, you then receive by becoming the seller of the service or item, 300% in your account of that which you actually bargained for. This Awareness indicates that the continuance of giving service and selling and buying is that which builds your points in your account, which brings credit and more talents into your account and which brings about the wealth which you desire. That each time this occurs as an exchange in your account, the general membership benefits by the percentage created for the bank which is keeping track of your exchanges. These general funds then are turned into public works projects or welfare projects which benefit the membership.

This Awareness indicates that, eventually, the points shall begin to become quite large in number and entities may notice that they have many points, and may wonder how they can spend these points. This Awareness indicates that wherein this occurs, this may be called "inflation", and the percentage may be changed so that so many points are not created to overbalance the supply and demand of the economy of the Unified States of Awareness club.

## Is the Unified States of Awareness Technocracy?

### Question:

Awareness, isn't this whole thing sort of a new twist on that economic theory called "Technocracy" that came out during the depression years?

### Cosmic Awareness:

This Awareness indicates there is a great similarity. That the actions as being somewhat colored by the inclusion in the total system of the transfer of power from the top to the bottom of the pyramid. This Awareness suggests that there may be many organizations which are already functioning to some extent in these levels. There are many who have tapped into certain aspects of this Unified States of Awareness and are presently putting the actions together. This Awareness suggests, for example, in terms of the People's Transit Company wherein rides are shared, in the Aquarian Research Foundation wherein various services are shared among the membership. That there are groups around the nation who are presently functioning as an aspect of the Unified States of Awareness, but often unable to function completely and with great efficiency because they are generally isolated in their own action.

This Awareness indicates that the purpose of these communications is to bring the actions together, to coordinate various actions, and to initiate new actions according to the inclination of those who wish to be involved. This Awareness indicates that many entities involved in these actions shall begin to communicate and study each other's works and researches and add ideas to that which this Awareness is presently giving.

This Awareness indicates that the power lies on the bottom of the pyramid. This Awareness is only an advisor and is only giving suggestions while the power is being transferred to the masses, so that the masses can look and discover how the power may be used without destroying themselves.

### How the Unified States of Awareness Will Co-Exist With Existing Governments that May be Hostile

### Question:

What does Awareness say about the coexistence of this government with other already existing governments which might be hostile to this system?

### Cosmic Awareness:

This Awareness indicates that there are few entities in governmental levels who will even bother to consider what is occurring here; and those who do, will not grasp the implications because they are in tune with the pyramid of power and do not wish to give this up for an organization that is relinquishing power and simply giving advice. This Awareness indicates that those who do grasp and understand what is occurring, many of these shall decide to join in the action. Many shall wish to become part of the action, wanting to be in on the ground floor as it begins.

This Awareness indicates that there will be some who grasp the implications of this and will perhaps feel that they should do something to stop the action. This Awareness indicates that wherein any entity who is functioning in the Unified States of Awareness is threatened by another entity from outside this system for being involved in the Unified States of Awareness; this Awareness suggests that whenever you are threatened, you simply explain that you are not in charge, and refer that entity to the people who selected you as a representative and advisor. This Awareness indicates that you may also pretend to have little advice that can be given in terms of what is going on.

This Awareness suggests that when this entity then goes to your superiors, (those entities which have appointed you or selected you), that they simply point to the ones that they represent and explain that they are but representatives and chosen to discover what is going on; and that in general they do not yet know what is going on. This Awareness suggests that this in essence is true on all levels of the pyramid. That no entity can in totality, in total truth, say that he or she knows what is going on. For what is going on depends on the changing mood of the masses who are joining and becoming involved, or becoming aware of the new pyramid which is growing.

This Awareness indicates, in other words, if approached by any government agent or any force which would be hostile to your action, refer that force to the people below your station and tell the force that you do not know what is going on, but that you are waiting to find out. This Awareness suggests that if you have just joined the organization and those above have referred that agent to you, and asked you, "what is going on here? Who is in charge?" Tell them: "I don't know. I just got involved in this myself out of curiosity."

#### Is the Administrative Structure a Full-Time Job?

##### Question:

In the administrative structure, is this a kind of 8 to 5 type government job?

##### Cosmic Awareness:

This Awareness indicates that you need not even go to offices to be an officer, for the office is but an advisory capacity, giving suggestions, passing the information on. The only requirement is that you be in communication and that you be available for communication from those who are your peer group and those who are beneath you in the next tier and the one who you chose as a representative on the tier above. This Awareness indicates, in other words, there are 12 within your circle and the 12 below you who are your superior, or boss, and the one which your circle chose as a representative, and these are the entities with whom you must remain in communication.

#### Another Way to Visualize the Tier System

##### Question:

Would it be accurate to picture the administrative system as an apartment house built like a layered wedding cake, where each floor has rooms and 12 people are in each room, and these people are living by the rules of their room and the rules of their floor, and sending orders to the floor above and receiving advice from the floor below?

##### Cosmic Awareness:

This Awareness appreciates your channel in relation to this image. That the interpreter was not capable of filtering this image as clearly.

This Awareness suggests that the floor below having control on the floors above so that the rules are passed up to the floor above, information is passed up and advice is handed down. For example, one room on your particular floor is having a party. The floor above is wishing to be allowed quiet and peace so as to conduct certain work. The floor below, having the power, having the right to make the noise, to party, continues in this action. This Awareness suggests that you on the floor above, wishing to continue your work, may gather together your 12 and pass a suggestion to the floor below, asking that they create some kind of rules which allow you the time and space to do your work so that you can produce that which they have demanded of you.

This Awareness indicates that if the floor below does not comply with your wishes, then you may simply resign and move down to that floor, and they have no choice but to select someone else to move up and take your position.

This Awareness suggests that while the power lies at the bottom, no entity can be forced into the higher positions. That in this sense, this likened unto the building wherein the floor below creates the rules of the floor above, but that no one needs to live on those floors, and the only purpose for those entities on the floors above is to assist through communicating, through advice, recommendations and requests those on the floor below. This Awareness suggests that in this manner, the power lying at the bottom of the building, the wisdom at the top, and the responsibility lying with those who have the power. For while advice can be given, it needs not be taken; and wherein it is not taken, the person who refuses the advice is responsible for that refusal. This Awareness indicates that in this manner, the power and wisdom come into balance. This Awareness suggests that more questions may be asked in regards to any of this information.

Question: How is crime to be dealt with in this government?

Cosmic Awareness:

This Awareness indicates that there are two major areas of crime: crimes of passion and crimes of greed. This Awareness indicates that in previous situations, in previous governments, there are the powers at the top controlling the masses below. In this situation, there are the masses below controlling the powers at the top.

This Awareness indicates that wherein an entity becomes a criminal in the old society, a policeman is brought out to apprehend that entity. This Awareness indicates that there are very few policemen whose duties are to keep the peace among entities, some of whom are rebellious in nature. This Awareness indicates in this new system, the individual who steps out of line is not brought back into line by a policeman representing a force from above, but is brought back into line by the entire society on the tier in which this entity exists.

This Awareness indicates that the two types of crime, the two major types of crime, are crimes of greed and crimes of passion. Crimes of greed being that which comes about when entities want what they cannot have, or what they feel they cannot have, or what they wish from others, or what they would like to deprive others from.

This Awareness indicates that wherein a system allows the entity the basic living rights: food, shelter, clothing and health care, through a guaranteed income: for example, 8000 points or talents per year, and that entity decides that it wishes to steal or cheat or in some way "rip off" the points or energies of others in the society, that entity then shall be brought to counseling in a type of judicial setting whereby 12 counselors, or one counselor dealing in 12 areas, talks with the entity about his or her behavior in terms of the 12 areas of the zodiac.

Zodiac Counseling for Criminals  
Eliminates the Prison System

This Awareness indicates that the interpreter has much of this information in the material called "Universal Services". This Awareness indicates that the counseling action, whereby a counselor moves through the various aspects of the entity's life, (the personality level, possessions, communication, home life, expression and romance, the entity's rational thinking, his personal order or disorder, his relationships with others, with creditors, with his business associates, his sex life, his desire to grow and learn, his purpose and direction, his motivation, his ability to give and serve and his compassion for others, and the general integration of the entity). This Awareness indicates this counselor, moving in these 12 zodiac areas of the person's psyche, may be able to solve the problem and bring the entity back into a situation whereby he can function properly.

This Awareness indicates that the victims of the crime is to be compensated by the General Fund for any loss created by the action of the entity who stepped out of line on the social structure. This Awareness indicates this likened unto criminal insurance whereby the society pays any victim for any loss due to criminal actions of any member in the society. This Awareness indicates this then encourages the society to prevent and to minimize criminal activities.

This Awareness suggests that the entity who can be dealt with in counseling situations may then move back into the society and continue functioning in a healthy manner. This Awareness indicates that if the situation cannot be dealt with by a counselor, then the entity is brought to a group of 12 counselors, or consultants, each consultant being an expert in his field. The one consultant being concerned with personality and stressing the personality factor of the entity. The next consultant being concerned with the possessions of the entity and what the entity feels about his or her possessions. The next consultant being concerned with the communication level of the entity: How well does the entity communicate? The next being concerned with domestic situations and home life, the environment of the entity's home. This Awareness indicates this continues on around the zodiac wherein each consultant is an expert in the particular area represented by that zodiac sign, as it applies to that criminal's psyche.

This Awareness suggests that in this manner, deeper probing of the entity's consciousness occurs and the entity begins to grow in deeper understanding of his own frustrations which led to the crime.

This Awareness indicates that wherein an entity is so warped or so distorted in his consciousness that these consultants cannot deal with the entity, cannot assist or help the entity, that entity then is taken to the area of Integrative Services. The Integrative Services being that wherein the entity is dealt with in great depth, as in intensive Psycho-analytical examinations for long periods of time, until the entity is cured of those problems.

This Awareness suggests that crime in the Unified States of Awareness shall be treated as an illness rather than as a crime, as presently named. This Awareness suggests that illness is the crime, and crime is an illness.

Crimes of Passion Eliminated  
by Removing Sexual Taboos

Question:

Would crimes of passion be handled the same way?

Cosmic Awareness:

This Awareness indicates that in terms of crimes of passion, that there will need to be places wherein these entities can be counseled, can be helped to move through their areas of frustration. This Awareness indicates in this sense wherein a tier creates a situation in their morality level where they wish to be involved in passionate activities and agree that houses of prostitution are acceptable to them, then, let these houses of prostitution thrive, so long as there are counselors and consultants available to help these entities move through these situations quickly, so that they can move on to other things which are more meaningful to them.

This Awareness suggests that as long as there is a sexual taboo in the consciousness of entities, sex will be a dominating force in their lives. This Awareness indicates that wherein an entity is constantly searching for sexual outlet, and finds another who is a willing partner in this, then let these entities become involved in that action. But let there be counseling and advice, so that there is no harm or damage created that is brought about by ignorance or lack of understanding.

This Awareness suggests that crimes of passion are not likely to occur wherein pressures are not being placed on entities from above. For most crimes of passion are in actuality nothing more than defense against a society, for the entity feels cornered and trapped by some force, perhaps by an individual, and lashes out at someone else, or at society in general. This Awareness indicates when this occurs, the society must take action: but they do not go to the representatives or leaders. They become the leaders, themselves. This Awareness indicates that they make their own rules and laws governing that tier in which the crime was committed, and deal with that accordingly, according to their own rules and regulations. This as power to the people, wisdom available at request.

Question:

Would the same type counseling apply to those entities who are sort of social parasites, the hard core of entities who won't contribute energy, but yet will demand services and goods above those basics Awareness listed?

Cosmic Awareness:

WHAT ABOUT THE SOCIAL PARASITES?

This Awareness indicates this as in the affirmative. That any entity who wishes more than food, shelter, clothing and medical care, with perhaps a later addition being public transportation. Any entity who wishes more than that being supplied freely then should work and contribute something to society for those further luxuries. This Awareness suggests this, of course, is according to the rules of those on that particular tier; that the system which this Awareness is giving is of but a suggestive nature. That entities may wish to allow that person greater latitude in expressing his demands. This Awareness suggests, however, that for his own welfare, the entity receives food, shelter, clothing and medical attention without giving anything in return is receiving enough from the society. And if this entity wishes more, then the entity should be able to contribute something worthwhile which would give that entity points or talents which he could place into his account to purchase the luxuries desired. THE BILL OF RIGHTS

AMENDMENTS TO THE CONSTITUTION OF THE UNITED STATES

ARTICLE I

[Freedom of religion, speech, of the press, and right of petition.] Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

ARTICLE II

[Right of people to bear arms not to be infringed.] A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.

ARTICLE III

[Quarterming of troops.] No Soldier shall, in time of peace be quartered in any house, without the consent of the Owner, nor in time of war, but in a manner to be prescribed by law.

ARTICLE IV

[Persons and houses to be secure from unreasonable searches and seizures.] The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

ARTICLE V

[Trials for crimes; just compensation for private property taken for public use.] No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising in the land or naval forces, or in the Militia, when in actual service in time of War or public danger; nor shall any person be subject for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation.

ARTICLE VI

[Civil rights in trials for crimes enumerated.] In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defence.

ARTICLE VII

[Civil rights in civil suits.] In Suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise re-examined in any Court of the United States, than according to the rules of the common law.

ARTICLE VIII

[Excessive bail, fines and punishments prohibited.] Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted.

ARTICLE IX

[Reserved rights of people.] The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.

ARTICLE X

[Powers not delegated, reserved to states and people respectively.] The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.

(Amendments I to X inclusive, popularly known as the Bill of Rights, were proposed and sent to the states by the first session of the First Congress. They became effective Dec. 15, 1791.)
